J&K Set To Hold Panchavat Elections By Year-End

Srinagar: Jammu and Kashmir is gearing up for Panchayat and urban body elections by December, following the conclusion of the Lok Sabha and Assembly polls.

Officials have confirmed to a Delhi based media outlet that security forces deployed during these earlier elections will remain in place to ensure peaceful conduct of the upcoming polls.

"Preparations are now underway for the Panchayat and urban body elections in J&K. For this purpose, security forces deployed to ensure the peaceful conduct of the Assembly elections will remain in J&K until the municipal and panchayat elections are completed," said an official.

The terms of the municipal corporations in Jammu and Srinagar expired last November, making the elections long overdue. The government is prioritizing the completion of these elections to fulfill legal requirements and restore local governance. | More on P6

Will Soon Crack Terrorists' **Encrypted Handsets: GoC**

Srinagar: General officer Commanding (GoC) of army's Srinagar based 15 Corps Lieutenant General Rajiv Ghai Thursday said the Army would soon be "able to crack" encrypted handsets used by terrorists in Jammu and Kashmir.

Talking to reporters here, Lt Gen Ghai acknowledged that the 'Ultra' communication was giving secrecy to terror groups but he assured that the work is in progress.

"Ultra communication has various layers of encryption and while presently, it is affording them the secrecy that they want.

"But I assure you that work is happening in that regard and soon we will be able to crack that encryption and I am hoping that will further dent the terrorist ecosystem network," Lt Gen Ghai said in his last press conference as commander of valley-based XV Corps. He will soon take over as Director General of Military



Operations.

To a question about weaponization of mobile phones used in Israel-Lebanon conflict, he said, "Every time a new method is employed by any military force across the world, we always take note of it to draw our own lessons. so we can incorporate what is relevant to us and prepare our army and armed forces

He added that the security forces in Jammu and Kashmir

are closely monitoring the situation in West Asia to ensure there is no adverse impact on the security scenario in the Union territory, he said.

"Regarding the ongoing global conflicts, such as those in the Middle East, and their potential impact, we have observed some minor effects. There have been some protests even within the valley. Right now, we have no indication that these could escalate into a more concerning situation," Lt Gen Rajiv Ghai, General Officer Commanding (GoC) of the Army's strategic Srinagar-based Chinar Corps, told reporters.

Srinagar: Three days after Iran stunned the world by launching a massive missile strike on Israel Supreme Leader Ayatollah Sayyed Ali Khamenei has announced that he will be personally leading weekly congregational prayers in Tehran this Friday.

The leader will be appearing in public after several Western media outlets reported that Avatollah Khamenei has been transferred to a "secure location with increased security measures" following Israel's assassination of Hezbollah Secretary-General Sayyad Hassan Nasrallah on September 27 and subsequent Iranian retaliation against Israel.

Sayyed Khamenei will be leading Friday prayers at Imam Khomeini Mosalla in suburban Tehran and his sermon is anticipated to set the tone for Iran's future strategy against Israel. Ayatollah leads Friday prayers only under extraordinary circumstances, the last time was 2020 after American assasination of Gen. Qassem Soleimani.

Game-Changer In J&K Polls?

5 Nominated MLAs To Hold Key To Govt Formation

Srinagar: For the first time in Jammu and Kashmir's political history, five nominated Members of Legislative Assembly (MLAs) will have a significant role in forming the new government following a decade-long hiatus.

These MLAs, representing Cashmiri displaced and those from Pakistan-Occupied Jammu and Kashmir (POJK), will hold full legislative powers and privileges, just like elected representatives.

As per the details, among the five, two will be Kashmiri displaced members—one woman and one man-while one will represent the POJK displaced community.

This will be a milestone in terms of representation for these communities, as their inclusion in the legislative assembly has been a longstanding demand.

With this new arrangement, the Jammu and Kashmir Legislative Assembly will expand to 95 members, including the five nominated ones, increasing the majority threshold to 48 seats to form a government.

The Lieutenant Governor will nominate these members based on the advice of the Home Ministry. This process follows an amendment to the Jammu and Kashmir Reorganization Act, 2019, which was further revised on July 26, 2023, to introduce these nominations.

Political experts said that the system mirrors the legislative structure of Pondicherry, where four nominated members already exist. However, this step has been taken in Jammu and Kashmir following the abolishment of the Legislative Council | More on P6

Climate Change Woes: Kashmir's Apple **Production Drops 30% For Second Year**

Srinagar: Apple production in Kashmir has plummeted by at least 30% for the second consecutive year due to climate change and erratic weather patterns.

Growers across the region said that a series of adverse weather conditions during the critical fruit set season to a huge drop in their yields.

Farmers said that March was characterised by dry, high temperatures, followed by a wet, cool April and a prolonged dry spell that adversely affected fruit production.

These erratic conditions disrupted essential spray schedules and led to outbreaks of scab and other diseases which further diminished an already low harvest, they said, adding that recent hailstorms and the prevalence of leaf miners have severely impacted both the quantity and quality of apple production.

Irshad Ahmad, a grower from Anantnag district, said that in some areas, production has dropped to just 70% of last year's yield.

Jahangir Ahmad Dar, a fruit



grower from Watchi Shopian, reported a drastic decline in his harvest. "I went from around 1,200 apple boxes last year to barely 300 this year," he said.

He explained that many marginal farmers are struggling to cover the costs of pesticides and fertilizers, particularly since more expensive treatments were necessary to combat diseases.

After years of challenges, including untimely snowfall and hailstorms, growers had hoped for better returns this year, but those hopes have been dashed.

Recent hail storms in south Kashmir have caused huge damage to apple crops, com-pelling growers to call for

immediate government action, including the implementation of a crop insurance scheme to mitigate their losses.

Bashir Ahmad Bashir, president of the Kashmir Valley Fruit Growers and Dealers Association, confirmed that overall production has decreased by approximately 30% this year | More on P6

J&K Assembly Staff Ordered To Report Back

Srinagar: Days ahead of counting of votes, the Jammu and Kashmir administration on Thursday directed all employees of the legislative assembly, who were sent on deputation to various departments, to report back to the House secretary immediately.

Voting for the 90-member assembly was held in three phases and the results would be declared

The General Administration Department's (GAD) states, "It is hereby ordered that all employees belonging to the Jammu and Kashmir Legislative Assembly, deployed in various departments/offices by the General Administration Department from time to time, shall immediately report in the office of secretary, I&K Legislative Assembly, Jammu/ Srinagar."

According to the order, the secretary of the Jammu and Kashmir Legislative Assembly shall furnish details of non-compliance with the order, if any, to the General Administration Department within one week.

Assembly elections in Jammu and Kashmir were held after a gap of 10 years. The last assembly was dissolved in 2018, prompting the GAD to use the services of Assembly employees in other departments.

New Haircuts, Same Streets: Homeless People Return To Life On The Pavement

Srinagar: A few months ago, in the Nawakadal locality of Old Citv. a homeless man sat under the spotlight as camera lenses captured his transformationa makeover that seemed to promise a fresh start. With every snip of the scissors, onlookers watched in hope, believing the change in his appearance might reflect a change within.

Days later, while his outward appearance may have been refreshed, the man has returned to the streets, highlighting that the deeper issues of homelessness and mental health do not change with a physical makeover.

Recently, an initiative swept across the streets of Srinagar and other districts in Kashmir. A team called Kashmir Youth Courage (KYC), led by Musadiq Bashir, embarked on a mission to offer haircuts, shaves, and clean clothes to the homeless



population. The team, composed of young volunteers, received widespread praise on social media for their efforts to help those who have been living in destitution, often neglected and left to fend for themselves.

The sight of unkempt hair, overgrown beards, and ragged clothes was replaced by fresh haircuts, shaven faces, and clean attire as the KYC team worked tirelessly to give the homeless a temporary makeover. However, this initiative has sparked significant debate within the medical community, particularly among psychiatrists and psychologists, who caution that it is not a solution

to the deeper, more complex issues faced by these individuals. Experts argue that without proper mental health care, rehabilitation services, and ongoing support, the homeless will continue to return to the streets,

regardless of how they look. Speaking to Observer, Dr. Yasir Rather, a

professor in the Department Psychiatry at the Institute Mental Health and Neurosciences (IMHANS), GMC Srinagar, noted that homeless individuals often suffer from chronic mental health disorders such as psychosis, bipolar disorder, and schizophrenia.

"A mere haircut cannot change years of mental illness. While these efforts may make them look better temporarily, they do nothing to address the underlying mental health conditions that led to their homelessness in the first place," Dr Yasir said.

He further said that they need proper rehabilitation where they have access to all the facilities including food, accommodation and other such things, which is not being done.

Researchers Link Climate Shocks With Increased Domestic Violence



limate shocks such as floods and landslides are likely to lead to an increased domestic violence over the next two years, researchers, who analysed survey data from 156 countries between 1993 and 2019, have found.

As global warming intensifies, the researchers, led by those at the University College London, UK, urged countries to include funds and gender action plans in climate mitigation to address this issue, even as they said the climate shock-violence link remains complex and challenging to discern in a manner understandable to policymakers.

The team did, however, add that domestic violence was increasingly prevalent and severe, especially in countries having patriarchal societies where violence against women is considered acceptable. Violence rates were found to be low in countries having a higher Gross Domestic Product. The analysis, published in the journal PLoS Climate, is the first to provide evidence of how climate shocks can influence national rates of physical and sexual intimate partner, or domestic, violence, the authors said.

It also adds to global evidence regarding the social impacts of climate shocks, which can often be felt long after the events, thereby building a case for policymaking and action, they said.



"All of this happens more often and with increased severity in countries that have patriarchal gender norms and where the use of violence against women is widely accepted as normal behaviour," lead author Jenevieve Mannell, from the University College London's Institute for Global Health,

stress and food insecurity in families in ways that can lead to increases in violence. They also reduce the social services often available for dealing with partner violence, such as police and civil society who are more focused on the disaster," Mannell said.

Previous studies have found that rising heat and humidity increases aggres-

"We set out to explore what was happening at a national level to help inform international climate change policy," Mannell said.

The researchers also included climate shocks data -- floods, storms, landslides, extreme temperatures, droughts, earthquakes, volcanoes, wildfires -- from 1920 to 2022 across 190 countries in their analysis.

Floods were found to be the most strongly linked with domestic violence, followed by storms and landslides. Earthquakes, volcanoes, and wildfires, on the other hand, were found to not influence violence rates. "National data representing 156 countries suggest a significant relationship between intimate partner violence and a climate factor composed of storms, landslides and floods," the authors wrote.

The researchers said they could not assess as to why certain kinds of climate shocks impacted intimate partner violence more than others.

They proposed that varied types of climate shocks can take different times before showing their effects on violence against women, which they said could possibly not be captured within the two-year window of the study period.

Therefore, they called for more regular data collection by countries for measuring domestic violence in the context of climate change.

'Housing Sales Rise 5%To 87,108 Units **Across Top 8 Cities In** Jul-Sep'

ousing sales rose 5 per cent annually during July-September to 87,108 units in eight major cities as demand stayed strong for premium homes, according to Knight Frank

Real estate consultant Knight

Frank India on Thursday released its report 'India Real Estate' for the third quarter of 2024 calendar year through a webinar, showing a modest increase in housing sales in contrast to data provided by Anarock and PropEquity which reported drop in total sales during July-September across major cities. 'Momentum in the residential market has trended up well in 2024 with O3, 2024 recording the highest quarterly sales this year at 87,108 units," the report said. Addressing a virtual press conference, Knight Frank India CMD Shishir Baijal said, the growth in housing sales is driven by demand for premium housing costing above Rs 1 crore each.

"There are concern in affordbale housing segment," Baijal said, adding that sales in this category have declined due to availability and affordability challenges.

Life Expectancy In Men Could Rise By A Year On Cutting Down Smoking: Lancet

utting down smoking to five per cent of current rates by 2050 would increase life expectancy by a year among men and

0.2 years in women, according to recent global modelling studies published in The Lancet Public Health journal.

The researchers found that based on current trends, smoking rates around the world could continue to reduce to 21 per cent in men and about four per cent in women by

Along with improving life expectancy, accelerating efforts to eliminate tobacco smoking could avoid 876 million years of lives lost to death, researchers forming the Global Burden of Disease, Injuries and Risk Factors (GBD) Tobacco Forecasting Collaborators said. They also found that banning sales of cigarettes and other tobacco products

could prevent 1.2 million lung cancer

deaths across 185 countries by 2095. Of Health Metrics and Evaluation (IHME), these deaths, nearly two-thirds would be averted in low- and middle-income countries, because they tend to have more younger populations compared to



high-income ones, the authors said. "We must not lose momentum in efforts to reduce, and ultimately eliminate smoking around the world. Our findings highlight that millions of premature deaths could be avoided by bringing an end to smoking," said senior author, Stein Emil Vollset, of the Institute for

University of Washington, US, which coordinates the GBD study.

The estimates regarding preventable deaths came from analysing how banning tobacco sales would impact lung cancer deaths among people

born between 2006 and 2010. They also depict the potential effects of the tobacco-free generation policy, which aims to prevent the sale of tobacco to people born

after a specific year. The policy has not been implemented in any country, the authors said.

New Zealand's December 2022 legislation to ban the sale of tobacco products to anyone born in or after

2009 was repealed earlier this year. Along with maintaining existing tobacco policies, the authors called for implementing new ones to avoid additional smoking-related risk of disease and ensure that the gains made over the past decades are not lost.

Similarly, the Addiction

Treatment Facility (ATF) at SKIMS, Bemina, reported 158 new patients seeking help, with 14,781 cumulative follow-up sessions during the same timeframe.

Law enforcement agencies in Srinagar shared that between April and August 2024, 20 cases under the Narcotic Drugs and Psychotropic Substances (NDPS) Act were registered, resulting in 35 arrests.

Additionally, 11 individuals were detained under the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PIT NDPS) Act.

Regarding seizures, 139.65 kg of heroin, 15.105 kg of poppy straw, bhang, 2.69 kg of Charas, 17.8 grams of brown sugar, 36 bottles of psychoactive syrups and capsules, and 3.5 kg of ganja were confiscated in the district during the same period.

The committee also reviewed efforts to eradicate wild cannabis and poppy cultivation. Over 82 Kanals of wild cannabis were reported to have been destroyed.

J&K Team For Tibet To Find Truth Of 'Shahtoosh Threat'

rinagar- Chief Minister Farooq Abdullah today said the Centre would be approached to seek China's permission for facilitating the visit of a team to Tibet to find if continuing Shahtoosh trade threatens antelope.

Speaking at a function held in observance of the mil¬lennium's first wildlife weak hare this afternoon, the chief minister said the team will comprise wildlife officials and representatives of Shahtoosh traders whose trip would be sponsored by the government. "If the team feels threat to antelope as genuine, the Shahtoosh traders will have nothing to do with it", he said, adding that with this the controversy over the issue would end once for all.

The chief minister said that as a result of measures taken to preserve wildlife, their population is on increase in the state. He stressed for creating awareness among the people especially students about the need for protecting wildlife and said that two zoos would be set up at Manda in Jammu and Dachigam in Srinagar for people to see nature's fauna. He asked for prepar¬ing comprehensive plans for conservation of various sanctuaries like Hokersar, Hygam and Mirgund.

Abdullah called for evolving a mechanism and adopt¬ing an integrated programme for making use of dead wood as fuel by those living near forest while stringent measures would be taken for preserving the green trees. Steps have to be taken for bridging the gap between ener¬gy-need and energy source. This has become imperative in view of growing pressure of forest resource since other sources of energy like electricity and LPG have become costlier and scarce. He made .a fervent appeal to the people for making judicious use of electricity, generation of which is affected during winter due to lesser water flow.

Waiting For The Day

fter the conclusion of the voting in the Assembly election, all eyes are now focussed on October 8 when the outcome is going to be declared. No one party is favourite is to win the election, although the NC and the BJP seem to have a distinct edge over others. More so, the BJP which operates in a less crowded electoral scene in Jammu division, with the Congress its only major competitor. This is perhaps why the state Congress chief Tariq Hameed Karra on Wednesday extended an invitation to "like-minded" parties for government formation, saying they were open to taking support in case the need arises.

This election did not generate a wave in favour of any political party, including that for Engineer Rashid who was supposed to galvanize a mass mobilization soon after his release. It is true that in the Valley, the NC started as a stronger party in the fray. But the initial perception was dented by the intensifying electoral competition as the campaign progressed. The NC now seems to barely holds on to its initial edge in the campaign. For example, in South and Central Kashmir, where the PDP, Jamaati-Islami and even Rashid's Awami Ittehad Party (AIP) crowded the electoral scene, making the outcome uncertain. The NC's once strong opponent, the PDP, has also showed some spark in its core constituencies in south Kashmir and is expected to garner some seats. The new political outfits like the Democratic Progressive Azad Party (DPAP) floated by the former top Congress leader Ghulam Nabi Azad and the Apni Party led by the businessman turned politician Altaf Bukhari were also in the fray, but they seem to have not made much of a mark so far, more so the former.

Although Kashmir has witnessed many elections over the decades, this one is likely to go down as one the most interesting and fiercely contested. Not only were several political parties vying for votes but there were also many independents in the fray. This confused the voter, probably preventing the formation of a coherent public opinion. Whether the voter exercised his wisdom in casting his ballot will be shortly known.

On the other hand, it would be interesting to see how the BJP fares in Jammu division. Will the party replicate its 2014 performance now? It could very well do so. But the electoral scene for the party is not as conducive as it was in 2014 when the Modi wave was at its peak. But if the saffron party does cross 25 seats in the region, it is certain to be in a driving seat in the government formation. But for now we can only wait and watch and hope for an elected government that gives people a sense of stake in the system.

India's Middle-Income Trap

The World Development Report is a sobering pointer on the need to be humble and nimble, else it will take 75 years for India to reach even a quarter of US GDP

To get rich is glorious. However, the road ahead is tricky as the world economy faces multiple challenges: slowing growth, ageing population, rising debt, intensifying geopolitics, and trade tensions

he World Bank releases an annual thematic report named the World Development Report (WDR). This year's WDR is based on middle-income (MI) trap. The theme is highly interesting as it opens up the debate on the future of the world economy from a different perspective. The WDR also makes an important reading for India's policymakers in their drive to make India a developed economy.

First, what is a MI economy? Since 1987, the World Bank has classifying economies across four income categories: high income (HI), high middle income, low middle income, and low income. In the 35-year period, the number of HI countries doubled from 41 to 86 and that of low-income countries halved from 49 to 26. The number of MI countries (both lower and upper) has increased from 74 to 108. In 2022, HI countries constitute 16% of the world population and 60% of the global gross domestic product (GDP). MI countries housed 75% of the global population and has about 38% of the global GDP. The share of low-income countries in the world population and GDP were 9% and 0.6% respectively.

What is an MI trap? Another World Bank Report released in 2007 (An East Asian Renaissance: Ideas for Economic Growth) showed that middleincome economies undergo systemic slowdowns and remain trapped in their middle-income status. Specifically, the trap occurs when a country reaches about 11% of the GDP per capita of the US. The WDR shows only 34 economies have succeeded in shifting from the middle-income to high-income category in the last 35 years. Since 1970, the mean income per capita of middle-income countries has never risen above one-tenth of the US'. This systemic slowdown of economic growth is the MI trap.

Why do countries remain in the MI trap? After all, we now know what it takes to shape a developed economy: a solid

macroeconomic foundation inviting both domestic and foreign investment, supported by strong institutions and clean governance. Economic research shows that in the low-income stages, countries can develop by simply channelling savings towards investment. As they reach middle income, diminishing returns from investments set in and they are unable to grow any further. Economic research has cited multiple fac-tors for the trap with different countries showing different combinations of the factors: volatile economic growth, slowing productivity, undervalued exchange rates, less technologyintensive exports, weakening institutions, etc.

What is the solution to escape the MI trap? After all, all middle-income economies have the ambition to enter the highincome club. The WDR has a nice phrase to sum up the ambition: To get rich is glorious. However, the road ahead is tricky as the world economy faces multiple challenges: slowing growth, ageing population, rising debt, intensifying geopolitics, and trade tensions. Yet MI countries are relying on old policies of expanding investment. You can't drive a car looking at a rear-view mirror. At current trends, it will take China more than 10 years and Indonesia 70 years just to reach one-quarter of the US income per capita.

The WDR identifies three drivers of growth in the new playbook: investment, infusion, and innovation, or the three Is. Middle-income economies have to undergo two transitions. First, primarily lower-middle-income countries should complement investment with infusion where focus is on imitating and diffusing modern technologies. Second, innovation is added to the investment and infusion mix, so that now the upper-middle-income countries become modern innovators themselves and join the high-income club.

Japan and Korea are excellent examples of the two transitions where their domestic firms initially licensed technologies from leaders before becoming tech leaders themselves. The WDR also discusses Eastern European economies like Estonia which managed the transition swiftly, Poland steadily, and Bulgaria slowly.

What lessons can be drawn for India? India transitioned from a low-income economy to low-middle-income in 2007. In 2022, India's per capita income was \$2,400 which is around 3.1% of the US per capita income (\$76,590). The evidence suggests MI trap starts at around 11% of the US GDP, so there is both high potential but also a long journey to becoming a high-income country. There is tremendous potential for all the three Is to develop in India. However, there is no policy document on the path towards becoming a developed nation. The WDR is a sobering pointer on the need to be both humble and nimble, else it will take nearly 75 years for India to reach even one quarter of the US GDP.

In a way, the WDR is not say ing anything new. Adam Smith, in The Wealth of Nations, made similar points albeit in a different jargon. However, economic history shows that transitions are neither linear nor smooth. Marx had argued that these transitions will be embroiled with class conflicts leading to crises. However, it was Schumpeter who showed that creative destruction in capitalism led to both crises and restoration. The WDR, based on Schumpeterian economics, wishes to make the "middle-income expression trap" completely obsolete. Over to the policymakers for distilling lessons from the WDR and acting

How To Archive Your Photos In The Digital Age

■aking photographs used to be a careful, conscious act. Photos were selective, frozen moments in time carefully archived in albums and frames. Now, taking a photograph is almost as effortless and common as breathing - it's something that people do all the time in the age of smartphone cameras with seemingly endless digital film.

But the downside to capturing every moment is that it creates a mountain of those moments to save for the future. Those photos can be easily lost if they're not archived properly. All it can take is one accidental dip in the toilet for your phone, and all that data is lost forever.

So what's a practical backup strategy for the average person? Here are a few ways to make sure memories are never lost:

Cloud storage

The simplest way to archive your photos is cloud storage. For Apple users, there's iCloud. which starts at US\$0.99 per month for 50 gigabytes all the way to \$59.99 per month for 12 terabytes with various tiers in between. With an average iPhone photo clocking in at 3 megabytes, that's a little over 16,000 photos for the cheap plan and 4 million or so for the largest plan. Google's Google One cloud storage is most cost effective for yearly plans, with 2TB going for \$99.99 per year and 5TB going for \$249.99 per

The actual amount you can store in that space does vary

greatly with how a file is shot. Video has larger file sizes than photos. HEIF files, a newer format on Apple phones, compresses files into smaller packages, but long-term compatibility is unknown since the format hasn't been in use for as long as the standard JPG file, which has been around since

While cloud services from big providers generally provide the easiest way for most average folks to back up their photos, and operate with little to no intervention via apps that are already on the phone constantly uploading every photo taken, there are risks involved.

Big companies often change their policies about how photos are saved. For instance, depending on what phone and when it was bought, Google's cloud storage may have saved photos in a "storage saver" format that lowers the quality of images by sizing them down or compressing them differently. This affects your ability to make high-quality prints or view the photos on high-resolution screens down the road. Unless someone is astute enough to notice small text here and there that mentions it, most users won't even realize it's happening.

And what happens to cloud services when things go badly wrong? Users of photo backup service Digital Railroad found out the hard way. In 2008, the company abruptly shut down and gave its users 24 hours to download everything before the servers were shut down. Photographers rushed for the exits, trying to grab their photos

on the way out, only to strain the servers to the point where few were able to recover anything at all. If this was the only way photos were backed up, it's a lost cause.

So while the cloud is easy, costs can add up and terms of service can change at a moment's notice. What are some

The easiest and most cost-efficient types of printers are dedicated 4x6 printers using a technology similar to professional labs called dye-sublimation. These yield high-quality, waterproof prints that cost about the same as what one would pay for drugstore developing. HP makes its popular Sprocket line of printers, though those require a phone and an app to print from, which makes plugging in a memory card from a professional camera out of the question. However, Canon's Selphy lineup includes many models with screens and a card slot

to make that possible. The rabbit hole goes very deep, and there are many professional printers that can print even larger sizes. Canon and Epson dominate this space, marketing a range of pigment- and dye-based printers that can emphasize archival needs or color saturation, respectively.

Another option is ordering a photo book, which, as the name suggests, is a physical bound book of your photos. However, photo books are probably more appropriate for memorializing an event - trip, wedding, project - than general archiving, given the typical costs and number of photos involved.

There's little reason to not make some sort of backups of photos in 2024, whether that's on printed media, hard drives or in the cloud. The important thing is not which method to use, but to do it at all.

year so far like last year. "We need a few more good years to make peace a permanent feature here. I believe maintaining this peaceful atmosphere is the biggest challenge for the security forces," the GoC 15 Corps said.

Lt Gen Ghai said that there hasn't been any active recruitment of terrorists this year. "The numbers were down to a dozen last year and this year it is next to nil," the GoC said.

He said as far as the terrorist-initiated incidents in Kashmir, they are between far and few. "Some incidents were reported where soft targets were made by even an untrained person using a pistol," the army officer said.

On the total number of active terrorists at present, the GoC said: "There are only 80 terrorists active in the region at present which is less than previous years," he said.

To a query whether any troop cut was possible at this juncture, the GoC said, "We are in a consolidation phase and no dilution of counter insurgency and counter terrorism grid is recommended. Both the grids need to be maintained. I definitely won't advocate any dilution to these grids at this stage," the GoC said.

Earlier, in his opening remarks, the GoC said that during the past a year-and-a-half, numerous attempts counter infiltration steps were taken while simultaneously prosecuting a very robust and successful counter terrorist campaign within Kashmir. "While doing this, we have been very conscious of our responsibility and nation building. So we have maintained our connection with the Awam (people of Kashmir," the army officer said.

He said that the region is seeing a new beginning as numerous significant events are taking place besides development. "This is because of the efforts put in by (Chinar corps) 15 Corps, police, CAPF, police and numerous other security agencies," the GoC said.

world. Every city has a Friday prayer Imam appointed by the state and prayers are held only in a central mosque or a major prayer ground. In Tehran tens of thousands attend Friday prayers at Tehran University grounds but this Friday prayers will be offered at Mosala grounds to accommodate larger numbers.

Ayatollah Khamenei is also expected to announce the date of the funeral and burial place of Sayyed Nasrallah which has not yet taken place due to ongoing war in Lebanon.

The Israeli offensive and fear of more attacks have also prevented Hezbollah from organising a nationwide funeral on a scale reflecting Nasrallah's religious and leadership status.

"No one can authorize a funeral in these circumstances," one Hezbollah source said, lamenting the situation in which officials and religious leaders could not come forward to properly honor the late leader.

Several commanders killed last week were buried discreetly on Monday, with plans for a proper religious ceremony when the conflict ends

Hezbollah is mulling the option of securing a religious decree to bury Hassan Nasrallah temporarily and hold an official funeral when the situation permits, some Lebanese sources said.

Speculation also continues over where Nasrallah will be buried, with conflicting reports suggesting either Lebanon or Iraq as his final resting place, according to an article released on Abu Dhabi-based The National.

Iraqi officials and local media have indicated that Sayyed Nasrallah may be buried at the Imam Hussein shrine in Karbala, as he was an important figure within the Shia community.

Abdul Amir Al Teiban, an adviser to Iraqi Prime Minister Mohammed Shia Al Sudani, posted on X that Nasrallah would be buried "next to Imam Hussein, in Karbala."

Now all eyes are on Friday sermon of Ayatollah Khamenei as speculations are rife that Iran leader will announce funarl date and place of burial of slain Hezbollah leader.

J&K Set To Hold

Security forces, initially deployed for the Amarnath Yatra and later for the Lok Sabha and Assembly polls, will remain in J&K. "The decision to retain the security forces has been taken, keeping in view the high cost associated with to-and-fro movement and redeployment," officials noted.

Once these polls are completed, Jammu and Kashmir will see the full restoration of democratic processes at all levels post the abrogation of Article 370. The Panchayat elections will be conducted by the J&K State Election Commission, rather than the Election Commission of India.

"The 2024 Panchayat poll will be held after fresh delimitation of 'Halqas' (Revenue Villages)," officials added, with almost 30,000 panches and sarpanches having completed their terms earlier this

Responding to media reports regarding the nominations, the Jammu and Kashmir Pradesh Congress Committee (JKPCC) said the authority to nominate these five members should rest with the newly formed government.

"The people have cast their votes to elect their representatives to form the government. The party that secures a majority in the elections deserves the opportunity to govern," Sharma asserted.

While the Congress party supports the idea of reserving seats in the Assembly for refugees from Pakistan-occupied Jammu & Kashmir (PoJK), Kashmiri Pandits and other minorities, it cautioned against the misuse of nomination provisions to subvert the electoral mandate.

"Using nominations to dilute the people's choice would be a grave injustice," he added. (KNO)

who received makeovers returning to the streets soon after, Naireen, a psychologist based in Srinagar said that is not unusual for these individuals to go back to their old ways because they need proper psychiatric treatment, not just a superficial change in appearance," she said.

Naireen further said that putting them on social media risks breaching their privacy and is against others.

Pertinently, the mental health challenges faced by the homeless population are profound. A 2019 meta-analysis revealed that the prevalence of psychosis (21.2%) and, more specifically, schizophrenia (10.3%) is significantly higher among homeless individuals compared

to the general population globally.

Psychologists argue while the haircuts and makeovers have provided a temporary boost in morale and self-esteem for some, the long-term challenges of mental illness and homelessness remain unaddressed.

Waseem Kakroo, another psychologist, voiced concerns about the ethical implications of the move.

"While the effort by the team of youth has been lauded across social media, it needs to be carefully examined. The act of cutting someone's hair, shaving their beard, and dressing them in clean clothes without their consent can be dehumanizing. It takes away their control over their own bodies and perpetuates the notion that people with mental health issues need to be 'fixed' by others. This approach, while seemingly compassionate, may actually reinforce the stigma surrounding mental illness," Wasim said.

Kakroo emphasized the importance of consent and the need for a more thoughtful approach when engaging with vulnerable populations. "At first glance, helping someone who is struggling seems like a praiseworthy act. However, the way it is done matters. Forcing someone to change their appearance without asking them can be disrespectful and unkind. It is crucial that we treat people with mental health issues with dignity and respect, recognizing their autonomy and right to make decisions about their own bodies."

Pertinently, despite videos of homeless people doing rounds on social media, government departments have turned a blind eye towards the suffering of these people.

Although old age homes are operational in various districts of Kashmir, they lack sufficient resources to adequately support individuals facing mental health challenges. Speaking on anonymity, an official from the social welfare department said the government department is not in a position to keep these centers working round the year in all districts.

Musadiq Bashir, the founder of KYC, acknowledged these concerns. Speaking to Kashmir Observer, he admitted that the team's efforts have only scratched the surface of the problem.

"We are aware that we are doing little for the homeless, and we know that many of them are returning to the streets after getting a haircut. However, we are in the process of establishing a rehabilitation center for the homeless and have approached the government for support in this endeavor."

Musadiq said that they have decided to establish their own center in South Kashmir, where they will avail the services of mental health professionals. "It was after the officials from the Social Welfare Department said that they don't have enough grants to establish the facility. We are awaiting permission and will run the facility in the next ten days."

Syed Mujtaba, a Lawyer, working on mental health rights said that these acts are not only ineffective but these videos also reveal the faces and locations of the persons they are assisting, thereby infringing upon their right to privacy.

"The actions of this group, in recording and disseminating videos without the consent of the individuals concerned, constitute a blatant violation of these legal provisions. Such practices not only demean the dignity of the individuals but also exacerbate their vulnerabilities, potentially leading to further stigmatization and discrimination."

Mujtaba said that the Mental Health Care Act, 2017, explicitly safeguards the privacy and dignity of individuals with mental health illness.

As per Act, "Every person with mental illness has a right to live with dignity and such persons should be protected from cruel, inhuman and degrading treatment" Mujtaba said.

With respect to privacy, the privacy of patients must be respected to the extent possible. Furthermore they have a right to be protected from physical, verbal, emotional abuse. With the extension of their Rights, No person with mental illness should be forced to shave their head as well. Mujtaba said the mental health Care Act 2017, under Sec 100 places duties on law enforcement officials for taking into protection homeless and wandering persons who are suspected of having mental illness.

The concerned police officer has to lodge an FIR for missing, and to report to the Magistrate about ill treatment or neglect. Additionally, Article 21 of the Constitution of India guarantees the right to life and personal liberty, which encompasses the right to privacy.

No Need To

now repealed and replaced by the Bharatiya Nyaya Sanhita (BNS), sexual intercourse or sexual acts by a man with his wife, the wife not being minor, is not rape. Even under the new law, Exception 2 to

Even under the new law, Exception 2 to Section 63 (rape) says that "sexual intercourse or sexual acts by a man with his own wife, the wife not being under eighteen years of age, is not rape".

"Furthermore, it is submitted that striking down the exception 2 of section 375 of IPC on the ground of its constitutional validity will have a far-reaching effect on the institution of marriage if sexual intercourse or sexual acts by a man with his own wife is made punishable as 'rape'," the Centre said in its affidavit.

"It may severely impact the conjugal relationship and may lead to serious disturbances in the institution of marriage," it said.

The Centre said in the fast growing and ever changing social and family structure, misuse of the amended provisions can also not be ruled out as it would be difficult and challenging for a person to prove whether consent was there or not.

It said to decide on the constitutionality of the provision, a holistic approach and consultation with all the states needs to be undertaken after taking their views into consideration.

"This is more so since the issues involved

have a direct bearing on the society in general and is a part of Concurrent List of the Seventh Schedule to the Constitution of India," the Centre said.

It said the issue involved in the matter is more of a social issue rather than a legal issue and the same cannot be decided without proper consultation with all the stakeholders or taking the views of all the states into consideration.

"It is submitted that the act colloquially referred to as 'marital rape' ought to be illegal and criminalised. The central government asserts that a woman's consent is not obliterated by marriage and its violation should result in penal consequences. However, the consequences of such violations within marriage differ from those outside it," the affidavit said.

It said Parliament has provided different remedies, including criminal law provisions, to protect consent within marriage.

"Given the nature of the marital institution in our socio-legal milieu, if the legislature is of the view that, for preservation of the marital institution, the impugned exception should be retained, it is submitted that it would not be appropriate for this court to strike down the exception," the Centre said.

It said the Government of India is committed to fully and meaningfully protect the liberty, dignity and rights of every woman who are the "fundamental foundation and a pillar of a civilised society".

The affidavit said a husband certainly does not have any fundamental right to violate the consent of the wife, however, attracting the crime in the nature of "rape" as recognised in India to the institution of marriage can be arguably considered to be excessively harsh and therefore, disproportionate.

It said the question involved in these petitions may not be treated merely as a question concerning constitutional validity of a statutory provision as the subject matter has and will have very far-reaching socio-legal implications in the country.

"The matter, therefore, needs a comprehensive approach rather than a strictly legal approach," the Centre said.

"Therefore, it is respectfully submitted that if the legislature decides to exempt, from the rigour of such a charge, and such a label, husbands, vis-a-vis their wives, given the intelligible differentia that exists in a marital relationship vis-a-vis other relationships, the said decision and discretion should be respected and not interfered with especially when a separate suitably tailored penal remedy is provided by the Legislature," it said.

The affidavit said the outcome of the petition will have a larger impact on the society, especially considering the concept of marriage in India which creates social and legal rights on the part of both individuals and others in the family.


A bench headed by Chief Justice D Y Chandrachud is seized of various pleas on the issue.

The top court on January 16, 2023 sought the Centre's response on a clutch of petitions assailing the IPC provision, which provides protection to a husband against prosecution for forcible sexual intercourse if the wife is an adult.

Later, it also issued a notice to the Centre on a similar plea challenging the BNS provision on the issue.

The BNS, Bharatiya Nagarik Suraksha Sanhita and the Bharatiya Sakshya Adhiniyam came into effect from July 1, replacing the IPC, Code of Criminal Procedure (CrPC) and the Evidence Act, respectively.

Advertising Policy Of Local Universities Remain Restricted To Urdu, English Languages,

SRINAGAR: As part of the efforts, the Islamic University of Science and Technology (IÚST) organized a national level conference titled "Promotion of Kashmiri Language" recently. The endeavour by the IUST is being highly appreciated in the

However, on the other hand, discontent is also being expressed over the lack of "practical measures" for the promotion and protection of the Kashmiri language. Many activities are being carried out in the varsity regarding promotion of Kashmiri language, but when seen practically, it appears as nothing but public

Scholars and literary experts have expressed happiness at the two-day conference organized at the Islamic University Awantipora and said that this initiative was important for the promotion of the original culture of this place. However, they said, there is a need to enforce such policies on the ground level. Otherwise, they said, there will be such conferences that serve very little or no results. Kashmiri language experts say that the basic things that must be taken into

account for the preservation of the language and culture is to ensure maximum access to the people. And in contemporary times, they said, the media is a necessary form of it. If any educational institutions want to take practical steps to promote and protect the glorious Kashmiri language and culture, they must take the local media along with it and make the most of it. "Publicity must be ensured," they said, expressing disappointment that not much is being done in this regard. "Here unfortunately the case is reversed," they said.

Kashmiri University and other educational institutions, be it Central University and Islamic University Awantipora, they said, carry out many activities related to Kashmiri language, but all this is done "within the campus". "There is lack of proper promotion thereafter and it does not have much benefit, more so when it comes to the world outside.

It is worthwhile to note here that in the University of Kashmir, there is a department for preservation of Kashmiri language and literature under the name of Sheikh Alam Chair. However many people say hardly anyone knows what the results of this chair has been on the ground level.

Central University Ganderbal also publishes a journal in Kashmiri language, but its reach is also limited, they point out. Experts say that if these universities use their expertise and experience to promote Kashmiri language and make it popular on the ground level, the results would have been different.

They said that it is strange that only English and Urdu language are used to advertise seminars, conferences and other activities related to Kashmiri language, although there is a well-known and reliable daily published in Kashmiri language, "Kahwat" through which the activities being done for the promotion and preservation of Kashmiri language would have been further strengthened.

It is also noteworthy that Kashmir University, Islamic University, Central University and other academic and literary institutions have effective advertising policy but for reasons best known to them, use of Kashmiri language as a medium is neglected. Apart from this, other institutions are also required to give priority to Kashmiri media for the promotion of the beautiful language. (KPS)

Babar Azam Quit White-Ball Captaincy After Being 'Solely' Blamed For Pakistan's Poor Performances

KARACHI: Babar Azam lost his interest in captaining Pakistan's white ball teams after a critical report submitted by head coach Gary Kirsten to the Pakistan Cricket Board, according to sources close to the team.

Babar on Wednesday resigned as Pakistan's white-ball cricket captain for a second time in 11 months, citing a need to lessen his workload and focus on improving his game.

He had stepped down as captain of all three formats last year after Pakistan failed to make the knockout stage of the 50-overs World Cup, before returning as white-ball skipper in March ahead of the Twenty20 World Cup, where Pakistan did not make it to the Super Eight stage.


Babar was disappointed that he was being blamed for Pakistan's lackluster showing in the T20 World Cup in July in which they were knocked out in the league stage, after suffering a shock loss to hosts USA.

Babar was not happy with the observations and recommendations of Kirsten and even assistant coach, Azhar Mahmood and felt he was solely being blamed for the diswas quoted as saying.

'He had indicated to the cricket board after some parts of Kirsten's report became public that he was not interested in remaining captain."

A PCB insider said Babar had complained to some board officials, who had worked a lot with him that it was unfortunate the PCB didn't take his past performances and results into their consideration nor showed the required confidence and trust in him.

Another insider said that the final nail in the coffin was when the PCB didn't announce him as captain



of the ODI squad while confirming him to lead Pakistan in the T20 World Cup.

Kirsten, in his report to PCB, discussed the dressing room environment and also the behaviour and non-cooperation of some players in England and the T20 Cup World Cup.

He also conveyed his opinion on whether Babar was equipped to handle the pressures of captaincy and his more significant role for the team as a specialist batter after the mental stress and criticism he had gone through since last year

According to one source, the PCB is in no hurry to announce, who will replace Babar as white-ball captain as internally they have told Kirsten, selector Asad Shafiq and some members of the selection committee to take a decision and make recommendation after much thought and debate.

"Chairman, Mohsin Naqvi has made it clear he wants minutes of all official discussions by the selection committee that includes both foreign head coaches to be recorded so that a clear reason is on record for making the appointment," he added.
