NC Secures Majority Without Congress After 4 Independents Offer Support

Srinagar: The Congress has been relegated from a junior partner in the incoming Jammu and Kashmir government to a relative non-entity, after four independent MLAs extended support to the National

Conference, the 'big brother' in the alliance that won this week's election.

Pyare Lal Sharma, Satish Sharma, Choudhary Mohammed Akram, and Dr Rameshwar Singh - who won the Inderwal, Chhamb, Surankote, and Bani seats have backed the NC.

The party now has the support of 46 lawmakers - the majority mark in the 90-member House; this does not include the five to be nominated by Lieutenant Governor Manoj Sinha.

This means the political party now does not need the Congress' support to govern,

adding to an existential crisis that has dogged the party over the last decade, fuelled by all-too-many leadership squabbles and election losses, the most recent of which was Haryana.

Delhi Tribunal Confirms Ban On J&K Jama'at

New Delhi: A Delhi High Court tribunal has validated the ban imposed on Jamaat-e-Islami, Jammu & Kashmir for its alleged involvement in activities which are prejudicial to internal security and public order, having the potential to disrupt the unity and integrity of the country.

A few members of the group, which was banned for five more years in February, had contested the recently concluded assembly elections in Jammu Kashmir. This and to speculation led that the ban imposed Jamaat-e-Islami (JeI), Jammu & Kashmir under the Unlawful Activities (Prevention) Act, (UAPA) 1967 might be withdrawn by the government.

While declaring the group outlawed, the home ministry had listed 47 cases registered against it. They included an NIA case for collection of funds and encouragement to violent and secessionist activities.

The funds were also used by the active cadres and members of Hizb-ul-Mujahideen, Lashkar-e-Taiba and other terrorist organisations through a well-established network of their cadres to organise violent protests, create public unrest and communal disharmony, thus instilling a sense of fear and insecurity in J&K and all over the country, the home ministry

had said. Another NIA case was registered against the members and cadres of the Jel, including Ameer Mohammed Shamsi, chief executive, Al-Huda Educational Trust

(AHET) for receiving funds through AHET, Rajouri, in the name of Jel even after its ban in February, 2019. AHET was formed by the top

leadership of Jel, including accused Ameer Mohammed Shamsi. They were the trustees of AHET. The home ministry also said

84% Of Newly Elected J&K MLAs Are Crorepatis

Srinagar: A staggering 84% of the newly elected Members of the Legislative Assembly (MLAs) in Jammu and Kashmir are crorepatis, marking a 9% to data compiled by the Association of Democratic Reforms (ADR), the average declared assets of these MLAs stand at Rs11.43 crore.

Over the past decade, the average declared wealth of MLAs has more than doubled, increasing from Rs 4.56 crore in 2014. Notably, Congress President of Jammu and Kashmir, Tariq Hamid Karra. and BJP leader Devender Rana are among the wealthiest MLAs, with personal assets exceeding Rs100 crore.

The ADR data reveals that out of the 90 newly elected

MLAs. 76 have declared assets worth over Rs1 crore. In contrast, in 2014, 75% (65 of 87) of the legislators were crorepatis. Karra, who represents the Central Shalteng constituency, tops the list with assets worth

Rs148 crore, followed by BJP's Devender Rana from Nagrota with Rs126 crore. National Conference (NC) MLA Mushtaq Ahmad Guroo, representing Chanapora, ranks third with assets totaling Rs 94 crore. On the other hand. A

Aadmi Party's Mehraj Malik is the poorest legislator in the newly elected assembly, with assets of just Rs 29,070. He is the first MLA from the AAP in Jammu and Kashmir. NC's Javaid Ahmad Mirchal, representing Karnah, is the second poorest with Rs 3 lakh, while Kokernag MLA Zafar Ali Khatana, also from NC, has a net worth of Rs 34 lakh.

The average wealth of the six Congress MLAs is over Rs 30 crore, while the 29 BJP MLAs have an average net worth of Rs14.55 crore. NC's

BANK **FRAUD** CASE

Ex-JKGB Manager's Assets Worth Over 3 Cr Seized

Srinagar: The ED on Thursday said it has attached assets worth Rs 3.40 crore of a former Jammu and Kashmir Grameen Bank (JKGB) branch manager, his family members and some others in a case linked to alleged fraud with the lender.

A provisional order was issued under the Prevention of Money Laundering Act (PMLA) against former bank official Ishtiyaq Ahmad Parray, (a resident of Tangbagh, Khayam, Srinagar), Tariq Ali Parray, Haseena Bano and Maqsood Ali Parray to freeze their properties located in Srinagar and a flat in Delhi's Zakir Nagar area, the agency said in a statement.

The money laundering case stems from a charge sheet

filed by the Central Bureau of Investigation (CBI) against Ishtiyaq and 10 others for "embezzlement" of funds to the tune of Rs 6.30 crore by fraudulently sanctioning various types of loans to non-existent borrowers.

According to the ED, while Ishtiyaq was posted as branch manager at JKGB Mirgund, Pattan and Khanpet between 2014 and 2019, he "fraudulently" sanctioned 107 Kisan Credit Card loans, 50 joint liability group loans, 17 vehicle loans, four cash credit loans and two easy finance loans.

He sanctioned these loans worth Rs 6.30 crore for 180 mule accounts, which later turned into non-performing assets (NPAs), it said.

Srinagar: In a bid to recover outstanding dues, the Jammu and Kashmir government is considering publicly naming individuals and entities who owe more than Rs 50,000 in unpaid power tariffs.

The move is part of a broader effort to address the significant revenue shortfall in the region's power sector. A senior official stat-

ed that the Jammu and Kashmir Power Development Corporation Limited (JKPDCL) has been directed to identify major defaulters and compile a list for submission to the government. This list, which includes businessmen and politicians with long-standing dues, will be made public.

The government is seriously concerned about the large number of defaulters, some of whom owe lakhs of rupees in unpaid tariffs. These names will be displayed on billboards in our department as well as in the defaulters' local areas. Additionally, the government plans to publish their names in newspapers," the official said. The official further men-

tioned that power connections for those with overdue payments will be disconnected as part of this initiative. Notices are also being issued to government departments with pending electricity dues.

This move is aimed at curbing power theft and improving tariff collection efficiency in the Union Territory. Over the past decade, Jammu and Kashmir has purchased power worth around Rs 30,000 crore, yet there remains an annual revenue realization gap of | More on P6

Study On Autistic Children Finds Higher Neuron Density In Their Brain's Amygdala

utistic children, known to have trouble with social skills, have been found to have a higher density of neurons in amygdala -- the area responsible for emotions, according to a new study.

It is, however, not clear from the study if a higher density of neurons in the amygdala was directly responsible for causing impaired social skills. Previous studies have linked an affect-

ed ability in autistic people to process faces with a lower neuron density in brain regions involved in the task. Researchers from the University of Rochester, US, also found in autistic people a lower neuron density in cerebral cortex, which is important for

tasks such as memory, learning and

reasoning. For the study, published in the journal Autism Research, the researchers analysed MRI brain scans of over 11,800 children aged 9-11 years, of which 142 were on the spectrum.

The scans of children having autism were compared with children of two categories -- those without any neurodevelopmental condition and those diagnosed with ADHD and anxiety. The results were the same, suggesting that these differences are specific to



autism, the researchers said. "People with a diagnosis of autism often have other things they have to deal with, such as anxiety, depression, and attention deficit hyperactivity disorder (ADHD). But these findings mean we now have a new set of measurements that have shown unique promise in characterising individuals with autism," study author Zachary Christensen, a doctoral candidate at the University of Rochester, said.

Reliably describing these unique de-

viations in the neuron structure of autistic children opens a lot of opportunities to understand how the condition develops, and these measures can potentially be used in diagnosis and therapy, Christensen said.

The brain imaging data used for analysis was taken from the Adolescent Brain Cognitive Development (ABCD) study, which began in 2015 and tracks brain development and mental health of children and adolescents across the US.

A Triumph Of The Old Political Order

ith the unanimous election of Omar Abdullah as the leader of the National Conference (NC) legislature party, the ball has been set rolling for the formation of J&K's first elected government in six years. With 42 seats under the NC's belt, Omar is poised to become the next chief minister. This development signals not only a victory for the NC and to some extent for its alliance partner Congress, but also a victory for the old political order in the Kashmir Valley. The pre-poll alliance of the NC, Congress, and CPI(M) has a comfortable majority in the 90-member assembly,

which is expected to ensure a stable government.

The election outcome underlines the resilience of traditional political forces in the face of the challengers that emerged in recent years. The entities such as the Apni Party, Democratic Progressive Azad Party (DPAP), the People's Conference (PC) and the Awami Ittehad Party fell by the way side with only the last two securing a seat each. Even the PDP, otherwise considered a rival to the NC, managed just three seats. This stark division between the old and new political orders offers key insights into the preferences of the electorate, particularly in the Valley.

The rise and rise of the BJP in Jammu which garnered 29 of the 43 seats in the region is the other important takeaway from this election. The BJP's rise in the former state is a post 2015 phenomenon when for the first time it won 25 of 37 seats from Jammu division in the then Assembly elections and later formed a coalition government with the PDP. But in the Valley, the BJP failed to make any gains. The voters in the Valley have reaffirmed their trust in the NC.

The NC's campaign, centered around the restoration of Article 370, statehood and the defense of regional identity, resonated with voters who saw the party as a bulwark against the BJP, which revoked Article 370 that granted J&K a special status within the India Union. However, Omar has tempered expectations, acknowledging that the restoration of Article 370 is not a realistic goal under the current government in New Delhi. Instead, he has prioritized restoration of statehood, signaling a pragmatic approach in dealing with the BJPruled center.

On the other hand, the new political parties forged in the aftermath of the abrogation of Article 370, such as the Apni Party and DPAP, failed to gain traction. Despite being heralded as fresh alternatives to the traditional players, they were unable to present a compelling enough narrative to displace the established parties. The Assembly election results, therefore, reflect the enduring influence of the established political parties in Jammu and Kashmir, particularly in

Going forward, the NC-Congress coalition will need to navigate the challenges of limited authority in a union territory setting while managing the expectations of their supporters, who hope for tangible tcomes despite the complexities of powerthe Lieutenant Governor and the BJP at the center.

Adverse Effects of Melting Glaciers in J&K

he glaciers in the Kashmir Himalayas are melting rapidly, threatening water security in the region. This alarming rate of glacier melt in Kashmir and Ladakh has raised concerns among experts, who warn of significant impacts on regional water availability and hydrological systems. The melting glaciers in Jammu, Kashmir, and Ladakh will affect water, food, and energy security, with adverse consequences for the livelihoods that depend on them. The researchers explained that the main drivers of the glacial melt in the Himalayan region are increasing temperatures and decreasing snow precipitation, resulting greenhouse gas emissions from industrialization and increasing use of fossil fuels worldwide.

The slow-moving glaciers of the Himalayas, essentially frozen rivers of ice, supply drinking water and support agricultural needs for vast populations across the Indo-Gangetic plains. Glaciers form over thousands of years as layers of snow accumulate, with the weight of the top layers compressing the lower ones into ice. This pressure, along with the pull of gravity, causes the glaciers to move.

As the carbon emission continues to increase, the melting of glaciers has gained a pace in Jammu— & Kashmir while as the experts assert that the union territory has lost nearly 30 percent of glaciers in the past 60 years and warned that 70 percent of them will receive by the end of this century if the prevailing pace continues.

As per the available media reports in which experts informed that there are 18000 glaciers in Jammu, Kashmir and Ladakh, but all of them are melting. The glaciers are melting in the entire Himalayas including J&K. In the past couple of years, the melting of glaciers has increased. The record melting of glaciers was witnessed last year and this year it was a bit low.

Described as 'nature's bulldozers, these solid rivers melt gradu-

ally with rise in temperatures and pick up vegetation and silt that comes in their way while flowing creating snow bridges, gullies, glacial lakes, glacial troughs, icefalls, valleys, crevasses and moraines and cause major changes in the topography as they descend

forming rivers rich in sediments. Kolahoi glacier is Kashmir's biggest glacier and is the main source of water for the river Jhelum, which serves as a blessing for the fertile Kashmir valley. It is named after the Kolahoi peak - 'Goddess of Light' and forms the West Lidder river upstream of Pahalgam and the East Lidder. Both the rivers join together to form the Jhelum river near Anantnag. Kolahoi's meltwater renders the Kashmir Valley extremely fertile with cultivation of cereal crops, dry fruits, saffron, and apples.

Smaller glaciers are retreating more rapidly than larger ones due to their greater sensitivity to

climate change, driven by their lower elevation and smaller accumulation areas. Glaciers located between 4200 and 4400 meters have receded more significantly than those found above 4800 meters. Additionally, glaciers with steep slopes experience less recession compared to those with gentler slopes, as the steeper slopes facilitate a faster transfer of glacier mass from the accumulation area.

Being an eco-fragile zone, Jammu and Kashmir is confronted with environmental challenges due to global warming, unplanned urbanisation, deforestation and encroachment of water bodies. Climate warming will not only affect the retreat patterns but might affect dependent sectors of the economy that include agriculture, hydropower, and tourism.

Is Stress Turning My Hair Grey?

When we start to go grey depends a lot on genet-

Your first grey hairs usually appear anywhere between your twenties and fifties. For men, grey hairs normally start at the temples and sideburns. Women tend to start greying on the hairline, especially at the front.

The most rapid greying usually happens between ages 50 and 60. But does anything we do speed up the process? And is there anything we can do to slow it down?

You've probably heard that plucking, dyeing and stress can make your hair go grey and that redheads don't. Here's what the science says.

What gives hair its colour?

Each strand of hair is produced by a hair follicle, a tunnel-like opening in your skin. Follicles contain two different kinds of stem cells:

- keratinocytes, which produce keratin, the protein that makes and regener-
- ates hair strands melanocytes, which produce melanin, the pigment that colours your hair and skin.

There are two main types of melanin that determine hair colour. Eumelanin is a black-brown pigment and pheomelanin is a red-yellow

The amount of the different pigments determines hair colour. Black and brown hair has mostly eumelanin, red hair has the most pheomelanin, and blonde hair has just a small amount of both.

So what makes our hair turn grey?

As we age, it's normal for cells to become less active. In the hair follicle, this means stem cells produce less melanin - turning our hair grey and less keratin, causing hair thinning and loss.

As less melanin is produced, there is less pigment to give the hair its colour. Grey hair has very little melanin, while white hair has none left.

Unpigmented hair looks grey, white or silver because light reflects off the keratin, which is pale yellow.

Grey hair is thicker, coarser and stiffer than hair with pigment. This is because the shape of the hair follicle becomes irregular as the stem cells change with age.

Interestingly, grey hair also grows faster than pigmented hair, but it uses more energy in the process.

Can stress turn our hair grey?

Yes, stress can cause your hair to turn grey. This happens when oxidative stress damages hair follicles and stem



cells and stops them producing melanin.

Oxidative stress is an imbalance of too many damaging free radical chemicals and not enough protective antioxidant chemicals in the body. It can be caused by psychological or emotional stress as well as autoimmune diseases.

Environmental factors such as exposure to UV and pollution, as well as smoking and some drugs, can also play a

Melanocytes are more susceptible to damage than keratinocytes because of the complex steps in melanin production. This explains why ageing and stress usually cause hair greying before hair

Scientists have been able to link less pigmented sections of a hair strand to stressful events in a person's life. In younger people, whose stems cells still produced melanin, colour returned to the hair after the stressful event passed.

4 popular ideas about grey hair - and what science says

1. Does plucking a grey

hair make more grow back in its place?

No. When you pluck a hair. you might notice a small bulb at the end that was attached to your scalp. This is the root. It grows from the hair follicle.

Plucking a hair pulls the root out of the follicle. But the follicle itself is the opening in your skin and can't be plucked out. Each hair follicle can only grow a single hair.

frequent It's possible plucking could make your hair grey earlier, if the cells that produce melanin are damaged or exhausted from too much regrowth.

2. Can my hair can turn grey overnight? Legend says Marie Antoi-

nette's hair went completely white the night before the French queen faced the guillotine - but this is a myth.

Melanin in hair strands is chemically stable, meaning it can't transform instantly.

Acute psychological stress does rapidly deplete melanocyte stem cells in mice. But the effect doesn't show up immediately. Instead, grey hair becomes visible as the strand grows – at a rate of about 1 cm per month.

Not all hair is in the growing phase at any one time, meaning it can't all go grey at the same time.

3. Will dyeing make my hair go grey faster? This depends on the dye.

Temporary and permanent dyes should not cause early greying because they just coat the hair strand without changing its structure. But permanent products cause a chemical reaction with the hair, using an oxidising agent such as hydrogen peroxide.

Accumulation of hydrogen peroxide and other hair dye chemicals in the hair follicle can damage melanocytes and keratinocytes, which can cause greying and hair loss.

4. Is it true redheads don't

go grey? People with red hair also lose melanin as they age, but differently to those with black or brown hair.

This is because the red-yellow and black-brown pigments are chemically different.

Producing the brown-black pigment eumelanin is more complex and takes more energy, making it more susceptible to damage.

Producing the red-yellow pigment (pheomelanin) causes less oxidative stress, and is more simple. This means it is easier for stem cells to continue to produce pheomelanin, even as they reduce their activity with ageing. With ageing, red hair tends

to fade into strawberry blonde and silvery-white. Grey colour is due to less eumelanin activity, so is more common in those with black and brown hair.

Your genetics determine when you'll start going grey. But you may be able to avoid premature greying by staying healthy, reducing stress and avoiding smoking, too much alcohol and UV exposure.

Eating a healthy diet may also help because vitamin B12, copper, iron, calcium and zinc all influence melanin production and hair pigmentation.

That loss invited scathing criticism from the party's INDIA bloc allies; the Shiv Sena of Uddhav Thackeray and Mamata Banerjee's Trinamool were particularly severe.

The Sena, the Trinamool, and the AAP slammed the Congress' "arrogance" and "overconfidence" and, ahead of elections in Maharashtra and Jharkhand later this year, as well as Delhi early next, lamented its ability to "turn a winning innings into a defeat".

One other important announcement followed a meeting of NC MLAs this afternoon.

Omar Abdullah was unanimously elected the legislative party leader and will become the next Chief Minister of Jammu and Kashmir.

This was expected; party patriarch Farooq Abdullah, his father, said as much Tuesday; he told reporters "Omar Abdullah banega Chief Minister" as his party strode towards victory.

Omar Elected Leader

the Congress, Omar Abdullah said he will stake claim for the government formation at Rajbhawan as soon as he receives support from the coalition partner.

'Once the Congress extends its support, I will move to Rajbhawan and meet with the Lieutenant Governor to stake claim for the government formation in Jammu and Kashmir. Since talks are on with the Congress at the moment, we have given them a day to finish the formalities," Omar told reporters after the LP

Omar also extended his heartfelt gratitude to all the members of the NC Legislature Party for unanimously electing him as their leader.

"You might be aware of the decision that was taken. NC's Legislative Party meeting was held today and all the members of the LP elected me as their leader. I am highly grateful to every NC legislator who trusted me and provided me with an opportunity to visit the Rajbhawan and meet with the LG in order to stake claim for the government formation, he added.

Earlier, Dr. Farooq Abdullah, the president of the NC, asserted that they will meet with the Congress tomorrow to decide on the CM candidate and the government formation tomorrow.

"We won't wait to stake claim for the formation of the government and deciding on a Chief Ministerial candidate. The alliance meeting is scheduled for tomorrow, and all matters will

be determined then," Dr Farooq added.

Omar Abdullah thanked the National Conference (NC) legislators for electing him their leader so that he can stake claim to form the government in Jammu and Kashmir.

'You are aware of the decision that was taken. A meeting of the NC legislature party took place, the legislature party has decided its leader and I am thankful from the bottom of my heart to the NC legislators that they have reposed their faith in me and given me a chance to stake claim for government formation," Abdullah told reporters after he was elected the leader of the legislature party here.

With 42 seats, the National Conference became the single largest party in the Assembly elections, results of which were announced on Tuesday, while the Bhartiya Janata Party managed to cling onto its stronghold Jammu with 29 seats.

Nevertheless, the Congress, the NC ally, performance remained dismal, winning just six seats, five of in the Kashmir valley and one in Jammu.

The National Conference, according to Omar, now has the backing of four out of the seven independent MLAs, bringing the total number of party members in the 90-member Assembly of the Union Territory to 46.

Some of those decisions paid off, while others - including a failed telecom venture and the Nano, which was billed as the world's cheapest car but flopped - lost money.

Tata was born in a traditional Parsi family in 1937. He studied architecture and structural engineering at Cornell University in the US. In 1962, he joined Tata Industries - the pro-

moter company of the group - as an assistant and spent six months training at a company plant in Jamshedpur. From there, he went on to work at the Tata

Iron and Steel Company (now Tata Steel), Tata Consultancy Services (TCS) and National Radio

and Electronics (Nelco). In 1991, JRD Tata, who had led the group for

over half a century, appointed Ratan Tata as his successor. "He [JRD Tata] was my greatest mentor... he was like a father and a brother to me and not enough has been said about that," Tata later told an interviewer.

In 2008, the Indian government awarded him the Padma Vibhushan, the country's second-highest civilian honour.

Prime Minister Narendra Modi hailed Tata as a "visionary business leader, a compassionate soul and an extraordinary human being".

Asad Ullah Mir, one of the alleged members of the Jel J&K, appeared before the tribunal through his counsel and submitted that it is a socio-religious organisation with a written constitution. It is committed to peaceful constitutional means and does not have any links with militant outfits nor it supports extremism in any form, he claimed.

Mir also said the group was set up in 1953 to spread the word of Islam and in doing so it extends its Da'wah (invitation to Islam) to all people without discriminating on the basis of sect, language, colour, race, nation or country. The constitution of the association has never supported violence, the JeI member submitted.

He said the JeI has always participated in the

democratic process. In 1969, it participated in the municipal and panchayat elections and had contested the Lok Sabha elections in 1971 securing more than 1 lakh votes, he added.

In 1972, five members of the association were elected members of the J&K assembly. In 1977, one member of the association was elected to the assembly. In 1983, none from JeI, J&K was elected to the state legislative assembly, although the association contested 20 constituencies, the tribunal has ben told.

"In 1987, two members of the JeI, J&K were elected to the assembly and it was first declared unlawful after emergency was imposed in 1975. The chief minister of Jammu and Kashmir at the time, Sheikh Mohammad Abdullah, got the central government to declare the association as unlawful because it was his only serious rival in the state.

"The declaration of the association as unlawful was lifted with the election of the new government at the centre, after Emergency was lifted," the group submitted through its counsel.

It also submitted before the tribunal that the group participated in the elections of 1987 and put up 22 candidates.

"However, the elections of 1987 were rigged, resulting in election of only two members from the association. That the 1987 elections were rigged is common knowledge and has been acknowledged even by former deputy prime minister and home minister, L K Advani, in his autobiography, 'My Country My Life', and by

"Most recently, the Union Home Minister, Amit Shah, while moving the amendment bill of the Jammu and Kashmir Reservation Act in the Lok Sabha also stated that farcical elections were conducted by the earlier Congress government in Kashmir"," the group said.

The Jel J&K said it was only after the "wholesale rigging of elections" of 1987 that it decided not to contest elections until there was a guarantee of free and fair elections.

"Although the association has always been opposed to violence, and although Ameer-e-Jama'at Hakeem Ghulam Nabi, expressly condemned violence at several public meetings when the state was in the grip of armed militancy in 1987, a misconception began to build that the association supported militancy.

'This misconception was entirely the creation of persons with vested interest against the association. It was because of this misconception that the association was declared unlawful in March 1990," it said.

However, the tribunal, consisting of Justice Navin Chawla, Judge, High Court of Delhi, concluded that the tribunal finds that there is ample justification to declare JeI J&K as an unlawful association under Section 3(1) of the UAPA and the central government was justified in taking recourse to the provision of Section 3(3) of the UAPA vide notification dated February 27.

"Thus, the Reference is answered in affirmative and an order under Section 4(3) of the Unlawful Activities (Prevention) Act, 1967 confirming the declaration made in the Notification No.S.O.924(E) dated 27.02.2024, published in the Gazette of India, Extraordinary issued under Section 3(1) of the Unlawful Activities (Prevention) Act, 1967 is hereby passed," the tribunal said.

'The administration collects less than 50 percent of the expected tariffs from consumers, further straining the exchequer," an official from the JKPDCL said. The revenue realization stands at Rs 3,500 crore, while the cost of power purchases annually reaches Rs 7,500 crore.

Statehood Resolution Won't Meet Autonomy Fate: NC's Bashir Veeri

SRINAGAR: The newly elected Member Legislative Assembly (MLA) from Bijbehara in South Kashmir's Anantnag district, Dr Bashir Ahmed Veeri Thursday said he was confident that the Statehood restoration resolution to be passed by the upcoming cabinet won't meet the same fate as that of Autonomy. He also said political battles are won by pursuing the issues and restoration of statehood will set ground for bringing back Article 370.

Dr Veeri said as already stated by the NC vice president Omar Abdullah that the first cabinet meeting of the new government will pass a resolution seeking restoration of Statehood to J&K. "I am damn sure and confident enough that the statehood resolution won't meet the Autonomy resolution fate. It won't be rather, it can't be trashed as there is no scope for that," the MLA Bijbehara said.

He said that Prime Minister Narendera Modi is on record that after polls Statehood would be restored to J&K. "Union Home Minister has made a statement about the same on the floor of the parliament. The BJP has given a written assurance to the Supreme Court about restoration of Statehood. So with all this, where is the scope for not getting the Statehood back," Dr Veeri said.

He said restoration of Statehood would be the first step for the big fight which is to get back Article 370. "I believe once we get back Statehood, our morale will go up a bit further and we would be able to raise the bar for the Article 370 restoration. We are also aware that it is not easy but we believe it is not impossible as well," he said. "NC's second name is to fight and strive hard for the peoples' rights. We will get back what we have promised in our

On NC vice president Omar Abdullah's statement that they



can't afford to have an antagonist relationship with the Government of India, Dr Veeri said this shouldn't be misconstrued that NC was going to surrender on Article 370. "We are dependent on the Centre for funds and so many things. We can't afford to stop working relation with the Gol. How can we run J&K affairs without having a working relationship with Centre," he said. "We will have a working relationship with GoI not BJP. This is where some people try to create confusion."

About how he managed victory against PDP's Iltija Mufti in Bijbehara that was considered as a strong bastion of PDP, Dr Veeri said people came out to vote for him. "My father's great legacy saved me and helped me sail through. My father had defeated the late Mufti Muhammad Sayeed as well. Apart from that, I got tremendous support from youth,

the first time voters," he said. To a query how interesting the contest was in Bijbehara, Dr Veeri said that it was not Iltija Mufti or Mehbooba Mufti but the entire PDP against whom he fought. "They were one behind the scene," he said.

On what made him sail through, Dr Veeri said it was Iltija herself who helped him win from Bijbehara.

"Indeed, Iltija made my fight easy. She used abusive language against me and my workers. She provoked people against me which helped me win finally," the NC leader said. —(KNO)

Police Arrest Drug Peddler In Ganderbal

SRINAGAR: Police in central Kashmir's Ganderbal district have arrested a notorious drug peddler after recovery of contraband substance from his possession.

Experts Call For Comprehensive Assessment To Enhance Services

SRINAGAR: On World Mental Health Day, experts have called for the urgent need for a detailed assessment of mental health issues within the general population to better understand the current landscape and improve services.

Mental health professionals said that while services have improved, they remain insufficient to meet the needs of the entire population.

Dr Nizam Ud Din, a psychiatrist at SKIMS Bemina, said the theme for World Mental Health Day 2024 is "It is time to prioritise mental health in the workplace". He said there are two significant barriers to mental health care: stigma and the shortage of qualified professionals.

"Reducing stigma is essential," Dr Nizam Ud Din said. "This can be achieved through awareness programmes and comprehensive assessments of mental health issues among

the general population. Addressing the genuine recommendations from these surveys will significantly im-

prove mental health care." praised the



efforts of NGOs and the government but called for continuous improvement, which he said can only be realised through feedback from these assessments. "While services have improved considerably, they are still inadequate to address the mental health needs of the entire population," he added.

"It's time to end the stigma, provide support to those struggling, and create safe spaces for open discussions about mental health," Dr Shoaib said. He pointed out that in Jammu and Kashmir, the stigma surrounding mental health remains a significant barrier for those seeking

KULGAM: Tensions boiled over in Kulgam district's Bachro and Tarigam villages, as supporters of rival political candidates clashed following the declaration of CPI(M) candidate Muhammad Yousuf Tarigami's victory in the Kulgam assembly segment.

Yesterday, a youth identified as Muhammad Omar from Bachro village was injured after being allegedly assaulted by Tarigami supporters in Tarigam village. Additionally, eyewitnesses reported that Farhan Ramzan also from Bachroo was critically injured during clashes between Jamat-i-Islami and CPI(M) supporters and was shifted to SKIMS Soura for treatment.

Locals from Bachro village alleged that Tarigami supporters from Tarigam village ignited firecrackers in a graveyard, sparking tensions when villagers intervened. The situation escalated into full-blown clashes, resulting in damage to multiple vehicles.

Police swiftly intervened, using cane charges to disperse the crowds and bring the situation under control. However,

tensions remain. The clashes have sparked widespread concern, with multiple videos going viral on social media. Netizens urged authorities to maintain law and order and prevent further escalation.

The Kulgam assembly segment witnessed intense campaigning, with CPI(M) candidate Muhammad Yousuf Tarigami ultimately emerging victorious. The election results sparked celebrations among Tarigami supporters, while rival factions expressed dissatisfaction.


