

## What's Affecting Kashmiri Kids' Mental Health? **IMHANS Report Points To Family Issues, Economic Pressures**

Srinagar: The annual report for year 2022-2023 prepared by the Child Guidance and Wellbeing Centre (CG&WC) –Institute of Mental Health and Neuro Sciences (IMHANS) Srinagar has concluded that the family dynamics and socio economic factors are two major reasons responsible for the falling mental health of children between the age of 0 to 18.

The report states that there

are many precipitating factors behind the falling mental

health of Kashmiri children. "Parenting Style issues that entail authoritarian parent and neglectful parenting contribute 6.14 per cent of mental health illness among children. Academic stress that includes examination stress and poor academic performance also contribute 15.68 per cent to falling mental

It stresses that the psychological disorders arise from multiple factors and have a complex aetiology and the data presented doesn't not suggest a direct one to one causality but rather highlights the range of issues observed at the clinic.

The report states that family accommodation issues, family history of psychiatric illness, sibling rivalry and family discord contribute to 26.73 percent of the psychological disorders observed in Kashmiri children. This makes familyrelated factors the largest contributing causes.

## **Surprise Inspection At Shopian Hospital**

#### Only 17 Out of 198 Staffers Present

Srinagar:A surprise inspection was conducted at the District Hospital Shopian by the Additional Deputy Commissioner on Wednesday. The inspection revealed a serious absenteeism issue - only 17 out of the hospital's 198 employees were present, with 181 members of the staff, including doctors, medical officers, paramedics, and ministerial staff, missing from duty.

The Deputy Commissioner issued a stern order, directing a salary deduction of one day for all absent employees and initiating disciplinary action as per rules. Notably, in a previous circular dated November 12, 2024, the administration had warned that unauthorised absences would lead to a deduction of one day's salary, which would be credited to the District Red Cross Society Shopian.

The Deputy Commissioner also ordered the Medical Superintendent of District Hospital Shopian to seek an explanation from the absent employees. | More on P6

## **'Disruption In Liver-Brain Communication Behind Overeating'**

orking odd hours or night shifts was found to disrupt signals liver sends to the brain telling it if eating is happening in sync with the body's clock, a result that researchers said could help treat the negative effects of eating at unusual times, such as overeating. Eating at irregular times is said to be related to weight gain and diabetes, largely because it is not in sync with one's body clock, or circadian rhythm -- a 24-hour cycle of physical, mental, and behavioural changes, including sleep-

ing and eating. Researchers from the University of Pennsylvania, US, found that working unusual hours disturbs the liver's internal clock and its signals, because of which the brain overcompensates, thereby leading to overeating at the wrong times.

The results, published in the journal Science, suggested that targeting specific parts of the vagus nerve -- via which the liver communicates with the brain -- could help address overeating in people working night shifts or experiencing jet lag, the team said. "Both mice and humans normally eat at times when they are awake and alert, and this circuit provides feedback from the liver to the central clock in the brain that keeps the system running smoothly," senior author Mitchell Lazar, a professor of diabetes and metabolic diseases, University of Pennsylvania, said. "This feedback is through a nerve con-

nection from the liver to the brain," Lazar said. For the study, researchers looked at the REV-ERB genes in mice, which are known to have genetic material and

biological processes similar to those in humans, and help them both control the body clock. Turning off these genes made the

mice's liver develop a faulty clock, because of which eating habits were found to change dramatically, with more food being consumed during less active hours, the team said.

However, the negative effects could be reversible, as cutting the nerve connection in obese mice was found to restore normal eating habits and reduce food intake.

"This suggests that targeting this liver-brain communication (route) could be a promising approach for weight management in individuals with disrupted circadian rhythms,' author Lauren N Woodie, a post-doctoral researcher in Lazar's lab, said. "Our findings reveal a homeostatic feedback signal that relies on communication between the liver and the brain to control circadian food intake patterns. This identifies the hepatic vagus nerve as a potential therapeutic target for obesity in the setting of chronodisruption," they wrote.

## **SKIMS Conducts Workshop On Renal Denervation Therapy**

Srinagar: The Department of Cardiology, SKIMS organized a one day workshop on "Renal Denervation Therapy" in the Cardiac Cath Lab on Wednesday.

The procedure is the first of its kind in the UT of J&K and only around 40 such procedures have been done in the entire country so far. The workshop was conducted under the proctorship of Dr. Praveen Chandra, who is an expert in the field of Interventional Cardiology with international acclaim; along with the SKIMS team including Prof. Hilal A. Rather HOD Cardiology, Dr. Amir Rashid

Asst. Prof Cardiology, Dr Imran Hafeez Add. Prof Cardiology, Dr Qayoom Yousuf FNB Int. Cardiology, Dr Beenish Anesthesiologist, Syed Bilal Senior Technologist and Maajid Nursing.

Procedures were done successfully and the patients were discharged home with no complications.

HOD Cardiology Prof. Hilal A. Rather while giving details said that Renal Denervation therapy consists of ablating various nerve connections which are located around the renal artery that are responsible for maintaining hypertension via various pathways. "It is the last resort in the treatment armamentarium of patients with resistant hypertension despite being on multiple antihypertensive medications. With its great safety profile and good efficiency it helps in controlling the hypertension and brings down hypertension related morbidity and mortality." Dr Rather said.

Director SKIMS Prof. M. Ashraf Ganie complimented the Department for conducting the workshop and performing this rare procedure in SKIMS, which will serve the resistant hypertensive patients in the Kashmir vallev who had to otherwise visit corporate hospitals outside the UT to get similar treatment.

## **Ending Bulldozer Justice**

tepping in to ensure the end of arbitrary demolitions of properties across the country, the Supreme Court on Wednesday issued nationwide guidelines to curb "bulldozer justice," emphasizing that demolitions of properties cannot be conducted solely on the basis of accusations or convictions. A bench comprising Justices B R Gavai and K V Viswanathan deemed it "totally unconstitutional" for authorities to act as both judge and executor, demolishing homes of alleged offenders without due process. To protect citizens' rights, the Court mandated that demolitions must follow a showcause notice, providing a minimum of 15 days after notice is served, and that all demolition proceedings should be videographed.

This certainly is going to put a stop to the instant justice being delivered by some state governments to punish people they deem criminals, without any due process of law. Hundreds of families across the country have been wrecked as a result of this justice. This will hopefully discourage these governments from an easy recourse to demolishing houses over the alleged blanket pretext of enforcing law and order. More so, in cases of the alleged crimes committed by one member of a family where other members of a family are held responsible for this and made to suffer as a result. Even in cases where a house or a business establishment has been built on illegally occupied land, the violation needs to be proven through a legal process before demolition can proceed.

There have been instances where houses of people arbitrarily alleged to have violated any law have been demolished. Worse, the demolitions have largely been carried out selectively. Besides, if the illegal nature of a structure was the sole basis for bulldozing it, then there are millions of such structures in the country, particularly in urban areas, a fact acknowledged also by the governments.

But the truth is the demolitions are pursued with a political goal in mind. Some political parties see lucrative electoral spin-offs from demolishing properties of some ethnic and religious groups. Sadly, the practice has so far less without any institutional check.

Significantly, the Supreme Court warns that any violation of the court directions could lead to contempt proceedings and along with compensation, the officials ordering the demolition could be asked to pay for the restitution of the property themselves. This will certainly act as a deterrent against arbitrary demolitions.

## What Do Young Advocates Expect from Omar Abdullah?

he legal landscape in Jammu and Kashmir (J&K) presents unique challenges for young lawyers as they embark on their professional journeys. The region's distinct socio-political context, coupled with the general difficulties faced by new entrants in the legal field, necessitates targeted government intervention. These are some expectations young lawyers have from Omar Abdullah, the new Chief Minister of J&K.

#### Revival of the Bar

Since the last five years, the government has taken a keen interest in the Bar association and its elections haven't been allowed under one pretext or the other. This has led to chaos and confusion for new entrants as they navigate alliances and licenses in Srinagar. Now that democratic process has restarted here, young lawyers expect free and fair elections to the bar association as well. This will give lawyers genuine representation and contribute to the welfare of the fraternity.

#### Constituting State Bar Council under The Advocates Act. 1961

The High Court of Jammu and Kashmir and Ladakh has been exercising the powers of the State Bar Council under Section 58 of the Advocates Act, 1961 which was meant to give special powers for a transitional period only. Bar Councils serve a particular purpose under the Act and should be a separate body to safeguard the independence of the bar from the bench. A separate State Bar council should be created as per the mandate of Advocates Act and those powers be taken from the High Court as it is already overburdened by the overload of cases pending adjudication.

#### Monthly Stipend Scheme

Young advocates who enter the profession struggle to find clients and for years they keep struggling in this profession and are not even paid well by their seniors. Young lawyers expect a dedicated monthly stipend scheme for initial years of their practice so as to have stability and be able to survive in the profession. Similar scheme was introduced in Kerala to support young members of the bar in their career growth.

#### Government Monitoring of Stipend Paid by Senior to Juniors

This is the generic issue of the whole country where junior lawyers are led to exploitation as they are not paid adequately by their seniors, young lawyers expect a government monitoring of the grievances of the young lawyers and ensure young lawyers get

their due share as per their work.

#### Advocates Protection Act

Advocates, who are intended to preserve the rule of law and ensure justice, have been the targets of violence, harassment, and intimidation. The issues that the legal profession faces are substantial and are becoming worse. Therefore there is a need for dedicated legislation for the advocates which will safeguard them.

#### Enhance judicial infrastructure

The current judicial system is overburdened due to which cases keep on lingering for years, severely affecting the fundamental rights of citizens. The overload of cases in the courts has been the point of discussion for a long time and the need of increasing the members of the bench cannot be amply stressed upon. Increasing the strength of the bench both at Hon'ble J&K High court and district courts is the need of the hour.

#### Government accommodation for Advocates

The already placed policy of the government of J&K, The Jammu and Kashmir Estates Department (Allot ment of Government accommodation ) Regulation, 2004 provides for accommodation of the government employees, including judicial staff and even for the media persons, however lawyers have been neglected. There are many young lawyers from far off areas practicing in Srinagar court and paying huge rents. This act of inclusion in the accommodation policy will also give them a sense of belonging.

#### **Frisking-free Entries**

Lawyers are frisked before entering Div com office at Srinagar and have to follow timing which are meant for the general public. Lawyers being the officers of the court who perform public duty, should be allowed hassle free movement enabling them to better serve the public. Conclusion

The challenges faced by young lawyers in Jammu and Kashmir require comprehensive government action to create a supportive and nurturing legal environment. By implementing targeted initiatives that address mentorship, job opportunities, access to resources, and professional development, the government can empower young lawyers to thrive in their careers and contribute positively to the region's legal landscape. Such efforts not only enhance the legal profession but also promote justice and the rule of law in J&K.


## In Pursuit of Morels A Childhood Adventure

Thile I was recovering under a stack of quilts due to feeling unwell a few days prior, I overheard a group of children excitedly spreading the news that a local named Tehleel had stumbled upon some morels.As the echoes of children's excitement filled the air, I peered through the window and saw them flocking to visit Tehleel. He was bombarded with a barrage of questions about the discovery of morels: where he found them, whose orchard they were from, and how many he had found.

Morels are prized mushrooms with a distinctive honeycomblike structure, often heralding the arrival of spring as the first to emerge. This early appearance adds to their allure and mystique. Tehleel laughed heartily and answered, "May Laeb' Emm kangnich Razaq Chachn'i Baaghi' Manzi—"I found these morels in Razzaq's orchard, where blessings abound."

Buzzing with delight, the kids enthusiastically followed Tehleel, vanishing from view like bees to flowers.I felt all kinds of emotions at once. Since the people of Srinagar owned all the orchards, Razzaq was only the orchard's custodian and not its owner. Even yet, Razzaq chachi's name remained on the orchard, even though those kids probably never saw him because he had died more than ten years prior. I thought back to my early years and remembered passing those orchards on my route to school. As the vernal equinox heralds its arrival, nature's dormant denizens emerge from their somnolent state, seizing the opportunity bestowed upon them to unfurl their verdant splendor in a symphony of resplendent bloomWhen gardens burst with an array of colorful flowers, the blossoming peach trees bring an extra charm to the scene. Back in the day, children headed to school without crisp uniforms, ties, or ID cards. Their shoes gleamed not from polish,



but from mustard oil. On my way home, passing orchards of apple and peach trees, we would share exciting discoveries. News of finding something new, like Guchi morels, spread through the village like wildfire.

All the children would dash home, quickly change their clothes, and return in search of morels (kangich). Every orchard became bustling with children, and once one child found a morel, every other child believed there was another nearby waiting to be found. They would gather in a circle at that spot, chanting "Joori'e Joo'er Nati Ninn oEr''' (either give me your pair or take your partner away), while searching nearby, displacing the

grass in their quest. In April, as the weather remains cool with frequent showers thunderstorms and lightning, every child, myself included, believed that morels grew and emerged from the soil during these storms.

Among the many myths circulating among us children, some believed that applying kajal to our eyes in the morning would improve our eyesight and aid in finding a larger quantity of morels. We were all engrossed in discussions about which orchard had the best abundance of morels, fueled by our shared curiosity and wonder.Each of us would bring home the morels, and our mothers would meticulously thread them together like garlands using needle and thread. These garlands would then be hung up for the drying process, filling our homes with the earthy aroma of the mushrooms as they preserved for selling -

As April drew to a close, it was announced that the presence of morels had dwindled, and

children began to compare how many morels they had collected. The once abundant and sizable morels had dried up, shrinking in size, much to the dismay of every child. They worried that they wouldn't make enough money, as what had once seemed like substantial garlands of morels now appeared diminished. Every child became increasingly eager to sell their morels at good prices, hoping to make the most of their harvest before the opportunity faded away completely. On Sundays, every child eagerly awaited the arrival of the morel merchant, who would come with a bag slung over his back, either on his bicycle or more commonly on foot. He carried a small measuring scale in his hands and pockets brimming with money. Everyone wanted to sell their morels directly in front of their eyes, as every child harbored trust issues, fearing that their parents or the merchant might cheat them and not pay them the exact amount they deserved-Since sometimes our mothers wouldn't disclose the actual amount of money they received when selling the morels, children felt compelled to sell their harvest directly to the morel merchant to ensure they received the full and fair value for their hard-earned bounty.While the children of this generation are often absorbed in mobile and virtual gaming, there's a unique allure to activities like searching for morels and selling them. It offers a different kind of engagement with nature and a sense of satisfaction from the tangible rewards of their efforts.I hope that the children of this generation will have the opportunity to experience the joys of exploring orchards and engaging in activities like morel hunting, just as we did at their age. It's a tradition worth preserving and passing down to future generations.

## Parenting in the Digital Age

Social media has become increasingly more accessible, with the vast majority of North American teens using it daily. With social media companies marketing to teens, it is no wonder that we see a steady increase in youth social media usage alongside a decrease in the age at which most kids get their first device and have access to the internet.

It is important to acknowledge that social media can serve as a way to connect and engage with peers. At the same time, there are also some known risks associated with youths' use of social media. Notably, brain development associated with our impulse control does not fully develop until about our mid-20s, and it is difficult for youth to self-limit screen time. As a result, they end up spending longer periods scrolling on social media.

Below are some ways mental health is impacted:

Neurological and Developmental Factors: Excitement for connection amongst peers is associated with brain development that typically occurs between the ages of 10 and 12. This is also the average age that many vouth access their first devices. The lack of fully formed impulse control makes it harder for youth to effectively selfregulate, spend appropriate amounts of time on social media, and create a healthy balance between online in-



teractions and interactions between friends, family, and peers in day-to-day life.

Peer Influence and Social Feedback:Factors such as "like" counts, comments, and push notifications on social media platforms can heavily influence youth. Feedback received on social media (whether positive or negative) can have tangible impacts on youth mental health, and lead to increased symptoms of anxiety and depression.

Self-Esteem and Body Image: Related to peer influence, interactions online can heavily contribute to one's self-image. Having access to a variety of different profiles, people, and content online provides an opportunity for youth to constantly compare themselves to others, and this can have negative effects on self-esteem and body image. Anita Federici, a clinical psychologist and researcher, has spoken out about the strong correlation between increased social media use and the increase in body dissatisfaction and emotion dysregulationseen in young people. Numerous weight-related memes and comments on social media

and increased pressure from the dieting industry are prevalent. Children and youth may not be able to manage and discriminate between what is toxic diet culture and what is appropriate and healthy in what they are seeing online. Inappropriate and Hateful Content: Extended social media use also poses the risk of exposure to content such as online discrimination, racism, homophobia, sexual content, and cyberbullying. Research demonstrates that exposure to this can increase symptoms of anxiety and depression in youth. What families can do to sup-

port their youths' safe social media use

A few different ways parents can mindfully connect with their youth about safe social media usage:

- 1. Monitor and discuss social media use with your child; answer questions honestly
- Initiate age-appropriate and supportive conversations surrounding online content
   Model healthy social media
- use for your child; help them recognize what is and what is not real online by teaching social media literacy
- 4. Watch out for problematic usage

Reducing social media use can also be helpful. Recent research by Smith and Mills(2024) suggests that even taking a weeklong break can have a significant positive impact on youth mental health and self-esteem, especially for young women.

Lisa Damour, a clinical psychologist and author of numerous youth development books (her latest book is *The Emotional* Lives of Teenagers), has spoken widely about the impact of social media on adolescents. While there are many positive components of social media, such as serving as a "lifeline for young people who struggle to make peer connections in their local community," Lisa Damour has also emphasized the importance of educating youth about the algorithms that social media use to provide information of interest to them and delaying social media use until older adolescent years. We want to teach youth how to filter out what is appropriate and what is not appropriate content. This can be connected to family values to guide the youth in developing appropriate judgments.

An advisory by the American Psychological Association (2023b) reinforces that developmental growth among children, youth, and teens is gradual, constant, and not always linear. As such, it is important to keep online interactions developmentally appropriate. As parents, it is also vital to maintain open lines of communication and monitoring regarding social media use. The bottom line is that youth social media use, functionality, and permissions should be tailored to youths' unique developmental capabilities to foster healthy and safe interactions, both in-person and online.

the death of loved ones, social stigma, and substance abuse, account for 21.73% of the rising mental health issues among children.

"Parental issues such as discord, illness, and separation contribute to 7.62% of the mental health challenges faced by children, while the trauma and abuse, including bullying, peer pressure, relationship stress, and corporal punishment, account for 9.29% of the mental health concerns among children," the study states.

It further indicates that 12.77% of children's mental health issues are linked to other factors, including excessive use of gadgets.

The report stated that the IMHANS Centre recorded 18006 visits total, 12477 follow-ups, and 5529 new registrations in 2022-23. "18006 children were provided tertiary care services at the centre. 13,165 students and teachers were reached out through school outreach. 3961 parents/caregivers were also reached out through community outreach," the report said.

It said that 17,356 beneficiaries were covered through psychoeducation. The report said that 2190 frontline workers were capacitated that include ASHA workers, ICDS workers, teachers, Paediatricians etc. As part of the achievements in the year 2022-23, the Centre said that Mental Health awareness programs were held in Waqf Board run schools in which 3825 students and 205 were covered.

"In total, 38 school outreach programs were conducted while 56 community outreach programs were held as well. Total number of individuals reached out through school outreach was 13165 and the total number of individuals covered through community outreach was 3961," the report said.

The report said that 350 ASHA workers and 1040 teachers were trained besides ICDS workers and other staff. (KNO)

number of children are also being diagnosed with cancer. Leukemia, a type of blood cancer, is the most common form among pediatric cancer patients in the region.

Early detection is crucial in treating childhood cancer, as it offers a high survival rate of around 80%. However, a lack of awareness and widespread misconceptions about childhood cancer often lead to delayed diagnosis, hindering effective treatment.

Kashmir Observer in March, this year, tried to uncover what exactly is causing a spike in cancers? Is there something we're eating, something we're ingesting, some combination of factors that are modern and harmful which is resulting in these increased cancers?

Dr. Abdul Hamid Samoon, Associate Professor, Department of Minimal Access and General Surgery, GMC Srinagar told Kashmir Observer that the trend of malignancies is rising worldwide, and a similar pattern is witnessed in Kashmir. Cancer happens when the body's cells grow uncontrollably and spread to other parts of the body where these cells can form tumours or invade nearby tissues and organs, leading to serious health issues and these cancerous cells can divide rapidly and disrupt the body's normal function, making it difficult for the immune system to combat them effectively. Presently, there's an increase in upper gastrointestinal (GI) cancers or stomach cancers, largely attributed to our dietary habits. While there's no definitive genetic or proven cause behind this trend, our dietary patterns play a significant role in driving the increase in malignancies, Dr. Samoon explained. He pointed out that alongside upper GI cases, colorectal cancers are also on the rise in the valley, especially among the younger population. "It's concerning because cancers tend to be more aggressive in younger patients, affecting their prognosis adversely compared to older individuals. Likewise, in females, there's a significant rise in breast cancers, often associated with genetic factors and familial history," Dr. Samoon had told Kashmir Observer. Professor of Surgery, Government, Medical College Srinagar, Dr Iqbal Saleem said the rise in cancer cases can be attributed to changes in our food habits and lifestyle. "Furthermore, the overuse of fertilizers and pesticides is also a major contributing factor for cancers. The indiscriminate use of these chemicals, driven by the desire for quick profits, results in them entering the food chain and ultimately reaching humans. This has led to alterations in genetic makeup, which in turn contribute to cancerrelated issues," Dr. Saleem said. Data shows that with the introduction of high-density apple crops of huge economic value, pesticide use also increased threefold in the last 12 years, especially in Shopian, Pulwama, Kulgam and Anantnag districts of South Kashmir. "Consequently, orchardists in these regions are regularly exposed to pesticides. The majority of cancer cases in these areas are attributed to this pesticide exposure. It is plausible to speculate that there is a correlation between the use of pesticides and the incidence of cancer in these communities," the health expert

A senior oncologist at SKIMS said that there are numerous risk factors for cancer including hormonal, hereditary, metabolic, autoimmune etc. "External causes of cancer include smoking, alcohol consumption, dietary imbalance (malnourished or obese), radiation or infections like Human Papilloma Virus (HPV), Hepatitis B Virus (HBV), Human Immunodeficiency Virus (HIV), H Pylori etc," he said. revealed that approximately 1,600 cancer patients have been registered at the hospital, with more than 400 patients diagnosed this year alone. "The hospital has been conducting thousands of chemotherapy sessions annually and efforts are ongoing to introduce radiotherapy facilities to enhance cancer treatment capabilities," he said.

Dr Shahid provided insights into the emerging trends in oncology, saying that huge advancements in cancer treatment have been made over the past few years. These advances, he said, have contributed to increased survival rates among cancer patients. He added that stomach cancer is more common among men, while breast cancer is prevalent among women in the region.

Dr Rukhsana Najeeb, Principal of GMC Anantnag, shared her observations on the regional patterns of cancer, saying that carcinoma cancers are notably common in south Kashmir. "The high incidence of cancer is due to dietary habits, including the consumption of rice, salt and dried foods," she said. Dr Najeeb called for early cancer detection, saying that with advancements in diagnostic techniques, cancer can now be identified at an earlier, more treatable stage, significantly improving the chances of survival.

"Early detection is crucial. When cancer is diagnosed in its initial stages, the likelihood of successful treatment and survival is much higher," Dr Rukhsana said adding that while advanced treatments are available for many types of cancer, some forms still lack effective treatment options.

Several other oncologists at the

"Omar (Abdullah) has said it has caused losses and we cannot generate more electricity. But we should also see whether the electricity we are generating is ours or not. We say we are suffering losses because we are not able to use more water and generate more electricity. I want to ask, "Is the electricity that we are producing ours?"

The PDP chief said it was the Abdullahs who handed over Jammu and Kashmir's power projects to the NHPC.

"When the late Sheikh (National Conference founder Sheikh Mohammad Abdullah) was chief minister, he gave the Salar project to the NHPC. When Farooq (Abdullah) was chief minister in 1997, he handed over seven power projects to the NHPC," she said.

The chief minister should focus on seeking the return of at least two power projects from the Centre, Mehbooba asserted.

"When we formed the government with the BJP, those power projects were mentioned in our alliance agenhydel power potential, primarily due to storage constraints.

However, Handwara MLA Lone said the criticism was music to the ears of the ruling party at the Centre.

"Typical rightwing gibberish. And a recently elected chief minister is bending his back backwards to please the ruling party at the Centre," he said in a post on X.

The Peoples' Conference chief said he personally did not support the treaty as it was "unfair" and signed by the then ruling party in India.

"May I, as a Kashmiri, ask what have the previous ruling parties, especially the National Conference, which has been in power for the longest time, done with our water resources?" he said in the post.

He said Jammu and Kashmir had not harnessed even 20 percent of its potential in hydroelectricity.

"And what we have harnessed is mostly owned by the NHPC. The NHPC's most profitable projects are in Jammu and Kashmir. We should have been net exporters of power. (But) we are net importers of power," he added. He urged Abdullah to advocate for Jammu and Kashmir's rights over its water resources.

The ministry said that as many as 50 civilians were killed in 2019 in the Union territory. While the figure came down to 14 by the first week of November this year, it is nearly three times more than what was recorded last year, when five civilians were killed by terrorists.

On the killings of security personnel, the ministry's data said 77 cases were reported in 2019, which was reduced to 58 in 2020, 29 in 2021, 26 in 2022, 11 in 2023 and seven in 2024.

The ministry also provided data on the number of terrorists killed in the region in various operations and encounters.

"In 2019 as many as 142 terrorists were killed but this year the number is around 44. This a cause of worry as it means that despite various efforts we are not able to eliminate them," a senior officer said, seeking anonymity.

The ministry said that the number of grenade attacks decreased from 49 in 2019 to one this year. Similarly, the number of infiltration bids by terrorists was reduced from 141 to three during these five years.

Home ministry officials said the safety of civilians has been a key focus area of the Narendra Modi government. # Work On Technique & Hit Reset Button: Brett Lee To Rohit, Kohli

SYDNEY: Former Australian pacer Brett Lee has advised India skipper Rohit Sharma and star batter Virat Kohli to hit the "reset button", work on their technique and hit the ground running in the five-Test series against Australia, beginning in Perth in less than 10 days' time.

The two batting stalwarts will be keenly observed during the Border-Gavaskar series Down Under following their underwhelming performance in the 0-3 Test whitewash by New Zealand recently.

"When you have a couple of bad runs back to back, that's when the pressure gets set in. So, I guess the thing now is that someone like Virat Kohli and Rohit Sharma, they've just got to go back to the drawing board," Lee said on his YouTube channel.

"They are champions because they do the basics better than anybody else. Then, just



hit the reset button, almost." Lee also warned that the Australian pacers would be aiming to attack Rohit and Kohli with the new ball, and that they

should quickly sort their batting. '(They should) work on their technique, freshen up, get away from cricket for as much as they can and then hit the ground

running when they go to Australia because I can promise you the Australian fast bowlers will be attacking Rohit Sharma with that brand-new ball," he added.

Rohit has managed 588 runs in 11 Tests at an average of just 29.40 this year, while Kohli has accumulated 250 runs in six Test at an average of 22.72.

Lee felt the tendency of the two batter to be too aggressive might have resulted in their poor show so far this year.

"It's hard to put your finger on why they (Rohit and Kohli) failed. If you first look at the way that Rohit Sharma got out, a lot to the quicks. "So, I can't say there's a tech-

nical fault there because I've seen him play for the last decade. I still believe he's one of the best players of the pull shot in world cricket, but maybe he's a little bit too aggressive.

'Maybe there were a couple of shots... was there a technique issue? Was his bat leaving his pad a bit too early? Was he getting that far forward or not enough forward? Or, was he sort of being a little bit hesitant?" Lee wondered

## **Pakistan Should Stop Playing Cricket** With India, Says Rashid Latif

NEW DELHI: Former wicket-keeper batter Rashid Latif says if had the power he would not let Pakistan play against India in any tournament and also suggested that ICC should not grant the hosting rights of global events to both countries until they resolve their issues.

The BCCI has refused to send its team to Pakistan for the upcoming Champions Trophy and there speculation that the entire tournament could be moved out of the country. The Pakistan Cricket

Board (PCB) has written to the International Cricket Council (ICC) asking for a written confirmation from the BCCI for India's inability to travel to Pakistan for the tournament.

"There's a big possibility that Pakistan can stop playing cricket against India. Had I been in power, then, yes, I may have taken this strong step. I would not blame anyone for this. If you don't want to play (in Pakistan), then don't play



against us (at all)," Latif, known for his plain speak, told PTI Videos. "If I would have been

there. I would have taken this decision, and fought against the BCCI. He suggested that the ICC should also stop giving

major tournaments to both India and Pakistan till issues are resolved.


"In my opinion, ICC should withhold the hosting rights for both countries until these issues between them are resolved; until their problems are settled," said the former wicketkeeper-batter who played 37 Tests and 166 ODIs.

Touching upon the issue of political interference in cricket, particularly in Asia, Latif referred to the ban im-

posed on Sri Lanka (in 2023) and Zimbabwe (in 2019) by the ICC and questioned why the global body was lenient towards India and Pakistan. The ICC had suspended

Sri Lanka Cricket (SLC) in November last year for alleged political interference in the administration of the sport in the country. The suspension was lifted in January this year.

"Why aren't India and Pakistan getting banned? Because, ICC has a lot of stake on them," he said.
