'DECEASED, TRANSFERRED IN ABSENTEE LIST'

Shopian DH Staff Protests, Demands Apology

Shopian: In a shocking oversight, Shopian district authorities have included a deceased paramedic, a doctor who had been transferred two years prior, and another terminated doctor, in a list of employees marked absent during a surprise inspection at the district hospital.

Healthcare workers from District Hospital Shopian Thursday staged a protest over the absentee list that they claim falsely marked numerous active staff members as absent. The protest followed a surprise inspection by the Additional Deputy Commissioner (ADC) on Wednesday, which revealed that only 17 out of the hospital's 198 employees were present, with 181 marked absent. staff

protesting

members argued that the absentee list included names of doctors, paramedics, and other personnel who were, in fact, present and on duty during the day. "The list contains the names of those who had passed away, those transferred, and medical professionals no longer employed at the hospital," the portesting staff claimed.

"If only 10% of the staff were present, how would the hospital function smoothly? At 10:00 a.m., there's a shift rotation. Some doctors come in, others have night shifts, and the paramedical staff also has a different rotation schedule,' a doctor, working at the hospital, said.

Man-animal Conflict Claims 1 Life Every Month In Kashmir

Srinagar: At least one person loses life every month in Kashmir due to man-animal conflict.

According to official figures, around 15 people lose their lives annually due to such conflicts in the region.

Over the last 18 years, more than 270 people have lost their lives, while over 3,200 have been injured in mananimal conflict incidents.

The data reveals an upward trend in recent years. During 2020-21, there were five human deaths, which increased to 10 in 2021-22, and further to 14 and 16 in the subsequent two years. Similarly, the number of injuries rose from 87 to 89, then to 65, and finally to 181 over these four years.

Reports of bears and leopards venturing out of forests



in search of food and encountering humans and their livestock are nearly daily occurrences, often leading to attacks in Kashmir.

"The main reasons include an increase in human

settlements, habitat fragmentation, and the growing

population of dogs, which become easy prey for leopards. Additionally, there is a behavioral shift where leopards tend to breed near human settlements," said a senior official from the Wildlife Department.

The official added that wild animals approaching residential areas should not always be labeled as man-animal conflict; rather, it should be considered a man-animal interaction unless there are injuries to humans or damage to crops.

The Wildlife Department has issued several advisories urging people to take preventive measures to avoid such encounters.

Wildlife officials also emphasize the urgent need for protective equipment such as shields, chest plates, helmets, shin guards, and calf guards to enhance their safety during operations.

SRINAGAR: On world diabetes day, the department of Endocrinology SKIMS organised a daylong event SKIMS Auditorium where the outcomes/ results of the world's largest ICMR INDIAB Study of Jammu Kashmir & Ladakh on communicable disease (NCD) was presented.

The session was chaired by Director SKIMS/ EOSG Principal Investigator of the study Prof. Mohd. Ashraf Ganie & Dean Medical Faculty SKIMS Prof. Shariq Masoodi.

Director SKIMS / EOSG Prof. Ashraf Ganie had a detailed interaction with the media about the study outcomes. Prof. Ashraf stressed that the pandemic of Noncommunicable diseases is preventable through healthy lifestyle choices. He said health care setups, administration, govt. and social organizations need to work collectively and need to work on social & cultural practices and there is an urgent need to make people aware about the serious repercussions of these diseases which are mainly due to unhealthy lifestyle practices. He urged the media to play a constructive role in creating wide awareness among the gen-



The study showed that non- communicable disease (NCD) rates are rapidly increasing in India with wide regional variations. The study aimed to quantify the prevalence of metabolic NCDs in India and analyze interstate and inter-regional variations

The Indian Council of Medical Research–India Diabetes (ICMR-INDIAB) study, a cross-sectional population-based survey, assessed a representative sample of individuals aged 20 years and older drawn from urban and rural areas of 31 states, union territories, and the National Capital Territory of India. in multiple phases with a stratified multistage sampling design, using threelevel stratification based on geography, population size, and socioeconomic status of each state. Diabetes and prediabetes were diagnosed using the WHO

criteria, hypertension using the Eighth Joint National Committee guidelines, obesity (generalized and abdominal) using the WHO Asia Pacific guidelines, and dyslipidaemia using the National Cholesterol Education Program— Adult Treatment Panel III guidelines.

The Kashmir & Ladakh

Report (July, 2023- January, 2024) of ICMR INDIAB study conducted under the leadership of Prof. M. Ashraf Ganie, reports on the prevalence of diabetes, prediabetes, obesity, hypertension and dyslipidemia in a representative sample of adults in both The study was conducted urban and rural areas of union territory, and attempts to identify regionwise and state-wise differences in the status of these NCDs in the country using robust sampling and diagnostic methods and therefore helps in assessing the present status of

the epidemic of NCDs and their likely future trajectory. Kashmir & Ladakh prevalence- Known Diabetes- 5.4 percent, New Diabetes- 2.4 percent, To-tal Diabetes- 7.8 percent, Prediabetes- 10.5 percent, Hypertension- 30 percent and Obesity- 57.6 percent.

The findings from the ICMR-INDIAB study are expected to have farreaching implications for public health policies and initiatives in India. State governments, which bear primary responsibility for healthcare delivery, will benefit from the study's granular data in planning region-specific programs to prevent and manage NCDs. The comprehensive dataset from ICMR-INDIAB will help policymakers allocate resources more effectively, focusing on preventive healthcare, early diagnosis, and management of NCDs.

In future discourse ICMR plans to use insights from the ICMR-INDIAB study to foster collaboration with local healthcare providers, and community leaders. This multi-level collaboration aims to implement targeted interventions, promote healthy lifestyle modifications, and improve access to diagnostic and treatment services, particularly

Trump Taps Rubio, Gaetz, Gabbard For Key Cabinet Positions

Washington: President-elect Donald Trump filled more key positions in his Cabinet on Wednesday as he tapped Sen. Marco Rubio, R-Fla., to serve as secretary of state; Rep. Matt Gaetz, R-Fla., as U.S. attorney general and former Congresswoman Tulsi Gabbard for director of national intelligence.

After meeting with President Joe Biden for two hours at the White House in Washington, Trump revealed his latest nominations.

"It is my great honor to announce that Sen. Marco Rubio, of Florida, is hereby nominated to be the U.S. secretary of state. Marco is a highly respected leader and a very powerful Voice for Freedom," Trump said in a statement Wednesday.

"He will be a strong advocate for our nation, a true friend to our allies and a fearless warrior who will never back down to our adversaries."

Rubio, a Cuban American, would become the first Latino person to serve as secretary of state, if confirmed. A three-term senator, Rubio is the top Republican on the Senate Intelligence Committee and serves on the Senate Foreign Relations Committee.

Last year, Rubio voted against additional aid for Ukraine's fight against Russia's invasion and has said the war in Ukraine will end with a "negotiated settlement," which Trump also supports.

Rubio also backs Israel's right to defend itself in its war with Hamas and favors maintaining U.S. alliances, including NATO. The senator also backs Trump's depor-

After Wednesday's announcement, Rubio vowed to "earn the support of my colleagues in the U.S. Senate so the president has his national security and foreign policy team in place when he takes office on Jan. 20."

"Leading the U.S. Department of State is a tremendous responsibility and I am honored by the trust President Trump has placed in me," Rubio said in a statement Wednesday.

"As secretary of state, I will work every day to carry out his foreign policy agenda," Rubio added. "Under the leadership of President Trump we will deliver peace through strength and always put the interest of Americans and

1 Million Migrants In US that Trump Could Target

Washington: Maribel Hidalgo fled her native Venezuela a year ago with a 1-year-old son, trudging for days through Panama's Darien Gap, then riding the rails across Mexico to the United States. claims that Haitians who live and work legally in Springfield, Ohio, as TPS holders were eating their neighbors' pets. They were living in the US when the Biden administration announced Venezuelans would be offered Temporary Protected Status, which allows people already in the United States to stay and work legally if their homelands are deemed unsafe. People from 17 countries, including Haiti, Afghanistan, Sudan and recently Lebanon, are currently receiving such relief.

But President-elect Donald Trump and his running mate, JD Vance, have promised mass deportations and suggested they would scale back the use of TPS that covers more than 1 million immigrants. They have highlighted unfounded

"What Donald Trump has proposed doing is we're going to stop doing mass parole," Vance said at an Arizona rally in October, mentioning a separate immigration status called humanitarian parole that is also at risk. "We're going to stop doing mass grants of Temporary Protected Status."

Hidalgo wept as she discussed her plight with a reporter as her son, now 2, slept in a stroller outside the New York migrant hotel where they live. At least 7.7 million people have fled political violence and economic turmoil in Venezuela in one of the biggest displacements worldwide.



UN Resolutions Back Palestinian Sovereignty, Compensation For Lebanon, Syria

LONDON: The UN Economic and Financial Committee has approved resolutions calling on Israel to compensate Lebanon and Syria for an oil slick, and to hand sovereignty to the Palestinians over their natural resources.

The US, Argentina, Canada, Israel, Micronesia, Nauru and Palau voted against both resolutions.

The slick occurred after the Israeli Air Force struck storage tanks near the Jiyah electric power plant in 2006, covering two-thirds of Lebanon's coastline with oil.

The draft resolution was intro-

duced by Uganda's representative, who highlighted the disastrous impact the slick has had on biodiversity and the local economy.

It reiterated the UN General Assembly's "deep concern" over the negative impact the incident has had on Lebanon's long-term sustainable development, and reaffirmed a UN report that damage to the country caused by the slick amounted to \$856.4 million in 2014.

The resolution was passed by 161 votes in favor to seven against, with nine abstentions. It called for "prompt and adequate compensation" from Israel to Lebanon and Syria, which was also affected by the slick.

Lebanon's representative thanked his country's supporters at the UN, the World Bank and elsewhere.

He said the slick had hindered Lebanon's ability to implement the UN's Sustainable Development Goals by 2030, and Israel's use of chemical and toxic substances in its ongoing military campaign could cause long-term agricultural, economic and biodiversity damage.

He called for an investigation into Israeli war crimes in Lebanon and for further compensation.

The Ugandan representative also introduced a draft resolution calling on Israel to "cease the exploitation, damage, cause of loss or depletion and endangerment of the natural resources in the Occupied Palestinian Territory, including East Jerusalem, and in the occupied Syrian Golan."

The draft also recognizes the right of the Palestinian people to seek compensation for any illegal activity by Israel or Israeli settlers that exploits or damages their natural resources.

It cited an International Court of Justice advisory opinion from July 19, and reaffirmed "the principle of the permanent sovereignty of the peoples under foreign occupation over their natural resources and the applicability of the Geneva Convention on the protection of civilians in time of war."

The committee passed the resolution with 159 states in favor. Seven countries opposed the motion, with 11 abstentions.

The Palestinian representative said Israel must be held accountable for crimes committed against her people and on their territory, saying it has "for over a year" violated the UN Charter with its "incomprehensible" acts in Gaza.

She added that Israel has been allowed to act as a state "above the law with brazen impunity, classifying all Palestinians as terrorists to justify its acts."

The Syrian delegate said genocide, destruction and displacement committed by Israel "have also threatened to set fire to the entire region and beyond." He blamed the US for preventing the UN Security Council from taking firm action.

Dutch Reflect On Amsterdam Violence One Week On

THE HAGUE: The Netherlands is still dealing with the social and political fallout of violence a week ago in the streets of Amsterdam between supporters of Maccabi Tel Aviv and men on scooters.

The attacks have put Amsterdam, famous for its tolerance and diverse community, on edge, with police and authorities ramping up security measures.

Supporters of the Maccabi Tel Aviv club were chased by men on scooters and beaten after a Europa League match against Ajax in Amsterdam on November 7.

Dutch authorities also report-

During a parliamentary debate late on Wednesday, Dutch Justice Minister David van Weel said the investigation was "racing ahead" and that police so far were targeting 29 suspects, based on images taken on the night.

Van Weel said investigations were hampered by perpetrators wearing hoodies and that the incidents happened at night.

At the same debate, far-right MP Geert Wilders, leader of the biggest party in the coalition government, claimed the perpetrators of the violence against Maccabi Tel Aviv football fans were "all Muslims" and "for the most part Moroccans."

The anti-Islam Wilders called

ed Maccabi fans setting fire to a Palestinian flag before the match, chanting anti-Arab slurs and vandalising a taxi.

The violence took place against the backdrop of an increasingly polarized Europe, with heightened tensions following a rise in anti-Semitic, anti-Israeli and Islamophobic attacks since the start of the war in Gaza.

Police, prosecutors and other law authorities have launched a massive probe into the incidents surrounding the Maccabl-Ajax match, making eight arrests so far. for the attackers to be prosecuted "for terrorism, lose their passports and kicked out of the country."

But opposition parties condemned Wilders' statements, saying he was "pouring oil on the fire, abusing the genuine fear and pain of one group to stoke hate against another."

Many opposition politicians and commentators said although anti-Semitism was abhorrent, the violence was not one-side, pointing out Maccabi supporters had chanted anti-Arab slurs, vandalized a taxi and burned a Palestinian flag.

6 Soldiers Killed During Combat In Lebanon, Says Israeli Army

Jerusalem:Israel suffered one of its deadliest days of its ground offensive against Hezbollah in Lebanon on Wednesday when six of its soldiers were killed in combat near the border.

The soldiers "fell during com-

The soldiers "fell during combat in southern Lebanon", the army said in a statement. Their deaths mean 47 Israeli troops have been killed in combat with Hezbollah since September 30, when Israel sent ground forces into Lebanon.

The army's announcement came after Israel's new Defence Minister Israel Katz said there would be no easing-up in the war against Hezbollah.

Israeli Prime Minister Benjamin Netanyahu on X shared an image of the "Golani" Brigade symbol – the unit the soldiers killed belonged to – a green olive tree against a yellow background, with a broken heart emoji.

Since September 23, Israel has stepped up its bombing campaign in Lebanon, mainly targeting Hez-



bollah strongholds in south Beirut and in the east and south of the country. On September 30, it sent in ground troops.

It came after nearly a year of cross-border exchanges of fire, launched by Hezbollah in support of its Palestinian ally Hamas following their October 7, 2023 attack on Israel that triggered the Gaza war.

Earlier on Wednesday, an Israeli strike hit Aramoun, a densely-packed area south of Bei-

rut which is located outside Hezbollah's traditional strongholds, which the health ministry said killed eight people.

Lebanese state media on the same day reported a third wave of Israeli raids on Hezbollah's south Beirut bastion in 24 hours.

The Israeli army meanwhile said it had intercepted some of the "five projectiles" that had crossed from Lebanon into Israeli territory.

Delhi Sees Dense Fog, Lowest Minimum Temp. Of Season

Air Quality 'Severe'

New DELHI: A blanket of fog covered parts of Delhi for the second consecutive day on Thursday with the air quality index remaining in the 'severe' category, an official said.

The city recorded its lowest minimum temperature of the season so far at 16.1 degrees Celsius, three notches above the normal, according to the weather department.

According to the Central Pollution Control Board, Delhi's Air Quality Index at 9 am was 428, which falls in the 'severe' category.

"Of 39 monitoring stations in Delhi, 32 recorded air quality in the 'severe' category, with readings above 400. These stations include Anand Vihar, Ashok Vihar, IGI Airport, ITO, Mandir Marg, North Campus, Patparganj, Punjabi Bagh, and Pusa among others," an official said.

The air quality in Delhi on Wednesday was reported as the worst in the country, plunging into the 'severe' category for the first time this season.

The city's 24-hour AQI, recorded at 4 pm every day, stood at 418 on Wednesday, up from 334 the previous day.

An AQI between zero and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", 401 and 450 "severe" and above 450 "severe plus".

A thick veil of fog blanketed the city on Wednesday morning, reducing visibility to zero and affecting flight operations. The situation improved slightly on Thursday as the visibility at the Delhi Airport at 8.30 am was 400 metres.

The weather department said the maximum temperature is expected to settle at around 29 degrees Celsius.

Iran Hangs Man 'For Second Time': Report

aris: Iran hanged a 26-year-old man for a second time Wednesday months after a previous execution was halted half a minute in, an NGO said.

Ahmad Alizadeh was arrested in October 2018 on a murder charge, which he denied, and was sentenced to death, Norway-based Iran Human Rights (IHR), which tracks executions in Iran, said in a statement.

His death sentence was carried out on April 27 in Ghezel Hesar prison in Karaj outside Tehran. But just 28 seconds into the hanging he was brought down from the gallows when the victim's family suddenly shouted "forgiveness". His "lifeless" body was successfully resuscitated and the execution was halted, IHR said.

Under Iran's sharia law, a victim's family can ask for blood money to spare the life of the perpetrator or also decide to forgive. However, in many cases, the family of the condemned person cannot afford the sum set and the execution goes ahead, according to activists.

Alizadeh remained under the threat of the death penalty in the absence of any deal with the victim's family for blood money.

which this month reported that it had reached 275 million monthly active users. (A Meta spokesperson declined to share whether that number had changed postelection.)

There has been a "feeling of momentum" on Bluesky since the election, said Shannon McGregor, an associate professor at the Hussman School of Journalism and Media at the University of North Carolina, Chapel Hill. Many of the people leaving X are disappointed by the outcome of the election, she said, and now associate the platform with Musk's support of Trump.

Others are frustrated by the type of content that seems to be rising to the top of their feeds. "You were getting this awful timeline of far-right, white supremacist, conspiracy theory posts — which the great majority of people don't want to interact with on a daily basis," said Mc-Gregor, whose research focuses on the intersection of social media and politics.

'Nearly Half Of Those With Diabetes Unaware Of Their Condition'

SRINAGAR: On the occasion of World Diabetes Day, healthcare experts in Kashmir said there is an increasing prevalence of diabetes in the region and that many people are unaware of their condition. They called for early diagnosis, lifestyle modification and regular physical activity to combat this growing health issue.

Dr Mashkoor, a prominent doctor from Government Medical College (GMC) Anantnag said that diabetes is a chronic condition that occurs when the pancreas either does not produce enough insulin or when the body cannot effectively use the insulin it produces.

He said there are three main types of diabetes: Type 1, Type 2, and gestational diabetes (de-

veloping during pregnancy).
"In all cases, sugar builds up in the bloodstream because the pancreas fails to produce enough insulin. Type 1 and Type 2 diabetes may arise due to a combination of genetic and environmental factors," the

doctor said. Dr Mashkoor said while diabetes was previously thought to be more common in urban areas, it is now being reported in both rural and urban populations. However, many remain unaware of their condition because symptoms can be subtle and often go unnoticed, he added.

Common symptoms of diabetes include increased thirst, frequent urination, unexplained weight loss, fatigue, irritability, blurry vision and slow-healing sores, the doctor said, adding that while these symptoms may not always be obvious, those with a family history of diabetes or other risk factors should be especially vigilant.

He warned that uncontrolled diabetes can lead to serious long-term complications. "The longer you have diabetes and uncontrolled blood sugar levels, the higher your risk of developing complications," he

Doctors said that lifestyle modifications play a crucial role in preventing and managing diabetes.

Dr Shahnawaz Ahmad, an endocrinologist, said that nearly half of people with diabetes are unaware of their condition. He urged those with a family history of diabetes or those with lifestyle-related risk factors (such as obesity or hypertension) to undergo regular screenings

"If you are over 35 years old and have risk factors like obesity, hypertension or a family history of diabetes, you should get your blood sugar tested at least once a year," Dr Shahnawaz advised. He recommended a 45-minute brisk walk daily to help maintain a healthy weight

and reduce the risk of diabetes.

Dr Rafaqat, another endocrinologist, termed diabetes a "silent killer" and called for weight reduction, dietary control and exercise to prevent the disease. "Diabetes education is just as important as treatment. People with diabetes should avoid self-medication or visiting quacks, as these can lead to further complications," he said.

Govt Unveils 'Procurement Preference Policy—2024' To **Boost Local MSEs**

SRINAGAR: In a significant step to empower the local economy, the Jammu and Kashmir government has unveiled the Draft Procurement Preference Policy for Micro and Small Enterprises (MSEs) for 2024.

The groundbreaking initiative is designed to channel 30 per cent of the government procurement to registered local MSEs, offering them greater access to public sector contracts and fostering economic growth

The policy drafted by the Department of Industries and Commerce (I&C) aims to create an inclusive and supportive business environment for local enterprises.

It includes several key provisions aimed at providing MSEs with a competitive edge, such as a 25% price preference over nonregistered suppliers. Additionally, local businesses will enjoy reserved procurement quotas and a simplified process for participating in government tenders.

To further reduce financial barriers, the policy offers local MSEs a waiver on Earnest Money Deposits (EMDs) and application fees, encouraging more businesses to compete for government contracts. Special provisions have also been made to support women-owned and SC/ST-owned businesses by reserving a portion of procurement for these groups, fostering diversity and inclusivity in

the business landscape. The Directorate of Industries & Commerce will act as the nodal agency for implementing the policy, assisting businesses in meeting quality standards through mandatory certifications and training.

The government has partnered with organizations like the Quality Council of India and IIT Jammu to provide vendor development programs, helping local MSEs improve product quality and qualify for the prestigious ZED (Zero Defect, Zero Effect) certification.

A key feature of the policy is the introduction of a digital dashboard that will enable real-time tracking and monitoring of MSE procurement. This platform will provide transparency, allowing businesses to access data on government purchasing trends and offer feedback. It will also serve as a tool for government departments to ensure compliance with the new policy.

To oversee the implementation, a UT-level review committee, led by the Principal Secretary of the Industries and Commerce Department, will be established. The committee will address grievances and track progress toward achieving the procurement targets. ensuring the policy's effective

PC To Challenge Police Verification System In Supreme Court

SRINAGAR: Buoyed by the Supreme Court's judgment on "bulldozer justice," Peoples Conference on Thursday announced that it would challenge the existing police verification system in the Supreme Court.

A day after the Supreme Court observed that the demolition of a house solely because the person residing there is either an accused or convicted in a criminal case will amount to inflicting "collective punishment" on the entire family, Peoples Conference today announced that it would approach the apex court against the police verification system in Jammu & Kashmir, which it termed as a more chronic and serious case of collective punishment against the family.

"Encouraged by the bulldozer judgment where the Supreme Court clearly ruled that it is a collective punishment against the family, the JKPC will approach the Supreme Court with a plea that the system of police verification in Jammu and Kashmir is a more chronic and serious case of collective punishment against the family," the party said in a post on X, formerly Twitter.

In a post on X, PC president Sajad Ĝani Lone said that an adverse police verification certificate in Kashmir is a collective punishment against the family. "In the highlighted para, the Supreme Court calls it collective punishment against the family. An adverse police verification certificate because a relative has an adverse police record is also a collective punishment against the family. Kashmir-specific Stone Age justice," Lone said.

In its election manifesto for the 2024 assembly polls, PC had promised to put an end to the "practice of Kashmiris being blacklisted by security agencies, which bars them from getting jobs, passports, and government contracts."

In the recent assembly session, Lone said the police verification is a sword over the youth. "In the whole country, an individual is verified, but here the whole family and even extended family is verified," he said, adding that police verification should be brought at par with other parts of the country—(KNO)

Crucial State Battles

pcoming elections in Maharashtra and Jharkhand are crucial for the ruling BJP and the opposition parties, particularly for the Congress. After a surprise victory in Haryana, the BJP has got wind back in its sails. And the Congress, on the other hand, looks once again adrift after a reasonably good showing in the general elections. So, does the larger opposition. Maharashtra and Jharkhand, therefore, assume a critical significance for the future political direction of the country - albeit, the BJP, despite some setback in the national polls is still way ahead in popularity over the opposition parties.

The polls in Maharashtra are drawing more media and political attention. The BJP is leaving no stone unturned to ensure a win for itself. So do the Congress, NCP and the Uddhav Thackeray led Shiv Sena. Prime minister Narendra Modi, Home Minister Amit Shah, UP Chief Minister Yogi Adityanath and other senior BJP leaders are addressing rallies in the two states and their speeches seem to be appealing to the people.

PM Modi's central role in the BJP's campaign, leveraging India's rising global status and emphasizing Hindu nationalist credentials, are expected to help the party over the finish line. Earlier in the national polls, voters prioritized local livelihood issues over the BJP's Hindutva agenda, which failed to resonate in areas with strong regional identities. The party's economic messaging, focused on India's growth as the world's fastest-growing major economy, fell flat against the backdrop of high inequality and youth unemployment. While the general election outcome was undoubtedly a setback for the brand Modi, the PM has since proved that it was premature to count him out. Haryana and even J&K poll results have brought the BJP back in the reckoning. The PM's ability to adapt and reinvent himself politically is well-documented, and the BJP remains a formidable force in Indian politics, even as it navigates coalition dynamics.

Should the BJP win one or both the states, it would once again make the BJP an all-encompassing party that it has been over the past decade, and the general elections would only appear a blip in its track record. But if the opposition triumphs in either or both the states, it would be back in the reckoning. A see-saw battle between political parties is good for a democracy. Going by the election campaigns of the BJP and the opposition, it could be anybody's game. In Maharashtra, the BJP is part of the ruling coalition and may be expected to face anti-incumbency. However, the saffron party has generally bucked the antiincumbency trend and could be expected to repeat this in Maharashtra as it did earlier in Haryana. 
How Idolizing YouTubers and TikTokers Skews Youth's Idea of Success

Feeling that they fall short of the unrealistic standards set by the social media influencers, the young people may develop a poor sense of self esteem and self worth. Youth may feel easily frustrated when they do not see immediate results of their efforts in contrast to the success portrayed by the social media influencers and this may discourage them to pursue longterm goals. Pursuit of overnight success can reduce the value of patience and persistence. two essential qualities that are needed in both personal and professional development.

The Dangers of Following Trends

and Fads Since young people are keen to follow the trends set by the influencers, they may emulate fashion and lifestyle

established for them by the influencers. Among such fads are those that can promote superficiality and discourage originality. In this way the youth may miss the opportunity to explore their own interests and values required for genuine self exploration and growth.

Risky Behaviors and Lack of Accountability

Few if not all influencers promote behaviors that may be dangerous unrealistic or even harmful such as severe dieting, excessive spending, or a lack of concern for mental health. Young people who adopt such behaviors risk suming unrealistic and unnatural lifestyle patterns without giving it a proper thought. The situation gets further complicated as the content uploaded by the influencers remains accessible to all in the public domain despite having detrimental impact on the followers.

Autumn's Glory: Magnificent Chinar trees in Kashmir

chinar, a tree of antiquity and magnificence is an integral part of the landscape of Kashmir and holds a unique place in its cultural traditions. The tale of changing seasons in Kashmir often finds expression in the distinct appearances of Chinar.

Chinar is pride of Kashmir and represents the aspirations of its people. It is a magnificent and vibrant tree which predominantly grows on the entire landscape of Kashmir. Being an enormous tree, it houses significant biodiversity of birds and burrowing animals. Its large foliage is a source of lifegiving oxygen and significantly mitigates air and noise pollution.

Numerically, Chinar trees have seen a decline over the past decades, due to plant diseases, pests, as well as impact of urbanization. Government is taking proactive steps for the conservation of mighty Chinars, and has embarked on, zealously, for planting Chinar trees on various locations like educational institutions, office complexes, parks, gardens, and other open areas.

The number of mighty Chinar trees once reported to be around 40,000 in Kashmir are now on decline. Hence, conservation of existing trees and planting of more Chinars is being carried out. Chinars are generally planted in parks and gardens by Department of Floriculture, who also maintain these trees.

Chinar, the state tree, is a living heritage of the union territory of Jammu and Kashmir. This majestic tree is an integral part of rich culture of Kashmir and has a very special place in every Kashmiri's heart. The tree is known for its elegance and exuberance and is a very special attraction for the tourists who visit Jammu and Kashmir.

The name Chinar is derived from a Persian word which means, "What a Fire"; it reflects impressive orange red colour of Chinar in Autumn. Its leaves acquire varied hues from blood red to mauve, amber and yellow depicting various seasons of Kashmir. Being a deciduous tree, it is leafless in winters and stands out magnificently during the period of snowfall.

With renewed focus on Chinar, the concern departments are taking up several measures to conserve and promote its plantation at suitable locations across Jammu and Kashmir. Plantation of Chinar in spa-



cious complexes of educational and other institutions, office complexes, public premises is being promoted. As the number of mighty chinars is on decline, a fresh census and geo-tagging with modern tools for their conservation & monitoring is also planned. This will help in their future monitoring and care.

It was during the Mughals, when someone saw its leaves turned into yellow radiant red which signified autumn, and he thought it was fire ,made him shout out the words "Che-Naar Ast?" which means "What flame it is?" in Persian. It is from this question that the royal tree got its name, CHI-NAR, and is believed to be given by Mughal emperor Jahangir.

The tree is an ineffaceable part of Kashmir's history, religion, literature, politics, and romance and its motif finds expression in Kashmiri art and craft particularly Papier-mâché, pottery, shawl embroidery,

silverware and carpet making.

Throughout history, as entire civilizations have withered and mankind has continued to move at a breathless pace, the trees have remained. For some, these trees harbour the secrets to longevity, for others, they provide clear evidence of our journey across lifetimes and the path that awaits us in centuries to come.

Kashmir is always visualized as a big garden, scented with fresh blossoms and fruits and more importantly lined with magnificent Chinar trees. Chinar is synonymous to Kashmir valley. The golden Chinar leaf is a symbol of Kashmir. Every village here has at least one Chinar tree, if not more. Poets and writers have written literature focused on Kashmir's age-old association with Chinar and Chinar scape of Kashmir. They have been an important part of Kashmiri tradition.

The Chinar, the Oriental (Eastern) Plane

tree, Platanus orientalis, or Buen and Booyn in Kashmiri language, is a living heritage of Kashmir. Chinar trees characteristically grow in Eastern Himalayas. Chinar being a long-living tree has survived for ages. It spreads wide across a region of cool climate with sufficient water.

It takes around 30 to 50 years for the trees to reach their mature height and around 150 years for them to grow to their full size. The tree has several properties leaves and bark are used as medicine, the wood, known as lace wood is used for delicate interior furniture and the twigs & roots are used for making dyes.

The shape of the chinar leaf is a popular motif in Kashmiri craft and artwork, particularly in Kashmir's world-famous papiermâché work. The leaves decorate many shawls, women's apparel, and woodwork, such as the popular wood-carved chinar leaf souvenir.

Monarchs like the Mughals, Pathans and Maharajas treated the Chinar as an integral part of Kashmiri's soul and existence. The Mughals even declared the Buen as the Royal tree. Mughal emperor Akbar planted more than 1100 Chinar trees at place called Naseem bagh beside Dal Lake at Hazratbal. Over the

years many Chinar trees were removed to make space for infrastructure expansion, many trees got infected with disease-causing pests & pathogens to reduce number from over 1100 to present population of less than 700

Even though the tree is believed to have existed in the valley even before the Mughal annexation, not only the credit of giving such a beautiful name but also the credit of adding it to the landscape as an attractive shade bearer goes to Mughals. References to the tree can be seen in both Akbar Nama as well as Tuzk-i-Jehangiri, both stating that the King took shelter in the hollow trunk of the tree with its soldiers.

Islamic preachers who travelled to Kashmir four centuries ago from Central Asia and Persia also revered the tree. It is said that the oldest Chinar tree in Kashmir, around 700 years old, was planted by the Sufi Saint Syed Qasim Shah in Chattergam, in central Kashmir's Budgam district. The tree grew to be 14.78 metres tall with a bisal growth of about 19m.

The Chinar has always enjoyed the high favours and patronage of the Mughals as they had recognized and valued its aesthetic and spiritual essence. The world famous Mughal Gardens have stood out as the centres of global attraction for their enticing and charismatic beauty springing from their systematically-planted Chinars.

Chinar - The King Tree is a reminder of the importance of rekindling our respect and love for nature. It is seen as a symbol for the region, and a part of its soul. The Valley of Kashmir is acknowledged as paradise on earth for its diverse rationale and is known for its rich natural environmental heritage. Nature has bestowed our region with a vanity of trees like Deodar, Kail, Fir, Chilgoza pine, Taxus, Juniper, and Cypress etc but without "Chinar" the paradise is incomplete.

Being the Village: 5 Ways to Support the Mothers in Your Circle

"It takes a village to raise a child."

In the past few years, mothers and their circles, have reclaimed this passive advice into an active answer: "I am the village."

While this whispered mantra may empower a struggling mother, it has morphed into a rallying cry for the rest of us. We might have seen the mother in our circle juggle doctor's appointments and diaper changes, feedings and finances, sleepless nights and long days. We might quietly mourn that she wasn't allowed extensive parental leave, family and friends weren't nearby to help her, or that her motherhood is entirely without a partner. She could be balancing a marriage, widowhood, divorce, a career, school, and more, not to mention, her own well-being. "How am I going to do this?" she might ask herself.

And we've responded wholeheartedly. Organising MealTrains, sending along care packages, or even writing a gift card are just small ways that we've given without expectation. But while these actions are appreciated, they are only sustainable for the short-term of motherhood.

So what of the long-term? I spoke with single mothers, first-time mothers, and mothers of more than one who shared how we, as aunts, sisters, neighbours, classmates, coworkers, and friends can be the village.

1. Being "The Village" can mean just be-

One of the most daunting things about motherhood is that a child, especially a young one, requires constant attention. Tasks like grocery shopping, tidying up, and cooking are now joint acts. A baby has to be put in a high chair, or a car seat, or monitored fully by someone else.

Anse, a childless woman, uses this method, "How can I be an extra set of hands,

eyes, or just a body?"

There are many answers, especially when



there's also more than one child. If a mother has to go to the store or an appointment, she has to bring her children as well. Dropping other children off at school or at extracurricular events becomes so much more time-consuming. Going out to eat or to see a movie can also be difficult.

By being the mother's extension of herself, Anse has stayed with the child at home or in the car while the mother went inside. Running errands on the mother's behalf is also something that she recommends.

"The next time you're out shopping, you can give the mother a call or text (whichever is more preferable), and say, 'Hey, I'm at [Store Name], do you need anything?" Baby supplies run out quickly, not to mention other household items.

"Beyond safety reasons, young children can also be entertained or socialised with," Anse writes. By playing with the children, the mother can also get work done around the house, or focus on her other guests if she's hosting a party. Even something as uneventful as taking a child to the bathroom or changing their diaper will give a mother cause for celebration.

2. Supporting a mother goes beyond supporting the child

Motherhood changes a woman in many ways—including the relationships she already has. Making plans or even going out at certain times can be difficult and isolating. But your friendship or sisterhood shouldn't have to suffer. Think of activities the two of you did together before the baby,

and see how you can adjust after.

My friend and I loved going out for coffee and treats before she was a mother. After her daughter was born, despite how busy she was, I offered her the same opportunity with her tiny plus one. Only a few things changed after that; her husband strapped their daughter in my car's backseat, she and I met at a time that worked well for her child's sleeping schedule, and I would hold the little one as my friend got a minute to breathe

breathe.

Even when a mother might be raising a girl, she shouldn't have to deprive herself of girl dates! The mother in your circle likely misses the things she used to be able to do before she got busy with motherhood. Perhaps, even more than you do. And sometimes, gatherings between the two of you can be more simple. When I had another friend stay over for a wedding in town, she brought her infant with her. Dining in with

takeout was just as fun as going out, and we didn't have to overstimulate the baby for our own comfort.

Mothers also struggle with "cabin fever" and may just want to talk to another adult. A call, with video or audio, can also help her stave away any isolation she might feel. This also gives you some time to see the baby in a controlled and quiet setting, rather than her or you making a separate visit.

"What I needed with each of my children was help for me," Hajar told me. "People often forgot that my older children also needed care, as well as my household, while I was trying to take care of the baby." She would've welcomed visitors to take her other children playing, or take care of her living space. The first few years of childhood are the most formative, and she ached for more quality time to spend with her newborn.

3. Giving grace is just as important as giving gifts

The new mother in your life is often running in circles. She might forget something you told her lately, or be late to a meetup that the two of you agreed on. Her body and mind are going through a large amount of changes in a short amount of time. In many cases, mothers may also be having a difficult postpartum period without a strong circle. Due to societal or family pressure, she may not be honest about potential postpartum depression, which can last for months after birth.

It's important to foster sympathy and be understanding when a mother is late, or if she seems a bit distracted while speaking to you. If you can, do a bulk of the research about a place you'd like to meet at. Consider the times of day that the restaurant is busy and crowded, if they have changing stations or high chairs available, and potential allergens in the food.

Check in often. Sometimes all she needs is an ear to listen to her. Enquire if a voice note is convenient for her as she's running around her living area, or if it's something

that might wake her baby up. Similarly, a text might mean that she has to stop everything that she's doing to read what you're saying—or it could be something that she can happily read in peace and quiet.

Moreover, recognise that she's still learning about this process everyday. Breastfeeding, exhaustion, and lonelinessare just a few of the daily struggles that she endures.

Advise with experience and empathy Advice, although well-intentioned, may not always be welcomed. For example, not every household is able to afford living on a single income. A mother who has had to return to work and place her child in daycare is not sinful. She may be doing so for a variety of reasons besides economical—like socialising and educating her child, finding purpose outside of motherhood, and stimulating her own mental capacities. Approach her with the mindset that she is doing her very best, and that a person's very best

looks different for everyone.

Sharing stories of your own experience with motherhood, or even the birthing process, can be overwhelming for a new mother. While visiting the new baby can be exciting, in many cases, a woman in postpartum is still using this period to recover. Internalise that you are there to help, not to have her host.

Know your own capabilities and talents given by Allah

Sometimes we may not be able to act on the promises we made to a mother. Higher studies may become too time-consuming, finances may not be as expected, and your health may take a turn for the worse. In addition to this, a mother's needs may change over time. Preparing food may no longer be an issue, however, she might wish that she had someone to eat the food with.

While sometimes the simplest acts can be the most helpful in this life and most rewarded in the next, some of us want to give more meaningfully and intentionally.

IISc Scientists Develop Enzyme-Based Solution To Break Antibiotic-Resistant Biofilms

A team of scientists at the Indian Institute of Science (IISc) has developed a method to break down biofilm barriers, which protect bacteria from antibiotics and contribute to drug resistance.

The breakthrough involves using an enzyme from the cow's digestive tract, according to a press statement, issued by IISc on Tuesday.

Klebsiella pneumoniae, an opportunistic bacterium, infects hospital patients and causes conditions like pneumonia, urinary tract infections, and meningitis, said

Dipshikha Chakravortty, professor at the department of Microbiology and Cell Biology (MCB) and a corresponding author of the study.

In individuals with diabetes, it infects wounds that heal slowly, sometimes leading to complications requiring limb amputation, she added. The bacterium secretes

a tough biofilm matrix composed of sugars, fats, proteins, and DNA. Polysaccharides, formed by strings of sugar molecules in this matrix, play a crucial role in strengthening the biofilm, Chakravortty explained.

To address this, the IISc team sought a biocompatible

strategy to disrupt the biofilm by targeting polysaccharides. "We realised that polysaccharide-degrading enzymes could serve the purpose, and a cow's gut was the ideal place to look for them," said Debasis Das, assistant professor in the department of Inorganic and Physical Chemistry (IPC) and

another corresponding au-

thor of the study. The team identified glycoside hydrolases (GH) enzymes from the rumen, the largest compartment in a cow's stomach, and synthesized a specific enzyme, GH-B2, in the lab. Testing GH-B2 on four strains of Klebsiella pneumoniae isolated from hospital patients

revealed it effectively broke down biofilms in all strains.

The enzyme was tested in lab mice with wounds infected by Klebsiella pneumoniae. A combination of GH-B2 and meropenem successfully cleared the biofilms.

"The chances of bacteria gaining resistance are minimal because our enzyme targets the biofilm matrix, not the bacteria directly," said Reshma Ramakrishnan, PhD student in Das's lab and the study's first author. She noted the "potential for combinatorial therapy using the enzyme and antibiotics to treat biofilmassociated infections.

The researchers plan to

incorporate the enzyme into wearable wound dressings. "For local infections, especially in diabetic individuals, this is very promising," said Chakravortty. Das also suggested the enzyme could be used as a coating on medical devices to prevent biofilm formation.

"It is vital to develop innovative strategies to disrupt bacterial lifestyles," stated Chakravortty, adding, "We must continuously identify potent enzymes to combat infectious diseases, which remain a significant threat.'

The findings were published in Nature's 'NPJ Biofilms and Microbiomes'.

Exports Jump 17.25% In Oct, Highest In Over 2 Years; Trade Deficit Widens

NEW DELHI- India's merchandise exports in October rose by an impressive 17.25 per cent year-on-year, highest in over two years, to USD 39.2 billion, while the trade deficit widened to USD 27.14 billion on a sequential basis.

According to the government data released on Thursday, imports increased by 3.9 per cent to USD 66.34 billion in October compared to USD 63.86 billion in the year-ago period, mainly due to a 13.34 per cent rise in

crude oil imports.

The trade deficit (gap between imports and exports) narrowed as compared to USD 30.42 billion recorded in October last year. However, it has widened from USD 20.78 billion recorded in September this year.

The country's merchandise exports have recorded the previous high growth of 30.12 per cent in June 2022.

During April-October this fiscal, exports increased by 3.18 per cent to USD 252.28 billion, and imports by 5.77 per cent to USD 416.93 billion.

The deficit during the latest seven-month period was USD 164.65 billion as compared to USD 149.67 billion during

WPI Inflation Rises To 4-Month High Of 2.36% In Oct; Food Prices Spike

NEW DELHI: Wholesale price inflation rose to a 4-month high of 2.36 per cent in October as prices of food items, especially vegetables, and manufactured goods turned dearer, showed the government data released on Thursday.

The wholesale price index (WPI) based inflation was 1.84 per cent in September 2024. It was (-) 0.26 per cent in October last year.

As per the data, inflation in food items shot up to 13.54 per cent in October, as against 11.53 per cent in September. This was led by 63.04 per cent inflation in vegetables, as against 48.73 per cent in September.

Inflation in potato and onion remained high at 78.73 per cent and 39.25 per cent, respectively, in October.

Fuel and power category witnessed deflation of 5.79 per cent in October, against a deflation of 4.05 per cent in September. In manufactured items, inflation was 1.50 per cent in October, as against 1 per cent in the previous month.

The month of October witnessed the second consecutive month of rise in WPI inflation print. WPI higher than October's level was recorded last in June 2024, when it was 3.43 per cent.

"Inflation in October 2024



is primarily due to increase in prices of food articles, manufacture of food products, other manufacturing, manufacture of machinery & equipment, manufacture of motor vehicles, trailers & semi-trailers, etc." the Ministry of Commerce & Industry said in a statement.

Barclays Regional Economist Shreya Sodhani said perishable food prices, particularly vegetables, are driving both retail and wholesale prices. Manufactured products WPI rose moderately, reflecting the rise in prices of metals in the month.

"The surprise to our estimate was due to a higherthan-expected acceleration in

food prices," Sodhani said. ICRA Senior Economist Rahul Agrawal said food inflation alone pushed up the headline WPI print by as much as 63 basis points between September and October 2024.

On a year-on-year (YoY) basis, the core WPI print rose to 0.3 per cent in October 2024 from 0.1 per cent in September 2024, while remaining muted.

"Owing to the expected softening in food inflation, ICRA estimates the WPI inflation to ease to approximately 2 per cent in November 2024," Agrawal said.

Looking ahead, the robust increase in kharif output for most food items and the healthy outlook for rabi crops amid elevated reservoir levels augurs well for the WPI food inflation prints in the near term, even as fertiliser stocks are a monitorable.

However, the outlook for the headline WPI inflation remains vulnerable to movements in global commodity and crude oil prices, Agrawal said.

Indian Economy Sailing Smoothly Amid Global Headwinds: RBI Guv Das

MUMBAI: Reserve Bank Governor Shaktikanta Das on Thursday said the Indian economy has been sailing "smoothly" amid the global headwinds.

Speaking at an event organised by CNBC-TV18 here, Das declined to comment on a suggestion by Union Commerce Minister Piyush Goyal for a rate cut, maintaining that the rate-setting panel will take an appropriate call on it at its next meeting in December.

In comments made days after headline inflation shot up beyond the 6 per cent tolerance band of RBI for October, Das said inflation is "expected to moderate despite periodic humps"

The Governor said the domestic economy has sailed very well through the prolonged period of turbulence in the recent past exhibiting resilience, but added that there are a slew of headwinds prevailing in the global economy right now like rising bond yields, commodity prices showing a divergence and a contradiction of financial markets showing resilience despite rising geopolitical risks.

"The Indian economy is sailing smoothly, powered by buffers like strong macroeconomic fundamentals, a stable financial system and a resilient external sector," said the bureaucrat-turned-central banker, who will be completing six



With the rupee hitting new lows, Das said India's external sector has exhibited "strength and stability" in the recent period as seen in the current account deficit remaining at a manageable level, merchandise exports starting to grow, and service exports growth being strong.

He reminded that the country has the fourth largest forex reserves in the world. The forex reserves, which stood at USD 682 billion as of October 31, are sufficient to cover the entire external debt and a year's import payments, he added.

The Governor also made it clear that the RBI does not target a rate for the rupee, and the fore interventions are for ensuring orderly movement and curbing volatility in the currency.

"If the Indian rupee has re-

mained relatively stable despite severe external shocks, including the largest and the steepest tightening by the US Fed in 2022 and 2023, it speaks volumes about the sea change in our macro fundamentals from the days of the taper tantrum," Das said.

Rupee Falls To All-Time Low Of 84.46 Against US dollar

MUMBAI- The rupee depreciated by 7 paise to close at an all-time low of 84.46 against the US dollar on Thursday, weighed down by unabated foreign fund outflows and strong dollar demand from investors.

Forex traders said the downward pressure on the USD/INR pair is largely driven by persistent inflation and significant foreign fund outflows.

At the interbank foreign exchange, the rupee opened at 84.40 against the US dollar. During the session, the local currency touched a high of 84.39 and a low of 84.47. It finally settled at its fresh alltime low of 84.46 against the greenback, 7 paise lower than its previous close.

On Wednesday, the rupee moved in a narrow range and settled flat at 84.39 against the US dollar.

"The US dollar index has hit a fresh cycle high of 106.76 as it approaches the stiff resistance at 107.50," said Praveen Singh - Associate VP, Fundamental Currencies and Commodities, Sharekhan by BNP Paribas.

"There was no respite on the



US inflation front as the data released yesterday showed that the US core consumer price index increased 0.3 per cent for a third month. It was up 3.3 per cent on a year-onyear basis," Singh said. Anil Kumar Bhansali, head

of Treasury and executive director Finrex Treasury Advisors LLP, said the rupee's fall was held by the RBI which continued to sell dollars

"The rupee is expected to remain weak but protected by RBI between 84.30 to 84.60 during the next week and is expected to weaken towards 85.00 by possibly December as Trump trades continue to ensure sell off of assets," he added.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading higher by 0.30 per cent at 106.80.

Brent crude, the global oil benchmark, rose 0.03 per cent to USD 72.30 per barrel in fu-

Forex traders said the USD-INR pair may touch Rs 85 level in near-term, though the intervention by the Reserve Bank of India (RBI) may slow the pace.

On the global front, China's recent 1.4 trillion yuan stimulus, coupled with expecta-tions of more fiscal support, has strengthened Chinese markets and added downward pressure on Indian assets, traders said.

Moreover, India's inflation surge is putting additional pressure on the currency.

Wholesale price inflation rose to a 4-month high of 2.36 per cent in October as prices of food items, especially vegetables, and manufactured goods turned dearer, according to government data released on Thursday.

Retail inflation breached the RBI's upper tolerance level, soaring to a 14-month high of 6.21 per cent in October mainly on account of rising food prices.

In the domestic equity market, the 30-share BSE Sensex fell 110.64 points, or 0.14 per cent, to close at 77,580.31 points, while Nifty fell 26.35 points, or 0.11 per cent, to settle at 23,532.70 points.

'AI-Vistara Ready For Coming' Aviation Revolution; Will Fulfil Sky High Expectations'

NEW DELHI- Tata Sons Chairman N Chandrasekaran on Thursday said the best qualities of Vistara are being brought to Air India, which was in decline for a number of systemic reasons when Tatas took over the airline two years back, and fulfil the "sky high expectations".

"We are fully aware that

expectations for the new Air India are sky high. We expect nothing less, and we expect to deliver nothing less," he said and asserted that the merged entity will be ready for the country's coming aviation

Nearly two years after announcing the merger, the integration of Vistara with Air India was completed on November 12 and Singapore Airlines now has a 25.1 per cent in the enlarged Air India.

Vistara was jointly owned by Tatas and Singapore Airlines.

"Given our ambitions, this merger should be seen as part of a journey. Different parts of the business were at different points of maturity when the merger commenced, so they will take time to fully align," Chandrasekaran said in a LinkedIn post.

While acknowledging that there is still more work to do

full service carrier.

Amid concerns in certain quarters on whether Vistara passengers will continue to get the same services as now since Air India, which is in the transformation phase has been facing various service issues, it has been repeatedly emphasised that "Vistara in-flight experience is not going away' post-merger.

He said the merger is an important milestone in the commitment to transform Air India into a world-class global airline with an Indian heart.

According to him, mergers take time to play out and that the group has moved quickly, completing the process in two years while "keeping our eye on the ultimate goal: to realise AI's potential and turn it into a world-class global airline".

EU Slaps Meta With Nearly 800 Million Euro Fine

LONDON- European Union regulators hit Facebook parent Meta with a fine of nearly 800 million euros on Thursday for what they call "abusive practices" involving its Marketplace online classified ads business.

The European Commission, the 27-nation bloc's executive branch and top antitrust enforcer, issued the 797.72 million euro (\$841 million) penalty after its longrunning investigation found that the company abused its dominant position and engaged in anti-competitive behaviour.

Brussels had accused Meta of distorting competition by tying its online classified ad business to its social network, automatically exposing Facebook users to Marketplace "whether they want it or not" and shutting out competitors.

It was also concerned that Meta was imposing unfair trading conditions with a terms of service that authorised the company to use ad-related data – generated from competitors who advertise on Facebook or Instagram — to benefit Marketplace.

Meta said in a statement that the decision fails to prove any "competitive harm" to rivals or consumers and "ignores the realities of the thriving European market for online classified listing services." The company vowed to appeal.

Gold Slide Continues; Tanks Rs 700 To Rs 77,050 Per 10 Grams

NEW DELHI- Gold prices saw yet another steep fall on Thursday, with the precious metal declining Rs 700 to Rs 77,050 per 10 grams in the national capital amid subdued demand trend in the global markets, according to the All India Sarafa Association.

The precious metal of 99.9 per cent purity closed at Rs 77,750 per 10 grams in the previous session, a day after falling marginally by Rs 50 on Wednesday. Silver also plummeted Rs 2,310 to Rs

of Rs 92,500 per kg. Extending the losses for the fourth straight session, the price of gold of 99.5 per cent purity fell Rs 700 to Rs 76,650 per 10 grams. It had ended at Rs 77,350

per 10 grams on Wednesday. In futures trade on the MCX, gold contracts for December delivery plunged Rs 804 or 1.08 per cent to trade at Rs 73,678 per 10 grams. During the day, the precious metal declined Rs 1,182 or 1.59 per cent to Rs 73,300 per 10 grams.

"Gold's weakness persisted with price falling near Rs 73,500 in MCX as the dollar climbed. The US CPI data, which came in higher at 2.6 per cent compared to the expected 2.4 per cent, fuelled the dollar's strength.

"While the Fed has been continuing with rate cuts as inflation approached its 2 per cent target, the CPI data raised concerns that further cuts may be paused," Jateen Trivedi, VP Research Analyst - Commodity and Currency, LKP Securities, said.

This development added pressure on gold prices, which reacted negatively to the stronger dollar and the potential shift in Fed policy, Trivedi added. Silver contracts for December deliv-

ery plummeted Rs 2,067, or 2.32 per cent, to Rs 87,130 per kg. Globally, Comex gold futures fell USD

29.10 per ounce, or 1.13 per cent, to hit a two-month low of USD 2,557.40 per ounce. "Gold extended its fall during Thursday's European session, hitting its lowest level since September 19.

"The US Dollar's (USD) post-election rally persisted, reaching a fresh yearhigh which continues to put pressure on gold prices," Saumil Gandhi, Senior Analyst of Commodities at HDFC Securities, said.

The US Dollar buying remains unabated by traders in the wake of optimism over the expected expansionary policies by US President-elect Donald Trump. This, in turn, is seen as a key factor dragging the commodity lower for the fifth successive day, traders said.

Sensex Drops 110 Pts, Nifty Slides For 6th Day On FII Selling

Reliance Industries, Kotak Mahindra Bank, Tech Mahindra, Mahindra & Mahindra and HDFC Bank were among the gainers.

Foreign Institutional Investors

(FIIs) offloaded equities worth Rs 2,502.58 crore on Wednesday, while Domestic Institutional Investors (DIIs) bought shares worth Rs 6,145.24 crore, according to exchange data.

The domestic market experienced a lacklustre trading, but some stability was observed throughout the day, from the low. The sustainability of this trend remains uncertain as FIIs continue to be on the selling side. working, we'd take responsibility. But presenting this situation like this is an insult." he added.

During the protest, the medical staff demanded an official apology from the Deputy Commissioner (DC) for the harm and humiliation caused by the erroneous data.

"The list is not only inaccurate, but it also insults those of us who are committed to serving our patients," said one of the protesting doctors. "We work with honesty and integrity, and to be publicly marked as absent when we are working day and night is an affront."

The protestors also highlighted the damaging impact the list had on public perception and the fragile trust between healthcare providers and the community. "Our families are being insulted and questioned because of this mistake. The DC's office must take responsibility for this error and issue an apology," another protestor added.

According to the staff, the list inaccurately included the names of individuals who had passed away, such as Dr. Shahid, a paramedic who died recently, and Dr. Bilal, a doctor who had been terminated. The protestors expressed concern over the fact that the list was shared publicly without verification, accusing the authorities of neglecting proper data filtering before releasing such sensitive information.

"They should have conducted a proper inspection and ensured that the staff's attendance was accurately recorded," one doctor stated. "Instead, we were publicly humiliated, which only creates further mistrust."

The protestors also pointed out the lack of accountability for the flawed list, emphasizing that the DC and other administrative offices should have ensured better management and verification of the data before posting it. They called for an apology not only for the administrative mistakes but also for the emotional distress it caused to the healthcare workers and their families.

"We are ready to work under any conditions, but we cannot tolerate this kind of disrespect," said a paramedic during the protest. "We demand a public apology from the DC, and we want to ensure that this does not happen again."

The Deputy Commissioner (DC) Shopian, Mohammad Shahid Saleem Dar said that the inspection was part of a broader effort to ensure discipline and accountability in government institutions.

"We received complaints about negligence from staff in various departments, which is why the ADC visited the District Hospital for a surprise check," the DC said.

He added that both biometric attendance and hard copy registers were thoroughly reviewed. "We are in the process of verifying all data. If there is a technical issue, we will look into it," the DC said.

"The MS (Medical Superintendent) has been instructed to provide an explanation within two days regarding the discrepancies noted."

The DC further emphasized that this inspection was not limited to the District Hospital. "We will conduct surprise inspections across all institutions, not just in the mornings but throughout the day, to ensure accountability," he added. He expressed support for employees who work diligently. "We stand with those who are honest and dedicated in their work. Our priority is to ensure that the system functions properly, and that everyone is accountable for their responsibilities," he said.

Therefore, they can't come to terms with the fact that someone from OBC has been the PM of the country for the last 10 years," he said.

"The Prince of Congress, while he is abroad, openly claims that his party will scrap reservations. To further their agenda, Congress and Maha Vikas Aghadi are conspiring to divide SCs, STs and OBCs into small castes," he said

Modi also said the BJP-led Mahayuti government renamed Aurangabad as Chhatrapati Sambhajinagar, and fulfilled the wish of Shiv Sena founder Bal Thackeray.

"The whole of Maharashtra knows that the demand to rename this city as Chhatrapati Sambhajinagar was raised by Balasaheb Thackeray," he said. The Congress party went to the court to overturn this decision, he added.

The Maha Vikas Aghadi government was in power for two-and-a-half years but did not have the courage to rename the city under pressure from the Congress, he said.

"This election in Maharashtra is not just an election to elect a new government. In this election, on one side there are patriots who believe in Sambhaji Maharaj and on the other side there are people who praise Aurangzeb." Modi said.

"BJP-Mahayuti ahe, tar gati ahe, Maharashtrachi pragati ahe (If there is Mahayuti there is progress in Maharashtra)," Modi said.

The people of Maharashtra and Marathwada had been demanding for decades to give classical language status to Marathi, Modi said. This work related to Marathi pride was completed by the BJP, he added.

"Maharashtra has attracted the maximum FDI after the formation of the Mahayuti government. The people have benefited due to the investment," he said.

Who Said Art 370

He accused the BJP of keeping the Article 370 issue alive merely to create divisions in society.

Addressing a press conference in Pune, Kharge accused Prime Minister Narendra Modi of abusing the Congress and its senior leaders Sonia Gandhi and Rahul Gandhi.

"Amit Shah, in his poll rallies, accuses the Congress of spreading lies. (But) He (himself) is saying the Congress wants to bring back Article 370 (in J&K). Tell me, who said that and when? You are raking up an issue. If it (resolution to repeal Article 370) had been already passed in Parliament, why are you raking up the issue again? It means you want to keep the issue alive to divide. If you want to say this, go to Kashmir and say it. Elections are over in Kashmir," Kharge noted.

Article 370 of the Constitution, which provided special status to Jammu & Kashmir, was nullified by the

BJP-led central government in August 2019.

The Congress is aligned with the National Conference, which heads the government in J&K. Last week, the Jammu and Kashmir assembly passed a resolution asking the Centre to hold talks with elected representatives for restoration of the erstwhile state's special status.

Referring to Uttar Pradesh Chief Minister Yogi Adityanath, the Congress president said one of the BJP leaders is saying 'batenge toh katenge' (we will perish if we are divided) and questioned the rationale behind coining such a slogan.

"Why (give such a slogan)? The country is united. The Congress worked to keep the country united. (To keep the country united) Indira Gandhi and Rajiv Gandhi sacrificed their lives. Mahatma Gandhi was assassinated. The Congress did this (sacrifices), but you neither fought for the country's unity, nor its independence or the poor," Kharge opined, hitting out at the BJP.

He pointed out that it was the Congress which made provision for reservation in the Constitution as first Prime Minister Jawaharlal Nehru and Dr Babasaheb Ambedkar worked to approve the quota for SCs/STs in jobs and education.

"But they (BJP) are still raking up the (reservation) issue," Kharge remarked. He claimed the BJP is pitting the country's towering political figures like Nehru, Ambedkar, Vallabhbhai Patel and Subhas Chandra Bose against each other.

"They (BJP) now say Babasaheb wanted to do this, but Jawaharlal Nehru did this. Vallabhbahi Patel said this and Bose said that. When they were alive, you were against the Constitution. You did not even keep the Indian flag in your office.

"You were not ready to accept the Ashok Chakra (centred in middle of the tricolour) and you wanted to have a Constitution on the basis of Manu (Manusmriti, an ancient religious text) and now you remember the Constitution," he insisted.

The AICC president asserted the Congress wants to keep the country united and was ready to make any sacrifice for it.

Just 5 per cent people in the country hold 62 per cent wealth and 50 per cent people have only 3 per cent wealth, he said.

"Instead of reducing this disparity, Modiji is encouraging his friends by selling public sector units. The maximum drug supply is taking place at the port given to Adani. In October, 400 kg cocaine was seized. In February, 4,000 kg charas was seized. Illegal things are being brought in which are destroying (youths in) Pune, Bengaluru, Punjab," Kharge averred.

Asked how the Congress and opposition MVA will mobilise finances to fund populist schemes promised in their manifestos if they come to power in Maharashtra, he said, "Give us power, we will give you a budget. We work as per the budget."

"We do not believe in 'khoke' (boxes of money), but 'doke' (brain). We have brains and they have khoke," the Congress leader remarked.

ited Sangaldan, Ramban and Batote areas of the district and interacted with people, said, "Bulldozers were specifically used against one community, targeting their religious places, madrassas and work places. I congratulate the Supreme Court for taking notice of this."

He also congratulated the apex

court for recognising Aligarh Muslim University as a minority institution that needs protection.

Abdullah reiterated the call for a review of the Indus Water Treaty, asserting that it restricts Jammu and Kashmir's access to its own resources,

rivers benefiting Pakistan.
"Omar Sahab recently raised this issue in a meeting of power ministers. He brought up the matter of the Indus Water Treaty, which Pandit Jawaharlal Nehru, as Prime Minister of India,

with the Chenab, Indus and Jhelum

"Through this treaty, three rivers from Jammu and Kashmir — the Chenab, Indus and Jhelum — were handed over to Pakistan. In return, India retained the Ravi, Beas and Sutlej," he said.

Supporting a strong review, he added, "Today, we cannot even take a single drop or a glass of water from these rivers for ourselves. We want its review"

He further pointed out that Jammu has grown substantially and recalled that during his tenure as chief minister, the government prepared a Rs 200-crore plan to lift water from the Chenab for Jammu but it could not be completed due to the Indus Water Treaty.

"If we want to save people, we need a solution for water. Look at the current administration under the Lt Governor – we don't have electricity but our own power is being given to Uttar Pradesh and Rajasthan, while we remain deprived.

"What kind of situation is this?" he questioned.

Expressing concerns about the funds meant for providing safe drinking water to people, he questioned the fate of the Rs 3,000 crore reportedly allocated for safe drinking water but allegedly mismanaged.

He demanded an investigation into the role of officials involved, calling for accountability.

"We want to review what happened to the 3,000 crore rupees allocated for providing safe drinking water to the people. We will investigate this," he said.

Abdullah said it has to be investigated.
"That officer is still alive. He is not in

the government now, but we will call him to account for this issue. "Where did those 3,000 crore rupees go? Why was no action taken by

the Lt Governor and chief secretary of that time?" he said. He called for a review of all such

decisions.
"We want a review of the treaty provisions that the Lt Governor implemented, giving power to Uttar Pradesh

and Rajasthan. We want everything

reviewed," he said.

Abdullah reiterated the pressing need for restoration of statehood to JK and said, "Omar Sahab met with the prime minister and the home minister in the first week. He has now met with

the vice president, and he is meeting

with the president of India."

The NC chief further mentioned that the chief minister has also attended a conference of power ministers because of a severe power shortage in the region.

"He will also meet with the finance minister to address our financial situation. We are trying from every angle to improve the state's condition, but this will only happen when we all work together.

"This responsibility cannot just be left to the government. We, too, must monitor the work being done as the government cannot be everywhere. Everyone needs to keep an eye on things," he urged.

Abdullah also emphasised the importance of stopping the use of outside contractors.

"Are our people so incapable that

"Are our people so incapable that they can't handle these contracts? All the contractors are from outside and the labourers are from outside.

"Can't our own labourers work here? What have they achieved in these 10 years that people can say we are progressing?" he asked.

Abdullah stressed the importance of restoring the Upper House of the state Assembly to give representation to the marginalised regions and communities.

"I am hopeful that when statehood is restored, the number of ministers will increase. When statehood returns, we will restart the Upper House as well because there are many regions and communities that currently have no representation but they should be represented," he said.

The former chief minister said during his time, the government provided representation to the regions where no one was advocating for their issues, either in the Assembly or in the

government.
"We want this restoration to happen as soon as possible so that these people and groups receive representation, work can be done for them and their

problems can be resolved," he said.

Abdullah voiced deep concerns over the deteriorating infrastructure and lack of basic services in JK. Speaking on the state's healthcare, schools and access to clean drinking water, he highlighted the challenges plaguing the region, particularly mentioning a village in Kulgam where residents lack

safe drinking water.
"The government has so much to do that they should not be able to sleep or rest until they bring the state out of these difficulties," Abdullah urged,

 Γ ormer India cricket coach Ravi Shastri believes Virat Kohli has the potential to turn around his poor form and prosper during the upcoming five-Test Border-Gavaskar series in Australia.

Kohli has been going through a rough run across all formats over the last few months. The 36-year-old star batter has scored just one half-century and averaged only 21.33 across five Test matches against Bangladesh and New Zealand since the start of the year.

But Shastri has warned Australia and said Kohli is back in the country where he loves to bat and score runs. "Well, the King is back in his territory. That's all I will

tell them." Shastri said on The ICC Review. "When you've earned that title after your exploits in Australia, it will be on your (opponent's) mind when you go out to bat."

Shastri was referring to Kohli's phenomenal performances in Australia, which include a fighting century in Adelaide in his first-ever Test tour in 2011/12, a staggering 692 runs from four Tests during the 2014 tour, and an exceptional 123 in Perth during the 2018/19 series when he captained the side.

Shastri, however, cautioned Kohli to be mindful during the initial phase of the tour.

"Your juices are flowing, you're charged up. It's again a case with Virat. You want to see calmness because, at times, you are overeager to get out there and throw the first punch," the former India all-rounder said

"But, I think that calmness in the first half an hour where he gets out to bat or in the first three innings of the series will be extremely important. If he can be calm and play the game at his own pace rather than being in a hurry, I think he'll be fine."

Pakistan bans weddings, shuts schools as 15K taken ill in a day after AQI reaches 604 in Lahore

The toxic smog, which continues to grip Lahore and other parts of Pakistan, has worsened, with the city reporting over 15,000 cases of respiratory and viral infections in just 24 hours, Ary News reported.

According to Ary News, Lahore's hospitals are overwhelmed with patients suffering from dry cough, breathing difficulties, pneumonia, and chest infections.

The majority of cases were reported at major government including hospitals,

Mayo Hospital (4,000+ patients), Jinnah Hospital (3,500 patients), Gangaram Hospital (3,000 patients), and Children's Hospital (2,000+ pa-

As per Ary News, medical experts in Pakistan have warned that children and patients with pre-existing conditions, such as asthma and heart disease, are particularly vulnerable to the smog's effects. "Special children are se-

verely affected," said Ashraf Zia. The smog has led to an increase in various viral diseases, including pneumonia, chest infections, and skin diseases. "Over 10 viral diseases are currently prevalent in Lahore," he said.

These include the imposition of a three-month ban on weddings to the release of new guidelines by the transport department in response to the situation of smog in most parts of the province. Other measures include the Pakistan Punjab government closing schools and colleges in the state.

The severe smog, which now engulfs northern Pakistan was also reported by NASA's Moderate Resolution Imaging Spectroradiometer (MODIS).

"A thick blanket of sky-soiling smog hung over northern Pakistan in early November 2024, causing air quality to plummet, schools to close, and sending hundreds of people to the hospital", NASA MODIS said.

It also made note of the plummeting levels of AQI in the country. "According to several news reports, the Air Quality Index in parts of the Punjab region of Pakistan spiked to more than 1,900 on November 10".

It reported Pakistani media sources who announced that Pak-



istan's Punjab Provincial Disaster Management Authority had declared smog a "calamity" and instituted emergency measures.

"On November 12, the Puniab government website advised that the AQI for the province over last 24 hours had averaged 604--well into the Hazardous range", NASA MODIS said.

Speaking on the thick layer of pollution, NASA MODIS reported, "The tan haze is so thick that it completely obscures the landscape of Pakistan from view. Irregular patches of a lighter color indicate that fog hugs the ground underneath the haze. The city of Lahore, Pakistan--which has ranked as the most polluted city in the world in recent days--is located near the northeastern edge of the fog"

IIT Indore is developing intelligent receivers that can automatically detect and decode key communication methods, such

"This technology is vital for future 6G networks and military communications. It enables receivers to decode signals in difficult environments, like when military transmissions are intercepted. By automatically identifying these methods, it ensures that important data can be gathered from unclear or noisy signals, making it crucial for intelligence operations," IIT Indore's Director Professor Suhas Joshi said.

"As the world moves towards 6G, communication systems will need to handle ultra-fast mobile internet and vast networks of devices, such as Internet of Things (IoT). Traditionally, different receivers were required for different scenarios, making systems complicated and expensive. IIT Indore's technology aims to create a single receiver that can adapt to any situation, eliminating the need

for multiple systems," he said. The receiver is being developed under the leadership of Dr Swaminathan R, Professor, Department of Electrical Engineering of IIT Indore.

"This technology could revolutionise both telecommunications and military fields by improving efficiency and security. Unlike existing systems, IIT Indore's receivers can recognise modulation, coding, and interleaving methods together, a capability that hasn't been fully achieved before. Early tests have shown promising results, accurately identifying different channel encoders and interleavers," Swaminathan said.

Currently, the testing of these models in real-time and expanding them to cover a wide range of communication standards from 3G to 6G is being done, he said.

Prime Minister Narendra Modi, while addressing the 'India Mobile Congress 2024' last month, said India has become the world's second largest market for 5G telecom technology and is now working fast on 6G.

British writer wins Booker for space story Orbital

Judges of the prize, now in its 55th year, praised her writing for the "intensity of attention to the precious and precarious world". Past winners of the prestigious Booker, which is open to works

EU slaps Meta with nearly 800 million euro fine for engaging in 'abusive' Marketplace practices

uropean Union regulators have slapped Facebook's parent company, Meta, with a fine of nearly 800 million euros for what they have described as "abusive practices" related to its Marketplace online classified ads business.

The European Commission, the EU's executive arm and chief antitrust watchdog, imposed a penalty of 797.72 million euros (approximately \$841 million) following a long-running investigation. The Commission found that Meta had abused its dominant market position and engaged in anti-competitive behavior.

Brussels accused Meta of distorting competition by linking its Marketplace service to its social media platform, Facebook, automatically exposing users to Marketplace "whether they want it or not," while blocking competitors from reaching Facebook's

The Commission also raised



concerns about Meta's terms of service, which, they argued, allowed the company to use ad-related data from its rivalsadvertisers on Facebook and Instagram—to benefit its Marketplace business unfairly.

In response, Meta issued a statement rejecting the ruling, arguing that the decision fails to demonstrate any "competitive harm" to rivals or consumers. The company also claimed that the decision overlooks the "thriving European market for online classified listing services" and vowed to appeal the fine.
