Light Snowfall Expected Till Sunday: MeT

Srinagar: With the Srinagar, the summer capital of Jammu and Kashmir, recording the coldest night of season, a feeble Western Disturbance (WD) is set to affect the Union Territory from tomorrow, which may result in light snowfall over the higher reaches and also the rain showers in the plains till November 24.

The night temperature improved at multiple places, but the coldest night of the season at minus 1.2 degree Celsius was recorded in Srinagar in the intervening night of Thursday-Friday.

As per the details, several areas across Kashmir recorded the sub-zero temperatures for the third consecutive night.
The details reveal that

Qazigund, a gateway of Kashmir, recorded a low of minus 1.4 degrees Celsius, while Pahalgam recorded the coldest temperature in the Valley at minus 2.3 degrees Celsius.

Gulmarg, a famous skiresort, recorded a low of minus 0.6 degree while Kupwara recorded minus 0.8 degree in the intervening night of Thursday-Friday.

Meanwhile, a weak Western Disturbance would affect Jammu and Kashmir from tomorrow and under its influence light snowfall and rains are expected at isolated places of the Union Territory.

J&K's New Reservation Policy **Sparks Political Firestorm**

Will Sit Outside CM's Residence If Policy Not Reviewed By Dec 22: Ruhullah

Srinagar: The new reservation policy in Jammu and Kashmir has triggered a heated political debate, with opposition parties criticizing the policy and demanding its limitation to 50%. The policy, introduced after the region's reorganization, includes reservations for Other Backward Classes (OBC) for the first time and grants Scheduled Tribe (ST) status to hill and other tribal communities. Notably, the new framework

expanded reservations from 43% to nearly 60%, reducing opportunities for the general category to 40%.

The final turnout in the Maharashtra Assembly polls, held on November 20, was 66.05 per cent, up from 61.1 per cent in 2019, election officials said.

Defaced Currency Notes In J&K

SC Grants Centre Last Opportunity To File Response

New Delhi: The Supreme Court on Friday granted a last opportunity to the Centre to file its response on a PIL seeking CBI probe into the RBI exchanging defaced currency notes worth Rs 30 crore allegedly belong-

ing to a Kashmiri separatist group. While noting enough time had been given to the Union of India to file its reply, a bench of Justices Surya Kant and Ujjal Bhuyan granted four more weeks "in

the interest of justice". The top court was hearing a PIL filed by one Satish Bhardwaj, who alleged in 2013 the Jammu branch of RBI exchanged the currency notes amounting to Rs 30 crore allegedly belonging to a separatist group called "Kashmir Graffitti".

Bhardwaj's plea said, "The act of the Jammu branch of Reserve Bank of India to exchange the defaced/ imperfect Indian currency notes worth Rs 30 crore

-- that too done by a separatist group of Kashmir with the main aim of destabilising peace and harmony in the region of Jammu

and Kashmir and to create an environment of tension and terror in the minds of common residents of the region -- is illegal and worth the interference of this court." | More on P6

Will US Charges Against Adani Lead to **Arrest Warrants, Extradition?**

New York: With the US filing civil and criminal charges against billionaire Gautam Adani and seven others over a multi-million-dollar bribery scheme, a prominent attorney here has said that the case could escalate significantly, potentially leading to arrest warrants and even extradition attempts.

Adani, India's second-richest man, and seven others, including his nephew Sagar Adani, have been charged by the US Department of Justice with paying bribes to unidentified officials of state governments in Andhra Pradesh and Odisha to buy expensive solar power, potentially earning more than US\$ 2 billion in profit over 20 years.



Adani Group, however, denied the charges saying the allegations by US prosecutors are "baseless" and the conglomerate is "compliant with all laws".

"US Attorney Breon Peace has the right to get arrest warrants issued against Adani

and seven others indicted and serve them on the nations where they reside," Indian-American attorney Ravi Batra told PTI on Thursday. He further said, "If that nation, as India does, has an ex-

tradition treaty then according to the bilateral contract between sovereign nations, the resident nation must turn over the person extradited by the United States. There is a process that the resident nation must comply with, consistent with its laws." Batra noted that ultimately, extradition occurs "absent the rarest of circumstances", as in the case of former Chilean president Augusto Pinochet. Al Predicts Mood Swings, Detects Bipolar Episodes Through Sleep Patterns

esearchers have developed an AIbased tool that can predict episodes of mood disorder in patients using only sleep-wake data recorded by wearable devices such as smartwatches. People suffering from mood disorders, including bipolar disorder, experience long periods of sadness, depression, joy or mania. Mood disorders are closely linked with sleep-wake rhythms with disturbances potentially triggering a mood episode. The team of researchers, including from the In-stitute for Basic Science in South Korea, said the growing popularity of wearable devices has made collecting health data much easier.

"By developing a model that predicts mood episodes based solely on sleep-wake pattern data, we have reduced the cost



of data collection and significantly improved clinical applicability.

"This study offers new possibilities for cost-effective diagnosis and treatment of mood disorder patients," lead researcher Kim Jae Kyoung said. For the study, published in the journal 'npj Digital

Medicine', the researchers analysed 429 days' worth of data from 168 mood disorder patients. Thirty-six sleep-wake, or circadian, rhythms were extracted, which were used for training machine learning algorithms.

A form of artificial intelligence (AI), a machine learning algorithm learns to detect patterns in the data it is trained on to make predictions about the future.

The AI model that the team developed was thus able to predict depressive, manic, and hypomanic episodes with an accuracy of 80 per cent, 98 per cent and 95 per cent, respectively.

mathematical modelling to longitudinal data from 168 patients, we derived 36 sleep and circadian rhythm features. These features enabled accurate next-day predictions for depressive, manic, and hypomanic episodes," the authors wrote.

The researchers found that daily changes in circadian rhythms are a key predictor of mood episodes.

Specifically, delayed circadian rhythms, falling asleep and waking up later in the day, increase the risk of depressive episodes. On the other hand, advanced circadian rhythms -- sleeping and waking up earlier in the day, increase the risk of manic episodes, the researchers said.

"Notably, daily circadian phase shifts were the most significant predictors: delays linked to depressive episodes and advances to manic episodes." the authors of the study added.

IIT-Indore Develops Technology To Enhance Safety Of ECG Machines, Pacemakers; Gets Patent

The Indian Institute of Technology (IIT) Indore has developed a technology to enhance the safety of electrocardiogram (ECG) machines and pacemakers used in the treatment of heart diseases, an official said on Wednesday.


This technology, developed under the leadership of Prof Anirban Sengupta of IIT-Indore, has been granted a patent by the country's patent office. According to the official, the new technology developed by the IIT-Indore team was designed to create safe and secure chips for these ECG devices and pacemakers. It includes a crucial feature that distinguishes between genuine and counterfeit ECG detector chips before they are manu-

factured or integrated into devices. This capability is vital for ensuring the reliability of ECG devices and cardiac pacemakers, minimising the risks of misdiagnosis and errors that can lead to inadequate treatment. Currently, many ECG devices and pacemakers encounter reliability challenges, which can sometimes lead to errors in medi-

cal diagnoses that may go unno-ticed, potentially affecting patient outcomes.

"This technology not only secures chips used in devices

but also guarantees that these devices contain authentic chips marked with a unique fingerprint hallmark,"

When Will Kashmir University Students Union Elections Happen?

tudent politics forms an essential part of university life. It is important for honing leadership, advocacy, and democratic engagement skills among students. Across the globe and nationally also, student unions have played a pivotal role in shaping leaders. Many of India's best leaders are products of campus politics.

Prominent figures like Subhas Chandra Bose gained recognition as a dynamic student leader during his time at Presidency College, from which he was expelled for his role in a student strike. Jayaprakash Narayan, who later spearheaded the anti-Emergency movement, was actively involved in student activism during his college days in the United States and later in India. Leaders like Chandrashekhar, who became India's Prime Minister, also began as a fiery student leader during the JP Movement. Similarly, many contemporary Indian politicians, such as Arun Jaitley and Nitish Kumar, started their political journeys through student unions, particularly during the Emergency period of the 1970s. These leaders typify how student activism has often served as a springboard for significant roles in Indian politics.

Through participation in student politics, young minds learn to address injustices. It equips them to engage in societal dynamics, and uphold the rule of law. It trains students with practical experience in public speaking, representation, and community building,

while instilling a deeper sense of responsibility.

However, at Kashmir University, students are bereft of such benisons of campus life. Students face a glaring void of an official student union. This absence not only stifles student voices but also curtails oppor-

tunities for meaningful participation in campus life.

A History of Student Politics in Kashmir

Student politics in Kashmir, particularly at Kashmir University, has had a chequered past. The Kashmir University Students Union (KUSU), established in 2007 after significant efforts, was a critical platform for student engagement. However, in the wake of the 2008 unrest, the state tightened its grip on political activities, leading to the closure of KUSU's office in 2009 and its demolition in 2010.

Interestingly, in response to an RTI query in 2017, Kashmir University admitted that no formal ban or circular had ever been issued against KUSU. Yet, soon after, the administration released an order explicitly barring political and religious discussions on campus, cementing the unofficial ban on student union activities.

This ban has suppressed a vital platform for students to voice concerns and contribute to a vibrant campus culture. While student politics in Kashmir might historically have faced ups and downs, outright prohibition undermines the democratic values universities are meant to uphold.

Why Campus Politics Matters

Universities are not merely academic institutions; they are microcosms of society where students encounter diverse perspectives and ideas. Student politics offers a space for students to engage with these differences. These roles prepare students for future challenges. It instils values of negotiation, teamwork, and conflict resolution.

Dwight D. Eisenhower (the 34th US President) once said, "Politics ought to be the part-time profession of every citizen who would protect the rights and privileges of free people and who would preserve what is good and fruitful in our national heritage".

In functioning student unions, leaders take up critical issues that students face at the campus. By acting as a bridge between students and the administration, campus politics ensures that the voices of the student community are heard and acted upon. Without a union, students often feel disconnected, unable to voice grievances or seek redress effectively.

Campus politics is vital in addressing student issues, creating a platform for collective advocacy and problem-solving. For instance, in 2019, students at Jawaharlal Nehru University (JNU) in India protested against a proposed fee hike, leading the administration to roll back several charges after intense negotiations. Similarly, in 2022, student representatives at Delhi University campaigned for better hostel facilities, prompting the university to allocate funds for renovations. These examples show how campus politics directly impacts the quality of student life by addressing pressing concerns like affordability and infrastructure.

Moreover, a vibrant democracy relies on informed citizens who value dialogue and dissent. Student unions nurture these qualities, offering a safe space for debate and discussion. Through campus politics, students learn to appreciate differing perspectives, engage respectfully with opposing views, and develop nuanced understandings of ideologies.

The lack of a student union at Kashmir University represents a missed opportunity to instill these values. Suppressing student voices risks creating apathy and disengagement. Encouraging student politics does not mean endorsing chaos; it means fostering a platform where students can express themselves responsibly and negotiate disagreements.

Addressing Concerns Around Campus Politics

Many people often point to the disruptions caused by student politics, such as ideological clashes, law and order problems or confrontations with administration. While these concerns are valid, they do not warrant a blanket ban on student unions. Instead, they underscore the need for structured and constructive engagement.

Kashmir University can establish guidelines to ensure that student politics remains confined to purely student issues and doesn't drag in unrelated political issues unnecessarily. The university should turn student politics into a positive force, empowering students to contribute meaningfully to campus life.

The Case for Reinstating KUSU

Reinstating the Kashmir University Students Union would have far-reaching benefits. Beyond empowering students to actively participate in campus life, it would strengthen the region's democratic culture. A student union could become a model for responsible activism, demonstrating how young people can channel their energies toward constructive advocacy.

Omar Abdullah, the Chief Minister of Jammu and Kashmir, has consistently championed elections as the bedrock of democracy, particularly since 2019 when assembly elections were delayed. He has argued passionately for the democratic rights of the people of J&K. Now that he is in office and assembly elections have been held, the same principles should apply to campus politics.

There is no justification for maintaining an unofficial ban on student unions at Kashmir University. The arguments that advocate for the importance of assembly elections are equally valid for student elections. It is time for Abdullah to direct university authorities to reinstate the Kashmir University Students Union.

Conclusion

The reinstatement of the Kashmir University Students Union is not merely a call for a student body—it is a call for a democratic, inclusive, and engaged campus environment. Student politics is integral to university life. It prepares young minds for leadership while fostering values of dialogue, diversity, and dissent.

Kashmir University has the opportunity to nurture these ideals by allowing students to organize and advocate within a democratic framework. By doing so, it can inspire a generation of leaders committed to creating a better society. Now is the time to reinstate KUSU and reimagine campus politics as a force for positive change.

Is AI Ignoring Consent And Harming Users?

rtificial intelligence (AI) is reshaping our digital world, unlocking opportunities while sparking ethical debates. As forms collect data under the guise of "informed" consent, they draw lucrative inferences about our attitudes and behaviours, often without our full understanding. This information asymmetry between users and firms raises questions about the ethics of data hoarding. Furthermore, clever design elements nudge us into sharing more than we realise, leaving us vulnerable to exploitation. The complexities of these issues urge us to take a closer look at the balance between innovation and ethical responsibility.

Is consent really "informed" if users don't know the extent of the inferences drawn by firms? Within AI and digital markets, informed consent is a prerequisite between users and firms that allows firms to extract user data in exchange for the digital service, which is often free, resulting in a non-price transaction with data as currency. Two aspects of legal consent are unique to digital markets: (a) whether users are adequately informed about the amount of their data that firms will collect (if there exists low awareness, the contract is imperfect, and the value derived by one party is greater than the other, resulting in user exploitation); and (b) whether users are informed of the breadth and depth of inferences drawn by digital firms about their users using their data. In (b), if users are unaware that their data will be used outside of the purposes of firms' immediate service, perhaps to gain a competitive advantage in an adjacent market, serious consumer welfare and competition concerns arise. For instance, Netflix has leveraged users' viewing data to enhance the development of Netflix-produced

content. This practice challenges the foundational ethics of data use, as users inadvertently contribute to other markets.

Why are people who are concerned about the privacy of their data doing little to actually protect their privacy? Surveys show that people do not fully comprehend key concepts described in privacy policies. Moreover, they report feeling coerced by online platforms into accepting these policies (Bashir et al., 2015). Users do not know enough about what they consent to when using digital services, which goes against major international regulations calling upon digital firms to make it easier for users to make informed decisions. As of 2021, 137 out of 194

that may not align with their best interests. For example, Facebook and Instagram offer users various privacy settings and controls, giving them the perception of having control over their data. However, these settings may be complex and difficult to navigate, leading users to default to the platform's preselected options, which favour data collection and sharing. Moreover, platforms utilise behavioural science techniques to nudge users towards actions that benefit the platform's bottom line. One such technique is confirm-shaming, where users are subtly coerced into accepting data collection policies by framing privacy-conscious choices as inconvenient or socially undesirable.

countries had enforced data protection and privacy legislation (UNCTAD, 2021). By creating informational asymmetry and undermining informed consent, digital firms may be not compliant with most of these countries' regulations.

Navigating these ethical complexities necessitates a pivot not just towards prioritising consumer welfare but redefining it. Upholding user welfare should mean securing consent and ensuring user data isn't exploited for undisclosed, intricate inferences. It involves safeguarding the integrity of user choice and curbing persistent nudges towards profit-driven objectives that distort genuine user experiences. Policy initiatives like the European Union's AI Act and GDPR have set commendable benchmarks in protecting privacy and user data control. The GDPR grants individuals greater control over personal data, requires explicit consent before collecting and using their data, and imposes strict data security measures. However, the ethical

challenges posed by inferred preferences and choice architectures demand a broader conversation.

India has taken steps to safeguard digital consumer welfare with the Digital Personal Data Protection (DPDP) Act, 2023, and the Digital Competition Bill (DCB). The DPDP Act mandates that consent must be free, informed, specific, and clear by enforcing stricter transparency requirements. Similar to the GDPR, it attempts to reduce information asymmetry over data usage between users and firms. The DCB could promote fair competition while addressing monopolistic behaviour like rentseeking and data hoarding. Both legislations emphasise accountability and transparency from digital firms about their data practices and competitive behaviours. If the DCB is enacted, in conjunction with the DPDP Act, they can foster a more ethical AI ecosystem in India by empowering users with better control over their personal information.

Regulatory agencies like the Competition Commission of India are crucial in enforcing these laws and holding firms accountable for violations. Safeguarding digital consumers requires a multi-faceted approach encompassing legal, regulatory, and enforcement measures.

AI systems delving beyond explicit user consent should mandatorily disclose and seek consent for these extended uses. Simultaneously, crafting digital frameworks that prioritise user autonomy over commercial gains holds significance. Ethical AI development demands user-centric designs that respect users' original objectives, nurturing genuine interactions devoid of coercive nudges towards profit-oriented goals.

Preservation of Kashmiri Shawls

Valued for its warmth, light weight and characteristic buta design, the Kashmir shawl trade inspired the global cashmere industry. The shawl evolved into its high-grade, sartorial use in the 13th century and was used in the 16th century by Mughal and Iranian emperors, both personally and for honouring members of their durbar.

The production of Kashmiri shawls was greatly influenced by the Mughal and Persian cultures that flourished in the region during the 14th and 15th centuries. The Mughals, who were great patrons of the arts, encouraged the production of high-quality textiles, including Kashmiri shawls.

The Persian influence on the design and embroidery techniques of Kashmiri shawls can be seen in the intricate floral and paisley motifs, as well as the use of rich colours and gold thread. The influence of Mughal and Persian culture on Kashmiri shawls is still evident in the designs and patterns used by weavers and embroiderers today.

About Kashmiri shawls it is said "Of all Indian textiles none excels in beauty, colour, texture and design as the famous Kashmir Shawl". Shawls are produced by two techniques, loom woven or kani shawls and the needle embroidered or sozni shawls.

The basic fabric is of the three types - Shah Tush, Pashmina and Raffal. Shah Tush (King of wool) comes from a rare Tibetan antelope living at a height of over 14000 ft in the wilds of the Himalayas. Pashmina is known world over as cashmere wool, it comes from a special goat (Capra hircus) living at an altitude of 12000 to 14000 ft reared by shephered nomads around famous pongkong lake in close vicinity of western Tibet. Raffal is spun out of marino wool tops and is a popular type of shawl.

The shawls are embroidered in floral motifs, various designs available range from Neemdoor, Doordaar, Paladaar, Baildaar, Jaalis and Jammas, with the help of needle. Where as Kani shawls are woven on looms with the help of kanis. Kanis are small eyeless bobbins used instead of the shuttle.

In earlier times, shawls were used as a warm protective gar-

ment against cold weather. By the 13th century, Kashmir shawls had risen in status and quality and were commonly used as fashion statements. Shawls were marketed towards the ruling elite and foreign markets.

Technically the shawl as a garment and as a word comes from 14th century Persia. They were woven rectangles worn over the shoulders and made from kashmiri goat. That's significant I think because Kashmir was a major trade center.

All these early shawls were woven. They were made in whatever fiber was on hand; silk in the east, cashmere in the near east, wool in the New World. They were square or rectangular in shape and usually large enough to wrap and fold around the body.

Decorative lace shawls seem to have come into fashion in the

early 1800's. The earliest styles were made on tambour or other netting with intricate designed stitched/embroidered on that base fabric. This seems to be when shawls became circular and triangular.

Film Review

Wicked: A Movie Done Right

The journey from successful stage musical to big-screen adaptation is rarely truly successful. From director Joshua Logan's use of coloured filters in the 1950s adaptation of South Pacific (which looks as if something is wrong) to Tom Hooper's recent mega-mess movie of Cats, there are so many pitfalls to avoid.

The suspension of disbelief we willingly embrace in live performance is disrupted by the naturalism of cinema so that the aggressive ballet of the West Side Story gangs looks prissy and tame when filmed on the realistically gritty streets of New York. Similarly, Nathan Lane's Max Bailystock was hilarious onstage in The Producers, but translates to the film as monstrous over-acting.

Like these musicals, Wicked has proven a remarkable success onstage and is the second highest-grossing musical in the history of New York's Broadway (after The Lion King). Now it arrives on-screen in two parts; the first released this year and the second in 2025. Eyebrows have been raised at the 2 hour 40 minute running time for a movie that covers act one of the musical, which is 90 minutes onstage.

Inspired by figures like Saddam Hussein, Wicked began life in 1995 as a novel by Gregory Maguire who, drawing on L. Frank Baum's 1900 novel The Wonderful Wizard of Oz, wanted to explore how certain figures became demonised in society.

ety.
Set in the years before Dorothy crash lands in Oz, the story shows the Wicked Witch to not be evil; she is, in fact, good, becoming radicalised by the broken politics of Oz.

The novel was bought almost immediately by Demi Moore and Universal Studios who struggled to develop a screenplay until composer Stephen Schwartz suggested it became a stage musical.

Working with author Winnie Holzman, they created a female-centric story that jettisoned much of Maguire's politics to concentrate on the "frenemy" relationship between "pretty in pink" Glinda and the greenskinned outsider, Elphaba.

Director John M Chu's movie takes Wicked back to its political roots. In a time when populist leaders are on the rise, it arrives as a warning of the dangers of modern fascism.

In particular, it expands the storyline of Oz's speaking animals who lose their voices. Unlike onstage, these animals are CGI characters in fully animal form and Chu captures how societies are stunned into silence by outrageous political actions. In doing so, he emphasises the unthinking unkindness of the herd mentality. He also makes the film a paean to the power of goodwill.



Set mostly during the Wicked Witch's schooling years, Shiz University is also more fleshed out. In this section, the movie is in danger of losing its narrative thrust. However, just as we begin to feel trapped in the love child of Mean Girls and Harry Potter, we are whizzed off to the Emerald City.

Here Maguire's backstory to the Grimmerie, the Ozian book of spells, is now musicalized in a new sequence featuring the original stage stars Idina Menzel and Kristin Chenoweth, and topped by a cameo from Stephen Schwartz. Once in the City, Jeff Goldblum's Wizard proves a

scheming huckster too aware of his own limitations

One of the classic pitfalls of the movie musical is in casting. From Lucille Ball in Mame to Russell Crowe in Les Misérables, missteps here can prove fatal. Thankfully, Wicked is expertly cast.

Ariana Grande captures the over-dramatising spoilt brat Galinda (to become Glinda the Good Witch), with precision vocals. Jonathan Bailey has a ball with the athletic, knowingly objectified heartthrob Fieryo, cementing his place as a leading man. Michelle Yeoh and Jeff Goldblum bring sinister gravitas and

reasonable vocals to their respective roles.

However, the casting masterstroke is Cynthia Erivo as Elphaba who brings the quiet dignity to the role that she first revealed onstage in The Color Purple. As a queer black woman, for her, Elphaba's story is one of pride, this is a woman who refuses to be ashamed of who she is and is determined to fulfill her potential.

mined to fulfil her potential.

She has a distinctive singing voice and the confidence to erase memories of Menzel's stylings. Film also brings dimensions to Erivo's talent. The use of close-ups allows an inti-

macy in her relationships that is impossible in a live setting. She is also able to show her ability to convey the pain she is suffering in

a simple glance.

The film is a remarkable feat of 2D and 3D design and there are a dazzling array of quotes to other cinematic renderings of the Oz legends, all of which are delivered with a contemporary sensibility. This is a mechanically driven Oz, full of cogs and wheels, which reference the stage design of Wicked and includes a stylish train.

The costume designs reference both the stage show and the all-black disco musical The Wiz (1978). While the memories of the iconic Judy Garland's 1939 movie are prompted every few minutes. In one scene, for instance, Elphaba transports a (cowardly) lion cub in a bicycle basket reminiscent of Toto's dog-napping.

MGM changed Baum's silver slippers to ruby (and the Wicked Witch's skin to green) to showcase the newly developed Technicolor process. In this film they remain silver but are first presented in a ruby-encrusted box. There's also nods to Baum's original. Notably, the strangeness of the book's Oz is more accurately captured than in any other cinematic version.

The best musical theatre is like experiencing a series of highwire acts in which the performers must flawlessly execute choreography, act convincingly and hit the highnotes eight times a week. Musical films, which can be re-shot and overdubbed, necessarily lack this sense of danger.

If at times Wicked struggles to capture the sheer energy of the stage, it reimagines the work in a spectacular, but also thoughtful fashion, deepening serious themes and emotional connection. I will be back to see it and will undoubtedly see the four-plus hours in one sitting once part two is released next autumn. I only wish Judy Garland could see it.

Fear Grips Pakistan's Kurram District As 50 Killed In Cold Blood

Fear gripped Parachinar: Pakistan's northwestern Kurram district on Friday as the death toll from two terror attacks rose to 50, with authorities imposing a curfew and suspending mobile phone services in the remote mountainous region.

Terrorists suspected to be members of Daesh opened fire on vehicles carrying members of Shia Muslim community on Thursday in one of the region's deadliest such attacks in recent years.

The vehicles were traveling in a convoy from Parachinar to Peshawar, the capital of Khyber Pakhtunkhwa when gunmen opened fire, the officials said. The vehicles were ambushed in

cal journalist said. Local media reports say that there were over 200 vehicles in the convoy. Rescue authorities said 50 peo-

ple, including eight women and five children were killed in the attack. One report said terrorists checked identity cards of the victims before shooting them.

The assault took place in Kurram, a Shia dominated district in Sunni majority Khyber Pakhtunkhwa province. Kurram has been under relentless attacks by hardline militants for years.

"Total 42 people have been killed and 19 others are injured in the attack," Deputy Commissioner Kurram, Javaid Ullah Mehsud, said on Friday, saying police were yet to file a

report on the incident.

No one immediately claimed responsibility for the latest attack. which came a week after authorities reopened a key highway in the region that had been closed for weeks following deadly clashes.

However according to Iftikhar Firdos, a local journalist and analyst, an Islamic State cell active in the region (known as ISKP, which stands for Islamic State Khorasan Province) 'has been trying to exert influence in the area for some time by targeting the Shia population and fomenting sectarian violence'.

A senior administration official told the AFP news agency the situation was "extremely tense" with locals staging a sit-in in Parachinar,

"A curfew has been imposed on the main road connecting Upper and Lower Kurram, and the bazaar remains completely closed, with all traffic suspended," the official said.

Shop owners in Parachinar had announced a strike on Friday to protest the attack.

Locals described an atmosphere of fear across the district.

The night was spent in tension," said local youth activist Irfanullah Khan. "People in different villages were guarding their homes ... The region is in grief as the situation is tense. Anything can happen."

Successive governments both in Islamabad and KPK have been accused of not taking any action

against the terrorists except issuing mere statements.

According to Amelia Gill, a human rights activist based in the UK, 'the main cause of these incidents is hate speech that can incite mob violence and religious extremism'.

The activist also accused the state of being absent in some regions of the country: 'What is the state doing, why is it not dealing with these monsters? In fact, the silence of the state is the main reason for all these unpleasant incidents. The citizens of KP and Baluchistan live their lives like hell because the state has failed to control the situation. My question is: is Pakistan a place where innocent citizens can live freely? When will the state protect its

Baqir Haideri, a local Shia leader, denounced the assault and accused local authorities of not providing adequate security for the convoy of more than 100 vehicles despite fears of possible attacks by terrorists.

Wahdat-i-Muslimeen Mailis (MWM) announced nationwide protests and a mourning period against

the attack on unarmed civilians. Addressing a press conference at the National Press Club in Islamabad, Syed Nasir Abbas Shirazi and other party leaders criticised the provincial and federal governments for failing to protect civilians. He particularly criticised Chief Minister Gandapur, federal Minister of Interior Mohsin Naqvi and the inefficiency of security institutions.

"More than 50 people have been martyred. We condemn the criminal silence of the interior minister," he added. "The rulers want to run this country at the cost of our blood."

"This is not a Shia-Sunni problem. The responsibility for the blood of these innocent passengers lies with law enforcement agencies," he said. Prime Minister Shehbaz Sharif and President Asif Ali Zardari condemned the attack, and Sharif said those behind the killing of innocent civilians will not go unpunished. Interior Minister Mohsin Naqvi called the shootings a "terrorist attack".

Shia Muslims make up about 20 percent of the 240 million population of Sunni-majority Pakistan.

Lost Homes, Shattered

where will we go in these tents? How will we survive these harsh nights?"

In another tent, Afrooza sits with her two young daughters. Her husband, Bilal Ahmad, who suffers from kidney failure, had painstakingly raised Rs 26 lakh through social media for his treatment. That, too, was lost to the flames.

"I had withdrawn the amount and kept it at home to pay for my next medical procedure," said Bilal, "The doctor in Chandigarh refused online payments, citing tax deductions, and insisted on cash. I had no choice but to withdraw the money, and now it's all gone."

His wife, Afrooza, adds tearfully, "We still need Rs 40 lakh for his treatment, but now not only is his treatment uncertain, we also have no roof over our heads. I urge people to help my husband-his life depends on it."

The plight of these families mirrors the experience of many across Kashmir, where fires—especially during winters-turn cherished homes into smoldering ruins. Abi Gurpura is just the latest in a long list of neighborhoods to fall victim to fire incidents in the region.

From January to July 2024, Srinagar alone witnessed over 115 structures going up in flames, according to data from the Fire and Emergency Department. These included 76 residential homes, 12 commercial buildings, and several hotels.

Every few days, news of a fire emerges from different areas of Kashmir. In October this year, nearly the entire village of Mulwarwan, comprising 100 houses, was reduced to ashes in a devastating fire.

It was on October 14 when fire engulfed the entire Mul Warwan village and raised everything to the ground, outer circle at a distance.

People could do nothing but to save their lives by running for safety and whatever they had saved to spend the winters was burnt in the devastating blaze.

On the fateful day, most of the people were out for work and women folk and elders were in their homes when the fire engulfed the village. People were able to react immediately and left the area to save lives.

As most of the houses were made of wood, it didn't take much time for the fire to raze everything to the ground.

People were left helpless to douse the fire as there were no fire tenders available in the entire region. Even tap water wasn't also available due to the absence of pipes which the Jal Shakti department hasn't provided to the

"Had there been fire tenders or water available through pipes, people would have been able to save something. They were looking towards their houses being razed to the ground with helpless eyes and all their belongings vanished within no time," said Sheikh Zafarullah, District Development Council member from Marwah.

"Whatever we had stocked up for winter was lost in the fire. We have nothing left now. Yes, relief is coming in, but without proper shelter, where will we go in this harsh winter?" a fire victim from the village had said.

Similarly, on September 9, a fire incident damaged three residential houses in Srinagar's Noorbagh area. At least three residential houses were damaged in an early morning blaze at Noorbagh area of Srinagar city.

This isn't just about statistics it's about lives upended overnight. Families lose not only their homes but also their sense of security, financial stability, and cherished memories. While government relief and NGO interventions provide some solace, the larger question remains: is it enough to rebuild lives after such devastating losses?

The impact of losing one's home to fire goes far beyond physical displacement. For families like Raja Begum's, it means starting over from scratch, often with little or no resources. The winter season amplifies the struggle, as temporary shelters fail to provide adequate protection against sub-zero

Families often face psychological trauma from the loss of their homes and belongings.Research indicates that most survivors endure life-threatening situations during these disasters, resulting in a heightened prevalence of conditions like depression and post-traumatic stress disorder (PTSD) in the aftermath.

According to the American Psychological Association, losing your home in a fire involves not only the loss of your residence, but also many other things of value such as photo albums, important documents, and treasured objects. "Most importantly, though, the home is your place of security, comfort, and safety. After a fire, this sense of security can also be lost and can significantly disrupt the normality of daily life."

Why Have Fires Become So Common In Kashmir?

Experts point to several factors contributing to the high incidence of fires in Kashmir. According to Aqib Hussain Mir, Deputy Director Fire & Emergency Services, traditional wooden structures, the absence of proper firefighting infrastructure, and narrow access roads in congested neighborhoods contribute to damages during these incidents

Speaking to Kashmir Observer, Mir said there is a spike in fire incidents due to the excessive use of heating gadgets negligently.

He explained that gas-operated heating devices, in particular, are prone to fire outbreaks due to gas leakage, which can lead to the accumulation of flammable charges.

Rapid urban growth has outpaced the implementation of fire safety measures, leaving many neighborhoods vulnerable. Mir emphasized that the construction style of residential buildings exacerbates the situation.

"Although concrete is used in conruction, aesthetic additions such as wall panelings, khatam band ceilings, and wooden trusses can act as accelerants. When a heating gadget catches fire, these materials help spread it rapidly," he said.

He also pointed out instances of negligence, like leaving traditional wood-burning stoves (bukharis) unattended, as a common reason behind many fire mishaps.

A Call for Better Preparedness

As Kashmir urbanizes, the region urgently needs to adopt modern fire safety measures. Experts stress the importance of enforcing the National Building Code of India, which recommends fire gaps between structures, improved life safety systems, and fire protection protocols.

Mir also urged homeowners to take precautions. "Avoid keeping gas cylinders inside homes, ensure proper ventilation, and never leave bukharis unattended. These small steps can prevent significant losses.'

For families like in Abi Gurpura, however, these precautions come too late. As the winter chill intensifies, their focus remains on survival. Temporary shelters offer little respite from the biting cold, and the promise of long-term rehabilitation feels like a distant dream.

In a region where fire incidents claim hundreds of homes every year, the need for proactive measures is more urgent than ever. Until then, for families like Raja Begum's, life in Kashmir's fiery winters will remain a tale of survival amidst ashes.

We have witnessed such incidents in the past where people have been called to police camps and they have lost their precious lives to torture," Abdullah said.

The incident involving the alleged beating of the five civilians has revived memories of a tragic event in which three youths lost their lives after enduring brutal torture in the Poonch area last year.

Mehbooba Mufti, president of the Peoples Democratic Party (PDP), reiterated the call for swift action against the Army personnel implicated in the alleged ill-treatment.
"The allegations of severe torture

from Kishtwar remind us of earlier incidents this year in Bafliaz Surankote," she stated on social media.

Mufti identified four of the victims as Sajad Ahmad, Abdul Kabir, Mushtaq Ahmad and Mehraj-ud-Din, claiming that they were summoned to the Army camp for questioning and subjected to extreme physical violence.

She highlighted their dire condition. stating that they had to be carried to a hospital due to their injuries.

In a statement, Mufti urged the Union territory government to conduct an impartial investigation and hold those responsible accountable, emphasising the necessity of protect-

ing civilian safety and dignity. She also called for civil society's involvement in monitoring the situation

to ensure justice is served. Apni Party leader Altaf Bukhari echoed the concerns, describing the reports of brutal torture as deeply troubling and demanding a thorough investigation and severe punishment for those responsible.

J&K's New Reservation

MLA Waheed ur Rehman Para has also called for a practical and equitable policy, stating, "Opportunities for general category people are shrinking. Reservation should be based on population ratio."

The controversy intensified with news of recruitment for 575 lecturer posts in the education department. Of these, only 238 are allocated to the general category, while the rest are distributed among various reserved categories, including SC, ST-1, ST-2, OBC, and others. The policy change has particularly impacted the Gujjar-Bakarwal community, now classified under ST-1, while hill tribes are categorized as ST-2. Measuring the scale of the policy's impact, Shah highlighted that 69% of Jammu and Kashmir's population falls under the general category, yet their opportunities are shrinking. The regions of Poonch and Rajouri, on the other hand, see a near-total reservation due to the concentration of SC, ST, OBC, and other reserved communities.

The government has urged patience as it works on resolving the matter. NC MP Aga Syed Ruhullah remains firm, stating, "If a decision isn't made by December 22, I will sit on a dharna." Meanwhile. PDP and other parties are pressing for an equitable approach warning of the implications for equality and social harmony.

KPDCL Raises Alarm On Spike In DT Damage Rate

SRINAGAR: Kashmir Power Distribution Corporation Limited (KPDCL), Friday again issued a fervent appeal to its consumers to use electricity judiciously so that locality Distribution Transformers (DTs) are protected from damage and subsequent power outages.

As many as 49 DTs were damaged across Kashmir valley on November 21 alone, indicating a steep rise in unsanctioned heating load across all Divisions of Kashmir valley.

Expressing serious concern over increase in DT damage rate early in winter, a KPDCL spokesperson advised domestic consumers to strictly adhere to their sanctioned load and avoid using crude heaters and boilers, which have been banned by the Government. "While 49 DTs were reported damaged on November 21, 32 were damaged on November 20, 37 on November 19 and 40 on November 18," he added.

The spokesman, however, clarified that KPDCL's Central Workshop at Pampore and Divisional Workshops are operating in double shifts to reclaim the Buffer Stock by repairing the damaged DTs. "Against 158 DTs damaged across Kashmir valley over the last 4 days, 143 were also repaired and restored during the same period," he stated.

Attributing rising DT damage rate and power outages to rampant use of crude heaters/ boilers and illegal hooking on bare conductor in metered areas, the spokesperson stated that KPDCL has intensified its inspection and disconnection drives across all Electric Divisions of Kashmir valley to curb power theft.

"As many as 1484 inspection drives were conducted across all 18 Electric Divisions by KPDCL on November 21, during which 1396 domestic and 514 commercial installations were disconnected for unauthorised use of power," he said, adding the inspection drives will be further accelerated on daily basis in all districts of Kashmir Division.

Anticipating DT damage in peak winter months, KPDCL has maintained a buffer stock of 1554 DTs. "We have also kept a reserve stock of DTs to meet any eventuality on account of higher DT damage," he said, adding Buffer Stock was pegged at 1412 last year.

Reiterating KPDCL's commitment to replace the damaged DT within the stipulated timelines, the spokesman, however, clarified that repeat damage of DT by increase in unsanctioned load shall attract longer duration timelines, factoring in limited manpower available at Central Workshop Pampore and Divisional Workshops of KPDCL—(KNO)

Srinagar, Anantnag Lead In Rising Head & Neck Cancer Cases In Kashmir

SRINAGAR: Head and neck cancers are on the rise in Kashmir, with Srinagar and Anantnag districts showing the highest number of cases, according to experts.

The World Health Organization's Global Cancer Observatory (GLOBOCAN 2022) ranks head and neck squamous cell carcinoma (HNSCC) as the 7th most common cancer globally, mostly among men. In Kashmir, the incidence of these cancers has been steadily increasing over the past few decades, with thyroid cancer now ranking among the top ten cancers in the region.

Unlike other Indian states, where oral cavity cancers are more common, Kashmir has seen a shift. There is a growing number of thyroid and laryngeal cancers. However, according to experts, most of these cancers are preventable by avoiding modifiable risk factors, and if detected early, 90% of head and neck cancers can be cured.

Dr Aamir Yousuf, Head of the ENT & Head and Neck Surgery Department at GMC Anantnag

SKIMS Regional Cancer Centre found that Srinagar and Anantnag have the highest number of head and neck cancer cases in the region. He said that over five years, more than 400 cases were evaluated, diagnosed and managed at GMC Anantnag. "Of these, 65% were thyroid cancers, 17% were laryngeal and hypopharyngeal cancers, and 11% were salivary gland cancers. Other types of cancers included oral, oropharyngeal, nasopharyngeal and sinonasal cancers," he added.

The rising incidence of these cancers calls for increased awareness about the early symptoms and risk factors, Dr Yousuf said. The primary modifiable risk factors for head and neck cancers include tobacco and betel nut chewing, smoking, alcohol use and some occupational hazards such as chronic radiation exposure, he said, adding that other factors include chronic oral infections and nutritional deficiencies.

The doctor said that early warning signs of head and neck cancers can be subtle, and often go unnoticed until the disease has progressed. "The common early symptoms include continuous oral ulcers, swelling in the neck or mouth, difficulty swallowing or moving the jaw, white or red patches in the mouth or throat, voice changes, trouble breathing, nasal or ear bleeding and continuous pain in the back of the throat radiating to the ear," he said. "In elderly individuals, facial pain or weakness may also indicate the presence of head and neck cancers."

Preventing head and neck cancers is possible through lifestyle changes. Experts recommend avoiding tobacco and alcohol use, maintaining good oral hygiene and protecting oneself from prolonged sun exposure. A healthy diet and the use of protective gear when working with hazardous substances, such as fertilizers and pesticides, can further reduce the risk of these cancers.

Treatment for head and neck cancers requires a multi-disciplinary approach, involving surgery, radiation therapy, chemotherapy, targeted therapy, immunotherapy and rehabilitation, doctors said—(KNO)

'More CCTV Cameras To Be Installed Across NH Stretch In Kashmir'

Tral Residents Demand Long-Awaited Bridge Over Watal Ara Nallah

PULWAMA: Residents of various areas in Tral, a hamlet in south Kashmir's Pulwama district, have been urging authorities to construct a bridge over the Watal Ara Nallah near the Sub-District Hospital (SDH) Tral. They said the absence of a permanent bridge has caused hardships for locals, particularly during emergencies.

The residents said that every year makeshift arrangements are made, but these temporary bridges are washed away by floods or heavy rains, leading to ongoing difficulties for people trying to access essential services. They said the nallah serves as the shortest route for several villages to reach the town, making it a vital link for daily commuters.

"Every year, we see temporary bridges being constructed, but they get washed away with

each flood season. This has been going on for years, and people are suffering," said one local resident. "Elderly people, women and children find it especially difficult to cross the nallah, and it is becoming increasingly dangerous."

Abdul Hamid Ganie, an-

other local resident, said they face specific challenges in emergency situations. "During emergencies, it's nearly impossible to get across safely," he said. "The government should focus on building a permanent concrete bridge as a long-term solution instead of wasting resources on makeshift arrangements."

The residents said they have been raising the issue for the past 25 years, but despite numerous appeals to various authorities, no concrete steps have been taken to address the problem. "The government spends lakhs on other works,

but we are still waiting for a bridge here," said Khursheed Ahmad, another resident. "The makeshift bridges are extremely risky, and people from six villages have to take long detours to reach the hospital."

The residents have once again urged the government to prioritise the construction of the bridge so that they can finally have a reliable and safe crossing.

An official from the concerned department said that the government has recently approved the construction of a permanent bridge over the Watal Ara Nallah. "A 1×30 metre span steel bridge will be constructed on the Tral-Pinglish road near SDH, at an estimated cost of Rs 2.5 crore," the official said. "The construction work is expected to begin soon, and we are hopeful that this issue will be resolved once and for all."—(KNO)

Sony India Secures \$170M Asian Cricket Media Rights

Cony's opens new tab India unit said on Friday it had secured the media rights for all Asian Cricket Council (ACC) tournaments until 2031, which a source with direct knowledge of the matter put the value at \$170 million.

Disney and Reliance (RELI.NS), seen as frontrunners, did not bid for the rights, another source said on condition of anonymity.

The deal comes at a crucial time for the country's media industry, which is going through a consolidation phase after the \$8.5 billion merger of Reliance and Walt Disney's India media assets.

Earlier this year, India's antitrust body raised some concerns about the merged entity's grip over the broadcast of the world's most populous country's favourite sport, Reuters had reported.

The entity currently holds the rights to the matches of the Indian Premier League and International Cricket Council.

The newest deal ensures the coverage of Asian cricket's marquee tournaments across television, digital and audio platforms, Sony India said in a

Rising Lebanese Football Star Left In Coma By Israeli Airstrike

eading Lebanese footballer Celine Haidar is in a medically-induced coma after she was critically wounded in an Israeli strike near her home in Beirut's southern suburbs - her international championship prospects on hold.

Captain of her club team and already included in the national youth team twice, the 19-year-old refused to allow her training to be interrupted by Israel's bombardment, even as her own family fled to a mountain town east of Beirut.

She convinced her parents to let her return home alone so she could continue training, assuring them she would leave every time the Israeli army issued an evacuation warning for a neighbourhood it was

intending to bomb. But last Saturday, she missed the warning. She was asleep when the Israeli military spokesman posted an evacuation warning for her neighbourhood. Her parents called her and urged her to leave immediately, but time was short.

An Israeli warplane struck as she leapt onto her motorbike. She was hit by shrapnel, which left her with severe brain injuries, including multiple skull fractures and brain bleeding.

She is now in an intensive care unit at Saint George Hospital in Beirut, connected to monitors and a breathing tube, with her head bandaged, according to her coach Samer Barbary.

Spain Drawn Against Netherlands In Nations League Quarter-Finals

European champion Spain was drawn against the Netherlands in the quarter-finals of the Nations League on Friday, while France was paired with Croatia in a rematch of the 2018 World Cup final. Italy will face Germany and Portugal will play

Denmark. Spain is also the defending Nations League champion after winning the tournament last year. The quarter-finalists advanced by placing first or second in the four Nations League top-tier groups

that finished this week. The two-leg quarter-finals will be played on March 20 and 23. The winners advance to a Final Four minitournament scheduled for June 4-8, hosted by one of the teams involved.

The four semi-finalists will not be available to start qualifying games for the 2026 World Cup until




