

#### **US SEC Summons** Adani In **Bribery Case**

New York: Adani group founder and chairman Gautam Adani and his nephew Sagar have been summoned to explain their stand on the US Securities and Exchange Commission (SEC) allegation of paying USD 265 million (Rs 2,200 crore) in bribes to secure lucrative solar power contracts.

Summons have been sent to Adani's Shantivan Farm residence in Ahmedabad and his nephew Sagar's Bodakdev residence in the same city for a reply to SEC within 21 days.

"Within 21 days after service of this summons on you (not counting the day you received it)...vou must serve on the plaintiff (SEC) an answer to the attached complaint or a motion under Rule 12 of the Federal Rules of Civil Procedure," said a November 21 notice sent through the New York Eastern District Court.


"If you fail to respond, judgment by default will be entered against you for the relief demanded in the complaint. You also must file your answer or motion with the court," it added.



## **Govt To Fix Test Rates At** Private Labs: Sakeena Itoo

Srinagar:The Jammu and Kashmir government is all set to fix and notify rates of the tests being conducted at the Private Diagnostic Centres in the Union Territory, the Minister for Health and Medical Education, Sakina Masood (Itoo) said on Saturday.

Itoo said that the government has already fixed rates of few diagnostic tests in government run hospitals and the rates for tests in private diagnostic centres will be notified soon.

"We are going to fix and notify rates of all tests for private diagnostic centres so that patients will know about it and nobody can charge them more," she said. She added that usually it is being witnessed that some private diagnostic centres have been charging at their will for different tests and patients don't have

any other option than to pay it. The Minister further added that nobody will be allowed to loot poor patients in the name of tests.

## Non-operational **Traffic Lights Continue To Irk Commuters**

Srinagar: The much-anticipated Intelligent Traffic Management System (ITMS) under the Srinagar Smart City initiative continues to remain non-operational, causing inconvenience to the commuters across the City.

While the traffic police continue their rigorous campaign against traffic norm violations and minor driving, the lack of functional traffic signals has exacerbated the challenges faced by commuters.

Notably, the non-functioning of traffic lights has caused diversions at key intersections, forcing commuters to take lengthy routes.

Several commuters said that from Shaletnag Chowk, travellers heading towards Bandipora road are compelled to take a U-turn near Mustafaabad Gurdwara, significantly increasing travel time.

"At Shaletnag Chowk, we cannot cross directly to Bandipora road, we have to take a

#### U-turn at Mustafaabad," said Waseem Ahmad.

He said that if commuters coming from Bandipora road side have to take Baramulla road they have to take a U turn at Parimpora near Faird eal shopping complex.

Similarly, on MA Road, blockades have necessitated long-distance tours, adding to take more time among daily commuters.

There are many intersections across Srinagar City where traffic lights were installed but were never made functional.

Many commuters said that due to rising traffic volume on roads in Srinagar, traffic police could be seen managing intersections manually due to non-functional lights, but that was leading to long delays and congestion.

Notably, some signals, which were initially functional, have stopped working, while the traffic at those intersections too is being managed



factors equally shape the rivalry (not religion per se) between the two political heavyweights. The Iran and Saudi Arabia discord "has nothing to do with the Sunni-Shia divide in Islamic theology." The animosity between the two energy titans stems not from Islamic theology but from their shared quest for regional dominance (power projections), security, and survival.

Discourses unleash epistemic violence. By perpetuating these sectarian narratives, the West has further poisoned Iran-Saudi relations, leading to escalations. The dominant narrative amplified by Western media portrays an Islamic Iran that seeks to 'export' the Revolution. Such narratives ignore the pragmatism in Iran's foreign policy. Those who view Islamic ideology as the primary determinant of Iran's foreign policy fail to recognize the ideological flexibility embedded in both Islamic culture and the Shi'i tradition. The March 2023 agreement highlights the dominance of pragmatism over ideology, much like the 2015 nuclear deal Iran signed with the U.S. (the "Great Satan," a sobriquet Iran uses for America). It demonstrates Iran's capacity to prioritize pragmatism over ideology.

The argument that the Shia-Sunni binary or a clash of ideologies makes rapprochement between Iran and Saudi Arabia impossible is a distorted narrative. There is a historical precedent for Iran-U.S. détente. Since the 1990s, Iranian presidents have made similar diplomatic overtures to Saudi Arabia. In 1997, Saudi Crown Prince

Abdullah bin Abdul-Aziz visited Tehran, leading to a bilateral cooperation and security agreement until 2005. The rapprochement peaked with Mohammad Khatami's "Dialogue among Civilizations." In May 1999, Khatami visited Riyadh, and King Fahd optimistically stated, "The doors have been opened to both countries." Similarly, Hassan Rouhani's foreign policy, guided by the discourse of 'constructive engagement with the world," sought to reinvigorate Iran's relationships with the Persian Gulf neigbours. Rouhani's Foreign Minister, Javad Zarif, emphasized, "Our neighbors are our priority." However, Donald Trump's "maximum pressure" campaign, which had the active support of Crown Prince Salman, hindered serious diplomacy with the Saudis. Late Iranian President Ebrahim Raisi's "Neighborhood Policy' encouraged dialogue with the Saudis, and Iran's current President, Masoud Pezeshkian, recently visited Qatar and met with Saudi Foreign Minister Faisal bin Farhan. Pezeshkian referred to the Islamic countries of the region as "brothers" and called for strengthened cooperation between the two nations. Crown Prince Salman is expected to visit Tehran at Iran's invitation.

Not only ideology but pragmatism also shapes Iranian foreign policy thinking. "Cultural maturation" has led Iran's foreign policy to shift increasingly away from religious ideology toward pragmatic calculations of national interest. The March 2023 agreement has undermined the axis of confrontation-the so-called 2020 Abraham Accords-designed to contain and isolate Iran. The nascent axis of brotherly nations of Iran and Saudi Arabia has become a countervailing force against the impending regional war triggered by Israel's genocidal assaults on Gaza and Lebanon. The Iran-Saudi tension has had a ripple effect in the region. It has helped stabilize Yemen. Since October 2022, a truce supported by both Iran and Saudi Arabia has been in place in Yemen. It has rehabilitated Syria within the Arab world; Iran's relations with the UAE, Turkey, Egypt, Jordan, Bahrain, and Kuwait have all been restored. The thaw in Saudi-Iran relations has averted a major war between Iran and Israel, as the Persian Gulf nations have pledged not to allow Israel to use their "soil or airspace" to attack Iran.

This deal has the potential to transform the region. However, the odds remain high. The litmus test will be how both sides manage expectations, compartmentalize issues, and demonstrate ideological flexibility. Iran and Saudi Arabia need, in Huberman's terms, an "empathetic understanding" (Verstehen)-a rational discourse to mitigate the conflict. Decoupling will be necessary: Riyadh cannot expect Iran to sever its links with the 'Axis of Resistance,' which Iran views as its forward-defense strategy against Israel and the U.S. Similarly, Iran must accept that the GCC countries, particularly Saudi Arabia, cannot (and will not) end their security partnership with the U.S. Both must also commit to noninterference in each other's domestic affairs, as stipulated by the deal. This approach serves their larger national interests and is vital for the overall stability and security of the region.

## s Donald Trump A Neocon?

rump reminds one at times of the famous line from the novel Don Quixote by 17th century Spanish author Cervantes: "In order to attain the impossible, one must attempt the absurd." Trump's first presidency was reduced to a theatre of the absurd, with the so-called Deep State blocking his path every inch of the way and rendering him ineffectual, beating his wings in the void in vain. A glaring example was the Pentagon openly flouting Trump's order to vacate the occupation of northeastern Syria (which continues.)

Well-known American podcaster Judge Napolitano titled one of his indispensable daily podcasts last week 'Is Trump a Neocon?'. Napolitano echoed the criticism among Trump's detractors (and sceptics.) In reality, though, the neoconservatives are getting frantic that Trump 2.0 is genuinely rebooted, but that's another matter.

Trump is handpicking loyalists to ensuring that Trojan horses won't infiltrate his stable — likes of Nikki Haley or Mike Pompeo. This means total rejection of so-called globalists, who repose faith in Pax Americana. At least four key figures proposed by Trump fit into this paradigm - Elon Musk and Vivek Ramaswamy who will preside over a purge of neocons dominating the bloated bureaucracy; Tulsi Gabbard as the intelligence tsarina who will not let misinformation pass as 'intelligence' or allow rogue operations, Pete Hegseth as defence secretary who will keep flamboyant Pentagon commanders in tight leash. One way or another, they take a dim view of US interventionism.

What is neoconservative foreign policy? Its parenthood can be traced to Wilsonian idealism to 'make the world safe for democracy'. Promoting freedom and democracy and protecting human rights around the world are its central tenets. Lib-



eral internationalism is its grand strategy. (Neoliberalism is a revised version of liberalism.) Thus, the neoconservative foreign policy typically advocates unilateral promotion of democracy and interventionism abroad rooted in a militaristic philosophy of 'beace through strength'.

Through the past three decades, neoconservative idealism took the form of an assertive and interventionist foreign policy that targeted regimes which defied US hegemony. Nonetheless, Trump never propagated a regime change agenda - not even toward authoritarian regimes. In this respect, he is a solitary exception while his peer group -

George H W Bush, Bill Clinton, George W Bush, Barack Obama and Joe Biden — unabashedly promoted regime changes (eg, Yugoslavia, Georgia, Ukraine, Afghanistan, Iraq, Syria, Libya, etc.).

That said, a caveat must be added as Trump also agrees with the neoconservatives that the US' military might can be employed whenever US interests are at stake. Now, that's some strategic ambiguity where subtlety comes in defining 'interests'. Trump's one major criticism of the Iraq war was that neither Bush nor Obama paid sufficient enough attention to seizing control over that country's fabulous oil resources.

Arguably, therefore, it is entirely conceivable that when Trump harps on an immediate ceasefire and a freeze on further Russian offensives in Ukraine that may create new facts on the ground, he may well be having an unspoken neo-mercantilist agenda

Ukraine is a treasure house of multi-trilliondollar mineral resources, including rare earths. Its famed 'chernozem' (black soil) containing high percentages of humus (4 per cent to 16 per cent) and phosphorous and ammonia compounds with high moisture-storage capacity, makes it very fertile giving great agricultural yields — which indeed already captivates MNCs, and George Soros, consistent with Trump's 'America First' and MAGA strategies.

However, the main thrust of Trump's national policy is about dismantling the Deep State. But here too, he is supportive of a strong military. Interestingly, Trump is not advocating a disbandment of NATO. His pressure tactic narrows down to NATO allies hiking defence budgets so that they remain a captive market for US weaponry — ie., vitalising the military-industrial complex.

Trump doesn't want an independent Europe. An analyst recently invoked a biting metaphor of a dominating daddy to thumb-sketch Trump's dialectic with Europeans - who habitually beats wife and kids and bullying junior to pay rent and work in daddy's business to pay back the money spent for his education.

It is a moot point whether Trump is a neocon. The crux of the matter is that Trump can be as oppressive as his neocon peer group in the pantheon of post-Cold War US presidents.

## Anaemia is More Than Fatigue It can silently impact fertility

naemia, characterized by a deficiency of red blood cells or haemoglobin, is a common health issue among young women worldwide. Its prevalence is particularly high in developing countries, where nutritional deficiencies, menstrual blood loss, and chronic illnesses often contribute to its development.Anaemia is the major health issue in Jammu and Kashmir, especially among women and children. In Jammu and Kashmir, over 27 lakh women between the ages of 15-49 are anaemic, according to NITI Aayog's "State Nutrition Profile of Jammu and Kashmir" report. The Union Territory saw higher cases of irondeficiency especially in women between (2019-2020).

What Causes Anaemia in Young Women?

The most common type of anaemia in young women is **irondeficiency anaemia**, which arises when the body lacks sufficient iron to produce adequate haemoglobin. This can result from:

*Heavy menstrual bleeding*: Prolonged or heavy periods can lead to substantial blood loss, depleting iron stores.

- **Poor dietary intake**: A diet low in iron-rich foods such as red meat, leafy greens, and fortified cereals contributes to anaemia.



### 2. Take Iron Supplements if Needed

Women diagnosed with iron- sult

deficiency anaemia may benefit from prescribed iron supplements. It's important to take them under medical guidance to avoid side effects like gastrointestinal discomfort.

#### 3. Monitor Menstrual Health

Address heavy menstrual bleeding through medical consultation and explore treatments such as hormonal therapies if necessary.

### 4. Check for Underlying Conditions

Treating conditions like hypothyroidism, celiac disease, or chronic inflammation is essential to resolving secondary anaemia and restoring fertility.

#### 5. Preconception Care

Women planning to conceive should undergo a thorough health assessment, including blood tests to check iron levels and overall reproductive health.

By recognizing the signs of anaemia early and taking proactive steps to address its root causes, women can not only improve their overall health but also enhance their chances of a healthy conception and pregnancy. a dire need for healthcare infrastructure in the region.

They lamented that both AIIMS projects were approved simultaneously but have not been completed at the same pace. The people of Kashmir, who have limited healthcare options compared to Jammu, are more in need of

AIIMS Awantipora, they said. Many locals called for completing the project early to reduce the hardships faced by patients requiring treatment for critical illnesses.

Meanwhile, officials working on the project said efforts are in full swing and aim to complete the work by June 2025.

They cited several reasons for the delay, including legal disputes over land acquisition for the access road, restrictions following the abrogation of Article 370, challenges posed by a nearby army base, erratic weather, and the COVID-19 pandemic. These factors collectively hindered the progress of this mega project, they said

An official said that progress has been made over the past two years. "Work on four academic blocks, multiple hospital blocks, and hostel blocks is nearing completion, and efforts are underway to hand over the facility to the concerned authorities as soon as possible," he said.

The Central government approved AIIMS Awantipora in 2019 at an estimated cost of Rs 1,828 crore. The project includes the construction of approximately 57 buildings, encompassing a hospital, hostels, residential quarters, a football ground, tennis courts, gardens with medicinal plants, and other state-of-the-art facilities.

"Due to security reasons, the construction got delayed," a senior official from the administration on anonymity told Kashmir Observer earlier this year. He, however, had said the work is going on in full swing and the project is to be inaugurated by 2025.

Upon completion, the institute will provide 1,000 beds, including 300 super-speciality beds, which is expected to bolster Kashmir's healthcare infrastructure. The project also includes a medical college with a capacity for 100 students and a nursing college for 60 students.

The government has set December 31, 2024, as the new deadline for completing the project. However, officials are optimistic that the facility will be fully operational by June 2025. (KNO)

#### NDA Sweeps

Separate from the indictment brought by the US Department of Justice, the US SEC has also charged the two and Cyril Cabanes, an executive of Azure Power Global, for "conduct arising out of a massive bribery scheme".

"The Adani Group has always upheld and is steadfastly committed to maintaining the highest standards of governance, transparency and regulatory compliance across all jurisdictions of its operations. We assure our stakeholders, partners and employees that we are a law-abiding organisation fully compliant with all laws.'

An indictment in the US is basically a formal written allegation originating with a prosecutor and issued by a grand jury against a party charged with a crime. A person indicted is given formal notice to reply.

That person or persons can then hire a defence lawyer to defend.

Prosecutors said the investigation started in 2022 and found the inquiry obstructed.

They also allege that the Adani Group raised USD 2 billion in loans and bonds, including from US firms, on the backs of false and misleading statements related to the firm's antibribery practices and policies, as well as reports of the bribery probe.

"As alleged, the defendants orchestrated an elaborate scheme to bribe Indian government officials to secure contracts worth billions of dollars and... lied about the bribery scheme as they sought to raise capital from U.S. and international investors," US Attorney Breon Peace said in a statement announcing the charges on Wednesday.

"My office is committed to rooting out corruption in the international marketplace and protecting investors from those who seek to enrich themselves at the expense of the integrity of our financial markets."

high power consumption during winters, compounded by reduced water levels in power-generating water sources, he disclosed that Chief Minister Omar Abdullah has initiated discussions with Delhi for an additional 350 MW of electricity to mitigate the shortages.

"Once we get that, power supply issues will be redressed by and large," he added.

On the issue of road connectivity, the Minister urged patience, stating that major road repair works would commence in summer.

He also stated that concerned departments have been directed to address urgent issues through consolidation wherever necessary.

#### Winter Power

said that "Soon we will be announcing the new power curtailment schedule. We are already working on it and most likely we will be announcing the curtailment schedule this week only.'

"Currently, we have availability of 2300-2400 Megawatts for both the Jammu and Kashmir regions. However, the demand is 2500-2600 Megawatts," the official said.

He said, "We have a number of Power Purchase Agreements (PPAs) that go for 20-25 years. Besides, we have central allotments as well. There is a regular purchase process.'

The official further said, "We are also receiving the power from the centre from the PPA made in 2023.'

Earlier this week, it was reported that in Jammu and Kashmir, the power generation from the state pool has reduced by nearly 80 percent.

"From across the regions, the total powr generation capacity is 1200 Megawatts However, as of now we are only able to generate a total of 200-260 Megawatts of power from the UT pool," the official said. About the ongoing power curtailment, the official had said, "We cut off nearly 200-250 Megawatts during the peak hours. That is a force curtailment. Otherwise we have 38-40 feeders that are working 24 hours.' The official had also said, "In urban areas, as of now there is a power curtailment of over 6 hours and over eight hours of power curtailment in rural areas."(KNO)



## **BGT 1st Test: Rahul Silences Doubters** As India Openers Dominate Australia

PERTH: Makeshift opener KL Rahul repaid the faith India have showed in him despite recent struggles, helping to put the touring side in the driving seat against Australia in the first test in Perth on Saturday.

Rahul finished unbeaten on 62 as India reached 172 without loss at the close on day two, leading by 218 having bowled Australia out for 104. The 32-year-old has played

a chanceless knock, silencing his critics by balancing the youthful positivity of Yashasvi Jaiswal (90 not out) with maturity borne from 10 years in, and sometimes out, of the test team.

"They worked very hard," paceman Harshit Rana said of India's opening pair.

"It was not easy at the start but they spent some time in the middle after which they faced no real problem."

Rahul adopted the same mature approach on a dizzying opening day too, when India



were rolled for 150 inside two sessions by Australia's seamers. The Bengaluru-born righthander was the only top-order batsman intent on preserving his wicket, but fortune did not

favour him. The third umpire judged on review that Snicko showed balledging-bat off Mitchell Starc to keeper Alex Carey and Rahul had to trudge off for 26.
