Srinagar: The recent visit by a US Army delegation to the Indian Army's High Altitude Warfare School (HAWS) in Sonamarg, Jammu and Kashmir, highlights the growing emphasis on operations in extreme cold environments, as both nations focus on adapting to shifting geopolitical dynamics.

This visit underscores India's longstanding expertise in high-altitude warfare, forged by its strategic deployments along the Himalayan frontier against



Pakistan and China. The focus has intensi-

fied following the 2020 standoff with China along the Line of Actual Control (LAC), prompting the Indian military to increase its preparedness for

prolonged deployments in 'super high altitude' areas, the tribune reported.

## Khamenei: Netanyahu Must be Sentenced to Death

TEHRAN: Days after the International Criminal Court (ICC) issued arrest warrants against Benjamin Netanyahu and others for war crimes, Iran's supreme leader Ayatollah Sayyed Ali Khamenei demanded the death sentence for the Israeli Prime Minister.

"They issued an arrest warrant, that's not enough... Death sentences must be issued for these criminal leaders", Khamenei told a gathering of paramilitary Baseei

bore criminal responsibility for actions including murder, persecution and using starvation as a weapon of war.

"What the Zionists did is a war crime. They issued an arrest warrant for him [Netanyahu]. This is not enough. Death sentence for Netanyahu must be issued. Death sentence for these criminal leaders must be issued," said Khamenei in Persian, according to Tasnim news agency.

## **Blood-Like Liquid Floods Streets** In Hyderabad, Sparks Panic

Hyderabad: Panic gripped people in the Venkatadri Nagar area near the Jeedimetla Industrial Estate in Hyderabad as red-colour liquid resembling blood flooded

The liquid gushing out from a manhole caused concern among the residents.

Foul stench and difficulty in breathing worried them further.

Alarmed over this, the locals approached the municipal authorities and heaved a sigh of relief after they were informed that the gushing, noxious liquid was

The officials told the residents that it was a red-coloured chemical that was apparently discharged from the nearby industrial units

Venkatadri Nagar in Subhash Nagar division is adjacent to the industrial area.

According to owners of some warehouses in the area, few industrial units directly discharge the chemicals into the drainage system. They said the municipal authorities were not taking any action.

As the manhole was overflowing, the red-coloured liquid flooded the streets, causing panic. The residents were concerned over the impact of the chemical effluent on their health and demanded immediate action.

The Telangana Pollution Control Board officials visited the area to take stock of the situation and assured the residents that steps would be taken to check the discharge of chemicals

## **Six Security Personnel Killed During Protests By Khan's Party In Pakistan**

Islamabd: Four paramilitary personnel and two policemen have been killed and over 100 security personnel injured as the protest by supporters of jailed former prime minister Imran Khan turned violent prompting the federal government to deploy the army in the national capital along with shoot at sight orders on Tuesday, state-run media said.

Pakistan deployed the army amid a tense stand-off with Khan's supporters from his Pakistan Tehreek-e-Insaf (PTI) pushing forward by removing hurdles on their way to Islamabad's D-Chowk venue as the government vowed to foil their attempt "even if a curfew needs to be imposed".

Radio Pakistan said a vehicle rammed into Pakistan Rangers personnel killing four Rangers officials on the Srinagar highway in Islamabad late on Monday night.

Five other Rangers personnel and several police officials too sustained severe injuries.

About five kilometres from this spot, a bunch of miscreants, equipped with weapons and ammunition, pelted stones on the Rangers personnel and carried out indiscriminate firing on the security personnel at Chungi No 26 in Rawalpindi, Radio Pakistan said.

It also reported that two policemen were killed but didn't provide any details.

According to Punjab police, one policeman was killed at Hakla interchange on Islamabad outskirts during clashes with the PTI protestors on Monday but it also did not give details about the second policeman.

Separately, Interior Minister Mohsin Naqvi said, at a late night media interaction, that more than 100 security personnel, mostly from police, were injured and added, "One senior police officer

## Centre Okays PAN 2.0 **Project; Here Are The Details**

New Delhi: The Cabinet Committee on Economic Affairs (CCEA), chaired by Prime Minister Narendra Modi, has given its approval for the PAN 2.0 project of the Income Tax Department. The financial implications for the PAN 2.0 Project will Rs 1,435 crore.

The project aims to streamline and modernise the process of issuing and managing PAN and TAN, making it more userfriendly and efficient.

With existing PAN data base of 78 crore Permanent Account Number (PAN) and 73.28 lakh Tax Deduction and Collection Account Number (TAN), the project addresses the requirements of taxpayers, focusing on consolidation of multiple platforms, portals and efficient services to PAN and TAN holders.

Currently, PAN-related services are spread across three different platforms: the eFiling Portal, UTIITSL Portal, and Protean e-Gov Portal. The new project will be an upgrade of the current PAN and TAN 1.0 eco-system.

With the implementation of PAN 2.0, all these services will be integrated into a single. unified portal. This one-stop

platform will handle comprehensively issues and matters related to PAN and TAN, including application, updates, corrections, Aadhaar-PAN linking, re-issuance requests, and even online PAN validation.

The project will enable upgradation of the 10-digit alphanumeric PAN with a QR Code incorporated in all new and old cards. It will also feature enhanced cybersecurity to protect user data.

By doing so, the Income Tax Department aims to simplify processes, eliminate delays, and improve grievance redressal mechanisms.

- A single portal for all PAN/TAN-related services to simplify access for users
- Eco-friendly paperless processes to reduce paperwork
- PAN will be issued free of cost, with quicker processing times
- Personal and demographic data will be protected through enhanced security measures, including a PAN Data Vault
- A dedicated call center and helpdesk to address user queries and issues

debates by the think-tank PRS India, the Constitution's first copy was handwritten by Prem Behari Narain Raizada and published by him in Dehradun.

Every page was decorated by artists from Shantiniketan, including Beohar Rammanohar Sinha and Nandalal Bose.

It took two years, 11 months and 18 days to complete the final draft. At present, it contains 395 Articles and 12 Schedules. The Constitution has been amended 106 times so far.

Approximately 36 lakh words were spoken during debates in the Constituent Assembly and twothirds of all deliberations were during the clause-by-clause discussions during the second reading.

From November 1948 to October 1949, the Constituent Assembly met for clause-by-clause discussions on the draft Constitution. The members met for 101 days during this period.

Fundamental Rights were included in Part III of the draft Constitution and discussed for 16 days.

As much as 14 per cent of the total clause-by-clause discussions was dedicated to Fundamental Rights.

## **Jobs Under Threat**

he latest Reserve Bank of India data has put the net household savings as a percentage of GDP at their lowest level in nearly 50 years. This has left families with less disposable income, and which, in turn, has impacted consumption patterns. A report by Marcellus Investment Managers, has traced the slowdown to three basic factors: technological disruptions, a cyclical economic downturn, and deteriorating household balance sheets. Among the three, the 'technological disruptions' are fundamentally altering the job economy. As underlined by the report, the jobs that once formed the backbone of middle-class employment are increasingly being replaced by automation and technology. Artificial Intelligence threatens most of the jobs, more so, the white collar ones. A report from Goldman Sachs has indicated that the AI could replace 300 million jobs globally, and impact two-thirds of jobs in the US and Europe. One-fourth of the jobs could be performed completely by AI. OpenAI and Mckinsey Global Institute estimate that AI would affect half of the job tasks for 20% of the workers. These are grim predictions for the job prospects for the educated youth just entering the job market.

Fallout of the AI is being compounded by the economic downturn and declining household incomes. This is despite the fact that the Indian economy is doing relatively well. Projected to grow at 7% this year, India's economy is the fastest-growing among the world's major economies. But the benefits aren't sufficiently trickling down to people. Despite this economic expansion, job opportunities remain limited, and the competition is intense, with only graduates from well-known colleges securing desirable positions. The unemployment rate in the country for those in the 15 years and above category remained unchanged at 3.2% in 2023-24. However, the youth unemployment rate for those in the 15-29 years age group rose to 10.2% in 2023-24 from 10% in 2022-23. The employment is more for females, rising from 10.6% in 2022-23 to 11% in 2023-24.

Job security is another area of growing apprehension, with more Indians expressing concerns about potential layoffs. These worries are not unique to India, as global issues like recession, economic slowdown, and multinational conflicts weigh on the minds of individuals worldwide. Kashmir mirrors this tough job situation. In fact, the situation is more difficult in the UT as there are fewer opportunities outside government jobs: In the July-September quarter of 2024, Jammu and Kashmir recorded the highest unemployment rate at 11.8 percent, followed by Odisha with 10.6 percent. This calls for not just a job plan for also an education

plan for the youth, so that the new generation has required

skills and know-how to be relevant to the new job market.

## **Dangerous Pan-Indian Portents** of Waqf Amendment Bill (2024)

he ruling Bharatiya Janata Party, buoyed by a thumping victory in Maharashtra after Haryana polls, is now to be more aggressive, as on the very onset of the winter-session of Parliament, PM Narendra Modi has stated that Waqf Law does not have a place in India's Constitution. The ends are now to justify the means, as the façade built over forming a Joint Parliament Committee (JPC), on the Waqf Amendment Bill (2024) is now all cleared to become an Act, which obviously will have reverberations all across the nation. JPC had 31 Opposition MPs from Lok Sabha as well as Rajya Sabha. The Opposition sought an extension of JPC, which does not seem to have any takers. JPC chairman, a BJP MP, Jagdambka Pal, has informed that the 500-pages report is ready to be tabled. Heady days are therefore ahead.

It is worth recalling that Waqf properties are protected by the Constitution of India through the Shariat Application Act, 1937. After independence, came the first Waqf Act of 1954, was amended in 1995, and later again amended in 2013. This Bill, slated to now become an Act, was brought in Parliament, on August 8, had 40 pages and covered 44 changes. It is therefore going to change everything of the past. Despite that being completely antithetical and inconsistent with the Constitution!

The Act, once made, is most likely going to fuel a full-blown storm. It is going to be a 'final end' to the last vestige where Muslims exercised some control. Muslims have called for protests; it happened in Jaipur, Kolkata and Gulbarga etc. The Bill was opposed by the largest Opposition party, Samajwadi Party (SP). The narrative to finally gulp, in the name of reforms, the Waqf properties, on an India level was led by the spread of a national canard, that the 32 Waqf Boards in India, hold properties only third to Indian Railways and Army. Railways and Army own these properties, but the Waqf Board is not the owner of these properties. It only looks after their maintenance, as per the Waqfnamas (Endowment deeds).

Waqf in English means an endowment, through which Muslims donated their lands, moveable and immoveable properties, for the welfare of widows, orphans, schools, hospitals, madrassas, etc. There are two types of Waqfs: one is Waqf Alal Aulad (meant for progeny's welfare) and the other is Waqf Alal Khair (for general public welfare), with an appointed Mutawalli (Manager). In no case can a Waqf be sold, even the owner cannot take it back once a property is designated as Waqf. Thereafter, the property is to be vested with God. In UP alone, there are 2,10,239 properties registered in Sunni Central Waqf Board and

15,386 properties in Shia Central Waqf Board. The Act will authorize that if any Waqf by 'user', used as such, without any endowmentdeed for decades/centuries, is not registered, then after the Act is passed, can be registered as Waqf within six-months. How easily said? What if one could not get a Qabristan, Kerbala, Dargah, Khanqah, Yateem Khana, Mosque and Sarai etc as 'registered Waqf' in six months? Government will obviously take over it! Both Nitish Kumar of JD (U) and CB Naidu of TDP, partners of the government, are supportive of the government on all this.

Will it not be better to recall that despite the guarantees of Waqf Act (previous) the demolition of a 100 years mosque in district Barabanki (UP) in 2021, by district authorities, under anti-encroachment drive, had taken place. This happened when it was registered as Waqf. A 16th century Shahi Masjid in Allahabad in 2023 was razed. In 2022, a 300 years old mosque in Muzaffarnagar was also demolished! All were Waqfs. The 150 old Sunehri Masjid in New Delhi, is facing a similar fate! Now what more is to happen?

The Act is patently violative of our Fundamental Rights enshrined in the Constitution (Article 12 onwards to 35), which interestingly are subject to other Articles, but it is only the specific Article 26, which is absolutely free from any such embargo, and allows Muslims, and people of all other religious denominations, an unconditional freedom to manage their religious affairs, 'subject to public order, morality and health.'

Now, in the wake of Article 26, it warrants a threadbare analysis on the government initiative to bring about changes. For instance, to nominate non-Muslims on state boards; re-

deed. Article 26 gave Muslims a complete autonomy on them, through its Clause (D). The right of administration is not at all in any way hindered. But, now it is the District Collector (DC) who will decide. After the Act, the DC in each district is to be made the sole arbiter regarding any particular Waqf property, and not the Waqf Tribunal, as was the case before. Therefore, now if the DC entertains any doubt, about the nature and user of that property, nobody can do otherwise except and un-

belonged to Muslims (donated by Muslims

of course) even if there was no endowment

less the DC passes final orders. The DC may keep the matter pending for decades and till the DC makes a decision the property cannot to used! Earlier, if Waqf Board was to stake a claim, it was open to be contested in Waqf Tribunal within three years, and on its decision the property was either to remain in Waqf Board or otherwise given to the other party. Why should the DC be given such overwhelming powers, when Article 26 Clause (C) clearly states that the right of ownership of such properties, through documents or otherwise by user, under no circumstances, can be taken away. This is what the Act will nullify.

The Act also allows the nomination of two non-Muslims members in the State Boards. For this, the government will need to first circumvent the whole of Article 26, which in its Clause (B) allows Muslims to manage their own affairs in matters of religion. The reality is that inside Muslim themselves, there are two distinct Sunni and Shia sects, and there are a vast number of differences between Sunni themselves as well as within Shias. The presence of non-Muslims members in the management of Waqf Board will affect the whole system.

There is going to be only more chaos in future, as Clause (A) of Article 26, clearly specifies that establishing institutions for religious and charitable purposes, has to be seen in the spirit and thought of the person who has dedicated the property. Here an awkward situation will arise, as one thing may be religious and charitable for one but not for another, and as such, the person who has dedicated his or her property, will deprive him or her off-springs to use the property. This will result in absolute contravention of the right

The Act will squeeze every bit of autonomy from the Waqf Board, by appointing a Non-Muslim Chief Executive Officer (CEO), who as under Section-26 of Waqf Act, has been accorded with unbridled powers, to the extent that CEO has the right to not to implement a resolution passed by the Board, and may send it to the 'State Government along with his objections to the order or resolution, and the decision of the State Government thereon shall be final.' In fact a Sunni and a Shia CEO deserves a place in each respective board. The CEO, therefore, is far more powerful than even the Chairman of the Board. Every resolution of the Board, after the Act, will hang in a limbo.

The Act will give a final blow to the Waqf Board, which is likely to open the floodgates for continued illegal occupancies. The lawof-limitation over adverse possession by the opposite party, from which the Waqf Board was earlier exempted, will now be in place. After the proposed amendments in Section 107 of the erstwhile Waqf Act, the Board will abdicate its right to stake its claim thereon. What deserves to be mentioned is that after 1947, a peculiar situation had arisen, particularly in Punjab, where a large number of mosques etc were abandoned by migrating Muslims to Pakistan, and such buildings were possessed by Sikhs, but after the 2013 amendments, many of such buildings have been returned back to Muslims. This Act will block this passage.

Waqf is an exclusive Muslim domain as it stems from donations of Muslims since ages but this Act will make them lose all control over it and the government will take over. No wonder, Muslims are now up to their last-

# Migratory Delights

**T**ith the onset of winter in the Kashmir Valley, migratory birds have started flocking to wetlands, seeking refuge from the harsher climates of Siberia, China and Eastern Europe while as hundreds of birds, including species like mallards and gadwalls, have already started arriving at Hokersar and other wetlands.

Migratory birds arrive every year to stay in lakes, marshes, and at least five wetland spots in Jammu and Kashmir, typically for about five months. The annual migration brings not only birds but also wildlife photographers, hobbyists, and bird watchers who flock to these wetlands for a glimpse of the rare visitors and this winter season a good number of migratory birds are expecting as the temperature dips in the coming months, the number of migratory birds will increase. Over one million migratory birds arrived in Kashmir during last winter season.

This year, Kashmir experienced a prolonged dry spell, although recent snowfall in mountainous and hilly areas is signalling a return to colder conditions. With colder months ahead, the wetlands of Kashmir will continue to serve as a vital sanctuary for migratory birds, adding to the valley's natural beauty and ecological diversity.

An impressive number of migratory birds have flocked to the region, upholding the centuriesold tradition of wintering in the wetlands. Hundreds of migratory birds, including mallards, gadwalls and various other species, have arrived at Hokersar wetland. Notably, more than 90 species of birds trek to breed and feed in the valley's wetlands, travelling from Siberia, China, and Eastern Europe. These include mallards, common teals, bitterns, graylag geese, pintails, shovelers, tufted ducks, and cor-

For bird watchers, it's an exciting time, especially as sightings can vary each year, however, despite the beauty and biodiversity, poaching remains a challenge for the wildlife department. The



Jammu and Kashmir Wildlife department have already identified areas vulnerable to poaching and plan to intensify monitoring to prevent illegal activities in and around the boundaries of the wetland areas as they are committed to safeguarding these migratory species, and efforts to prevent poaching incidents are being prioritized with extra vigilance around the wetlands.

In a remarkable development for bird enthusiasts and conservationists alike, the elusive Great Bittern (Botaurus stellaris) has been sighted for the first time in the Kashmir Valley at the renowned Wular Lake. This significant event not only highlights the ecological importance of the region but also strengthens the ongoing efforts to preserve its rich biodiversity. As migratory birds return to their seasonal habitats, Wular Lake has once again proven to be a vital refuge for avian species.

The arrival of the Great Bittern, known for its distinctive booming call and cryptic plumage, marks an extraordinary occasion for ornithologists and nature lovers. Its presence in the valley underscores the significance of wetland conservation in sustaining diverse bird populations.

The Wular Lake, one of the largest freshwater lakes in Asia, serves as a crucial habitat for numerous migratory birds each year. The arrival of the Great Bittern adds to the lake's already impressive roster of avifauna, including various species of ducks, herons, and other migratory birds that grace the region during the winter months.

Bird watchers and researchers are encouraged to visit Wular Lake to witness this remarkable event and participate in ongoing conservation initiatives. The sighting of the Great Bittern not only fosters excitement within the community but also serves as a reminder of the need for collective action to protect our natural heritage.

Wular lake is much cleaner and full of water. A dry spell has reduced the areas of the other water bodies across the Valley, especially in neighbouring areas like Hygam, Hokersar and Shallbough. Poaching of migratory birds has also come down due to strong vigilance around the lake. Now birds find this big water body a safe heaven.

Census (AWC) in the Kashmir had revealed that the wetlands here provide a pleasant stay for the birds from across Europe, Japan, China and Central Asia. According to official Census figures the arrival of migratory birds ranged between eight to 12 lakh in 2022-23 and 11 to 12 lakh in 2021-22.

The migratory birds visiting Kashmir travel from the colder areas of the world, flying over continents in flocks. The birds that arrive here every year are mallards, greylag geese, pochards, common tails, shovelers, pintails and gharwals, which visit the region between October and April. Twelve lakh migratory birds from Eastern Europe and Central Asia visited Kashmir's wetlands the previous year, as per the Wildlife Department Kashmir's annual census.

Every year, the Wildlife Department Kashmir, in collaboration with several other agencies and stakeholders, conduct a census to determine the number of migratory birds that visit there is also a lurking threat from the poachers and hunters. The wildlife department seized more than 30 guns, including a rifle worth more than Rs 5 lakh, in the past two years. Around the same time, the Forest Protection Force (FPF) in north Kashmir's Bandipora, where Wular Lake is one of the main sites for bird visits, claimed to have seized as many as 11 punt guns - about 9 feet long – from the poachers.

## What's Fueling Their Love for the Past?

n an age of constant progress, I find myself retreating to the past. The world's demands feel lighter when I'm watching old shows from the 2000s. My film camera gives me the satisfaction of simpler moments in a way my iPhone can't. Photos of "how things used to be" fill me with a sense of calm. And I know I'm not the only one in Gen Z who feels this way. Our generation may be the most nostalgic yet; 40% of Gen Z longs for eras we never lived through, while 70% regularly consumes media from earlier decades. Why is nostalgia so pervasive for us?

We have more advanced technology, more global connectivity, and more options than any generation before. Yet we reach for things like film cameras and binge old episodes of Gilmore Girls or Wizards of Waverly Place. We wear Y2K fashion and embrace aesthetics that make the early 2000s feel "vintage." Brands cater to us with marketing filled with "vintage" and "nostalgic" imagery because they know it resonates. Why?

Nostalgia can act as a form of selfcare, with familiar, pleasant activities activating the brain's reward centers. For Gen Z, turning to early 2000s media offers that familiarity in a time when the present feels increasingly uncertain. There's comfort in returning to shows like Gilmore Girls, Harry Potter, and Friends, where you know exactly what to expect—every character's quirks, every predictable conflict. While these shows may deal with drama, the problems feel contained, almost trivial, compared to the daunting global crises Gen Z faces today. Watching exaggerated portrayals of teenage struggle can feel reassuring, a reminder of when



issues were simpler and more manageable. However, with nostalgia often comes romanticization, leading to phrases like, "I was born in the wrong generation." While this sentiment is understandable, it's not unique to Gen Z. Every generation looks back longingly on what feels like a simpler, freer time, often as they transition into adulthood and face new responsibilities. Millennials felt a similar yearning for a world

they hadn't lived through—cue songs

like Sandi Thom's "I Wish I Was a Punk Rocker" with its idealized view of earlier eras. It's human nature to crave those carefree years, even if each "simpler time" had its own set of challenges. The early 2000s were iconic, but like any other decade, they weren't free of global issues.

Part of nostalgia, maybe, is the sheer speed and exposure of modern life. We can experience the world with a scroll or a swipe, which brings endless opportunities but also re-

lentless comparisons. Social media shows us constant highlights, making it easy to feel that "yesterday"

was brighter than today. Documenting every moment is both a gift and a burden: we can cherish memories, yet we constantly measure them against the curated snapshots of others.

Unlike previous generations, Gen Z faces the additional pressure of presenting a polished, marketable version of ourselves on social media-whether we're making friends, dating, applying to schools, or seeking jobs. This need to "sell" ourselves can make even meaningful moments feel lacklustre if they don't measure up to the endless parade of life's "best" scenes. It's no surprise that Gen Z reports higher levels of stress, anxiety, and depression than previous generations.

It wasn't always this way. In the 70s, 80s, 90s, and early 2000s, people weren't flooded with images of past decades or perpetual comparisons. They simply lived each moment, free from the looming shadow of a virtual audience. They had more room to savour the uniqueness of their present without the fear of falling short.

But social media is only part of the equation. For much of Gen Z, crucial moments of adolescence were overshadowed or stolen by a global pandemic. In addition, we face a housing crisis, inflation, and global warfare playing out on our screens, amplifying the weight of these challenges. Our generation stands at the intersection of hyper-individualism and a deep commitment to social justice, which creates a unique tension: while we're encouraged to craft distinct personal identities online, we're also more aware than ever of the world's problems, from systemic inequalities to environmental crises. This awareness is intensified by the ways history and current events

are documented and shared with us. Through our phones, we have access to images, testimonies, and news of injustices across the world in realtime. The past isn't a distant memory—it's alive in our feeds, in stories that spotlight both the struggles and victories of previous generations.

We inherit these documented memories and feel their weight, seeing not only how the world once was but also how much remains unchanged. With resources and platforms that allow us to organize and mobilize, we often feel both empowered and pressured to fix wrong things and to advocate for a better future.

Maybe nostalgia isn't just an escape; it's a response to what's missing. While we're surrounded by options and technology that connect us more than ever, this hyper-connected world can also feel fragmented and detached. With everything seemingly for sale, it's difficult to find meaning in what's organic and real. Capitalism's endless drive for progress and consumption can make our lives feel driven by metrics, achievements, and aesthetics, rather than genuine connection or fulfillment. In revisiting the past, we find a grounding sense of authenticity—a bridge between eras that gives us a safe space to recharge and a glimpse of life outside the pressures of the modern world. For Gen Z, nostalgia offers a way to cope with today's complex pressures and to hold onto a vision of simpler times. It's no surprise, then, that even in an age of endless innovation, the past still feels like home.

## **Existing PAN Holders Do Not Need To Apply Afresh Under PAN 2.0: Tax Dept**

New Delhi- Existing Permanent Account Number (PAN) card holders are not required to apply for a new one under the upgraded PAN 2.0 system that is primarily aimed at introducing a 'common identifier' for all business-related activities, the Income Tax Department said on Tuesday.

The Cabinet Committee on Economic Affairs (CCEA), chaired by Prime Minister Narendra Modi, had approved the Rs 1,435-crore PAN 2.0 Project to streamline and modernise the process of issuing and managing PAN and TAN, making it more user-friendly and efficient.

PAN is a unique 10-digit alphanumeric number issued by the Income Tax Department to Indian taxpayers.



"With existing PAN database of 78 crore PANs and 73.28 lakh TANs, the project addresses the requirements of taxpayers, focusing on consolidation of multiple platforms/portals and efficient services to PAN/TAN holders," Central Board of Direct Taxes (CBDT) said in a release

on Tuesday. PAN 2.0 is an e-governance project of the Income Tax Department (ITD) for re-engineering the business processes of taxpaver registration services, it said, adding that the objective of the project is to enhance the quality of PAN services through adoption of latest technology

The Tax Deduction and Collection Account Number (TAN)related services are also merged with this project.

In an FAQ, the CBDT further said, "The existing PAN card holders are not required to apply for new PAN under the upgraded system (PAN 2.0)."

The PAN card will not be changed unless the PAN holders want any updation/correction, it added.

The existing valid PAN cards will continue to be valid under PAN 2.0," FAQ said.

CBDT also clarified that the "QR code is not a new feature, and it has been incorporated in PAN cards since 2017-18" and the same will be continued under PAN 2.0 project with enhancements (dynamic QR code which will display latest data present in PAN database).

## **Govt To Soon Provide Long-Term Finance Via PACS To Empower Farmers: Amit Shah**

New Delhi- Cooperation Minister Amit Shah on Tuesday said the government will soon provide long-term finance through Primary Agricultural Credit Societies (PACS) to further empower the farming community.

Speaking at the National Federation of State Co-operative Banks Ltd (NAFSCOB)'s Diamond Jubilee Celebration, Shah also directed the National Federation of State Cooperative Banks to prioritise making PACS more viable, transparent, and modern.

The minister stressed the strengthening of the spirit of cooperation while expressing concern over the "dilution" of this spirit in state and district-level cooperative banks in many places.

"We will provide longterm finance through PACS... We will start this soon. This will further empower farmers," Shah said, addressing NAFSCOB's Diamond Jubilee Celebration.

Currently, PACS provide short-term finance to the farmers.

Urging the NAFSCOB to play a bigger role in strengthening the cooperative banking sector, Shah said its work is "not just about holding meetings and resolving problems with the RBI and government; its job is to make PACS viable, transparent and modern".

Highlighting the critical aspects of cooperative bank ing reforms, he pitched for strengthening Primary Agricultural Credit Societies (PACS), totalling 105,000 with only 65,000 functional.

He asked NAFSCOB to

focus on implementing technological upgrades, creating opportunities for youth engagement, and focus on increasing low-cost deposits.

On expansion plans, Shah said the government aims to increase the number of district cooperative banks by 50 per cent from the current 300 in the coming years.

The minister urged NAF-SCOB to conduct workshops to help PACS adapt to new technologies and recommend ed studying successful models like Ahmedabad District Cooperative Bank and Gujarat State Cooperative Bank.

The minister asked both state and cooperative banks to keep higher targets for deposits and annual profit from the current level by focusing on raising low-cost deposits in the local area.

"No one will purchase their products, buy from our Hindu people," the woman was seen telling others in the earlier video. "Don't come in my area,"

## **Antimicrobial Resistance Continues To Be A Growing Global Health Threat: Experts**

**SRINAGAR:** Antimicrobial resistance (AMR) continues to pose one of the greatest threats to global health, jeopardising the effectiveness of treatments for infectious diseases and undermining decades of medical progress, experts warn.

A senior doctor at the Government Medical College (GMC) Srinagar said that the world's most powerful antibiotics, once capable of saving millions of lives, are now becoming increasingly ineffective.

"AMR occurs when bacteria, viruses, fungi, and parasites evolve resistance to the drugs that previously killed or inhibited them," the doctor said. "As a result, standard treatments become ineffective, leading to prolonged infections, the spread of diseases, and an increased risk of severe health complications.

Experts said there are several factors leading to AMR, including the overuse and misuse of antibiotics, incomplete courses of treatment, poor infection control measures, agricultural practices, and the lack of new antibiotics. The doctor highlighted the importance of

cautious antibiotic use. "Think twice and seek medical advice before using antibiotics. Misuse of these drugs puts everyone at risk," he urged. "Overuse of antibiotics is promoting the emergence and spread of resistant bacteria, making even common infections harder to treat."

The doctor said it is urgent to address this growing concern. "The rising levels of AMR require immediate action to explore and implement strategies to curb its spread," he said.

A 2022 report in The Lancet highlighted the devastating global impact of AMR, revealing that bacterial resistance was responsible for an estimated 4.95 million deaths worldwide by 2019. Without substantial interventions, the report predicts that AMR could lead to 10 million deaths annually by 2050.

Another expert said that AMR has far-reaching effects, including public health crises, economic burdens, and the exacerbation of global health inequities. "There is a need for responsible antibiotic use, proper disposal of unused or expired medications, and stricter regulations on pharmaceutical waste to reduce the environmental impact and prevent further resistance development," he said.

To combat AMR, experts recommend the rational use of antibiotics, improved infection prevention measures, strengthened surveillance systems, public education campaigns and increased funding for research into new antibiotics and alternatives.

In the Kashmir Valley, inappropriate antibiotic use is a major contributor to rising AMR levels. One doctor revealed that more than two-thirds of antibiotics are unnecessarily prescribed for viral infections or conditions that do not involve bacterial pathogens at all. The widespread over-the-counter antibiotic use without proper prescription, especially in chemist shops, and the indiscriminate use of antibiotics in hospitals without appropriate testing are major concerns.

"There is an urgent need for an antibiotic policy that regulates and rationalises antibiotic use both in hospitals and in the community," the doctor said. "Such a policy would help standardize treatment protocols and ensure antibiotics are used appropriately, reducing the risk of resistance."—(KNO)

They said that the electric lines touch roofs of houses and trees on roads, posing risk to life and public property. "We have been requesting the concerned department to replace the dangling and electric wires and poles but our pleas fell on deaf ears," Javid Ahmad, a resident of Rakh said.

He said that in several back

year they demanded electric poles and wires for the area but on the ground nothing has been done. "Almost all low tension wires in our village have been tied with trees in absence of poles," said Aadil Ahmad a resident of Zahid Bagh.

Shabir Ahmad, a resident Darbagh while echoing the same voice said that the government has been increasing power bills almost every month but

#### have failed in augmenting the infrastructure.

The residents of these villages said that they are living under constant fear due to low lying wires in the area but the government isn't taking their pleas seriously.

They said that LT wires often fall down in the area and anytime it can lead to a big incident for which PDD will be responsible. Locals claimed that they

have taken up their issues with administration several times but on ground nothing has been done. They urged the higher ups to look into the matter and provide new electric wires and poles.

altitudes, requiring advancements in training, equipment, infrastructure, and logistical support to sustain operations in these challenging environments.

The US Army is also shifting its attention to Arctic operations, following more than two decades of engagements in the Middle East and Afghanistan. The growing importance of the Arctic region, driven by climate change and heightened competition from Russia and China, has led the US to reassess its coldweather combat strategies.

At HAWS, the US delegation engaged in discussions on training, tactical operations, and potential future collaborations with the Indian Army, emphasizing field activities. HAWS, established in 1948, is renowned for its specialized training in snowcraft and winter warfare, offering courses like the Mountain Warfare and Winter Warfare Courses. These courses are essential for troops stationed in regions such as the Siachen Glacier. Personnel from several countries, including the US, UK, and Germany, also receive training at HAWS.

Similarly, the US Army's Army Mountain Warfare School (AMWS) in Vermont focuses on training for mountain and cold-weather operations, while the 11th Airborne Division, based in Alaska, specializes in Arctic operations. This division, reactivated in 2022, plays a key role in preparing the US Army for cold-weather combat in the rapidly changing Arctic environment.

The plea further sought a direction to mandate an extensive voter education campaign to raise awareness and importance of informed decision making.

"Today, 32 per cent educated people are not casting their votes. What a tragedy. If democracy will be dying like this and we will not be able to do anything then what will happen in the years to come in future," the petitioner said.

In April, the top court dismissed a batch of petitions seeking a return to the paper ballot

Terming the suspicion of manipulation of the EVMs "unfounded", the apex court then rejected the demand for reverting to the old system, saying the polling devices were "secured" and eliminated booth capturing and bogus voting.

However, the top court opened a window for aggrieved unsuccessful candidates securing second and third places in poll results and allowed them to seek verification of microcontroller chips embedded in five per cent EVMs per assembly constituency on a written request upon payment of a fee to the poll panel.

It directed that from May 1, the symbol loading units should be sealed and secured in a container and stored in a strongroom along with the EVMs for a minimum period of 45 days post-declaration of results.

'There are issues caused by local pressures, such as U-turns in unusual spots and wrong entry points from colonies. These need to be rectified. We must prioritize collective safety over individual convenience," Bukhari stated, adding that corrective measures would be implemented promptly. The inspection follows a tragic accident on

November 21, when two people died, and one was critically injured in a collision between a Mahindra Thar and a parked tipper in the Tengpora area of Srinagar. The incident has served as a wake-up call for stricter enforcement of traffic laws.

"That unfortunate accident reminds us of the urgency to take corrective measures. In the coming days, we will intensify action against traffic violators. There will be no compromise on road safety," Bukhari said.

**NEW DELHI:** Returning skipper Rohit Sharma will walk into the Indian playing XI for the second Test in Adelaide in place of young Devdutt Padikkal but in-form KL Rahul's batting slot in the pink ball warm-up game in Canberra will certainly keep everyone interested.

It will all depend on whether the injured Shubman Gill gets fit in time for the match, failing which Rahul might be slotted at number three in place of Padikkal. But there is a school of thought that believes the team might be served better if Rohit bats in the middle order, preferably at number five or six.

Rahul was seen more as a makeshift opener due to Rohit's absence going into the opening Test in Perth.

But he has been technically the most compact among all Indian batters across both innings at Optus Stadium, with scores of 26 and 77.

Having already played an India A game at the MCG and now a Test match, Rahul has settled



nicely at the top of the order. The Indian captain, who is also searching for runs, has been opening in Test matches for the past five years.

Rohit's numbers with the willow has been a bit underwhelming during the five home Tests but those were played on difficult tracks. On Australian pitches, with true carry and bounce, he could get back to form with liberal usage of the horizontal bat shots.

Gill, who has suffered a hairline fracture during the intra-squad game at the WACA, missed the first Test, and is yet

to start batting in the nets. Unless Gill gets adequate net practice, the team manage-

ment might not risk him, with only a couple of training sessions available with pink ball in Adelaide. If he is fit, then Dhruv Jurel will automatically get dropped.

The only possible tactical change in playing XI at the Adelaide Oval could be in spin

The two senior spinners --Ravichandran Ashwin and Ravindra Jadeja -- were benched in Perth at the expense of Washington Sundar.

If one goes back to the 2021 Pink Ball Test in Adelaide, Ashwin with figures of 4 for 45, including a beauty to dismiss Steven Smith, gave India the first innings lead before the 36-all out happened.

But, going by current form in the nets, there is not much to choose between Ashwin, Jadeja and Washington at the moment. There is also the fact that in Pink Ball Tests, the spinners don't come into equation a lot, and batting becomes key.

At the Adelaide Oval, expect some rejigging in batting order if not in the playing XI.

The Pakistan Tehreek-e-Insaaf party of the former Pakistan captain and prime minister Imran Khan started a protest march towards main Islamabad since Sunday. There have been incidents of clashes and violence reported between protestors and forces of law enforcement and security.

The federal interior minister Mohsin Nagvi, also the chairman of the PCB, had announced that the army had been called in to quell the unrest.

ICC Board To Meet On Nov 29 To Finalise Champions Trophy Schedule

The all-powerful board of the Interna-

tional Cricket Council will meet virtually on November 29 to finalise the much-delayed schedule of the Champions Trophy to be held in Pakistan in February-March next year.

The cause of the delay has been India's refusal to play in Pakistan considering the tense relations between the two countries. India has not toured Pakistan since the 2008 Mumbai terror attacks.

The BCCI wants the tournament to be played in a hybrid model with India games scheduled in a third country, preferably UAE, something that its Pakistani counterpart has not agreed to thus far.

The crucial virtual meeting takes laces two days before BCCI secretary Jay Shah takes over as ICC chairman on December 1.

He and other board members would be keen to resolve the matter before the new regime takes over.

With the deadlock over the schedule and venue yet to be broken, questions have been raised against the current dispensation of the ICC including chair Greg Barclay and CEO Geoff Allardice over why it did not resolve the issue earlier and left it for the 11th hour.

With the Indian government firmly sticking to the status quo, Champions Trophy in a hybrid model with India games outside Pakistan is the most likely option.
