

Dachigam Shootout Leaves 1 Dead

Police Identifies Slain As Terrorist Involved In Gagangir Attack

Srinagar: A Lashkar-e-Taiba terrorist, alleged to be the mastermind of the October 20 attack in central Kashmir that left seven people dead, was killed in an encounter with security forces in the Dachigam forest area on Tuesday.

Officials said, the terrorist of the banned Lashkar-e-Taiba (LeT) was identified as Junaid Ahmed Bhat. He was involved in other crimes, including shooting at non-locals in south Kashmir last year.

The October 20 strike along with a Pakistani terrorist near a tunnel construction site in Gagangir, a place close to tourist spot Sonamarg, resulted in the deaths of a local doctor and six others. Following the attack, Bhat was listed as a 'Category A' terrorist, indicating him to be most wanted. According to the officials, security forces, acting on specific intel-

J&K's Drug Crisis: 26% Of Prison Inmates Linked To Narcotics

Srinagar: In a grim reminder of the growing menace of drug abuse in Jammu & Kashmir, as many as 26 percent of inmates in the Union Territory's prisons are there for drug -related offences

The latest data released by J&K Prison department shows that out of 5335 persons languishing in different jails as on October 31, 2024 ,1413 were arrested or detained under "The Narcotic Drugs and Psychotropic Substances Act, 1985"- the law used to combat narcotics and psychotropic



substance abuse in India. Of these 1413 inmates, 23 are convicts, 1242 are undertrials and 148 are detenues, the data reveals. data, 28 According to

'World Disability Day' Marked As 'Black Day' In Srinagar

Srinagar: The Jammu and Kashmir Handicapped Association observed World Disability Day as a "black day". They staged a protest in Srinagar's Press Enclave on Tuesday.

The protesters, holding banners and raising slogans, called for immediate government action to improve the welfare of the disabled community. They demanded a comprehensive overhaul of the existing system, citing the need for a special recruitment drive for qualified disabled individuals and revision of the reservation system in government jobs from

ous noise." Another resident, Mubashir from Chattabal, said, "Our children can't study properly because of the noise. 'Sale sale sale, 150 rupees sale'-this is what we are hearing all day,' he said, adding, "Once the sale is over, another vendor shouting 'Tamatar, Mattar, Gougjii'

Gaza, Ukraine Wars, **Regional Tensions Boosting Arms Sales: Report**

Sweden: Sales by major arms makers were boosted last year by wars in Ukraine and Gaza and tensions in Asia, with marked increases for manufacturers based in Russia and the Middle East, a report said Monday.

Sales of arms and military services by the world's 100 largest arms companies totalled \$632 billion in 2023, up 4.2 percent, according to a report by the Stockholm International Peace Research Institute (SIPRI)

Revenues had dipped in 2022 as global weapons makers struggled to meet the increase in de-

"A lot of them specialise in either a component of something or build systems that require one set of supply chains," allowing them to react more quickly. Nan Tian, Director of SIPRI's Military Expenditure and Arms Production Programme, told AFP.

Among the leading producers, US companies recorded a 2.5 percent increase in their sales last year and still account for half the world's arms revenues, with 41 US weapons producers in the world's top 100.

Lockheed Martin and RTX (formerly Raytheon Technologies), the world's two largest arms makers, on the other hand, report

mand, but many of them managed to increase production last year, the authors of the report noted.

In a sign of this surge in demand, all 100 companies tracked achieved sales in excess of \$1 billion last year for the first time.

"There was a marked rise in arms revenues in 2023, and this is likely to continue in 2024," Lorenzo Scarazzato, a researcher with the SI-PRI Military Expenditure and Arms Production, said in a statement.

Sales from the world's top 100 arms companies "still did not fully reflect the scale of demand, and many companies have launched recruitment drives, suggesting they are optimistic about future sales," Scarazzato added.

Smaller producers have been more effective in meeting the demand linked to the wars in Gaza and Ukraine, growing tensions in East Asia and rearmament programmes in other regions, the ined a fall in revenue of 1.6 percent and 1.3 percent respectively.

Such behemoths "often depend on complex, multi-tiered supply chains, which made them vulnerable to lingering supply chain challenges in 2023," Tian said.

Russia's Rostec surges In Europe, home to 27 of the top 100, arms makers on average saw an increase of just 0.2 percent.

But European groups manufacturing complex weapons sys tems were still in the process of honouring old contracts last year, so the revenues do not reflect the influx of orders since then.

"At the same time, a num ber of other European producers saw their arms revenues grow substantially, driven by demand linked to the war in Ukraine, particularly for ammunition, artillery and air defence and land systems," SIPRI noted.



"Apocalyptic": UN Chief On Situation In Gaza Amid Israel-Hamas War

Cairo: The United Nations chief said Monday the situation in war-torn Gaza was "appalling and apocalyptic", warning conditions faced by Palestinians in the territory may amount to the "gravest international crimes".

In remarks read out on his behalf at a Cairo conference aimed at increasing humanitarian aid. UN Secretary-General Antonio Guterres urged the international community to "build a foundation for sustainable peace in Gaza and

across the Middle East". The war in Gaza broke out

when Palestinian group Hamas attacked southern Israel on October 7, 2023, resulting in 1,208 deaths, mostly civilians, according to an AFP tally of Israeli official figures.

Israel's retaliatory campaign has killed 44,429 people in Gaza, according to figures from the territory's health ministry that the UN considers reliable.

Guterres highlighted the devastating toll of the conflict and the urgent need for international action. "Malnutrition is rampant... Famine is imminent. Meanwhile.

the health system has collapsed," he said.

The UN chief added that Gaza now has "the highest number of children amputees per capita anywhere in the world", with "many losing limbs and undergoing surgeries without even anesthesia".

The secretary-general also criticised the severe restrictions on aid delivery, calling the current levels "grossly insufficient".

According to UNRWA's count, only 65 aid trucks per day had been able to enter Gaza this past month, compared to a pre-war average of 500.

International aid organisations have repeatedly raised alarm over the deteriorating conditions in Gaza, warning that civilians are

lowest since the start of the war.

conflict imposed a complete siege for a period on the Hamas-ruled territory, has blamed aid issues on what it says is the inability of relief organisations to handle and distribute large quantities of aid.

UN's Guterres said on Monday that the blockade of aid to Gaza "is not a crisis of logistics" but rather "a crisis of political will and of respect for fundamental principles of international humanitarian law".

UNRWA said all the attempts it made to deliver aid into northern Gaza had either been "denied" or "impeded" between October 6, 2024 and November 25, amid fierce fighting in the area.

Guterres said UNRWA is an "irreplaceable lifeline for millions of Palestinians", adding that "if UNRWA is forced to close, the responsibility of replacing its vital services ... would rest with Israel".

40 Years After Horrific Bhopal Gas Leak, Ailments Rise At Faster **Pace Among The Affected**

Bhopal: An organisation working with survivors of the Bhopal Gas Tragedy, the world's worst industrial disaster, on Monday said ailments were being detected among those affected at a rate much higher than those who remained unexposed.

The outcome was based on analysis of clinical data of 16305 gas-exposed and 8106 unexposed patients, the Sambhavana Trust Clinic functionaries told report ers here.

These patients received care at their facility in the last 16 years, they said, adding the data highlighted the need for continued medical research and sustained healthcare services for the victims.

In the intervening night of December 2-3, 1984, highly toxic gas methyl isocyanate (MIC) leaked from the Union Carbide factory, killing 5.479 people and maiming more than five lakh others.

"Rates of diseases known to disproportionately affect gas-exposed populations, such as respiratory illnesses and mental health disorders, remained significantly higher throughout the last 16 years. Both obstructive and restrictive types of respiratory diseases were 1.7 to 2 times higher in the gasexposed group compared to the unexposed population," physician Dr Usha Arya of the Trust said.

Diabetes was found to be five times higher among the gas-exposed patients compared to the non-exposed. Hypertension was found to be over three times higher," Arya said.

Gynaecologist Dr Sonali Mittal said hormonal conditions such as early and premature menopause were 2.6 times more frequent in gas-exposed women than those who were not exposed.

"Kidnev-related conditions. possibly ignited by the initial injury from MIC (Methyl Isocyanate) exposure, have remained seven times higher in the exposed group. Acute conditions like myocardial infarction and ischemic heart diseases were found to be 4.5 times more prevalent in the gas exposed population," pointed out physician Dr B Raghuram

Shedding light on the neurological conditions, physician Dr P K Aswathi said hemiplegia and neuralgia were found to be almost four times more common in the gas-exposed group.

"Neuropathy, likely influenced by factors such as diabetes. was found to be seven times more prevalent in the exposed population. We also found that hypothyroidism, a metabolic disorder, has been rising over the past seven years in both populations but remains 1.7 times higher in the gasexposed group," Awasthi said.

J&K Has Over 43,000 Lakhpati Didis: GoI

SRINAGAR: The Government of India on Tuesday informed the House that Jammu and Kashmir has a total of 43,050 Lakhpati Didis.

The figures were revealed through a written reply by the Minister of State in the Ministry of Rural Development, Dr. Chandra Sekhar Pemmasani.

In a written reply, he said that the Lakhpati Didi initiative is one of the outcomes of DAY-NRLM. A structured approach has been adopted to make SHG members "Lakhpati," i.e., to ensure they earn a minimum income of Rs 1 lakh per year on a sustainable basis

He said that the Deendayal Yojana–National Antyodaya Livelihoods Mission Rural (DAY-NRLM) is a centrally sponsored scheme of the Ministry of Rural Development.

"It is being implemented across the country (except Delhi and Chandigarh) with the objective of alleviating rural poverty, primarily by organizing rural poor women into Self Help Groups (SHGs) and continuously nurturing and supporting them. The aim is to help them achieve a significant increase in income over time, improve their quality of life, and lift them out of abject poverty," the Minster said.

He said that the NAMO Drone Didi Scheme of the Ministry of Agriculture and Farmers' Welfare aims to provide drones to 15,000 SHG members under DAY-NRLM from 2023-24 to 2025-26. "In 2023-24, fertilizer companies, using their own resources, distributed 503 drones to SHG members," he said.

"Under DAY-NRLM, 10.05 crore women have been mobilized into 90.87 lakh SHGs as of October 2024. DAY-NRLM is a process-driven program where various benefits, such as Revolving Fund, Community Investment Fund, and Bank Linkage, are extended to SHGs based on their eligibility and requirements," he added.

"The Ministry has commissioned impact evaluation studies to assess the financial independence of SHG women through interventions under DAY-NRLM. An impact evaluation study of DAY-NRLM was conducted in 2019-20 by the International Initiative for Impact Evaluation, with support from the World Bank," he said.

Proposed Pahalgam Railway Sparks Outrage Among South Kashmir Farmers

SRINAGAR: Local farmers in the Anantnag-Bijbehara region of South Kashmir have launched protests against the proposed expansion of the railway network to Pahalgam, citing concerns over the destruction of orchards and fertile fields.

Political parties have also joined the chorus of opposition, demanding that the state and central governments reconsider the plan.

The central government has proposed extending the railway line from Anantnag to Pahalgam, a key tourist destination and the base camp for the Shri Amarnath Yatra. While a regional survey for the project is underway, the move has triggered alarm among local farmers, who fear that hundreds of acres of agricultural land will be rendered barren. Farmer Aqib Mir voiced concerns about the devastating impact on the region's econ-

SRINAGAR: There is a huge gap of nearly 200 MWs to overcome the unscheduled power and distress cuts in Kashmir as at present less than 1500 MWs are available against a total requirement of 1700 MWs.

Top officials in the Power Development Department (PDD) said that the local DIS-COM in Kashmir vallev was not getting the same amount of power in which the consumers could not face distress cuts and unscheduled power cuts.

"Right now, we require at least 1700 Megawatts to provide distress free power to our consumers as per the load curtailment schedule so that there are no unscheduled power cuts," the official said.

WORLD DISABILITY DAY

Supreme Court Guidelines Not Being Implemented, Says Padma Shri Awardee

SRINAGAR: On World Disability Day, Javed Ahmad Tak, a Padma Shri awardee and a specially-abled person from south Kashmir, expressed serious concerns over the nonimplementation of Supreme Court guidelines and the Rights of Persons with Disabilities Act 2016 in Jammu and Kashmir.

Tak said that despite the clear directives, including reservations in promotions for employees with disabilities, the J&K government has failed to enforce these policies, which has left many persons with disabilities in a state of stagnation and discontent. "It is unfortunate that peo-

ple with disabilities continue to protest on World Disability Day to press for their rights. Such protests reflect the marginalised position of this community," he lamented. "World Disability Day is not about charity; it's about enhancing the capabilities of persons with disabilities and ensuring their full inclusion in society." Despite the launch of the

'Accessible India Campaign' by Prime Minister Narendra Modi, Javed criticised the minimal progress made on the ground, claiming that only "superficial" changes have been made, and most funds allocated for accessibility have lapsed.

The government should have issued a directive mandating accessibility in all new public buildings, including facilities like ramps and lifts, to ensure that persons with disabilities are not sidelined, he said.

"The absence of special educators, disabled-friendly washrooms in schools and suitable teaching materials is a major barrier for disabled students. How can they attend school without proper provisions?" Tak asked.

He said the government has failed to implement the four per cent job reservation for people with disabilities, a policy that remains largely ignored in many sectors.

Javed further said that while the government has exempted persons with disabilities from exam fees, in practice, students are often asked to submit fees, and even clerks are unaware of the exemption. He lamented that the community is often treated as invisible and that the government's failure to provide basic assistance, such as necessary medicines and related support, is a direct violation of their rights.

Tak also raised concerns about the social security pension for people with disabilities in Jammu and Kashmir, which is only Rs 1,000-far below the range of Rs 5,000 to Rs 15,000 provided in other states and Union Territories. He called for an immediate increase to Rs 6,000 per month and demanded that heads of families with disabilities be exempted from electricity and water charges, and provided free ration to support their livelihoods.

Mohammad Rafee, a wheelchair-bound person from Srinagar, said that while World Disability Day is celebrated with much fanfare, the commitment to addressing the challenges faced by persons with disabilities often wanes after the day's events.

"In Kashmir, individuals must pledge to address these challenges, but too often, the commitment fades away," he said. Rafee said there are issues like inaccessible infrastructure, attitudinal barriers, health access, stigmatisation, and the lack of employment opportunities.

Mudasir Ahmad, Principal of Abhinandan Home Srinagar, highlighted the remarkable achievements of students with disabilities, despite facing numerous challenges. "Our deaf and dumb students have outperformed their nondisabled peers, securing top positions in events like the Kashmir Marathon," he said. "They have also shown exceptional talent in painting, sports, and vocational training, proving that disability is not a limitation."

Mudasir added that the educational landscape in Jammu and Kashmir is struggling to meet the needs of students with disabilities due to a severe shortage of special educators. "At least 300 special educators are needed to cater to students with disabilities, especially at the college level where there is no support for 12th-pass students with disabilities," he said. -(KNO)

Rising Heart Attacks

ome winter, the heart attacks show a sharp surge in number. This is because cold and harsh weather often lead to reduced physical activity during winter. This inactivity can result in weight gain, higher blood pressure, and increased cholesterol levels. collectively raising the risk of heart issues. R esports cit-ing the senior cardiologists in the Valley have indicated a 20 to 40 percent likelihood of increased heart attacks during the winter season. The winter is very harsh in the Valley and its onset brings with it several health-related ailments. However, the incidence of heart attacks has increased in recent years. Its victims have not just been elderly people but increasingly younger individuals are facing serious heart-related issues.

However, these issues are not traceable to weather changes, even though it is a factor. Health experts have pointed to increasing substance abuse, and sedentary lifestyles as the primary culprits. Some even have blamed the post-Covid complications, albeit there is still no conclusive evidence.

Similarly, a sedentary lifestyle, excessive consumption of junk food, and widespread smoking, especially among young people, are also contributing factors to the elevated risk of heart attacks. According to the National Health Family Survey 5, a substantial percentage of men in Jammu and Kashmir are smokers of cigarettes and other tobacco products.

Experts have also sounded alarm on the escalating problem of substance abuse among the youth. The use of opioids, inhalants, and particularly heroin, has surged, leading to overdose-related deaths and heart attacks. A survey conducted by the Union Ministry of Health has revealed that around 9 percent of the population of Jammu and Kashmir has diabetes. The reason for this is again our unhealthy lifestyle. A significant number of people don't exercise, nor do we eat balanced food.

One more factor that has affected the health of a large mass of people is the stress and depression which has now become veritably an epidemic in Kashmir. According to a study carried out by the Doctors Without Borders in 2016, nearly 1.8 million people in the region suffered from mental health disorders. But it is clear that the number has since only further risen. We need to have a proper study to get an estimate of how many are afflicted by the disease now. Compounding the growing mental health burden in the UT is the lack of adequate mental health services, creating a significant treatment gap. Last year, in a welcome effort toward prioritizing mental health, J&K had set up a dedicated mental health authority. The primary objective of this authority is to oversee and regulate all mental health facilities within the region, ensuring they are properly registered and conform to established guidelines. That said, we need a proper investigation of the growing incidence of heart attacks in the UT. And more importantly, we need to improve and upgrade the health infrastructure to ensure swift medical attention to the people when they suffer from heart attacks. As of now, many lives are lost as the patients can't be moved to hospitals quickly enough to be administered treatment. It is time the government pays attention.

Children with Disabilities: Co-curriculars Help With Learning Disability

earning disability is described as certain kinds of learning problems that can cause someone to have trouble learning or using certain skills (such as reading, writing, listening, speaking, reasoning, and doing math). Due to such academic difficulties, kids may feel insecure and frustrated when they are unable to complete the academic difficulties that have been placed before them.

They can find a method to express themselves outside of the classroom through cocurricular activities, which can help them feel successful about accomplishing something in a different way. Eventually, these students will need special guidance and support from their educators.

Participation of children with disabilities in sports and cultural activities, programs, promotes physical, emotional, and social wellbeing. Co-curricular activities can make a huge difference in a life of children with special needs (CWSN). These activities can enhance learning, while offering ways for students to express themselves and explore their strengths. Out of home, to the Resource Room, (irrespective of their disability), to the playground, on the stage, facing the teachers, peers and at times general public also showing their talents, academic, and sporting prowess speaks volumes of the overall development of CWSN. Participation in cultural programmes and curricular activities is a source of inspiration and development of self-confidence.

Behaviour which cannot be inculcated through academic activities can be developed through co-curricular activities and other recreational programs. Descriptive exploratory survey design was employed in the present study to answer the research questions. The findings of the present study revealed that children with special needs voluntarily participates in sports and cultural activities and CWSN are competent of performing with regular students in sports and recreational activities in areas such as Drawing, Music, Dance, and Sports, in preparation of illustrative aids as well. The impact of participation of CWSN in these activities on their development was reflected in; confidence in self leading to the development of self concept.

Extracurricular activities (ECAs) are a

core part of the student experience, especially regarding skills and personal development, sense of belonging and graduate outcomes, as has recently been emphasised by universities. Indeed, they are often used to distinguish graduates in job applications. However, students with a disability are under-represented in these opportunities and suffer as a result.

A learning objective has to be set in order to improve the student's writing skills. This objective cannot be directed towards perfection because it is hardly possible for an autistic child to acquire the writing skills of the same level as in case with an ordinary child. By the end of the experiment the student will demonstrate his ability to understand the information, to discuss it, and to reflect his ideas in writing.

Taking into account the disability of the student, no separate activity can be offered

in order to meet the learning objective. Instead, a set of activities implemented stepby-step is better to use. Since the student in question has kinesthetic style of learning, multisensory learning seems to be the most appropriate and beneficial for him due to his visual learning (reading) being his major strength. If the student is able to read, he is able to perceive pictures/objects and interpret their meaning. The set of offered activities consists in playing associations through describing the qualities of given objects first orally and then in writing. The second stage of the experiment will consist in skipping the discussion stage and offering the student to write about the object at once.

Improving the writing skills of the students in regular education classroom could be achieved through the like activities. Considering the fact that the regular students' general reading and writing skills are better, the activities should be more complicated. For example, the pictures can be used instead of the objects (because describing the objects is too easy for the fifth grade). The students can be offered to describe two pictures separately and then to compare them. This can not only improve their writing skills, but give them an idea of a proper essay structure and make the flow of their thoughts more logical.

Education is not merely obtaining a degree or boosting the intelligence of students but also an all-around holistic development of an individual -physical, intellectual, emotional, spiritual, social, and moral development. It goes beyond only helping pupils achieve academic success or increase their intelligence. Collectively, all educational activities result in total development in all spheres. In the teaching of academic subjects, the cognitive aspects are fostered more, but the emotive and psychomotor aspects are not. Co-curricular activities and programs that take place outside of the typical classroom but in some way support academic learning from the classroom curriculum are known as co-curricular activities. Co-curricular activities aid them to enjoy and at the same time benefitting their growth.

Diversity groups are more likely to get involved with causes that concern them directly, so peer mentoring, awareness days or student-staff partnerships aimed at improving the student experience can all be ways to engage these students. When these events are targeted well, there is potential for students to become experts, be validated and have a say in how they are represented. For example, an awareness day for a disability could include a screening of a movie that a student chose to represent their experience and share with others.

The benefits of physical activities are universal for all children, including children with special needs. The participation of children with disabilities in sports and recreational activities promotes inclusion, optimizes physical functioning, and enhances overall well-being. Despite these benefits, children with disabilities are more restricted in their participation, have lower levels of fitness, and have higher levels of obesity than their peers without disabilities.

Developing inclusive schools that cater to a wide range of pupils in both urban and rural areas requires: the articulation of a clear and forceful policy on inclusion together with adequate financial provision; an effective public information effort to combat prejudice and create informed and positive attitudes; an extensive programme of orientation and staff training; and the provision of necessary support services.

To conclude co-curricular, improve academic performance by fueling learning, stimulating creative thought, and building a passion for particular subjects. It enhances social skills, which are important skills to build for college, career, and life in general, and provides students with a chance to build friendships. It also can develop or help a student to find a new interest, talent, or career goal.

Insulin Resistance May Make Men More Prone To Common Heart Valve Disease


nsulin resistance can increase the risk of aortic stenosis-a common heart valve diseasein men over the age of 45, finds a study on Wednesday.

The study published in the peerreviewed journal Annals of Medicine may open doors to new treatments for aortic stenosis, which can lead to life-threatening heart failure.

Aortic stenosis occurs when the aortic valve narrows or does not open fully, reducing blood flow from the heart to the body. If not addressed timely, the valve will gradually thicken and stiffen, making the heart work harder to pump blood.

Researchers from the Kuopio University Hospital, in Finland identified several biomarkersfasting insulin, insulin at 30 minutes and 120 minutes, proinsulin, and serum C-peptide-related to high insulin resistance in people with aortic stenosis.

A person is said to be insulin resistant when his or her body is unable to respond well to insulin. This prompts the body to produce more insulin than normal to manage blood sugar levels.



Importantly, the team found that these biomarkers remained significant predictors of aortic stenosis, even after adjusting for other known risk factors, such as body mass index (BMI) and high blood pressure, or excluding participants with diabetes or an aortic valve malformation.

"This novel finding highlights that insulin resistance may be a significant and modifiable risk factor for aortic stenosis," said lead author Dr Johanna Kuusisto, from the Kuopio University Hospital, in Finland.

As insulin resistance is becoming increasingly common, "managing metabolic health could be a new approach to reduce the risk of aortic stenosis and improve cardiovascular health in ageing populations", Kuusisto added.

For the study, the researchers analysed data from 10,144 Finnish men aged 45 to 73 years old, all initially free of AS. After an average follow-up period of 10.8 years, 116 men (1.1 per cent) were diagnosed with aortic stenosis.

While weight control and exercise are known to improve insulin sensitivity, Kuusisto called for further studies to explore how these lifestyle modifications can help prevent the heart condition.

Study Reveals Increased Risk Of Pregnancy Complications Due To Pollution

Exposure to PM2.5 pollution is linked to higher inflammation levels among pregnant women, which can potentially result in adverse birth outcomes, such as low birth weight and preterm birth, according to a study.

The findings, published in the journal Science Advances, provided a new understanding of the biological routes through which air pollution affects pregnancy and birth outcomes, researchers said.

Particulate matter (PM) 2.5 pollution is caused by particles sized 2.5 micrometres or less. Common sources are vehicular and industrial emissions, while natural ones can include carbon from wildfires and dust. The study, led by Harvard Uni-

versity's School of Public Health, US, found that exposure to PM2.5 can influence the histones of pregnant women. Histones are proteins found in chromosomes, vital to DNA structure and cell function.

Air pollution can, thus, disrupt the normal balance of cytokine genes -- genes involved in producing immune responses -- and lead to increased inflammation in both women and foetuses, the researchers said.

Among pregnant women, the increased inflammation could be



related to adverse pregnancy outcomes, they said.

"Our findings highlight the importance of minimising air pollution exposure in pregnant women to protect maternal and foetal health," co-author Youn Soo Jung, a research associate at Harvard University's School of Public Health, said.

"Policy interventions to improve air quality as well as clinical guidelines to help pregnant women reduce their exposure to pollution could have a direct impact on reducing pregnancy complications," Soo Jung said.

While previous studies have found links between PM2.5 exposure and complications in maternal and child health including low birth weight and developmental delays, the study is the first to examine the effects of PM2.5 on maternal and foetal health at a cell level, the authors said

The study involved both nonpregnant women and 20-week pregnant women. Average exposure to PM2.5 was calculated using air quality data from the US Environmental Protection Agency.

Within each cell, the researchers were able to map changes to histones -- the proteins that help control the release of cytokines, which are known to help regulate inflammation.

"These modifications in specific histones and cytokines could indicate the toxicological mechanism of PM2.5 exposure in inflammation, inflammasome pathway, and pregnancy complications," the authors wrote.

LS Passes Banking Laws (Amendment) Bill Allowing 4 **Nominees In Bank Accounts**

NEW DELHI: The Lok Sabha on Tuesday passed the Banking Laws (Amendment) Bill, 2024, which allows bank account holders to have up to four nominees in their accounts.

Another proposed change relates to redefining 'substantial interest' for directorships, which could increase to Rs 2 crore instead of the current limit of Rs 5 lakh, which was fixed almost six decades ago. The Bill piloted by Finance

Minister Nirmala Sitharaman was approved by a voice vote. Replying to the debate on the Bill, Sitharaman said depositors will have the option

of successive or simultaneous nomination facility, while locker holders will have only successive nomination. She also said that since

2014, the Government and the RBI have been extremely cautious, so that banks remain stable.

"The intention is to keep our banks safe, stable, healthy, and after 10 years you are seeing the outcome," Sitharaman said.

The bill proposes to in-crease the tenure of directors (excluding the chairman and whole-time director) in cooperative banks from 8 years to 10 years, so as to align with the Constitution (Ninety-Seventh Amendment) Act, 2011.

Once passed, the bill would allow a director of a Central



Cooperative Bank to serve on the board of a State Cooperative Bank.

The bill also seeks to give greater freedom to banks in deciding the remuneration to be paid to statutory auditors. It also seeks to redefine the reporting dates for banks for regulatory compliance to the 15th and last day of every month instead of the second and fourth Fridays.

"The proposed amendments will strengthen governance in the banking sector and enhance customer convenience with respect to nomination and protection of investors," Sitharaman said while moving the bill for consideration and passing.

members Opposition fiercely criticised the bill with TMC MP Kalyan Banerjee describing it as a "donkey passage towards privatisation of the Indian banking sector". While the bill ostensibly

seeks to improve bank guarantees and investor protec-

tion, its real intent is to reduce the government's minimum holding in public sector banks from 51 to 26 per cent, he argued.

Banerjee also flagged cybersecurity concerns, emphasising the need for robust IT systems to detect fraud and ensure strict adherence to data privacy regulations. Congress Member Karti

Chidambaram also raised the issue of rising cyber frauds in the country and wanted to know what the government was doing to stop that.

Chidambaram also said that the tyranny of KYC should be stopped as multiple calls are being received by people though nothing has changed.

Aviation Minister Naidu Moves Bill To Replace 90-Yr Old Aircraft Act

NEW DELHI- Union Aviation Minister Kinjarapu Rammohan Naidu on Tuesday moved a bill, which seeks to replace the 90-year-old Aircraft Act, for passage in Rajya Sabha.

The Bharatiya Vayuyan Vid-heyak, 2024, was passed in the Lok Sabha in the last session of Parliament in August this year. Moving the bill for consideration and passage, Naidu said that the bill was taken up after a suggestion by The Interna-tional Civil Aviation Organization (ICAO) to amend the prin-

cipal act. "We have organised everything in the bill which provides different section for powers of bodies like DGCA. So there is clear demarcation and indication on which each body has to do as recommended by ICAO,"

he stated. Naidu mentioned that the aviation sector has the potential to drive the economy and should be expanded.

He informed the House that the number of airports has increased from 74 in 2014 to 157 in the country and the fleet size has also doubled from 400 (aircraft) in 2014 to 813.

"In the earlier Act, only the world maintenance was mentioned. There was no definition. Now we adding design and manufacturing also. We are also defining all these three terms (in the new law). We have brought the appeal system," he stated.

The minister explained that most of the times, we amend rules of the Act with backing of the principal act and that is why we are amending the



principal act.

"We are giving strong legal backing to the rules under the Act," he stressed.

He also stated that today everybody wants to have an airport in their district.

"We want to cater to those dreams. We want to build those airports. We feel that if we cannot do it today, it will be a challenge tomorrow. The land is going to be scarce," he added.

The Bill seeks to resolve existing anomalies between various aviation laws and ensure a coherent regulatory environment with well-defined chapters and clauses.

With the proposed legislation, the ministry also aims to promote the ease of flying by having a robust regulatory framework, encouraging foreign direct investment, and ensuring compliance with international conventions and

best practices. Congress MP Syed Naseer Hussain raised the point that the name of the bill should not be in Hindi as 60 per cent of the population is non-Hindi

Speaking. He said that naming the bill in Hindi is an exclusionary trend as it is difficult for non-Hindi-speaking people to comprehend.

For projects that do come up for review, PRAGATI's integrated approach helps break long-standing deadlocks in areas such as land acquisition and environmental clearances.

A Digital Governance Ecosystem

PRAGATI operates within a broader ecosystem including PM Gati Shakti for infrastructure planning and PARIVESH for environmental clearances. This integration has dramatically reduced approval timelines environmental clearances that once took 600 days can now be obtained in 70-75 days. The study offers key lessons for other emerging economies: the importance of high-level leadership in driving digital transformation, the value of regular review mechanisms, and the power of integrated platforms in accelerating development. New Zealand Penalised WTC Points, Drop To Fifth In Table

New Zealand's aspirations of qualifying for the World Test Championship Final suffered a setback after they were docked three penalty points due to slow over-rate against England leading to a drop in the ranking table, the ICC stated on Tuesday.

The deduction is a welcome news for India, who enjoy pole position with 61.11 percentage points. New Zealand now have a points percentage of 47.92 percent and can only move as high as 55.36 percent with victories from their remaining two fixtures against England. South Africa (59.26), Australia (57.26) and Sri Lanka (50) are placed second, third and fourth

respectively. While England are already out of contention of reaching next year's final despite the impressive eight-wicket triumph at Hagley Oval, the loss in competition points is a major blow to New Zealand who drop from equal fourth to outright fifth on the standings as a result.

It means the inaugural World Test Championship winners face a tough ask to qualify for next year's one-off Test in June 2025.

LONDON: The captains of two English Premier League teams are in the spotlight for their choices last weekend when the competition celebrated LGBTQ+ inclusion in its campaign to promote equality and diversity.

Rainbow-colored captain armbands were issued to the 20 clubs for matches last weekend and the upcoming midweek round.

Ipswich's Sam Morsy was the only captain in action who didn't wear the rainbow armband, with the club saying he made the decision "due to his religious beliefs."

Morsy, a British-born Egypt midfielder, is a practising Muslim.

Ipswich said it "respect(s) the decision" of Morsy but is "committed to being a fully inclusive club."

"We will continue to grow an environment where all are valued and respected, both on and off the pitch," Ipswich said.

Crystal Palace will play Ipswich on Tuesday and its captain, Marc Guehi, wore a rainbow armband bearing the words "I love Jesus" on it during the match against Newcastle on Saturday. A heart was used instead of the word "love.'

The England defender, who is a de-



vout Christian, could face punishment if it is judged to be a religious slogan. The laws of the game allow "initiative slogans/emblems" but don't allow "political, religious or personal slogans, statements or images."

The league's Rainbow Laces campaign, introduced in 2013, is in partnership with LGBTQ+ charity Stonewall and includes a range of activities to "highlight community and education initiatives designed to encourage discussion and promote allyship with LGBTQ+ communities," the competition said. Rainbow Laces branding is widely visible within stadiums on things like corner flags and ball plinths.

In France, Nantes fined striker Mostafa Mohamed for refusing to play against Toulouse last year on the weekend teams wore rainbow-colored numbers on their jerseys to support the fight against homophobia. In May, Monaco midfielder Mohamed Camara was given a four-game suspension by the league for covering up an anti-homophobia message on the team's shirt during the club's final league game of the season. 


