IIT Indore Designs Technology To Protect Farmers' Fruits And Vegetables, Extend Their Shelf Life

Researchers at the Indian Institute of Technology (IIT) Indore have developed a special LED light-based storage technology that protects farmers' fruits and vegetables from getting spoiled and helps extend their shelf life, an official said on Wednesday.

The technology employs photodynamic inactivation (PDI) of microbes using a specially designed kit, which utilizes a safe, derivatized vitamin B2 spray as a photosensitizer and a flash visible light source at effective wavelengths of 455 and 476 nm (nanometres), he said. This combination destroys microbes on open and packed food items, ensuring complete sterilization and preventing microbial reproduction, the official explained.

He said this innovative technology can prove to be very beneficial, especially for cultivators with small farms who want to keep their produce safe in their home until they get better prices.

"With the help of our technology, fruits and vegetables can be preserved for 30 to 40 days without cold storage in a 10x10 square feet room at a cost of only

Rs 1,000 per month," IIT Indore professor Debayan Sarkar told PTI.

He said under this technology, blue and green LED light of special wavelength is cast on fruits and vegetables and a special spray of vitamin B2 is done on them as a photosensitizer, thus protecting them from getting spoiled, extending their shelf life and keeping them fresh longer.

The system has been linked to a mobile application that allows farmers to monitor fruits and vegetables even while staying away from their storage rooms, Sarkar maintained.

Omar Govt At Odds With Raj Bhavan?

Srinagar: Less than two months into its tenure, the newly elected Omar Abdullah government in Jammu and Kashmir is reportedly facing differences with the Raj Bhavan over several administrative issues, according to sources in the know.

Following the imposition of central rule in Jammu and Kashmir in 2018, the governor and subsequently, the current lieutenant governor, Manoj Sinha, maintained full administrative powers. However, the dynamics shifted after the elected government assumed office on October 16.

Under laws enacted by Parliament, the lieutenant governor retains authority over All India Service officer

other responsibilities. However, recent actions taken by the LG administration have sparked tensions, particularly concerning several transfers of Jammu and Kashmir Administrative Service officers that were ordered while Chief Minister

Abdullah was away in Saudi Arabia for pilgrimage. While some transfers of IAS officers fall within the LG's iurisdiction, the elected government has voiced strong objections against the transfer of certain Jammu and Kashmir administrative officers ordered by the LG, the sources said.

Another point of contention involves the position of Advocate General D C Raina, who had submitted his resignation prior to the Omar Abdullah government's formation. Raina initially appo

Speaking to Kashmir Observer, Dr. Ahmad emphasized that while La Niña can influence global weather patterns, it does not specifically trigger snowfall or extreme cold in Kashmir

Diabetes Cases: Centre

Srinagar: Jammu and Kashmir has recorded a total of 46,99,015 diabetes patients as of November 30, 2024, the Ministry of Health and Family Welfare said on Friday.

The data indicates that 43,18,708 patients have been screened for diabetes, 3,41,071 have been diagnosed with the condition, and 3,40,236 are currently under treatment.

The government said that the Department of Health and Family Welfare, Government of India, provides technical and financial support to states and Union Territories under the National Programme for Prevention and Control of Non-Communicable Diseases (NP-NCD), as part of the National Health Mission (NHM).

"This program focuses on strengthening infrastructure,



human resource development, early diagnosis, referrals for treatment, and health promotion to prevent non-communicable diseases (NCDs) including diabetes," it said.

"A population-based initiative for the screening, management, and prevention of common NCDs, including diabetes, has been launched as part of the Comprehensive Primary Health Care under NHM," the government added. (KNO)

KEEMA Raises Alarm Over Closure of 701 MSMEs In J&K

Srinagar: The closure of 701 Micro, Small, and Medium Enterprises (MSMEs) in Jammu and Kashmir over the past four years has sparked grave concerns within the industry, with the Kashmir Electrical Equipment Manufacturers Association (KEEMA) warning that the actual figures may be much higher.

"The actual number of closures is far higher, with many units shutting down silently due to unsustainable conditions," said KEEMA Secretary General Waseem Ahmed Khateeb, emphasizing that the reported data only scratches the surface of a much deeper

crisis. KEEMA President Raja Nayeem Ahmed Khan highlighted how flawed policies are driving local industries to the brink of collapse. "Despite policies designed to uplift MSMEs, including the MSME Act of 2006, their implementation has been grossly inadequate," Khan said, pointing to violations in public procurement processes. Under the MSME Act, 358 items are reserved for exclusive procurement from MSEs, and 25% of public procurement is mandated to come from these enterprises. However, KEEMA

Uproar in Lok Sabha as **BJP links Congress with US** billionaire George Soros

New Delhi: Lok Sabha proceedings were on Friday adjourned for the day amid protests by Opposition members over BJP's attempts to link the Congress party to US-based billionaire investor George Soros.

BJP member Nishikant Dubey raised the issue during Zero Hour, plunging the House into chaos with Congress members trooping to the Well of the House.

Samajwadi Party member Dharmendra Yadav and Trinamool member Saugata Roy were also up on their feet, apparently in support of the Congress.

Dubey had also raised the issue on Thursday, prompting the Congress members to rise in protests against BJP's attempts to link Soros with Leader of the Opposition Rahul Gandhi.

On Friday, the Lok Sabha was adjourned till noon within a minute of assembling at 11 am as Congress members Gaurav Gogoi and K C Venugopal tried to counter the allegations levelled by Dubey.

When the House reassembled at noon, BJP member Dilip Saikia, who was in the chair, allowed laying of parliamentary papers on the table of the House. before calling Dubey to speak on the issue he could not complete



on Thursday.

Congress members trooped to the Well of the House raising slogans against the BJP and the government. Saikia then adjourned the proceedings for the day.

At 11 am, Opposition members mostly from the Congress. tried to raise some issues which

the Speaker objected to. You don't want to allow the Question Hour to continue . The House has high standard and I can't allow it to be lowered. I can't allow the dignity of the House to be lowered," he said and adjourned the House immediately.

While the House could not function properly in the first week of the winter session due to protests by Opposition members demanding to raise issues related to the Adani group and Sambhal violence, it functioned properly on Tuesday and Wednesday.

Iran Achieves Milestone In **Space Tech With Saman-1** And Fakhr-1 Launch

Tehran: In a landmark achievement for Iran's space program, the country successfully launched a domestically-developed satellite carrier, Simorgh, carrying the Saman-1 orbital transfer block, the Fakhr-1 nanosatellite, and an additional research payload into low Earth orbit (LEO) early Friday morning. The launch took place at the

ment, saying that the Saman-1 system provides a smoother transition for satellites to their operational orbits, enhancing Iran's competitiveness in satellite deployment.

Fakhr-1 honors martyr Fakhrizadeh Among the payloads was the Fakhr-1 nanosatellite, named in tribute to Dr. Mohsen Fakhrizadeh. a prominent Iranian scientist. This compact, three-unit CubeSat was developed collaboratively by the Ira-



Imam Khomeini Space Launch Terminal near Semnan, marking a significant step forward in Iran's growing space capabilities. According to Iranian media, the payloads achieved an orbital apogee of 410 kilometers and a perigee of 300 kilometers, a precision that underscores the sophistication of the mission.

The Saman-1 orbital transfer block, developed by the Iranian Space Research Center (ISRC), is designed to move satellites into higher orbits. This reduces reliance on large, high-fuel-consump tion launch vehicles, making satellite deployment more efficient and cost-effective. The system's development aligns with Iran's strategic goals of advancing its space technology and expanding its operational range in orbit.

Speaking to Mehr news agency, Hassan Salaryieh, head of Iran's space agency, lauded the achieve-

nian Army, SA Iran Corporation, and Malek Ashtar University of Technology. It is equipped with advanced systems for telemetry, power management, and radio communications. Simorgh: A reliable workhorse

The Simorgh rocket developed by the Iranian Ministry of Defense, carried the payloads to orbit in its eighth successful launch. The two-stage liquid-fueled rocket set a new national record by lifting a combined payload weight of 300 kilograms, demonstrating its ability to handle complex, multipayload missions.

The launch precision, with a velocity tolerance of less than 0.1%, underscores the advancement of Iranian engineering in orbital deployment. Simorgh remains a critical component of Iran's space ambitions, capable of placing satellites into LEO with high accuracy.



Bangladesh removes Mujib from banknotes, bans Hasina's speeches

angladesh's International Crimes Tribunal on Thursday ordered a ban on disseminating deposed prime minister Sheikh Hasina's "hate speeches" in the mainstream media and social media networks as the tribunal is set to try her on numerous charges of crimes against humanity.

The order follows Hasina's recent speech, her first public address after fleeing to India on August 5, in which she mounted a stinging attack on the country's interim leader Muhammad Yunus, accusing him of perpetrating "genocide" and failing to protect minorities including Hindus. "The ICT has banned broadcasting, publishing and spreading any hate speech by ousted PM in all types of mass and social media," an said.

The country has also begun the process of erasing the image of Sheikh Mujibur Rahman -- her father and the iconic figure behind the founding of the country from its currency notes. Bangladesh Bank is printing new notes, including in



them features of the July uprising, the Dhaka Tribune reported Thursday, referring to the student-led protests that forced Hasina to flee. Banknotes of Taka 20, 100, 500, and 1,000 are being printed on the instructions of the interim government.

Rising Trend of Contractual and Outsourced Employment in J&K

n recent years, Jammu and Kash-

mir (J&K) has witnessed a grow-

ing shift toward contractual and

outsourced employment across

various government departments.

This shift has significant implica-

The Government's increasing reliance on outsourcing and contractual employment for administrative and development tasks has been a key factor driving this shift. Contractual and outsourced jobs, which are typically short-term or project-based, are becoming increasingly common in sectors such as education, healthcare, social welfare, universities, tourism and even administrative roles. Contractual and outsourced jobs are temporary positions, typically lasting from a few months to a few years, without any guarantee of permanence. Outsourced jobs in the government often involve third-party agencies either government or private firms for hiring employees for various roles. In recent years, the prevalence of these job types has surged in Jammu and Kashmir.

There are several reasons contributing to this shift. The Jammu and Kashmir government has been turning to contractual and outsourced jobs in various departments as a cost-cutting measure because these positions do not require the same long-term financial commitments as permanent staff, particularly when it comes to salaries, pensions, healthcare, and other benefits. In addition to these savings, the government has been increasingly opting for fixed salary contracts for these positions, which provide a predictable and controlled expenditure for the



state's budget.

By hiring employees on contractual or outsourced terms, the government is able to fill positions on a fasttrack basis without going through the lengthy process associated with permanent employment. The consequences are not only economic but also social, as this precarious employment situation can lead to increased stress, frustration, and feelings of alienation among young workers, potentially undermining their overall well-being and social stability. The fear of job loss creates immense psychological pressure, and many young people in Jammu and Kashmir face this uncertainty daily. This lack of stability and the challenges associated with it are contributing factors to the rising mental health issues and drug addiction in the region,

as individuals seek ways to cope with the stress and hopelessness brought on by their employment situations.

To mitigate the negative impacts of contractual and outsourced employment, several policy measures are needed. First, the government of Jammu and Kashmir should focus on creating more permanent, stable jobs in critical sectors like healthcare, education, social welfare, and universities. This could be achieved through the implementation of well-defined employment policies aimed at hiring permanent staff in these sectors. Additionally, labor law protections for contract workers should be strengthened to ensure fair wages, job security, and access to benefits such as health insurance and paid leave. By providing these protections, the government can help reduce the insecurity faced by contractual and outsource workers and improve their overall working conditions. By adopting these recommendations, the government of Jammu and Kashmir can create a more equitable and sustainable environment for contractual and outsource employees. These measures will not only improve the livelihoods of workers but also contribute to the broader economic development of the region, fostering a more stable and productive workforce.

The Human Capital Imperative

Unless India's baseline of human development improves, it will not be able to raise the share of manufacturing and grow into a developed nation.

oosting the share of manufacturing to 25% of gross domestic product (GDP) is an important aspirational objective of India's policy establishment. So, too, is becoming an advanced economy by 2047 like the East Asian miracle economies. During the last 10 years, the ruling dispensation has adopted several measures in this regard like the Make in India programme, production-linked incentives, and generous tax reliefs. As preparations for the Union Budget for FY26 are underway, there are deliberations on revitalising manufacturing with assistance linked to employment generation and fresh investments. However, despite these efforts to raise the share of manufacturing, it has stubbornly hovered around 16% of GDP since FY15.

Instead of sops to bolster manufacturing, it might perhaps be more appropriate to learn from the experience of East Asian miracle economies, including China. They became global exportoriented manufacturing hubs and progressed to higher levels of development by addressing preconditions at the level of human development. India, too, must do so to realise its aspirational objectives. Economies like South Korea, for instance, made huge investments in education that improved literacy and schooling of its population. This enabled it to grow rapidly for long periods of time and make a successful transition from a developing to a developed economy. All these East Asian economies had a high baseline of human development.

India's challenge is indeed daunting as only 5% of its workforce has received formal skill training as against 80% and 96% in countries like Japan and South Korea. Although India has the advantage of a predominantly youthful labour force, this demographic dividend can turn into a curse if they lack the skills to be gainfully absorbed in manufacturing. More so, as the policy establishment has unveiled ambitions to become a leading player in sunrise industries like semiconductors, green hydrogen, artificial intelligence, robotic hardware, besides labour-

intensive manufacturing. Clearly, the overriding policy focus must be on upgrading human capital so that it is more in alignment with the country's ambitions for manufacturing.

The contrast with China is striking as its better educated workforce facilitated its rise as a global export-oriented manufacturing power. Unlike India's top-down approach, China adopted a bottom-up policy of focusing on primary mass education from the early 1900s, prior to communism. This shifted to secondary education during the 1960s-80s under communism, and later to tertiary education during the post-communist era. Nearly 25% of China's students at the secondary level and above are enrolled in vocational education as against 2% in India. China produces a higher share of engineering, medicine, and teacher training graduates while humanities dominate among our graduates, reflecting a colonial bias to produce administrators.

These facts are from Nitin Kumar Bharti and Li Yang's paper, "The Making of China and India in 21st Century: Long-run Human Capital Accumulation from 1900 to 2020". India's relative neglect of primary education (till the 1990s) left much of its population without the education needed to shift from low-productivity agriculture towards manufacturing and services in the cities - a process associated with modern economic development. In 1987-88, China and India had 62% of their workforce in agriculture. Over the next 30 years, China reduced this to 15%, while India only reduced it to 40%. Of late, there has been a noteworthy reversal in terms of a migration from factories back to the farms of rural India, which

complicates efforts to boost manufacturing.

The big question is, what must be done to raise India's threshold levels of human development to match its aspirations on manufacturing? A useful means to integrate youth into the labour market is through skill development measures like apprenticeships. For starters, India could adopt best practices of countries like Germany which runs the most successful apprenticeship programme in the world that is linked with the higher educational curriculum. In India, the process could start even earlier with skilling and vocational training imparted in secondary school education. The bad news in this regard is that the launch of the ambitious PM Internship Scheme on December 2 to train people in real-life skills has been postponed despite indications of a favourable response.


More than the government, the onus of improving human capital lies with Indian industry as it is not getting enough skilled labour for its operations despite a growing reserve army of educated unemployed youth. India Inc must collaborate with educational institutions so that its requirements form an integral part of the curriculum. What can perhaps nudge industry into taking apprenticeships more seriously is if training and skilling of youth constitute part of corporate social responsibility obligations. This kind of a programme could lower the dropout rate seen in other skilling programmes and improve the employability of the workforce. India Inc must ensure that the gap between China and India with regard to the average years of education for manufacturing jobs reduces much further: this was as much as 5.2 years in 1988, which narrowed down to 2.4 years in 2018 according to Bharti and Yang. Unless India's baseline of human development improves, it will not be able to raise the share of manufacturing and grow into a developed nation.

LIFE IN A FULL CIRCLE

The caravan of memories moves before my eyes....

■ I vividly recall my dear English teacher from college, Mrs. Malik, whose radiant smile seemed to light up the classroom. She would read the poems of Keats and Wordsworth, delve into Shakespeare's plays with references to Greek tragedies Homer and Chaucer, and explore the novels of Dickens—all during the 4 best years of my youth. I shall never forget her influence.

Years later, I discovered a collection of poems by **S.Sarwar.M**, the son of my dear teacher, as I came to know about it some years back. Little could I Imagine that Sarwar was Mrs. Malik's son. Yes, the smile on his face mirrors hers in such a striking way.

The book is titled "CRIES OF THE THORN BIRD", a title that speaks volumes in itself. It compels the reader, like me, to ponder: what causes the bird to cry? Is it wounded? Is it in pain? Does it feel sorrow for everything it encounters? The poet himself is present in every line of each poem, as he reflects on his own emotions-his love, his longing, his hurt, his disappointments, and his wish for things to be as they should. The poems are filled with rich imagery and powerful expression, capturing feelings, thoughts, and profound reflections.

Sometimes the poet's words take us beyond the world of language, into his homeland of Kashmir, where words like *sadreh mouj*, *nage vigin*, *Chinar*, *Veth* and *Aharbal* evoke a deep sense of place. Through these metaphors, Sarwar forces the reader to understand the true meaning of these terms, often providing explanations along the way.

One of his poems, "O! MEN WITH THE PEN-Speak Your Mind a Little Louder!", is a tribute to the legendary poet of our time, the Gyan Peeth awardee Rehman Rahi, and to the Kashmiri language itself. When those from your own soil, even non-Kashmiri literature students, acknowledge the greatness of such a poet, it is an honor in itself. Recognition from your own people, especially from younger generations like Sarwar, carries immense weight.

I must admit that despite being an English literature student, I struggle to express my thoughts on this book in English. I feel as though Sarwar's words elude full understanding. There is a sense that his poems leave me pondering, questioning: what can it be? What is he trying to say? And perhaps that is the **true success of a writer-leaving the reader in contemplation**, **never fully offering easy answers**.

Be it his first poem "Hesitation", "Dreamers Fling", "Eternal Beauty" or "My Journey", the poet is always present, as I mentioned earlier. Sometimes, he is in the loving embrace of his mother; other times, he is with his beloved, enjoying and rejoicing ; while at other times, he expresses the worry of losing and parting from loved ones. This cycle, one can see everywhere —questions without answers, much like life itself.

His mastery of the English language is evident in every word he chooses. Yet, I wish someone would translate some of his poems to Kashmiri for readers like me.

At the end, while it is difficult to express fully the gratitude I feel, I must acknowledge the honor Sarwar has bestowed upon me by writing a poem titled "O' MY TALL HEETHERIYE". I am both humbled and honored, S. Sarwar. May God bless you with the power of the pen, paper, imagination, thoughts, feelings, and expressions. I hope you write in Kashmiri as well. *Khwaab....*

Does the Weather Affect Our Emotions?

A s we move toward winter and colder temperatures in the northern hemisphere, many people are happy to beat the heat and enjoy a cool and cozy winter wonderland. And then there's another group wistfully looking back on the sunshine and warm weather that we've now left behind.

It's not news that people differ in their seasonal preferences, mention that they "run hot" or "run cold," or have strong opinions on what their ideal temperature is. What might be more surprising is that the subjective experience of the weather is what actually affects us emotionally, with the objective conditions playing a very small role.

A recent study my colleagues and I published in BMC Psychology linked the objective, highly localized weather conditions to individuals' perceptions of their environments ("How hot or cold is it?"), how comfortable the temperature was, and how they were feeling in the moment. Study participants completed a number of these surveys on a smartphone in outdoor environments during the summertime, and they had GPS and time information, so the objective weather conditions could be linked to the time and place they completed the survey.

We expected that there



may be a reasonably strong relationship between actual weather conditions and whether or not people reported it being hot or cold, comfortable or uncomfortable. And we were quite wrong! If we looked at the relationship across all of the people in the study, our results showed a pretty weak relationship between the actual weather and perceptions of temperature or comfort. Even on days where it was over 90 degrees F, some people were perfectly comfortable, and on days when it was 73 degrees F and sunny, some people were uncomfortable and found it too cold!

More importantly, we did see a relationship between temperature discomfort and negative emotions—if people reported feeling uncomfortably hot, they felt more tired, distressed, and generally unhappy. However, we only see this relationship if people said that the heat made them uncomfortable—which means on a 95-degree day, plenty of

people said it was very hot but they weren't uncomfortable, and therefore, the scorching heat didn't seem to have a negative impact on them. On some level, it's not sur-

prising that discomfort should lead to more negative emotions. Discomfort is by definition not an enjoyable experience. What is more important and more surprising to note is that these individual differences in comfort and perceived temperature are much larger and more important than the actual weather conditions themselves.

This opens up interesting questions about why people differ so much in their perceptions and comfort. There's a lot of evidence that physiology plays a role-depending on body composition, age, physical fitness, hormones, etc., you may thermoregulate better or run hotter/colder. But that is only one piece of the puzzle. It actually seems like personality traits might play a role. Preliminary results from my lab and other research have identified that trait neuroticism seems to amplify the relationship between temperature discomfort and negative emotions. Ultimately, this is one area where we still know very little, but is an exciting opportunity for additional scientific exploration.

This also means that if you disagree with your roommates or coworkers about the thermostat setting this winter, you can take solace in knowing that there's no "correct" temperature; it's all subjective anyway!

RBI Keeps Interest Rates Unchanged, Cuts CRR As Economy Slows

Mumbai- The Reserve Bank of India on Friday kept its key interest rate unchanged but cut the cash reserve ratio that banks are required to park with the central bank, as it did a balancing act between inflation management and supporting economic growth.

With India's GDP seeing a sharper-than-anticipated dip in the July-September period to 5.4 per cent -- its slowest pace in seven quarters, inflation on the uptick and rupee under pressure, the RBI had few choices to make.

Its monetary policy committee, which consists of three RBI and an equal number of external members, kept the repurchase or repo rate unchanged at 6.5 per cent for a record 11th

meeting in a row.

Four of the six members of the panel voted for a status quo in rate, while retaining its policy stance at "neutral". External members - Nagesh Kumar and Ram Singh - voted for a quarterpoint reduction.

Announcing the monetary policy committee meeting decisions, RBI Governor Shaktikanta Das said the Cash Reserve Ratio -- the proportion of deposits that banks must set aside with the central bank -- has been cut by 50 basis points to 4 per cent, effective in two tranches on December 14 and December 28.

The cut will infuse Rs 1.16 lakh crore into the banking system and will soften short-term interest rates and enhance capacity of banks to extend credit and invigorates economic activity across sectors.

No Hepatitis B Deaths Reported In J&K Since 2018: Govt across the country, including in

SRINAGAR: No deaths have been reported due to Hepatitis B in Jammu and Kashmir since 2018, according to the Ministry of Health and Family Welfare. In a reply to a question in Parliament, the Minister of State for Health and Family Welfare, Anupriya Patel said that no fatalities have occurred in Jammu and Kashmir due to

Hepatitis B. "Hepatitis B is a viral infection that causes chronic liver disease and can lead to severe complications such as cirrhosis and hepatocellular carcinoma, which can ultimately result in death," she said.

Patel added that efforts to combat viral hepatitis, including Hepatitis B, are carried out through a coordinated approach between the central and state governments under the National Health Mission (NHM). The National Viral Hepatitis Control Program (NVHCP), launched under NHM, employs various preventive strategies

Jammu and Kashmir. 'These measures include universal screening of antenatal women to prevent vertical transmission, screening of high-risk groups and the gen-

eral population, screening of all blood donors for Hepatitis B and screening individuals undergoing surgical procedures," the minister said. Officials here said this success is due to the sustained ef-

forts of the state health department in managing and treating the disease.

"Thousands of individuals across J&K have been screened and treated under programmes like the National Viral Hepatitis Control Programme, which provides free treatment and vaccination to those affected by the disease," an official said. He said despite these achievements, challenges remain, particularly in districts with limited testing facilities. "Further improvements are needed in healthcare infrastructure," he added

Acquisition Of Budgam Land In 2011 **Defense Ministry Deposits** ₹181 Cr Out Of Rs 234 Cr

SRINAGAR: The Ministry of Defense sanctioned the acquisition of land in Budgam in 2011 at an estimated cost of Rs 234.25 crore, with Rs 181.54 crore already deposited for landowners' compensation, Lok Sabha was informed on Friday.

The MoD said this while responding to a query raised by Member Parliament, Aga Ruhullah Mehdi regarding compensation for land acquired in 2011-2012 at Karewa Damodar, near Srinagar airport, affecting nearly 600 families.

It said the acquisition, valued at an estimated cost of Rs 234.25 crore, was approved on March 4, 2011. "As of now, Rs. 181.54 crore has already been deposited by the Defense Estates Office Srinagar with the Deputy Commissioner of Budgam for the release of compensation to the affected landowners," the government said. discrepancies "However.

were found in the area of acquired land mentioned in the Form J Notification issued by the Jammu and Kashmir Government under the J&K Requisitioning and Acquisition of Immovable Property (RAIP) Act, 1968. The acquired land on the ground was found to be less than what was reflected in the notification," it added.

The MoD said the Directorate General of Defence Estates (DGDE) has requested the Government of Jammu and Kashmir to amend the notification accordingly. The compensation award will be processed once the necessary amendments are made to the Form J Notification, it added.

The ministry further clarified that there is no provision to reassess compensation under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, as the land has already been acquired under the J&K RAIP Act, 1968.

also decline. However, there is no one-to-one relationship between La Niña and snowfall in Kashmir," he reiterated.

While higher altitudes in Kashmir are witnessing some snowfall, he said that these events are not significant enough to influence the weather patterns across the Valley.

Pertinently, some reports have been attributing the dropping temperatures in Kashmir to the La Niña effect. Experts had earlier said that the La Niña phenomenon is set to intensify this winter, potentially leading to severe conditions in Kashmir and Ladakh. Predicted increases in snowfall and precipitation could make the regions even harsher.

Dr Ahmad added that as per instances of La Niña years in the past, the Himalayan region experienced above normal precipitation and below normal minimum temperature for 60% of the years (last 50 years) & 40% of the years having normal winter during La Niña years.

There may be some other factors also which can be attributed to above or below normal precipitation.

Notably, Jammu and Kashmir has witnessed very little rain and snow the last few years due to the El Nino effect, which impacted the weather conditions across the region, including Kashmir Valley.

Furthermore, Shopian was the coldest place in Kashmir where the mercury settled at minus 6.6 degree Celsius. Pahalgam, a famous tourist destination, recorded a low of minus 6.5 degree Celsius while Gulmarg, a famous ski-resort, recorded a low of minus 4.3 degree Celsius.

Also, Qazigund, a gateway of Kashmir, recorded a low of minus 4.4 degree Celsius while Kupwara in north Kashmir recorded minus 3.4 degree Celsius. Kokernag in South Kashmir recorded a low of minus 2.4 degree Celsius.

Furthermore, the weatherman here has predicted further dip in the night temperature, saying that there is no forecast of any major wet spell weather and the minimum temperature would likely go down as well.

Director Meteorological department (MeT). Dr. Mukhtar, Ahmad, said, that the weather would remain generally dry till tomorrow, adding that generally cloudy weather with possibility of light rain over few plains & hilly areas of Jammu division & light rain and snow (higher reaches) over few places of Kashmir division during late evening of 8th to 9th forenoon.

He said that a few places of Jammu division may experience thunder with gusty winds during the 8th evening and night.

However, he said that from December 10 to 14, the weather would remain generally dry, adding that on December 15 & 16, light rain and snow is expected over isolated places.

Notably, the department of Disaster Management, Relief, Rehabilitation & Reconstruction (DMRRR) has issued a comprehensive advisory to combat ongoing cold wave conditions.

The Advisory has highlighted the need to pay special attention to vulnerable groups like the elderly and children during the cold wave phases. The guidelines issued by the J&K's

DMRRR department focus on safety measures for individuals, animals, and crops to mitigate the risks associated with severe cold weather.

During the cold wave phase, the advisory has asked residents in the region to limit outdoor exposure and dress in multiple layers of clothing. It has also insisted on using protective gear like hats, mufflers, and insulated shoes.

"Stay indoors as much as possible and minimize travel to prevent exposure to cold. Maintain warmth through healthy food, hot drinks, and proper hydration. Keep yourself dry. If wet then cover your head, neck, hands and toes adequately as the majority of heat loss occurs through these body parts. Change wet clothes immediately," reads the advisory.

The advisory has also flagged to take care of elderly people, newborns and children and check neighbours who live alone, especially the elderly about their wellbeing.

"Cover your head as most body heat is lost through the top of the head. Drink hot fluids regularly, as this will maintain body heat to fight cold," reads the advisory.

Before the cold wave, the advisory recommended staying updated on weather forecasts through radio, TV, and newspapers. It has also asked to stock essential items, including winter clothing, food, water, and emergency supplies.

"Ênsure doors and windows are properly sealed to block cold winds," states the DMRRR advisory.

In case of exposure to cold wave conditions, and to address frostbite and hypothermia, the advisory has stated to promptly warm affected areas and seek medical attention and not to ignore shivering, stating that It is the first sign that the body is losing heat.

The advisory has asked to avoid alcohol, stating that it reduces body temperature.

With regard to the agricultural and

animal husbandry guidelines, the advisory states that farmers should irrigate plants lightly to protect crops and use mulch to preserve warmth.

The advisory reads that cultivating frost-resistant varieties and sheltering fields with windbreaks are recommended.

"Mulching nursery beds of soil near the main trunk with black or silver plastic sheets increase radiation absorption and provide a warmer thermal regime during winter. In case plastic mulch is not available, making thatches (jhuggis) of straw or Sarkanda grass or organic mulching will also protect crops from cold," reads the advisory.

For animals, the advisory states that livestock and poultry should be sheltered indoors, provided with bedding materials, and fed high-quality forage to meet increased energy demands during cold weather.

It also states that during Cold waves animals and livestock require more food for sustenance as the energy requirement goes up. It adds that extreme variations in temperature may affect the fertility rate of animals, during the optimum breeding season for buffaloes /cattle.

"Cover the animal habitat from all sides during night in order to avoid direct exposure of animals to cold winds. Apply some bedding materials such as dry straw under animals during winters. Avoid giving cold feed and cold water to the animals," states the advisory.

Kashmir Faces Water

Irrigation and Flood Control (IFC) for Kashmir and also with additional charge of CE PHE Jal Shakti, Er. Braham Jyoti Sharma said despite the ongoing dry spell with reduced water levels in the water bodies, they were managing 'adequate' water supply in the region.

"Our rivers, ponds, and springs are drying up because of the lack of rainfall and snowfall. These water sources are critical for our drinking water supply and agricultural needs. We are hoping for precipitation soon, as natural recharge remains beyond human intervention," CE IFC said.

In response to the crisis, he said that they have taken steps to stabilize the water supply, stating that the irrigation demand has significantly decreased with the end of the agricultural season in the region.

"For now, we are managing to maintain adequate drinking water supply, but the lack of precipitation poses a serious challenge for the coming months," a top officer stated.

Another senior official from Irrigation and Flood control department highlighted the critical role of snowfall in sustaining Kashmir's water resources. "Snowfall acts as a natural reservoir, feeding glaciers, streams, and rivers during the summer months. Without sufficient snow, the region could face severe water shortages during peak demand periods," official said.

The officer said snowfall was

essential for replenishing streams and rivers in the region, stating that it serves as a summer reserve, and its absence could lead to increased strain on our water resources.

The officer added that while the onset of winter has brought a marked reduction in demand due to the end of irrigation activities, the departure of seasonal populations has also enhanced the water supply in the region.

The officials also acknowledged that despite ongoing mitigation efforts there was growing pressure on water reserves, stating that the rainfall and snowfall remained the only sustainable solutions to the valley's deepening water crisis.

"We are doing everything in our control to manage the supply, but without nature's help, our resources will remain under threat," the official

Messi Wins MLS MVP Award: Latest On Long List Of Honors For Inter Miami Star

FORT LAUDERDALE: It was a rare instance of Lionel Messi stepping on a soccer field and having no idea what was happening.

There they were, more than 250 Inter Miami academy players, a slew of kids lined up at midfield in a formation that spelt out three letters: MVP. And when Messi saw his children, he realized they were holding a trophy.

That's how Messi learned he was Major League Soccer's best player in 2024. Messi is the MLS MVP,

even after a season where he missed 15 of Inter Miami's 34 regular-season matches with injuries or commitments to Argentina's national team.

He factored into a leaguehigh 36 goals – scoring 20, assisting on 16 others – for the highest rate per 90 minutes in MLS history.

"Truly, it is an honour for me to receive this award from all of you," Messi told



the academy players. MLS revealed the voting results Friday. Messi edged out Columbus Crew forward Cucho Hernández for the award, which is determined by a poll of players, club technical staff and select media members.

The club voters preferred Hernández over Messi by a slight margin; Messi was the choice of 41% of players and 43% of the media.

Messi wound up with 38.4% of the average vote, Hernández got while 33.7%. Portland Timbers midfielder Evander (9.2%), DC United's Christian Benteke (7.1%), and Messi's Inter Miami teammate Luis

Suárez (2.2%) rounded out the top five in the voting. Messi's win capped a 2024 campaign where he led Inter Miami to the Supporters Shield and the best regular season record in MLS history, plus captained Argentina to a Copa America title. Inter Miami fell in Round 1 of the MLS Cup playoffs. "I would have liked to

receive this award in another situation, being able to play the (MLS Cup) final next Saturday," Messi said. "But, that's also what football is about, overcoming yourself every day. We had a big dream of being MLS champions this year. It didn't happen, but next year, we'll come back stronger to try again."


The MLS MVP – named for Landon Donovan – is vet another entry on the absurdly long list of career honours for Messi. He's an eight-time Ballon d'Or winner, eight-time FIFA Player of the Year winner, a seventime Spanish League MVP, past UEFA Player of the Year, past Champions League Player of the Season, World Cup Golden Ball winner, Club World Cup Golden Ball winner, and the list goes on and on and on from there.

Best player ever? It's tough to argue.

Messi stunned many in the soccer world when he picked Inter Miami last year, instantly turning the franchise into one of the game's biggest brands.

Winning the Leagues Cup shortly after Messi arrived gave Inter Miami its first trophy, and his No. 10 jersey has been MLS' biggest seller from basically the moment that the most decorated player ever picked Miami.


