

### **MeT Predicts Cold Wave Over Next 4 Days**

Srianagar: A day after plain areas in Kashmir received the season's first snowfall, the minimum temperatures dropped across the valley on Friday, with the weather department predicting a cold wave at many places over the next four days, officials said.

The night temperatures decreased across the valley, after the snowfall in the higher reaches and some plains of Kashmir, the meteorological department said.

The Met department has forecast mainly dry weather till December 21. However, the minimum temperature is expected to fall further in the valley and there would be a cold wave over many stations during the next four days, they said.

Jammu and Kashmir summer capital, Srinagar, recorded a minimum temperature of minus 2 degrees Celsius, down from minus 0.5 degrees Celsius the previous night, the officials said.

They said that Gulmarg, a tourist destination in north Kashmir popular for skiing, was the coldest recorded place in the valley, with the mercury plunging to minus 9.6 degrees Celsius, compared to minus 5.2 degrees Celsius the night before. ## **Delhi-Sgr Train To Start In 4 Months** Final Track Work Completed For USBRL Has Been Completed: Officials

Srinagar: The final track work for the Udhampur-Srinagar-Baramulla Rail Link Project (USBRL) has been completed, Union Minister Ashwini Vaishnaw announced on Friday. In a post on the social me-dia platform X, Vaishnaw described it as a "historic milestone." He wrote,"Final track work on the Udhampur-Srinagar-Baramulla Rail Link is complete. The ballastless track work for the 3.2-kmlong Tunnel T-33, located at the foothills of the Shri Mata Vaishno Devi Shrine and consuccessfully completed today at 2:00 AM." necting Katra to Reasi, was

An official said that work on the 17-km section between Katra and Reasi is now complete following the successful completion of the 3.2-km-long tunnel. "Inspections and trial runs are expected to begin soon on this stretch. The first train from Kashmir to Delhi is expected to commence operations within the next four months

(March-April)," he said. He said the third version of the Vande Bharat train, a sleeper variant, will serve as the new Delhi-Srinagar train, reducing the 800-kilometre journey time to less than 13 hours. The newly constructed 46-

km route from Sangaldan to Reasi has already been completed. This section passes through tunnels and the challenging terrain of the Chenab Bridge-the world's highest railway bridge—located in the Reasi district. The iconic Chenab Bridge spans 1,315 metres, featuring an arch span of 467 meters and a height of 359 metres above the riverbed. It is considered a marvel of engineering.

### **J&K Reports** 22,196 **TB** Cases In 2 Years

Srinagar: Jammu and Kashmir has recorded a total of 22,196 Tuberculosis cases, with 11,754 cases recorded in 2023 and 10,442 cases up to October 2024, the Government of India informed the Parliament on Friday.

Minister of Health and Family Welfare, Jagat Prakash Nadda, in a reply to a question has informed that the government is imple-menting a National Strategic Plan (2017-2025) to eliminate tuberculosis (TB) by 2025, five years ahead of the United Nations' Sustainable Development Goal target of 2030.

"Under the National TB Elimination Programme (NTEP), significant progress has been made, with the TB incidence rate declining by 17.7%, from 237 per 100,000 population in 2015 to 195 per 100,000 in 2023, and TB-related deaths reduced by 21.4%, from 28 per lakh in 2015 to 22 per lakh in 2023," the Minister said in a reply.

"Measures taken include targeted interventions in highburden areas, free drugs and diagnostics, active case-finding campaigns, integration of TB services with Ayushman Bharat, private sector engagement with incentives, and scaling up molecular diagnostic | More on P6

## **Govt Violated HRHM Scheme During 2007 Selections: HC**

Srinagar: The High Court of J&K and Ladakh on Friday upheld its single bench's 2013 judgement that authorities acted in violation and contrary under NRHM scheme in selection of some doctors and paramedics in 2007.

"In a nutshell we are in agreement with the Writ court that in the matter of selections, which were questioned before the Writ court, the official respondents (authorities) had acted contrary to and in violation of NRHM Scheme and paragraph No.4 of the advertisement notification," a division bench of Justice Sanjay Dhar and Justice Rajesh Sekhri said while dismissing as "without merit" numerous appeals filed against Single Bench's 27th May, 2013 verdict.



The single bench had held the appointment of the candidates belonging to other blocks i.e. non-locals, contrary to the NRHM Scheme as well as to para 4 of the Advertisement Notification, issued Chairman Executive Committee, J&K State Health Society on 31.11.2007, that "preference will be given to the candidates below the age of 40 years and are residents

of block where the health institution is located so as to ensure continuous presence of the doctors/paramedics for 24 hrs x 7 days.

"However, since these se-lections and appointments were made in the year 2007 i.e. more than seventeen years back, it would not be appropriate for us to disturb these selections," the division bench said, "We are aware that these engagements are contractual, initially for a period of one year and extendable from time to time subject to the satisfactory work and conduct of the candidates. It would, therefore, be in the fitness of the things as also to better serve the ends of justice that the engagements already made are not disturbed and the writ petitioners | More on P6


#### **Anti-Drone System Declined PaK** Activity At IB: IG BSF

## Why Winter Makes You More Vulnerable To **Colds, Here Is The Science Behind The Season**

ou've probably heard "Don't go outside in the winter with your hair wet or without a coat; you'll catch a cold." That's not exactly true. As with many things, the reality is more complicated. Here's the distinction: Being cold isn't why you get a cold. But it is true that cold weather makes it easier to catch respiratory viruses such as the cold and flu. Research also shows that lower temperatures are associated with higher CO-VID-19 rates.

"As a professor of nursing with a background in public health, I'm often asked about infectious disease spread, including the relationship between cold and catching a cold. So here's a look at what actually happens", says Libby Richards from Purdue University.

Many viruses, including rhinovirus - the usual culprit for the common cold - influenza, and SARS-CoV-2, the virus that causes COVID-19, remain infectious longer and replicate faster in colder temperatures and at lower humidity levels. This, coupled with the fact that people spend more time indoors and in close contact with others during cold weather, are common reasons that germs are more likely to spread.

The flu and respiratory syncytial virus, or RSV, tend to have a defined fall and winter seasonality. However, because of the emergence of new COVID-19 variants and immunity from previous infections and vaccinations decreasing over time, COVID-19 is not the typical cold-weather respiratory virus. As a case in point, COVID-19 infection rates have surged every summer since 2020.



Virus transmission is easier when it's cold. More specifically, cold weather can change the outer membrane of the influenza virus, making it more solid and rubbery. Scientists believe that the rubbery coating makes person-to-person transmission of the virus easier.

It's not just cold winter air that causes a problem. Air that is dry in addition to cold has been linked to flu outbreaks. That's because dry winter air further helps the influenza virus to remain infectious longer. Dry air, which is common in the winter, causes the water found in respiratory droplets to evaporate more quickly. This results in smaller particles, which are capable of lasting longer and traveling farther after you

How your immune system responds dur-

ing cold weather also matters a great deal. Inhaling cold air may adversely affect the immune response in your respiratory tract, which makes it easier for viruses to take hold. That's why wearing a scarf over your nose and mouth may help prevent a cold because it warms the air that you inhale. Also, most people get less sunlight in the winter. That is a problem because the sun is a major source of vitamin D, which is essential for immune system health. Physical activity, another factor, also tends to drop during the winter. People are three times more likely to delay exercise in snowy or icy conditions.

Instead, people spend more time indoors. That usually means more close contact with others, which leads to disease spread. Respiratory viruses generally spread within a six-foot radius of an infected person. In addition, cold temperatures and low humidity dry out your eyes and the mucous membranes in your nose and throat. Because viruses that cause colds, flu and CO-VID-19 are typically inhaled, the virus can attach more easily to these impaired, driedout passages.

#### What you can do:

The bottom line is that being wet and cold doesn't make you sick. That being said, there are strategies to help prevent illness all year long:

#### Wash your hands often.

Avoid touching your face, something people do between nine and 23 times an hour. Stay hydrated. Eight glasses a day of water is a good goal, but that could be more or less depending on lifestyle and the size of the person.

Eat a well-balanced diet. Dark green, leafy vegetables are rich in immune system-supporting vitamins, while eggs, fortified milk, salmon and tuna have vitamin D.

Stay physically active, even during the winter.

Get adequate sleep. Clean hard, high-touch surfaces in your home often. If your nose or throat gets dry in the winter, consider using a humidifier. Get your annual flu and COVID-19 vaccine. Following these tips can ensure you have a

healthy winter season.

**'Excessive Smartphone Use Adversely Impacting** Parent-Children Relationships In India'

he rise in dependence on smartphones and their excessive usage are adversely impacting relationships between parents and children in India, a survey commissioned by Chinese mobile devices company Vivo said. The survey conducted by Cybermedia Research found that on average, parents spend more than five hours and children spend over four hours daily on their smartphones, with social media and entertainment accounting for the largest portion of usage for both groups. "Excessive smartphone use has strained personal relationships, with both parents and children recognising it as a source of conflict between them. Sixty-six per cent of parents and 56 per cent of children notice negative changes in their personal relationships due to excessive smartphone usage," the vivo Switch Off 2024 Survey report said. As per the study, both parents and children yearn for closer relationships with each other but neither group is willing to curb their excessive and purposeless smartphone habits The survey found 73 per ents and 69 per cent of ch


Dr. Owais reiterated that timely and efficient execution of projects is essential for better service delivery, ensuring that the community benefits from improved infrastructure and services.

## **Coaching Fad in Kashmir** Balancing Aspirations and Anxieties

he coaching craze in Kashmir has become a defining feature of the region's educational landscape, symbolizing a unique and multifaceted tragedy. Over the past two decades, coaching centres have proliferated in urban and semiurban areas, emerging as key players in shaping students' futures. This phenomenon is fuelled by the high stakes associated with competitive exams for fields such as medicine, engineering, and administrative services, which are often perceived as the most viable paths to upward social mobility. Parents, driven by societal pressures and aspirations for their children, willingly invest significant financial resources into these institutions, often at the cost of their own financial stability. For middle- and lower-income families, this means making extraordinary sacrifices, such as selling ancestral land, depleting savings, or taking loans, to afford the steep fees charged by these centres. The situation highlights not only the commercialization of education but also the emotional and financial toll it exacts on families striving to secure better futures for their children.

The rise of coaching centres has fundamentally altered the educational dynamics of the region, with many institutions prioritizing profit over quality education. While they promise academic excellence and success in competitive exams, the reality often falls short of expectations. Overcrowded classrooms, inadequate infrastructure, and an overemphasis on rote learning characterize many of these centres. The lack of personalized attention and mentorship leaves students grappling with the pressures of high expectations, which, when unmet, can lead to feelings of failure and inadequacy. This has created a parallel education system where traditional schools are increasingly side lined, their role diminished in the eyes of both students and parents. Many students prioritize coaching centre attendance over regular school classes, eroding the foundational purpose of schools in providing a well-rounded education and fostering holistic development.

The psychological toll of this craze is immense, particularly on students,

who are often subjected to relentless academic pressure. Long hours at coaching centres, combined with regular school responsibilities and the weight of familial expectations, leave little time for relaxation, recreation, or personal interests. This lifestyle fosters a culture of burnout, where anxiety, stress, and depression are common. The fear of failure and the societal stigma attached to it exacerbate these issues, pushing some students to the brink of mental health crises. In extreme cases, this relentless pressure has resulted in self-harm or suicidal tendencies, underscoring the tragic dimensions of this educational rat race.

The normalization of the coaching craze is perhaps its most troubling aspect. In Kashmir, the pursuit of coaching is seen not as an option

but as a necessity, creating a culture where alternative career paths or approaches to education are rarely explored or valued. This single-minded focus on specific careers, particularly in the fields of medicine and engineering, stifles creativity, critical thinking, and individuality. The emphasis on academic success above all else leaves little room for fostering talents in arts, humanities, or entrepreneurship, perpetuating a narrowly defined vision of success. Furthermore, the coaching industry has deepened educational inequalities. Affluent families can afford premier coaching centers, gaining an advantage in the competitive race, while students from economically disadvantaged backgrounds struggle with limited resources, creating a widening gap in opportunities and outcomes.

Addressing this multifaceted issue requires a collective effort from all stakeholders-policymakers, educators, parents, and society at large. The government must implement stringent regulations to oversee the functioning of coaching centres, ensuring they adhere to standards regarding infrastructure, class size, and teacher qualifications. Simultaneously, strengthening the traditional school system is essential to restore its significance in the education process. Schools must be equipped with adequate resources, well-trained teachers, and modern pedagogical approaches that can rival the appeal of coaching centres. Career counselling programs should be introduced at the school level to guide students in exploring diverse career options beyond the conventional choices of medicine and engineering.

Equally important is the role of parents, who must be made aware of the dangers of overburdening their children and the importance of balancing academic aspirations with emotional well-being. Mental health support systems, including counsellors and psychologists, should be integrated into educational institutions to help students cope with stress and develop resilience. Finally, society as a whole must work to redefine the meaning of success, encouraging a broader appreciation for diverse talents and careers.

The coaching craze in Kashmir, though a symbol of aspirations and ambition, reflects deep-seated systemic flaws and societal pressures that demand urgent attention. Without a concerted effort to address its underlying issues, this craze risks perpetuating a cycle of stress, inequality, and a myopic focus on academic achievement at the expense of students' holistic development and well-being. By fostering a balanced and inclusive approach to education, Kashmir can transform this tragedy into an opportunity for a more equitable and sustainable future.

## Closing the AI Skills Gap in 2025

ith artificial intelligence poised to reshape industries worldwide, a paradox is emerging. Despite growing demand for people with the knowledge to leverage the technology's potential, AI-related skills remain in short supply.

The scarcity of AI-related skills – from proficiency in machine learning, prompt engineering, and data science to an understanding of AI's ethical implications – is becoming a major obstacle to deploying the technology effectively. In one recent report, 47% of executives say their employees lack the necessary skills. This will affect companies' ability to move AI projects from conception to implementation. A 2023 report from the World Economic Forum finds that "six in 10 workers will require training before 2027, but only half of workers are seen to have access to adequate training opportunities today."

This skills gap bodes ill not only for individual career growth, but also for economic growth more broadly. Capitalizing on the opportunities that AI presents will require updated approaches to education and training. In the coming year, educational and vocational institutions will likely place a much greater emphasis on teaching AI ethics skills, offer flexible lifelong learning, and infuse AI into their offerings to be more competitive.

AI ethics skills will become a core concern – and for good reason. In the space of just a few years, generative AI has become available to anyone with a computer and an internet connection. For employers and their information technology (IT) departments, this raises the problem of "shadow AI," or unsanctioned use of generative AI by employees, which could expose companies to a wide range of security, compliance, and reputational risks. In addition, the workforce will need AI ethics skills to manage new AI agents: tools that can automate complex tasks that would otherwise require

human resources.

Shadow and agentic AI both demand new guardrails to help users protect AI applications based on responsible AI practices. To this end, education providers will begin to emphasize training on the fundamentals of AI explainability, fairness, robustness, transparency, and privacy. Without a basic understanding of how AI models generate their output, for example, those responsible for protecting data or controlling autonomous systems will be illequipped for the task.

With AI and other new technologies evolving rapidly, lifelong learning will become the new normal. The process can be divided into developing skills that meet immediate needs, anticipate future needs, and furnish always-indemand expertise.

Many traditional roles within an organization will soon change. For example, some employees who currently work independently (who don't manage other people) may join new types of teams in which humans manage AI agents. And to prepare them for this fundamental change, demand for online courses and digital credentials in AI-related fields like natural language processing and machine learning will likely increase. Moreover, the future use of quantum computing will continue to drive the need for new skills. And the steady rise in the number and variety of cyberattacks - such as "harvest now and decrypt later" (HNDL) hacks - underscores the importance of up-to-date cybersecurity skills.

That is why our own organization is working with community colleges across four US states to offer a new cybersecurity certificate that will prepare students for in-demand roles across the workforce. Similarly, our collaborations with Singapore Polytechnic and historically black colleges and universities (HBCUs) in the US provide free training in AI to young learners. And while this process may begin in the classroom, we can also expect to see more opportunities for upskilling as the relevant technologies evolve. For anyone who wants to stay competitive in the job market, lifelong learning has become indispensable.

Finally, AI and automation technologies can make existing education platforms far more effective, as we are likely to see in 2025. AI-powered solutions have reached a tipping point from being a nice-to-have to a must-have. Educators, whether in schools or other organizations, will find new ways to apply AI-powered tools to personalize and tailor learning experiences, understand students' needs and match them with relevant courses, or enhance coaching and feedback.

The same technologies can also enhance customer-service aspects of education. For example, at IBM, we have already seen the benefits of using AI to analyze feedback from more than 60,000 learners in 47 languages, which led us to simplify online registration and other parts of the process. In the coming years, education systems and platforms will also benefit from multimodal AI models that can process audio, video, charts, and images to provide an even more effective, individualized learning experience.

By embracing AI, we can enhance learning and professional outcomes, improve operational efficiency, and reduce costs across the economy. But all of that will require developing the skilled workforce we need.

It is Time to Redefine Parenting

arenting has never been easy, but in the unique socio-cultural landscape of Kashmir, it has become an increasingly challenging endeavor. The role of parents today extends beyond providing for their children; they must navigate the delicate balance of preserving traditional values while adapting to the rapid changes brought by modernity. Moreover, some parents tend to impose their expectations on children without considering the changing realities. Academic excellence, career choices, and behavior are areas where children feel pressured, leading to resentment and withdrawal. While parents may see this as "guidance," children often perceive it as control, deepening the communication gap.

#### Children and the Digital Revolution

On the other hand, children in Kashmir are growing up in a world vastly different from that of their parents. The rise of smartphones and social media has introduced them to ideas, cultures, and lifestyles far removed from traditional Kashmiri values. While these platforms offer opportunities for learning and expression, they also create distractions and barriers to real-world connections.

Children, engrossed in their digital lives, often fail to acknowledge the wis-



dom and experiences of their parents. They may see their parents as outdated or irrelevant, dismissing their advice and concerns. The digital world also exposes them to stress, anxiety, and peer pressure, which they might be reluctant to share with their parents, fearing judgment or misunderstanding. Our children are vulnerable. They are unable to compete as normal. They like loneliness.

They are being challenged by society at every step they take.They can not face their problems properly. They do not have a good decision taking power.They feel anxious, depressed.

#### Where Are We Going Wrong?

The communication breakdown is not entirely the fault of one party. It is a shared failure, rooted in a lack of mutual understanding. Parents expect obedience, while children seek acceptance. Parents want to impart values, while children want their individuality respected. Unfortunately, both parties often fail to meet halfway.

In Kashmiri society, open dialogue about feelings and emotions is still stigmatized. Parents hesitate to discuss sensitive topics like mental health, relationships, or personal challenges, leaving children to navigate these issues alone. Similarly, children often hide their struggles, fearing criticism or disappointment. This silence creates an

emotional distance that erodes trust and connection over time.

The Consequences of the Divide The consequences of this communication gap are far-reaching. Children may feel isolated and misunderstood, leading to issues like low self-esteem, anxiety, or even rebellion. Parents, on the other hand, may experience frustration, disappointment, and a sense of failure in their roles. This growing disconnect can also weaken the cultural and moral foundations that Kashmiri society prides itself on.

When communication falters, families risk becoming fragmented. The warmth and unity that once defined Kashmiri households could give way to alienation and estrangement, threatening the very essence of the region's cultural identity.

#### How Can We Bridge the Gap?

The solution lies in fostering mutual respect and understanding between parents and children. Both parties need to take responsibility for rebuilding the lost connection.

#### 1. Embrace Open Dialogue:

Parents should create a safe space where children feel comfortable sharing their thoughts and emotions without fear of judgment. Similarly, children must learn to articulate their concerns respectfully and listen to their parents' perspectives.

Parents need to recognize that times have changed, and their children face challenges they never encountered. By blending traditional values with modern insights, they can provide guidance that is both relevant and meaningful.

#### 3. Limit Digital Distractions:

Both parents and children should set boundaries for technology use to prioritize family interactions. Engaging in shared activities, like meals or outings, can strengthen bonds and foster communication.

#### 4. Educate on Emotional Intelligence:

Parents should educate themselves and their children on emotional intelligence, emphasizing empathy, active listening, and conflict resolution. Schools and community groups can also play a role by organizing workshops on family communication.

#### 5. Lead by Example:

Children learn more from what parents do than what they say. By demonstrating patience, kindness, and openmindedness, parents can set a powerful example for their children to follow.

To the parents: Be friends with your children. Take serious attention and listen to their problems carefully and try to resolve them in the best way. They need your attention.

## What if Everything You Believe About Yourself Is Wrong?

Have you ever thought to yourself, "Wow, I'm so inspirational!"? Then again, maybe your lingering thoughts are darker. Perhaps you have reached the conclusion that you aren't really good at some things like mathematics, being organized, or maybe acting like a social butterfly.

These self-evaluations about where we excel and what we can accomplish feel real and accurate and determine things like the goals we set and what challenges we are willing to accept. However, research suggests our beliefs about our own motivationare often misguided and can become self-fulfilling prophecies that limit our potential (Meunks et al., 2018). But where do these impressions originate, and what can we do to orchestrate desired change based on reality?

Confluent research reveals that when we repeatedly hear or think about information, there is a strong possibility we come to believe the information as true regardless of accuracy or source (Kahneman, 2011). This problem is so severe that psychologists invented the label of illusory truth to describe the tendency to believe statements that are familiar, even when the message has previously been identified as false. In other words, recurrent impressions will result in personal reality that may or may not be accurate.

When told something repeatedly, we internalize that information, and it becomes part of who we are, and for some of us, this is a huge problem. Minimally, self-evaluations result in some of us becoming harsh critics of our own behaviors and values, while others are prone to inflated selfimages. Either approach can be troublesome.

Self-impressions are influenced by biased opinions grounded in the interpretation of feedback but are also based on such factors as the type of relationship you had with your parents or guardians, socioeconomic opportunities, and a long history of cultural and biologically determined influences. The evaluations are highly meaningful because self-impressions turn into motivations and behaviors. Self-beliefs include many aspects related to values and personality, but when it comes to motivated behavior, these beliefs are focused on how people think about themselves, their capabilities, and the probabilities of achieving success.

Some belief-revealing statements might include "I can never be a (insert occupation or emotion, e.g., 'doctor' or 'happy') no matter how hard I tried," "Hard work doesn't matter much because success is based on who you know," or "What's the point being honest these days? People will just take advantage of you." These types of statements easily reveal how and where you will invest your physical effort and emotional energy and when you will hold back.

#### What happens in your brain The real trouble with the ac-

ceptance of beliefs starts when we get into comfortable behavioral patterns that create neurological benchmarks in our brain, often described as sparking neuronal plasticity. These variations impact the production of important motivational, emotional, and effort investment neuromodulators like tion becomes dysfunctional, and you wind up being in a bad mood, feeling apathetic, and having less fun than having a new toy with no batteries. In the worst cases, you might develop depression or turn to risky behaviors like overeating or substance abuse to get the quick hit of mind-pleasing neuro-



dopamine, serotonin, and adrenaline (Maloney, 2021), the neurological messengers that broadly determine our thinking, motivation, and behavior.

Repetition means neural stability. What feels "naturally" motivating is often simply what we've practiced enough to find rewarding or, in some cases, debilitating. When your brain doesn't get the rewards it craves, neuromodulamodulators that your brain craves.

#### Breaking free from false beliefs

The solution is two-fold: calibrating beliefs with facts and embracing a growth mindset. First, recognize and adjust inaccurate self-beliefs. Start by questioning your narratives. Have they developed from sound evidence or hearsay and wishful thinking? Examine the stories that foretell est accomplishments and determine which conditions contributed to your success.

Apply those conditions to your current challenge. Ask yourself, "When do I engage more deeply? What barriers might be artificial or self-contrived reasons not to act and move forward?" Ultimately, focus on how your engagement commitment develops over time rather than making snap judgments about your "natural" inclinations.

Second, realize that the hallmark of success is embracing a growth mindset (Yeager & Dweck, 2020), an unwavering belief that skills and intelligence are developed via commitment, hard work, and self-development and not by chance or manifest destiny. Embracing a growth mentality means welcoming challenges, persevering despite setbacks, and seeing failures as chances for growth, not a blemish on the portfolio of life. It means rejecting prior impressions and especially the expectation and reaction of others when determining what you need to do and feel best.

Realize that motivation is not fixed but rather dynamic and contextual. Instead of trying to discover your "true" motivational nature, focus on creating conditions that support engagement and growth.

Mindset individuals question assumptions, experiment with different approaches, and design supportive environments because they know they can break free from limiting self-beliefs. Remember, your current beliefs about what motivates you are not fixed truths, and your brain will thank you when you do the hard work to foster change from useless, self-limiting historical patterns of behavior that may be nothing more than a collection of false memories.

Meanwhile, the weatherman here has predicted no wet spell till December 21.

Director Me<sup>T</sup>, Dr Mukhtar Ahmad said that the weather would remain dry for the next 24 hours while on December 15, there is a forecast of cloudy weather conditions.

On December 16 & 17, the weather would remain generally while from December 18-20th, the cloudy weather is expected in Jammu and Kashmir.

As per the MeT's advisory, there is a forecast of a cold wave over many stations during the next four days. "In view of fresh snowfall, subfreezing temperature & icy conditions over roads of important passes and higher reaches, the tourists, travelers and transporters are advised to follow administration and traffic advisory," it reads.

"Still, it is a cabinet proposal and so far not tabled in the parliament. Let there be a detailed discussion on the issue. reporters in connection with the 60th Raising Day celebrations of the force and to highlight the achievements registered by his troops in Jammu this year, Boora said the sector has a sensitive border which is being monitored round-the-clock by boots-on-ground (manpower) and technological advancement with focus to ensure no infiltration from across the border.

"The (drone) activities from across the border have come down and the exact reason for all across the world.

"It is obvious that the terror groups will use it and so our agencies like police, Army and BSF will try it as well. So this is a general process that the type of technology that is available, it is available for everyone and everyone uses it. And the technology that is available, its counter is also available at the same time," the BSF officer said, referring to drone and counter-drone gadgets.

He said if there is any upgradation of technology in Pakistan, the Indian forces are also getting a new version. In fact, India is ahead of its opponents, he added.

"It happens everywhere... there is no need to worry about it because this upgrade is a normal process. If any new thing is available, then it is available for us too. So we use it.

"And I assure you that our government and the forces do not leave any such shortage in upgradation that we are left behind of those who work against us," Boora said, responding to a question on the steps taken to counter terrorists using advanced weapons.

He said the Jammu border comes under the most sensitive border in the country and "our soldiers and officers do a very difficult duty here".

"And in doing this work, the BSF has also achieved great success. For this, I would like to congratulate all the people working under my command," Boora said.

Asked about the threat posed by the use of US-made M4 carbines by terrorists, the senior police officer said there is no specific threat as all weapons are the same.

"There is hype about the foreign-made carbine even though it does not do anything different. It has the same system as other weapons... magazines, bullets and a trigger.

"Today, India is not the same as it was when we had old-fashioned weapons. Now we have new technology, new India-made weapons which are very good," he said.

About the new technology and weapons inducted by BSF in the recent past, Boora said it is not right to divulge the details in the public domain. "I can assure you that the BSF has the latest technology and latest weapons. And whatever technology is upgraded, we immediately invest in it.

## **Power Sector In JK Functions** With Rough-Edges: Dy CM

SRINAGAR: Deputy Chief Minister of Jammu and Kashmir, Surinder Kumar Choudhary Friday said that there were some loopholes in the power sector and more stock was needed ahead of possible harsh winters and snowfall.

Speaking to the reporters, Choudhary said that a review meeting with the Power Development Department was held in Srinagar on the directions of Chief Minister Omar Abdullah.

"We took a review of the available stock and loopholes in the power sector. We found that there were still some loopholes and there was a need for more stock ahead of possible harsh winters and snowfall," he said.

Choudhary further said that the people have an elected government now and if they will face any issues like unscheduled power cuts and distress cuts in Kashmir, they will come and complain with their elected government

"People will be satisfied that their elected government is working and trying hard to provide them all sorts of facilities which the government has promised them," he said.

The Deputy CM added, "We



assure the public of Kashmir that the government has put their representatives everywhere and in the snowfall season, they will not face any sort of problem."

Earlier this week it was report-ed that the Power Development Department (PDD) has requested for more power to reduce the issues of distress and unscheduled power cuts in Kashmir.

A top official had said that demand for power has increased significantly from the past two weeks and requires extra electricity to overcome it. "We are expecting some power from the authorities because we have demanded more power. Let's see what we get," the official had said.

He also said, "As of the, the unrestricted demand of electricity including the ongoing power curtailment schedule has reached 2600-2700 Megawatts. However, as of now we have only 1450 MW of power."–(KNO)

The demand-driven Centrally Sponsored Scheme allows States and Union Territories to propose hostel facilities based on local needs, approved by the Programme Approval Board. The scheme focuses on rental-based accommodations with provisions for day-care facilities for children in urban, semi-urban, and rural areas with employment opportunities for women. Since the launch of Mission Shakti on April 1, 2022, the scheme has discontinued funding for new constructions, shifting its focus to rental accommodations, she said in a reply.

Previously, the grant-in-aid was provided for constructing and expanding hostel buildings, as well as for paying rent for some facilities, the reply added.

## Health Centre In Anantnag's **Dadoo Awaits Completion**

ANANTNAG: Over seven years since its construction began, a health and wellness centre in the Dadoo area of Bijbehara in south Kashmir's Anantnag district remains incomplete. The abandoned building is now being used to store fodder for animals, leaving residents in distress over the lack of healthcare facilities in the area

"In the absence of a local health facility, we are forced to visit hospitals far from our area," said Mohammad Abbas, a resident of Dadoo. He added, "The government should either dismantle the incomplete structure or complete it and make it functional immediately. We feel insecure visiting distant hospitals due to the presence of wild animals."

Locals also expressed concern over the difficulties faced by women and children in travelling to other hospitals, particularly withour families," they said.

**BARAMULLA:** MBBS students of Government Medical College (GMC) Baramulla protested on Friday against recent amendments to the reservation policy and other administrative decisions, demanding justice and fair policies.

The students demanded the restoration of SRO 49, the removal of Rule 17, and the introduction of a Bond Policy for AIQ (All India Quota) students.

Holding placards with messages "Justice for Doctors" and "Eradicate Draconian Rule 17", the students chanted slogans against "unfair and oppressive policies" which they said jeopardise their future in the medical profession.

"We are not against reservation, but the current policy is not justifiable. If 70% of the population belongs to open merit, then 70% of seats should

The students demanded the reinstatement of SRO 49, a regulation they believe ensures fairness for open-merit candidates. "We demand the return of SRO 49, which will provide justice to open merit students who work hard for their seats," another student added.

Raising concerns about the categorisation under the Economically Weaker Sections (EWS), the protesters alleged discrepancies and misuse. "The government needs to reassess the EWS categories. Many people are taking undue advantage of this category, which is unfair to those who genuinely qualify for it," one of the students said. ## **ICC To Finalise Hybrid Model For CT With PCB**

The ICC top brass is likely to finalise the hybrid model modalities for the Champions Trophy during a virtual meeting with Pakistan Cricket Board (PCB) chief Mohsin Naqvi on Saturday, it has been learnt. It has been agreed in principle that neither India

nor Pakistan will travel to each other's country for ICC events. Hence, India and Pakistan will play in Dubai during the 2025 Champions Trophy which will be held from February 19 to March 9.

The tournament will feature eight teams, divided into two groups. The top two teams from each group will advance to the semifinals.

The PCB had said that it was willing to accept the hybrid model only if the same arrangement will be made for all ICC events, awarded to India and Pakistan.

It means that when India will host the 2025 Women's ODI World Cup, Pakistan will not travel to the neighbouring nation and play against them at a neutral venue.

During the 2026 men's T20 World Cup, to be cohosted by India and Sri Lanka, India will not be able to play the marquee clash against Pakistan at home and instead travel to Colombo for the high-voltage clash.

"There's a virtual meeting tomorrow which ICC chairman Jay Shah will join from Brisbane. It is expected that ICC will make an official announcement after that," an ICC official told PTI.

As of now, no compensation will be given to the PCB for accepting hybrid model.

Gukesh became the youngest world champion in the sport after he trumped reigning champion Ding in the 14th round. The game was set for a draw before reigning champion Ding blundered in the 55th move, effectively gifting the game to his rival.



#### "As Nasser Hussain aptly observed, "He's the complete bowler. As he has had back surgery already, it is not certain he will have a long career, but if he does, his name will be mentioned in the same breath as the champions above," Chappell wrote in the 'Sydney Morning Herald'

An all-format bowler, Bumrah has reinforced his status as the best bowler in the world several times including when he led India to a 295run win in the Perth Test recently.

"While the legends of yesteryear established the foundations, Bumrah is carving his own legacy - one that promises to inspire future generations of pacemen."

The former Australia captain said Bumrah's lethal yorkers and unsettling bounce evoked memories of Lillee's raw aggression on the field.

"Lillee was a warrior, combining raw aggression with psychological prowess. I opposed him many times in domestic cricket and watched him

from close quarters against the best batsmen of his era.

"His ability to make it hard for batsmen to score runs with his probing line and length, allied to his guile and determination, made him the champion that he was. Bumrah, though less overtly combative, channels Lillee's ability to unsettle batsmen. His deadly yorkers and disconcerting bounce especially with his unorthodox release point and trajectory - echo Lillee's capacity to dictate terms.

"Bumrah's quiet intensity and precision make him a nightmare, much like Lillee's unrelenting aggression."

Another great of the game was Roberts, who combined pace with strategic brilliance. Chappell felt Bumrah's 2018 performance at the MCG where he used variations to get the better of the batters was reminiscent of the way Roberts operated.

"Bumrah shares Roberts' cerebral approach. Both bowlers use subtle variations to outfox batsmen, relying

on strategy rather than brute force. Bumrah's spell in the 2018 Boxing Day Test against Australia - culminating in 6-33 - was a modern echo of Roberts' game-changing bursts."

"Roberts had a loping and relaxed run-up and a very strong shoulder action like Bumrah, and skidded onto you quite quickly, so it was important to be focused on the ball leaving the hand.

"The danger of a bowler who zeroes in on the stumps, as Roberts did and Bumrah does, is that if you relax for a moment and try to hit across their deliveries, you become even more vulnerable to LBWs and bowled. I would use the same approach against Bumrah," Chappell added

The 31-year-old has consistently churned out stellar performances and is the go to bowler when the Indian team is need of wickets.

"With 151 wickets at an average of 21.03 in just 30 Tests, his ability to excel in diverse conditions recalls Marshall's dominance. Bumrah's reverse swing on abrasive surfaces and his ability to seam and swing the ball under cloudy skies have been pivotal, evoking the same uncertainty that batsmen faced against Marshall.

"As Ian Botham famously remarked of Marshall, "He gave you no respite." Today, batsmen echo similar sentiments about Bumrah," Chappell wrote.

Drawing comparison to Hadlee, Chappell said "Bumrah's meticulousness draws comparisons to Hadlee. His mastery of English conditions, where he averages 22.02, and his ability to exploit even the slightest movement resemble Hadlee's clinical dismantling of batting orders.

"Like Hadlee, Bumrah's focus on perfecting every delivery has made him indispensable in critical moments. He is also carrying the Indian pace attack at present as Hadlee did for New Zealand in his era," he added.
