

J&K's Cesarean Rate At 41%: Late Marriages & Lifestyle Changes Under Spotlight

and Srinagar: Jammu Kashmir's caesarean delivery CD rate of 41 percent is significantly higher than the national average, according to the Lancet Journal's analysis of the National Family Health Survey-5 (NFHS-5) data for 2019-2021. The report highlights significant variations in caesarean delivery (CD) rates across India.

According to a survey of the Lancet Journal, the national CD rate stands at 21.5 percent,

but this figure masks substantial disparities between states, economic groups, and healthcare sectors

States like Telangana, Tamil Nadu, and Andhra Pradesh exhibit the highest CD rates, with Telangana leading at 60.7 percent. Conversely, states such as Nagaland, Meghalaya, and Bihar show some of the lowest rates, with Nagaland at just 5.2 percent.

The survey states that Jammu and Kashmir's CD rate of 41 percent is significantly higher than the national



average. This elevated rate reflects patterns of over medicalization, particularly in private

healthcare settings.

Shah To Chair **Security Meet On** J&K On Dec 19

New Delhi: Union Home Minister Amit Shah is set to lead a high-level security meeting in the national capital on December 19. Official sources confirmed that the meeting will focus on key security issues, particularly concerning Jammu and Kashmir.

Lieutenant Governor of Jammu and Kashmir Manoj Sinha will join the discussions to review strategies for maintaining peace and stability in the Union Territory. Other prominent attendees include National Security Advisor Ajit Doval, Union Home Secretary Govind Mohan, Intelligence Bureau Director Tapan Deka, Chief of Army Staff General Upendra Dwivedi, senior army officials, Director Generals of Central Armed Police Forces (CAPFs), and top officers from Jammu and Kashmir, including the Chief Secretary and the Director General of Police.

This meeting comes nearly five months after Amit Shah last chaired a similar security review in June. The agenda will revisit strategies like the "area domination plan" and "zero terror plan," which have been successfully | More on P6

'One Nation, One Election' J&K Reorganisation Act Set For Amendment

Srinagar: The Union Government is set to introduce a significant bill in the Lok Sabha on Monday, aiming to amend The Jammu & Kashmir Reorganisation Act-2019 as part of its push to align the region's electoral cycle with the "One Nation, One Election" initiative.

The amendment, which will be presented by Union Law Minister Arjun Meghwal, will also affect other legislative frameworks, including the Government of Union Territories Act, 1963 and the Government of National Capital Territory of Delhi Act, 1991, to synchronize elections in Puducherry and Delhi with



Jammu & Kashmir Legislative Assembly, ensuring its alignment with the term of the Lok Sabha. Under the new bill, the J&K Assembly's term shall come to an end when the Lok Sabha's full term concludes.

effect on an "appointed date," which will be notified by the President after the first sitting of the Lok Sabha following a general election. Since the first sitting of the 2024 Lok Sabha has already ocwill be during the first sit-ting of the 2029 Lok Sabha. Consequently, the first simultaneous elections in Jammu and Kashmir could be held by 2034 when the current Lok Sabha term concludes.

The bill clarifies that it will not affect the current five-year term of the J&K Assembly. In cases where the Assembly is dissolved before completing its term, midterm elections will only be held for the re-

mainder of its five-year term. In cases of premature dissolution, the remaining period of the original term will be treated as the unexpired term, with any new Assembly formed during this time serving only the remainder of that period. Furthermore, the new

"Submitted this impeachment motion today with signatures of more than 100 Hon'ble members of Parliament. I am thankful to them and feel assured that we still have people in the country who believe in unity, plurality, equality and all other values and spirit of the Constitution," Ruhullah said in a post on X.



He expressed his gratitude to the political parties and his colleagues in Parliament who supported the notice.

"My thanks to @AITCofficial, @samajwadiparty for their unconditional support. I thank @ INCIndia for letting their individual members decide out of their

individual free will. I also thank @asadowaisi, @BhimArmyChief, Rajkumar ji, Mohibbullah sahab and Zia u Rahman sb for their support (sic)," Ruhullah said on the microblogging platform.

On December 10, Ruhullah had said he would move the notice for impeachment against Justice Yadav and needs the support of 100 MPs for the same.

Addressing a provincial convention of the legal cell and high court unit of the Vishva Hindu Parishad (VHP) on December 8, Iustice Yadav said the main aim of a uniform civil code (UCC) is to promote social harmony, gender equality and secularism.

Power Supply In Kashmir Increased By 100-150 MW

Srinagar: In order to minimize the unscheduled power and distress power cuts in Kashmir valley, the Power Development Department has recently increased the power supply by nearly 100-150 Megawatts (MWs).

A top official of PDD said that the decision of supplying extra was taken in a recent review meeting of PDD and Chief Minister Omar Abdullah.

"Recently, some important decisions were taken by the Chief Minister Omar Abdullah regarding the electricity issues in Jammu and Kashmir. We have implemented those

decisions to reduce the power cuts," the official said.

He said, "KPDCL was receiving 1500 MWs of power and now it has been further increased to 1600-1650 MWs to address the unscheduled and distress power cuts. The same amount of power is already being supplied.'

About the status of installation of smart meters in Jammu and Kashmir, the official said that "Over 6.5 Lakh smart meters have already been installed."

Police Attach Property Worth Lakhs Under NDPS Act

Srinagar: In its relentless efforts to curb the menace of drug peddling, Jammu and Kashmir Police in Srinagar on Saturday said to have attached a singlestoried residential house valuing about Rs 19 lakhs, belonging to a chronic drug peddler namely Mohammad Younis Wani, son of Mohammad Maqbool Wani resident of Ranbirgarh Srinagar.

The property was attached in a case under FIR number 85/2024 NDPS Act, a police spokesman said in a statement issued to Kashmir Observer.

"The accused person is a drug ped-

dler who has been found involved in selling drugs and narcotics among the youth for which case FIR No. 85/2024 under sections of 8/21 Narcotic Drugs & Psychotropic Substances Act (NDP-SA) stands registered in Police Station Shalteng, Srinagar," police said. '

In compliance to section 68 E and 68 F of NDPS Act, the immovable property acquired by the accused person through illegal means which stands seized and attached, shall not be transferred/ sold/purchased or otherwise dealt with without the prior permission of the competent authority." police said.

Internet Telephony Soon

•EW DELHI: In a major policy decision, the government has de-cided to scrap the old Telegraph Act and replace it with a new Con¬vergence Act, which allows making telephone calls through the In¬ternet, Union Information Technology Minister Pramod Mahajan announced in Pune on Sunday.

Under the existing 1886 Telegraph Act, there were separate rules for delivery of voice and picture data through telecommunication channels and hence using the Internet to make telephone calls (In¬ternet telephony) was not permissible, he said addressing the con¬cluding function of a two-day conference on Information Tech¬nology and Biotechnology.

The new Convergence Act takes into consideration all these as ¬pects and evolves a uniform law, Mahajan said. He said the Conver¬gence Act will have uniform laws regarding the delivery system of voice, picture, digital and other forms of data through telecom-munication channels. He said the final version of the new Con¬vergence Act was ready and will be cleared by December 21 by a Group of Minister dealing with this act. By December 25, it will be released on the Net for people to give suggestions and objections.

New Reservation Policy Government Must Reverse it Now!

pen any social media platform today, and you are greeted with posts, videos, and discussions dominated by a single contentious issue: the new reservation policy. Students are taking to the streets in protest, and those who aren't, they can be seen channeling their frustrations through every means available. The topic of reservation is becoming pervasive. It is sparking debates that are increasingly polarized and acrimonious.

The timing of the discussion about the reservation issue, just after elections, has added fuel to the fire. Many voters, particularly the youth, had pinned their hopes on political parties they believed would bring fairness and justice to governance. With the National Conference (NC) government now in power, supported significantly by the youth electorate, public expectations are soaring. The government is seen by many as the final resort that can rectify what they view as an unjust reservation policy.

However, the government's initial response—forming a cabinet sub-committee to review the policy—has not inspired confidence. The committee's composition, made up of majority of members from reserved categories, has been criticized for lacking impartiality. Adding to the skepticism is the absence of a clear deadline for the submission of the committee's findings. To many pragmatic observers, it is a tactic to buy time than a sincere attempt to resolve the issue.

Recently during a media interaction, education minister Sakina Yatoo, a member of the cabinet subcommittee, stated that commenting on the reservation issue is inappropriate as the matter is sub-judice. Such remarks make it evident how much we can realistically expect from the sub-committee.

The Litmus Test for the National Conference For the NC government, the reservation policy represents one of the first major challenges since coming to power. The youth, who voted overwhelmingly for the party, see this as a defining moment. Their dissatisfaction with the policy was evident during the election campaign, and now they expect swift and decisive action. How the government handles this issue will be a litmus test for its ability to meet public expectations and honor its promises. At the very least, the NC government must take steps to reverse the policy to its previous state. Restoring the status quo ante would not

solve all the problems associated with reservation, but it would quell immediate tensions and bring relief to those who feel disenfranchised by the new rules. Such a move would also demonstrate that the government is listening to its electorate and is capable of acting in the public's interest.

NC government must understand that people want them to reverse the new reservation policy immediately — long-term reforms can wait.

The Social Media Battle

The debates around reservation on social media are becoming increasingly toxic. Arguments have turned into personal attacks, with individuals from opposing sides trading barbs. The open hostility is alarming, and if left unchecked, this divisiveness could escalate into something more serious, threatening the social fabric.

One common grievance voiced by those from open merit categories is that reservations are unwarranted and lead to undeserving candidates occupying government positions. This narrative is both unfair and misleading. The difference in scores between open merit candidates and those from reserved categories is often negligible, and reserved category candidates also face intense competition within their respective quotas. viduals from reserved categories view reservations as an inherent right rather than a temporary measure to address historical injustices. This perspective has led to resistance against any reforms, including the sub-categorization of Scheduled Castes (SCs) and Scheduled Tribes (STs). Yet, many rightthinking individuals within these communities recognize the need for reform and advocate for measures like sub-categorization, which could help address disparities within reserved groups.

Systemic Reforms Needed

While reversing the new policy is an immediate priority, it is clear that the reservation system as a whole needs systematic reform. Over the years, the system has strayed from its original purpose of bridging social and economic inequalities. Instead, it has often become a tool for political appeasement, leading to resentment and polarization.

Any meaningful reform must strike a balance between addressing historical injustices and ensuring meritocracy. Sub-categorization of SCs and STs, for instance, could ensure that the benefits of reservation reach the most disadvantaged within these communities. Similarly, periodic reviews of the socio-economic status of beneficiaries could help prevent the misuse of reservations by those who no longer need them. However, these reforms require a national dialogue and consensus. They cannot be implemented hastily or without considering things thoroughly. For now, the NC government must focus on calming the immediate unrest by reversing the policy to its previous state. This would provide breathing room for broader discussions on long-term reforms.

Tailpiece

As the protests continue and the debates grow louder, will the government choose to act decisively and restore public confidence, or will it succumb to the inertia of political expediency? The answer to this question will determine not just the fate of the reservation policy but also the legacy of the National Conference government.

In the end, what is needed is not just a rollback of policies but a genuine effort to address the issue. Only then can we hope to move beyond the divisive debates and towards a future where opportunity is not a matter of privilege but a fundamental right for all.

enhanced community mobilisation. It has united various community stakeholders creating a mass movement to increase awareness and to provide nutritional, vocational, and psychological support to TB patients. This government-citizen symphony anchored in the spirit of Jan Bhagidari has inspired 1.75 lakh Nikshay Mitras to provide 21 lakh food baskets to patients across the country.

Over the years, India has introduced newer drugs such as Bedaquiline and Delamanid to ima shorter 9–11-month regimen available alongside the conventional 19–20-month regimen, with the BPaLM regimen, patients will now complete treatment in just six months!

We have consistently strived to ensure that advanced tools are available at the grassroots levels to find and treat all patients at the earliest. To enable this, we introduced more efficient and accurate diagnostic tools — molecular tests. From a few hundred machines in 2014-15, we now have 8,293 molecular di-

agnostic machines available in all districts.

In fact, taking a cue from the Make in India initiative, indigenous molecular tests have been field-tested and introduced. We have been able to not only reduce the time taken for TB diagnosis at district and block levels but have drastically reduced the costs of testing and treatment. We must also take great pride in the fact that the Indian Council of Medical Research (ICMR) has consistently been among the top public funders of TB research worldwide since 2018. We will continue making investments to quickly develop and roll out newer tools, including more efficient PoC diagnostics.

India's journey toward TB elimination is a testament to its leadership. From pioneering research that has led to advanced diagnostics and treatments, to the introduction of universal social support provisions, India stands at the forefront of the global TB response. The need of the hour is to ensure a massive Jan Bhagidari in the identification, diagnosis, treatment and prevention of TB. The intensified 100-day campaign is another testament to our collective commitment to eliminate TB. I am confident that under the PM's leadership and with the participation of all stakeholders, we will defeat this great enemy of humanity and create a healthier future for all

ways. Over a period of time, these become roads and highways; for movement of men, material and ideas too; transactions of all types, to state it briefly.

During the 70's & 80's of the last century(- that happened to be my prime time), the activities of foreign as well as local trekkers & expeditionists kept circulating at a good pace and in a sense built on what I had inculcated from the mission school, where I had studied. Though presently my involvement remains limited(merely) to reading about expeditions, & treks or studying-maps & atlas; (- that shed more light on the study material in hand), but of late a good number of our local youth have again started participating actively in these adventuresports; and they, I learnt, are finding the encouraging gestures of another son of the soil, Mehmood sb(-ex Director Tourism), contributing positively; even when he is looking after another department, officially. Now, O'dear readers, here is the verbal-tour that I was designing.

Scanning the rolled out map of J&K, reveals that almost 140 kms away from Srinagar lies Gurez (*Gurais*) where Kishenganga river flows. Just ahead of Gurez, beyond Minimarg lies the famous *Burzil Pass*,that further ahead leads to *Astore, Bunji* & then to *Gilgit* on the North-West side; further to *Hunza* and *Khunjarab pass* & then to *Kashgar*. North East of *Burzil* leads to *Skardu* and then to *Shigar etc.* Skardu can be reached from Kargil too, via *Kiri.*

Gurez we know falls in the ancient Silk-route. *Dawar* is the Central town and the Valley of *Tulail* (*Telail*) lies north of *Gurez* valley.When winter brings heavy snow the famous *Razdan* Pass, we hear every year, cuts off this area.

Moving from Srinagar to Kargil via Zojila pass and then to Leh (of Ladakh); crossing Khardungla Pass, moving ahead to Bogdan, then to Chorbat, to Khapulu, we can also reach Skardu.

If one goes from *Leh* to *Khardungla* and thence to *Changla* (Nubra), then via *Thalam-buti* valley to *Karakoram* Pass we reach *Yarkand* (- in *Xinjiang/ Sinkiang* of China).

There is one more route from Baramulla via Muzaffarabad to *Chilas* to *Bunji* to Gilgit to Hunza, then to *Nagar &* ahead *to Khunjarab Pass* reaching ultimately Kashgar. As of present we find J&K is nestled by Pakistan on the west, China (*Xinjiang*) on North and China/Tibet on south. Before we proceed to things of our present interest, refresh the fact of history that politics keeps on changing boundaries though geographical markers remain more permanent.

On these roadways of yore men travelled, mostly traders,but a significant number of expedition- lovers who left accounts of their travel, trekkers,

hunters, explorers, knowledge/ faith workers & scholars, tourists and of course men on special missions too. Quite interesting is the fact that humans traversing these routes recorded their 'gains- in- the- knowledge sector'; what they observed, learnt, studied, has been transmitted and all that has impacted, not only the people of their time but future generations, too. For a moment build a mental image

of these foreign guests travelling with a huge retinue, consisting of porters/ coolies (two for one visitor, each carrying a load half of the pony; earning half

'epitomised' for stubbornness.

Fallen to disuse, haunted by injury or ill health or old age the members of this species breathing in 'the backyard of yesteryears', i:e Ladakh, these pack animals were lucky to gain good care and health with the coming up of special care Donkey-Sanctuary in Leh recently, in 2008. One little diversion: During the years spent in Ladakh, a poem occurred when I, for the first time, saw some Skiang, Wild Mule/Horse (Equus hemionus or Equus kiang), related to this creature, in the Nyoma block, standing some meters away from the river; that was covered with a very thick layer of ice when it was the second fortnight of March 1985.

Recall. In 1847 Alexander Cunningham was in Ladakh. Men Of Moravian Mission were active in Leh from 1885 and in Khalsi from 1899. They worked in the field of Education, Health, Archeology and Literature. It was they who translated the Royal Chronicles Of Ladakh, *La-dvags-rgyal-rabs;* that were collected in 1856 by Munich Schlagintweuit after being sponsored by Alexander Von Humboldt of Munich.

From 1870 onwards the British Joint Commissioner of Ladakh looked after the upkeep of the roads leading from Zojila and Karakoram Pass [...more than 400 kms] and that between Leh and Lahoul. Postal service was organised by the British while as telegraph offices by the Dogra Maharaja; in the era of annexations ushered by their famous General Zorawer Singh(around 1841). *Dak Banglows* and *Sarais* were maintained by the British Joint Commissioner of Ladakh. Since every trade employed men and packs of loads, roped on their back; off they negotiated difficult terrains, for weeks, their feet placed in pieces of hides,covered with woven woollen cloth pieces, tied with leather bands, braving harsh climate,scarce food and water, onwards moved these men along with these ponies; facilitating their employer (rich traders as well as *Sahabs*). Some photographic evidence of woman porters of the nomads of Nobra too are there. Heart-renting ones too; of bare-footed porters, while a layer of snow on gravel paths was also visible.

On every pony a tax of three *Pice* was levied on crossing the *Khardungla;* (-being the rate of 1893), or produce valuing the same amount. Ponder: by 1920 trade worth ninety three lakh Rupees is said to have happened via Ladakh (..that is what i have read somewhere.).

During the rule of Maharaja Pratap Singh Ladakhi's were given loan to breed ponies.

In 1876 Gilgit was the extreme North West area of the British Empire. In 1889 a '*Political Agency*' was opened there, though earlier in 1876 a feeble attempt had been made, first. Notable point is that North of Gilgit 'Russian officers held sway'.

Almost all the parts of Baltistaan(-*Astore, Hunza, Khapalu* etc) had there local *Rajas* and quite interesting is an account that says that a descendant of *Yabgo* dynasty of East Turkistan, namely Nasir Ali khan was reportedly ruling the *Khapalu* region of Baltistaan in 1911. Hold it...an interesting info: for weeks together, entourage of many rajas of Baltistaan area were seen trudging in compliance through these terrains (Oct-Dec 1911); when directed to be present in Delhi where Coronation Day of King George V, as emperor of India, was going to be celebrated.

The population of Baltistaan is constituted of Tibetans and Dards(-of Aryan origin; like those in *Drass* of kargil) and travellers leaving behind the *gonpas* of Nobra are greeted by small mosques as followers of *Shia-Islam* of Nurbakhshiya order grew there right from 15-16 centuries, to gain dominance in Baltistaan.

Post-1947 era and post 1962 happenings interests me not, today.

As far as trade- items are concerned, Ladakh had salt of Tso-ker lake, Sulphur, Borax, dried Apricots, sheep wool and above all Pashm; Lhasa/Tibet sent Turquoise, Carpets, Tea and Fur; Khapalu had Apricots, Walnut etc; Gilgit had Apricots, Walnut, Apple; Sinkiang had Tea, Precious Stones and Silk; Yarkand had Tobacco; Turkmenistan had Hashish; Kashmir had Rugs & Opium and from India a number of items Spices, Cloth and the list can go on & on. Salutations Moorcroft, Trebeck, R.Shaw, Cunningham, Hedin Drew Francke Sn lgrove S, Neve, Petech, J. Rizvi, and scores of others (including E.Joldan) but wait I am expecting mail from one more writer John Bray. Bye!///

Since Ladakh had very few things of their own but geographical positioning gave them an advantage and they tapped it to the extant that Leh (it's capital) came to be described by writers as 'the cosmopolitan city' because of the fact that traders from all surrounding countries/ areas, from different ethnic groups, of India, Punjab, Kashmir, Afghanistan, Lhasa, Tibet, East Turkistan; (-distinguishable by their physical features and dresses, as recorded); have been seen in the Leh-Bazar; even some have mentioned '...from Siberia and the remotest districts of Central Asia, ... of various races and creeds'; used to visit Leh and stay there even for months; busy in trade related activities. During his first stint August Her-

During his first stint August Hermann Francke worked in the Khalsi region of Ladakh from 1899 to 1906 and coming back from Germany to Leh again in 1914, he further went to Central Asia. Another important guest, Dr.Ernest Shaw, too visited in Ladakh, and died here in 1907, it is said, due to Typhus. Besides trading off a few things that Ladakh had, they, like the people of Balti-staan, profited mainly from portering and hiring out pack animals. Compulsions of earning money led many to become porters, carrying

J&K Editors Seek Advt Rates As Per DAVP Norms

Srinagar: Leading newspaper editors in Jammu and Kashmir have called on Lieutenant Governor Manoj Sinha to address the ongoing disparity in advertisement rates set by the Department of Information and Public Relations (DIPR).

In a joint statement, the editors highlighted a significant disparity between the advertisement rates offered by the Jammu and Kashmir Government and those in other Union Territories like Delhi and Chandigarh. While advertisements government in these UTs are issued at rates prescribed by the Directorate of Advertising and Visual Publicity (DAVP), as per the Union Ministry of Information and Broadcasting, J&K continues to follow its lower DIPR rates, which fall well below the DAVP standard.



"This disparity in advertisement rates is severely undermining the financial stability of newspapers in Jammu and Kashmir," the editors said. "While other UTs have adopted DAVP rates, the persistent reluctance of J&K to follow suit is making it increasingly difficult for us to sustain our operations in an already challenging environment." The editors further stressed that the cost of newsprint has surged by an alarming 300%, worsening the financial strain on

In their appeal, the editors urged the Lieutenant Governor to consider the long-term effects of this issue. "Aligning J&K's advertisement rates with DAVP norms would not only provide muchneeded relief to local newspapers but also enhance their ability to effectively disseminate government policies and initiatives in this strategically important border region," they stated.

The signatories of the appeal include editors from leading publications such as Daily Excelsior, Rising Kashmir, Kashmir Observer, Dainik Jagran, Early Times, News Now, Udaan, Kashmir Monitor, Kashmir Scan, Uqaab, Greater Jammu, Punjab Kesri (Jammu), Morning Kashmir besides others.

Through this collective plea, the editors have called on Lieutenant Governor Manoj Sinha to personally oversee the revision of the advertisement policy to bring it in line with DAVP rates. Such a move, they argued, would help ensure the survival of media outlets in the region and strengthen the democratic process by supporting a free and vibrant press.

could improve accessibility for disadvantaged groups. Additionally, better regulation of private healthcare and awareness campaigns promoting safe vaginal deliveries could help balance medical necessity with equitable access.

On the issue of high cesarean rates in the Union Territory of Jammu & Kashmir, speaking to Kashmir Observer, Dr. Masuma Rizvi, HOD, Obstetrics and Gynaecology, LD Hospital, Srinagar said that there are various social and medical reasons for which the trend of cesarean deliveries is higher in J&K.

For medical reasons, she said the age of pregnancies is very high.

"We have many patients who are more than 35 years of age with hypertension, diabetes, and they come to know about these ailments before getting pregnant, so they are not ready to take the risk of a normal delivery. Usually, our hospitals don't have round-the-clock maternity services. When a patient goes into labor, she does not find herself safe, and labor is a process which takes a minimum time of 24 hours. This is one of the reasons," Dr. Rizvi said. She further added that the cesarean delivery

rate has increased throughout the world. "It ranges from around 20 percent in Sub-

Saharan Africa due to the lack of facilities to 70 percent in Ireland and the US, where all advanced facilities are available."

Another reason for higher cesarean rates, Dr. Rizvi said, is the attitudinal changes in the younger generation.

"Patients are not ready to bear the pain during the delivery period, they look for easy ways, i.e., cesarean. Lack of manpower and infrastructure in the private sector is another reason. Those patients who do not want to get their deliveries done in governmental hospitals have very little chance of a normal delivery in a private hospital."

The Lancet report also reveals that economic inequalities play a significant role in CD rates. Women in the richest wealth quintile experience a CD rate of 39.1 percent, compared to only 7.3 percent in the poorest quintile. The national inequality ratio between the richest and poorest groups is 5.3, highlighting the stark contrast in access to this critical procedure. Furthermore, the private healthcare sector consistently performs more CDs than the public sector across all economic groups, with wealthier populations disproportionately represented in private facilities According to Dr. Rizvi, the socioeconomic burden on women has increased. "One group of girls is career-oriented, and the other group does not have the right economic position and ends up getting married late, which leads to complicated pregnancies. If there are two girls of the same economic and family backgroundone getting married at 20 and one at 40-the one getting married at 40 has fewer chances of a normal delivery, as the risk of different diseases increases with age. The one at 20 has fewer chances of abnormalities in delivery," she explained. Seconding Dr. Rizvi, Dr. Farhat Jabeen, a senior gynecologist and ex-HOD, Gynaecology, GMC, Srinagar said, "A lot of high-risk pregnancies are being reported in Kashmir. One major reason is late marriages. Patients are not ready to bear the labor pain, and they say, " want to have painless labor.'

make people aware that cesarean is a traumatic delivery, an abnormal route of delivery, and the surgery has complications associated with it." She also voiced concern on cesarean delivery rate in Jammu and Kashmir being above the national average is a matter of concern.

"I always tell my patients that vaginal delivery is the best mode of delivery, and it has many advantages. I try to make them understand that around eighty percent of women can deliver babies without complications, but they want one hundred percent surety, which cannot be given. "We resolve to reinvigorate our struggle for peace with dignity for the state of Jammu and Kashmir, using all democratic and constitutional methods to resolve the Kashmir issue, including the restoration of the special status that was enjoyed by our people until August 5, 2019, under the Constitution of India," the PDP said in the resolution.

The party also expressed "deep concern over the increasing climate of hatred against Muslims in India" and implored Prime Minister Narendra Modi to leverage his influence to curb violence, dispel false narratives and halt the "targeting of Muslims through what we perceive as judicial overreach".

"We reaffirm our belief in India as a nation that celebrates diversity, mutual respect, and the protection of individual rights and beliefs," the PDP said in the resolution. The general council also called for the release of political prisoners.

It is more a bent of mind wherein people think that through a cesarean, the baby is taken out, and the patient has no trauma, no distress, and no issue in the birth canal. People want shortcuts."

"We often say a woman delivered normally in retrospect. However, I cannot firmly say, 'This patient will deliver her baby vaginally,' because from labor pains to delivery, a mother must overcome many hurdles. If there are no high-risk factors, around eighty percent of patients can deliver without problems. However, about twenty percent may require cesareans or experience traumatic vaginal deliveries, which are well-known facts worldwide. Therefore, we need to educate people."

Dr. Jabeen said that they, as a medical fraternity, have a bigger role to play. "Ordinary people, elders, social media—everyone has a role to "India's democracy, its republican past, has been very prosperous. "So no. In the two months that I've been chief minister, I have yet to come across a single example where J-K has benefited out of being a Union Territory. Not one. There's not a single example of governance or development that has come to J&K by virtue of it being a Union Territory," he said.

Jammu-Kashmir was reorganised into a Union Territory in August 2019 under an Act of Parliament after the abrogation of Article 370 of the Constitution, which had given the erstwhile state special powers and status.

The Union's Territory's governance was

be taken by only two persons -- the Prime Minister and the Home Minister.

"Ultimately, the Prime Minister and the Home Minister are the ones who are going to have to sit down and decide if this is what has to be done and this is when it has to be done. Either that, or then it has to be mandated," he said while replying to a question that the National Conference could use allies of NDA to influence the government for the restoration of statehood.

Heart Attack Incidence Soars In Kashmir During Winter, Say Cardiologists

SRINAGAR: The incidence of heart attacks and strokes doubles in Kashmir during winter as exposure to cold constricts blood vessels, forcing the heart to work harder, experts warn. Dr Irfan, a cardiologist at GMC

Srinagar said that cold weather significantly impacts cardiovascular health, which leads to a rise in heart attacks and strokes during the winter months.

'The incidence of heart attacks and strokes more than doubles in Kashmir during winters compared to summer," he said. "Exposure to cold causes blood vessels to constrict-a process known as vasoconstriction-which elevates blood pressure and forces the heart to work harder to circulate blood throughout the body. This added strain exacerbates existing heart conditions and increases the risk of cardiovascular events."

He explained that colder temperatures thicken the blood and make it more prone to clotting, which heightens the risk of heart attacks and strokes. "People with underlying medical conditions like diabetes, hypertension and smokers are more vulnerable as they are usually immunocompromised," Dr Irfan said. "In winter, increased tea consumption can elevate blood sugar levels, a major risk factor for heart attacks and strokes.'

Dr Irfan also highlighted that



many heart attack patients are misdiagnosed and treated for other illnesses, complicating their condition further. Dr Javid, another cardiologist,

advised people to take extra precautions in winter to prevent heart attacks and strokes. He recommended dressing in layers, using scarves, gloves, and hats to maintain body warmth, keeping homes wellheated and avoiding prolonged exposure to the cold.

The doctor urged people to exercise indoors if it is too cold outside and to avoid strenuous outdoor activities, such as heavy shovelling, in extreme cold. "To reduce risks, people should consume a heart-healthy diet rich in fruits, vegetables, whole grains, and lean proteins while limiting salt, sugar, and saturated fats," he added.

Doctors advised staying hydrated to prevent blood thickening and knowing the symptoms of heart attacks (e.g., chest pain, shortness of breath) and strokes (e.g., face drooping, arm weakness, slurred speech)

presented which envisaged smooth functioning of essential services and connectivity across the Union Territory, particularly in snow prone areas. It was informed that as a mat-

ter of priority, MED will oversee the clearance of 10,223 km of roads with 6,728 km categorised as Priority-1, including highways, hospital routes and roads to critical infrastructure. Besides,



for snow clearance on 4042 km of rural roads with an additional 4 contracts under process, the

meeting was apprised It was also given out that 310 snow clearance machines have been mobilized by MED, with an increase from 254 machines last year. Besides, a total of 293 operational staff have been deploved, compared to 231 last year, to handle challenging conditions.

The meeting discussed key roads and highways such as (Banihal-Qazigund), NH-44 Mughal Road, Bandipora-Gurez Road, and Patnitop routes as critical areas of focus requiring special focus. Ensuring uninterrupted supply chains for LPG, petroleum and essential commodities was identified as a priority area.

BRO, NHIDCL and PWD (R&B) highlighted the availability of snow cutters, dozers and graders to maintain road connectivity. Besides, SMC and Urban Local Bodies (ULBs) presented their readiness to handle city roads with 422 machines in-

'Low Fibre Intake, Sedentary Lifestyle Can Lead To Constipation'

SRINAGAR: A low-fibre diet and sedentary lifestyle are key contributors to constipation, a common digestive issue which includes infrequent bowel movements, difficulty passing stool, or a feeling of incomplete evacuation, according to experts. Dr Murtaza, a general physician at DHSK, said that constipa-

tion is defined as having fewer than three bowel movements per week. While occasional constipation is normal, chronic cases can affect quality of life. "Constipation can result from dietary factors such as low fibre intake insufficient water consumption and a diet high in processed

foods," he said. Lifestyle factors include a sedentary routine, ignoring the urge to defecate, and stress. Medical conditions such as irritable bowel syndrome (IBS), hypothyroidism, diabetes, neurological


disorders, intestinal obstructions and scar tissue can also lead to constipation, he added.

Certain medications, including painkillers (especially opioids), antidepressants, iron supplements, and antacids containing calcium or aluminium, as well as pregnancy and ageing (slower metabolism and reduced bowel muscle strength), also lead to constipation.

Dr Mushtaq warned that chronic constipation can lead to complications such as haemorrhoids, anal fissures, faecal impaction, rectal prolapse and psychological distress.

He advised lifestyle and dietary changes to prevent constipation, including consuming high-fibre foods such as fruits, vegetables, whole grains, and legumes. Drinking at least 6-8 glasses of water daily, engaging in regular exercise, and establishing a consistent bathroom routine are also essential, he said. –(KNO)



Australian Openers Start Well On Rain-Curtailed Day One

BRISBANE: Local hero Usman Khawaja and young Nathan McSweeney displayed sound defensive technique against Jasprit Bumrah but persistent rain played havoc with the opening day of the third Test, allowing only 13.2 overs of play in which Australia scored 28 for no loss against India, here Saturday.

The gloomy weather didn't allow any action after the raincurtailed first session. The weather in Brisbane indicates a start-stop game throughout

the next four days. Khawaja (19 batting, 47 balls) and McSweeney (4 batting, 33 balls) traded aggression with caution but the senior left-hander still got a couple of boundaries when Mohammed Siraj pitched it short.

While India skipper Rohit Sharma would be happy that Australia didn't score way too many runs, his bowlers did not force the opposition openers to play more deliveries. A lot of



deliveries were left from length. Just when it seemed that Indian attack was getting into its groove, heavens opened up, putting brakes on the bowling momentum.

Bumrah (0/8 in 6 overs) bowled his least potent open-

ing spell of the series so far. Despite overcast conditions and enough bounce on offer, he didn't bowl too many wickettaking deliveries in that sixover first spell while Siraj (0/13 in 4 overs) was guilty of occasionally pitching it short.

In case of Bumrah, he rightly pitched it up but there was very little hint of swing on offer due to high humidity and only on few occasions he was able to square up Khawaja while coming round the wicket. The lines that they bowled,

drifted towards the leg-side more often than not.

With not many probing questions asked, the first 25 minutes before the steady drizzle stopped proceedings saw Australia reach 19 for no loss.

While McSweeney defended dourly, Khawaja did pull Siraj for a boundary before the break and added one more after play resumed.

During the hour's play, the highlight was how Khawaja dealt with Bumrah's first spell.

He defended well by dropping his bottom hand and trying to play as late as possible. The balls that went past Kha-waja's outside edge weren't about being getting beaten but rather, he kept the bat close to his body, allowing the ball to deviate past the willow. He only played deliveries that were bowled into his body.

He knew that if they can manage Bumrah's first spell which is generally between six to eight overs, they can dominate other bowlers.

Amir Announces Retirement

Real Kashmir To Play Namdhari FC In I-League Today

SRINAGAR: In their first away game of the 2024-25 I-League season, Real Kashmir FC will take on Namdhari FC today, Sunday, December 15, at Namdhari Stadium in Bhaini Sahib, Ludhiana, Punjab. The game kicks off at 2:00 PM and will be broadcast Sony Sports 2 and SSEN App.

The Srinagar-based Snow Leopards are unbeaten in the league after four rounds of games. They have taken eight points after winning two and drawing two at home, ranking third in the I-League standings. On the other hand, Namdhari are second-last after winning one, drawing one and los-

ing two games thus far. Real Kashmir will be

the favourites for this game, but considering it is an away match, any thing is possible. Amorim Says Man United Will 'Fight' For Victory At Man City

MANCHESTER: The Portuguese is preparing for his first derby since arriving at Old Trafford last month -- with both teams desperately in need of a win.

United, 13th in the table ahead of the weekend fixtures, have won only once in four league matches since Amorim joined the club.

Pep Guardiola's City have just one victory in 10 games in all competitions but are still eight points ahead of their rivals in the English top flight.

United were buoyed by Thursday's 2-1 Europa League comeback win at Viktoria Plzen but they desperately need to turn their form around in the league -- they have their lowest points total after 15 matches since 1986.

"I am always looking forward to coaching Manchester United, especially in the derby but we have so much to focus (on)," United manager Amorim told MUTV.

'We are focused on improving day by day, and we want to see different things.

"I think we did a good job in the first half against Arsenal (in an eventual 2-0 loss), so we have that ability, we have players to do it, and we will try to do it again and try to win the game

The former Sporting Lisbon boss said it was vital to create a winning culture after United's Europa League victory in midweek, during which they recovered from a goal down, thanks to two strikes from Rasmus Hojlund.

"You don't (get) carried away about the winning -- we should win this type of game that we had Thursday -- so now we're going to another game we need to win." he said. "We lost the other two in the Premier League (Arsenal and Nottingham Forest). We have to have this feeling of winning these kind of games, and we

will be ready. "Of course, we know that we have a lot to improve. A lot of things are changing here but we will fight for the game." United have had some torrid

Guardiola Accepts Man City May Need To Sign More Players

Manchester City manager Pep Guardiola believes he will need a bigger squad to handle soccer's ever-expanding fixture schedule.

City has been weakened by a host of injuries and is still competing in three competitions, including an expanded Champions League. At the end of the season, it has the Club World Cup in the United States.

"It made me reflect that maybe with this calendar you need a squad with 25, 30 players. It will be more difficult financially for the club," Guardiola said on Friday.

"People say, 'What is the problem?' The problem is the schedule.

"Sooner or later it will happen for all clubs. When we won the treble (in 2023), the four domestics, we have one, two,

stable. That's why we could compete, and now we cannot."

Key players Rodri, Kevin De Bruyne, John Stones, Ruben Dias and Phil Foden have been injured or ill and City's form has unravelled. The four-time defending Premier League champion is on a run of seven losses and only one win in its last 10 games in all competitions.

City is fourth in the standings, eight points behind leader Liverpool going into the derby against Manchester United on Sunday.

"We are sad, I'm sad for the players because the way they run and they fight with the circumstances they have," Guar-diola said. "Our fans, maybe they are sad. I understand completely because maybe we lose seven games, eight games in one season or in two seasons, and now (in) a month and a half."

In September, Rodri said players were close to taking strike action over the number of games they have to play.
