

Srinagar: Chief Minister Omar Abdullah Monday reiterated his government's commitment to unbiased governance, emphasizing that decisions would not be influenced by political affilia-

tions or party lines. He urged officers to address public issues brought forth by elected representatives with seriousness and urgency. Chairing a district review meeting at the Conference Hall in Samba, the Chief Minister was accompanied by Deputy Chief Minister Surinder Choudhary, Ministers Sakeena Itoo, Javed Ahmad Rana, Javid Ahmad Dar, and Satish Sharma.

Highlighting the importance of responsive governance, the Chief Minister stated, "I urge all of you and your officers to address the public issues raised by MLAs with seriousness and urgency. They are elected representatives

of the people, and it is natural for people to expect solutions through them. As I have always maintained, this governmentor any government—should not make decisions based on the basis of political affiliations. We must prioritize whether a project holds public utility or a pub-lic issue benefits the people. If it does, it must be processed and dealt with without delay."

The Chief Minister acknowledged the challenges faced by the administration this year, citing two major elections as key reasons for delayed developmental activities.

He remarked, "The Parliament elections stretched over a long period, and the imposition of the Model Code of Conduct brought work to a halt. Even in some areas, where the work season coincided with the elections, progress was further delayed.'

Light Snowfall On Dec 21-22: MeT

Srinagar: Chelleh or Chellai Kalan, the 40-day harshest winter period is all set to commence by this weekend, the weatherman here has forecasted a light snow over higher reaches on the occasion. However, there is no forecast of any major wet spell till the next 10 days.

The cold wave continued to tighten its grip across Kashmir amidst the persistent dry spell at the majority of places.

As per the details, Srinagar witnessed a low of minus 3.4 degree Celsius while Gulmarg, a famous ski-resort, recorded a low of minus 4.0 degree Celsius.

In Pahalgam, the mercury settled at minus 5.0 degree Celsius while in Qazigund, a gateway of Kashmir, it settled at minus 4.0 degree Celsius. North Kashmir's Kupwar recorded a low of minus 4.2 degree Celsius while Kokernag in South Kashmir recorded a minimum temperature of 3.9 degree Celsius.

Furthermore, the Meteorological department has predicted persistent cold wave conditions at isolated to scattered places.

For the next four days till December 20, the Director MeT, Dr Mukhtar Ahmad has predicted generally dry and cloudy weather conditions.

Practising Advocate Can't Work As Journalist: BCI To SC

New Delhi: The Bar Council of India on Monday informed the Supreme Court that practising advocates cannot simultaneously work as journalists, whether on a full-time or part-time basis.

A bench comprising Justice Abhay S Oka and Justice Manmohan took on record the position of the BCI, which cited Rule 49 of the BCI Rules.

"We have heard the learned counsel for BCI which has submitted that as per the rules laid down, an advocate cannot be allowed to pursue part-time or full time journalism. The petitioner has filed an affidavit of undertaking stating that he is no longer working as a journalist and will only practice as an advocate," the bench said.

Repairs/ Renovations In Restricted Dal Zone HC Asks Govt To Take Policy Decision By Feb 7

Srinagar: The High Court of J&K and Ladakh has directed the government to take a "policy decision" by February 7 as to how to deal with repair and renovation of buildings and houses within the 200 meters from the Dal Lake which were "legitimately" constructed be-

fore the ban came into effect. The High Court on 19 July 2002 had directed the authorities to ensure that no erection of buildings shall be allowed within 200 meters from the center of the foreshore road wherever the road has been constructed, and that no changes will be made in the buildings as it existed on that

date (19.07.2002). However, subsequently, another order was passed by the



Court on 16 September 2021, which took cognizance of several applications moved by different persons seeking permission for repairing of their houses, renovation, face-lifting and for interiors as well as for development of parks within the 200 meters of the prohibited area of the Dal Lake.

Of the cases, the Lake **Conservation and Management** Authority (previously LAWDA) passed orders stating that the applications cannot be considered as the properties were within the 200 meters of the prohibited area.

'This Court feels that a human angle also must be taken into cognizance alongwith the well being of the Dal Lake as human habitation is as much a part of the ecosystem as the Lake," said a Justice Atul Sreedharan and Justice Mohd Yousuf Wani while hearing an application on behalf of the Chairman, Building Permission Authority /Vice Chairman of the LCMA, seeking appropriate directions..

There are two kinds of constructions within the 200 meters boundary which may be existing as on date, the court said.


J&K Has 8 **Polluted River** Stretches:Centre

Srinagar: Jammu and Kashmir has eight polluted river stretches identified in 2022, according to Union Minister for Environment, Forest, and Climate Change, Bhupender Yadav.

The pollution in these river stretches is primarily attributed to the discharge of untreated or partially treated sewage from urban areas, industrial effluents, improper solid waste management, operational issues in sewage and effluent treatment plants, lack of dilution, and other non-point sources, the minister said.

Yadav further said that J&K has one Grossly Polluting Industry (GPI), which is operational and complies with environmental standards. "GPIs are defined | More on P6

Shrinking Wings, Bigger Beaks: Birds Are **Reshaping Themselves In Warming World**

The Conversation

For wildlife, climate change is a bit like the "final boss" the protagonist faces in a video game: big, hulking and inescapable.

This formidable enemy has forced wildlife to alter where and how they live. Higher temperatures exert so much stress on wildlife that over generations, they are forced to change and adapt.

We wanted to better understand how this pattern of change was playing out in Australian birds. Our two pieces of recent research identified that, in response to warming, more than 100 species of Australian birds have developed smaller bodies and bigger beaks over time.

Shape-shifting wildlife

When we talk about shape-shifting, we're not talking about werewolves or Ant-Man. Rather, we are referring to body size getting smaller and appendages such as beaks, tails and limbs getting bigger. This enables animals to shed ex-

cess heat more efficiently by providing more surface area to do so something engineers know when designing radiators, for instance. Just as the hot water pipes in radiators help dissipate internal heat through the periphery, bird beaks are perforated with blood vessels that transfer heat from the body's core to the beak surface, where it

is then lost to the environment. This way, for both a radiator and a beak, increasing the surface area of the structure (while minimising the distance the heat has to travel from the core) maximises the heat loss.

The link between body shape and heat loss has led to the prediction that animals will change body shape over time, in response to climatic warming.

Three years ago, Deakin University researchers published a paper showing examples of such changes occurring in a handful of diverse species all across the world. Now, we significantly expand on this with two recently published studies focusing on Australian birds. We identified decreasing body sizes and increasing beak sizes over time, in response to climatic warming. Combined, the studies include over 100 species of birds from across Australia

What we did and what we found Our studies used two different data sets and methods to detect shrinking and shape-shifting. The first used an extraordinary dataset collected by community scientists of the Victorian Wader Study Group and the Australasian Wader Studies Group, who have been monitoring Australian shorebirds for nearly 50 years. Their monitoring includes measurements such as bill length,

wing length and body mass in more than 100,000 individual birds. The data allowed us to identify increasing beak sizes and decreasing body sizes in both resident and migratory species of shorebirds in northern and southern Australia.

For example, iconic migrants like red knots and sharp-tailed sandpipers have both increased beak size over the last 50 years. The second dataset, collected by Deakin researchers, used 3D scans of museum specimens to measure the beak surface area of speci-

mens from the past century. Through this approach, more than 5,000 specimens were measured for beak surface area, which was responses in bird shape that contradict the long-term trends. While body size decreases in response to shorter-term periods of higher temperature, bill size also shrank. Since beak sizes increase over the

long-term because of climatic warming, why would they decrease in response to short-term bursts of higher temperature? Climatic warming does not only affect the temperature birds experience, but also their environment.

In an environment with high baseline temperatures, such as Australia, periods of high temperature may mean less food. This can hamper the growth of young birds.

In this way, both body and beak size would decrease after hot temperatures due to stunted growth as food gets more scarce. And in short-term periods of extreme temperatures, having a big beak can be a liability. Hot air from the environment will actually move into the beak, causing the bird to heat up too much, with potentially fatal consequences. Whatever their cause, the contrasting trends between short and long-term responses to hot environments show things are complex in a changing climate.





Illegal Excavation Threatens Hokersar Wetland

Agencies

Srinagar: Concerns are mounting over illegal excavation activities at the Hokersar wetland in central Kashmir's Srinagar district, a vital ecological zone in Kashmir that serves as a key habitat for migratory birds.

Locals said that the excessive soil removal and mismanagement are severely damaging the wetland's biodiversity and disrupting the natural habitat of migratory birds.

They said the continuous activity by heavy machinery and trucks in the area has caused significant ecological disruption.

"We used to see large flocks of migratory birds every season, but their numbers have dwindled drastically." said Nazir Ahmad, a resident living near the wetland. "The noise and disturbance from these activities are pushing them away," he said.

Bashir Ahmad Khan. another local, said that unauthorized soil excavation and improper management have led to a drop in critical water levels in the wetland. "Wetlands are delicate ecosystems, and any imbalance can have cascading effects on biodiversity," he said.

Notably, the Hokersar Wetland, which is part of Kashmir's network of wetlands, plays a crucial role


Smart City earlier told KNO that they have developed an Integrated Public Transport System, detailing bus routes, stops, halting points, depots, and charging stations to streamline the service.

A 40-year-old male patient had presented to a peripheral hospital with symptoms of acute chest pain and headache. A CT scan in the periphery had revealed acute aortic dissection. He was immediately referred to the department of CVTS, SKIMS where further investigation revealed that he had acute Aortic dissection involving Arch of Aorta including arch vessels which supply blood to the brain and upper part of body, a statement issued Kashmir Observer reads. There was associated severe leakage of Aortic Valve. The condition if untreated has a risk of 100 percent mortality, it added. "The patient was successfully operated with restoration of blood flow to the brain and the rest of the body. The procedure involved replacement of the Aortic valve along with the major blood vessel called Aorta and blood vessels supply brain arising from Aorta by an artificial Dacron tube graft. The surgery lasted for 6 hours

Look Past EVMs

he Congress and the J&K Chief Minister Omar Abdullah are at odds over the reliability of Electronic Voting Machines (EVMs). Omar recently slammed Congress' selective criticism of the EVMs, saying the party can't celebrate when it gets 100 MPs using the same machines and then find fault with them when it loses polls. This has drawn a sharp reaction from the Congress, otherwise an ally of Omar's party, National Conference. The party has clarified that Samajwadi Party (SP), Nationalist Congress Party (NCP), and Shiv Sena (UBT) have also voiced concerns over EVMs. More tellingly, the Congress MP Manickam Tagore has accused Omar of taking on their "partners" after "being chief minister." Incidentally, Omar's statement was cited by the BJP IT Cell chief Amit Malviya as proof that there was nothing wrong with EVMs.

However, the controversy over EVMs apart, the incident reveals the ongoing rumblings within the INDIA bloc. More so, after the stunning defeat of the Maha Vikas Aghadi in Maharashtra. This was the second successive setback to the INDIA bloc after Haryana, and came after the alliance spectacularly denied the BJP an absolute majority in the general elections. Ever since, the INDIA bloc has struggled to retain its gains. On the contrary, the BJP is back in the driving seat and looks set to further cement its dominance.

This has naturally caused strains in the INDIA Alliance with some partners questioning the Congress' leadership of the bloc. As Omar rightly said, the Congress has to earn its place as the leader of the political grouping. It can't lose election after election and still command the following of opposition parties. West Bengal Chief Minister Mamata Banerjee has sought to lead the bloc and she has been supported in this by some other constituent parties. Having been elected successively for the third time as the chief minister of West Bengal, Banerjee deserves to be the leader of the opposition alliance. And Congress should certainly back her. The party should learn the lesson from the exit of the Bihar Chief Minister Nitish Kumar in the run up to the national polls early this year. Had he been given responsibility to steer the INDIA bloc, the alliance might very well have been in power. Kumar's party Janata Dal (United) went on to win 22 seats in Bihar which would have brought the opposition closer to majority figure of 272. Going forward, the opposition parties, particularly the Congress, need to rethink not just their election strategy but also the political narrative they need to craft to take on the might of the BJP. The alternative is a fragmented opposition, unable to present a united front, thereby ensuring continued dominance for the BJP.

Online RTI Error Government Fails on its Promise Yet Again

he residents of Jammu & Kashmir were eagerly waiting for December 10th 2024 to see RTI go online. Once again the Government couldn't fulfil their promise and we missed this deadline once again. For the last many years, RTI campaigners have been demanding this facility in J&K but this was always delayed by the Government on one pretext or the other. Even at the highest levels in Government, assurances were given by Chief Secretaries but these promises were derailed by some corrupt Govt officers who don't want to be accountable under the RTI Act. He has now sought an unconditional apology from the Executive Engineer and also asked him to retract lic Authority who is executing a project and destroying natural resources like streams and rivers? Infact, the aggrieved activist Rasikh Rasool has now taken up the mining issue matter with National Green Tribunal (NGT) as he failed to get justice from Govt officers. How can we now expect such Govt officers allowing RTI to go online in J&K?

They set up this narrative in such a fine way that even the honest officers are also made to believe that all the information seekers are either blackmailers or anti -development ? But when the same Govt officers retire they are the ones who keep seeking information under RTI from Govt offices. I know many Govt officials who were designated PIOs and were reluctant to share information but when they have retired from Govt service they want to access a lot of information from Govt offices and in fact use some RTI activists to get the information from Govt offices.

Recently an RTI Activist from

from the para – which allegedly damaged his reputation. Contrary to the condition, the activist has warned the Executive Engineer to be ready to pay him damages in tune of Rs 25 lakhs after expiry of the set deadline.

The Legal Notice was sent by Badru Duja, Advocate at J&K High court Srinagar on behalf of his client Rasikh Rasool. In the legal notice served to Executive Engineer, the counsel for Rasikh Rasool has mentioned that his client is a reputed Right to Information (RTI) Activist working in the field of Law, Governance and Public Policy who wants to ensure transparency on a project that is being executed in the Kupwara district. Rasikh Rasool had submitted a complaint to LG's grievance cell depicting 'shabby and irregular work' on Bangus Road plus large scale illegal riverbed mining in Bakiaker-Zachaldara Nallah. The contractors were using 'heavy machinery which is a criminal act and clear violation of J&K Minor Mineral Concession Rules 2016. Instead of addressing the grievance the Executive Engineer mentioned in his reply which reads:

"Rasikh Rasool 'is habitual of making such grievances and files applications under the Right to Information Act and defaming the name of R&B Division Handwara and sabotaging the Prestigious Handwara Bangus Road Project."

Can't citizens seek information?

The Right to Information Act was enacted by Parliament in 2005 and empowers citizens to seek information from Govt officers and ensure transparency and accountability in governance. How can an Executive Engineer say that this or that man is habitual of making grievances or filing RTI applications? If law or constitution has given certain rights to citizens can't they use these rights? Can't they seek information from a Pubas applicants don't have to travel all the way to reach the Govt offices. If central Govt offices entertain online RTIs why not the officials in J&K?

There is no need to buy the Indian Postal Orders -IPOs to pay the application fees. These IPOs are hardly available in Govt offices. The PIOs cannot say that he or she hasn't received the RTI application as digital RTI application provides the applicant with the instant receipt. The RTI portal ensures that the process of seeking information from government agencies is transparent and accountable. This is a convenient and easy way to file RTI requests. The RTI applicants can track the status of their applications in real-time. The portal provides access to information about public authorities, public information officers, appellate authorities etc. The citizens can file first appeals online if they are not satisfied with the information provided. The applicants living below the poverty line (BPL) can file RTI applications without paying any application fee.

Conclusion

Chief Minister Omar Abdullah while chairing a comprehensive review meeting of the Information Department recently stressed on Digital Outreach by the Information Department so as to ensure more transparency and efficiency in working of the department. In such a scenario if there is a group of govt officers who are trying to derail the process of digital RTI in J&K need to be identified and taken to task. I will appeal to Chief Minister Omar Abdullah to take it very seriously. What are the reasons that RTI isn't going digital in J&K while Central Govt Ministries are giving this facility to citizens for more than 7 years now?

From Hope to Hopelessness The Plight of JKPSC Aspirants

he Jammu and Kashmir Public Service Commission (JKPSC) Civil Services Examination (CSE) is a beacon of hope for thousands of aspirants seeking to contribute to public administration. However, its disorganized functioning and lack of accountability have plunged countless candidates into despair, costing them valuable time, opportunities, and a fair shot at realizing their dreams. Compared to the disciplined and transparent framework of the Union Public Service Commission (UPSC), JKPSC's inefficiencies and repeated failures to meet expectations highlight a pressing need for systemic reforms.


A Stark Contrast: UPSC vs. JKPSC

The UPSC, the benchmark in competitive examinations in India, maintains a defined model by publishing the calendar for the year in advance and following a strict schedule. Such reproducibility does indeed enable candidates to be very specific with respect to the time points for their preparation phases, and thereby make sure that they are able to properly coordinate the demands of both prelims and mains.

Conversely, the inconsistent timetable of the JKPSC has been one of the major sources of agony to prospective students. For example, the JKPSC CSE Prelims 2023 that took place on October 23, fell in the overlap of the critical mains preparation of UPSC candidates. Those preparing for UPSC CSE in May or June lost precious time, forced to divert their focus to JKPSC's prelims. This disarray did not end there. The JKPSC mains, which ran from March to April 2024, not only about to exhaust the aspirants with meager time to gear up for UPSC CSE Prelims 2024 which is undoubtedly a highly competitive exam

Give preference to JKPSC over UPSC or vice versa

Many candidates have been left disheartened, with some missing the UPSC prelims entirely or failing to qualify due to inadequate preparation time. The lack of synchronization and foresight in IKPSC's scheduling



attempt in a career-defining examination.

An Alarming Trend in Question Setting

The second glaring issue lies in the quality and relevance of questions asked in JKPSC's CSE. Prelims questions for exams are laden with nonspecific and irrelevant questions, providing little value in answering questions from the static parts of syllabus, which candidates study for months. Although the problem is not unique to JKPSC, it is very evident here, revealing a deficiency in a consistent approach to formulating the examination papers.

A closer look at JKPSC Mains 2023 further concerns

The weightage of subjects across General Studies papers displayed a troubling lack of balance and coherence:

GS 1: Despite society being a critical part of the syllabus, no questions were asked from this section, undermining its importance and candidates' prepara-

tion efforts.

GS 2: A disproportionate 120 marks out of 250 were allocated to International Relations, heavily favoring students with Political Science and International Relations (PSIR) backgrounds, while polity and governance—core sections with a vast syllabus—were limited to just 100 marks.

GS 3: Internal Security, a vital and expansive topic, received scant attention, despite its significance in the context of Jammu and Kashmir's unique geopolitical challenges.

These discrepancies indicate a lack of responsibility and a fragmented approach to paper-setting. Not only is it a work of bias, it also damages the confidence of aspirants towards the whole examination process as well as the system it represents.

The Cost of Negligence

The ripple effects of JKPSC's inefficiencies are profound. Candidates devote years of their personal and occupational time to

preparation for conviction tests. However, blame (either on the commission's failure to stick to schedules, or on the commission's failure to design fair and impartial question papers) has caused the students to grow cynical. Uncertainty leads candidates to a never-ending state of flux and makes it extremely difficult to plan strategically.

In addition, the commission's failure to hold exams on schedule ripples through the system, cascading into recruitment cycles that are delayed and for which the administration is deprived of new personnel. In a zone such as Jammu and Kashmir, where administrations are challenged in such ways, such ineptness is worst.

The Way Forward

So as to rebuild the credibility and bring about a fair, meritocratic system, the JKPSC should proceed with progressive reform orientation:. Strict Adherence to Timelines: Similarly, the JKPSC, rather than just issuing an annual calendar long in advance, should follow the annual calendar strictly. This will allow aspirants to plan their preparation efficiently.

Transparent and Balanced Question Papers: Paper-setters should be made responsible to see to it that questions pertain to the set syllabus and all sections have an equitable weighting. Independent review committees could help achieve this.

Aspirant-Centric Approach: The board of commission shall interact with applicants, taking into account their feedback and experience. Regular revisions, open dialogue lines, and workshops with specialists may overcome the lacuna between commission and candidates.

Capacity Building: Investing in better technology, training for officials, and an overhaul of administrative processes can make JKPSC more efficient and transparent.

Broader consultative role : There is a need to expand the advisory role of the UPSC in matters concerning the governance and administration reforms.

Conclusion

The JKPSC CSE is not just another test, but it is a gateway for young potential to serve the development and administration of the region. On the other hand, the current approach has destroyed its standing and crushed its potential in the commission which has now lasted for over five years. It is high time for JKPSC to rise to the occasion, prioritize accountability, and align its processes with national standards. Aspirants deserve a system that respects their time, effort, and aspirations—not one that repeatedly lets them down.

The future of Jammu and Kashmir depends on the talent and dedication of its youth. The onus lies on JKPSC to ensure that this talent is nurtured, not wasted. The time for reform is now.

Images of the Self: How Technology Encourages Narcissism

Recent technologies have had a profound effect on our self-image. The advent of photography gave the average person the opportunity to nail down their appearance. Photography makes it possible to replace the momentary subjective image we create of ourselves with a permanent picture.

Unlike a mirror image, the photograph stands still and cannot be interacted with. It is easier to have an outside perspective on oneself concerning a photograph. It is easy to forget that, unlike the mirror, it is not reality that is made available through a photograph but an image. The family camera, the video camera, and nowadays the smartphone have had far-reaching consequences for our ability to remember. Nowadays, we take it for granted that we know what we and our parents looked like as children and young people. This knowledge was not available before the invention of the camera, except for the few who could afford to have themselves and their children painted.

A newer phenomenon is selfies. The third-person experience of yourself you get from the picture or movie you just took is mixed with how you experience yourself from a first-person perspective. The more selfies you take, the more your self-percep-



tion is influenced by the indirect experience you get through these images. Your external self-image no longer needs to be mediated by other people. You are sitting next to yourself as you looked a few seconds ago.

Until a few decades ago, developing images took a long time. The photograph therefore served mainly as a memory and it was tenderly saved—framed or in albums. Now, digital and mobile cameras allow us to see ourselves more or less directly in photos or videos. The mobile phone camera also acts as a pocket mirror.

Today's image production is not only fast, it's cheap too. We can afford to take a large number of pictures of ourselves and immediately discard those that we don't think do us justice. Then we can easily manipulate and copy images using a computer. They can then be immediately posted on social media. Images become a consumable commodity and are often deleted immediately after viewing. Your self-image becomes a constantly fluttering billboard. The function of photos as memory aids has been greatly diminished. On Snapchat, they are not even meant to create memories, just momentary connections with other people; the photos you send disappear as soon as the recipient has seen them.

The current interest in the personal spaceis a consequence of the development and availability of these new image media. Inner qualities such as a person's character, intelligence, and morals have taken a back seat to appearance and other external characteristics.

For some people, the firstperson experience is not enough, and they feel they only exist as individuals when viewed from the outside. Narcissus has always had followers, but modern media opens up new opportunities for exposure. Social media such as Facebook, where people 'like' other people's pictures, offers a more generalized approach that fulfills a similar function while contributing to a kind of group community. People compensate for the lack of real-life contacts by eagerly liking others' social media posts. As a gift, they offer themselves as audience.

Facebook and Instagram are perfect technologies for narcissists. A typical phenomenon is all the personality tests offered on Facebook. For example, you can find out which animal or famous person you are most like. Such tests are, of course, pure nonsense.

Sociologists have extensively studied changes in the relationship between the public and the private. they note that narcissism is not just self-admiration but a preoccupation with the self that prevents the individual from healthy relationships with the outside world. The narcissist constantly asks the question: What does this mean to me? There are no fellow humans, only audiences. He or she is chronically bored, flitting from one thing to another without commitment and without dependency, demanding the admiration of others but avoiding intimacy.

the district-specific concerns, he urged the administration to expedite developmental activities, stating, "Accelerate the pace of work as much as possible, ensuring it is executed effectively at the ground level. Efforts must focus on completing the work satisfactorily."

He also stressed the importance of timely submission of Utilization Certificates (UCs) for funds to be allocated by the central government. He said, "When we approach the central government repeatedly—whether to discuss with a minister or secure funds for Jammu and Kashmir—the common complaint is that UCs are not submitted on time. Prompt submission of UCs will ensure continuity of financial support and effective resource utilization."

The speaker will seek the names of members for the proposed panel from the parties on the same day.

petitioner's counsel had accepted the correctness of the stand taken by the BCI.

The BCI rule prohibits advocates from pursuing any other full-time profession, including journalism.

The decision comes in the context of a case filed by one Mohd Kamran, who reportedly identified as both a lawyer and a freelance journalist.

Kamran, subsequently filed an affidavit of undertaking, saying he no longer worked as a journalist and only practised law.

In an affidavit filed on December 13, the BCI clarified while full-time journalism was categorically impermissible for advocates, even part-time journalistic activities were generally not allowed unless strictly connected to the legal profession.

The BCI submitted that part-time journalism could only encompass scholarly articles, opinion pieces, or editorial contributions that maintained a "meaningful nexus" with the legal profession.

"Èven (when it comes to) part-time journalism ... the said professional activity will also be an embargo on the practice of law as an advocate," it said.

Any journalistic engagement by an advocate, the BCI said, must not conflict with their primary professional obligations, compromise the dignity and independence of the legal profession, or result in a dual-profession arrangement.

While Rule 51 of the BCI Rules provides some leeway for advocates to engage in journalism,

the BCI said such activities must be limited to contributions directly related to legal practice and understanding.

Having addressed the legal issue, the bench would proceed to hear the petition on February 3, 2025.

The plea challenges an Allahabad High Court order that quashed the criminal defamation proceedings against former parliamentarian Brij Bhushan Sharan Singh.

The defamation case arose from letters written by Singh in September 2022 to the UP chief minister and chief secretary, alleging that Kamran was a "conspirator and thief" in various criminal cases.

The letters were also circulated on social media and in newspapers, prompting Kamran to allege defamation and seek restoration of the proceedings against Singh.

Notably, Singh is facing a separate trial over sexual harassment allegations made by six Indian wrestlers.

bar of having any construction/building within the 200 meters from the Lake came into existence, the court noted.

The second category, the court said, relates to those constructions that may have come up within the 200 meters of the Lake after it was prohibited and are "outrightly "illegal constructions as they could not have come up after the ban on construction in that area".

However, the court said, the problem refers to those buildings which are in existence within the 200 meters boundary from the Dal Lake, which came into existence legitimately before the ban on constructions/raising of buildings within the 200 meters of the Dal Lake.

"Those may be residential houses used by people who on account of the orders passed previously are unable to repair damages/ wear and tear that houses experience with the passage of time on account of the orders passed by this Court," the court sai, adding, "Those constructions which were legitimately built and are being used, may require repair/reconstruction as per original plan unless the houses are acquired by the State under procedure established by law for the purpose of clearing accommodation in close proximity of the Dal Lake."

Many of these houses whose existence at the site may be legitimate may now have been converted into Lodges, Guest Houses or offering accommodation to the tourists as paying guest which besides changing the nature of its occupancy, would also bring within it, the excess load of waste disposal that is generated by the tourists residing in these accommodations, the court said.

"As on date, it is not known as to how many of these premises are used as Guest Houses or Houses for tourists and the nature of the pressure caused by the waste generated by the tourists residing in these houses and what is the manner for effective waste disposal/management of this excess waste arising from a commercial use of these residential premises," the court said, adding, "Thus, for a long term solution, a policy decision needs to be arrived at by the Union Territory Government, as to how to deal with this issue of these buildings/houses within the 200 meters from the Dal Lake which were legitimately constructed before the ban came into effect by ensuring that the livelihood of the people is also sustained and ensuring at the same time that there is no deleterious environmental effect on the Dal Lake or in the areas in proximity to the Dal Lake."

Therefore, the Division Bench requested the UT Government to constitute a Committee in right earnest to form a policy which would address the concerns reflected by the Court and ensure the sustainability of Dal Lake without disturbing the livelihood and lives of those who have been residing in houses and buildings which were legitimately constructed in the area.

"We hope that the Committee will be constituted and a policy be framed before the next date of hearing of this case," the court said and ordered listing of the case on 7 February 2025.

participation and cooperation of school authorities to ensure that vehicles used for transporting students are fit and adhere to safety standards," the spokesperson said.

School authorities were directed to ensure that all vehicles are equipped with functional speed governors, limiting the speed to 40 kmph, as per the guidelines.

Govt Forms Committee To Resolve Land Issue For GMC Handwara Relocation

SRINAGAR: The Jammu and Kashmir government has constituted a high-level committee to address the issue of land allocation for the relocation of the Government Medical College Handwara and its co-located Nursing College.

This decision was formalized through Government Order No. 2090-JK(GAD) of 2024, issued by the General Administration Department, with the Divisional Commissioner of Kashmir appointed as the committee chairperson.

The committee includes senior officials from various departments, such as the Deputy Commissioner of Kupwara, the Engineer-in-Chief of the Public Works Department, the Principal of GMC Handwara, and representatives from the Agriculture Department, Irrigation and Flood Control, SKUAST Kashmir, and other key sectors. Together, they are tasked with resolving critical issues surrounding the identification and approval of land for the project.

The committee's responsibilities include evaluating the feasibility of new sites proposed by the Deputy Commissioner of Kupwara for the construc-tion of GMC Handwara and its Nursing College. This involves assessing safety and environmental factors such as soil quality, terrain gradient, and flood risks, as well as ensuring the availability of utilities like water supply, road connectivity, and electricity.

The land identified must also meet the National Medical Commission's minimum requirement of 200 kanals, with additional provisions for future expansion.

Moreover, the Committee has been directed to ensure the availability of encumbrance-free land and facilitate the issuance of No Objection Certificates (NOCs) and other necessary clearances from relevant departments, including Forest, Agriculture, and SKUAST Kashmir. It has the authority to co-opt additional members as needed to accomplish its ob-

Elaborating on the streamlined process, RPO Kumar said, "Once the formalities are completed, we process the application on the same day and forward it to the police, CID, and other departments for verification. The issuance of the passport then depends on these verifications.

He added that in cases where there are no issues with verification or documentation, passports are issued within 15 days. To address public grievances, the RPO said, "I have instructed staff and security to allow people with issues or grievances to meet me directly." He said applicants facing document-related problems or delays are guided on how

Govt Approves Subsidized Helicopter Service For Jammu, Poonch

SRINAGAR: The central government has sanctioned a new subsidized helicopter service to connect Jammu, Poonch, and Mendhar, along with an additional route linking Jammu directly to Mendhar.

Batters Botch Up Again; India 51/4 On Rain-Marred Day 3

BRISBANE: The Indian batters' inability to grind it out against a relentless Australian pace attack in testing conditions left the team precariously placed at 51 for four at the end of a rainmarred day three of the third Test here on Monday.

On a stop-start day, India bowled out Australia for 445 in their first innings, the hosts adding 40 runs to their overnight total, as the peerless Jasprit Bumrah continued to do the heavy lifting to finish with excellent figures of 6/76.

Alex Carey chipped in with an entertaining 70 off 88 balls after contrasting hundreds by Steve Smith and Travis Head on the second day laid the foundation for a total which looked more than enough just 14 overs into the Indian first innings.

With the exception of the gutsy KL Rahul (33 batting), who was willing to hang in there, none of the Indian top-



order batters showed the stomach to fight.

Playing the red Kookaburra has become tougher since they changed their ball in 2020 by adding extra lacquer on a reinforced seam, making it firmer and ensuring more movement

off the pitch. Under the circumstances, the Indians needed to be patient and play out the first 25-30 overs when bowlers of the calibre of Mitchell Starc and Josh Hazlewood were in operation. But the visiting top-order batters did not do what was required of them. The likes of Virat Kohli once again fell to deliveries in the channel just outside the off-stump.

There is no doubt that the conditions were challenging but the Indian batters could have

taken a leaf out of Smith's book as he initially negotiated testing spells of fast bowling from Akash Deep and Bumrah on way to a drought-breaking hundred.

After Australia racked in nearly 450 runs, left-arm pacer Starc struck twice and Josh Hazlewood once as the two teams took an early lunch with the visitors reeling at 22 for three.

Pat Cummins got the big wicket of Rishabh Pant in the second session to make matters worse for the Indians.

Returning to the middle after the lunch break, Rahul and Pant faced some hostile fast bowling from the duo of Starc and Hazlewood before heavy showers interrupted the proceedings, one of the many on the day.

Starc removed Yashasvi Jaiswal in the second ball of the India innings and then dismissed Shubman Gill before Hazlewood accounted for Kohli as the visitors once again stared down the barrel after their failures in Adelaide.

New Zealand Sets England 658 To Win The 3rd Test

Kane Williamson made 156 as New Zealand Mamassed a lead of 657 runs before both England openers were dismissed to leave the hosts in a commanding position at the end of the third day of the third cricket test on Monday.

To compound an already dismal day for the tourists, England captain Ben Stokes limped from the field with a recurrence of a hamstring injury.

Williamson's 33rd test century was his seventh at Seddon Park and his fifth in consecutive tests on a home ground on which he averages more than 100. During his six-hour innings, Williamson overtook South Africa's Graeme Smith to move up to 17th place on the list of leading test run-scorers six behind another South African, Hashim Amla.

New Zealand finally was dismissed for 453 after leading by 204 on the first innings and in five overs before stumps England slumped to 18-2. The highest winning fourth innings total in test history is 418.

Guardiola 'Not Good Enough' After Latest Man City Loss

Pep Guar-diola declared himself "not good enough" after Manchester City's season sunk to a new low after a 2-1 defeat to Manchester United on

Sunday. The four-time defending Premier League champion has lost eight of its last 11 games in all competitions

- winning just once in that run.

City is fifth in the standings and nine points behind leader Liverpool, having played a game more.

"I'm the boss, I'm the manager and I'm not good enough. It's as simple as that," Guardiola said after the latest loss. "I'm not doing well. That is the truth."

Guardiola has led City to unprecedented success, winning an unprecedented four Premier League titles in a row and six in the last seven seasons. He has won 15 major trophies at the club, including the Champions League.

But he is experiencing the worst run of form in his coaching career, which has seen him win 33 major trophies at Barcelona, Bayern Munich and City.

Guardiola signed a two-year contract extension last month, but that has not sparked an upturn in his team's form.

City led 1-0 going into the 88th minute against United, but then conceded late goals to Bruno Fernandes and Amad Diallo – prompting boos from fans after the final whistle.

"I knew that it would be a tough season from the beginning. I said (that) many times, even when we were winning, but I didn't expect it was so hard like it was right now," Guardiola said.

It's A Team In Transition, Won't Point Fingers At Each Other: Bumrah Explains India's Oz Struggles

BRISBANE: Jasprit Bumrah on Monday defended the struggling Indian team in Australia and played down talk of additional pressure on him, saying it's a side in transition and given his experience, it's his "job" to shoulder extra responsibility.

Having taken a seemingly erroneous call of bowling first in the third Test at the Gabba here, India conceded a huge first-innings total of 445 despite Bumrah returning 6/76.

In response, the visitors were 51/4 on a rain-hit third day with questions being raised about batters' technique and the quality of bowling, save for Bumrah.

"We don't, as a team, point fingers at each other and we don't want to get into that mindset where we are pointing fingers at each other that 'you should do this, you should do that'," Bumrah told media after stumps when asked for his assessment of India's batting.

"We, as a team, are going through a transition, new players are coming here and it's not the easiest place to play cricket. Over here, it's a different atmosphere with this wicket being a different challenge so yeah, we are not looking at that."

Bumrah, who leads the bowling chart in the Border-Gavaskar Trophy with 18 wickets so far, defended the Indian attack amid chatter that he is not getting adequate support from fellow bowlers.

"As a bowling unit, as I said, we are in transition so it's my job to help the others. I have played a little more than them so I am trying to help them," said the owner of 191 Test wickets in just 43 Tests.

"Everyone will learn through it, will get better and eventually will find different ways so this is the journey that you'll have to go through," he added.

Bumrah rejected suggestions that India's poor first innings scores were putting more pressure on the bowlers and on him.

"We have 11 players, it's not like that. I don't look at it that I have to do extra (work). As I said, we are a new team, a lot of new players have come into the side. We have to be considerate and give them that cushion that they will learn from experience," he said.

"Nobody is born with all the experiences, nobody is born with all the skills. You keep learning, you keep finding new ways (and) you keep learning



about your own game," he continued. The Indian vice-captain said he has enjoyed the challenge of bowling on different pitches in Australia.

"I always find different challenges very interesting. Because in the Test match that we played in Perth, the

wicket was different. (At) Adelaide (with the) pink ball (was) different, the wicket behaved different, the ball behaved differently," he said.

"Here it is a little different because the wicket is at a level and the runup is low. In India we are not used to that," he explained.

'DON'T LIKE WHINGING, DON'T TAKE OPINIONS SERIOUSLY'

Bumrah said his primary target on encountering a challenge is to tackle it instead of looking at others to come up with the solutions.

"...I look at how do I solve it, what can I do in this scenario rather than whinging or complaining or looking at someone else or pointing fingers that I need this from this person," he said.

Bumrah reiterated he wants to remain level-headed in dealing with success and failures and that he cannot carry the "baggage of expectations".

"When I was a youngster, yes, maybe I used to take extra baggage of fans and opinions. But I don't take any opinions seriously," he said.

"I look at myself. I look at answers what I have to do. I give it my absolute best. If I have given it my absolute best, I will accept the results. (But) I cannot carry someone else's energy or baggage that people are expecting me to do the heavy-lifting," he gave a peak into his mindset.

"There will be days when I will not get wickets. Somebody else will do, so I will have to do a holding job," Bumrah added.

#don't look at it that I have to do extra (work). As I said, we are a new team, a lot of new players have come into the side. We have to be considerate and give them that cushion that they will learn from experience," he said.
