6 Of Family Killed In Kathua Fire

Jammu: A tragic fire in Jammu and Kashmir's Kathua district has claimed the lives of six family members, including a former deputy superintendent of police (Dy SP) and his three-year-old grandson. The devastating incident occurred early Wednesday morning when the family was trapped inside their rented accommodation, suffocating from thick smoke that quickly engulfed the house.

Four other people injured in the incident are undergoing treatment in a hospital.

According to police, locals noticed the house on fire around 2:30 am and rushed to rescue its occupants. The house was filled with thick smoke, suffocating its occupants in their sleep, they said.



The victims were shifted to the Government Medical College (GMC) Hospital in Kathua where six of them, including two minors, were declared 'brought dead', officials said.

The deceased have been identified as 81-year-old former deputy SP Avtar Krishen Raina, his daughter | More on P6

HM To Review J&Ks Security Grid Today

New Delhi: Union Home Minister Amit Shah on Thursday is likely to review the security situation in Jammu and Kashmir, the first such meeting after the last assembly elections held in September-October, sources said.

As Jammu and Kashmir Lieutenant Governor Manoj Sinha heads the Unified Command (UHQ), he would represent various stakeholders operating in the valley. Union Home Secretary Govind

Mohan, Director of Intelligence Bureau Tapan Deka, Chief of Army Staff General Upendra Dwivedi, Director General of CAPFs, Chief Secretary, DGP of Jammu and Kashmir, will attend the meeting.



"The home minister will review the security situation in Jammu and Kashmir. He will be briefed about the prevailing situation in the Union Territory (UT) and the situation along the border areas,"

sources said.

This will be Shah's first meeting after the assembly elections conducted in the UT where a National Conference (NC) government, headed by Chief Minister Omar Abdullah After the abrogation of the Article 370 and bifurcation of the erstwhile state into two UTs in 2019, the law and order is the direct responsibility of

the central government.

The home minister is likely to have a detailed discussion on the security roadmap ahead for 2025, the sources said.

Sporadic incidents have been continuing in Jammu and Kashmir. On October 20, seven people were killed in a terror attack in central Kashmir. Before that, there were attacks on outsiders working in Kashmir.

J&K Contributes 0.8% To National GDP

Srinagar: Jammu and Kashmir is making a proportional contribution to the country's economy, with its share in the national Gross Domestic Product (GDP) standing at 0.8 per cent, according to the government data.

According to data, this aligns closely with J&K's population share of 0.98 per cent in the country.

The report states that J&K's economic growth has been steady, with the tertiary sector contributing 61 per cent, followed by the secondary and primary sectors.

For the financial year 2023-24, the Union Territory's Real Gross State Domestic Product (GSDP) is projected to grow by 7.41 per cent, with a Nominal GSDP estimated at Rs 2.46 lakh crore.

Muslim Daughter Cannot Be Expelled From Father's Inheritance: HC

Srinagar: Observing that Quran bestows right of inheritance first to female then to male survivor, the High Court of J&K and Ladakh has said that a Muslim daughter cannot and could not be expelled by any excuse or pretext to inherit the property of her father.

A bench of Justice Vinod Chatterji Koul made the observations while dealing with a "pathetic" case of a woman, who sought share from her father's property being biological daughter some fortythree (43) years back but died midway. Her children stepped her in that race who are also still dreaming to have had their mother's right matured and plucked albeit having a Division Bench judgement in her favour, the court said.

"The parties hereunto this controversy are Muslims. They are practising in daily and routine life all rituals of Islam strictly in accordance

with Quranic injunctions and Ahadith, which include ablution for performing daily prayers; celebrations of Eids; performing Hajj and sacrifice of lamb/camel; paying Zakah; burying of dead body in strict accordance with Islam," the court said, adding," "All these acts and activities are being performed by parties strictly in conformity with Quranic commandments and Shariat, but it has been seen when it come to giving share to daughter/ sister, certain individuals come up with a pretext of Custom." Such a practice, the court said, is even deprecated by Islam.

"It is worthwhile to mention here that Surah An-Nisa, Verse 11, of Holy Quran, stipulates inheritance laws, specifically distribution of inheritance amongst inheritors," the court said, adding, More on P6

Plant-Based Meat Alternatives Linked To Increased Risk Of Depression In Vegetarians

egetarians consuming plant-based alternatives to meat—suggested as one of the means to lower the environmental impact of meat consumption—could have a 42 per cent increased risk of depression compared to vegetarians who refrain from them, according to a study.

Published in the journal Food Frontiers, the study also found higher blood pressure and inflammation levels, along with lower levels of 'good' cholesterol, in vegetarians who ate plant-based meat alternatives.

Researchers at the University of Surrey, UK, analysed data from over 3,300 vegetarians in the UK Biobank—about half were consumers of plant-based meat alternatives, and half were non-consumers.

Made using plant-based proteins such as soy, plant-based meat alternatives (PBMA)

are considered a potential solution for sustainability, as fewer natural resources such as water, land and energy are required to produce them compared to animal meat. However, these meat alternatives are also considered 'ultra-processed foods,' as chemicals are often added to make them taste like



most

The researchers noted that while consuming plant-based meat alternatives was not linked with clear health benefits, more studies are needed to investigate concerns related to inflammation, which may arise from eating these products.

from eating these products. "In conclusion, while no clear health risks or benefits were associated with PBMA consumption in vegetarians, the higher risk of depression, elevated C-reactive proteins (CRP), and lower apolipoprotein A levels (HDL cholesterol) in consumers of PBMA suggest potential inflammatory concerns that warrant further investigation," the au-

Co-author Anthony Whetton, a professor of translational biosystems at the University of Surrey, said, "Ultra-processed plant-based meat alternatives can be a useful way for people to transition to a vegetarian diet effectively, which helps with sustainable agricultural practices."

"Further research, including longitudinal studies and trials with more diverse populations, is necessary to confirm these findings and the relationship between vegetarian foods and mood," Whetton added.

In the study group, the researchers found no notable differences in the intake of sodium, free sugars, total sugars, or saturated fatty acids between vegetarians who ate plant-based meat alternatives and those who did not. The team also found that consuming plant-

The team also found that consuming plantbased meat alternatives was linked to a 40 per cent lower risk of irritable bowel syndrome.

"The overall findings are reassuring, suggesting that plant-based meat alternatives may be a safe option when they are part of an overall balanced diet. However, the potential link between these foods, inflammation, and depression warrants further investigation," said senior author Nophar Geifman, a professor of health and biomedical informatics at the University of Surrey.

Instagram Now Lets You Schedule DMs

nstagram users can now schedule direct messages (DMs) to be sent at a later time, a feature that has been officially launched to enhance the app's messaging experience. As reported by The Verge, the feature allows users to schedule text-only messages, providing more flexibility for communication.

To use the new scheduling feature, Instagram users can long-press the "send" button in a chat and select the date and time they would like the message to be sent. While this option offers an added layer of convenience for those who want to send messages at a specific time, it is important to note that the feature only supports text-based messages at this

Instagram's support page clarifies that once you schedule a message, the app will display a notification in the chat to show how many scheduled messages are pending. If users want to make any changes, they can tap the notice to view the scheduled message.

Additionally, users can either delete the message or opt to send it immediately by long-pressing it. Currently, the scheduling feature allows users to plan their messages up to 29 days in advance, as per The Verge. This new addition is part of Instagram's ongoing efforts to enhance its messaging platform, which already includes features like message editing, the ability to draw on photos, and sharing live locations, similar to Snapchat's functionalities.

Different Fungi Groups Behind Allergy-Induced Sniffles, Asthma: Study

eople with allergy-induced sniffles and asthma may have different fungal colonies or mycobiomes in their noses, finds a study on Tuesday. The common respiratory disease, formally called allergic rhinitis, has frequently been associated with asthma. Typical symptoms of allergic rhinitis include sneezing, itching, inflamed nasal mucous membranes, and a blocked and runny nose. It's often comorbid with asthma, which also involves inflammation and obstructed airways.

Researchers from the University of Porto, Portugal, showed that this association may be because of different fungal colonies or mycobiomes in their noses.

"We showed that allergic rhinitis samples displayed a significantly higher fungal diversity and a different fungal community structure compared to those of healthy controls," said Dr. Luís Delgado of the University of Porto.

"This may suggest that allergic rhinitis increases the diversity and changes the composition of the upper airway's microbiome."

To study the nasal mycobiome, the researchers recruited 214 participants among children and young adults attending an immunology and asthma clinic in Porto. About 155 patients had both allergic rhinitis and asthma, while 47 were only diagnosed with allergic rhinitis and 12 with asthma. The team also enrolled 125 healthy controls.

The team analysed 306 samples, taken via nasal swabs. DNA sequencing revealed Ascomycota and Basidiomycota as the most common fungi families across all samples. In these two families, 14 genera dominat-

"Among these dominant genera we detected common fungi that have been recognised in humans as allergenic or opportunistic pathogenic fungi," said Delgado.
"This suggests that the nasal cavity is a major reservoir for fungi that could be involved in allergic rhinitis and asthma."
The findings, published in an article in the

Frontiers in Microbiology journal, showed

a very clear and statistically significant

difference between the patients with respiratory diseases as well as the healthy controls

The fungi sampled from patients with both allergic rhinitis and asthma also showed more evidence of connections between them than the fungi in the healthy participants' noses and those who only had allergic rhinitis. This could indicate that the fungi are affecting the nose's immune environment, the researchers said.

ITMS OERATIONALIZED IN SRINAGAR

Nearly 200 E-Challans Issued On Day One

Srinagar: With the start of the Intelligent Traffic Management System (ITMS) officially going live in Srinagar, the e-challans have been issued to about 200 traffic violators on its first day of operation on Wednesday.

Officials from Srinagar Traffic Police said that the start of the ITMS system in Srinagar marks a major shift toward a technology-driven approach to traffic regulation and law enforcement.

They said the system. launched by the Traffic Police, uses high-resolution cameras and radar sensors to monitor vehicle movements, detect violations, and issue echallans automatically.

They said on the first day of ITMS, about 200 echallans have been issued all over the city, and the initiative is just a beginning as today is the first day of the ITMS system.

Moreover, Muzaffar Shah, Senior Superintendent of Police (SSP) Traffic City said, "The system minimizes human interface and ensures law enforcement is evidence-based, transparent, and efficient.'

lar process and with the introduction of ITMS, the system will monitor traffic movement and various traffic violations while the software generates challans in real-time.

In the meanwhile, the locals have welcomed the move, calling it a positive step toward safer roads and improved traffic management.

Tahir Ahmad a local said, with the introduction of e-challans, the drivers will now be more cautious. "This is a much-needed initiative. It will reduce congestion and ensure everyone follows traffic rules," he said.

Another local said the ITMS system is a gamechanger. It uses modern technology to address old traffic problems, and this will lead to better coordination and safer roads.



IMHANS Registers 1200 Drug Abusers In Last 9 Months

Srinagar: A shift is being witnessed among drug abusers in Kashmir as they prefer to use pharmaceutical drugs over heroin, which they procure through illegal routes, the health experts said.

A top psychiatrist at GMC Srinagar said that the trend of drug abuse continues to rise and every day new patients are being brought to the hospital for treatment.

He said that the majority of the drug abusers are the heroin users and over 50 per cent of them are being tested positive for Hepatitis C.

The psychiatrist said that around 1200 drug abusers were registered at the Institute of Mental Health and Neurosciences (IMHANS) Kashmir in the last 8-9 months and 90 per cent of them are heroin addicts and inject-

He, however, said that a shift has been witnessed amongst the drug addicts as the heroin abusers are using pharmaceutical drugs that include Pregabalin, Topentadol and Tramadol.

The psychiatrist added that Pregabalin, a medication commonly prescribed for epilepsy, neuropathic pain, and anxiety, has seen a significant increase in misuse, particularly among individuals using opioids like heroin.

He added that heroin users are turning to prescription medications like pregabalin to enhance or modulate the effects of opioids.

Meanwhile, the officials said shift is being witnessed due to the high cost and scarcity of heroin, and the abusers find it easy to procure the pharmaceutical drugs by using illegal ways. They said that Tramadol is a

Misuse of Law: Are Gender **Rights Only Women's Rights?**

ne Bharatiya Nyaya Sanhita (BNS) seeks to modernize and unify various legal frameworks in India. Notably, Sections 85 and 86 of the BNS mirror the provisions of Section 498A of the Indian Penal Code (IPC), which pertains to the issue of cruelty inflicted upon married women by their husbands or relatives. This mirroring serves to maintain continuity and strengthen the legal safeguards for women. The misuse of Section 498A IPC (Now Sections 85 and 86 of the BNS) is not merely anecdotal; it has been substantiated, as instances have emerged where false allegations have been made under this provision, leading to unjust consequences for husbands. Furthermore, there is a lack of legal recourse for men facing abuse from women, and it has been observed that Section 498A IPC (Now Sections 85 and 86 of the BNS) is frequently misused in cases across district courts. The cases remain unresolved, and the obligation of husbands to provide maintenance to their wives does not imply that they are solely responsible for all financial obligations and benefits.

Nevertheless, the commission has suggested that the offence should not be entirely abolished. The existence of abuse does not negate the importance of laws that serve the broader public interest.

The recent Suicidal Death of Atul Subhash, a 34-year-old deputy general manager based in Bengaluru, has shed light on the pressing issue of domestic violence perpetrated against men in India. In a detailed 24-page suicide note, Subhash implicated his wife, her relatives, and a judicial official in acts of harassment and corruption. He disclosed that his wife had lodged numerous unfounded allegations against him, including accusations of murder, sexual misconduct, and demands for dowry. This unfortunate incident under-

It compels us to reflect on whether we are fostering a just society or one that penalizes men solely based on their gender. The very laws designed to offer protection are being manipulated in ways that devastate innocent lives. Atul's narrative reveals a societal indifference to male suffering, even as it drives individuals to the brink of despair. This scenario does not represent justice; rather, it is a manifestation of cruelty masquerading as equity.

This situation is not an isolated occurrence. In recent times, numerous men have experienced similar challenges that could have been prevented through timely intervention and a more balanced legal framework, leading to tragic outcomes such as suicides. Critics argue that laws like Section 498A, originally designed to protect women from abuse, have

Kashmir's dairy farmers are in a stiff competition to record highest dairy production

ashmir's dairy are currently engaged in a friendly yet intense competition as they aim to outperform each other and secure the prestigious title of top milk producer. Their unwavering dedication and expertise are driving the region's dairy industry to unprecedented levels. Anantnag district has now surpassed Pulwama district in terms of milk output, earning the moniker 'New Anand of Kashmir'.

Anand, a true 'land of milk and honey,' is a lush district in the Indian state of Gujarat that is well-known for producing an abundance of milk. Interestingly, Anantanag, Kashmir, has experienced a similar situation where a 'white revolution' has made the area a dairy powerhouse, earning it the nickname 'Anand of Kashmir' This striking similarity draws attention to the common wealth and success that these two far-off places have in common. Anantnag currently produces 7.29 lakh litres of milk per day. Officials claimed that the district's yearly milk production is roughly 266.35 thousand tonnes, exceeding Pulwama's annual milk production of 262.95 thousand tonnes.

Other districts reported varied amounts of milk production, including Budgam (240.70 thousand tonnes), Baramulla (199.85 thousand tonnes), Kulgam (161 thousand tonnes), Kupwara (153.95 thousand tonnes), Bandipora (119.98 thousand tonnes), and Srinagar (100.410 thousand tonnes). Ganderbal and Shopian had the lowest milk production, with 96.37 thousand tons and 72.96 thousand tonnes per year, respectively. The district's animal husbandry department officials stated that Anantnag farmers have adopted modern practices, such as sophisticated breeding methods and improved dairy cattle nutrition.

These initiatives have resulted in an increased milk output per cow, which has contributed to overall production growth, they stated. "Government policies supporting the dairy industry, including subsidies on cattle feed, veterinary services, and financial assistance for infrastructure development, have played an important role in encouraging farmers to invest in their dairy operations.

Will AI Save The Planet? Why The Evidence Is Flawed

ptimistic advocates for AI say this environmentally costly technology will become more sustainable with time. We can use AI more efficiently, and explore less energy-intensive designs inspired by the human brain. We can build data centres more sustainably, using wood or low-carbon concrete and steel. The heat from the data centres can warm homes in the local area.

Of course, if we start using AI systems too widely (including where we don't really need them), the growth might outweigh any of these potential gains in efficiency. But recently, I've been hearing another argument: that AI itself is tackling climate change. AI can help to model wildfires, optimise energy consumption to stabilise the grid, accelerate the development of lowcarbon materials, and much more.

My research team recently published a report that digs into these claims - and found some cause for concern.

As it turns out, it's difficult to compare the environmental impacts of asking AI to carry out a task versus asking people. Take writing and making art. One study says that it is much more environmentally friendly for AI to do these creative tasks than humans.

But one of its methods for investigating this is to allocate a slice of the carbon footprint from all human activities (eating cows, catching planes and so on) to the creative activity. By this logic, there would be the same carbon emissions from an hour's work by an artist, a dairy farmer, a billionaire CEO, or an ecologist restoring a wetland.

A related paper acknowledges the simplification and instead allocates carbon iust for the electricity a human consumes. The authors say this is a practical approach to carbon accounting. Establishing a fair comparison

between human and AI work is hard because the tasks may look alike, but their underlying processes are fundamentally differ-What about the cur-

rent total carbon impact of AI? Another paper, partly funded by Microsoft, mentioned that AI is today responsible for just 0.01% of global carbon emissions.

When we looked closer we found this figure was based on the emissions of one year's AI server sales by Nvidia the biggest manufacturer of such hardware - as estimated in one analysis. This prediction hasn't been verified, and if it is accurate, it wouldn't include Al being run on servers installed in previous years.

When contacted for comment, some of the authors said that this estimate wasn't the article's main focus. Assessing the climate impacts of AI is complicated because we don't know how future AI models will be built, operated and used, they added. Another study reviewing AI's sustain-

ability benefits cited several other articles that, in our view, appeared to feature mistakes – like referring to studies to back up their claims which did not contain relevant information. AI systems sometimes make mistakes - known as "hallucinations" – like when Microsoft Copilot accused a journalist of committing the crimes he had reported on. So we asked the authors if they had used an AI to write the ar-

ticle. They dismissed this idea and stood by the integrity of their review. They agreed that not all of the AI

sustainability solutions their review referred to can be supported by existing studies. But they said that they had also included predictions about what AI might one day be capable of, based on their own expert judgement, which they said was standard practice.

The authors also pointed out that their work has been widely shared without complaint. But the fact that articles can be read widely without eliciting alarm is exactly the issue. Would every reader assume that the article was predicting what AI might one day do, rather than explaining what AI can already do? Overall, how reliable is current research

on AI and sustainability? We're not sure. We haven't yet had the chance to conduct a more comprehensive investigation. But assessing Al's future potential requires a clear understanding of its

achievements to date. Such an investigation is urgently needed. Questions to ask

about AI

Meanwhile, we should avoid lumping all kinds of AI together. There are in fact diverse forms of AI: big, small, discrimi-

native, generative,

symbolic and more. I can be excited about an AI that excels at counting carrots, and helps farmers to plant them more effectively, without offering a blanket endorsement There are different types of climate ac-

tion too. Climate mitigation is about getting carbon emissions down to net zero to stop global warming. Climate adaptation is about learning to live and thrive in a warmer world. We need both. AI for climate adaptation is very welcome

indeed (say, helping us to increase carrot yields, despite more volatile weather). But it doesn't simply offset the carbon cost of AI. It would be like comparing apples with oranges (or carrots). It's a tricky calculation to make, one with political and ethical di-

Whenever AI is celebrated for amazing achievements, let's remember that it had some human help. What time, effort, energy and other resources were invested in the project? Could similar results have been achieved using more traditional data collection and analysis, potentially at a lower

environmental cost? The authors of our report have mixed views on AI. None of us are against it, or against using it to solve environmental problems. But to properly govern AI's net impact on the climate, its benefits must not be overstated.

Barkha Raina (25), son Takash (3), 17-yearold Ganga Bhagat, 15-year-old Danish Bhagat and 6-year-old Advik, a police officer said.

Those injured and undergoing treatment are 61-year-old Swarna (the wife of Avtar Krishen Raina), Neetu Devi (40), Arun Kumar (15), and a 69-year-old woman, he said.

Dr Surinder Atri, the principal of the hospital, said, "Ten people were brought to the hospital. Six were brought dead, and four others were injured."

Preliminary investigations suggest the victims died of smoke inhalation and suffocation, he said, adding that no burn injuries were reported.

"It is an unfortunate incident. Our assistant matron, who had recently retired, was living in the rented house. The incident happened between 2 am and 3 am. She called over the phone and I immediately informed the police and fire brigade," the doctor added.

Rocky Sharma, a student, said he was studying late at night when he noticed the fire and rushed to the house along with others. "The fire had engulfed the drawing room, and the smoke that seeped into other rooms resulted in the deaths," he added.

The police have registered a case and initiated an investigation into the matter.

Chief Minister Omar Abdullah also expressed deep sorrow and desscribed the incident as deeply painful, particularly as it claimed the lives of six people and injured another four.

"It is heartbreaking to learn about this tragedy where six precious lives were lost. I pray for eternal peace to the departed souls and for the swift recovery of those injured in this unfortunate incident," he said.

The Chief Minister extended his heartfelt sympathies to the bereaved families, praying for strength and forbearance to help them endure this difficult time.

Muslim Daughter

"It provides guidelines on how the estate of a deceased person should be divided, taking into account the shares for children, spouse, and other family members."

In this verse, the court said, it is ordained that the portion of the son will be two times that of the daughter.

"During the time of ignorance, the people were only giving from inheritance to their sons and daughters were being deprived of their portions completely, but in Islam such discrimination has been removed and daughters have been given their right of inheritance," the court said, adding, "The son is given two times the amount of the daughter because he (son) is required to spend from his wealth to maintain the household and fulfil the needs of his wife and children and other family members, including parents".

It is from Verse 11 of Surah An-Nisa, the court said, a duty, obligation, command, ordain, injunction to assign and give the share to the daughter(s).

"Even its plain reading, in my opinion, bestows the right of inheritance first to a female, then to a male survivor," the court said, ordering that petitioners and/or their mother cannot/could not be expelled by any excuse/pretext to inherit the property.

The Case It was 43 years back, i.e., in the year 1981, that mother of petitioners, filed a suit before the High Court and she was admitted to be entitled to share under Muslim Personal Law to the extent of 1/3rd but that suit was dismissed on the ground that no possession was claimed by her. Against that judgement and decree, an appeal was preferred by petitioners after the death of their mother before the Division Bench of the Court, which set-aside the Single Bench order.

The petitioners contended that they were misled by ill advice of an advocate and they instituted a suit for partition and possession on 3rd July 1996 and same was returned to them after a period of seven years on 30th December 2003, to be presented before Revenue Authority as the same was barred by Section 139 of the Land Revenue Act. Thus, petitioners presented an application under the Land Revenue Act. Settlement Tehsildar (Collector 1st Class) issued notices to other-side and after hearing parties and considering objections of other-side, attested mutation as per decree passed by the Division Bench, Brother of the deceased woman, feeling aggrieved of mutation, filed an appeal before Settlement Officer, Kashmir, who set-aside the mutation passed in favour of petitioners on "flimsy" grounds vide order dated 28th July 2009 by misinterpreting the Division Bench judgement.

Against the order of Settlement Officer, further appeal was filed before Settlement Commissioner, J&K, Srinagar, who dismissed petitioners' appeal confirming the order of Settlement Officer.

"Revenue Officers, including Settlement Officer and Settlement Commissioner, have oblivious of Muslim Personal Law, passed impugned orders. In essence and core, they have declared (woman) as not being the daughter of late (........). As a matter of fact, she has been excluded to inherit the property of her father's property," the court said, adding, "Not only this, Settlement Officer and Settlement Commissioner have sat over the judgement of the Division Bench of this Court and have tried to show as if the judgement of the Division Bench is a mere plain paper, having no force in law."

The Division Bench, the court said, has held the woman entitled to inherit the share of property under Muslim Personal Law.

"The said judgement has long since attained finality and all that has been said and observed therein, in law, is a binding precedent and as a consequence whereof subordinate courts, which includes revenue courts, and in the present case Settlement Commissioner and Settlement Officer were under legal obligation to follow it in letter and spirit," the court said, adding, "However, they have startlingly done contrary thereto. In such circumstances impugned orders or for that matter any other order/injunction/relief passed/given by any forum/ court in contravention to the aforesaid Division Bench judgement, per se, is/are illegal and is/are set at naught."

Subsequently, the court allowed the appeal and quashed the order dated 8th December 2010 passed by Settlement Commissioner, J&K, Srinagar as also order of Settlement Officer dated 28th July 2009.

"Respondent-Revenue Department is directed to implement the judgement of the Division Bench of this Court dated 9th February 1996in letter and spirit, by giving petitioners the share of their mother,, in the property of (woman's father) to the extent of 69 Kanals 02 Marlas situate at Zainakote Srinagar) as per Muslim Personal Law within three months from today."

The court also made it clear that in the event, brother of the woman has created any third party interest in the property in question, then in such situation, it shall be responsibility of respondent (the brother) to give landed property at some other place(s) having equivalent market value and/or according to the market value of the property in question.

and "malicious lies" cannot hide its misdeeds and said the home minister had exposed the opposition party's "dark history of insulting" Ambedkar.

Parties like the Congress, Trinamool Congress, AAP, RJD, SP, Shiv Sena (UBT) and the Left protested against Shah inside Parliament and outside.

Trinamool Congress MP Derek O'Brien submitted a notice to move a privilege motion against Shah in the Rajya Sabha, where the Home Minister made the remarks.

Congress chief Mallikarjun Kharge warned that there will be a countrywide agitation if Shah does not resign.

Addressing a press conference here, Shah alleged that the Congress in the past has also misrepresented his and even PM Narendra Modi's comments to spread confusion and mislead people.

"I condemn the Congress for twisting facts. Why did it happen? It happened because BJP leaders spoke on how the NDA governments upheld the Constitution and established with facts that the Congress is anti-Ambedkar, anti-constitution and anti-reservation," Shah told reporters

"When all these facts came out, the Congress used its old tricks and made an effort to mislead the society by presenting twisted facts," Shah said, adding that he comes from a party that will never insult Ambedkar.

Congress president Kharge too addressed a press conference and demanded that Shah resign or else PM Modi should sack him.

Asked about Kharge's demand, Shah said in a lighter vein that he can quit if this would make the Congress president happy but it would never solve his problems. He has to remain in his chair, a reference to his party being in the opposition, for 15 more years, Shah said.

Kharge said a person becomes a minister by taking oath of the Constitution and if he insults it, he has no right to remain in the Cabinet.

"We want Amit Shah to quit his post and if he doesn't, I want to tell the prime minister that if he has even little respect for Babasaheb, he should dismiss Amit Shah from his post before midnight," he said.

"If there is no resignation, there will be protests all over the country. Babasaheb Ambedkar ji belongs to everyone because he used to talk about every person of society including Dalits, the oppressed and the deprived. He had sympathy for everyone," he said.

Leader of Opposition in the Lok Sabha Rahul Gandhi said, "Baba Saheb is the architect of the Constitution, a great man who gave direction to the country. The country will not tolerate his insult or the insult to the Constitution framed by him. Home Minister should apologize!"

He later claimed, "They are against the Constitution. They had said earlier that we will change the Constitution. They are against Ambedkar and his ideology. Their whole work is to finish off Ambedkar's contribution and the Constitution. The whole country knows."

Several MPs of the INDIA bloc also held a protest in Parliament premises demanding Shah's apology for his remarks on Ambedkar. The uproar in Parliament also spilt onto the streets of the national capital and other states

like Maharashtra, Bihar and Tamil Nadu where various parties held protests. In Delhi, AAP convenor Arvind Kejriwal led a protest with hundreds of supporters outside the BJP chanting slogans of "Amit Shah maafi

maango, Amit Shah sharm karo".

Speaking to reporters, Omar said, "I don't know where these reports originate. If there is any meeting, you will be informed, either by me or by the Home Minister's office."

He, however, acknowledged the critical role of the Home Minister in Jammu and Kashmir's affairs. "Jammu and Kashmir is currently a Union Territory, and as such, the Home Minister has a significant role to play. There are several issues we need to discuss with him, and I plan to meet him in the future," he said.

Speaking about his recent comments regarding Electronic Voting Machines (EVMs), Omar said he had made no new statement. "I've consistently maintained that if someone has concerns about EVMs, they should express them year-round, not just when they lose elections. Complaints should persist even after victories, or else we must return to ballot papers. But have we forgotten the manipulations that occurred with ballot papers, like ballot stuffing? I experienced those issues in my early elections before EVMs were introduced," he said.

Asked about allegations from Congress leaders that some alliance members adopt a different tone after assuming ministerial roles, the Jammu and Kashmir Chief Minister dismissed the claims, reiterating his praise for the Congress party's leadership. "In the same interview, I appreciated Sonia Gandhi's leadership and stated that Congress has a natural role in leading the opposition, given its pan-India presence. This is not BJP's language but the truth. I won't stop speaking the truth just because I've held a leadership position," he said.

The Board held a comprehensive and critical review of its past decisions, ratified the actions taken after its last Meeting and took several new decisions against 25 key Agenda Items having far reaching implications for functioning of the Board and augmenting pilgrim services.

Important decisions were taken in respect of new and underway projects of the Board such as construction of Exit Track from Durga Bhawan to Manokamna (a part of the Master Plan for Bhawan area), development of helipad in collaboration with Shri Shiv Khori Shrine Board in village Hutt at Katra, construction of temples in District Reasi, review of projects and status of operationalization of Medical College of the Board at Kakryal etc.

The meeting was attended by Members of the Board- Mahamandleshwar Swami Vishveshvaranand Giriji Maharaj; Shri Baleshwar Rai, Dr Ashok Bhan, Shri Kul Bhushan Ahuja, Dr Neelam Sareen, Shri K.K Sharma, Shri Suresh Kumar Sharma and Shri Raghu K. Mehta.

Dr Mandeep K. Bhandari, Principal Secretary to Lieutenant Governor and Anshul Garg, CEO, SMVDSB also attended the meeting. The Meeting accorded approval to tripartite Memorandum of Understanding (MOU) with the Geological Survey of India (GSI) and THDC India Limited (THDCIL) with an aim to identify and treat slopes that are vulnerable to landslides and rockfalls along the Yatra Route between Adhkuwari and Bhawan. The collaboration will focus on ensuring the safety of pilgrims by mitigating the risks associated with

unstable slopes.

To address congestion issues near Battery Car
Point at Bhawan, the Board approved measures
to improve the area's infrastructure by developing a dedicated parking facility for Battery
Cars opposite to Parvati Bhawan, constructed
atop a 3-storey structure. This will provide a
convenient and organized space for Battery
Cars to operate from, reducing congestion and
enhancing the overall ambiance of the area.

The Board also approved the Master Plan for the Sanjichhat Area addressing augmentation of key sectors like Accommodations, Toilets, Water Points, Food Points, Queue Management, Holding Area etc.

The Board observed that the Shrine Board has significantly developed the Kakryal area by creating facilities like Hospital, University, Nursing College and Medical College and desired the CEO to explore the modalities to address educational needs of the employees associated with these facilities.

The meeting also reviewed the progress of ongoing works and emphasized on timely completion of all projects for the ease of pilgrimage. The important projects in this regard were New Vaishnavi Bhawan at Bhawan, Covered Holding Area at Adhkuwari, Exit Track & Remodelling of Manokamna Area at Bhawan, Queue Complex at Darshani Deodi, Banganga and Cottages (near Sport Stadium), Katra.

The Board appreciated façade lighting project initiated for enhancing the Shrine's aesthetics and ambience in different sector of Shrine and approved revamping of lighting at the facade of the old Gufa in the Atka area, inside the three caves and the sanctum sanctorum through a combination of LEDs and optic fibre lighting.

The Board also gave its approval to the additional Grant-in-Aid for Shri Mata Vaishno Devi Charitable Society to support the operation of the Board's peripheral institutions such as the Medical College, Hospital, Gurukul, Sports Complex, and College of Nursing, all of which are managed by the SMVD Charitable Society.

Earlier, Anshul Garg, CEO, SMVDSB, gave a detailed presentation on varied activities of the Shrine Board and the action taken as regards the implementation of various decisions of the previous meetings of the Board.

'Shubhra Bhawan' at Banganga, Katra built at a cost of Rs. 6.50 crore includes holding area for disaster management, a comfortable and spacious waiting lounge, lactating mothers' zone, a centralized information and registration centre, souvenir shop, refreshment kiosks, Bank and Water ATMs etc. 18 modern staff quarters have also been provided in the complex. A well-equipped disaster management store is a key feature of Shubhra Bhawan that is expected to serve as a 'critical resource for emergency response and disaster mitigation'.

USBRL Project

Rail Connectivity To Boost Kashmir's Apple Industry, Say Farmers

SRINAGAR: The Udhampur-Srinagar-Baramulla Rail Link (US-BRL) project is now 100 percent complete, with railway stations in Kashmir soon connecting to the rest of the country. Stakeholders in Kashmir's fruit trade are optimistic that the project will boost the apple industry, saving valuable time and money. However, transport associations have expressed concerns about its impact on the local transport sector.

Union Minister Ashwini Vaishnaw announced the completion of the final track work for the USBRL project on Friday, calling it a "historic milestone" in a social media post.

He wrote: "Final track work on the Udhampur-Srinagar-Baramulla Rail Link is complete. The ballastless track work for the 3.2-km-long Tunnel T-33, located at the foothills of the Shri Mata Vaishno Devi Shrine and connecting Katra to Reasi, was successfully completed today at 2:00 AM."

Officials said that inspections and trial runs are expected to begin soon on this stretch. "The inspection will include a detailed examination of the track using a trolley. It will cover the tracks, electrification work, tunnels and bridges," they said

According to officials, the first train from Delhi to Srinagar is expected to commence operations within the next four months.

Aarif Husain Khatana, a student, shared his experience of a two-day journey to Srinagar, costing him Rs 2,000 to appear for exams.

"Train connectivity is the need of the hour and should be introduced as soon as possible. This rail network will bring us closer to the rest of India. It will save time, reduce costs and encourage tourism in ways we couldn't imagine before," he said.

The All Jammu and Kashmir Transporters Welfare Committee, an amalgamation of various transport associations, has expressed concerns that rail connectivity could adversely affect the local transport sector. It has called for proper norms to regulate and safeguard the interests of local transporters.

General Secretary of the Kashmir Welfare Transporters Association, Sheikh Muhammad Yusuf, said that railway connectivity from Delhi to Srinagar is going to adversely affect the local trans-



port sector in J&K. "There should be some norms that the authorities need to keep in mind. We have already suffered losses when the Banihal-Baramulla train was introduced," he said.

Yusuf said the authorities should acknowledge that for three decades, the transport sector has operated under challenging circumstances, including hartals and other issues. "Now that the situation in Kashmir has improved, the introduction of the railway is causing the transport sector to vanish," he said, adding that the government is issuing expensive permits to vehicle owners, which should be

The KWTA leader further said that truck drivers transporting goods to other parts of the country are going to suffer immensely. He urged the government to take measures to safeguard the local transport sector and support truckers who transport goods to other regions of the country.

tion often causes delays, spoilage and losses for farmers. Rail connectivity offers a solution.

However, inefficient transporta-

The direct movement of appleladen wagons from Kashmir to major markets in Delhi, Mumbai and beyond will drastically reduce transit time. "Earlier, it took us days to transport our produce via trucks. Now, train connectivity will ensure quick delivery, better shelf life and competitive prices," said Azhar Hussain, an entrepreneur from south Kashmir's Anantnag district.

He said that rail cargo facilities also mean lower transportation costs, improving profits for farmers while ensuring that Kashmiri apples reach customers in pristine condition.

Bashir Ahmad Basheer, chairman of the Kashmir Valley Fruit Growers and Dealers Union said that Kashmir's limited connectivity makes the new train service a valuable addition in the long term. "Train connectivity will help fruit growers transport their produce to other states more easily and efficiently. This will open up new markets and increase their income." he said.

Basheer said any benefit to this sector will positively affect the

economy of everyone involved. "With better connectivity, farmers will have easier access to markets, lower transportation costs and fresher produce for consumers," he said. "This development is expected to boost Kashmir's overall economy, support farmers and promote growth in the horticulture industry."

Manzoor Pakhtoon, a member of the Kashmir Chamber of Commerce and president of the Houseboat Association, told KNO the train connectivity is a welcome and developmental step and will boost the tourism sector in the valley.

He said many tourists were unable to visit Kashmir, which is a dream for everyone, due to high airfares during both the summer and winter seasons. "The main benefit of tourists visiting Kashmir by train is that they can manage their budget. This will mostly boost domestic tourism. Students can travel easily on a lower budget. General trade will benefit as well," he said.

Pakhtoon said Kashmir is a well-known destination within the country and abroad. "Both international and domestic tourists want to visit Kashmir at least once in their lives." he said—(KNO)

Congress Protests For Restoration Of Statehood In J&K's Twin Cities

SRINAGAR: The Jammu and Kashmir Congress unit staged protests outside the Raj Bhawan in Jammu to press for its demand for the immediate restoration of statehood for the I&K, action against Adani, demand of normalcy in Manipur.

Addressing the media during the demonstration, J&K Congress Chief Tariq Karra led the protest in Jammu and tried for Raj Bhawan Gharo which foiled. Similarly congress party also held a protest demonstration held by the party in Srinagar.

The Congress party raised a range of pressing issues, including corruption, economic mismanagement, and law and order concerns in Manipur, alongside the demand for statehood.

Karra criticized the central government for failing to restore Jammu and Kashmir's statehood. a move he said was essential for the J&K's progress and dignity. He accused the government of

the J&K in administrative limbo. "The people of Jammu and Kashmir deserve their rightful statehood, which has been denied to them for far too long," he said. Karra also expressed gratitude

to the Supreme Court for ensuring the conduct of elections in the region but questioned the government's reluctance to restore statehood despite repeated promises in and outside Parliament.

Karra accused the central gov-

ernment of fostering a "generation of corruption," suggesting that it has turned a blind eye to rampant irregularities.

He also pointed to administrative confusion in Jammu and Kashmir, where officers are uncertain about their chain of command—whether under the Governor or the Chief Minister. "This lack of clarity has allowed the bureaucracy to exploit the situation, with some acting within the law and others blatantly disregarding it, increasing hardships for the common people," Karra alleged.

Karra called on the Prime Minister and Home Minister to fulfill the promises made to the people of Jammu and Kashmir.

He warned that the Congress would escalate its agitation if statehood is not restored soon. 'The promises made on the land of Jammu and Kashmir must be honored, or the government will face intensified protests," he asserted.

The Congress leader also took aim at the Adani Group, accusing it of financial irregularities on national and international levels vindicated by the US Justice De-

Karra criticized the government for failing to act against the conglomerate despite allegations of fraud and misrepresentation, which he claimed were affecting small investors and damaging the economy.

He warned of the cascading effects of such economic mismanagement, citing rising unemployment as one of the consequences.

Gulmarg Gondola Generates Rs 11.86 Cr In 2 Months

SRINAGAR: The famous Gondola in Gulmarg has witnessed a significant influx of tourists over the past two months, with a staggering 1,48,357 visitors recorded in November and December so far.

The data accessed states that the cable car, one of the top attractions in Jammu and Kashmir, generated a revenue of Rs 11,86,85,600 during this period (November - December).

In November alone, the Gondola saw 93,921 tourist arrivals, while December, with its ongoing charm of fresh snowfall, attracted 54,436 visitors.

Gulmarg Gondola, operated by the Jammu and Kashmir Cable Car Corporation (JKCCC), in two phases is Asia's highest and longest cable car project, offering breathtaking views of the snow-clad Pir Panjal mountain range — the first phase connects Gulmarg to Kongdoori at an altitude of 8,530 feet, and the second phase takes visitors to the stunning Apharwat Peak at 13,780 feet above sea level.

Speaking with KNO, Managing Director, J&K Cable Car Corporation, Syed Qamar Sajjad

said that, they have increased the quota and introduced the Tatkal facility to ensure foreign tourists, especially those planning at the eleventh hour, are provided with Gondola services, irrespective of their numbers.

The Gondola capacity is already full for the next two months, which aligns with the anticipation of winter games and the snowfall season that attracts skiers in large numbers, he said.

Six Drug Peddlers Arrested In Kashmir

SRINAGAR: Continuing its efforts to eradicate the menace of drugs from the society, Jammu and Kashmir Police on Wednesday said to have arrested six drug peddlers in Srinagar, Kupwara, Shopian & Kulgam and recovered contraband substances from their possession.

In Srinagar, a police party of Police Station Nowhatta during routine naka checking at Malkha chowk, apprehended an individual under suspicious circumstances, a police spokesman said in a statement.

During the search, approximately 40 grams of charas like contraband substance was recovered from his possession. He has been identified as Zubair Ahmad Ahanger son of Amin Ahanger resident of Kathi Darwaza.

On his disclosure, another individual namely Bilal Ahmad Sheikh son of Gh. Qadir Sheikh resident of Tujgari Mohalla, was apprehended near old Malkha Chowk. Upon his personal search, approximately 80 grams of charas were recovered, police said.

In Kupwara, a police party of Police Station Kralpora at a checkpoint established at Khazanmatti, intercepted two suspicious persons. During the search, approximately 13 grams of heroin-like substance was recovered from their possession.

They have been identified as Aasim Sultan Sheikh, son of Mohd Sultan Sheikh, resident of Trehgam, and Mujtahid Nazir son of Nazir Ahmad Lone, resident of Khumriyal. Further investigation has been initiated to establish the backward and forward linkages of the drug trade and uncover any networks involved.

In Shopian, Police Station Keller received information that one person namely Gh Mohammad Parray son of Ab Ahad Parray resident of Chowan Keller has concealed Charas like contraband substance in his residential house.

Acting swiftly, a police Party from Police Station Keller along with the Executive Magistrate raided the said residential house. During the search, 41 grams of charas-like contraband substances were recovered. Further investigation is underway to unearth the forward and backward linkages of the arrested individual. The operation was meticulously executed by SHO Police Station Keller under the supervision of SSP Shopian Anayat Ali Chowdhary, police said.

BRISBANE: Indian skipper Rohit Sharma hailed the resilience of the lower-order batters after his team managed to salvage a crucial draw in the rain-hit third Test against Australia here on Wednesday, saying it has given the side renewed confidence for the remaining series.

BRISBANE: India's premier off-spinner R Ashwin on Wednesday stunned the cricketing world by bidding adieu to his international career in the middle of the ongoing Test series against Australia here despite having a "bit of punch left" in him.

The 38-year-old retires from the game as the second highest wickettaker for India in Tests with 537 scalps in 106 games, placing him only behind the great Anil Kumble (619 wickets) in the overall statistics.

In the limited-overs format, being part of the 2011 World Cup and the 2013 Champions Trophy-winning teams would count among the highlights of his career.

He will continue to play club cricket, including the IPL, where he will return to compete for Chennai Super

Kings next year. 'Today will be the last day for me as an India cricketer in all formats," Ashwin said at the end of the drawn third Test here in a joint press conference with captain Rohit Sharma during which he declined to take any questions and left after making the announcement.

The series is still alive with two

more Tests to go in Melbourne and Sydney as the two teams are tied 1-1 after logging one win each.

Ashwin, who would be headed back to India on Thursday, was seen having an emotional conversation with star batter Virat Kohli in the dressing room hours before the announcement, sending social media into a frenzy.

Kohli had his arm around the senior bowler's shoulder and Ashwin was seen wiping his eyes before breaking into a chuckle.

Ashwin played the day in Adelaide and picked up one wicket. He not being a sure starter in the playing eleven over the course of the three Tests prompted him to think about his future in the team and eventually call time on a remarkable career.

Ashwin was not just the master of his craft, he was also considered one of the brightest minds in world cricket.

The Chennai-based player, who holds an engineering degree, usually does well to hide his emotions but sitting alongside longtime teammate Rohit, Ashwin left the stage for the fear of getting overawed by the occasion.

Ashwin played 116 ODIs for India, claiming 156 wickets, while his 65 T20 International outings yielded 72 scalps.

'Sore' Head Confident He'll Be 'Fine' For Boxing Day Test

Australia's man in form Travis Head played down concerns over his fitness after appearing to struggle with a potential groin issue during the rainmarred drawn third Test against India at the Gabba here on Wednesday.

Head said he expects to be "fine" for the Boxing Day Test in Melbourne.

The five-match series is tied 1-1 going into the Boxing Day Test after the drawn affair.

'Very pleased with the way I am batting at the moment. Just a little sore, but I should be fine (before the next game)," Head, who was adjudged the player of the match, said after the game.

The 30-year-old, who has been in red-hot form with 409 runs at an average of 81.80 this series, noticeably struggled to run between the wickets during his brief innings of 17 on day five.

At times, he was seen clutching his groin, raising concerns among the commentators.

Head did not take the field during India's second innings, fuelling further speculation.
