Srinagar: A day before the harshest winter period in Kashmir 'Chillai Kalan', temperature plunged several degrees below freezing point across Kashmir valley, with Srinagar witnessing its coldest night of the season so far, officials said on Friday.

Srinagar recorded a minimum temperature of minus 6.2 degrees Celsius, slightly down from minus 6 degrees Celsius the previous night, the officials said.

The night temperature on Thursday was 4.2 degrees below the season's normal, they said. The biting cold conditions led


The Kashmir University Wednesday also announced winter break for main and its satellite campuses January 01 to February 23.

Over 1 Lakh Transport Vehicles Declared Unfit In J&K

Srinagar: Over one lakh vehicles falling under the category of End-of-Life Vehicles (ELVs) category have been declared unfit in Jammu and Kashmir, an official data shows.

Official data states that 110,793 transport vehicles lack valid fitness certificates, while 154,020 non-transport vehicles are not validly registered. Also, 7,742 vehicles have had their registration certificates cancelled till December 17 20204.

'Diarrhoea Continues To Be 'Leading Killer' Among Children Under 5 And Elderly'

iarrhea and related infections continue to be a leading cause of death among children under five years and the elderly, particularly in sub-Saharan Africa and South Asia, even though deaths from these conditions have dropped globally by 60 per cent between 1990 to 2021, a study says.

Published in The Lancet Infectious Diseases journal, the study found that in 2021, diarrheal diseases -- infections that cause diarrhea -were responsible for 12 lakh deaths worldwide, a significant decrease from 29 lakh deaths in 1990.

These estimates are the latest and most comprehensive from the Global Burden of Disease (GBD), coordinated by the Institute for Health Metrics and Evaluation (IHME) at the University of Washington, US.

The findings suggest that health interventions, including oral re-



hydration therapy, improved sanitation, and global immunisation efforts against rotavirus (which causes diarrheal infections), are proving effective, researchers said. They also found that the largest decline in deaths occurred among children under five, although mortality rates remain highest in this age group.

Individuals aged 70 years or older were the second most affected





Regionally, children under five in sub-Saharan Africa had the highest mortality rates, with over 150 deaths per 100,000 population, compared to other global regions. In South Asia, the highest mortality rates were found among those

aged 70 and older, with 476 deaths per 100,000 population. The authors stated that preventive measures targeting key risk factors and infection-causing microbes could further reduce the global burden of diarrheal diseases.

"The new granular-level analysis in our study can help decisionmakers better target and prioritise evidence-based strategies to fight diarrheal diseases," said Dr. Hmwe Hmwe Kyu, a study author and associate professor at IHME.

"Despite the encouraging progress made in combating diarrheal mortality, a multipronged approach is needed to simultaneously implement life-saving solutions while also prioritising preventive interventions to alleviate the burden on health systems," Dr. Kyu added. The authors also suggested that as more vaccines are added to the World Health Organisation's Expanded Programme on Immunisation, combining them could reduce manufacturing costs and make scheduling easier.



"Parking First, E-Challans Later!"

KTMF Expresses Concerns Over ITMS E-Challan System Without Adequate Infrastructure

Srinagar: The Kashmir Traders and Manufacturers Federation (KTMF), President Mohammad Sadiq Baqal, has voiced serious concerns over the introduction of the Intelligent Traffic Management System (ITMS) and the e-challan system by the traffic department in Srinagar district. While acknowledging the need for modern traffic management solutions, Mr. Bagal emphasized that the implementation of this system must be preceded by adequate infrastructure and stakeholder engagement.

"We are not against the ITMS e-challan system," said Mr. Baqal. "However, the fundamental issue lies in the lack of proper parking facilities in the busy areas of Srinagar city, particularly in the century-old markets, bazaars, downtown,

and civil lines areas. Without addressing these issues, the echallan system only adds to the hardships faced by shopkeepers and customers alike.'

The KTMF President highlighted that the government has been repeatedly approached with representations to resolve the parking crisis in Srinagar city. Yet, no tangible steps have been taken to provide parking spaces, particularly in the old city of Shehr-I-Khaas and civil lines areas.

"Shopkeepers are already grappling with financial difficulties and low sales," he noted. "Now, the e-challan system is creating additional problems. Vehicles parked for just a few minutes to facilitate shopping are photographed and e-challans are issued online. This approach, implemented without consulting stakeholders, is unfair to both shopkeep-

Srinagar: The ongoing cold wave in Srinagar and elsewhere has affected the water supply at multiple places across the Valley as the supply pipes and taps froze in the night amidst the sub-zero temperatures in Kashmir. City residents in Old City ar-

eas including Habba Kadal and other parts complained that they didn't get the water supply till the afternoon today.

"Most of the pipelines froze due to the below freezing temperatures. We didn't get the water supply till the afternoon hours today," Muhammad Shafi, a local from Karfali Mohalla, said.

He said that the taps were running dry again today, leaving the people to lurch at large. One of the residents from

Batamaloo area stated that


Similar reports were also received from other parts of the Valley.

Meanwhile the parts of Dal Lake also froze today amidst the coldest night of season in Srinagar at minus 6.2 degree Celsius.

The people living in the houseboats were seen making their way through the water body today after the below normal temperatures froze the Dal Lake today.

Meanwhile, an official from the Jal Shakti department told KNO that the supply was provided to the people except the Gupkar line due to some issues.

However, he said that the supply could have got affected due to the frozen pipes. "The pipes could have got blocked due to the freezing temperatures that's why the people may have not received the water supply," he said—(KNO)

Mehdi Hasan Anxious To Sing Again

AHORE- Severe mental stress, excessive use of pan with tobacco contents, smoking and fluctuating blood pressure are some of the factors which led to severe paralysis stroke to world's renowned singer and Ghazal Maestro, Mehdi Hasan who is currently under treatment at Sheikh Zaid Hospital here.

This is what his doctors said while talking to The Nation newspaper on Monday. This did not come as a surprise to the great singer as he had already suffered a mild stroke of paralysis almost a year back when he was in India in connection with some musical concert. He has been under treatment since then complaining

weakness in his right leg, his son Kamran told this scribe. "I underwent a similar low intensity attack of paralysis as far back as in 1968 but recovered soon by the grace of God Almighty, Mehdi Hasan himself told in a stumbling tone while recalling his past medical history.

"The stroke affected left side of his brain where lies the speech area and thus paralyzed the rightside of the body including the tongue"', said Dr.Farrukh Idbal who is closely monitoring the health of the great singer of the subcontinent. Khan Sahib is also suffering from asthma and has difficulty in breathing, he further said, adding that he is being nebulized every six hours to ease his breathing.

University of Kashmir NIRF Rankings Reveal Deeper Institutional Challenges

This is the two performance in the 2024 National Institutional Ranking Framework (NIRF) shows concerning trends that merit serious attention from policymakers and educational administrators. Over the past five years, KU has struggled to maintain its competitive edge despite substantial financial resources.

While KU secured the 14th position in the newly introduced 'Top 50 State Public Universities' category in NIRF 2024, there is more to this achievement than meets the eye. The university has slipped 11 positions in the Overall Ranking and 12 spots in the Top 100 University category compared to the previous year. This decline is particularly worrying for an institution with a 76-year legacy and substantial financial resources.

Mixed Performance

KU's teaching metrics show modest progress, with a 0.5-point overall gain in Teaching, Learning & Resources (TLR). Two factors drove this improvement: Faculty-Student Ratio rose by 0.78 points, while Faculty Quality and Experience increased by 0.14 points. These gains likely reflect recent recruitment efforts, which expanded the teaching staff from 552 to 644 between 2021 and 2024.

Despite these positive developments, KU lost ground in other areas: Financial Resources and Utilization (FRU) sub-parameter.

KU's Resource Efficiency Challenge

Perhaps the most striking finding is what might be termed the "efficiency gap" in KU's resource utilization. With an annual FRU of approximately Rs 375 crore, KU outspends several better-performing institutions. Yet, this financial advantage has not resulted in proportional improvements in key performance metrics.

While KU's operational expenditure increased by 21.80% over three years (from Rs 276 crores to Rs 337 crores), its academic expenditure saw only a modest 6.80% rise (from Rs 35 crores to Rs 37 crores). This disparity raises questions about the institution's spending priorities and efficiency in resource allocation.

The NIRF measures FRU using two main factors:

- Academic expenditure (ACE): Average yearly capital spending per student.
- 2. Operational expenditure (OPE): Average yearly recurring costs per student

These calculations exclude hostel maintenance and related services.

Over the last three years (2020-2023), KU's spending per student has grown by 23% to Rs 3.85 lakh. While day-to-day operational costs per student jumped by nearly 23% to Rs 3.46 lakh, academic investments saw a modest 9.31% rise to Rs 39.000 per student. But here is the catch:



dropped 0.37 points this year, reflecting sharp declines in both funding and consultancy. Research funding at KU has plummeted by 68% - from Rs 40.91 crore for 82 projects in FY 2020-21 to Rs 13.25 crore for 84 projects in FY 2022-23. Consultancy projects have seen an even steeper decline of 79%.

These figures suggest a significant weakening of the university's research ecosystem. This decline has broader implications since funded research, which help generate new empirical data, often leads to high-quality publications in prestigious journals. To improve its Research and Professional Practice score, KU must actively pursue diverse funding sources beyond ICSSR to retain intellectual property rights and data usage and focus on converting research projects into impactful publications.

The Employment Challenge

The placement figures paint a troubling picture at KU. With less than 15% of its students securing jobs through campus recruitment, KU lags far behind its peer institutions. Anna University, Panjab University, University of Kerala, and Jadavpur University all boast placement rates above 40% - nearly triple KU's performance. This falls drastically short of UGC's 2018 'Quality Mandate' target of 50% placement. What makes this even more concerning is that KU ranks second highest in faculty-student ratio among these institutions (excluding PhD scholars), and third highest when including doctoral students. Despite this advantage in teaching resources, the university's placement outcomes remain disappointingly low.

Anna University, operating on about half of KU's FRU (Rs 23,000 per student), achieves a 60% placement rate for postgraduates. Even more impressive is Jadavpur University, which manages 68% placement despite spending just Rs 20,000 per student - less than half of KU's investment.

ago, has shown remarkable progress in NIRF rankings, jumping from 78th position in 2020 to 27th in 2024. Similarly, SRM Institute of Science & Technology has climbed from 35th to 12th place. Meanwhile, KU's advancement has been minimal, improving by only three positions over five years before its recent decline.

Money does not seem to be the issue. KU's Rs 375 crore budget actually exceeds LPU's Rs 367 crore. The message is clear: it is not about how much you spend, but how effectively you use those resources.

As competition within the higher education sector intensifies, KU must not only improve its absolute performance but also keep pace with the rapid advancements of newer, more agile institutions. This requires innovative approaches to education delivery, research output, and stakeholder engagement to reverse the current negative trend in rankings.

Falling Short of Legacy

Despite impressive credentials - 644 experienced faculty members, 1,160 full-time PhD students, and over 540 PhD graduates in three years - Kashmir University's research standing falls short of expectations. The university's absence from NIRF's 'Top 50 Research Institutions' list stands in stark contrast to peer institutions like Panjab University, Jadavpur University, and Anna University.

This underperformance extends to specific departments. The 50-year-old Law Department fails to crack the 'Top 30 in Law', while the 33-year-old School of Business remains outside the Top 100 in Management, lagging behind even relatively new business school at LPU.

The research quality at KU's Law Department and School of Business raises serious concerns. A telling example: The Business School's publication list on its website consists entirely of works from Notion Press, a self-publishing company. Similarly, three out of four books listed on the Law Department's website are self-published through the same platform. This reliance on vanity publishing, rather than peerreviewed academic outlets, not only hurts KU's NIRF rankings but also damages the academic reputation of these departments. It raises serious questions about research standards and academic rigor at these flagship departments.

The Way Forward

Strong rankings boost prestige and appeal, while poor performance risks decreased interest, reduced funding (in some cases), and a weakened reputation. This makes the university's competitiveness and growth contingent on its ranking. Therefore, KU must adopt a strategic approach to improve its rankings and fulfil its potential.

First and foremost, KU must develop a 'comprehensive strategic document' to guide the university toward academic excellence. It is not merely about increasing spending, but about making targeted investments in priority areas, identifying where immediate interventions are needed, and ensuring that these investments yield optimal outcomes.

Without strategic planning, efficient resource utilization, and a culture of academic excellence, even well-funded institutions risk falling behind in the increasingly competitive higher education landscape. KU stands at a critical crossroads. As newer institutions demonstrat markable agility in climbing the NIRF rankings, KU must move beyond merely increasing expenditure to implementing strategic reforms. The success of private institutions offers valuable lessons in adaptation and innovation. The performance of private institutions in the NIRF rankings raises some questions. What strategies are these newer institutions employing to achieve such significant improvements? How can provincial universities like KU adapt to the competitive tertiary education landscape? What other factors, apart from financial resources, are contributing to these ranking disparities? For KU, although located in a specific regional and political context, these trends signal an urgent need for strategic planning. The university must identify areas where it lags behind its competitors within SPU category and accordingly frame and implement targeted initiatives to improve its performance across key NIRF parameters.

Despite higher spending per student, KU's placement record raises serious questions about how effectively these resources are being used to prepare students for the job market. In a region already grappling with 18% unemployment - more than double the all-India average of 8% - KU's placement struggles are particularly concerning. While the valley's limited private sector poses challenges, this alone does not explain the full picture. Other universities in moderately industrialized states, like Odisha, have managed to secure jobs for over 80% of their postgraduates. KU's low placement rates may be contributing to J&K's growing educated unemployment crisis. For a premier institution in the region, this calls for an urgent rethinking of how academic programs align with employment opportunities.

KU's Image Problem

KU reputation among employers and academics remains a major concern. Scoring just 30.53 out of 100 in perception ratings, KU lags far behind its peers - Panjab University (69.13) and Jadavpur University (86.62). This score, based on feedback from a large category of employers, professionals and academic peers, represents a critical area for improvement if KU aims to climb the rankings.

To improve its Perception score KU needs to strategically focusing on key areas. To enhance visibility among employers, KU can strengthen collaboration with industry through partnerships with leading private organizations. Introducing 'Industry PhD program' can help aligning doctoral research with industry needs. This will allow KU attract partnerships with companies, offering students valuable industry exposure and improving their job prospects. Regular and deeper interactions with employers and recruiters, regular feedback sessions, and tailored training programs for students can help in aligning KU's curriculum with industry needs, thereby improving employer and peer perception of KU. Effective communication and branding, including a strong online presence and media engagement, are crucial to positively influence perception of KU among the stakeholders.

The Private Sector Challenge

Lovely Professional University (LPU), established just 18 years

To this end, the following recommendations are crucial:

- 1. KU must ensure that its financial investments lead to tangible improvements in key ranking parameters, particularly in areas that directly impact academic and research excellence.
- 2. It must invest in modern facilities to drive innovation and increase the potential for patents.
- 3. It must incentivise high-impact research and address insufficient research output. One way to do it is to establish awards for outstanding research contributions.
- 4. It can recruit a large pool of postdoctoral research fellows on short-term but well-paid contracts. Postdoctoral fellows are often eager and highly productive researchers. With their expertise, they can help attract research grants and funding, as well as mentor junior scholars. This can create a thriving research culture within the institute.
- 5. It must develop a well-thought out strategic plan to enhance the university's perception among employers and academic peers. It can initiate targeted and long-term programs to improve the university's reputation within academic and professional circles.
- 6. It should develop deeper ties with industry for internships, placements, and collaborative projects to create more job opportunities for its graduates. Introducing Industry PhDs can improve graduate outcomes by providing relevant skills and valuable industry connections to enhance employability.

The path forward requires more than incremental changes. KU must transform its approach to education delivery, research output, and stakeholder engagement. In today's competitive academic landscape, maintaining the status quo is not an option. The university needs decisive action to reverse its ranking decline and ensure sustained progress in academic excellence. This strategic overhaul is challenging but essential for KU to reclaim its position as a leading institution of higher learning.

The numbers become even more concerning when looking at academic spending. As student enrolment grew from 9,380 to 9,730 between 2021 to 2023, academic expenditure per student unexpectedly fell from Rs 39,628 to Rs 38,970 - a 1.66% decline. This raises important questions about resource allocation: shouldn't adding 350 more students lead to increased academic investment, not less?

The Research Conundrum

KU's Research and Professional Practice (RPP) score increased by 4.32 points year-over-year. However, this improvement is primarily due to the new Sustainable Developments Goals (SDG) sub-parameter, which inflated the score to 31.25 points. When considering only the original four sub-parameters, KU's performance actually declined by 0.09 points to 26.84, indicating that the overall increase does not reflect genuine improvement in core research practices.

Despite a 1.2-point increase in Publication score, KU's Quality of Publication score dropped by 0.93 points. Given NIRF's strong emphasis on RPP scores and its reliance on Scopus and Web of Science databases, KU should incentivize its faculty to publish in these indexed journals rather than predatory ones. A 2021 study found that about two-thirds of KU's social sciences publications appeared in predatory journals, which do not contribute to RPP scores. The focus should shift from quantity to quality in research output.

KU scored just 0.50 points in Intellectual Property Rights (IPR) for 2024. While this, perhaps, reflects a patent from Dr. Shabir Ahmad Parah and his team from the Department of Electronics and Instrumentation Technology, recent patents for water tank cleaning technology and smart room heater is expected to improve KU's IPR score in the next NIRF ranking, as these fall outside the current three-year assessment period (2020-2022).

Kashmir in Memory, **Poetry and Translation**

In Conversation with Neerja Mattoo

Neerja Mattoo is a distin-guished academic, writer, and translator whose work has been pivotal in bringing Kashmiri culture and literature to a wider audience. A former professor of English at Government College for Women, Srinagar, Mattoo has dedicated her life to preserving and showcasing the rich literary traditions of Kashmir, particularly the voices of women. Her acclaimed translations, such as "The Mystic and the Lyric" and "The Stranger Beside Me", illuminate the depth of Kashmiri poetry and prose, bridging the gap between the region's unique heritage and global readers.

Besides, her testimony is a liv-ing embodiment of the minority community's persecution, violence and memory.

This interview of Matto with Bilal Wagay for *Kashmir Observer*, will explore Mattoo's literary journey, her contributions to reviving Kashmiri women's narratives, her role in fostering crosscultural understanding through her works, Pandit exodus and the current hindutva narrative to appropriate Pandit question. By highlighting her legacy, we aim to inspire readers to delve into the heart of Kashmiri identity through her lens.


1. What inspired you to focus on translating and preserving Kashmiri literature, particularly women's narratives?

In 1985, I was at a seminar in Delhi University with a colleague of mine from the college. In a break we were speaking to each other in Kashmiri when a Professor from Delhi University asked us which language we were speaking because he had never heard it before. We answered that it is Kashmiri to which he responded with sur prise, "Is Kashmiri a language?" I was dismayed that our language which had a history of more than a thousand years was not even heard of in parts of our country. It was to answer his question that I decided to translate from Kashmiri into English, so that the rest of the country should become aware of our rich literature. I wanted the world to know the powerful voices of women writers from the fourteenth century onwards who enriched the Kashmiri language and literature. Besides, when militancy struck Kashmir in the early nineties, it seemed that everything in Kashmir was being destroyed, and I wanted to preserve some of our rich literary legacy. 2. It is said that in Kashmir, personal is political. How has your upbringing in Kashmir shaped your literary sensibilities and creative vision? I grew up in a Kashmir that was syncretic, where different communities didn't live in separate mohallas. Every neighbourhood had a mixed population, of course the Muslims were in a huge majority but there would always be a sprinkling of Kashmiri Pandit homes in every mo-

halla. We took this diversity for granted, enjoyed each other's festivals and spoke the same language. There was no concept of the Other. I grew up with the songs of Habba Khatoon and the vakhs of Lal Ded ringing in my ears. The folk singers would begin their performance with a Lal vakh and then go on to sing the lyrics of our women romantic po-ets like Arnimal. Later on, I paid serious attention to the thought contained in these and realised that they were such powerful voices in the two streams of poetry, Mysticism and lyricism that they needed to be translated into English for a wider audience. I also wanted to dispel the notion of Kashmiri women as weak or tongue less.

3. What do you believe is unique about Kashmiri literature, especially its poetry and mysticism, that sets it apart from other regional literatures?

I haven't studied much regional literature but I know that mysticism is a very powerful stream 0





of the world. Whether it is located in the Christian, Sufi or Buddhist traditions. The her verses. experience described had similar tones so the vocabulary is available in all the languages which describe a mystic experience. So the challenge was only to find equally powerof Kashmir? ful vocabulary in Eng-lish which fortunately was available in English poetry. 6. Many of your works bridge the gap between Kashmiri heritage and a global audience. How do you approach this balance?

Language is the most important tool in communication. English is a global language and translating the classic work of Kashmiri writers into English makes it available to a global leadership. One has to be faithful to the original, not add or delete anything, nor try to impose one's own feelings or ideas on the original.

7. Translation can sometimes dilute the essence of a text. How do you ensure the authenticity of the original work while translating?

In the beginning, I used to send my translation of a short story to the original writer and wait for his response. I was fortunate that most of these great short story writers were still alive. It was only after their approval that I proceeded. Besides, if one has the ability to think in two languages simultaneously, one's instinct should be the best judge.

8. Do you think enough is being done to promote Kashmiri literature on a national and global scale? If not, what can be done?

Translation can play a vital role in this as the world becomes aware of the rich literature used by Kashmiris, the interest will grow, as it already has. The BBC recently did a forum discussion on Lal Ded, in which, apart from me, American and British scholars who had studied Lal Ded participated.

9. How do you see the contemporary literary scene in Kashmir? Are young writers' poets carrying forward the legacy?

Yes, there are young poets, men and women who are writing to carry forward the two great streams of Kashmiri poetry, mystic and the lyrical. Bimla Raina and Azi Ded in the former Rehman Rahi, Naseem Shafai and Nighat Sahiba in the latter. I find the literary scene is bright.

Cab driver stabbed to death following dispute over Rs 400 fare in Delhi

New Delhi, Dec 20: A 26-yearold cab driver was stabbed to death by a passenger and his friends after they picked up a fight over the fare of Rs 400 in northeast Delhi's Sonia Vihar area, police said on Thursday. The incident took place on the intervening night of

December 17 and 18. Sandeep, who drove a taxi for Rapido, was found injured in a pool of blood at the roadside near Sonia Vihar Pusta, roliae acid in a ctatomort

police said in a statement. Sandeep told police that he brought three passengers --Deepanshu alias Ashu, Rahul and Mayank -- from Noida. After reaching Pusta 2 in Sonia Vihar, the ride was completed. Sandeep told police the accused did not want to pay the fare of Rs 400 and started fighting with him.

During the fight one of their associates Nikhil and a minor

allegedly stabbed Sandeep in his head and abdomen. Later, Sandeep succumbed to his injuries during the treatment, police said.

Deputy Commissioner of Police (northeast) Rakesh Paweriya said during investigation, the CCTV footage near the spot was checked. During further investigations, it was found that the cab was booked in the name of one Prateek.

"Prateek revealed that on December 17, he along with Deepanshu, Rahul , Mayank, Nikhil, and one minor met in Kondli where they consumed liquor. Thereafter, he booked a cab for Depanshu, Rahul and Mayank as they live in the Sonia Vihar area," Paweriya said.

At the instance of Prateek, Deepanshu was arrested and he disclosed that his friend Nikhil, who later joined them during the fight, allegedly stabbed Sandeep.

It ends on January 31 next year, but the cold wave continues with a 20-day long 'Chillai-Khurd' and a 10-day long 'Chillai-Bachha'.

department (MeT), Dr Mukhtar Ahmad told Kashmir Observer.

From December 23 to 24, a dry weather condition is expected in J&K followed by a light snowfall over higher reaches towards 27th late evening or night to 28th forenoon, he said, adding that the weather would remain generally dry on December 29 &30.

He added that the light snow is also expected at a few higher reaches on December 31st. Furthermore, the MeT in its advisory has said

that the cold wave is expected to continue at isolated to scattered places.

In view of fresh snowfall, sub-freezing temperature & icy conditions over roads of important passes and higher reaches, the tourists, travelers and transporters are advised to follow administration and traffic advisory.

Pertinently, Kashmir parts, mostly plains, are experiencing the prolonged dry spell

while the deficit rainfall in this season starting from October 01, 2024 to December 18, 2024 increasing to 78 per cent across Jammu and Kashmir. The increase in the deficit precipitation has been witnessed amidst no forecast of any major wet spell for the next ten days in Jammu and Kashmir.

Moreover, the MeT Director said the situation is expected to continue for the next few days, but the night temperatures would likely improve between December 27 and 31st.

"We have seen such conditions in the past as well and today the prolonged dry spell, snowfall in the higher reaches and the impact of La Nina is leading to the present situation," he said.

since June, with temperatures reaching 34°C. On July 3, 2024, Kashmir recorded a temperature of 35.6°C, the highest in the last 25 years.

"The dry spells have become longer, and the rains, when they come, are too heavy, washing away what little we have left. It's heartbreaking to see our fields barren," said Shakeela Begum, a grower from Pulwama.

Official data indicates that saffron production over the past two decades has decreased by 65 percent, dropping from 15.95 tonnes in 1990 to 2.6 tonnes in 2023-24. Additionally, the area under saffron cultivation has shrunk from 5,707 hectares in 1996-97 to 2,387.71 hectares in 2018-19.

In response to these challenges, the government introduced a drip irrigation system in 2010 as part of the Rs 412-crore National Saffron Mission to combat prolonged dry spells.

"The National Saffron Mission had good intentions, but the implementation faced technical and logistical challenges. We are working to address these issues," admitted an official from the Agriculture Department.

The ongoing crisis has serious implications

not only for the saffron growers but also for the regional economy. Saffron, often referred to as the "golden spice," is an integral part of Kashmir's agricultural heritage, and its decline threatens the livelihoods of thousands of farmers who depend on it for their income.

"We used to produce enough to support our families, but now, I have had to borrow money just to survive. This isn't just about saffron—it's about our lives," said Abdul Ghani, a seasoned grower in Budgam.

Climate experts have also weighed in on the issue. "The rising temperatures and changing rainfall patterns are not temporary. The government and farmers must adapt quickly to preserve this iconic crop," said Dr. Farooq Ahmad, a leading climate expert in the region.

The challenges faced by Kashmir's saffron farmers due to prolonged dry spells and climate change highlight the urgent need for effective government interventions and climateresilient farming practices.

"We have invested significantly in infrastructure and research, but changing climate dynamics require long-term and collaborative solutions. Farmers also need to adopt modern practices," said a senior official in the Horticulture Ministry.(inputs from KINS)

HC Quashes 2 PSA

detainees from the preventive custody forthwith provided they were not required in connection with any other case.

Sheikh was booked under PSA in terms of an order passed by District Magistrate Srinagar on August 30, 2022, while Dar was placed under "preventive detention" by virtue of an order issued by the Magistrate on 19.08.2019. "The unexplained delay in execution of the warrant of detention upon the petitioner renders the subjective satisfaction of the detaining authority doubtful. Consequently, the impugned order of detention has been rendered unsustainable in law", the Court said in response to one of the grounds raised by the detainee against his detention.

In reply to another ground of the challenge to the detention order, the court pointed out that the detainee could not be expected to make an effective and purposeful representation which is his constitutional right guaranteed under Article 22(5) of the Constitution of India, unless and until the material, on which the detention was based, was supplied to him.

"The failure on the part of detaining authority to supply the material renders the detention order illegal and unsustainable in law," the court said and quashed the detention against Sheikh. Similarly the court quashed the detention of Dar under PSA and ordered his release if not needed in any case.

Over 1 Lakh

Functions of Vehicle Scrapping Facility) Rules, 2021, and the Central Motor Vehicles Rules, 1989, ELVs are defined as vehicles that are either no longer validly registered, declared unfit through Automated Fitness Centres, or have had their registrations cancelled.

Vehicles not tested within 180 days of the last fitness test or the expiration of their fitness certificate also qualify as ELVs.

As per the rules notified by the Central government, these vehicles are to be scrapped at Registered Vehicle Scrapping Facilities (RVSFs).

The establishment of such facilities and strict enforcement of the scrapping process will not only reduce road hazards but also contribute to environmental sustainability by ensuring the responsible disposal and recycling of vehicle components.

Unending Saga Of Unscheduled Outages, **Distress Cuts In Kashmir**

SRINAGAR: With the onset of Chilay-Kalan-the 40 harshest winter days, people of many areas in Kashmir continue to face the unscheduled outages in both 'metered and non-metered' locales.

The electricity consumers of different areas said that the Kashmir Power Distribution Corporation Limited (KPDCL) was unable to cater the least expected services to them or were 'making concocted promises' which the DISCOM couldn't deliver.

One of the locals of Kani Mazar in Downtown, Furqan Faroog said that the area is facing

long durational power cuts. Although the Power Development Department (PDD) has installed smart meters in our area, we continue to face unscheduled power outages. It seems that KPDCL has either failed to deliver the promised electricity as per the ongoing curtailment schedule or is

making concocted promises to its consumers which the DIS-COM is unable to cater." He said, "In the bone chilling winters, we are being forced

to use frosty water.' Another local of Fateh Kadal, Imtiyaz Mir said, "Despite facing the extra power curtailment, the power voltage is extremely low during the peak

hours." "This year, the power curtailment has increased further in comparison to the previous years," Mir said, adding that, "We have a COPD patient at home and ironically the unscheduled power cuts and the low voltage are putting their lives at risk."



In the meantime, consumconsumers

One of the locals in Pulwama said, "Kashmir is reeling under intense cold for a month now and the authorities seem to least bothered about them in providing any sort of relief with regard to the unscheduled power cuts."

The residents of different places in north Kashmir and central Kashmir also expressed resentments against the unscheduled outages and extra curtailments.

Top officials of PDD informed KNO that, "Power demand is gradually increasing because of the intense cold weather conditions.'

"If there are any areas that are facing unscheduled power outages and distress cuts, we will work on streamlining the issue." the official said.

NGT Directs JKPCC To Provide List Of

The official further said, 'Recently, we have increased the power supply by 100 to 150 Megawatts (MWs). Besides, we are also working on minimizing the AT&C losses so that our consumers will get uninterrupted power supply as per the schedule program."

In order to minimize the unscheduled power and distress power cuts in Kashmir valley, the Power Development Department has recently increased the power supply by nearly 100-150 MWs.

"Recently, some important decisions were taken by the Chief Minister Omar Abdullah regarding the electricity issues in Jammu and Kashmir. We have implemented those decisions to reduce the power cuts," the official had said.

He said, "KPDCL was receiving 1500 MWs of power and now it has been further increased to 1600-1650 MWs to address the unscheduled and distress power cuts. The same amount of power is already being supplied."—(KNO)

Dr Murtaza Ahmad, a general physician at the Directorate of Health Services Kashmir erbate respiratory issues, particularly among children and

He said children and the elderly are more vulnerable due to weaker immune systems. "Children's immune systems are still developing, making them less effective at fighting off infections like colds, flu or pneumonia, while ageing leads to a decline in immune function, reducing the ability of elderly individuals to combat respira-

asthma or allergies are at higher risk of exacerbations during cold weather, while elders with

chronic illnesses such as diabetes, heart disease or emphysema are more susceptible to respiratory problems.

Dr Showkat further said that children's bodies are less efficient at maintaining core temperature. This, he said, increases the risk of hypothermia, which can worsen respiratory distress. Similarly, ageing reduces the body's ability to sense and respond to temperature changes and leads to complications.

Doctors have advised people to keep living spaces warm but well-ventilated to avoid indoor pollution, ensure children and elderly people dress in warm, layered clothing, provide a balanced diet with plenty of fluids and immunity-boosting foods, avoid outdoor exposure during extremely cold or foggy conditions and seek medical advice at the first sign of respiratory distress. They said children and elderly

persons should avoid unnecessary outdoor activities, especially during early mornings and late evenings when temperatures are lowest. "Maintaining hydration, nutrition, proper ventilation and vigilance for symptoms of hypothermia or frostbite-such as shivering, numbness, or confusion-is crucial," they added. "Immediate medical attention must be paid if these symptoms occur."

This matter came up for hearing before NGT's Principal Bench in New Delhi on 14.12.2024. The bench of Justice Prakash Srivastava (NGT Chairperson) and Dr Senthil Veil (Expert Member) while hearing the application filed by noted activist Dr Raja Muzaffar Bhat through his counsel Advocate Saurabh Sharma directed the Member Secretary J&K Pollution control Committee -JKPCC to file a comprehensive report disclosing the details of all the legal and illegal stone crushers operating in district Doda.

"He will supply an advance copy of the report to the counsel for the applicant, who, on

receipt of the same, will take appropriate steps to impede the concerned violating stone crushers and serve them. Respondent No. 5 (Member Secretary JKPCC) will also submit a report disclosing the extent of illegal mining and dumping of muck in the Chenab River, which is being done in the district concerned" reads the order.

The petitioner in the case Dr Raja Muzaffar Bhat raised the grievance against the illegal operation of about 10-12 stone crushers in district Doda J&K and alleged that these stone crushers are located near the banks of Chenab around Doda town within a radius of 5 to 6 km. The applicant has further alleged that illegal stone material is

excavated from surrounding mountains in the district of Doda on Doda-Kishtwar Road and Doda-Jammu Road, and this excavated material is used by illegal stone crushers.

The counsel of the petitioner Advocate Saurabh Sharma during the hearing informed the NGT bench that the illegal stone crushers are dumping muck into River Chenab and causing environmental hazards and also these stone crushers were causing air pollution in the area. He also said that Doda town falls under seismic zone and there were instances of land sinking in the past and illegal mining in mountains would have disastrous consequences in the area. The case is again listed for hearing on April 14th 2025.

The GDA CEO warned that nobody will be allowed to disturb Gulmarg's ecology. He urged local stakeholders and service providers to regulate their trade practices.

Govt Committed To Safeguard Kashmir's Handicrafts

SRINAGAR: The Jammu & Kashmir Government has assured to safeguard the interests of Kashmir's famed handicraft and handloom sector, which is directly linked to the livelihood of lakhs of artisans associated with the heritage craft, a spokesman said on Friday.

Responding to certain reports that have appeared in a section of the media with regard to proposed revision of tax slab in the upcoming GST Council meeting, a Government spokesman today clarified that the UT Government has already taken up the matter with the Union Ministry for Commerce & Industry, requesting therein for lowering the GST rate structure from existing 12% to 5% uniformly, including shawls priced above Rs.1,000, with the objective of reducing the tax burden on this artisan-driven industry and supporting marketability.

The spokesman described Handicrafts as a labourintensive industry which constitutes 80% of the human workforce. He further stated that all efforts shall be made to revive the handicrafts sector, keeping in view the stiff competition from global markets and machine-made imitations.

'Hormonal Imbalance, Sedentary Lifestyle Leading To Rising PCOD Cases In J&K'

SRINAGAR: Hormonal imbalance and sedentary lifestyles are some of the major reasons behind the rising cases of Polycystic Ovarian Disease (PCOD) in Kashmir, doctors said. However, with timely medication and lifestyle changes, PCOD can be managed effectively, they added. Dr Barjasta Bahar, a gyn-aecologist at DHSK said that PCOD occurs when the ovaries produce excessive amounts of male hormones (androgens), which leads to the formation of multiple cysts in the ovaries. "These cysts are immature follicles that fail to release eggs during the menstrual cycle, disrupting ovulation," she said. She added that the major

causes of PCOD are hormonal imbalances, such as excessive androgen production disrupting normal ovulation, poor diet, lack of physical activity, obesity, insulin resistance and genetic factors.

Dr Bahar said that PCOD can lead to infertility as difficulties in ovulation make it harder to conceive. It can also cause irregular periods, weight gain, acne, excessive hair growth and mental health issues.

Dr Rukhsana, another gynaecologist, said that PCOD has long-term health risks, including Type 2 diabetes, cardiovascular disease and endometrial cancer. "Regular exercise and a balanced diet help regulate hormones and insulin levels," she said,

on foods with a low glycemic index, such as whole grains, lean proteins and vegetables, and avoid processed foods and sugary snacks." Dr Rukhsana also underlined the importance of staying active, managing stress

and ensuring early diagnosis and regular monitoring to prevent complications. Doctors said that hormonal

therapy, insulin-sensitising drugs and other prescribed medications can help regulate periods and alleviate symptoms.

They said that PCOD is a manageable condition, adding that with lifestyle changes and timely medical interventions, women can reduce its impact on their lives and overall health-(KNO)

In Brisbane, some time before he accompanied skipper Rohit Sharma to the post-match press conference to announce his retirement at the end of the third Test, Ashwin was seen engaged in an emotional conversation with Kohli during which the batting maestro expressed his surprise even as the ace spinner wiped his eyes.

At the end of the conversation, which took place inside the Indian dressing room, both were seen hugging each other.

It was this dressing room discussion that sparked speculations about a possible retirement announcement by the seasoned spinner.

Ashwin landed in Chennai on Thursday and received a warm welcome from his family and friends.

During a glorious career, Ashwin featured in 106 Tests, picked up a whopping 537 wickets, including 37 five-wicket hauls, and scored 3,503 runs.

BCCI SGM To Elect Shah,

Shelar's Replacement On Jan 12 The BCCI will hold a Special General Meeting (SGM) I in Mumbai on January 12 to elect its new secretary and treasurer after the two posts were vacated by Jay Shah and Ashish Shelar respectively earlier this month.

The BCCI constitution states that any post lying vacant should be filled within 45 days by calling a Special General Meeting. The upcoming BCCI SGM will be held within 43 days of the deadline.

Shah has already taken over as the youngest chairman of ICC on December 1 and Shelar, a seasoned BJP politician, has been sworn in as a cabinet minister in the recently-formed Maharashtra government.

As per the Lodha Committee reforms accepted by the Supreme Court, one person can't hold two positions. Shah, who still had a year left in his BCCI tenure before the mandatory cooling off period, relinquished his post as required.

Shelar, who has been a Maharashtra BJP president, had to quit the BCCI post as Lodha Reforms do not allow any minister or public servant to be an officebearer.

Afghan Pacer Faroogi Fined For Showing Dissent



A fghanistan left-arm pacer Fazalhaq Farooqi has been fined 15 per cent of his match fee for showing dissent at an umpire's decision during the second ODI of the three-match series against Zimbabwe in Harare. Farooqi was penalised for breaching Level 1 of the ICC Code of Conduct.

The violation falls under Article 2.8 of the ICC Code of Conduct for Players and Player Support Personnel, which addresses "showing dissent at an umpire's decision during an international match."

The incident occurred in the fifth over of Zimbabwe's innings on Thursday when Farooqi showed dissent after an LBW appeal against Craig Ervine was turned down.

Farooqi gestured for a review despite the absence of DRS in the match.

In addition, one demerit point has been added to Farooqi's disciplinary record, for whom it was the first offence in a 24-month period. Farooqi admitted the offence and accepted the sanction.

MELBOURNE: Teenage sensation Sam Konstas was handed a maiden call up as Australia on Friday dropped rookie opener Nathan McSweeney for the final two Test matches of the Border-Gavaskar Trophy against India.

The 19-year-old is set to become Australia's youngest Test batting debutant in over 70 years.

If Konstas, who turned 19 on October 2, is selected in the playing XI in the Boxing Day Test, he would become Australia's youngest Test debutant since captain Pat Cummins, who was 18 years and 193 days old when he made his debut against South Africa in Johannesburg in 2011. The teenager would also become the youngest specialist batter to debut for Australia since Ian Craig when he played against South Africa at the MCG in 1953 aged 17 years 239 days. Konstas' inclusion follows a series of disappointing performances from the Australian top order in the first three Tests especially McSweeney. The 25-year-old, who made his Test debut in the series-opener in Perth, failed to score a single half century and could only manage scores of 10, 0, 39, 10 not out, 9 and 4 in his six innings and was dismissed by Indian pace Jasprit Bumrah spearhead four times.

Konstas had been in the reckoning to partner experienced Usman Khawaja after grabbing the attention of Cricket Australia's selection committee following his twin Sheffield Shield centuries for New South Wales.

He had scored an unbeaten 73 at the MCG against India A while notching up a ton (107) in the Prime Ministers XI pink ball game against India in Canberra.

Konstas' inclusion follows a warning from former pacer Merv Hughes, who cautioned selectors against making any changes to the batting lineup for the Boxing Day Test.

New Knockout Format For European Football Competitions Debuts

NYON: Ahead of the Champions League finishing its first-ever opening league phase in January, the new format for European competitions took shape Friday with the draw for knockout playoffs in the third-tier Conference League.

The 16 teams that placed from ninth to 24th in the single-league, 36-team standings that finished Thursday were paired in a seeded bracket like a tennis tournament.

Eight winners of two-leg playoffs on Feb. 13 and 20 will advance to the round of 16 scheduled in March, joining league leader Chelsea, third-place Fiorentina and the other top-eight finishers. Fiorentina lost in the past two finals of the Conference League.

The playoff pairings included Champions League regular Copenhagen hosting European newcomer Heiden-



heim, Gent hosting Real Betis, and Celje of Slovenia playing at home first against Cypriot club APOEL, which was a Champions League quarterfinalist in 2012.

Cyprus is the only country with three teams left in the competition and Friday's draw set up a domestic derby between Omonoia and Pafos. Shamrock Rovers is the

first Irish team to advance to the knockout stage of a UEFA competition and will play the first leg in Norway against Molde.

Molde's passage to the knockout phase was the most dramatic Thursday in the last round of the league phase.

Molde scored a stoppage-time goal to beat Mlada Boleslav 4-3 and rise from 27th to 23rd in the

standings. That goal also eliminated Mlada, which dropped to 27th, and Hearts which fell to 25th and was eliminated on the tiebreaker of total goals scored.

The Champions League and Europa League have their draws for the knockout playoff rounds on Jan. 31, after completing their eight-round league phase program that week.
