been recorded at the institute since 2014. According to details, a total of 5,200 new cancer registrations have been made at SKIMS Soura this year so far. Since 2014, the institute has docu-

mented 50,302 cases of cancer. The annual breakdown of cases shows 3,940 cases registered in 2014, 4,417 in 2015, 4,320 in 2016, 4,352 in 2017, 4,816 in 2018, 2024 (to date) 4,337 in 2019, 3,814 in 2020, 4,727 in 2021, Over 5,200 cases

# Freezing Temperatures Disrupt Life, Hit Water Supply

Srinagar: Minimum temperatures decreased at most places in Kashmir as the valley continued to reel under intense cold conditions, leading to the freezing of several water bodies and water supply lines in many areas.

Srinagar recorded a low of minus 7.3 degrees Celsius on Tuesday night -- down from the previous night's minus 6.6 degrees Celsius, the meteorological department said on Wednesday.

It has predicted a dip of two to three degrees in the minimum temperatures in Kashmir over the next two days.

Except in Gulmarg, the

#### **GOI Proposes To Extend Coal Act To J&K**

Srinagar: The Union Government has proposed amendments to the Coal Bearing Areas (Acquisition and Development) Act-1957 to make it applicable to Jammu & Kashmir.

According to the draft bill, the amendment proposes to omit the words "except the State of Jammu and Kashmir." The Coal Bearing Areas (Acquisition and Development) Amendment Bill, 2024, proposes to extend the law to Jammu & Kashmir, which was previously excluded.

According to reports, the Union Ministry of Coal has written to all states and Union Territories, inviting comments from the public and State Governments on the proposed amendments. Following the Union Ministry's communique, the J&K's Department of Law, Justice, and Parliamentary Affairs has written to the Commissioner Secretary of the Mining Department to submit their comments on the matter directly to the Union Coal Ministry.



## **Trial Run Successful** On Katra-Reasi Track

Srinagar: As Kashmir prepares to be connected to the rest of India by rail, Northern Railway is putting the final touches on the groundwork, bringing the long-awaited project closer to completion.

As a part of the preparations a successful train run, comprising an engine and goods train, was conducted on the 17-kilometer Katra-Reasi track on Wednesday. "Another trial run of a tower wagon was also conducted on India's first cable-stayed railway bridge at Anji Khad, which is part of the USBRL (Udhampur-Srinagar-Baramulla Rail Link) project," a senior Railway official said.

"The engine trial train ran at 30 km/h, and the goods train at 20 km/h. The trial will continue until the final inspection," he added.

# Switching Off From Work Can Be Difficult But Taking Proper Break Is Good For Your Health

t's never been easier to stay connected to work. Even when we're on leave, our phones and laptops keep us tethered. Many of us promise ourselves we won't check emails during our break. But we do.

Being away from the workplace, and even in a new location, is often not enough to detach psychologically. We might still be thinking about a demanding project we raced to finish or even feel guilty about leaving others to cover for us.

#### 'Digital presenteeism'

It mightn't be spelt out by our employers but having phones and laptops can create an underlying expectation we are constantly available, even outside the usual work hours.

This feeling of connection or "digital presenteeism", can impact our

ious and burnt out.

Switching off our work tools when we are out of the office or on leave can remove these problems as well as helping improve and enjoy our non-work activities and relationships.

#### Right to disconnect

While recently passed right to disconnect laws in Australia legally support workers to switch off, there's another option already available to workers. Taking annual

Unfortunately, many workers don't take advantage of this valuable resource, with an estimated 160 million annual leave days banked up by Australian workers. One in five have more than the typical yearly allocation of four weeks unused.

#### The benefits of taking a break

Taking a break doesn't just feel good, it's been shown to benefit your health.

A 2017 meta-analysis of 86 studies



revealed taking holidays can lead to reduced stress and less exhaustion during the holiday period.

So what do we do with all the extra time we have? Sleep more? Do more exercise? Studies show that's exactly what happens when we are on holiday. We studied movement patterns of 375 adults during annual leave. We found people were more physically active, less sedentary and had more sleep each day - all of which are good for our health.

Holidays can also be associated with changes in how our body functions. A study of 112 holiday makers who attended a wellness resort for six days in the United States had increased heart rate variability which indicates greater resilience to stress.

Also, the odds of meeting metabolic syndrome criteria decreased with each break taken each year in a cohort of workers who took on average five holidays each year. If you're male and still not con-

taking holidays is linked with living longer. Men who take more frequent holidays and more leave days a year have lower mortality rates than those who don't?

#### The best type of break?

Simply taking leave is beneficial. Longer breaks do not have increased benefits and where you go is also unimportant.

A study of locations found those who took a short four day break in a hotel did not benefit more than those who took a break at home. Both groups showed positive changes to stress, recovery, strain and wellbeing.

In our study, the largest favourable changes were experienced by people who took one to two weeks' leave or those who spent time outdoors camping or hiking. However positive changes were observed for all types of holidays. Ultimately, the best vacation is the one that fits your preferences and budget - there's no such thing as a

If you haven't already, book some time off and get away from the workplace. Here are five ways to make the most of the time:

1. Finish up your to-do list and clear out your inbox: returning to work after a summer holiday with fewer unfinished tasks allows the positive effects of the holiday to linger longer.

2. Step away from the normal routine: try to limit work-like activities (such as shopping, cleaning, computer-based tasks) and find environments that feel removed from your typical routine and obligations.

3. Engage in "soft fascination" activities: exploring nature is an example of an activity that gently holds your attention while leaving headspace for reflection. These types of activites have been shown to provide restorative mental benefits.

## Study Finds Baby's First Sounds Directly Linked To Changes In Heart Rate

baby's first sounds and attempts to form words could be signs that their heart is working in sync with developing speech, according to a study that found that they were directly linked to each other.

Researchers from the University of Houston, US, explained that for infants, producing recognisable speech is more than a cognitive process -- it is a motor skill requiring a coordination of many muscles performing varied functions throughout their body.

This coordination is directly linked to fluctuations in heart rate, they said. "Thus, for the developing infant, heart rate fluctuations align with the timing of vocal productions, and are associated with their duration and the likelihood of producing recognisable speech," the authors wrote in the study published in the journal Proceedings of the National Academy of Sciences.

The findings are important for understanding how language develops and



potential early indicators of speech and communication disorders, they

For the study, the researchers analysed over 2,700 sounds of varying dynamics -- such as a laugh, babble or a coo -- made by 34 infants, aged 18-27 months old and who did not speak

whole words yet. The team found that changes in heart

rate were in line with the timing and duration of sounds.

"Heart rate naturally fluctuates in all mammals, steadily increasing then decreasing in a rhythmic pattern. It turns out infants were most

likely to make a vocalisation when their heart rate fluctuation had reached a local peak (maximum) or local trough (minimum)," author Jeremy I. Borjon, an assistant professor of psychology at the University of Houston, said.

"Vocalisations produced at the peak were longer than expected by chance. Vocalisations produced just before the trough -- when the heart rate is decelerating -- were more likely to be recognised as a word by na ve listeners," Borjon. About 10 per cent of the sounds analysed were found to be reliably identified as words by naive

The researchers explained that the first few years of one's life are marked by significant changes in how the heart and lungs function -- known to be controlled by the autonomic nervous system.

"The relationship between recognisable vocalisations and decelerating heart rate may imply that the successful development of speech partially depends on infants experiencing predictable ranges of autonomic activity through development," Borjon said.

## Unite For Equitable **Job Quotas**

he National Conference leader and Member Parliament Ruhullah Mehdi's protest outside the Chief Minister Omar Abdullah's residence on Monday has triggered rumblings within his party with some NC leaders accusing the MP of going against his own party. Salman Sagar, the party's first time MLA has termed Ruhullah's protest a breach of the party discipline, and reminded him that no one was above the party including the chief minister. However, Ruhullah responded sharply, issuing a strong yet vague statement, metaphorically likening NC leaders to 'house slaves' and 'field slaves,' identifying himself with the latter.

Ruhullah's protest against his own party was over unfair job quotas, 70 percent of which have been granted to marginalized groups comprising less than 30 percent of the population. Significantly, Ruhullah was supported in his protest by the opposition parties like the PDP and the Awami Ittehad Party. Actually, the protest was a part of Ruhullah's campaign promise to the open category unemployed youth of the Valley. He had earlier assured them of the NC government's action on the equitable job reservation for the general category population within the first two months of assuming the power, promising to protest against his own government if it failed to deliver. He fulfilled the promise, and, in the process, brought much-needed attention to what is one of the most urgent issues facing the government.

J&K has now just 30 percent reservation quota for the open merit category. The reduction followed the LG administration's decision early this year to raise reservation for Paharis by 10 percent and that of the other tribes and the Other Backward Classes by 8 percent. According to the 2011 census, 69 percent of the Valley's population falls under the general category, which includes those not classified under Scheduled Castes, Scheduled Tribes, and Other Backward Classes. But while reservations in the rest of the country have been capped at 50 percent, in J&K, they have been fixed at 70 percent.

Not that the NC-led government is not seized of the matter. To be fair to the chief minister, he has promised action. Soon after taking over, he formed a cabinet sub-committee to look into the matter. The committee has been tasked to give its report within six months. Omar also met a student delegation representing the protesters to assure them of justice. Ruhullah's protest, which he was duty-bound to register the foreground. It were promises like these that earned the NC the faith of voters, so Ruhullah can't be blamed for keeping it. However, through it all, it is important that the NC stays strong and united. This alone will enable the party to steer Jammu and Kashmir through its challenging political landscape, address grievances and champion the aspirations of the people.

## **Reservation in Jammu & Kashmir: The Other Side**

ne subject of reservation in Jammu & Kashmir has once again become a focal point of public debate and political discourse. The framework introduced earlier this year through S.O. No. 176 dated 15th March 2024, aimed at addressing longstanding socio-economic disparities, is now a topic of contention. While its intent was to ensure inclusivity and fairness, objections raised months after its implementation suggest deeper motives, possibly more political than social. The time has come to evaluate the policy with clarity and reason.

#### The Reservation Framework

The reservation policy seeks to distribute opportunities equitably among all sections of society. It is designed to allocate resources in a balanced manner, addressing the needs of marginalized communities without alienating others. The policy is structured into four categories:

#### 1. Category A: Specific Reservations for Marginalized Communities (36%)

- Scheduled Castes (SC): 8%
- Other Backward Classes (OBC): 8% Scheduled Tribes (ST-1): 10%
- Scheduled Tribes (ST-2): 10%

#### 2. Category B: Common Reservations for All (24%)

These are applicable to both the general and reserved categories.

- Residents of Backward Areas (RBA):
- Areas Along the Line of Control (ALC): 4% Economically Weaker Sections (EWS): 10%
- **Total: 24%**

#### 3. Category C: Horizontal Reservations (10%)

These apply across all categories (A, B, and D).

- Ex-servicemen: 6%
- Persons with Disabilities (PW Total: 10%

#### 4. Category D: General Category (30%

#### Inclusion of Newly Recognized Groups

In a significant move, an additional 10% reservation has been provided for underrepresented groups, including the Paddari Tribe, Pahari Ethnic Group, Gadda Bregmans, and Koli communities. Importantly, this inclusion was achieved without affecting the existing 10% quota for Scheduled Tribes, reflecting the government's intent to uplift marginalized communities without compromising existing entitlements.

The Emerging Controversy

raises questions about whether the protests are genuinely in the public interest or politically motivated to secure voter support.

Politicizing sensitive issues such as reservation risks disrupting social harmony. The matter is currently under judicial review and being assessed by a Sub-Cabinet Committee, making premature protests unnecessary and potentially harmful.

#### Unemployment: The Real Challenge

Jammu & Kashmir faces a pressing unemployment crisis, with a jobless rate of 32.8%, the highest in India as reported by the Centre for Monitoring Indian Economy (CMIE). In rural and remote areas such as Marwah, Paddar, Warwan, Dudu, Bani, and Bhalessa, the situation is dire, with poor infrastructure, inadequate education, and limited job opportunities.

The amendment in J&K Reservation Rules, 2005 by the Jammu and Kashmir government approved 10% additional reservations for the Scheduled Tribe (ST) category and slashed the reservations of general or OM category to mere 40%. With this move, the total reservations of ST category has now gone up to 20%. This move has shattered the aspirations of numerous open merit students who burn their midnight oil to secure a government job or to get admission in higher educational institutes.

It is clear that about 60% of the seats are reserved for the candidates belonging to SCs, STs, OBCs, and EWSs etc which can be filled only by candidates from the same categories while 40% of the seats are available for general category. Navigating the Crossroads of Religion and Education in India



A British-American author and critic of religion, Hitchens proclaimed that religious indoctrination, together with education, should not be mixed together. In his book God Is Not Great, he declared that religious teachings often clash with science and ethics, which led to an education of scientific thought and view.

Quite vocally regarding postulates about the relationships of religion and education did the German philosopher and economist, Karl Marx. His most influential essay, A Contribution to the Critique of Hegel's Philosophy of Right (1843), includes the statement that religion is "the opium of people." This simply means that, although very popular, religion often acts as a source of pacification, controlling the masses and not letting them ask questions about the realities around them in society and political life. Marx would believe in the propagation of inequalities through religious teachings. He would see the dangers of such teachings away from the social change the people needed. Marx advocated for a secular system of materialist education, one that would satisfy man's desire to understand the world in line with scientific analysis and critical thinking. It was through education of people for Marx that a person was to be liberated from religious illusions and was to become aware of the material conditions of life, which could in this manner transform into social and political activities.

It is an undeniable fact that religion is the greatest inspirer of values and also the highest moral guide. When religion comes into formal education in a slightly excessive manner, it would asphyxiate students' development. Education for India must go forward as a secular, inclusive, and intellectually powerful society only if this serves to strengthen the secular element that combines scientific inquiry and critical thinking with religion and religious teachings kept strictly in the personal or cultural context. Education that values and supports diversity but gives objective, evidence-based facts can actually give students the sensibilities to be well-grounded open-minded citizens in today's

artificial intellinew gence (AI) model has just Lachieved human-level results on a test designed to measure "general intelligence"

On December 20, OpenAI's o3 system scored 85% on the ARC-AGI benchmark, well above the previous AI best score of 55% and on par with the average human score. It also scored well on a very difficult mathematics test.

Creating artificial general intelligence, or AGI, is the stated goal of all the major AI research labs. At first glance, OpenAI appears to have at least made a significant step towards this goal.

While scepticism remains, many AI researchers and developers feel something just changed. For many, the prospect of AGI now seems more real, urgent and closer than anticipated. Are they right?

#### Generalisation and intelligence

To understand what the o3 result means, you need to understand what the ARC-AGI test is all about. In technical terms, it's a test of an AI system's "sample efficiency" in adapting to something new - how many examples of a novel situation the system needs to see to figure out how it works.

An AI system like ChatGPT (GPT-4) is not very sample efficient. It was "trained" on millions of examples of human text, constructing probabilistic "rules"

about which combinations of words are most likely.

The result is pretty good at common tasks. It is bad at uncommon tasks, because it has less data (fewer samples) about those tasks.

Until AI systems can learn from small numbers of examples and adapt with more sample efficiency, they will only be used for very repetitive jobs and ones where the occasional failure is tolerable.

The ability to accurately solve previously unknown or novel problems from limited samples of data is known as the capacity to generalise. It is widely considered a necessary, even fundamental, element of intelligence.

#### **Grids and patterns**


The ARC-AGI benchmark tests for sample efficient adaptation using little grid square problems like the one below. The AI needs to figure out the pattern that turns the grid on the left into the grid on the right.

Each question gives three examples to learn from. The AI system then needs to figure out the rules that "generalise" from the three examples to the fourth.

These are a lot like the IQ tests sometimes you might remember from school.

#### Weak rules and adaptation

We don't know exactly how OpenAI has done it, but the results suggest the o3 model is highly adaptable. From just a few examples, it finds rules that can be generalised.



To figure out a pattern, we shouldn't make any unnecessary assumptions, or be more specific than we really have to be. In the-ory, if you can identify the "weakest" rules that do what you want, then you have maximised your

ability to adapt to new situations. What do we mean by the weakest rules? The technical definition is complicated, but weaker rules are usually ones that can be described in simpler statements.

In the example above, a plain English expression of the rule might be something like: "Any shape with a protruding line will move to the end of that line and 'cover up' any other shapes it overlaps with.

#### **Searching chains of thought?**

While we don't know how OpenAI achieved this result just yet, it seems unlikely they deliberately optimised the o3 system to find weak rules. However, to succeed at the ARC-AGI tasks it must be finding them.

We do know that OpenAI started with a general-purpose version of the o3 model (which differs from most other models, because it can spend more time "thinking" about difficult questions) and then trained it specifically for the ARC-AGI test.

French AI researcher Francois Chollet, who designed the benchmark, believes o3 searches through different "chains of thought" describing steps to solve the task. It would then choose the "best" according to some loosely defined rule, or "heuristic".

This would be "not dissimilar" to how Google's AlphaGo system searched through different possible sequences of moves to beat the world Go champion.

#### What we still don't know

The question then is, is this really closer to AGI? If that is how o3 works, then the underlying model might not be much better than previous models.

The concepts the model learns from language might not be any more suitable for generalisation than before. Instead, we may just be seeing a more generalisable "chain of thought" found through the extra steps of training a heuristic specialised to this test. The proof, as always, will be in the pudding.

Almost everything about o3 remains unknown. OpenAI has limited disclosure to a few media presentations and early testing to a handful of researchers, laboratories and AI safety institutions.

Truly understanding the potential of o3 will require extensive work, including evaluations, an understanding of the distribution of its capacities, how often it fails and how often it succeeds.

When o3 is finally released, we'll have a much better idea of whether it is approximately as adaptable as an average human.

If so, it could have a huge, revolutionary, economic impact, ushering in a new era of self-improving accelerated intelligence. We will require new benchmarks for AGI itself and serious consideration of how it ought to be governed.

If not, then this will still be an impressive result. However, everyday life will remain much the

#### **SKIMS Records**

There have been many cancer-related deaths in Jammu and Kashmir, with 35,623 fatalities recorded between 2018 and 2022. These include 6,824 deaths in 2018, 7,003 in 2019, 7,189 in 2020, 7,211 in 2021, and 7,396 in 2022.

A study conducted by SKIMS in 2012 said the rising incidence of cancer is due to dietary practices, lifestyle choices and the consumption of foods with high salt content.

Kashmir Observer in March, this year, tried to uncover what exactly is causing a spike in cancers? Is there something we're eating, something we're ingesting, some combination of factors that are modern and harmfulwhich is resulting in these increased cancers?

Dr. Abdul Hamid Samoon, Associate Professor, Department of Minimal Access and General Surgery, GMC Srinagar told Kashmir Observer that the trend of malignancies is rising worldwide, and a similar pattern is witnessed in Kashmir. Cancer happens when the body's cells grow uncontrollably and spread to other parts of the body where these cells can form tumours or invade nearby tissues and organs, leading to serious health issues and these cancerous cells can divide rapidly and disrupt the body's normal function, making it difficult for the immune system to combat them effectively.

Presently, there's an increase in upper gastrointestinal (GI) cancers or stomach cancers, largely attributed to our dietary habits. While there's no definitive genetic or proven cause behind this trend, our dietary patterns play a significant role in driving the increase in malignancies, Dr. Samoon

He pointed out that alongside upper GI cases, colorectal cancers are also on the rise in the valley, especially among the younger population. "It's concerning because cancers tend to be more aggressive in younger patients, affecting their prognosis adversely compared to older individuals. Likewise, in females, there's a significant rise in breast cancers, often associated with genetic factors and familial history," Dr. Samoon had told Kashmir Observer.

Professor of Surgery, Government, Medical College Srinagar, Dr. Iqbal Saleem said the rise in cancer cases can be attributed to changes in our food habits and lifestyle.

"Furthermore, the overuse of fertilizers and pesticides is also a major contributing factor for cancers. The indiscriminate use of these chemicals. driven by the desire for quick profits, results in them entering the food chain and ultimately reaching humans. This has led to alterations in genetic makeup, which in turn contribute to cancerrelated issues." Dr. Saleem said.

Data shows that with the introduction of high-density apple crops of huge economic value, pesticide use also increased threefold in the last 12 vears, especially in Shopian, Pulwama Kulgam and Anantnag districts of South Kashmir. "Consequently, orchardists in these regions are regularly exposed to pesticides. The majority of cancer cases in these areas are attributed to this pesticide exposure. It is plausible to speculate that there is a correlation between the use of pesticides and the incidence of cancer in these communities," the health expert said

A senior oncologist at SKIMS said that there are numerous risk factors for

cancer including hormonal, hereditary, metabolic, autoimmune etc. "External causes of cancer include smoking, alcohol consumption, dietary imbalance (malnourished or obese), radiation or infections like Human Papilloma Virus (HPV), Hepatitis B Virus (ĤBV), Human Immunodeficiency Virus (HIV), H Pylori etc," he said. Independent weather forecaster Faizan Arif said that he he believes that there is a possibility that lowlevel clouds might develop during the morning hours and persist until the afternoon, particularly in the plains of

The city was colder than Gulmarg, where the mercury settled at a low of minus 6.6 degrees Celsius, up from minus 7.4 degrees Celsius the previous night, the department added.

Pahalgam registered a minimum temperature of minus 8.4 degrees Celsius, down from the previous night's minus 7.8 degrees Celsius, it

It ends on January 30 next year, but the cold wave continues even after that in the valley. The 40 days are followed by a 20-day 'Chillai-Khurd' (small cold) and a 10-day 'Chillai-Bachha' (baby cold).

While giving the details of the upcoming railway operations on the Udhampur-Srinagar-Baramulla Rail Link officials said that from January 5 to January 6, 2025, statutory inspections will be conducted for the opening of the Katra-Reasi (16.501 km) section. "This section is part of the Udhampur-Srinagar-Baramulla New Broad Gauge (B.G.) Rail Link Proiect. The inspection will start at 20:50 hrs on January 5 and conclude at 07:55 hrs on January 6," they added.

The Commissioner of Railways Safety (CRS) is expected to submit an inspection report to the Union Government on January 8.

It is in place to mention here that the Phase-I of the Udhampur-Srinagar-Baramulla Rail Link (USBRL) Project, covering the 118-km-long Qazigund-Baramulla section, was inaugurated in October 2009. Subsequent phases included the inauguration of the 18-kmlong Banihal-Qazigund section in June 2013 and the 25-km-long Udhampur-Katra section in July 2014.

In February, the first electric train trial run on the Banihal-Katra section of the USBRL project was successfully conducted on approximately 40 km of track and tunnels between Banihal and Sangaldan Railway Stations in Ramban district.

The USBRL Project involves 38 tunnels with a combined length of 119 km. The longest tunnel, T-49, measures 12.75 km, making it the country's longest transportation tunnel. The project also includes 927 bridges with a combined length of 13 km.

Among these is the iconic Chenab Bridge, with an overall length of 1,315 m, an arch span of 467 m, and a height of 359 m above the riverbed. This bridge stands about 35 meters taller than the Eiffel Tower and is recognized as the world's highest arch railway

#### Kashmiri 'Kandur Roti' Price **Hike Fuels Anxiety Among Low-Income Families**

SRINAGAR: The recent doubling of the price of Kashmiri "Kandur Roti," a staple food item in the region, has triggered strong reactions from both bakers and residents, particularly among those facing economic challenges.

Traditionally sold at Rs 5, the bread is now priced at Rs 10, a change that has raised concerns throughout the Valley, especially among the poor.

Sofi Abdullah Majeed Pampori, president of the Kashmir Bread Makers and Bakers Union, defended the price hike, stating that it was necessary due to the rising costs of key

ingredients like ghee and flour. He explained that after extensive discussions, the decision was made to adjust the prices in response to mounting

operational expenses, and it had been communicated to the authorities.

However, many residents, particularly those in lowerincome groups, have voiced their displeasure over the price increase. Kulsum Jan, a local from Beerwah, expressed her frustration: "We can't afford to spend Rs 50 for five rotis, which used to cost just Rs 25. A small increase would have been manageable, but this is an excessive hike."

Sajad Ahmad, another resident from Srinagar, added that the new price is unaffordable for many, especially those earning between Rs 200 and Rs 300 a day. "This price hike is hitting us hard, particularly during the harsh winter. I urge the government to step in and set a fair price that everyone can afford," he said.(KINS)

# Kashmir Reports 18 Dog Bite Cases Daily

**SRINAGAR:** With an alarming average of 18 dog bite cases reported daily, stray dogs continue to pose a significant threat across Kashmir.

Official data accessed by news agency KINS reveals that the valley registers around 6,000 to 6,500 dog bite cases annually; indicating 18 cases of dog bites are reported daily.
A senior official from the

Srinagar Municipal Corporation (SMC) stressed the urgent need to manage the growing stray dog population. "Open garbage points must be closed, as they attract dogs, especially due to poultry waste. Responsible waste disposal is crucial for public safety," the official said, urging residents to remain vigilant, particularly for children and the elderly. Residents across the valley

report rising fear and inconvenience due to stray dogs. Mushtaq Ahmad from Batamaloo expressed frustration



over the authorities' inaction. "Children are scared to attend school, and the issue remains unresolved," he said.

In Nowpora, Bashir Ahmad shared his ordeal, stating, "After sunset, we are confined to our homes due to the stray dog menace. I have even stopped attending prayers at the mosque during early morning and evening hours."

The situation is equally dire at healthcare facilities and educational institutions. At Jawahar Lal Nehru Memorial Hospital (JLNM), Rainawari, and Shri Maharaja Hari Singh Hospital (SMHS), stray dogs roam the premises, often chasing attendants bringing food for patients.

"Dozens of dogs inside the hospital compound terrify us. We avoid stepping out due to the constant threat," said Mushtaq Ahmad, an attendant at SMHS Hospital. Similar issues plague SKIMS Soura and Kashmir University, where stray dogs freely roam within the premises. (KINS)

#### Fire Safety Alert

#### **JKDMA Issues Life-Saving Winter Guidelines**

**SRINAGAR:** With temperatures plummeting in Kashmir valley, Jammu & Kashmir Disaster Management Authority (JK-DMA) has issued critical fire safety guidelines, stating that fire incidents were on the rise in the region during the winters.

IKDMA has urged people to prioritize safety measures to protect lives and property from fire incidents during the harsh winter months.

Sharing the fire safety guide-lines, JKDMA has advised to install smoke detectors and smoke alarms in all buildings, stating that its functioning can increase survival chances by 50 per cent.

With regard to electrical safety, the guidelines have advised to avoid running electric wires or cords under carpets or in high- foot traffic areas.

For children safety, guidelines have keeping matches and lighters locked away from children. The guidelines have advised placing extinguishers at strategic locations, ensuring that they are functional, and training household members to use them during emergencies.

In another set of guidelines issued by JKDMA with regard



to the response to facing or getting caught up in a fire incident, it has asked to stay calm and to evacuate immediately and call emergency services. The guidelines have advised not to re-enter the building.

In case the clothing catches fire, the guidelines have advised to drop to the ground and roll to extinguish flames. It has advised to avoid running, stating that the air will 'accelerate' the burning.

The guidelines have mentioned that a shower can also quickly douse flames.

The JKDMA in the guidelines have stressed the of fire safety education to mitigate risks during winters, when reliance on heating devices increases significantly.

The advisory has asked to ensure proper ventilation, not leaving heating devices unattended, and keeping flammable materials away from heat sources are essential practices.

## 'Helminthic Infection, Not Taking Iron Rich **Diets Main Reasons Of Anemia'**

SRINAGAR: Helminthic infections and not eating a balanced or iron rich diet are the main reasons behind the increasing prevalence of anemia among children, the health experts said.

Several doctors said that the regular deworming is very important for both kids and adults and can be taken in any season.

Dr Rukhsana, a gynaeco-logist at DHSK said that the main cause of anemia in children is Helminthic infection. She said that intestinal helminth infection in a concomitant state of malnutrition is observed among children. "Helminthic infections.

caused by parasitic worms, can contribute to anemia through various mechanisms. These parasites can affect the host's nutritional status, impair iron absorption, and induce chronic inflammation, all of which play crucial roles in the development of anemia," she said.

Dr Shugufta, another gynaecologist at DHSK said that helminthic infections are parasitic infections caused by helminths, which are a group of multicellular

worms and may lead to nutrient competition, impaired iron absorption, blood loss, inflammation response and other issues.

She said that there is a misconception that deworming can't be done in winters but it can be given any season at regular intervals but most of the children aren't being given it that also leads to anemia.

"Deworming helps to remove worms and any infection that might disturb the patient and it is important for those infected by these worms," she added. Doctors said that diet plays

a crucial role in the prevalence of anemia among children as the insufficient dietary iron is a primary cause

They said adequate intake of vitamin B12 and folate, nutrient-rich foods, breastfeeding and complementary foods, dietary diversity, hygiene and food safety are main things that play a role in preventing anemia among children.

Doctors said that children, who have worms, always feel tired because of malnutrition and anemia while they can have impaired physical

They said that there is no need to panic as worm infection is easy to control but parents must keep vigil on their children and monitor their growth and other behavior as well, adding that untreated worm infections

prevent children's healthy

growth, cause poor nutrition

and cognitive development.

and reduce their capacity to concentrate and learn. "The treatment is simple, safe, effective and free of charge. A single dose of deworming treatment drastically reduces the number of worms in each child," they

Worm infections can cause various health problems, including anemia, abdominal distention (swelling) or severe abdominal pain, diarrhoea, etc. It can also cause loss of appetite, malnourishment, impaired mental and physical development as well as tissue damage that may require corrective surgery." Doctors said.

"Deworming improves your child's immunity, and thereby protecting him/her from chronic illnesses caused by worms, improves concentration and attendance, making them more productive in

school, increases nutrient uptake and controls infections such as anemia, loose bowels, improves work potential and livelihood opportunity and can help in reduction of worm infection in the community," they said.

Notably, as per NFHS-5, about three-fourths (73%) of children aged 6-59 months are anaemic. This includes 25 percent who are mildly anaemic, 44 percent who are moderately anaemic, and 4 percent who have severe anaemia.

"The overall prevalence of anemia in children increased from 43 percent in NFHS-4 to 73 percent in NFHS-5. There is a slight difference in the prevalence of anaemia among girls (71%) and boys

(71%) in NFHS-5," it said. Children of mothers who have anaemia are much more likely to be anaemic. Although anaemia levels vary somewhat according to background characteristics, anaemia among children is

widespread in every group.
As per NFHS-5 three-fourths (74%) of children in Jammu & Kashmir are anaemic even if their mother has 12 or more years of schooling-(KNO)

#### 9 Drug Peddlers **Arrested In Kashmir**

**SRINAGAR:** In its tireless efforts to eradicate the menace of drugs from the society, Police on Wednesday said to have arrested nine drug peddlers in various districts of Kashmir valley and recovered contraband & psychotropic substances from their possession.

During the search, a substantial quantity of contraband substances was recovered from their possession, a police spokesman said in a statement.

"Let's not worry about that. I think who bats where, we should be discussing that within ourselves and I shouldn't be answering this question in every press conference," the skipper just about held his composure.

CENTURION: South Africa will be eyeing a place in the World Test Championship final with an all-seam attack against Pakistan in the first test, starting Thursday.

The Proteas need to win one of its remaining two test matches in this WTC cycle to guarantee a place at the Lord's final next year and captain Temba Bavuma believes expectations have risen in his team to do well in the two-test series.

"There'll be pressure that comes with that," Bavuma said. "But to be honest with you we're coming into the series to win the series 2-0. We understand that for us to do that, there's certain things that we need to do as a team: keep things simple, keep doing the small things right, and allow the results to take care of itself."

South Africa has included four fast bowlers in the lineup with Corbin Bosch, who consistently bowls above 140 kph, set to play his first test at his hometown. Seasoned fast bowlers Kagiso Rabada and Marco Jansen will team up with Dane Paterson and Bosch to challenge Pakistan's batters on an expected pacey Centurion pitch where fast bowlers have a clear advantage over the last six years, picking up 227 wickets with spinners dismissing only 16 batters.

Heading into the tests, South Africa's top-order batters did struggle against Pakistan in a rare 3-0 ODI whitewash with Tony de Zorzi, Ryan Rickelton and Tristan Stubbs all failing to read the offspin bowling of Salman Ali Agha in the opening game of the series.

Pakistan has long been struggling in test matches in South Africa, losing 12 and winning just two of the 15 test matches since it first toured the country in 1995. Pakistan's below-par show in South Africa includes its lowest test score of 49 at the Wanderers in 2013.

Pakistan is lying at No. 7 in the ITC points table and Aagib Javed is its fourth head coach in this WTC cycle with Mickey Arthur and Mohammad Hafeez quitting after one series. Jason Gillespie resigned just two weeks before Thursday's test

Shaheen Shah Afridi, who played in the preceding white-ball series in South Africa, has been surprisingly left out for the test matches.

Naseem Shah and Babar Azam return to the test fold after missing the last two home tests against England while selectors have recalled seamer Mohammad Abbas after three years with the left-arm seam option of Mir Hamza in the squad. Abbas took 90 wickets in 25 test matches from 2017 to 21 before he ran out of selectors' favor.

#### World Cup Triumph; T20 Farewell To Rohit And Kohli

The Indian cricket team and its unparalleled fan base were desperate for an ICC trophy after repeatedly faltering in the knockout stages over the past decade, most recently in the ODI World Cup final at home last year.

The trophy finally came home after Rohit Sharma and Co. played a near perfect tournament to become the T20 World Cup champions in the USA and the Caribbean.

India's clarity of thought throughout the one-month long event was remarkable and with a little bit of luck on their side, especially in the final at Barbados, they were able to go the distance.

On undercooked pitches in New York, they were pace heavy before unleashing their trump card Kuldeep Yadav from the Super 8 stage of the tournament. India picked as many as four

A better script could not have been written for the likes of Rohit and Kohli, who got to say goodbye to the T20 format with the coveted trophy in their hands. It was also a fitting farewell for head coach Rahul Dravid, whose tenure drew to a close.

#### **Change Of Guard In Coaching; Surya's Unexpected Elevation**

With Rohit calling it a day, it was expected that Hardik will lead the T20 side into the transition phase, having captained the side in the former's absence.

However. Dravid's successor

Gautam Gambhir had a different line of thinking as he played a major hand in elevating India's best T20 batter Suryakumar to the leadership position ahead of the series in Sri Lanka.

To be fair to Suryakumar, the team has ticked all the boxes since he took over, also witnessing the rise of Tilak Verma and rebirth of the likes of Sanju Samson and Varun Chakaravarthy.

All three were simply sensational in India's recent T20 series in South Africa. Alongside Samson, Abhishek Sharma has also shown the talent and resolve at the top of the order and could serve India for long.

#### **India Hit Rock Bottom Against**

While India moved on from the mighty duo of Rohit and Kohli in the shortest format rather quickly, the same is unlikely in the Test team.

The chatter around the future of senior players in the Test team has gained momentum after India's first whitewash at home in a three-match series and more recently, the sudden retirement of premier off-spinner R Ashwin. India's loss to New Zealand in their own backyard was easily one of the most embarrassing outcomes for the team in Test cricket over the past decade. Having slayed 'Bazball' ear-

lier in the year against England, India blanked Bangladesh and were expected to hand out a similar treatment to the visiting Black Caps.

However, in a stunning turn of events, the spirited Kiwis outbatted and out-bowled Rohit and Co. to script their biggest series wins overseas

The Indian batters' weakness against the turning ball was exposed threadbare and the duo of Ashwin and Jadeja, who run through sides for fun at home, were bettered by Mitchell Santer and Ajaz Patel.

It was only after landing in Australia, Ashwin made up his mind on retirement but his underwhelming outing against New Zealand may have contrib uted to his big decision.

With Ashwin gone and Mohammed Shami not available, a Test transition is well underway Down Under.

The outcome of the remaining two Tests will determine where the Indian batting stands.

#### **Jay Shah Becomes Youngest ICC** Chairman

India is the engine of the global game and its influence on the sport increased further with the elevation of Jay Shah as ICC chairman, making him the fifth from the country at the helm of the governing body after Jagmohan Dalmiya, Sharad Pawar, N Srinivasan and Shashank Manohar.

Shah took over in early December and has already made his presence felt by ending the deadlock over the hosting of the Champions Trophy in Pakistan by ensuring consensus for a reciprocal hybrid model in which India will not be required to travel across the border for any ICC event till 2028. Going forward, Shah will need

to make a conscious effort to align India's interests with the game globally.
