Not Empowered As CM Of UT: Omar Abdullah

Says Court Should Be Last Resort For Statehood

Srinagar: Omar Abdullah Thursday said that he does not view himself as an empowered Chief Minister, and that no Chief Minister of a Union Territory holds the same level of authority as that of a state. "That is a fact. There is no point in living in denial. If I were an empowered CM, why would I ask for restoration of statehood."

The chief minister took questions on various issues confronting his two-monthold government, including the functioning of an elected government that has to share powers with the Centre's appointee -- the lieutenant governor.

Omar acknowledged the difference of being a chief minister of a Union territory and a state, saying "it has been a little over two months since we came to power. It took us time to understand how the UT Biggest challenge is to get statehood back

Art 370 Sowed Seeds Of Separatism In J&K: Shah

Says Kashmir Inseparable Part Of India's Soul

Srinagar: Union Home Minister Amit Shah emphasized the historical and cultural integration of Jammu, Kashmir, and Ladakh with India, referencing 8,000-year-old ancient texts. He made these remarks dur-

ing the launch of the book 'Jammu, Kashmir, and Ladakh: Through the Ages," published by the Indian Council of Historical Research (ICHR).

Speaking at the event in New Delĥi, Shah emphasized that Kashmir was not just a territorial part of India but an integral part of its civilizational essence.

Shah referred to historical granths (ancient scriptures) that validate Kashmir's connection to India for millennia, emphasizing that the region is inseparable from India's cultural identity.



He reiterated that Article 370 was a temporary provision and its abrogation in 2019 was essential.

Post-abrogation, he claimed, separatism and terrorism have significantly declined, and the ecosystem sustaining such activities has been dismantled.

Will Try To Bring 100 MPs On Board: Ruhullah Responds

Srinagar: Hours after Jammu and Kashmir Chief Minister Omar Abdullah remarked that National Conference MP Aga Syed Ruhulla should organize protests in front of Parliament for the restoration of statehood to Jammu and Kashmir, Ruhulla said that not only statehood but even restoration of Article 370 is his demand.

Aga Ruhullah Mehdi took to social media platform 'X' to reaffirm his stance on the abrogation of Article 370 and the subsequent political developments in Jammu & Kashmir.

'Misuse' Of Police Verification Process

Sajad Lone Files PIL In HC

Srinagar: People's Conference chief Sajad Lone on Thursday filed a public interest litigation (PIL) in Jammu and Kashmir and Ladakh High Court against the "misuse" of police verification process.

The PIL, submitted through advocate Syed Sajad Geelani, seeks to address the "growing misuse" of police verification as a tool of "collective punishment, targeting individuals based on the actions or affiliations of their family members", the party said in a statement.

The party said Lone's move comes in response to his earlier commitment to protect the rights of citizens, emphasising that the police verification process should not penalise individuals for factors outside their control, particularly the conduct of their relatives.

been used to deny citizens their basic rights, such as employment, access to passports and other essential opportunities. It is imperative that the verification process remains transparent, fair and aligned with legal standards," Lone, the MLA from Handwara, said.

The PC president said the petition calls for strict enforcement of the Jammu and Kashmir Civil Services (Validation of Character and Antecedents) Instructions, 1997, along with amendments introduced through Government Order of 2021 and Circular of 2024, which mandate clear timelines for police verifications.

J&K Fire Services Recruitment Under Scrutiny

ACB Probe Reveals Rigged Marks, Favoritism

Srinagar: What could spark an outrage over recruitment process in Jammu & Kashmir, an investigation by the Anti-Corruption Bureau (ACB) has revealed that 109 candidates secured lower marks than the cutoff marks in the job test for the Fire & Emergency Services in 2020, but were selected by showing them to have secured higher marks in the final selection list than the marks actually secured by them.

The ACB also found that five real brothers from Budgam district, along with relatives of officials from the Fire and Emergency Services (F&ES)

Department and candidates from the same localities, figured in the selection list.

In an official handout, the ACB said that a manual review of the OMR sheets vis-a-vis answer keys revealed discrepancies in the selection process.

"Out of 690 selected candidates. 109 were found to have secured lower marks than the cutoff marks, but were selected by showing them to have secured higher marks in the final selection list than the marks actually secured by them. For instance, candidates actually securing 11, 17, 24 marks were shown to have secured 90 marks each in the final selection list," it said. More on P10

HC Closes PIL Over Non-recruitment To Gazetted Posts In Ladakh

Srinagar: The High Court of J&K and Ladakh has closed a Public Interest Litigation concerning the alleged non-recruitment to the posts of Gazetted Cadre in the Union Territory of Ladakh over the past

five years. A division bench of Chief Justice Rabstan Tashi and Justice M.A. Chowdhary passed the orders after advocate Kachroo Manzoor Ali Khan, representing PIL petitioner, submitted that during a high-powered committee, chaired by the Union Minister and attended by eight representatives each from the Leh





"Our presence will be felt in the Security Council," Ambassador Akram, Pakistan's top diplomat at the UN, told state-run APP (Associated Press of Pakistan)

Pakistan will sit in the Security Council for the 2025-26 term as a non-permanent member the eighth time that the country has had a seat on the 15-member body's horseshoe table.

In June, Pakistan was elected to the council with a massive majority as a non-permanent member, polling 182 votes in the 193-member General Assembly far more than the required 124 votes representing a two-thirds

"We enter the council at a time of great geopolitical turbulence, intense competition between the two largest powers, raging wars in Europe, the Middle East, Africa and elsewhere and a sharply escalating and multi-dimensional arms race," Akram said.

Bhopal Gas Tragedy

40 Years On, Toxic Waste Shifted From **Union Carbide Factory For Disposal**

Forty years after the Bhopal gas tragedy, 377 tons of hazardous waste has been shifted from the defunct Union Carbide factory for its disposal at a unit in Dhar district, officials said on Thursday

The toxic waste was transported around 9 pm on Wednesday in 12 sealed container trucks via a 'green corridor' from Madhya Pradesh capital Bhopal to Pithampur industrial area in Dhar district, located 250 km away.

Amid tight security, the vehicles reached around 4.30 am on Thursday at a factory in Pithampur where the waste will be disposed of. Dhar Superintendent of Police Manoj Singh told PTI over phone.

The trucks were currently parked on the factory campus in Pithampur, he added.

"A green corridor was created for the nearly seven-hour journey of the vehicles to the Pithampur industrial area in Dhar district," Bhopal Gas Tragedy Relief and Rehabilitation Department Director Swatantra Kumar Singh said on Wednesday.

Nearly 100 persons worked in 30-minute shifts since Sunday to pack and load the waste in trucks.

"They underwent health check-ups and were given rest every 30 minutes." Singh added

The highly toxic methyl isocyanate (MIC) gas leaked from the Union Carbide pesticide factory on the intervening night of December 2-3, 1984, killing at least 5,479 persons and leaving thousands with serious and longlasting health issues.

The Madhya Pradesh High Court on December 3 rebuked authorities for not clearing the Union Carbide site in Bhopal despite directions from even the Su-

preme Court. The High Court set a fourweek deadline to shift the waste, observing that even 40 years after the gas tragedy, authorities were in a "state of inertia".

The High Court Bench had warned the government of contempt proceedings if its directive

Fire Claims Lives Of Two Siblings In Tangmarg

BARAMULLA: Tangmarg in north Kashmir's Baramulla district is in mourning after a devastating fire engulfed a residential tin shed, which claimed the lives of two minor siblings. The tragedy sparked outrage over alleged negligence by authorities in addressing the family's repeated pleas for housing assistance.

Officials said that the fire incident occurred at Ferozpora village in Tangmarg on Thursday, engulfing the residential tin shed. Despite rescue efforts from the neighbours and fire and emergency service personnel, the lives of minor siblings could not be saved.

The victims were identified as Mina Ashraf, a 4-year-old girl and a 3-month-old Muntazir Ashraf – the children of Mohammad Ashraf Dar.

As per the locals, the family had been living in the tin shed due to financial constraints and alleged negligence in securing housing assistance under the government's Indira Awaas Yojana (IAY), a scheme for underprivileged families.

"This is a tragedy that should never have happened," said Abdul Qayoom Wani, chairman of the Jammu Kashmir Civil Society Forum (JKCSF). He criticised the administration for ignoring the family's repeated applications for proper housing and called for a timebound investigation into the matter.

The tragic loss sparked widespread grief and outrage across the valley.

Meanwhile, Tehsildar Tangmarg, Eyaad Qadri expressed grief over the loss of lives in the incident. He termed the incident as "heart wrenching and unfortunate". "We are investigating the incident and the cause of the fire is being ascertained,"

Tehsildar assured that the family will be provided the necessary assistance. "They will be rehabilitated in a nearby building," he said, extending sympathies and to the bereaved family—(KNO)

Estates Deptt Files Status Report On Ex-Legislators' Eviction From Govt Housing

he Estates Department on Thursday informed I&K and Ladakh High Court that many former ministers and legislators have vacated the government accommodation.

In response to the Public Interest Litigation No.17/2020 seeking eviction of former ministers, former legislators and political persons from the ministerial bungalows, A-type Kothis and government quarters, the Estates Department pursuant to order dated 12-12-2024 passed by the Division Bench of the High Court of J&K and Ladakh filed its updated compliance/status report.

The report stated that former Deputy Chief Minister Kavinder Gupta has vacated the government accommodation. The compliance report also highlighted that eviction order was issued to J&K BJP President Sat Sharma on 21-11-2024 and notice for payment of penal rent amounting to Rs. 73,470/-upto 30-12-2024 has also been issued to Sat Sharma. The report further stated that the premises under occupation of Sat Sharma was sealed on 30-12-2024.

It is worthwhile to mention herein that the Division Bench of the High Court of J&K and Ladakh had expressed its displeasure/anguish vide its

orders dated 07-11-2024 and 12-12-2024 and Commissioner/Secretary Govt. of J&K, Estate Department was specifically directed to file updated status report with regard to occupants namely Kavinder Gupta, Ex-Dy. CM, Sat Sharma, President of BIP(I&K), Surinder Ambardar (Ex-MLC) and Zaffar Iqbal Manhas (Ex-MLC) whose names were mentioned in para 5 of the status report dated 11-12-2024 filed by the Estates Department. The Division Bench had categorically directed that in case, the updated status report was not filed with regard to the occupants mentioned in the paras 5 & 6 of the status report dated 11-12-2024 failing which the Commissioner/Secretary Estates Department was directed to remain present on the next date of hearing and the court had made it clear that no exemption or excuse shall be entertained by the Court. It was further disclosed in the compliance report that eviction process under Section 4 of J&K Public Premises (Eviction of Unauthorised Occupants) Act,1988 has been initiated against EX-MLCs Zaffar Iqbal Manhas and Surinder Ambardar by issuing them the notices on 28-12-2024. In the status report, it has also been revealed that Govt. accommodation has been vacated by S.S. Channi

and notice for payment of penal rent amounting to Rs.14,690 has been issued to him on 20-12-2024. Further Mohammed Abbas Wani, Ex-MLA has also vacated the accommodation and notice for penal rent amounting to Rs. 19,586/- has been issued to him on 12-12-2024. The status/compliance report has also pointed out that Ex-MLA Abdul Rahim Rather has also vacated the Govt. accommodation and notice for penal rent amounting to Rs. 28,211/- upto 20-12-2024 has been issued to him. Similarly, Ex-MLC Vibodh Gupta has also vacated the accommodation and notice for penal rent amounting to Rs. 13,993/upto 20-12-2024 has been issued to him. Warmest Year

he year 2024 has been declared the warmest on record, capping a decade of unprecedented global heat. The World Meteorological Organization (WMO) attributes this alarming trend to human activities that continue to fuel greenhouse gas emissions. These emissions, reaching record highs, are locking in even more heat for the future, creating a cycle that the planet can ill afford. The fallout of this climate crisis is unfolding in devastating ways, leaving no corner of the globe untouched, including tourist places such as Kashmir. Although, winter in Kashmir has by and large been normal, 2024 was an erratic weather. In July last, the Valley experienced the highest recorded temperatures, with Srinagar city recording a high of 36.2 degrees Celsius. The Valley also recorded a 34% deficit in rainfall from June to July, and in October the region witnessed a 74% shortfall. Overall also, the Valley has received less precipitation beginning with last winter itself. Data reveals that in the past 28 years alone, nine winters in the Valley have passed more or less snowless - three of them in the last decade - a frequency that has created a deep sense of alarm.

Although climate change is a global phenomenon, Kashmir has become its microcosm. It is mirrored in the fragile ecosystem of the region. From erratic weather patterns to heatwaves, Kashmir has been experiencing the same changes as on the global level. The changes are not mere aberrations but harbingers of a dire future if immediate actions are not taken. For example, one of the victims of climate change has been the Valley's apple and saffron production, which have suffered irreparable damage due to soaring temperatures, causing significant economic repercussions.

On a bigger scale and which has consequences beyond the boundaries of Jammu and Kashmir, the rising temperatures have led to a rapid retreat of glaciers. Over the past six decades, Jammu and Kashmir has seen a staggering 25 percent reduction in glacier size, a trend exacerbated by the looming threat of climate change. If left unchecked, 48 percent of these vital sources of water could vanish by the end of the century.

UN Secretary-General António Guterres in his New Year message has taken a due note of this catastrophic turn in the global climate, and called for global measures to reverse the trend. "We must exit this road to ruin-and we have no time to lose," Guterres said in his message and called on countries to "put the world on a safer path by dramatically slashing emissions, and supporting the transition to a renewable future." World needs to heed the message for its own survival.

Healthcare Crisis in Anantnag

Addressing the Dire State of Medical Facilities

edical facilities are fundamental to public health, serving as the backbone of healthcare systems worldwide. They provide essential services that cater to the diverse needs of society, including hospitals, clinics, rehabilitation centers, and nursing homes.

In District Anantnag, however, the reality is starkly different. Despite being home to a population exceeding 10 lakh, the medical infrastructure is severely lacking, with most hospitals in disarray and unable to meet basic healthcare standards. Anantnag, a vast district in Jammu and Kashmir, comprises numerous healthcare facilities intended to serve its diverse population. The district is equipped with several hospitals, including the Government Medical College (GMC) Anantnag, Maternity Hospital Sher Bagh, and various sub-district hospitals (SDHs). However, a significant portion of these institutions are poorly maintained and inadequately equipped. Notable hospitals such as GMC Anantnag and Maternity Hospital Sher Bagh suffer from neglect, with little-to-no government initiative aimed at upgrading their services or infrastructure.

The lack of investment in medical facilities has resulted in outdated equipment and insufficient resources for both patients and healthcare providers. This situation is particularly concerning given the increasing demand for quality healthcare services in the region.

Recently, the issue of rat infestation was reported at GMC Anantnag when a widely circulated picture showed rodents on hospital beds. Multiple newspapers verified and reported on the incident as well.

In yet another report, it was revealed that Maternity and Child Care Hospital (MCCH) in Anantnag, which caters to patients from four south Kashmir districts as well as Ramban and the Chenab Valley, has been functioning from an unsafe building since 2014 — it was declared unsafe by the Fire and Services department a decade ago.

Accessibility Issues

Accessibility to quality healthcare is paramount, especially in a region with such a large population. Many residents prefer seeking treatment within the district rather than traveling to facilities outside Anantnag due to financial constraints and logistical challenges. Unfortunately, the existing hospitals fail to meet basic healthcare standards. Patients often find themselves forced to seek private care due to the lack of reliable services in government hospitals. This situation is exacerbated by the fact that many doctors prioritize their private practices over their duties in public hospitals, leading to a shortage of medical staff during critical hours. More-

over, the absence of adequate emergency services further complicates matters. Many patients requiring urgent care are left waiting for extended periods or are referred elsewhere when they should be treated immediately. This delay can have dire consequences for patient outcomes.

Inadequate Facilities and **Hygiene Concerns**

The government hospitals in Anantnag are devoid of basic amenities essential for patient care. Reports indicate that these facilities lack proper sanitation and hygiene standards. For instance, there are no separate washrooms for male and female patients, which raises serious concerns about privacy and dignity.

Furthermore, inadequate drainage systems contribute to unsanitary conditions, with unpleasant odors permeating the environment. Recently, images circulating on social media depicted rats on patient beds, highlighting the dire state of cleanliness in these hospitals. Staffing Shortages and Professionalism

A significant issue plaguing medical facilities in Anantnag is the lack of professional medical practitioners. This shortage often leads to a high number of patients being referred to more advanced facilities like GMC Srinagar or SKIMS for specialized care.

The distance-approximately 60 kilometers-between Anantnag and these hospitals poses a grave risk for patients requiring urgent treatment; delays can be fatal. Moreover, many doctors in government hospitals exhibit a lack of punctuality and commitment to their roles. Their preference for private clinics over public service undermines the quality of care available to patients who rely on government facilities. Reports suggest that doctors often prioritize their private practices due to financial incentives, leaving public hospitals understaffed during critical hours.

The Need for Government Intervention

Given the critical state of healthcare in Anantnag, it is imperative for the newly elected government, particularly the Health Minister, Ms. Sakina Ittoo, to take immediate action. A comprehensive assessment of the medical facilities at the ground level is essential for understanding the challenges faced by citizens. The government must prioritize public welfare by addressing the deficiencies within these hospitals. In their manifesto, the National Conference (NC) government pledged to improve healthcare services; now is the time to fulfill that promise. Upgrading infrastructure, ensuring proper sanitation, and enhancing staffing levels are crucial steps toward restoring public trust in medical services. Additionally, it is vital for local authorities to engage with community members to understand their needs better. Public forums and feedback mechanisms can help identify specific issues within healthcare delivery and foster a sense of accountability among healthcare providers.

Conclusion

The current state of medical facilities in Anantnag is alarming and demands urgent attention from both local authorities and government officials. With a growing population that deserves access to quality healthcare, it is essential that immediate measures are taken to rectify existing shortcomings. By prioritizing public health and welfare through targeted investments and community engagement initiatives, the government can work towards creating a healthcare system that serves all citizens effectively and compassionately. In conclusion, addressing these issues will not only improve health outcomes but also foster a sense of security among residents who rely on these essential services. The people of Anantnag deserve better: it is time for action.

Al Is Game Changer For Students With Disabilities. Schools Still Learning To Harness It

or Makenzie Gilkison, spelling is such a struggle that a word like rhinoceros might come out as "rineanswsaurs" or sarcastic as "srkastik."

The 14-year-old from suburban Indianapolis can sound out words, but her dyslexia makes the process so draining that she often struggles with comprehension. "I just assumed I was stupid," she recalled of her early grade school years.

But assistive technology powered by artificial intelligence has helped her keep up with classmates. Last year, Makenzie was named to the National Junior Honor Society. She credits a customized AI-powered chatbot, a word prediction program and other tools that can read for her.

"I would have just probably given up if I didn't have them," she said.

Artificial intelligence holds the promise of helping countless other students with a range of visual, speech, language and hearing impairments to execute tasks that come easily to others. Schools everywhere have been wrestling with how and where to incorporate AI. but many are fast-tracking applications for students with disabilities.

Getting the latest technology into the hands of students with disabilities is



a priority for the US Education Department, which has told schools they must consider whether students need tools like text-to-speech and alternative communication devices. New rules from the Department of Justice also will require schools and other government entities to make apps and online content accessible to those with disabilities.

There is concern about how to ensure students using it — including those with disabilities — are still learning.

Students can use artificial intelligence to summarize jumbled thoughts into an outline, summarize complicated

passages, or even translate Shakespeare into common English. And computergenerated voices that can read passages for visually impaired and dyslexic students are becoming less robotic and more natural.

"I'm seeing that a lot of students are kind of exploring on their own, almost feeling like they've found a cheat code in a video game," said Alexis Reid, an educational therapist in the Boston area who works with students with learning disabilities. But in her view, it is far from cheating:

"We're meeting students where they are." Ben Snyder, a 14-year-old freshman from Larchmont, New York, who was recently diagnosed with a learning disability, has been increasingly using AI to help with homework.

'Sometimes in math, my teachers will explain a problem to me, but it just makes absolutely no sense," he said. "So if I plug that problem into AI, it'll give me multiple different ways of explaining how to do that."

He likes a program called Question AI. Earlier in the day, he asked the program to help him write an outline for a book report — a task he completed in 15 minutes that otherwise would have taken him an hour and a half because of his struggles with writing and organization. But he does think using AI to write the whole report crosses a line.

"That's just cheating," Ben said.

Schools have been trying to balance the technology's benefits against the risk that it will do too much. If a special education plan sets reading growth as a goal, the student needs to improve that skill. AI can't do it for them, said Mary Lawson, general counsel at the Council of the Great City Schools.

But the technology can help level the playing field for students with disabilities, said Paul Sanft, director of a Minnesota-based center where families can try out different assistive technology tools and borrow devices.

India's Manufacturing Growth Hits 12-Month Low In Dec

NEW DELHI: India's manufacturing sector growth fell to a 12-month low in December, as new business orders and production expanded at softer rates, a monthly survey said on Thursday.

The seasonally adjusted HSBC India Manufacturing Purchasing Managers' Index was at 56.4 in December, down from 56.5 in November, indicating a weaker improvement in operating conditions. Despite the decline, the headline figure remained above its long-run average of 54.1 thereby signalling a robust rate of growth.

In PMI parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

"India's manufacturing activity ended a strong 2024 with a soft note amidst more signs of a slowing trend, albeit moderate, in the industrial sector. The rate of expansion in new orders was the slowest in the year,

suggesting weaker growth in future production," Ines Lam, Economist at HSBC, said.

The manufacturing sector growth was hampered by competition and price pressures.

Lam said there was some uplift in the growth of new export orders, which rose at the fastest pace since July.

"Although new export sales rose at a slower rate than total new business, the pace of growth for the former strengthened as firms were able to secure international orders from across the globe," the survey said.

According to the survey, the "substantial" rate of growth resulted in further expansions in buying levels and employment.

Ongoing improvements in new work intakes prompted manufacturing companies in India to purchase additional inputs for use in production processes and on the job front, around one in ten companies recruited extra staff, while fewer than 2 per cent of firms shed jobs.

Investors Richer By ₹8.52 Lakh Crore In Two **Days Of Market Rally**

MUMBAI- Investors' wealth surged Rs 8.52 lakh crore in two days of market rally, with the benchmark Sensex climbing nearly 2 per cent on Thursday alone.

The 30-share BSE benchmark Sensex jumped 1,436.30 points or 1.83 per cent -- its best single-day gain in more than a month -- to settle at 79,943.71 on Thursday. During the day, it soared 1,525.46 points, or 1.94 per cent, to 80,032.87.

On Wednesday, the benchmark gauge had climbed 368.40 points, or 0.47 per cent, to settle at 78,507.41.

The market capitalisation of BSE-listed firms surged Rs 8,52,239.27 crore to Rs 4,50,47,345.71 crore (USD 5.25 trillion) in two days.

Markets surge: Sensex jumps 1,436 points to settle at 79,943; Nifty surges 445 points to 24,188

"While markets failed to deliver a Christmas rally over the past few weeks, the New Year has provided strong optimism in the first two days with Sensex touching the psychological 80,000-mark on the back of broad-based

short-covering.

"Gains in banking, IT, auto and metal triggered a major rally despite concerns in the currency market which saw the rupee scaling fresh lows amid rising crude oil prices and subdued growth," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd. said.

From the 30 Sensex blue-chip firms, Bajaj Finserv jumped nearly 8 per cent while Bajaj Finance soared 6.50 per cent. Maruti, Titan, Mahindra, Mahindra & Mahindra, Infosys, HCL Tech, Zomato, UltraTech Cement and Kotak Mahindra Bank were the other major gainers. Sun Pharma emerged as the only laggard.

The BSE midcap gauge jumped 0.89 per cent and smallcap index climbed 0.68 per cent.

All sectoral indices ended in positive territory. Auto surged the most by 3.66 per cent, followed by BSE-focused IT (2.34 per cent), IT (2.31 per cent), consumer discretionary (2.24 per cent), teck (2.19 per cent), consumer durables (2.02 per cent) and commodities (1.41 per cent).

As many as 2,395 stocks advanced while 1,574 declined and 117 remained unchanged on the BSE.

Employment Increases 36% To 64.33 Cr In Last Ten Years: Union **Labour Minister**

NEW DELHI: Union labour minister Mansukh Mandaviya on Thursday said employment in the country has increased by 36 per cent to 64.33 crore in 2023-24 from 47.15 crore in 2014-15, which shows improvement in job creation during NDA period.

Talking to media persons, the minister also stated that employment under UPA grew by just about 7 per cent be-tween 2004 to 2014.

He noted that under the UPA government between 2004 to 2014 just 2.9 crore additional jobs were created whereas under the Modi government between 2014-24, 17.19 crore jobs were added.

In the last one year (2023-24) alone, the Modi government has created around 4.6 crore jobs in the country, the minister stated.

The data assumes significance in the backdrop of pressure on the government for job creation in the country.

About the agriculture sector, the minister stated that employment declined by 16 per cent between 2004 to 2014 under UPA tenure whereas it has grown by 19 per cent between

Traders said a rally in the precious metal rates in the international markets, which aided in bullion prices.

Meanwhile, in futures trade on the MCX, gold contracts for February delivery rose Rs 205, or 0.27 per cent, to Rs 77,098 per 10 grams.

"Gold's positive rally extended beyond Rs 77,300 in the domestic market, supported by Comex gold sustaining above USD 2,640.



"This upward momentum was further fuelled by rupee weakness. The combination of international strength and currency dynamics has reinforced bullish sentiment for gold," Jateen Trivedi, VP Research Analyst -- Commodity and Currency, LKP Securities, said.

India-EFTA Trade Pact Likely To Be Implemented Before End Of 2025: Goyal

NEW DELHI: The implementation process of free trade agreement (FTA) between India and the four-nation European bloc EFTA is progressing fast and is expected to come into force before the end of this year, Commerce and Industry Minister Piyush Goyal said.

The two sides signed the Trade and Economic Partnership Agreement (TEPA) on March 10, 2024. Under the pact, India has received an investment commitment of USD 100 billion in 15 years from the grouping while allowing several products such as Swiss watches, chocolates and cut and polished diamonds at lower or zero duties. The European Free Trade Association (EFTA) members are Iceland, Liechtenstein, Norway, and Switzerland.

'Yes, EFTA is progressing very fast." Goval told PTI when asked if the agreement would come into effect this year. The minister said the Swiss Council of States has approved the agreement and now will go to their National Council for approval.

"So this overwhelming support in political circles in Switzerland for the TEPA with EFTA is truly a sign of the times to come... and in their statement also, it shows that that it has



cleared an important hurdle and they are hoping to bring in entry to force by autumn of 2025, before the end of calendar year 2025," Goyal said.

The bloc committed an investment of USD 100 billion --USD 50 billion within 10 years after the implementation of the agreement and another USD 50 billion in the next five years -- which would facilitate the creation of 1 million direct jobs in India. This is a first-ofits-kind pledge agreed upon in any of the trade deals signed by India so far.

The commitment is the key substance of the TEPA (Trade and Economic Partnership Agreement), which took almost 16 years to conclude, for India in return for opening its markets for several products coming from the EFTA nations.

There is a provision in the agreement that if the proposed investments would not come because of some reasons, India can suspend duty concessions to the four countries.

Dir Agri Inaugurates First Harvest Of Shiitake Mushrooms

JAMMU: Director Agriculture Production and Farmers Welfare Jammu S. Arvinder Singh Reen inaugurated the first harvest of the Shiitake mushrooms (Lentinula edodes), here on Thursday at the Shiitake lab of the Spawn Production Office, Krishi Bhawan.

Shiitake mushrooms. known for their rare medicinal properties including antiimmune-boosting, and anti-allergic effects, require a specialized cultivation environment. These mushrooms can only grow on sawdust blocks made from hardwood, with a cultivation cycle ranging from 120 to 180 days and a biological efficiency of 20-30% on a wet weight basis.

In his address, Director S. Arvinder Singh Reen emphasized the immense potential of Shiitake mushroom cultivation as a high-value crop for Jammu and Kashmir. He stated that this initiative will not only foster employment generation but also open new avenues for startups, particularly among the region's unemployed youth. Additionally, the project supports the diversification of existing mushroom cultivation

activities within the UT. The key raw material for



Shiitake cultivation is sawdust, and Jammu and Kashmir is uniquely positioned to benefit from this, with its abundant supply of sawdust and Wooden Chips generated by the Jammu and Kashmir's cricket bat industry. Furthermore, the ideal temperature range of 20-28°C (68-82°F) for Shiitake growth is wellsuited to the region's climate, making it an ideal location for large-scale production.

The Directorate of Agriculture Production and Farmers Welfare Jammu has successfully initiated the commercial cultivation of Shiitake mushrooms for the first time in the region. The Spawn Production Laboratory at Talab Tillo Jammu has successfully achieved spawn production and spawn run, following the protocols established by the Directorate of Mushroom Research,

Chamba Ghat, Solan (H.P). Additionally, 1,000 ready-tofruit blocks have been procured from District Project Manager-JICA, ODA Palampur, and are being supplied to progressive mushroom growers and DCTCs across the Jammu Province to encourage commercial cultivation of Shiitake mushrooms. Fruit initiation in these blocks has also been successfully achieved across the Jammu division.

The programme was attended by Deputy Director Central Dr. Ashwani Sharma, Agriculture Chemist Dr. Aman Jyoti Sharma, Spawn Production Officer Verinder Dogra, Mushroom Development Officer Raghubir Pal Kochar, SMS-RL Dharmesh Vaid, SMS-SDL Kewal Krishan Sharma, along with the staff from the Spawn Production and Mushroom Development Offices.

STD Urges Taxpayers To Practice Invoice-Based Trade, Report Actual Sales

JAMMU- State Taxes Department (STD) Thursday conducted inspections and enforcement drives across various district of Jammu division to curb the menace of recycling of B2C bills, Input Tax Credit mismatches and other GST violations.

The inspections were carried under the guidance of Commissioner State Taxes J&K, P K Bhat and under the supervision of Additional Commissioner Enforcement and Administration Jammu, Namrita

Based on inputs generated by various AI tools like Business Intelligence and Fraud Analytics (BIFA), E-way Bills Portal, the department constituted special teams headed by STOs. The teams visited various business premises to investigate violations under

Based on the inputs, teams specifically inspected dealers who were found engaged in the recycling of B2C invoices into B2B invoices, thereby passing on ITC to other dealers and contractors. The ITC was being used to settle GST output tax instead of being paid in cash.

The STD urged the dealers to follow the fair-trade practices and avoid indulging in tax evasion activities or fraudulent practices involving fake ITC.

Furthermore, the department appealed all taxpayers to practice invoice-based business and report their actual sales and pay the necessary amount of GST in their monthly/ quarterly returns to avoid enforcement actions and penalties.

"It has been a little over two months since we came to power. It took us time to understand how the UT government works. We have been associated with the government earlier, but there is a vast difference between that form and the present form," Omar said.

The Centre in August 5, 2019, revoked Article 370 of the Constitution that gave special status to the erstwhile state of Jammu and Kashmir and reorganised the state into two UTs. While J-K has a legislative assembly with limited powers, Ladakh is without a legislature.

In December 2023, the Supreme Court upheld the Centre's decisions to revoke special status and create the two UTs but told the Union government to restore the statehood of J&K as soon as possible.

Prime Minister Narendra Modi and Union Home Minister Amit Shah have on numerous occasions, including in Parliament, said that the statehood of J&K would be restored at an appropriate time.

Abdullah, speaking to the reporters, said the start of the new government has been "decent" and that they "did not find much difficulty" in

"We are bound by our election promises. We have started the process of implementing some of the promises and for other promises, we need change in the system. I hope J&K being a UT is a temporary phase," Omar said.

He said it is important to understand that his party's manifesto was for a five-year term, not five weeks or five months.

"Some issues were important to us and we fulfilled those, including the resolution on statehood and the resolution on the special status." he said.

Asserting that the Centre should be given "first chance" to fulfil its promise of restoring the statehood to Jammu and Kashmir, he said that approaching courts on the issue would mean a "fight" and that it should be the "last

During his first media meet here since assuming office in October, Omar also dismissed suggestions that his National Conference was under pressure to join the BJP-led NDA and expressed optimism that the promises made by the Centre to restore statehood of Jammu and Kashmir will be fulfilled at the earliest.

When asked why the J&K government did not approach the court for restoration of statehood and went to the Centre with the resolution on it, he said going to the courts would mean getting into a confrontation.

"Simply going to courts will be a fight. A fight should never be the first option, it should be the last option.

"If the SC had not spoken about the restoration of statehood, if the prime minister and home minister had not spoken about it, then we could have gone to courts. They have made promises and we have to give them a chance first," he added.

Omar said the Supreme Court in its judgement in December last year had also stated that the statehood should be restored as soon as possible. "One year has passed since and we think one year should be enough," he said.

He also maintained that the region's current status as a Union Territory should be viewed as a temporary arrangement and restoration of statehood was the "biggest challenge" for his

Countering the BJP's narrative that the "Kashmir issue" had been resolved with the abrogation of Article 370 five years ago, Jammu and Kashmir Chief Minister Omar Abdullah on Thursday pointed out that a part of erstwhile state continues to be occupied by Pakistan.

"Let us assume for a minute that this side of Kashmir issue has been resolved, but let us not forget that there is another part of Jammu and Kashmir across the line of control (Pakistan-occupied-Kashmir).

"When the BJP says that the Kashmir issue has been finally resolved, should we assume that the part across the border has also been resolved? But in reality it has not been," he

He was responding when asked if he believed that the Kashmir issue was resolved with the abrogation of Article 370 as has been maintained by the BJP.

"So, the Kashmir issue remains whether this side of LoC or that side, we can debate about it but the issue has not been resolved. We want it to get resolved," he said.

National Conference leaders have in the past been arguing about a Parliament resolution of February 22, 1994 in which the entire House had noted with "deep concern Pakistan's role in imparting training to the terrorists in camps located in Pakistan and Pakistan Occupied

The resolution had called upon Pakistan to vacate the areas of the Indian State of Jammu and Kashmir which they have occupied through aggression.

He further added, "I don't share a relationship with Ruhullah where we exchange good morning and good night messages. When there's a need to talk, we communicate, just as I do with my other counterparts."

Addressing speculation about internal dynamics within the National Conference (NC), Omar said, "The media often plays up narratives suggesting that only Farooq Abdullah's words matter and that there's aristocracy in the party. But times have changed. There was a time when even the thought of a protest was considered anti-national. The fact that Ruhullah's protest reached my gate shows we are not afraid of the people and that we will not

shy away from engaging with them. During the interaction, Omar Abdullah's body language visibly shifted everytime Ruhullah's name was brought up. When Kashmir Observer tried to ask another question following this exchange, it was not given a chance, as the atmosphere had noticeably shifted in the room. The fact that he seemed unaware of the reasoning behind Ruhullah's protest at his residence raises even more questions. Are they not talking

directly? Was Omar not willing to dwell on the subject? Was there underlying frustration with Ruhullah's actions? Could this be a sign of deeper political differences, or is it merely a personal disagreement that has spilled over into the public eye?

'No Pressure From

minister and home minister that the National Conference government would remain stable and that they would receive the same cooperation extended earlier to the lieutenant gover-

"They have stated they will respect the mandate of the people. Those spreading rumours that I will now join NDA and that I have changed my ideology, I cannot help that. I am here to work and I will work," he said at the media interaction held at the Sher-i-Kashmir International Convention Centre.

'Dual Power Centres Not An Advantage' Omar Abdullah said the hybrid model of governance in the Union territory is not to anyone's advantage and the systems work better

when there is a single centre of command. "Obviously, dual centres of power are not to anyone's advantage. If dual centres were effective tools of governance, you would see it everywhere," Omar told reporters at a media interaction here when asked about the hybrid

model of governance in Jammu and Kashmir. The chief minister said while there have been "differences of opinion on some issues", there was no confrontation with the Raj Bhavan.

"Systems work better when there is a single centre of command. For the UT, the dual centres of command are inbuilt. There have been differences of opinion on some issues, but not on the scale at which it is being speculated. Such reports are just a figment of imagination," he added.

Omar said the business rules for the government would be framed after proper consultations and then sent to Lieutenant Governor Manoi Sinha.

The chief minister said that he was not the one to tell people not to go to the Raj Bhavan.

"I would say people should go wherever they can get their issues resolved -- be it in the Raj Bhavan or with the local MLA or the officers,' he added

As far as reservation is concerned, I told the delegates that the cabinet sub-committee has been framed, the chief minister said.

The party expected that Ruhullah, the Lok Sabha MP from Srinagar, would hold a similar protest for the restoration of statehood in Parliament as well, he added.

Omar, however, said while we can fight the reserved and open category fight, "but first we

have to save our jobs". "What will we do when people from other places come here for jobs?" he asked.

Responding to a question about the Raj Bhavan not restoring public holiday on NC founder Sheikh Mohammad Abdullah's birthday on December 5, and July 13 as Martyr's Day, the chief minister said it cannot erase the legacy of those who have made sacrifices.

"The legacy of Sheikh Mohammad Abdullah does not begin and end on December 5. Same goes with the martyrs of July 13. When a farmer tills his land, he thinks of Sheikh Mohammad Abdullah. When a student receives free or subsidized education, it is legacy of Sheikh Mohammad Abdullah. The hall where we are sitting right now was his legacy as well," Omar

"The holidays became a big story. Ideally, we ould want to have them as they ally attached with people," he added.

Asked about difficulties faced by the candidates on account of police verification for appointments in the government jobs, Omar said although it is outside his domain as of now, he has discussed the matter with the CID chief.

"I have been saying this that a militant's son is not a militant. Consciously, we did away with this blacklisting (in his first term as CM). We can only counsel about it right now. But I believe there is some relief. More will be done for them when we are a state," he said.

Omarr also said that his government was framing a policy to address the situation of hoteliers in Gulmarg whose land leases have expired after they had opted for now-disbanded Roshini scheme.

Responding to a question on the row over land acquisition for a campus of the National Institute of Technology (NIT) in south Kashmir's Pulwama district, the chief minister said there

is a need to find a balance between development and protecting our productive agriculture land.

"We cannot increase our land, development cannot stop. We will try to ensure that development projects are on non-productive lands as much as possible. I met a delegation from Pulwama and I said to them that if you don't want NIT in Pulwama, we will take it to some other location," Omar said.

"Not everyone is against development. There are other areas where we can locate this NIT. We will have to find a balance between development and protecting our productive agriculture land," he added.

On the opposition's allegation about a satellite colony being built, the chief minister said there is no such proposal on his table as he looks after the department.

"The people who are making the most noise were the ones who talked about greater Jammu and Srinagar," he said.

The chief minister said if the townships would be built, they will just for decongesting the Srinagar city.

"When we talk generally to the residents in Srinagar, they talk about decongestion. There is the problem of housing. 3-4 families are living in a single house, they say if they get an opportunity they would move to the suburbs," Omar

He said his government will focus on reducing power distribution losses and expediting metering in the union territory to ensure more electricity supply for the people.

"Metering is an ongoing process, it is a part of the government of India scheme. We are committed to implementing it and we will. Obviously, the more metering that happens, the less pilferage there will be," Omar told reporters at a media interaction here.

He said both the J&K administration and the Union Power Ministry are committed to advancing these reforms and ensuring their successful implementation, "which we will do".

Further, the chief minister said J&K is spending Rs 9,500 crore a year to buy power from the

On the power cuts in Kashmir, Omar said the government is providing more electricity supply to the people than the previous year.

...we are supplying 1,700-1800 MW electricity, but the unrestricted load is more than that," he said.

He said the sooner the power projects in J&K are completed, the sooner more electricity can be provided to the people.

"Even if their generation in winters is low, we can bank the power generated during summers. We will try to bank more electricity in the summers every year so that we utilise it in the winters," he said.

The chief minister said I&K's AT&C losses are more than 50 per cent and efforts are on to bring it down.

"Other states have brought it down to 15-17 per cent. Our endeavour is to bring it down at least below 20 per cent so that we can supply more electricity to the people," he added.

Asked about his poll promise of providing

200 free units of electricity, Omar said the scheme will be rolled out in March or April.

"What we have promised in our manifesto. That will only happen when there is (com-We measure units only when there is metering...," he said.

At the time of government formation, the Congress had taken everyone by surprise by deciding to stay out and support the NC from outside. Reduced to six seats, the party is in no position anyway to dictate terms to the NC.

Asked about the Congress continuing to remain outside the government, Omar said: "The National Conference is part of the INDIA bloc, the Congress is supporting our government, and at the moment it is outside support. They have said that they will remain out until statehood is restored. I haven't heard of any change after that." (inputs from PTI)

The CM also addressed public speculation about his political image, particularly the shift in his clothing style. In a candid remark, he dismissed the idea that his wardrobe choices were politically motivated. "I don't open my cupboard and decide what to wear based on the message it will send. I went to Delhi wearing a suit, and people criticized me for that too. The truth is, Karakuli doesn't suit me, and Sozni and Pashmina are part of my heritage. I wear them because they keep my head warm and my hairline too has receded," he explained.

Abdullah's remarks come amidst heightened security operations in the region since the abrogation of Article 370. Security forces have intensified crackdowns on militants, separatists, and their supporters, leading to the detention of hundreds of young people. The Jammu and Kashmir administration argues that these actions are vital for dismantling the militancy ecosystem, which includes measures to target those who promote and support it.

Pertinently the recent official reports reveal that more than 86 government employees, including doctors, teachers, and police personnel, have been dismissed for alleged ties to militant activities or anti-national sentiments. A further list of individuals suspected of similar connections is under review, with dismissal orders expected once evidence is compiled.

Omar Abdullah had earlier also expressed concerns, calling the terminations unjust and calling for the employees to be given a chance to prove their innocence. "This is creating fear among employees and impairing the work culture in government departments," he said, adding that the issue would be revisited once there is a change in leadership. Amid these political tensions, the abrogation of Article 370 continues to be a point of contention, shaping the region's security landscape and employment policies.

"The abrogation was a political statement, a declaration that our sacrifices mean nothing, and that our future is theirs to dictate," he wrote stating his moral obligation to prioritize the fight for the J&K's honor, identity, and autonomy over what he described as "the hollow promise of mere statehood."

Ruhullah also vowed to persist in raising his voice. "Shouldn't our voices first rise for our honor, our identity, and the autonomy we have long been denied? I think they should, and I will keep raising mine louder each time.

Ending on a poetic note, he declared, "The Tree Remembers," symbolizing resilience and the enduring spirit of Kashmir.

The statement which he wrote after Chief Minister Omar Abdullah's first 'public interaction' has sparked discussion among political observers and the general Kashmiri populace with many saying that Mehdi's position as a vocal advocate for J&K's special status has been

SYDNEY: Battered by extra bounce and seam movement along with scathing criticism of his leadership, India skipper Rohit Sharma's career as a Test cricketer seems headed for a dispiriting climax amid swirling speculation that he is set to be dropped from the fifth and final Test against Australia starting here on Friday.

"We will take a call on the playing XI after looking at the pitch," Gambhir gave a cryptic reply to a straight query on whether Rohit will play.

If it happens, Rohit will become the first Indian captain to be dropped on account of poor form and he would have none



to blame except for the abysmal return of 31 runs from five innings.

Pace spearhead Jasprit Bumrah, who has been the team's top performer with an astonishing 30 wickets in four outings at a sub-20 average, will take over the leadership role

Bumrah's captaincy that India won its only Test on the tour so far -- the lung-opener in Perth.

Where Would That Leave Rohit?

Mahendra Singh Dhoni and Anil Kumble walked into Test retirements mid-series as their bodies could no longer take the rigours of the longest format.

However, in Rohit's case, he will be dropped on the basis of form after Gambhir made it clear that performance is the only thing that would keep a player in the dressing room

If he doesn't come out for toss on Friday, it would be safe to conclude that Rohit, the Test batter, played his last knock at the MCG earlier this week where he looked completely out of place on a good track.

While Gambhir didn't spell out the playing eleven, there were enough indications that India might bring back Shubman Gill at number three.

Won't Be Surprised If Rohit Retires From Tests: Shastri

SYDNEY: Former India head coach Ravi Shastri will not be surprised if underfire captain Rohit Sharma announces his Test retirement in near future, saying talented and in-form youngsters like Shubman Gill are knocking hard on the doors of the side.

Rohit has managed a highest score of 10 in the five innings he has played in the Border-Gavaskar Trophy after missing the series-opener due to the birth of his second child.

Speculation over Rohit's place in the playing eleven for the Sydney Test grew on Thursday when head coach Gautam Gambhir turned up for the pre-match media interaction and did not confirm the captain's place in the team.

Shastri, who was the head coach last time India toured Down Under and is currently here as a commentator, wants the 37-year-old to go out with a bang if he does decide on his Test future.

"He'll take a call on his career but I won't be shocked at all (if Sharma retires) because he's not getting youngar," said Shartri on ICC Poview.

er," said Shastri on ICC Review.

"There are other young players in the wings, there's Shubman Gill, a player of his quality averaging over 40 in the year 2024 and not playing. It tricks your brain as to what is he doing sitting on the bench and warming it. So I won't be surprised but it's his call."

Rohit has looked far from the class batter that he is and Shastri wants the opener to play with absolute freedom. "If I was anywhere near Rohit Shar-

ma, I'll tell him, 'Just go and smash it. Just go out there and have a blast'. Just as it is when you're trying to play the way you are at the moment, it's not looking great. Go out there and take the attack to the opposition and then let's see what happens.

"At the end of the day, if India had qualified for the World Test Championship (Final) or if they still qualify for the World Test Championship Final, then it's another thing altogether.

"Otherwise, I think it might just be the opportune time - but (if Sharma plays) he should go out with a blaze of glory," Shastri said.

He also feels Rohit has struggled with his feet movement thus far in the

"From the outside when I see it, he's a little late on the ball. His feet aren't moving as well as they normally do. Even at his prime, his footwork was minimal, but there was more. He was more towards the ball. At the moment, he's caught on the crease.

"I want him to just get out there, smash it, try and win this Test match. You might have lost a Test. You have not lost the series as yet. Try and win this Test match to keep that Border-Gavaskar Trophy," Shastri added.

It was around half past one when Gautam Gambhir walked towards the centre strip at the Sydney Cricket Ground with Jasprit Bumrah in tow.

A few minutes later, Rohit Sharma also joined the duo in the middle but there was hardly any communication between the head coach and the designated captain. All present at the SCG witnessed a complete communication breakdown between skipper and the head coach.

There were already enough indications but the developments on Thursday made one thing as clear as daylight. Rohit Sharma is no longer in coach Gautam Gambhir's scheme of things after scoring just one second innings half-century in the eight Tests that he has played this season.

Marsh Dropped, Starc Declared Fit For BGT Finale

All-rounder Beau Webster will replace an out-ofform Mitchell Marsh in Australia's squad for the fifth and final Test against India, home skipper Pat Cummins said here on Thursday.

The 33-year-old Marsh scored only 73 runs in seven innings across four Tests and Cummins cited this as the reason for his axing. He has bowled merely 33 overs in the series so far, claiming just three wickets.

The 31-year-old Webster, who played against India A in November, has scored 5247 runs and taken 148 wickets in first-class cricket. Webster has been in good form in the Sheffield Shield as well and averaged over 55 last season.

Cummins also put to rest the speculation surrounding Mitchell Starc's fitness, saying the left-arm pacer will play the game. "He went for scans yesterday. But he got the all clear to play this match. He is good to go," Cummins said.

The 34 year old's fitness was the main concern for

The 34-year-old's fitness was the main concern for the hosts after he battled through sore ribs in the Boxing Day Test but still managed to bowl effectively with help from the team's physios.

A victory or a draw in the fifth Test here is crucial for the hosts as it will help them regain the Border-Gavaskar Trophy for the first time since 2014-15.

Bhaker, Gukesh Among Four To Get Khel Ratna Award

The quartet of shooter Manu Bhaker, chess world champion D Gukesh, men's hockey captain Harmanpreet Singh and para-athlete Praveen Kumar were on Thursday named recipients of this year's Major Dhyan Chand Khel Ratna Award -- the country's highest sporting honour.

The 22-year-old Bhaker became independent India's first athlete to win two medals in a single edition of the Olympics with her bronze-winning show in the 10m air pistol individual and 10m air pistol mixed team events in August.

In the same Games, Hamranpreet led the Indian hockey team to its second consecutive bronze medal.

The 18-year-old Gukesh, on the other hand, became the youngest ever World champion while also helping the Indian team win a historic gold in the Chess Olympiad last year.

The fourth recipient will be para high-jumper Praveen, who was crowned the T64 champion in the Paris Paralympics.

The T64 classification is for athletes who have one or both legs missing below the knee and rely on a prosthetic leg for running.

"The awardees will receive their awards from the President of India at a specially organised function at Rashtrapati Bhavan on 17th January, 2025 (Friday) at 1100 hours," the sports ministry said in a press release.

Liverpool, top of the Premier League and the Champions League, has its sights on equalling United 's record 20 Premier League titles and more. Liverpool has lost to United just once in seven years in the Premier League, and most recently won 3-0 at Old Trafford in September.

United is closer to the relegation zone than the top in another calamitous campaign which has seen the departure of a manager, a sporting director and the exile of one of its leading players.

The gap between Liverpool and United is widening to the point where one is in contention for a quadruple of trophies and the other is talking about top flight survival.

Klopp won a full set of trophies at Anfield and was denied much more success in the Premier League than just the 2020 title only by Pep Guardiola's Manchester City.

Slot has Liverpool leading the Premier League by six points with a game in hand, the Champions League by three points, and through to

the semifinals of the English League Cup.

Perhaps he has been fortunate to take over when City has gone into freefall but Liverpool's 14 wins from 18 games in the league would be title-challenging form in any season.

Ambulance crosses speed-breaker and 'dead' man jolts to life

or 65-year-old Pandurang Ulpe, a speed-breaker proved to be a life-saver after an ambulance carrying his "body" from the hospital crossed it and his family noticed

his fingers moving. On December 16, Ulpe, a resident of Kasaba-Bawada in western Maharashtra's Kolhapur district, suffered a heart attack and was rushed to a private hospital, where doctors declared him dead.

An ambulance then began the journey with his "body" from the hospital to his home, where neighbours and relatives had gathered upon hearing the news of his demise, and were preparing for his last rites.

"When we were bringing his "body" home from the hospital, the ambulance passed over a speed-breaker and we noticed that there was a movement in

his fingers," his wife said. He was then taken back to another hospital, where he remained for a fortnight, and underwent an angioplasty during the period, a family member

Ulpe walked home from the hospital on Monday, a fortnight after the ambulance passed over the speed-breaker, taking him back to life instead of the crematorium.

Narrating the sequence of the events of December 16, Ulpe, a warkari (devotee of Lord Vitthal) said, "I had come home from a walk and was sitting after sipping tea. I felt dizzy and breathless. I went to the bathroom and vomited. I don't remember what happened afterwards, including who took me to the hospital."

There has been no comment so far from the hospital which had declared him dead.



IIT-Guwahati develops injectable hydrogel for breast cancer therapy

esearchers at Indian Institute of Technology (IIT), Guwahati have developed an advanced injectable hydrogel for localised cancer treatment with significantly less side effects typically associated with conventional cancer treatments, according to officials.

The research conducted in collaboration with Bose Institute, Kolkata, has been published in "Materials Horizons", a journal of the Royal Society of Chemistry.

Debapratim Das, Professor at IIT-Guwahati's Department of Chemistry, said cancer continues to affect millions of patients worldwide but current treatments such as chemotherapy and surgical interventions often have severe limitations.

"Surgical removal of tumours is sometimes not feasible, particularly for internal organs, while chemotherapy's systemic delivery often results in harmful side effects by affecting both cancerous and healthy cells. We have addressed these challenges by designing a hydrogel that delivers drugs precisely to the tumour site, ensuring localised action," Das said.

Hydrogels are water-based, three-dimensional polymer networks capable of absorbing and retaining fluids. Their unique structure mimics living tissues, making them suitable for biomedical applications. This newly developed hydrogel acts as a stable reservoir for anti-cancer drugs and releases them in a controlled manner, responding to specific conditions in the tumour micro-environment.

The hydrogel, composed of ultra-short peptides - biocompatible and biodegradable building blocks of proteins – is designed to remain insoluble



in biological fluids, ensuring it stays localised at the injection site. It responds to elevated glutathione (GSH) levels, a molecule abundant in tumour cells.

Upon encountering high GSH levels, the hydrogel triggers a controlled drug release directly into the tumour, minimising its interaction with healthy tissues and reducing systemic side ef-

"This work exemplifies how scientific innovation can directly address the pressing needs of cancer treatment. The hydrogel's unique properties allow it to work in harmony with the biological environment, offering precision where it is needed most. We are excited by its potential to transform our thoughts about localised drug "In preclinical tridelivery." als on a murine model of breast cancer, the hydrogel showcased remarkable efficacy.

A single injection of the hydrogel, loaded with the chemotherapy drug Doxorubicin, resulted in a Rs 75 per cent reduction in tumour size within 18 days. Crucially, the hydrogel remained localised at the tumour site, steadily releasing the drug over time without causing detectable side effects on other organs," he said.

Das explained that innovative delivery system enhances the drug's effectiveness while reducing the required dosage, thus minimising toxicity.

"Laboratory studies further demonstrated that the hydrogel improves drug uptake by cancer cells, induces cell cycle arrest, and promotes programmed cell death, thereby attacking tumours on multiple fronts.

"Further studies are going on to find out the maximum amount of reduction in the size of the tumour by a single dose. Moreover, we are also looking into other types of tumours. Once all the studies are complete, will apply to take the material for clinical trial and are looking for an appropriate partner to do the same.'

Indian man crosses over into Pak to marry FB friend, lands in jail

30-year-old Indian man crossed over illegally into Pakistan to meet a Facebook friend he wanted to marry, but instead found himself behind bars. And the woman told the local police she did not want to tie the knot with him.

Badal Babu from Aligarh district of Uttar Pradesh was arrested last week in Mandi Bahauddin district of Pakistan's Punjab, some 240 km from Lahore, for illegal border crossing.

Babu attempted to cross the border illegally to meet the Facebook friend who he wanted to marry.

Police have recorded the statement of Babu's Facebook friend Sana Rani, 21, who said she wasn't interested in marry-

ing him. "In her statement to police, Sana Rani said that Babu and she had been friends on Facebook for the last two-and-a-half years. But she is not interested in marrying him," a Punjab police officer, Nasir Shah, told PTI on Thursday.

He said Babu illegally crossed the border and reached Sana Rani's Maung village in Mandi Bahauddin, where he was arrested by law enforcers.

When asked whether Babu met Rani, the police officer said he couldn't confirm this.

It is also not independently confirmed whether Rani gave a statement to the police refusing to marry Babu under pressure.

However, a source told PTI that officials of an intelligence agency quizzed Rani and her family over her relationship with Babu.

Upon his arrest, Babu narrated his "love story" to the police. Babu was detained under Pakistan's Foreign Act sections 13 and 14 as he was travelling without any legal documents.

Later, he was presented before a court, which placed him in judicial custody for 14 days. The next hearing is on January 10.

This is not the first time someone from India has crossed into Pakistan to meet a love interest developed through social media.

Previously, an Indian woman named Anju travelled to Pakistan to meet her lover. She converted to Islam and married a Pakistani man, Nasrullah.

Last year, Seema Haider, a woman from Pakistan, befriended an Indian man through the PUBG game. She crossed into India via Nepal with her four children and later married him.

Similarly, last year, 19-yearold Pakistani girl Iqra Jiwani struck up a friendship with 25-year-old Indian national Mulayam Yadav through an online game. Iqra and Mulayam later
