

Research Discovers New Skeletal Tissue With Potential For Regeneration: Study

international research n team has discovered a new type of skeletal tissue that Soffers great potential for advancing regenerative medicine and tissue engineering.

An international research team led by the University of California, Irvine has discovered a new type of skeletal tissue that offers great potential for advancing regenerative medicine and tissue engineering.

Most cartilage relies on an external extracellular matrix for strength, but 'lipocartilage', which is found in the ears, nose and throat of mammals, is uniquely packed with fat-filled cells called 'lipochondrocytes'.

It provides super-stable internal support which enables the strength of tissue. It makes to remain soft and springy -- similar to bubbled packaging material.

The study, published in the journal Science, describes how lipocartilage cells create and maintain their own lipid reservoirs while remaining constant in size. Unlike ordinary adipocyte fat cells, lipo chondrocytes never shrink or expand in response to food availability. 'Lipocartilage's resilience and stability provide a compliant, elastic quality that's perfect for flexible body parts such as earlobes or the tip of the nose, opening exciting possibilities in regenerative medicine and tissue engineering, particularly for facial defects or injuries," said corresponding author Maksim Plikus, UC Irvine professor of



developmental and cell biology. "Currently, cartilage reconstruction often requires harvesting tissue from the patient's rib -- a painful and invasive procedure. In the future, patientspecific lipo chondrocytes could be derived from stem cells, purified and used to manufacture living cartilage tailored to individual needs. With the help of 3D printing, these engineered tissues could be shaped to fit precisely, offering new solutions for treating birth defects, trauma and various cartilage diseases.

Dr. Franz Leydig first recognized lipochondrocytes in 1854, when he noted the presence of fat droplets in the cartilage of rat ears, a finding that was largely forgotten until now. Now with modern biochemical tools

and advanced imaging methods, UC

Irvine researchers comprehensively characterised lipo cartilage's molecular biology, metabolism and structural role in skeletal tissues.

In their research, they also uncovered the genetic process that suppresses the activity of enzymes that break down fats and reduce the absorption of new fat molecules.

When stripped of its lipids, the lipocartilage becomes stiff and brittle, highlighting the importance of its fat-filled cells in maintaining the tissue's combination of durability and flexibility. In addition, the team noted that in some mammals, such as bats, lipo chondrocytes assemble into intricate shapes, like parallel ridges in

their oversized ears, which may enhance hearing acuity by modulating sound waves.

New Study Of Supernovae Calls Dark **Energy's Existence Into Question**

y looking at light from distant exploding stars called supernovas, in 1998 astronomers discovered the universe isn't just expanding its expansion is speeding up. But what's behind this acceleration?

Enter dark energy. It's one of the most de-bated and intriguing missing puzzle pieces of modern physics – a mysterious form of energy believed to uniformly permeate all of space. In the current most accepted model of modern cosmology, dark energy is what drives the accelerated expansion of the universe.

But what if there's another explanation that doesn't involve dark energy? Â recent study using data from supernovas hints there might indeed be one, and it's called the Timescape model.

This finding could profoundly challenge our understanding of the cosmos, so let's dive in.

What is dark energy?

The backbone of modern cosmology is the Lambda-Cold Dark Matter (Lambda-CDM) model. It describes a universe where a dark energy – denoted with , the Greek letter Lambda – is the driving mechanism behind the universe's accelerating expansion.

Under this model, galaxies are dancing together under the effect of an invisible dark matter web made of heavy particles that don't interact with anything. The effects of this cold dark matter can only be observed through gravity.

Dark energy accounts for nearly 70% of the universe's total energy budget, but its exact nature remains one of the greatest mysterformly spread throughout cosmos. But for the Lambda-CDM model, we assume the universe is homogeneous and isotropic. This means that, on cosmic scales, the distribution of matter appears smooth and uniform. Any clumps and gaps we might find can be considered insignificant due to the grand scale of the entire thing. By contrast, the Timescape model takes the uneven distribution of matter into account. It suggests our intricate cosmic web - made up of galaxies, clusters, filaments and vast cosmic voids – directly affects how we interpret the expansion of the universe. This would mean the universe isn't stretch-

ing out evenly. According to the Timescape model, the universe's expansion rate varies across different regions, depending on how dense

they are. The key parameter in the Timescape model is the "void fraction": it quantifies the proportion of space occupied by expanding voids. Gravity dictates that voids expand faster than denser regions - they have less matter to hold them back, allowing space to stretch more freely. This creates an average effect that can mimic the accelerated expansion attributed to dark energy in Lambda-CDM.

In short, the Timescape model suggests it might only appear to us that the universe's expansion is speeding up. The expansion speed depends on where you are in the universe.

What did the study find?

The authors of the new study looked at one of the biggest collections of Type Ia supernovas, called the Pantheon+ dataset. These supernovas are a reliable standard used to test cosmological models. The team compared two major models: the standard Lambda-CDM (our "vanilla" recipe of the universe), and the Timescape model. When looking at nearby bright supernovas, the Timescape model explained things better than our standard model. This was only statistical though, with the statistical analysis showing a "very strong" preference. Even when they examined more distant supernovas, where things should be more evenly spread out, Timescape still held up slightly better than the usual model. The takeaway? The Timescape model, which focuses on how cosmic "clumps and gaps" change the way we see the universe growing, might be better at capturing the true nature of our universe's expansion. This would be especially so for the nearby universe - we have a lot of voids and filaments near us, which would affect how we see the expansion.



J&K Faces Driest Year In 5 Decades

Jammu Srinagar: and Kashmir experienced its driest year in five decades in 2024, with rainfall levels plung-ing to just 870.9 mm against the normal annual average of 1232.3 mm - a significant deficit of 29%

According to independent weatherman, Faizan Arif, this marks the fifth consecutive year of below-normal precipitation in the Union Territory, raising serious concerns about water scarcity and its impact on agriculture, hydropower, and the overall environment.

A closer look at the rainfall trends over recent years highlights the alarming pattern: 2023 recorded 1146.6 mm (7% deficit), 2022 witnessed 1040.4

mm (16% deficit), 2021 saw 892.5 mm (28% deficit), and

2020 experienced 982.2 mm (20% deficit). With the 2024 figures nearing the previous low of 802.5 mm recorded in 1974, the **5-Year Rainfall** region's precipita-tion levels continue **Deficit Trend** to dwindle, pointing towards a concerning long-term trend. The data reveals that January recorded a stagger-ing 91% shortfall, while February and March saw deficits of 17% and 16%, respectively. Although April offered some respite with a 48% surplus, it was the only month to wit-

Srinagar: Security will be paramount in Kashmir's new rail network, with cuttingedge measures implemented to safeguard passengers and infrastructure.

Cameras have been installed every 50 meters inside the tunnels, linked to a state-ofthe-art central control room for real-time monitoring of security and operational data. Additionally, the project includes 67 km of escape tunnels, ensuring enhanced during emergencies. safety These features are part of Udhampur-Srinagarthe Baramulla Rail Link (USBRL) project, a monumental effort to connect Jammu with Kashmir.

Officials privy to the development said that the tunnels, including the 12.77 km-long T-50-the longest in the section-were constructed using Himalayan tunneling tech-nology instead of traditional methods. Ballastless tracks, akin to those used in metro systems, ensure smoother and more efficient train operations. Infant Deaths Double At Lal Ded Hospital In 2024

Srinagar: Lal Ded Hospital, Srinagar's key maternal and child healthcare facility, reported a troubling surge in infant mortality in 2024, with 297 newborn deaths compared to 142 in 2023-marking a nearly twofold increase.

Over the past five years, the hospital has recorded approximately 900 infant deaths, reflecting a steady upward trend.

The spike in fatalities has raised alarm among locals and

health experts, who attribute the issue to staff shortages, inadequate resources, and insufficient neonatal care equipment. The data highlights a deficit of around 140 staff members across various roles, further

straining the hospital's capacity to provide quality care. The hospital has also experienced a significant rise in patient load, with outpatient visits increasing from 142,088 in 2020

to 221,163 in 2024, and inpatient admissions growing from 29,757 to 37,908 | More on P6

Only Industrial Tribunal Can Adjudicate JKB-Workman Dispute: HC

Srinagar: The J&K and Ladakh High Court has held that only the labour court or Industrial tribunal, established by the Central Government, shall have power to adjudicate an industrial dispute between the Jammu & Kashmir Bank and its workman.

However, a bench of Justice Rajnesh Oswal said that the Central Government may refer the dispute to the labour court or Industrial Tribunal established by the State Government and in that eventuality only, the labour court or Industrial Tribunal established by the State Government shall have jurisdiction to adjudicate the same.

On 13 March 2019, Industrial Tribunal Cum Labour Court J&K at Srinagar had rejected the preliminary objection raised by the



J&K Bank by holding that the State Government was the 'appropriate Government' for the bank and the Industrial Tribunal or Labour Court established by the State Government shall have the jurisdiction to adjudicate a dispute between the bank and its workman. The bank had assailed the order before the High Court. "..this court is of the considered view that in case of in-

dustrial dispute between the Jammu and Kashmir Bank Ltd. and its workman, the appropriate Government would be 'the Central Government'," the court

'Kashmir Separatist Group's Money Exchange' SC Dismisses PIL Against RBI

New Delhi: The Supreme Court on Friday dismissed a PIL alleging the RBI exchanged Rs 30 crore-worth defaced currency notes belonging to a Kashmir

separatist group. A bench of Justices Surya Kant and N Kotiswar Singh dismissed the PIL, which sought a CBI probe into the allegations, after the RBI said petitioner Satish Bhardwaj was fired from the RBI and he had suppressed the fact before the court.

"He appears to be a disgraced employee of a bank," the bench told senior advocate Jaideep Gupta, representing the RBI. Gupta submitted there was no basis for Bhardwaj's claim.

Bhardwaj, appearing in person, referred to a newspaper report on the issue and said the RBI was denying the allegations five years after the PIL was filed. Justice Surya Kant told the petitioner he was the one who concealed the relevant facts in his petition.

After Bhardwaj admitted he was dismissed by the bank, the bench said, "We are not inclined to entertain this writ petition purportedly filed in public interest. The same is accordingly dismissed. However, the issues, if required to be adiudicated, shall be gone into in an appropriate case.'

On January 7, 2020, the top court asked the Centre to look into the PIL saying "the issue may be of national importance".

Bhardwaj alleged in 2013 the Jammu branch of the RBI exchanged the currency notes which belonged to a separatist group called "Kashmir Graffitti". He said he had approached

Former prime minister Manmohan Singh's vision of 'breakfast in Amritsar, lunch in Lahore, and dinner in Kabul' remains a wistful reminder of what could have been

'hen former prime minister Manmohan Singh visited Jammu and Kashmir in September 2017 as the head of a Congress delegation, he evoked some nostalgia about his tenure, a period during which a solution to the Kashmir issue had seemed within reach. Singh went about his activities in his familiar inconspicuous way. He chose to only listen and not issue any statement, nor talk to the media. But he struck a chord as a throwback to a time when centre apparently tried to be sensitive if not accommodative towards the issues facing J&K.

Singh's ten years at the helm - 2004-2014 - had witnessed the most promising peace process between India and Pakistan which had nearly culminated in a resolution of Kashmir. At one point of time as the Kashmir solution seemed close at hand, Singh had famously talked of a time when people in India would be able to have "breakfast in Amritsar, lunch in Lahore and dinner in Kabul".

There was some public criticism of Dr Singh too. Some people argued that despite making attempts and starting many initiatives on internal and external fronts to resolve Kashmir, Singh had baulked at taking these to their logical conclusion. Besides holding substantive negotiations with Pakistan over the then Pakistan president Pervez Musharraf's four point formula for Kashmir resolution, Singh had also set up five working groups and the three-member group of interlocutors to evolve a comprehensive response to the then state's problems but none of their recommendations was followed through

In his book, 'In Pursuit of Peace,' the late Indian diplomat S K Lambah provides a comprehensive account of the behind-the-scenes efforts led by Singh and his then Pakistani counterpart Pervez Musharraf to secure peace between India and Pakistan by resolving Kashmir. The "accord" being worked out between the two countries on Kashmir aimed to make borders irrelevant without redrawing them, with key elements such as bus services between two parts of Kashmir already in play during Singh's tenure.

Lambah's book also highlights the possibilities for peace that presented themselves over the past quarter century, including the Delhi-Lahore bus service that began in 1999, the visit of Prime Minister Atal Bihari Vajpayee to Islamabad in 2004, General Pervez Musharraf's visit to India in 2005, and the near-reopening of consulates in Mumbai and Karachi, among others.

Earlier, another book on the Singh-Musharraf's Kashmir initiative by the then Pakistan foreign minister Khurshid Kasuri, 'Neither Hawk, Nor Dove' also provided a detailed account of the ambitious transformation underway at the time.

Kasuri writes that by the time Musharraf was ousted from office, Pakistan and India had made progress on the last of the contentious points of his four point settlement formula for Kashmir which had brought the two countries tantalizingly close to a solution. This was about creating a joint consultative mechanism between the divided parts of Jammu and Kashmir. The two countries had agreed that such a mechanism would consist of a specified number of elected members from each of the two units. There was also an agreement on "the principle of the presence of Pakistanis and Indians" in this mechanism. What was still under discussion was "the manner of the presence and association" of the two countries with the arrangement.

However, the current state of affairs is far from promising, with no direct flights, hardly any visas issued, and no bus or train services between

the two countries. As Lambah noted in his book, India-Pakistan hostilities have become an instrument of political mobilization and that the painful memories of partition are being revived. He pointed out that hate is the guiding political philosophy of both countries today, and as long as this remains the case, no channel, front or back, will work.

The situation has considerably transformed since, and in almost every sense: regionally in terms of the growing power disparity between India and Pakistan, and in J&K too, which has since been divested of its special status and downgraded into two federally controlled units, in other words, two union territories. This, in turn, has altered the complexion of the Kashmir issue as we understood it.

And if at all the two countries return to dialogue in the near or medium future, it seems hardly probable that they will revisit the Four Point Proposals. But should the two countries choose to go back to them as a broader framework for settlement, they will need to adapt it to the new reality, But again, getting to that point won't be easy.

HMPV: New Virus in Town

s Jammu and Kashmir has entered the colder months of season, a lesser-known respiratory virus, Human Metapneumovirus (HMPV), is becoming a public health concern At least eight HMPV cases have been reported across India so far. This virus, which often mimics the common cold, can cause severe respiratory illnesses, particularly in vulnerable groups. While there are not any reported cases of this virus in Jammu and Kashmir, Understanding and taking steps to prevent HMPV is essential to safeguard the health of our community.

What is HMPV?

HMPV is a respiratory virus that spreads through droplets when an infected person coughs, sneezes, or speaks. It can also spread through contaminated surfaces and direct contact with infected individuals. While most cases result in mild symptoms, it can lead to severe complications, such as pneumonia and bronchiolitis, in certain high-risk groups.

Who is at Risk?

While anyone can contract HMPV, the following groups are especially vulnerable:

- Young children under 5 years, especially those born prematurely.
- Older adults over 65 years of age
- People with chronic respiratory conditions like asthma or COPD.
- Individuals with weakened immune systems due to conditions such as HIV/ AIDS, cancer, or autoimmune disorders.

Wear Masks

Use masks in crowded public spaces or during outbreaks.

Avoid Smoking

Smoking weakens the respiratory system and increases vulnerability to infections.

Special Care for Jammu and **Kashmir Residents**

The colder climate of Jammu and Kashmir makes residents, especially young children, the elderly, and individuals with chronic conditions, more vulnerable to respiratory infections like HMPV. Parents should take extra care to protect children under 5 years, while older adults are advised to consult healthcare providers at the first sign of respiratory symptoms. Those with compromised immunity should closely monitor their health and seek timely medical attention to avoid severe complications.

By staying informed and taking preventive steps, we can protect ourselves and our loved ones from HMPV this season. Let's work together and spread the information to ensure a healthier. safer winter for everyone in Jammu and Kashmir.

In 2019, the Delhi High Court also ruled that private schools cannot assign teachers nonteaching duties, including bus attendants. The court stated that teachers are hired to teach and not to perform other tasks.

Therefore, it is imperative that school administrations and policymakers take immediate action to address this issue. Teachers must be treated with the dignity and respect they deserve and their rights must be protected. This includes ensuring that they are not assigned tasks that are not related to their core responsibilities as educators. This unique practice transcends physical and cultural boundaries, serving as a beautiful reminder of sharing, caring, and the enduring ties of family and community.

Not only this but the Urs has deep spiritual, culturally and religious significance, bringing the community together in faith, remembrance, and love. The shrine of Hassan Bab, located within the village graveyard, becomes a sacred site where people gather to of-fer prayers (Faithwa) for their deceased loved ones. This act of visiting graves not only honours the departed but follows the Sunnah of Prophet Muhammad (PBUH), reminding everyone of the transient nature of life and the importance of prayers for those who have passed. The Madrasa located in the vicinity of the

shrine where from every year a good number of students irrespective of gender do Arabic course as well as do *"Hafiz*" of Holy Quran.

2024 Becomes Warmest Year On Record, 1st To Breach 1.5 Deg C Guardrail

NEW DELHI, Jan 10: The year 2024 was the hottest year on re-cord, and the first with a global average temperature 1.5 degrees Celsius above pre-industrial levels, European climate agency Copernicus confirmed on Friday.

Every month from January to June 2024 was the warmest ever recorded for those months. From July to December, except for August, each month was the second warmest on record, behind 2023, it said.

According to scientists at the Copernicus Climate Change Service (C3S), 2024 was the hottest year since global temperature tracking began in 1850.

The average global temperature was 15.1 degrees Celsius - 0.72 degrees above the 1991-2020 average and 0.12 degrees higher than that in 2023, the previous record-holder.

Scientists noted that the average temperature in 2024 was 1.60 degrees Celsius above the 1850-1900 baseline, the period before human activities like burning fossil fuels began significantly impacting the climate.

This is the first time the average global temperature has remained 1.5 degrees Celsius above the 1850-1900 average for an entire calendar year. However, a permanent breach of the 1.5-degree Celsius limit specified in the Paris Agreement refers to long-term warming over a 20- or 30-year period.

That said, experts feel that the world is now entering a phase where temperatures will be consistently above this phase threshold Harjeet Singh, climate ac-

tivist and the founding director of Satat Sampada Climate Foundation, said the world is entering a new climate reality - one where extreme heatwaves, devastating floods, and intense storms will become increasingly frequent and severe. "To prepare for this future, we must urgently scale up adaptation efforts across every level

of society - redesigning our homes, cities, and infrastructure, and transforming how we manage water, food, and energy systems," he said. Singh said the world must

move from fossil fuels to clean energy quickly and fairly, making sure no one is left behind, and that rich countries have a bigger responsibility to take bold steps.

The year 2024 will also be remembered as the year developed nations had their last big chance to prevent the world from permanently crossing the 1.5 degrees Celsius threshold by funding climate action in the Global South, but that didn't seem to materialise. Relentless warming fuelled

record-breaking heatwaves, deadly storms, and floods that devastated lives and homes by the thousands in 2024. Millions were displaced, and all eyes turned to the UN climate conference in Baku, Azerbaijan, hoping for a climate finance package capable of ramping up action in the Global South. A study published in 2023 estimated that developed coun-

tries owe around USD 170 trillion for their excessive emissions, having consumed 70–90 per cent of the total carbon budget since the industrial era.

2% in August. The situation worsened toward the end of the year, with deficits of 41% in September, 74% in October, 69% in November, and 58% in December.

"The impact of such deficits is already visible across the region. Reduced water availability is severely affecting agriculture, impacting crop yields and livelihoods of farmers. Hydropower generation, a crucial source of energy for the region, has been significantly impacted due to decreased water flow in rivers," Faizan said.

Dr. Bhat argued that incorporating snow clearance into MG-NREGA would address these challenges while simultaneously providing much-needed employment to rural residents during the harsh winter season.

In addition to highlighting the gaps in service delivery during snowfall, Dr. Bhat pointed out the lack of economic activity in snowbound areas during winter. He noted that MG-NREGA, a flagship employment guarantee scheme, is underutilized during these months in regions like Jammu and Kashmir, where life comes to a virtual standstill. By integrating snow clearance into the scheme, the government could ensure livelihood generation for thousands of rural workers, fulfilling the program's primary objective of providing income support to the poorest segments of society. Dr. Bhat also drew attention to successful precedents set by other states. He cited the example of Kinnaur district in Himachal Pradesh, where local authorities included snow clearance under MG-NREGA over a decade ago. This move not only streamlined snow management but also demonstrated the feasibility of adapting the scheme to meet local geographic and climatic needs. Dr. Bhat urged the Jammu and Kashmir administration to learn from such examples and push for similar measures in the Union Territory. Pertinently, Dr Raja Muzaffar Bhat has been advocating for this issue for years. In 2022, he persuaded former Baramulla MP Mohammad Akbar Lone to write to the Government of India, urging the inclusion of snow clearance in MG-NREGA not only for Jammu and Kashmir but also for other hill states and Union Territories like Himachal Pradesh, Uttarakhand, Ladakh, and Sikkim. His call for action was supported by other prominent legislators, including MLA Banihal Sajad Shaheen and MLA Sumbal Sonawari Hilal Akbar Lone, who have raised the issue at various forums. With the J&K government now poised to formally present this proposal to the Union Ministry, there is growing optimism that the initiative could become a reality. Observers say if approved, it would not only provide a sustainable solution to snow clearance challenges but also set a precedent for other snowbound regions across India.

Due to clear skies, Kashmir continued to experience sub-zero night temperatures, with the minimum temperatures remaining several degrees below freezing, officials said.

They said that most parts of the Kashmir valley have been experiencing clear skies with bright sunshine during the day over the past few days, which contributed to the drop in night temperatures.

The minimum temperature in Srinagar settled at minus 4.3 degrees Celsius, slightly up from the previous night's minus 4.4 degrees, officials said.

Gulmarg recorded a low of minus 8.1 degrees Celsius, up from the previous night's minus 9.6 degrees.

In Pahalgam, the minimum temperature settled at minus 10 degrees Celsius, up from minus 10.4 degrees the night before, according to the weather office.

Pahalgam was the coldest recorded place in the valley.

Qazigund logged a low of minus 7.6 degrees Celsius, while Konibal in

Pampore town also recorded a minimum temperature of minus 6.2 degrees.

Kupwara in north Kashmir recorded a minimum of minus 5.6 degrees Celsius, while Kokernag in south Kashmir saw the mercury settle at minus 5.7 degrees Celsius.

Moreover, the MeT has issued an advisory, predicting cold wave at isolated places and advising the tourists, travellers and transporters to follow administration and traffic advisory.

SRINAGAR: The Chenab Valley, comprising the districts of Ramban, Doda, and Kishtwar, has become a critical hotspot for road accidents in Jammu and Kashmir, with 20% of all road accidents in the region occurring here over the last six years.

The primary reason cited for these accidents is poorly constructed roads, a fact outlined by a government-formed committee tasked with investigating the issue and recommending preventive measures.

Despite this acknowledgment, little progress has been made in improving road conditions in these districts. Factors such as overloading, speeding, unfit vehicles, and a poorly managed traffic system exacerbate the problem.

Nashri-Ramban-Ban-The ihal-Qazigund section, de-clared a "black spot" by the Union Ministry of Transport and Roads, continues to wit-



Reconstruction Of Khankah-e-Faiz-Panah Awaits Completion

PULWAMA: The reconstruction of the revered shrine of Shahi-Hamdan, Hazrat Ameer-e-Kabeer, Mir Syed Ali Hamdani (RA) in Tral remains incomplete, even 27 years after a devastating fire incident in December 1997.

The historic shrine, known as Khankah-e-Faiz-Panah, was destroyed in a mysterious fire, following which the government announced its reconstruction with a target completion date of two years. However, more than two decades later, the shrine's restoration remains unfinished, which causes inconvenience to the large number of devotees who visit daily.

Locals said that despite repeated requests and assurances, the government has failed to complete the pending works.

Manzoor Ahmad, a local, said several critical works at the shrine remain incomplete without any clear explanation. "Hundreds of people visit the shrine every day, but they face significant inconvenience due to the pending construction work,"

Locals added that they had initially offered to rebuild the shrine themselves after the fire incident but were assured by the government that the reconstruction would be completed within two years. "They have failed to keep their promises," said another resident.

Despite raising the issue repeatedly with both the government and local political leaders, the shrine's restoration remains in limbo. The people have now appealed for the intervention of higher authorities to ensure the work is completed at the earliest. An official from the district administration told KNO that over 90 per cent of the work has already been completed. "The remaining work is pending due to certain issues, but we are actively taking up the matter with the concerned authorities. It will be completed soon," the

official said. Locals, however, remain sceptical and urge the government to expedite the remaining work to restore the shrine to its former glory-(KNO)

SRINAGAR: The MBBS and BDS interns in Jammu and Kashmir continue to grapple with a meagre monthly stipend and have urged the Chief Minister Omar Abdullah to increase their stipends by including it in the coming budget.

Interns said that despite the committee recommendations for an enhancement in the stipends upto Rs 26,350 formed via order number 538 JK-HME dated 27-06-2023, nearly one and a half year ago, to address the issue of "reasonable stipend enhancement."

The committee comprised three members, Director Finance H&ME Department; Principles of Government Medical Colleges in Jammu and Srinagar; the Director (Coordination) of New Government Medical Colleges; and Principals of Dental Colleges in Jammu and Srinagar, which submitted its report in August 2023.

It recommended an enhancement in the stipends of the interns, raising it to Rs 26,350 from Rs 12,300 based on the half of the basic pay of a Medical Officer in J&K, as per the NMC norms. Despite the submission of the

report, the matter has remained stalled in the Finance department with no progress for more than a year now.

Man Kills Wife, Burns **Her Body Parts** The Government's financial Agencies

ANANTNAG: In a shocking incident, a man has killed his wife and later burnt her body parts in the Aishmuqam area of Anantnag district, officials said on Friday. The man and his mother has been arrested by the police.

An official said that police arrested a man namely Imran Ahmad Khan for killing his wife - Shabnam Akhtar in the Aishmuqam area. The crime was committed in October last year, while the man was arrested today after investigation of the case revealed the gruesome details.

He said that during investigation of the case the man confessed that he killed his wife on October 4 last year and later buried her in a cow shed.

After committing the crime, the man had filed a missing report about her wife at Aishmuqam police station and after ten days he retrieved the body from the debris of his cow shed. "He dismembered his wife's body and then burnt the parts to bury them again," the official said. The deceased woman was his second wife, and he lived with his first wife after killing her. Police said that the man's mother has also been arrested in the case.

The official said that police have recovered hair, some bones and a cell phone and they have sent for forensic investigation. "A case FIR NO 01/2025 U/S 103(1) BNS,61(2) BNS has been registered against the accused and his mother," he said-(KNO)

women who are supposed to avoid high radiation exposures, reads the statement.

NEW DELHI: Spin legend R Ashwin feels Rishabh Pant will score a century in every game if the maverick India wicketkeeper-batter is able to curb his extravagance and impetuosity as he has got "one of the best defences" in world cricket.

Hailing Pant's ability to singlehandedly turn a match on its head, Ashwin said a lot of his shots are high-risk, something that is not allowing him to realise his full potential.

Pant scored the second-fastest Test fifty by an Indian during the fifth match of the Border-Gavaskar Trophy against Australia in Sydney recently, after a hard-fought 40 in the first innings of the same game. "We have to tell him prop-



erly what he has to do if he has but he didn't play like someto bat solid or bat with intent. one without runs. He has a lot He hasn't scored a lot of runs, of time on his hands. Rishabh

"He has all the shots -- reverse sweep, slog sweep, everything -- but the problem is that all these shots are high-risk shots. With his defence, he will surely score runs every game if he faces 200 balls.

"The point is finding that middle game. If he combines all of it, he will score 100 runs every game. He has to find that middle game," the recently-retired cricketer added.

Pant played contrasting knocks in the two innings of the SCG Test, as his 98-ball 40 in the first was followed by 33ball 61 in the second essay. The keeper, though, could not do an encore of his exploits in the 2020-21 BGT, when he powered

Pant is yet to realise his fullest India to a famous win in the potential," said Ashwin on his series-decider at Gabba, which was until then known as Australia's fortress.

While Pant is known for his penchant to play expansive shots, Ashwin was not surprised by the keeper's tenacious innings in the first essay.

"I have always grown up hearing that you have fight it out. In Sydney, he played two different knocks in one single game. He got hit everywhere and scored a 40, it will be the least spoken innings of Rishabh Pant. It is very unfair.

"In the second innings, he scored a swashbuckling fifty, earning him a lot of praise. Everyone forgot that first innings and praised him for the second knock," Ashwin pointed out.

ICC Chairman Jay Shah To Be Felicitated By BCCI At Its SGM

Newly-elected International Cricket Council (ICC) chairman Jay Shah will be felicitated by the BCCI's state units on the sidelines of the Special General Meeting, scheduled here on Sunday.

Shah, a former BCCI secretary, became the young-est ICC chairman after he was elected unopposed in August last year and took over the prestigious post on December 1. He replaced Greg Barclay who decided not to seek a third term. Shah was the BCCI secretary since October 2019 and chairman of the Asian Cricket Council since January 2021.

Shah will, however, not be a part of the SGM as he is no longer an office-bearer of the BCCI.

The cricket administrator has been at the forefront of expanding the game's imprint globally and recently met top officials of the 2032 Brisbane Olympics organising committee to discuss the sport's inclusion in the Summer Games.

Cricket will make a return to the Olympics after 128 years when it is played in the 2028 Los Angeles Games. The sport is not yet confirmed for the 2032 edition in Brisbane.

Australian newspaper, The Age, recently reported that Shah will meet meet Cricket Australia chair Mike Baird and his England counterpart Richard Thompson later this month to discuss the finer points of a twotier Test system to facilitate more series between the big three nations.
