

The Other Side Of Domestic Harassment: Men Speak Out In Kashmir

Srinagar: "I didn't know men could also file cases," said Sameer (name changed), his voice heavy with disbelief.

He recounted his descent into a nightmare: a once-happy marriage spiraling into a web of accusations, legal battles, and emotional turmoil.

"Everything seemed fine when I got married in 2019," Sameer recalled with a trembling voice, "but soon, my wife

began exhibiting erratic behav-ior, psychiatric symptoms I nev-er anticipated." He confessed that this was likely part of a cal-culated plan.

He realized his wife's true intentions over time. "She had always lived with her mother," he said, "and marriage seemed to be primarily a means to have a child while remaining close to her family." After their son was born four years ago, things dramatically worsened. "They began manipulating me,

blindsided when his wife filed a domestic violence case against him and his mother.

"I had no idea this could happen," he said. The legal battle spiraled out of control, tarnishing his family's reputation. "They even included my sister in the legal notice. The police, instead of offering assistance, unnecessarily shamed her," he alleged.

The court proceedings further deepened his despair. "My inlaws presented a false witness, who later admitted to lying. Yet, the case drags on, and justice feels increasingly elusive. I feel disillusioned, | More on P10

GOI Announces 8th Pay Commission

New Delhi: In a major decision, the government on Thursday decided to set up the 8th Pay Commission to revise salaries of central government employees and allowances of pensioners.

The chairman and two members of the Commission will be appointed soon, I&B Minister Ashwini Vaishnaw told reporters here.

"Prime Minister has approved the 8th Central Pay Commission for central government employees," the minister said.

The term of the 7th Pay Commission will end in 2026. Since 1947, seven Pay Commissions have been con-

stituted, with the last one implemented in 2016.

As the 7th Pay Commission's term concludes in 2026, initiating the process in 2025 ensures sufficient time to receive and review recommendations before its completion, the minister added. He said the setting up of the new Pay Commission in 2025 will | More on P10

Jayin added, "If we can do it in our 60s, why can't young people do it?"



> **SMC Deploys** Machinery, **Manpower To Tackle Snowfall**

SRINAGAR: The Srinagar Municipal Corporation (SMC) has completed preparations for snow clearance in Barubari and other areas, ensuring a well-equipped response with a range of machinery and manpower. Commissioner SMC, Dr. Owais Ahmed, stated that modified tractors, 4x4 vehicles, JCBs, loaders, and additional machinery have been deployed for efficient snow removal. A ward-wise team has been formed, with ward officers and Junior Engineers (JEs) overseeing operations. "We have set up a dual monitoring system for both mechanical and manual snow clearance to ensure smooth progress," Dr. Owais said. He highlighted that over 5,000 lanes and bylanes would be manually cleared, supported by sufficient manpower, while 1.500 km of roads would be cleared mechanically. Additionally, SMC has deployed water pumps at key locations to address water accumulation issues post-clearance. "Our control room, equipped with GPS monitoring, operates 24x7, allowing real-time tracking of machinery and quick response to public grievances through telephone or social media," he added.

the competent authority and leave the station without approval for such leave.

"This has been taken very seriously by the authorities as it is unbecoming of a Government employee, violates service rules, and warrants disciplinary action against the defaulting employees," the communication stated.

The authorities also pointed out that Heads of Departments (HoDs) and Sectional Heads are recommending leaves for employees without proper justification, even amid the prevailing staff shortage. In this regard, HoDs and Sectional

Heads have been instructed to recommend leave requests "very judiciously, with proper justification, until the staff strength is restored." Additionally, SKIMS authorities

raised concerns over officers availing ex-India earned leave without following the prescribed procedure.

"For ex-India leave, applications

must be submitted 45 days in advance after obtaining Vigilance Clearance from the GAD (Vigilance) to ensure administrative approval is sought in time, avoiding mismanagement and maladministration." the communication stated.

To address the issue, HoDs and Sectional Heads have been instructed not to frequently recommend leave cases.

"There is already a staff shortage, and any recommended leaves must be based on genuine grounds, keeping in view the constraints within departments," the authorities emphasized.

All employees, including HoDs. faculty members, and Sectional Heads, have been directed to strictly adhere to these instructions. "Failure to comply will result in disciplinary action as per the rules, without further notice," the communication warned.

Thousands Across Gaza Celebrate Ceasefire Deal

EIR EL-BALAH: Crowds of Gazans chanted and embraced on Wednesday as news spread that a ceasefire and hostage release deal had been reached between Israel and Hamas aimed at ending more than 15 months of war in the Palestinian territory.

After a US official and a source close to the negotiations first revealed the agreement, Israel cautioned that several points "remain unresolved" that it hoped would be resolved.

But celebrations were already underway in Gaza, where AFP journalists saw crowds of people hugging and taking photos to mark the announcement.

"I can't believe that this nightmare of more than a year is finally coming to an end. We have lost so many people, we've lost everything," said Randa Sameeh, a 45-year-old displaced from Gaza City to the Nuseirat Camp in the centre of the territory.

'We need a lot of rest. As soon

as the truce begins, I will go to the cemetery to visit my brother and family members. We buried them in Deir el-Balah cemetery without proper graves. We will build them new graves and write their names on them.

Outside Deir al-Balah's Al-Aqsa Martyrs Hospital, where so many of the war's casualties have been taken, hundreds of Palestinians gathered to chant, sing and wave flags, AFPTV footage showed.

At one point, a member of the crowd and a journalist in body armour were raised on people's shoulders to conduct an interview above the mass of elated Gazans.

As an ambulance squeezed through the crowd to reach the hospital, smiling men and women alike chanted "Allahu Akbar", or "God is greatest" in Arabic, and waved the Palestinian flag.

Young children, some looking confused by the commotion, gathered outside the hospital too, milling between adults and watching as they gave interviews to the waiting media.

A gaggle of young boys in the

centre of the crowd led a popular pro-resistance chant as adults filmed the moment on their phones.

In Gaza City, 27-year-old Abdul Karim said: "I feel joy despite everything we've lost.

"I can't believe I will finally see my wife and two children again," he added. "They left for the south almost a year ago. I hope they allow the displaced to return quickly."

Large crowds also gathered in Khan Yunis, in southern Gaza, with young men surfing through the crowd on the shoulders of others beating drums and cheering, an AFP photographer saw.

The deal agreed on Wednesday is expected to halt the fighting in the devastated Palestinian territory and see hostages held in Gaza released in exchange for Palestinian prisoners held in Israeli jails.

Hamas sparked the war in Gaza by staging the deadliest-ever attack on Israel on October 7, 2023, resulting in the deaths of 1,210 people, mostly civilians, according to an AFP tally of official Israeli figures.

Palestinian militants also took 251 people hostage during the attack, 94 of whom are still being held in Gaza, including 34 the Israeli military says are dead.

Israel's retaliatory campaign in Gaza has killed 46,707 people, most of them civilians, according to figures from the Hamas-run territory's health ministry that the UN considers reliable.

The advisory introduces labelling and disclosure norms requiring parties to clearly label any images, videos, audio or other materials generated or significantly altered by AI technologies with a notation such "AI-Generated"/ "Digitally Enhanced"/"Synthetic Content" It also requires political

parties to include disclaimers during dissemination of campaign advertisements or promotional content, wherever synthetic content is utilised.

DHAKA: Bangladesh's Constitution Reform Commission on Wednesday submitted its report to interim government chief Muhammad Yunus, proposing the replacement of the state principles of secularism, socialism and nationalism.

The commission set up by the Yunus administration, after the ouster of Sheikh Hasina as prime minister following a mass agitation led by students, also proposed a bicameral parliament for the country and a two-term limit on a premier's tenure.

The three principles are

"fundamental principles of state policy" in the country's constitution. Under the new proposals, only one -- "democracy", remains unchanged.

"We are proposing five state principles -- equality, human dignity, social justice, pluralism, and democracv -- for reflection of the great ideals of the 1971 Liberation War and the people's aspiration during the 2024 mass upsurge," commission chairman Ali Riaz said in a video statement.

The report kept "democracy" alone in the constitution's preamble alongside the four new principles as it presented

The commission suggested the lower house be based on majority representation and the upper one on proportional representation.

The commission believes that one of the main reasons the "autocratic authoritarianism Bangladesh" faced over the past 16 years was because of the absence of an institutional power balance and concentration of power in the prime minister's office.

The report said, therefore, it proposed the creation of a constitutional body named the National Constitutional Council to establish a system of checks and balances between the three branches of the state and the two executive positions — the prime minister and the president.

During the visit, Jaishankar will also have meetings with representatives of the incoming administration, as well as some other dignitaries visiting the US on that occasion.

In a press release, MEA said, "On the invitation of the Trump-Vance Inaugural Committee, External Affairs Minister (EAM) Dr S Jaishankar will represent the Government of India at the Swearing-In Ceremony of President-Elect Donald J. Trump as the 47th President of the United States of America.

The ceremonial event is set to take place on January 20, approximately two weeks after Trump's electoral college win was certified by the US Congress.

Earlier on January 6. Trump's election victory was certified ahead of his inauguration with no objec-



tions from any lawmakers as the tally of states was announced on the House floor. Donald Trump won 312 electoral votes while Harris got 226 votes, a total that was confirmed during the certification on Monday, marking the final step in the election process before Trump returns back to the White House on January 20.

Republican lawmakers gave a standing ovation in the chamber when Harris announced Trump's victory was certified. The Hill reported. A bipartisan standing ovation broke out in the House Chamber after HArris announced that the joint session of Congress was dissolved.

Kawaki Bazar Bridge In Kulgam's **Qaimoh Sees No Progress**

KULGAM: The old Kawaki Bazar bridge in South Kashmir's Kulgam district, dismantled four months ago, has seen no progress, leaving residents of over ten villages in hardship. Locals alleged that the con-

cerned authorities have taken the work for granted, and the temporary footbridge has also been closed, further adding to the sufferings of people, especially the elderly.

The Kawaki Bazar bridge at Qaimoh area was dismantled on October 21st last year due to its narrow structure, which caused traffic congestion.

A temporary footbridge was erected to provide convenience to the people.

Locals told KNO that the bridge is crucial as it connects almost ten villages to the Jammu-Srinagar National Highway. Unfortunately, no work has been carried out on the bridge since its dismantling, they said.

Jahangir Ahmad, a local, said, "When the administration doesn't have any planning, why did they dismantle the bridge? The bridge needs to be completed quickly as it holds great importance." He said dismantling the

bridge without any clear timeline for completion has left them stranded. "The suffering of the people, especially the elderly, could have been avoided if the authorities took their responsibilities seriously."

Another local said the authorities seem to have forgotten that the bridge connects vital areas. "Their indifference is causing us daily hardships and a temporary footbridge was a solution, but now it is also closed now. How much longer will the administration ignore our pleas for basic infrastructure?"

He also pointed out, "It is a harsh winter; if any emergency arises, what can we do? Even vehicles have to travel kilometers to reach here. Authorities should start work on it as soon as possible and the temporary footbridge needs to be reopened for commuters on a priority basis.'

Police Arrests Fraudulent Gold Smith From Bijbehara

SRINAGAR: Police in Srinagar on Thursday have apprehended an individual involved in the sale of counterfeit gold ornaments.

"On 09/01/2025, a written complaint was lodged at Police Station Nowhatta by an individual namely Nisar Ahmad Bhat, a resident of Bindoo Kokernag, at present living in Srinagar & working as a storekeeper at Lalmandi Srinagar, stating therein that he had purchased gold ornaments from one Mehraj Din Qazi, the proprietor of M/S Soliya Ornaments in Bijbehara. Upon close observation once purchased, they turned out to be fake," a police spokesman said in a statement.

In this connection, police said that a case under FIR number 02/2025 under relevant sections of law was registered in Police Station Nowhatta.

Acting swiftly, the investigating team arrested the accused

shopkeeper identified as Mehraj Din Qazi son of Gh Mohammad Qazi resident of Bijbehara, and seized the fake jewellery, police said.

During questioning, the accused admitted to deceiving customers by embossing fake hallmarks on gold-like ornaments. The investigating team also learnt that the accused had been making home deliveries of these counterfeit items to various locations of Srinagar City, including Nowhatta, the statement added. The laboratory tests of the seized gold jewellery have confirmed that the ornaments in question are indeed counterfeit, police said, adding that the investigation of the case is going on to uncover any further links in this fraudulent network.

"People are requested not to fall prey to fraudulent elements who dupe people on various counts including sale of golden ornaments on cheap rates," police said.

hief Minister Omar Abdullah on Wednesday stressed on adopt ing urban planning strategies for planned development, an initiative that if taken forward will make a redeeming difference to the cities of Srinagar and Jammu. According to the initiative named as the Land Pooling Policy, landowners and developers will pool land for development, ensuring infrastructure like roads, parks, and amenities, with remaining land returned to owners. The policy aims to create sustainable infrastructure and enhance land value, benefiting both the government and stakeholders. The meeting also reviewed policies such as Transferable Development Rights (TDR) Policy. Under the policy, the potential use of TDR for heritage properties, ensuring their preservation while enabling urban growth was also discussed. Similarly, the discussion of the concept of Transit-Oriented Development (TOD) focused on sustainable urban mobility and planned development around public transport hubs.

The implementation of the schemes could make a redeeming difference to the land use, infrastructure and transportation in the union territory. More so, in the urban areas of the region. Srinagar needs urgent urban planning. Over the past few decades, Srinagar has witnessed unregulated urban growth. Colonies after colonies have come up across the city, few of which are planned. This growth continues unabated. A forbidding mass of cement and bricks has taken shape in all its ugliness across large swathes of the orchards, green highlands, paddies, swamps, flood plains, canals and of course even on Dal lake. Planned urban growth is not merely about infrastructure; it is about creating spaces where communities thrive. For Srinagar, this means harmonizing modernization with its rich cultural legacy.

Srinagar's modern urban growth is tied up with the political conflict in the state. As the government collapsed in the nineties and the internal migration to Srinagar from the countryside created the need for housing on a mass scale, the land mafia took over. In the subsequent years, the vacant spaces got filled up and Srinagar expanded.

Government also needs to address the public transportation in Srinagar. The city is now grappling with a modern-day menace: relentless traffic congestion. The latest data reveals that Kashmir recorded over 69,000 vehicle registrations in the fiscal year 2023-24, with Srinagar alone contributing more than 26,000 new vehicles. This surge in vehicle registrations has brought Srinagar's total vehicle population to over 335,000, exacerbating the already critical traffic situation.

To mitigate this situation, a paradigm shift towards public transport is urgently needed. A reliable, and efficient public transportation network can serve as a viable alternative to personal vehicles. reducing the number of cars on the road and easing congestion. The introduction of modern buses, and even metro lines could transform the way people commute within the city. Although modern buses have been introduced, they are not sufficient enough in numbers to address the city's transportation problem. It is essential that the government acts decisively to implement these plans, ensuring a better future fo

US-India: Diamonds Are Not Forever

he US state department disclosed on Thursday in an accounting of gifts received from foreign leaders during 2023 that Prime Minister Narendra Modi's was the "priciest" gift that President Biden received. rather, his wife Jill Biden received - a diamond valued at \$20,000 (over Rs. 17 lakh.)

To an observer of the US political culture, it would invoke the analogy of a Middle Eastern sheikh from the Gulf region kow-towing to curry favours from the White House. Indeed, troubling questions do arise.

Touched to the quick, Delhi reacted immediately to put the record straight - that it was an artificial lab-grown diamond with a cost price between Rs. 15000-25000, which would put the value of the gift between Rs. 1.1-1.9 lakh only.

What Delhi didn't say, or more likely its bureaucrats didn't know, is that while real diamond has no limits on its shelf life, a lab-grown diamond may look the same, but has zero resale value. Suffice to say, the brilliance of the relationship may be gone, but the stone won't lose its lustre and doesn't get worn out with time.

Delhi's clumsy clarification, unattributed of course, makes things worse. Actually, none of the three famous people looks good in this controversy. It makes Jill Biden who apparently took the gift seriously and retained it for official use, somewhat foolish.

A lavish edition of Mahabharata, the great epic that tells a millennia-old tale about the futility of war would have probably made a more appropriate gift from Modi to Biden who poked his nose into a fratricidal strife in distant Eurasia, undermined a nascent peace treaty between two brothers, and coaxed the impetuous kid brother to instead go into a futile proxy war that ultimately caused the death of hundreds of thousands of his subjects and destroyed his kingdom.

Biden is still unrepentant. Earlier this week, columns of American military vehicles loaded with weaponry were crossing border from Iraq into Syria in anticipation of some war in the making just 4 years after the old one ended.

However, the good part is the diamond controversy is emblematic of the matrix of US-Indian relationship beneath the rhetoric. Some sixteen months after gifting the diamond, BJP accused the Biden administration of conspiring to overthrow Modi government. Which means that the estimation of Jill Biden being a 'silvery influencer' in the White House was a wrong notion. The Biden administration is no longer believing that in Modi government it has a potential ally to curb China's rise as superpower that would spell doom for the 5-century old Western hegemony in the world order. The Biden Team belatedly realised that Delhi was not only boosting the ties with Russia but also had a master plan to engage with China bilaterally and work out the guard rails of co-habitation as immediate neighbours. The common refrain is that constraints in India's development path forced the government,

under pressure from the industry and business, to ease the tensions with China to attract investments and boost trade. But that is not the whole story. Chinese commentaries are stressing that the two countries have a higher destiny that is easier to realise if they cooperate rather than undercut each other. There is much truth in this, as the colonial history would testify.

At any rate, the defining moment in the US-Indian relationship came with the G20 Summit, which Modi hosted in the third quarter of 2023, when Biden came to Delhi and in tandem with his Canadian counterpart Prime Minister Justin Trudeau took up with Modi the report of the Five Eyes (US, Canada, UK, Australia and New Zealand) that India was involved in transnational crimes in North America.

The whiplash, albeit administered in private, came as a bolt from the blue when Indian diplomacy



CEASEFIRE IN GAZA A fragile calm amid unending struggle

ance of power, the brutal reality of occupation, the suffocating blockade – these

The announcement of a ceasefire agreement in Gaza undoubtedly marks a critical moment in the ongoing conflict. For those of us who have witnessed, experienced, and then watched, mourned, and advocated from afar, this pause in hostilities provides an opportunity to reflect on the past 15 months, and the heavy price paid for this fleeting calm.

As a Palestinian, receiving this news feels like standing in the eye of a storm, in a moment of ghostly calm surrounded by chaos and destruction. For me, at least it marks the end to the bloodshed, but the fact is, the ones we lost will never return, and these scars will never heal. How would a ceasefire ever change that fact?

Ceasefires are often hailed as victories for diplomacy, but to me, they are more like pauses in a constant nightmare. This latest agreement is a reminder that, for the people of Gaza, survival often hinges on the fragility of politics. Children, mothers, and fathers carry the unbearable weight of uncertainty. I find myself asking: Is this truly a step towards peace, or just another chapter in a story of delayed justice and extended suffering?

The ceasefire's terms, reached under immense international pressure, include a halt to air strikes and rocket fire, along with provisions to allow humanitarian aid into Gaza. These measures are desperately needed. But their necessity is also an accusation of the international community's failure to act sooner to prevent the crises that make such measures critical. Aid is vital, but it cannot heal the wounds of oppression, wide open and bleeding. Temporary peace cannot replace the right to live freely and to dream beyond survival.

The International Court of Justice (ICJ), the International Criminal Court (ICC), and their arrest warrants, which were meant to address crimes committed against our people, are overshadowed by political inaction. Will the world pursue these mechanisms when the war ends, or will justice be buried under a mountain of



bureaucracy and indifference? The failure to enforce accountability before, during, and after the conflict reveals how deeply flawed these institutions are.

Aid is vital, but it cannot heal the wounds of oppression. Temporary peace cannot replace the right to live freely and to dream beyond survival. This prompts another crucial question: Will Palestinians ever get their rights to have full control over their political and diplomatic path to justice, or will they always be eliminated from the political stage and portrayed to fit in the victim's role? While international recognition of our plight is critical, we must chart a path towards independence from unreliable global powers.

For Palestinians, especially those in

Gaza, the siege is its own kind of war. It is violence without bombs, but no less devastating. The blockade, now in its 17th year, has eroded the fabric of life. It has robbed families of opportunities, denied them access to basic rights, and imposed a daily struggle that defies the bounds of human endurance. How do we rebuild a life in such conditions, knowing that this ceasefire might crumble as quickly as it came? How do we dream of a future when the present feels like an everlasting state of mourning?

During the war, decisions such as halting the funding of the United Nations Relief and Works Agency for Palestine Refugees (UNRWA) exacerbated the humanitarian crisis. The inability of the international community, including entities as disparate as the UN, the G8, or BRICS, to intervene in time to restore such vital lifelines for Palestinians further highlights its failure to protect civilian life and uphold humanitarian law. What happens when the safety nets, already too fragile, are arbitrarily stripped away without global resistance powerful enough to alleviate the crisis?

The international community, particularly Western powers, must confront their role in preserving this cycle. Statements of support for ceasefires ring hollow when they are not accompanied by meaningful action, accountability, protection for civilians, and a real commitment to addressing the root causes of this conflict. The imbalare not peripheral issues. They are the core of the problem.

How can we trust the same US administration – led for now by Biden and soon Trump – that pressured for this ceasefire when its actions have consistently undermined peace in the region? Decisions by the first administration of President-elect Donald Trump to relocate the US embassy to Jerusalem and recognise the Golan Heights as part of Israel are stark reminders of an agenda that prioritises power over justice. Moreover, the fear remains that this administration will shift its focus to the West Bank, transferring the same policies of violence and displacement there. Such decisions show that any pause in violence does not equate to a shift in policy or priorities.

As I process this moment, I feel both a flicker of hope and a tide of anger. Hope that this pause might save lives, and anger that it has taken so much suffering to reach even this fragile point. The cameras will turn away soon, the world's attention will shift, but for us, this is not an end. Ceasefires are not peace. They are moments of quiet in an unending storm. Until justice is realised, until dignity and equality are more than distant dreams, the cycle will continue.

This is not to diminish the significance of the ceasefire for those whose lives hang in the balance every day. For many, it means the difference between life and death. But as a Palestinian, I cannot ignore the deeper truth: peace is not just the absence of war. It is the presence of justice. It is the freedom to live without fear, to rebuild without the certainty of destruction, to dream without limits. Anything less is not peace. It is survival. And survival is not enough for people who deserve so much more.

New AI Method To Pick Up Arthritis, Lupus Early In **High-Risk Patients**

rtificial intelligence (AI) can significantly aid in early detection of autoimmune diseases. like rheumatoid arthritis and lupus especially in high-risk patients, leading to better outcomes, finds a study.

In people with autoimmune diseases, the immune system mistakenly attacks their body's healthy cells and tissues. Some well-known diseases include type 1 diabetes, multiple sclerosis, lupus, and rheumatoid arthritis.

Early diagnosis is critical and may improve treatment and better disease management, said the team led by researchers from the Penn State College of Medicine.

Using machine learning, a type of AI, the team developed a new method that could predict the progression of autoimmune disease among people with preclinical symptoms

These diseases often include a pre-



clinical stage before diagnosis that's characterised by mild symptoms or certain antibodies in the blood.

The method dubbed Genetic Progression Score or GPS, could predict the progression from preclinical to disease stages.

In the study, the team used GPS to analyse real-world data to predict the progression of rheumatoid arthritis and lupus.

Compared to existing models, this methodology was found between 25 and 1,000 per cent more accurate in determining mild symptoms that would move to advanced disease stage, the findings showed.

"By targeting a more relevant population—people with a family history or who are experiencing early symptoms—we can use machine learning to identify patients with the highest risk for disease," said Dajiang Liu, Professor, Penn State College of Medicine. Liu noted that this can also help "identify suitable therapeutics that may be able to slow down the progression of the disease"

Accurate prediction of disease progression using GPS can enable early interventions, targeted monitoring, and personalised treatment decisions, leading

Having Sleep Disorders? Melatonin Is No 'Magic Pill', Say Experts

hen 35-year-old Shruti Nagpal from Noida faced sleep issues, she tried 'melatonin gummies' on an experimental basis.

"They helped soothe my mind and eventually helped me sleep. I spoke to my doctor, who prescribed them for me as an experiment," said Nagpal, a media professional.

However, melatonin isn't the quick fix. Experts advise against relying on the popular supplement and suggest concentrating on "sleep hygiene", which includes keeping a regular bedtime, relaxing your mind, staying active, and avoiding screens or devices at least an hour before sleep.

Melatonin, available in various forms like gummies, pills, and liquid, has become a go-to for many with sleep problems. For the unversed, the supplement is a synthetic version of the hormone produced naturally by the pineal gland in the brain that helps regulate sleep-wake cycles.

Several health experts caution that while the supplement may seem like a safer choice, it is no 'magic pill'. They recommend that individuals struggling with sleep issues consult a psychiatrist or undergo psychotherapy, including cognitive behavioral therapy (CBT), before turning to melatonin supplements.

"People having underlying anxiety or depression are unlikely to respond to melatonin supplements. It is possible that everything that happens during the day affects their night-time sleep.

"They will need to consult with a psychiatrist, and therefore, should not resort to melatonin," says Dr Neetu Jain, who deals with sleep-related breathing disorders at Pushpawati Singhania Hospital & Research Institute, New Delhi.

Supporting Dr Jain's point is Dr Sanjay Saxena, principal director and head of



Neurology Department at Max Hospitals in Patparganj, New Delhi and Vaishali, Ghaziabad, as he recommends that individuals try CBT before resorting to pharmacological treatments for sleep related problems.

CBT is a talking therapy in which a patient's thought processes are addressed to help them cope with challenges in life.

The doctors, in general, are of the opinion that these supplements are probably most beneficial for people with irregular work shifts (as long as it's a temporary situation), those crossing time zones, or individuals recovering from periods of poor sleep patterns, like during exam preparation.

Melatonin levels are known to rise as the sun sets, reaching their peak between midnight and 3 am, before gradually decreasing.

"So, that's why, if we synchronise our

bedtime with our melatonin, we will get a good night's sleep and wake up feeling rested. But if we function against this, it can disrupt the circadian rhythm (body clock)," explains Dr Manvir Bhatia, a senior consultant neurologist, who runs Neurology and Sleep Centre in New Delhi.

Shift-workers are especially prone to such disruptions, as their day and night differentiation is affected.

Health experts further clarify that melatonin supplements are not sedatives or sleep-inducing drugs, but rather "physiological supplements" that support the brain in restoring the quality, structure, and pattern of sleep.

For example, Dr Arun Garg, chairman, Neurology and Neurosciences, Medanta The Medicity, Gurugram, explains that while melatonin supplements stimulate hormone production, sleeping pills like benzodiazepines work by affecting brain receptors that release GABA.

GABA, or gamma-aminobutyric acid, is a chemical that promotes sleep by slowing brain activity.

The doctors also advise those using melatonin on their own to assess if it is still needed after its intended purpose has been fulfilled

For instance, Tanyaa Sharma, a 32-yearold cafe server in Goa, shared that she used melatonin for 10 days to stabilize her routine after being diagnosed with ADHD.

Sharma now takes it occasionally when her sleep schedule is off.

The experts also claim that melatonin supplements typically serve their purpose within four to six weeks, and prolonged use can lead to side effects like grogginess and nausea.

"There is also talk of how these supplements can impact one's immunity and also suppress the internal production of melatonin, even though there is not enough evidence to substantiate," says Dr Bhatia.

Ultimately, doctors emphasize the importance of good "sleep hygiene", which includes avoiding stimulating activities or drinks in the evening, reducing screen time, and engaging in relaxing activities like reading or listening to calming music before bed.

Dr Garg suggests that individuals avoid caffeine, screens, and video games before bed and instead opt for a gentle 30-minute walk.

Even cafe server Sharma acknowledged that melatonin, by itself, is far from a solution for sleep disorders.

"I take melatonin and then turn off the lights, stop using devices, and only allow myself to read books sometimes when sleep doesn't arrive still. I've realised over time that it's not a magic sleeping pill -- in fact, very different than that," she added.

Book Suggests Ways To Mitigate Human-Animal Conflict

Conservationist G Susheel, who has spent nearly 50 years in the jungles of India, has come out with a real-life account of the man-animal conflict in which he also suggests how small steps can resolve much of the tension and keep both the animals and humans safe.

In "Rogues: Elephants, Maneaters, Poachers", he further discusses how perilous the land and laws are for wildlife as well as people.

Susheel wonders how safe will wildlife hotspots remain as the pressure of 1.4 billion people on them increases rapidly He says it is time to urgently relook conservation in the agricultural landscape, where huge numbers of wildlife exist.

According to him, tigers and other animals do not have any protection in the agri-landscape and a better management plan for dealing with these big cats needs to be put in place.

"For maneating tigers and leopards, a standard operating procedure has to be put in place to deal with these problem animals. The local populace usually gets terrorised by these animals. It has to be seen to be believed to see the fear that people go through during all such episodes in any affected area, Susheel writes in the book, published by Storywell Books Foundation.

He says incidents of man-animal

He suggests that in the event of an attack on humans or cattle kill, a waitand-watch policy should be adopted to identify the errant animal among the many in the specified habitat.

The moment there is an incidence of man-eating, a series of immediate steps should be taken to remove the problem animal, by following a well-tested, scientifically devised SOP," he writes.

On the shooting tranquiliser darts, he says there is no training provided.

"It is better to train some forest staff in the art of shooting - experts to do the real shooting of the dart and allow vets to accompany them to calculate weights and dosages and carry the drugs and to aid in

90k Salaried Individuals Withdraw Wrongful Tax Claims Worth ₹1,070 Crore

NEW DELHI: As many as 90,000 salaried individuals, both from PSUs and the private sector, have withdrawn wrongful tax deductions claims totalling Rs 1,070 crore as of December 31, 2024, government sources said on Thursday.

During various search & seizure and survey operations conducted by Income Tax Department, it has come to notice that various individuals are claiming incorrect deductions, under sections 80C, 80D, 80E, 80G, 80GGB, 80GGC, in their ITRs, leading to reduction of tax payable to the government.

During investigation, it was revealed that such individuals are employees of organisations operating in diverse fields including PSUs, big corporations, MNCs, LLPs, Private Ltd Companies, etc, sources said. Also, most of them who claimed wrongful deductions were working in the same company.

Analysis of the information with the department showed that there is a vast mismatch between total deductions under section 80GGB/80GGC claimed by taxpayers in their ITRs as against the total receipts shown by the donees in their ITRs.

deductions Similarly, claimed under sections 80C, 80E, 80G also appear to be suspicious in nature, sources said.

They said, a list of common employers (TDS deductors) has been identified and tax depart-



ment would be reaching out to as many persons as possible who are suspected to have claimed bogus deductions under section 80E, 80G, 80GGA, 80GGC and other deductions.

"Further, verification has revealed that certain unscrupulous elements have misguided taxpayers for claim of incorrect deduction/refunds," a source said. Sources said the department has been conducting outreach programmes with employers to spread awareness about the consequences of claiming incorrect deductions in the ITRs and corrective measures which can be taken by the taxpayers to rectify the errors of omission or commission.

'Till 31st December, 2024, approximately 90,000 taxpayers have withdrawn incorrect claim of deductions amounting to Rs 1,070 crore approx in their ITRs and have paid additional taxes," a source said. As per the provisions of

Income-tax Act, 1961, taxpayers can file updated returns on payment of some additional tax rectifying the errors within two years from the end of the relevant assessment year, for AY 2022-23 to 2024-25.

The UK-based higher education firm QS evaluates countries' readiness to meet evolving global job market demands. Ranked 25th, India is recognised as a 'future skills contender'. The country excelled in the 'future of work' metric, achieving the second-highest

global score of 99.1, just behind the United States. This index evaluated over 190 countries, over 280 million

job postings, over 5,000 universities, 5 million employer skill demands reviewed and 17.5 million research papers. QS World Future Skills Index classifies economies into four categories based on their overall performance - future skills aspiring, practitioner, contender,

and pioneer. India is positioned



in the contender category.

betrayed by the very system I trusted." Sameer is just one of many Kashmiri men grappling with the often-overlooked reality of domestic harassment. According to him, in Kashmir the silence of harassed husbands echoes louder than their voices.

The recent suicide of Atul Subhash in Bengaluru, allegedly due to harassment and false accusations by his wife, has sparked a national conversation about domestic violence against men. His death brought allegations of harassment and false cases by his wife, Nikita, and her family to the forefront.

Pertinently, Atul was found dead at his home, leaving a note and video accusing his wife. His family claimed he was under immense stress due to ongoing legal battles, leading to the arrest of Nikita, her mother, and brother on charges of abetment of suicide.

In Kashmir, this tragic event has emboldened some husbands to finally speak out about their own experiences of abuse and manipulation.

Abrar (name changed) is another victim of alleged harassment. His wife's demand to move out of his family home and live with her parents became the primary point of contention. "I offered her a separate space in my own house," he said, "but she insisted I either live with her parents, rent a place nearby, or build a new house. This was unreasonable and unacceptable."

Despite numerous attempts to resolve the issue amicably, Abrar was eventually forced to seek recourse through the Sharia court. His wife now lives at her parents' home, and their 11-year-old daughter resides with her. "I pay Rs 15,000 monthly for her maintenance, but the emotional toll is immense. My daughter has become distant, and I fear she has been brainwashed against me." Abrar recalled a heartbreaking moment in court when the judge asked his daughter his name, and she responded with her maternal grandfather's name.

"The judge was furious and asked where the child had been living all these years. When he learned she'd been with her maternal grandparents for five or six years, he commented on how inappropriate the values being instilled in her were."

For Abrar, the entire ordeal has been emotionally draining.

"I just want to be a father to my daughter, but it feels like I am being punished for wanting to keep my family together. This isn't just about me—it's about the impact on my child and the values she's being taught."

For Umar (name changed), the situation has been even more distressing. After a visit to his in-laws, he was humiliated by his wife's uncle. The following day, he received calls from the police station and the women's police station, accusing him of defamation.

"When I arrived, my wife's uncle taunted me, saying, 'Gach tsandun sa ladki'—'Go look for her' in a dismissive manner. I left feeling humiliated," Umar said.

The next day, things took a dramatic turn. "I received a call from the police station, accusing me of defaming my in-laws. Soon after, I got another call, this time from the women's police station. It felt like they were trying to silence me and shift the narrative."

Umar has been separated from his child for five months. He said that his wife uses excuses like the child's ill health to keep her away. His father-in-law further exacerbates the situation, openly boasting about raising the child and demanding exorbitant sums for her upbringing. "It's as if I don't exist," Umar lamented.

"He openly warned me to use all my power. Then he handed me a list of bills, claiming the child's upbringing had cost Rs 22 lakhs. He included Rs 2,00,000 for milk and Rs 2,50,000 for air tickets for travel expenses, all to prove that they were raising my child instead of me,"

Despite the challenges, Umar said that he is determined to fight for his rights as a father.

"I'm not asking for much—just the chance to be a father to my child. But they are making it a battle over ego and control. My child deserves better than this."

Dr Peerzada Merajudin, a lawyer who holds a doctorate in conflict studies, attributes the harassment to many factors.

He said that this sociological phenomenon arises when material culture—marked by rapid advancements like motor cars, modern facilities, and new homes—outpaces non-material culture, which fails without fully investigating the situation. Even though the man may have spent large sums of money on maintenance for the children or wife, years later, it is often discovered that the woman's claims were false."

He believes that men, especially, have very few legal options to defend themselves and often get caught in a situation where they can't even properly present their defense.

"The process is so overwhelming that they are left with the painful choice of either paying a large maintenance fee or facing imprisonment, so long as laws are misused 'husbands' may continue to face harassment at the hands of their wives.

Pay commissions hold extensive consultations with central and state governments and other stakeholders before giving recommendations to the government. The pay commission has a key role in deciding salary structures, benefits and allowances for government employees. Most of the state-owned organisations follow the commission's recommendations.

The 7th Pay Commission was constituted in 2014 and its recommendations were implemented on January 1, 2016.

Sources said around 50 lakh central government employees, including defence personnel, will benefit from the decision.

Also, about 65 lakh pensioners, including defence persons, will also see an uptick in their pensions, they added.

In Delhi alone, about 4 lakh employees will benefit, including defence and Delhi government employees, from the recommendations of the panel. Delhi is going to assembly polls on February 5, 2025.

In past, salaries of Delhi government employees increased with the central pay commission, sources added.

The 7th pay commission saw an expenditure increase of Rs 1 lakh crore for fiscal 2016-17.

Implementation of the pay panel's recommendations provides a significant boost to consumption and economic growth, along with improved quality of life for government employees.

Usually, every 10 years, the central government constitutes a pay commission to revise the remuneration of its employees.

The pay commission also recommends the formula for the revision of dearness allowance and dearness relief for central government employees and pensioners with a view to compensating them for inflation.

Several state governments also revise the remuneration of their employees on the lines of the central pay commission.

Hard-liners in Netanyahu's government were still hoping to stop the deal, though a majority of ministers were expected to back it.

Finance Minister Bezalel Smotrich's Religious Zionism Party said in a statement that its condition for remaining in the government would be a return to fighting at the end of the first phase of the deal, in order to destroy Hamas and bring all the hostages back. Far-right police minister Itamar Ben-Gvir has also threatened to quit the government if the ceasefire is approved.

In Jerusalem, some Israelis marched through the streets carrying mock coffins in protest at the cease-fire, blocking roads and scuffling with police.

Despite the hold-up to the cabinet meeting, political commentators said the latest delay would likely be resolved and that the ceasefire was a done deal.

The White House also downplayed reports of a snag in the ceasefire deal on Thursday. Jonathan Finer, the deputy national security adviser, said in an interview with CNN: "We fully expect the deal to be implemented."

Father Loses

in just a few days. Now, my only daughter is fighting for her life. I have nothing left but her," he said, his voice trembling with a mix of grief and hope," dejected Aslam said.

"I couldn't save my other children, but I'll do whatever it takes to save her," he said, adding that her condition remains critical.

Aslam said his children were healthy until last Sunday when they began showing symptoms of minor vomiting and fever. They were rushed to the hospital, but six out of seven, including his five children and his maternal uncle, succumbed to the illness, he said.

"My daughter is still alive, but I fear I may receive news of her death any moment," the devastated father expressed.

Aslam expressed frustration over the lack of timely support from authorities, saying that while the Deputy Commissioner and SSP visited his residence and provided some assistance, no representative from the government, especially the NC-led administration, has come forward to help.

He urged the government to expedite the investigation to identify the cause of the outbreak and take immediate action to prevent further loss of life. "I have lost everything, but I don't want others to suffer the same fate. The government must act quickly to save lives in this area," he pleaded.

The victims of the tragedy have been identified as Nabina, Jabeena, Safeena, Zahoor Ahmad and Mohammad Maroof, along with their maternal uncle, Mohammad Yousuf. The lone surviving daughter battling for her life is Yasmeena Jan.

The outbreak has caused widespread panic in Badhaal village, with residents increasingly worried as the illness continues to claim lives, including those of children. The situation is worsening as the fatalities are not limited to a single family, leaving every household anxious about the health of its members.

The symptoms observed in victims include high fever, excessive sweating, vomiting and episodes of loss of consciousness. Despite extensive medical interventions, the precise cause of the illness remains unidentified. The doctors are treating patients symptomatically while awaiting conclusive findings.

The tragic sequence of events reportedly began on December 8, 2024, when Mohammad Fazal and his four children died. This was followed by the deaths of three children from another family, led by Mohammad Rafiq. Rafiq's pregnant wife also passed away on December 23, reportedly due to medical negligence.

J&K Police have constituted an 11-member Special Investigation Team (SIT) to probe the mysterious deaths reported in the area over the past 45 days. The SIT is headed by Superintendent of Police (Operations) Budhal, Wajahat Hussain and includes experts from forensic medicine, toxicology, microbiology, paediatrics and pathology, as well as local police officials.

The quantity of Petrol or Diesel which was paid by the Consumers was not guaranteed to them in absence of the certification and checks by the concerned agencies.

In light of these facts all such dispensing units were sealed in Budgam, Bandipora, Baramulla, Pulwama, Shopian, Srinagar and Anantnag. Cases have been registered against the owners/operators of these sealed petrol pumps and legal proceedings under the relevant sections of the Legal Metrology Act and Petroleum Rules are underway.

The Order issued by Controller Legal Metrology J&K has mentioned that there are reports of various outlets operating in Kashmir valley in contravention of Section 24, Section 12, Section 30 and Section 26 of Legal Metrology Act 2009 which not only goes against the interest of Consumers but they also pose a serious hazard to the public safety as they are operating without any safety standards required from Petroleum and Safety Organisation.

The order further reads that these outlets are operating in violation of the terms and conditions laid down under Rule 141 of Petroleum Rules and the allied From XIII & Article 4 therein and this non-compliance with the Legal Metrology Act and the rules therefore compromises with the transparency and consumer interest. The breach of Petroleum Rules further jeopardizes the safe handling and storage of flammable substances like Petrol and Diesel.

Anuradha Gupta said the Legal Metrology will continue such drives to ensure compliance and deter future violations. Consumers are also advised to get fuel from authorised outlets only, she added.

Meanwhile, the department has urged consumers to be vigilant and report any short delivery at fuel stations to the department. The cooperation of consumers is vital in curbing illegal operations and ensuring fair and safe fuel distribution.

"All pending gazetted cadre recruitments will be made by the UPSC and then a decision will be taken about the recruitment agency for Ladakh whether the UT will have its own dedicated PSC or will affiliate with Jammu and Kashmir PSC. The immediate concern is that recruitment process should start for Ladakh," the Hill Council Leh chief said.

Since Ladakh was separated from Jammu and Kashmir and made a Union Territory on August 5, 2019, no gazetted cadre recruitments have been made in the absence of a PSC. There has been a demand from almost all bodies of Ladakh for age relaxation in the recruitments due to prolonged delay in advertisement of vacancies. The age relaxation demand is likely to be conceded by the UT administration, the sources said.

On 95 percent reservations for locals, 80 percent will go to STs, 4 percent to Actual Line of Control (ALC), 10 per cent to Economically Weaker Sections (EWS), one percent to SCs and five percent to others but they too will be domiciles of Ladakh.

"A blueprint for domicile will be ready within the next few days," he said. The non-gazetted recruitments in Ladakh UT were conducted on the basis of LRC (Ladakh Resident Certificate), which was a replica of State Subject used in the erstwhile State of Jammu and Kashmir of which Ladakh was third division besides Jammu and Kashmir.

As far as recruitment for the non-gazetted posts are concerned, the LAHDC Leh chairperson said the Recruitment Board for UT is now in place and divisional cadre posts which were earlier filled by the Staff Selection Commission (SSC) will be made by the Board while district cadre posts will continue to be filled by the Hill Development Councils.

Tashi expressed confidence that after completion of all formalities, the process for recruitment will be set in motion as early as possible.

LAB and KDA have been agitating for a four-point agenda including Statehood, Sixth Schedule status, dedicated PSC and two Parliamentary seats for Ladakh. While there was almost a breakthrough on recruitment, there has been no response from the MHA on Statehood and Sixth Schedule status. As far as two Parliamentary seats for Ladakh are concerned, the LAB and KDA have been told that this can be done only after delimitation for Lok Sabha seats is taken up after 2026.

"This gap affects the growth and adaptability of children, both boys and girls, as they struggle to align with changing times. This cultural disconnect often leads to disputes," he said.

Another significant factor is the influence of contemporary serials, which also contribute to this issue.

He believes that newly married couples often need support from their in-laws, but instead of providing this support, disputes are sometimes escalated into crises by family members.

Dr Mehraj said that from a legal perspective, while laws like IPC 498A exist to protect women, these should be applied judiciously. Divorce should only be considered in extreme situations, as 99.9 percent of marriages can be saved with understanding and compromise.

"Matrimonial disputes affect both parties deeply, with men often bearing the brunt mentally and professionally. To mitigate this, fast-track family courts should be established to resolve these cases more efficiently."

Badru Duja, an advocate who practices at the J&K High Court and sees matrimonial cases at family courts. He said victims typically fall into two categories : women and children, who are more likely to be victims of crimes. As a result, special laws have been created for their protection and these laws are being misused.

"In our society, certain individuals manipulate the law in a way that it benefits them rather than the intended victims"

"Women file domestic violence cases against their husbands, in-laws, or others. However, we rarely hear of a case where a mother-in-law files a case against her daughter-in-law, even though the law allows for this," Duja said.

According to him, this lack of awareness or understanding of the law in family courts is a significant issue.

"Initially, the law only allowed women to file cases against their husbands, but over time, it has been misused. The Supreme Court and High Courts have ruled that there are situations where a daughter-inlaw may file a false domestic violence case against her mother-in-law," he said.

Duja said that awareness among men is also low, as it is deeply challenging for a man when his wife files a case against him.

"Men often find themselves in severe physical and mental distress, and they rarely have the power to counteract it. Even a small notice from the court can cause a lot of trouble for a person who is otherwise law-abiding," Duja said.

"Men often find themselves overwhelmed when they receive multiple notices from various courts, police, and NGOs. This bombardment of legal notices can make them forget that they have the option to defend themselves"

Another problem, Duja said, is that courts are not proactive when men try to counter the cases against them.

"The court tends to believe the woman's claims

The accord requires 600 truckloads of humanitarian aid to be allowed into Gaza every day of the ceasefire, with 50 carrying fuel. The first phase of the agreement will also see Israel releasing more than 1,000 Palestinian prisoners, including many longserving fighters.

Israelis may find it hard to see Palestinian militants who were serving life sentences for their involvement in deadly attacks in their country, set free.

But successive surveys have shown broad support among the public for a deal that would see the hostages released, even at what is seen as a heavy price.

"This has to be the only choice that we take in order to continue surviving as a state and as a nation, knowing that we will do anything to save each other," said Jerusalem resident Chava Treitel.

While people celebrated the pact in Gaza and Israel, Israel's military conducted more attacks, the civil emergency service and residents said.

Around half of the dead were women and children, Zaher Al-Wahedi, head of the ministry said. He said the toll could rise as hospitals update their records.

Israel secured major gains over Iran and its allies, mainly Hezbollah, as the Gaza conflict spread. In Gaza, however, Hamas may have been crippled, but without an alternative administration in place, it has been left standing.

Reacting to the news of the ceasefire, Iran's Supreme Leader Ayatollah Ali Khamenei commended the "sacrifices and valor" of Palestinians and their resistance in the face of the year-long "Israeli aggression" that resulted in a ceasefire in the Gaza Strip and "forced the regime to back down."

"It will be written in books that one day, a Zionist group massacred thousands of women and children in the most horrific way and at the end, they were quashed," he said in a post on X.

The ceasefire will halt fighting that has razed much of heavily urbanized Gaza, killed over 46,000 people, and displaced most of the tiny enclave's pre-war population of 2.3 million.

The truce is likely to defuse tensions across the wider Middle East.

With 98 foreign and Israeli hostages remaining in Gaza, phase one of the deal entails the release of 33 of them, including all women, children and men over 50. Potential pitfalls

The war began when Hamas-led militants stormed into Israel in a surprise attack on Oct. 7, 2023, killing some 1,200 people and abducting around 250.

Under the deal reached Wednesday, 33 hostages are set to be released over the next six weeks in exchange for hundreds of Palestinians imprisoned by Israel. Israeli forces will pull back from many areas, hundreds of thousands of Palestinians would be able to return to what's left of their homes, and there would be a surge of humanitarian assistance.

The remainder of the hostages, including male soldiers, are to be released in a second -- and much more difficult -- phase that will be negotiated during the first. The latest incident on January 12, 2025, saw ten members of a family hospitalized after another community meal, with six children currently under treatment.

specially constituted teams of the Legal Metrology Department carried out simultaneous inspections in seven districts of Kashmir division where these outlets were operating illegally.

These special inspection teams were constituted for this purpose by way of a special order issued by the Controller, Legal Metrology and intensive inspection drives were carried out by the respective teams on Thursday during which it was found that these illegal fuel outlets were violating key legal standards and regulatory norms, including the use of unverified Nozzles and teampering with the measuring devices.

It was observed that these fuel dispensing units were operating without any authorisation either from the Oil Marketing Companies or the Petroleum and Safety Organization and the Nozzles which were used for delivering fuel to consumers were found the Satish Dhawan Space Centre in Sriharikota, and about 15 minutes after liftoff, the two small spacecraft weighing about 220 kg each were launched into a 475-km circular orbit as intended.

Yamal Conjures Messi Memories After Barcelona Runs Riot Over Madrid & Betis

BARCELONA: When Lamine Yamal glided past two Real Madrid defenders before coolly tucking the ball just inside the post, it was hard not to get a shiver that Lionel Messi was back in a Barcelona shirt.

He still wears dental braces, but Barcelona's teenage phenom has emerged as opponents' No. 1 problem thanks to his speed, creativity, and gorgeous goals from Messi's old spot on the right flank.

Yamal has run amok in back-to-back five-goal blowouts for Barcelona. He led its humiliation of Madrid 5-2 in the Spanish Super Cup final last weekend and helped demolish Real Betis 5-1 in the Copa del Rey on Wednesday.

Yet, beyond the goals, it is his grace with the ball that is conjuring up comparisons to Barcelona's greatest player. Yamal, like Messi, makes it look so easy as he flicks past defenders who always seem just one, or two, steps too slow. They also share an incredible

scoring touch with their left foot, whether scoring powerful strikes from distance or applying a finesse finish amid traffic as Yamal did against Madrid on Sunday.

"After Lionel Messi, he is our best player," Barcelona midfielder Gavi said about Yamal after the forward recorded an assist and scored the fifth goal to round out the thrashing of Betis.

Yamal has rewritten the records books for his precociousness, becoming La Liga's youngest scorer when he was 16. He also became Spain's youngest scorer in the history of last summer's European Championship, where he also scored the goal of the tournament in the semifinals before his team won the final over England.

This season, Yamal leads La Liga with nine assists of his 13 overall, to go with nine goals across all competitions.

Yamal is also a major reason why attack partners Robert Lewandowski and Raphinha have combined for 46 goals.



His passing makes the attack click and, as he often attracts two defenders, he opens up

spaces for teammates. "I have enjoyed Lamine for years, and now everyone is

doing the same. He deserves (the praise) he is getting,' said center back Pau Cubarsí,

who is also 17 and another piece of Hansi Flick's rejuvenated Barcelona.

Cubarsí credited the winter break for helping Barcelona start 2025 in fine fashion. The team hit a rough patch in late November and December after a spectacular start to the campaign and suffered nearly inexplicable losses at home to minnows Las Palmas and Leganes.

That dip let an in-form Atletico Madrid take the lead of the domestic league. Barcelona is six points adrift of Atletico in third place. Madrid is second at one point back.

Barcelona visits Getafe on Saturday. Three days later it visits Benfica in Portugal as it resumes the Champions League group phase sitting second in the standings behind Liverpool.

Araújo playing amid rumors of a move

Iñigo Martínez's right hamstring injury might actually save Flick from a headache. Spanish sports media has been rife with rumors that Barcelona defender Ronald Araújo is considering a transfer after not seeing much playing time following his return from a leg injury this season. He has been linked to interest from Juventus.

But Araújo replaced Martinez after he was hurt during the Spanish Super Cup final. He then started for Barcelona against Betis. With Martínez expected to be sidelined for a month, Araújo has become Flick's logical pick to accompany Cubarsí in the heart of the defense.

This week, Barcelona club president Joan Laporta said the club was talking with Araújo "to find a solution" after saying that they wanted the Uruguay central defender to stay.

Atletico on a record roll of 15 wins

Atletico will aim to add to its club-record streak of 15 wins across all competitions when it plays at Leganes on Saturday.


