## Police Detect 150 Fake Finance Companies In J&K

ammu: The crime branch of Jammu and Kashmir police has detected 150 finance companies operat-ing in the state allegedly without any registration from the Reserve Bank of India (RBI). These have de-frauded gullible depositors to the tune of Rs 80 crore. Cases have been registered against 40 such allegedly fake companies, mostly in Jammu involving over

Disclosing this to Kash¬mir Observer, the inspector general of police, crime and railways, Masood Chaudhary, said over 99 per cent or the companies were fake and had defrauded people mostly from rural areas in the name of higher interest on their deposits. Most of these operators are be-lieved to have gone abroad along with their families while some of them have declared themselves bankrupt and closed down their companies.

Chaudhary said the cases were registered on receipt of complaints from the affected people. A spe-cial team of sen-ior police offi-cials, headed by the deputy inspector gen¬eral (DIG) of police, crime and railways, Prem Kumar, has been constituted to investigate the cases. He said some of the accused have been apprehended while some more were likely to be arrested shortly.

In the absence of more stringent laws, Chaudhary said, police were finding it difficult to intervene in the matter. It can take action only after a formal com¬plaint is received. Some of the accused had defrauded the depositors to the tune of Rs 10 crore to Rs 15 crore. He said some special teams had been rushed to places like Mumbai and other major cities across the country to apprehend the culprits.



The opposition voiced strong reservations, labeling the initiative an "assault" on the Basic Structure of the Constitution. Following which, Union Ministers Amit Shah and Arjun Ram Meghwal had suggested referring the bills to a Joint Parliamentary Committee for scrutiny. The JPC will have 90 days to review the bills however, it may request for an extension.

#### **Historical Context of** Simultaneous Elections in India

India's tryst with simultaneous elections is not new. The country's first general elections, held between

October 25, 1951, and February 21, 1952, marked the initiation of a unified electoral process, wherein Lok Sabha and state assembly elections were conducted simultaneously. The elections were conducted over a span of 100 days, reflecting the logistical complexity of managing a nation as vast and diverse as India.

However, the model faced challenges early on. The reorganization

of states and the premature dissolution of many state assemblies disrupted the synchronicity of elections. Although efforts were made to sustain this system, with simultaneous elections held in 1957, 1962, and 1967, the dissolution of the Lok Sabha in 1970 and subsequent statelevel disruptions led to the eventual fragmentation of this practice. By 1971, the unified electoral process had given way to staggered elections, driven by internal and external political complexities.

#### The Push for 'One Nation, One Election' under Modi

After a protracted hiatus, the idea of simultaneous elections has re-emerged in contemporary Indian politics, particularly under the leadership of Prime Minister Narendra Modi. In his 2019 Independence Day address, PM Modi highlighted the growing support for this initiative, drawing parallels with the successful implementation of the Goods and Services Tax (GST), branded as 'one nation, one tax.' He reiterated the need for synchronized elections during discussions with political leaders in June 2019 and emphasized its relevance during his address to the All India Presiding Officers in November 2020.

According to PM Modi, the frequent cycle of elections hampers governance by imposing recurring administrative and financial burdens. As per him, the imposition of the Model Code of Conduct (MCC) during elections often delays devel opmental projects, leading to escalated costs. In January 2022, Modi reaffirmed his support for 'One Nation, One Election,' arguing that a unified electoral system could streamline governance and reduce the disruptions caused by perpetual

#### Federalism in jeopardy

India's federal structure is characterized by its rich diversity, encompassing a multitude of political, cultural, and linguistic landscapes. Each state has its unique set of priorities and issues, often addressed more effectively by regional parties. A synchronized electoral process risks marginalizing these regional voices, as national-level narratives may overshadow state-specific concerns. This could lead to a homogenized political discourse, undermining the pluralistic ethos of Indian

One of the primary criticisms of 'One Nation, One Election' is the potential for centralizing power at the national level. By aligning state and national elections, the influence of state governments in shaping localized policies could diminish. This centralization might erode the autonomy of state governments, challenging the principles of federalism and democratic decentralization enshrined in the Constitution.

#### Challenges and Concerns

Conducting simultaneous elections across a country as vast as In-

dia poses significant logistical challenges. The Election Commission would require an extensive overhaul of its infrastructure, including the procurement of additional electronic voting machines (EVMs) and the expansion of polling stations. Ensuring adequate security and administrative support during such a largescale electoral exercise would strain existing resources and necessitate substantial financial investment.

The experience of Indonesia's unified elections in 2019 serves as a cautionary tale. Voters faced long lists of candidates, leading to higher rates of ballot errors and voter fatigue. A similar scenario in India could confuse voters, diminishing the quality of electoral participation and potentially suppressing turnout.

Synchronizing elections may exacerbate governance disruptions during the electoral period. Government resources, which should be allocated to public service delivery, often get diverted toward election-related activities. A unified election cycle would intensify this diversion, potentially hampering developmental initiatives and public welfare programs.

Moreover, political parties may manipulate the timing of state elections to coincide with favorable national cycles, prioritizing political strategy over governance and local issues. This could undermine the democratic principle of accountability, shifting the focus from performance-based governance to election-driven politics.

#### Tail piece:

The proposition of "One Nation, One Election" is politically impractical, administratively complex, and constitutionally unsound. Politically, it assumes consensus among diverse political parties with varying regional and ideological interests, but regional political parties have discarded this idea. They view simultaneous elections as undermining their local agendas and electoral prominence.

Administratively, managing logistics for conducting Lok Sabha and state assembly elections together across 28 states and 8 Union Territories is a colossal challenge. Issues like varying electoral terms, dissolution of assemblies, and election preparedness at different levels further complicate the proposition.

Constitutionally, the idea undermines the federal structure enshrined in the Constitution by diluting state autonomy over legislative timelines. Altering assembly tenures or dissolving legislatures prematurely strikes at the heart of federalism.

athematician Cathy O'Neil once said that an algorithm is nothing more than someone's opinion embedded in code. When we speak of "the algorithms" that power Facebook, X, TikTok, YouTube, or Google Search, we are really talking about choices made by their owners about what information we, as users, should see. In these cases, "algorithm" is just a fancy name for an editorial line. Each outlet has a process of sourcing, filtering, and ranking information that is structurally identical to the editorial work carried out in media – except that it is largely automated.

This automated editorial process, far more than its analog counterpart, is concentrated in the hands of billionaires and monopolies. Moreover, it has contributed to a well-documented list of social ills, including large-scale disinformation, political polarization and extremism, negative mentalhealth impacts, and the defunding of journalism. Worse, social-media moguls are now doubling down, seizing the opportunity of a regulation-free operating environment under Donald Trump to

roll back content-moderation programs. But regulation alone is not enough, as Europe has discovered. If our traditional media landscape featured only a couple of outlets that each flouted the public interest, we would not think twice about using every available tool to foster media pluralism. There is no reason to accept in social media and

search what we would not tolerate in legacy media. Fortunately, alternatives are emerging. Bluesky, a younger social-media platform that recently surpassed 26 million users, was built for pluralism: anyone can create a feed based on any algorithm they choose, and anyone can subscribe to it. For users, this opens many different windows onto the world, and people can also choose their sources of content moderation to fit their preferences. Bluesky does not use your data to profile you for advertisers, and if you decide you no longer like the platform, you can move your data and followers to another provider without any disruption.

Bluesky's potential does not stop there. The product is based on an open protocol, which means anyone can build on top of the underlying technology to create their own feeds or even entirely new social applications. While Bluesky created a Twitter-like microblogging app on this protocol, the same infrastructure can be used to run alternatives to Instagram or TikTok, or to create totally novel services - all without users having to create new accounts.

In this emerging digital world, known as "the ATmosphere" (so named for the underlying AT Protocol), people have begun creating social apps for everything from recipe sharing and book reviews to long-form blogging. And owing to the diversity of feeds and tools that enable communities or third parties to collaborate on content moderation, it will be much harder for harassment and disinformation campaigns to gain traction.

One can compare an open protocol to public roads and related infrastructure. They follow certain parameters but permit a great variety of creative uses. The road network can convey freight or tourists, and be used by cars, buses, or trucks. We might decide collectively to give more of it to public transportation, and it generally requires only minimal adjustments to accommodate electric cars, bikes, and even vehicles that had not been invented when most of it was built, such as electric scooters.

An open protocol that is operated as public infrastructure has comparable properties: our feeds are free to encompass any number of topics, reflecting any number of opinions. We can tap into social-media channels specialized for knitting, bird watching, or book piles, or for more general news consumption. We can decide how our posts may or may not be used to train AI models, and we can ensure that the protocol is collectively governed, rather than being at the mercy of some billionaire's dictatorial whims. Nobody wants to drive on a road where the fast lane is reserved for Cybertrucks and the far right.

'Open social media," as it is known, provides the opportunity to realize the internet's original promise: user agency, not billionaire control. It is also a key component of national security. Many countries are now grappling with the reality that their critical digital infrastructure - social, search, commerce, advertising, browsers, operating systems, and more - is subordinated to foreign, increasingly hostile, companies.

But even open protocols can become subject to corporate capture and manipulation. Bluesky itself will certainly have to contend with the usual forms of pressure from venture capitalists. As its CTO, Paul Frazee, points out, every profit-driven socialmedia company "is a future adversary" of its own users, since it will come under pressure to prioritize profits over users' welfare. "That's why we did this whole thing, so other apps could replace us if/ when it happens.

Infrastructure may be privately provided, but it can be properly governed only by its stakeholders - openly and democratically. For this reason, we must all set our minds on building institutions that can govern a new, truly social digital infrastructure. That is why I have joined other technology and governance experts to launch the Atlas Project, a foundation whose mission is to establish open, independent social-media governance, and to foster a rich ecosystem of new applications on top of the shared "AT Protocol." Our goal is to become a countervailing force that can durably support social media operated in the public interest. Our launch is accompanied by the release of an open letter signed by high-profile Bluesky users such as the actor Mark Ruffalo and renowned figures in technology and academia such as Wikipedia founder Jimmy Wales and Shoshana Zuboff.

There is nothing esoteric about our digital predicaments. Despite the technology industry's claims, social media is media, and it should be held to the same standards we expect from traditional outlets. Digital infrastructure is infrastructure, and it should be governed in the public interest.

urely the contribution of Jayadeva; the 18th century singer-poet [- who authored Geet-Govinda; the opera cum ballet on the love-tale of lord Krishna & cowherd maidens], can't be denied but prior to 7th century, great dramatists existed in India. Kalidasa and Bhavabuti,for example; to name only few. The former contributed plays like Abhiinana-Shukuntala; inspired by a story in the Mahabharata and the latter created Mahavira-charita;

It has to be accepted that music, dance and drama had gained popularity in India during 11-14 centuries AD. Thus the existence of Theatre- Enclosures, Natak Mandapa, in Hindu Temples that served as an important adjunct -used as a community-centre as well as place of worship, proves that theatre- tradition in India existed, almost, from antiquity. Some writers state that in THE INDIAN MYTHOLOGICAL PLAYS of rural India 'Ritualistic -Worship' or 'Obeisance (Ranga-Puja), 'Introductory Verses, Music & Dance' (Purva Ranga) was performed prior to the main performance, in front of the 'Holy Altar'. Masks- made of papier-mache, wood, clay etc were also used often. Imagine the performance proceeding at a leisurely pace..... music, dance and gestures accompanying....with interlude by 'Clown' (Vidushaka).

In the whole Himalayan area rich traditions of Monastery Dramas are said to have evolved

Tibet had its share of formalised folk dance among sedentary agriculturists. Folk tales about legendary cum historical heroes and **Buddhist Canonical Literature** of Tibet could be the source of ache-lhamo; The Morality Plays of Tibet in which masks were used. Patron saint, also known as 'Mad Yogi', Thongton Gyalpo is said to have realised, through his Tibetan Opera style (Lhamo), that dramatised religious teachings had greater influence. The Buddhist Jatakas (written from 6th to 2nd century BC), also called 'The Birth Stories', are morally instructive stories in whose dramatisation main characters, often, are 'animals'. The Natas that are said to be mentioned in Jataka Books were wandering ministerial. Later, tropes associated with village monasteries performed in the plays when gradually the dictum 'forbidding music & dance (for entertainment) to monks> was diluted by time.

Out of many great figures of the Buddhist world, the one that I would like to mention here is: Asvaghosha, [-probably of 1st century AD; -- considered as the greatest expounder cum systematiser of The Mahayana School of Buddhism ( Teg-pa-Chenpo); who was the first propounder of the 'Shuniya Theory' (Stongpa-nyid) and rendered commentaries of the Mahayana scriptures], is said to have written, around 1st Century AD, Lyrical Poems, out of which the Tibetan lyrical dramatic pieces, Poesy, is



said to have evolved. Nonetheless one should be open to the idea that Indian & Tibetan theatre might

have been mutually benefited. Now let us move to the wider canvas.

It is true, centuries before the birth of Lord Christ, the theatre of Athens; revolving round GREEK MYTHOLOGY was played in open-air-theatres wherein costumes, voice, gestures and masks, etc were employed, and in which genres like tragedy, comedy, satyr existed. In Greek theatre not only one hears about great playwrights like Aeschylus (-Prometheus Bound), Sophocles (-The Oedipus Trilogy), Euripedes (-Hercules) etc but quite interestingly it is said in the city of Dionysia (Athens), the Dionysiac spring festival, rituals performed were accompanied by chorus, music & dance; and metrical spoken words were employed in the Phallicsongs . Above all, ponder on the name of the Roman god of theatre, Dionusos.

Roman theatre too has a history of its own and it is said we owe pantomime to Romans. It is of great interest to me that in ROMAN MYTHOLOGY the chief -god Juniter, Lord of Heaven & Earth, sky & thunder, (Brahaspati in Sanskrit; biggest planet in our solar system), is said to have figured in some post-

GREEKS, around Alexander's time, even contributed towards ancient Indian theatre. Yet it is apt to remember that around 315BC king Chandra Gupta drove out Seleukus(- the Greek ruler of Indus province); married his sister, whereby was born, Ashoka Vardhana Piyadasi [ - the great propagator of Buddhism; whose empire included Kashmir as well. Around 150 BC Kashmir came under the rule of Greek Meander, who, it is believed, became a Buddhist; coins of Meander exist in SPS Museum of Srinagar, if my memory serves me right ]. True, the role of Greek theatre in modern theatre round the globe cannot be denied; including in British India of post-1860; as well as 20th century theatre.

Ladakh is the living repository of a form of Buddhism, popularly called Lamaism and it is a land of living, soaring monasteries, Gomnas. As is well known the Prince of Sakiya tribe of the mini-republic of Kapilvastu (-now in Nepal), Lord Siddhartha Gautama Buddha; (named by some as 'Yuna

The Buddhist Priests/ Monks Lamas reserve to themselves the exclusive right to act in these mystery plays; masquerading in quaint attire, with dramatic display and droll masked dances in the Gompas- -complex/ courtyard.

The Lama Dance Dramas, presented for the edification of the faithful, is the sacred drama of religious nature; illustrating in adapted form, the famous Buddhist Birth Stories i:e ' Buddha's previous lives as animals in which he practised COMPASSION; karuna; Snyingrje, (- « such as the Visvantara and Sudhana Jatakas»)- tales about former lives of saints; about the triumph of Gurus like Padma-Sambhava; killing of enemies like Langdharma (-devil with horn: historic enemy of Buddhists ), stories of Black-Hat-Dancers (zhwanags) with aprons of bones & brocades; portrayal of demons & devils and deities encountered within the <intermediate state between death</p> and next life> (bar-do) or on the way to heaven'. The characters are identifiable by their masks e:g Stag (Sa-ba), Lion (Sen-ge), Tiger (tschan) or by peculiar clothes like Skeleton Clothes of The Graveyard Ghoul (Tur). Storyline of the plays, chiefly, is the victory of good over evil.

But Pre-Buddhist fables also figure.

These masked dances are artistic creations, masterpieces of production and choreography. In masks where the grotesque or terrifying may seem expressionistic to us, we only have to deal with the codified iconography which has settled the actual appearance of the figures of the pantheon once and for all.

To conclude let me reiterate an interesting information: Experts say, that the early reflection of complete drama, is evident in NAGA-NANDA; the most acclaimed five act play of 7th century, attributed to king Harsha Vardhana (- ruled from 606-648 AD), belongs to Buddhist tradition; and is based on an enlightening Buddhist legend; with invocation to Lord Buddha, is said to be in Sanskrit language.

## **Fireside Unity**

Winter Tradition in My Village, Gadole

estled in the lap of gigantic mountains, crisscrossed by a gentle nallah at the front and served by a 14-foot-wide macadamized road, my village, Gadole, is situated 12 kilometers from the Tehsil headquarters in Kokernag and 40 kilometers from the district headquarters in Anantnag. The village comprises two distinct sections: Gadole Payeen (Bon Gadole), characterized by densely packed houses and apple orchards, and Gadole Bala (Her Gadole), marked by sparse and unplanned housing.

According to the 2011 census, the village spans 690.8 hectares, with 1,612 houses built on the land. Although the number of houses has increased significantly since then, the village remains home to 12,540 inhabitants, known for their simplicity, honesty, and authenticity.

While modernization has undoubtedly impacted local culture, I firmly believe that certain traditional aspects continue to thrive. One such enduring custom is the evening gathering around a roadside fire, where locals come together to share stories and warmth

from a humble tin fire pot. Every year, with the onset

of winter and snowfall, the men of our village gather at the Herm-adda, near the erstwhile upper bus stop, to warm up and socialize. As the cold reaches its peak and work slows down, they congregate in the evenings, huddling around

a fire burning in a tin pot.

Though the fire ignites in the tin pot with the onset of Chillakalan, the preparation for the tin fire and congregation begins much earlier, in late November or early December. First, fuel is collected and hoarded at a previously selected place. Care is taken to ensure that the fuel remains dry and protected from

The fuel for the fire is creatively sourced from discarded materials, including scrapped paper sheets, tattered remnants of worn-out clothes, fabric scraps from tailors, dried leaves, straw, and dried twigs and branches. Once the necessary amount of fuel is gathered, a tin pot approximately 3 feet in height, 2 feet in length, and 2 feet in width is carefully chosen and modified to suit the occasion. The tin pot is then stored away with the fuel.

When it finally snows and the branches of trees sag under its weight, the cold intensifies. The world looks white. serene, and silent. People are caged inside the beautiful white bars. The water freezes and turns into gigantic white sugar cubes, which are slippery like the skin of fish. Paths become dangerous pistes. As the evening chill intensifies and the mercury plummets, the local male folk converge

at the designated gathering spot. The tin pot and fuel are brought forth, lit, and ignited, casting a warm glow over the assembly. The rising smoke dances and serves as a beacon, inviting stragglers to join the gathering.

As the fire crackles, flames dance, and embers glow, the attendees lose themselves in the warmth and camaraderie. Time loses its weight. The surroundings reek of fire, flames, smoke, warmth, love, and laughter. The members, as listless as lumps of dough, become mesmerized. Their faces glow as they engage in lively discussions. Diverse themes emerge and engage the congregation, ranging from politics, religion, science, and farming to spring, love, wars, orchards, books, and folklore. Conversations flow effortlessly, and the relaxed atmosphere encourages open sharing of thoughts.

Attendees speak their hearts out, sharing their deepest joys and sorrows. They seek help, offer support, and extend helping hands to one another. This fosters an unshakable sense of oneness and weaves them together in a tapestry of

empathy, sympathy, and unity. Meanwhile, the younger folk in the crowd secretly whisper about the latest Bollywood releases, while mentioning a Hollywood movie is considered shameful. People here are so simple that, to them, every English movie contains some explicit content. Jokes can be cracked, but they must remain polite and respectful. Lewd humor is strictly forbidden, and uttering such jokes may lead to ostracism from the gathering. This directly fosters a refined culture of healthy values and good principles.

Thus, the humble tin pot transcends its practical purpose to become a powerful symbol of unity and togetherness for our villagers. Its warm flames foster a sense of synergy and harmony, bridging gaps and healing rifts. Even those who may have been at odds just moments before find themselves reunited, as if their differences had never existed. The tin pot's magic lies in its ability to bring people together, reminding us that community and social connection are the greatest warmth of all.

May the fire of the tin pot continue to burn bright, and may it serve as a beacon of unity and harmony for generations to come.

## Centre to hold meeting with protesting farmers on Feb 14; Dallewal takes medical aid

Chandigarh, Jan 18 : The Centre will hold a meeting with Punjab's protesting farmers on February 14 in Chandigarh to discuss their demands, thus ending a stalemate over the resumption of a dialogue with the agitators, who have been demanding a legal guarantee on the MSP for crops.

Following the announcement of the proposed meeting, farmer leader Jagjit Singh Dallewal, whose fast-unto-death entered the 54th day on Saturday, agreed to take medical aid

However, he will not end his indefinite fast till a legal guarantee on the minimum support price (MSP) for crops is given, said farmer leader Sukhjit Singh Hardojhande.

showing Later, pictures Dallewal taking medical aid with an intravenous drip were released by the farmers.

The breakthrough came after a delegation of officials from the Union agriculture ministry, led by Joint Secretary Priya Ranjan, met Dallewal and held a meeting with the representatives of the Samyukta Kisan Morcha (Non-Political) and Mazdoor Morcha (KMM), which are spearheading the agitation

for the last 11 months.

Following the announcement of the meeting on February 14, farmer leaders appealed to Dallewal to take medical aid so that he can participate in the proposed deliberations.

The Centre's delegation also urged Dallewal to take medical aid so that he can participate in the proposed meeting, which will take place at the Mahatma Gandhi State Institute of Public Administration at Chandigarh at 5 pm on February 14.

Talking to reporters at the Khanauri protest site, Ranjan said a high-level delegation was sent by the Centre, keeping in mind the deteriorating health of Dallewal.

"We enquired about his health and held a meeting with the representatives (of the protesting farmer bodies)," he said.

Ranjan said the meeting will be held in Chandigarh on February 14.

"We urged him (Dallewal) to break his fast and take medical aid, so that he can participate in the meeting," he said.

A letter addressed to Dallewal, SKM (Non-Political) and KMM read: "This is in continuation of the previous meeting with the



leaders of SKM (Non-Political) and Kisan Mazdoor Morcha (KMM), which was held on February 15, 2024 at Chandigarh.

"A meeting with the ministers of the government of India and the Punjab government regarding the demands of the farmers' unions has been convened on February 14, 2025 (5 pm) at the

Mahatma Gandhi State Institute Public Administration Punjab (MGSIPA), Sector-26, Chandigarh. You are cordially invited to the meeting, please attend at the scheduled time. We hope that Dallewal will soon end his fast, recover and join the discussion," said the letter writ-

ten by Ranjan.

**PM Distributes** 

Four rounds of meetings had taken place between Union ministers and the protesting farmers on February 8, 12, 15 and 18 last year, but the talks remained inconclusive.

Earlier in the day, the farmers protesting at the Khanauri and Shambhu border points between Punjab and Haryana said

they have received a proposal from the central government which they will discuss.

The Centre's delegation held meetings with the representatives of both the forums.

A Punjab government team led by retired additional director general of police Jaskaran Singh and former deputy inspector general of police Narinder Bhargav, who were holding discussions with the farmer leaders, was also present.

According to farmer leader Abhimanyu Kohar, officials have said February 14 has been fixed for the meeting as Assembly polls are due in Delhi and the Model Code of Conduct will be in force in the capital till February 9.

When the Model Code of Conduct is in force, no government can make any announcement, Kohar said.

Sharing details Dallewal's health, Kohar said the farmer leader was unable to take water and had been vomiting.

Doctors have warned that anything could happen to Dallewal, he added.

Before agreeing to take medical aid, Dallewal had asked the farmer leaders to take consent from the 121 farmers who were also on an indefinite fast.

A few days ago, a group of 111 farmers and later, 10 more farmers sat on a fast-unto-death in solidarity with Dallewal.

Dallewal, who is the convenor of the SKM (Non-Political), has been on the indefinite hunger strike at the Khanauri border point since November 26 last year in support of various demands, including a legal guarantee on the MSP for crops.

Farmers had said Dallewal had not eaten anything since November 26 last year and was just surviving on water.

Farmer leaders on Thursday said Dallewal has lost about 20-kg weight during his fast-unto-death.

The weight of Dallewal has reduced to 66.4 kg now from 86.9 kg, when he began the indefinite

Farmers, under the banner of the SKM (Non-Political) and KMM, have been camping at the Shambhu and Khanauri border points since February 13 last year, after security forces did not allow them to march to Delhi to press for their various demands. including a legal guarantee on the MSP for their crops.

It also states that on an average at least seven teachers were posted or deployed in schools of Jammu and Kashmir.

Despite repeated attempts, Project Director Jammu and Kashmir Samagra Shiksha was not available to comment on the issue.

In 2024, it was reported that over 4400 government run schools were closed owing to 'zero or extremely low' enrollment of students.

In July-2024, it was said that there were a total of 23,117 government run schools in Jammu and Kashmir out of which 4394 have been deleted from the UDISE data.

An official had said that the count of overall public schools in Jammu and Kashmir reduced because "There were some government schools that were having zero or extremely low students enrollment. Those schools were merged with the nearby public schools."

The official figures previously had revealed that the primary schools category of government schools was hit badly wherein the count of overall public schools in Jammu and Kashmir reduced by nearly 30 percent.

According to the official figures a total of 12,977 government primary schools were functioning in Jammu and Kashmir. However, after the merger, only 8966 primary schools are functional.

Similarly, 392 government middle schools, three high schools and one higher secondary were deleted from the UDISE Plus list.

Stating the statistics of private and other chools the official figures had previously revealed that there were a total of 5688 such educational institutes out of which only 5555 schools were functional as of now.

Overall, Jammu and Kashmir used to have 28,805 government and private schools. However, as per the official figures, the count had reduced to 24,279 schools.

Previously, the School Education Department had said that it had identified more than 1200 such government schools that were having low enrollment of students.

It had said that such schools would likely be merged in accordance to the catchment and feasibility of the students.

In April-2022, School Education Department had said that it was all set to merge 720 government-run-schools of Jammu and Kashmir having an inadequate student enrollment. (KNO)

A newly formed special investigation team of police has rounded up over 60 people for questioning as part of its investigation after autopsy reports by CSIR-IITR revealed the presence of neurotoxins.

On Friday, Jammu and Kashmir Chief Minister Omar Abdullah chaired a high-level meeting here to discuss the situation in Badhaal village of Kotranka sub-division and directed health and police departments to expedite investigations.

Located about 55km from Rajouri district headquarters, the villagers are gripped by fear and want the mystery to be resolved already.

People complained of fever, pain, nausea and loss of consciousness before dying within days of their admission to the hospitals. A girl alone was able to buck the trend and withstand the condition for days. Her condition though continues to be critical.

According to a doctor, the MRI scan of the patients revealed oedema in the brain, a condition where fluid builds up in the brain tissue.

"It is a big challenge for all of us ... I appeal to the people that if anyone has any clue, please come forward and help in the ongoing investigations," National Conference leader and local Member of Legislative Assembly (MLA) Javid Iqbal Choudhary said.

A new graveyard has come up in the village on agricultural land belonging to Mohammad Aslam, who lost five children and his maternal uncle and aunt, who adopted him, between January 12 and 17.

While Yasmeena Jan, the sole surviving daughter of Aslam remains in critical condition, no other villagers have reported illness, further compounding the mystery.

Aslam's brother-in-law Fazal Hussain and his four children were the first to die under suspicious circumstances in the village on December 7. They were initially believed to have perished to food poisoning for the family had attended a wedding just before.

The pregnant wife of Mohd Rafiq, a cousin of Aslam, and her three children died on December 12.

"The government responded to the situation in a very sensitive manner, leaving nothing to chance. Health teams from within and outside J&K were mobilised and all the villagers were screened within the shortest possible time,' Choudhary said.

He said the chief minister has been monitoring the situation since day one.

'The meeting chaired by the chief minister was informed that a total of 68 people have been rounded up for questioning by the SIT," he said, expressing hope that ever become clear once the probe is complete.

A grieving Aslam did not rule out a "conspiracy" against his family.

"Hundreds of people had a feast but only Hussain and his children died first. A few days later my cousin's wife and children passed away and then death reached my doorstep. How is it that only our family perished like this?" he said, adding that his family had meals at Hussain's house where a special prayer meeting was held to mark the 40th day since the deaths.

He said fear has gripped the villagers to such an extent that many avoided meeting him when he was grief-stricken.

Zaheer Ahmad Gorsi, a local social activist, said the villagers are yet to come to terms with the unexplained deaths. "A new graveyard has to be prepared ... It is a testing time for the whole village."

Zahid Shah, a relative of Aslam, said he has full faith in the administration and the police.

"This type of fear was not there even when militancy was at its peak or during the COVID-19 pandemic. People are not coming forward even to dig the grave for the dead," Nazim Din, another relative, said.

Earlier, a government spokesperson said investigations and samples empirically indicate that the incidents were not due to a communicable disease of bacterial or viral origin and that there is no public health angle.

"All samples taken from the victims and the villagers have tested negative for any viral or bacteriological aetiology. The tests were conducted on different samples in some of the most reputed labs in the country.

The toxicological analysis conducted by CSIR-IITR has detected toxins in multiple biological specimens.

The chief minister said the administration is treating the situation with the highest priority.

"The health and safety of our people remain our top priority. The government is fully committed to resolving this crisis and ensuring justice for the affected families," Omar earlier said. (Inputs From Agencies)

Keeping in view this situation, officials stated, District Magistrate has ordered closure of road till further orders.

"Around 2.24 crore beneficiaries in villages will now have SVAMITVA property cards after 65 lakh cards are distributed today," the prime minister said

"Property rights are a major challenge across the world. Years ago, the United Nations had held a study, which revealed people did not have legal documents for property rights in several countries. The UN has said property rights are important for poverty alleviation,

Modi said an eminent economist had opined that property in villages is a "dead capital" because people cannot do anything with it, and it can't help increase their income.

"India was also impacted by this challenge. People in villages have property worth lakhs of crores (of rupees), but they did not have papers for it. There were disputes, properties were snatched, and even banks did not provide loans over it." he said.

The prime minister emphasized that no sensitive government could leave its villagers in

"Previous governments should have taken steps to do something about it but nothing much was done," he said.

Modi said Dalits, backward classes and tribals were the worst affected by this. Elaborating on the SVAMITVA Yojana, he

said it involved mapping houses and lands in illages using drones and providing legal documents for residential properties to villagers. He added that the benefits of this scheme are now

"India has over six lakh villages, with drone surveys completed in nearly half of them," Modi said.

He highlighted that after receiving legal documents, lakhs of people had taken loans from banks based on their properties and started small businesses in their villages.

"After getting legal property rights, lakhs of people have taken loan. They have used this money to start their businesses. Many of these are farmers, for whom this property cards is a guarantee to financial security," he said.

Modi said that once property cards are issued in all villages, the scheme will unlock economic activities worth over Rs 100 lakh crore. He emphasized the substantial capital that will be added to the country's economy.

Noting that earlier, land disputes were common for farmers and obtaining land documents is challenging, often requiring multiple visits to offices and leading to corruption, the prime minister said that land records are being digitized to deal with these issues. Highlighting that SVAMITVA and Bhu-

Aadhaar are foundational systems for village development, he said that Bhu-Aadhaar provides a unique identity to land, with around 23 crore Bhu-Aadhaar numbers issued, making it easy to identify land plots.

"Over the past seven-eight years, approximately 98 per cent of land records have been digitized, and most land maps are now digitally available," Modi added. Later, in a post on X, the prime minister said

rural land digitisation is "furthering rural empowerment by leveraging the power of technology and good governance". Union Minister of Panchayati Raj Rajiv

Ranjan Singh 'Lalan', Union Minister of State for Panchayati Raj S P Singh Baghel and Ministry of Panchayati Raj Secretary Vivek Bharadwaj were also present at the event. It was attended virtually by several chief

The scheme also helps facilitate monetization of properties and enabling institutional credit through bank loans; reducing propertyrelated disputes; facilitating better assessment of properties and property tax in rural areas and enabling comprehensive village-level

#### **NGT Summons**

Budgam & ordered that no illegal mining should take place in the river.

The members of the NGTs constituted committee that comprised of senior officers of Ministry of Environment Forests and Climate Change- MoEF, Central Pollution Control Board (CPCB), JK Pollution Control Committee (JKPCC) & Director Fisheries J&K Govt had visited the site in Sail and Kangripora villages in Beerwah on December 26th 2024 along with local SDM, Tehsildar, Sub Divisional Police Officer-SDPO & SHO. The petitioner in the case Dr Raja Muzaffar Bhat and local residents were also present on the occasion. The Joint Committee-JC later on submitted the report to NGT on January 13th and matter was listed for hearing on January 15th 2025.

The Joint Committee's preliminary findings submitted in NGT reads, "During the site inspection by the Joint Committee, it has been found that illegal mining has taken place in the Sukhnag River. Due to diversion/disruption of water supply caused by the mining/illegal extraction of minor minerals and boulders, the trout fish farms of Peerzada have suffered losses. The mining activities and extraction of boulders from the Sukhnag river, has affected the water sources and resulted in the increased turbidity and decrease in water level.'

The Geology and Mining Department has issued 163 STPs to the executing agencies, viz. PWD (R&B), PMGSY, NHAI, SE Hydraulic, NBCC, on the authorization of Deputy Commissioner, Budgam and Executive Engineer Flood Spill Division Narbal during the year 2020-2024 for the purpose of developmental projects. The area upon which the Sukhnag nallah flows in Beerwah Sub Division of District Budgam is a state land recorded in the revenue record. It is recorded in the occupation of the state.

Advocate Saurabh Shamra, petitioner of the counsel Dr Raja Muzaffar Bhat told NGT that under the garb of disposal permits the loot and plunder has been taking place in Sukhnag for the last more than 3 years.

The NGT three member bench of Justice Prakash Shrivastava (Chairperson) Sudhir Agarwal (Judicial Member) and Dr. A. Senthil Vel (Expert Member) in its order on January 15th 2025 said :

"Since neither the Respondents No. 2 (DC Budgam) is represented nor the reply on his behalf has been filed, therefore, we direct Respondent No. 2 (DC Budgam) to appear virtually on the next date of hearing. Respondent No. 2 (DC Budgam) is also directed to ensure that no illegal sand and boulder mining in the area concerned takes place without requisite permission, environmental clearance and without complying with the other norms till the next date of hearing. It will be open to the learned Counsel for the Applicant to file a response to the report of the joint Committee within four weeks.

Petitioner in the case Dr Raja Muzaffar Bhat has appreciated the NGTs order and the preliminary findings of the Joint committee & demanded imposition of environmental compensation on accused contractors and govt officers

"I appreciate the way the Joint Committee reported the loot and plunder taking place in Sukhnag. NGTs intervention is also appreciated. I wish the Govt had acted 3 years back when the damage was not much. What all I had been saying for the last more than 3 years has proven to be correct and the JC report is self explanatory. I will push for payment of Environmental Compensation -EC by the company involved in illegal mining along with Govt Departments / officers who have allowed this illegal work under the garb of disposal permits and short term permits which are all vague and illegal." said Dr Raia Muzaffar.

He also issued a stern warning against dangerous behaviours like stunt driving, particularly when they threaten public safety.

Mahajan said the transport subsidy scheme aimed at replacing vehicles over 15 years old offers financial assistance of upto Rs 5 lakh or 16 per cent of the cost of a new vehicle, whichever is lower.

'We have received around 35 applications in Kashmir and 100 in Jammu under this scheme. Vehicle owners must complete scrapping procedures, including chassis cutting, and obtain certification from the Motor Vehicle Department," he explained.

Additionally he said that meters have been made mandatory for all other auto-rickshaws. Mahajan while talking to reporters, warned that strict action would be taken against drivers overcharging passengers or operating without proper permits.

Highlighting the importance of road safety, the Commissioner stressed that drivers play a critical role in preventing accidents. "Road safety is the primary responsibility of the driver," he said, urging drivers to avoid violations like speeding and not wearing helmets.

On the issue of driving licenses, he acknowledged delays in issuance but assured that a new tender for license printing is nearly complete, and licenses will soon be delivered by post. Meanwhile, drivers were encouraged to use the Digilocker app for digital access to their licenses.

The Commissioner also urged citizens to follow designated routes, emphasizing that measures are in place to ensure public safety.

#### **Over 50 Doctor, Paramedic Posts Vacant In Ganderbal Medical Block**

SRINAGAR: Over 50 critical posts, including doctors and paramedics, remain vacant in the Ganderbal Medical Block, with District Hospital Ganderbal bearing the brunt of these shortages.

The unfilled positions in-Consultant Surgeon, Consultant Pediatrician, Medical Officers, Anesthesia Assistants, X-ray Technicians, Pharmacists, Blood Bank Technicians and support staff such as cleaners and drivers, according to an RTI reply.

Despite recruitment efforts, the block has only managed to appoint 8 doctors and 3 paramedics since 2019. Meanwhile, 9 doctors and paramedics have retired over the past five years.

Several staff members, including pharmacists and assistants, have been attached to offices outside the medical block, which has further strained resources. Two ambulances at Primary Health Centers (PHC) in Shuhama, Chundina, and Tulmulla are non-functional.

Locals have raised concerns about doctors stationed at the same location for over 6-10 years, despite the government's claims of adhering to a strict transfer policy. Eleven Medical Officers have report-

edly not been transferred for more than three years, and nine doctors posted between 2014-2017 continue to work at District Hospital Ganderbal without relocation.

Residents questioned why many employees are attached to other departments if the government claims strict enforcement of transfer and posting policies. They called for an investigation into the alleged violations and accountability for the officials involved.

The report highlights that no sanctioned posts for gynaecologists exist within the block, except at the District Hospital, leaving no access to specialized care in rural areas.

While construction projects for healthcare infrastructure are underway, progress is slow. For instance, the construction of AAM SC Pandach was completed in 2024; the new building for NTPHC Nunner remains incomplete due to funding shortages, with only 70% of the work finished; and the work on AAM SC Theeru started in 2024, is ongoing

## **Burglars Decamp With Vital Machinery Of WSS In South Kashmir**

PULWAMA: The burglars have stolen machinery from a Water Supply Scheme in South Kashmir, rendering the water supply to three villages affected.

An official said that vital machinery of the water supply scheme worth lakhs located in Darbagh Zainapora Shopian has been stolen during the night due to which the supply got defunct.

He said that this scheme is catering to Darbagh in Shopian and Zahid Bagh and Rakh in Pulwama district. The official said that the incident has left the residents of these villages without access to potable water, exacerbating the existing water scarcity issues.

The residents of the area stated that the water supply scheme has become a headache for them as it has been facing different issues from day

They said the scheme was constructed for just 200 households but later around 500 households have been added to it due to which the people are suffering. They demanded the govern-

ment to take steps for creating a separate source for Zahid Bagh and Rakh villages so that they can get better water facilities.

The residents demanded investigation in this regard and urged authorities to take steps to restore supply at an earliest.

Meanwhile, an official of PHE Mechanical Engineering Wing said that employees, who were assigned night duty were absent and thus are responsible for this negligence.

He said that they have informed police in this regard who visited the spot and investigation has been taken up.

### **Chattabal Residents Demand Shifting Of Fish Market**

**SRINAGAR:** The residents of Chattabal area here have appealed to the authorities to shift the fish market near Police Post Bagiya, which they say have led to persistent traffic congestion and inconvenience to the pedestrians.

Locals from Chattabal alleged that the shoppers who stop their vehicles near the market occupy a significant portion of the road, thereby leading to the traffic chaos in the locality.

"The fish vendors usually occupy the roadsides, leaving little space for the vehicles and pedestrians, but the shoppers who visit the market in their vehicles further worsen the situation. It has become a

daily struggle to pass through this area," said Mukhtar, a local resident.

Another resident. Fareeda Begum, said the narrow road is already prone to accidents. With the vendors and their makeshift stalls blocking the way, it's become extremely dangerous for schoolchildren and elderly people. "The situation gets further worsening as the fish vendors pour water on the roads, which lead to the slippery condition and thus become prone to the accidents further," she said.

Meanwhile, the residents urged the administration to relocate the fish market to a designated area so that the traffic movement is eased and the locals could heave a sigh of relief—(KNO)

## **Northern Railway To Spend** Rs 450 Cr On Jammu Tawi **Station Upgradation**

**IAMMU:** As the train is all set to connect Kashmir with Kanyakumari, Northern Railway has decided to invest approximately Rs 450 crore in the modernization and redevelopment of Jammu Tawi Railway Station.

According to the details available, the ambitious project aims to enhance passenger experience, safety, connectivity, and operational efficiency, bringing the station in line with modern infrastructure standards.

An official said that the commissioning of the remodeled Jammu Tawi yard is slated for March 6, 2025. "With yard remodeling nearing completion, the remaining non-interlocking work is also progressing rapidly," he said, adding, "The yard remodeling is a challenging yet critical component of the station redevelopment. It will pave the way for further infrastructure upgrades."

The official said that the number of platforms will in-



crease from the current three to seven, with the addition of four new platforms equipped with state-of-the-art ballastless track technology. "Enhanced hygiene will be ensured with washable aprons on all platforms, contributing to a cleaner environment," he said, adding. "The expansion will streamline train operations and provide passengers with a more comfortable experience."

"The expansion plan also includes two new foot overbridges (FOBs), each 12 meters wide, a 72-meter-wide air concourse to connect all seven

platforms, allowing seamless passenger movement and improved flow. A new 4,500 sqm second entry building will be developed on the Narwal side to cater to growing passenger needs," the official said, adding, "The main station building will be upgraded to a 15,600 sqm facility, featuring modern amenities and a contemporary design. The signal control room will be relocated to the new station building. The number of washing pit lines will increase from three to five, allowing the station to handle more trains efficiently." ## "Those Brewing Hatred Will Not Be Spared," Says MMU

SRINAGAR: The Muttahida Majlis-e-Ulema (MMU) an amalgam of many religious organisations of Kashmir on Saturday addressed the media in Srinagar on Saturday regarding the recent Mushaira controversy, issuing a strong warning against actions that sow discord.

Ulemas and religious scholars from across Kashmir attended the urgent meeting after sectarian controversy brewed in Kashmir. Scholars presented their views on the sensitive matter, calling for unity and mutual respect among Muslims.

Speaking to the media, Mufti Azam Jammu & Kashmir Mufti Nasir-ul-Islam condemned the incident, describing it as an unacceptable act of bigotry against the companions of the Holy Prophet (PBUH).

He emphasized that this would be the last instance of such behavior, warning, "If someone sows discord, they will not be spared." Mufti Nasir also called for a social boycott of individuals who instigate division within the community.

Addressing broader societal concerns, he urged tourists visiting Kashmir to respect local social norms. "We will not tolerate anyone drinking in front of mosques,' he said, emphasizing the importance of maintaining cultural and religious sensitivity.

Maulana Mohammad Rahmatullah Mir Qasmi emphasized the importance of moderation and propagating messages that foster harmony. "We need to protect our faith

for the younger generation and focus on unifying, rather than dividing, the community," he said.

The scholars collectively urged the public and community leaders to rise above sectarian differences, respect diverse beliefs, and work towards preserving Kashmir's rich Islamic heritage. They reiterated that unity is essential to counter external and internal forces aiming to destabilize Kashmir. President Anjuman-e-Sharie-

Shian, Aga Syed Muhammad Hadi underlined the importance of engaging Kashmir's younger generation with Islamic teachings, stating that their faith is being questioned.

He called for mutual respect between Shia and Sunni sects, saying how minor incidents often result in accusations and divisions.

"Enemies killing Muslims do not distinguish between sects, so why should we?" Hadi advocated for unity over sectarian disputes.

Patron Ittehadul Muslimeen, Maulana Masroor Abbas Ansari highlighted the existence of international conspiracies aimed at dividing Muslims and stressed the need to thwart such plans. "No one should be allowed to sow discord among Muslims in Kashmir," he said, urging unity in the face of these challenges.

Scholar from South Kashmir, Dr. Muhammad Sameer Siddiqui voiced disappointment over divisive rhetoric from certain clerics who, under the guise of leadership, insult the beliefs of others.

"As representatives of all sects of Muslims, we can come together and have tea. Why, then, should small clerics use pulpits to sow discord?

The scholars present unanimously decided to disown anyone who would fuel hatred on pulpits and urged police and administration to initiate action against those individuals.

When both parties arrived at the site, a fight broke out, with stones and sticks allegedly being used. In the incident and stated that five people were injured due to the gravevard dispute.

Meanwhile, the District Magistrate, recognising the potential for a breach of peace, has attached the land and placed it under the custody of the Tehsildar Aloosa.

An order issued by the DM, prohibits any individual from entering, using, or possessing the disputed land until further notice, aiming to prevent further violence or unrest.

To ensure the strict implementation of this order, the Station House Officer (SHO) of Bandipora has been directed to take all necessary measures to prevent any attempts to violate the terms.

Also, all parties involved in the dispute have been called to appear before the District Magistrate on January 20, 2025, for resolution. — (KNO)
