Trump Returns To White House

Launches New Era of Upheaval

Srinagar: Donald J Trump on Monday took oath for a second term as the United States President, announcing a raft of executive decisions, saying that the "golden age" of America had just begun.

In a fiery inaugural address, the 47th US president described January 20 as the "liberation day" and declared that "America's decline is over" as changes will come "very quickly".

"America will reclaim its rightful place as the greatest, most powerful, most respected nation on earth, inspiring the awe and admiration from the entire world," he said.

Trump storms back to the White House for the second term with a strongman persona and a vision of an all-powerful presidency with a promise to

aggressively reset US policies in a range of domains including immigration, tariffs and energy.

The new US president listed a series of actions he would roll out immediately including declaring a national emergency at the US-Mexico border, renaming the Gulf of Mexico as the Gulf of America, and that the US would take back the Panama Canal.

"From this day forward, our country will flourish and be respected again all over the world. We will be the envy of every nation, and we will not allow ourselves to be taken advantage of any longer," Trump said.

The Republican leader vowed to put America "first" and that the country would "flourish and be respected" under his leadership as a "peacemaker and a unifier". The American dream will

Srinagar: J&K Bank today announced robust financial results for the October-December quarter (Q3 FY 2025), with net profit surging by 26.2% year-on-year (YoY) to Rs 531.51 Cr compared to Rs 421.08 Cr reported during the same period last fiscal.

The Bank's Board of Directors approved the numbers for the quarter and nine-months during a meeting held today at the Bank's Zonal Office in Jammu.

Well on its course to meet annual profitability targets, the Bank's net profit for the first nine months of the current financial year has jumped 32.7% YoY to Rs 1497.92 Cr, compared to Rs 1128.60 Cr recorded for the same period last year, reflecting its sustained growth trajectory. | More on P6

Study Relates Exposure To Air Pollution Prior To Conceiving With Higher BMI In Children

ncreased exposure to air pollution in the months prior to pregnancy is associated with higher body mass index (BMI) and obesity risk factors in children up to two years after birth, a study involving over 5,800 motherchild pairs from China has shown.

The study, published in the journal Environmental Research, found that an increase in PM2.5 levels by 16.2 micrograms per cubic metre during preconception -- three months prior to pregnancy -- was linked to a rise of 0.078 in child BMIZ at age two.

A BMIZ, or body mass index z-score, is used to compare a child's BMI with that of peers of the same age and sex. Risks of pollution during preconcep-

Researchers from the US and China

recruited the mother-child pairs from maternity clinics in Shanghai to understand how exposure to PM2.5, PM10 and nitrous oxide pollution during preconception impacted children's growth in the first two years of life.

The team also found that an increase in PM10 pollution by 21.1 micrograms per cubic metre was associated with an increase of 0.093 in the child's BMI at age two.

Further, from the age of six months onward, children exposed to higher levels



of pollution during preconception were found to have higher weight, BMI and BMIZ growth rates. Air pollution exposure at the participants' home addresses was estimated using satellite data, pollutant modelling and meteorological factors.

"The magnitude is small, but because air pollution is widespread and everybody is exposed, the risk of exposure on children's obesity may be substantial and may start before their mothers' pregnancy," senior author Zhanghua

Chen, an assistant professor of population and public health sciences at the Keck School of Medicine, University of Southern California, US, said.

Exposure of pregnant women to air pollution has been linked to negative effects on children's health, such as respiratory conditions and a higher risk for chronic ones, including obesity and heart disease.

However, few studies have looked at preconception -- environmental exposures during this period can affect the

health of sperm and eggs, which are in their final stages of growth, the researchers said.

"These findings imply that the three months before conception are important and that people who plan to bear children should consider taking measures to lower their air pollution exposure to reduce their children's risk for obesity," first author Jiawen Liao, a postdoctoral research associate in population and public health sciences at the Keck School of Medicine.

While the study is observational and could not establish cause-and-effect links, the researchers suggested measures to lower potential harm, including wearing a mask, using air purifiers and staying indoors as much as possible when outdoor air quality is poor.

Study Estimates Life Expectancy In Dementia Depends Strongly On Age At Diagnosis

ow long one survives with dementia depends strongly on one's age at diagnosis, ranging from about nine years at age 60 for women to a little over two years at age 85 for men, a research has estimated. Overall, women were estimated to live for 4.5 to eight years to following a dementia diagnosis. The review of 261 studies, published in The British Medical Journal, also found that dementia shortened life expectancy by about two years for people diagnosed at 85 years of age, by three to four years at age 80, and by up to 13 years at age 65. Researchers at Erasmus MC University Medical Centre, the Netherlands, looked at studies published between 1984 and 2024 (largely from North America and Europe), involving over five million people with dementia. Over 60 per cent of the individuals, aged 80 years on average, were women.



As population around the world ages, cases of the ageing-related neurological disorder are projected to rise, with loss of vision and high cholesterol added to a list of 12 risk factors previously identified, including low education, air pollution, obesity, and depression, according to a 2024 Lancet Commission report.

However, estimates of how long one survived with dementia varied widely, the researchers said.

In the analysis, they wrote, "Median (typical) survival from diagnosis appeared to be strongly dependent on age, ranging from 8.9 years at mean age 60 for women to 2.2 years at mean age 85 for men." Overall, women were found to live four years fewer than men, which the researchers attributed to a later age at the time of diagnosis. Further, people in Asia were found to survive the ageing-related condition more than a year longer, compared to those in the US and Europe. The analysis of the "largest number of studies to date over a prolonged period" offers potential for personalised prognosis (outcomes) and planning for the care of the affected, the authors said.

E-Rickshaw Controversy

Authorities Assure "Fair Fare" Settlement

Srinagar: The ongoing controversy between E-rickshaws and the transport department was finally settled on Monday after a meeting between authorities and representatives from the E-rickshaw association.

Officials from the Erickshaw association stated that they met with the RTO Kashmir and SSP Traffic Srinagar, who assured them that the matter would be resolved within two to three days.

According to details, the dispute escalated earlier when the Transport Commissioner announced the fare structure for E-rickshaws. Many E-rickshaw drivers disagreed with the rates and subsequently stopped operating.

In a tweet on X, (formally twitter), Transport Commissioner J&K, Vishesh Mahajan wrote: During the day while interacting with the media the rate of e rickshaw was elaborated. "I would like to clarify that it is 10 rupees per Km per vehicle and not per passenger. I have asked the RTOs Jammu/Kashmir to further clarify and issue rate lists.

Notably, the disruption impacted E-rickshaw operations across many parts of Srinagar city. On Monday, E-rickshaw drivers held protests in several areas of Srinagar city and Ganderbal district alike, expressing their dissatisfaction with the fare structure.

Auto drivers in Ganderbal district protested against

the recently fixed fare rates by the government. "The drivers claim the rates are inadequate and unfair, and they are demanding a revision to protect their livelihoods," a protester said.

Meanwhile, Arshid Bhat, General Secretary of the All J&K E-Rickshaw Association, said that the issue has been resolved. "The protests that occurred yesterday and today were not called by our association. We met with the RTO Kashmir and SSP Traffic Srinagar, who assured us that the matter would be taken up with the authorities. Erickshaws are now operating normally," he said.

A senior official from the Srinagar Traffic Police told KNO that they have no objection to E-rickshaws operating on city roads. "The Traffic Police is an implementing authority. If the fares are revised, we will ensure compliance. The revision of rates is solely the responsibility of the Transport Department, and they are only working on it," the official said.

Lack Of Dedicated Stops For Smart City Buses Causes Traffic Woes

Srinagar: The absence of designated bus stops for Smart City buses creates significant challenges for traffic management in Srinagar.


Commuters have raised concerns about the unregulated stops made by e-buses, which often occur every few meters. These frequent halts are leading to traffic congestion, especially during rush hours, making it difficult for people to reach their destinations on time.

"Being stuck behind a Smart City bus is incredibly frustrating," said Sajad Mir, a daily commuter. "The buses are so large that they block entire lanes, leaving vehicles trapped behind them for extended periods."

Many passengers believe that introducing specific bus stops is essential for the system to function efficiently. Without such stops, buses are forced to pick up passengers from random locations, adding to delays and disrupting traffic.

"If proper stops were established, people would gather at those points, and the buses wouldn't have to stop at irregular intervals," said Aijaz Ahmad, another commuter.

While the Smart City buses come equipped with modern technology and applications, locals say that their current operation mirrors traditional buses, defeating their purpose. "These buses are meant to provide a streamlined service, but they are creating more chaos instead. We benefit from them, but it shouldn't come at the expense of worsening the traffic situation," a local said. [KNT]



Sakeena Itoo Reviews Functioning Of SKIMS

While reviewing the current state of infrastructure at SKIMS, including inpatient and outpatient facilities, diagnostic centers as well as emergency services, the Minister urged the administration to expedite the works on ongoing projects aimed at modernizing facilities and ensuring patient comfort at the institute. She also asked them for decongestion of the emergency ward so that the patients are treated effectively.

Addressing the issue of manpower and staffing shortage, Sakeena Itoo asked the Director SKIMS to recruit the necessary paramedics and other medical professionals for key departments on contract basis till regular recruitments are made. She asked the SKIMS administration to maintain due transparency during the entire process of recruitment.

Reviewing the financial and resource allocation of the institute, Sakeena Itoo called upon the SKIMS administration to maintain due transparency and accountability while executing different works. She asked them for timely updation of expenditure on BEAMS portal in coordination with the Finance department.

During the meeting, Director SKIMS gave a detailed presentation informing the meeting about various interventions being made for improving patient care at this prestigious institution. He informed the meeting that two major achievements will be accomplished by the institute this year with the start of Liver transplant and Neonatal/Paediatric cardiac surgery. PDD Now Says Power Only For 2.5 Hours

RINAGAR-With break-downs in two major transmission lines, the valley shall have to do with just 2.5 hours of electricity in every twenty four hours for some time to come. The near round-the-clock curtailment shall continue till such time as the tower, total damage to which has been cited as the cause of the crisis, has been re-erected

Bomb blasts at transmission towers in Qazigund and Wagoora have reduced power supply to the valley by 90 per-cent, a chief engineer of the PDD said today in Srinagar.

Addressing a press conference summoned ostensibly to explain away unprecedented power cuts, the chief engineer, Abdul Majeed Mattoo, denied reports that power supply from the northern grid had been cut off following non-payment of dues by the state. "Power has not been cut off. There is a fault is the transmission line," he said. Mattoo said that efforts were on to re-erect the tower but declined to set a specific time-frame for the complete restoration of power supply. The chief engineer said that a mere 85 MW of power were available to the valley as against a requirement of 750 MW. Out of this 85 MW, thirty went to essential services like hospitals, telephone exchanges, army and broadcasting institutions, he said.

Abdul Majeed Mattoo said that on the night intervening the 13th and 14th of January a breakdown of the 220 KV Kishenpur-Pampore line and the 132 KV Udhampur-Srinagar line occurred because of a blast in one special 220 KV tower in Qazigund, completely damaging the tower. This, he said, had deprived the valley of 230MW of peak power and about 50 lakh units of energy. The chief engineer claimed that the department had quickly swung into action and restored the 132 KV Udhampur- Srinagar line thereby ensuring supply of about 60MW of power and 12 to 14 lakh units of energy.

The World Trumped

he inauguration of Donald Trump as the 47th US president marks a critical juncture not just for the United States but for the entire world. In his second term, Trump inherits a world that has dramatically changed. The war in Ukraine, the escalating US-China rivalry, and a global economy teetering on recession provide the backdrop for his administration. This time, however, Trump's strategies appear poised to be even more disruptive.

However, Trump's inauguration has started on a positive note: Israel and Hamas have finally agreed to a ceasefire. Already three Israeli hostages and 90 Palestinian prisoners have been freed. It would be interesting to see how the Trump administration will deal with the situation. The world will hope that it works towards not just a durable ceasefire but towards an abiding solution that brings the decades long conflict and bloodshed towards an end. In South Asia, the countries including India will watch keenly how Trump deals with China. Overall, Trump as the US president holds out a fraught prospect for the world. The coming weeks and months will make clear how the situation evolves. For now we can only wait and watch.



n the age of artificial intelligence, technology has enchanted education so deeply as to metamorphose the way and manner in which students learn and interface with knowledge completely. The integration of AI tools has made the classroom completely flawless, creating an artificial sense of convenience and efficiency. But what about AI itself? AI's strengths and productivity rely on predefined rule sets concerned with standardized outcomes. And so creativity, instead of being seen in terms of original dimensionality and uniqueness, is made into something efficientan AI-crafted poem or painting is

expected to sheer perfection, but at the same time it is cold and lacks all the emotion brought by human expression. This sometimes becomes a kind of vicious cycle, that of AI-created generations growing up lacking the capacity to think unconventionally or expressing personal constructs even if it is intrinsic, as

the skills of their creativity have been surpassed by the possibilities of the machine.

Another concern lies in the culture of instant gratification that AI fosters. Creativity is not an instant process; it demands time, effort, and the willingness to embrace failure. And what is Al but a means for instant, al-

most immediate results when one can get results the hard way by brainstorming, sketching or experimenting for hours? After one swift change, the whole essence of hard work is lost on working students. Patience and persistence at doing the real work will also be stripped from young learners.

Additionally, the very nature of AI's assistance can limit students' exposure to diverse ways of thinking. Human creativity is not only shaped by individual effort but also by collaboration, cultural influences, and varied experiences. AI, as we have been saying, is the game changer; it is still developed to observe its coding boundaries. An illustration of stifling creativity is one that narrows the number of ideas that might be synthesized. It is with more or less certainty and then becomes less than likely that les-

sons taught in school will motivate learners to think unconventionally or revert to seemingly meandering experiments.

We should, as parents, educators, and policymakers, ensure that AI in education is not used in such a way that it kills the imagination. This is by allowing students to be independent thinkers and to take risks, to accept challenges, and to value the process of creating something. In this regard, students should have opportunities to say what they have to say and not just resort to AI-given solutions. An environment that encourages students to explore, experiment, and make mistakes will help them feel a sense of accomplishment and build creative confidence.

AI can be a powerful ally in the learning journey, but it should not replace the invaluable experiences that nurture the creative spirit. Creativity is the cornerstone of innovation, and its preservation is essential for building a future driven by ideas, originality, and human ingenuity. If we are to prepare the next generation for an increasingly technological world, we must ensure that they do not lose the essential skills that make them unique skills that machines can't replicate, no matter how advanced they become. Tn a modest classroom in Edo State, Nigeria, an educational revolution unfolded. Over six weeks, students accomplished what would typically take two years. This wasn't a product of extra hours or an elite teaching corps. It was the result of generative AI—a large language model serving as a virtual tutor in an after-school program. The pilot program, supported by the World Bank and published on their website, delivered remarkable results: students made significant strides in English, digital literacy, and even foundational AI concepts. 

India's Social Protection Coverage Doubled from 24.4% to 48.8%: Mansukh Mandaviya

New Delhi: Union Minister of Labour & Employment and Youth Affairs & Sports, Dr. Mansukh Mandaviya inaugurated a two-day international seminar on "Formalization and SocialSecurity Coverage for Workers in the Informal Sector: Challenges and Innovations" in New Delhi on Monday. Union Minister of State for Labour & Employment, Sushri Shobha Karandlaje, Secretary (Labour & Employment), Dawra, ISSA President, Dr. Mohammed Azman along with other dignitaries graced the inaugural session of this technical seminar. Addressing the gathering,

Dr. Mandaviya highlighted the significance of the twoday seminar, stressing that social security must reach ordinary people to ensure they can live with their basic needs adequately met. He emphasized that the concept of social security dates back to ancient times and remains a continuous process. Quoting the great philosopher Chanakya, Dr. Mandaviya underscored that those living below the poverty line, particularly from the lowest strata of society, should be entitled to all benefits and ease of living. He further stressed that even self-employed individuals should also be provided with social security measures.

Dr. Mandaviya pointed out that, given India's size and demographic diversity, no other country has made as significant progress as India in improving social security for its citizens over the past decade. He highlighted that "India's social protection coverage doubled from 24.4% to 48.8%," according to



ILO's World Social Protection Report 2024-26. Nearly 920 million people, or 65% of the population, are covered by at least one social protection benefit—either cash or in-kind—through schemes initiated by the Central Government. The global average in social protection coverage increased by 5% points due to India's substantial

advancements. India has made notable strides in areas such as health security, pension security, livelihood security, and food security, ensuring comprehensive support for its population. Dr. Mandaviya shared specific achievements, such as 600 million Indians now being covered under health security, with free health coverage of up to 5 lakh available at over 24,000 hospitals across the country. He also mentioned that 800 million people benefit from free food grain distribution, and the launch of the eShram portal has been a key initiative, enabling more than 300 million informal workers to register and access social security benefits. In the past decade, 248 million people have escaped multidimensional poverty due to these social

security measures.

The Union Minister also highlighted India's impressive economic growth, with a GDP growth of 6.7% and a workforce of 643 million people. Women's participation in the workforce has risen from 23.3% to 41.7% in the last six years. Dr. Mandaviya also addressed the emerging gig economy, announcing that the new labour code has defined gig workers, and efforts are being made to bring them under the umbrella of social security.

Union Minister of State for Labour & Employment, Sushri Shobha Karandlaje, also addressed the gathering, emphasizing the significance of the seminar, calling it timely. She highlighted that this international event marks an important milestone in advancing social protection for informal workers. Sushri Karandlaje reiterated the government's strong commitment to promoting and protecting workers' rights, ensuring they are shielded from discrimination and exploitation, and provided with equal economic and social opportunities. She pointed out that this vision aligns with Prime Minister

Modi's clear direction, who acknowledges the crucial role of informal sector workers in nation-building, referring to them as partners in achieving a "Viksit Bharat" (developed India). She further stressed the need for both the government and social security institutions to innovate and collaborate in creating solutions that effectively address gaps in social protection for workers.

Employment), Sumita Dawra, highlighted India's Sumita commitment to providing adequate social protection and generating quality jobs. She emphasized harnessing the demographic dividend, noting that over 65% of India's population is below the age of 35 years. Dawra mentioned that to ensure social security for formal sector workers, the government is strengthening services and expanding coverage under the guidance of Union Minister Dr. Mansukh Mandaviya through the EPFO and ESIC. She also highlighted the government's efforts to extend social protection to informal sector workers, pointing out the launch of several schemes, including the eShram portal, which serves as a one-stop solution providing easy access to central and state welfare schemes for over 300 million unorganized sector workers already registered on the platform.

Handicrafts Dept Warns Against Sale of Fake Products

Srinagar: Handicrafts and Handloom Department, Kashmir Monday warned showroom owners dealing with hand-made craft products to desist from selling machine-made items in the garb of genuine handmade products, failing which strict action under the ambit of Tourist Trade and Quality Control Acts shall be initiated.

A spokesperson from the Handicrafts and Handloom Department stated that several complaints have been received by the department wherein machinemade Turkish carpets have been sold to tourists and other buyers in the name of Kashmir handknotted carpets, thus bringing a bad name to the rich heritage of Kashmir. "Acting swiftly, several showrooms are being inspected and unlabelled machine-made products confiscated," he said.

The spokesman further stated that the Central Inspection Squad from the Quality Control wing of the Department has been directed to intensify inspections of various showrooms in Srinagar City Centre and en route health resorts of Gulmarg and Pahalgam, besides other locations to crackdown on traders engaged in sale of counterfeit products, branded as hand-made Kashmir Art.

In order to promote sale of exquisite hand-made products, the spokesperson urged the stakeholders to approach the Handicrafts & Handloom Department for GI tagging, testing and certification of their products at CDI & IICT, reaching out to the customer satisfaction and safeguarding the rich heritage of Kashmir.

"The department has worked out a plan to significantly increase the capacity of testing and certification of hand-made products especially at Pashmina Testing and Quality Certification Centre at CDI," he said, adding that various IEC campaigns are currently running at local as well as national level to motivate the customers to insist upon buying labelled hand-made products.

The team members received a briefing from senior district, health and police officers before heading to the village early on Monday.

Union Home Minister Amit Shah ordered the constitution of the inter-ministerial team to ascertain the causes of the deaths in the three families related to each other in the remote village, about 55 kilometres from Rajouri town, between December 7 and January 19.

The officials said the team, accompanied by dozens of senior officers of various departments, reached Badhaal around 11.30 am and visited the bereaved families, even as gravediggers were preparing the last resting place of Yasmeen Kousar (15) -- the sixth child of Md Aslam who breathed her last at the SMGS Hospital in Jammu on January 19.

The central team divided itself in two groups and undertook an investigation, including collecting samples, they said.

National Conference leader and local MLA Javid Iqbal Choudhary said the team's visit was meant to carry forward the ongoing investigation to ascertain the cause of the deaths.

"Earlier, health teams from the ICMR (Indian Council of Medical Research), AIIMS (Delhi), PGI (Postgraduate Institute of Medical Education and Research in Chandigarh) and others from premier institutions visited the village along with a full-fledged laboratory. They were all experts in the field and the visit of this inter-ministerial team is to carry forward that investigation," he said.

The officials said Kousar's body reached the village late in the afternoon and was buried in the new graveyard set up adjacent to her five siblings and grandparents who died over the past week. Nine members of two families died in the village between December 7 and 12.

Additional District Magistrate (Kotranka) Dil Mir carried out the proceedings of sealing Aslam's single-storey thatched-roof home shortly after the experts accompanying the team collected samples from there.

"This is the house where eight of the deceased persons were living in and the seizure is routine work. The house, along with the house of another victim, Fazal Hussain, were sealed earlier and reopened to facilitate the experts to collect samples," Mir told PTI.

He said the government had already banned holding any feast, whether related to weddings or religious ceremonies of the dead, for the time being, similar to the restrictions imposed during the COVID-19 pandemic, as the investigation to ascertain the causes of the deaths was yet to be completed.

"The people are fully cooperating as they understand the gravity of the situation," the officer said.

While the village is in grief, one resident -- Ikhlaq Shah -- tied the knot in a simple function that saw the groom accompanied by four of his close relatives and friends visiting the home of the bride in the nearby Draj village and performing 'nikah'.

"We cancelled the marriage function due to the grief in the village but performed the nikah ceremony, according to the already-announced schedule," Shah's relative Md Hafeez said.

He said they had sought permission from the executive magistrate concerned and added that no one was invited to the function.

According to the officials, the central team, in collaboration with the local administration, would work on providing immediate relief as well as taking precautionary measures to prevent such incidents in the future.

Experts from some of the most reputable institutions in the country have been arranged to manage the situation and understand the causes of the deaths.

The patients complained of fever, pain, nausea, intense sweating and loss of consciousness before dying within days of their admission to hospitals.

Earlier, a Jammu and Kashmir government spokesperson had said that investigation and samples empirically indicated that the incidents were not due to a communicable disease of bacterial or viral origin and that there was no public health angle.

The police have also set up a special investigation team after certain neurotoxins were found in the samples of the dead.

Authorities recently sealed a spring in the village after its water tested positive for some pesticides or insecticides.

The additional deputy commissioner ordered the sealing of the spring, along with deployment of two to three security personnel round-the-clock, at the water resource in the village

"It is a precautionary measure... We are already providing them (villagers) fresh water through tankers," he said.

of the detention order (No. DMP/PSA/23/11) dated 31 March 2023.

"The detenue (detainee) cannot be expected to make a meaningful exercise of his Constitutional and Statutory rights guaranteed under Article 22 (5) of the Constitution of India and Section 13 of Jammu and Kashmir Public

Safety Act, 1978, unless and until the material on which the detention order is based, is supplied to detenue," the court said.

The representations by Bhat's wife and the son were moved after the detention order was approved by the Government on 5 April 2023, the court observed. It implies he has been deprived of his right of making a representation against his detention before the detention order was approved by the Government, for, having not been informed to do so, the court said.

"It has consistently been held by the Courts of law that violation of any of the constitutional rights of the detenue,by the detaining authority,puts under cloud the whole detention order."

Furthermore, the court said that it was not convinced to accept the plea of the authorities that Bhat was not showing the signs of remorse after having been bound down under Section 107 Cr.PC read with Section 151 Cr. PC, as there is nothing on record in support of such contention.

"The respondents (authorities) cannot be expected to take recourse to hollow assertions only, as they were obliged, by law, to see that the detenue has indeed indulged in the similar activities for which he was bound down and there was a reasonable prognosis about his future conduct, in light of the well-articulated circumstances, that similar activities would likely be repeated by the detenue," the court added.

1330 Schools With 31,000 Enrolment Run By 'Single Teachers'

SRINAGAR: In Jammu and Kashmir more than 31,000 students are enrolled in those schools that function with a single teacher posted or deployed—thus raising a question on quality of the education in educational institutes.

The updated official figures reveal that In Jammu and Kashmir, '31,054 students were enrolled' in those educational institutes wherein only one teacher was posted or deployed.

According to the recent official figures, more than 1300 schools in Jammu and Kashmir were those institutes that were functioning with only a single

It has been learnt that "At least 1330 schools in Jammu and Kashmir were functioning with single teachers."

Principal Secretary, School Education Department was not available to comment on the issue. Besides, Project Director of Jammu and Kashmir Samagra Shiksha could not answer the repeated calls.

President of the Private School Association of Jammu and Kashmir (PSAJK) G N Var said that "In more than 5400 private schools in Jammu and Kashmir, we have a Pupil

Teacher Ratio of 1:20. Besides, in every school, we have a minimum of seven teachers in each private school.

On asking about the closure of any private schools owing to low or zero student enrolment, Var said, "Right from the very inception, not even a single private school has remained with zero student enrolment. However, because of government restriction, intimidation and harassment by way of imposing filing of NOCs and other documents, some private schools may have got closed due to the government restriction."

On Saturday, it was reported that the updated official figures reveal that in Jammu and Kashmir, at least 119 schools were functioning in the region with no student enrolled in the institution.

The figures have revealed that at least 238 teachers were posted or deployed in the schools wherein no student

was enrolled. It also states that on an average at least seven teachers were posted or deployed in

schools of Jammu and Kashmir. In July-2024, the news agency reported that there were a total of 23,117 government run schools in Jammu and Kashmir out of which 4394 have been deleted from the UDISE data—(KNO)

Army Man Killed In Sopore Gunfight

SOPORE: An army man was killed in an encounter that erupted in the Sopore area of north Kashmir's Baramulla district on Monday. The operation marks the first gunfight in Jammu and Kashmir in the year 2025.

The operation, conducted in Gujjar Pati, Zaloora, under the jurisdiction of Sopore police district, was based on intelligence inputs regarding the presence of terrorists, an offi-

He, however, said that after an extensive search, the terrorists managed to flee the encounter site. The operation was then called off.

The official said the operation began with a joint team of the Army, CRPF, and Jammu & Kashmir Police cordoning off the area. The search intensified after fire was observed from inside a busted hideout.

The operation, which was halted due to darkness, resumed at first light. Security measures had already been heightened across the valley ahead of Republic Day celebrations.

In the ensuing gunfight, an army man, Swr Pangala Kartheek of 22 Rashtriya Rifles, sustained fatal injuries and succumbed, the official said, adding that despite sealing all entry and exit points, the terrorists escaped.

The Indian Army's Chinar Corps paid rich tributes to Swr Pangala Kartheek for his "supreme sacrifice".

In a post on social media platform X, Chinar Corps said: "All ranks of the Chinar Corps of Braveheart Swr Pangala Kartheek, who laid down his life in the line of duty. Chinar Warriors salute his immense valour and sacrifice, express deepest condolences, and stand in solidarity with the bereaved family."

Lieutenant Governor Manoj Sinha also paid homage to the martyred soldier. "I salute the supreme sacrifice of our Army braveheart Swr Pangala Kartheek. His valour and sacrifice will never be forgotten. The entire nation stands firmly with the family of the martyr in this hour of grief".

GMC Anantnag Introduces Diet Facility For Patients

ANANTNAG: To enhance patient care and uphold hospital decorum, the administration of Mirza Mohammad Afzal Begh Memorial (MMABM) Associated Hospital, Government Medical College (GMC) Anantnag, has prohibited outside food for patients while introducing a dedicated diet facility tailored to their medical needs.

A hospital official said that this decision is aimed at improving hygiene, discipline and overall care standards within the hospital.

He said attendants are now allowed to visit patients strictly between 3:00 pm and 4:30 pm, adding that this restriction ensures minimal disruptions to patient care and helps medical staff focus on their duties efficiently.

'The hospital now provides four meals daily, from breakfast to dinner, specially prepared to meet the nutritional and medical needs of patients. Attendants can access food from outside facilities such as the

hospital canteen," he said. To ensure hygiene and pre-

vent health hazards, patients are no longer permitted to bring outside food into the wards, the official said, adding that the use of polythene bags within hospital premises has been strictly banned to maintain cleanliness and align with eco-friendly practices.

The measures were introduced following concerns about improper hygiene and issues such as rodent infestation, which were exacerbated by food brought from outside.

The hospital's Incharge Security Officer has been directed to enforce these rules diligently, with strict action to be taken against any violations.

administration has urged patients, attendants and staff to cooperate with the new measures, saying these changes aim to create a safe and conducive environment for patient recovery.

"This initiative ensures patients receive hygienic and nutritionally balanced meals while also contributing to better hygiene and discipline within the hospital," the official said-(KNO)

J&K Cabinet Clears Key Proposals

Recommends Convening Of Assembly Session In March

JAMMU: The Jammu and Kashmir Cabinet which met under the chairmanship of Chief Minister here on Monday cleared several administrative proposals.

Sources revealed that the Cabinet cleared the proposal of revision of Dearness Allowance (DA) rates payable to government employees, pensioners, and family pensioners, effective from July 1, 2024.

It also gave its nod for implementation of a 3-tier faculty structure in Government Dental College, Srinagar, and Indira Gandhi Government Dental College, Jammu, as per the norms of the Dental Council of India (DCI) on staffing patterns. It also cleared the proposals

relating to grant of administrative approval for key proposals mooted by the Housing & Urban Development Department. The proposals included dumpsite remediation through bio-mining/bioremediation of 11.00 Lakh MTs of legacy waste at Achan dumping site, Srinagar, at an estimated cost of Rs. 60.50 crore (Rs. 33.00 crore from 14th FC and Rs. 27.50 crore from SBM 2.0), pollution abatement and conservation of River Jhelum at Chuntkul and Gawkadal areas in Srinagar, at an estimated cost of Rs. 6445.68 lakh (Rs. 6380.68 lakh under the National River Conservation Plan) and pollution abatement and conservation of River Banganga at Katra Rs. 92.10 crore under the National River Conservation Plan. The cabinet also cleared the

proposal of construction of a new hospital block for the emergency operation theatre at SMHS Hospital, Srinagar. It also cleared the proposal

on dispensing with oral tests/ interviews for posts in pay level-6, as recommended by the J&K Service Selection Board.

The amendments to the Jammu and Kashmir Goods and Services Tax Act, 2017, were also cleared by the cabinet.

Sources disclosed that the cabinet also recommended to the Lieutenant Governor to convene a session of J&K Assembly from the first week of March.

J&K To Import 900 High-Quality Sheep From Australia

Town, at an estimated cost of

SRINAGAR: In a bid to meet the rising demand for meat in Jammu and Kashmir, the state government has approved the import of 900 sheep from Australia under the Integrated Agriculture Development Program (HAPD).

The initiative, with a budget of Rs 26 crore, focuses on two high-yield breeds, Dorper and Texel, renowned for their superior meat production capabilities.

As per the details, the Jammu and Kashmir government has decided to import 900 high-quality sheep from Australia to meet the increasing demand for meat in the region. These sheep, belonging to the Dorper and Texel breeds, are known worldwide for their superior meat production. The initiative is part of the Integrated Agriculture Development Program (HAPD) and comes with a budget of Rs 26 crore. The plan aims to make the state self-sufficient in meat production, reducing

dependency on imports. Currently, Jammu and Kashmir consume approximately 15 lakh sheep annually, with 41% of the demand being met through imports from other parts of the country, costing the state Rs 1,400 crore. The new project is part of a broader Rs 329 crore, five-year

plan to boost wool and mut ton production while cutting

down on imports. Official sources said that the imported sheep will undergo a thorough quarantine process, spending one month in quarantine in Australia before being transported to India, where they will stay in dedicated quarantine centers for another two months. A center has already been set up in Rajbagh Srinagar, Kathua- Jammu, and the sheep will later be housed at government sheep rearing farms in Reasi. Out of the 900 sheep, 450

Dorper sheep will be allocated to the Jammu division, while the same number of Texel sheep will go to the Kashmir division.

Dorper sheep, originally from South Africa, are known for their high fertility, adaptability to different climates, and rapid muscle development. Lambs of this breed can grow to 35-40 kilograms in just four months, with adult sheep weighing up to 90 kilograms. Texel sheep, a Dutch breed from the Netherlands, are equally prized for their exceptional muscle development. They have smooth heads and legs, short height, broad faces, black noses, and small ears, making them ideal for meat production.

Reports inform that a team of six sheep farming experts from Jammu and Kashmir will soon leave for Australia to oversee the selection and transportation process. (KNO)

Traffic Enforcement Generates More Than Rs 28.36 Cr Of Revenue

SRINAGAR: The traffic enforcement authorities in Kashmir have made significant strides in improving road discipline, generating a revenue of Rs 28,36,03,261 from 8,25,304 challans issued between January and December 2024.

In addition to this, a total of 12,612 vehicles were seized across the region for various traffic violations.

In Traffic City Srinagar, 4,13,150 challans were executed, leading to a revenue collection of Rs 16,56,97,211.

December saw the highest number of challans at 43,947, followed by 41,225 in July and 37,506 in August. August also recorded the highest revenue collection at Rs 1,61,85,600, while February brought in Rs 1,52,42,000.

In terms of vehicle seizures, the Traffic City Srinagar impounded 9,118 vehicles, including 2,244 two-wheelers, 2,688 three-wheelers, and 4,186 four-wheelers. July saw the highest number of vehicle seizures, with 1,063, while



April had the lowest, with 528 impounded vehicles.

Meanwhile, in Traffic Rural Kashmir, 4,12,154 challans were executed, generating Rs 11,79,06,050 in revenue. March recorded the highest number of challans in rural areas, at 40,410, followed by October with 39,583 and January with 37,883. October also witnessed the highest revenue collection of Rs 1,26,35,630, followed by Rs 1,08,10,850 in July.

In rural areas, 3,497 vehicles were seized, including 1,504 two-wheelers, 112 threewheelers, and 1,861 fourwheelers. The highest number of seizures occurred in April, with 386 vehicles, while March recorded 265.

Officials emphasized that the enforcement drive aims to enhance road safety and ensure compliance with traffic regulations. The implementation of modern technology has allowed for online fine issuance, and vehicles are seized for violations to maintain order.

An official stated that while the enforcement drive plays a key role in regulating traffic, it is not a standalone solution to reducing accidents. "We can fine and seize vehicles, but road safety is everyone's responsibility. It is essential for people to follow traffic rules, wear helmets, and avoid reckless driving," he remarked.—(KNO)

J&K Election Commission Concludes Annual Revision Of Panchayat Electoral Rolls

JAMMU: The J&K Election Commission concluded annual revision of Panchayat Electoral Rolls with publication of Final Electoral Rolls, with January, 1st 2025 as qualifying date.

During the annual revision of Panchayat Electoral Rolls, which was started on 11-11-2024 with the publication of draft electoral rolls, several additions, deletions and changes in the entries of electoral rolls were incorporated.

A total of 341072 new voters have been added and 110768 names have been deleted because of death, shifting or other reasons. Besides, corrections were carried out in details of 10726 voters and 31180 voters were transposed to other Panchayat Halqas/Wards.

The final panchayat electoral roll has a total of 7000670 voters which includes 3566475 males, 3434048 females and 147 third gender voters and are available in the offices of



District Panchayat Election Officers, EROs, AEROs and PBEOs.

The Commission appreciated the cooperation of all stakeholders including political parties, District Panchayat Election Officers, Panchayat Observers, EROs, AEROs, PBEOs and youth in particular who turned up in huge numbers to register their names in the Panchayat Electoral Rolls.

It is pertinent to mention here that the process of Revision of Panchayat Electoral Rolls is a continuous updation exercise. All eligible voters who are 18 years of age as on 01-01- 2025 and their names are not figuring in the Final Electoral Rolls can get themselves enrolled by filling the requisite form and depositing the same with the concerned ERO/AERO.(KNS)
