

Srinagar: At 24, Salim Manzoor begins each day with a mix of determination and dread as he climbs into his e-rickshaw. A B.Com student by day and a driver by necessity, Salim uses the modest income to fund his education and support his family. Yet, despite his efforts, he feels the sting of societal judgment.

"Being a driver is seen as a low-class job here," Salim said. "People pass countless hurtful

comments without understanding how much it affects us mentally. Ambulance drivers are respected as lifesavers, but we are labeled as drug addicts or alcoholics. Why this discrimination?'

### **NDMA** Issues **Forest Fire Alert** For J&K

Srinagar: The National Disaster Management Authority (NDMA) has issued a warning of a very high risk of forest fires in Jammu and Kashmir over the next seven days due to an extended dry spell in the region. The advisory, valid until 11 am on January 30, highlights an alarming rise in fire incidents, particularly in the Jammu region.

"Very High Forest Fire Risk is likely to occur over forest areas in J&K in the next seven days. In case of emergency, dial 112," the NDMA stated.

Jammu and Kashmir, a forestrich region, has 20,230 square kilometers of forest, covering around 10% of its geographical area. Excluding Ladakh, where natural forests are minimal, the forest cover rises to 47%.

The forests in Kashmir mainly belong to the dry temperate category, with Deodar, Kail, and Fir trees flourishing at different altitudes. While these evergreen forests are generally less susceptible to fires due to their dense ground cover, extended dry conditions significantly increase the risk.

Officials noted that the region has recorded an 81% deficit in rainfall from January 1 to 22, receiving only 11.4 mm compared to the normal 60.5 mm for this period. This severe shortfall in precipitation has heightened the forests' vulnerability during the ongoing dry spell. Authorities urge residents and

forest personnel to remain vigilant and take necessary precautions to prevent and respond to potential fire outbreaks.

## **GMC Letter On 'Quackery' Ignites** Debate, Officials Remain Silent

Srinagar: A letter allegedly written by the Professor and Head of the Department of Pediatrics at Government Medical College (GMC), Srinagar, has sparked a heated debate on social media. Addressed to the Principal/ Dean of GMC Srinagar, the letter raises serious concerns about the prevalence of quackery in the region, particularly highlighting the dangers of seeking "miracle cures" in Dara Harwan. . However, the document's authenticity remains unconfirmed, with officials refusing to comment and passing the buck .

The letter, which has stirred considerable attention, bears the subject line, "Circulation of information & action against quackery thereof." Sources revealed that Dr. Parvez Ahmad, the Head of the Department of Pediatrics, is currently on leave. Dr. Sheikh Mushtaq Ahmad, who is temporarily heading the department, is said to have authored the communication. The letter states, "With pro-

found reverence and humble submission, it is to request your august self to protect public health and safety. We need to take some strong

measures against the practice of quackery. During the past few years, there have been several cases of Acute Liver Failure (ALF), who were previously discharged from this hospital. After leaving the hospital, they went to some place in Dara Harwan to get miracle cures, wherein they received some unproven medical treatments and complementary therapies, only to land in the ICU with ALF and subsequently die. Kindly take all possible necessary measures against such unqualified individuals to safeguard future generations."

## **Food, Medicine That Can Change Your Skin Colour – Sometimes Permanently**

hen an 84-year-old man in Hong Kong went to hospital with an enlarged prostate, doctors were startled to see that his skin - and even the whites of his eyes - had turned silver-grey. A deeper investigation revealed silver deposits permeating his tissues, turning him a hue more often reserved for science fiction.

Far from a one-off oddity, in 2007 press reports described Paul Karason as a "blue man" after he attempted to cure sinus and skin problems by ingesting a homemade silver chloride solution – and there are many other examples.

These striking cases reveal a profound truth: our bodies can display the residue of what we consume. The adage "you are what you eat" usually refers to overall health and nutrition, but that phrase can be startlingly literal when our skin takes on unexpected colours.

The cases above illustrate dramatic instances of the condition known as argyria, in which silver particles accumulate in the body. Silver was once a mainstay in medical treatments for its antimicrobial properties. But modern evidence shows that consuming or absorbing too much can transform one's skin in ways that seldom fade. In argyria, silver ions circulate through the bloodstream and become embedded in the dermis, a layer beneath the surface where the body cannot easily clear them. This is the layer that tattoo pigments reside in.

A similar phenomenon, albeit rarer, is chrysiasis, in which gold deposits infiltrate the skin. Historically, gold-based therapies

were occasionally prescribed for inflammatory disorders, and in some cases, patients who received these treatments developed a distinctive slate-grey or grey-purple discolouration that, much like argyria, could not be easily undone.

Pigments from the plate Orange, yellow and red pigments exert the most influence over skin, and orange seems to reign supreme. This shade, often associated with carrots, sweet potatoes and pumpkins, comes from carotenoids, a class of pigments naturally found in plants.

Carotenoid pigments are fat soluble. When consumed, they are absorbed in the small intestine and transported via lipoproteins in the bloodstream to be stored primarily in fat-rich tissues, including the subcutaneous layer of the skin. This storage gives the skin a characteristic golden hue, most notably when carotenoid-rich foods are consumed in high quantities.

Of the many carotenoids found in nature, beta-carotene is the star player: a strong orange tint and high "bioavailability" – the term used to describe drug absorption – make it particularly

ning. But moderation is key. The 90s juice brand Sunny Delight never really recovered from the controversy of orange-stained Sunny D kids.

Naturally occurring dietary pigments such as anthocyanins, betalains and chlorophyll offer many health benefits, but rarely leave a mark.

Anthocyanins, found in berries, red cabbage and purple carrots, provide the deep reds, purples and blues we associate with these foods. Known for their antioxidant properties, they are water-soluble, meaning they are quickly metabolised and therefore unlikely to leave a mark on the skin.

Similarly, betalains, the pigments responsible for rich reds and yellows, offer detoxifying and anti-inflammatory benefits but are excreted by the body without a visible effect on skin tone. Excess ingestion may, however, cause urinary and faecal colour change.

These colourful tales carry more than an aesthetic message. They highlight the fine balance required in our relationship with the substances we ingest. From wholesome pigments to unintended consequences, they serve as a vivid reminder that while food may be medicine and may be transformative, we are, quite literally, what we eat. Sunlight compounds the effect by triggering a process called photoreduction, which turns silver ions into metallic silver or related compounds. As a result, affected lighter skins adopt a bluish or greyish tinge. And in brown and black skin, the discolouration may appear as a darker grey or slate-blue hue, effectively creating an inadvertent tattoo.

**Global Survey Finds Public Trust In** Science Second Highest In India

ublic trust in science is the second highest in India, following Egypt, with a moderately high level overall worldwide, according to a survey spanning 68 countries, including under-researched ones in the Global South.

Australia ranked fifth and Bangladesh sixth, while New Zealand ranked ninth and the US twelfth for public trust in scientists. The analysis, published in the journal Nature Human Behaviour, found no evidence for the oft-repeated claim of a crisis of trust in science, researchers said. "Our results show that most people in most countries have a relatively high level of trust in scientists and want them to play an active role in society and politics," lead researcher Viktoria Cologna, from ETH Zurich, Switzerland, said. The survey, the first in a post-pandemic world, included nearly 72,000 people. The majority of the participants also perceived scientists as qualified (78 per cent), honest (57 per cent) and concerned about people's well-being (56 per cent), the authors found.

However, significant differences between countries were noticed -- in particular, people with right-wing political views in Western countries tend to have less trust in scientists than those with left-wing views.

Further, 83 per cent of the survey respondents believed that scientists should communicate with the public about science, and 52 per cent that scientists should be more involved in the policy-making process, the researchers found.

The participants also gave high priority to research related to improving public health, solving energy problems, and reducing poverty.

While research related to developing defence and military technology was given a lower priority overall, people in African and Asian countries often demand high priority for developing defence and military technology, the authors said.

"Our results also show that many people in many countries feel that the priorities of science are not always well aligned with their own priorities. We recommend that scientists take these results seriously and find ways to be more receptive to feedback and open to dialogue with the public," co-author Niels G. Mede, from the University of Zurich, said.

"Our 68-country survey challenges the idea that there is a widespread lack of public trust in scientists. In most countries, scientists and scientific methods are trusted," the authors wrote.

The study provides global, representative survey data on the populations and regions in which researchers are perceived to be most trustworthy, the extent to which they should engage with the public, and whether science is prioritising important research issues, the team said.



## **DC Finalizes Arrangements** For Meraj-Un-Nabi (PBUH)

The meeting was attended by Additional Deputy Commissioners. RTO, Kashmir, Superintenit will encourage citizens to dents of Police, Traffic, Security, Joint Commissioner SMC, Superintending Engineer R&B, PDD, dents also expressed their SDM East, Chief Medical Officer, besides senior Officers of Information, Fire & Emergency, PHE, JKRTC, and other line Departreckless driving and disregard ments, besides Executive Magistrate of J&K Wakf Board and Management members of Hazratbal

Shrine and Jenab Sahib Soura. At the outset, the Deputy Commissioner sought a detailed action plan from concerned Departments regarding the arrangements being put in place during auspicious days of Meraj-un-Nabi (PBUH) with regard to electricity, water supply, sanitation, cleanliness, fire service, transport, parking and medical facilities etc.

The DC directed the Officers of all line Departments to ensure special arrangements for smooth observance of the religious occasion at the Shrine for the Devotees particularly during the intervening night(Shab) 26-27th Rajab 1446 Hijri, which falls on intervening night of 27-28 January 2025 and on Friday Following that falls on January 31, 2025.

To ensure adequate availability of transport facility, the RTO was asked to make better transport arrangements particularly during night and wee hours for the devotees during the auspicious days of Meraj-un-Nabi(PBUH) and make availability of e-Rickshaws from parking slots to Shrine for old age and physically challenged people.


With regard to power supply, the DC asked the PDD Engineers to ensure uninterrupted power supply at the Shrine during the auspicious days of night prayers as well as on the day of display of Holy Relic and keep proper power backup to tackle any power breakdown.

In this regard the DC was informed that in addition 400 KVA Genset and 20 KVA UPS has been kept as backup to provide power supply during any failure so that devotees do not face any difficulty.

Similarly, the DC directed the PHE authorities to ensure adequate water supply at the Shrine so that devotees do not face any inconvenience. He instructed them to keep a sufficient number of water tankers at the premises to cater to the demand.

Likewise, the DC asked the SMC Officers to deploy sufficient men and machinery at the venue to ensure proper cleanliness in and around the Shrine. They were also asked to take measures for establishment of mobile toilets besides a concrete mechanism to contain stray dog menace in and around the Shrine.

**Court Halts Suspension Of Two** Hospitals, Orders Fresh Inquiry

Srinagar: The Jammu Kashmir and Ladakh High Court has stayed the suspension of Shifa Medical Centre and Florence Hospital under the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB PM-JAY). The suspensions, issued by the State Health Agency (SHA) on January 11, 2025, were challenged on grounds of procedural lapses and denial of natural justice. Justice Muhammad Yousuf Wani as per the news agency Kashmir News Trust ordered the suspen-

sion to be kept in abeyance until the next hearing on February 7, 2025. The court directed the

SHA to conduct a fresh inqui-



ry, providing the hospitals with two weeks to respond to the show-cause notices dated December 18, 2024. The hospitals had been accused of coercing patients into paying extra charges and violating scheme guidelines. While the SHA defended its actions citing complaints and inspections, the court high-

lighted procedural irregularities and emphasized the need for fairness in disci plinary actions. [KNT]

### Cease-Fire Extended By Another Month

EW DELHI - Despite reservations from within, government today extended the cease-fire in Jammu and Kashmir by a month beyond republic day to give peace every chance and asked Pakistan to curb.and control militant activities of organisations like Lashkar-e-Taiba and Jaish-e-Muhammad.

"The present ceasefire is being extended (for restoring peace in the state) by another month," External Affairs Minister Jaswant Singh told reporters outside Prime Minister Atal Bihari Vajpayee's 7 Race Course Road residence.

The Cabinet Committee on Security headed by the prime minister discussed the situation in Jammu & Kashmir for three hours before deciding to extend the truce.

'Yes, the CCS felt that despite the continuing violence .unleashed by the militant groups, especially by Jaish-e-Muhammed and Lashkar-e-Taiba, the government must extend the ceasefire by another month," Singh said

But the government is still debating the issue of clearing the proposed travel plans of the All-Parties Hurriyat Conference delegation which wants to go to Pakistan for talks with militant commanders based there.

Government believes violence must be ended and peace, which has been welcomed by the people of Jammu and Kashmir, given every chance

The CCS took the decision of cease-fire extension notwithstanding views of sections within the government opposing extension. The entire security scenario in Jammu and Kashmir, particularly acts of cross-border 'terrorism and militant acts against civilians', was reviewed at the CCS meeting.

The CCS meeting was attended by home minister L.K.Advani, Jaswant Singh, defence minister George Fernandes, finance minister Yashwant Sinha, deputy chairman of planning commission K.C.Pant, national security advisor Brajesh Mishra, army chief Gen. S.Padmanabhan besides other top officials.

Singh said Vajpayee's peace initiative on Ramazan eve was taken despite heinous acts of terrorism and violence against innocent people. Asked about the possibility of Indo-Pak talks on the Kashmir issue,

he said India has always been in favour of a dialogue and will remain so. A congenial atmosphere has to be created and the onus for that

ties on Pakistan. Dialogue on one hand and gun-talk on the other does not work, he said.

The ground situation in Jammu and Kashmir as well us on the border and the Line of Control (LoC was reviewed in its entirety, Singh said, adding that chief minister Farooq Abdullah was Informed and consulted in the matter.

They said the main aim of Vajpayee government's announcement of extending the cease-fire by a month\* beyond January 26 was to meet people's desire for peace in Jammu and Kashmir. Tell the international community that India sincerely wanted to end violence and also address Pakistan for a positive response.

We have been able to convince the people in the state that we sincerely want to give a chance to peace, they said adding that the international community has appreciated New Delhi's gesture across the board.

## Listen To People On **Mega Projects**

he proposed acquisition of 4.834 kanals of fertile horticultural land in Pulwama for a National Institute of Technology (NIT) campus is being resisted by local people. For them, this land, where almonds are cultivated, is a major contributor to their agricultural economy. Residents, who have cultivated the land for generations, argue that the project's scale far exceeds necessity. Their plea is simple: build, but not at the expense of their livelihoods.

Similarly, the ambitious Ring Road project encircling Srinagar, with its proposal for 30 satellite colonies, has sparked widespread unease. Critics, including former Chief Minister Mehbooba Mufti, have pointed out that such ventures violate landuse policies and threaten prime agricultural terrain. The Kashmir Valley, already grappling with limited arable land, cannot afford to lose its fertile heartland to urban sprawl disguised as progress.

Another contentious initiative is the Bijbehara-Pahalgam railway line, cutting through apple orchards that sustain thousands of families. With apple farming employing over 3.5 million people and contributing 10 percent to the Valley's GDP, this isn't just about land but the very backbone of Kashmir's rural economy. So for people, this isn't an abstract policy debate, it's about survival.

The government insists these projects will bring economic upliftment, better connectivity, and educational opportunities. While that may be true, the question remains: at what cost? Development that affects the livelihood of the very people it claims to benefit is not development, it is disruption.

There is no denying the need for infrastructure. Education, connectivity, and housing are essential for progress. However, projects must be undertaken with a nuanced approach. This means minimizing land acquisition, exploring alternative locations, and engaging with local communities to ensure their voices are heard.

Already, the past decade has witnessed a worrisome trend in the Valley's farm sector: While the rice yield per hectare of paddy land is increasing, the paddy land itself has been diminishing at an alarming rate. According to official figures, over the past seven years, Kashmir has lost 6,000 hectares of paddy land, reducing the total land under paddy cultivation from 1,35,000 hectares to 1,29,000 hectares. One reason for this is the indiscriminate construction on the paddy land right across the Valley that successive governments have failed to stop.

So, as the government pushes forward on the mega projects, it must take on board not just the grievances of the people but also their wider environmental implications. In a place as fragile as

## **Decoding the Reservation Conundrum**

arge-scale public discussions are currently being witnessed in public forums on the most contentious issue of reservation in J&K. There is no denying the reality that extending the contours of reservation to the justified sections of society has visibly raised their living standards. However, the deep-rooted discrimination and alienation the unreserved category youth are currently experiencing have compelled them to vent their resentment against the disproportionate quota for reserved category candidates in government jobs and in admissions to premier institutions.

The issue of reservation is compounded even more in a place like Jammu and Kashmir, where people majorly rely on government jobs as the private sector is still in its nascent stage, besides being highly unorganized. The youth, therefore, have pinned their hopes on the government sector. The issue, and a justified one, is the limited carrying capacity of the government sector to accommodate the selected few who emerge victorious from cut-throat competition in a highly level playing field. This is even aggravating the core issue of unemployment as the Union Territory of Jammu and Kashmir is leading the chart with one of the highest unemployment rates in the country.

### **Controversial Incorporations in Reservation Rules 2005**

The Parliament, in February 2024, approved reservations for the Pahari ethnic tribe, Padari tribe. Kolis, and Gadda Brahmins during the budget session. Later, the UT administration of Jammu and Kashmir, in March 2024, approved the proposal of the Social Welfare Department to amend the Jammu and Kashmir Reservation Rules, 2005, in light of:

- The Jammu and Kashmir Reserva-1. tion (Amendment) Act, 2023, dated 15.12.2023.
- The Constitution (Jammu and Kashmir) Scheduled Castes Order (Amendment) Act, 2024.
- The Constitution (Jammu and Kash-3. mir) Scheduled Tribes Order (Amendment) Act, 2024.
- Recommendations of the Jammu and Kashmir Socially and Educationally Backward Commission.

Four new tribes—the Pahari ethnic group, Padari tribe, Kolis, and Gadda Brahminswere included in the Scheduled Tribes, and

The pool open for the general category has been reduced to 40%, which has statistically shrunk to 30%, as the 40% seats for the unreserved category include 10% horizontal reservation (6% for ex-servicemen and 4% for physically handicapped persons, which are to be absorbed from the unreserved quota).

### **Realistic Issues Emerging out of** Reservation Policy

The increased proportion in reserved categories is violating the provisions of the Jammu and Kashmir Reservation Act, 2004, which categorically underlines that the percentage of reservation shall in no case exceed 50%. This provision has drawn its essence from a 1992 nine-bench judgment of the Honorable Supreme Court, which, in its verdict, accepted a 50% cap on caste-based reservations. But over the years, this ceiling has been continuously eroded by various states and UTs across the country.

Providing reservation to socio-economically disadvantaged strata of society is integral to addressing the uneven developmental pattern of the country so that the marginalized sections of society are in a position to break the vicious cycle of poverty, educate their children, and stand shoulder-to-shoulder with other citizens to cherish the actu-

society. We need to take a pause and ponder: have the seeds of reservation truly reached the people who were really deserving? Who actually benefited? If the marginalized sections of society have harvested the fruits of reservation, are there visible indicators showing that they truly have prospered? Are they at par with the people from the upper strata of society in terms of living standards, dignity, employment, and education?

When the provisions of reservation were incorporated into the constitution, they were purely added as a temporary measure until developmental uniformity was realized and those living in abject poverty attained a degree of economic prosperity. It has been 77 years since independence, and the temporary provision of reservation has attained a degree of permanency and has become an inevitable tool in the political landscape, shaping regional and national political dimensions.

### Way Forward

The implementation of a just reservation model must revolve around the following core principles:

The main criterion for reservation must be the economic status of the family, irrespective of tribe, caste, region, etc. When the reservation policy revolves around economic status, people residing in mountainous regions or semi-urban or urban pockets,

## **Before Handcuffs, Hear Their Cries**

Kashmir is currently being overshadowed by a mental health crisis of alarming proportions. The rising rates of suicides, substance abuse, unemployment, and associated societal issues reflect a silent epidemic, gnawing at the very foundation of its youth. This crisis demands urgent intervention from every stakeholder, particularly the Jammu and Kashmir (J&K) Police and the administration, who must collaborate with mental health professionals to tackle this growing concern effectively. The problem is not merely one of law enforcement but of deepseated mental health issues that need an empathetic and structured approach.

### A Surge in Suicides: A Grim Reality

Kashmir has witnessed an exponential increase in suicides over the past two decades, and the numbers paint a grim picture. Between 1999 and 2019, the suicide rate rose significantly, according to recent reports. As per the National Crime Records Bureau (NCRB)'s report, published in December 2023, Jammu and Kashmir had the

highest number of reported cases of attempted suicide in 2022. Of the 1,769 cases recorded by the Bureau across India in 2022, 497 were reported from the UT alone. These are merely the reported cases; countless others go unreported due to societal stigma, fear of judgment, or lack of awareness.

The J&K Police often step in only after a tragic suicide attempt or death is reported, but by then, the damage is irreversible. Families are left grieving, while potential warning signs that could have been addressed earlier remain overlooked. Unfortunately, these reported cases are just the tip of the iceberg. Beneath the surface lies a massive population grappling with severe mental health strugglesundiagnosed, untreated, and unseen.

### The Menace of Substance Abuse: A Growing Epidemic

Adding to this crisis is the alarming rise in substance abuse across Kashmir. As per the Drug De-Addiction Centre reports from the police, over 70,000 people in Kashmir, including children as young as 10, are addicted to some form of substance. The primary substance of abuse has shifted from cannabis and alcohol to opioids like heroin. Official data shared by the ministry of social justice and empowerment in parliament, as per new reports from 29 March 2023, said that over 1 million in a population of over 14 million in Jammu and Kashmir were involved in substance abuse (one out of 14 people in the union territory)

The J&K Police frequently bust drug trafficking networks, seize large quantities of narcotics, and arrest those involved. However, their efforts address only the supply chain; the root cause of addiction remains largely unaddressed. The administration needs to recognize that drug abuse is not merely a criminal issue but a severe mental health problem requiring early intervention and professional support.

abusers, often under the influence of drugs, resort to crimes ranging from theft to violence. This criminal behavior puts additional strain on law enforcement. ### Unemployment, Pornography, and Societal Pressures

Unemployment in Kashmir is another major contributor to this crisis, with rates hovering at over 20%, among the highest in the country. The lack of job opportunities, coupled with societal expectations, drives young individuals into despair. Late marriages, caste-based restrictions, and increasing choosiness in partner selection add further strain, particularly on men who struggle to find outlets for their

natural instincts and emotions. An overlooked yet significant issue in the region is pornography consumption. Reports suggest that Kashmir ranks among the highest in pornography viewership in India, despite its deeply rooted conservative culture. A study conducted in 2021 highlighted that internet penetration and social isolation during the pandemic only exacerbated trend. The this contradiction is stark: in a region steeped in Sufi values and religious teachings that prohibit such behavior, pornography becomes easily an accessible

for escape those grappling with loneliness. unemployment, and social restrictions.

A Call for **Integrated Mental Health Solutions** While the JK

Police and administration have made efforts to address these issues, the measures remain far from adequate. Mental health services in the region are grossly underdeveloped. With only a handful of psychiatrists, psychologists, and counselors serving millions, the mental health infrastructure is incapable of meeting the growing demand.

This gap highlights the need for a comprehensive strategy to integrate mental health professionals into the existing healthcare and law enforcement systems. Primary health centers (PHCs) must employ trained mental health experts who can assess and address early warning signs. By equipping PHCs with such resources, the administration can ensure that individuals grappling with psychological issues receive timely intervention before their problems escalate.

Additionally, a record-keeping system, leveraging data from Anganwadi centers and local health workers, can help identify children and adolescents showing signs of developmental or behavioral issues. This proactive approach would allow for early referrals to specialists and prevent future crises.

> to Make a Difference As a passionstudent, recognized dire the need for action in this space. Along with a group of dedicated

professionals, including doctors, nurses, advocates, and students from arts and MBBS fields, I initiated a grassroots project to address mental health and substance abuse issues in Kashmir. ## If It Bleeds, It Leads

or decades, newsrooms ◄ have operated under the premise that 'if it bleeds it leads'. While grim, it is a clever approach: fMRI brains scans appear to confirm the neurological draw of bad news. When we view threats, for example, a greater and earlier blood oxygen level-dependent (BOLD) activation in the amygdala and periaqueductal gray can be observed. This could be considered a fight-or-flight response, as both are parts of the brain associated with rapid defensive action.

### **Negativity Bias**

This negativity bias is reflected in a recent study of 105,000 headlines (with more than 370 million impressions), which found that for every positive word included in a headline of average length, the click through rate (CTR) decreased by 1%. Consistent with a negative bias hypothesis, each negative word increased the CTR by 2.3%. What's more, the word 'joy' lowered CTR's, while the word 'sadness', conversely, increased them.

#### If It Burns, It Earns

A similar slogan often cited in newsrooms is 'if it burns, it earns,' a recognition that imminent threats promote our survival instinct and can be consid-

ered a form of attentional bias. It is likely why negative, shocking Facebook and Meta posts are more liked and shared than positive-bias posts.

A 2018 study, for example, studied two populist rhetoric driven campaigns: the Donald Trump's 2016 US presidential campaign and the UK Brexit referendum from the same year. Researchers reported that both campaigns heavily appealed to similar pain points-fear, for example, as well as lost national pride, overplayed immigration fears, baiting opposing voter groups, and racism, or the fear of other nationalities or ethnicities. These negative headlines powerfully drove exposure and engagement.

### The Effect of Neuroticism

Compellingly, out-group animosity (denigrating one's political opponents online) appears to be a stronger motivation to vote than in-group amity (friendliness). Thus, there appears to be political capital in encouraging online hate by one's supporters. Specifically, research shows that pain point dimensions of fear, lost pride, and loss aversion are all associated with the personality dimension of neuroticism. Neuroticism subsequently emerged as a reliable predictor of voting in the 2016 Brexit ref-

erendum and the 2016 US presi-

dential election, even when controlling for variables such as political attitude and regional industrial heritage.

#### **The Sleeper Effect**

Obshonka et. al. (2018) subsequently referred to a 'sleeper effect' of neuroticism as a meaningfully impactful force on the

election campaigns. Unfortunately, in stoking this kind of neurotic intent, bad news, fear, and hatred appear

American Psychological Association State of Our Nation Report 2017 identified, for example, that while 95% of Americans said they follow the news regularly, more than half also claimed that doing so caused them stress. Further, much of the news content we end up being exposed to appears unsolicited via our social media feeds (a phenomenon known as incidental exposure). Incidental exposure is designed to catch us off guard, jarring us with shocking, negative posts. It is particularly damaging to our mental health because it triggers us to instinctively fire off a reply. That can turn out great for a content creators' pay-per-click revenue, but it isn't so positive for our anxiety levels.

#### Playing on our emotions

Negative headlines seriously play on our emotions, which is why they push engagement so powerfully. A recent Stanford University study reported, for example, that emotional stories are around 22 times more memorable than facts alone. Combining negative headlines with emotionally triggering words and images subsequently offer a powerful means of gaining viral political exposure, maximizing the chances that a story will rise to the top of an editor's pile and become an outlet's next headline.

#### Minimize your exposure

Worryingly, research has shown that people can exhibit increased depression and anxiety symptoms after only 14 minutes of news consumption. It makes sense to avoid being part of that statistic.

### So what can we do?

Organizations like the APA offer easy but useful tips and interventions, such as allocating only specific times in the day (e.g. half hour over lunch) to check the news, and avoiding checking headlines before bed (to avoid disrupting sleep and mood). Selectively opting for regulated news sources is also a positive approach, as is avoiding social media (to avoid incidental exposure and outrage clickbait). Choosing positive news-only sites like the Good News Network can also offer a panacea to the constant doom and gloom.

Finally, turn off notifications from news sites, to avoid being caught off guard with a negative, adrenaline-spiking headline. You'll stay informed, you'll avoid news overload, and you might just increase the odds of finishing each day with a bigger smile on your face.

young people who are turning to e-rickshaws for employment. He views driving as both a necessity and a symbol of change."E-rickshaws have created employment opportunities for many youths like me," Salim said. "But in Kashmir, whenever something new is introduced, people criticize it, claiming it negatively affects other professions.'

Salim acknowledged that e-rickshaws have affected the income of sumo and petrol auto drivers. However, he believes they serve as a lifeline for unemployed youth. "There was a time when young people like us spent our days playing games or wandering aimlessly," he said. "Even after earning degrees, many of us were stuck at home, idle and disheartened. E-rickshaws gave us a chance to earn a livelihood and support our families."

Salim also faces financial pressures. As an e-rickshaw driver, he pays a portion of his earnings to his superior, leaving little for himself. "Every morning, I step out with the stress of earning enough to pay my boss and still save something for my family," he said. "And yet, when people treat us with contempt, it deeply hurts."

For Bilal Ahmad, another e-rickshaw driver from Mehjoor Nagar, societal stigma is only part of the issue. Unjust government policies have worsened the challenges faced by drivers like him. "The government recently fixed e-rickshaw fares, but the rates are so low that we can barely cover our expenses," he said. "We protested, but some auto drivers supported the decision. They know it's unfair, but they don't care."

Bilal highlighted the daily harassment e-rickshaw drivers face, from verbal abuse to physical violence. "There have been cases where drivers were beaten up just because people assumed they were drunk," he said. "Every day, we argue with auto or sumo drivers over passengers. No one thinks about how all this affects us."

Petrol Rickshaw Drivers Hit Hard

While e-rickshaws create opportunities for some, they pose challenges for traditional petrol rickshaw drivers. Hilal, a driver from Barbar Shah, stated that the competition has become overwhelming. "E-rickshaw drivers operate without fixed routes or proper permits," Hilal explained. "They don't pay passenger taxes like we do, yet they run freely in city areas. Meanwhile, we follow the rules, pay taxes, and struggle to make ends meet."

The financial burden of running a petrol rickshaw is immense. Hilal outlined the expenses: renewing documents annually costs Rs18,000, insurance is Rs12,000, and fuel expenses can reach Rs 11,000 a month. "After covering all these costs, we're left with almost nothing for our families," he said.

Nazir Ahmad, another petrol rickshaw driver, highlighted the unfair competition created by erickshaw fares. "The government set rates at Rs 2.50 per kilometer for e-rickshaws," he said. "It's too low for them to survive, but it also creates problems for us. How are we supposed to compete?'

The Struggle To Stay Afloat

For sumo drivers, the introduction of e-rickshaws and e-buses has been devastating. Sajad Ahmad, who has been driving a sumo for 18 years, said his income has been halved. "Before e-rickshaws and e-buses, we earned enough to run our families and maintain our vehicles," Sajad said. "Now, we're lucky if we can make one or two trips a day.'

At his stand, where 70 to 80 sumos wait for passengers, drivers often sit idle for days before getting a fare. "By 10 a.m. in the past, you wouldn't find any drivers sitting here," another sumo driver said. "Now, the stand is rarely empty."

Sajad and his colleagues bear significant expenses, from road taxes and fitness certificates to maintenance costs. "We don't want e-rickshaw drivers out of business-they have families to feed too," he said. "But the government needs to make policies so we can all coexist."

Bus Drivers Face Bleak Future, Demand Fair Policies

Bus drivers, who once dominated public transportation, are also struggling. Taufeeq Ahmad, a bus driver whose family has been in the profession for generations, described the cascading effects on the local economy. "With public buses, it's not just the driver and conductor who depend on this workmechanics, tea stall owners, and others rely on it too," he said. "But smart city buses and e-rickshaws have reduced our income. The revenue from smart citv buses doesn't even stay in the state; it goes to private companies. Zahid Ahmad, another bus driver, shared the harsh realities of his work. "A round trip from Soura to Lal Chowk costs Rs 500 in fuel, but we only earn Rs 600 a day," he said. "After supporting our families and maintaining our buses, there's nothing left." For many bus drivers, the future of the profession looks bleak. "No one wants to join this line of work anymore," Zahid said. "Some drivers have left to sell clothes on the streets. The government hasn't introduced any clear policies for transportation."

and frustration, threatening the livelihood he has sustained for decades.

Mohd Amin, said, "When the scrapping policy was first introduced, we were told it wouldn't apply to us. But now they're saying these buses will eventually be rejected for running on the roads." He added, "The scrapping policy is inefficient. Even if we were to take new buses under the scheme, the money would only reach our bank accounts after we're dead."

Amin's words reflect the sentiments of many bus drivers who feel left behind by policies that seem out of touch with ground realities, leaving them with little hope for a stable future in the profession. The Weight Of Stereotypes

One of the most pervasive stereotypes is that Kashmiri drivers are inherently "reckless and ag-gressive." This generalization, often fueled by isolated incidents and fueled by fear, ignores the complex realities faced by many drivers.

Studies say that these stereotypes can have significant real-world consequences. The fear of being profiled or targeted can create a constant sense of anxiety and insecurity.

"People often say things like, Drivers are a nuisance, or make other derogatory remarks," said Zahoor Ahmad, a truck driver from south Kashmir.

"People see us just as drivers, but we are more than that. We are fathers, sons, brothers. We work hard to support our families," he said, adding that people in general consider them not belonging to good families.

"It is just our means of livelihood. Like other professions, we deserve respect too," he said

As National Drivers' Day passes, drivers in Kashmir continue to navigate their challenging roads, not only transporting passengers but also shouldering the burdens of societal judgment and economic hardship. Their stories, much like their journeys, serve as a testament to resilience and hope for a better future.

### NDMA Issues

officer from the Jammu and Kashmir Disaster Management Authority (JKDMA) said, "This alert is generated through our portal and is scientifically validated. Based on its severity, we activate responders such as the fire and emergency services and the forest department."

He said the residents are urged to call 112 in case they spot a fire, and their teams will take immediate action to contain and manage the situation, stating that their top priority remains to save lives and protect properties.

The advisory stresses the importance of ensuring all fire-related materials, such as campfires or cooking stoves, are completely extinguished after use. People are also advised to avoid forested areas during this high-risk period.

The JKDMA official said that they have set up operation centers to handle any incidents, urging the public to stay vigilant and follow safety protocols to prevent environmental damage, loss of wildlife, or human casualties.

Notably, such alerts come in response to dry weather conditions, rising temperatures, and reduced humidity, which significantly increase the likelihood of forest fires in the region.

Similar warnings have been issued by the authorities in the past, where residents and visitors near forest areas were urged to exercise extreme caution and avoid activities that could trigger fires, such as lighting campfires or discarding cigarette butts.

As per the current advisory, NDMA has advised to stav calm if a sudden fire occurs and to avoid panic and follow emergency protocols.

The advisory strongly advises not to enter forest areas during such a high-risk period.

The NDMA, including JKDMA, has been highlighting the importance of vigilance during such critical periods to prevent any such incidents that could lead to environmental damage, loss of wildlife, or risk to human lives.

### **Sports Development**

Badhaal village in Rajouri district has been declared a containment zone as of Wednesday, with prohibitory orders in place for all public and private gatherings following the recent deaths, officials said.

Magistrate orders have sealed the homes of families where the deaths occurred as part of the primary containment zone. Entry into these homes, even by family members, is strictly prohibited without permission from officials on duty.

The secondary containment zone includes families that had close contact with the affected individuals, who are under constant health monitoring, they said.

The third zone encompasses all families in Baddal village, where arrangements for food and water are being made and communal dining has been prohibited

A total of 17 people, including 13 children from the families of Mohammad Fazal, Mohammad Aslam, and Mohammad Rafiq in Baddal village, have died due to a mysterious illness over the past month and a half.

According to officials, the condition of Ejaaz, who was airlifted to PGI Chandigarh on Tuesday night, is reported to be stable. Ejaaz is currently admitted to the emergency ICU at PGI Chandigarh, where initial investigations are underway. A definitive assessment of the illness awaits the receipt of test reports.

Three new patients airlifted to a hospital by the Indian Air Force (IAF) in Jammu are currently under observation, officials added.

A central team continues its investigation into the cause of the deaths in three families, with over 230 samples sent for testing to various institutes.

The Special Investigation Team (SIT), established by the police after neurotoxins were found in samples from the deceased, continues its probe into potential criminal aspects.

Officials indicated that more than 50 persons have been questioned in connection with the case.

Dr A S Bĥatia, Principal of Government Medical College Hospital Rajouri, revealed that the common factor among all 17 deaths is the involvement of the brain and damage to the nervous system.

### MLA Blames 'Dual

had sent the team here which took samples, but the samples are still here as they are being sent by vehicle which will take time," he said. "Air ambulance should have been here to take them to the respective institute for immediate analysis so as to ascertain the reasons for deaths but that isn't happening due to the dual power system.

He added, "I myself contacted Dr Jitendra Singh, LG, CM for air ambulance but failed. That is why people need to wake up and fight to end this dual power system."

MLA Javaid Iqbal Choudhary hit out at the Principal of Government Medical College Hospital Jammu, accusing the hospital management of mismanagement in handling patients.

"There is total mismanagement at the GMC hospital in Jammu. They failed to save the children. While one ill person shifted to PGI Chandigarh was stable but others shifted to GMC in Jammu are serious. We demand that all should be shifted to Chandigarh", he told reporters in Rajouri.

The MLA asserted that the hospital's handling of the situation has been inadequate, citing the lack of air ambulance services for patients despite repeated efforts.

Commending the efforts of the district administration, police, and health department of Rajouri, the MLA emphasized that higher authorities must address the situation more effectively.

Critically, Choudhary accused the Principal, GMC Jammu of causing unnecessary delays in referring the ill siblings to PGI Chandigarh, saying that personal conflicts and "ego clashes" are endangering lives. "If anything happens to these children, the Principal should be held accountable." he said.

The MLA said the situation warrants the declaration of a national emergency. "We must all work collaboratively-this is not the time for politics," he said, adding that playing partisan games could detract from essential public health responses. Principal, GMC Jammu, Dr Ashutosh Gupta said the hospital was informed at 6:30 pm on Wednesday about airlifting three children exhibiting symptoms of the mysterious illness from GMC Rajouri to GMC Jammu. "To facilitate their care, GMC Jammu contacted PGIMER Chandigarh to confirm bed availability. Despite repeated requests to the Director and HOD of PGIMER Chandigarh, the administration at PGIMER conveyed their inability to accept the patients due to a lack of available beds." he said. Dr Gupta said that, in response, GMC Jammu immediately dispatched critical care ambulances to the technical airport in Jammu for potential road transport to Chandigarh. However, considering the urgency of the children's condition, they were transferred to SMGS Hospital, Jammu, where senior pediatric consultants, including the HoD Pediatrics, received them, he said. "One child's condition deteriorated rapidly upon arrival, requiring immediate ventilator support and advanced ICU interventions. Timely and high-end interventions at SMGS Hospital prevented adverse outcomes that could have occurred during transit to Chandigarh," he added. Dr Gupta said the GMC Jammu medical team is in constant touch with their counterparts at PGIMER Chandigarh. Experts from ICMR and NCDC Delhi are also providing regular updates and guidance on patient management. He also acknowledged the efforts of MLA Budhal Javed Iqbal Choudhary for arranging midnight airlifting and for standing by the public of Bhudhal during this critical time. Dr Gupta praised the dedication of the GMC Jammu medical fraternity, including faculty, paramedics and administrative staff, who he said are working tirelessly to save lives. "We will leave no stone unturned to support the people of Bhudhal and ensure the best possible medical care during these extraordinary times," he said.(KNO)

Pertinently, days ago the People's Democratic Party leader, Iltija Mufti, had raised concerns over alleged discrepancies in the telecommunications and photographer exams conducted by the Jammu and Kashmir Services Selection Board (JKSSB), questioning the fairness and transparency of the results.

Department saying that the Merit list for the Photographer (CONSTABLE) post has raised serious concerns, as there are hardly any candidates who meet the stringent eligibility criteria.

"These requirements, including 10+2 with Science, a 6-month computer diploma, age below 28, height specifications, and two years of experience in Photography/Videography from a recognized organization, are exceptionally rare," said Rahil Hussain, an aspirant.

"How is it possible for someone without a journalism or relevant background to hold a valid photography certificate and be eligible for this position? It's troubling that so many ineligible candidates were able to appear for the exam without meeting the basic criteria." he added.

Pertinently, the successful candidates will proceed to physical evaluation rounds after the result was declared, however after marred by allegation of discrepancies the recruitment process has entered a hiccup.

Shortlisted candidates from the written examination will move on to the next stage of selection, which includes the Physical Standard Test (PST) and Physical Endurance Test (PET).

The written examination took place on December 1, 8, and 22, 2024, in an offline ÔMR-based format. The test assessed General Knowledge, Aptitude, and role-specific skills through 100 multiple-choice questions, with one mark awarded for correct answers and a penalty of 0.25 marks for incorrect responses. The recruitment aims to fill 4,002 constable vacancies in the Jammu and Kashmir Police.

The National Conference (NC) and the People's Democratic Party (PDP) have clashed over recruitment scams in Jammu and Kashmir, with leaders from both parties accusing each other of irregularities in recruitment examinations. Iltija Mufti, daughter of PDP chief Mehbooba Mufti, highlighted alleged discrepancies in the Jammu and Kashmir Services Selection Board (JKSSB) exams. She guestioned how candidates who failed in two previous recruitment exams managed to top the Jammu and Kashmir Police Constable examination while hard working candidates were left out. Iltija called for transparency and accountability from the JKSSB and the government.

Responding to these allegations, NC spokesperson Ifra Jan criticized the PDP for its alleged involvement in the J&K Bank recruitment scam, labeling it the largest in the region's history. She stated that the NC is answerable to the people of Jammu and Kashmir, not to the PDP. Ifra emphasized that the controversial exams were conducted under the Lieutenant Governor-led administration and suggested Iltija direct her questions toward the BJP and LG administration rather than targeting the NC.

Ifra further accused the PDP of consistently u dermining the NC and deflecting blame. She urged Iltija to show the courage to question the LG administration regarding the recruitment process instead of "sabotaging the elected government," Ifra also highlighted that the PDP's actions have hindered the collective fight for the restoration of Jammu and Kashmir's statehood.

The meeting was attended by Advisor to the Chief Minister Nasir Aslam Wani, Additional Chief Secretary to the Chief Minister Dheeraj Gupta, Principal Secretary Power Development Department (PDD) Rajesh H Prasad, Principal Secretary Finance Santosh D Vaidya, Managing Director JKSPDC Pankaj Magotra and other senior officials.

During the meeting, the Chief Minister emphasized the need for timely execution of these projects to ensure their public utility and stressed the importance of tackling challenges such as contractual issues,time and financial overruns in case of projects under construction and operation and maintenance issues of commissioned projects.

The roadmap for the next five years was presented showing substantial capacity addition to meet growing energy demands which would gradually reduce reliance on power imports, and boost the state's energy self-sufficiency. Upcoming projects, Detailed Project Report (DPR) formulation and appraisal were also discussed and JKSPDC was asked to focus on strategic project planning for development of hydropower assets on Chenab, Jhelum, Ravi and Indus rivers.

Highlighting the government's commitment to sustainable energy, Chief Minister Omar Abdullah urged officials to study revival plans for stalled projects and execute them efficiently.

He called for a proactive approach to address the challenges faced by JKSPDC and stressed that enhancing J&K's hydropower capacity is essential for meeting our energy demand.

"The timely execution of hydropower projects is essential to unlocking Jammu and Kashmir's potential as a power-surplus state. I urge all stakeholders to address challenges proactively and expedite ongoing works to serve the public interest," Chief Minister Omar Abdullah said. Earlier, Principal Secretary PDD provided a comprehensive update on the status of hydroelectric power development in Jammu and Kashmir.

Of the region's estimated 18,000 MW hydropower potential, 15,000 MW has already been identified, making it a key driver for future energy initiatives.

A detailed review of commissioned projects, including the Baglihar Hydroelectric Power Project (Stages I & II) on the Chenab River, Upper Sindh Hydroelectric Project (Stages I & II) on the Sind River, Lower Jhelum Hydroelectric Project in Baramulla was carried out during the meeting. The meeting also deliberated on projects under construction, including the New Ganderbal Hydroelectric Project (93 MW) on the Sind River, the Pakal Dul Hydroelectric Project (1,000 MW) under the Chenab River cascade, and the Ratle Hydroelectric Project (850 MW), which has been revived through a joint venture between NHPC and JKSPDC.

Discussions highlighted the importance of expediting work on these projects to ensure these become operational at the earliest.

Vehicle Scrappage Policy

The vehicle scrappage policy is a governmentfunded initiative introduced in 2021 aimed at removing old, unfit, and polluting vehicles from Indian roads. This policy encourages the adoption of modern, environmentally friendly vehicles to reduce the country's carbon footprint.

Under the car scrapping policy, vehicles are required to undergo a mandatory fitness test once they reach a specific age. For both private and commercial vehicles, this age is set at 15 years. The fitness test is crucial as it assesses whether a vehicle is still roadworthy or should be scrapped. These tests are conducted at automated centres and evaluate emission levels, safety standards, and the overall condition of the vehicle.

Vishesh Paul Mahajan, the Transport Commissioner of Jammu and Kashmir, stated that the transport subsidy scheme, which is part of a broader initiative to phase out vehicles older than 15 years, is receiving a positive response.

In a recent media briefing in Srinagar, Mahajan announced that buses, matadors, and minibuses are eligible to apply for a subsidy by scrapping their old vehicles and providing proof of the scrapping process. He stated, "We have advertised this initiative. The RTO has informed me that approximately 35 applications have been received so far." He encouraged more people to take part in the scheme.

### **Our Identity**

The land of Jammu and Kashmir, a region restive for decades, must be protected by its people at all costs, he said.

"When we talk about these matters - about the Constitution, special status, and the prosperity of Jammu and Kashmir – we are also talking about our identity. And our identity is tied to our land," Omar said while addressing a function in the Bari Brahmana area of Samba district.

"We want this land to remain ours. The land that Sheikh Abdullah, with a single signature, transferred to you without any compensation ... Without it, what do we truly possess?" he said.

"It must not be taken away from us, and this should remain our collective effort," he added.

Omar also paid his tributes to Dr B R Ambedkar for his contributions to the drafting of a Constitution that ensured equality between all.

"No matter how much is said about Ambedkar, it will always fall short. The foundation of any nation lies in its Constitution, and Ambedkar gave this nation its Constitution. He laid the foundation of this country, and wherever we stand today, it is because of him." he said.

Referring to the West, he said some of these countries exercised discrimination on the basis of one's skin colour, while India after Independence wrote away all such differences, even seeing men and women as equal.

"This is the kind of day we celebrate – a day where Ambedkar ensured from the very beginning that no matter your colour, caste, or background, there would be no difference between your vote and anyone else's. A vote is equal, free from discrimination, transcending caste or creed," he said.

All the same, Omar expressed concerns at the succeeding generations' failure in upholding the values of the Constitution. He said this failure has given rise to conflicts, predominantly to the detriment to the marginalised.

"Even today, if we look at the largest legislative houses in India, how many men are there, and how many women? The same can be observed in the Jammu and Kashmir Assembly – compare the number of men and women, and the difference is like that between the earth and the sky," he said.

The maximum temperature settled at 13.3 degree Celsius in Srinagar, the summer capital of Jammu and Kashmir, which was 6.2 degree Celsius above normal while the minimum temperature was also 0.3 degree above normal.

As per the details, Gulmarg recorded a day temperature of 3.0 degree Celsius against the normal of 0.1 degree while the night temperature settled at minus 7.5 degree Celsius against minus 8.4 degree Celsius normal.

### Why Students Prefer Pvt **Schools Over Govt Institutes?**

**SRINAGAR:** The government school in Jammu and Kashmir despite having 244 percent extra institutions in comparison to private schools, the Teacher School Ratio (TSR) in public schools is very low.

In only 5452 private schools, more than 12 Lakh students were enrolled in comparison to the 18,785 government schools wherein only over 14 Lakh students were enrolled-thus raising a question on claims of the authorities with regard to the influx in student enrolment in government-run-schools.

The official figures reveal that there are a total of 5452 private schools in Jammu and Kashmir wherein at least 70.234 teachers are posted to teach over 12.03.064 students. However, in a shocking rev-

### elation, the official figures reveal that there were a total of 14,21,643 students in 18,785 government schools wherein at least 96,380 teachers were posted.

According to the updat-ed official figures, the Pupil Teacher Ratio (PTR) in government schools as of now is 14:75 while the PTR in private schools remains 1:17.

The figures further reveal that the Teacher School Ratio (TSR) is 1:5 in government schools and 1:13 in private schools.

It also states that there are a total of 1.67.046 teachers in Jammu and Kashmir with at least 29,616teachers posted or deployed at Primary level, 61,045 at Upper Primary level,43,789 at Secondary level and 32.596 teachers were posted or deployed at Higher Secondary level—(KNO)

## **Amid Tourism Boom, Operators** Struggle In Kashmir

SRINAGAR: A group of tour and travel operators representing hoteliers, houseboat owners, and tour operators on Thursday urged the government to take decisive steps to address challenges faced by the tourism sector, highlighting the need for an advisor dedicated to the industry. Addressing the media in

Srinagar, Tour and Travel operators representing different associations, said that while tourism in Kashmir has witnessed growth, the lack of adequate promotion and a dedicated representative has affected businesses on the ground.

"The tourism economy is performing better compared to other trades, but in the last five years, particularly post-COVID, over 1 lakh people have entered this sector. Despite its promising potential,

efforts need to be doubled to address key issues," said, one of the representatives.

He said, PM Modi in Mann Ki Baat talked about Kashmir having witnessed a tourism boom but, "our people have also done promotions alike and in the last four years, this sector has faced a need for an individual advisor, with whom they can share queues and that can reach the government."

He said that high accommodation costs have deterred tourists, resulting in homestavs and hotels witnessing fewer bookings. "To push tourism forward, focused promotional campaigns are essential. We have repeatedly raised these concerns with higher authorities, and we hope the Chief Minister will create a dedicated advisor for tourism

operations," he added. Before five years, the capacity of hoteliers in J&K were about fifty thousand and this

time it is about more than a lack in only Kashmir valley and homestay of about fifteen thousand and this has given a good boost to the tourism sector, he said.

He further noted the need for a single executive advisor to address the issues faced by hoteliers, houseboat owners, and other stakeholders as accommodation has increased and there is a need to look after the tourism industry.

The group also requested the government to focus on reviving the houseboat industry, which has dwindled to just 750 houseboats, and to ensure the direct operation of trains to Kashmir to boost connectivity.

"Environmental concerns and other pressing issues must also be addressed. Having an advisor for the tourism sector would ensure our voices are heard and our problems resolved," they said. –(KNO)

### **Republic Day Celebrations: Shopian** Declared "No Drone Flying Zone"

SRINAGAR: In preparation for Republic Day celebrations, District Magistrate Shopian has designated the district as "No Drone Flying Zone" from January 24th to January 26th, 2025.

As per an order issued by District Majistrate Shopian a copy of which lies with Kashmir Observer reads, In light of the upcoming Republic Day celebrations on January 26th, 2025, and in the interest of ensuring the smooth, safe, and secure conduct of events and activities, it is hereby ordered that the entire area of Shopian district is designated as a "No Drone Flying Zone" with immediate effect, extending through and beyond the period of Republic Day observances.

Order further reads, this restriction is enacted to maintain public safety, protect sensitive infrastructure, and prevent any potential security threats posed by unauthorized unmanned aerial vehicles (UAVs). The prohibited airspace will remain in effect from January 24th to January 26th, 2025, in the entire District, Shopian.

All relevant law enforcement agencies, including local police, security forces are instructed to strictly enforce this order. Drones detected within the restricted airspace will be immediately intercepted, and violators will be subject to legal action as per applicable laws. Any drone activity within the designated no-fly zone, noticed by an individual, should be immediately reported to the District Administration/ Police Authorities, it reads.

This action is taken with a view to ensuring a secure, peaceful, and orderly Republic Day celebration for all citizens and participants, reads the order.

### Ranji Trophy: J&K Dominate **Mumbai On First Day**

Mumbai were all out for 120 runs in 33.2 overs. Umar Nazir Mir finished with 4 wickets for 43 runs, and Yudhvir Singh claimed 3 wickets for 31. J&K lost wickets at regular intervals, but Shubham Khajuria (53) and Abid Mushtaq (44) steadied the ship with crucial contributions. ### Ranji Trophy: Pant's Delhi **Crumble Against Jadeja's Spin**

Ravindra Jadeja's excellent all-round effort - five wickets and 38 runs - outshone Rishabh Pant's minuscule 10-ball 1 as Saurashtra gained good foothold over a shoddy Delhi after Day 1 of their Ranji Trophy Elite Group D match in Rajkot on Thursday.
