Uttarakhand Becomes First To Implement Uniform Civil Code

New Delhi: BJP-ruled Uttarakhand on Monday became the first state in independent India to implement the Uniform Civil Code, which promotes equal laws for every citizen across all religions and standardises personal laws on marriage, divorce and property.

With the implementation of the UCC which applies to all people of Uttarakhand except those belonging to the Scheduled Tribe community, the BJP has fulfilled a major commitment made to people of the state ahead of the 2022 assembly polls which saw the party storming to power for a second consecutive term.

Chief Minister Pushkar Dhami announced UCC's implementation at a programme at his official residence here, saying THAT with this the constitutional and civil rights of people across all religions have become uniform.

"With the implementation of UCC, the BJP has fulfilled all its major ideological commitments, including abrogation of Article 370 in Jammu and Kashmir, illegalisation of triple talaq, the CAA and building of a Ram temple in Ayodhya," the chief

He unveiled the notification on UCC, released its rules and regulations and launched a portal designed for the mandatory online registration of marriages, divorce and live-in relationships, in the presence of his ministerial colleagues and members of the UCC

The chief minister was the first to register his marriage on the UCC portal. Chief Secretary Radha Raturi handed over the certificate of his marriage registration to him. Chief Minister Dhami

Trump Might Defy Policy To Reach Nuclear Deal With Iran: Report

Washington: President Donald Trump has signaled an unexpected shift in the conventional US policy regarding Iran, revealing that the only issue his administration would face with the Islamic Republic is its development of a nuclear weapon.

Speaking on Fox News' Hannity show on January 23, Trump did not address Iran's regional policies, its defiance of the Israeli occupation, or the possibility of enforcing a regime change. Rather, his only focus was preventing Iran from acquiring nuclear weapons.

In this regard, a Responsible Statecraft report, written by Eldar Mamedov, recalled previous statements by Iranian officials, confirming that the nation does not seek nuclear weapons, adding that this could facilitate a political agreement between Washington and Tehran.

Tehran has also gestured its willingness to re-engage with the West, particularly following the election of Iranian President Masoud Pezeshkian and his government coming to power. However, despite the mutual political willingness, the path to a deal remains highly complex and is vastly different from 2015, when the JCPOA curtailed Iran's nucleIs a nuclear deal possible? Following Trump's 2018

ar program.

withdrawal from the JCPOA, his imposition of sanctions, and the EU's failure to abide by the terms of the deal, Iran significantly advanced its program, including enriching uranium to 60%—a step away from weapon-grade levels (90%)-and deploying advanced centrifuges. Nuclear expert Kelsey Davenport notes that Iran could now produce enough material for five to six nuclear bombs in just two weeks, according to Mamedov.

The situation is further complicated by the limited access the IAEA has had to Iran since 2021, heightening concerns about unmonitored nuclear material potentially being moved to covert sites, as well as shifts in Iran's nuclear rhetoric that suggest a potential rethinking of its doctrine.

While Tehran officially maintains it is not pursuing nuclear weapons, regional challenges could incentivize Iran to consider a nuclear deterrent, Mamedov explained.

Israeli Prime Minister Benjamin Netanyahu's threats of a direct attack, possibly with US support and cover, could possibly motivate Iran to contemplate threshold weaponization as a defensive measure.



festival of unity and integrity in the holy city of Prayagraj," he added.


According to the state government, over 53.29 lakh people had taken the holy bath at the Maha Kumbh on Monday by 10 am.

J&K Govt **Hikes DA Of Employees To 53%**

Srinagar: The Jammu and Kashmir Government on Monday announced a hike in the Dearness Allowance (DA) for all government employees working under the 7th Pay Commission.

This decision follows the Council of Ministers' approval on January 20.

According to an order issued by the Finance Department, a copy of which lies with Kashmir Observer, the Dearness Allowance will be revised to 53% of the basic pay, effective from July 1, 2024, up from the previous rate of 50%.

The revised DA will be applicable to employees working in regular pay levels under the 7th Pay Commission. The government also announced that employees will receive arrears for the additional DA installments from July to December 2024 in their February 2025 salary. From January 2025 onwards, the increased DA will be included in the monthly salary.

Furthermore, the government clarified that any fraction of 50 paisa or more in the DA calculation will be rounded up to the next higher rupee, while any fraction below 50 paisa will be disregarded.

joint parliamentary committee has voted in favour of 14 alterations to the draft version of the Waqf Amendment Bill, which had been tabled in the Lok Sabha in August last year and seeks to make 44 contentious changes to the way Muslim charitable properties are managed in the country.

The 14 alterations include distinguishing between the mandatory two non-Muslim members - as specified in the original draft of the bill - and nominated ex-officio members (Muslim or non-Muslim).

This means waqf councils, whether at state or pan-India levels, will have at least two, and possibly more (if the nominated exofficio members are also not Muslim) members not

from the Islamic faith. Another key change is directing an officer nominated by the concerned state to determine if a property is 'waqf'. In the original draft this decision was left

to the District Collector. A third change is establishing that the law will not apply retrospectively, so long as the property in question is already registered. To this point, Congress leader and JPC member Imran Masood raised a red flag, noting an estimated 90 per cent of waqf properties are not, in fact, registered.

s there any engagement taking place between the centre and Hurriyat as reported by Deccan Chronicle? It is quite possible that there is. With either side staying short of denying the news, it is safe to assume that there might be some contact. And if so, one can't but welcome the development, and hope it leads to some concrete outcome. Hurriyat-centre dialogue has had a chequered past. Although the two have interacted frequently in the past, nothing was ever achieved. This is because the expectation of both the parties from the talks have been a polar opposite of each other. Centre wants Hurriyat to join the national mainstream and play a role as a mainstream political party, but Hurriyat has long harboured a secessionist goal.

After the abrogation of Article 370, which granted J&K a special position under the constitution, the complexion of things on the ground has drastically altered in the union territory. New Delhi will no longer engage with either Pakistan or any local entity in J&K over what was earlier regarded as a Kashmir issue. It has also by and large successfully overcome the political and armed separatist campaign within the union territory. This has transformed the situation, and, in a sense, rendering not just India-Pakistan dialogue redundant but the Centre-Hurriyat engagement too. More so, the latter. Only discussion that appears to have been left to do between the two is if and when Hurriyat joins the mainstream.

However, it is also not that Hurriyat is completely extinct. The organization's underlying idea, if not the organization itself, could still be a challenge for the centre to deal with. And it could be for this reason that the centre will certainly seek to engage with it. If this is sought to be done, it is a worthwhile cause. For decades, Kashmir has been mired in violence, political unrest, and a sense of alienation among its people, so a reported dialogue between the Centre and Hurriyat offers hope that the cycle of confrontation and mistrust can finally be broken.

The timing of this alleged dialogue is also crucial. The political landscape in Jammu and Kashmir has changed beyond recognition over the past five years with the last year's assembly election creating an opportunity for a fresh start. By engaging with the Hurrivat, the Centre can address the sense of disenchantment among sections of the Kashmiri population and work towards rebuilding trust.



Ending Modern-Day Untouchability Need Of Addressing Employer Bias Against Non-NLU Students

ndia's legal education landscape has transformed substantially over the past few decades, primarily with the establishment of National Law Universities (NLUs). Regarded as the gold standard, NLUs are elite institutions that admit students based on the highly competitive Common Law Admission Test (CLAT). Only a fraction of applicants secure admission, creating an aura of exclusivity around NLU graduates. Yet, this perception often leads to biases against students from other law schools, categorizing them as less competent despite their potential. The reality is far more complex, as many talented students outside of NLUs face socio-economic barriers or narrowly miss the CLAT cut-off, while still possessing the skills to excel in the legal profession.

In February 2023, Chief Justice of India (CJI) DY Chandrachud addressed the convocation at NALSAR University, urging NLU students to respect their peers from other law schools. He emphasized the need for humility, cautioning against a sense of superiority based solely on institutional affiliation. Justice Chandrachud also acknowledged the challenges NLUs face in making legal education accessible to diverse socioeconomic backgrounds, a gap that reinforces inequity in the legal field.

In July 2024, the Supreme Court again highlighted these challenges in Gaurav Kumar v. Union of India, where CJI Chandrachud and Justice JB Pardiwala acknowledged the barriers non-NLU graduates face. The judgment underscored that students from marginalized communities or those lacking an NLU degree often encounter discrimination in elite law firms, senior lawyer chambers, and other prestigious roles, all of which are critical for establishing a career in law. The judgment reaffirmed the need to dismantle institutional biases and called for a more inclusive approach to legal hiring.

The "Modern-Day Untouchability" in Law

In India's legal job market, non-NLU students are often sidelined, treated almost as "untouchables" by many recruiters who gravitate towards the NLU brand. Despite having comparable skills, determination, and legal acumen, these students find doors closed to prestigious law firms, judicial clerkships, and corporate roles simply because they don't hold an NLU tag. This bias, deeply rooted in institutional elitism, overlooks individual talent and reinforces an unfair hierarchy NLUs account for approximately 3,000 seats annually across India, while the country's broader network of law schools produces over 80,000 graduates each year, with non-NLU students making up the overwhelming majority. Yet, the "NLU-only" mindset fosters an elitism that permeates legal hiring, often translating into biased recruitment practices favoring pedigree over talent. For example, In 2014 graduates from a single National Law School held 26% of partnership positions in India's top six corporate law firms, despite abundant talent from other law schools.

lower fees, allowing students from diverse financial backgrounds to pursue a legal education. However, many employers equate higher fees and exclusivity with competence, an assumption that overlooks the immense talent in non-NLU schools.

The Disparity in Employment Opportunities

In the competitive field of law, where networks and mentorship play crucial roles, NLU graduates often have an advantage, enjoying campus recruitment from prestigious firms and clerking opportunities that set them up for successful careers.

In 2024, a social media post ignited with discussions after KIA India, a major motor vehicle manufacturer, posted a job opening for a Legal Specialist, initially specifying a preference for applicants from National Law Universities (NLUs) only. The announcement sparked criticism online, with commenters expressing disappointment over the bias against candidates from non-NLUs and the broader preference many employers show for law graduates with an NLU background.

A few years ago, a Delhi University graduate filed a petition in the Patna High Court challenging a recruitment post by Bihar Mining Corporation Limited, which restricted eligibility for law officer positions to graduates from Chanakya National Law University (CNLU), Patna. In response, the court issued a notice to the State in March 2022. Similarly, in June 2022, the Kerala High Court invalidated a notification by the National Thermal Power Corporation Limited (NTPC) that limited applications for an Assistant Law Officer role to candidates who had passed the CLAT 2021 postgraduate exam. Declaring the restriction discriminatory, Justice VG Arun remarked, "There is no logical basis for the assumption that professionalism and competence is the fiefdom of only those passing from elite institutions.' These are not the only case where the preference in job applicants was given to students from National Law Universities. This has become a routine in Indian job market. This disparity is largely due to the longstanding bias in the legal community that considers NLU graduates inherently superior, while overlooking the competence, dedication, and unique insights of non-NLU graduates. This bias extends beyond recruitment, affecting career growth, salary potential, and professional respect. Many law firms and corporate legal departments often reserve entry-level positions and internships for NLU graduates, creating a cycle where non-NLU students face fewer opportunities, which impacts their professional trajectories. Moreover, top-tier firms rarely visit non-NLU campuses for recruitment, further restricting access for those graduates. Such discrimination perpetuates an elitist view that limits the potential for innovation and diversity within India's legal profession.

surpassed their NLU counterparts across various legal fields, proving that skill and commitment are not restricted by institutional tags.

Numerous non-NLU graduates have topped the Judicial Services Examinations in multiple states, securing distinguished roles in the judiciary. In states like J&K, Uttar Pradesh and Madhya Pradesh, a significant portion of high-ranking judicial officers are non-NLU alumni. These graduates have shown outstanding dedication to the legal field and earned positions of influence in the judiciary, dispelling the myth that only NLU graduates can reach the top. Their success highlights that high achievement in competitive exams and subsequent legal careers depends on individual hard work and capability, not just the institutional name on a degree.

Non-NLU students have often excelled in moot court competitions on both national and international stages. For example, teams from institutions like Symbiosis Law School, Pune, and ILS Law College, Pune, have advanced to final rounds in renowned competitions like the Philip C. Jessup International Moot Court Competition. This prestigious event draws participants from the world's top law schools, and these successes reflect that legal acumen, critical thinking, and research skills can be nurtured in diverse academic environments. In addition to excelling in moots, many non-NLU graduates have secured prestigious scholarships and fellowships for advanced legal studies abroad, including the Rhodes Chevening and Fulbright scholarships. These accolades are globally recognized, awarded based on merit and leadership potential, and show that non-NLU students have a place in international legal academia and beyond. This demonstrates that non-NLU students can match their NLU counterparts in scholarly achievements and intellectual pursuits, reinforcing their value on a global stage. Non-NLU graduates are also making significant strides in top law firms and corporate legal roles. Some of the top-performing associates and partners in Indian law firms come from non-NLU backgrounds, breaking the stereotype that corporate legal success is reserved for NLU graduates. Law firms are beginning to recognize the unique qualities that non-NLU graduates bring to their roles, including resilience, diverse perspectives, and adaptability honed through rigorous and often challenging paths to success. The notion that NLUs represent the only "elite" legal minds in India is outdated and does a disservice to the legal profession by excluding highly capable individuals from diverse institutions. Recognizing and respecting the accomplishments of non-NLU graduates is essential to building a more inclusive and competitive legal landscape in India. Addressing Financial Inequities

The government can also intervene by increasing funding to NLUs, allowing these institutions to lower fees without compromising quality, thereby opening doors to talented students from diverse backgrounds.

Data from the National Law Universities Consortium (NLUC), which includes 22 NLUs across India, reveals that in 2020, only 14% of admitted students came from Scheduled Castes (SCs), Scheduled Tribes (STs), and Other Backward Classes (OBCs).

Many students don't attend NLUs not because they're incompetent but because they can't afford the exorbitant costs of education. The high fees, often reaching several lakhs, make it impossible for talented students from less privileged backgrounds to access these institutions. Its economic barriers, not a lack of ability, that hold them back, leaving many bright minds out of the NLU system simply due to financial constraints.

The Role of Employers: Embracing Diversity in Legal Hiring

The responsibility to dismantle these biases also lies with employers, who must make hiring practices more inclusive. Rather than focusing solely on institutional affiliation, employers should prioritize competency, critical thinking, and real-world skills. Research supports that diversity in educational backgrounds brings fresh perspectives to law firms, enabling them to better address complex legal issues and represent varied client interests effectively.

Law firms and legal departments can further contribute to an inclusive hiring process by participating in recruitment drives at non-NLU campuses. Offering internship programs specifically for non-NLU students can provide them with essential training and networking opportunities. Such initiatives can help level the playing field and ensure that the legal profession does not miss out on exceptional talent.

Achieving equality in legal education and employment requires structural changes. Collaborative programs between NLUs and non-NLUs, including shared courses, faculty exchanges, and academic partnerships, can help standardize legal education across institutions. Such collaborations would raise the overall quality of legal training, benefiting the profession at large and reducing institutional bias. standardized Furthermore, accreditation measures can help bridge the perceived gap in quality between NLUs and non-NLUs. By setting clear standards for legal education across all law schools, students from different institutions can receive comparable training, ensuring that the quality of graduates is uniformly high, regardless of the institution.

Non-NLU students often face institutional discrimination, facing rejection from top firms and judges' chambers solely due to their alma mater. This pervasive "brand bias" not only reduces diversity within the profession but also limits the range of perspectives that can enrich legal practice.

Access to NLUs is heavily reliant on the CLAT, an entrance examination that has been criticized for creating structural barriers. In 2024, around 60295 students competed for just 3,243 seats, giving NLUs an acceptance rate around 5%. Students from economically marginalized backgrounds are disproportionately disadvantaged, as they often lack the resources to access specialized coaching that many affluent students rely on to prepare for CLAT. Consequently, highly capable students are sidelined-not due to a lack of ability, but due to systemic inequities that hinder access

The average NLU tuition fee exceeds 10-15 lakh for a five-year program, a staggering amount for most Indian families, especially when considering that the annual per capita income in India is around 1.5 lakh. In comparison, non-NLU institutions offer significantly

Breaking the Stereotype

In India, non-NLU students have repeatedly demonstrated that talent, dedication, and success in the legal profession are not exclusive to NLU graduates. Though NLUs often carry a prestigious reputation, many students from non-NLUs have excelled and sometimes even

The exorbitant fees at NLUs exclude economically disadvantaged

students, creating an elitist system that fails to reflect India's socio-economic diversity. In response, both government and private entities need to increase the availability of scholarships and fee waivers specifically for economically marginalized students. Presently, while NLUs offer some scholarships, they are often insufficient to meet the high demand.

The deep-rooted bias against non-NLU graduates has far-reaching implications, not only limiting individual career prospects but also hindering the growth of India's legal profession. By excluding talented individuals based on institutional pedigree, the legal sector risks becoming insular and homogenous, missing out on diverse perspectives that are essential for a dynamic profession.

A more equitable legal landscape requires collective action from students, educational institutions, employers, and the government. Breaking free from the "modern-day untouchability" of institutional elitism means moving toward a future where all law students, regardless of their alma mater, have equal opportunities to contribute meaningfully to India's legal ecosystem. The legal profession, founded on principles of justice and fairness, must rise to the occasion by dismantling institutional biases, embracing diversity, and championing inclusivity.

Through sustained efforts, it is possible to create a legal community that values hard work, commitment, and skill over the brand name of an institution—ensuring that every aspiring lawyer has the chance to fulfil their potential and impact society positively

Procrastination, An Enemy of Results

Beating procrastination requires self-regulation, self-control, and strong determination

Imagine this:

"Have you finished the assignment that needs to be submitted by Monday?" asked Mudasir's mother, who is a 10th-grade student. Actually, his mother had noticed him scrolling through his phone on Sunday. He hesitated for a moment but had the courage to reply, "Not yet, I will do it after dinner. I have more than enough time to complete it." As he sat down with his books after dinner, Mudasir got distracted by a series on YouTube, which cost him two hours of precious study time. His mother again noticed him wasting time and asked, "What is wrong with you? Why aren't you working on your homework assignment?'

"Relax, Ammi Ji, I will definitely finish it before bedtime," Mudasir said confidently. He was exhausted by the time bedtime arrived and postponed his decision to do the assignment until the next morning. The next morning, he could hardly make preparations to get ready for school with the assignment still undone, regretting and saying to himself, "Dude, why did you procrastinate and not start working on the assignment earlier?"

This is not the case with Mudasir only; we all procrastinate from time to time. We put off decisions, skip reading books, tell ourselves to wait until tomorrow, or don't complete tasks because we don't feel like it.

PROCRASTINATION HAS A PRICE

Everybody wrestles with procrastination in one way or another. It is like trying to pull ourselves out of a deep hole once we get caught in it. Pondering the costs of procrastination is a difficult task, as it makes us feel worse when we are already



down, grappling with its worst effects. A study published in the American Psychological Society journal discusses the cost of procrastination. It is linked to depression, low self-esteem, irrational beliefs, anxiety, stress, robbing of precious time, and more. Stress, for example, is a result of delaying a task until it becomes unbearable. The task you have been putting off doesn't disappear; instead, it appears more frightening as the deadline approaches. This type of stress is not just uncomfortable; it affects our judgment, makes us exhausted, and even makes us fear starting. Consequently, our results are prone to imperfection and flaws. As a result of procrastination, we suffer more mentally than the task itself. Low self-esteem is born each time we delay a task.

This is because when we put off a task until later, we are telling ourselves, "We can't do this task right now." Over time, this feeling becomes internalized, and we start to believe that we are incapable of performing tasks promptly and efficiently. What happens is the shame of unfinished tasks sneaks into negative self-talk, damaging our self-esteem and making it even harder to break out of this cycle once we get caught in it. The study presents enough

evidence that procrastinators enjoy themselves, go out, and have a great time, experiencing no stress at all rather than working on assigned tasks—until the rising pressure of imminent deadlines forces them to get to work. From this perspective, procrastination may occur due to a lack of self-regulation, and the motivation required to work depends on externally imposed forces.

BEATING PROCRASTINATION

Self-regulation, willpower, and strong determination are all essential when it comes to beating the cycle of procrastination. Everyone may agree with this, but there is one more thing worth discussing here: the comfort zone. We all fear, for some unknown reason, stepping outside of our comfort zones. It takes courage to make bold moves and finish tasks within the stipulated time frame. Remember, procrastination has nothing to do with the task at hand-whether it is big or small; it always waits until later. In fact, the word "later" is what feeds it. When we start working on a task, we are excited

and focused, but then, after some time, we think: "Let's have a look at the latest score in a cricket match." Then, we think: "Let's watch one episode of a series on YouTube," and then another one. And so forth. Initially, we might have thought of just one thing, but it opens up a whole bunch of distractions that drag us further and further from where we started. Then, when we realize this thought derailment, we say to ourselves: "This is the last time we are wasting our time!"

RULES TO GET OUR WORK DONE

What we really need is a system for getting work done. It is not always courage that works; what matters most is a system of organized people working collectively and efficiently. This kills procrastination. To get things done on time, research has proven effective methods such as self-imposed deadlines, working/studying in intervals, exercising for 30 minutes a day, maintaining a healthy diet, eliminating distractions, and most importantly, having internal motivation. The methods outlined above combine the right tactics that are productive in creating an efficient system. But there is no system that can help us beat procrastination if we do not have an inner drive. Researchers even compare procrastination to alcohol or drug abuse. Breaking its cycle today and not tomorrow is recognizing its true costs. It is the right time to start.

How Artificial Intelligence Can be Weaponized for Harassment

A rtificial Intelligence (AI) tools – especially those that generate images, videos, and audio – have been marketed as "creativity apps" for individuals and "efficiency tools" for businesses, but there are few ways to control how they're actually used and the harms that these artificially created visuals can cause.

It may come as no surprise that AI tools are making the problem of online harassment even worse, such as through the creation and sharing of non-consensual intimate imagery (NCII) — these are intimate photos or videos, including nudity or sexually suggestive or explicit images exposing someone's real or AIgenerated body, shared without their permission.

NCII affects many people – not just the celebrities you might hear about in the media – and it's not easy to deal with. Even platforms and law enforcement are struggling to keep up.

THE PROBLEM IS BIGGER THAN YOU MIGHT THINK

The technology is advancing so quickly that now it only takes one image of someone (and it could even be a totally wholesome picture) to be able to create sexually explicit content using one of many Alpowered tools.

While certain AI tools supercharge the problem of harassment, making it easy to create NCII of anyone, other AI tools are being used to tackle it. However, AI-powered tools that are trained to detect AI images are not perfect, and much of the work to identify and take them down still falls on the people working as content moderators.

ly explicit AI-generated deepfake images of Taylor Swift. These images first appeared on 4chan and, within minutes, spread like wildfire across various social media sites. One of the images was seen over 47 million times before it was removed. It's possible that these images are still being shared online since there is no real way to completely wipe them off the internet.

But this is not an isolated case. According to a 2021 study, 41 percent of over 10,000 survey respondents in the US said that they had personally experienced a form of online harassment. Of the respondents under 35 years old, 33 percent of women and 11 percent of men said they had specifically experienced sexual harassment online. On a similar note, a 2023

analysis of over 95,000 deepfake videos found that up to 98 percent of them were deepfake pornography, and, of those, 99 percent of the individuals targeted were women. Other vulnerable groups, such as minors and LGBTQ+ people, are also disproportionately victims of online sexual harassment.

WHAT STEPS CAN YOU TAKE TO PROTECT YOURSELF FROM THIS KIND OF HA-RASSMENT?

There are some guardrails in place by online platforms to support you in locking down your information from unwanted eyes. While these tips won't build you an impenetrable fortress, they can make it harder for bullies or those trying to do harm to get to you. Every platform is different

and has settings and options accessible to users. As an example, here are a few things you can do to tighten controls on your Instagram and TikTok:

Set your profile to "private." On platforms like Instagram and TikTok, you can set your profile to private so that only people who you approve as followers can see what you share in most cases. However, they can still see comments you make on other people's posts and can even still send you messages. Learn to set your profile to private on Instagram and TikTok.

Remove followers or block people. If someone is giving you a hard time or making you feel uneasy, you can remove them as a follower or block them altogether. But if you know the person in real life, you'll need a different strategy. Learn how to block people on Instagram and TikTok.

IT TAKES A VILLAGE

Looking at how many people are getting targeted by online harassment, it seems logical to assume there are a lot of harassers, too. But the fact is, it only takes one bad actor to do widespread harm. Would you consider someone who reshares NCII a harasser, even if they didn't originally generate the images? In the example of Taylor Swift, it took only a few people to create the NCII of her, but it wouldn't have gone viral without many people sharing it. So, how can you be an ally to someone who is being targeted and harassed? No matter which social media platform

you use, it likely will have a "report" function. On apps like Instagram, you can report specific posts or entire profiles or accounts if you spot anything that looks like abuse or harassment. Reporting on Instagram is a great option to flag problematic people or things you see or hear. Instagram won't share the identity of the person reporting with the person being reported.

When you "report" on Instagram, the platform may remove the post or may warn, deactivate, or ban the profile or account, depending on what happened and whether it goes against their Community Guidelines. Worth noting is that Meta's Community Guidelines are not always helpful, and post takedowns and account bans have caused recent controversies.

If you personally know the person who is being targeted, gently reach out to them if you feel comfortable doing so. It might be that they had no idea this was happening and could react with strong distress, anger, or sadness. If you feel prepared to support them, you can offer them resources (like those linked at the end of this guide) and help them monitor and document the harassment. Even though you most likely will not want to look at the harassment again, it might be helpful to document it before it's taken down. Consider taking

a video capture or screenshot

of the post or comment that

includes the account name of

the other person and the date.

Save the documentation some-

where safe and out of sight on your phone or computer. For example, on some phones you can set up a password-protected "secure folder."

Documentation, when done well, can be useful in case the person being targeted decides to bring the issue to law enforcement and needs some sort of evidence.

It's important that the person being targeted decides what they want to do. Do they want to contact law enforcement, get a lawyer, or reach out to their school, university, or workplace? Or would they rather keep it confidential as much as they can? Especially in a situation of NCII, so much choice is being taken away from them, so make sure to support them in getting back in control.

KNOW WHERE TO GO FOR HELP

If you or someone you know is targeted with NCII, know that there are dedicated organizations out there who are ready to help. You don't have to deal with it alone. Here are just a few supporting English-speakers:

- Chayn (worldwide): Chayn provides resources and support to survivors of gender-based violence.
- StopNCII (worldwide): StopNCII has a bank of resources as well as a tool that can help you get non-consensual intimate images taken down.
- Take Back the Tech (worldwide): Take Back the Tech offers explainers and resources like Hey Friend, with tips on how you can support your friends when they are targets of harassment.

Chinese AI startup DeepSeek overtakes ChatGPT on Apple App Store

Beijing- Chinese startup Deep-Seek's artificial intelligence (AI) Assistant on Monday overtook rival ChatGPT to become the top-rated free application available on Apple's App Store in the United States.

Powered by the DeepSeek-V3 model, which its creators say "tops the leaderboard among open-source models and rivals the most advanced closed-source models globally", the artificial intelligence application has surged in popularity among US users since it was released on January 10, according to app data research firm Sensor Tower.

The milestone highlights how DeepSeek has left a deep impression on Silicon Valley, upending widely held views about US primacy in AI and the effectiveness of Washington's export controls targeting China's advanced chip and AI capabilities.

AI models from ChatGPT to DeepSeek require advanced chips to power their training. The Biden administration has since 2021 widened the scope of bans designed to stop these

chips from being exported to China and used to train Chinese firms' AI models.

However, DeepSeek researchers wrote in a paper last month that the DeepSeek-V3 used Nvidia's H800 chips for training, spending less than \$6 million.

Although this detail has since been disputed, the claim that the chips used were less powerful than the most advanced Nvidia products Wash ington has sought to keep out of China, as well as the relatively cheap training costs, has prompted US tech executives to question the effectiveness of tech export controls.

Little is known about the company behind DeepSeek, a small Hangzhou-based startup founded in 2023, when search engine giant Baidu released the first Chinese AI large-language model. Since then, dozens of Chi-

nese tech companies large and small have released their own AI models, but DeepSeek is the first to be praised by the US tech industry as matching or even surpassing the performance of cutting-edge US models.

Govt May Consider Giving Agri Subsidies Via DBT: Chouhan

New Delhi- The government is trying to bring policy-level changes for simplifying agriculture, Union Minister Shivraj Singh Chouhan on Monday said and indicated that providing subsidies on fertiliser, seed and farming equipment through direct benefit transfer could be considered in the future

In an interaction with farmers, who were invited to witness the Republic Day parade as special guests, at his residence here on Monday, the Agriculture and Rural Development Minister said the government spends up to Rs 2,00,000 crore on fertiliser subsidies.

'The fertiliser subsidy that the government gives costs to the tune of Rs 2,00,000 crore. A sack of urea costs Rs 265 to the farmers, but it costs Rs 2,400. The subsidy goes to the company. The fertilizer is also used for other purposes... If there is a reliable system, farmers can be given the subsidy directly in their accounts," Chouhan said.

Nidhi's cost comes to around Rs 60,000 crore, if the fertilizer subsidy is given through DBT, the bank balance will increase further." he said.

Similarly, he said, the government will explore if direct benefit transfer can be applied for other subsidies related to agriculture as well, like for drip irrigation, polyhouse or tractors.

The minister also said that the government is considering bearing the transportation cost for agricultural produce so as to enable farmers to sell their products across the country.

"We are making efforts to simplify agriculture for farmers. Soybean rates went down, so we imposed a 20 per cent duty on import of (soybean) oil... We removed the restriction from export of Basmati rice..." he said.

"Agricultural produce is cheap, but it becomes expensive by the time it reaches cities. We are contemplating how to reduce this difference for the consumer, like if the Centre and states can share the transport expense," he said.

Investors Lose Rs 9.28 Lakh Crore As Stock Markets Fall For 2nd Day

New Delhi- Stock investors took a severe hit on Monday as key indices slumped to more than seven-month lows due to widespread selling amid increased uncertainty over US trade policy, wiping out Rs 9.28 lakh crore of market wealth.

The market capitalisation of BSE-listed companies tanked Rs 9,20,654.51 crore to Rs 4,10,31,199.48 or USD 4.75 trillion. The market breadth was negative as 3,588 shares declined, 532 advanced and 114 stocks remain unchanged

The 30-share BSE barom eter plunged by 824.29 points or 1.08 per cent to close at 75,366.17, a level not seen since June 2024. During the day, the barometer plummeted 922.87 points or 1.2 per cent to a low of 75,267.59.

"Dalal Street continues to

bleed, extending its losses from Friday last week, as the wind of slowing corporate earnings swayed away hopes of earnings revival and bolstered pessimism about tepid earnings.

"Volatility geared up during the day, driven by a mix of factors such as heightened anticipation around the fiscal budget, concerns about slowing corporate earnings, and uncertainties surrounding the upcoming Federal Open Market Committee (FOMC) meeting," Ameya Ranadive Chartered Market Technician, CFTe, Sr Technical Analvst, StoxBox, said.

Geopolitical tensions and continued selling by foreign institutional investors (FII) further hit the sentiment. Mid and small-cap continue to face the brunt of heightened volatility as richer valuations trigger sell-off across the segment, Ranadive said.



Posts Vacant At GMC Rajouri

Amid Health Crisis, 60% Of

SRINAGAR: Amid the ongoing health crisis in the Badhal area of Rajouri district, the Government Medical College (GMC) Rajouri is grappling with a severe staff shortage, with around 60% of sanctioned posts currently vacant.

Official sources revealed that nearly 62percent of the sanctioned positions at GMC Rajouri remain unfilled, which affects the institution's functioning.

"Out of 23 sanctioned posts for professors, only one professor is currently available," an official said, adding that the hospital is also facing acute shortages of doctors and paramedics, leaving key departments understaffed and overburdened.

The hospital lacks critical diagnostic and treatment facilities, including an MRI machine and a Cath Lab, forcing patients from Rajouri and neighbouring Poonch district to travel to Jammu for advanced medical care.

Residents of Rajouri and Poonch have expressed concern over the inadequate healthcare facilities and have urged the government to address the shortages in staff and infrastructure at GMC Rajouri.

MLA Budhal, Javed Iqbal Choudhary said the hospital is in a dire state. "The hospital is

severely short-staffed and is functioning without many essential diagnostic facilities," he

said. Principal GMC Rajouri has formally requested the Health and Medical Education Department to establish an MRI facility at the hospital.

In a letter to the Health Secretary, the Principal stated: "In continuation of Office No. GMCR/2022-23/9754-59 dated 21.11.2022 and in reference to the request submitted by the In-charge Head of the Department, Radio Diagnosis & Imaging, GMC Rajouri, it is forwarded with a request to kindly

direct the concerned authorities for the establishment of an MRI facility at the Associated Hospital of GMC Rajouri."

In light of the mysterious illness that claimed 17 lives in Badhal village, authorities recently deployed 10 paediatricians and anesthesiologists to GMC Rajouri. All leaves for doctors and paramedics have been cancelled under a medical alert issued by the administration.

The residents of Rajouri have appealed to the government to prioritise the hospital's needs. They said the absence of proper medical facilities in this frontier district is causing undue suffering. Local treatment options should be improved to minimise patient reliance on distant healthcare facilities, they added-(KNO)

Police Arrests 7 Drug Peddlers; Contraband Substances Recovered

SRINAGAR: Continuing its efforts to eradicate the menace of drugs from the society, Police have arrested 7 drug peddlers in Kulgam, Baramulla, Anantnag & Awantipora and recovered contraband substances from their possession. Besides, police detained a notorious drug peddler under PIT-NDPS Act in Kupwara.

In Kulgam, a police team of Police Station Kulgam at a checkpoint established at Chawalgam, Kulgam intercepted a suspicious person. During the search, 2 kgs of poppy strawlike contraband substance was recovered from his possession. He has been identified as Mashoog Ahmad Hilla son of Abdul Rashid Hilla resident of Vesbatpota, Kulgam.

In Baramulla, a police team of Police Post Old Town Baramulla headed by Incharge Police Post Old Town Baramulla at a checkpoint established at Janbazpora Baramulla, intercepted a suspicious person. During the search, 288 banned capsules were recovered from his possession. He has been identified as Aijaz Ahmad Sofi son of Ghulam Hassan resident of Chakloo.

In Anantnag, a police team

of Police Station Srigufwara at a checkpoint established on the Sirhama link road intercepted a suspicious individual carrying a bag. Meanwhile, Police in Kupwara detained a notorious drug peddler namely Mohd Shafi Sheikh son of Gh. Hassan Sheikh resident of Sheikhpora, Trehgam, under the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act (PIT-NDPS), 1988. The accused was involved in multiple cases of drug trafficking, including FIR No. 12/2021 under Section 8/20 NDPS Act and FIR No. 23/2023 under section 8/20 NDPS Act of Po-

lice Station Trehgam. The detention warrant was issued by the Divisional Commissioner, Kashmir and accordingly the accused has been taken into custody and lodged in District Jail Udhampur. The detention is aimed at preventing his further involvement in illicit drug trafficking and ensuring a safer society.

ICC Awards: Jasprit Bumrah Named Test Cricketer Of The Year

DUBAI: Pace spearhead Jasprit Bumrah was chosen for the men's Test Cricketer of the Year, while big-hitting batter Smriti Mandhana bagged the women's honour in the ODI format as Indian cricketers dominated the ICC individual awards that were rolled out on Monday.

ICC announced three more awardees from its annual list this afternoon, continuing a process that started on Friday. The final two honours -- the men's and women's Cricketer of the Year -- will be revealed on Tuesday and Bumrah is in contention to bag a double after having been named in the Test Team of the Year.

Bumrah was a standout performer in the last 12 months in which he dominated all opposition teams, grabbing 71 wickets from a mere 13 matches at a brilliant average of 14.92.

Bumrah bowled a phenom-



enal 357 overs in Test cricket in the cycle, maintaining a strikerate of just 30.1.

Bumrah, who was instrumental in India's home series victories over England and Bangladesh, was the fourth Indian

bowler to take 70 or more wickets in a calendar year after Kapil Dev, Anil Kumble and R Ashwin.

"I am really happy to win the ICC Men's Test Cricketer of the Year award. This format is always close to my heart. The last

year was really special, to be having a lot of learning and wins. "I am happy to play a lot of

cricket this year, and a lot of wickets have been special. But the wicket of Ollie Pope (England) at Visakhapatnam was really special because that shifted the momentum in our favour," Bumrah was guoted as saying in an ICC release.

The 31-year-old's brightest moments came during India's tour to Australia, where his astonishing 32 wickets across five Tests earned him the Player of the Series award, despite India going 1-3 down in the Border-Gavaskar Trophy.

During the series Down Under, Bumrah crossed the 200 Test wickets milestone, becoming the 12th Indian bowler to achieve the feat.

Bumrah also set a unique record while achieving the feat, becoming the only bowler in Test history with a minimum of 200 dismissals to have an average less than 20 (19.4).

He is the first male Indian cricketer to bag an individual ICC honour since 2018, when Virat Kohli claimed the Test player of the year as well as the cricketer of the year.

Teams In Danger Heading Into Pivotal Week In Champions League

MANCHESTER: The Champions League's new look league phase reaches its conclusion on Wednesday with big names like Manchester City and Paris Saint-Germain in danger of early elimination.

Holder Real Madrid is fighting to avoid a playoff and so is six-time winner Bayern Munich.

With so much jeopardy going into the final round of games before the knockout stages, UEFA's revamp of European club soccer's elite competition looks to have delivered.

The group stage was scrapped and replaced by a 36-team league phase. The revamp saw each team play oneoff games against eight different opponents based on a seeded draw.

The top eight teams automatically advance to the round of 16. Teams placed ninth to 24th go into a playoff and those below are eliminated.

How will the final round of games work?

Traditionally the group stage finale was split over two days, but all 36 teams will play at the same time on Wednesday. Kickoff is 9 p.m. CET (2000 GMT). Only leader Liverpool and second-



place Barcelona are guaranteed a place in the last 16. Record 15-time winner Real Madrid is one of 16 teams are vying to be one of the other six teams to automatically qualify for the round of 16 and avoid a playoff.

What are the big stories to look out for?

Manchester City, the winner in 2023 and four-time defending Premier League champion, needs to win against Brugge just to secure a place in the playoffs. Anything less and it

will be eliminated.

PSG beat City last week to move into the playoff spots, but a loss to Stuttgart could still see it go out.

Madrid eased concerns about a potential early exit with a 5-1 win against Salzburg last week. The defending champion may yet have to settle for a playoff and the possibility of an uncomfortable draw, given so many big teams are currently positioned in places 9-24.

Those include Bayern, Juventus,

PSG and last year's beaten finalist Borussia Dortmund. City will be hoping to join that list as well.

Who tops the league?

Liverpool is in first place with a 100% winning record from its first seven games and has already booked its place in the round of 16 along with second-place Barcelona.

Liverpool needs a point against PSV Eindhoven to win the league phase. Barcelona is three points behind and could yet take top spot with a win against Atalanta if Liverpool loses.

to atropine injections—a standard antidote for organophosphate poisoning.

A senior doctor explained, "Atropine was initially administered to two patients for heart rate management, and they showed significant improvement. This led us to consider organophosphorus poisoning as a likely cause."

However, the doctor cautioned against premature conclusions, as official reports from top laboratories are still awaited.

Organophosphorus poisoning is caused by exposure to organophosphates, a class of chemicals commonly used in pesticides, herbicides, and nerve agents. Exposure can occur via ingestion, inhalation, or skin contact.

Common symptoms include excessive saliva and tears, vomiting and diarrhoea, small pupils, sweating, muscle tremors and confusion.

The Forensic Science Laboratory (FSL) report from Chandigarh, which could provide critical insights, is expected within 2–3 days.

Dr Shuja Qadri, an epidemiologist and Head of Community Medicine at GMC Rajouri, stated that active and passive surveillance of cases has ruled out communicable diseases, bacteria, viruses, and zoonotic causes. "Our investigation has narrowed down to food-related toxins, either ingested accidentally or deliberately," he said.

Samples have been sent to toxicology labs for screening against 200 potential toxins. Dr. Qadri expressed optimism that the investigation will identify the toxin within a week, enabling authorities to prevent further deaths.

Over the last two months, 17 people, including 14 children, succumbed to the mysterious illness, with several others requiring hospitalisation.

Authorities are maintaining strict surveillance in the affected village, and all efforts are focused on identifying the cause to ensure no further loss of life. Minister for Health and Medical Education, Sakina Itoo expressed confidence in the investigating team. She assured that all possible efforts are being made to identify the cause behind the mysterious deaths in Rajouri.

"The team is working diligently to gather more information and laboratory results, which will provide critical insights into the situation," she said.

With the situation seeming to normalise, the minister appealed to the public to remain vigilant and cooperate fully with the authorities. Pertinently, Jammu and Kashmir is presently witnessing the prolonged dry spell with the first three weeks of this month recording the deficit rainfall of 81 percent from January 01 to January 22. In addition, the opposition members said they highlighted a few "wilful and wanton disregards" by the chairman in sharing the details of deliberations.

During the proceedings, 95 per cent of the stakeholders deposed against the Bill and the remaining 5 per cent appeared before the committee under the communal entity or umbrella, according to the joint statement.

They also claimed that minutes of the sittings held in Delhi and other places were not supplied to the members and members were stopped from placing their views on the amendments.

"No discussion on clause by clause was permitted by the chairman, which is the essential element in the process," they claimed.


They also said that after the joint committee's tour of Patna, Kolkata and Lucknow to hear the views of stakeholders of the respective states and, having heard them, the chairman directed those stakeholders to submit their views within 15 days.

"These documents are yet to reach the committee for perusal of the members. Meanwhile, another sitting of the committee was convened on (January) 24 and 25 with the agenda for clause-by-clause consideration. Suddenly, on the midnight of (January) 23, for reasons best known to the chairman, the agenda was changed as stakeholders for Jammu and Kashmir for their views and 25th sitting was cancelled without assigning any reason," according to the statement.

"This issue was raised by us in the meeting held on (January) 24 for which we were suspended undemocratically," the opposition members added.

"Knowing fully well, out of our earlier experiences that the subsequent meeting might be called in short notice by the chairman", the opposition members said they had orally demanded on January 24 and subsequently in writing that depositions or documents of the stakeholders who appeared before the committee on tour had to be placed before the panel for perusal "so that we can ascertain our participation effectively and legally".


