Dark Nights Ahead As Kashmir's Hydel Power Generation Falls by 76 %

Srinagar: Owing to the low water level, the Power Development Department (PDD) is currently able to produce only 24 Megawatts (MWs) of electricity against the total capacity of around 250 MWs from the power plants in Kashmir region.

Quoting an unnamed senior official of the Power Development Corporation (JKSPDC) Kashmir News Observer reported that "From Kashmir power plants, we have a power generation capacity of around 250 MW out of which currently, we are



producing only around 60 MW power.

'In view of low water availability, we are able to produce only 40 MW of power from lower Jhelum in the night hours and 5 MW during the other hours and 15 MW at Kangan," the official said.

The official further said that from the power plants in Kangan, water was available for only one machine which has a power producing capacity of 150 MW. As of now we are able to produce only around 15 MW

of power from Kangan." "As of now we are reserving during the peak hours. This is the routine power generation but in upcoming month, we are expecting increase in power generation," he said.

The official further said, "We are in the middle of lean season and this year it started earlier in comparison to previous years."

There is a total power generation capacity of around 1200 MW from the power projects of Jammu and Kashmir and 2250 MW from NHPC.

The easy accessibility of online betting platforms has lured many, particularly youth, with the illusion of quick financial gains. However, this often results in heavy monetary losses, debt and psychological suffering.

According to details, a youth from south Kashmir initially won Rs 10,000 in online betting



within a few days. Encouraged by this, he borrowed lakhs of rupees from neighbours and relatives, promising to repay them double within days. However, when he invested lakhs into the game, he lost everything and went missing for several days. His family had to step in and clear his massive debts to bring him back home. Another young gambler

shared his ordeal, narrating how he initially won Rs 10 lakh. which fueled his addiction. However, as he continued playing, he not only lost his winnings but also an additional Rs 5 lakh. "I understood too late that

even if one wins in gambling, they ultimately lose. It has ruined me and my family. I suffered massive business losses due to online | More on P6


Very Few Regions Possess Youth Power Like J&K: LG

Muscle Fat Can Increase Risk Of Heart Disease, Regardless Of BMI: Study

at stored in muscles can damage blood vessels and increase risk of hospitalisation or death due to heart disease, regardless of body mass index, according to a new study. Researchers, led by those at Brigham and Women's Hospital, US, found that every one per cent increase in muscle fat was associated with an increase of two per cent in risk of coronary microvascular dysfunction -- when small blood vessels of heart malfunction -- and that of seven per cent for serious heart disease, irrespective of

known risk factors. The findings, published in the European Heart Journal, added evidence that existing measures, such as body mass index or waist circumference, are not adequate to evaluate the risk of heart disease accurately for all people.

"Obesity is now one of the biggest global threats to cardiovascular health, yet body mass index -- our main metric for defining obesity and thresholds for intervention -- remains a controversial and flawed marker of cardiovascular prognosis. This is especially true in women, where high body mass index may reflect more 'benign' types of fat," lead researcher Viviany Taqueti, a director at Brigham and Women's Hospital,

She explained that compared to subcutane-

ous fat (stored beneath the skin), fat stored in muscles can contribute to inflammation and altered glucose metabolism, potentially leading to insulin resistance and metabolic syndrome.

These "chronic insults" can then damage blood vessels, including those supplying the heart, the researcher said. "Intermuscular fat (hidden inside muscles) can be found in most muscles in the body,

but the amount of fat can vary widely between different people," Taqueti said. However, it is not yet known how the risk of heart disease could be lowered in people having fatty muscles, she said.

For the study, nearly 670 people with no evidence of obstructive coronary artery disease were examined. They were being evaluated at the hospital for chest pain and shortness of breath. Most were women, and about half of the study group were non-white.

The researchers calculated fat stored in muscles through the ratio of intermuscular fat to total muscle plus fat, and termed it 'fatty muscle fraction'.

Positron emission tomography (PET) and CT scans were taken to assess each individual's body composition, measuring the amounts and location of fat and muscle in a section of torso, and see how well their heart was functioning. The patients were followed up for about six years.

"Increased intermuscular fat is associated with (coronary microvascular dysfunction) and adverse cardiovascular outcomes independently of BMI and conventional risk factors." the authors wrote.

"What we don't know yet is how we can lower the risk for people with fatty muscles. For example, we don't know how treatments such as new weight-loss therapies affect fat in the muscles relative to fat elsewhere in the body, lean tissue, and

'Diabetes Drugs Lower Heart Disease Risk, Raise Gastro, Arthritic Disorders'

lommonly used diabetes drugs could lower the risk of cardiometabolic conditions but heighten the risk of gastrointestinal and arthritic ones, hypotension, among others, according to a study. Researchers from Washington University in St. Louis analysed data from the US Department of Veterans Affairs to examine links between taking 'GLP-

1RA' drugs and 175 health outcomes. Data from 2.4 million participants with diabetes were analysed. GLP-1RA, or glucagon-like peptide 1 receptor agonists, are drugs that work by mimicking the action of the hormone GLP-1 that helps control blood sugar and promote feelings of satiety. Through weight management, the

drugs can also treat type 2 diabetes. While the GLP1-RA class of drugs have become popular for weight loss, their effectiveness is also being evaluated for a wider range of conditions, including Alzheimer's disease, osteoarthritis and sleep apnea, the research-

However, previous studies nave reported adverse effects of these drugs, such as thoughts of committing suicide and gastrointestinal complications.

In this study, published in the journal Nature Medicine, about half of the 2.4 million participants continued the use of non-GLP-1RA drugs, such as sulfonylureas and SGLT2 inhibitors, while the rest were initiated with GLP-1RA.



However, previous studies have reported adverse effects of these drugs, such as thoughts of committing suicide and gastrointestinal complications.

The authors found the anti-obesity drugs to be associated with a decreased risk for 42 health outcomes

"Compared to usual care, GLP-1RA use was associated with a reduced risk of substance use and psychotic disorders, seizures, neurocognitive disorders (including Alzheimer's disease and dementia), coagulation disorders, cardiometabolic disorders, infectious illnesses and several respiratory conditions," the authors wrote.

"There was an increased risk of gastrointestinal disorders, hypotension, syncope (low blood pressure), arthrittial nephritis and drug-induced pancreatitis associated with GLP-1RA use compared to usual care," they wrote. The findings could help describe the broad health effects of GLP-1RAs, the authors said but added that further research is needed to confirm results in other cohorts, including more di-



Digital Addiction

Can We Afford a Generation of Brain-Rotten Idiots?

"Jear the day that technology will surpass our human interactions. The world will have a generation of idiots."

Albert Einstein

Well, here we are — a generation of idiots amusing ourselves to death, oblivious to what may possibly be the last great pandemic known to humankind. We are unaware of the fact that handing over digital devices/screens to kids and adolescents will irreparably damage their brains in their formative years. It is akin to connecting your home power circuit to an ultrahigh-voltage power line. The current condition of our brain is not much different from what would remain of the home circuit. Our 1.7 millionyear-old mind is simply not equipped to handle the endless stream of digital information and algorithms that we are being exposed to. The result is isolation and impaired relationships, reduced attention spans, insomnia, stress, reduced cognition, creativity blocks, sadness, anxiety, depression, suicide, and much more. It is the fastest and most pervasive addiction known to humanity.

Smartphones and the allied digital lures are engineered and designed to be addictive, and this addiction kills all creativity, meaning, and purpose from the lives of its users, turning them into digital junkies. Neuroscientists have termed the dopamine deficit state as 'learned helplessness'.

We recently organized an event under the 'Common Interest Conversations' program at Amar Singh Club, Srinagar, presided over by Prof. S.A. Romshoo, Vice Chancellor, Islamic University of Science & Technology, and chaired by eminent senior advocate Mr. Zaffer A. Shah. The conversation left me scared and anxious as I woke up from my high-octane, digital-stimuli-infused slumber. I am slowly coming to terms with the disastrous power I allowed technology to have over me and the costs in terms of lost time and relationships. Expert views shared by me in this article are mostly attributable to Dr. Anna Lembke, a renowned American psychiatrist, a world-leading expert on addiction, Medical Director of Addiction Medicine at Stanford University, and author of three important books on the subject, including the New York Times bestselling book Dopamine Nation. Inputs have also been taken from Netflix documentaries The Social Dilemma (nominated for seven Emmys) and Buy Now: The Shopping Conspiracy. I strongly recommend watching them, as well as Fabeha Syed's Urdunama episode on "Brain Rot" to gain a deeper understanding of the scale of this addiction.

Incidentally, the Oxford Word of the Year for 2024 is 'Brain Rot', which describes the negative effects of consuming too much online content, es-

pecially low-quality or unchallenging material. In Urdu, it can be translated as 'Zehani Zawaal'.

The digital world today provides endless opportunities for education, research, and enrichment of the mind, which responsible users are effectively utilizing to their advantage and to the world's benefit. However, they are in the minority, as this virtual world appears to have been taken over by vested commercial interests that make more money from increased online time. We need to draw a clear distinction between healthy usage and problematic usage, which results in impaired minds and disrupted lives. I am reminded of the words of Urdu poet Vikas Sharma Raz: "Mayreh Urooj Ki Likhi Thi Dastaan Jisme, Meray Zavaal Ka Kissa Bhi Uss Kitab Main Tha". Those connected with the online business are today the richest human beings in the history of humankind. Billions and trillions of dollars are being made without a thought for the costs and consequences to humankind and the planet. Fifteen out of the top twenty in the latest Forbes Billionaires List are connected to this business. This has given rise to many unfair practices and manipulations, as they remain focused on sales and profits alone. Surveillance Capitalism and Planned Obsolescence are cornerstones of the new business methodology. The product is you and your onscreen attention span.

A joint study by the Shanghai Institute of Early Childhood Education and the Faculty of Education and Human Development, Education University of Hong Kong, concludes as follows

"...digital addiction in children and adolescents leads to structural brain changes, including reduced grey and white matter volume in various regions involved in executive function, reward processing, and sensorimotor activities, impacting cognitive capabilities and contributing to problematic smartphone use, internet gaming disorder, and internet addiction."

Studies have established the negative impact of digital addiction on children and adolescents from multiple aspects — physical, emotional, cognitive, and brain structure and function. For example, vision and hearing, social skills, social relationships, aggressive behavior, high frequency of depression and anxiety, reduced attention span, memory, and problem-solving skills. The smartphone has been termed the modernday hypodermic needle to which we turn for quick digital hits, seeking attention, validation, and distraction with each swipe, like, and tweet. The obsession with instant gratification means we are constantly living in our limbic brain, which processes emotions, rather than in our prefrontal cortex, which deals with future planning and problem-solving and is essential for personality development.

Experts warn that behavior which we initially find pleasurable and which engages us in approach behavior, puts us in such a dopamine deficit state that we continue to indulge in that behavior not to feel good, but to stop feeling bad. We don't enjoy it, but yet we just cannot stop

going back to the screen.

Homeostasis is any self-regulating process by which biological systems tend to maintain stability while adjusting to conditions that are optimal for survival. If homeostasis is successful, life continues; if unsuccessful, disaster ensues. The idea was first explored by French physiologist Claude Bernard in 1849, and the word homeostasis was coined by American neurologist and physiologist Walter Bradford Cannon in 1926. When the system of dynamic equilibrium is disturbed, built-in regulatory devices respond to establish a new balance, as in the control of body temperature to a steady 98.6°F.

Modern-day psychiatrists have discovered that abstinence from any drug or addiction for a month is the minimum time required for brain neuroadaptation to restore homeostasis balance and decrease the anxiety and depression that social media can induce. This 30-day abstinence allows us to realize the true impact of compulsive overconsumption on our lives. It is required to reset our brain pathways to be able to re-engage in recovery work and reassess our goals. The goal is how to do nothing. It's crucial to take time just to be. Scientific studies have observed the importance of "resting mental networks," meaning that between activities, people demonstrate a synchronicity between different parts of the brain that has its own rhythm and breathing. This state contributes to original ideas and a general sense of wellness. An example of this can be found in the interview of popular actor Aamir Khan, who says: "When I stopped using the phone, I didn't realize how big a step it would be. It has totally changed my life as I have started thinking, and mental windows started opening up so fast. Mobile devices had made us stop thinking. I have managed to complete my assignment in 6 weeks, which would otherwise have taken no less than two years. As we used to do before, I have now started thinking about my children, my family, and my work."

Apart from the structural brain damage it causes, the time wasted scrolling through trivial and junk data on your phone is a waste of your life because time is also a measure of life, just as moments are.

The main problem with treating digital addiction is that the user is unaware of being afflicted with this disease. For a start, it is critically important that such awareness is raised. The support of family and community must play a significant role. The problem I see here is that the family and community may itself be afflicted to a considerable degree. A look around us would answer this beyond a doubt. It is the sheer scale of this addiction that is worrisome and unprecedented. We can beat our digital dependencies by embracing a more monastic mindset. Experts warn that we need to stop hunting for pleasure all the time, and this hunting needs to be replaced by what they term as "painful pursuits" like exercise, fasting, prayer, meditation, and other mind-engaging activities. We need to consider how this addiction affects our ability to be a good parent, spouse, or friend.

Here, I would humbly suggest to the readers that what neuroscience has discovered recently was revealed to us by our beloved Prophet Muhammad (PBUH) more than 1400 years ago. Every Muslim, every year, is required to fast and reflect for a month during the most holy and sacred month of Ramadan. It is a time to practice self-control, gratitude, and compassion. Sawm (fasting) is the fourth pillar of Islam, and abstinence forms its core. Other religions also practice fasting and abstinence for spiritual reasons.

Keeping in view the views expressed above, there is a dire need for our society to rise together in solidarity to fight this addiction. I would suggest to all residents of Jammu and Kashmir, irrespective of their religion, to come together as human beings and collectively withdraw from the digital world and give their minds time to breathe, think, and restore mental balances that are vital for our present and future. Let us collectively abstain, or to the extent possible reduce, the use of digital devices during the holy period of Ramadan.

he education system in Jammu and Kashmir (J&K) is in a state of crisis, with numerous challenges undermining its effectiveness. Among these challenges, the failure of flagship programmes like the Sarva Shiksha Abhiyan (SSA) highlights the systemic inefficiencies that plague the region's educational infrastructure.

that plague the region's educational infrastructure. The Sarva Shiksha Abhiyan also appears to be a vision which is now derailed. Launched with the vision to provide free and compulsory education to children aged 6 to 14 years, the SSA aimed to bridge educational gaps by establishing schools in far-off areas of J&K. Since its inception in the early 2000s, the programme led to the establishment of 18,021 schools across the region, including 10,690 primary schools and 7,331 upper primary schools. This effort raised the total number of government-run schools in J&K to 23,117.

However, the scheme's execution was marred by haphazard planning and poor management, leading to the closure of 24% of these schools, primarily due to zero or minimal enrollment. As per updated official figures, at least 119 schools in J&K were operating without a single student enrolled. Shockingly, 238 teachers were still posted in these schools, effectively drawing salaries despite no active teaching responsibilities.

This mismanagement underscores the broader issues within the education system. On average, seven teachers were deployed in schools, even those with negligible or no enrollment, highlight-

Data-Driven Insights: UDISE and Beyond

The Unified District Information System for Education (UDISE) data further reveals the extent of these inefficiencies. In July 2024, reports stated that out of the 23,117 government schools, 4,394 schools were removed from UDISE due to closure or lack of functionality. This alarming figure reflects a significant regression in the accessibility and availability of education, particularly in remote areas.

Impact on Educational Equity

The closure of schools under the SSA has had a cascading effect on the region's literacy and enrollment rates. While J&K's overall literacy rate stands at 77.30%, disparities persist, particularly among females, whose literacy rate is 68%, compared to

the male literacy rate of 85.70%. The closure of schools in remote areas has further exacerbated this gap, denying children access to education and perpetuating socio-economic disparities.

Underlying Challenges

Many SSA schools lacked basic facilities such as proper classrooms, sanitation, and learning materials, leading to a lack of trust in government institutions. Additionally, schools were established without considering the local population's needs, resulting in schools in areas with insufficient student populations. Moreover, the deployment of teachers in non-functional schools reflects a lack of monitoring and accountability within the system.

To address these systemic challenges, a comprehensive overhaul of the education system in J&K is essential.

1. Data-Driven Planning: Conduct detailed population and enrollment surveys before establishing

schools to ensure resources are utilized effectively.
2. Infrastructure Development: Invest in building and maintaining school infrastructure to create a conducive learning environment.

3. Teacher Training and Deployment: Implement transparent policies for teacher recruitment and ensure equitable distribution of qualified teachers.

4. Community Engagement: Foster community involvement in monitoring and supporting schools to enhance accountability and trust.

5. Monitoring and Accountability: Establish independent bodies to regularly evaluate school performance and address inefficiencies promptly.

The defunct state of the education system in Jammu and Kashmir, as exemplified by the failure of the Sarva Shiksha Abhiyan, is a sobering reminder of the need for effective planning, execution, and accountability. The closure of schools, misallocation of resources, and declining enrollment rates have created a crisis that threatens the region's socio-economic future. Immediate and sustained efforts are required to address these issues and ensure that the vision of quality education for all becomes a reality in J&K.

Dr Lone's Work on Enduring Legacy of Two Pioneering Muslim Reformists

Dr Lone's book is a concise yet insightful exploration of enduring legacies of two pioneering Muslim reformists, Abduh and Sir Syed, in a lucid style

A decade ago (in 2014), Dr Ab. Hamid Lone (a College Professor of Arabic in the Higher Education Department, J&K) published an Urdu book titled "Imam Muhammad Abduh: Hayat-o-Khidmat" (Muhammad Abduh: Life and Legacy), which delved into Abduh's contributions to various fields, including literary, cultural, journalistic, intellectual, religious, ethical, political, and educational facets in the framework of Islamic reformist thought (I had reviewedthis book in Kashmir Reader on 20th June, 2017).

Recently (in mid-2024), Dr Lone (now retired) has come up with another scholarly work, "Sheikh Muhammad aur Sir Syed Ahmad Khan: Ek Taqabuli Mutala" (Sheikh Muhammad Abduh and Sir Syed Ahmad Khan: A Comparative Study). This book provides a thorough and comparative analysis of the ideas and contributions of these trailblazing reformist thinkers in an accessible Urdu style. Both Abduh and Sir Syed have significantly contributed to the reformist legacy, driving Islamic reform through their focus on socio-religious and educational aspects. They have been labelled, and fairly so, as "pioneers of Islam

The book, published by Takbeer Publications Srinagar, consists of seven (7) chapters, preceded by a 'Foreword' by Dr Jauhar Qudussi (pp. 7-9), a 'Preface' by Dr Muzaffar Hussain Nadwi (pp. 10-14), an Introduction (pp. 15-16) by the author, and ends with a 3-page Conclusion (pp. 96-99) and a Bibliography (pp. 101-105). The chapters examine lives and legacies of Abduh and Sir Syed, highlighting the similarities and differences in their ideas and approaches in areas like educational reform, journalistic services, contribution to Quranic exegesis, and response to orientalists' propaganda.

Dr Qudussi and Dr Nadwi, two renowned Kashmiri scholars of Urdu and Arabic respectively, applaud the author's effort by describing it as an "appreciable research work" on an important topic that aids in understanding, in a comparative manner, different dimensions of the life and ideas of these two pioneering figures" (pp. 7, 9, 13-14).


Dr Lone outlines the objectives for writing this book in the Introduction, arguing that he not only identified many commonalities in the thinking of these reformist pioneers, but also found potential to deliver solutions to the concerns and challenges confronting Muslims today (pp. 15-16).

In the first chapter, Dr Lone, situates the biographical sketch of Abduh and Sir Syed within their respective socio-political and intellectual contexts, setting the ground for the subsequent discussions. Despite their variance in ideology and perspective, he argued, both these visionaries converged on the imperative of "revitalizing Muslim ummah to ensure its survival and progress" (p. 19).

The second chapter compares in detail their approaches on the "Acquisition of Education and Training" (pp. 24-51) highlighting their major initiatives, curriculum reforms, and approaches that emphasized modern education, reform of traditional education, promoting critical thinking, and focusing character development in line with the Islamic sources. Summarily, while both shared similar educational reform goals, their techniques and beliefs differed in terms of emphasis on Islamic education, religion's role, methodology, and context.

The third chapter concentrates on the literary oeuvre ("Books and Literary Works", pp.53-59) of Abduh and Sir Syed and provides a long list of works authored, compiled, and translated by them with a brief description that helps in understanding the overall theme of each work. This description not only helps in understanding their respective fields and levels of interest and expertise, but also in gauging the significance and influence these works have on the Islamic intellectual tradition. For Dr Lone, "Abduh left behind a prodigious academic legacy, which was centered on exploring themes of reform and Islamic topics" with modern interpretations, and Sir Syed too has made "a commendable contribution through his prolific writings" (pp.

The fourth chapter focuses on their "Journalistic Services" (pp. 61-70) as both contributed their writings to various newspapers and periodicals with the purpose

Muhammad Abduh aur Sir Syed Ahmad Khan: Ek Taqabuli Mutala" (Sheikh Muhammad Abduh and Sir Syed Ahmad Khan: A Comparative Study). This book provides a thorough and comparative analysis of the ideas and contributions of these trailblazing reformist thinkers in an accessible Urdu style

socio-religious, fostering intellectual, and educational reform within their communities. Abduh frequently penned articles in Arabic advocating for Islamic reform, social justice, anticolonialism, Muslim solidarity, and the necessity for Muslims to return to the original sources of Islam. Sir Syed sought to advance social reform and Muslim welfare, highlighting the importance of modern education, science, and technology for Muslim progress through an accessible Urdu style. Thus, both utilized journalism as a "powerful tool for promoting their ideas and thoughts, the central axis of which were the Islamic teachings" (p.70). Through their unique writing style and intellectual perspective, as Dr Lone further asserts, many journalists and writers were greatly impacted and, as a result, contributing in various manners to transformation in their communities (pp. 63, 69).

The fifth chapter, "Responses to Orientalist Criticisms" (pp. 71-79), addresses the misunderstandings, misinterpretations, and biases presented by certain Orientalists and Christian missionaries in their writings concerning Islam and Islamic subjects. It aims to expose their focus on Islam's rational and intellectual heritage and on presenting the true portrayal of Prophet Muhammad (pbuh), which was misrepresented in numerous Orientalist texts. For instance, Dr Lone mentions Sir Khutbat-e-Ahmadiya/ Essays on the life of the Prophet (pbuh) as a response to The Life of Mahomet (London, 1858-61) by Scottish orientalist William Muir (1819-1905) and Abduh's writings like Islam and the Response to the Critics, several articles in Al-Manar and Islam and Christianity in relation to Science and Civilization countering the writings of Farah Antun (1874-1922), Gabriel Honotaux (1853-1958) and Ernest Renan (1823-1892). These orientalists claimed that Islam was rigid, stagnant, and incompatible with reason, science and progress. Abduh and Sir Syed refuted these claims with robust arguments, authentic evidence, and objective and thoroughly analysis (pp. 73, 74, 79).

The sixth chapter examines the "Contributions of Abduh and Sir Syed to the Quranic Exegesis and a (Critical) Review of their Opinions" (pp. 81-95), highlighting their innovative methodologies and approaches

to interpret the Our'an by combining rational and scientific methods with the main objective of promoting "social and religious reform" (p.81). He further asserts that although their interpretations faced criticism from traditional Muslim scholars, the reality is that within the context of their socio-political and intellectual climate, their contributions as exegetes remain substantial. thinkers recognized Both the need for a "contextually relevant interpretation of the Qur'an, distinct from traditional commentaries", though they ideological "exhibit limited convergences" (p. 94).

These chapters are succeeded by brief "Concluding Remarks" (pp. 97-98) that offer a succinct overview of the ideas, insights, and impacts of Abduh and Sir Syed. Their contributions, as reformers, have made an "exceptional impact on the Muslim Ummah" (p. 97), motivating and shaping an entire generation of Muslims worldwide, as "the ideas of both these thinkers possessed an inherent spirit to catalyze significant change", resulting in the formation of two well-organized movements: 'Aligarh Movement' and 'Al-Manar movement' (pp. 98-99). The author anticipates a reevaluation of their contributions in the contemporary context (p.

The book has two major limitations: the absence of Urdu translations for Arabic and English quotes and statements (see, e.g., pp. 19, 67, 68, 69, 77, 95), which hinders the readability and comprehension; and the lack of full bibliographical details for the journal articles (pp. 107-108); though the Bibliography is arranged and organized language wise and into two broad categories: Arabic, Urdu, and English Books and Periodicals and Journals.

Overall, Dr Lone's scholarly work represents a significant addition to the literature on reform and reformist thought, offering a comprehensive and comparative analysis of Abduh's and Sir Syed's contributions, illuminating their shared concerns, unique methodologies, and distinctive approaches. The book has the potential to benefit scholars and students alike.

Mehbooba Urges Nitish, Naidu To Oppose Waqf Bill



Srinagar- Peoples Democratic Party (PDP) chief Mehbooba Mufti has written to Bihar Chief Minister Nitish Kumar and Telugu Desam Party (TDP) chief N. Chandrababu Naidu, urging them to 'oppose the proposed Waqf amendment bill'.

In a letter shared on her social media handle, the former Jammu and Kashmir chief minister expressed deep concern over the bill, calling it "unconstitutional, unconscionable, and authoritarian." She argued that the proposed amendments directly undermine the core purpose of the Waqf Act, which is to protect and preserve properties dedicated to religious and charitable causes for the Muslim community.

"The bill comes at a time when, for the past decade, Muslims have been systematically disenfranchised, disempowered, and marginalized politically, socially, and economically," Mufti wrote.

She accused the government of disregarding opposition concerns, calling the parliamentary consultation process a "farce" without genuine efforts to engage with the affected

She further warned that the bill represents "a direct assault on the fundamental rights guaranteed by our Constitution" and reflects "majoritarianism that has fueled bigotry and the marginalization of Muslims since 2014."

Mufti also invoked Mahatma Gandhi's vision of an inclusive India, saying that the bill 'threatens the secular fabric of the

Appealing to Nitish Kumar and Naidu, both key allies in the NDA government, she urged them to use their influence to halt the bill, warning that its passage could 'harm national unity and communal harmony'.

"You have always been staunch believers in our Constitution and have consistently championed the spirit of Ganga-Jamuni tehzeeb (composite culture). Today, as key members of the NDA, you are uniquely positioned to influence this matter and prevent this onslaught," she wrote.

The proposed Waqf amendment bill has sparked widespread debate, with opposition parties and minority organizations voicing strong objections.

iPhone Was Top Selling Model In India In Oct-Dec, It Is A Huge Market: Apple CEO

NEW DELHI, Jan 31: Apple is very keen on India where it has seen record business during the December quarter with iPhone emerging as the top-selling smartphone model, a top company official said on Friday.

During the company's earnings call, Apple CEO Tim Cook said India offers a huge growth opportunity for the company.

"We have had great results in the emerging market. I am particularly keen on India. India has set a December quarter record. iPhone was top selling in India for the quarter. It is the second-largest smartphone market in the world and third largest for PCs and tablets. So there is a

huge market," he said.

"We have a very modest share in these markets. I think there are lot of upsides there...," Cook said.

He said the company has announced plans to open more Apple stores in India.

According to Counterpoint Research, Apple led the India market in 2024 with 23 per cent share in terms of value of total smartphones supplied in the country.

In the December quarter, Apple had 11 per cent share in the Indian smartphone market.

Cook said Apple is expanding Apple Intelligence and



will launch a localised English version in India in April.

On financial performance during the December quarter, Cook said Apple has registered an all-time record revenue of USD 124.3 billion, up about 4 per cent on a year-onyear (YoY) basis.

The company, however, posted a decline of about 7 per cent in net income to USD 36.33 billion during the October-December period from USD 33.91 billion a year carlier.

The product sales of the company grew 1.5 per cent to USD 97.96 billion from USD 96.45 billion and services sales grew about 14 per cent to touch record high quarterly revenue of USD 26.34 billion

from USD 23.11 billion on a year-on-year basis.

The iPhone sales during the quarter declined marginally to USD 69.13 billion from USD 69.7 billion a year ago.

69.7 billion a year ago.
Sales of Apple's Mac PC increased 15.5 per cent to USD 8.98 billion from USD 7.78 billion and iPad sales grew about 15 per cent to USD 8 billion from USD 7 billion on a year-on-year basis.

The company's sales grew across all geographies except in China where it manufactures the majority of Apple products.

Apple sales in China declined 11 per cent to 18.5 billion during the December quarter from USD 20.8 billion a year earlier. (Agencies)

Gold Prices To Decline, Silver To Rise In 2025: Economic Survey



New Delhi: Gold prices are expected to decline in 2025 while silver prices may increase, according to Economic Survey 2024-25 tabled in Parliament on Friday.

Citing the World Bank's Commodity Markets Outlook for October 2024, the economic survey highlighted that commodity prices are projected to decrease 5.1 per cent in 2025 and 1.7 per cent in 2026.

The projected declines are led by oil prices but tempered by price increases for natural gas and a stable outlook for metals and agricultural raw materials.

Among precious metals, gold prices are expected to decrease while silver prices may increase. Prices for metals and minerals are expected to decline, primarily due to a decrease in iron ore and zinc prices, the economic survey said.

"In general, the downward trend movement in prices of commodities imported by India is a positive for the domestic inflation outlook," it added.

Meanwhile, the survey said "a global rise in uncertainty has led to fluctuations in the composition of foreign exchange reserves. CY24 saw gold bullion holdings nearing their highest level since World War II, which was largely driven by an

accumulation of gold by emerging market central banks".

Gold imports have increased, influenced by higher global prices, early purchases ahead of festive spending, and demand for safe-haven assets.

The survey observed that uncertainty in global markets has led to fluctuations in the composition of foreign exchange reserves, as central banks adjust their holdings to mitigate risks.

Further, the International Monetary Fund (IMF) has noted steady changes are underway in the global reserve system, including a gradual movement away from dollar dominance and a rising role of non-traditional currencies, it said.

The survey suggested that while the projected decline in gold prices may affect investor sentiment, the expected rise in silver prices could provide some support to the bullion market.

As the government prepares for the upcoming fiscal year, it expects to closely monitor price movements of the bullion and their impact on inflation, trade, and foreign exchange reserves.

India, one of the world's largest importers of gold, has traditionally witnessed strong demand for the metal, particularly during the festival and wedding seasons.

LG Inaugurates 32nd International Conference Of Indian Association Of Palliative Care At AIIMS Jammu

SAMBA, Jan 31: Lieutenant Governor Manoj Sinha inaugurated the 32nd International Conference of the Indian Association of Palliative Care (IAPC), at AIIMS Jammu.

More than 800 national and international delegates will join deliberations to foster advancements and innovations in palliative care for quality of life for patients diagnosed with terminal illness. The three-day conference is being organised by IAPC J&K Chapter and AIIMS, Jammu.

In his keynote address, the Lieutenant Governor exhorted the experts to keep Standard Operating Procedures (SoPs) up to date and be more sensitive towards the needs of individuals diagnosed with life-threatening disease, well-being of families, alleviate pain and suffering and

provide spiritual support. The Lieutenant Governor

asked the private sector to work with the administration to set up Palliative care centres in backward and remote areas.

"In J&K, the administration in 2022 had set up 10-bed state-of-the-art Palliative and Geriatric Care Wards in all the districts. We have tried to bridge urbanrural divide to certain extent. Our aim is to deliver medical and psychological support at people's doorstep," he said.

The Lieutenant Governor emphasised that all the experts and the Indian Association of Palliative Care should work together to promote multisectoral partnerships so that a human resource pool of trained care-givers is made available.

"In Palliative care, health



ecosystem and healthcare professionals have a moral responsibility to reduce the pain and suffering of patients. Apart from adopting innovative approach to pain management, health care professionals at all levels should be given training for continuity in the care of such patients," the Lieutenant Governor said.

The Lieutenant Governor made valuable suggestions for seamless integration of curative care and Palliative care in health ecosystem. He suggested that uniform SoPs may be prepared for community awareness, palliative support and pain management at the district level.

Palliative Care system is

constantly evolving and we need to work on strategic framework, SoPs and its effective implementation, he said.

The Lieutenant Governor further highlighted the need to bridge the gap in healthcare facilities and special services for the ageing population.

"By 2050, 20.8% of India's total

population will be above 60 years of age. This increase in the elderly population requires us to develop a strong care economy to ensure that our elders can live healthy, dignified and fulfilling lives," the Lieutenant Governor said.

He also suggested developing a comprehensive healthcare package which includes regular checkups, geriatric care, mental health support and palliative care.

inaugurated Radiotherapy Oncology and Operation Theatre Complex at AIIMS Jammu. He launched AIIMS Pain Policy and lauded the AIIMS Jammu's vision of pain-free patient care.

He also commended the Indian Association of Palliative Care for playing a significant role in the expansion of specialized care based on the principles of palliative care.

Meanwhile, the Lieutenant

Governor inspected various blocks at AIIMS, Jammu and interacted with the medical staff. Standard Operating Procedures of Department of Anaesthesiology and the Patient Information Booklet of Chemotherapy were also launched.

The establishment of Radiotherapy Oncology facility at AIIMS Jammu will reduce the need for patients to travel long distances for radiation therapy, ensuring timely diagnosis and treatment within the region. The service will cater to increasing number of cancer patients, offering advanced radiotherapy techniques, personalized treatment plans and multidisciplinary care. The Hospital-Based Cancer Registry, under ICMR's National Cancer Data Project has also been commenced which will further aid in shaping effective cancer care operations and strategies.

The Operation Theatre Complex featuring 08 advanced operation theatres at AIIMS Jammu, includes Four Integrated OTs with live surgical broadcasting for real-time medical training, One Hybrid OT with rotatory MRI and CT scan technology for complex procedures like transplants and cochlear implants.



International Conference Of IAPC Begins In Jammu

JAMMU: The 32nd international conference of the Indian Association of Palliative Care (IAPC) commenced at the All India Institute of Medical Sciences (AIIMS) here on Friday, officials said.

Jammu and Kashmir Lt Governor Manoj Sinha inaugurated the three-day conference at the Vijaypur campus of AIIMS where more than 800 national and international delegates will join deliberations to foster advancements and innovations in palliative care for quality of life for patients diagnosed with terminal illness.

The conference is being organized by IAPC J&K Chapter and AIIMS, Jammu, an official spokesman said.

In his keynote address, the Lt Governor exhorted the experts to keep Standard Operating Procedures (SoPs) up to date and be more sensitive towards the needs of individuals diagnosed with life-threatening diseases, the well-being of families, alleviate pain and suffering and provide spiritual support.

Sinha asked the private sector to work with the administration to set up palliative care centers in backward and remote areas.

"In J&K, the administration in 2022 had set up 10-bed state-of-the-art palliative and geriatric care wards in all the districts. We have tried to bridge the urban-rural divide to a certain extent. Our aim is to de-

liver medical and psychological support at people's doorstep," he said.

The Lt Governor emphasized that all the experts and the IAPC should work together to promote multi-sectoral partnerships so that a human resource pool of trained caregivers is made available.

"In Palliative care, the health ecosystem and healthcare professionals have a moral responsibility to reduce the pain and suffering of patients. Apart from adopting innovative approaches to pain management, healthcare professionals at all levels should be given training for continuity in the care of such patients," he said.

The Lt Governor made valuable suggestions for the seamless integration of curative care and Palliative care in the health ecosystem.

He suggested that uniform SoPs may be prepared for community awareness, palliative support and pain management at the district level.

"Palliative Care system is constantly evolving and we need to work on a strategic framework, SoPs and its effective implementation," he said. Sinha highlighted the need

Sinha highlighted the need to bridge the gap in healthcare facilities and special services for the ageing population.

He also suggested developing a comprehensive healthcare package that includes regular check-ups, geriatric care, mental health support and palliative care.

The other arrested gangster was identified as Arjun Kumar alias "Billu", a resident of Akhnoor who is presently living in Arnia area, the official said.

He said an FIR has been registered under relevant sections of law and further investigation is on.

Govt Disallows AIP's Hunger Strike

SRINAGAR: Authorities on Friday disallowed the Awami Ittehad Party (AIP) from holding a hunger strike in Srinagar, Jammu and Delhi in solidarity with its jailed leader and Member Parliament (MP) Er Rashid, the party here said on Thursday.

The party said they will seek fresh permission to hold a peaceful protest. It, however, condemned the move, calling it an attack on democratic rights.

They said several party leaders and workers, including the jailed MP's son, were detained.

Expressing disappointment over the authorities' refusal to grant permission for their peaceful protest, MLA Langate and senior AIP leader Sheikh Khursheed said they had formally sought permission but were denied to hold a hunger strike in support of their party chief Er Rashid.

MLA criticized the detentions, saying the government's



response was unjustified. "If the authorities had security concerns at Pratap Park, they could have allowed us to conduct the strike at our party office, as we had requested. Instead, our leaders and workers were detained. It is our right to stand with our leader," he said. Asked whether Er Rashid

has begun his hunger strike
inside Tihar Jail, Khursheed
said they have no direct contact with him. However, he
confirmed that through legal
counsel, Er Rashid had con-

veyed his decision to begin the

hunger strike at 10:30 am.

Meanwhile, AIP vice president, G N Shaheen said they have "called off" the hunger strike protest call, and will discuss the future course of action after applying for fresh permission for the peaceful protest.

Shaheen said the party in no way will hold violent protests, but a peaceful one in solidarity with Er Rashid, who he alleged was denied his political rights. "It will be entirely within the parameters of law," he said.

Bukhari Demands Monthly Allowance For Unemployed Youth

SRINAGAR: Apni Party President Altaf Bukhari has demanded that the central government provide a financial package for a monthly allowance to unemployed youth in order to give them some relief until they secure employment.

He said that "there are more than seven lakh jobless youth, mostly graduates and postgraduates, who should be given a monthly allowance of up to Rs 20,000 to ease their financial burden".

He made this and other demands while speaking to reporters after a crucial party meeting in Jammu.

Bukhari also called on the central government to double J&K's grant in light of the prevailing economic conditions and the financial challenges that the Union Territory (UT) is facing.

He said, "A significant amount of

he said, 'A significant amount of hydropower is being generated using the water resources of Jammu and Kashmir, yet the Union Territory derives only minimal benefits from it. Also, we are grappling with challenging economic conditions and financial hardships. In light of these circumstances, the Union government must take these factors into account and double J&K's grant, which currently stands at Rs 10,000 crore."

Furthermore, Bukhari urged the central government to allocate the funds for the proposed tunnels in Jammu and Kashmir so that reliable road connectivity is established here.

He said, "The Centre should also allocate funds for long-awaited

projects, such as tunnels at Sadhna Top and on the Gurez-Bandipora Road, as well as the proposed Vailoo-Kishtwar tunnel and the Peer Ki Gali tunnel on the historic Mughal Road. The construction of these tunnels would ensure reliable road connectivity between regions and provide all-weather access to remote areas across Jammu and Kashmi."

Responding to questions about the performance of the government, Altaf Bukhari said that "We are not going to judge the performance of this government so soon. However, the fact remains that the government itself admits its inability to perform. That said, I do not agree with the argument that two power centers are hindering the government's performance."

3 Drug Peddlers Arrested In Kashmir

SRINAGAR: Continuing its efforts to eradicate the menace of drugs from the society, Police on Friday said to have arrested three drug peddlers in Budgam & Handwara and recovered contraband substances from their possession.

Police Post Mochwa received information from reliable sources that a person Saqlain Mushtaq son of Mushtaq Ahmad Bhat resident of Batpora Chadoora has concealed contraband substance at his residential house. Following the information, a search warrant was obtained from Hon'ble Court. Subsequently, a police team of Police Post Mochwa raided the house and conducted the search in the presence of the concerned Executive Magistrate, a police

spokesman said in a statement.

During search, 545 grams of charas like substance, 230 grams of grinded charas like substance and 33.10 Kg of semi grinded cannabis leaves were recovered from the said location. He was accordingly arrested and a case under relevant sections of law has been registered and investigation has

been initiated, police said. In Handwara, during naka checking at Baghatpora Crossing, a police team from Police Station Handwara intercepted a suspicious individual carrying a bag. During the search, 8.93 grams of heroinlike substance was recovered from his possession. He has been identified as Ashiq Ahmad Shah son of Mohd Subhan Shah resident of Kachwari Handwara. In another operation at Badkote Handwara, a police team intercepted a person identified as Bilal Ahmad Najar son of Gh Nabi Najar resident of Badrehar Handwara. During the search, 63 grams of charas-like substance was recovered from his possession, police said.

Regarding the incidents, police said that cases under relevant sections of law have been registered in Police Station Handwara. Investigations are underway to trace further links in the drug trade.

J&K Police remains resolute in its mission to eliminate drug-related activities in the area and safeguard the community. The general public is requested to remain vigilant and report drug peddling activities to the nearest police station, ensuring collective action against the menace of drug addiction and trafficking, the statement reads.
