## Step Up Fight Against Terrorism In J&K: Shah Calls For Achieving Zero-infiltration Goal

#### **Observer News Service**

New Delhi:Union Home Minister Wednesday directed all security agencies to step up the fight against terrorism in Jammu and Kashmir with the goal of achieving 'zero infiltration'.

Chairing two high-level review meetings in as many days here on the security situation in Jammu and Kashmir, he also said the ecosystem of terror in the Union Territory has been weakened due to the sustained and coordinated efforts of the Narendra Modi government.

He asked all security agencies to take more stringent action on infiltration and acts of terror with a ruthless

approach, saying the goal should be to uproot the existence of terrorists.

The home minister directed them to step up the fight against terrorism with the goal of 'zero infiltration', according to an official statement.

Shah said under

leadership of Prime Minister Narendra Modi, the government is committed to wiping out terrorism from Jammu

He emphasised the Modi government's policy of zero tolerance against terrorism to achieve the goal of a

terrorism-free Jammu and Kashmir and directed all security agencies to remain vigilant and continue to work in synergy to eliminate terrorism in the Union Territory.

The home minister said the narco network is providing support to infiltrators and terrorists to carry out their activities.

"There is a need to take prompt action against terror funding from the proceeds of the narcotics trade with alacrity and rigour," he said.

Shah directed the agencies to make new appointments in the Forensic Science Laboratory (FSL) in view of the timely implementation of the new criminal laws.

## 143 Out Of 161 Srinagar **Smart City Projects Completed: Official**

Srinagar: As the year 2025 enters its second month, officials from Srinagar Smart City Limited (SSCL) on Wednesday said that 143 out of the total 161 projects under the Smart City initiative have been completed.

An official from SSCL said that the initial budget was Rs 940 crore, and among the remaining 18 projects, work is currently underway. We are hopeful of achieving full completion by March 2025, he said.

Regarding infrastructure developments, the official said that one of the major ongoing projects is Riverfront Phase II, covering the stretch from Amira Kadal to Chattabal.

Shahr-e-Khaas development, divided into Sections A, B, and C, along

with three other projects, has reached an 85 percent completion rate," he said, adding that the underground ducting project along the right bank of the riverfront is progressing well, with about 75% of the work completed.

Srinagar: The well-known Kashmiri Meenakari work is taking its last breath and it is on the verge of extinction with the last surviving artists finding it difficult to manage the family affairs.

Nazir Ahmad Pahalwan (72), son of Ghulam Nabi Pahalwan of Teergaripora, Rajouri Kadal, Srinagar, a last surviving artist of Meenakari said that he has been associated with this work since 1968.

Nazir has learnt this art from his father and continues to do Meenakari work whenever he gets any order.

Narrating the difficult situation, Nazir said Meenakari work has gone very down and he hardly gets any order, which makes his struggle to earn a livelihood difficult.

"There were few Meenakari artisans but due to no demand in the market, they switched to some other iob," he said. "My own son is working as a fitter as he refused to take the legacy forward due to the low market."

He said that nobody at present is ready to learn this art, adding that demand is on

decline for the last 15 years. Meenakari work is being done on gold and copper items by writing different names and other things.

Despite ailing health and bad financial conditions, Pahalwan has kept the dying art of Meenakari alive for the last 50 years. He continues to do 'Meenakari' from the dilapidated workplace in the premises of his residence at Rajouri Kadal whenever he gets any orders.

"Old Kashmir 'Meenakari' pieces are treasured by collectors and museums. Nowadays, we only come to see old Kashmir Meenakari pieces in museums and art books. Kashmir was once a renowned center for meenakari on silver, gold, and brass. The process of meenakari involves the use of special micro tools and needs a lot of patience," he said.

He said the government can make efforts by attracting youth in this work so that the legacy is preserved and the dying art will be kept alive for the future generations—(KNO)

## **Stray Dog Population Surges In City**

Srinagar: The increasing population of stray dogs in various parts of Srinagar has instilled fear among residents, particularly in areas like Bhorikadal, Khanyar, Eidgah, Nawakadal and Dalgate. Residents complain that venturing out during morning and evening hours has become a daunting task, as packs of stray dogs roam the streets, often chasing pedestrians and creating a sense of insecurity.

A resident from Bhorikadal expressed concern over the growing menace. "We are afraid to step out early in the morning or late in the evening. The dogs chase us, and even our children fear going to their tuition classes. We often have to accompany them to ensure their safety," he said.

The uncontrolled growth of stray dogs has become a pressing issue, with frequent cases of dog bites being reported from different localities. Elderly individuals, children, and women are particularly vulnerable, as aggressive canines are often seen blocking pathways and chasing vehicles and pedestrians. Several instances of dog attacks on school-going children have been reported, raising serious safety concerns.

Despite repeated appeals to the concerned authorities, residents claim that no substantial action has been taken to address the menace A shonkeener from Khanyar voiced his frustration, stating, "Every day, we witness people, especially children and the elderly, being chased by these stray dogs.

We are afraid to step out early in the morning or late in the evening. The dogs chase us, and even our children fear going to their tuition classes. We often have to accompany them to ensure their safety,"

We have approached the authorities multiple times, but no concrete steps have been taken.

The presence of uncollected garbage on roadsides and in residential areas is being cited as one of the main reasons for the surge in the stray dog population. The lack of proper waste disposal management has turned many streets and bylanes into feeding grounds for canines, further worsening the situation. "Until the authorities implement an effective waste management strategy, this problem will persist," said another resident

from Nawakadal. When Associated News Bureau contacted an official from the Srinagar Municipal Corporation department responsible for managing the stray dog population, he acknowledged the issue but wished to remain anonymous. He revealed that the sterilization program had

been temporarily halted due to the harsh winter conditions. 'We cannot conduct steriliza-

tion during the cold months. However, once the temperature rises, we will resume the program to control the dog population," he said.

While sterilization remains a long-term solution, many believe that immediate measures such as dog shelters and designated feeding zones should be established to prevent further attacks. Experts have also suggested increased public awareness about handling stray dogs and coordinated efforts between municipal bodies and animal welfare organizations.

Apart from the fear of attacks, residents are also worried about the potential spread of diseases such as rabies.

A local doctor from a Srinagar hospital highlighted the risks associated with uncontrolled stray dog populations. "Rabies is a fatal disease, and timely vaccination is crucial. If the number of stray dog attacks increases, the demand for vaccines will rise, putting immense pressure on healthcare facilities," he warned.

The residents, however, demand immediate intervention. 'We are not against animals, but human lives matter too. The authorities must act swiftly before the situation gets worse," said a resident from Dalgate.

Until concrete steps are taken, the streets of Srinagar will continue to be plagued by this growing menace, leaving residents in perpetual fear every time they step out of their homes. (ANB)

## Cycle Of Violence

he killing of ex-Territorial Army soldier Manzoor Ahmad Wagay in Kulgam is a reminder of how fragile the situation in Kashmir remains. His wife and young niece, wounded in the attack, are now struggling to recover. For Kashmir, it is another reminder that the militancy in the Valley is very much alive and can strike at any time, without warning.

can strike at any time, without warning.

Security forces have detained hundreds in overnight raids, and interrogations are underway to try and identify the perpetrators. But the forces have to ensure that the innocent people do not suffer. This will only alienate more people, something that has never served the cause of peace in the union territory in the past.

That said, this attack has raised difficult questions. Was it a random act of terror, or a revenge killing? Just weeks ago, security forces killed top Hizbul Mujahideen commanders in the same area. Was this strike meant to show that militant groups still have the ability to hit back? These patterns are all too familiar in Kashmir—an encounter, followed by a retaliatory killing, and then by another crackdown. The cycle repeats itself, and ordinary people remain trapped in its grip.

The statements of condemnation have come, as they always do. Leaders have expressed their grief, vowed justice, and promised that the perpetrators will be punished. But what does justice look like for a family that has lost its provider?

The reality is that despite repeated claims of improved security, attacks like this prove that the threat has not gone away. Militants still manage to regroup, and strike where it hurts. The fight against militancy cannot be won through arrests alone. It requires deeper efforts—better intelligence, stronger community trust, and a strategy that does not rely solely on force. The central government has certainly taken steps in this direction. Last year, Assembly polls were held and an elected government led by the National Conference assumed power. This has made the governance approachable and given people a sense of stake in the system.

It is also true that the situation has significantly improved in recent years. Although the militancy has persisted in one form or another, its local component has by and large been reigned in. As for the militancy sustained by infiltration, here again the forces have pulled the situation back from the brink. The results are already visible in Rajouri and Poonch, where terror incidents have notably declined. But the challenge is far from over. Militancy in J&K has often shown the ability to adapt to the situation and survive, hence all the more reason for the security forces to stay one step ahead.

# NGT Steps In as J&K Fails to Enforce Environmental Laws

This matter needs to be taken seriously by Chief Minister
Omar Abdullah so that the executive is held accountable and made to
enforce all environmental laws in letter and spirit

remember the late former Union Finance and Law Minister Arun Jaitley stressing the importance of drawing a line between the judiciary and the executive. While speaking at the "Indian of the Year 2015" awards ceremony, organized by Network 18 News (formerly CNN News 18), he said that courts cannot perform the functions of the executive, and the independence of the two must be strictly maintained. He further stated that if the judiciary fails to act, the executive cannot take up that role under the plea of mounting pending cases. Similarly, courts also cannot take over executive functions. However, when our government officers (the executive) fail to perform their constitutional duties, the judiciary has shown a willingness to use its power. Many critics call it judicial encroachment into the executive domain, but after experiencing the lukewarm response of the executive in enforcing environmental laws in Jammu & Kashmir, I believe the judiciary, especially the National Green Tribunal (NGT), is our only hope for the implementation and enforcement of environmental legislations and the rules governing these laws.

#### Judicial Activism

The judiciary plays a pivotal role in promoting and upholding the rights of citizens. It also plays an important role in upholding the rights of citizens guaranteed under different environmental laws. The active role of the judiciary in upholding the rights of citizens and preserving the nation's constitutional and legal system is referred to as judicial activism. After the enactment of the Air (Prevention and Control) of Pollution Act in 1981, the Indian judicial system, particularly in the realm of environmental law, underwent a major transformation, abandoning its weaker stance in favor of charting new social justice possibilities. Environmental activism received a significant boost from judicial activism, especially when environmental rights were recognized as a "fundamental right" under Article 21 (Right to Life) of the Constitution. This gave the right to a clean and healthy environment constitutional sanctity. Our High Courts, the Supreme Court of India, and more specifically the National Green Tribunal (NGT) have played a great role in enforcing environmental laws, as the executive has

#### NGT Performing the Role of the Executive in J&K

From my experience, the National Green Tribunal (NGT) is doing the work that should be done by law-enforcing agencies in Jammu & Kashmir. Our District Magistrates, Urban Local Bodies, Rural Local Bodies, the J&K Pollution Control Committee (JKPCC), and other institutions have hardly been serious about ensuring the implementation of the Air Act, Water Act, Municipal Solid Waste Rules 2016, J&K Mining Rules 2016, etc. This is reflected in the fact that the NGT has imposed huge penalties on the J&K Government in the last 3 to 4 years. Even in petty cases, government institutions have failed to act, and the aggrieved

are now knocking on the doors of the National Green Tribunal (NGT). This is a very serious issue that our elected government, especially the Chief Minister, must address urgently!

#### Latest Case Study from Bandipora

Recently, the National Green Tribunal (NGT) had to intervene because the District Administration of Bandipora and the J&K Pollution Control Committee failed to shut down an illegal hollow cement brick manufacturing unit at the Naidkhai locality in Bandipora district. This pollution-causing unit is located just next to a Government Higher Secondary School. The school principal made a written complaint to the local Tehsildar in 2022, who then sought a report from his Naib Tehsildar. Despite this, the officers failed to act, even after the aggrieved parties approached the SDM Sumbal and the DC Bandipora. They then turned to the J&K Pollution Control Committee (JKPCC), which ordered the closure of the unit for violating the Water Pollution Act of 1974 and the Air Pollution Act of 1981. The unit owner challenged the closure order before the

Act. We also find that the order of the Member Secretary, JKPCC, dated May 27, 2024, is also under Section 31A of the Air (Prevention and Control of Pollution) Act, 1981, and the Air Act also creates a jurisdictional bar under Section 46 of the Air Act."

The NGT's Principal Bench advised the JK-PCC to bring this matter to the attention of the CJM of Srinagar to modify the order accordingly. The NGT's order further reads:

"The JKPCC must bring the said jurisdictional bar to the notice of the Civil Court which passed the order in the civil suit, where the order of JKPCC dated May 27, 2024, under the Air Act, Water Act, and EP Act has been stayed. The OA raises substantial issues related to compliance with environmental norms. Issue notice to the respondents to file their response/reply by affidavit before the Tribunal at least one week before the next date of hearing. If any respondent files the reply directly without routing it through their advocate, they must remain virtually present to assist the Tribunal. The applicant is directed to serve the respondents and file an affidavit of service at least one

# The environmental legal regime in Jammu & Kashmir has many facets and institutions, but they have failed to address our concerns. Ironically, some institutions have not only been mute spectators but have even become collaborators in environmental crimes, as evidenced by the NGT's orders over the last

Chief Judicial Magistrate (CJM) of Srinagar. Technically, the CJM had no jurisdiction to handle this case, and relief was granted to the brick manufacturing plant owner. Ironically, the JKPCC did not challenge this order before the District Court or the National Green Tribunal (NGT).

4 to 5 years

With all executive avenues closed and even the lower judiciary passing a defective order, the aggrieved locals, through one Zahoor Ahmad Dar, had no option but to seek the indulgence of the National Green Tribunal (NGT) in New Delhi. The case was listed before the Principal Bench of Justice Prakash Srivastava (Chairperson of NGT) and Dr. Afroz Ahmad (Expert Member) on January 21, 2025.

#### NGT's Order on January 21, 2025

The petitioner, Zahoor Ahmad Dar, was present before the NGT's Principal Bench on January 21, 2025, through virtual mode. He pointed out that the J&K Pollution Control Committee (JKPCC) had passed a closure order on May 27, 2024, based on his complaint, but the brick plant owner had challenged the order in a Civil Suit before the Chief Judicial Magistrate (CJM) of Srinagar. The CJM passed an interim order on October 28, 2024. In compliance with the CJM's order, the closure order was kept in abeyance by the Member Secretary of JKPCC on January 8, 2025. The Principal Bench of the NGT stated that the CJM of Srinagar had no jurisdiction to issue an order in this case.

#### The NGT's order reads:

"We find that the order dated May 27, 2024, was passed by the Member Secretary, JKPCC under Section 33A of the Water (Prevention and Control of Pollution) Act, 1974, and Section 58 of the Water Act, 1974, which creates a jurisdictional bar for civil courts to entertain any suit or proceeding in matters under this

#### Conclusion

The environmental legal regime in Jammu & Kashmir has many facets and institutions. but they have failed to address our concerns. Ironically, some institutions have not only been mute spectators but have even become collaborators in environmental crimes, as evidenced by the NGT's orders over the last 4 to 5 years. Had the Tehsildar of Hajin acted on the application of the Principal of the Higher Secondary School of Naidkhai Sonwarai in 2022, the locals wouldn't have had to approach the NGT. Similarly, had the J&K Pollution Control Committee (JKPCC) challenged the CJM Srinagar's order, the NGT wouldn't have had to intervene in this petty case. Earlier, it was only I who sought the indulgence of the NGT, then we had a case filed by Rasikh Rasool from Kupwara, and now another application has been moved from Naidkhai, Bandipora. When I examine all these cases, it is clear that the local administration and regulatory authorities could have addressed these petty environmental violations, but they didn't, forcing all of us to approach the NGT. I believe this matter needs to be taken seriously by Chief Minister Omar Abdullah so that the executive is held accountable and made to enforce all environmental laws in letter and spirit.

## The Altering Winters of Kashmir and Their Influence on Its Identity

The winters of Kashmir have long been classified by snow. The arrival of snow followed a predictable timeline and impacted day-to-day activities, binding people to their roots. However, with snowfall now becoming increasingly unpredictable, Kashmiris are undergoing deep emotional and cultural changes. The decrease in snowfall is not just an environmental concern-it is changing how Kashmiris view their past, present, and future.

The Importance of Blizzard to the People of Kashmir

In earlier times, the first snowfall was a cause for celebration. For the older generations, snow was an integral part of life, intertwining with memories, traditions, and activities. Ghulam Mohammad, a retired teacher from Baramulla, says, "I remember winters when the valley was covered in a thick layer of snow." For Ghulam, snow was more than just a weather phenomenon-it was deeply embedded in life and culture.

Snow also helped keep track of time. It marked the onset of winter, and life was structured around these seasonal rhythms. In Kashmir, snow evoked a sense of calmness-people spent more time indoors, sharing stories over warm Nun chai and dried fruits. It was a time to reflect, rest, and bond with one another.

**A Changed Environment** 

Baramulla, otherwise known

as the 'Venice of the North,' was once famous for consistent snow falls during winter. However, these days, snowfall in Kashmir is no longer a guarantee. Nowadays, it's a guessing game for winters, as snow can arrive too early, too late, or not at all. The world as a whole has changed, and so has Kashmir due to the climate crisis, leaving the region with this unfortunate inconsis-

Faizan, a 23-year-old student, commented, "We don't experience winter the same way our elders did, but winter for us is still special. It's a time when we can get together and relax with our friends over hot drinks and cozy houses."

Young Kashmiris have started carving out their own ways to celebrate winter in the absence of heavy snow. They are using these newfound customs to highlight their experiences while preserving the tales of previous generations. "I feel like it's okay to alter the way winter is celebrated. That means we still have some of our grandparents' memories alive, but we get to create our own too," Faizan said.

## A Critical Analysis of Iqbal's Shikwa and Jawab-e-Shikwa

A Poetic Masterpiece or a Theological Dilemma?

llama Iqbal's Shikwa (Complaint) and Jawab-e-Shikwa (Reply to the Complaint) are two of his bestknown poems. They are highly praised for their powerful message to the Muslim Ummah, urging them to get back on track and become more self-aware. However, a closer examination of these poems reveals theological concerns that conflict with core Islamic beliefs In Shikwa, the direct complaint is made against God, questioning His fairness and suggesting that He has forsaken His people. Jawab-e-Shikwa, claimed to be Allah's reply, attempts to provide answers, and if true, could ascribe human speech to the Godhead, which has no place in Islamic theology.

#### The Problems in Shikwa

From an Islamic point of view, one should not complain in an accusatory way to Allah. Islam recommends that believers approach Allah with humility and submission, framed by the practices of patience (Sabr) and gratitude (Shukr) when seeking from Allah, rather than questioning divine wisdom. Nevertheless, in Shikwa, Iqbal's poetry expresses resentment toward Allah in a way that contradicts these principles.

One of the most controversial lines states: "Tujhko maloom hai leta tha koi naam tera?"

"Do You even know if anyone used to take Your name?"

This line assumes that Muslims were the only ones who gave proper account of God and that He has something to give them in return. This misrepresents the relationship between humans and the Creator. Allah does not require human remembrance, as He is completely independent of all creation:

"O mankind, you are those in need of Allah, while Allah is the Free of need, the Praiseworthy." (Surah Fatir 35:15)

Similarly, Iqbal writes: "Hum wafadar nahi, tu bhi to dildar nahi.'

"We are not loyal, but You are also not generous.'

This verse questions Allah's bounty, implying that divine mercy comes with a trading requirement. Islam teaches, however, that Allah's mercy is boundless and not contingent upon human actions:

"My mercy encompasses all things." (Surah Al-A'raf 7:156)

Another problematic aspect of Shikwa is that it absolves Muslims of their responsibilities to Allah, instead of urging introspection. The Quran repeatedly emphasizes that human actions determine their success or failure:

"Indeed, Allah will not change the condition of a people until they change what is in themselves." (Surah Ar-Ra'd 13:11)

However, Shikwa frames the decline of Muslims as if Allah has punished them inequitably, rather than as a consequence of their own failures. This contradicts the Islamic conviction that all things happen through divine provi-dence and that problems should lead to repentance, not grumbling.

Iqbal, however, expresses doubt as to why a deity would favor angels and celestial beings over Muslims:

"Hoor aur ghilman ki ky humse?'

"Why are the angels and heavenly beings favored over us?" Islam believes that all created things have a design, and it is not for humanity

to deny Allah's design: "He is not questioned about what He does, but they will be questioned." (Surah

Al-Anbiya 21:23) Such complaints suggest a sense of entitlement before Allah, which goes against

"Reh gayi rasme azan, rooh-e-bilali na rahi."

the Islamic principle of humility.

"The ritual of Azan remains, but the spirit of Bilal is no more."

This sentence presumes that the heart of Islam has been lost, almost accusing Allah of it. However, Islam teaches that faith is an individual responsibility. The dissolution of Muslims is not caused by Allah's negligence, but due to the mistakes of Muslims. Verily, a believer should replace questioning the divine will with self-correction and seeking Allah's mercy. "Qahar tujhko, magar hum tujhe razi kar

"You are angry, but we will find a way to please You."

This sentence suggests that divine blessings are embedded in a commercial negotiation with God, in which Muslims must make efforts to ask God to make blessings move in their favor. But Allah's mercy is not limited to human effort. His grace is vast and unconditional:

"My mercy encompasses all things." (Surah Al-A'raf 7:156)

The notion of bargaining with Allah is incompatible with Islamic beliefs, where submission and thankfulness, rather than complaints, are conducive to divine grace. "Chheen li mard ki masti, bhi to be-daar

"You took away the zeal of men, but You are not even aware."

This sentence implies that Allah has purposefully made the power and will of Muslim males feeble, painting Allah as apathetic to their sufferings. This contradicts the Islamic belief that Allah is always aware and never unjust:

"And your Lord is not ever unjust to [His] servants." (Surah Fussilat 41:46)

#### The Problems in Jawab-e-Shikwa

Although Shikwa voices issues from a Muslim perspective, Jawab-e-Shikwa tries to address them by framing the issue in the form of a divine response from God, Allah. This very structure is problematic because Islam teaches that God's words are absolute and final in the Qur'an. No human can assume Allah's voice without revelation, and doing so is likely to falsely attribute words to Him. Jawab-e-Shikwa contradicts the Quranic principle:

"He is not questioned about what He does, but they will be questioned." (Surah

Even if one maintains that Jawab-e-Shikwa is metaphorical, it establishes a potentially harmful precedent. Islam has very few limitations on who is permitted to speak in Allah's name, i.e., only the holy Prophets. Once revelation ended with Prophet Muhammad (PBUH), no one—not even a great poet like Iqbal could claim the right to present "Allah's words" in poetic form.

Furthermore, Jawab-e-Shikwa presents a debate-like exchange between Allah and Muslims. This concept does not exist in Islamic theology. The Quran makes it clear that human beings have no capacity to contest the ruling of Allah or to request rationalization:

"And your Lord is not ever unjust to

[His] servants." (Surah Fussilat 41:46) Another issue is that Jawab-e-Shikwa presents Allah's response in a way that suggests He has to explain Himself, almost as if justifying His actions. Islam teaches that Allah's wisdom is beyond human comprehension and does not need to be defended. It is expected, however, that the faithful yield to His will with trust and patience.

#### Conclusion

Although both Shikwa and Jawab-e-Shikwa are highly praised for their poetic merit, their theological points of controversy conflict with the tenets of Islamic teachings. Shikwa represents God in a way that suggests He has let humans down, asking about His justice and mercy in a manner that contradicts Quranic teachings. Jawab-e-Shikwa, in an effort to answer, adopts the form of God-an extremely sensitive issue in Muslim theology, as it can never be claimed by any human to represent the Divine.

Islam teaches that suffering should be borne with prayer, contrition, and selfbetterment, not by grumbling at God. The true revival of the Muslim Ummah is not attained by doubting the will of Allah but by being so pious that acts of thanksgiving and betterment for the community flow from a sincere heart, good deeds, and unshakeable trust in Allah's wisdom.

Other leaders who intend to rejoin Congress include G M Saroori, Muhammad Amin Bhat from Devsar, Ashok Kumar, Gulzar Ahmad Wani and others, sources privy to the development said.

"The mass rejoining is expected to take place in Jammu or in New Delhi this week," they said. Several leaders, who are expected to rejoin Congress, have already resigned from DPAP last year.

Pertinently, KNO had reported that the DPAP is facing an uncertain future following its crushing defeat in the 2024 assembly elections.

The party's activities have come to a standstill, with Azad himself maintaining an unusual silence and absence from the political scene in Jammu and Kashmir. (KNO)

Countries from Russia, China, Germany, Spain, Ireland and the UK said they continued to support the two-state solution that has formed the basis of Washington's policy in the region for decades, which has held that Gaza would be part of a future Palestinian state that includes the occupied West Bank.

Welcoming Israeli Prime Minister Benjamin Netanyahu to the White House on Tuesday, Trump said he would support an effort to permanently resettle Palestinians from Gaza to places where they can live without fear of violence, and he and his team had been discussing this possibility with Jordan, Egypt and other regional countries.

An official from Hamas, which ruled the Gaza Strip before fighting Israel in a brutal war there, said Trump's statement about taking over the enclave was "ridiculous and absurd".

"Any ideas of this kind are capable of igniting the region," Sami Abu Zuhri told Reuters, saying Hamas remains committed to the ceasefire accord with Israel and "ensuring the success of the negotiation in the second phase".

Russian Foreign Minister Sergey Lavrov said, 'There are Israeli plans to take full control of the occupied West Bank and attempts to displace Palestinians from the Gaza Strip," adding that, "practicing a policy of collective pun-ishment is a method that Russia rejects," Al Jazeera reported.

The Chinese Foreign Ministry expressed opposition to the forced transfer of the people of Gaza and expressed hope that all parties will take ceasefire and post-conflict governance as an opportunity to bring the Palestinian issue back to a political settlement on the basis of the two-state solution. Some of the toughest criticism came from France, which said the forced displacement of Gazans would be a serious violation of international law, an attack on the legitimate aspirations of the Palestinians and destabilise the region.

Permanent displacement

Russia believes a settlement in the Middle East is only possible on the basis of a two-state solution, the Kremlin said on Wednesday, while Spain's Foreign Minister Jose Manuel Albares said "Gaza is the land of Gazan Palestinians and they must stay in Gaza".

Trump's proposal raises questions whether Middle East power Saudi Arabia would be willing to join a renewed U.S.-brokered push for a historic normalisation of relations with U.S.

Saudi Arabia, a key U.S. ally, said it would not establish ties with Israel without the creation of a Palestinian state, contradicting Trump's claim that Riyadh was not demanding a Palestinian

Trump would like Saudi Arabia to follow in the footsteps of the United Arab Emirates, a Middle East trade and business hub, and Bahrain which signed the so-called Abraham Accords in 2020 and normalised ties with

In doing so, they became the first Arab states in a quarter century to break a longstanding

Michael Milshtein, a former intelligence officer and one of Israel's leading specialists on Hamas, said Trump's comments put Israel on a collision course with its Arab neighbours.

"Maybe Trump is trying to promote pressure on the Arab states (so) that they will not create any obstacles if he will try to promote a normalisation between Saudi Arabia and Israel." he said.

Netanyahu would not be drawn into discussing the proposal, other than to praise Trump for trying a new approach.

Palestinians fear another 'Nakba'

Displacement is a highly sensitive issue among both Palestinians and Arab countries.

As fighting raged in the Gaza war, Palestinians feared they would suffer from another "Nakba", or catastrophe, referring to the time when hundreds of thousands were dispossessed of their homes in the 1948 war at the birth of the state of Israel.

"An extraordinarily compassionate global leader," Canadian Prime Minister Justin Trudeau said Tuesday, calling him a very good friend. "He will be deeply, deeply missed by people around the world.'

Treated as a head of state, the Aga Khan was given the title of "His Highness" by Queen Elizabeth in July 1957, two weeks after his grandfather the Aga Khan III unexpectedly made him heir to the family's 1,300-year dynasty as leader of the Ismaili Muslim sect.

He became the Aga Khan IV on October 19, 1957, in Dar es Salaam, Tanzania, on the spot where his grandfather once had his weight equalled in diamonds in gifts from his

He had left Harvard to be at his ailing grandfather's side, and returned to school 18 months later with an entourage and a deep sense of responsibility.

"I was an undergraduate who knew what his work for the rest of his life was going to be," he said in a 2012 interview with Vanity Fair magazine. "I don't think anyone in my situation would have been prepared."

A defender of Islamic culture and values, he was widely regarded as a builder of bridges between Muslim societies and the West despite or perhaps because of — his reticence to become involved in politics.

The Aga Khan Development Network, his main philanthropic organization, deals mainly with issues of health care, housing, education and rural economic development. It says it works in over 30 countries and has an annual budget of about USD 1 billion for nonprofit development activities.

A network of hospitals bearing his name are scattered in places where health care had lacked for the poorest, including Bangladesh, Tajikistan and Afghanistan, where he spent tens of millions of dollars for development of local economies.

The extent of the Aga Khan's financial empire is hard to measure. Some reports estimated his personal wealth to be in the billions.

The Ismailis – a sect originally centred in India but which expanded to large communities in east Africa, Central and South Asia and the Middle East — consider it a duty to tithe up to 12.5 per cent of their income to him as steward. "We have no notion of the accumulation of

wealth being evil," he told Vanity Fair in 2012. "The Islamic ethic is that if God has given you the capacity or good fortune to be a privileged individual in society, you have a moral responsibility to society." The Ismaili community's website said he was born on December 13, 1936, in Creux-de-

Genthod, near Geneva, Switzerland, the son of Joan Yarde-Buller and Aly Khan, and spent part of his childhood in Nairobi, Kenya – where a hospital now bears his name. He became well-known as a horse breeder and owner, and he represented Iran in the 1964 Winter Olympics as a skier. His eye for building

and design led him to establish an architecture prize, and programmes for Islamic Architecture at MIT and Harvard. He restored ancient Islamic structures throughout the world. The Aga Khan lived at length in France and had been based in Portugal for the past several

He added that the passengers have been detained and further investigations are underway under the Customs Act, 1962. Customs Delhi noted its commitment to curbing smuggling activities and protecting national security.

## **Police Crack Mosque Burglary Case, 3 Arrested**

SRINAGAR: Srinagar Police have solved a burglary case involving the theft of cash from a mosque donation box in Nishat, leading to the arrest of three suspects and the recovery of stolen money.

According to an official statement, on February 2, Police Station Nishat received information about a break-in at a mosque located at Syed Rahman Chowk, where unidentified thieves had forcibly opened the donation box and taken away cash during the intervening night of February 1-2.

Following the complaint, an FIR (No. 07/2025) was registered, and an investigation was launched. Using a combination of intelligence inputs and technical evidence, the police swiftly identified and apprehended the suspects.

The arrested individuals have been identified as Aamir Rafig, son of Rafiq Ahmad Sheikh alias Dobhi, a resident of Buchwara Dalgate

Mohd Sufyan Bage, son of Mohd Rafiq Bage, originally from Bage Mohalla Uri Baramulla, currently residing in Gulab Mohalla Dalgate

Danish Bashir Khan, son of Late Bashir Ahmad Khan, a resident of Buchwara Dalgate, presently living near Sumo Stand Khunmoh

It further reads, Police also seized a Swift car (registration number JK04A-5786) used in the commission of the crime. Upon questioning, the accused led investigators to the stolen cash, which has now been recovered.

Authorities have assured that further legal proceedings are underway, and the case remains under investigation.

## **Misbranded Pesticide Seized** In Kashmir

SRINAGAR: The Jammu and Kashmir government has directed the seizure of a pesticide product, Indofil M-45, after it was declared misbranded by the Agriculture Chemist at Lalmandi, Srinagar. The directive was issued by the Office of the Deputy Director of Law Enforcement following an intimation from the Assistant Director of Law Enforcement.

According to official documents, a sample of Indofil M-45, which contains Mancozeb 75% WP as its active ingredient, was tested and found to be misbranded. The batch in question (CMZ24-660) was manufactured on December 13, 2024, by Indofil Industries Limited and has an expiry date of December 12, 2026.

The authorities have instructed law enforcement officers to seize the stock of the pesticide and take necessary action under the provisions of The Insecticides Act, 1968, and its associated rules. Further steps will be taken based on the findings and legal provisions.

The move is part of efforts to regulate the quality of pesticides in Kashmir and ensure that only approved and effective products are available for agricultural use", said an official. [KNT]

### **Z-Morh Tunnel Transforms Sonamarg Into Winter Tourism Hotspot**

SRINAGAR: The newly inaugurated Z-Morh Tunnel in Ganderbal district is proving to be a game-changer for the Sonamarg tourist destination, boosting winter tourism in the region at a very large scale. Since its opening on January 13, more than 55,000 tourists have visited Sonamarg within just 16 days during the otherwise slow winter months.

The 6.5-kilometer-long tunnel, connecting Gagangir to Sonamarg, was inaugurated by Prime Minister Narendra Modi and has since facilitated seamless access to the picturesque valley, which was previously difficult to reach due to heavy snowfall and road closures. Official data reveals that among the 55,935 tourists who arrived post-inauguration, 1,114 were

foreign visitors. According to Ghulam Mohammad Bhat, CEO of the Sonamarg Development Authority, 33,990

tourists had visited Sonamarg in the first 10 days of January 2025. However, after the opening of the tunnel, the number surged significantly.

"Earlier, due to the lack of road connectivity, Sonamarg would witness a sharp decline in visitors during December, January, and February, leaving local businesses struggling. This year, however, the scenario has changed completely," Bhat said.

The increase in tourism has revitalized the local economy, with hotels, restaurants, and shops witnessing a surge in activity. "This place, which usually remained silent during winters, is now bustling with

visitors," Bhat added. He also noted that Sonamarg currently has about 1.5 feet of snow, making it an ideal location for winter sports. The authorities are in talks with the sports department to organize skiing, skating, ice hockey, and other winter activities to further promote tourism.—(KNO)

## Wildlife Dept Successfully **Performs Corneal Repair Surgery On Leopard Cat**

**SRINAGAR:** In a significant step, the Department of Wildlife Protection, Kashmir Division, has successfully carried out a corneal repair surgery on a leopard cat with impaired vision.

Officials of the department said that this marks a crucial intervention in wildlife healthcare, highlighting the department's commitment to the conservation and rehabilitation of injured wild animals.

The Leopard Cat, found in distress, was rescued and provided with medical attention by experts, ensuring its chances of survival in the wild, officials said.

An official said that a leopard cat having approximate weight of 2.5-3 kg's was presented from Ajas control room Bandipora from north division with a history of trauma and injury in the left eye.

"The animal on examination showed signs of pain, distress, redness and swelling of left eye, corneal edema and cloudiness. The clinical examination also revealed that the animal was having a prolapsed mass of aqueous humor that had been solidified in the area inside the eye," he said.

Giving details of the surgical procedure, Veterinary Officer Department of Wildlife Protection Kashmir, Dr Mohsin Ali Gazi said the operation required utmost care due to the delicate nature of the eye and



precautions before and after the surgical procedure were also taken care of.

"At first the pre-surgical examination of the animal was conducted including tests and anesthesia was given keeping in view the body weight and other parameters of the animal" he said.

"The surgical technique involved superficial lamellar keratectomy, antibiotics, analgesics, topical medications, ophthalmic solutions, multivitamins and other necessary medication was given" he added.

Gazi further said that the animal exhibited immediate post-operative visual recovery.

He said that post-operative care is critical for successful recovery and has been a big challenge after completion of this surgery and it took a lot of effort from our team.

"Post-operative care included pain management, administration of regular antibiotics, analgesics, topical medications, regular follow-ups to monitor sings of infection and signs of recovery, even restricted movement inside premises and avoiding allergens which has been a big challenge and has been taken care in a very professional manner"

He thanked the Staff of Dept of Wildlife protection Kashmir Bashir Ahmed Reshi and Mehrajuddin who, according to him, provided all possible care to the animal during follow-ups.

"All necessary follow ups, feeding was done in hygienic manner and after a few days the animal was released into its natural habitat," he said.

## **J&K Bank Fraud Cases Drop By 50% In 2023-24**

SRINAGAR: Jammu and Kashmir Bank has made significant progress in combating fraud with a 50% reduction in the number of such cases in 2023-24 compared to the previous

Finance Minister Nirmala Sitharaman provided data on fraud cases across all banks, including Jammu and Kashmir Bank, in response to a question in the Lok Sabha.

The amount involved in these frauds also saw a dramatic decline, dropping to just 2.7% of the total amount from 2022-23. This improvement reflects the bank's enhanced security measures and proactive risk mitigation efforts.

Despite efforts to strengthen security and compliance measures, the bank continues to grapple with varying levels of fraud, with some years seeing alarming spikes in the amounts involved.

The bank reported 13 fraud cases, involving a total of Rs 69.71 crore in 2019-20. In 2020-21, the fraud cases decreased to 10, but the amount involved surged by 42.3% to Rs 99.23 crore, marking the high-

## Focussed On England & CT: Rohit Plays Down Speculations On Future

NAGPUR: Indian captain Rohit Sharma on Wednesday played down speculations about his future in international cricket, saying it is irrelevant to talk about his career at a time when he is "focussed" on the three ODIs against England and the Champions Trophy.

India will tune up for the Champions Trophy, starting February 19, with the three One-Day Internationals against England beginning with the first one here on Thursday.

"How it is relevant that I talk about my future plans when there are three ODIs and a Champions Trophy. The reports (on my future) are going on for a number of years and I am not here to clarify those reports," Rohit said at the pre-match press conference.

"For me, the three games (against England) and the Champions Trophy is very important. My focus is on these games and I will see what happens thereafter," the India skipper added.

The 37-year-old has been battling poor form for a while now, managing only 31 runs across five innings at an abysmal average of 6.20 in the Border-Gavaskar Trophy in Australia.

While there is no doubt that he is not looking to walk into international sunset anytime soon, there were reports that



the BCCI has asked him to spell out his future plans after the Champions Trophy.

With India now competing in ODI cricket, a format in which

Rohit has enjoyed a lot of success, the skipper stressed that instead of harping on the past, he is focussed on the assignments ahead of him.

"This is a different format, different time. As cricketers, there will be ups and downs and I have faced those a lot in my career. This is nothing new to me. We know everyday is a fresh day, every series is a fresh series," and irate Rohit said when asked how confident he is feeling after his recent failure in red-ball cricket.

"I am looking forward to the challenge, not looking at what has happened in the past. There is no reason for me to look behind too much.

"It's important that I focus on what is coming up and what lies ahead for me. Look to try and start this series on a high," he added.
