CUK Extends Winter Vacation Till Feb 14

Srinagar: The Central University of Kashmir (CUK) on Thursday announced extension of winter vacation till February-14.

"Due to inclement weather conditions and ongoing student internship programs outside Jammu & Kashmir, the university has decided to resume its offline classwork from February 17," reads a communique of CUK.

The notification further states that the regular classwork will be conducted online from February 10 to February 14.

The decision was taken following a meeting of Deans and Heads of Departments (HODs) with an approval from the competent authority to ensure uninterrupted academic activities.

Meanwhile, all Heads and Coordinators of Departments have been directed to structure the academic timetable efficiently so that the syllabus for the even semester is completed before the End Semester Examinations (FSF)

Earlier, university was scheduled to re-open on February 10, after a long winter break.

Police Urge People To Maintain Order

Srinagar: Two separate incidents in Jammu and Kashmir—one in Baramulla and the other in Kathua—have sparked controversy, with political leaders demanding investigations into the circumstances of the civilian deaths.

A truck driver was killed in Army firing when he allegedly refused to stop his vehicle at a checkpost in Baramulla district of Jammu and Kashmir despite repeated warnings, officials said on Thursday.

The checkpost was set up at Sangrama Chowk on Wednesday following inputs about the movement of terrorists in the area, they said.

"On 05 Feb 2025, based on a specific intelligence input about the movement of terrorists, a Mobile Vehicle Check Post (MVCP) was established by Security Forces.

MLAs Nomination Case

J&K HC Sets Final Hearing For March 20

Srinagar: The J&K High Court today fixed March 20th, the next date for final hearing in the significant MLAs nomination case, filed by Mr Ravinder Sharma, former MLC & Chief Spokesperson of J&K Congress.

A Division Bench comprising Justice Sanjeev Kumar and Justice Rajesh Sekhri, after briefly hearing Solicitor General Tushar Mehta's plea on behalf of the respondents for a short extension to file a reply, directed both parties to complete all pleadings, including replies and counter-replies, before the next hearing date.

Senior Supreme Court lawyer Dr. Abhishek Manu Singhvi, along with D.K. Khajuria, represented petitioner Ravinder Sharma. The counsel suggested March 20 as a suitable date for the final hearing, which the court accepted with the mutual consent of all parties. The bench assured that it would be available for a full-day hearing on the matter.

2 Doctors Suspended After Botched Surgery In Sopore

Srinagar: Authorities in north Kashmir's Sopore have sealed the operation theatre of Hakeem Sanaullah Hospital and suspended two doctors following an alleged case of medical negligence, where a woman admitted for ear surgery reportedly had her uterus removed instead.

Sources said that the woman had been undergoing treatment at the private hospital and was scheduled for ear surgery. However, in the absence of the doctor treating her, the procedure was allegedly conducted by another doctor, who mistakenly performed a hysterectomy (removal of the uterus).

Following public outcry, authorities acted swiftly and sealed the hospital's operation theatre, citing serious violations of medical protocols.

"We are investigating the matter thoroughly and have served notices to the hospital management, doctors, and staff to explain their position. Preliminary inquiry and evidence suggest that this operation theatre should not have been operational in the first place, and therefore, we have sealed it," said Additional Deputy Commissioner (ADC) Sopore, SA Raina.

He assured that a comprehensive probe is underway and strict action will be taken against those found guilty. Taking further action, the

Jammu and Kashmir government has suspended two doctors allegedly involved in the incident. According to an official order, a copy of which lies with KNO, the following doctors have been suspended: Dr. Anjum Nazir, Consultant Gynaecologist, SDH Sopore, and Dr. Tariq Ahmad Dar, Medical Officer (Diploma in Anesthesia), DH Bandipora.

The government has also barred both doctors from engaging in any form of private practice across Jammu & Kashmir until | More on P6

Private Hospitals Warn Exit From SEHAT Scheme

Srinagar: The Jammu and Kashmir Private Hospitals and Dialysis Centre Association has raised serious concerns over the future of the Ayushman Bharat SEHAT scheme, warning that they may stop providing free treatment under the programme unless urgent reforms are introduced.

In a letter addressed to the CEO of the State Health Agency (SHA), J&K, the association said that following extensive deliberations, they have concluded that the current contract—set to expire on March 15, 2025—is no longer viable under existing terms.

The letter highlighted several key grievances arising from the 9th Governing Council Meeting held on January 19, 2025, where certain decisions were made that the association considers detrimental to private healthcare providers.

"The reservation of four surgical procedures for public hospitals, a 10% reduction in

UT-specific incentives, and the implementation of HBP 2.2 instead of HBP 2022 are not in our interests. These measures are anti-private sector and will push many hospitals to the verge of bankruptcy, given that we have already been suffering for the past ten months," the letter stated.

The association also expressed concern that the meeting failed to address longpending payments, interest on delayed reimbursements, or the review of unjustified deductions and claim rejections dating back to 2022.

HC Upholds ₹1 Million Compensation To Cross-firing Victim

Srinagar: The High Court of J&K and Ladakh has dismissed a plea challenging its single bench order, directing Rs 10 lakh as compensation to the Helper in Forest Department whose arm was amputated following firearm injury during cross-firing incident in 2000.

The High Court's Single bench on 9 June 2023 had directed payments of Rs 10 lakh compensation to the helper, Jehangir Ahmad Khan while disposing of a petition filed by him in 2015.

According to the pleadings, Khan was serving as Helper in the Forest Department of the Government of Jammu & Kashmir, when he became a



victim of cross firing between the security forces and the militants in 2000. He was seriously injured in cross firing, which ultimately resulted in the amputation of his right arm.

Subsequently, Khan had approached authorities for grant of compensation to him for the injuries which he suffered while serving in the Department of Forest. However, the authorities only released Rs. 75,000 as ex-gratia in his

favour "which was too meagre to meet the expenditure of his treatment."

In 2015, Khan moved the High Court, seeking directions to the authorities to provide Rs. 15 lakh by way of compensation for "85% permanent disability suffered by him".

After considering the rival contentions of the parties, the single bench granted a compensation of Rs. 10.00 lakh in lumpsum on 9 June 2023.

However, the government challenged this judgment which was dismissed by the division bench comprising Justice Sanjeev Kumar and Justice Puneet Gupta.

Master Woodcarver Fights To Preserve Kashmir's Dying Art

Ghulam Nabi Srinagar: Hakak, a 78-year-old master woodcarver from Nawabazar, Srinagar, is renowned for his elaborate floral patterns and is believed to have carved the United Nations logo in the 1970s, which still adorns the

General Assembly wall. Despite his age, Hakak remains dedicated to his craft, working tirelessly to preserve the centuries-old tradition of Kashmiri woodcarving.

Ghulam Nabi Hakak recalled learning the art from a seasoned woodcarver six decades ago. "Handling the chisel was challenging at first. I injured myself several times before mastering the craft," he said.

Operating from his workshop in Srinagar's downtown, Ghulam Nabi Hakak, along with two fellow artisansincluding his brother-continues to create exquisite wooden pieces, ranging from intricately designed doors to Qur'an stands and furniture. However, he lamented the decline in demand for handcrafted items

"The work is not as abun-

prefer machine-made products over traditional handcrafted woodwork." he said. urging the government to step in and support artisans in reviving this fading heritage.

Despite the challenges, Hakak remains committed to passing on his skills to younger generations, hoping to keep Kashmir's woodcarving legacy alive for years to come.

It may be recalled that a woodcarver in Kashmir typically has a background deeply rooted in the centuries-old tradition of intricate walnut wood carving. Artisans, known locally as "Naqash," utilize the abundant walnut trees in the region to create detailed designs on furniture. decorative items, and architectural elements.

The craft often traces its origins back to the 15th century when Sheikh Hamza Makhdoom introduced it to the valley. Their work often features floral motifs, geometric patterns, and Islamic influences and is highly prized for its delicate craftsmanship and the unique qualities of Kashmir walnut wood—(KNO)

Srinagar: Police have intensified their crackdown on drug trafficking by booking five notorious drug peddlers under the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PIT-NDPS) Act. The action follows formal detention orders issued by the Divisional Commissioner, Kashmir, based on dossiers prepared by the police.



Trump's Gaza Overreach

onald Trump's latest proposal on Gaza is a dangerous mix of fantasy, imperial overreach, and disregard for Palestinian self-determination. His suggestion that the United States should take over the war-ravaged territory, forcibly resettle its people, and transform it into a luxury destination is both absurd and deeply troubling. It is a plan rooted not in diplomatic realism but in Trump's characteristic mix of grandiosity and ignorance.

Trump's announcement, made alongside Israeli Prime Minister Benjamin Netanyahu, elicited audible gasps-an indication of just how shocking the proposition was. Josiane Fahed-Sreih, in her book "Corruption: New Insights", delves into the historical roots of this pervasive issue. It is as old as human civilization itself. Whispers of the Winter Sky

The Silent Toll of Seasonal Affective Disorder in Kashmir

With the sun veiled behind thick clouds for weeks, the valley experiences a collective descent into Seasonal Affective Disorder (SAD). The absence of adequate sunlight disrupts the body's internal clock, leading to mood disorders, lethargy, and a decline in motivation. This phenomenon is not merely a shift in mood but a neurological recalibration, where the circadian rhythm, governed by the suprachiasmatic nucleus, fails to align with the external environment. The depletion of serotonin levels. coupled with the heightened secretion of melatonin, leads to an altered state of consciousness, making the simplest of tasks feel burdensome. Neurological signaling slows, affecting decision-making, concentration, and response times, ultimately contributing to the valley-wide psychological

Frozen Minds: Depression, Anxiety, and Seizures Amidst the

As the valley braces for the biting cold, an increasing number of individuals exhibit symptoms of clinical depression and anxiety. The interplay between reduced serotonin levels and excessive melatonin secretion contributes to this mental fog, making daily functioning arduous. More alarmingly, epileptic patients experience a higher frequency of seizures during these months, indicating a neurological collapse in signal transmission. The disruption of circadian rhythms due to a lack of sufficient morning light (10,000 lux or more) prolongs confusion, delaying time orientation and increasing seizure vulnerability. A critical factor is the role of CGRP (Calcitonin Gene-Related Peptide) receptors, which, when dysregulated, can lead to migraines and neurological hypersensitivity, worsening symptoms of both depression and seizure disorders. The brain's fragile equilibrium is disturbed, amplifying symptoms of pre-existing conditions. SAD, in Kashmir's context, extends beyond just a seasonal slump—it morphs into a widespread neurological event, leaving thousands struggling against an unseen force, ng urgent nsychiatric and neurological intervention.

The Migration Dilemma: **Escaping Winter, Escaping SAD?**

Every year, a significant portion of Kashmiris migrate to Jammu to escape the unforgiving cold and its psychological burden. Those with financial stability opt for relocation, experiencing notable improvement in mood and vitality. The Light We Cannot See: Sunlight, Optic Nerves, and the **Biological Clock**

Scientific studies suggest that the retina transmits crucial daylight signals to the brain, helping regulate the internal biological clock. In Kashmir, where sunlight remains scarce for months, this mechanism is thrown off balance. The suprachiasmatic nucleus, which governs circadian rhythms, fails to synchronize with the external world, leading

cognitive confusion and exacerbating neurological disorders. Encouraging residents to spend more time outdoors during brief sunny intervals, or to install high-intensity lighting indoors, could mitigate the neurological effects of SAD. Cognitive behavioral therapy (CBT) tailored to seasonal depression also serves as an adjunctive approach to counteract the behavioral withdrawal and mood disturbances associated with winter.

The Silent Epidemic: Blood Pressure, Acid Reflux, and **Medication Overload**

With reduced physical activity, dietary changes, and heightened stress levels, Kashmir's population faces an alarming rise in hypertension and digestive issues during winter. The sedentary lifestyle leads to poor circulation, increasing dependency on calcium channel blockers and beta-blockers to manage high blood pressure, while tension headaches are often treated with CGRP inhibitors. The constant lack of movement results in vascular stiffness, exacerbating the problem. Moreover, disrupted digestion due to stress-induced acidity sees

ing stable calcium and magnesium levels helps in reducing neuromuscular tension, thereby preventing blood pressure-related headaches.

The Dopamine Deficit: A **Generation at Risk** The younger generation, raised

in an era of digital stimulation and instant gratification, faces a heightened risk of SAD due to excessive screen time. The constant exposure to artificial blue light disrupts melatonin secretion, leading to poor sleep cycles, further compounding depressive symptoms. The overstimulation from digital content creates a dopaminergic imbalance, reducing motivation levels and increasing susceptibility to anhedonia-a core symptom of depression. Dopaminedriven instant gratification weakens the brain's ability to sustain focus and long-term goal-directed behavior, making individuals more prone to SAD and attention deficits. Social withdrawal and reliance on digital interactions exacerbate the isolation that winter already enforces. Without proactive measures such as structured physical activity, comement, and regulated screen exposure, this pattern may

How AI Imagery Could Be Used To Develop Fake Archaeology

enerative AI is often seen as the epitome of our times, and sometimes even as futuristic. We can use it to invent new art or technology, analyse emerging data, or simulate people, places and things. But interestingly, it is also having an impact on how we view the past.

AI imagery has already been used to illustrate popular articles, such as covering scientific discoveries about Neanderthals. It was employed to animate the Mesolithic period (from about 9,000 to 4,300 years ago) in a museum. TikTok users have adopted it to make realistic short videos about archaeology and history. It's even been used in a TV documen-

tary about Stonehenge. Yet there are many issues with using AI imagery in archaeology – some of which are also found more broadly within generative AI use. These include its environmental impact and the violation of intellectual property (using train-

ing data created by humans). But others are more specific to archaeology. As an academic who has worked extensively on "resurrecting" the past through digital technology, generative AI has both fascinating potential and enormous risk for archaeological misrepresentation.

Even before the use of AI, it

was widely accepted within archaeology that visualisations of the past are highly fraught and should be treated with extreme caution. For example, archaeologist Stephanie Moser examined 550 reconstructions published in academic and popular texts on human evolution. Her review found highly biased depictions, such as only males hunting, making art and tools and performing rituals, while women were in more passive roles.

A similar study by Diane Gifford-Gonzalez revealed that "not one of 231 depictions of prehistoric males shows a man touching a child, woman, or an older person of either sex ... no child is ever shown doing useful work." These reconstructions do not reflect scientists' nuanced understanding of the past. We know humans organised themselves in an incredible array of variety, with a multitude of gender roles and self-expression.

A recent DNA-based study, for example, showed that women were actually at the centre of societies in the iron age.

The stakes of representation in archaeology are high. For example, the hotly-debated, dark-skinned reconstruction of "Cheddar Man", originally found in south-west England, was based on ancient DNA analysis. It made headlines for disrupting the perception that all human ancestors in the

north were light-skinned. This and similar controver-

sies reveal the iconic power of reconstructions, their political implications, and their ability to shape our understanding of construction

While the Cheddar Man redemonstrates that research is iterative, such reconstructions are sticky. They have profound visual legacies and are not easily supplanted when new data becomes available

This is exacerbated as they are incorporated into generative AI data sets. Beyond the use of outmoded data, generative AI visualisations of the past can be extremely poor.

Even when more plausible details are included, they can be seamlessly integrated with other highly inaccurate elements. For example, it is impossible for viewers to disentangle the data-led from the so-called hallucinations (mistakes) produced by AI.

Highlighting uncertainty is of central importance and concern among archaeologists. Archaeological illustrator Simon James noted that reconstruction artists have used strategically placed clouds of smoke to obscure unknown elements.

As a digital archaeologist, I have made virtual reconstructions of many different sites and subjects. I know there is often estimation and guesswork involved in making holistic representations.

Indeed, photo-realistic accuracy is not always the paramount consideration in visualisation – particularly when exploring different hypotheses or addressing young audiences. But knowing what is backed by archaeological data and what is more speculative is key for authentic visual communication.

Pseudoarchaeology

This is particularly important at a time when pseudoarchaeology is increasingly prevalent in popular media, such as the Ancient Apocalypse show on Netflix. The celebrity host and author Graham Hancock asserts there was a lost ice age civilisation of Atlantis, with advanced technology. But this claim has been thoroughly repudiated by archaeologists.

Arguably, hoaxes will be much easier to perpetuate using generative Al. Beyond the high potential for misinformation about archaeology, the use of generative AI for archaeological visualisations can actually be harmful for archaeological

knowledge production. My research has shown that crafting reconstructions and illustrations in archaeology is incredibly important for understanding and interpreting the past. Creating visualisations based on science – and indeed soundscapes, smellscapes and other interpretations based on multiple senses

- is very helpful for generating new questions.

Drawing allows archaeologists to create more detailed mental models and therefore a better understanding of archaeological remains. By delegating this creation to AI, archaeologists lose a powerful tool for knowledge generation. Moreover, my collaborative work with artists has demonstrated the intriguing possibilities that creative approaches open up to tell new stories about the past.

Even with all of these problems, I encourage an engaged, critical, applied approach to understanding the impact of digital technologies on our investigation of the past. And this includes exploring the uses of generative AI for archaeological visualisation.

Archaeologists and nonspecialists are able to leverage generative AI to creatively produce interpretive media. Indeed, some archaeologists are already exploring AI to generate hypotheses about ancient life. And we are teaching critical uses of AI to our archaeology students.

But what remains imperative is that archaeologists engage with and critique all visualisations - both those created by generative AI and using other media.

Egypt lobbies against Trump plan to empty Gaza of Palestinians as Israel makes preparations

Cairo, Feb 6: Israel says it has begun preparations for the departure of Palestinians from Gaza despite international rejection of President Donald Trump's plan to empty the territory of its population. Egypt has launched a diplomatic blitz behind the scenes against the proposal, warning it would put its peace deal with Israel at risk, officials said.

The Trump administration has already dialled back aspects of the proposal after it was widely rejected internationally, saying the relocation of Palestinians would be temporary.

US officials have provided few details about how or when the plan would be carried out.

In a social media post on Thursday, Trump said Israel would turn Gaza over to the United States after the war and that no US soldiers would be needed for his plan to redevelop it

The Palestinians have vehemently rejected Trump's proposal, fearing that Israel would never allow refugees to return. Egypt has warned that an expulsion of Palestinians would destabilise the region and undermine its peace treaty with Israel, a cornerstone of stability and

American influence for decades.

Saudi Arabia, another key US ally, has also rejected any mass transfer of Palestinians and says it will not normalise relations with Israel — a key goal of the Trump administration — without the creation of a Palestinian state that includes Gaza.

Trump and Israeli officials have depicted the proposed relocation from war-ravaged Gaza as voluntary, but the Palestinians have universally expressed their determination to remain in their homeland.

Trump and Israeli officials have not said how they would respond if Palestinians refuse to leave. But Human Rights Watch and other groups say the plan, if implemented, would amount to "ethnic cleansing," the forcible relocation of the civilian population of an ethnic group from a geographic area.

Israeli Defence Minister Israel Katz said Thursday that he has ordered the military to make preparations to facilitate the emigration of large numbers of Palestinians from Gaza through land crossings as well as "special arrangements for exit by sea and air."

There were no immediate signs of such preparations on the ground.

Israel's 15-month campaign against the militant Hamas group had reduced large parts of Gaza to rubble before a fragile ceasefire took hold last month.

But Egyptian officials, speaking Wednesday on condition of anonymity to discuss the closed-door talks, said Cairo has made clear to the Trump

administration and Israel that it will resist any such proposal, and that the peace deal with Israel — which has stood for nearly half a century — is at risk.

One official said the message has been delivered to the Pentagon, the State Department and members of the US Congress. A second official said it has also been conveyed to Israel and its Western European allies, including Britain, France and Germany.

In a statement Thursday, the Egyptian government said efforts to move Palestinians out of Gaza would constitute a "blatant violation" of international law.

A Western diplomat in Cairo, also speaking anonymously because the discussions have not been made public, confirmed receiving Egypt's message of its strong opposition through multiple channels. The diplomat said Egypt was very serious and viewed the plan as a threat to its national security.

The diplomat said Egypt rejected similar proposals from the Biden administration and European countries early in the war, which was sparked by Hamas' October 7, 2023 attack into southern Israel.

The earlier proposals were broached privately, while Trump announced his plan at a White House press conference alongside Israeli Prime Minister Benjamin Netanyahu.

Hamas, which still rules most of Gaza, has repeatedly condemned Trump's proposal. On Thursday it said that any US takeover of Gaza would be considered an occupation, implying that the militant group would respond with armed resistance.

The group has yet to draw any connection between its objections to Trump's proposal and the ongoing ceasefire. It's unclear if it will have any impact on the next release of Israeli hostages and Palestinian prisoners, set for Saturday.

US officials scale back Trump's proposal

Trump said he wanted to "permanently" resettle most of Gaza's population in other countries and for the United States to take charge of clearing debris and rebuilding Gaza as a "Riviera of the Middle East" for all people. He did not rule out the deployment of US troops there.

US officials later appeared to walk it back, saying the relocation of Palestinians would be temporary and that Trump had not committed to putting American boots on the ground or spending American tax dollars in Gaza.

The Egyptian officials said their government does not believe the Palestinians need to be relocated for reconstruction to proceed and is committed to the creation of a Palestinian state in Gaza, the West Bank and east Jerusalem, territories Israel seized in the 1967 Mideast war.

Israel's government is opposed to Palestinian statehood and has said it will maintain open-ended security control over both Gaza and the occupied West Bank. Israel annexed east Jerusalem in a move not recognised by most of the international community and considers the entire city its capital.

Last week, Egypt hosted a meeting of top diplomats from Jordan, Saudi Arabia, Qatar and the United Arab Emirates — which was the driving force behind the 2020 Abraham Accords Trump brokered with Israel. All five Arab nations rejected the transfer of Palestinians out of Gaza or the West Bank.

In an editorial on Thursday, Egypt's main state-run daily, Al-Ahram, warned that "the Arab countries' independence, their peoples' unity and their territorial integrity are under grave threat."

European countries reject call to take in Palestinians

Katz, the Israeli defence minister, said in a social media post Thursday that Spain, Norway, Ireland and other countries whose officials had criticised Israel's actions in Gaza should take in the Palestinians.

Spain's Foreign Minister Jose Manuel Albares roundly rejected the idea. "Gaza is the land of Gazans," he said in an interview with Spanish radio station RNE.

A spokesman for Ireland's minister of foreign affairs said "the objective must be that the people of Palestine return safely to their home and any comments to the contrary are unhelpful and a source of distraction.

he was declared dead," it added. The Army said the loaded truck was sent to the nearest police station.

"Detailed search of the truck in police custody is underway and investigation on antecedents of the suspect is in progress," it said.

The driver has been identified as Waseem Majeed Mir (35), son of Abdul Majeed Mir, resident of Goripora Darpora Bomai Sopore. His family members and relatives on Thursday said that Waseem was innocent and had never taken part in any anti-national activity. They said the authorities must make the CCTV footage viral so that everything will come to light. They have sought the attention of higher authorities and demanded a thorough investigation and justice in this regard.

Meanwhile, Police urged people to Maintain peace and order in the wake of the incident.

In a statement, the police said that it received information that an RR party had established a Mobile Vehicle Check Post (MVCP) to intercept potential threats.

The spokesman further stated that a suspicious civil truck was spotted moving at high speed. Despite repeated warnings, the vehicle did not stop and instead accelerated past the check post.

Troops pursued the truck for over 23 km and, as per protocol, fired at the tyres to deflate them, forcing the vehicle to halt at Sangrama Chowk, he said.

A detailed search was conducted, and the

injured driver was immediately evacuated to GMC Baramulla, where he was declared dead, he said.

FIR has been registered in PS Baramulla. The

truck has been registered in PS Baramula. The truck has been moved to the nearest police station for thorough search. Post mortem proceedings have been initiated to ascertain cause of death, he said.

A thorough investigation is underway, and all updates will be communicated through official channels. Any attempt to disrupt public order or spread false information will be dealt with strictly, reads the statement.

However, the Army's account of the shooting has come under scrutiny. Iltija Mufti, daughter of former J&K Chief Minister Mehbooba Mufti, questioned the official version of events.

"How strange that after chasing the truck for over 23 km, they claim to have fired at the tyres but somehow misfired at him instead. Are Kashmiri lives so cheap? How long will you justify this unbridled impunity by pointing everyone with the needle of suspicion?" she

In another incident, a 25-year-old civilian, Makhan Din from Perody, Billawar, was found dead in Kathua after reportedly being tortured in police custody.

Locals alleged that Din had been detained on suspicion of links with militants and subjected to severe physical and mental abuse. They claimed he had even recorded a video inside a mosque, swearing that he had no knowledge of militant activity in the area.

The police have not yet issued an official statement on the circumstances of his death, but the incident has triggered widespread

Former Chief Minister Mehbooba Mufti, in a post on X, alleged that Din was falsely accused of being an Over Ground Worker (OGW) and tortured into making a forced confession.

"He was reportedly subjected to brutal thrashing and torture, forced into a confession, and tragically found dead today. innocent youths on fabricated charges. I urge the Director General of Police to initiate an immediate investigation," Mufti wrote.

Bukahri said the incident needs to be thoroughly investigated.

"My deepest sympathies are with the bereaved family of truck driver Waseem Majeed Mir from Goripora Bumia in Sopore, who was killed in a firing incident at a checkpoint in Baramulla. Initial reports suggest that he was driving his truck carrying apple boxes, when he failed to comply with a signal from the security forces, who wanted him to stop at the Naka.

"This incident requires a thorough investigation to determine the exact circumstances under which this unfortunate event occurred. May Almighty Allah grant the departed soul eternal peace and give his bereaved family the strength to endure this profound loss," Bukhari said in a post on X.

Pradesh Congress Committee president Tariq Hameed Karra also condemned the killing as "very fortunate and a matter of grave concern." He said such incidents are detrimental to

peace initiatives, attributing to fear psychosis in the society.

"Killing of Innocent persons is barbaric, in-

"Killing of Innocent persons is barbaric, inhuman and unacceptable in a civilized society. Government should look into the matter very seriously and ensure that no innocent life is lost," he said in a written statement.

Karra urged the government to order a judicial probe into the incident.

The JKPCC president also condemned the

death of Makhan Din of Perody (Kathua) in police custody.

Karra urged the government to bring the facts out and ensure justice to Makhan Din's

family.

"Though the magisterial enquiry has been ordered into the incident, it should be time bound, ensuring that justice is delivered to

These reforms include implementation of HBP 2022 (approved by the National Health Authority in 2022), special rate revision for dialysis patients to reflect rising operational costs, no reservation of surgical procedures for government hospitals so that patients retain the right to choose between public and private healthcare under PMJAY, adherence to National Health Authority guidelines to ensure fair reimbursement practices.

It demanded 1% interest on delayed payments and resolution of past claim deductions and rejections, finalisation of deduction rates before implementation to prevent financial uncertainty, immediate release of pending payments, including Bajaj reimbursements, with 1% interest and continuation of the 10% UT-specific incentive for private hospitals.

The association warned that if their concerns are not addressed, they will be forced to withdraw from the scheme by March 15, 2025, which could severely impact thousands of patients relying on private healthcare facilities under Ayushman Bharat SEHAT. (KNO)

record, we are of the considered opinion that the view taken by the Writ Court (Single Bench), in the context of Article 21 of the Constitution of India, which guarantees life and personal liberty of a citizen, is unexceptionable," the court said.

It is not in dispute that Khan suffered injury which ultimately resulted in amputation of his right arm during the course of his employment, the Court said.

"He was serving as Helper in the Forest Department and, therefore, was entitled to salary," the court said, adding, "Nevertheless, (Khan), who was made to live the rest of his life without a right arm, has suffered immense loss in terms of amenities of life. The Respondent (Khan) would not be in a position to supplement his small amount of pension by doing any menial job after his retirement without the right arm".

Besides, the court said, Khan would face the "stigma" of being a person without the right arm for the rest of his life.

"It also cannot be denied that because of the injury, which ultimately resulted in amputation of his right arm, the Respondent (Khan) suffered huge mental pain and agony," the court said, adding, "In such circumstances, the compensation of Rs. 10.00 lacs, in addition to Rs. 75,000/-, as ex-gratia, cannot, by any stretch of reasoning, be said to be exorbitant or irrational."

Delhi HC Seeks NIA's Stand On Er Rashid's Plea For Custody **Parole To Attend Parliament**

NEW DELHI: The Delhi High Court on Thursday sought the response of the National Investigation Agency (NIA) regarding jailed MP Engineer Rashid's request for custody parole to attend the ongoing Parliament session while facing trial in a terror funding case.

Justice Vikas Mahajan questioned the objection to allowing Rashid to attend the session while remaining in judicial custody, emphasizing that he is an elected Member of Parliament. "What is the difficulty in sending him in custody?" the judge asked.

The court granted the NIA time until Friday to provide its stance on the matter. The agency's counsel, however, argued that the case involved security concerns and was not straightforward.

The court was hearing Rashid's petition, which alleged that he had been left without legal recourse after the NIA court handling his bail application failed to take a decision following his election to the Lok Sabha last year. The delay was attributed to the NIA court not being a des-

ignated special MP/MLA court. During the proceedings, a counsel representing the high court administration informed the bench that an application seeking clarification had been submitted to the Supreme Court and would be mentioned on Friday for listing. The Supreme Court's website indicated that the case was likely to be heard on February 10 or 11.

Earlier, the NIA had opposed Rashid's plea for interim bail to attend the Parliament session, asserting that he had no such "right" as a parliamentarian. In his petition, Rashid urged the high court to either expedite the disposal of his pending bail plea in the NIA court or intervene and decide the matter directly.

On December 24, 2023, Additional Sessions Judge Chander Jit Singh dismissed Rashid's request for an order on his bail application, instead requesting the district judge to transfer the case to a court designated to try lawmakers. However, the case was later sent back to him, leading the trial judge to clarify that he could only rule on miscellaneous applications, not the bail plea itself.

The case remains under legal scrutiny, with further developments expected after the Supreme Court's hearing on the matter. [KNT]

J&K PCC Expands Water, Air **Pollution Monitoring Network**

SRINAGAR: J&K Pollution Control Committee (JKPCC) Kashmir has considerably prioritised one of its basic mandates of environmental monitoring and pollution control in the past one year.

All the laboratories in Kashmir Division have been equipped with new machinery and environmental monitoring has been expanded and streamlined covering different aspects like water, air, microbiology and vehicular pollution.

J&K Pollution Control Committee has been monitoring the performance of all 10 Common Sewage Treatment Plants (CSTPs) operational in Kashmir Division having a combined capacity of 68.0 MLD (million litres per day), with the particulars of designed capacity, utilisation and quality of influent and effluent. Besides, the performance of all individual industrial STPs and Effluent Treatment Plants (ETPs) like those installed in hotels, hospitals and other water polluting industrial units are under constant observation.

Besides, important water bodies like Dal Lake, River Jhelum, Lidder, Sindh and wetlands are being constantly monitored for their water quality viz a viz parameters like DO, BOD, COD, Phosphates and pH.

In this regard, the capacity of JKPCC water laboratory located in Rajbagh Srinagar has been enhanced in terms of new monitoring and analysis equipment. During the current financial year (April 2024 to January 2025) total 1394 water samples were collected and analysed for various physico-chemical parameters.

To study parameters like total coliform and faecal coliform in these water bodies, JKPCC has streamlined and improved the capability of its microbiology laboratory by installing latest equipment and increasing the manpower. During the present financial year, total 865 samples were collected and analysed.

JKPCC also regularly monitors the air pollution levels at its stations spread across Kashmir division with parameters being studied including PM 2.5, PM 10, NOx and SOx.

At present, 23 air quality monitoring stations are operational in Kashmir division while installation of 14 more stations in different districts of Kashmir valley is in the pipeline. A state-of-the-art Continuous Online Air Monitoring Station (COAMS) is already functioning in the Rajbagh campus of JKPCC which monitors and displays the air pollution levels in real time. During the present financial year, a total 5303 air quality monitoring samples were analyzed.

The Vehicular Emission Monitoring Laboratory has also been geared up to keep a check on the functioning of the Pollution Testing Centres and also to randomly cross-check the emission from individual vehicles. Total 1638 vehicles have been checked for emissions and PUC certificates besides 90 inspections have been conducted during the current financial year.

A number of recent reports submitted by JKPCC Kashmir in the National Green Tribunal (NGT) in different matters regarding Dal Lake, wetlands and tourist resorts have resulted in significant directions from the apex environmental court of the country. The reports were submitted after carrying out detailed surveys and analysis of water samples from the water bodies, wetlands and Sewage Treatment Plants.(KNS)

FCS&CA Pulwama Faces **Dearth Of Staff**

PULWAMA: The Food Civil Supplies and Consumer Affairs (FCS&CA) department in South Kashmir's Pulwama is facing a severe dearth of staff as no recruitment has taken place for the district since 2013.

Official sources revealed that there is not enough manpower in the department, which simultaneously has resulted in additional charges of more than

They added that since last one decade, over 200 employees have reached superannuation but at their place, the department has hardly got 15 to 20 employees during this period.

They said that the department advertised over 100 posts of storekeeper, Kandaman and deport assistants since 2013, however, due to unknown reasons the recruitment process was never completed.

"In other districts, the persons who were selected through the same recruitment process have got promoted as well, however, this district continues to grapple under staff dearth," they said.

The official sources said that for the last 12 years, the population has increased manifold but no attention has been given towards enhancing the staff in the department.

They said that even watchmen and helpers are holding charge of 2-3 sale depots besides that officials posted either at district headquarter or tehsil supply office headquarters are holding charges of one or more sale outlets in addition to their duties, which create impediments for the smooth functioning of the office.

The official sources said that in the year 2014 and 2015 the then Assistant Director of the department, who was also Chairman of the recruitment process framed the shortlist but used different criteria forcing some aspiring candidates to knock the doors of court where the case is going on for the last

"The second recruitment process remained withheld too because some shortlisted candidates from first recruitment put a stay on it and asked authorities to first complete their recruitment process. It has been over six years since the matter is at the standstill," they said.

They further added that more than 110 Multi Tasking Staff (MTS) posts are lying vacant in the district due to which people are suffering. Due to staff shortage, many

government sale centres are run by private dealers despite License holders can't hold many charges, he can have only one license. But they are running government sale centres which should be otherwise run by government employees not licence holders.

They further added that the post of Assistant Director Food Civil Supplies and Consumer Affairs (FCSCA) is also lying vacant in the district since 30 September, 2024 and at present AD FCSCA Shopian is holding the additional charge of Pulwama.

1st ODI: Gill Anchors India To 4-Wicket Win Over England

NAGPUR: Vice-captain Shubman Gill orchestrated India's chase with grace, while debutant Harshit Rana dazzled with the ball as the hosts registered a four-wicket win against England in the series opener here on Thursday.

Gill (87), Shreyas Iyer (59), and Axar Patel (52) rose to the occasion, guiding India to a commanding chase after Rana (3/53 from 7 overs) and the seasoned left-arm spinner Ravindra Jadeja (3/26 from 9) shared six wickets between them, dismantling England for a belowpar 248.

Rana's fourth over, which claimed the twin wickets of Ben Duckett and Harry Brook, decisively stifled the England



innings, putting India firmly in control as the visitors never managed to rebuild despite fifties by skipper Jos Buttler (52) and Jack Bethell (51).

Chasing a below 250 score, Gill anchored the innings, forging key partnerships with Iyer and Axar that became the back-

bone of India's chase.

He adapted perfectly to the match situation, playing the perfect foil to Iyer when the Mumbai batter was in full flow, then stepping up as the mainstay, steering India towards victory.

leashed a counter-attacking knock, filled with sizzling shots, including back-to-back sixes.

Gill continued to exude confidence, as he smashed 14 fours, while Axar too brought up a memorable fifty.

England took a flurry of wickets, causing some nervous moments for the hosts but India managed the win with 68 balls remaining.

Earlier, England blazed out of the blocks with electrifying intent after opting to bat, but India's disciplined bowling and razor-sharp fielding orchestrated a remarkable fightback.

The eight-team Champions Trophy begins on February 19 and Australia have until February 12 to make at least four changes to their provisional squad of 15 after Cummins and Hazlewood joined allrounder Mitchell Marsh in the injured category.

Complicating matters was Stoinis, who declared on Thursday that he would no longer play the ODI format to "fully focus on the next chapter" of his career, which might mean freelancing in T20 leagues. The 35-year-old, who has
