AAP candidate from Matia Mahal Aaley Mohammad Iqbal registered the highest victory margin of 42,724 votes in the polls, defeating BJP's Deepti Indora, according to the Election Commission's (EC) data.



BJP's Chandan Kumar Choudhary won the Sangam Vihar seat by the lowest margin of 344 votes.

### **City Girl Makes** 250 'Origami', Achieves **Guinness World Record**

SRINAGAR: Setting a new record in the art of paper folding by making 250 Origami paper boats in one hour, multitalented Rutba Showkat from Srinagar has once again made Kashmir proud by achieving a Guinness World Record.

Rutba is a national-level martial arts player having won 60 medals, including a gold medal. She is a calligrapher and a painter.

Rutba expressed her joy about achieving another feat. "I had been applying for this record (Guinness World Record) for the past three years, and after two failed attempts, I finally achieved it. Alhamdulillah, hard work never disappoints," she said.

"I had kept my Guinness World Record attempt a secret to surprise my family. My parents have always been my biggest supporters, encouraging me in both athletics and artistic endeavors. This international recognition is a proud moment for me and my entire family," she said.

Moreover, Rutba also holds records in the India Book of Records and has won nationallevel awards.

Referring to her latest achievement she said, "Origami is about creating models by folding paper in different ways. ### **Intensive Food Safety Inspection Drive Conducted In City**

SRINAGAR: A team of food safety officials from the Drug and Food Control Organisation conducted an intensive inspection drive at Jehangir Chowk and HSHS in Srinagar. The drive, led by Assistant Commissioner Food Safety Srinagar, Yameen ul Nabi Asstt. Commissioner food safety Srinagar focused on roadside eateries and Kashmiri snack stalls

The primary objective of the inspection was to ensure compliance with the Food Safety and Standards Act, particularly in terms of sanitary and hygienic

various food stalls and vendors, checking for adherence to proper food handling, storage, and preparation practices.

During the inspection, roadside vendors were educated on the importance of maintaining hygiene and sanitary standards. They were also instructed to take measures to protect prepared food from environmental hazards and pests. Failure to comply with these regulations would result in the cessation of their operations under the FSS Act.

Furthermore, food business operators involved in the preparation of ready-to-eat food were

In another show of force by Hamas, which has paraded fighters during previous releases, dozens of its militants deployed in central Gaza as it handed hosPalestinian prisoners freed

Israel's President Isaac Herzog described the release ceremony as cynical and vicious. "This is what a crime against humanity looks like," he said.

In exchange for the hostages' release, Israel is free ing 183 Palestinian prisoners. some convicted of involvement in attacks that killed dozens of people, as well as 111 detained in Gaza during the war.

In Ramallah, in the Israeli-occupied West Bank, a bus carrying 42 freed Palestinian prisoners was welcomed by a cheering crowd. Some waved Palestinian flags and others chanted "Allahu akbar" or "God is the greatest"

### **Congress Fails To Open Account In Delhi For Third Consecutive Time**

New Delhi: The Congress was decimated in the Delhi elections on Saturday, failing to open its account in the 70-member assembly for a third consecutive time and its key candidates suffering crushing defeats.

The only consolation, however, was a slight improvement in the party's vote share, with lead ers proclaiming that they would win back the trust of the people and exuded confidence of forming its government in 2030.

An early one segment lead in Badli was soon lost and the party, now a pale shadow of its glorious past under late chief minister Sheila Dikshit, failed to open its account once again.

Her son Sandeep Dikshit finished third in New Delhi segment where BJP's Parvesh Sahib Verma defeated AAP chief Arvind Kejriwal by over 3000 votes. While Verma polled 25057 votes and Keiriwal 22057. Dikshit gathered just 3873, in a shock culmination of the Sheila Dikshit legacy. Sheila Dikshit was the chief minister of Delhi for three terms.

Congress heavyweights were decimated - state unit chief Devender Yadav ended up third in Badli, Mahila Congress president Alka Lamba finished third in Kalkaji where Chief Minister Atishi won: former minister Haroon Yusuf was third in Ballimaran which he represented five times between 1993 to 2013.

Congress scripted the same story of losses everywhere with only one tiny consolation of a 2.1 per cent improvement in vote

share over 2020.

The party polled 6.39 per cent of the valid votes as against 4.3 per cent in the 2020 assembly polls, massively denting its IN-DIA bloc partner Aam Aadmi Party across segments.

AAP's vote share loss was massive -- down from 53.6 per cent in 2020 to 43.19 per cent -- a drop of over ten per cent.

The Congress managed to play a spoiler for the AAP which suffered heavily in Scheduled Caste and Muslim-dominated segments where Congress made minor gains at AAP's cost and BJP's advantage.

"Aur lado aapas mein!!! (Keep on fighting each other)," National Conference leader and Jammu and Kashmir Chief Minister Omar Abdullah posted on X with a meme, in an apparent jibe at the AAP and the Congress.

The decimation of the Congress and its role of a spoiler are bound to impact the unity of an already-fragile INDIA bloc whose partners have been at variance over ideological issues and electoral alignments. The friction between INDIA bloc partners may be visible in the assembly polls in Bihar.

The poor show of the Congress in Delhi, after Haryana and Maharashtra, will also lead to further diminishing of its dominant position in the Opposition bloc.

So while Congress and AAP had tied up for the 2024 Lok Sabha elections in Delhi, Chandigarh and Haryana, they decided to go it alone in Delhi.

### **US Envoy's Anti-Hezbollah Stance Causes Controversy** In Lebanon

BEIRUT: Morgan Ortagus, US deputy special envoy to the Middle East, caused controversy following her meeting with Lebanese President Joseph Aoun on Friday, after making comments about militant group Hezbollah.

Ortagus, who arrived in Beirut on Thursday evening, emphasized "US commitment to strengthening close relations with Lebanon.

However, she told reporters that she believes excitement from the Lebanese diaspora about the future of Lebanon "is largely in part, of course, because Hezbollah was defeated by Israel. And we are grateful to our ally, Israel, for defeating Hezbollah.

"But it's also thanks to you, thanks to the Lebanese people. It is thanks to President Aoun and Prime Minister-designate Nawaf Salam, and everyone in this government who is committed to an end of corruption, who is committed to reforms and who are committed to making sure that Hezbollah is not a part of this government in any form, and that Hezbollah remains disarmed and militarily defeated.'

She continued: "That, of course, starts with the pressure that US President Donald Trump is now placing on the Islamic Republic of Iran so that they can no longer fund their terror proxies through the region.'

Ortagus added: "We will be working again to make sure that the Islamic Republic of Iran doesn't achieve a nuclear



weapon and that they are unable to inflict chaos and harm into this country and to so many other countries around the region, which they were allowed to do for decades. That ends with President Trump.

"We're incredibly hopeful that hope comes because we know that we have men and women of character, of resilience, of transparency. The men and women of character in this government will ensure that we start to end corruption. That we end influence from Hezbollah and that we embark on the reforms for Lebanon, that all of you, the people of Lebanon, deserve.

Ortagus said she informed Aoun that "we don't want to look at Lebanon as a donor country. You're a beautiful. sophisticated country that deserves to have the most impressive businessmen and women, the most impressive businesses, companies and country from around the world investing in here. We want to get to Lebanon, back to that place where it is, the place and the hope of the Middle East. And I know we'll get there together.

### **NH-1 Signboards To Feature Urdu Language Alongside English, Hindi**

**SRINAGAR:** The Border Roads Organisation (BRO) has decided to update signboards along the National Highway by incorporating the local language, Urdu, alongside English and Hindi.

This change will be implemented in the upcoming working season to ensure better accessibility for travelers.

Notably, Urdu was one of the official languages of Jammu and Kashmir, recognized alongside Kashmiri, Dogri, Hin-

di, and English. The J&K Official Languages Bill, 2020, passed by the Indian Parliament, granted official status to these languages for administrative and communi-

Currently, the signboards installed in the Area of Responsibility (AoR) of BRO's Project Beacon are written in English and Hindi.

In response to an RTI query, BRO has confirmed that corrections will be made to include Urdu, considering the linguistic demographics of the region.

The decision is part of an effort to improve communication and clarity for all commuters, it

"The inclusion of Urdu aligns with the guidelines of the Indian Roads Congress (IRC:67), which emphasize the importance of bilingual or multilingual road signs for improved safety. By adding Urdu, BRO aims to make road signage more user-friendly for resi-



dents who primarily use the language," it added.

'Future signboards within the jurisdiction of Project Beacon will follow this multilingual approach," it added. "Urdu will be incorporated as a standard language alongside English and Hindi on all newly installed signboards," the BRO said.

This measure is expected to assist local commuters, making directions and road instructions more accessible to a broader section of the population.

BRO has outlined that the necessary corrections will be made in the next working season. The project will ensure that new signboards conform to this policy, helping travelers navigate roads more efficiently. The initiative reflects an effort to enhance road safety and improve ease of travel for local

Itoo assured that all the government schools will receive 100 percent free textbooks prior to reopening of schools after the winter vacations.

"We have book banks in the schools wherein we store the sets of old books. As of now, we have nearly 200 winter tutorial centers in the Kashmir division in which 33,000 are being taught. We have provided them with all those old books," he

The Director further said that the department was examining the recent gaps highlighted in the ASER survey.

"DSEK have constituted a special team in this regard. Besides, an administrative level meeting in this regard was also conducted," he said.

Itoo further said that the directorate will soon submit a comprehensive roadmap to the government to overcome these

### **Hygam Wetland Bustles** With Nearly 3 Lakh **Migratory Birds**

SRINAGAR: The Hygam Wetland in north Kashmir has once again become a haven for migratory birds, with around 3 lakh avian visitors from more than 25 species flocking the area this winter, even as anti-poaching squads are on high alert, officials said.

Wetland serves as a seasonal home to thousands of migratory birds including White Heeled Duck, Shoveller, Red-Crested Pochard, White-Eyed Pochard, Pintail, Mallard, Gadwall, Coot and Graylag. It spans over 7.25 kilometres and has around 1,400 hectares of land and is designated Ramsar site.

The officer concerned with Hygam Wetland, said, "During peak winter, when the water tends to freeze, the movement of birds helps keep some pathways open. However, intervene where necessary to ensure their survival, particularly in terms of food availability."

Approximately 3 lakh migratory birds are there, however, the exact count will be determined and rounded up at the end of the season, he said, adding that the fi-nal figures will be compiled through a detailed field and comprehensive surveys.

Historically, poaching was rampant in the region, posing a severe threat to migratory birds. However, officials have taken strong measures to curb illegal hunting.

"During the tenure of Maharaja Hari Singh, hunting was allowed under a licensing system. However, after the Supreme Court ruling and the enactment of the Wildlife Protection Act in 1972, hunting was completebanned," Mohammad Iqbal Wani, an official said.

To further tighten regulations, the Wildlife Protection Act was amended in 2022, introducing stricter penalties for poaching, Wani said, adding, "Now, even an attempt to hunt birds is treated as a serious offence. The law mandates fines up to Rs 1 lakh and imprisonment of 3 to 7 years for violators."

To enforce the law effectively, the Wildlife Department has established antipoaching squads, comprising members from the Forest Protection Force and Wildlife Department. These teams conduct regular surveillance operations, particularly during peak poaching hoursearly morning and evening. The official said they have carried out several operations/ seizures, and those caught are facing legal action under the Wildlife Protection Act. Despite repeated awareness campaigns, some individuals still believe poaching is permitted. However, strict action is being taken against violators, he added.

Wani claimed that poaching has been reduced by 98%, and a 100% target is in sight. He said the ongoing efforts have vielded significant results. We are now working towards achieving a 100% poachingfree wetland," he added.

The official said they have been conducting awareness drives to educate locals about the legal implications of hunting migratory birds. 'We urge people to mend their ways and respect the law to avoid legal consequences. These birds are a vital part of our ecosystem and must be protected at all costs," he said—(KNO)

### **Kashmir Wetlands Witness Bird Resurgence**

ith subzero temperatures subsiding in the Kashmir valley, wetlands are witnessing a resurgence in migratory bird populations, with authorities preparing for an extensive bird census between February 15 and 20, officials said.

Altaf Hussain, Wildlife Warden Wetlands, Department of Wildlife Protection said that with an improvement in both day and night temperature, the valley wetlands were witnessing resurgence in migratory bird population.

The official said the department is planning a yearly census to propopulation, stating that the guest birds have shown a promising increase over the last two years.

"Currently, our wetlands have a significant bird population, and we anticipate similar numbers to last year," the official said, adding that previous censuses recorded over 12 lakh birds across Kashmir's

Water Regulation Success in Hokersar Wetland The top officer also added that

they achieved a major breakthrough in maintaining the water levels inside the Hokersar wetland, stating that newly constructed water regutained optimal water levels

"These gates ensure water retention, preventing unregulated leakage. As a result, areas that had remained dry for decades are now submerged, naturally reclaiming wetland habitat and deterring encroachment," an official said.

The officer also added that they are also focusing on other key wetlands. like Haigam and Shalbugh, stating that better habitat restoration there was also among the top priorities.

"Siltation and waste accumulation are major challenges. A strategic plan is being developed to mitigate these issues and restore the official said—(KNO)

### **Circular Road Turns Into Garbage Dump At Pulwama**

SRINAGAR: Authorities putting in abeyance under construction solid waste management project here in South Kashmir have turned the Circular Road in the main town into a "garbage dump." Locals said that the Munici-

pal Committee, after collecting the garbage from various areas of the town, throws it on the Circular Road near Government Degree College (GDC) for Women. "This all important road has turned into a garbage dump," they said, adding, "Foul and filthy smell emanating from the garbage has engulfed the entire area. If the dumping continues it can lead to an outbreak of an epidemic.'

"Shopkeepers in the area are suffering losses as people want to stay away from the area where garbage is being dumped," said Zakir Ahmad, a social activist.

He said that the dumping site has made the life of the people residing close to spot hell as they are unable to open their doors and windows.

Javid Ahmad Bhat another local resident said that for the last two years they have been hearing that the site will be shifted soon but till date nothing has been done. "The garbage dumping site has also become a breeding ground for dogs," he added.

"Despite ample space available at multiple locations, the authorities have chosen to dump garbage in a residential area, causing significant inconvenience to the residents," Bhat said. Residents and passersby

stated that, despite repeatedly bringing the issue to the

attention of the concerned authorities, no action has been taken on the ground.

They demanded immediate intervention from the government to relocate the dumping site, emphasizing the difficulty of living under such condi-

### No Breakthrough In **Identifying Cause Of Deaths In Rajouri**

Patients Remain Under Observation, Await Government Nod For Return

**SRINAGAR:** More than two months have passed since the mysterious deaths in Rajouri's Budhal village, yet authorities remain unable to determine the exact cause of the tragedy. Despite extensive investigations, locals are still waiting for answers.

Since December 7, 2024, a total of 17 people-including 13 children—have died from an unidentified illness. While no new cases have been reported in the last 20 days, and all previously admitted patients have recovered, the fear and uncertainty continue to grip the village.

Residents said that while the government's preventive measures have helped contain the

crisis, they remain deeply concerned about the lack of clarity regarding the cause of deaths. They urged authorities to expedite the investigation so that appropriate safety measures can be put in place and normal life can resume without fear.

Expressing frustration over the slow pace of the probe, locals said the issue should have been treated as a health emergency and resolved on priority. "More than 20 days have passed since high-level teams, including an inter-ministerial delegation, visited the area, yet no concrete findings have been shared," they said.

"The recovered patients are currently being kept in hospital observation wards, along with their immediate family members. We expect the final reports from premier health institutes soon, after which the government will take a decision," the official added—(KNO)

### **Navigating Change?**

### Mirwaiz's recent Delhi meetings have reignited political speculation

ver since withdrawal of Kashmir's special constitutional position in August 2019, centre has strictly denied separatist politics a space and a role in Jammu and Kashmir. Mirwaiz Umar Farooq, the head of one faction of the Hurriyat Conference, was too sidelined in the shifting political landscape of Jammu and Kashmir. He has been under a prolonged house arrest, often kept away from delivering his Friday sermons at the Grand Mosque and denied freedom to freely meet people. Yet now, with a series of high-profile meetings in Delhi, murmurs of Centre-Hurriyat dialogue, and his involvement in an interfaith committee for Kashmiri Pandit rehabilitation, Mirwaiz finds

himself back in the news. What does this mean for Kashmir, for New Delhi, and for Mirwaiz himself? There are no clear answers to these questions. Mirwaiz's meeting with BJP MP Jagdambika Pal over the Waqf Bill, his interactions with Kashmiri Pandit representatives, and his heading the interfaith committee do not necessarily signal a shift. Considering Mirwaiz's role has traditionally straddled politics and religion, the recent activities can easily fall within the scope of his religious responsibilities.

Over five years after the withdrawal of Article 370, Kashmir has changed beyond recognition. Once vaunted separatist conglomerate Hurriyat Conference has become extinct. Many of the grouping's top leaders continue to be in jail or are under house arrest. This has hobbled its capacity to organize any political activity.

But even if the separatist leaders were free - and some of them are free - the situation would hardly be different. The government has outlawed any sign of separatist activity in whatever form and disproportionately raised the costs for any leader or an activist to go out and champion the cause.

Similarly, while Pakistan may not have reconciled to the constitutional changes in Kashmir, it has now kind of gotten used to the new state of affairs in the region. Its protestations about India's actions in Kashmir haven't found adequate traction across the world. In fact, the US and Europe, which largely influence world opinion, have been barely responsive - their attention is now centered on the ongoing war in Ukraine.

What does the future hold for Kashmir? The probability is that it will be more of the same. Even if the BJP loses power in the future, the Article 370 move remains a fait accompli. Although militancy has persisted in some form, it hasn't affected the drift of normalcy that has by and large prevailed.

Hurriyat-centre dialogue has had a chequered past. Although the two have interacted frequently in the past, nothing was ever achieved.

This is because the expectation of both the parties from the talks have been a polar opposite of each other. The Centre wants Hurriyat to join the national mainstream and play a role as a mainstream political party, but Hurriyat has long fought for the resolution of the Kashmir issue.

After the abrogation of Article 370, New Delhi no longer wants to engage with either Pakistan or any local entity in J&K over the resolution of what is seen as the Kashmir issue. It has also by and large successfully overcome the political and armed separatist campaign within the union territory. This has transformed the situation, and, in a sense, rendering not just India-Pakistan dialogue redundant but the Centre-Hurriyat engagement too. More so, the latter. Only discussion that appears to have been left to pursue between the two is if and when Hurriyat joins the mainstream.

Is that possible? On the face of it, such a prospect seems highly improbable. At the same time, it is also true that the separatist politico-religious outfit Jamaat-i-Islami, or a faction of it, did join the political mainstream last year and unsuccessfully fought Assembly elections. This was a turn of events that once seemed unthinkable. But even with Jamaat precedent behind us, Hurriyat following suit may not be as easy. Not just for ideological reasons, which are currently challenged by a dramatically transformed context, but also for the reasons of survival. Once cut off from its ideological moorings, Hurriyat would in all likelihood shrink into yet another mainstream party, more or less like yet another Apni Party, with no political future, as was amply demonstrated by the last year's Assembly polls where even cadre-based Jamaat sank without a trace. While Hurriyat has the option to die as an organization, it has none to adapt to the altered situation. This makes it a tricky situation for the grouping to deal with. For now, everything is in the world of speculation. Mirwaiz has a prominent religious role in the Valley and his current activities are in line with that. As for his politics, the coming weeks and months will make things clearer.

### India Cheered Trump's Return. Now It's Worried

India has already offered a concession by agreeing to work with the White House to take back its undocumented workers, despite the political embarrassment the government will face back home.

ven as recently as November, when the US election outcome was clear, the mood in India was optimistic. The Hindu right wing, which supplies Prime Minister Narendra Modi with some of his most ardent supporters, held religious ceremonies to celebrate Donald Trump's win. Many in the analyst community cheered from the sidelines, expecting India to be a net beneficiary of new tariffs of 60 per cent on all Chinese exports to the US, which is what the president had promised during his campaign.

India's challenge around the time of the vote was largely domestic: Cost-of-living pressures, especially high food prices, were taking a toll on urban consumption. Growth was slowing rapidly; yet stubborn inflation was delaying monetary stimulus. As I wrote back then, the bigger headache for Indian authorities was tomatoes, not Trump.

While the domestic slowdown is still the biggest headache for policymakers, the drum beats of Trump's trade war are no longer so distant. From even before his return as president, there has been some unease around how the relationship between Trump and Modi will evolve. Their personal bonhomie was at its peak five years ago, with Trump showing up for the "Howdy Modi" extravaganza in Houston, and Modi returning the favor with a "Namaste Trump" spectacle in his home state of Gujarat a few months later. But this time around, there was a palpable lack of enthusiasm — from Trump's side.

And it was noticed in India. Rahul Gandhi, the main opposition leader, said in parliament that S Jaishankar, the Indian foreign minister, had been sent to the US to secure an invitation for Modi to Trump's swearing-in ceremony. Jaishankar accused Gandhi of spreading a deliberate falsehood. "At no stage was an invitation (for) the prime minister discussed," he said in a post on X, the social-media platform.

Aside from the political point-scoring, what is true, however, is that even before Trump's Jan. 20 inauguration, jitters about the US-India relationship had begun to replace complacency, with first signs of trouble showing up not in trade but immigration. The Make America



Great Again camp split down the middle on the issue of H-1B visas, which allow Indian-born software professionals to live and work in the US pending permanent residency. Outsourcing firms from Bengaluru, India's Silicon Valley, compete furiously for these visas for their employees to serve their biggest market.

The sense of foreboding worsened when, soon after moving into the White House, the new president passed a Birthright Citizenship Order, which has been temporarily blocked by a federal judge. It denies US citizenship for children born to parents who aren't permanent residents: Techies on H-1B visas can take years — sometimes decades — to obtain their so-called green cards. Many young Indian couples in the US opted for pre-term deliveries to beat the Feb. 20 deadline in Trump's order.

This is just the white-collar angst. At the other end of the immigration spectrum are undocumented workers. Between 2019 and 2022, Indians were the third-largest group to enter the US illegally, often via the risky "donkey" route of border crossing. The fact that Trump sent back an estimated 104 of them in a military plane before Modi could have a chance to meet

him during a much-anticipated visit to Washington shows that the US president wants to negotiate from a position of strength.

India has already offered a concession by agreeing to work with the White House to take back its undocumented workers, despite the political embarrassment the government will face back home. Every incoming flight of deportees would shine a spotlight on the Modi administration's record of employment creation: Why are so many Indians desperate to leave the world's fastest-growing major economy? Don't they have jobs at home?

That's just one of the aces the US president holds as he looks to play trade and immigration policy cards to bargain for greater access for the likes of Walmart Inc. to the Indian market. The Modi government is already striking a conciliatory tone: Its annual budget on Saturday cut import tariffs on many products. Additionally, it could offer to limit imports of crude oil from Russia, which the US has sanctioned for its invasion of Ukraine. It might even set aside national-security concerns — and ignore vehement opposition from local telcos — to allow Elon Musk's Starlink Inc. and Amazon.com Inc.

to offer satellite broadband services in the most-populous nation.

New Delhi might want a few things in return, like a mothballing of the US Justice Department's bribery charges against Indian infrastructure tycoon Gautam Adani, a prominent Modi ally. Separately, it would hope that Washington would not push it any further on allegations of organizing a conspiracy to murder an American citizen on US soil. (India has said it's recommended legal action against an individual it believes is involved in the plot.)

Trouble is, nobody can predict if the concessions currently on the table will be enough, or whether the White House will ask for more. After all, were Trump to pick his adversaries by how much they contributed to the US trade deficit, Asia's old and new export powerhouses — China, Vietnam, Taiwan, Japan, and South

— China, Vietnam, Taiwan, Japan, and South Korea — would all be juicer targets than a far more inwardly focused economy like India.

It's that navel-gazing approach to trade, and the favoring of domestic corporate interests over foreign players, that has put a target on India's back. The budget, which has finally started to walk back several years of increases in import duties, is a sign that fear of Trump reigns supreme. "We are signaling that India is not a tariff king," Finance Secretary Tuhin Kanta Pandey told Bloomberg News in an interview Sunday, trying to shake off the label that the new US president has used to describe the country in the past. "We are indicating that we are a competitive economy and we are open for business."

Even as the world's largest economy lurches toward Trump's "America First" brand of protectionism, it's making smaller economies open up. That may not be a bad thing altogether. As a businessman who just lost his startup to bankruptcy told me in Mumbai, anybody can float an enterprise in India, though only a half dozen or so local conglomerates have the wherewithal to keep it afloat amid bureaucratic red tape. That lock may be about to open. Fear — of Trump — is the key.

### My Love Affair with Radio

icture this—it's a little past 3 PM, and the day is crisp, the kind of crisp that makes the air feel alive, carrying with it the faint scent of earth and smoke. The kitchen is kutcha, its walls painted with the earthy aroma of muddy water, a scent that feels ancient, grounding, as if the very soil has seeped into the room. My mother sits in the corner, her hands moving rhythmically, kneading flour into a soft, pliable mound. Few doughs rest on a plate dusted with flour that keeps it from clinging to the surface. In the corner, the Daanbur—a traditional stove—crackles and hums, its flames dancing like mischievous spirits, leaping and twirling, playing a game only they understand. The twigs and wood snap and hiss, their burning scent mingling with the earthy air, creating a symphony of warmth and nostalgia. The firelight flickers, casting golden shadows on the walls, painting the room in hues of amber and ochre. The ghee would glisten and melt in a small cup, fondly called chin pyalie, perched delicately on a pan resting atop the Daanbur, the traditional stove that crackled with life. The flames danced beneath, their warmth infusing the air with a comforting, buttery aroma that seemed to wrap the kitchen in a golden embrace. But what truly brought the household to life was the radio—a steadfast companion in every home, its voice echoing from the crack of dawn until the stars claimed the night. It was the heartbeat of the home, a constant hum of news, music, and stories that wove itself into the fabric of daily life.

I was just a child then, sitting cross-legged on the floor, sharing breakfast with my parents and grandparents. The radio would blare its morning messages, and I, too young to understand, would tilt my head in confusion. The women's voices, melodic yet foreign, would chant, "Subhuk Payaam soanie, shireen kalaam soanie, bouziv ti shaad roziv, Shireen kalaam soanie.payaam- e subahi' " To my innocent ears, it sounded like some mysterious Ladakhi incantation, a language of enchantment that I

couldn't decipher. Among the three treasures of my childhood-the Daanbur, the chini pyalie, and the Radio-none have survived the relentless march of time. They have faded into the annals of memory, relics of a bygone era that once defined the rhythm of our lives. Of these, the radio held a special place in my heart. I was utterly captivated by its magic, its ability to conjure voices and melodies from thin air. My grandfather, a man of simple pleasures, owned a small radio that he kept in an empty tea bag a peculiar, sack-like pouch with the imprint of tea leaves on its fabric. It hung delicately to a nail in our old house, a humble vessel for something so extraordinary still remember the day my grandfather rummaged through that bag, his hands pulling out forgotten treasures. Among them was a watch, heavy and archaic, its weight surprising in my small hands. He told me it needed to be wound with a key to come alive, a notion that, at the time, failed to amuse my youthful curiosity. But then, he revealed the radio—a sleek, black device, elegantly designed, its surface gleaming with a quiet sophistication. It was beautiful, almost regal, and I was instantly mesmerized. From that moment, I harbored a dream, a burning desire to possess that radio at any cost. It wasn't just an object to me; it was a portal to a world of stories, songs, and voices that felt both intimate and infinite. The radio symbolized something greater—a connection to my grandfather, to the past, and to the simple joys that once filled our home. Even now, as I think back, the image of that black radio lingers in my mind, an evidence to a time when life moved slower, and the smallest things held the greatest magic.But alas, I never mustered the courage to ask him for that radio. It wasn't fear that held me back, but a strange. unspoken reverence—a sense that some treasures were meant to remain where they were, untouched, as if asking for it would somehow break the spell it held over me. So, I contented myself with listening, absorbing every word, every note that spilled from its speakers. I became a devoted follower of its programs, my young mind meticulously memorizing the schedule-knowing exactly which show would air and when. I would sit for hours, lost in the cadence of the poetry, the rise and fall of the singer's voice, the delicate strumming of the sitar or the harmonium in the background. It was more than just music: it was an experience, a journey into the heart of something intense. Those moments by the radio were pure magic. Even now, the thought of it brings a bittersweet ache—a longing for those simpler days, for the sound of my grandfather's

The excitement of participants answering questions, the tension in the air, and the joy of learning something new made it a favourite in every household

For women, there was "Bazm-e-Niswa", a platform where voices often unheard found their space. Women from all walks of life would share their stories, their struggles, and their triumphs, creating a tapestry of experiences that felt both personal and universal. And then there were programs for children, where young voices giggled, sang, and recited poetry, filling the air with innocence and hope.

Ah, "Hello Aapki Farmayish"—a program that wasn't just a show, but a celebration of connection, music, and the sheer joy of being heard. It was a jope for countless listeners, a space where dreams met reality, even if only for a few precious minutes. Anchored by the ever-graceful RJ Sakeena, the program was a symphony of voices, laughter, and melodies, a tapestry woven with the threads of countless hearts yearning to be part of something magical.

The program was a masterclass in community building, a space where the wisdom of the past met the innovations of the present. ### 'Sleep Disorders Highly Individual In Nature, Ai Essential For Diagnosing'

rtificial intelligence will be essential for diagnosing sleep disorders such as sleep apnoea or insomnia, which are increasingly acquiring an individual character, neurologist Dr Manvir Bhatia said.

Further, once diagnosed, are we able to say that a certain individual will be a good user of the treatment or not? That's where the role of AI is really going to come up, said Dr Bhatia, the vice-president of Indian Society for Sleep Research.

She was addressing a workshop conducted at the All India Institute of Medical Sciences (AIIMS), New Delhi, ahead of the 11th Congress of Asian Sleep Research Society that will be held here during February 8-9.

Obstructive sleep apnoea is a common disorder, estimated to affect about a billion worldwide. Muscles in the throat narrow the airways, thereby affecting one's breathing and blood oxygen levels.

A 2023 study by the AIIMS estimated that 104 million Indians of working age suffer from obstructive sleep apnoea, of whom nearly 50 per cent have it moderate or severe.

First line of treatment usually includes PAP or 'positive airway pressure', in which pressured air is delivered to the patient via a mask to

keep the upper airway open, thereby preventing 'apnoea' or breaks in breathing.

"It's ok that the technology will be to say about the usage of PAP. But are we able to say that a certain individual will be a good user of the treatment or not, similar to how we are now able to predict one's risk of having a stroke or a cardiac event? That's where the role of AI is really going to come up -- in predicting one's PAP compliance," said Dr Bhatia, who runs Neurology and Sleep Centre in New Delhi.

While sleep has been studied extensively over the years,

the focus has largely been on AHI (apnoea-hypopnoea index) and sleep stages because the human eye could see only so much, according to the neurologist. AHI measures how often one's breathing stops or slows down.

She added that as sleep technology becomes more compact and sophisticated, and the recorded information more granular and voluminous, artificial intelligence will be almost indispensable for analysing the data.

"There's no way that the human mind can analyse all this data," the neurologist said.

"Sleep disorders are very

heterogenous in nature, be it sleep apnoea or insomnia -- there must be something that we are missing. It's never one treatment or diagnostic method that fits all and that's why, we definitely need to incorporate AI into sleep medicine," she said.

Dr Bhatia also acknowledged the resistance of medical doctors in turning away from how sleep studies have been traditionally conducted towards newer technologies.

A traditional sleep study or a polysomnography uses wires and sensors attached to a participant to measure physiological activity, including

inf

brain waves, breathing and heart rates, and oxygen levels during sleep.

However, polysomnography is expensive and "technology, technique, and techniciandependent", Dr Bhatia said.

Further, the sensors on the body can interfere and "if you're trying to assess someone's sleep, are we really doing a good job?", she added.

Home sleep testing devices, including patches, therefore, can be comfortable, convenient and less tech-heavy, Dr Bhatia said.

She also pointed out that consumer wearable technologies, including smartwatches, are increasingly highlighting the importance of sleep, even though data may not be accurate.

"People are becoming very conscious. The devices are creating an awareness that sleep is important," Dr Bhatia said.

However, she cautioned these wearable devices are different from those used for medically diagnosing sleep disorders. She also advised taking an "overall, temporal" view of the information provided by wearables, rather than diving deep into a "night-by-night" analysis.

"Sleep apnoea is a highly prevalent condition, with serious comorbidities and consequences. No way are we going to be able to diagnose so many people using traditional systems, even though they will continue to have a place," Dr Bhatia said in conclusion.

### **'Exposure To Air Pollution Can Affect One's Cognition, Daily Task Performance'**

he short-term exposure to air pollution can cloud one's judgment, affecting emotional intelligence and focus and potentially making routine activities more challenging, according to a new study.

Researchers, including

zheimer's and dementia. where cognition and memory are affected.

The long-term exposure to PM2.5 air pollution has also been linked with poor learning and memory among children.

However, the study, published in the Nature Communications journal, showed that "even shortterm exposure to particu-



those from the University of Birmingham, UK, compared the performance of 26 adults divided into two groups — one exposed to high levels of air pollution, using candle smoke, and the other to clean air.

The team found that brief exposure to high levels of particulate matter (PM) pollution could affect the participants' higherorder cognitive functions, including self-control and sustained attention, which are critical for work and other aspects of life.

Air pollution has been studied as a major risk factor for neurological diseases, including

late matter can have immediate negative effects on brain functions essential for daily activities, such as doing the weekly supermarket shop," co-author Thomas Faherty from the University of Birmingham said.

For the study, the cognitive abilities of the participants, including attention and emotion recognition, were tested before exposure to polluted air and four hours after.

"Results showed significant reductions in selective attention and emotion expression discrimination after enhanced PM exposure versus clean air exposure," the authors wrote.

**NEW DELHI:** Real estate developers hailed the RBI's decision to cut the benchmark lending rate by 25 basis points, saying this will benefit existing home loan borrowers and also encourage the fence sitters to invest in residential properties.

Realtors' apex body CREDAI feels that the RBI's decision might have a "limited direct impact" on the sector and made a case for further reduction for "stronger impetus" to

Another leading association Naredco said the RBI's move to slash the repo rate by 25 basis points to 6.25% could lead to lowering of interest rates on home loans, which in turn will boost housing sales.

CREDAI National President Boman Irani said, "The RBI's decision to reduce the repo rate supplements recent announcements in the budget aimed at boosting spending and spurring economic growth.'

"While the current cut may have a limited direct impact, we anticipate that a further rate cut in the next MPC (monetary policy committee) meeting will provide stronger impetus to overall demand, accelerating housing sales, particularly in the mid-income and affordable segments," Irani observed.

Naredco national president G. Hari Babu said the rate cut will have a positive impact on the

real estate sector, making home loans more affordable and increasing demand for housing.

'With lower interest rates, we expect to see increased sales, improved liquidity, and a reduction in the inventory of unsold homes. This, in turn, will encourage developers to launch new projects," he added.

Domnic Romell, President of CREDAI-MCHI, said the rate cut, combined with the increase in the income tax exemption limit to ₹12 lakh, creates an environment that encourages consumer spending and home ownership.

Prashant Sharma, president of Naredco-Maharashtra, expected banks to ensure swift transmission of the reduced rates.

Among developers, Tata Realty and Infrastructure MD and CEO Sanjay Dutt said, the RBI's decision would make home loans more affordable, thus easing the financial burden on aspiring homeowners.



"So, this is an ongoing process. We want to make India a lot more investor-friendly, trade friendly, and at the same time, balance it with Aatmanibhar Bharat where we need to have production, particularly through the MSMEs. We will provide the tariff protection as required by the industry," the Finance Minister, who presented her eighth straight Budget on February 1, said.

In her Budget speech, Sitharaman had announced rationalisation of customs tariff structure for industrial goods. As part of comprehensive

### No Level For Rupee In Mind, **Market Forces Decides Forex Rate: RBI Guv**

NEW DELHI- Reserve Bank Governor Sanjay Malhotra on Saturday said that the market forces decide the value of rupee with respect to the US dollar and the central bank is not worried about day-to-day movement of the currency

Addressing the media after the meeting of Finance Minister Nirmala Sitharaman with the Reserve Bank board, Malhotra said that the central bank focuses on the value of the rupee in the medium to long term.

"There is no change in RBI's approach. It does not look at any price level or band. It is our endeavour to curb excessive volatility. We should not be looking at daily movement or exchange rate," he said in reply to a query on the rupee depreciation.

On the impact of the depreciation of the rupee against the US dollar on price rise, he said 5 per cent depreciation impacts domestic inflation to the extent of 30-35 bps.

He further said that RBI took

on board the current rupee-dollar rate while working out the growth and inflation projections for the next financial year.

The rupee recovered 9 paise from its all-time low level to close at 87.50 against the US dollar on Friday after the Reserve Bank of India reduced the key policy rate by 25 basis points in line with street expectations.

The Governor also said most of the depreciation in the Indian currency is driven by the uncertainties which have



come up because the global issues and especially, the tariffrelated announcements by US President Donald Trump.

### **New Income Tax Law Explainer: No New Taxes, Simple Read For Common Man**

NEW DELHI: The new Income Tax Bill, which will replace the six-decade old Income Tax Act of 1961, will make direct tax laws simple to understand, remove ambiguities and reduce litigations.

The law, which is expected to be tabled in Parliament in the Budget session, will go to the Standing Committee on Finance for further scrutiny, Finance Minister Nirmala Sitharaman has said.

Finance Secretary Tuhin Kanta Pandey has already indicated that the new Bill will not have provisos and explanations or long sentences. It will be tax neutral.

Following is an explainer of what the government intends to do and what can the new law hold for taxpayers: Q. Why is a review of the I-T Act needed?

A. Income tax law was enacted about 60 years ago in 1961 and since then a lot of changes have taken place in the society, in the way people earn money and companies do business. The 1961 Act was framed at a time when Indian republic was young and faced challenges peculiar to those times. Over the time, as the country progressed, the Income Tax Act was amended to keep pace with changing times. Presently, technology has changed the way people pay taxes and file return of income. There is also a system where ITR forms are prefilled based on data available to the tax department from various other sources, like TDS statement filed by banks, employers, forex dealers and at the time of property trans-



advancement and changes in the socio-economic fabric of the country, there is a pressing need to completely overhaul the archaic Income Tax Act which has become bulky on account of hundreds of amendments in the law. It was become almost impossible for the common man to comprehend the law and multiple references to different sections, sub-sections, and provisos.

Q. What did the Finance Minister announce?

A. Finance Minister Nirmala Sitharaman in her Budget speech on July 23, 2024, had announced a comprehensive review of the Income Tax Act, 1961, within six months. The purpose of the review is to make the Act concise, lucid, easy to read and understand, Sitharaman had said in her July 2024 budget speech. This will reduce disputes and litigations, thereby providing tax certainty to the taxpayers. It will also bring down the demand embroiled in litigation, she had said.

In her 2025-26 Budget speech on February 1, 2025, she announced that the Bill will be introduced in Parliament in the ongoing Budget session.

Q. What the new Income Tax Act proposes to do?

A. The new law is expectd to be leaner and reader-friendly, which even a common man could comprehend. The intention of the government is to halve the volume and make the language simpler so that taxpaver can know his exact tax liability. It would also help in reducing litigations and thereby cut down on disputed tax demands.

O. How will the new law will be leaner?

A. The Income Tax Act, 1961, deals with imposition of direct taxes — personal I-T, corporate tax, securities transaction tax, besides gift and wealth tax. The Act currently has about 298 sections and 23 chapters. Over the time, the government has abolished various levies including wealth tax, gift tax, fringe benefit tax and banking cash transaction tax.

### **States Demanding Funds In Proportion To Taxes They Contribute** Is 'Petty Thinking': Goyal

**MUMBAI:** Commerce Minister Piyush Goyal on Saturday said the demand by some states that they should get central funds in proportion to their contribution of taxes to the central kitty was "petty thinking" and "unfortunate." Prime Minister Narendra

Modi is of the view that if the country is to prosper, the eight states of the Northeast and eastern Indian states like Bihar, West Bengal, Odisha and Iharkhand must develop, he said.

The BJP leader was speaking at the `Rashtriya Ekatmata Yatra 2025', an event organised here by the Akhil Bharatiya Vidyarthi Parishad (ABVP) and the Students Experience in Inter-State Living (SEIL)' initiative.

In the last 11 years, the Modi government's "laser focus", like that of Arjuna of the Mahabharata, was on the Northeast and eastern states, the minister added.

"It is unfortunate that some states and some leaders...I don't want to politicise it but some leaders from Maharashtra used to say....leaders of the earlier government which was there for two and a half years, they used to calculate the tax paid by Mumbai and Maharashtra and (demand) it should get back that much amount (of central funds)," said Goyal, MP from Mumbai North.



He was apparently referring to the Uddhav Thackeray-led Maha Vikas Aghadi government.

"There are some states like arnataka, Tamil Nadu, Telangana which say they should get back the amount of taxes they have paid. There can't be any (greater) petty thinking ("chhoti soch") than this. There can not be anything (more) unfortunate than this." he said.

But there was no need to worry now as the present BJPled government in Maharashtra is very sensitive towards Northeast India, the minister added. The Modi government, for

the last 11 years, has been following "Act East" and "Look East" policy, prioritising Northeast India, said Goyal. Under the Modi government,

the capitals of the northeastern states are being connected by railway and a network of highways is being built, he said.

PM Modi has visited the Northeast more than 65 times. he noted, and urged the people to visit the region at least once to see its beauty and culture.

### **Pakistan Requests China To** Reschedule USD 3.4 Billion Debt

ISLAMABAD: Pakistan has requested China to reschedule USD 3.4 billion debt for two years to bridge a foreign funding gap identified by the International Monetary Fund, according to a media report on Saturday.

This is the second time in the past five months that Islamabad has requested Beijing to reschedule loans provided by its Exim bank.

Deputy Prime Minister Ishaq Dar made the formal request during this week's visit to Beijing, The Express Tribune newspaper reported, quoting govern-

ment sources. Pakistan requested the Export-Import (Exim) Bank of China to consider rearrangement of its loans due from October 2024 to September 2027, said the government officials.

A two-year extension was sought to repay the official and guaranteed debt obtained from the Exim Bank. Pakistan would

keep making interest payments. Sources said that Pakistan was required to identify financing sources to fill the external financing gap of USD 5 billion for the three-year programme period.

They added the Chinese authorities were positive and that Beijing would hopefully accept the request to lessen Pakistan's external funding woes.

Earlier, in September last year, the Finance Minister wrote to the Exim Bank, requesting the rescheduling.

According to a joint China-Pakistan statement issued on Thursday, the Pakistani side reiterated its high appreciation for China's valuable support for its fiscal and financial stability. The statement was issued after President Asif Ali Zardari's state visit to Beijing.

The USD 3.4 billion debt was maturing between October 2024 and September 2027, which coincided with the three-year IMF programme period. According to the sources, the bank has given two types of loans, direct lending and guaranteed lending to State-Owned Enterprises (SOEs).

The rescheduling is said to be critical for Pakistan and is part of the overall USD 5 billion external financing plan that Islamabad has to implement to bridge the gap identified by the IMF at the time of the bailout package's signing in September last year.

# **Kashmir Orchardists Warned As Govt Finds Pesticides Misbranded**

Srinagar: The government of Jammu and Kashmir has warned orchardists after two commonly used pesticides were found to be misbranded in consecutive quality control tests, leading authorities to seize these products from the market.

On Wednesday, the Agriculture Department's Quality Control Laboratory declared Indofil M-45, a commonly used pesticide for apple orchards, as misbranded. This pesticide, which contains Mancozeb 75% WP as its active ingredient, was produced by Indofil Industries Limited on December 13, 2024, and has an expiry date of December 12, 2026.

A day later, the department identified another pesticide, CAPTAF, which contains 50% WP Captan, as misbranded. Manufactured by Rallis India Ltd. on November 4, 2024, it has an expiry date of November 3, 2026, and the product was also ordered for seizure.

Deputy Director of Law Enforcement Feroz Ahmad Shapoo instructed field officers to stop selling and confiscate all stocks of misbranded pesticides in accordance with the Insecticides Act of 1968.

As the horticulture season in Kashmir begins next month, farmers are expressing concerns about the quality control of pesticides. This region contributes nearly 70% of India's total apple production, generating an annual revenue of approximately 26-27 crore, making effective pesticide use crucial.

However, orchardists believe that the government's response to these concerns is inadequate compared to the support provided to farmers in states like Himachal Pradesh and in some European countries.

"The government collects



pesticide samples in April, but it takes almost a year to get the results back. What should take 10 to 15 days ends up taking months, leaving farmers exposed to ineffective pesticides," said Abdul Rehman Dar, General Secretary of the Fruit Growers Association in Ganderbal.

Farmers usually start pesticide spraying between March 1 and March 20, depending on the temperature. The use of substandard pesticides can have devastating effects on crops. As Dar explained, "Just as giving the wrong medicine to a human can lead to complications, using ineffective pesticides can cause irreparable damage to plants. Diseases such as scab and Alternaria cannot be cured if ineffective pesticides are applied."

Another challenge he pointed out is the lack of awareness among farmers. "Not every farmer is literate; some can't even read the label to understand what type of pesticide they are using," Dar emphasized, highlighting the need for stricter regulations and improved education initiatives.

"Misbranded refers to pesticides that contain a lower quantity of active ingredients, making them ineffective for controlling diseases. Therefore, farmers are advised not to use such products,"

Shapoo stated in an interview with a local news outlet.

According to the Insecticides Act of 1968, a pesticide is considered misbranded if it has misleading or incomplete labelling, exhibits toxicity levels exceeding prescribed limits, or does not match the claimed chemical composition.

Farmers are now urging authorities to expand testing to include other pesticide brands in order to ensure product quality and prevent economic losses.

"Our government must take this matter seriously. Farmers rely on these pesticides to protect their crops, and using ineffective products jeopardizes their livelihoods," Dar said.

"This year, we have accomplished a significant amount. We have seized approximately 31.105 metric tons and 6,442.75 Liters of pesticides, as well as 196 metric tons of fertilizers from various companies in Kashmir." Shapoo stated, "This process will continue, and the Honourable Minister of Agriculture in J&K has also created a task force to address these issues."

As enforcement officers continue to seize misbranded pesticide stocks, orchardists hope the government will take stronger measures to prevent such products from entering the market.

enhancing connectivity to Ladakh and improving military logistics in the region.

Abdul Rashid Lone, who works at Zojila Pass, emphasized the dedication of his team in maintaining the route. "So far this winter, Zojila has only been closed for a few days," he stated. "Our team begins work at 5:30 a.m. to monitor road conditions, particularly in areas prone to avalanches. The team is led by the junior engineer (JE). We are working tirelessly with snow cutters and JCB machines. Operating in such freezing conditions is extremely challenging."

He also highlighted the ongoing significance of the pass, even after the Zojila Tunnel is operational. "This road will continue to be necessary and provide its own advantages," he

Fayaz Ahmad Mir, who has been involved in clearance operations for over 20 years, highlighted the ongoing challenges faced by workers. We follow proper drills and use a set of advanced machines to manage operations. The strong winds and avalanche risks make this work even more critical. While the Zojila Tunnel will bring benefits, it is essential to keep this pass operational."

Chief Engineer Chirag Ghuru emphasized the importance of this achievement, stating, "Zojila is the only pass connecting Kashmir to Ladakh. It is essential for both civil administration and military operations, so our goal is to keep it open for as long as possible."

He also shared historical context regarding previous closures. "In 2015-16, it was closed for two to four months. Last year, it was closed for 30 days. This year, however, it has remained open so far, and we are hopeful it will stay open for a longer period," he explained.

He also highlighted the advantages of the Sonamarg Tunnel in improving travel and maintenance operations. "It will make the Amarnath Yatra more comfortable by reducing the need for extensive snow clearance," he explained. ### **BJP Sweeps AAP**

43.57 per cent votes and the Congress's poll percentage was 6.34.

In the 2020 Delhi Assembly polls, the Aam Aadmi Party (AAP) got a 53.57-per cent vote share and bagged 62 seats. Despite a 38.51-per cent vote share, the BJP could win just eight of the 70 seats.

In the 1993 Assembly polls, the BJP won 49 seats in Delhi, while the Congress got 14 and the Janata Dal four. Three independent candidates had also secured victories in that election.

The BJP will form its "double-engine" government in the capital as there is a party-led government at the Centre.

BJP's Parvesh Verma and Tarvinder Singh Marwah emerged as the biggest giant-slayers, defeating AAP chief Arvind Kejriwal and former deputy chief minister Manish Sisodia from the New Delhi and Jangpura constituencies respectively.

In a fierce contest in the New Delhi seat, Verma secured 30,088 votes, while Kejriwal trailed behind with 25,999 votes. Congress's Sandeep Dikshit finished a distant third with 4,568 votes.

In another major upset, Marwah defeated Sisodia from Jangpura by a narrow margin of 675 votes. Marwah polled 38,859 votes, while Sisodia secured 38,184 votes. Congress candidate Farhad Suri garnered 7,350 votes.

Amid the BJP's sweeping victory, Chief Minister Atishi and three ministers in the outgoing AAP government -- Gopal Rai, Mukesh Ahlawat and Imran Hussain -- managed to secure wins.

cure wins.

Atishi emerged victorious in Kalkaji, defeating BJP's Ramesh Bidhuri by a margin of 3,521 votes. Rai retained the Babarpur seat with a margin of 18,994 votes against BJP's Anil Kumar Vashisht.

Hussain, the food and civil supplies minister, won from Ballimaran with the highest margin among the AAP's prominent faces, defeating BJP's Kamal Bagri by 29,823 votes. Hussain's victory provided one of the few bright spots for the AAP in the Old Delhi region.

Outgoing health minister Saurabh Bharadwaj was defeated by BJP's Shikha Roy by a margin of 3,188 votes from Greater Kailash.

BJP's Mohan Singh Bisht won the Mustafabad seat by 17,578 votes, while his colleague Kapil Mishra secured victory in Karawal Nagar with a margin of 23,355 votes. AAP's Sanjeev Jha won the Burari seat by a margin of 20,601 votes.

BJP leader Raj Kumar Chauhan, who shifted to the saffron party from the Congress, bagged the Mangol Puri seat by a victory margin of 6,255 votes.

AAP's Virender Singh Kadian won the Delhi Cantonment seat by 2,029 votes, while his party colleague Kuldeep Kumar defeated his closest rival by a margin of 6,293 votes in Kondli

BJP's Ravinder Singh Negi won the Patparganj seat by a margin of 28,072 votes, defeating poll debutant Avadh Ojha, who was fielded by the AAP after replacing Sisodia, who had represented the seat in the Assembly for three consecutive terms.

AAP's Sahi Ram won the Tughlakabad seat by 14,711 votes. Ahlawat won from Sultanpur Majra by 17,126 votes, while AAP's Jarnail Singh secured victory from Tilak Nagar by a margin of 11,656 votes.

BJP's Rekha Gupta won the Shalimar Bagh seat, defeating her AAP rival by 29,595 votes, while the saffron party's Manjinder Singh Sirsa emerged victorious from Rajouri Garden by 18,190 votes.

While the AAP dominated Delhi's political landscape for the last 10 years, the BJP was out of power in the city since 1998.

The Congress, which ruled the capital from

1998 to 2013 and was hoping for a resurgence, finished third.

# 2nd ODI: Rohit, Kohli In Focus As India Eye Series Win Over England

CUTTACK: The barren run of skipper Rohit Sharma and the selection conundrum that a fitagain Virat Kohli's return poses are the towering obstacles in India's quest for a series win against England in the second ODI here on Sunday.

India had taken a 1-0 lead after their four-wicket win at Nagpur and there was good news for the fans as batting coach Sitanshu Kotak confirmed that Virat Kohli is "completely fit and good to go" for Sunday's game.

India's batting megastar was in fact first to enter the nets during the optional session on Saturday evening and batted close to an hour with no apparent signs of discomfort. Kohli was ruled out of the first game due to sore right knee.

The vice-captain Shubman Gill had indicated after the opening game that Kohli could be back for the second match, which will be played at a venue



where the latter made a matchwinning 85 against the West Indies in 2019. The Indian team will certainly welcome that sign, but it also raises a challenge in terms of selection.

Combination questions apart, Kohli too is in need of runs, and

he will need a good outing here if he indeed makes a return.

Kohli's form has been under scrutiny in recent months, especially after his struggles in Australia, where he repeatedly nicked deliveries to the slip cordon or wicketkeeper

His last competitive outing for Delhi in the Ranji Trophytoo was a low-yielding one, managing just six before getting bowled by Railways pacer Himanshu Sangwan.

But One-day cricket is Kohli's staple format, and the 36-yearold needs just 94 runs to become the third batter to reach 14,000 runs in the format after Sachin Tendulkar (18,426) and Kumar Sangakkara (14,234).

Having played 283 ODI innings, Kohli can also become the fastest to this milestone ahead of Tendulkar (350 innings) and Sangakkara (378).

#### **Rohit's Lean Run**

Rohit's struggles continued as he perished for just two in the first ODI, failing to shake off the disastrous run in the Test series against Australia.

His dismissal -- a mis-timed lofted shot off Liam Livingstone that ballooned to midwicket -reflected his desperation for runs.

The Mumbai man has not scored a fifty in any format since August last year when he made 64 against Sri Lanka in Colombo in the third match.

If Rohit fails to get going in these two ODIs against England, it could raise deeper concerns about his form and future.
