Colleges In Kashmir To Reopen Today

Srinagar: Colleges in the Kashmir Valley are set to resume academic activities on Saturday after a 50-day winter vacation.

The Jammu and Kashmir Higher Education Department announced the winter break on December 20, 2024, for degree colleges in the winter zones of the Kashmir division. According to the official notification, degree colleges in the Kashmir division and those in the winter zone of the Jammu division observed winter vacations from December 27, 2024, to February 14, 2025.

Additionally, the government had declared a winter break for colleges in the summer zones of the Jammu region from January 1 to January 10, 2025.

Meanwhile, more than 2 lakh students of the 10th and 12th standards are set to appear in the annual regular board exams starting tomorrow.

Schools in the Kashmir division and the winter zones of the Jammu division will reopen on March 1. According to the School Education Department, winter vacations were scheduled in phases: for students up to the 5th standard, | More on P10





'Depression Could Hasten Pace Of Developing Physical Conditions By Over 30%

dults with depression could develop chronic conditions, such as osteoarthritis and hypertension, 30 per cent faster as compared to those with no history of the mental disorder, according to a study that suggested physical effects of the mental condition.

Researchers, led by those from the University of Edinburgh, UK, said that treating depression should, therefore, involve methods that help manage both mental and physical health.

The mental disorder, marked by a per-

sistent low mood, is known to heighten one's chance of developing heart disease or diabetes, with previous studies having looked at a patient's risk of developing a small number of illnesses, according to the authors. However, the study, published in the journal PLOS Medicine, examined people with a history of depression for their risk of developing 69 physical

average of about seven years. The team noted that those with depression had an average of three physical conditions, hypertension being the most common, compared with an average of two in those without.

Over the study period, the participants with a history of depression developed



an average of 0.2 additional physical conditions a year, while those without accrued 0.16.

The most common new conditions were osteoarthritis (15.7 per cent of those with depression at baseline vs 12.5 per cent without), hypertension (12.9 per cent vs 12 per cent) and gastroesophageal reflux disease (13.8 per cent vs 9.6 per cent)," the authors

The results revealed that a history of depression could be a marker indicating a risk of developing physical conditions in the long-term.

The team added that while most healthcare systems are designed to treat conditions individually rather than individuals with multiple conditions, approaches combining methods to manage mental and physical health could improve outcomes.

Risk factors, such as smoking, high body mass index and low physical activity, could also contribute to how quickly an individual with depression develops physical conditions in middle- and old-age, which present opportunities for improving future health, the authors said.

About 18 per cent of the study group had a history of depression at the start of the study. Widespread pain in the body, sleeplessness, stressful life events, loneliness and obesity were more common among these participants, compared to those without de-

Card Swapping Scam

Financial Assistance Provided

SRINAGAR: In a commendable breakthrough, Police in Srinagar on Friday have successfully apprehended an accused involved in an ATM card swapping fraud.

"On February 12, 2025, Police Post Bagyas received a written complaint from a lady namely Shaheena wife of Zahoor Ahmad Najar resident of Kupwara, stating therein that she along with her daughter, had visited Dental College, Shreen Bagh, for a dental checkup. While using an ATM located within the complex, an unknown individual inside the booth deceptively swapped her ATM card and subsequently withdrew ₹40,000 from her account," a police spokesman said in a statement issued to Kashmir Observer.

Acting promptly, police

said that a case under FIR number 14/2025 U/S 318(4), 305 BNS was registered in Police Station Safakadal and

investigation was taken up.

"During the course of investigation, a team headed by Incharge Police Post Bagyas was constituted. After strenuous efforts and with the help of technical input and analysis of CCTV footage from the ATM, it led to the identification of the suspect as Burhan Al Rah son of Gh Qadir Rah resident of Bonpora, Nowgam. The accused person has been subsequently arrested, and multiple ATM cards were recovered from his possession," police said.

Further investigation is going on to ascertain the involvement of the accused person in other similar fraudulent activities. More recoveries are expected, police said.



After Revolution, Bangladesh **Textbooks Rewrite History**

Dhaka: Bangladeshi high schooler Laiba is being educated for the future, but what she learns has been determined by the latest chapter in her country's battle over its past

Her ouster has prompted Bangladesh to do something that has followed every sudden change in national leadership: rewrite its history books to suit new orthodoxies.

US Sending 1 More Planeload of Illegal Immigrants to India

New Delhi: A US plane carrying 119 illegal immigrants is likely to land at Amritsar airport on February 15, the second such batch of Indians deported by the Trump government as part of a crackdown it resolved to carry out when it was sworn in last month.

According to official sources, the plane is expected to land at the airport around 10 pm on Saturday.

Among the 119 illegal Indian immigrants, 67 hail from Punjab, 33 from Haryana, eight from Gujarat, three from Uttar Pradesh, two each from Goa, Maharashtra and Rajasthan and one each from Himachal Pradesh and Jammu and Kashmir, they said.

Another US plane carrying deportees is also expected to land on February 16.

The development came days after a US military aircraft carrying 104 illegal Indian immigrants landed at the Amritsar airport last week. Of them, 33 each were from Harvana and Gujarat and 30 from Punjab.

Most of the deportees hailing from Punjab had said they wanted to migrate to the US for a better life for their families. However, their

dreams were shattered when they were caught at the US border and brought back in shackles.

After Donald Trump assumed office as the US President, the country's law enforcement agencies have launched a crackdown against illegal immigrants.

Many people from Puniab and some other states, who entered the US through "donkey routes" -- an illegal and risky pathway used by migrants to enter America or other illegal means by spending lakhs of rupees - are now facing deportation.

Several political leaders in Punjab had questioned the landing of a US aircraft in Amritsar.

"The BJP-led Central government wants to defame Punjab. Why does it not land in Gujarat, Haryana or Delhi?" Punjab Finance Minister Harpal Singh Cheema said on Thursday while replying to a question on the likely arrival of another US plane carry ing illegal immigrants.

Notably, the Punjab government had recently formed a special investigation team to probe the issue of illegal human trafficking following the deportation of Indian citizens domiciled in Punjab from

Bollywood Music Seeks to Challenge OpenAI in India



group of India's top Bollywood music labels. from T-Series to Saregama and Sony, is seeking to join a copyright lawsuit against OpenAI in New Delhi, highlighting worries about improper use of recordings to train AI models, legal documents show.

Microsoft-backed OpenAI's le gal challenges are mounting globally and in India, its second biggest market by users. But the company says it follows fair-use principles in employing publicly available data to build its AI models.

On Thursday, the Indian Music Industry (IMI) group, T-Series and Saregama India asked a New Delhi court to hear concerns about "unauthorised use of sound recordings" in training AI models that breaches their copyright.

The companies' contentions in the lawsuit "are crucial for the entire music industry in India. and even worldwide," they said in their filing, which is not public but was reviewed by Reuters. OpenAI and the music labels

did not respond to requests for comments on Friday. The music labels want to join

a lawsuit launched last year by Indian news agency ANI that accused OpenAI's ChatGPT application of using its content without permission to train AI models.

Since then, book publishers and media groups, some backed by billionaires Mukesh Ambani and Gautam Adani, have banded together to oppose the company in the New Delhi court. Bollywood and Hindi pop mu-

sic are big business in India.

T-Series is one of India's largest music record labels which releases about 2,000 sound records or songs annually, while Saregama, more than 100 years old, owns a repertoire of famed Indian singers such as Mohammed Rafi and Lata Mangeshkar.

On its website, the IMI group says it also represents global names such as Sony Music and Warner Music. In India, the music labels are

MAKERS The Scent Of The Mummy. Research Discovers **Ancient Egyptian Remains Smell Nice**

ONDON: At first whiff, it sounds repulsive: sniff the essence of an ancient

But researchers who indulged their curiosity in the name of science found that well-preserved Egyptian mummies actually smell pretty good.

"In films and books, terrible things happen to those who smell mummified bodies," said Cecilia Bembibre, director of research at University College London's Institute for Sustainable Heritage. "We were surprised at the pleasantness of them."

"Woody," "spicy" and "sweet" were the leading descriptions from what sounded more like a wine tasting than a mummy sniffing exercise. Floral notes were also detected, which could be from pine and



juniper resins used in embalming. The study published Thursday in the Journal of the American Chemical Society used both chemi-

cal analysis and a panel of human sniffers to evaluate the odors from nine mummies as old as 5,000 years that had been either in storage or

on display at the Egyptian Museum in Cairo.

The researchers wanted to systematically study the smell of mummies because it has long been a subject of fascination for the public and researchers alike, said Bembibre, one of the report's authors. Archaeologists, historians, conservators and even fiction writers have devoted pages of their work to the subject — for good reason.

Scent was an important consideration in the mummification process that used oils, waxes and balms to preserve the body and its spirit for the afterlife. The practice was largely reserved for pharaohs and nobility and pleasant smells were associated with purity and deities while bad odors were signs of corruption and decay.

SRINAGAR: Jammu and Kashmir Police have allegedly seized literature affiliated with Jamaat-e-Islami (Jel), a religious-political organisation, which has been banned in Jammu and Kashmir for the last six years. Police teams arrived at several bookshops in the city centre and seized over 650 books, officials said.

"Based on credible intelligence regarding the clandestine sale and distribution of literature promoting the

ideology of a banned organisation, police conducted a search in Srinagar, leading to the seizure of 668 books. Legal action has been initiated under Section 126 of the BNSS," Srinagar district police said in a post on X.

Under Section 126 of Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023, an executive magistrate can order a person "to show cause why he should not be ordered to execute a bond or bail bond for keeping the peace for such period, not exceeding one year, as the magistrate thinks fit".

Kashmir: Sangtarash See Their Art Dying

SRINAGAR: Sangtarash (stone carving workmen) in Kashmir are facing an uncertain future as the demand for the carved stones is on decline.

Ghulam Rasool Mir, 60, of Sempora, a sangtarash, who has chiseled hardest of stones into decorative shapes since his childhood believes that this work will be over soon.

Mir said, "I see the art of stone carving dying as the demand of the products is decreasing with each passing day. The introduction of modern techniques has led to decline in the demand for the carved stones."

"Youngsters don't want to learn the art of stone carving as most of them believe that it has no future prospects," he added. He said, "Now other material is being used in Hammam and other things in Kashmir which is much cheaper than the famous Devri stone."

"We suffered huge damage in the 2014 floods as our whole material was washed away but no compensation was paid to us," Mir lamented.

He said that despite sangtarash working from morning to evening, they are hardly earning a few hundred rupees on a daily basis.

Abdul Gani another sangtarash said, "The government has been repeatedly asking us to vacate the state land where we are working. If we are displaced around 100 families dependent on this art will get affected."

J&K Sees 79% Deficit Rainfall, All Districts Record Deficiency

SRINAGAR: With no forecast of any weather activity in Jammu and Kashmir, all the districts across the Union Territory have recorded a large deficit of rainfall in the last one and a half months. Kathua tops the list with 97 per cent deficiency from January 01 to February 12,

J&K has recorded a deficit rainfall of 79 per cent as against the normal precipitation of 140 mm, the rainfall of just 29.8 was recorded during the period.

As per the data, Jammu has recorded a deficit rainfall of 94 percent while Udhampur and Samba districts have recorded a deficiency of 92 percent each

a deficiency of 92 percent each. Srinagar, the summer capital of Jammu and Kashmir, has recorded a deficit rainfall of 82 per cent during the period while seven other places including Shopian, Reasi, Ramban, Kulgam, Doda, Budgam and Anantnag have recorded a deficiency in between 80 to 89 per cent.

Pulwama, Kupwara, Bandipora and Baramulla districts have a deficiency of between 70 to 79 percent during the period, according to the data. Four districts including Poonch, Rajouri, Kishtwar and Ganderbal have recorded a deficiency in between 60 to 69 per cent.

All the districts across the Union Territory have been categorised in large deficiency, the data reveals.

Meanwhile, the weatherman here has predicted dry weather conditions till tomorrow.

Director Meteorological Department Dr Mukhtar Ahmad, said that on February 16, the weather would remain partly to generally cloudy with light rain and snow expected at isolated higher reaches of north & central Kashmir mainly towards evening and night

wards evening and night.
On February 17-18, partly to generally cloudy weather is expected with the possibility of a brief spell of light rain and snow at isolated higher reaches, he said, adding that nothing significant is expected till February 18.

As per order, BMO Hajan has been appointed as the Chairperson of the committee while Shaheen Chalkoo, Consultant Anaesthesia CHC Sumbal, Dr Nisar Ahmad Medical Officer CHC Hajan, Nasreena Kounsar In-Charge Labour Room and Mohammad Yaqoob Ganaie BM&EO Hajan are its members.

The committee has been asked to do a detailed case analysis of the deceased patient, including medical history, antenatal care received, and any complications noted during pregnancy. It has been asked to examine the treatment protocol followed during admission, delivery, and post-operative care and also assess the role of duty doctors, nursing staff, and support staff in managing the

Curtailing Benefits of the Golden Card Scheme is Anti-Poor

Reserving some surgical procedures to be done only in government hospitals violates the Right to Health. The health budget in J&K needs to be enhanced

he Jammu & Kashmir's much-appreciated insurance scheme (Golden Card), launched in 2020, is losing its sheen day by day. Initially, there was a legal tussle between the government and the insurance company. Now, the issue is about reserving certain surgical procedures to be done only in government hospitals. The PM and LG Administration had received much appreciation for this public welfare health program, but due to various reasons, the Golden Card scheme may not benefit the poor in the months to come.

Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PM-JAY), commonly known as the Golden Card scheme, was launched around December 2018 in Jammu & Kashmir. This is a medical insurance scheme meant to benefit only the poor population living under the Below Poverty Line (BPL). By the end of 2020, this scheme was renamed the AB-PM-JAY SEHAT scheme, and its benefits were extended to all 20 lakh families living in J&K. The scheme was formally launched by Prime Minister Modi on December 26 2020

What is this scheme all about?

The main focus of Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (PMJAY) - SE-HAT scheme is protection from catastrophic health expenditures. According to the State Health Agency (SHA), this scheme is delivered through both public and private healthcare providers for providing secondary and tertiary care health services.

- The scheme provides a cover of Rs. 5 lakh per family per year. All medical and surgical conditions are included with minimal exclusions.
- It covers both pre- and post-hospitalization expenses.
- All pre-existing conditions are covered from day one.
- There is no family size or age limit.
- Public hospitals are deemed empanelled, while private health-care facilities have been empanelled based on defined criteria (including specialty-specific criteria).

How did the problem start?

Bajaj Allianz GIC was the implementing agency for Ayushman



Bharat Pradhan Mantri Jan Arogya Yojana (PMJAY) and AB PM-JAY SEHAT in Jammu & Kashmir until 2022. After the contract ended with Bajaj Allianz, IFFCO-TOKIO General Insurance Company signed the contract with the State Health Agency (SHA) in November 2023. The contract, which came into effect on March 10, 2022, was supposed to continue for three years (until March 2025). However, IFFCO TO-KIO, according to media reports, suffered financial losses and ended the contract much before its expiry date. The State Health Agency (SHA) requested IFFCO-TOKIO to continue the contract "in the interest of patient care," but the company refused.

SHA moved to the High Court

As the company was unable to continue its work, the State Health Agency (SHA) sought judicial intervention by filing a writ petition against IFFCO-TOKIO in the Jammu & Kashmir High Court. SHA requested the court to stay the termination of the contract and order the insurance company to fulfill the contract until its expiry on March 14, 2025, citing the importance of "patient care" and public well-being. The SHA also urged the court to direct the company to refrain from opting out of the contract. In September last year, the High Court directed the J&K government to utilize a premium amount of Rs. 427.73 crores lying with it for reimbursement of medical claims.

The division bench of Justice Sanjeev Kumar and Justice Sindhu Sharma, however, said that reimbursement of the premium amount

would be subject to the outcome of an appeal filed by IFFCO Tokio General Insurance Co. Ltd against an order by the court's single bench, which had earlier asked the company to continue with the existing arrangement. This order helped service providers (private hospitals) receive payments that had been held up for the last few years. As this issue started getting addressed, another issue regarding the health insurance scheme arose: the government, according to media reports, plans to exclude some surgical procedures under the ABPM-JAY SEHAT scheme.

Excluding Some Surgical Procedures

Four surgical procedures—cholecvstectomy. hemorrhoidectomy, appendectomy, and fissure surgery—are said to be excluded from the ABPMJAY SEHAT scheme, and they will no longer be covered in private hospitals starting from March 15, 2025. This is a major policy shift under active consideration by the government. This change will lead to prolonged waiting times in government-run hospitals. It is a known fact that for smaller surgical procedures, like fissures or piles, one has to wait for months to get the surgery done. Once private hospitals are exempted from these procedures, it will directly impact poor patients. The wealthy will go to private hospitals and pay the surgical but where will poor patients go? The J&K Chief Secretary, Atal Dulloo, chaired the 9th Governing Council Meeting of the State Health Agency (SHA) on January 19, 2025, and it is said that this decision was taken in

that meeting

Decision Against the Private Sector

The decision taken during the governing council meeting, chaired by the Chief Secretary, is not only against poor patients but also against the interests of private hospitals. It is a known fact that private hospitals providing Golden Card services have already suffered a lot in the past 10 months due to the legal tussle between the State Health Agency (SHA) and Insurance Company IFFCO TO-KIO. In the governing council meeting, nothing was decided regarding the release of long-pending payments to these service providers, 1% interest for the delayed payments, or other issues. The Private Hospital Association has written to the government and believes that the contract with the State Health Agency, after the completion of the three-year term starting on March 15, 2025, can no longer be tenable, as it won't be possible for them to meet the expenses at the diminishing rates, especially with delayed payments.

"Neither have the packages been revised, even after the Union Government's enhancement of the budget for the Ayushman Bharat scheme by 24%, raising it to Rs. 9,406 crores," reads a representation from the Private Hospitals and Dialysis Centre Association.

Conclusion

To make the Golden Card health insurance scheme viable, the government must increase the budget allocation from the current Rs. 589 crores to Rs. 900-950 crores for the smooth running of the AB-PMJAY SEHAT scheme in J&K. There should be no reservations for any surgical procedures to be done in private hospitals, as the right to health is a constitutional right guaranteed under Article 21 of the Constitution. Chief Minister Omar Abdullah and Health Minister Sakina Masood must intervene personally because this will not only impact the economically weaker sections of society but also give a significant jolt to the National Conference politically.

You wake up at 7:00 and reflexively reach for your phone. Between the stream of emails, WhatsApps and breaking news alerts, you see a worrying reminder: you averaged 11 hours of daily screen time last week. You swipe the notification away and open TikTok, where a woman in a matching athleisure set and glossy, slicked-back ponytail urges you to "get ready with me for my 5-9 before my

You think about getting out of bed for a workout or meditation before you start answering those emails. But before you know it, it's 8:57 - and if you don't get off the apps and onto your computer, you'll be

Sound familiar? Though many people have more leisure time now than in the past, paradoxically, more free time comes with increased time pressure. For many of us, it feels as if we don't have control over our time - rather, time is controlling us. This is because our collective experience of time both comes from and governs society.

Instead of saving us time, the pace of modernity has led to many of us feeling as if our time is slipping away. And any time we "gain back", we devote – by necessity or choice – to making more money, maybe through a side hustle. Losing control over time can have negative consequences for both physical and mental wellbeing.

We are trapped in a perpetual cycle of rushing to survive and consume. But consumption also takes time, so the time available to enjoy our newly acquired possessions declines. You buy a faster new computer, but then need to spend multiple, frustrating hours configuring it to your preferences.

Even trying to save time by mastering a productivity hack or reading a self-help book takes (you guessed it) time.

As time use researchers, we often grapple with an uncomfortable truth - your time is not fully yours – it belongs to us all. Time is a network good. We live in a web of time: giving, taking and sharing time with everyone around us. In other words, the decisions and actions of the people around

you shape how much time you have. This presents a catch-22. Friends, family, colleagues and even neighbours require our time, and we need theirs, too. We share time with our social network members because we need strong ties for our wellbeing. However, building lasting relationships means that we have to control our time in order to share it with others.

Unfortunately, we don't all have the

same amount of control. Socioeconomic

and demographic factors - gender, financial circumstances, age, race, and where you live - all influence how you can make decisions about time. These factors shape how we can interact with others.

Even seemingly mundane choices, such as how many extra minutes of sleep you give yourself in the morning, are shaped by societal expectations, power structures and economic constraints. This is why the hundreds of self-help articles telling you how to optimise your time by carefully budgeting every minute passion in the face of the demands on your time.

Get in control

Gaining control over your time starts with "why". We don't all have the luxury of saying no to tasks we deem unnecessary or unpleasant.

We can, however, ask ourselves why we are spending our time on certain things. Before your next decision, big or small, try asking yourself: why am I doing this?

If the answer is rooted in social pressure, outdated norms, or an obligation toward someone who does not deserve the gift of your precious time, consider how you could switch to doing something else.

Try to spend your time on activities and with people who nourish you, enriching your moments. You may not be able to completely avoid spending part of your time as your boss dictates. But understanding the larger power dynamics shaping your personal situation and your time will help you approach decisions with conscious intention, giving you greater control over this irreplaceable resource.

Regularly questioning the reason behind your actions will reveal the social patterns driving your decision-making processes. Why did you agree to do something, only to regret it later? Why are you always the one donating time to emotional labour at the office?

Consistently asking "why" creates a habit of mindfulness, and will give you the insight needed to begin to make more informed choices that reflect your true priorities. Ultimately, gaining more control over your time is not about rigidly adhering to a schedule or productivity hacks. It is impossible to subject every minute of your existence to your will – time is not yours to hold on to.

Study Suggests Reason Behind People Showing Increased Creativity After Brain Injuries Disorders

Researchers have identified a brain circuit for creativity and suggested that people with brain injuries or neurodegenerative diseases -- in whom the circuit is affected -- may have increased creativity.

"Some people with neurologic diseases experience a new onset of creative behaviour and show specific patterns of damage that align with our creativity circuit," lead author Julian Kutsche, a research fellow at Brigham and Women's Hospital, US.

Co-senior author Isaiah Kletenik, a neurologist at Brigham and Women's Hospital, said, "We wanted to answer the questions, 'What brain regions are key for human creativity and how does this relate to the effects of brain injuries?"

The study, published in The Journal of the American Medical Association (JAMA) Network Open, first looked at brain scans of



857 people to identify regions that help perform creative activities such as drawing, creative writing and making music. The brain scans were taken from a review of studies published between 2004 and 2019.

The researchers then analysed

data of patients who had changes in creativity due to brain injury and neurodegenerative diseases.

The team found that brain regions involved in creative tasks are part of one common brain circuit, defined by a simultaneous reduced

activity in the right frontal pole -important for monitoring and rulebased behaviours.

The reduced activity could align with the hypothesis that creativity requires shutting down the 'inner critic's' function, according to Kletenik.

"To be creative, you may have to turn off your inner critic to allow yourself to find new directions and even make mistakes," Kletenik said.

"These findings could help explain how some neurodegenerative diseases might lead to decreases in creativity while others may show a paradoxical increase in creativity," the author added.

"Brain regions activated by creativity tasks map to a brain circuit defined by negative functional connectivity to the right frontal pole. Damage to this circuit aligned with changes in creativity observed in individuals with certain brain diseases, including paradoxical creativity increases," the authors wrote.

IIT Guwahati Researchers Develop Selfcleaning, Exible Heating Fabric For Cold Climates

Researchers at the Indian Institute of Technology (IIT) Guwahati have developed a self-cleaning, exible heating fabric for cold climates, which can mitigate health risks from prolonged exposure to extreme cold.

The ndings of the research have been published in the journal Nano-Micro-Small.

According to Uttam Manna, Professor at the Department of Chemistry, IIT Guwahati, extreme cold temperatures can lead to health problems that may even be fatal.

"Studies indicate that deaths due to extreme cold outnumber those caused by extreme heat.

Traditional solutions for protecting oneself from extreme cold, such as heaters or layered clothing, are often bulky or require a constant power source. Conductive textiles offer a lightweight, exible alternative, but existing versions often have limitations, such as poor durability, high power consumption, and vulnerability to water exposure," Manna said.

To overcome these challenges, the IIT Guwahati research team developed a novel approach by spraying ultra-thin, clean silver nanowires onto cotton fabric to make it conductive.

"These nanowires are 100,000 times thinner than a human hair, allowing electricity to ow through the fabric, helping it generate heat while remaining soft and exible. Due to its exceptional electrical conductivity and the ability to convert both electricity and sunlight into heat, silver nanowires were chosen for this experiment. The low electrical resistance of silver allows for electrothermal conversion at low applied voltage, eliminating the risk of electrocution," Manna

3.5 Kilometres Underwater, Scientists Found A Staggeringly Energetic Particle From Outer Space

Three and a half kilometres beneath the Mediterranean Sea, around 80km off the coast of Sicily, lies half of a very unusual telescope called KM3NeT.

The enormous device is still under construction, but today the telescope's scientific team announced they have already detected a particle from outer space with a staggering amount of energy.

In fact, as the team report in Nature, they found the most energetic neutrino anyone has ever seen – and it represents a tremendous leap forward in exploring the uncharted waters of the extreme universe.

To explain why it's such a remarkable discovery, we need to understand what KM3NeT is, what it's looking for, and what it saw

What is KM3NeT?

KM3NeT is a gigantic deep sea telescope being built by an international collaboration of more than 300 scientists and engineers from 21 countries.

At the site off Sicily, and another off the coast of Provence in France, KM3NeT will be made up of more than 6,000 light detectors hanging in the pitch-black depths. When the telescope is complete, it will cover about a cubic kilometre of sea.

Down deep, KM3NeT is shielded from ordinary sources of light, such as the Sun. It is



also shielded from other particles like electrons and protons, which are absorbed by the water long before they reach the detectors. So what does it see?

What is KM3NeT looking for?
Of all the particles that phys-

Of all the particles that physicists have discovered, only the elusive neutrino can reach all the way down to KM3NeT.

The neutrino is an elementary particle with no electric charge and only a very tiny mass. It interacts with matter so weakly that it can pass through kilometres of ocean – and even thousands of kilometres of Earth itself – to reach the detector. That's why KM3NeT is at the bottom of the sea: to see neu-

trinos, and only neutrinos. But won't the neutrinos pass through the detector, too? Yes,

almost all of them.

But very rarely, a neutrino will crash right into a water molecule. When it does, it can neck an enormous punch

molecule. When it does, it can pack an enormous punch.

The energy of the neutrino can create many more particles.

can create many more particles. As these particles blast through the water, they create a bluish glow. That's what KM3NeT detectors see.

By analysing this bluish

By analysing this bluish light, and by timing each flash, scientists can reconstruct the original energy of the neutrino, and the direction from which it came. (Either that, or they've just clocked one of those deepsea glowing fish travelling at nearly the speed of light.)

The most energetic neutrino ever detected On February 13 2023, KM3NeT detected a neutrino travelling so fast it had 30 times more energy than any previously detected.

The amount of energy is 220 petaelectronvolts, but that doesn't mean much to a non-particle physicist. It's hard to imagine, but let's try.

The neutrino had 100 trillion times more energy than a typical particle at the centre of the Sun. It's a trillion times more energy than medical X-rays, and ten billion times more than the most dangerous radioactive particles. Earth's biggest particle accelerators can't produce a particle with even one ten thousandth of this energy.

Mitochondria May Hold Key To Curing Diabetes: Study

itochondria are responsible for creating energy, which fuels cells and keeps them functioning. However, mitochondrial abnormalities have been linked to the development of disorders like type 2 diabetes. Patients with this illness are unable to produce enough insulin or use the insulin produced by their pancreas to maintain normal blood sugar levels.

Researchers at the University of Michigan used mice to show that dysfunctional mitochondria trigger a response that affects the maturation and function of b-cells.

Several studies have shown that insulin-producing pancreatic b-cells of patients with diabetes have abnormal mitochondria and are unable to generate energy. Yet, these man pancreatic islet cells.

Their results prompted the team to expand their search into other cells that are affected by diabetes.

"Diabetes is a multi-system disease--you gain weight, your liver produces too much sugar and your muscles are affected. That's why we wanted to look at other tissues as well," said Scott A. Soleimanpour, M.D., director of the Michigan Diabetes Research Center and senior author of the study.

The team repeated their mouse experiments in liver cells and fat-storing cells and saw that the same stress response was turned on. Both



studies were unable to explain why the cells behaved this way.

"We wanted to determine which pathways are important for maintaining the proper mitochondrial function," said Emily M. Walker, Ph.D, a research assistant professor of internal medicine and first author of the study.

To do so, the team damaged three components that are essential for mitochondrial function: their DNA, a pathway used to get rid of damaged mitochondria, and one that maintains a healthy pool of mitochondria in the cell.

"In all three cases, the exact same stress response was turned on, which caused b-cells to become immature, stop making enough insulin, and essentially stop being b-cells," Walker said. "Our results demonstrate that the mitochondria can send signals to the nucleus and change the fate of the cell."

The researchers also con-

The researchers also confirmed their findings in hucell types were unable to mature and function properly.

"Although we haven't tested all possible cell types, we believe that our results could be applicable to all the different tissues that are affected by diabetes," Soleimanpour said. Regardless of the cell

type, the researchers found that damage to the mitochondria did not cause cell death.

This observation brought up the possibility that if they could reverse the damage, the cells would function normally.

To do so, they used a drug called ISRIB that blocked the stress response. They found that after four weeks, the bcells regained their ability to control glucose levels in mice.

NEW DELHI- Gold prices soared by Rs 1,300 to hit an all-time high of Rs 89,400 per 10 grams amid heavy buying from jewellers and retailers, according to the All India Sarafa Association.

The precious metal of 99.9 per cent purity had closed at Rs 88,100 per 10 grams on Thursday.

Gold of 99.5 per cent purity climbed by Rs 1,300 to hit a fresh peak of Rs 89,000 per 10 grams against previous close of Rs 87,700 per 10 grams.

Silver also rallied by Rs 2,000 to hit a four-month high of Rs 1 lakh per kg on Friday. The metal had finished at Rs 98,000 per kg on Thurs-

In futures trade on the MCX, gold contracts for April delivery rose Rs

184 to Rs 85,993 per 10 grams. "Gold prices continued their upward momentum, driven by a weaker dollar index and sus-tained support from US tariff policies. Gold rose on MCX, while Comex gold gained to trade at USD 2,935 per ounce," Jateen Trivedi, VP Research Analyst - Commodity and Currency at LKP Securities.

The focus now shifts to upcoming US Retail Sales and Core Retail Sales data, which could influence the next move in gold, Trivedi added.

Silver futures zoomed by Rs 2,517 or 2.64 per cent to Rs 97,750 per kg on the Multi Commodity Exchange (MCX).

Globally, Comex gold futures for April delivery rose USD 6.49 per ounce to USD 2,951.89 per ounce. Meanwhile, spot gold traded higher at USD 2,929.79

New I-T Bill To Simplify Tax Framwork, Help Boost **MSMe Growth: ICAI**

come Tax Bill will simplify the country's six-decade old tax structure as well as help boost growth of MSMEs, chartered accountants' body ICAI said on Friday.

The Institute of Chartered Accountants of India (ICAI), a key stakeholder in tax matters, is also setting up a fivemember group to closely examine various provisions of the bill.

Introduced in Lok Sabha on Thursday, the bill seeks to achieve tax certainty by minimising the scope of litigation and fresh interpretation.

With an intent to simplify the six-decade old tax framework, the main objective was to streamline the provisions, removing obsolete references and creating a simpler legal framework, ICAI said in a release.

It said the objectives have been sought to be achieved by replacing the concept/terminology of previous year and assessment year with 'tax year' and 'financial year succeeding the tax year', doing away with the provisos and explanations, among others.

ICAI President Charanjot Singh Nanda said the bill is a measure for strengthening employment generation and MSME growth as it would simplify India's tax structure and will give a boost to the Indian economy at large.

"The provisions relating to charitable trusts spread across different Chapters of the Income Tax Act, 1961 are being simplified and consolidated in a single chapter. All the TDS provisions are now contained in one section and presented in the form of a table.

"All presumptive income provisions for residents have been grouped and presented in a single clause," the release said.

Fund Misappropriation Led To RBI Action

MUMBAI- The RBI action on New India Co-operative Bank was prompted by almisappropriation of funds by the lender's staffers, sources said on Friday.

NEW DELHI- Wholesale price inflation moderated marginally to 2.31 per cent in January due to the decline in prices of food items especially bles, government data released on Friday showed.

The Wholesale Price Index (WPI) based inflation was 2.37 per cent in December 2024. It was 0.33 per cent in January

As per the data, inflation in food items eased to 5.88 per cent in January, as against 8.47 per cent in December 2024. Înflation in vegetables came down significantly to 8.35 per cent, as against 28.65 per cent in December 2024.

In the eggs, meat and fish category inflation declined to 3.56 per cent as against 5.43 per cent last month.

Within vegetables, tomato prices declined to 18.9 per cent while inflation in potato continued to be high at 74.28 per cent, and in onion it spiked to 28.33 per cent in January.

The fuel and power category witnessed a deflation of 2.78 per cent in January, against a

deflation of 3.79 per cent in December. In manufactured items, inflation was 2.51 per cent as compared to 2.14 per cent in December 2024.

Retail inflation data released on Wednesday showed that Consumer Price Index (CPI) based inflation eased to a 5-month low of 4.31 per cent in January on easing prices of food items.

ICRA Senior Economist Rahul Agrawal said, "We project the WPI to average at 2.4 per cent in FY2025 and inch up further to 3 per cent in FY2026, despite expectations of a cooling in the prints for the food segment".

According to CARE Ratings Chief Economist Rajani Sinha, food prices are likely to ease in the coming months driven by seasonal correction in prices.

However, there are headwinds as far as global commodity prices are concerned. Their prices have been hardening amid growing uncertainty around the impact of the US protectionist trade policies. This would exert an upward pressure on the WPI non-food

Trump's Tariffs And India: An Explainer

NEW DELHI- US President Donald Trump has asserted that Washington will not spare India

from reciprocal tariffs. The President has set in motion his plan to impose reciprocal tariffs on imports, which is expected to further deepen the global trade war.

During 2021-24, the US was the largest trading partner of India.

During April-November 2024-25, the bilateral trade in goods between the two countries stood at USD 82.52 billion (USD 52.89 billion exports, USD 29.63 imports). The trade gap was USD 23.26 billion which is in the favour of India.

The US accounts for about 18 per cent of India's total goods exports, 6.22 per cent in imports, and 10.73 per cent in bilateral trade.

Trump has announced a 25 per

cent duty on all steel and aluminium imports. It will come into effect from March 12.

Moody's Ratings have stated that Indian steel producers will face increased challenges in exporting their products following the US decision to impose the 25 per cent tariff.

*What are tariffs?

In international trade parlance, tariffs or customs duties or taxes are imposed on the import of goods. The importer has to pay this duty to the government. Normally, companies pass on these taxes to end users.

For example, if a company is importing a product 'X', having 10 per cent customs duty, valued at Rs 100 from other country, the cost of the product will go up to Rs 110.

These duties, which are indirect taxes, are a source of revenue for a country.

Anti-dumping duty, counter-

vailing duty or safeguard duty are also kinds of tariffs.

*What are reciprocal and retaliatory tariffs?

Normally, both can be used synonymously. They are imposed by countries to match hike in duties or high tariffs by trading partners. For example when in 2018, the US imposed higher duties on certain steel and aluminium products, India retaliated by raising tariffs on 29 US products, recovering equivalent revenue.

*Why countries impose tariffs? These tariffs are imposed to make imported goods expensive and in turn, promote domestic manufacturing and job creation. It also protects domestic play-

ers from cheaper imports. *What are the negative impacts of tariffs?

Higher import duties are inflationary in nature and make inputs expensive for the domestic

industry. For example, if an auto company needs some component, which is not produced in the country, it will have to pay a higher price for its import because of tariffs.

This will make the product expensive for domestic users. *Why Trump is talking about

imposing reciprocal tariffs? The US is facing huge trade imbalances with countries, especially with China. With India, the US has a trade deficit of USD 35.31 billion in goods in 2023-24. To bridge this gap, the US Presi-

dent is imposing these duties. *Is there any substance in Trump's allegations that India is a 'tariff king' or 'tariff abuser'?

According to the economic think tank Global Trade Research Initiative (GTRI), these are unfair and the US itself imposes high duties on several goods to safeguard its domestic markets.

Rs 262 Crore In Q3: BSNL Posts Quarterly **Profit For First Time In 17 Years**

NEW DELHI- BSNL has posted a net profit of Rs 262 crore for December quarter, marking its return to profitability after almost 17 years, Union Minister Jyotiraditya Scindia said on Friday terming it a "significant turning point" for the stateowned telco that has been focused on expansion of service

offerings and subscriber base. BSNL scripted an improvement on several counts, clinching 14-18 per cent growth across mobility, FTTH and leased line service offering, Scindia, Minister for Communications said adding that the subscriber base too has risen to about 9 crore in December, from 8.4 crore in June.

"Today is an important day for BSNL, and for the journey

of the telecom sector in India... BSNL has, in third quarter of FY2024-25, for the first time in 17 years, posted a profit on a quarterly basis. The last time that BSNL posted a quarterly profit was in the year 2007," he said on BSNL's earnings.

The net profit came in at about Rs 262 crore in the third quarter of the financial year. Mobility services revenue grew by 15 per cent, Fiberto-the-Home (FTTH) revenue increased by 18 per cent and leased line services revenue rose by 14 per cent over Q3 of the previous year.

The Q3 scorecard underlined the telco's focus on innovation, network expansion, cost optimisation, and customer-centric service improvements.

Additionally, BSNL has cut its finance cost and overall expenditure, leading to a decline in losses by over Rs 1,800 crore compared to last year.

With a view to enhancing customer experience, BSNL has introduced offerings such as National WiFi Roaming, BiTV - Free Entertainment for All Mobile Customers, and IFTV for All FTTH Customers, and first private 5G connectivity for mining.

"We certainly hope that this year will not just see an increase in revenues at the end of fourth quarter for the full financial year, but will also (see BSNL) keep expenditure and costs under control and significantly reduce losses from the figures of last year," the minister said.

Prime Minister Narendra Modi and US President Donald Trump will activate new initiatives under the Quad grouping and convene partners from the India-Middle East-Europe Corridor and the I2U2 Group to announce new initiatives, said the joint statement issued by India and the US after the two leaders met in Washington DC Friday.

The statement said PM Modi and President Trump launched a new bilateral forum, Indian Ocean Strategic Venture, and that they are also expected to announce new partnership initiatives across the Western Indian Ocean, Middle East, and the Indo-Pacific.

This comes at a time when President Trump has been talking about walking out of multilateral groupings and initiatives. Sources said this means that Trump is strategic in his approach on which initiatives to invest in. He has walked out of the Paris Climate Agreement, the World Health Organization (WHO), and has threatened North Atlantic Treaty Organization (NATO) countries by asking them to share the financial burden.

"They announced plans to pursue this year new procurements and co-production arrangements for 'Javelin' anti-tank guided missiles and 'Stryker' infantry combat vehicles in India," it said.

In another important move, the two sides decided to review their respective arms transfer regulations, including International Traffic in Arms Regulations (ITAR), in order to streamline defence trade, technology exchange and maintenance and in-country repair and overhaul of US-provided systems.

Modi and Trump also announced a new initiative - the Autonomous Systems Industry Alliance (ASIA) - to scale industry partnerships and production in the Indo-Pacific.

Gang Rape: HC

recovered from the possession of the accused person at NS Bridge Uriand in her statement under Section 164 Cr.P.C. she deposed that she was jointly raped by accused persons at unknown place, so offences punishable under Section 376D (gang rape), 384 (extortion), 506 (criminal intimidation) were incorporated in the case. The government said that the petitioners were involved in a heinous offence against a woman.

As per the petitioner, Syed Imtiyaz Hussain married a woman who is an adult and entered into the marriage of her own free will and consent on July 28, 2021.

"Worthwhile to mention here that settlement or compromise must satisfy the conscience of the Court. Quashing of offence or criminal proceedings on the ground of settlement between an offender and victim is not same as compounding of offence," the court said, adding, "For serious offences, like murder, rape, dacoity, etc., or other offences of mental depravity under Indian Penal Code or offences of moral turpitude under special statutes, like the Prevention of Corruption Act or the offences committed by public servants while working in that capacity, settlement between offender and victim can have no legal sanction

Each case will depend on its own facts and no hard-and-fast category can be prescribed, the court said.

The bench said that the High Court must consider whether it would be unfair or contrary to the interest of justice to continue with the criminal proceeding or continuation of the criminal proceeding would tantamount to abuse of process of law despite settlement and compromise between the victim and the wrongdoer and whether to secure the ends of justice, it is appropriate that the criminal case is put to an end.

'The rape is not an offence against the person alone, but it is against society - in legal terms the victim gets a right in rem - which will entail the State to take necessary measures to fend the victim and ameliorate them," the court said, adding, "The Courts have to take a victim-sensitive approach and not pronounce verdicts that could infringe upon the victim's rights while being under the influence of various cultural or gender biases which could seriously jeopardise the credibility of the judiciary.

In a country like India where religious practices are centered around deities who are women, the court said, it must recognise the strength of this gender and take all measures to show unwavering respect to uphold their mental as well as bodily integrity, rather than treating them as mere chattels of men.

"In view of the nature of offences alleged in the present case, the power under Section 482 Cr.P.C. cannot be used to quash the proceedings based on compromise if it is in respect of heinous offence which are not private in nature and have a serious impact on the society," the court said, adding, "In cases of this nature, the fact that in view of compromise entered into between parties, the chance of conviction is remote and bleak also cannot be a ground to terminate the investigation and quash FIR and all the proceedings emanating therefrom by invoking the power under Section 482 Cr.P.C. In such circumstances, an impugned FIR does not call for any interference." Consequently,

the court dismissed the plea. Art 370 was Temporary.

interview, Sackur asked Chandrachud whether he believed that 75 years was too short a period to revoke Article 370, considering its historical significance. Chandrachud explained that Article 370 was originally part of the transitional provisions in the Constitution and was never meant to be permanent. He said, "Since I was the author of one of the judgments in the case, a judge by their very nature of profession has some restraints on either defending or critiquing their judgments... Article 370 of the Constitution when it was introduced into the Constitution at the birth of the Constitution was part of a chapter which is titled 'transitional arrangements' or 'transitional provisions'. It was later renamed as 'temporary and transitional provisions', and therefore at the birth of the Constitution, the assumption was that what was transitional would have to fade away and have to merge with the overall text, the context of the Constitution. Chandrachud explained that the Supreme Court recognized the power of an elected government to revoke a provision that was meant to be transitional. He stated that if the government, which is accountable to the people, decides to remove such a provision, it is legally

Furthermore, the Supreme Court emphasized the need to restore democracy in Jammu and Kashmir, setting a timeline for the revival of its democratic process. Chandrachud remarked, "We said that what was intended to be transitional provision, if the government which is accountable to the people and the elected government takes the view, the Centre that we are abrogating what was essentially transitional that is fine. Second, the Supreme Court said that the democratic process in Jammu and Kashmir must be restored, effectively setting a

timeline for that.' The former CJI also addressed allegations regarding his faith and its potential impact on his judgments. "I make no bones of the fact that I am a man of faith," he said. "Our Constitution does not require you to be an atheist to be an independent judge, and I value my faith." Justice Chandrachud emphasised that his faith teaches him the universality of religion and the importance of dispensing equal and evenhanded justice.

ICC Champions Trophy: Winners To Receive Prize Money Of USD 2.24 Million

DUBAI: Winners of the upcoming Champions Trophy will walk away with a whopping USD 2.24 million cash reward after the International Cricket Council (ICC) announced a 53 per cent hike in its prize money pool for the eight-team tournament starting February 19.

The winners' purse would be close to 20 crore in Indian currency. The runners-up will receive half the amount, USD 1.12 million (INR 9.72 crore), while each losing semi-finalist will take home USD 560,000 (INR 4.86 crore). The total prize pool has increased to USD 6.9 million (Rs 60 crore approx).

"The substantial prize pot underscores the ICC's ongoing commitment to investing in the sport and maintaining the global prestige of our events," ICC chairman Jay Shah said in a statement ahead of the tournament which will be held in Pakistan and the UAE.

Each group stage win would



be worth over USD 34,000 (INR 30 lakh) for the victorious team.

Teams finishing in fifth or sixth place will receive USD 350,000 each (INR three crore), while the seventh and eighthplaced sides will take home USD 140,000 (INR 1.2 crore).

Additionally, all eight teams will receive a guaranteed USD 125,000 each (INR 1.08 crore) for participating in the event.

This tournament marks the first time Pakistan will host an ICC event since 1996. However, India will play all their matches

in Dubai owing to security concerns related to travelling to Pakistan. Rohit Sharma's men will begin their campaign on February 20 against Bangladesh.

The Pakistan leg will feature games in Karachi, Lahore and Rawalpindi.

Dakistan's international footballers are facing another spell in the sporting wilderness after the country's federation was hit with a third FIFA suspension in less than eight years, just a month before the men's national team was scheduled to start qualification for the 2027 Asian Cup.

FIFA recently announced the latest ban after the Pakistan Federation Congress voted on Jan. 25 to reject changes to its constitution that were recommended by the sport's world governing body and the Asian Football Confederation. It follows similar punishments in 2017 and 2021 which lasted five and 14 months respectively.

"It's not surprising any more as there are power struggles in Pakistan football with people promoting themselves and not caring about the game," Pakistan international Navid Rahman told The Associated Press. "Also FIFA and the AFC should take some of the blame as this is a recurring issue which should have been sorted out before."



In 2017 and 2021, FIFA banned Pakistan due to third-party interference in the running of the PFF. In 2019. FIFA installed a Normalization Committee to run Pakistan soccer and organizing PFF elections. With no elections yet held, the committee is still in

There has also been a lack of action on the field with no nationwide league in the country of more than 250 million since 2019 and no national team games

played at home for eight years after 2015.

That barren run ended in 2023 when Pakistan defeated Cambodia in Islamabad to progress to the second round of World Cup qualification for the first time. It meant six more official international fixtures and some optimism for the future.

"As soon as there is a little traction that develops in Pakistan football then something happens" Rahman said. "For a player my

age, the last 10 years have been terrible. There have been three FIFA bans and a global pandemic. So much time has been taken away from us."

Pakistan, which is No. 198 among FIFA's 210 ranked national teams, was set to start Asian Cup qualification against Syria on March 25. Soccer's Asian organizers have stated that if the national team is to compete, the ban needs to be lifted by March 4.

There may be a chance. The PFF has decided to hold an Extraordinary Congress on Feb. 27 at Lahore where "the revision of the PFF Constitution as suggested by FIFA and AFC," is on the agenda, according to a letter, dated Feb. 12, sent by Muhammad Shahid Niaz Khokhar, the PFF's acting general secretary, to congress members.

Any development would be welcomed by players. "The Asian Cup qualifiers are

huge," Rahman said. "The issue with the national team is a lack of official games. It's now time for a permanent solution that allows football to resume and whatever elections need to be held, should go ahead.


The second leg is next Thursday at Tallaght Stadium in Dublin.

Depression could hasten pace of developing physical conditions by over 30 pc study finds

New Delhi, Feb 14: Adults with depression could develop chronic conditions, such as osteoarthritis and hypertension, 30 per cent faster as compared to those with no history of the mental disorder, according to a study that suggested physical effects of the mental condition.

Researchers, led by those from the University of Edinburgh, UK, said that treating depression should, therefore, involve methods that help manage both mental and physical health.

The mental disorder, marked by a persistent low mood, is known to heighten one's chance of developing heart disease or diabetes, with previous studies having looked at a patient's risk of developing a small number of illnesses, according to the authors

However, the study, published in the journal PLOS Medicine, examined people with a history of depression for their risk of developing 69 physical conditions. Over 1.7 lakh people from the UK Biobank were followed for an average of about seven years.

The team noted that those with depression had an average of three physical conditions, hypertension being the most common, compared with an average of two in those without

of two in those without.

Over the study period, the participants with a history of depression developed an average of 0.2

additional physical conditions a year, while those without accrued 0.16.

"The most common new conditions were osteoarthritis (15.7 per cent of those with depression at baseline vs 12.5 per cent without), hypertension (12.9 per cent vs 12 per cent) and gastroesophageal reflux disease (13.8 per cent vs 9.6 per cent)," the authors were to

The results revealed that a history of depression could be a marker indicating a risk of developing physical conditions in the

The team added that while most healthcare systems are designed to treat conditions individually rather than individuals with multiple conditions, approaches combining methods to manage mental and physical health could improve outcomes.

Risk factors, such as smoking, high body mass index and low physical activity, could also contribute to how quickly an individual with depression develops physical conditions in middle-and old-age, which present opportunities for improving future health, the authors said.

About 18 per cent of the study group had a history of depression at the start of the study. Widespread pain in the body, sleeplessness, stressful life events, loneliness and obesity were more common among these participants, compared to those without depression.

Russia detains another US citizen on drugs charges days after swap, reports say

Moscow, Feb 14: Russia has detained another US citizen, after customs officials found cannabis-laced marmalade in his luggage, Russian media said Friday, days after a Moscow-Washington prisoner swap that the White House called a diplomatic thaw and a step toward ending the fighting in Ukraine.

Russian police said the 28-year-old American had attempted to smuggle a "significant amount" of drugs into the country, the Interfax agency reported, citing Russia's Federal Customs Service.

The agency said the American was detained at Moscow's Vnukovo airport after flying in from Istanbul last Friday.

Mash, a Russian Telegram channel with links to the security services, said the US citizen, identified only as K. Byers, faced up to seven years in prison if convicted.

There was no immediate



comment from the US State Department. The Washington-Moscow prisoner exchange this month saw Alexander Vinnik, a Russian cryptocurrency expert who faced Bitcoin fraud charges in the United States, returned to Russia after being freed for American Marc Fogel, a teacher from Pennsylvania who was detained in 2021 when traveling to Russia to work at a school.

Fogel had been serving a 14-year sentence for having

with what his family and supporters said was medically prescribed marijuana. President Joe Biden's administration designated Fogel as wrongfully detained in December.

President Donald Trump on Wednesday upended three years of US policy toward Ukraine, saying he and Russian leader Vladimir Putin had agreed to begin negotiations on ending the conflict following a lengthy direct phone call.

Military flight from US with 119 illegal immigrants to reach in Amritsar on Feb 15

Washington, Feb 14: A military flight will deport 119 individuals, who were in the US illegally and will reach Amritsar in India on Saturday, hours after Prime Minister Narendra Modi asserted the need to fight against the "ecosystem" of human trafficking.

Earlier this month, a US military aircraft carrying 104 illegal immigrants from various states landed in Amritsar, the first such batch of Indians deported by the Trump government as part of a crackdown against illegal immigrants.

down against illegal immigrants. Sources told PTI on Friday here that one military flight will be reaching Amritsar on February 15 with 119 people.

On Thursday, Prime Minister Modi, during a joint press conference with US President Donald Trump here, asserted the need to fight against the "ecosystem" of human trafficking that lures people from ordinary families with big dreams and promises and are brought to other countries as illegal immigrants.

"This is not a question about India only but is a global issue," Modi said in response to a question by PTI on the issue of illegal immigration during the joint press conference with Trump in the White House.

He said, "We are of the opinion that anybody who enters and lives in another country illegally, they have absolutely no legal right or authority to live in

Modi added that as far as India and the US are concerned, "we have always said that those who are verified Indian citizens and who are living in the US illegally, India is prepared to take them back."

Later, in response to a question by PTI on the deportation of illegal immigrants from the US and whether the issue of the manner in which they were brought back to India in the first military aircraft and shackled was raised during Modi's meeting with Trump, Foreign Secretary Vikram Misri said "yes, it (issue of illegal immigration) did figure during the discussions today."

Misri added that Modi did emphasise during the discussions that the return of illegal immigrants is not the end of the story.

Bakery owner in New England says he was offended over town's decision against pastry painting

Concord, Feb 14: A New Hampshire bakery owner testified Friday that his excitement about displaying a painting by high school students of giant pastries quickly turned to annoyance after a zoning code officer told him it was a sign and had to be changed or removed.

Sean Young said the the work atop his bakery is art, and was never intended to be a sign.

"I was artistically offended for the students," said Young, who's suing the town of Conway because he says it violated the First Amendment's guarantee of free speech. "It's offensive to move it," he

"It's offensive to move it," he said in court Friday. "I just didn't want to do it."

A federal judge is considering whether the town is infringing

on Young's rights. For now, the painting has been allowed to remain since it was first displayed in June 2022. The zoning board determined the painting is not

so much art as advertising.

If it didn't show what's sold

inside — baked goods — it wouldn't be considered a sign and could stay, board members said. But because of its size, they say it can't remain as-is. At about 90 square feet (8.6 square meters), it's four times bigger than the local sign code allows.

Jeremy Gibbs, the zoning officer who issued the citation, testified that he was following the town's definition of a sign, which some lawyers and even the judge remarked seemed to cover "everything."

A sign in Conway is "any device, fixture, placard, structure or attachment thereto that uses color, form, graphic, illumination, symbol, or writing to advertise, announce the purpose of, or identify the purpose of any person or entity, or to communicate information of any kind to the public, whether commercial or noncommercial,"

according to the sign code.
Gibbs testified that if there

Gibbs testified that if there were no regulation, then signs could be placed anywhere and there could be safety concerns about lighting or distracted drivers. He also noted that Conway, near the White Mountains, draws tourists to its natural resources.

If signage was unregulated, he said, "we could lose a lot of that District Judge Joseph Laplante couldn't resist adding a bit of levity to the proceeding.

"It's shocking that no one brought doughnuts to this trial," he said at one point.

During another moment, he asked Young to describe each pastry in the painting, starting with a scone on the left. He quibbled over Young's description that a raspberry cookie was actually the top of a cupcake.
