## LG Sacks 3 Govt Employees For Terror Links

Srinagar: Jammu and Kashmir Lieutenant Governor Manoj Sinha on Saturday dismissed three government employees including a jailed policeman for their alleged terror links, officials said.

ployees have been identified as police constable Firdous Ahmad Bhat, teacher in school education department Mohammad Ashraf Bhat and orderly in forest department Nisar Ahmad Khan who was earlier arrested in connection

with the killing of a National

Conference minister in 2000,

The officials said the LG invoked Article 311 (2) (c) of the Constitution to terminate the services of the three employees after investigation by law enforcement and intelligence agencies clearly established their terror links.

Over 70 government employees have been fired by the LG in the Union Territory for their terror links in the past few years.

## Waqf Bill To Safeguard Muslim Properties: Rijiju

Says Budgetary Allocations According To UT Status | 'No Timeline For Statehood Restoration'

Srinagar: Union minister Kiren Rijiju on Saturday said that the Waqf (Amendment) Bill is for transparent management of properties for the benefit of Muslims. "There is no way that anyone can snatch the properties," Rijiju said.

Rijiju claimed that Andhra Chief Minister N Chandrababu Naidu and his Bihar counterpart Nitish Kumar were on board with the government's decision.

Asked if Naidu and Kumar were supportive of the bill, the minister replied in the affirmative saying several Muslim MPs too have privately supported it.

"Several Muslim MPs have expressed support (for



the bill) while thousands of Muslims, including women, have welcomed it," Rijiju said. He said Prime Minister

He said Prime Minister Narendra Modi and Home Minister Amit Shah have made it clear that statehood to Jammu and Kashmir will be restored in due course of time. However, Rijiju, who holds the parliamentary affairs and minority affairs portfolios, declined to give a timeline for the restoration of state-

hood to the Union Territory.
"The prime minister and

the home minister made clear indications in the past that in due course of time, statehood will be restored (to Jammu and Kashmir) and the powers and functions will be demarcated very clearly,"

Rijiju told reporters here.

The Lok Sabha MP from Arunachal West said he would not like to comment on the timeline for restoration of statehood or division of powers between the lieutenant governor and the elected chief minister at this time as his visit to Kashmir was confined to the Union Budget.

## J&K No Longer Conflict Zone, Hopes Soaring High: Dhankhar

Says Art 370 Was Temporary Provision, Ambedkar Refused To Draft It

Jammu: A new journey began in Jammu and Kashmir after the "historic" abrogation of Article 370 in 2019 with the sacred region no longer considered a conflict zone and the hopes of its people soaring high, Vice-President Jagdeep Dhankhar said on Saturday.

He reiterated that Article 370 was a temporary provision and Dr B R Ambedkar, the architect of the Indian Constitution, had refused to draft it.

Addressing a gathering



during the 10th convocation ceremony of Shri Mata Vaishno Devi University (SMVDU), the vice president said, "Where there was once disorder, we now witness real order and tability."

"The aspirations of generations found wings when the constitutional walls of separation crumbled in 2019 with the historic abrogation of Article 370. In the sacred land of Mata Vaishno Devi, a new pilgrimage began --the journey from isolation to integration. Article 370 was a temporary article in the Constitution," he said.

B R Ambedkar, the architect of the Constitution, drafted all articles except Article 370, he said. "I would urge | More on P10



#### Peoples Panel Plans Varsity On Open Land

SRINAGAR: A group of citizens who have gathered under the banner of "Elaqaie Coordination Committee Jamia Imambargah Shalimar" have announced the decision to establish "Imam Jaffar Sadiq University" on vacant land between Ishbar and Lashkari Mohalla.

The body claims that the land was originally designated for rehabilitation of Dal dwellers but the plan was later shelved and those relo-

cated from Mir Behri area of Dal were instead shifted to Rakh-e-Arth Bemina.

Vast tracts of vacant land, according to the statement signed by committee chairman Muhammad Yusuf Wadoo, will be utilised for the university and a hospital. The statement has also disclosed the name of a former High Court judge as proposed varsity's Vice Chancellor. 

## **Tower Blasts Deepen Power Crisis**

Qazigund Fault Forces Extra Shedding

SRINAGAR: Power supply to the valley seemed to take a turn for the worse this evening with possibility of total darkness looming in event of blasted transmission towers near Banihal town collapsing under the impact of heavy snowfall in the region. Authorities were keeping their fingers crossed in anticipation of the damaged towers withstanding heavy snowfall or fierce winds. They were under stood to be charting desperate contingency measures, including temporary restoration, to tide over the grim situation arising out of the blasts. The picture would be dear by tomorrow.

According to reports, mysterious blasts reportedly triggered by some 'unidentified persons' on Sunday and Monday morning damaged the double circuit 132-KV Udhampur-Srinagar transmission tower in 220-KV Kishenpur Pampore transmission tower in Banihal area. All the four legs ofthe 132-KV tower are damaged while the 220-tower, though standing has tumbled twards one side. Their total collapse can cut off the entire power import to the valley, leaving it with a mere 70 megawatts (mw) - 50 mw from uri project and 20 mw from other power stations - barely sufficient for the essential loads only.

When contacted, the power development commissioner, Vinod Sharma, told Kashmir Observer this evening a of engineers led by a superintending engineer visited the spot yesterday and, after collecting some equipment, left Udhampur again today to start restoration of the damaged towers, possibly tomorrow. Strengthening of the 220-KV tower and re-erection of the '132-KV tower would be taken up simultaneously. He said it would require a minimum of three days to effect the repairs.

Meanwhile, Sharma said, extra curtailment was resorted to in the valley this evening following a snag in one of the circuits of 220-KV transmission line between Qazigund and Wanpoh. With a big question marie banging over the 17-hour relief in six days provided to the valley consumers last week, the availability of energy is likely to be badly disrupted. At present, the power import has come down to 230 mw which includes 50 mw from Uri project. The availability had I gone up to 350 mw last week, mainly due to fall in demand, facilitating the 17-hour relief.

Sharma said one of the double circuit 132-KV Udhampur-Srinagar transmission line had been in a state of disrepair for the past two years. This leaves the department with only one circuit of this line besides the 220-KV Kishenpur-Pampore transmission line to import power to the valley. However, Sharma insisted the valley was getting "more than 55 per cent" of the available power against Jammu's 45 per cent. He attributed the longer spells of darkness in Kashmir to tigher con-sump turn" compared to Jammu region's load.

It may be recalled two transmission towers of both 132-KV and 220-KV lines at Qazigund were blasted in similar circumstances on the night between January 13 and 14 last year followed by blasting of 400-KV tower at Kutpora near Wagoora in Budgam district a day later. The power supply to the valley was disrupted for more than a fortnight till the temporary restoration equipment was airlifted from Delhi for erect the damaged towers. Curiously, the blasts have been taking place only in winter.

## **Jaishankar Slams West's 'Double Standards' On Democracy**

New Delhi: External Affairs Minister S Jaishankar took a dig at the Western countries for treating democracy as a "Western characteristic", accusing them of not practising abroad what they valued at home.

Jaishankar made these remarks on Friday at a panel discussion titled "Live to Vote Another Day: Fortifying Democratic Resilience" at the Munich Security Conference.

He also said that "if you do want democracy eventually to prevail, it's important the West also embraces successful models (democracy) outside the West." "There was a time — I have to say this in all honesty — when the West treated democracy as a Western characteristic and was busy encouraging non-democratic forces in the Global South. It still does. Everything you value at home, you don't practice abroad. "So, I do think the rest of the Global South will view the successes, shortcomings and the responses of

other countries," he said.

He also said India, for "all the challenges that we have had, even at a low income, we have stayed true to the democratic model, which is almost if you look at our part of the world. We are pretty much the only country that has done that." "So I think it's something the West should look at, because if you do want democracy eventually to prevail, it's important the West also embraces successful models outside the West,"

Today since we are a democratic society we give nutrition support, and food to 800 million people. That is a matter of how healthy they are and how full their stomachs are. So, the point I want to make is that different parts of the world are going through different conversations. Please do not assume that this is a kind of universal phenomenon, it is not," he said.

"There are parts where it is working well. Maybe there are parts where it's not and the parts which are not. I think people need to have honest conversations about why it's not," the External Affairs Minister said.

## OpenAI board Rejects Musk's \$97.4 Billion Offer

Washington: OpenAI on Friday rejected a \$97.4 billion bid from a consortium led by billionaire Elon Musk for the ChatGPT maker, saying the startup is not for sale and that any future bid would be disingenuous.

The unsolicited approach is Musk's latest attempt to block the startup he co-founded with OpenAI CEO Sam Altman — but later left — from becoming a for-profit firm, as it looks to secure more capital and stay ahead in the artificial intelligence race.

"OpenAI is not for sale, and the board has unanimously rejected Mr. Musk's latest attempt to disrupt his competition.

Any potential reorganization of OpenAI will strengthen our nonprofit and its mission to ensure AGI benefits all of humanity," it said on X, quoting OpenAI Chairman Bret Taylor on behalf of the board.

Musk's lawyer Marc Toberoff, in a statement, responded that OpenAI is putting control of the for-profit enterprise up for sale, and said the move will "enrich its certain board members rather than the charity.

OpenAI in late December had outlined plans to revamp its structure, saying it would create a public benefit corporation to make it easier to "raise more capital than we'd imagined," and remove the restrictions imposed on the startup by its current nonprofit parent.

Altman on Monday had rebuffed the consortium's offer with a "no thank you" posted on X, prompting Musk to retort: "swindler."

On Tuesday, Altman told news website Axios that OpenAI



Musk's lawyers, in a court filing on Wednesday, said the consortium, which includes Musk's own AI startup xAI, would withdraw its bid for OpenAI's non-profit arm if it drops plans to become a forprofit entity.

"Two days ago, you filed a pleading in court adding new material conditions to the proposal. As a result of that filing, it is now apparent that your clients' much publicized 'bid' is in fact not a bid at all," the OpenAI board said, according to a letter signed by William Savitt, a lawyer representing the company, and sent to Toberoff on Friday.

Other investors in the consortium include Valor Equity Partners, Baron Capital and Hollywood power broker Ari Emanuel.

Altman and Musk have been at loggerheads for years.

After Musk's departure in 2019, OpenAI created a for-profit arm that has drawn billions of dollars in funding, sparking allegations from Musk that the startup breached its original mission by putting profit ahead of the larger

Musk sued Altman, OpenAI and its biggest backer, Microsoft, in August last year for alleged breach of contract.

In November, Musk asked a federal court for a preliminary injunction to block OpenAI from moving to a for-profit structure.

## **Envoy Confirms Iran's Indirect Contact With** Syria's De Facto Rulers

Tehran: The Iranian foreign minister's special envoy for Syria has confirmed that Tehran is indirectly in contact with the ruling Hay'at Tahrir al-Sham (HTS) administration in Syria, more than two months after the militant group captured Damascus.

Mohammad Reza Raouf Sheibani's announcement on Saturday came after remarks by Syria's de facto foreign minister Asaad Hassan al-Shihani about the exchange of "positive messages" between the two Muslim states.

The seasoned Iranian diplomat highlighted that Tehran has a forward-looking approach vis-à-vis developments in Syria and seeks restoration of ties with Damascus.

Iran is closely and patiently monitoring the status quo in Syria and will take its appropriate decisions in due time, Sheibani said.

He underlined the need for all Syrian political parties to have a role in shaping Syria's future.

"The Islamic Republic of Iran's positions concerning the developments in Damascus are clear. Given Syria's special position in the West Asia region, we believe that its future and fate must be decided by its own people with the involvement of all political currents,"

Sheibani stated

He emphasized that Syr ia's stability and peace are of paramount importance to Iran, and the Islamic Republic is opposed to any foreign intervention in the internal affairs of the Arab country.

Sheibani also noted that he has discussed Syria with the Russian president's special envoy for Syria Alexander Layrentiev and Russian Deputy Foreign Minister Sergey Vershinin during a recent visit to Moscow.

Tehran and Moscow share views about a series of issues regarding Syria, he stated.

Syria's de facto foreign minister said on Wednesday that his country had received positive messages but wanted further reassurance from Russia and Iran.

he Central Vigilance Commission has directed the Public Works Department of Delhi government to conduct a detailed probe into the alleged merger of properties to expand the 6, Flagstaff Road bungalow and the expenditures incurred on its interiors, BJP leader Vijender Gupta said on Saturday.

The bungalow labelled as "Sheesh Mahal" by the BJP for alleged corruption was occupied by Arvind Kejriwal as the chief minister of Delhi from 2015 till the first week of October last year.

No immediate reaction was available from the Aam Aadmi Party (AAP) or its convener Kejriwal on the matter.

Gupta said the Central Vigilance Commission (CVC) took cognisance of his two earlier complaints and sought factual reports from the Public Works Department (PWD) based on which it has now directed to conduct a detailed probe.

In his first complaint to the CVC, the newly-elected BJP MLA from Rohini alleged that Kejriwal flouted building regulations to construct a lavish mansion covering 40,000 square yards (8 acres) of land.

Government properties, including plot Nos. 45 and 47 on Rajpur Road (previously housing senior officials and judges in Type-V flats) and two bungalows (8-A and 8-B. Flag Staff Road) were demolished and merged into the new residence, violating ground coverage and floor area ratio norms and lacking proper layout plan approvals, Gupta alleged.

In his second complaint, Gupta alleged "extravagant spending" on the renovation and interior decoration of the bungalow on 6, Flag Staff Road. He also claimed "massive financial irregularities" and expenditure of crores of rupees from the taxpayers' money on luxurious amenities in the bungalow.

#### **Srinagar Dental College Doctor Suspended Amid Inquiry**



**SRINAGAR:** A controversy has erupted at the Government Dental College (GDC) in Srinagar after a patient alleged that a doctor extracted the wrong tooth during a procedure. The incident, which has sparked public outrage, led to the suspension of the involved doctor and the formation of a threemember inquiry committee to investigate the matter.

The patient, Nadeem Ahmad,

surprise at the later accusation of extracting the wrong tooth, especially since the patient had indicated the upper tooth and didn't object during the anesthesia process. Dr. Meeran also highlighted that the consultant had confirmed the extractions were correct, but the patient later changed his statement. He performs numerous extractions daily and questions why only this case is being scrutinized. He maintains implied consent was obtained.





claimed that the doctor mistakenly removed his healthy upper right tooth instead of the problematic lower right tooth. Following the procedure, Ahmad took to social media to share his ordeal, which quickly garnered widespread attention and criticism from the public.

In response to the allegations, the Principal of GDC Srinagar, Professor Aijaz Shah, confirmed that the doctor involved in the incident has been suspended pending the outcome of the inquiry. "A three-member com-mittee, led by a senior professor and including the Medical Superintendent and Administrative Officer, has been formed to investigate the matter. The committee has been directed to submit its findings within three days," Dr. Shah stated.

He further emphasized that GDC Srinagar is committed to providing the best possible care to its patients and assured that there would be no compromise on patient care under any cir-

Dr. Meeran, the suspended doctor, speaking to Kashmir Observer, explained that the patient presented with his assistant professor, and the case had been discussed with the consultant, Dr. Altaf, who had devised a treatment plan. Dr. Meeran said he was asked to extract the upper right tooth.

He described the procedure, noting that he asked the patient which tooth was bothering him, and the patient pointed to the upper tooth. Dr. M ministered anesthesia, with the patient's attendant and his own assistant present. He claims the patient was satisfied after the extraction and left without complaint. He expressed

"During anesthesia, the patient's attendant was present, as was my anesthesia assistant. If the patient had any concerns, he could have stopped me at that stage. The extraction went smoothly, and the patient did not express any discomfort at the time. Later in the day, I received a call claiming that the wrong tooth had been extract-

ed. However, my consultant,

Dr. Altaf, reviewed the case and

confirmed that the extraction

was correct," the suspended

doctor said.

Dr. Altaf Hussain Malik, Assistant Professor at the Dental College, corroborated Dr. Meeran's account. He explained that Nadeem Basheer presented with pain and was examined by Dr. Meeran. Dr. Altaf stated that the upper third molar was malposed, while the lower right molar was carious but erupted. He explained that while the upper molar was sound, it was decided to extract it due to its position, a procedure known as therapeutic extraction. He emphasized that such extractions are sometimes necessary to prevent future problems, like infections or discomfort.

He defended Dr. Meeran's qualifications and experience, stating he has full faith in him and that the doctor acted according to accepted practice.

"Dr. Meeran documented the procedure and even gave the extracted tooth to the patient. He cautioned against rushing to judgment without considering he doctor's qualifications and the rationale behind the extraction," he said. He reiterated that not all sound teeth are extracted, but sometimes malposed or impacted teeth are removed for the patient's benefit.

#### **Achabal Garden Dries Up Amid Climate Change**



**ANANTNAG:** For the first time, the historic Mughal garden at Achabal, once a lush marvel known for its cascading waterfalls and natural spring, is facing an unprecedented crisis as its water sources dry up due to climate change. The iconic garden, built by Empress Nur Jahan in the 17th century, is struggling with severe water scarcity, leaving its foun-

tains and streams barren. Shabir Ahmad, a local resident and social activist, said, "We have never witnessed such a change in the Mughal Garden at Achabal drying up. This is the first time we are seeing such a disheartening scene."

He said the spring has completely dried up, leading to a shortage of drinking water. "Our sinshow we are polluting the water bodies-along with a decline in rain and snowfall due to climate change, are the main reasons for

this worsening situation," he said. When asked about the future

situation, he said, "When water is not available, how can we irrigate our land? Both horticulture and agriculture depend on water, and

this situation will have a severe impact. Shortages have already started in nearby areas, and people are suffering as they now rely on water tankers. It is time to unite and work together to preserve our water bodies from pollution."

"Achabal Garden is our heritage, a part of our identity. Seeing it dry up is heartbreaking," said Mushtaq Ahmad, a local resident. "If immediate action is not taken, we fear it may never be the same again."

Experts attribute the crisis to rising temperatures, deficient rainfall, and depleting groundwater levels. "Climate change has altered precipitation patterns in Kashmir, affecting the natural springs that have sustained Achabal Garden for centuries," Dr Masoon A. Beig, a geographer, told KNO. "The reduction in snowfall and prolonged dry spells have further worsened the

Gowhar Ahmad, AEE Jal Shakti Achabal, said that the Achabal spring catered to over a dozen villages, with as many as 15 water supply schemes depending on the source. However, after the spring dried up, the villages are now being served by tanker services.—(KNO)

#### **Pvt Hospitals Association Urges** Govt To Take Them On Board

**SRINAGAR:** Private Hospitals Asso- 50-60% of total surgical cases." the government must take them on board before taking any decision regarding Ayushman Bharat Scheme, a health insurance programme that provides free or low-cost care to eligible families.

Members of the private hospital association said that the reservation of four surgical procedures for public hospitals, a 10% reduction in UT-specific incentives, and the implementation of HBP 2.2 instead of HBP 2022 are not in their interests.

"These measures are anti-private sector and will push many hospitals to the verge of bankruptcy, given that we have already been suffering for the past ten months," they said.

They said that the government owes them over Rs 100 crore and despite that they have always cooperated and are ready to cooperate in future also.

They said that the pre-bid offer of the government to the insurance company must be delayed and the government must take the private hospitals association on board as they are the important stakeholders in the scheme. "The government's plan to exclude key surgeries such as gall bladder, hemorrhoids, appendectomies and fissure from the scheme and restrict them to government hospitals is a concern as these surgeries constitute around

procedures would not only defeat the purpose of providing free healthcare but also increase patient suffering, as government hospitals already have long waiting lists.

They warned that financially stable patients may opt for private hospitals and pay for their treatment, while economically weaker patients would be forced to wait for months for their turn at public hospitals and they may have to sell their assets to avail treatment.

They cautioned that staff layoffs would become inevitable as private hospitals are likely to experience a 50-60% drop in surgical procedures, worsening the unemployment crisis in the region.

The association urged the authorities to implement the reforms to ensure the sustainability of the SEHAT scheme. "These reforms include implementation of HBP 2022 (approved by the National Health Authority in 2022), special rate revision for dialysis patients to reflect rising operational costs, no reservation of surgical procedures for government hospitals so that patients retain the right to choose between public and private healthcare under PMJAY, adherence to National Health Authority guidelines to ensure fair reimbursement practices," they said.—(KNO)

## **Kashmir's Faith** and Media Ethics Crisis

The Waripora Kunzar Incident Exposed the Deep-Rooted Fault Lines of Kashmiri Society

he recent incident in Waripora Kunzar Tangmarg, Baramulla, where a psychologically unwell man attempted to construct a replica of the Kaaba and invited people to perform Umrah there, sparked widespread outrage across Kashmir. In addition to making false religious claims, he also likened himself to the revered Kashmiri saint Sheikh-ul-Alam (RA). The public backlash prompted authorities to demolish the structure and arrest the individual.

This episode raises several critical concerns. It highlights the issue of religious gullibility, the media's role in sensationalizing sensitive matters for social media traction, and the shifting perception of Hajj and Umrah—from deeply spiritual acts to symbols of affluence and status. These aspects warrant thoughtful reflection and discourse.

#### Religious Gullibility

Kashmir has a rich history of spiritual reverence, with countless people devoted to saints and Sufis who played a major role in shaping the region's religious consciousness. However, this deep-rooted faith sometimes borders on gullibility, allowing fraudulent individuals to exploit religious sentiments. The Waripora Kunzar incident is a prime example of how quickly some people can start following an mentally distressed individual without questioning his legitimacy.

In recent years, self-anointed "peers" have proliferated across Kashmir, claiming esoteric knowledge and divine ordination, amassing significant wealth, influence, and followership by preying on religious sentiments. The unsettling ease with which many Kashmiris deify such individuals blindly accepting them as Wali-A-Khuda (friends of God)—reflects a disconcerting trend.

Even in this instance, despite the man's overt mental disorders and the absurdity of his claim to establish an alternative Umrah, a faction of people still entertained his narrative. While the broader community denounced and repudiated his actions, the very occurrence of such an episode signals a systemic issue. Islam enjoins rationality and vigilance in recognizing religious authority, yet many continue to fall victim to pseudo-spiritual figures who exploit faith for personal gain.

The Waripora Kunzar Incident underscores the need for critical thinking in matters of faith. Blind reverence without discernment allows fraudulent individuals to manipulate religious sentiments for personal gain. The lesson here is to question, verify, and not follow blindly. Faith should be rooted in knowledge, not superstition. People must educate themselves to distinguish genuine spirituality from deceit ensuring that devotion does not become a tool for manipulation in the hands of opportunists.

the role of journalism. The increasing trend of sensationalizing sensitive events for social media engagement is deeply concerning. Instead of immediately reporting the issue to religious scholars or police, many journalists and social media pages took to filming and uploading videos. They prioritizes likes, shares, and views over ethical responsibility. They turned the situation into an entertainment spectacle. The footage of an unsound man making absurd claims became viral content, drawing the man in question, with many imitating his tone of recitation. This troubling scene highlighted the unintended consequences of media sensationalism. Had journalists acted responsibly, the negative impact of such incidents on children and society at large could have been mitigated. These kids, unaware of the gravity of their actions, were not just mocking a man but unknowingly disrespecting the Quran.

The press and digital media have an obligation to inform and educate rather than exploit such incidents for engagement. This event should have been handled with sensitivity, ensuring that a person with mental health issues was not made a subject of ridicule or hysteria. True journalistic responsibility would have entailed immediately

baseless religious assertions.

The fundamental question remains: if the man was of unsound mind, why were his claims afforded a public platform? The Waripora Kunzar case serves as a stark indictment of social media-driven journalism, which often prioritizes sensationalism over ethical reporting.

#### The Changing Nature of Hajj

Perhaps the most ironic dimension of this controversy lies in the pseudo-peer's justification—offering an alternative Umrah for those unable to afford travel to Mecca. While his proposition was patently fraudulent, it inadvertently exposes an uncomfortable reality: has Hajj and Umrah devolved into rituals of social elitism rather than

The proliferation of repeat pilgrimages, often undertaken as indulgent retreats rather than transformative spiritual journeys, inadvertently reinforces the notion that access to this sacred rite is contingent upon financial privilege, thereby diluting its intrinsic sanctity and relegating it to a mere token of opulence.

The Waripora Kunzar Incident indirectly raises the question: If pilgrimage were not increasingly associated with financial capability, would people even entertain the idea of an alternative Umrah?

Would it not be more virtuous to allocate these funds toward alleviating poverty rather than indulging in multiple pilgrimages? Should not resources be directed towards enabling financially disadvantaged believers to fulfill their Hajj obligations rather than being spent on redundant trips by the affluent? These pressing ethical questions merit introspection.

#### Conclusion

The Waripora Kunzar incident is symptomatic of deeper societal issues that demand urgent redress. As a community, Kashmiris must cultivate discernment in matters of faith, ensuring that religious devotion does not devolve into blind subservience. Equally imperative is the call for journalistic accountability—demanding reportage that upholds integrity rather than perpetuates sensationalism. The truth is this incident was not merely an isolated act of religious deception; it was a mirror reflecting the broader vulnerabilities of society

When the United States and India work together, i.e. 'MAGA' plus 'MIGA', the 'mega' partnership for prosperity is formed. And this mega spirit gives new scale and scope to our goals." The effusive language came despite the fact that Trump unhesitatingly announced reciprocal tariffs that would clearly impact India and in fact, underlined the tariffs in his remarks with Modi, calling out India as "just about the highest tariffs nation in the world". He added for good measure that "whatever India charges, we will charge them."

It was always clear that Trump would play by his own rules, and put India under pressure, as indeed he has done with other nations. Some of his ways are based on simplistic ideas set out in his book Art of the Deal - a cocky real estate developer's manual stretched thin to apply to other fields, and to life itself. Chapter 2 of the vintage 1997 book, republished in a mass market edition in 2005, is titled Trump Cards: The Elements of the Deal and it begins thus: "My style of deal making is quite simple and straightforward. I aim very high, and then I just keep pushing and pushing and pushing to get what I'm after. Sometimes, I settle for less than I sought, but in most cases I still end up with what I want.'

American foreign policy has always been about American interests, marked by short-termism and an instrumentality that has many of its claims to principles of openness, democracy or peace sound hollow. Now, the mask is off, the pretence of values is gone, and naked power-play is at work. India will

need to carefully navigate this partnership, expecting to be pushed, and so has to be ready with its own list of asks and redlines and non-negotiables. In short, the Trump playbook will have to be used against Trump.

#### Politics in play

Modi, and India, would be helped in this if the nation has a foreign policy approach that all political parties could sign up and profess as the agreed Indian consensus. In this, the BJP needs the Congress and other parties on its side to make strong, clear and specific demands on Trump instead of caving in on every ask made from the other side. But political bitterness has been brought even to foreign affairs, the bureaucrat-turned-foreign minister S Jaishankar personally feeding into some of it with barbs against Opposition leaders that apparently secure his position in the BJP and with the Prime Minister. Without this forced injection of bitterness, it should not have been difficult to have an all-party consensus to publicly condemn the way the Trump administration has begun the deportation of unauthorised Indians.

The use of a military plane, with Indian citizens

under deportation orders set in chains, and the act duly promoted in a video by the US agencies, is in poor taste and tries to showcase a negative image of India at the cost of dignity and rights of Indian citizens. It is shocking that Indians are being treated no different from migrants who have been called "high threat criminal illegal aliens"

India should condemn the US for treating Indians thus. The Prime Minister chose not to speak out on this openly. However, he correctly pointed out that gangs who help smuggle people illegally across borders must be curbed and that those who are poor are being misled and lured into a trap. This is the correct position. But the next logical step is to ask Americans not to treat Indians found to be undocumented as criminals, or put them in shackles as they are sent back. Instead, the Indian foreign minister has earlier been quoted as saying that this is normal procedure for the US. "The standard operating procedure for deportations by aircraft used by ICE (Immigration and Customs Enforcement of the US) that is effective from 2012, provides for the use of restraints," he said. How does this help at all? Is Jaishankar, the foreign minister of a Vishwaguru nation not ashamed about this treatment of ordinary Indians?

The planned deportation of 20,000 Indians from the US will require an endless stream of flights, if all are to be sent back, not to speak of more who are being caught as raids by US immigration continue. None of them should be allowed to be detained without access to lawyers, medical aid and humane conditions at the facilities they are kept in. None of them should be allowed to be sent back in chains. This is not to speak of other issues on which Trump will continue to push as teams from the two nations iron out energy deals and defence supplies. India can play along but only up to a point. It is important to draw a clear line beyond which India will not give in.



#### **ED Seizes 'Biggest' Crypto Fund** Worth ₹1,646 Crore In PMLA Case

**NEW DELHI-** The Enforcement Directorate (ED) has seized its biggest-ever cryptocurrency worth Rs 1,646 crore as part of a "mega" money laundering investigation into a fraud investment scheme where numerous depositors were duped in the name of securities investment, official sources said.

The Ahmedabad office of the federal probe agency has also seized Rs 13.50 lakh in cash, an SUV and a number of digital devices after it concluded a fresh round of searches on Saturday in the case related to "fraudulent" and unregistered offering and sale of securities in the form of investments through 'BitConnect lend-

ing program'.
The ED case, filed under the Prevention **Money Laundering** Act (PMLA), stems from an FIR of the Surat Police crime branch which said the alleged fraud that took place between November 2016 - January 2018 (after de-

monetisation). The agency deployed a team of its tech-savvy experts who examined the "complex web" of transactions carried out in "numerous" crypto wallets to unmask the origin and controllers of these crypto wallets.

It was found that many transactions were carried out through the "dark web" to make the transactions untraceable, the sources said.



ous" web wallets and gathered ground intelligence to zero-inon the wallets and the premises where the digital devices containing the said crypto currencies were available, they said.

Sources told PTI that cryptocurrencies worth Rs 1,646 crore were seized and transferred into a special crypto wallet of the agency making it the big-gest-ever seizure of virtual dig-

ital assets in a mega money laundering investigation which is still going on.

The agency found during the probe that the founder of BitConnect, an unincorporated organisation, established "a worldwide network of promoters, and rewarded them for their promotional efforts by paying them commissions.'

In order to "induce" investors to deposit funds in the form of cash and Bitcoins, into the purported lending program, BitConnect represented, among other things, that it would deploy a purported proprietary volatility software trading bot" (Trading Bot) that, they claimed would use investor funds to generate returns as high as 40 per cent per month,

## **New India Cooperative Bank's General Manager Held For** 'Misappropriation' Of ₹122 Crore

MUMBAI- The Mumbai police on Saturday arrested Hitesh Mehta, General Manager and Head of Accounts of the New India Cooperative Bank, for allegedly misappropriating Rs 122 crore from the bank, officials said.

Mehta was placed under arrest by the Economic Offences Wing (EOW) of the city police after being questioned for more than three hours, an official said.

He was called to record his statement before the probe agency at its south Mumbai office in connection with the case registered against him and others, he said.

Mehta will be produced before a local court on Sun-

day, the police official added. The Reserve Bank of India (RBI) on Friday superseded the cooperative bank's board for a year and appointed an administrator to manage its affairs. A day prior to that, it imposed several restrictions on the lender, including on withdrawal of funds by depositors, citing supervisory concerns emanating from the recent material developments in the bank, and to protect the interest of its depositors.



Acting Chief Executive Officer of the bank, Devarshi Ghosh, on Friday lodged a complaint against Mehta and others at the Dadar police station in central Mumbai for alleged misappropriation of the bank's funds, the police said.

'Based on the complaint, the police registered a case in the wee hours of Saturday, which was then transferred to the EOW for investigation," another official said.

As per the complaint, Mehta along with other associates hatched a conspiracy and embezzled Rs 122 crore from the safes of Prabhadevi and Goregaon offices of the bank, he said.

A case under the Bharatiya Nyaya Sanhita (BNS) sections 316 (5) (criminal breach of trust by public servants, bankers, and others in positions of trust), 61(2) (criminal conspiracy) was registered, he said.

During the investigation, it came to light that the misappropriation of the funds had started soon after the COVID-19 pandemic broke out. While the accused embezzled Rs 112 crore from the safe in Prabhadevi, Rs 10 crore were siphoned off from the Goregaon branch, he said.

"As Mehta's involvement in the crime came to the fore, the EOW placed him under arrest," the official said.

New India Cooperative Bank has 28 branches and most of them are located in Mumbai, while two are in Surat in neighbouring Gujarat and one in Pune.

"A new chapter has been added to the India-US partnership, enabling much stronger collaboration in strategic sectors including defence, energy, semiconductors, space and emerging technologies like artificial intelligence (AI), quantum computing, advanced materials, and biotechnology.

"This creates an environment for the private sector on both sides to flourish in true partnership. The visit is especially significant as it will boost acturing in India, attract increased foreign direct investment and create jobs," said Chandrajit Banerjee, Director General, CII.

Prime Minister Narendra Modi's discussions with President Trump strongly reaffirmed a commitment to expand trade and investment between the two countries, it stated.

CII welcomed the decision to work on the first phase of a bilateral trade agreement to reduce trade barriers and streamline regulatory processes, laying a strong foundation for increasing two-way trade.

It also expects that easier market access and regulatory harmonization will emerge from the proposed bilateral trade agreement dialogues, helping Indian products and services find greater foothold in the US market and vice versa.

## **Sebi Issues Rules For Related Party Transaction Disclosure**

NEW DELHI- Markets regulator Sebi has introduced industry standards for the minimum information that listed entities are required to provide to the audit committee and shareholders when seeking approval for the related

party transactions (RPT). The Industry Standards Forum (ISF) comprising representatives from three industry associations -- ASSO-CHAM, CII and FICCI -- have formulated these standards for minimum information to be provided for review of the audit committee and shareholders for approval of RPTs in consultation with Sebi under the aegis of the stock exchanges.

The industry associations and stock exchanges will publish these standards on their websites to facilitate a uniform approach and assist listed entities in complying with the requirements, the Securities and Exchange Board of India (Sebi) said in a circular on Friday.

The new disclosure requirements will come into effect from April 1, it added.

Under Sebi's LODR (Listing Obligations and Disclosure Requirements) rules, related party transactions (RPTs) require approval by the audit commit-

tee and from the shareholders as well, if material.

As per the modifications. Sebi said the listed entities are required to provide the audit committee with the information as specified in the industry standards while placing any proposal for review and approval of a related party transaction.

Similarly, the explanatory statement accompanying notices sent to the sharefor any RPT will include the information in addition to requirements under the Companies Act, 2013, the circular said.

Further, the regulator has directed the stock exchanges to bring the contents of this circular to the notice of the listed entities to ensure compliance, it added.

On Friday, Sebi launched a dedicated RPT portal to enhance transparency in corporate transactions.

'This portal will simplify investor access to critical governance data on RPTs. It will ensure that transparency in related party transactions is no longer a privilege reserved for institutional investors but a right accessible to all," Sebi's whole-time member Ashwani Bhatia said.

#### **Income Tax Dept Activates Section** Wise Mapping Of I-T Act, Tax Bill

NEW DELHI- Income Tax payers can now match the sections of the I-Tax Act, 1961, with the corresponding clauses in the simplified I-T Bill, 2025, on the tax department portal.

Also, Section to Section mapping as per Income Tax Act, 1961 and Section number as per New Income Tax Bill has been uploaded on the I-T department's website.

A simplified Income Tax Bill, 2025, was introduced in the Lok Sabha on February 13 by Finance Minister Nirmala Sitharaman. The Bill, once enacted, will replace the 64 years old Income Tax Act which has become bulky over time with its traditional style of drafting and numerous amendments.
The simplified Bill has a

word count of 2.6 lakh, lower than 5.12 lakh in the I-T Act. The number of Sections is 536, as against 819 effective sections in the existing law.

The number of chapters also have been halved to 23 from 47 currently. The Bill has 57 tables, compared to 18 in the existing act, besides formulae which make it easier for a taxpayer to calculate tax liability. It has removed 1,200 provisos and 900 explanations.

In a post on X, the department on February 14 said it has activated the utility to check Section of the Income Tax Act, 1961, vis-a-vis corresponding clause of the new Income Tax Bill. A taxpayer can select the section of I-T Act, 1961, from a



drop down menu and accordingly the corresponding clause in the I-T Bill will appear.

Besides, a section wise mapping has been given in tabular format for taxpayer convenience.

The Bill uses shorter sentences and has been made readerfriendly with the use of tables and formulae. Tables have been provided for provisions relating to TDS, presumptive taxation, salaries, and deductions for bad debt.

The Bill introduces a new concept of 'tax year' as the 12-month period beginning from April 1. This would replace the present concept of assessment and previous year. Currently, income earned in the previous year (PY) say in the year April 2024 to March 2025 will be assessed in assess-

ment year (AY) 2025-26.
The Bill will come into effect from April 1, 2026, after it is vetted by a Select Committee of the Lok Sabha and cleared by Parliament.

The new bill has omitted redundant sections, like those relating to Fringe Benefit Tax. The Bill is free from 'explanations or provisos', thereby making it easier to read and comprehend.

#### 'International Finance **Corporation Increasing Equity Investment In Pakistan'**

ISLAMABAD- The World Bank's private investment arm, the International Finance Corporation (IFC), is increasing equity investments and focusing on large-scale infrastructure financing in Pakistan, a media report said on Saturday. According to IFC Chief

Makhtar Diop, who is visiting Pakistan, the investment plan could unlock up to USD 2 billion annually over the next decade, reported The Express Tribune. His visit to Pakistan follows the

Diop highlighted the IFC's interest in Pakistan's agriculture, infrastructure, finance, and digital industries.

Additionally, Diop noted that equity-based transactions will play a larger role in the country's development as the IFC increases its equity investments globally, including in Pakistan.

According to Radio Pakistan, Prime Minister Shehbaz Sharif while talking to Diop, who called on him here on Friday, lauded the IFC's role in fostering private investments in Pakistan.



World Bank's announcement of a USD 20 billion Country Partnership Framework, with the IFC matching this allocation.

Diop emphasised that the USD 2 billion annual investment is not significant for Pakistan, which needs extensive infrastructure development in sectors such as energy, water, ports, and international airports.

Diop expressed confidence that within a few months, progress on key projects will signal Pakistan's readiness to receive large-scale financing for critical infrastructure.

The prime minister encouraged the IFC to enhance its support in key areas, including infrastructure and logistics, outsourcing of large airports, agriculture, information technology, mining, climate resilience, healthcare and water and sanitation.

Sharif stressed export-led growth and underlined the need for digitization of the entire ecosystem of Pakistan's economy. Ongoing digitization efforts of the Federal Board of Revenue were also highlighted.

## Trump's Reciprocal Tariffs And WTO Rules: An Explainer

NEW DELHI- American President Donald Trump has announced imposing reciprocal tariffs on its major trading partners including China that levy higher import duties on goods shipped from the United States.

He has already announced a 25 per cent duty on steel and aluminium imports, which will come into effect from March 12.

While announcing the new tariff

policy, the president has also spoken about how India is "right at the top of the pack" when it comes to tariffs. With all these countries being members of the global trade body World Trade Organisation (WTO), the

decisions of the US may challenge the WTO principles. A list of Q & As (questions and answers) to explain the wider implications of the US move:

#### Q. What is WTO?

A. The 166-member Geneva-based WTO is a multilateral body which for-

mulates rules for global trade and adjudicates disputes between the countries. Its main objective is to promote smooth, predictable and free flow of

Both India and the US have been members since 1995.

The nations have signed multiple agreements governing trade in goods, services, and intellectual property. These pacts set rules and guidelines for international trade.

#### Q. What are tariff commitments under WTO?

A. One of the key principles of the WTO is tariff binding, which ensures predictability and stability in global

Bound tariffs are the maximum tariff rates that a WTO member commits to under its Schedule of Concessions. These commitments are legally binding, meaning a country cannot impose tariffs above this level without rene-

Applied tariffs are the actual tariff rates a country levies on imports. These can be lower than the bound rate but cannot exceed it without violating WTO rules.

#### Q. What if a country imposes higher tariffs than the bound duties?

A. If a member country imposes a tariff higher than its bound commitment, it violates Article II of GATT (General Agreement on Tariffs and Trade) 1994, which says that members must not impose duties or charges exceeding those listed in their schedules and they cannot impose any other duties or charges that are not specified in their schedules.

Affected countries can file a complaint with the WTO Dispute Settlement Body (DSB) against high duties.

The first step to resolve the dispute under DSB rules are bilateral consultations. If consultations fail, the complainant country may be allowed to impose retaliatory tariffs or other trade countermeasures after receiving approval from the WTO.

Q. Can a WTO member increase its

#### bound tariff rates?

A. Yes. But only by negotiating that with affected countries under GATT Article XXVIII (Modification of Schedules), where it must offer compensatory concessions or by invoking emergency provisions like safeguards, or national security exceptions in spe-

The US under the previous Trump regime, had introduced additional tariffs of 25 per cent on steel and 10 per cent on aluminium products, on grounds of 'national security' under section 232 of its Trade Act. It had cited threats to domestic steel production capacity. However, the WTO has ruled against this measure in multiple

India had also imposed retaliatory duties on 28 American goods.

The Global Trade Research Initiative (GTRI) said that the WTO dispute panel stated that national security exceptions cannot be used arbitrarily and must be linked to real security concerns during war or emergencies.

#### Q. What did the US do in response? A. According to the GTRI, America

refused to comply with the WTO ruling, arguing that it has the sovereign right to determine its national security policies. It has also blocked the WTO Appellate Body, preventing an appeal resolution.

#### Q. Why countries like India have high import duties and developed countries like the US have low tariffs?

A. Developing countries like India maintain high import duties primarily to protect domestic industries, generate revenue, and support economic development.

These nations often rely on tariffs to shield their emerging sectors from foreign competition, promote self-suf-

ficiency, and manage trade imbalances. On the other hand, developed countries like the US have lower tariffs because their industries are already globally competitive, and they benefit from open markets that allow their businesses to access foreign consumers with minimal trade barriers.

Historically, according to the GTRI, when the WTO was established in 1995, developed nations agreed to let developing countries retain higher tariffs in exchange for commitments on Trade-Related Aspects of Intellectual Property Rights (TRIPS), services trade liberalization, and agricultural rules that primarily favoured wealthier nations.

#### Q. What is the special and differential treatment under WTO?

A. The WTO agreements contain special provisions which give developing countries special rights and allow other members to treat them more favourably.

For example, developing countries like India can take more time to reduce its tariffs and export subsidies than more rich nations.

#### Q. Does India have a right to fight the 25 per cent tariffs on steel and aluminium and the threat of reciprocal tariffs at the WTO?

A. Yes, according to RV Anuradha, Partner, Clarus Law Associates.

capital cities of Srinagar and Jammu, directing the security agencies to intensify anti-terror operations to neutralise terrorists and terror ecosystem.

The officials said the dismissed policeman, who was arrested in May last year, was initially appointed as Special Police Officer (SPO) in 2005 and subsequently promoted as constable in 2011.

Currently lodged in Kot Bhalwal Jail, Bhat was posted at a sensitive position of Electronic Surveillance Unit in the J-K Police but started working for terror outfit Lashkare-Taiba (LeT).

However, he got exposed when two terrorists -- Waseem Shah and Adnan Beigh -- were arrested in Anantnag with a pistol and a hand grenade as they were planning to attack non-local civilians and tourists, the officials said.

During the interrogation, Bhat revealed his sinister design and led to the recovery of a sizable quantity of arms including pistols, ammunition and explosives from his residential quarter in Police Housing Colony in Srinagar and a newly constructed house in Mattan, Anantnag.

According to the officials, 3 kg of charas was also recovered from his residence which was dropped by Pakistan-based LeT terrorist Sajid Jutt alias "Saifullah" through a drone in Samba district a few days earlier.

Using his police constable cover, he was transporting arms, ammunition and explosives for terrorists and investigation also revealed that he was also working for Hizbul Mujahideen's Commander Khursheed Dar and LeT terrorist Hamza Bhai and Abu Zarar besides Jutt.

"He not only provided classified information about security forces movement, collection, storage and delivery of arms ammunition but also guided terror attacks," the officials said.

They said he was also found involved in an attack on a police party in 2020 which led to the killing of sub-inspector Ashraf Bhat, an attack on a group of tourists in Pahalgam on May 18 last year that left two persons injured.

The officials said he was also involved in radicalising and luring the youth to join terror ranks besides using terrorists to blackmail government officials including his colleagues and businessmen.

They said Ashraf Bhat, a resident of Reasi who was appointed as 'Rehbar-e-Taleem' Teacher in 2008 and later regularised in June 2013, was affiliated with LeT.

"For many years his activities were undetected but eventually came to light in 2022 and he was arrested and currently lodged in district jail, Reasi," the officials said.

During the course of investigation, it was revealed that Bhat's handler was the most wanted LeT terrorist Mohd Qasim, who is based in Pakistan.

"LeT found him to be very useful because as a teacher Bhat was best placed to radicalise youth and carry out terror activities. He helped LeT to raise finances for terror activities and coordinated transport of arms, ammunition and explosives," they said.

Khan, who joined the forest department in 1996 as a helper and currently posted as an orderly at the forest range office, Verinag (Anantnag), was found working for Hizbul Mujahideen, the officials said.

They said his links with the outfit first came to light in the year 2000 when a landmine blast in Anantnag killed the then power minister Ghulam Hasan Bhat and two policemen.

"Khan and another accused had provided logistical support to the terrorists to carry out the attack. He also helped in smuggling RDX used in the blast," the officials said, adding he was arrested, chargesheeted but later acquitted in 2006 due to "witnesses backtracking, intimidating environment inside and outside the courts".

However, despite his acquittal in 2006, Khan continued his work for the terror group. His role was once again exposed in 2016 when he played a central role during the valley's unrest following the killing of Hizbul terrorist Burhan Wani, the officials said.

They said he also mobilised mobs and youth for stone pelting and arranged weapons to attack security forces and is named in four FIRs.

After the killing of another terrorist Yawar Nisar Wagay in 2017, he once again played a key role in organising violent protests and was subsequently detained under the Public Safety Act for eight months.

Lt Governor Manoj Sinha, earlier in the day, invoked Article 311 (2) (c) of the Constitution to terminate the services of the three government employees after investigation by law enforcement and intelligence agencies accused them of terror links.

In a post on X, Mehbooba said, "Arbitrary and summary dismissals of government employees has become a daily occurrence since 2019. What is perhaps most surprising and puzzling is that it continues unabated despite an elected government in power that had promised to put an end to such practices once in office."

The former chief minister said the people had pinned hopes on the National Conference government, expecting some relief.

"People had pinned their hopes on the new government expecting at least some relief through vigorous advocacy of these issues with the LG," she added.

JKPC Chief and Handwara legislator, Sajad Gani Lone said that "the termination of three employees is a stark reminder of our continued disempowerment."

"This will not work. More than the termination it is disdain and contempt of Delhi towards Kashmiris, that's revealed through these actions. These actions have not worked in the past. They will not work in the future. It will only widen the gulf and make it even more vicious," he said.

Mirwaiz Umar Farooq said that the termination of three more state employees in such an authoritarian manner is highly condemnable. "Do the rulers want to remove all Kashmiris slowly and steadily from government services and render them jobless? It is the duty of the elected representatives to take up this issue urgently with the concerned as they have committed in their manifesto, and stop this harassment. Also cracking down on Islamic literature and seizing them from bookstores while condemnable is ridiculous. Policing thought by seizing books is absurd to say the least, in the time of access to all information on virtual highways,' he wrote in a post on X.

BJP senior leader Abhijeet Jasrotia said those aiding terrorism are more dangerous than terrorists and must face strict laws.

He urged strict action against terror sympathizers, blaming Pakistan for J&K's turmoil and advocating intensified crackdowns. He emphasized government efforts for peace, highlighting discussions with traders and stakeholders. "Fear of violence has decreased, enabling development. We aim to restore a peaceful Kashmir," he stated.

Meanwhile, Awami Ittehad Party (AIP) senior leader and MLA Langate, Sheikh Khursheed also condemned the move, calling it a grave injustice and a violation of natural justice.

Sheikh Khursheed questioned the government's selective approach, stating: "Prime Minister Narendra Modi ji says 'Nation is one, Law is one,' but then why are government employees in Jammu and Kashmir being arbitrarily dismissed without even being given a chance to defend themselves? Why are we being treated differently? This discrimination must end."

He urged Lieutenant Governor Manoj Sinha to adhere to the commitments of PM Modi and ensure that people in J&K are not let down. He emphasized that arbitrary dismissals undermine faith in the system and create an atmosphere of uncertainty among government employees.

"J&K has a special situation. There is a lot of relief for horticulture and handicrafts. Special mission mode announcements have been made to enhance exports of handicrafts and Kashmiri art," Rijiju said.

After this Budget, small-scale and medium-scale industries will get a boost in Jammu and Kashmir, he added.

Rijiju also highlighted the provisions of the 2024-25 Union Budget, calling it a significant step towards achieving the vision of a "Viksit Bharat" (Developed India).

"In this budget, India's middle class has received a major relief as income up to Rs 12 lakh has been made tax-free. This is a big step towards the welfare of the people, allowing the middle class to live without financial hassles," he said, congratulating the middle-class citizens on the reform.

The Minister further pointed out that the budget has prioritized industrial growth, both for small and large-scale industries, while also taking major steps for farmers. "The Kisan Credit Card limit has been enhanced to Rs 5 lakh, ensuring better financial support for farmers," he said.

He credited Prime Minister Narendra Modi for prioritizing J&K's development, stating that PM Modi had instructed his cabinet ministers to engage with the region at the grassroots level. "The day is not far when Jammu and Kashmir will be counted among the most developed places in the world. Over the last decade, I have seen how the region has changed."

He said, "There is no shortage of resources from the Centre. Earlier, the infrastructure budget was Rs 1,000 crore, but today it has been increased to Rs 11,000 crore,"

Rijiju said that the Centre has put relentless efforts to transform Jammu and Kashmir during the past few years. "The Union Territory has witnessed remarkable infrastructure development, with express highways and railway connectivity linking Kashmir with the rest of the country," he said. "The events like the Khelo India Winter Games have put the region on the global tourism map."

The Minister also emphasized that the PM Modi led government has provided a clean and corruption-free administration. "No minister in our government has been found involved in any scam or corruption. If any act of corruption is detected, strict action will be taken. There are no loopholes in governance," he assured.

said, adding, "The Supreme Court has issued a slew of comprehensive directions in larger public interest to streamline urban development and enforcement."

The Supreme Court, the Bench said, in a catena of decisions has categorically held that illegality of unauthorized constructions cannot be perpetuated.

"If a construction is made in contravention of the Acts/Rules, it would be construed as illegal and unauthorized construction, which has to be necessarily demolished," the court said, adding, "It cannot be legitimized or protected solely under the ruse of the passage of time or citing inaction of authorities or by taking recourse to the excuse that substantial money has been spent on the said construction."

In the ultimate analysis, the Bench said, the Supreme Court opined that constructions put up in violation or deviation of building plan approved by local authority and constructions which are audaciously put up without any building

planning approval, cannot be encouraged.

"Each and every construction must be made scrupulously following and strictly adhering to the rules," the court said, adding, "If any violation is brought to the notice of the Courts, it has to be curtailed with iron hands and any lenience afforded would amount to showing misplaced sympathy."

The Supreme Court has also observed that unless the administration is streamlined and the persons entrusted with implementation of the act are held accountable for their failure in performing their statutory obligations, violations of this nature would go unchecked and become more rampant, the Bench said.

"If the officials are let scot-free, they will be emboldened and would continue to turn a nelson's eye to all the illegalities resulting in derailment of all planned projects and pollution, disorderly traffic, security risks, etc."

The court underlined that the Supreme Court issued a slew of directions and mentioned them. Among others, the Top court has said that while issuing the building planning permission, an undertaking be obtained from the builder/applicant, as the case may be, to the effect that possession of the building will be entrusted and/or handed over to the owners/ beneficiaries only after obtaining completion/ occupation certificate from the authorities concerned.

The builder/developer/owner shall cause to be displayed at the construction site, a copy of the approved plan during the entire period of construction and the authorities concerned shall inspect the premises periodically and maintain a record of such inspection in their official records, the court said.

"Upon conducting personal inspection and being satisfied that the building is constructed in accordance with the building planning permission given and there is no deviation in such construction in any manner, the completion/occupation certificate in respect of residential / commercial building, be issued by the authority concerned to the parties concerned, without causing undue delay," the court said,

adding, "If any deviation is noticed, action must be taken in accordance with the Act and the process of issuance of completion/ occupation certificate should be deferred, unless and until the deviations pointed out are completely rectified."

Referring to case in hand in which two brothers raised construction in Srinagar in "blatant violation of terms and conditions of building permission", the court said, authorities were required to take stern action against the officials and officers who were at the helm of affairs at the relevant point of time when the violations were committed by the duo.

Dhankhar also said that Jammu and Kashmir, which had the highest voter turnout in 35 years during the 2024 Lok Sabha polls, witnessed a 30-point increase in voter participation in the Valley.

"Democracy has found its real voice, its real resonance. The region is no longer a story of conflict; every investment proposal in new Kashmir is not just about capital, it is about trust being restored, faith being rewarded.

"The change is not imperceptible; it is

perceptible. Perception has changed, ground reality is changing, hopes of the people are soaring," he said. In just two years, Dhankhar said Iammu

and Kashmir received investment proposals worth Rs 65,000 crore, signalling strong economic interest in the region.

"For the first time since 2019, foreign

direct investment (FDI) has entered Jammu and Kashmir with multiple international companies showing interest. The region is a confluence of confidence and capital," the vice-president said.

"The visit of over two crore tourists in 2023 gave a tremendous boost to the local economy. What was once called heaven on earth is now a symbol of hope and prosperity. The winds of change have brought peace and progress. Let us be the architects of a new dawn for Jammu and Kashmir and for Bharat," he added.

Taking to social media, Matto remarked sarcastically, "As for NC's stand on a liquor ban and J&K being made a 'Dry State'—here we go. Since tourism and Arab countries, ergo 'Yes' to alcohol in Kashmir. Congratulations to the 'stakeholders' lobbying for free-flowing alcohol and the patron-party of everything rotten in Kashmir."

The controversy arises at a time when a private members' bill, proposed by PDP legislator Fayaz Mir and NC legislator Ahsan Pardesi, is set to be tabled in the upcoming budget session. The bill aims to implement a complete liquor ban in Jammu and Kashmir, in line with the cultural and religious sentiments of the majority population.

Soon, the team boarded an afternoon flight to Dubai amid heightened optimism of netting another global trophy after winning the T20 World Cup last

A Jasprit Bumrah-less India will open their campaign against Bangladesh on February 20 in Dubai before the muchanticipated blockbuster against traditional rivals Pakistan on February 23, and then the Men in Blue will take on New Zea-

land on March 2 to round off their league engagements.

The confidence -- of the fans and the team -- has been boosted by India's recent 3-0 ODI series whitewash at home over England.

Those supporters assembled at the Mumbai airport will be hoping that the icons, led by

Rohit and Kohli, will pull off another triumph like they did in the West Indies last year.

#### One Last Opportunity For

India will need some runs from Rohit and Kohli, who have copped heavy criticism after repeated failures in Test cricket.

But they replied in kind, as Rohit made a characteristically fluent hundred — a 90-ball 119 in Cuttack ODI against England - and Kohli his 73rd fifty in

This might have brought them a temporary relief but a productive outing in the Champions Trophy is mandatory in the context of the duo's future in top-flight cricket.

With the emphasis firmly on hitting the next World Test Championship cycle from June and building a team for the 2027 50-over World Cup the Ajit Agarkar-chaired selection panel will closely observe how the two veterans fare in Dubai.

achieved so much in their career. "It is important to normalise things in Indian cricket. We must not encourage this superstardom and super celebrities within the Indian cricket team," Ashwin said on his Hindi YouTube channel,

'Ash Ki Baat'. "We must normalise all these things going forward. We are cricketers. We are not actors or superstars.

'We are sportspersons, and we must be someone that the common people should resonate with, and can compare them-



selves with."

In recent times, Indian men's team's head coach Gautam Gambhir has also strongly spoken against the superstar culture in the team, and like Ashwin, urged that the focus should be on team effort rather than individual achievements.

Gambhir, himself a successful former India player who has rubbed shoulders with legends such as Sachin Tendulkar, Rahul Dravid and Anil Kumble, has made it his mission to end Indian cricket's affinity for superstardom.

Ashwin, who retired from international cricket after a glittering 14-year career, further said, "For example if you are a Rohit Sharma or a Virat Kohli, who have achieved so much. When you hit one more century, it is not just about your achievement anymore. It should be the business as usual, and our goals should be bigger than these achievements."

Ashwin believed that personal milestones should not overshadow the ultimate goal of winning tournaments for the country.

allow for an investigation. "Initially it was ascertained that the lady used a rolling pin for torture," spokesman Sajjad ul Hassan told AFP.

"The victim had multiple fractures; legs, ankle, arms, head. All this happened due to a missing chocolate," he said.

Child labour in domestic work remains widespread in Pakistan, according to an International Labour Organisation rein every four households employing a child in domestic work, predominantly girls aged 10-14.

It is illegal to employ individuals under the age of 15 but it remains

a common practice, with impoverished parents often sending their young daughters to work.

Igra's father Sana Ullah, who lives in a rural Punjab village, told AFP that his daughter had been working with the couple for the past 22 months, during which they paid him 8,000 rupees (around \$28) a month.

"The beasts tortured my daughter in a way that no human could ever do," he told AFP.

"I demand justice for this brutality."

Domestic frequently face exploitation, violence and sexual abuse, with Pakistan's patriarchal and rigid social-class structure leaving them without a voice.

In the past, parents frequently forgave the accused through out-ofcourt settlements under Islamic law, which allows the victim's heirs to either seek retribution or accept compensation in the form of blood money.

Prosecutions housemaid abuse are rare despite media attention on high-profile cases, few or no consequences.

In 2020, a couple in the same city was arrested for allegedly murdering their seven-year-old maid, who was blamed for letting a pet bird escape.

Minister of Minority Affairs Kiren Rijiju had last month presented a sacred chadar on behalf of Prime Minister Narendra Modi at the revered shrine of Khwaja Moinud-din Chishti in Ajmer.


