Environmental experts attribute this crisis to climate change and glob-al warming, which have significantly impacted the lower Himalayan region. "The Jhelum River, Kashmir's main water source, has recorded its lowest levels in decades. Other water sources, including subsoil water, are also drying up," environmentalist Aijaz Rasool said.



SRINAGAR: A groundbreaking scientific study has, for the first time, mapped the reproductive seasonality and stress patterns of the critically endangered Kashmir Hangul (Cervus hanglu) using non-invasive physiological monitoring. The findings of the research pro-

vide crucial insights for conservation efforts and the establishment of captive breeding programs. The study, conducted in Dachi-gam National Park—the last vi-

able habitat of the Kashmir Hangul-used fecal hormone analysis to determine reproductive cycles and stress levels in both male and female deer. Researchers monitored oestrogen, progesterone, testosterone, and glucocorticoid metabolites, offering a baseline for future conservation strategies.

ductive cycles in Hangul, a species inhabiting subtropical latitudes, differ significantly from their counterparts in higher northern latitudes Female Hangul exhibting and birth iles had a more



JERUSALEM: Israeli Prime Minister Benjamin Netanyahu on Sunday signaled that he was moving ahead with US President Donald Trump's proposal to transfer the Palestinian population out of Gaza, calling it "the only viable plan to enable a different future" for the region.

Netanyahu discussed the plan with US Secretary of State Marco Rubio, who kicked off a Middle East visit by endorsing Israel's war aims in Gaza, saying Hamas "must be eradicated." That created further doubt around the shaky ceasefire as talks on its second phase are vet to begin.

Rubio, in his upcoming stops in Saudi Arabia and the United Arab Emirates, is likely to face more pushback from Arab leaders over Trump's proposal, which includes redeveloping Gaza under US ownership. According to officials, after a recent painting work, the school in Dhamupur village in the district was renamed 'PM Shri Composite School'.

Jameel Ahmed, the grandson of Hamid, said the school was repainted four days ago. 'PM Shri Composite School' was painted at the entrance, replacing 'Shaheed Hamid Vidyalaya', he added.

When Ahmed and his family raised an objection with headmaster Ajay Kushwaha, he directed them to approach Basic Education Officer Hemant Rao.

According to the family members, Rao informed them that Hamid's name had been painted on one of the school's external walls. However, the entrance remained unchanged, the family claimed.

Dissatisfied, they filed another complaint on Saturday, demanding that the martyr's

name be reinstated at the school's



entrance. While Rao assured it would be done "immediately", Ahmed claimed that the name was still not displayed at the entrance, as of Monday, leaving the family "deeply hurt"

Chandigarh: Promised a legal entry into the US, Mandeep Singh's life was at risk after he was made to deal with crocodiles and snakes, trim his beard despite being a Sikh, and having to go without food for days. But his dream to secure a

better life for his family in Amritsar came crashing down on January 27 when he was arrested by the US Border Patrol while trying to sneak into America via Tijuana in Mexico. Mandeep was part of 112

Indians to be deported by a US military aircraft that landed

at the Amritsar airport late on Sunday, the third such batch of Indians to be sent back amid a crackdown by the Donald Trump administration against

illegal immigrants. The deportees' arrived within 24 hours of a US military aircraft bringing back a batch of 116 Indians living illegally in that country.

Instead of a legal entry as Mandeep's travel promised, agent put him on the 'donkey route' - an illegal and risky pathway used by migrants to enter the US.

Speaking to reporters in Amritsar, Mandeep (38) showed several videos of the perilous

journey his travel agent and subagents put him through.

"When I spoke to my agent, he said within one month I will be taken to the US in a legal way," Mandeep said.

The agent demanded Rs 40 lakh, which he paid in two instalments. The journey began from Amritsar to Delhi last August on a flight.

"From Delhi, I was taken to Mumbai, then Nairobi, and onwards to Amsterdam through another nation. From there, we were taken to Suriname. When I reached there, the sub-agents demanded Rs 20 lakh, which was paid back home by my family," he said.

Singapore's Indian-origin Opposition leader found guilty of lying in Parliament

ingapore's Indian-origin Leader of the Opposition, Pritam Singh, was found guilty on Monday of giving a false testimony to a parliamentary committee, a verdict that could see him disqualified from Parliament and contesting a general election this year.

In the verdict delivered in the State Courts, Deputy Principal District Judge Luke Tan convicted Singh of the two charges against him.

The charges against Singh relate to his handling of Raeesah Khan, a former lawmaker from his party, who lied to Parliament in a separate case.

Singh, 48, was accused of wilfully giving two false answers to the Committee of Privileges (COP) during its inquiry into Khan's case on December 10 and December 15, 2021.

The case stems from Singh's handling of Khan's false claim in Parlia-



ment about accompanying a sexual assault victim to the police station.

Singh faces up to three years in jail, a fine of up to SGD7,000 (USD 5,290), or both for each charge.

Singh's trial began four months ago. Politically, the conviction could disqualify Singh from his parliamentary seat and rule out his standing in the next general election which must be called by November 2025.

'Prolonged Dry Spell May Lead To Early Flowering'

SRINAGAR: Fruit growers in Kashmir are seriously concerned as experts warn that the prolonged dry spell and rising temperatures may trigger early sprouting of flowers, which would ultimately affect both the quality and quantity of fruit production.

Experts said the continuous lack of rainfall and snowfall this winter has heightened worries among farmers. They said

"If early flowering occurs and is followed by erratic spring weather, including sudden rainfall or snowfall, pollination will be disrupted, which will lead to a significant drop in fruit production,"

the early rise in temperatures, combined with insufficient soil moisture could severely impact fruit-bearing trees, especially apple orchards.

"Prolonged dryness reduces soil moisture, which is crucial for healthy flowering and fruitsetting. Any disruption at this stage could lead to lower yields and affect the overall quality of the fruit," they said.

Dr Parvez, a scientist at SKUAST Srinagar, said that, as of now, the situation remains manageable, but any continued dryness beyond February 20, coupled with further temperature rise, could lead to premature flowering and poor fruit-setting.

"If early flowering occurs and is followed by erratic spring weather, including sudden rainfall or snowfall, pollination will be disrupted, which will lead to a significant drop in fruit production," Dr Parvez said.

Another expert from the Department of Botany at the University of Kashmir said that adequate chilling hours are crucial for proper bud formation. If trees do not receive sufficient cold exposure, bud development will be adversely

The lack of rainfall has also lowered the water table, creating concerns for irrigation. Since most orchards in Kashmir depend on rainwater, the prolonged dryness could further affect fruit quality.

According to experts, frost conditions at night could also damage new fruit plantations, particularly saplings in both lower and upper hills. They said

dry weather may further increase the risk of pest infestations, making fruit trees more vulnerable to diseases.

Growers across Kashmir are anxious, fearing heavy losses due to flower shedding in spring, which could reduce fruit yield.

Dr Tariq, another scientist at SKUAST, said, "While dryness and warm weather have certain advantages-such as reduced fungal diseases-these conditions also favour insect pests and can lead to deficiencies affecting fruit size, colour and overall quality."

He advised, "Prolonged heat exposure can cause sunburn on fruits and tree stems. To mitigate these effects, farmers should focus on increasing organic matter in the soil, which helps retain moisture. Mulching can also help regulate tem-

perature and protect roots." Notably, Jammu and Kashmir has witnessed an 80% rainfall deficit over the past several months. If the dry spell continues, experts warn of not only agricultural losses but also an impending shortage of drinking water—(KNO)

Solid Waste Management Shed In Cherwan Turns Into **Dumping Yard**

KANGAN: A Solid Waste Management shed in Cherwan area of Kangan, in Central Kashmir's Ganderbal district, has turned into a dumping yard as the heaps of garbage remain unsegregated, locals alleged on Monday.

Residents said that while the construction of the shed was an appreciable move, the Rural Development Department (RDD) has failed to manage and segregate the waste dumped there.

'The shed emits a foul smell, making it difficult for us to access our land for necessary work," said a local resident. He added that the garbage is piling up in the shed without proper segregation by the Block Development Office (BDO) Kangan, and despite repeated concerns, the authorities have not taken any action.

"If they built a waste management shed, why are they not segregating the waste?" questioned another resident.

Officials, however, claim that they have a plastic management unit in place, which was recently cleaned and brought back into use with the help of machines.

"The garbage collection vehicle has also resumed operations in Block Kangan after previous issues were resolved," an official said.

He further added that there are nearly six to seven segregation sheds in the block, out of which two are currently non-operational.

"All garbage is being segregated at the Plastic Management Unit (PMU) in Wussan," he assured, adding that if any waste management shed is found to have unsegregated garbage, the department will ensure it is cleaned-(KNO)

Fear Returns To LoC villages Amid **Cross Border Firing Debate**

SRINAGAR: For the first time in four years, fear is creeping back into the villages along the Line of Control (LoC) in Jammu and Kashmir as debates over cross-border firing raise concerns that tensions between the Indian and Pakistani armies could escalate, endangering the fragile peace since the 2021 ceasefire.

The 2021 ceasefire agreement between India and Pakistan had brought an unprecedented sense of security, allowing residents to rebuild their lives without the constant fear of shelling but the current discourse has reignited anxieties about a return to violence.

"A fresh exchange of fire occurred along the LoC in Poonch's Pir Panjal Valley on Sunday, with no casualties reported," officials said.

In Rajouri district, residents said they lived without the terror of mortars falling on their homes in the past four years. "Now, with these discus-

sions, we fear being caught in the crossfire again," Mohammad Suleiman, a local, said. Similarly, in Poonch, Kashim

Khan, a local farmer, said the ceasefire gave their children a future. "If hostilities resume, we will be forced to flee, and their studies will suffer," he said. "Business had picked up as people felt safe to move around. We've rebuilt our lives and livelihoods. The mere thought of returning to those dark days is distressing." Another resident of Poonch

added, "A potential breakdown



of the ceasefire agreement is deeply unfortunate for border residents like us. We are the ones who bear the brunt of shelling, losing our homes, livelihoods, and sometimes our loved ones.

Mushtaq Ahmad, a resident of Karnah, said the recent debates over cross-border firing have gripped LoC residents with fear. "We have lived in peace for four years, but now uncertainty looms over our

lives once again," he said. Meanwhile, locals in Gurez Valley expressed a strong desire for the ceasefire along the LoC to remain intact, saying it has brought much-needed stability to their lives. "We pray and hope that peace continues, as it has allowed our areas to witness significant development," said Ajaz Ahmad.

"Infrastructure has improved, and even border tourism has gained momentum, benefiting local businesses and providing employment," he added.

Deputy Chief Minister Surinder Kumar Choudhary said the cross-border firing has caused immense suffering since 1947.





Others, while genuinely trying to help, may oversimplify complex issues or share information that is useful for them but counterproductive for others in fundamentally different situations.

On the other hand, direct, personal conversations between friends, family members, colleagues, and trusted individuals are qualitatively different These interactions allow for mutual understanding, tailored support, and real-time responses, making them far more meaningful than generic online discussions that amplify problems without offering real solutions.

Rethinking Awareness

The quality, context, and medium of mental health discussions matter.

Mental health professionals and researchers aren't beyond criticism, nor should they be the only voices on the topic. Psychology has had its share of theories later found to be weak or unable to be replicated. Our understanding of mental health is still evolving, and ongoing discussions, research, and evidence remain essential. Superficial, self-serving, or poorly evidenced awareness efforts can do more harm than good.

Likewise, individuals have valuable insight into their own mental states. Introspection, self-awareness, and social context are crucial but often flattened by awareness campaigns that fail to account for these nuances.

But perhaps we need less raising of awareness at superficial levels and a stronger focus on developing healthy interpersonal relationships that are not curated for public consumption.

'Warmth Promotes Dengue Spread; Effects Of Rainfall On Its Outbreak Can Vary'

hile rising temperatures consistently promote the spread of dengue, rainfall could either increase or decrease the spread, depending on how long a region has experienced a dry season, a study has found.

As warmer, humid conditions, driven by climate change, increase dengue outbreaks, including in countries previously unaffected, the study, published in the journal Science, detailed how temperature and rainfall interact, and affect disease spread.

Researchers, led by those from Korea Advanced Institute of Science and Technology and the Institute for Basic Science, stressed on the role of local climate conditions in spreading dengue, thereby warranting tailored strategies in preventing disease.

Dengue is a viral infection, caused by the bite of an infected mosquito. Climates of tropical and sub-tropical regions are known to favour the disease's spread, mostly in urban and semi-urban areas.

Focussing on 16 regions of the Philippines, known for their diverse climate, the researchers analysed five years' data, recorded between January 2015 and December 2019.

While rising temperatures were con-



sistently related with a higher rate of dengue spread across the regions, rainfall was found to increase disease spread in eastern regions and decrease it in western ones.

The team explained that the contrasting effects of how rainfall affected the spread of dengue depended on a "previously overlooked" critical factor- 'variation in dry season length', which refers to the differ-

ences in how long a dry season (with little to no rainfall) lasts between varied geographic regions.

In regions seeing fewer changes in the duration of dry season, rainfall tended to flush out stagnant water, reducing breeding sites for mosquitoes, thereby suppressing dengue spread, the researchers said.

However, in regions experiencing more

changes in dry season length, sporadic rainfall created new breeding sites and weakened the flushing effect, thereby driving an increase in mosquito populations and dengue cases.

'Our findings provide robust evidence for how climatic factors influence dengue transmission in diverse environments. This represents a significant step toward understanding how climate change may impact mosquito-borne diseases globally,' first author Olive R. Cawiding, from Korea Advanced Institute of Science and Technology and the Institute for Basic Science, said.

To validate their findings, the researchers extended their analysis to Puerto Rico, another region with diverse climate patterns. Data from municipalities, including San Juan, Adjuntas, and Ponce, covering a 20-year period from 1986 to 2005 was analysed.

The findings revealed similar patterns in how rainfall regulated the spread of dengue and "aligned with the results from the Philippine data".

We found that temperature consistently increased dengue incidence throughout all the regions, while rainfall effects differed depending on the variation in dry season length, a factor previously overlooked," the authors wrote.

'Our findings emphasise the need for tailored prevention strategies based on local climate conditions, rather than a onesize-fits-all approach," they wrote.

'US FDA-Approved Diabetes Drug Shows Promise Against Heart Attacks, Strokes'

team of researchers, led by one of Indian origin, has found that a drug recently approved by the US Food and Drug Administration (FDA) to treat type 2 diabetes can also reduce heart attacks and stroke.

The international clinical trial involving more than 10,000 participants showed that the drug -- Sotagliflozin which is also approved to treat kidney disease -- can additionally also reduce cardiovascular risk among these patients.

Sotagliflozin is a sodiumglucose cotransporter (SGLT) inhibitor. It blocks the function of two proteins, known as SGLT1 and SGLT2, which move glucose and sodium across cell

a new mechanism of action -combined blockade with sotagliflozin of the SGLT1 receptors (found in the kidney, gut, heart, and brain) and SGLT2 receptors (found in the kidney) -- to reduce heart attack and stroke risk.

tors; and analysed the ability of sotagliflozin to reduce the risks of life-threatening cardiovascular outcomes. The participants were followed for an average of 16 months.

The results, published in The Lancet Diabetes and Endocrinology, showed that people in the sotagliflozin group had a 23 per cent reduction in the rate of heart attacks, strokes, and deaths from such cardiovascular causes compared with the placebo group.

Bhatt said that sotagliflozin was approved to reduce the risk of deaths from cardiovascular causes, hospitalisations for heart failure, and urgent heart failure visits for patients with either heart failure or type 2 diabetes, chronic kidney disease, and other cardiovascular risk factors.



Sebi Notifies Procedure To Amend Rules, Mandates Public Consultation Press Trust Of India

NEW DELHI- To bring more transparency, markets watchdog Sebi has specified a new procedure for making regulations, mandating public consultation and for engagement of stakeholders for modifying norms.

In a gazette notification, the regulator has notified Sebi (Procedure for making, amending, and reviewing of regulations) Regulations, 2025. To make regulations, Sebi will publish on its offi-

cial website the proposal containing the suggested changes to the policy; a statement of the regulatory intent and objectives of the proposed regulations; and the manner, process and timelines for receiving public comments.

"A minimum of 21 calendar days shall ordinarily be provided for receiving public comments", Sebi said.

On receipt of public comments, the rationale for rejection, if any, of comments will be published on the Sebi's official website.

Thereafter, the proposed regulations and the related agenda paper will be considered by Sebi. If the agenda paper has been prepared following a public consultation, it will include a systematic compilation of comments received or a summary of such comments, and the remarks thereon of Sebi.

Kashmir's Rivers

from I&FC Department stated that the water level is low due to the snowless winter. "The persistent deficit rainfall has affected the recharging of the water reservoirs across the Valley," they informed.

Notably, Jammu and Kashmir has recorded a total deficit rainfall of 29 per cent so far with the highest deficiency recorded in the month of January 2024 at 91 per cent.

Also, in the first two months till February 12, all the districts across the Union Territory have recorded a large deficit of rainfall.

The Union Territory has recorded a deficit rainfall of 79 per cent as against the normal precipitation of 140 mm, the rainfall of just 29.8 was recorded from January 01 to February 12, 2025.

In the meantime, the ongoing situation has landed Jal Shakti Department (JSD) in a manageable position to provide drinking water facility to the households of Kashmir region.

A top official of Jal Shakti Department said that "We are in a situation wherein I cannot say that we have sufficient or insufficient drinking water availability for the consumers of Kashmir region." "As of now, we are in a good position to manage

the supply of drinking water to almost all areas of Kashmir region," he said.

Asked about the backup plan or alternative in case of any water scarcity, the official said that the government has ensured every backup for the PHE and consumers. (KNO)

Fresh WD Likely

to increase, with light to moderate rainfall over most parts of Jammu and Kashmir, and some areas predicted to receive heavy rain or snow. The forecast indicates that weather conditions will improve on February 21, with dry conditions expected across the region.

In the Kashmir Valley plains, rain is expected initially, though a sharp drop in temperatures could lead to snowfall especially in scattered higher reach areas if heavy precipitation persists. Temperatures are predicted to remain between 15 and 18°C on February 19 before falling further below to 7°C on February 20.

As per the forecast, the Jammu region is expected to record higher rainfall than the Kashmir Valley with Ramban, Kishtwar, and Doda districts in the Chenab Valley likely to see moderate to heavy rainfall.

The Pir Panjal range is expected to receive heavy snowfall, particularly in popular destinations such as Gulmarg, Sinthan Top, Peer Ki Gali, and areas along the Mughal Road.

With relatively higher temperatures, lightning and thundershowers are likely in the Jammu region. Weather conditions are expected to improve from February 21 onwards after the anticipated wet spell.

Kashmir's Vital Achabal

warn that without a comprehensive water management policy, the crisis will worsen. "We need a holistic approach to manage water resources, particularly for rivers like Jhelum and Chenab. A structured policy would help regulate water release and conservation," Rasool emphasized. The impact of global warming is visible worldwide, with extreme weather patterns causing floods and droughts.

Experts suggest that conserving wetlands, lakes, and rivers could mitigate climate change effects.

Rasool urged both the government and citizens to take immediate action to prevent further environmental degradation. "Pollution in our riverbanks must be stopped at every level—from households to municipal authorities. Sustainable conservation efforts are crucial for the survival of our water bodies," he said.

With no official water management policy in place, experts stress the need for immediate intervention to safeguard Kashmir's water resources and prevent a deeper crisis. (KINS)

Hydropower Generation

250 Megawatts of power from the local hydel projects that amounts to 20 percent of the total generation capacity. However, in the ongoing month, the power generation has further reduced by five percent.

A top official of the department said, "In the month of January, PDD on an average was generating nearly 250 MWs of power from the power plants across Jammu and Kashmir."

"However, the power generation has further decreased with the officials saying that the department was able to generate only 190 MWs of power in the ongoing month," the official said.

It also said that in the month of February, the department was facing less production. "As of now, we are generating around 190 MWs of power across Jammu and Kashmir out of a total generation capacity of 1200 MWs."

The official further admitted that the department was not able to generate power as in previous years during the peak time. We are reeling under global warming and climate change.

"Over a period of time, we have not been able to generate the normal power that we used to generate in previous years because of less water availability. Water availability period is also shortening," the official said.

It also said that the generation capacity cannot be measured in one day only. "The power generation varies. We reserve the water in the daytime to generate power during the peak hours. In the peak time, we are generating 50 MWs of power from the lower Jhelum and 5 MWs during the regular time. Besides, we are able to generate only 8 MW of power from the Kangan and 6 MWs from Sumbal power projects respectively," the official said.

In Jammu and Kashmir we have a total of 1200 Megawatts (MWs) hydel power production capacity of which 900 MW is from the Baglihar Hydroelectric Power Project.

"Across Jammu and Kashmir, as far as snowfall occurrence and early winters are concerned, last year we were in the same situation with regard to the power generation in the month of February," the official said. Adding, "This year we look forward to at least generating what we did last year. If the snow occurs now onwards there will be the added advantage of power generation." The official also said, "We have made some of the machines functional that were earlier defunct in the shut-down period. We are hoping that we get a good outcome from it." (KNO)

Lack Of Snowfall

2025 Khelo India Winter Games has further dented the tourism sector, leading to substantial cancellations.

He added that beyond the Khelo India event, the lack of snow has resulted in a 20–30% decline in business in Gulmarg and a 50% dip in other destinations like Pahalgam and Srinagar. "The industry, which usually thrives on winter tourism, is struggling due to the unseasonal dry spell," he said.

Chaya highlighted concerns that mounting 'unorganised' and 'unchecked' commercial expansion in the region is a term for worsening climate change factors.

"We have been vocal about the need for sustainable and green architecture. The government must prioritise eco-friendly infrastructure to preserve Kashmir's fragile ecology," the industry expert, Chaya, added.

He said that the impact extends beyond tourism, with warnings of water scarcity affecting agriculture and horticulture due to reduced snowfall, urging immediate policy interventions to mitigate long-term damage to both tourism and the environment.

Manzoor Pakthoon, Chairman Kashmir Houseboat Owners Association (KHOA), also highlighted the challenges faced by stakeholders this year.

"Our winter economy depends on snowfall. People visit Kashmir for winter activities and snow-covered landscapes, but this year, there was hardly any snow. As a result, we saw a significant number of cancellations. Tourists, who expected snow through March, had to change their plans," Pakthoon said.

According to Pakthoon, foreign tourist arrivals also witnessed a steep decline, particularly from Europe and Russia, which were key markets in previous years.

"Last year, even with slightly less snowfall, tourists still came. However, this year, due to the unfavourable weather conditions, many international visitors cancelled their plans. The decline in foreign tourists has been significant," he added.

Chaya said while Gulmarg previously boasted full occupancy in peak winter, this season saw only around 60% bookings. The industry was relying on February to recover losses, but low snowfall dashed those hopes.

He highlighted that as climate change was tightening its grip on Kashmir, the tourism sector faces an uncertain future, warning of greater economic setbacks if sustainability measures are not implemented soon.

SRINAGAR: The 5th edition of the Khelo India Winter Games (KIWG), which was set to be held in Gulmarg from February 22 to 25, has been postponed due to inadequate snowfall.

A fresh assessment will be conducted once snow conditions improve, and a revised schedule will be announced accordingly.

Officials said that in consultation with the technical conduct committee, they have decided to postpone the event, as key ski slopes at Affarwat and Bowl lack sufficient snow.

"The required amount of snowfall for competitive games is not there, which is why we had to postpone the event. Unless there is fresh snowfall, it is not possible to conduct the games", Rauf Tramboo, President Winter Games Association of Jammu and Kashmir (WGAJK) told KNO. Tramboo added, "We had a de-

tailed meeting on this, and it was decided that the next decision will be taken after February 19, as the weathermen have predicted wet weather conditions, with Gulmarg expected to receive snowfall."

Around 700 participants, including 650 technical staff, delegates and local athletes were expected to attend the event. This year, 19 teams representing states, Union Territories, and institutional outfits are competing across six disciplines, including alpine skiing, nordic skiing, ski mountaineering and snowboarding.

Earlier, the J&K government constituted two high-level committees to ensure the successful organisation of the games. (KNO)

Manu Bhaker Wins BBC Sportswoman Of The Year Award

NEW DELHI: Star Indian pistol shooter Manu Bhaker was named the BBC Indian Sportswoman of the Year on Monday, following her outstanding performance at the Paris Olympics.

Manu was among five nominees for the award, alongside golfer Aditi Ashok, para shooter Avani Lekhara. India women's cricket vice-captain Smriti Mandhana, and wrestler Vinesh Phogat -- each recognised for their exceptional contributions to Indian sport.

The nominees were shortlisted by an eminent jury of sports journalists and writers.

Now in its fifth edition, the IS-WOTY Award celebrates and honours remarkable achievements of women athletes in India.

Manu, 22, won the award for winning two bronze medals at the Paris Olympics, becoming the first Indian athlete since Independence to win multiple medals at a single Games.

She secured bronze in the 10m air pistol individual event as well as the 10m air pistol mixed team event.

In 2018, Manu made history as the youngest Indian shooter to win a World Cup gold at just 16.



A recipient of the Arjuna Award, she previously won BBC's Emerging Player of the Year award in 2021.




