# Shah Outlines Criminal Law Roadmap for J&K 'With Terror Declining, J&K Police Must Focus On Citizen Rights'

Srinagar: Stating that the Jammu & Kashmir police should now prioritize safeguarding citizen rights, Union Home Minister Amit Shah on Tuesday directed the Union Territory administration to ensure the full implementation of three new criminal laws by April 2025.

Shah, who chaired a highlevel review meeting on the implementation of these laws in Jammu & Kashmir, noted that with the decline in terror activities and improvement in the security scenario in the



region, the police should now prioritize safeguarding the rights of its citizens.

Shah, who reviewed the implementation of the laws in the presence of LG Manoj UT administration to ensure the full implementation of the three new criminal laws, made under the leadership of Prime Minister Shri Narendra Modi, by April 2025.

# 'Road Project' Triggers Wildlife **Conflicts In Rajwar Handwara**

RTI Reveals 128 **Incidents Since 2018**

Srinagar: A surge in human-animal conflict in the Rajwar area of Handwara has claimed four lives and injured nine others since 2018, according to data obtained through a Right to Information (RTI) request. Local residents attribute the increase in incidents to the construction of the Handwara-Bangus road which they say has disrupted the wildlife habitat.

The RTI, filed by activist and lawyer Rasikh Rasool Bhat, reveals 128 incidents of human-animal conflict in Rajwar between 2017-18 and the present. It also shows that wildlife authorities received 136 SOS calls regarding | More on P10

# **AIIMS Delhi Acquires Cutting-Edge Technology With Surgical Robot**

ew Delhi- AIIMS Delhi has installed a state-ofthe-art surgical robot in its department of surgical disciplines, making it one of the first general surgery units in a government hospital in India to acquire such cutting-edge technology.

The introduction of robotic surgery underscores AIIMS's commitment to enhancing patient care, enabling the execution of complex procedures with unmatched precision, and keeping pace with global advancements in medical technology, said Dr Hemang Bhattacharjee, professor of surgery at AIIMS.

"The initiative to incorporate robotic surgery into its general

surgery department is a strategic move to elevate the standard of care provided in a government healthcare setting," he said. The surgical robot allows for a magnified, three-dimensional view of the operative field and offers unparalleled dexterity through robotic arms, enabling surgeons to perform intricate procedures with precision. The technology is particularly advantageous for surgeries requiring meticulous dissection and suturing in confined anatomical spaces, Bhattacharjee said. "For example, complex colorectal surgeries, esophagectomies, and pancreatic surgeries that were traditionally challenging due to their invasive nature can now be performed with reduced complications, shorter hospital stays and faster recovery times," he



While private hospitals in metropolitan cities like Delhi, Mumbai, and Chennai have embraced robotic systems in specialties such as urology and gynaecology over the last decade, its adoption in

government hospitals, especially for general surgery, has been relatively limited, Bhattacharjee

AIIMS Delhi is bridging this gap by bringing advanced robotic capabilities to a public healthcare setup, ensuring that patients from diverse socio-economic backgrounds benefit from the technology, Sunil Chumber, head, department of surgical disciplines, said.

"AIIMS is an academic institute and more than 100 surgical residents pursue their training in the department at any given point of time.

"Successful installation of the system will provide our resident doctors ample opportunity to get trained on this latest technology during their residency period. This has positioned our training curriculum on par with any of the renowned medical institutes of the world," Chumber said.

# **Tsoonti Koul Turns Into** Garbage Dumping Site, Locals Aghast

**SRINAGAR:** One famed Tsoonti Koul in Srinagar City, is rapidly turning into the garbage dumping site as the heaps of garbage could be seen piled up in the water body, causing concern among the local residents.

In Karfali Mohalla area of Habba Kadal Srinagar, the locals alleged the increasing garbage has been affecting their health badly.

The residents said that the steady rise in pollution levels in Tsoonti Koul is unbearable and all the silt and plastics have gathered in the stream.

"I have lived here for years, and I have never seen such a waste in the water body. The

water in Tsoonti Koul is contaminated. We can no longer use it for daily chores," said Umar, a resident of Karfali Mohalla.

Another local, Sahil, expressed frustration over the lack of action. "We have repeatedly raised the issue, but no steps have been taken to address it. We want the authorities to take responsibility and clean up this water body," he said.

Additionally, Danish, another resident, said pollution is not just limited to the water but extends to the air as well. "The increasing waste and lack of proper disposal methods are causing not only water pollution but air pollution too. The whole area stinks," he said—(KNO)

# **30-Hour Water Supply** Shutdown In City on Feb 22-23

**SRINAGAR:** The Executive Engineer Water Works Division Srinagar on Tuesday issued an "urgent public notice" regarding a 30-hour shutdown of the Sindh Power Canal HEP Old Ganderbal and desilting of the Forebay.

As per the Urgent Public Notice, this shutdown is scheduled to take place from '22nd to 23rd February 2025' as part of necessary repair work by the Department of Civil Investigation & Design Wing, JKPDC.

It reads, as a result of this work, raw water supply to the Water Treatment Plants of Nishat, Alusteng, and Rangil will be severely impacted. Consequently, potable water supply will be affected in major parts of Srinagar City and sur-

rounding areas. # **UPSC Further Extends** Last Date To Apply For Civil Services Prelims Exam

New Delhi: The Union Public Service Commission (UPSC) has extended the last date to apply for this year's civil services preliminary examination till February 21.

This is the second extension in the deadline to apply for the examination, conducted annually by the UPSC in three stages -- preliminary, mains and interview -- to select officers of the Indian Administrative Service, Indian Foreign Service and Indian Police Service, among others.

The last date for submission for Civil Services (Preliminary)-2025 and Indian Forest Service (Preliminary)-2025 "has been further extended till February 21 (6 pm)," said a notice put out by the Commission on its website.

Further, a correction window will also be open for the applicants "from February 22 to February 28", read the notice, without mentioning any reasons behind the second extension.

The Commission had recently also introduced certain changes in its online application system for the exam after aspirants The civil services examination's notification was issued in January and the last date to apply for it was February 11. It was earlier extended till

# **Saudi Arabia Hosts US-Russia** Talks, No Seat For Ukraine

RIYADH: Top US and Russian diplomats will meet in Saudi Arabia on Tuesday for talks on resetting their countries' fractured relations and making a tentative start on trying to end the Ukraine war.

Both sides played down the chances that the first high-level meeting between the countries since US President Donald Trump took office would result in a breakthrough.

Still, the very fact the talks were taking place has triggered concern in Ukraine and Europe following the United States' recent overtures towards the Kremlin.

Ukrainian President Volodymyr Zelensky said Kyiv was not invited to the discussions in Riyadh, while European leaders were gathering in Paris for emergency talks on how to respond to the radical pivot by the new US administration.

Preparations for a possible summit between presidents Trump and Vladimir Putin are also expected to be on the agenda.

Trump is pushing for a swift resolution to the three-year conflict in Ukraine, while Russia sees his outreach as a chance to win concessions.

Zelensky said Kyiv "did not

know anything about" the talks in Riyadh, according to Ukrainian news agencies, and that it "cannot recognise any things or any agreements about us without us'

He said on social media that any peace deal would need to include "robust and reliable" security guarantees, which France and Britain have called for but not all European powers support.

Russia said ahead of the meeting that Putin and Trump wanted to move on from "abnormal relations" and that it saw no place for Europeans to be at any negotiating table.

Russia's Foreign Minister Sergei Lavrov and senior Putin aide Yuri Ushakov will meet with US Secretary of State Marco Rubio, National Security Advisor Mike Waltz and Middle East envoy Steve Witkoff.

Possible Trump-Putin summit

Kremlin spokesman Dmitry Peskov told reporters the talks would be "primarily devoted to restoring the whole complex of Russian-American relations", alongside discussions on "possible negotiations on a Ukrainian resolution. and organising a meeting between the two presidents"

Moscow, which for years has sought to roll back NATO's presence in Europe, has made clear it wants to hold bilateral talks with the United States on a plethora of broad security issues, not just a possible Ukraine ceasefire.

Before invading in February 2022, Putin was demanding the military alliance pull its troops equipment and bases out of sever al eastern members that were under Moscow's sphere of influence during the Cold War.

The prospects of any talks leading to an agreement to halt the Ukraine fighting are unclear.

Both Russia and the United States have cast the meeting as the beginning of a potentially lengthy process.

"I don't think that people should view this as something that is about details or moving forward in some kind of a negotiation," US State Department spokesperson Tammy Bruce said.

Russia's Ushakov told state media the talks would discuss "how to start negotiations on Ukraine."

Both Ukraine and Russia have ruled out territorial concessions and Putin last year demanded Kyiv withdraw its troops from even more territory.

Zelensky will travel to Turkey on Tuesday to discuss the conflict with President Recep Tayyip Erdogan, and then Saudi Arabia a day later.

# 'Alcohol-Related Cancers A Growing Concern In India'



New Delhi: Alcohol-related cancers are a growing concern in India, said health experts on Monday, even as the World Health Organisation (WHO) recently called for prominent health warning labels on alcoholic beverages

The WHO defines alcohol as a toxic, psychoactive, and dependence-producing stance that has been, decades ago, classified as a Group 1 car-

also causes cancers of the breast in women and prostate in males.

"In India, alcohol-related cancers are a growing concern. Alcohol metabolises into acetaldehyde -- a toxic compound that can damage DNA and proteins -- leading to mutations that initiate cancer development. In addition, alcohol can impair the body's ability to absorb essential nutrients like folate and vitamins A, C, D, and E, which are vital for maintaining healthy cells and prevent-



cinogen by the International Agency for Research on Cancer. Group 1 carcinogen is the highest risk group, which also includes asbestos, radiation, and tobacco.

"Alcohol consumption increases the risk of cancer, and more than 20 types of cancers can be attributed to consumption of alcohol," Dr. (Prof) Puneet Garg, Vascular Interventional Radiologist and Endovascular Surgeon, Safdarjung Hospital, New Delhi, told IANS.

The most common cancers linked to alcohol are of mouth, throat, foodpipe, stomach, colon, rectum, and pancreas. It ing cancer," Dr Taraprasad Tripathy, Assistant Professor at All India Institute of Medical Sciences Bhubaneswar, Odisha, told IANS.

Alcohol is a well-established carcinogen that is contributing significantly to the global burden of the deadly disease. Nearly 4 per cent of cancers diagnosed worldwide can be attributed to alcohol consumption, according to the WHO.

A recent study in the journal Lancet estimates that alcohol consumption was responsible for approximately 62,100 new cancer cases in the India 2020.

# SC Bails British Arms Dealer in Chopper Scam

NEW DELHI: India's top court on Tuesday granted bail to a British arms dealer imprisoned for more than six years on charges of bribing officials over a multimillion dollar helicopter deal.

Christian Michel has been in jail since December 2018. The Supreme Court said that while the nvestigation is still ongoing' Michel must be released on conditions laid down by a lower court.

The Central Bureau of Investigation, India's top investigating agency, has filed three chargesheets in the case.

In January 2014, New Delhi cancelled a deal with Italian-British consortium AgustaWestland agreed under a previous government in 2010 - after allegations the firm paid bribes to win the \$677 million contract for 12 helicopters.

Indian investigators charged Michel in 2017 with arranging \$52 million as kickbacks.

"Considering facts and circumstances of the case and in particular, that petitioner who was extradited in 2018 and has been in custody for more than 6 years now, and according to the Respondent CBI despite filing 3 chargesheets and 2 supplementary chargesheet, the investigation

is still ongoing as stated in the counteraffidavit." the court observed "We are inclined to grant bail

on conditions as may be determined by the trial Court. The CBI may appropriately request the trial Court for imposing conditions before releasing him on bail," the bench further said.

What Is the chopper scam?

The CBI, in its chargesheet, has alleged an estimated loss of 398.21 million euros (about Rs 2,666 crore) to the exchequer due to the deal that was signed on February 8, 2010 for the supply of VVIP choppers worth 556.262 million euros to the Indian government. The ED, in its chargesheet filed

against James in June 2016, has alleged that James had received 30 million euros (about Rs225 crore) from AgustaWestland. The other two alleged middlemen are Guido Haschke and Carlo Gerosa.

Iran Mulls Moving Capital To 'Lost

problems including gridlocked traffic and a sinking earth surface in its current capital, Iran is considering a drastic solution -- moving it to an altogether different location on the Gulf of Oman

Though the idea of moving the capital has cropped up on various occasions since the 1979 Islamic Revolution, the proposals were repeatedly shelved as unrealistic due to the massive financial and logistical hurdles.

But reformist President Masoud Pezeshkian, who took office in July, has recently revived the idea, citing Tehran's management, extreme air pollution, as well as subsidence -- the gradual sinking of land mass due to either natural processes or human activity.

In January, government spokeswoman Fatemeh Mohajerani said the authorities were studying the possible relocation.

'The Makran region is being seriously considered," she said, without specifying a timeline.

President Donald Trump's immigration policies already are affecting schools across the country, as officials find themselves responding to rising anxiety among parents and their children, including those who are here legally. Trump's executive actions vastly expanded who is eligible for deportation and lifted a ban on immigration enforcement in schools.

While many public and school officials have been working to encourage immigrants to send their children to school, some have done the opposite.

# **Students Hide, Attendance Drop: Schools Around US Confront Anxiety Over Trump's Actions On Immigration**

Oklahoma and Tennessee have put forward proposals that would make it difficult — or even impossible — for children in the country illegally and US-born children of parents without

documentation to attend school at all. As they weigh the risks, many families have struggled with separating facts from rumour.

In the Alice Independent School District in Texas, school officials told parents that the district "received information" that US Border Patrol agents could ask students about their citizenship status during field trips on school buses that pass through checkpoints about 60 miles from the Texas-Mexico border. The information ended up being false.

Angelib Hernandez of Aurora, Colorado, began keeping her children home from their schools a few days a week after Trump's inauguration.

Now she doesn't send them at all. She's worried immigration agents will visit her children's schools, detain them and separate her family.

"They've told me, 'Hopefully we won't ever be detained by ourselves," she said. "That would terrify them." Hernandez and her children arrived about a year ago and applied for asylum. She was working through the proper legal channels to remain in the US, but changes in immigration policies have made her status tenuous.

In the past week, her fears have intensified. Now, she says, her perception is "everyone" - from Spanishlanguage media to social media to other students and parents — is giving the impression that immigration agents plan to enter Denver-area schools. The school tells parents that kids are safe. "But we don't trust it." Immigration and Customs



Enforcement agents are not known to have entered schools anywhere. But the possibility has alarmed families enough that some districts are pushing for a change in the policy allowing

agents to operate in schools. Denver Public Schools last week sued the Department of Homeland Security, accusing the Trump administration of interfering with

the education of young people in its care. Denver took in 43,000 migrants from the southern border last year, including children who ended up in the city's public schools. Attendance at schools where migrant kids are concentrated has fallen in recent weeks, the district said in the lawsuit, saying the immigration raid at a local apartment complex was a factor.

Around the country, conservatives have been questioning whether immigrants without legal status should even have the right to a public education.

Oklahoma's Republican state superintendent, Ryan Walters, pushed a rule that would have required parents to show proof of citizenship — a birth certificate or passport — to enrol their children in school.

The rule would have allowed parents to register their children even if they could not provide proof, but advocates say it would have strongly discouraged them from doing so. Even the state's Republican governor, Kevin Stitt, thought the rule went too far — and vetoed it.



A senior official from the department said that while the government holds the authority to decide on the matter, there is no official directive or plan currently under consideration.

"As of now, the Ial Shakti Department has not received any proposal or order from the government regarding the installation of water meters in Kashmir," the official confirmed.

The official also spoke about the Jal Jeevan Mission (ĴJM), a centrally-sponsored initiative aimed at providing safe drinking water to all households. He said that over 85% of households in Kashmir now have access to drinking water, with expectations of achieving 100% coverage by March 31, 2025.

Water metering is the process of measuring water usage in residential and commercial buildings, the official said, adding that it helps in monitoring consumption, improving water management, and ensuring efficient distribution through public water supply systems—(KNO)

# 2 Kashmiri Youth Arrested Along With Rs 2 Cr Cash

JAMMU: Police on Tuesday arrested two persons along with around two crores of cash on National Highway in Lakhanpur area of Kathua, the state border town between Jammu-Kashmir and Punjab.

As per details available, on a tip off, police laid a surprise check post at Lakhanpur and intercepted a Hyundai Creta bearing registration number HR98J-9889, heading towards Kashmir.

Police searched the vehicle and found a huge quantity of cash packed in polybags and placed in the footrest area of the passenger seat.

The cash was seized and counted in the presence of the magistrate, which amounts over Rs 2 crore in denominations of Rs 500 notes.

Two Kashmir based youth were also arrested and taken to Lakhanpur Police Station for further questioning.

"An investigation is underway to find out the reason behind carrying so much money. We are exploring all the angles including drugs, terror fund and tax evasion to find the sources of cash," a police officer said.

The authorities have registered a case and are proceeding with their investigation into the incident—(KNO)

# 2 IEDs Recovered, Destroyed In **South Kashmir**

# **Lingering Dry Winter**

ne water bodies in Kashmir Valley are witnessing his toric declines in levels due to an ongoing dry spell and minimal snowfall - January alone saw a 91% shortfall in rainfall. The decline is conspicuously visible in Jhelum, the Valley's primary water source, crucial for irrigation, drinking water, and hydroelectric power. The current data from the Irrigation and Flood Control Department reveals that water levels in the river have fallen below the Reduced Level (RL) of zero at Sangam, with similar declines recorded at Ram Munshi Bagh and Asham. Tributaries such as Lidder, Pohru, and Ferozpora are also flowing at unprecedented lows.

For now, this has affected the Valley's hydropower generation the most.It has plummeted by a whopping 84 percent, forcing the administration to rely on external sources to meet the shortfall. Power plants generated only 250 MW in January, a fraction of the 1200 MW capacity, with February seeing a further 5% decline. Unless water levels improve, the situation is expected to deteriorate.

The snowfall, however, is important not merely for tourism but as a lifeline for the glaciers which keep our rivers and streams flowing and agriculture fields irrigated. High-altitude areas retain their sub-zero temperatures, enabling the snow to endure throughout the year. Kashmir witnesses its heaviest snow during chilai kalan and the snowfall progressively reduces in February and March when spring sets in. This keeps glaciers replenished. Alarmingly, the experts fear a drastic reduction in snowfall by the century's end, and this can have horrific consequences not just for Kashmir but the region.

Going forward, agriculture and horticulture are also going to be hit hard if the current dry spell lingers. With glaciers failing to replenish due to growing snow-deficit, and also melting prematurely due to an unusually warm winter, farmers are worried about the upcoming agriculture season. The likelihood of an impending drought could devastate apple orchards, paddy fields, and vegetable farms.

Needless to say, the tourism sector could be another casualty. Inadequate snowfall, even in the upper reaches, has already led to a sharp decline in visitors to the popular winter destinations like Gulmarg and Pahalgam, with hoteliers reporting a 20-50% drop in bookings. Already, the government has been forced to postpone the 2025 Khelo India Winter Games.

Over the last three years, the growing tourism has gone a long way to shore up the Kashmir economy and brought back employment lost to the successive security and Covid-19 lockdown. The boom in tourism, which forms 6.8 percent of Kashmir's GDP and employs over two million people, has also had a positive spillover effect on other sectors.

Here's hoping that snow does bless the hills and plains in the remaining period of winter. Snowfall is a boon for tourism and the Valley's economy. There's still time for snow as we are still heavy rainfall and snowfall as a fresh western disturbance is approaching. We are all waiting.

# 5 Bn People Lack Medical Oxygen **Access, Poorest Nations Worst Hit: Lancet**

ive billion people or nearly twothird of the world's population lack access to medical oxygen, with highest inequities in lowand middle-income countries, estimated a new Lancet Commission report.

The report by the Lancet Global Health Commission on Medical Oxygen Security is the world's first estimate of how unequally medical oxygen is distributed, gaps in coverage of patients in need, along with costs required to bridge these gaps.

Medical oxygen is essential in a healthcare system for treating patients, including those of surgery, asthma, trauma and maternal and child care.

It is also critical to a country's pandemic preparedness by helping prevent a repeat of the COVID-19 oxygen shortages and the mass fatalities that resulted, said an international team of researchers, including those from the

University of Melbourne, Australia.

In this study, the researchers said that 82 per cent of patients worldwide requiring medical oxygen live in lowand middle-income countries (LMICs), and nearly 70 per cent concentrated in south and east Asia, the Pacific and sub-Saharan Africa.

The patients include those with acute medical and surgical conditions, and long-term oxygen needs due to chronic obstructive pulmonary disease (COPD).

However, less than one in three people needing oxygen for medical or surgical conditions receive the lifesaving gas due to gaps in service contact, readiness, provision and quality, leaving almost 70 per cent of the patients without coverage.

The gaps are even higher in regions, including Sub-Saharan Africa (91 per cent) and South Asia (78 per cent), the authors said.

In a case study accompanying the report, the authors described the scenario of medical oxygen in India,



especially as observed during the CO-VID-19 pandemic.

'The pandemic had a catastrophic effect not just because of the rates of contagion and the virulence of the disease but also because of the drastic scarcity in life-saving resources such as medical oxygen," the team from One Health Trust, India, wrote.

They added that with hospitals

largely replying on third-party vendors for meeting their oxygen demand pre-COVID-19, the surge in demand during the pandemic led to black-marketing and hoarding.

Desperate requests for medical oxygen were also raised on social media and in exceptional cases, the court intervened by issuing orders against supplying agencies and the government for replenishing oxygen supplies, the authors said.

The commission report also suggested recommendations for how governments, industry, global health agencies, academic institutions and civil society can work together to strengthen health systems in providing access to medical oxygen.

The authors added that medical oxygen is a highly cost-effective investment to advance global public health that will accelerate the world's progress towards meeting the Sustainable Development Goals for health by 2030, but also help countries prepare for the next pandemic.

# 'Green Cover In India Absorbed More Carbon Than It Emitted Annually'

he green cover in India has absorbed more carbon than it emitted annually in the last decade, but the rate of sequestration declines during extreme climate events such as drought, a study has revealed.

The study by researchers at the Indian Institute of Science Education and Research (IISER), Bhopal, also stressed the critical role of vegetation in climate change mitigation and adaptation.

Green vegetation absorbs carbon dioxide (CO2) from the atmosphere through photosynthesis and releases it back into the air through respiration.

"The overall balance this uptake and release of CO2 is known as the net ecosystem exchange (NEE). When the NEE is positive, it means vegetation is releasing more carbon than it absorbs, and when it's negative, it indicates that the vegetation is effectively storing carbon," said Dhanyalekshmi Pillai, associate professor, head of the Max Planck Partner Group Germany, and of the Earth and Environmental Sciences, IISER, Bhopal.

"For the last decade, India's (green) ecosystem absorbed more carbon than they emitted annually, with annual NEE estimates ranging from 380 to 530 million tonnes



of carbon per year," she said.

Researcher and co-author of the paper, Aparnna Ravi, said this level of carbon sequestration is impressive but tends to decline in response to climate extremes, emphasising the critical role of vegetation in climate change mitigation and adaptation.

Scientists also studied how different types of vegetation across India help absorb CO2 each year.

Pillai said evergreen forests in India are highly efficient in capturing CO2 through photosynthesis. However, the deciduous forests in central India released more carbon into the atmosphere as plant respiration surpassed primary produc-

"They (green vegetation) released 210 million tonnes of carbon annually, acting as carbon sources. Although croplands are less effective at absorbing carbon per unit area than forests, their extensive coverage across the country benefits significant CO2 removal from

the atmosphere," she said. Pillai said the sequestration rate is not constant but shows a decreasing trend, especially in response to drought.

She said drought is an example of climate extremes, and these conditions are increasing due to climate change.

"Green vegetation is favouring us (reducing global warming), but the sequestration potential cannot be limitless... under climate extremes, it shows decreasing sequestration. This is concerning," Pillai said.

She said the study reflects on creating and implementing effective climate policies and ecosystem management in consonance with nationally prioritised action plans.

IISER scientists, in collaboration with international experts, led and established an innovative technology-driven approach using highly resolved observations of plants' fluorescence ("glow") and advanced physics-based computer models to quantify vegetation's sequestration across India for the first time.

In this novel approach, IISER-Bhopal researchers led long-term analyses across India by tracking several thousands of observational records of the last 10 years (2012-22), together with research experts from the Max Planck Institute for Biogeochemistry (Germany), University of Exeter (United Kingdom) and National Remote Sensing Centre (India).

Pillai said this newly demonstrated system also benefits from the recently available radiance observations from multiple satellite instruments, including the TRO-POMI instrument onboard the Sentinel-2 satellite.

# **Air Pollution May Be Higher Inside Your Home Than Outdoors: Study**

new study reveals that people may be exposed to unhealthy levels of airborne pollutants inside their homes, even if the outdoor air quality is good.

Researchers at the University of Birmingham used low-cost sensors and innovative techniques over a twoweek period to compare particulate matter (PM) in three homes. They discovered that pollution levels in each house were higher and more variable than outdoor levels. The researchers found significant differences in PM levels between the three houses, with one home exceeding the World Health Organisation (WHO) 24-hour PM2 5 limit on nine days.

This highlights the importance of monitoring indoor air quality at a householdspecific level.

Published in Scientific Reports, this is the second paper published by McCall MacBain Clean Air Fellows studying the philanthropically funded Master's degree in Air Pollution Management and Control at the University of Birmingham.

Co-author and Clean Air Fellow Catrin Rathbone commented: "Our study shows the need to monitor indoor air pollution, as people can have unhealthy air at home even if outdoor air is good. PM levels varied significantly between homes, indicating that monitoring just one location isn't enough.'

The team note that factors such as household location, ventilation, and occupancy patterns influenced particle levels - demonstrating the complexity of indoor air quality.

Co-author and Clean Air Fellow Owain Rose commented: "With more time spent working from home, understanding the factors that affect air quality within households is increasingly important. The methods we used accurately modelled indoor PM levels, helping to improve exposure estimates at a low cost.

Researchers identified five different factors contribtwo relating to indoor activities, such as increased movement by residents and three linked to external factors such as a nearby restaurant's kitchen vent. They found that larger particles (PM10) tended to settle faster compared to smaller particles (PM1, PM2.5).

Researchers used Nonnegative Matrix Factorization (NMF) - a powerful tool for uncovering latent patterns in data - to more accurately model indoor PM levels. Using low-cost sensors enabled them to build a more detailed picture of pollutant levels within the properties. (ANI)

On the modus operandi, a release from Cyberabad Police Commissionerate said the ac-



cused launched a mobile application and website, falsely presenting Falcon Invoice Discounting Platform as a legitimate peer-to-peer invoice discounting service.

They claimed to connect depositors with reputed companies while in reality, they fabri-

cated vendor profiles and fake deals to create an illusion of authenticity, police said. Total deposits to

the tune of Rs 1,700 crore were collected and out of which Rs 850 crore was repaid to the investors, while the rest (outstanding fraudulent amount Rs 850 crore) was to be paid to as many as 6,979 depositors, police said.

The accused promised returns of 11–22 per cent per annum and the deposit range was between Rs 25,000 to Rs 9 lakh. The maturity period was of 45 to 180 days.

# **Markets End Marginally Lower** After A Day's Breather Amid **Foreign Fund Outflows**

**MUMBAI-** Benchmark indices Sensex and Nifty ended marginally lower on Tuesday as uninterrupted foreign fund outflows and lower-than-expected corporate earnings continued to hit investors' sentiment.

After a day's breather, the 30-share BSE benchmark Sensex ended 29.47 points or 0.04 per cent lower at 75,967.39. Intra-day, it dropped 465.85 points or 0.61 per cent to 75,531.01. The NSE fty dipped 14.20 points or 0.06 per cent to settle at 22,945.30.

"On Tuesday, the Indian bluechip equity indices, Sensex and Nifty-50, closed with a slight decline, primarily due to a slowdown in earnings and concerns over ongoing foreign selling, which affected market sentiment," Ameya Ranadive, Chartered Market Technician, CFTe, Sr

Technical Analyst, StoxBox, said. From the Sensex pack, IndusInd Bank, Mahindra & Mahindra, UltraTech Cement, Hindustan Unilever, Sun Pharma, Tata Consultancy Services, ITC and Asian Paints were among

the biggest laggards. NTPC, Zomato, Tech Mahindra, Power Grid, Kotak Mahindra Bank and HCL Tech were among the gainers.

The BSE smallcap gauge dropped 1.71 per cent and midcap index declined 0.19 per cent.



Among BSE sectoral indices, industrials dropped 1.51 per cent, consumer durables (1.19 per cent), telecommunication (1.06 per cent), capital goods cent) and consumer discretionary (0.55 per cent).

BSE utilities climbed 1.03 per cent, BSE Focused IT (0.86 per cent), oil & gas (0.70 per cent)

and energy (0.38 per cent).
As many as 2,918 stocks declined while 1,032 advanced and 114 remained unchanged on the BSE.

'The domestic market has experienced both profit-booking and bottom-fishing amid persistent concerns over FII outflows and pressure on the INR. Small and midcap stocks continue to lag due to apprehensions about premium valuations. Mean-while, India's trade deficit has widened beyond expectations, driven by rising imports due to depreciating domestic currency and surging commodity prices," Vinod Nair, Head of Research, Geojit Financial Services, said.

**NEW DELHI-** India and Qatar are "exploring" the possibility of signing a bilateral free trade agreement in future, and this was discussed during the talks between Prime Minister Narendra Modi and Amir of Qatar Sheikh Tamim Bin Hamad Al-Thani on Tuesday, officials said.

Responding to a query during a briefing on the two-day State visit of the Amir to India, Arun Kumar Chatterjee, Secretary (CPV & OIA) in the Ministry of External Affairs, also said India and the Gulf Cooperation Council (GCC) at this moment are "negotiating about having an FTA".

The GCC is an influential grouping comprising the United Arab Emirates (UAE), Bahrain, Saudi Arabia, Oman, Qatar and Kuwait. "India and the Gulf Co-

operation Council, we are at this moment, negotiating about having an FTA, a free trade agreement. As far as Qatar is concerned, both sides are exploring the possibility of signing a free



And, that was one of the discussions that took place in this round of talks," Chatterjee said when asked about the status of the India-GCC FTA negotiations.

Earlier in the day, Prime Minister Modi held wideranging talks with the Amir at the Hyderbad House as the two leaders decided to elevate India-Qatar relations to a "strategic partnership" with focus on trade, investments, technology, energy and people-to-people ties, further cementing the "deep and traditional relationship" between the

two countries. Briefing reporters, Chatterjee also said Modi and the Qatari Amir decided to set a target to double bilateral trade from the current USD 14 billion to USD 28 billion over the next five years.

The GCC, a six-nation grouping is headquartered in Riyadh.

External Affairs Minister Jaishankar in September 2024 had visited Riyadh to attend the first India-Gulf Cooperation Council (GCC) foreign ministers' meeting.

Ahead of EAM's visit, the MEA had said that India and the GCC enjoy a deep and multifaceted relationship, including in areas of trade and investment, energy, cultural and people-to-people ties.

# Tesla Starts Recruitment In India, **Sends Signal Of Entering EV Market**

**DELHI-**American electric carmaker Tesla has opened recruitments for various roles in India, including business operations analyst and customer support specialist, in what could be a precursor for the company's entry into the country.
As per the job postings on

the company's website, the posts are for the 'Mumbai Suburban' area.

These roles include service advisor parts advisor service technician, service manager, sales & customer support, store manager, sales & customer support, business operations analyst, customer support supervisor, customer support specialist, delivery operations specialist, order operations specialist, inside sales advisor, and consumer engagement manager.

A mailed query to confirm if the recruitments are part of the company's plans to enter the Indian market and the possible timeline for starting sales in India remained unanswered.

The hiring by Tesla in India comes close after the recent meeting of company founder and American tech billionaire Elon Musk with India's Prime Minister Narendra Modi during the latter's recent US visit. Tesla's possible entry into

the Indian market has been keenly awaited.

Last April, company founder and American tech billionaire Elon Musk had postponed his proposed visit to India at the last minute citing "very heavy Tesla obligations" but the proposed visit had raised expectations of Musk announcing plans for the way forward for selling Tesla electric cars in In-

dia at the earliest. His planned visit to India came weeks after the government announced a new electric vehicle policy under which import duty concessions will be given to companies setting up manufacturing units in the country with a minimum investment of USD 500 million, a move aimed at attracting major global players like Tesla.

An advisor representing Tesla -- The Asia Group (TAG) had even attended a stakeholders' meeting on the new EV policy along with those from Viet nam's EV maker VinFast and all the major manufacturers in India, including Maruti Suzuki, Hyundai, Tata, Mahindra, Kia, Skoda Auto Volkswagen India, Renault, Mercedes-Benz, BMW and Audi.

Musk had said in 2022 that Tesla, which was earlier seeking a reduction in import duties to sell its vehicles in India, would not manufacture its products unless it is allowed to first sell and service its cars

in the country.
In August 2021, Musk had said that Tesla may set up a manufacturing unit in India if it first succeeds with imported vehicles in the country. He had said Tesla wanted to launch its vehicles in India "but import duties are the highest in the world by far of any large country!"

# **Unemployment Rate Dips** Marginally To 6.4% In **December Quarter: Survey**

**NEW DELHI-** The rate of unemployment among people aged 15 years and above in urban areas dropped marginally to 6.4 per cent in the October-December quarter of the current fiscal, according to the National Sample Survey Survey (NSSO).

Joblessness, or unemployment rate, is defined as the percentage of unemployed people in the labour force.

The unemployment rate in the December quarter of FY24 was 6.5 per cent. However, the rate stayed flat when compared sequentially.

In the preceding July-September quarter of FY25, the rate of unemployment for people aged 15 years and above in urban areas was at the same level of 6.4 per cent, the 25th Periodic Labour Force Survey (PLFS) showed.

The unemployment rate among females (aged 15 years and above) in urban areas declined to 8.1 per cent in October-December 2024 from 8.6 per cent in the same quarter a year ago. The rate was 8.4 per cent in July-September, 2024.

Among males, the unemployment rate in urban areas remained flat at 5.8 per cent in October-December 2024 as compared to the rate of the same quarter a year ago. The rate was 5.7 per cent in July-September, 2024.

Labour force participation rate in Current Weekly Status



(CWS) in urban areas for people aged 15 years and above increased to 50.4 per cent in October-December from 49.9 per cent in the same quarter a year ago. The rate was 50.4 per cent in the July-September 2024. Labour force refers to the

part of the population, which supplies or offers to supply labour for pursuing economic activities for the production of goods and services and, therefore, includes both employed and unemployed persons.

The NSSO had launched PLFS in April 2017.

On the basis of PLFS, a quarterly bulletin is brought out giving estimates of labour force indicators namely unemployment rate, worker population ratio (WPR), labour force participation rate (LFPR), distribution of workers by broad status in employment and industry of work in CWS.

WPR for male aged 15 years and above for urban areas increased from 69.8 per cent in October-December, 2023 to 70.9 per cent during October-December, 2024.

The estimates of unemployed persons in CWS give an average picture of unemployment in a short span of seven days during the survey period.

# **Gold Rises ₹300 To ₹88,500** Per 10 Gm, Silver Climbs ₹800

**NEW DELHI-** Gold prices rose Rs 300 to Rs 88,500 per 10 grams in the national capital on Tuesday amid firm global trends, according to the All India Sarafa Association.

The precious metal of 99.9 per cent purity had ended at Rs 88,200 per 10 grams on Monday. Gold of 99.5 per cent purity advanced Rs 300 to Rs 88,100 per 10 grams.

Silver prices also jumped Rs 800 to Rs 99,000 per kg from the previous close of Rs 98,200

In futures trade on the MCX, gold contracts for April delivery jumped Rs 435 to Rs 85,490

"Gold continued its positive trend, driven by persistent global uncertainty over tariffs. With banks and funds maintaining high allocations to the safe-haven asset, gold remains well-supported," Jateen Trivedi, VP Research Analyst --Commodity and Currency, LKP Securities, said.

Key events like Trump's speech on Wednesday, along with the Federal Reserve and RBI meeting minutes, will add to the market's volatility in the coming sessions, Trivedi said. Silver futures for March de-

livery also appreciated Rs 439 to Rs 96,019 per kg on the Multi Commodity Exchange (MCX).

In the international markets, Comex gold futures for April delivery climbed USD 24.94 per ounce, or 0.86 per cent, to USD 2,925.64 per ounce in the



global markets.

"Comex is trading above USD 2,925 as investors continue to monitor tensions between the US and European Union, as well as developments in Ukraine peace talks," Kaynat Chainwala, AVP-Commodity Research at Kotak Securities, said.

Meanwhile, spot gold in the verseas markets rose nearly USD 16 to USD 2,912.50 per ounce.

"Gold gained modestly on Tuesday, maintaining its position as the primary safe-haven asset and an appealing inflation hedge.

"However, further gains were capped due to hawkish remarks from Fed member Patrick Harker, who advocated on Monday night for the central bank to keep interest rates unchanged," Saumil Gandhi, Senior Analyst of Commodities at HDFC Securities, said.

# **STD Intensifies Inspections Against Sale Suppression, Fake Invoicing, GST Violations**

**JAMMU-** State Taxes Department (STD), Jammu and Kashmir has intensified its drive against menace of sale suppression and launched massive inspection drive across Jammu division to check GST violations.

Based on inputs generated by various AI tools including Business Intelligence And Fraud Analytics (BIFA), E-way Bills Portal and other components of enforcement wings, the inspections were carried under the guidance of Commissioner State Taxes J&K, PK Bhat and under the supervision of Additional Commissioner (Enforcement and Administration) Jammu, Namrita Dogra.

Led by State Tax Officers, specially constituted teams visited various business units in Rajouri, Kishtwar and Kathua simultaneously to investigate violations under GST Law by verifying documents, physical stock position, bill books etc.

While giving details on these drives, Additional Commissioner (Enforcement and Administration) Jammu, Namrita Dogra said, "The inspections are part of enforcement activity. 13 teams have been constituted to carry out inspections across the division". She added that teams specifically targeted dealers who were found engaged in sale suppression and fake invoicing. The State Taxes Department urged the dealers to follow the fair-trade practices and avoid indulging in tax evasion activities or fraudulent practices involving fake ITC.

# SC Slams States, UTs For Not Filing Status Reports

New Delhi: The Supreme Court on Tuesday pulled up several states and union territories for not filing status reports over the implementation of the domestic violence law while allowing them four more weeks subject to the payment of Rs 5,000 as costs.

A bench of Justices B V Nagarathna and Prasanna B Varale took note when the petitioner's counsel said several states and UTs did not file their status reports despite the top court's direction.

"The counsel for the respective states have sought for some more time to file status reports. Hence, four more weeks are granted to file status reports subject to payment of cost of Rs 5,000 to the Supreme Court mediation centre," the bench said.

The bench noted Andhra Pradesh, Arunachal Pradesh, Himachal Pradesh, Madhya Pradesh, Maharashtra, Meghalaya, Odisha, Telangana, West Bengal and Assam were among the defaulters. UTs of Dadra and Nagar Haveli and Daman

and Diu, Jammu and Kashmir, Ladakh and

Lakshadweep also did not file the status reports, it was further informed.

"Pay cost of Rs 5,000 and file it. If you

don't file it, next time it will double," said Justice Nagarathna.

The bench posted the matter on March 25. In its December 2 2024 order, the apex court said the status report had to be filed with regard to implementation of the Protection of Women from Domestic Violence Act, 2005.

On January 17, the top court extended the time for filing of the status reports by the states and UTs till February 14.

While hearing the matter in November last year, the apex court said the prayers in the petition were essentially for the implementation of the 2005 law.

While issuing notices, the top court said the obligation for the implementation of the law not only rested with the Centre but also with the respective state governments.

The plea sought directions to the authorities for the proper enforcement and implementation of the provisions of the 2005 Act aside from directions for adequate appointments, notification and establishment of protection officers, service providers and shelter homes as directed under the Act.

The plea also sought initiation and strict implementation of awareness campaigns related to crime against women.

# **Pending Criminal Case Not Obstacle For Appointment: DB**

Srinagar: In a landmark judgment, the Jammu and Kashmir and Ladakh High Court has ruled that the pendency of a criminal case does not bar an individual from being appointed to a Government position or performing their duties.

The Division Bench, comprising Chief Justice Tashi Rabstan and Justice MA Chowdhary, passed this ruling while dismissing an appeal filed by the Union Territory (UT) of Jammu & Kashmir.

The case involved a respondent who had been appointed under SRO 43 due to the death of his father.

The petitioners, the Jammu & Kashmir PWD (R&B), Division Bhaderwah, had issued the appointment on November 22, 2023, following approval from the administrative department.

After joining the position on December 6, 2023, the respondent disclosed that he was facing a criminal trial, though he had not been convicted.

Despite this, the respondent was allowed to start his duties, with a character verification report from CID showing no adverse remarks.

However, on January 3, 2024, the petitioners withdrew the respondent's appointment, citing the pendency of a criminal case under the NDPS Act.

The petitioners argued that the ongoing trial constituted grounds for cancelling the appointment.

This led to the respondent filing an appeal before the Central Administrative Tribunal, which ruled in his favour, directing that the withdrawal of the appointment was unjustified.

The Division Bench of the High Court, while hearing the appeal filed by the UT, held that the "mere pendency of a criminal case should not be construed as a reason for denying a person their appointed role."

The Court emphasized the principle of "presumption of innocence" until proven guilty in a court of law, asserting that unless a person is convicted, their character cannot be judged based on the pending trial alone.

The Bench further referred to the J&K Civil Services (Verification of Character and Antecedents) Instructions, 1997, which mandate periodic verification of government employees' character. In this case, the respondent had disclosed his criminal charges, and the verification report from CID was clear of any adverse comments.

Hence, the Court found no legal basis for withdrawing the appointment on the grounds of an ongoing trial.

With this ruling, the High Court dismissed the UT's appeal, upholding the Tribunal's decision and clarifying that the pendency of a criminal case should not obstruct an individual's right to employment and performance of duties.

while some springs in south Kashmir have dried up completely due to the receding water table, they said.

"There has been 79 per cent deficient precipitation in the month of January and the situation in February so far is worse. If the dry weather continues, it is going to cause problems for the residents of the valley as there won't be enough water for drinking or irritating the fields," a MET department official said.

An official of the Irrigation and Flood Control Department said the water level in River Jhelum and several other water bodies was more than a metre below the usual water level for this time of the year.

"If it does not rain or snow in the next fortnight, there is a possibility of a crisis with regards to water for drinking and irrigation purposes," he added.

Social media is flooded with videos and images of dried up water bodies with Achabal springs in south Kashmir having dried up completely.

The river bed of Jhelum is visible at many places, especially upstream in south Kashmir areas while the water level downstream in north Kashmir is alarmingly low. The situation is similar in other major streams of the valley.

The lack of enough snowfall has forced authorities to postpone the fifth edition of Khelo India Winter Games which were scheduled to begin from February 22.

While most of the Gulmarg bowl is bereft of snow, the higher reaches of the famous skiing destination does not have enough snow for safe conduct of sports activities.

significant decline in snowfall over the past five years, particularly during the peak winter season. This has led to the current alarming situation. "Snowfall is a major source of water for Kashmir's population. With the pervasive lack of snow, rivers, tributaries, and streams are drying up. This could severely impact the tourism sector, horticulture, and food security systems in Kashmir, with far-reaching economic implications," Prof. Romshoo said.

Asked about the drying up of the Achabal water stream, Prof. Romshoo explained that geological factors could be at play. The mountains from which these streams originate are shallow, and their flow is sustained by snow accumulation. "Over the past several years, we have witnessed dry winters with little to no snowfall. This is the primary reason why streams are drying up," he said.

Meanwhile, the Jammu and Kashmir government has taken up the issue of the drying Achabal stream with the Geological Survey of India (GSI).

The sources said that the Chief Secretary has directed the General Administration Department to request the GSI to dispatch a team of experts to the region. The team will investigate the causes of the crisis and recommend remedial measures.

The famous Achabal waterfall, a key water source in the region, has completely dried up, leaving many communities struggling for water. Reports indicate that 65% of water sources in the area are severely depleted, creating drought-like conditions.

Environmental experts attribute the crisis to climate change and global warming, which have significantly impacted the lower Himalayan region.

The Jhelum River, Kashmir's primary water source, has recorded its lowest water levels in decades. Groundwater reserves and other water bodies are also depleting rapidly. While temporary conservation measures have improved some wetlands, such as Hokarsar, experts warn that the crisis will worsen without a comprehensive water management policy.

"We need a holistic approach to managing water resources, especially for rivers like the Jhelum and Chenab. A structured policy will help regulate water release and conservation," said Javaid Khursheed, a research scholar in environmental sciences.

The effects of global warming are being felt worldwide, with extreme weather patterns causing both floods and droughts. Experts emphasize that preserving wetlands, lakes, and rivers is crucial to mitigating the impacts of climate change. Khursheed urged both the government and citizens to take immediate action

to prevent further environmental degradation.

"Pollution in our riverbeds must be addressed at every level. Sustained conservation efforts are vital for the survival of our water bodies," he added. (KNO)

### 'Declining Snow

to culminate on (Wednesday February 19), the weatherman has predicted light to moderate rain and snow at many places on its last day.

The fresh rains and snow in Jammu and Kashmir will likely end the prolonged dry spell tomorrow as a two-day wet spell is expected to bring rains and snow in J&K till Thursday.

Notably, after a 20-day long Chillai-Khurd that occurs between January 31 and February 19, a 10-day long Chillai-Bachha will commence from February 20 to March 2.

Director Meteorological (MeT), Dr Mukhtar Ahmad told the news agency—Kashmir News Observer (KNO) there is a possibility of light to moderate rain and snow at many places during 19th evening to 20th late afternoon. "The fresh Western Disturbance is all set to hit the Union Territory," he added.

Dr Ahmad said that the plains of Kashmir & Jammu may receive light to moderate rain and thunder with gusty winds at few places, adding that the higher reaches of Chenab Valley & South Kashmir may receive moderate snowfall up to around 10 inches while the higher reaches of north & Central Kashmir may receive snowfall up to 8 inches.

Meanwhile, an Independent Weather Forecaster, Faizan Arif Keng said that a fresh Western Disturbance is set to develop over Afghanistan on February 19 and quickly move towards Jammu and Kashmir by February 20, bringing widespread rain and snow across the Union Territory.

"The first signs of the disturbance will be felt in the higher reaches from late night on February 19, with precipitation gradually intensifying as it spreads across the region. Most parts of Jammu and Kashmir are likely to witness a moderate spell of rain/snow, along with the possibility of a heavy spell in some parts," he said.

"Overall, on average, Jammu region may record higher precipitation than Kashmir Valley. The Chenab Valley districts - Ramban, Kishtwar, and Doda - are also expected to receive moderate to heavy precipitation. In Kashmir Valley plains, rains may dominate on that day, but a sharp drop in temperature could trigger a transition to snowfall, especially under prolonged heavy precipitation," Keng added.

Temperatures, which will remain in the range of 15 - 18°C on February 19, are expected to drop below 7°C on February 20. The Pir Panjal range is expected to receive heavy snowfall, affecting areas such as Gulmarg, Sinthan Top, Peer Ki Gali, and other parts of Mughal Road, Keng added.

Due to higher temperatures, lightning and thundershowers may remain a common feature on that day, especially in Jammu region. There is a risk of shooting stones/landslides on Jammu-Srinagar National Highway on 20th February. Weather is expected to improve from 21st February onward," he said.(KNO)

of the new laws, it is imperative to change the attitude of police personnel and the administration and create awareness about the new laws among citizens. "He said that optimum use of technology should be made to ensure speedy justice under the three new criminal laws," reads an official handout issued by the Ministry of Home Affairs (MHA) after the meeting.

Shah added that there is an urgent need to use the provision of Trial in Absentia in the Union Territory. The Union Home Minister stressed the need to fix the responsibility of police officers to expedite the process of filing chargesheets. are not misused.

"The home minister mentioned that similar review exercises have been conducted for 11 states and Union Territories so far. In the case of Jammu and Kashmir, implementation has been largely smooth, barring a few issues that will be resolved," Omar said.

While acknowledging that the implementation of the laws does not fall under the elected government's purview, he stressed the importance of educating citizens about the changes. "People must be made aware of these new laws through colleges, universities, and other platforms," he added.

In the government of India, he has rich experience of working as the joint secretary in the Ministry of Defence, joint secretary and additional secretary in the Ministry of Home Affairs, secretary in the Ministry of Parliamentary Affairs and secretary in the Ministry of Cooperation. He superannuated on January 31, 2024.

### **SC To Hear Pleas**

and election commissioners (EC) under the 2023 law.

A bench of Justices Surya Kant and N Kotiswar Singh was informed by advocate Prashant Bhushan, appearing for an NGO, that despite the Constitution bench verdict of 2023 directing selection and appointment of the CEC and ECs through a panel including the Chief Justice of India, the government excluded the CII and made a "mockery of democracy".

He said, "The matter is listed on February 19 but it is listed as item number 41. The government has appointed the CEC and EC as per 2023 law disregarding the view taken by a constitution bench. Kindly take up on top of the board as the matter requires urgent consideration."

Advocate Varun Thakur, appearing for petitioner Jaya Thakur, said three appointments were made by the government under the new law, which was under challenge.

The bench assured Bhushan and other parties that after some urgent listed matters, it would take up the petitions for hearing on February 19.

On February 17, the government appointed EC Gyanesh Kumar as the next CEC.

Kumar is the first CEC to be appointed under the new law and his term would run till January 26, 2029, days before the EC is expected to announce the schedule of the next Lok Sabha election.

Vivek Joshi, a 1989-batch Haryana-cadre IAS officer, was appointed as an election commissioner.

Born on May 21, 1966, Joshi (58) would serve in the poll panel till 2031.

According to the law, a CEC or an EC retires at 65 or can have a tenure in the poll panel for six years.

On February 12, the top court fixed February 19 to hear pleas against the appointment of the CEC and EC under the 2023 law saying if anything happens in the interregnum, the consequences were bound to follow.

It said the issue would be decided on merit and finally.

Bhushan had submitted that the 2023 verdict held that the election commissioners have to be selected for appointment by an independent panel comprising the prime minister, Leader of Opposition and Chief Justice of India.

"They have brought an Act by which they have removed the chief justice and brought in another minister, effectively making the commissioners appointment only at the pleasure of the government. You need to have an independent committee to appoint the election commissioners," he said.

On March 15, 2024, the top court refused to stay the appointments of the new ECs under the 2023 law which excluded the CJI from the selection panel and deferred the hearing on a batch of pleas challenging the appointments.

The apex court told the petitioners that the

March 2, 2023 verdict directed for the threemember panel comprising the Prime Minister, Leader of Opposition and the CJI to operate till Parliament enacted a law. The NGO Association for Democratic

Reforms has challenged the CJI's exclusion and

contended the election commission should be insulated from "political" and "executive interference" for maintaining a healthy democracy.

ADR's plea alleged the verdict was overruled by the Centre without removing its basis and the composition of the selection committee under the new law which amounted to excessive interference of the executive in the ap-

Locals allege that the problem worsened after forest clearance was granted for the 40-kilometer Handwara-Bangus road in 2017. They claim the road, which cuts through a large, dense forest, has forced wild animals out of their natural habitat and into closer proximity with human populations. The road traverses compartments 2, 3a, 3b, 4, 5, 6, 10, 11, 12, 13, 14,

15, 16, 24, 25, and 26 of the Rajwar forest area. "Before 2018, there were few, if any, such incidents," Bhat said. "The surge occurred after forest clearance was given for the road. A feasible alternate route existed via Rajwar Zachaldara-Wadder, making the current route unnecessary and environmentally damaging."

Bhat, who is also contesting the road construction in the National Green Tribunal (NGT), argues that the project has not only disrupted the ecosystem but also threatens local livelihoods.

"The increased human-animal conflict is

impacting agriculture and horticulture, key sources of income for residents. Furthermore, the road bypasses the main Rajwar area, potentially hindering economic benefits for the local community," he said.

He also alleged that Rule 7C of the J&K Forest and Afforestation rules was miscounted and dishonestly applied in granting forest clearance.

Bhat called for the cancellation of the Handwara-Bangus road project and the reforestation of the affected area. He suggested declaring the disturbed forest areas, which connect to other wildlife habitats in Kupwara, as a wildlife sanctuary. "There must be a safe haven for wildlife to prevent these conflicts and protect the animals," he added. He emphasized the need for a balanced approach that considers both development and environmental protection.

# Billionaire Jim Ratcliffe's First Year At Man United Has Not Gone To Plan

MANCHESTER: It's been a year since one of Britain's richest men bought into its most famous soccer team and vowed to bring the good times back.

So far, it hasn't gone to plan for Manchester United or Jim Ratcliffe. The record 20-time English champion is languishing in the bottom half of the Premier League, losing vast sums of money every year

and facing fan unrest. Even head coach Ruben Amorim said recently that this might be the worst team in the club's storied his-

That's not all on Ratcliffe, the billionaire owner of petrochemicals giant INEOS, but it has been a rocky start since he paid \$1.3 billion for an initial 25% stake in United and assumed control of its soccer opera-

There have been high profile hirings and firings, brutal cost cutting, a hike in ticket prices and new lows on the field for a team that had been in decline for more than a decade before he became minority owner.

While there was triumph in the FA Cup last year, that success has been overshadowed by supporter protests, job losses, unconvincing transfers and humbling defeats.

### **BOLD PLANS**

Ratcliffe said his investment was "just the beginning of our journey to take Manchester United back to the top of English, European and world football."

Those ambitions feel further away now than they have in decades, with United 15th in the standings and closer to the relegation zone than the top six after a woeful campaign. Sunday's 1-0 loss to Tottenham was the 12th in the league this season and an eighth under Amorim, who only took charge in November.

Amorim said: "I have a lot of problems, my job is so hard, but I am here to continue my job to the next week with my beliefs.'

# **MAJOR OVERHAUL**

He was one of a number of key hires made as part of Ratcliffe's overhaul of United's soccer opera-

Omar Berrada was lured away from Manchester City to become CEO and Dan Ashworth left Newcastle to take up the role of sporting director. Jason Wilcox, formerly



director of City's academy, became

technical director. Key figures at Ratcliffe's Ineos Sport, Dave Brailsford and Jean-Claude Blanc, were appointed to the board and Amorim became the final piece of a new leadership team after former manager Erik ten Hag was fired in October.

But that restructuring has been far from a smooth process.

Ten Hag was fired three months after being handed a one-year contract extension with United having lost four of its opening nine

Ashworth left the club less than six months after taking up his role, and after months of negotiations to take him away from Newcastle.

They were expensive missteps. In total it cost United 10.4 million pounds (\$13.09 million) to pay off Ten Hag and his staff and another 11 million pounds (\$13.85 million) to trigger Amorim's release from Sporting Lisbon.

It was reported it cost between 2 and 3 million pounds (\$2.5-3.78 million) to hire Ashworth, who spent five months on gardening leave during negotiations with

### **COST CUTTING**

Those numbers make uncomfortable reading at a time when United has implemented cost-saving initiatives that it said included staff redundancies of around 250 roles. More could be on the way, according to reports.

In October it emerged that managerial great Alex Ferguson was not beyond the reach of those measures. He will step down from his lucrative role as club ambassador at the end of the season.

In addition to cuts, United raised its lowest-priced tickets to 66 pounds (\$81) partway through the season, up from 40 pounds (\$49).

It defended that decision by telling fans it could not sustain its current financial losses and was in danger of breaching league rules if it did not act. United reported losses last year of 113.2 million pounds (\$140 million)

"We will get back to a cash positive position as soon as possible and we will have to make some difficult choices to get there," it said in a letter to fans.

### **FAN PROTESTS** That explanation has not gone

down well with supporters. "Fans should not be paying the

price for previous bad ownership & bad management," Manchester United Supporters Trust posted on X. "The supporters bring far more value than the simple collective ticket revenue.'

Supporters spent years trying to drive out the American Glazer family, which is still majority owner, and there continues to be anger towards them after Ratcliffe's investment.

There have been jeers for the team while United's performances on the field have continued to slide.

### **NEW LOWS**

Ratcliffe's first season as coowner saw United endure its worst league campaign in 34 years when it finished in eighth place.

The end of his first full season could be even worse.

The last time it lost 12 of its first 25 games in a league season was in the 1973-74 campaign when it was relegated from the top flight.

### TRANSFER STRATEGY

United has spent around \$260

million on players in the two transfer windows under Ratcliffe, but the squad still looks well short of the quality required to challenge for the

Forward Joshua Zirkzee has struggled to adapt to the Premier League and defender Leny Yoro missed a large part of the season through injury.

The pressure of complying with the league's financial rules has placed uncertainty on United's ability to spend big in the summer to bring in players to suit Amorim's preferred system, and there is unlikely to be a quick fix.

### STADIUM REBUILD

Ratcliffe wants a world class stadium, either by way of redeveloping United's iconic Old Trafford or building one from new

His plans, which include an ambitious redevelopment of the surrounding area, have been backed by the U.K. government. Financing them, however, is another issue and it is not yet clear where that money will come from.

The modernization of United's Carrington training ground is well underway after 50 million pounds (\$63 million) of investment.

# New Zealand changes 'Golden Visa' to lure wealthy foreigners

New Zealand is simplifying its so-called "golden visa" program, including removing an English language requirement, to attract wealthy immigrants and help spark an economic recovery.

From April 1, the Active Investor Plus visa will be narrowed to just two categories, while the scope of acceptable investments will be expanded, Immigration Minister Erica Stanford said Sunday in Auckland. As well as dropping the language test, other potential barriers to investment such as the amount of time investors must stay in the country will also be adjusted, she said.

After a sharp recession in 2024, the New Zealand government wants to capitalize on falling interest rates to lift economic performance but has acknowledged it needs lacks the necessary capital. It is reworking foreign investment regulations, created a single agency to act as a one-stop shop for overseas fund managers, and has eased rules to allow visitors to work remotely, hoping that might encourage highly skilled people to relocate permanently.

"Capital is highly mobile and in an increasing complex world, people are looking for a safe and stable country to do business," Stanford said. "We are now making our investor visa simpler and more flexible to incentivize investors to choose New Zealand as a destination."

The Active Investor Plus visa was successful at luring rich individuals to New Zealand and raked in an average NZ\$1 billion (\$570 million) a year, but has languished after rule changes in late 2022.

Just 43 applications have been fully approved since those adjustments were made, equating to NZ\$545 million of nominated investment funds, according to data from Immigration New Zealand. The actual amount of money coming across the border was significantly less, the government said today.

The new program will have two categories:

Growth, or higher risk, requiring a minimum investment

of NZ\$5 million over three years either directly into businesses or into managed funds; visa holders must spend just 21 days in the country

Balanced, or mixed risk, requiring a minimum of NZ\$10 million invested over five years into bonds, stocks, new property development including residential, or existing commercial and industrial property; holders must spend at least 105 days in the country but can reduce the period by investing above the minimum

By offering an option for lowrisk investors the program will be attractive to a wider group of people, rather than just focusing on those with a high risk appetite, Stanford said, adding there is already of a large amount of interest from applicants that had been generated during consultations with the industry.

New Zealand's easing of its investor visa rules comes at a time when many other nation are ending theirs. Spain will end its golden visa program on April 3, while the UK, Ireland, the Netherlands, Greece and Malta have either ended or tightened the rules around their golden visa or equivalent policies.

The Australian government has effectively scrapped its Significant Investor visa class — which was available for arrivals who invested more than A\$5 million (\$3 million) — over concerns that it had been abused by wealthy individuals who had used it to buy property or financial assets without contributing significantly to productive parts of the economy.

Marcus Beveridge, a business migration specialist and managing director at Queen City Law in Auckland, welcomed the changes as being well over due, and predicted they will give New Zealand's sluggish residential property market a shot in the arm.

"Over the last couple of decades every time we do something like this the property market picks up," he said. "It's not so much about huge numbers coming across the border but what happens is that the cash investment primes the pumps and our local market takes off."

# Obesity Breakthrough? Scientists Discover Neurons That Regulate Eating



Washington DC: Scientists have found specialized neurons in the brains of mice that order the animals to stop eating. Though many feeding circuits in the brain are known to play a role in monitoring food intake, scientists also believe that the neurons in those circuits do not make the final decision to cease eating a meal.

The neurons identified by the Columbia scientists, a new element of these circuits, are located in the brainstem, the oldest part of the vertebrate brain. Their discovery could lead to new treatments for obesity.

"These neurons are unlike any other neuron involved in regulating satiation," says Alexander Nectow, a physician-scientist at Columbia University Vagelos College of Physicians and Surgeons, who led the research with Srikanta Chowdhury, an associate research scientist in the Nectow lab.

"Other neurons in the brain are usually restricted to sensing food put into our mouth, or how food fills the gut, or the nutrition obtained from food. The neurons we found are special in that they seem to integrate all these different pieces of information and more."

The decision to stop eating is a familiar phenomenon. "It happens every time we sit down to eat a meal. At a certain point while we're eating, we start to feel full, and then we get fuller, and then we get to a point where we think, okay, that's enough," Nectow says.

How does the brain know when the body has had enough -- and how does it act on that information to stop eating? Other researchers had previously tracked the decision-making cells to the brainstem, but the leads ended there in previous research.

Nectow and Chowdhury deployed new single-cell techniques that make it possible to peer into a region of the brain and discern different types of cells that until now have been difficult to distinguish from one another.

"This technique -- spatially resolved molecular profiling -- allows you to see cells where they are in the brainstem and what their molecular composition looks like," Nectow says.

During their profiling of a brainstem region known for processing complex signals, the researchers spotted previously unrecognized cells that had similar characteristics to other neurons involved in regulating appetite. "We said, 'Oh, this is interesting. What do these neurons do?'

To see how the neurons influenced eating, the researchers engineered the neurons so they could be turned on and off, by the researcher, with light.

When the neurons were activated by the light, the mice ate much smaller meals. The intensity of the activation determined how quickly animals stopped eating. "Interestingly, these neurons don't just signal

an immediate stop; they help

the mice to slow down their eat-

ing gradually," Chowdhury says.

Nectow and Chowdhury also looked at how other eating circuits and hormones affected the neurons. The researchers found that the neurons were silenced by a hormone that increases appetite and activated by a GLP-1 agonist, a class of drugs now popular for treating obesity and diabetes. These experiments found that these inputs helped the neurons track each bite the

mice took.

"Essentially these neurons can smell food, see food, feel food in the mouth and in the gut, and interpret all the gut hormones that are released in response to eating," Nectow says. "And ultimately, they leverage all of this information to decide when enough is enough."

Though the specialized neurons were found in mice, Nectow says their location in the brainstem, a part of the brain that is essentially the same in all vertebrates, suggests that humans likely have the same neurons.

# India set to launch cancer vaccine for women in five to six months: Union minister

Avaccine to fight cancers affecting women will be available in five to six months, and those in the age group of nine to 16 years will be eligible for inoculation, Union Minister Prataprao Jadhav said on Tuesday.

Addressing a press conference here, the Union Minister of State for Health, Family Welfare and Ayush (Independent Charge) said that research on a vaccine is nearly complete and trials are underway.

"The number of cancer patients has increased in the country, and the Central government has initiated steps to address this issue. Women above 30 will undergo screening at hospitals, and daycare cancer centres will be established for early detec-

tion of the disease," Jadhav said. He said the government has also waived off customs duty for medicines used in cancer treatment. The minister said, "The research on a vaccine for cancers that affect women is nearly complete, and trials are underway. It will be available in five to six months, and girls in the age group of nine to 16 years will be eligible for inoculation." Asked about the cancers the vaccine will tackle, Jadhav said breast,

oral and cervical cancers.
Asked about transforming the existing healthcare centres into Ayush facilities, Jadhav said hospitals have Ayush departments, and people can avail of these

He said the country has 12,500 such health facilities, and the government is increasing them.
