'Anti-Alcohol' Signboard Removal Sparks Outrage

Srinagar: The removal of a signboard by the police in Lal Chowk, Srinagar, which urged tourists to respect local culture and avoid alcohol and drug use, has sparked controversy. The move has drawn criticism from political leaders, traders, and the public, with many questioning the administration's commitment to community-driven initiatives.

The signboard, which was installed by the Traders Association Central Lal Chowk Srinagar, welcomed visitors with a message encouraging them to "love and cherish their families" while respecting local traditions. It specifically advised tourists to refrain from consuming alcohol, using drugs, spitting on the streets, and smoking in public areas. However, within an hour of its installation, authorities reportedly took it

down, prompting accusations of cultural suppression and a lack of political will.

Several prominent political figures, including Mirwaiz Umar Farooq and Member of Parliament Aga Ruhullah Mehdi, condemned the removal.

Mirwaiz Umar Farooq wrote on his Twitter, "Why was this signboard seized? What exactly is wrong with urging tourists to respect local culture, avoid alcohol and the use of drugs, and keep the city clean?"

"Is promoting moral values and decency now a crime in Kashmir?" Mirwaiz questioned.

Mehdi also took to social media to express his frustration, writing on X (formerly Twitter), "Even appealing to tourists to respect local sensitivities is now illegal in Kashmir. Will @ JmuKmrPolice clarify which law was violated by the signboard? Or is the only | More on P10

Trump Fires Top US General In Unprecedented Pentagon Shakeup

Washington: President Donald Trump on Friday fired the chairman of the Joint Chiefs of Staff, Air Force General C Q Brown, and pushed out five other admirals



and generals in an unprecedented shake-up of US military leadership.

Trump said in a post on Truth Social that he would nominate retired Lieutenant General Dan "Razin" Caine to succeed Brown. A former F-16 fighter pilot, Caine was the associate director of military affairs at the Central Intelligence Agency until late last year.

Trump will also replace the head of the US Navy, a position held by Admiral Lisa Franchetti, the first woman to lead a military service, as well as the air force vice chief of staff and judge advocates general for the Army, Navy and Air Force, the Pentagon said.

Trump's decision sets off a period of upheaval at the Pentagon, which was already bracing for mass firings of civilian staff, a dramatic overhaul of its budget and a shift in military deployments under Trump's new America First foreign policy. While the Pentagon's civilian leadership changes from one administration to the next, the uniformed members of US armed forces are meant to be apolitical, carrying out the policies of Democratic and Republican administrations.

Brown, the second Black officer to become the president's top uniformed military adviser, had been expected to complete

his entire four-year term in September 2027. A US official said Brown was relieved with immediate effect, even before the Senate confirms his successor.

Reuters in November was first to report that the incoming Trump administration planned a sweeping shakeup of the top brass, with firings including Brown.

'WOKE' GENERALS

During last year's presidential campaign, Trump spoke of firing "woke" generals and those responsible for the troubled 2021 pullout from Afghanistan. On Friday, the president did not explain his decision to replace Brown.

"I want to thank General Charles 'CQ' Brown for his over 40 vears of service to our country, including as our current Chairman of the Joint Chiefs of Staff. He is a fine gentleman and an outstanding leader, and I wish a great future for him and his family," Trump wrote.

Defence Secretary Pete Hegseth had been skeptical of Brown before taking the helm of the Pentagon with a broad agenda that includes eliminating diversity, equity and inclusion initiatives in the military.

In his most recent book, Hegseth asked whether Brown would have gotten the job if he were not Black. "Was it because of his skin color? Or his skill? We'll never know, but always doubt - which on its face seems unfair to CQ.

But since he has made the race card one of his biggest calling cards, it doesn't really much matter," he wrote in his 2024 book "The War on Warriors: Behind the Betrayal of the Men Who Keep Us Free.

Brown, a former fighter pilot with command experience in the Middle East and Asia, recounted his experiences of discrimination in the military in an emotional video posted online after the 2020 killing of George Floyd, which sparked nationwide protests for racial justice.

Will Not Implement NEP Even If Rs 10,000 Crore Offered To Tamil Nadu: CM Stalin

New Delhi: Continuing his tirade against the Centre over the National Education Policy (NEP), Tamil Nadu Chief Minister MK Stalin on Saturday said he would not agree to implement it even if the Centre offered to provide Rs 10,000 crore in funds to the state.

The opposition to NEP was not merely due to the attempt to impose Hindi but also because of various other factors that would have serious consequences for the future of students and the social justice system, he claimed.

Apart from encouraging a screening test for admissions to even arts and science colleges, similar to NEET for medical courses. NEP would allow students to discontinue their studies.

"Permitting students to discontinue studies is akin to asking them not to study," Stalin said, addressing an event organised by Parents-Teachers Association here.

"We are not opposed to any language but will remain firm in opposing its imposition. We are not opposing NEP only for the attempt



to thrust Hindi but for several oth er reasons as well. NEP is regressive. It will drive students away from schools," Stalin claimed.

Apart from 'denying' financial aid to SC/ST and BC students, which is now being provided, NEP proposed public exams for third, fifth, and eighth standards, besides introducing a common entrance test for admissions to arts and science colleges, the Chief Minister said.

"The Centre says Tamil Nadu will get Rs 2,000 crore if the state implements NEP. I wish to say that we will not agree to NEP even if the Centre offers Rs 10,000 crore. I will not allow NEP and commit the sin of pushing Tamil Nadu backward by 2,000 years," Stalin said.



Thousands Fly To Lebanon For Funeral Of Hassan Nasrallah

Beirut: Nearly five months after Sayyed Hassan Nasrallah was assassinated by Israel, hundreds of thousands of supporters of Hezbollah's slain leader have flown into Beirut for his funeral on Sunday.

Sayyed Nasrallah was killed on Sept. 27 when Israel's air force dropped more than 80 bombs on Hezbollah's main operations room in southern Beirut. It was the biggest and most consequential of Israel's targeted killings in years.

Stream of visitors arriving in the Lebanese capital for the funeral of the assassinated leader, which is set for Sunday at 1:00 PM local time, include journalists, anti-imperialist activists and social media influencers from around

Beirut's airport and streets are seeing a steady stream of people, many waving Hezbollah flags and carrying portraits of Nasrallah as they gather to honour him.

Nasrallah, idolised by his supporters held the title of sayyid, an honorific meant to signify his lineage to the Prophet Muhammad (Pbuh).

Over the three decades run as Hezbollah supremo Nasrallah became a symbol of defiance, and his legacy is honorued by his supporters from across Arab and Islamic world.

Hezbollah suffered significant losses in the latest war with Israel, which it fought to ease

New Legal Framework to Tackle 'Harmful' SM Content

New Delhi: The Information and Broadcasting Ministry is examining the existing statutory provisions and the need for a new legal framework to regulate "harmful" content amid complaints of "obscenity and violence" being shown on digital platforms.

In its reply to a parliamentary panel, the ministry said there is a growing concern in the society that the constitutional right of "freedom of expression is being misused to showcase

obscene and violent content on digital platforms"

It told the Standing Committee on Communications and Information Technology headed by BJP MP Nishikant Dubey that while certain provisions exist un-

der the current laws, there is a growing demand for a stricter and effective legal framework to regulate such harmful content. It said, "This ministry has taken note of these developments and is in process of examining current statutory provisions and need for a new legal framework.'

The ministry said that many high courts and the Supreme Court, MPs and statutory bodies like the National Commission of Women have spoken on the issue, which has made headlines after the crass comments of social media influencer Ranveer Allahbadia drew

wide condemnation. Criminal cases have been registered against him, and his apology has done little to damp down the controversy. While the Supreme Court granted him protection from arrest, it also made very critical observations

over his vulgar comments. The ministry told the committee that it will submit a detailed note after due deliberations. The committee had asked the

Democrats had sounded the alarm about the appointment, saying they fear Patel will operate as a loyalist for Trump and abuse the FBI's law enforcement powers to go after the president's adversaries. They've cited past comments such as his suggestion before he was nominated that he would "come after" anti-Trump "conspirators" in the government and media.

Patel sought to assuage those concerns at his confirmation hearing last month, saying he intended to follow the Constitution and had no interest in pursuing retribution, though he also said at his swearing-in Friday that reporters had written "fake, malicious, slanderous and defamatory" stories about him.

Vehicle Numbers In J&K Double Over Eight Years

SRINAGAR: Over the past eight years, the number of vehicles in Jammu and Kashmir has doubled, resulting in increasingly congested and chaotic roads.

According to recent data accessed the region has seen a significant rise in both public and private transport. In 2016, there were 13,65,552 registered vehicles, a number that surged to 25,67,000 by the end of March 2024- a drastic surge of more than 12 lakh vehicles.

Revenue targets and achievements also show a positive trend. In 2020-21, the department achieved Rs 821.15 crore against a target of Rs 900.00 crore. The following year, 2021-22, saw an achievement of Rs 628.65 crore against a target of Rs 625.00 crore. In 2022-23, the department achieved Rs 725.03 crore against a target of Rs 800.00 crore. The most recent year, 2023-24, saw the department exceed its target, achieving Rs 925.00 crore against a target of Rs 915.00 crore.

The Motor Vehicles Department has reported substantial revenue growth, achieving Rs 925.12 crore against a target of Rs 915.00 crore during the financial year 2023-24. This period also saw the registration of 1.65 lakh vehicles, alongside the issuance of 11,196 fresh route permits and the renewal of 40,595 existing ones. Additionally, 99,191 fresh driving li-censes were issued, with 65,501 licenses renewed. The department also issued 14,963 fresh fitness certificates for commercial vehicles and renewed 93,292 such certificates.

The data highlights a consistent increase in vehicle registrations and related administrative activities over the years. In 2020-21, the department registered 93,366 commercial and 1,12,468 non-commercial vehicles, totalling 1,31,644. By 2021-22, these numbers rose to 18,491 commercial and 1,17,686 non-commercial vehicles, totalling 1,37,177. The trend continued in 2022-23 with 28,657 commercial and 1,36,298 noncommercial vehicles, totalling 1,57,792. By 2023-24, the numbers reached 36,282 commercial and 1,28,095 non-commercial vehicles, totaling 1,62,378.

In terms of permits and li-

censes, the department issued 3,697 fresh permits and renewed 36,364 permits in 2020-21, totalling 40,061. The following year, 2021-22, saw 6,681 fresh permits and 39,311 renewals, totalling 4,992. In 2022-23, the department issued 5,407 fresh permits and renewed 46,496, totalling 51,903. By 2023-24, the numbers rose to 11,105 fresh permits and 40,595 renewals, totalling 51,791.

A senior official of the Road and Transport Department said that the rise in vehicle numbers has put immense pressure on the region's infrastructure, leading to frequent traffic jams and road safety concerns. "We are now faced with the challenge of managing this exponential growth while ensuring the safety and efficiency of the transport system," he said.

The official added, "The roads aren't wide enough in cities and towns. There are concerns about people's safety with road accidents becoming normal. With the sale of the new vehicles, the government has to ensure it wouldn't turn into Frankenstein's monster - out to devour its very own masters."—(KNO)

Tral's Aripal Spring Runs Dry Despite Rains

SRINAGAR: Despite recent rainfall, the water level in Aripal Spring-on which nearly six water supply schemes depend—continues to remain dry, worsening the water crisis in the region.

Aripal Spring has remained dry for nearly three months, causing severe difficulties for the local population.

Officials from PHE Tral said that the depletion of the spring began in December last year, and despite recent rainfall, the water level has not improved even by 5 per cent.

The drying up of this key water source has led to a severe water shortage in many areas

An official from the Jal Shakti Department said the situation

remains critical. He said the residents have been facing water scarcity for the past three months.

"Tanker services have been deployed, but they can only meet about 10 percent of the demand," the official said. "The situation is extremely concerning as the recent rains have failed to restore the water source for six water supply schemes."

He added that every effort is being made to supply water through tankers, but the demand far exceeds availability.

"We were hopeful that the water flow in the spring would be restored by February 18, but that hasn't happened for unknown reasons," he said. "If the situation persists for a few more days, we could be facing an even tougher crisis."—(KNO)

"Similar operations have been launched in Udhampur," he added.

Cordon and search operations were also conducted in Mohalla Qasba, Allapir, Jaalian in Mandi, and Mankote in Poonch district. Other key areas under operation include Dera Ki Gali, Sunderbani, and Nowshera sectors in Rajouri district, the official said.

Several locations in Poonch-Rajouri and higher reaches

GMC Baramulla Operates Without Cardiologist

SRINAGAR: Patients in north Kashmir feel they are back to square one as Government Medical College (GMC) Baramulla has been functioning without a cardiologist for the past few months.

Several patients from cardiovascular issues, who had been receiving treatment at GMC Baramulla for the last two years, say that the absence of a cardiologist has left them in distress. They are now forced to travel to Srinagar once again for treatment, reversing the relief they had experienced.

"For two years, we had access to cardiac care at GMC Baramulla, which was a huge relief. Now, in the absence of a cardiologist, we are back to struggling with long and exhausting trips to Srinagar," said Abdul Rashid, a cardiac patient from Baramulla.

He added that cardiac patients previously benefited from local services, eliminating the need for strenuous travel. However, with no specialists available, even basic consultations and follow-ups now require travel to Srinagar.

Nazir Ahmad, another patient, highlighted the impact of the missing specialist. "The availability of a cardiologist at GMC Baramulla has eased our difficulties. We could get tests like echocardiograms and essential heart treatments locally. Now, we are back to where we started, facing the same hardships again," he said.

He added that regular fol-

low-ups are critical for heart patients, and travelling to Srinagar for every consultation is not only exhausting but also financially burdensome.

"In 2023, I had a dual-chamber pacemaker implanted at GMC Baramulla. However, after the cardiologist was transferred, I have been unable to receive regular follow-ups. Travelling to Srinagar for consultations is both physically exhausting and financially challenging," he said.

The absence of specialised cardiac care in Baramulla has also affected patients' families. Many have to take time off work or spend heavily on transportation to accompany their loved ones to Srinagar. This creates a major barrier to essential healthcare, especially for those with limited financial means.

Residents said that GMC Anantnag and GMC Baramulla were established at the same time, yet GMC Anantnag now has a functional cath lab, while GMC Baramulla does not even have a cardiologist.

They urged authorities to appoint a permanent cardiologist at GMC Baramulla to ease the suffering of cardiac patients across North Kashmir. The lack of a specialist is also increasing the patient load in Srinagar hospitals, as those from North Kashmir have no other option

but to seek treatment there. Meanwhile, Principal GMC Baramulla, Dr Majid Jahangir told KNO that the issue has already been raised with higher authorities. "We are hopeful that a cardiologist will be posted here soon," he said—(KNO)

Will the Karewa Protection Bill Become a Law in J&K?

he valley of Kashmir is an oval-shaped basin with a small plain area of approximately 160 x 60 km. The valley has large tracts of plateaus, locally known as Karewas or Woedder. These small hillocks are an intermountain fill that comprises unconsolidated gravel and mud. Geologists say that the Karewas of Kashmir were formed during the Pleistocene period, which began about 2.6 million years ago and lasted until about 11,700 years ago. During this time, the entire valley of Kashmir was submerged under water, resembling a massive lake (Sati Sar). When the valley's water drained out through Khadanyar (Baramulla), huge mud deposits were left behind, which solidified over time and came to be known as Karewas.

Kashmir's Karewas are massive plateaus—dry yet highly fertile. Over the last two to three decades, these Karewas have been plundered for clay excavation, a trend that has significantly increased over the last 5 to 6 years due to rising demand for clay in highway construction. The clay from Karewas in Budgam, Pulwama, Anantnag especially Bijbehera and Pattan area in Baramulla has also been used to fill low-lying areas and wetlands, a major contributing factor to the devastating floods in Kashmir, especially in Srinagar in 2014.

Thousands of hectares of Karewa land in Pulwama, particularly in the Parigam to Newa villages and the Chadoora area, including Kuzwera, Kultreh, Nagam, and Hayathpora villages, have been plundered by an organized mafia under the guise of development. Unfortunately, officers from the Revenue Department, including Sub-Divisional Magistrates (SDMs) and Tehsildars, have facilitated this loot by granting so-called Disposal Permits. These permits have also been misused to exploit Kashmir's rivers and streams.

Despite several laws protecting rivers and streams, there is no legislation safeguarding Karewas. The Revenue & Geology & Mining Departments continue issuing permissions to destroy these unique landforms.

Private Member's Bill

To protect and preserve Karewas, Dr. Syed Bashir Veeri, MLA from Bijbehara, has introduced a Private Member's Bill, an appreciable initiative aimed at regulating and curbing the destruction of Karewas due to the excavation of clay, sand, gravel, and other materials

Preamble of the Bill (2025)

I reviewed the draft Karewa Bill a



few weeks ago and shared some suggestions with Hon'ble MLA Dr. Veeri. However, due to time constraints, I couldn't consult more experts. Still, I find the bill commendable, and if passed into law, it will be immensely beneficial.

The preamble of the draft bill states:

"Whereas to regulate the excavation of clay, sand, gravel, and other construction materials from Karewas—unique plateau-like geological formations with a history dating back more than 1 million years. Karewas are geological and archaeological treasures, an unnoticed heritage of Kashmir Valley."

"Whereas Karewas hold great importance for agriculture and horticulture, particularly for saffron, almond, and apple cultivation. These landforms also play a crucial role in environmental conservation, with Karewa plantations serving as biodiversity hubs, often referred to as deemed forests."

"And whereas it is necessary to regulate mining activities in Karewas, especially clay, sand, and gravel excavation, to enforce strict penalties for violations and ensure sustainable land management."

Highlights of the Karewa Bill The bill's primary goal is to regu-

The bill's primary goal is to regulate mining in Karewas and protect local biodiversity and the environment. It strictly prohibits the excavation of clay and other materials like bajri and gravel from designated Karewa regions.

The bill states:

*"Mining shall be strictly prohibited in Karewa stretches designated as ecological, geological, and archaeological sensitive zones due to their 1-million-year-old history. Mining in

Karewas shall only be permitted in designated areas that have already faced destruction, subject to approval from the *J&K State Environmental Impact Assessment Authority (JKSEIAA)."

Mining in Karewa lands containing fruit trees, saffron fields, vegetable crops, or non-fruit-bearing trees shall be prohibited. All mining activities will require prior approval from the Karewa Protection Authority (KPA) and JKSEIAA, in consultation with the J&K Pollution Control Committee, Department of Geology & Mining, and Agriculture & Horticulture Departments.

A comprehensive Environmental Impact Assessment (EIA) will be mandatory before granting mining leases. Sustainable mining practices, including controlled extraction and periodic ecological assessments, will be enforced.

Penalties for Violations

The Private Member's Bill on Karewa Protection proposes strict action against illegal mining, including imprisonment of up to 5 years and a penalty of 10 lakh. Even government officers involved in unauthorized mining will face consequences.

"Any person or entity found guilty of illegal mining in Karewas shall be subject to a fine of up to 10 lakh per violation and up to 5 years of imprisonment for repeated offenses. Equipment and vehicles used for illegal mining shall be seized and confiscated. Government officials complicit in Karewa mining shall face suspension, dismissal, and prosecution under anti-corruption laws."

Construction Permission

The bill states that no individual or entity shall undertake excavation, cutting, or degradation of Karewas without prior approval from the competent authority (SEIAA).

Karewas identified as highly sensitive agricultural and horticultural zones shall be completely protected from excavation and construction. Before any construction on Karewa land, prior permission from the Village Halqa Majlis (Gram Sabha) will be mandatory.

Sustainable Land Use Policy

The Private Member's Bill advocates for a Sustainable Land Use Policy, requiring the government to formulate a Karewa Conservation and

Sustainable Development Plan with the following objectives:

(a) Afforestation and soil conserva-

(b) Promotion of horticulture and water conservation initiatives

(c) Strict regulations to prevent

commercial destruction (d) Providing subsidies for the installation of solar pumps for irrigation

(e) Developing Karewas as tourism hubs due to their geological and archaeological significance

Karewa Protection Authority (KPA)

The draft Karewa Protection Bill (2025) proposes the establishment of a Karewa Protection Authority (KPA) under the Department of Environment, Ecology & Forests. The KPA will consist of:

- Experts in hydrology, ecology, and environmental law
- Representatives from rural & urban local bodies, NGOs, and environmental conservation groups
- Government officials from relevant departments

The KPA will have the authority to inspect mining sites, revoke mining licenses for violations, and recommend policy changes to strengthen conservation efforts.

Whistleblowing Encouraged

Under the J&K Karewa Protection Bill (2025), citizens will be encouraged to report illegal mining activities via a dedicated helpline and online portal. Public-spirited citizens and whistleblowers will be protected and rewarded for credible information leading to legal action.

Conclusion

The protection of Karewas is crucial for our sustenance, as Kashmir's landmass is shrinking due to rapid urbanization. The excavated Karewa sites in Budgam and Pulwama now resemble the ravines of Chambal, contributing to severe dust pollution. Cases have been filed in the National Green Tribunal (NGT) against some construction companies for environmental violations.

The J&K Government must accept this Private Member's Bill and enact it into law immediately to protect Kashmir's geological, agricultural, and environmental heritage.

resident Donald Trump's electoral victory last November was decisive and sweeping. He now has majority control over both legislative houses, i.e. the lower house called the Congress or House of Representatives, and the upper house called the Senate. Sometimes both houses together are also misleadingly called the "Congress". He has of course the control of the White House,

and this is called a "governing trifecta", which is a sweet spot. He has already exercised his increased influence in the passage of 64 executive orders in barely three weeks of assuming office of the President for the second time.

Unlike his first term which began in 2017, he also has a two third majority of the conservative judiciary. This might prove crucial if he tries to deliver on his promise of no birthright citizenship. This cannot be merely done by an executive order, and might require a constitutional amendment, which might in turn be challenged in the Supreme Court. The apex court could come to Trump's aid, although this is not guaranteed in this case of citizenship debate.

Trump's popularity is also supposed to be ten percent higher than what he got from his voters, which means that even some of those who did not vote for him now support his policies. These policies cover tariff action against trading partners, stricter action against illegal aliens, withdrawing from expensive wars in distant theatres and making NATO allies pay more, and finally reducing the size of the government.

The President has threatened that America will charge reciprocal import tariffs, as a tit for tat strategy. In response India has immediately reduced import duty on American Bourbon whiskey from 150 to 100 percent. The duty on Harley Davidson motorcycles was reduced earlier. India enjoys a trade surplus of about 30 billion dollars with the U.S., and it is this that Donald Trump wants to reduce. The defense purchases of F35 fighters and other combat vehicles are on the cards, partly to assuage U.S. sentiment.

Some of President Trump's wishes seem contradictory. On one hand his desire to reduce the trade deficit and make the dollar cheaper is to increase

American exports and jobs. On the other hand, he wants the dollar to remain the strong and dominant currency in the world.

He threatened the BRICS nations, of which India is a member, that if they contemplate trading among themselves in non-dollar currencies, then he will impose 100 percent import tariffs on them. You can't simultaneously ask for a weak and a strong dollar. The fact is that the dollar index, measured as DXY is close to being the highest it has been in the past twenty-five years.

So, what is the real source of the dollar strength and its hegemony? Is it due to President Trump's

Yet what is the real source of dollar's hegemonic status? The first is simply that there is no other candidate currency. Neither the pound sterling in terminal decline since the second world war, nor the euro born in 1999, nor the Chinese yuan are anywhere close to the dollar's unmatched supremacy. In terms of global trade, the U.S. share is barely 11 percent. But the U.S. economy makes up one fourth of the global GDP and of course is the largest. President Trump is upset about the trade deficit which is close to 1 trillion dollars.

Mirroring that, the Chinese have a trade surplus of 1 trillion dollars, one third of which is with the $\,$

The President has threatened that America will charge reciprocal import tariffs, as a tit for tat strategy. In response India has immediately reduced import duty on American Bourbon whiskey from 150 to 100 percent. The duty on Harley Davidson motorcycles was reduced earlier. India enjoys a trade surplus of about 30 billion dollars with the U.S., and it is this that Donald Trump wants to reduce

political support and popularity? Or his enjoying the governance trifecta? Not really. Incidentally, the trifecta is still not good enough because in the upper house, the Senate, the bills need a 60 percent majority to be passed as law. Which Trump does not have at this stage. There are some murmurs from within the Republican Party, which indicate less than enthusiastic support for some of Trump policies, especially on downsizing government and cutting benefits.

United States. Many countries including India have a trade surplus with America. So, what happens to all the surplus dollars held by export surplus countries? It is in the form of exchange reserves. A whopping sixty percent of all reserves worldwide are held in dollar assets, i.e. United States government issued bonds.

So that is the real reason for dollar hegemony. It is due to the strong desire of the rest of the world to hold dollars, or dollar assets. This creates a strong

demand for U.S. bonds, which reduces the cost of borrowing for the U.S. government. This is the enormous privilege enjoyed by the U.S. due to the dominant status of its currency.

To add to the privileges of dominance is another favorable factor, and it is that ninety percent of all foreign exchange transactions worldwide are in dollars. It is the most preferred invoicing currency. Trump has already warned BRICS nations not to transact in non-dollar currencies. The preference for dollar invoicing is due to its inherent stability.

And the belief that America will never default on its debt. This is tested from time to time, since the law and constitution does not allow the U.S. government to pile on unlimited debt. It is currently about 33 trillion dollars. But the debt ceiling cannot be breached unless approved by the Congress, which sometimes leads to brinkmanship between the ruling party and the opposition. But invariably the debt ceiling is relaxed, until the new limit has to be relaxed again in a few years.

Whenever there is global turmoil and uncertainty, investors rush to dollar assets, causing outflows from developing countries, and leading to a fall of their currencies. This has happened to India as well. But the real reason is that implicitly the world has faith in the stability of America's financial system, its judiciary in resolving disputes speedily and fairly, its capability of resilience, and the US government's way of not passing too many irrational and isolationist laws and policies.

Of course, none of this can be taken for granted. The rise of India and China in the twenty first century will surely challenge the hegemony of the dollar. India's rise is benign, while China's rise threatens the west. Their evolving bilateral relationship will surely shape world trajectory as well as affect the dollar's dominance. But for now, the dollar is king.

Kashmiri is Dying **Speak Before It's Silent Forever!**

n reductive and prosaic terms, 'a living language is one that is used and spoken ■ by people of a given society or culture'. Given this, is Kashmiri a 'living language'? This question may sound preposterous to many. A 'common sense' reaction to this would be, 'but of course'. But probe deeper or scratch the surface, a different (and unsalutary) picture emerges: our mother tongue Kashmiri is a dying language. How? First, in vernacular terms, the Kashmiri we speak is far from haute Kashmiri. There is a correlation between thought (thinking) and language. If this is a tight correlation, this then means that we Kashmiris may have lost the mental paradigm of high thinking- a corollary of which is simple living. But this may not be too alarming given that there is a disconnect between haute culture- of which language is an indelible component of – and the vernacular idiom across the world.

Of greater concern and worry is that our Gen Next (Millennials of Kashmir) hardly speak Kashmiri. In the main they speak an approximation of Urdu sprinkled with English words and so on. Can this Kashmiri 'pidgin' this be named? I don't know. It is difficult to coin a neologism for this. But this is beside the point. The alarmingly gradual and inexorable drift into losing our language has deep implications and consequences captured best by the phrase,' lose your language, lose your culture'. The question that arises here is: Is culture important? Yes. It is. Why? Even though there is no such thing as an entirely original and authentic culture, but it(culture) is the anchor that gives people a meaningful framework to negotiate life and the world. Once a given peoples loses its culture, it loses this 'centre' or anchor. By way of a corollary and analogy a society or people that lose their culture are like 'floating atoms' that have no nucleus prone to be caught in the



whirlwind of forces that may or may not be sanguine.

But a contra hypothesis is that we live in a quasi- globalized world, where latching onto one's culture may not be prudent or even practical. This argument is quasi-facetious: globalization in the sense of movement of peoples, and negating identities in different and differential domains, time and space actually privileges hybridity. What is meant by this? Simply put, it means negotiating a globalized time space domain in real and practical terms both holding on to one's culture (the sanguine aspects) and engaging with the world at large in the idiom that it demands. It may, for example, mean that a Kashmiri man or woman speaks fluent

Kashmiri, is able to code, say for Google or Microsoft, but at the same time turns up at Microsoft or Google headquarters wearing the Kashmiri pheran(a loose woolen tunic worn by Kashmiris in autumn and winter). Key here is he or she must do excellent and unparalleled coding. This is a very important point. It perhaps goes to the heart of why our Gen Next is not encouraged to speak in Kashmiri- that is, a deep inferiority complex that appears to define us. There appears to be no alternative explanation for this. But there is a structural reason: a point or thesis elaborated upon by sociologists and anthropologists is that there is a correspondence between the structure of society and the language it uses. If this thesis holds, it suggests that a morphed, mutated and altered Kashmiri language or even 'pid-gin' Kashmiri is correlated with a morphed, and mutated societal and social structure. The corollary here is harks back to the point made earlier,' lose your language, lose your culture'. If then the drift continues, the day is not too far when we Kashmiris will not recognize ourselves in each other. We will have lost both our culture and languages.

Can this alarming drift be stemmed? Can a new bold and beautiful idiom that smacks of self-confidence (not arrogance), self-assuredness, cultural and social well-being be crafted? This is a difficult question to answer and what I will posit is more hope and aspiration than reality. This is in

my three beautiful children- all in the age bracket of 3-10 years. (I must confess here that I too am guilty of 'following the herd' and not imparting and teaching Kashmiri to my children)While the youngest one is too young to understand but will obviously follow her older siblings, my middle and older daughters harp on a theme that warms the cockles of my heart. The refrain for both is, ' mye chhu Kaeshur khosh karaan. Mye seath kar Kaeshur'.(I like Kashmiri. Talk to me in Kashmiri). Of course, this is said in an inflected and accented Kashmiri which is a problem. But their desire to speak in Kashmiri is a great starting point. What I cull from this is that there is hope and this springs eternal. Now returning to the core theme of this essay, I will conclude by positing that Kashmiri is a fertile, rich language that has excited the imagination and poetic genius of great luminaries. All is not lost then. There can come a day when a Pheran clad Kashmiri person, can after having created a great software program, or developed an AI application can saunter on the streets of Manhattan, Paris or London and regale his or non- western audiences in pure and sublime Kashmiri poems. Our hypothetical Kashmiri person can then return home(for vacation or otherwise), wander around our downtown, have some Nadir Monje(Kashmiri condiments), go home, place the Kanger (Kashmiri clay fire pot bound by wicker) under his or her pheran , put a potato in the Kanger and relish it after its roasted. And in wintry evenings or nights, dust off his or her book shelf read aloud the beautiful and sublime poetic verses of Soche Kraal sahib, Shamas Fageer sahib, Rasool Mir Sahib, Abdul Ahad Aazad sahib, Rahman Rahi sahib and other great

'Lifestyle And Environmental Factors Affect Health And Ageing More Than Genes'

new study led by researchers from Oxford Population Health has shown that a variety of environmental factors, including lifestyle choices (such as smoking and physical activity) and living conditions, have a more significant impact on health and premature death than our genes.

The study, which analysed data from nearly half a million UK Biobank participants, examined the influence of 164 environmental factors and genetic risk scores for 22 major diseases on

ageing, age-related diseases, and premature death. The findings were published today in Nature Medicine.

As per the key findings, the environmental factors explained 17% of the variation in risk of death, compared to less than 2% explained by genetic predisposition (as per the present). Of the 25 indepen-

dent environmental factors identified, smoking, socioeconomic status, physical activity, and living conditions had the most impact on mortality and biological ageing. Smoking was associated with 21 diseases; socioeconomic factors, such as



household income, home ownership, and employment status, were associated with 19 diseases; and physical activity was associated with 17 diseases.

The early life exposures, including body weight at 10 years maternal smoking around birth, were shown to influence age-

ing and risk of premature death 30-80 years later.

Environmental exposures had a greater effect on diseases of the lung, heart and liver. while genetic risk dominated for dementia and breast cancer.

Professor Cornelia van Duijn, St Cross Professor of Epidemiology at Oxford Population Heath and senior author of the paper, said 'Our research demonstrates the profound health impact of exposures that can be changed either by individuals or through policies to improve socioeconomic conditions, reduce smoking, or promote physical activity.

The research shows that whilst many of the individual exposures identified played a small part in premature death, the combined effect of these multiple exposures together over the life course (referred to as the exposome) explained a large proportion of premature mortality variation. The insights from this study pave the way for integrated strategies to improve the health of ageing populations by identifying key combinations of environmental factors that shape the risk of premature death and many common age-related diseases simultaneously

Lie In How Molecules Interact Under Stress

study has suggested that elasticity in an object possibly originates in the interactions between molecules of the flexible material, allowing it to regain its original shape once the external stress is removed.

The findings open the door for the design of new and elastically flexible crystals which could be used in spacecraft or electronic devices, the authors wrote in the study published in the journal Nature Materials.

The researchers, including from The University of Queensland, Australia, had set out to try and locate the exact "location" of the force stored in an flexible material which gives it elasticity.

To understand this, the team bent single crystals of three molecular materials -- which retain their properties at a molecule's level -- to locate precisely where the energy is stored.

'We looked at how and where the energy was stored as the crystals contracted and went back to their original shape and size," author Jack Clegg, a professor at the school of chemistry and molecular biosciences, The University of Queensland, said.

The researchers found that the energy that allowed the crystals to spontaneously straighten out and spring back to its original shape was stored as potential energy in the interactions between the molecules.

"We were able to show that enough

energy was stored in our bent flexible crystals to lift something 30 times the weight of the crystal a metre into the air," Clegg said.

The author added, "Under strain, the molecules reversibly rotate and reorganise in a way that stores energy differently on the inside and the outside of the bend.

The new understanding of this commonly observed phenomenon could allow the design of new hybrid

materials that could find their use in spacecrafts or electronic devices,

Clegg said.
"Elasticity is a property that underpins a myriad of existing technologies including optical-fibres, aeroplane "We show for each material that different intermolecular interactions are responsible for the restoring force under both expansive (tension) and compressive strain,"

BBC World Service India Fined ₹3.44 **Crore For Foreign Exchange Violation**

NEW DELHI- The Enforcement Directorate has levied a penalty of more than Rs 3.44 crore on BBC World Service India for alleged contravention of foreign direct investment (FDI) regulations, agency officials said on Friday.

The federal probe agency also fined three of its directors more than Rs 1.14 crore each as it issued an order against the British broadcaster following adjudication under the Foreign Exchange Management Act (FEMA).

A BBC spokesperson sa statement to PTI that "at this stage, neither BBC World Service India nor its directors have received any adjudication order from the Enforcement Directorate".

"The BBC is committed to operating within the rules of all countries we are based in, including India. We will carefully review any order when it is received and consider next steps as appropriate," the spokesperson said.

The adjudication proceedings were initiated after a show-cause notice was issued on August 4, 2023, to BBC WS India, its three directors, and the finance head for various "contraventions" under the said

The ED launched a FEMA probe against the BBC a few months after the income-tax department conducted a survey operation at the news organisation's office in



Delhi in February 2023.

BBC WS India, which is a 100 per cent FDI company, was engaged in uploading/streaming news and current affairs through digital media but "did not" reduce their FDI to 26 per cent, and kept it at 100 per cent in "gross violation" of the regulations issued by the government of India, sources said.

The press note 4 issued by the Department for Promotion of Industry and Internal Trade (DPIIT) on September 18, 2019, stipulates a 26 per cent FDI cap for digital media under the government approval route, they said.

The total penalty levied on BBC WS India stands at Rs 3,44,48,850, along with a fine of Rs 5,000 for every day after 15.10.2021 till the date of compliance for violation of the provisions of FEMA, 1999, the sources said. Three BBC directors -- Giles Antony Hunt, Indu Shekhar Sinha and Paul Michael Gibbons -- have each been fined Rs 1,14,82,950 for their roles in "overseeing" company operations during the period of

Kashmir Shawls, Carpet Lead In Exports: Govt

Pashmina Lab augmented to enhance testing, QR coding

SRINAGAR- The world-famous handicraft and handloom products worth ₹2,567 crore have been exported from Kashmir valley in the last two financial years and the first three quarters of the current fiscal.

However, the exports in the current financial year have been hit by global conflicts.

Giving details, a spokesperson of the Handicrafts and Handloom Department, Kashmir, hoped that the exports are expected to touch cumulatively ₹3000 crore for 3 years, by the end of the last quarter of the CFY.

As per the figures available with the Department, while Kani and Sozni shawls lead exports worth ₹1105 crore, hand-knotted carpet exports stood at ₹728 crore in the last three years. The other products exported include crewel, papier mache, chain stitch and wood carving.

The spokesman further stated that the Department shall facilitate export of hand-made Kashmir products for which a subsidy scheme is available, giving incentive of 10% of the total volume of handloom/ handicraft export products to any country with maximum reimbursement up to ₹5 crore in favour of the eligible exporters registered with the Department," he added.

Highlighting the Government's strategy for welfare of artisan community, the spokesman said the Depart-



ment has a well-established Design Studio in the Indian Institute of Carpet Technology and unique prototypes conceived by the School of Designs and Craft Development Institute. "The artisans can access these contemporary designs and packaging models to add value to their products in niche high-end markets," he added.

For welfare of artisans, the Department has several flagship schemes in operation including Credit Card Scheme, Mudra, Financial Assistance Scheme for Cooperatives, Karkhandar Scheme and Education Scholarship for the children of craftsmen.

Under the National Wool Policy, the department has selected 100 weaver beneficiaries for distribution of free modified modern steel carpet looms in Kashmir ata total cost of Rs.43.70 lakh

and the department will pitch for another 250 improvised looms for distribution in the next financial year.

Emphasizing upon the department's focus on testing and QR coding of GI registered craft products to weed out sale of counterfeit products, the spokesperson stated that the department has augmented manpower and equipment at its premier Pashmina Testing and Quality Certification Centre (PTQCC) and IICT lab for carpets. "The waitlist of 6 craft products including Sozni, Kani, Walnut Wood Carving, Khatamband, Papier Mache and Kashmir Pashmina at PTQCC has come down from 1700 on February 5 to 671 as on February 21, after strengthening of manpower," he said, adding that the lab will be further strengthened after more staff shall undergo necessary training at the Wool Research Association, Thane.

How Much Will Tesla Car Cost In India After Reduced Import Duty? Report Says...

NEW DELHI- s Elon Musk-led Tesla is soon planning to enter India, even after the reduction in the import duty to below 20 per cent, the cheapest car of Tesla will cost around Rs 35 to 40 lakh, according to a report by CLSA, a global capital market company.

The report highlighted that currently, Tesla's cheapest Model 3 in the US costs around USD 35,000 (approximately Rs 30.4 lakh) at the factory level. With an expected reduction in import duties to 15-20 per cent in India, along with additional costs such as road tax and insurance, the on-road price would still be around USD 40,000, or approximately Rs 35-40 lakh.

It said "The cheapest Model 3 for Tesla in the US is c.USD35k. With tariff lowered to c.15-20 per cent in India, along with road tax, insurance and other costs, on-road price would be c.USD40k, which is close to Rs3.5-4m".

If Tesla positions the Model 3 at a price 20-50 per cent higher than domestic EV models like Mahindra XEV 9e, Hyundai e-Creta, and Maruti Suzuki e-Vitara, the report added that it is unlikely to disrupt the Indian

EV market significantly.

Even if Tesla decides to launch an entry-level model priced below Rs 25 lakh onroad and gains market share, the report believes that the recent decline in Mahindra & Mahindra's stock is already factoring in this scenario.

However, the report suggests that Tesla's entry would not have a significant impact



on major Indian automakers, as the overall penetration of EVs in India remains lower than in China, Europe, and the US.

Tesla in the coming months would be launching its models in Delhi and Mumbai. Tesla has officially begun its hiring process in India, marking a significant step towards its longanticipated entry into the domestic market. On February 18, the electric vehicle (EV) giant posted a job listing on LinkedIn for the position of Consumer Engagement Manager in the Mumbai Metropolitan Region.

The report also outlined that Tesla would need to set up a manufacturing facility in India to make its cars more affordable and scale up its operations, even if import duties are reduced to below 20 per cent.

The report highlighted that under India's electric vehicle (EV) policy, Tesla could benefit from a lower import duty of 15 per cent on up to 8,000 units per year if it invests over Rs 4150 crore billion in setting up a local facility.

The report draws a comparison with the Indian motorcycle market, where Harley-Davidson's X440, priced 20 per cent higher than the Royal Enfield Classic 350, sells only around 1,500 units per month, whereas the Classic 350 sells about 28,000 units monthly.

Goyal Says Tesla Welcome To Invest, Manufacture In India

MUMBAI- India welcomes Tesla and also all the other global companies which want to invest and manufacture in the country, Union Minister Piyush Goyal said on Saturday.

Replying to a question on Elon Musk-promoted EV maker Tesla's speculated entry into India, Goyal said the American company is welcome to set up a presence in India.

It is the give and take which creates mutually beneficial partnerships, the minister said, making it clear that India is not anti-imports. "We welcome Tesla and also all the other global companies who want to invest and manufacture in India," Goyal said.

The minister also said that construction activity and vehicle exhaust are the prime reasons for pollution in cities. He assured that the government is committed to reducing pollution, citing efforts like encouraging usage of electric vehicles as a step in the same direction.

Mallya Pursues Annulment, Alleging 'Unreal Quality' To Uk Bankruptcy Order

LONDON- Embattled businessman Vijay Mallya has instructed his lawyers in the UK to pursue an annulment application against his bankruptcy order, with his legal team set to argue that Union Finance Minister Nirmala Sitharaman's statement in Parliament in December last year gives the order an "unreal quality".

It comes after Justice Anthony Mann reserved judgment, to be handed down at a later date, after hearings of three interlinked appeals related to Mallya's bankruptcy order concluded at the High Court in London this week.

The judge heard a set of complicated arguments involving a consortium of banks led by the State Bank of India (SBI) seeking repayment of an estimated judgment debt of around GBP 1.05 billion owed

by the 69-year-old businessman's now-defunct Kingfisher

Mallya is wanted in India on fraud and money laundering charges.

"From Mallya's perspective, these English bankruptcy proceedings have an unreal quality," Leigh Crestohl, Managing Partner of Zaiwalla and Co-Mallya's new lawyers, told PTI.

"Evidence has now come to light that shows that the banks' debt has not only been paid but, moreover, the banks have recovered in excess of what was due from Dr Mallya," Crestohl said, citing Sitharaman's statement in the Parliament on December 17 last year.

Sitharaman in her statement to the Parliament "confirmed that a sum of INR 14,131.6 crore has been collected and restored to the banks", he said.

USAID Was Allowed Here In Good Faith: Jaishankar On Voter Turnout Fund

New Delhi: External Affairs Minister S Jaishankar has raised concerns over information from the US that millions of dollars were sent to India, allegedly to influence elections in India.

US President Donald Trump first raised the issue of alleged funding of \$21 million for "voter turnout" in India, after he took over from former President Joe Biden.

"Your security can be threatened without you leaving your house because the thought processes, the influences, the narratives, your morale, your sense of what is right and wrong, are all influenced by your phone, what you read every day, the pictures you see," Jaishankar said at the Delhi University Literature Festival.

"... I think some information has been put out there by the Trump administration people and obviously that is concerning," the External Affairs Minister said.

"It would suggest that there are activities which have a certain objective out there, to push a narrative or a viewpoint. As a government we are looking into it because such organisations have an obligation to report. And my sense is, the facts will come out," Jaishankar said, alluding to the announcement by President Trump that the US Department of Government Efficiency (DOGE) posted a list of cancelled US taxpayer-funded initiatives with a mention of \$21 million earmarked for "voter turnout in India."

"Now, I read saying so-and-so dealt with USAID or so-and-so. Look, it's not a question of do you deal with USAID or not. USAID was allowed - has been here historically. But USAID was allowed here in good faith, to do good faith activities. Suggestions are being made out of America that there are activities which are in bad faith. So, it surely warrants a look," he said.

"And if there is something to it, I think the country should know who are the people involved in the bad faith activities," Jaishankar said.

The External Affairs Minister's comments come on a day the BJP sought an investigation into the alleged US funding of \$21 million for voter turnout in India and "kickbacks". The BJP alleged the money was used to sustain "deep state assets" in India.

President Trump on Thursday also repeated his questioning of the US government's allocation of the \$21 million, calling it a "kickback scheme".

The Enforcement Directorate and other security and financial agencies have started preliminary steps to identify Indian entities and individuals who served as conduits for receiving the now-scrapped USAID's \$21 million to influence voter turnout, news agency JANS reported.

Non-profits, social workers, media firms, and business entities are under the ED's scanner over alleged violation of anti-money laundering laws in a transnational conspiracy, sources said.

'100-day Intensified Campaign'

Over 5.1 lakh TB Patients Notified: Health Ministry

New Delhi: Over 5.1 lakh TB patients have been notified across India since the launch of the 100-day Intensified TB-Mukt Bharat Abhiyan on December 7, 2024, the Union Health Ministry said on Saturday.

A new strategy was designed for the early identification of TB by offering X-rays as a screening tool for populations at higher risk of developing TB.

With the use of ultraportable, hand-held X-rays and intensified efforts to conduct door-to-door screenings in congregate settings, risk groups such as diabetics, smokers, alcoholics, people living with HIV, individuals with a history of TB, the geriatric population, and household contacts of TB patients have been identified. Both asymptomatic and symptomatic individuals have been screened using X-rays, followed by confirmation through Nucleic Acid Amplification Testing (NAAT), which has helped identify asymptomatic TF patients.

To date, the campaign has made remarkable progress, the ministry said.

Over 3.5 lakh TB patients

The campaign is working to ensure complete treatment, scale up differentiated TB care to identify patients in immediate need of care or hospital admission, provide support to undernourished TB patients, and offer preventive TB treatment to vulnerable populations, the state-

These results are an outcome of a "whole-of-government approach" to ensure the success of the campaign, the statement noted.

Union Health Minister J P Nadda has chaired meetings with chief ministers, cabinet ministers and senior officials from 22 ministries. Furthermore, the Ministry of Health and Family Welfare organised a sensitisation session attended by over 250 parliamentarians across states and UTs to inform them about the campaign and encourage their involvement and support at the state and district levels.

The Union Minister urged the chief ministers of all states to closely monitor the progress of the campaign at the state level. High-level administrative officers have been appointed to oversee the implementation of activities across various departments to ensure seamless coordination, the statement said.

Building on the success of the Jan Bhagidari approach, the campaign emphasises the active participation of community members. Through Ni-kshay Shapaths, individuals, community leaders, NGOs, and corporates are being encouraged to become Ni-kshay Mitras and support TB patients with nutritional baskets, psychosocial support, and vocational assistance.

Since the launch of the campaign, over 2.4 lakh Nikshay Mitras have registered and over 2.3 lakh food baskets have been distributed,

the statement added. "India's commitment to fighting TB is evident in the nation's achievements to date. In 2024, India notified over 26 lakh TB patients, closing the gap between the estimated incidence and those notified to the program. It is worth noting that over 36 per cent of notifications were registered from the private sector, reflecting the success of the progressive policy changes, innovative strategies and interventions deployed by the program over the past ten years," the statement said.

The new strategy adopted under the 100-Day TB-Mukt Bharat Abhiyan is significantly contributing by identifying sub-clinical or asymptomatic TB, which contributes to TB transmission in the community. This approach helps reduce incidence by breaking the chains of transmission and reduces mortality through the early identification and treatment of TB.

The strategy is accelerating progress and bringing India closer to its goal of eliminating TB, the statement added.

PM's US visit went very well, Trump-Modi had good chemistry: Jaishankar

New Delhi, Feb 22: External Affairs Minister S Jaishankar on Saturday said Prime Minister Narendra Modi's recent visit to the US "went very well" and underlined that the chemistry between him and President Donald Trump in

Washington was also good.
Prime Minister Modi had paid an official working visit to the US on February 12-13 during which the two leaders held discussions on a broad range of bilateral issues.

"I have been doing this all my life, so I have some reference points, and some experiences as a comparative assessment. And, I would say with all objectivity, I thought, it went very well, and for a variety of reasons," Jaishankar said in response to a query on the Modi's US visit during an interaction at an event here late evening.

The external affairs minister said people know that PM Modi is a "very strong nationalist, and he sort of radiates that".

"Trump is an American nationalist, and I think in many ways nationalists kind of respect each other. They are very clear-eyed. They are in it for their country, Trump accepts that Modi is in it for India, Modi accepts that Trump is in it for America," he said.

"But, the purpose of the meeting is to say, ok, how do we find that something works, what is the common ground, something we can do together which makes both of us stronger," Jaishankar said.

The interaction was moderated by Sanjeev Sanyal, member of the Economic Advisory Council to the Prime Minister during the DU Literature Festival, hosted at the Shri Ram College of Commerce (SRCC).

"The second I felt was... the chemistry was good. Again, Trump being somewhat unusual, there are a lot of other leaders in the world, with whom he has not necessarily a positive history. Now the case of Modiji, it's not the case. He (Trump) had a great visit (to India), he remembered," the external affairs minister said.

Jaishankar also made a reference to a picture book on the first term of President Trump, and said, he was told the Trump "himself selected pictures after his term had ended".

And, maximum number of pictures were "about India", he said, adding it also had a picture of the 'Namaste Trump' event held at Motera Stadium in Ahemdabad during his visit in 2020.

"Clearly, he had a very good kind of a memory and feeling about the earlier term," Jaishankar said.

"President Trump appears to have a vision of what America's interests are, what he wants and he wants from the relation with us. We have the same.

law in place the one that silences Kashmiris?" He further criticized the administration, calling it a colonial force that suppresses Kashmiri identity. "The colonial LG administration, in cahoots with the security forces, has turned Kashmir into an Orwellian nightmare—where people can't protest, safeguard their identity, or even speak for their culture," he wrote.

Mehdi warned that such actions could intensify local resentment. "Suppression breeds resentment. The more you push Kashmiris to the wall, the stronger their will to break it down," he said. He urged law enforcement to act responsibly, stating, "@JmuKmrPolice is advised to not work like a colonial power but work and behave as local police guided by law and respectful to the community and its sensitivities."

The incident has reignited concerns over governance in Jammu and Kashmir, particularly regarding the role and influence of elected officials. Many critics argue that Chief Minister Omar Abdullah, despite holding office, lacks real authority, with power remaining concentrated in New Delhi.

A shopkeeper in Lal Chowk, speaking to a local media outlet, voiced his frustration. "If Omar Abdullah truly believes he has no control over law and order, then why does he remain in office? What purpose does his position serve? Instead of skiing in Gulmarg or attending functions, he should be standing up for the people who elected him," he said.

Another local resident, also quoted in a local media report, expressed deep disappointment over the Chief Minister's silence. "He is the elected leader, and even if he doesn't have direct control over law and order, he can at least raise his voice. Simply washing his hands off the issue won't absolve him of responsibility," he remarked. "People placed their trust in the National Conference, hoping for change, yet all they have received is empty rhetoric."

The Traders Association of Central Lal Chowk, which had installed the signboard, viewed its removal as a direct reminder of Kashmir's political vulnerability. "The administration

couldn't even allow a simple civic appeal to remain in place. What kind of governance is this?" one trader asked.

The controversy also prompted social media reactions, with Preacher Aga Syed Mohammad Hadi questioning the authorities' logic. "A polite appeal to honourable Kashmiri tourists to avoid using alcohol and drugs in indecent activities. What is the problem with Jammu Kashmir Police or the establishment that they could not tolerate even for an hour and picked them up? Isn't this supporting their drug-free Kashmir campaign?? Or the curtains.." he wrote on X.

Iltija Mufti, a leader of the People's Democratic Party (PDP), has initiated a signature campaign advocating for a complete ban on alcohol in Jammu and Kashmir. She is seeking support from various political parties, including the ruling National Conference (NC), the Bharatiya Janata Party (BJP), and the Peoples Conference (PC).

Mufti emphasized that the issue is social rather than political, arguing that rising unemployment is driving youth toward alcohol and drug abuse. She cited examples from Bihar, Gujarat, and Nagaland to support her call for Jammu and Kashmir to be declared a dry state. Additionally, she criticized the government for increasing the number of alcohol outlets and urged the exploration of alternative revenue generation methods.

"In case if there is a shortfall of power generation in peak time in view of low water level, the government always plans some sort of measures to tackle it," the official said.

Reportedly, in the past one month, the hydel power generation from the power plants across Jammu and Kashmir has further reduced by five percent owing to the less snowfall and low water levels.

Overall, the hydro power generation from the local plants in Jammu and Kashmir has reduced by 84.17 percent.

In the month of January, the Power Development Department (PDD) was generating nearly 250 Megawatts of power from the local hydel projects that amounts to 20 percent of the total generation capacity. However, in the ongoing month, the power generation has further reduced by five percent.

"However, the power generation has further decreased with the officials saying that the department was able to generate only 190 MWs of power in the ongoing month," the official said.

Besides, the authorities have said that Jammu and Kashmir may face 29 percent of 'forced load shedding' of annual power in the year 2034-35.

Besides, it has further projected that in the coming ten years, the Compound Annual Growth Rate (CAGR) of power demand is likely to increase by more than four percent in Jammu and Kashmir and Ladakh. (KNO)

DUBAI: Hyped as a marquee showdown but mostly lopsided on the field, India and Pakistan lock horns in the ICC Champions Trophy here on Sunday with Rohit Sharma's men aiming to seal a semifinal spot and Mohammad Rizwan's team desperate to avoid early elimination from the tournament.

While India are on a high after claiming a measured sixwicket win over a sprightly Bangladesh, Pakistan are evidently tense after the 60-run loss in the tournament-opener against New Zealand.

The sub-continental rivals' last Champion Trophy clash was the 2017 final in which Pakistan walked away with the win and the trophy. Rizwan and Co. would look to draw inspiration from that triumph in London but would also need to scale up their performance in



every department.

Though the buzz surrounding the match is nowhere close to being what it used to be at the peak of diplomatic tensions between the two countries, there is an air of quiet anticipation for the Group A clash at the Dubai International Cricket Stadium.

India will have a distinct advantage in every aspect. The side has settled in nicely while Pakistan have flown in a couple

of days ago after the drubbing handed by the Black Caps in Karachi.

More often than not, an India-Pakistan clash is as much a battle of nerves as cricketing abilities and India would be in

a much better space on both counts come Sunday afternoon. For starters, skipper Rohit, whose form was a major

concern in the run-up to the tournament, seems to be getting back to his best if the lucid stroke-making against Bangladesh was anything to go by.

In contrast, Pakistan would be fretting over the form and approach of their biggest star Babar Azam. The 90-ball 64 against New Zealand in a chase of 320 has been roundly criticised for being too slow.

Azam's inability to accelerate even when the asking rate kept climbing has come under scrutiny and he would be under tremendous pressure against India.

Adding to their woes is the injury-forced ouster of gamechanging opener Fakhar Zaman from the squad. Imam ul Haq has replaced him in the side and

has joined the squad here. Match starts at 2.30pm IST.

India's National Anthem Played Before Aus-Eng CT Matchup

LAHORE: Left red-faced after India's national anthem played for a fraction of a second at the start of the Austra-lia-England Champions Trophy match here on Saturday, the Pakistan Cricket Board has blamed the ICC for the fiasco and demanded an explanation from the world body.

At the start of the game when the two teams lined up for their national anthems, the spectators were left surprised as the Indian national anthem played for a second before being stopped.

A source close to the ICC confirmed that the PCB had sent a letter to the governing body outlining the incident and demanding an explanation.

"The PCB has made it clear that the ICC needs to offer some explanation as their people are responsible for the (national anthem) playlist of teams in the Champions Trophy.

"Since India is not playing in Pakistan, it is hard to understand how their anthem was played by mistake from the playlist," the source said. India had refused to travel to Pakistan citing security

concerns and are playing their share of Champions Trophy games in Dubai. The traditional rivals are due to clash on Sunday in a crucial match a loss in which will knock Pakistan out of the tournament.

The PCB had earlier also written to the ICC about its name logo not being displayed on television screens when India played Bangladesh in Dubai on Friday.

The ICC then assured the PCB that it was a mistake and all matches in Dubai will use the three-line horizontal logo with Pakistan's name.

Host Pakistan's Name Omitted From India-Bangladesh Broadcast

he PCB has expressed its displeasure to the sport's governing body ICC over the absence of country's name from the tournament logo shown during the live broadcast of India versus Bangladesh clash in the Champions Trophy.

The match was played in

Dubai on Thursday. According to PCB sources. the ICC has admitted the error and assured that it will use the three-line logo with Pakistan name in all matches in Dubai -- the same broadcast graphic which has been shown in matches in the host country.

It has been learnt that the ICC has informally told PCB that it was a technical error.

Assam Ends 90-Year-Old 'Namaz Break' Tradition In Assembly

Guwahati: The decades-old Assam Assembly tradition of a two-hour break to facilitate Muslim legislators to offer 'namaz' on Fridays was discontinued for the first time during the ongoing budget session. The decision to do away with the break was taken in the last session of the House in August, but implemented from this sitting.

Expressing dissatisfaction over it, AIUDF MLA Rafiqul Islam maintained that it was a decision imposed on the strength of numbers.

"There are about 30 Muslim MLAs in the assembly. We had expressed our views against the move. But they (the BJP) have the numbers and are imposing it on the basis of that," Islam said.

Leader of Opposition Debabrata Saikia of the Congress said provision can be made for the Muslim MLAs to offer 'namaz' nearby on Fridays. Moon or Mars? NASA's future at a crossroads under Trump

Washington: Is NASA still Moonbound, or will the next giant leap mean skipping straight to Mars?

Speculation is mounting that the Trump administration may scale back or cancel NASA's Artemis missions following the departure of a key official and Boeing's plans to lay off hundreds of employees working on its lunar rocket. Late Wednesday, NASA abruptly announced the retirement of longtime associate administrator Jim Free, effective Saturday.

No reason was given for Free's departure after his 30-year rise to NASA's top civil-service position. However, he was a strong advocate for Artemis, which aims to return crews to the Moon, establish a sustained presence, and use that experience to prepare for a Mars mission.


Though Artemis was conceived in President Donald Trump's first term, he has openly mused about bypassing the Moon and heading straight to Mars -- a notion gaining traction as Elon Musk, the world's richest person and SpaceX's owner, becomes a key ally and advisor.

Musk's SpaceX, founded to make humanity a multiplanetary species, is betting heavily on its prototype Starship rocket for a future Mars mission.

Trump has also tapped private astronaut and e-payments billionaire Jared Isaacman, a close Musk ally who has flown to space twice with SpaceX, as his next NASA chief.

Boeing this month told employees it could 400 jobs from the Space Launch System (SLS) rocket program to "align with revisions to the Artemis program and cost expectation."

"This will require 60-day notices of involuntary layoff be issued to impacted employees in



coming weeks, in accordance with the Worker Adjustment and Retraining Notification Act," the aerospace giant told AFP.

Boeing "saw the writing on the wall," Keith Cowing, a former NASA scientist and founder of NASA Watch, told AFP.

To date, SLS has flown just one mission -- 2022's uncrewed Artemis 1 -- and has proven exceedingly costly. It's "likely to fly only one or two missions, or they'll cancel it outright," Cowing added.

Reform or scrap? Skepticism about the exceedingly expensive SLS and the Orion crew capsule -- whose heat shield issues delayed future Artemis missions -- is widespread among space watchers.

Still, many advocate reform, not repeal.

"We need to stick with the plan we have now," Free said at an American Astronautical Society meeting in October.

"That doesn't mean we can't perform better... but we need to keep this destination of the Moon from a human spaceflight perspective. If we lose that, I believe we will fall apart and wander, and other people in this world will pass us by."

Space policy analyst Laura Forczyk noted Free had been in line to become NASA's interim administrator before being passed over in favor of another official, Janet Petro.

She warned that eliminating the Moon would remove a crucial testbed for technologies needed to ensure a safe Mars journey.

While Musk has called Artemis a "jobs-maximizing program" and said "something entirely new is needed," the initiative enjoys strong congressional backing.

It supports tens of thousands of jobs in states including Texas, Alabama, Mississippi, and Florida, with support from key Republicans, including Senator Ted Cruz.

Abandoning the Moon would also leave China unchallenged to plant its flag on the lunar south pole with a planned 2030 crewed mission.

Forczyk believes Artemis is more likely to be reformed than scrapped, with SLS potentially limited to one or two flights before private companies -- such as SpaceX or Jeff Bezos's Blue Origin -- assume key roles.

"However, the Trump ad-

"However, the Trump administration is unpredictable, and we really cannot get in the minds of Donald Trump or Musk," she told AFP.

Another looming uncertainty has been how Trump's broader effort to downsize the federal government could affect NASA.

Trump sends iconic Resolute Desk for refinishing after Musk's son picked nose in Oval Office

US President Donald Trump has ordered the 150-year-old iconic Resolute Desk removed from the Oval Office for refurbishment, days after Elon Musk's son seemingly wiped a booger on it during their visit to the White House, according to media reports.

"A President, after the election, gets a choice of 1 in 7 desks," Trump wrote on social media.

"This desk, the 'C&O,' which is also very well-known and was used by President George H W Bush and others, has been temporarily installed in the White House while the Resolute Desk is being lightly refinished—a very important job. This is a beautiful, but temporary replacement!" Trump wrote.

Trump did not mention the name of Musk's son in the post. However, some US media outlets like the New York Post and New York Daily News linked it to the visit by Tesla

CEO Musk's son X Æ A-Xii.

The change comes after Musk, who heads the Department of Government Efficiency (DOGE), and his four-year-old son appeared alongside Trump on live television last week, and the youngster picked his nose

the Resolute desk, the New York Post said.

According to the paper, Trump is known for his extreme

germophobia.

Trump has spoken openly about his phobia of germs in the past too.

The Georgian-style C&O Desk is made of walnut and features golden handles. The desk's acronym stands for the Chesapeake and Ohio Railway because the desk was built for one of the railway's owners and later donated to the White House, the paper said.

House, the paper said.
George H W Bush was the first and only president—up until Trump—to utilise the C&O Desk.

The Resolute Desk is perhaps the most famous and well-known desk to adorn the Oval Office, built from the remains of the British Arctic exploration vessel the HMS Resolute and presented by Queen Victoria to President Rutherford B Hayes in 1880, according to the paper.

Only three presidents are believed not to have used the Resolute Desk at all in the West Wing: Lyndon B Johnson, Richard Nixon and Gerald Ford, according to the White House Historical Association.

Theodore Roosevelt Desk, The Johnson Desk, The Hoover Desk, and The Wilson Desk are other desks a sitting president can choose from.
