MeT Issues 'Yellow, Orange' Alerts Till Feb 28

Srinagar: The weatherman has predicted a 4-day wet spell from Tuesday and issued yellow and orange alerts for Jammu and Kashmir regions till February 28.

There is a possibility of light to moderate rains and snow for the next four days from tomorrow (Tuesday) evening while the intensity would increase on February 27, the weatherman said.

As per the details, a yellow alert has been issued by the local Meteorological department (MeT) on February 25 and 26 across Jammu and Kashmir. An orange alert has been issued for February 27 for both J&K while one February 28, an orange alert has been issued for Jammu

and yellow alert for Kashmir region.

Isolated heavy rain and snow is expected during the period while the surface traffic may also be witnessed, reads the advisory issued by the MeT.

Generally cloudy weather is expected for the next four days as there is a possibility of light to moderate rain and snow at most places towards February 25th evening and night to February 28 late night with isolated heavy rain and snow over both Kashmir division & Jammu division during the above period, Director MeT, Dr Mukhtar Ahmad said.

J&K Panchayat Polls Likely In April-May

Srinagar: The much-anticipated panchayat elections in Jammu and Kashmir are likely to be held in April-May after a gap of seven years.

The State Election Commission (SEC) of the Union Territory has taken a crucial step forward by initiating the procurement of essential election materials, signaling that preparations are in full swing.

The final electoral rolls for these elections were published on January 20, paving the way for the next stages of the election process.

Reports said that the SEC is seeking to procure nearly 40,000 voting compartments and 64 other essential items required for

conducting the elections.

A senior official from the SEC, on the condition of anonymity, said, "We are working diligently to ensure a smooth electoral process. The procurement of election material is a significant milestone, and we are on track to complete it within the stipulated time frame."

The contract for finalizing the procurement process has a deadline of March 11, and the materials are expected to be supplied within a month. This ensures that the administrative machinery is well-equipped before the elections take place.

Know India Beyond J&K: Shah To Youth

Says, 'No Life Should Be Lost to Terrorism'; 'Violence In J&K Down By 80%'



New Delhi: There is peace in Jammu and Kashmir and this peace has to be permanent, and the Narendra Modi government's aim is to make a Jammu and Kashmir where no life is lost due to terrorism, Union Home Minister Amit Shah said here on Monday.

Interacting with youngsters from Jammu and Kashmir who have come to the national capital under the Watan Ko Jano youth exchange programme, Shah also said the people of Jammu and Kashmir had equal rights over the entire country, like the people of any other state, and the entirety of India looked at the people of the Union Territory with love and respect.

When terrorism comes to an end, there is no need for the deployment of police and that day is not far, he added.

"When there is peace, no police will be required. This message has to be carried by you to your friends, family and villages... When you go home, tell your friends, neighbours that the entire country is living in peace and the people of Jammu and Kashmir should also live in



peace," Shah said.

There is peace in Jammu and Kashmir and this peace has to be permanent and "our aim is to make a Jammu and Kashmir where no life is lost due to terrorism", he added.

Asserting that violence in Jammu and Kashmir has reduced by over 80%, Shah said that the Union Territory has achieved complete stability, and it would last forever.

"Violence brings nothing. Due to the decades of terrorism in Jammu and Kashmir, 36,000 people lost their lives,"

the home minister said.

Shah said Prime Minister Narendra Modi had made the country equal for all by abrogating Article 370 and, now, the people of Jammu and Kashmir had equal rights anywhere in India, like the people of Delhi, Rajasthan, Gujarat or Rajasthan.

"You have rights over Jammu and Kashmir. Is it not good that you also have equal rights over the other 29 states of the country? Like Jammu and Kashmir, the whole country is yours," he said.

Peace is most important for everyone and, under the Modi government, peace and development have come to Jammu and Kashmir, hospitals, roads and bridges have come, infrastructure has been created, he added.

"The entire country looks at the people of Jammu and Kashmir with love and respect. It is because peace is prevalent there. It is because of peace, development is taking place in Jammu and Kashmir," the home minister said.

There are 30 states in the country and Jammu and Kashmir is one of them. Together, all these 30 states become India, he said.

"Our country is our home. If you don't step out of Jammu and Kashmir, you will not be able to know the country. So, don't you think that you should visit and know the country well? In your next school vacation, you must visit any of the states along with your parents. If required, have a fight at home but you must visit one of the states," he added.

Cabinet Approves LG's Address To Assembly

Srinagar: J&K cabinet on Monday approved Lieutenant Governor Manoj Sinha's address to be delivered by him on the first day of the budget session in the Legislative Assembly, sources disclosed.

Sources said that the cabinet which met at civil secretariat Jammu today under the chairmanship of chief minister Omar Abdullah approved the LG's address to the Assembly on March 03.

"The cabinet met at 7:00 PM and lasted for nearly 80 minutes," they said. The LG's address would outline the policies and roadmap of the Omar Abdullah-led government.

As per Jammu & Kashmir Reorganisation Act-2019, the Lieutenant Governor shall address the Legislative Assembly at the commencement of the first session after each general election to the Legislative Assembly and at the commencement of the first session of each year.

The 43-day long budget session of J&K Assembly would begin on March 03 with the LG's address to

Withholding Material Facts Undermines Justice: HC Imposes Rs 25000 Costs On Ex-SBI Manager For Concealing Facts

Srinagar: Observing that withholding material facts from the Court not only undermines the process of justice but also violates the principle of coming to the Court with clean hands, the High Court of J&K and Ladakh has imposed Rs 25000 costs on a former manager of SBI for suppressing facts before it.

The ex-Manager, Madan Lal Goria, had filed a petition seeking quashing of order dated 01 April 2014, passed by Chief General Manager, Appellate Authority, State Bank of India Chandigarh, whereby penalty of "Compulsory Retirement" in terms of Rule 67(h) of State Bank of India Officers Service Regulations (SBIOSR) has been imposed upon him. The



54-year-old Goria had also sought quashment of order dated 14 March 2018 passed by the Reviewing Authority, rejecting his review plea.

"...due to lack of the territorial jurisdiction and the petitioner's (read Goria) failure to come to the Court without clean hands, this Court is not inclined to venture into the merits of the case," a single-bench of Justice Wasim Sadiq Nargal said, adding, "After analyzing all the material facts

on record, coupled with the stand of rival parties and arguments advanced, this Court is of the considered view that the instant petition is misconceived, false, frivolous and liable to be dismissed"

The Court while examining the record supplied by the SBI found that Goria had previously filed a petition before the High Court of Himachal Pradesh, Shimla, which was dismissed vide order dated 1 March 2013, "involving facts and circumstances that are strikingly similar to those in the present case".

However, the Benach said, Goria has deliberately concealed "this crucial and material fact from this Court."

Jammu: In response to recent publicity of notices by some members, Speaker, Legislative Assembly, Abdul Rahim Rather Monday said that as per rules and conventions of house, a notice shall not be given publicity by any member or other person until it has been admitted by the speaker.

The Speaker, while talking on the issue said, "Rule 368 of the Rules of Procedure and Conduct of Business in Jammu and Kashmir Legislative Assembly, provides that notice shall not be given publicity by any member or other person until it has been admitted by the Speaker and circulated to members. Similarly, a notice of a question shall not be given any publicity until the day on which the question is answered in the House".

The Speaker further said, "Rule 334-A of the Rules of Procedure and Conduct of Business in Lok Sabha also provides that notice shall not be given publicity by any member or other person until it has been admitted by the Speaker and circulated to members. Also a notice of a question shall not be given any publicity until the



day on which the question is answered in the House".

Er Rashid's Bail Plea

Delhi HC Directs NIA Court To Expedite Hearing

New Delhi: The Delhi High Court on Monday asked a court hearing cases of the National Investigation Agency (NIA) to expeditiously decide the bail plea of jailed J&K MP Abdul Rashid Sheikh alias Engineer Rashid in a terror funding case.

Justice Vikas Mahajan said, "The ASJ-03, Patiala House Court, New Delhi is requested to dispose of the bail application of the petitioner expeditiously."

The court was dealing with Rashid's plea alleging there was no remedy available after the NIA court, dealing with his bail application, left him in limbo post his election as a member of Parliament (MP). Justice Mahajan observed

a direction was passed by the high court on the administrative side clarifying that the NIA court would continue to hear the case.

In view of the development, Rashid's counsel, senior advocate N Hariharan, sought to withdraw the plea from the high court but prayed for a direction to the NIA court to decide expeditiously as possible the bail application that was pending since August last year.

'3 In 5 Die After Cancer Diagnosis In India, **Women Affected Disproportionately'**

Three in every five people in India succumb to cancer following diagnosis with women bearing a "disproportionate burden" compared to men, an analysis of global cancer data has estimated. The incidence to mortality ratio in the US was found to be about one in four, while in China it was one in two, according to the results published in 'The Lancet Regional Health Southeast Asia' journal.

The Indian Council of Medical Research (ICMR) study found that India ranked third highest in cancer incidence, after China and the US, and accounted for over 10 per cent of the world's cancer-related deaths, ranking second after China.

Researchers also projected that in the coming two decades, India will face a formidable challenge in managing deaths related to cancer incidence, with a yearly increase of two per cent in cases as the population ages.

The team examined trends in 36 types of cancer across age groups and genders in India over the past 20 years, using the Global Cancer Observatory (GLOBOCAN) 2022 and Global Health



Observatory (GHO) databases.

"Approximately three out of five individuals would be expected to succumb to mortality if diagnosed with cancer in India," the authors wrote.

The findings also revealed that the five most common cancers affecting both genders collectively account for 44 per cent of cancer burden in India.

However, women in India were found to bear a "disproportionate burden", as breast cancer continues to be the most prevalent cancer, contributing to 13.8 per cent of new cases from both genders, and cervical cancer the third most (9.2 per cent).

Among women, breast cancer made up for nearly 30 per cent of new cases and over 24 per cent of related deaths, followed by cervical cancer, accounting for over 19 per cent of new cases and almost 20 per cent of deaths.

Among men, oral cancer was found to be the most commonly diagnosed cancer, contributing to 16 per cent new cases, followed by respiratory (8.6 per cent)

and oesophagus (6.7 per cent) cancer. The team also detected a shift in cancer prevalence across age groups, with the geriatric age group (aged 70 years and above) exhibiting the highest cancer burden.

Those in the reproductive age group (15-49 years) showed the second highest incidence and were related to a fifth of cancer-related deaths.

Further, the middle- and old-aged individuals have an 8-10 per cent higher chance of developing cancer with a 5.5-7.7 per cent chance of succumbing to it, the authors said.

The findings highlighted the urgency of targeted interventions and strategies to tackle the escalating cancer burden in India, with about 70 per cent of cases and deaths occurring in the middle- and older-age groups, the authors said.

The study is the "first comprehensive evaluation of the current and future landscape of cancer in India, focusing on different age groups and gender disparities." The GLOBOCAN database provides estimates of cases, deaths and prevalence for 36 cancer types, including non-melanoma skin cancer, for 185 countries and territories worldwide.

Srinagar: While the administration promotes Kashmir's rich heritage through the 'Soun Meeras' festival, the historic Budshah Tomb in Srinagar continues to deteriorate due to neglect. This has raised concerns among locals.

Residents and shopkeepers near the tomb said that despite being a centuries-old heritage site, Budshah Tomb has received no attention from authorities.

"The Budshah Tomb is one of our oldest and most precious historical landmarks, yet it remains in shambles," said a local. "The government talks about preserving culture, but what about this historic site?"

Another resident blamed the Archaeology Department, saying that officials have been making excuses instead of taking action. "They always claim they lack the authority to repair it. Now that a gov-

ernment has been formed in J&K, we hope they will finally step in and restore the site," he said.

Many locals believe that while grand announcements are made about heritage preservation, actual restoration work remains stalled.

"Festivals like 'Soun Meeras' are great, but what's the point if our real heritage is left to decay?" another resident asked.

An official from the Archaeology Department said that they are unable to carry out repairs due to jurisdictional issues. "The site falls under the Centre's supervision, and we have no authority to restore it," the official said.

Last week, Director of Archives, Archaeology & Museums, K.K. Sidha, spoke about heritage projects, including modernising the SPS Museum in Srinagar, restoration of Shergarhi Palace & Mubarak Mandi complex and upcoming cultural initiatives like 'Tehzeeb Mahal'.

Fire Guts 9 Houses In Rajbagh, Eidgah

Injures Three Firefighters, Renders Several Families Homeless

Srinagar: At least nine residential houses were damaged in two separate fire incidents in Srinagar city on Monday, while three firefighter's sustained injuries during the operations, officials said.

The official said the first incident occurred in Rajbagh Srinagar, while the second took place in Eidgah, Srinagar.

The official further said that five residential houses were damaged in the Kursu Rajbagh that rendered several families homeless.

Later in the afternoon, another massive fire erupted in the Eidgah area, engulfing four residential houses. "During the operation to control the flames, three firefighters, identified as Mohammad Yaqoob Sofi and Fayaz Ahmad, and Aftab Alam sustained injuries," he said.

Meanwhile, firefighters along with local residents collectively douse the flames to prevent spreading of fire.

"An investigation has been initiated to ascertain the cause of both fire incidents," said an official.

Meanwhile, emotional scenes widely spread at both the locations as the victims were watching their properties burning to ashes. "We tried our best to save whatever we could, but the fire spread too fast," said a resident of Rajbagh.

Another resident from Eidgah

'Toothless' F&ES Can't Act Against Fire Safety Violators' In Kashmir

rinagar: Despite hundreds of fire incidents reported annually, the "toothless" Fire & Emergency Services Department remains powerless to act against violators due to the absence of enforcement powers under the pending Fire Safety Model Bill.

According to official data nearly 600 fire incidents were reported in Srinagar in 2023 alone, while Budgam district witnessed 276 incidents. In just the first month of 2024, Kashmir recorded 41 fire incidents, including 9 in Srinagar.

These recurring incidents have raised serious concerns about the lack of fire safety measures in both commercial and residential buildings, especially in the congested areas of the old city.

Deputy Director of Fire & Emergency Services Command Srinagar, Er. Mohmad Arif Mir,

said that the public came together to help, but the damage was already done. "Many families have lost everything and are left with nothing but faith in God," he said.

said that the primary reason for the frequent fire incidents is the increased use of heating devices during the harsh winter months. "Structures are already vulnerable, and the use of substandard equipment or failure to follow safety protocols often leads to devastating consequences," Mir said.

The department has been conducting fire safety audits for government buildings, schools, and hospitals through an online portal. A dedicated helpline is also available for reporting fire safety concerns.

However, Mir said that many establishments, particularly in Srinagar's Downtown area, continue to ignore safety norms. "While fines can be imposed, the department lacks the enforcement powers to take strict action against violators," he added.

A shopkeeper near the Eidgah fire site said fire tenders arrived, but the flames were uncontrollable. "It was heartbreaking to see houses turning to ashes," he said—(KNO)

Indo-Pak Dialogue Freeze

ammu and Kashmir Chief Minister Omar Abdullah's recent statement that there was "no scope" of India initiating a dialogue with Pakistan following a spree of terror attacks has only highlighted the existing geopolitical reality of the subcontinent. The CM, in an interview with the BBC, reasoned that Pakistan has never stopped meddling in J&K's affairs and called on the neighbouring country to take on board some of the Indian government's concerns for a "friendly

It wasn't long ago that Omar's party National Conference (NC) echoed the late Atal Bihari Vajpayee's line that neighbours can't be changed. The NC has historically stood by this pragmatic approach—dialogue, even with adversaries, was seen as the only real path to peace. But today, that optimism seems to have worn thin. The reasons aren't hard to understand. A surge in terror attacks—122 lives lost in 60 incidents last year alone has left little room for diplomatic idealism.

Ultimately, Abdullah's change in direction underlines the difficult balancing act facing leaders in Kashmir. His more rigid stance may win support from those calling for stronger action against terrorism, but it also sparks a broader debate. Can a pursuit of lasting peace in the region, let alone in Kashmir, afford to reject dialogue altogether?

The deep distrust and the entrenched animosity between India and Pakistan have ensured that the festering issues between them have remained unresolved. Talks have invariably been followed by the violence and the consequent break-up in the engagement. This has meant that no process of dialogue has been taken to its logical conclusion. This dismal state of affairs has been repeated so often that the people in both countries have grown cynical of any prospect of progress in the relations of the two countries. The current bilateral state of affairs is far from promising, with no direct flights, hardly any visas issued, and no bus or train services between the two countries

But it is also true that Pakistan wants to only discuss Kashmir and also seeks a reversal of the withdrawal of Article 370 which is not going to happen. The positions of the two countries have thus become too irreconcilable to make it easy for them to re-engage. But it is still possible that the prime minister Narendra Modi and his Pakistani counterpart Shehbaz Sharif will engage and break ice. In the interest of regional peace, the two neighbours need to transcend their differences and talk to each other. This alone will change the situation in the region for the better. But for that to happen, Pakistan has to also observe some ground rules. A true dialogue can only take place in an environment where there is no risk of it being upstaged by violence as has happened in the past.

omestic workers form an ssential part of households across the world. From sweeping floors and washing dishes to taking care of children, the elderly, and the disabled, they perform numerous tasks that make daily life easier for their employers. However, despite their indispensable contributions, they remain one of the most vulnerable and neglected groups of workers. Domestic work is often undervalued, unregulated, and even invisible in many societies. Most domestic workers come from impoverished backgrounds and take up such jobs out of necessity rather than choice. They are frequently subjected to low wages, excessive workloads, abuse, and lack of legal protection. What makes their plight worse is that many governments fail to acknowledge their rights as workers, leaving them trapped in a cycle of exploitation. It is essential that governments and societies recognize the sufferings of domestic workers-men, women, and children alike-and take immediate steps to ensure their safety, dignity, and well-being.

Unlike other workers who have defined work shifts, domestic workers are often expected to be available from dawn to midnightor even round the clock in cases where they live in their employers' homes. There is no concept of "office hours" for them. Some start their day before sunrise, preparfaced by domestic workers is abuse at the hands of their employers. Many endure verbal insults, belittling remarks, and constant humiliation. They are velled at, criticized, and treated as inferior human beings simply because of their socio-economic background. Physical abuse is another horrifying reality. Some workers, particularly live-in maids, have been beaten, slapped, and even tortured by their employers. Cases of women being burned with hot water, locked in rooms without food, or being thrown out onto the streets after an argument are not uncommon. Women and young girls are especially vulnerable to sexual harassment and assault. Many have been exploited by male employers or other family members in the household. Fear of losing their jobs, social stigma, and lack of legal support force them to suffer in silence.

One of the darkest aspects of domestic work is child labor. Millions of children worldwide work as domestic servants, often under cruel conditions. These children-sometimes as young as five or six—are deprived of education, proper nutrition, and emotional care. They are forced to carry out heavy tasks such as scrubbing floors, lifting water buckets, washing clothes, and cooking meals. Many work from morning till night, with no time to play, rest, rate washrooms or enter the house through the back door. They are made to feel inferior, as if their existence is only meant to serve others. This discrimination erodes their self-esteem and reinforces a class divide that denies them the basic respect they deserve as human beings.

The injustices faced by domestic workers demand urgent action. Governments across the world must recognize them as formal laborers and extend labor rights to them, including a legally mandated minimum wage, fixed working hours, weekly rest days, annual leave, and compensation for unfair dismissal. Strict laws must be enforced to prohibit child labor in domestic work. Instead of sending children to work, governments should provide financial assistance to poor families so that children can attend school and receive an education. Strong legal action must be taken against employers who physically or sexually abuse domestic workers. Helplines, complaint centers, and women's protection agencies should be established to assist victims. Employers found guilty of mistreatment should face fines, imprisonment, and permanent bans from hiring domestic workers.

Domestic workers must be provided with social security benefits, including health insurance, medical aid, pension schemes, housing, and compensation for workplace





payments for trivial reasons or withholding them altogether as a form of punishment. Since most domestic workers are employed informally and lack proper contracts, they have no legal recourse to claim their rightful earnings. Women and migrant workers are particularly vulnerable to wage theft. In extreme cases, some domestic workers are not paid at all and are treated like bonded laborers or modern-day slaves.

One of the gravest issues

Domestic workers are often treated as second-class citizens. Many employers do not allow them to eat at the same table, use the same utensils, or even sit on the same furniture. In some societies, they are forced to use sepano child is forced into labor, and that every human being is given the dignity, respect, and justice they deserve. It is time to break the silence. It is time to act.




30-year-old Man's Upper Jaw Reconstructed Using Advanced 3D Technology at Paras Health Srinagar

Srinagar, 24th February 2025: In a remarkable medical achievement, Paras Health Srinagar has successfully performed an advanced 3D Rapid Prototypingbased free flap reconstruction on a 30-year-old man diagnosed with residual sarcoma of the upper jaw. The patient had previously undergone treatment, but some of the disease remained, requiring a complex, multidisciplinary surgical approach to ensure complete excision and functional restoration.

The case was thoroughly discussed in the multidisciplinary tumor board at Paras Health Srinagar, where a team of oncologists, reconstructive surgeons, radiologists, and pathologists



collaborated to determine the best course of action. Given extensive involvement of the central upper jaw, the team planned a cutting-edge 3D-printed fibula-free flap reconstruction to restore the jaw's structure and function. This



technique, which is performed in select centers in India, including at Paras Health Srinagar, allowed for precise preoperative planning, accurate anatomical modeling, and significantly reduced surgical time.

The team of reconstructive

surgeons, which was led by Dr. Azhar Jan Battoo, included Dr. Abid Saleem, Sr. Oncoplastic surgeon, and Dr. Waseem Bhat-Onco Prosthodontist.

Commenting on the success of the case, Dr. Azhar Jan Battoo, Associate Director of Surgical

Oncology at Paras Health, Srinagar, stated, "This case marks a significant milestone in surgical oncology and reconstruction. The use of 3D rapid prototyping allowed us to plan and execute the surgery with exceptional precision. We were able to shape the graft before harvesting it, ensuring a perfect fit for the patient's jaw. While fibula-free flap reconstruction is performed at several centers, what makes this case unique is the preoperative 3D modeling, which significantly enhances accuracy and efficiency. The patient was discharged on the fifth day in excellent condition, and we expect him to lead a completely normal life once

his final dental rehabilitation is completed."

The surgical process involves multiple steps to ensure the best possible outcome for the patient. High-resolution CT and MRI scans were used to generate a detailed 3D model of the affected area, which was then 3D printed to guide the surgical excision and reconstruction. The fibula bone from the patient's leg, which is non-essential for daily movement, was used to reconstruct the jaw. With the help of the 3D-printed templates and cutting guides, the fibula bone was shaped to precisely match the patient's original jaw struc-

ture before being transplanted. The team meticulously joined

newly reconstructed jaw to the patient's neck, ensuring proper blood supply and viability of the flap. A temporary jaw prosthesis was made and permanent dental implants will be integrated within the next 5-6 months, restoring the patient's full oral function and appearance.

"When a party suppresses material facts, it renders the proceedings a nullity. It is the duty of every litigant to disclose all material facts, as withholding material facts from the Court not only undermines the process of justice but is also a violation of the principle of coming to the Court with clean hands," the

The Apex Court has further observed that failure to disclose material facts could lead to the dismissal of the petition, even if it has merit otherwise, the Bench said.

"Thus the imposition of costs for concealment of material facts has been used as a remedy to deter such fraudulent practices."

SRINAGAR: The prolonged dry spell and climate change have led to a worrying decline in water levels across Kashmir's water bodies, which has sparked concerns among civil society members and locals. They fear that if the rain deficit continues, the situation may worsen and directly affect agriculture, horticulture and daily livelihoods.

Citizens and civil society members called for collective responsibility rather than waiting for the government or other authorities to act.

"Everyone is looking at others for action, but real change starts at an individual level. Climate change has triggered a prolonged dry spell, and we must take steps to minimize its impact," said Tahir Ahmad, a DDC member from Shopian.

Tahir said that once-pristine canals, springs, and streams that were sources of drinking water are now polluted and unsafe. He criticised unsustainable development practices that have worsened environmental degradation.

"The so-called development that destroys our environment is not progress-it is a step toward destruction for both current and future generations," he added.

Zaid Ahmad, a social activist from south Kashmir, blamed illegal and unregulated mining for further depleting and polluting the region's water bodies. "Even the mining operations auctioned by the government are not being conducted as per guidelines. These activities have disturbed aquatic life and harmed indigenous fish species like Schizothorax, which was once found in abundance in Veshow and Rambiara but is now rarely seen," he said.

Ahmad and other civil society members said pollution in water bodies has made the crisis worse. "Most canals and tributaries are filled with garbage, including sanitary waste, household trash, and horticulture by-products. We, the people, are responsible for this mess," they said.

The civil society members urged the government to take concrete steps to preserve Kashmir's natural water resources before it's too late.

The key demands include regular cleaning of canals, streams, springs and rivulets across all districts; strict penalties for individuals and businesses polluting water bodies; enforcement of mining regulations to protect aquatic biodiversity; and formation of village-level committees to monitor and clean local water sources. -(KNO)
