# **Kashmir Receives Much-Needed** Rain, Snow

Braces For 3 More Days Of Wet Weather

Srinagar: The higher reaches of Kashmir received fresh snowfall, while the plains were lashed by rains on Tuesday, bringing muchneeded respite to the residents of the valley, officials said on Tuesday.

The famous tourist resort town of Gulmarg and the surrounding areas received fresh snowfall, while the higher reaches in other parts of the valley also witnessed snowfall this after-

noon, officials said. The plains of the valley, including Srinagar, were lashed by rains, which brought the day temperature down by several degrees, they added.

The local Meteorological department (MeT) has issued a yellow alert for

February 26 across Jammu 🗣 and Kashmir. An orange alert has been issued for February 27 for both J&K. On February 28, an orange alert has been issued for Jammu and yellow alert for Kashmir region.

Isolated heavy rain and snow are expected during the period while surface traffic may also be witnessed, reads the advisory issued by the MeT.

Generally cloudy weather is expected for the next three days as there is a possibility of light to moderate rain and snow at most places till February 28 late night with isolated heavy rain and snow over both Kashmir and Jammu divisions during the above period, Director MeT, Dr Mukhtar Ahmad said.



#### **CBSE To Conduct Class-10 Exams** Twice A Yr

New Delhi: The Central Board of Secondary Education (CBSE) on Tuesday approved draft norms for conducting Class-10 board exams twice a year from 2026, officials said.

The draft norms will now be put in the public domain and the stakeholders can submit their feedback till March 9 following which the policy will be finalised, they said.

As per the draft norms, the first phase of the exams will be conducted from February 17 to March 6, while the second phase will be conducted from May 5 to 20.

# Civil Society Seeks Pulpit Ethics Code From Religious Bodies

Srinagar: In a significant development, Kashmiri civil society has urged Mirwaizi-Kashmir Umar Farooq, the Chairman of Muttahida Majlis-e-Ulama (MMU), to convene an urgent meeting for drafting qualifications and ethical guidelines for religious preachers delivering sermons

from the sacred pulpit. In a letter addressed to Mirwaiz Umar Farooq, prominent civil society member Shakeel Qalander, on behalf

of the community, expressed deep concern over the rise of inflammatory and divisive rhetoric by certain preachers on social media. The letter highlights how these individuals have used religious platforms to promote personal agendas, disregarding the sentiments of various sects and threatening societal harmony.

"It has come to our notice with utmost pain that certain preachers have recently surfaced on social media and are using the sacred pulpit of the Holy Prophet for personal

publicity through highly provocative and inflammatory remarks," the letter reads. The appeal calls upon the

MMU and allied religious bodies, including the J&K Muslim Personal Law Board, to take immediate measures, including: Drafting Qualifications &

Ethical Guidelines for individuals addressing congregations in mosques, Imam Bargahs, and Khanqahs.

# **Melatonin Pills Could Help Repair DNA Damage Due To Night Shift Work**

elatonin supplements boost the body's ability to repair DNA damage related to night shift work, potentially lowering cancer risk among this group of workers, a study has suggested.

However, researchers, including those from the British Columbia Cancer Research Institute in Canada, cautioned that data from larger studies are needed before melatonin can be recommended for longterm use.

Normal production of the melatonin hormone, which is linked with one's body clock and daylight, is suppressed among night shift workers. Melatonin supplements are considered a 'physiological support' to help the brain restore the quality, structure, and pattern of sleep.

Researchers explained that producing lower levels of melatonin compromises the body's ability to repair DNA damage caused by everyday biological processes, potentially increasing the risk of certain cancers among night shift workers.

The findings, published in journal Occupational and Environmental Medicine, "suggest that melato-

nin supplementation may improve oxidative DNA repair capacity damage among night shift workers." For the study, the researchers looked at 40 night shift workers, most of whom were employed in healthcare.

Half the participants were randomly assigned a threemilligram melatonin pill (taken with food an hour before sleeping during the day) for about a month, while the other half were randomly assigned a placebo pill on the same schedule.

All the participants worked at least two consecutive night shifts every week, lasting seven hours each night, for a minimum of six months. None had sleep disorders or long-term conditions, the researchers said. Urine samples were collected during the second day of the night-shift-day-sleep routine -- once before starting the trial and once near the end of the four week-period.

Analysis revealed 80 per cent higher levels of '8-OHdG' -- a molecule that indicates one's capacity to repair DNA damage -- in the urine samples of night shift workers who were taking melatonin supplements. The researchers explained

that most of the 8-OH-dG is

removed from DNA as part of the repair process and excreted into urine, where its levels are measured -- therefore, higher levels mean a better capacity for

DNA repair. The study's results suggested that better repair might be occurring among those taking the melatonin supplement, compared to those taking the dummy pill, the authors said.

"Increased oxidative DNA damage due to diminished DNA repair capacity is a compelling mechanism that may contribute to the carcinogenicity of night shift work," they wrote.

However, they cautioned that larger-scale studies examining long-term impacts of melatonin pills are required, results from which would help determine if supplementation could be viable for lowering cancer risk among night shift workers. Doctors strictly advise melatonin supplements for those working irregular shifts and crossing time zones, among whom day-and-night differentiation is affected.

However, the supplements are not sedatives or sleep-inducing drugs and consulting with medical experts, including psychiatrists, is recommended before one considers melatonin pills for resolving sleep-related issues.

#### **Valley's Token Power Supply** Dips To 1½ Hr A Day

Tower Restoration Yet To Pick Up

**Observer News Service** 

**SRINAGAR** - Despite official claims to the contrary, there was no perceptible improvement in valley's power supply. Even after making, three units of the Pampore gas turbine operational since yesterday, the net avail-ability of electricity to the consumers averaged a little lover one and a half hour in 21 hours. Something unprecedented, indeed.

Official sources told Kashmir Observer the valley had been divided into 18 groups to whom electricity was being provided for one hour in every 18 hours by rotation. Follow-ing the availability of another 60 mw of power from the three units of gas turbine, a 'generous' relief of two hours in given five days. This works out to a total of 8.30 hours power supply in 120 hours.

With the power minister, S S Slathia's claim of "suspected militants' having blasted three transmission towers in Banihal area emphatically blasted even by official circles, people have blamed the government of engineering the total breakdown to deprive the valley of even the bare minimum of power during winter months to the advantage of warmer Jammu.

According to reports, even the divisional commissioner, Khursheed Ahmad Ganai, did not rule out the involvement of some contractors and power development department (PDD) officials in the blasting of the transmission towers. Nothing could be more damning for the power minister who has allegedly been employing circumlocution and subterfuge to the hilt to escape the blame for the valley's worst ever power crisis.

Meanwhile, according to CNS, the work on restoration of the transmission towers at Sher Bibi and Bonakot had not picked up yet A group of officials from the power grid corporation of India (PGCI) and the power development department (PDD) besides some labourers are reported to be camping at the two sites without taking up any actual work. The official claims of the work going on 'war footing' have proved to be a hoax, the report said

Rajinder Singh reports from Jammu: Even the government promised improvement by Saturday with the temporary restoration of 220-KV tower, the power minis-ter, S S Slathia told Kashmir Observer the valley would have to face power crisis for another week. He said resto-1 ration work was going on 'war footing' but it would take about two month. However, temporary restoration will be completed by February 27. He said 370 mw of power not being supplied to the valley at present was being saved with effect from

## CBI Conducts Searches At 60 Locations In Rs 6,600 Cr Scam

New Delhi: The CBI on Tuesday conducted countrywide coordinated searches at 60 locations as part of its probe into Rs 6,600 crore GainBitcoin cryptocurrency scam, officials said.

The searches were spread across multiple cities including Delhi, Pune, Chandigarh, Nanded, Kolhapur and Bengaluru, targeting premises allegedly linked to key accused individuals, a CBI spokes-

person said in a statement. The ponzi scam perpetrated through a web of platforms, including flagship site www.gainbitwas allegedly masterminded by Amit Bhardwaj (now deceased) and his brother Ajay Bhardwaj, the officials said.

Launched in 2015, the illicit operation was camouflaged under the facade of Variabletech Pte, Ltd, they said

The scheme lured the investors offering extraordinary returns of 10 per cent per month in Bitcoin over an 18-month period urging them to purchase the digital currency from external exchanges and deposit it with GainBitcoin through "cloud mining" contracts, the central agency said.

"The model followed a multi-level marketing (MLM) structure, commonly associated with pyramid structured ponzi schemes, where payouts were dependent on bringing in new investors," the spokesperson said.

In its early days, investors received payouts in Bitcoin, fuelling the illusion of a lucrative venture. However, as the influx of new capital dwindled by 2017, the charade began to crumble.

"In an attempt to cover up the GainBitcoin unilaterally switched payouts to their alleged in-house cryptocurrency called MCAP, which had significantly less value than Bitcoin, further misleading investors," the statement said. The sheer scale and complexity of the scam resulted in registration of multiple FIRs filed across India, from Jammu and Kashmir to Maharashtra and from Delhi to West Bengal. The Supreme Court handed over the investigation to the Central Bureau of Investigation (CBI), due to the expansive nature of the operation and the international ramifications it entailed.

"The CBI took over these cases and is conducting an omnibus and comprehensive investigation to uncover the full extent of the fraud, identify all accused parties, and trace the misappropriated including international funds. transactions," the statement said. The agency has launched a probe to unravel the full extent of the fraudulent activities, identify all implicated parties, and trace the misappropriated funds, including those that may

have crossed borders. "During searches, a few crypto wallets, incriminating digital evidences and digital devices have been seized. The evidences present in emails/clouds have also been seized," the agency said.



# **US Shifts Stance, Sides With Russia On Ukraine War**

UNITED NATIONS (AP) — In a dramatic shift in transatlantic relations under President Donald Trump, the United States split with its European allies by refusing to blame Russia for its invasion of Ukraine in votes on three U.N. resolutions Monday seeking an end to the three-year war.

The growing divide follows Trump's decision to open direct negotiations with Russia on ending the war, dismaying Ukraine and its European supporters by excluding them from the preliminary talks last week.

In the U.N. General Assembly, the U.S. joined Russia in voting against a Europe-backed Ukrainian resolution that calls out Moscow's aggression and demands an immediate withdrawal of Russian troops

The U.S. then abstained from voting on its own competing resolution after Europeans. led by France, succeeded in amending it to make clear Russia was the aggressor. The voting was taking place on the third anniversary of Russia's invasion and as Trump was hosting French President Emmanuel Macron in Washington. It was a major setback for the Trump administration in the 193-member world body, whose resolutions are not legally binding but are seen as a barometer of world opinion.

The U.S. then pushed for a vote on its original draft in the more powerful U.N. Security Council, where resolutions are legally binding and it has veto power along with Russia, China, Britain and France. The vote in the 15-member council was 10-0 with five European countries abstaining - Britain, France, Denmark, Greece and Slovenia.

The dueling resolutions also reflect the tensions that have emerged between the U.S. and Ukraine. In escalating rhetoric, Trump has called Ukrainian President Volodymyr Zelenskyy a "dictator" for not holding elections during wartime, when much of Ukraine is under Russian occupation, its soldiers are on the frontlines and the country is un-

der martial law. Trump also has falsely accused Kyiv of starting the war and warned that he "better move fast" to negotiate an end to the conflict or risk not having a nation to lead. Zelenskyy responded by saying Trump was living in a Russianmade "disinformation space."

In a whirlwind of diplomacy, Trump's meeting with Macron will be followed by a visit on Thursday from British Prime Minister Keir Starmer, key U.S. allies who were in lockstep with Washington on Ukraine just over a month ago. They now find themselves on opposite sides on the best pathway for the UN to call for an end to the war.

The General Assembly voted 93-18

with 65 abstentions to approve the Ukrainian resolution. The result showed some diminished support for Ukraine, because previous assembly votes saw more than 140 nations condemn Russia's aggres sion and demand an immediate withdrawal.

The assembly then turned to the U.S.-drafted resolution, which acknowledges "the tragic loss of life throughout the Russia-Ukraine conflict" and "implores a swift end to the conflict and further urges a lasting peace between Ukraine and Russia," but never mentions Moscow's aggression.

In a surprise move, France proposed three amendments, which add that the conflict was the result of a "fullscale invasion of Ukraine by the Russian Federation." The amendments reaffirm the assembly's commitment to Ukraine's sovereignty, independence, unity and territorial integrity, and call for peace that respects the U.N. Charter.

Russia proposed an amendment calling for "root causes" of the conflict to be addressed

All the amendments were approved and the resolution passed 93-8 with 73 abstentions, with Ukraine voting "ves." the U.S. abstaining, and Russia voting "no." Both assembly resolutions were supported by U.S. allies in Asia, including Japan, South Korea, Australia and New Zealand, its neighbors Canada and Mexico and European countries, with the exception of Hungary.

## Next Maha Kumbh On Sand As Rivers May Dry Up: Wangchuk In Letter To PM

New Delhi: Fresh from his tour to the US where he carried a piece of ice from a glacier in Ladakh to flag their fast melting, climate activist Sonam Wangchuk has written an open letter to Prime Minister Narendra Modi stating that India should take a lead in addressing the issue

Drawing attention to the gravity of the situation in the Himalayas, Wangchuk told a press conference in the capital that if steps are not taken to restore these glaciers which are the source of perennial rivers, the next Maha Kumbh after 144 vears may be held on sand as the rivers may dry up.

Wangchuk, who has been working on preserving Himalayan glaciers, travelled from Ladakh to Delhi, and then to the US with a piece of ice from a glacier in Khardung La. The ice was placed in a container wrapped in Ladakh's iconic Pashmina wool for insulation. The ice was taken to the UN office in Delhi, before he flew to the US where it travelled along with the climate activist to the Harvard Kennedy School, MIT, at Boston and to the UN head quarters in New York, before being immersed at the confluence of Hudson River and East River in New York on February 21, a month ahead of The World Day for Glaciers which will be observed on March 21. The United Nations (UN) has declared 2025 as the International Year of Glaciers' Preser-



Wangchuk, who sent out a message of reducing demands instead of finding new means of supply to manage climate change, delivered his talks with the glacial ice melting next to him, symbolising how glaciers are receding as talks go on. Back in India, the climate

activist recounted how they had to trek a few kilometres to get the ice from the glacier at Khardung La, the highest motorable pass in the world at 5,359 metres in Leh district. Wangchuk rued that over the vears, glacial ice has been reced-

ing but action remains delayed. In his open letter to the Prime Minister, Wangchuk stressed that India should take a lead in the year of glaciers, as the Himalayas have the third largest deposit of ice and snow on Earth after the Arctic and Antarctica, fetching it the name 'Third Pole'. "India needs to take a lead in

glacier preservation as we have the Himalayas, and our sacred rivers such as the Ganga and Yamuna come out of them," Wangchuk said.

# Sajjan Kumar's Old Age, Illness Weigh In **Favour Of Lesser Punishment, Says Court**

Delhi court on Tuesday awarded life imprisonment to former Congress MP Sajjan Kumar in a murder case connected to 1984 anti-Sikh riots, saying his old age and illness weighed in favour of a lesser sentence instead of death penalty.

Special judge Kaveri Baweja's verdict came over the killings of Jaswant Singh and his son Tarundeep Singh on November 1, 1984

The judge said the offences committed by Kumar were undoubtedly brutal and reprehensible but underscored certain mitigating factors, including his age of 80 years and illnesses that "weigh in favour of imposing a lesser sentence, instead of death penalty".

The offence of murder attracts a maximum of death penalty whereas the minimum punishment is life imprisonment.

"The 'satisfactory' conduct of the convict as per the report of the jail authorities, the ailments from which he is reportedly suffering, the fact that the



convict has roots in society and the possibility of his reformation and rehabilitation are material considerations which, in my opinion, tilt the scales in favour of sentence for life imprisonment instead of death penalty," the order said.

Nothing "adverse was reported about Kumar's behaviour" and his conduct was "satisfactory" according to a jail report, the court added. The judge went on to add that the case at hand was part of the same incident and could be seen in continuity of the incident for which Kumar was sentenced to life imprisonment by the Delhi High Court on December 17, 2018.

tudent leaders of the Government Holkar Science College in Indore allegedly locked their teachers inside a hall and even cut off the power supply after being denied permission for a Holi event, officials said on Tuesday.

After the incident at the college on Monday came to light, the district administration ordered an inquiry.

Student leaders, who were angry over the denial of permission for a Holi event, locked the door of the hall where teachers were, and cut off the electricity supply, said an official.

Several teachers remained locked inside for about half an hour as students shouted slogans. A college employee who too was confined inside managed to sneak out through a window and opened the door, allowing the teachers to exit.

Jain had filed a complaint, and an Additional District Magistrate (ADM) was asked to investigate the matter, he told reporters.

"Appropriate action will be taken based on the ADM's report," he averred.

No police case has been registered in the matter yet. The Holkar Science Col-

lege was established 133 years ago by the then Holkar rulers of Indore.

Some students had planned to organize the 'Holkar Ka Holi Fest' event with an entry fee of Rs 150 on March 7, featuring DJ performances and a 'rain dance', sponsored by a coaching class for civil services examinations.

Even though the college administration denied permission to the event, they went ahead and put up posters on campus advertising the same.

Addressing a press conference in Srinagar, Sajad Parray, said that while the order has been fully implemented in Jammu, Kashmir continues to face mismanagement and legal hurdles.

He accused certain officials in the Chief Engineer's office in Kashmir of disregarding court

orders, misleading authorities, and acting against the public interest. "Their actions threaten both employee rights and the water supply system," he said.

Parray also said that before any proposal is sent to the rnment employee sentatives of the transferred divisions must be consulted. He further stated that if their demands are not met, employees will stage a peaceful protest on February 27, 2025, from the Water Works Division Srinagar to the Chief Office. "If no corrective measures are taken, a complete work strike will follow," he said.

### **Rampant Destruction Of Chinar Trees In Anantnag, Authorities Silent**

SRINAGAR: In a disturbing environmental violation, dozens of majestic Chinar trees have been illegally felled in South Kashmir's Anantnag district, with authorities allegedly turning a blind eye to the destruction. The chopping down of these majestic trees, despite strict regulations for their preservation, has

sparked outrage among locals. Sources reveal that while authorities granted limited permissions to contractors for pruning branches, many misused the approvals and chopped down entire trees to extract maximum wood. This largescale felling has been reported from multiple areas, including Rani Bagh, Sarnal, and Kadipora, where the once-thriving Chinar trees now lie in ruins.

Locals have expressed deep concern over the administration's inaction, questioning why no measures have been taken to curb the illegal felling despite

the availability of geo-tagging technology meant to protect these heritage trees. "These trees have stood for centuries, providing shade, beauty, and a crucial ecological balance. But vested interests are axing them in broad daylight, and officials are doing nothing," a local from Anantnag told the news agency Kashmir News Trust.

The Chinar tree, which holds immense historical and cultural significance in Kashmir, is a protected species under the Jammu and Kashmir Preservation of Specified Trees Act, 1969. Under this law, even pruning requires official permission, yet entire trees are being cut with impunity.

Locals and environmental activists have demanded immediate action, urging the administration to identify and penalize those involved in the illegal felling. They have also called for a thorough probe into how contractors managed to exploit the permissions and why authorities have failed to intervene. [KNT]

# **Oppn Slams CM Over His Remarks** On Mirwaiz's Security

Omar's Comments 'Nonsensical', 'Highly Regrettable': Mirwaiz Manzil

**SRINAGAR:** Opposition parties in Jammu and Kashmir slammed the Chief Minister Omar Abdullah over his remarks on the security of Jama Masjid head cleric Mirwaiz Umar Farooq with Peoples Democratic Party (PDP) and Peoples Conference (PC) leaders accusing him of taking U-turn.

Chief Minister Omar Abdulah in an interview with a National TV Channel had linked the increased security provided to Mirwaiz Umar Farooq to a decline in separatist activities in Jammu and Kashmir, saying that it would have been unimaginable earlier for Mirwaiz to be provided with CRPF cover.

PDP MLA from Pulwama, Waheed-ur-Rehman Parra, in a post on X, accused the Chief Minister of taking complete U-turn from his election campaign and manifesto.

"Dear OmarAbdullah Sahab, Since you are now endorsing peace-If Kashmir appears peaceful today, it is due to UAPA, PSA, NIA, attachment of houses and assets, constant profiling, verification, the lodgment of prisoners outside under stringent laws, and the sacking of employees under 311. This is a complete U-turn from your election campaign and manifesto. Your endorsement now is nothing but a ratification of the iron-fist approach against Kashmiris," it reads.

"If there is no separatist activity today, it is due to tougher measures against separatist and the ban on Hurriyat and Jamaat. And if Mirwaiz Sahab has been given security, it is not for his safety but because his vulnerability has increased. Singling out Mirwaiz only puts him at greater risk, knowing well that his family has already paid a heavy price. The truth is, like hundreds of others, even graves, shrines, and mosques are guarded by JKP and CRPF. So why make an issue if Mirwaiz is?." he wrote.

Peoples Conference (PC) President Sajad Lone said that he was not surprised with the statement of Omar Abdullah.

"I may have millions of disagreements with Mirwaiz Umar Farooq sahib. But that his father was martyred is a reality. My father was matyred too. Even the date of martyrdom is the same and my father had gone to Idgah to commemorate the martyrdom of the Mirwaiz Mohammed Farooq sahib and was shot there,' Lone wrote

Lone further wrote that "CM sahib—-we are victims. We know what a violent death is. Our fathers were killed. Incidentally my father was killed under the watch of your father when he was the Chief Minister.'

"And yes. He did not provide him security despite having clear inputs from the CID that there is

likelihood of him being attacked. He did not provide me security when I wanted to go for his funeral. The Divisonal Commisioner at that time came and expressed inability to provide security. You know what your statements mean. Your mention of so called security for Mirwaiz is what we know as — speak to kill— in the last 3 decades," Lone wrote.

"You always had one of the highest security covers' in India And does it behoove you to act like a white collar killer and make statements which greatly increase the threat perception of a person. Loose talk. Cruel talk. Killer talk. What a shame??? And Wallah. I am not surprised," he wrote.

In the meantime, Mirwaiz Manzil office has strongly condemned recent remarks made by National Conference leader Omar Abdullah regarding the security provided to Mirwaiz-e-Kashmir Umar Farooq. In a statement, Mirwaiz Manzil called Omar Abdullah's comments "nonsensical" and "highly regrettable," asserting that as a leader, he is expected to speak with responsibility and understanding of the circumstances.

The statement criticized his remarks as being in poor taste and reflective of personal insecurities.

The reaction follows Omar Abdullah's response to a question about whether conditions in Jammu and Kashmir had improved since the abrogation of Article 370. While stating that only 2-3percent had changed, Omar remarked that no one could have imagined Mirwaiz Umar Farooq receiving CRPF security from the Central Government, saying, "I couldn't have ever thought of it, but situations have changed."

# **Mission Director Takes Financial Review Of Jal Jeevan Mission**

The Officer on Special Duty with Mission Director enjoined

upon the officers to clear the liabilities on account of completed works which will pave the way for transition to the new payment system. The meeting further directed the divisions to upload the details of infrastructure created on Gati Shakti portal for which training is being imparted by National Jal Jeevan Mission to the nodal officers.

The meeting concluded with directions that the next financial review will be held on the weekend to monitor the progress effectively.

### 3-Member Panel To Draft **Environment Rejuvenation Plan For Poonch**

SRINAGAR: The Jammu & Kashmir administration has appointed a three-member committee to draft an Environment Rejuvenation Plan for Poonch

This initiative comes in response to a directive from the National Green Tribunal (NGT) following the case against M/s Dewan Stone Crusher, which was found guilty of violating critical environmental regula-

The Joint Committee, comprising of District Magistrate of Poonch, members of the Jammu & Kashmir Pollution Control Committee (JKPCC), and representatives from the Central Pollution Control Board (CPCB), has been given two months to finalize the rejuvenation plan.

The primary focus will be on restoring the ecological balance, mitigating pollution, and rehabilitating the land impacted by unauthorized industrial activities.

Once the plan is approved, it will be implemented within three months, following the deposit of the environmental compensation. This ensures that timely corrective actions will be taken to remedy the damage caused by the stone crusher's unlawful operations.

The legal proceedings surrounding M/s Dewan Stone Crusher have been intense.

The IKPCC recently reaffirmed the NGT's order, emphasizing that the stone crusher violated essential environmental norms and must halt its operations immediately. This stance was part of the JKPCC's compliance report submitted to the NGT in case OA No. 151 of 2023, which was filed by Hassina Wajid, Sarpanch, against the State of Jammu & Kashmir and others.

The NGT had previously found the stone crusher and its associated hot mix plant in violation of siting norms, mandating their removal within two months. The tribunal also imposed an interim environmental compensation of ₹7,20,000, requiring the deposit within one month. However, JKPCC's latest submission reveals that the stone crusher continued its operations despite several legal orders, prompting authorities to take stronger measures.

**IKPCC's** report underscores that M/s Dewan Stone Crusher's activities have led to substantial environmental damage, including dust pollution, noise hazards, and potential groundwater contamination. The failure to comply with prescribed siting criteria has exacerbated the ecological crisis in the area, making the formulation of the rejuvenation plan crucial for the district's recovery—(KNO)

### **Hajin Road Along Jhelum Develops Cracks**

**BANDIPORA:** Massive cracks appeared on a road along the river Jhelum in Hajin town of north Kashmir's Bandipora district on Tuesday, creating panic among locals.

Locals said that cracks have been developing on the road over the past few days, but today, the damage worsened with fresh cracks.

They expressed concern that if the cracks worsen, a huge tragedy could occur as the road passes along the river Jhelum. The locals



urged the administration to take immediate action to prevent further cracks in the road.

An official said that a team has been rushed to the spot to assess the situation, and necessary steps will be taken accordingly. He added that public movement near the spot will be restricted—(KNO)

# **Soaring Airfares**

ne of the biggest spoilers of the tourism sector in Kashmir Valley, other than the troubled situation, has been the frequent hikes in airfares. This discourages tourists from visiting the Valley and diverts them to other parts of the country where they can travel with lower fares. In fact, often the tourists can travel with lesser cost to a foreign country such as the United Arab Emirates.

The exorbitant airfares thus create a man-made crisis for the Valley's tourism sector, which, in turn, affects the livelihoods of thousands of people. It goes without saying that tourism plays a key role in the economy of Jammu and Kashmir, contributing significantly to its GDP and providing employment opportunities across various sectors.

Due to a lingering dry spell, Kashmir already has had a lean tourist season this winter. In the most visited resorts such as Gulmarg and Pahalgam, visitor numbers have declined by 30 and 50 percent respectively. The government has already been forced to defer winter games scheduled to be held between at Gulmarg. The games would have put a spotlight on the Valley, drawing more tourists other than the sportsmen participating in the event. With snow still eluding the Valley, the government finds itself unable to reschedule the games. And, anyways, with March approaching, the chances of snowing will increasingly abate.

There's, however, hope that the upcoming spring will compensate for the winter shortfall. Apart from a snowbound winter, Kashmir's spring has been one of the biggest tourism draws for the Valley. As things stand, airfares are skyrocketing right at the onset of spring. According to reports, for Delhi-Srinagar flights, travellers pay Rs 12,000 to Rs 14,000, while those from Bangalore must pay around Rs 17,000. Mumbai residents are confronted with even steeper fares of Rs 27,000, and Kolkata passengers face rates around Rs 18,000. This will discourage the middle class, which comprises the majority of tourists, from visiting the Valley.

True, the issue of escalating airfares is not specific to Kashmir. It can and does happen with other places too. There are many factors at play in the air price variations, such as seasonal demand fluctuations and operational costs. At the same time, predatory pricing practices by the airlines too can't be ruled out. And this is where the government's intervention is required. More so, at a place like Kashmir that heavily relies on tourism to sustain its economy. With the largely dry winter already costing us dearly in terms of tourist inflow, higher air fares can dent spring arrivals too.

# The Illusion of a Grand School Reopening

'n a circular issued on Saturday, the Directorate of School Education Kashmir (DSEK) instructed school heads to ensure that schools wore a "festive" look ahead of their reopening on March 01 after winter vacation.

The DSEK emphasized that the occasion should be celebrated to create a welcoming atmosphere and encourage students to return to a positive and engaging learning environment.

In light of this directive, I took it upon myself to visit some schools, particularly middle and high, to see how well the "festive reopening" vision aligned with reality. What I saw was nothing short of alarming. Inside the very classrooms meant for learning, I found sheep and stray dogs taking shelterright where students are supposed to sit and study.

In such conditions, the health and safety risks for students are unimaginable. Young children, exposed to animal waste and unhygienic surroundings, are at constant risk of bacterial infections, respiratory diseases, and parasitic infestations. The unchecked presence of stray dogs heightens the danger—one sudden attack, a rabid bite, and an entire classroom could be thrown into chaos.

How do you create a "welcoming ambience" in schools where children share space with livestock? Where broken windows let in the cold and rain?

The government's own "Vision Document" published in 2023 indicated that nearly 5000 government schools, especially in remote and hilly areas, suffer from a lack of basic facilities, including proper classrooms, heating arrangements, sanitation, and adequate teaching resources.

Senior officials, particularly those at the ranks of Secretary and Director of Education, often focus their attention on select schools within city limits-institu-



areas remain summarily neglected.

School heads in these 'well-monitored" institutions ensure their campuses appear festive by putting up colourful buntings and decorative flowers, creating a visually appealing setting. The process is often superficial—once the decorations are in place, pho-

compliance with directives, satisfying higher-ups without addressing deeper systemic issues.

However, beyond these

staged visuals, the realities of thousands of schools struggling with inadequate infrastructure remain unaddressed, making such directives more about optics than meaningful improvement. Education departments

in India are largely managed by bureaucrats who often lack direct experience in the education sector. In Jammu and Kash-

mir, these departments are typically overseen by senior JKAS officers who are transferred from various other administrative roles, bringing with them expertise in governance but little to no background in pedagogy, curriculum development, or student engagement.

Take the case of Dr. G.N. Itoo, the current Director of School Education Kashmir. Before assuming this role, he served as the Mission Director of Jal Shakti, where his primary responsibility was ensuring the distribution of potable water to remote areas. While this role undoubtedly involved administrative efficiency and logistical management,

Education Kashmir, his career trajectory also includes diverse assignments such as Director of Tourism Kashmir, Deputy Commissioner of Baramulla, and Director of Estateseach requiring different administrative skills but not necessarily expertise in the

deadliest Pulwama terrorist attack, where 40 paramilitary personnel lost their lives. Yet he was later appointed as an advisor to oversee the Education in J&K. The logic? Unclear. What insights a former top cop could bring to curriculum design, pedagogy, or school infrastructure remains a mystery.

But, in the bureaucratic universe, it seems experience in handling security somehow translates to expertise in shaping young minds.

And then there's the pièce de résistance: Suresh Kumar Gupta, an Indian Forest Service (IFS) officer, currently helming education affairs. A forest officer managing schools-because in the grand scheme of things, trees and textbooks are obviously interchangeable. Maybe it's all part of some grand eco-education experiment where school infrastructure is expected to sprout organically like a well-tended forest. Or maybe it's just another example of how little regard the system has for domain expertise.

# Al-generated influencers: A new wave of cultural exploitation

You probably know what an "influencer" is — people with large, highly engaged social media followings who have the power to sway beliefs and purchasing decisions.

But you might not have yet heard of virtual influencers.

They're like human influencers ... but they're not human. They're characters brought to life by CGI and AI, designed to target demographic groups from a first-person perspective.

Virtual influencers are becoming more popular and prevalent every day. A full-blown industry has sprung up around them — an industry with agencies and companies dedicated to creating and managing them, with some of the top personas earning millions annually.

But our guest today has noticed a troubling pattern — many virtual influencers are crafted as young women of colour. And their creators are often men with



different racial identities who work at

marketing agencies.

Jul Parke is a PhD candidate at the University of Toronto's Faculty of Information specializing in social media platforms, digital racism, virtual influencers and AI phenomena. She is currently a visiting scholar at New York University. Parke's doctoral research explores what

motivates companies and creators to produce these virtual, racialized women, which she says is a new form of commercializing

gender and racial identity in digital spaces.
As we enter the era of AI proliferation, it seems virtual influencers are here to stay. There are at least 200 digital personalities out there today, and platforms like Facebook, Instagram and TikTok are rolling out

new tools that will enable everyday users to craft their own virtual personas.

Given the absence of laws for nonhumans, the rise of virtual influencers on social media raises a whole host of urgent ethical questions about authenticity online.

# **Working Memory Which Allows Multitasking Could Have Limits: Study**

orking memory, which allows one to juggle multiple tasks at the same time, may have its limits, according to a new study published in the journal eLife.

A learning process involving 'chunking' or grouping related pieces of information, rather than capacity, is the real driver of working memory, according to co-author of the study, Aneri Soni, agraduate student at Brown University, US.

The capacity of one's working memory -- how many tasks can be performed simultaneously -- is considered to be limited. However, there are competing theories as to why or how this might be true, the researchers said.

In this study, the team ran trials of everyday human tasks on a computer model of the basal ganglia and the thalamus -- brain regions relevant to the functioning of working memory. The model was shown multiple coloured blocks oriented in different directions and asked to recall which colored block was pointing in which direction. Over multiple trials, the

model learned how to strategically compress information and began chunking together similar colors, such as blue and light blue.

However, trials on the model without the ability to chunk, but with plenty of space to store items, showed that it was worse at both storing and retrieving the items,

the authors said.

The model did not seem to realise it had access to such a large amount of storage, they added.

The researchers found that a model that knew how to "chunk," or group related pieces of information, was able to strategically store information to its full stor-

"The simulations we ran show that if we held more than just a few items at a time, it becomes too dicult to learn how to manage so many pieces of information at once, such that the brain gets confused and can't use the information it does store," Soni said. Further, critical to learn-

ing is the brain chemical 'dopamine', which plays a role in producing motivation to learn and in consolidating newly learned information as memory.

The ndings could, therefore, help in understanding how learning is affected in disorders such as Parkinson's disease, attention decit hyperactivity disorder (ADHD), and schizophrenia, where dopamine production and regulation are known to be impaired.

In one of the experiments in this study, Soni altered a model to mimic what is known about dopamine levels in patients with Parkinson's disease, schizophrenia, and ADHD. When the model was challenged to perform the same commonly performed human tasks, the results

# 'New Cases Of Breast Cancer Could Be Up 38% By 2050 Globally Related Deaths By 68%'

By 2050, new cases of breast cancer and related deaths will have increased globally by 38 per cent and 68 per cent, respectively, disproportionately affecting countries with low human development index (HDI), a study has estimated.

Breast cancer is the most commonly diagnosed cancer and the leading cause of cancer-related death in women. HDI measures a country's overall quality of life after looking at aspects, including life expectancy, education levels, and standard of living.

Researchers, ing those from the International Agency for Research on Cancer -- WHO's cancer agency -- estimated current and projected burden, along with trends in breast cancer incidence and deaths over the past 10 years, in nearly 50 countries, using the GLOBO-CAN database.

The findings, published in the journal Nature Medicine, showed that only seven countries meet the World Health Organization's goal of reducing mortality by 2.5 per cent a year, including Denmark, Switzerland and the Netherlands.

The goal is outlined under the Global Breast Cancer Initiative (GBCI), launched

mortality. The authors found that there were 23 lakh new cases and 6.7 lakh deaths from

tries to lower breast cancer

breast cancer in 2022, globally. However, this was unevenly distributed, they said -- in regions low on the human development scores, people diagnosed with breast cancer disproportionately had the highest mortality rates.

For example, one's lifetime risk of being diagnosed with breast cancer was found to be highest in France (one in nine) and Northern America (one in 10), whereas the lifetime risk of dying from breast cancer was highest in Fiji (one in 24) and Africa (one in 47).

"By 2050, new cases and deaths will have increased by 38 per cent and 68 per cent, respectively, disproportionately impacting low-HDI countries," the authors wrote.

This translated to an estimated 32 lakh new cases and 11 lakh deaths in the year 2050, they said.

The authors said a sustained investment and improvements in early diagnosis and treatment are needed to address growing inequities in breast cancer survival globally.

They also called for highquality cancer data in countries with low and medium HDI to address inequities and monitor cancer control goals.

# Study Finds Possible Way To Heal Damaged Lungs After Premature Birth

esearchers have created 3D video images of mouse lung tissue grown in the laboratory using a four-dimensional microscopy technique. What they have learned has been nothing short of groundbreak-

A new study suggests that understanding resilience--the ability of injured lung tissue to heal and regenerate--may be key to advancing the treatment and prevention of life-threatening lung disease in extremely premature babies.

Using a four-dimensional microscopy technique, researchers at Vanderbilt University and Vanderbilt University Medical Center have created 3D video images



of mouse lung tissue grown in the laboratory.

"For the first time, we've been able to live-image the

lung as it forms, and quantify and measure those cellular gether to make an organ with a surface area large enough for gas exchange," said Jennifer Sucre, MD, associate professor of Pediatrics and Cell and Developmental Biology.

The group's findings. published Feb. 24 as the cover article in JCI Insight, the journal of the American Society of Clinical Investigation, represent a significant step toward improved treatment and prevention of bronchopulmonary dysplasia (BPD), which occurs in about 50% of infants born two to four months prematurely.

"If we can understand how the lung forms, then we have a blueprint for how to grow new lungs after injury," said the paper's first author. Nick Negretti, PhD, a senior postdoctoral fellow in the Sucre lab who co-led the research.

"Mice have an extraordinary ability to repair the lung," said Sucre, the paper's senior author, who directs the Biodevelopmental Origins of Lung Disease (BOLD) Center at VUMC. "I want to give babies the superpower of the mouse."

Premature babies with BPD require oxygen and mechanical ventilation in the early days after birth to help them breathe. Oxygen therapy is a double-edged sword because it also can damage delicate lung tissue.

The innovative technology implemented by the Sucre lab allows for testing and identification of the specific molecules and pathways that guide this process. It is also a discovery tool for drugs promoting tissue regeneration after injury.

# 8 Cities Saw 10% Rise In Housing Prices In Oct-Dec: Report

**NEW DELHI** -Housing prices appreciated at an average of 10 per cent during the December quarter across eight major cities on strong demand, higher input cost, according to a report by CREDAI, Colliers and Liases Foras.

Realtors' body CREDAI, real esconsultant Colliers India and data analytic firm "Interestingly, Liases Foras on average housing Tuesday released their joint report, which showed that prices have been on a rising Delhi-NCR saw a spree for the maximum appre-16th consecutive ciation of 31 pc annually during the October-December quarter, starting 2021" period of 2024.

"Interestingly, average housing prices have been on a rising spree for the 16th consecutive quarter, starting 2021," the report said.

The price appreciation was evident in all eight major cities. CREDAI National President Boman Irani said, "The sustained growth in housing prices underscores the strong confidence among homebuyers, driven by a preference for spacious

living and lifestyle upgrades."
"While evolving preferences
and lifestyle upgrades remain
key motivators, cost pressures

in construction and land acquisition are also significantly contributing to pricing trends," Irani said. Colliers India Chief Executive Officer Badal Yagnik believes 2025 may see similar increase in average prices across top eight cities.

Liases Foras Managing Director Pankaj Kapoor said sales witnessed a marginal decline, led by moderated new launches in

# India Imports 49 Bn Euro Worth Of Russian Oil In 3rd Year Of Ukraine Invasion

**NEW DELHI-** India, the world's third largest oil consuming and importing nation, bought crude oil worth 49 billion euros from Russia in the third year of Moscow's invasion of Ukraine, a global think tank said.

India, which has traditionally sourced its oil from the Middle East, began importing a large volume of oil from Russia soon after the invasion of Ukraine in February 2022. This is primarily because Russian oil was available at significant discount to other international benchmarks due to western sanctions and some European countries shunning purchases.

shunning purchases.

This led to India's imports of Russian oil seeing a dramatic rise, growing from less than 1 per cent of its total crude oil imports to a staggering 40 per cent in a short period.

"Russia's stronghold over new markets has solidified in the third year of the invasion. The three biggest buyers, China (EUR 78 billion), India (EUR 49 billion) and Turkey (EUR 34 billion) were responsible for 74 per cent of Russia's total revenues from fossil fuels in the third year of the invasion," Centre for Research on Energy and Clean Air said in its latest report.

The value of India's import saw an 8 per cent yearon-year increase, it said. Russia's total global fossil fuel earnings in the third year



of the invasion reached 242 billion euro and have totalled 847 billion euro since the invasion of Ukraine.

Some of the refineries in India turned Russian crude oil into fuels like petrol and diesel that were exported to Europe and other G7 countries.

rope and other G7 countries.
"In the third year of the invasion, G7+ countries imported EUR 18 billion of oil products from six refineries in India and Turkey that process Russian crude. An estimated EUR 9 billion of this was refined from Russian crude," the CREA report said.

In the first three quarters of 2024, as refineries in India and Turkey increased their consumption of Russian crude, the volume of Russian crude used to create products for G7+ countries jumped by an estimated 10 per cent. Concurrently, this also contributed to a rise in the price of Russian oil, boosting the value of the crude used for these exports by an estimated 25 per cent. it said.

per cent, it said. The EU is the biggest importer of oil products from India's and Turkey's refineries. On average, 13 per cent of these refineries' total production is targeted towards exports for the bloc in the third year of the invasion.

The top-five importers within the EU were the Netherlands (3.3 billion euro), France (1.4 billion euro), Romania (1.2 billion euro), Spain (1.1 billion euro), and Italy (949 million euro). The single-biggest buyer was Australia, whose imports from these refineries totalled 3.38 billion euro in the third year of the invasion.

In the third year of the invasion, 23 per cent of the oil transshipped in EU waters was destined for China, 11 per cent for India, 10 per cent for South Korea, and 2 per cent for Turkey, with the remainder distributed among other markets.

"CREA's data shows that from February to September 2024, 331 shipments arriving in India's Sikka port (in Gujarat) averaged USD 90.8 per barrel," it said.

# Gold Jumps ₹250 To ₹89,350 Per 10g Amid Rupee Depreciation

**NEW DELHI-** Gold prices jumped by Rs 250 to Rs 89,350 per 10 grams on Tuesday extending gains for the second day amid depreciation in rupee, according to the All India Sarafa Association.

The gold of 99.5 per cent purity rose by Rs 250 to Rs 88,950 per 10 grams from the previous close of Rs 88,700 per 10 grams.

On February 20, gold of 99.9 per cent and 99.5 per cent purity hit all-time highs of Rs 89,450 and Rs 89,050 per 10 grams, respectively.

However, silver prices slipped below the Rs 1 lakh mark, falling by Rs 500 to Rs 99,500 per kg. "Silver fell due to weakness

in the industrial metals and rebound in the dollar index. Global equity markets are also struggling due to Trump's tariff fears and pressure on industrial metals but reversal in the US Treasury yields could support silver prices at lower levels," Rahul Kalantri, VP Commodities at Mehta Equities Ltd, said.

On Tuesday, the rupee fell sharply by 51 paise to settle at 87.23 (provisional) against the US dollar due to month-end dollar demand by importers amid uncertainty over US trade tariffs.

In futures trade on the Multi Commodity Exchange (MCX),



gold contracts for April delivery appreciated by Rs 275 to Rs 86,459 per 10 grams.

"Gold traded positively in MCX as rupee weakness below 87.10 provided support to domestic prices. Meanwhile, Comex gold remained rangebound between USD 2,930 and 2,955, continuing its consolidation phase over the past few sessions," Jateen Trivedi, VP Research Analyst - Commodity and Currency at LKP Securities, said.

On the other hand, silver futures for March delivery increased by Rs 241 to Rs 95,330 per kg on the commodities bourse.

According to HDFC Securities' Senior Analyst of Commodities Saumil Gandhi, traders will be awaiting the macro data, including the CB Consumer Confidence Index and the Richmond manufacturing index to be release later on Tuesday, along with some of the US Federal Reserve members speech which will provide trajectory for the bullion prices.

# US Sanctions 4 Indian Firms For 'Involvement' In Iran's Oil Industry

WASHINGTON- Four Indian companies are among 16 firms sanctioned by the US on Monday for their alleged involvement in Iran's petroleum and petrochemical industry.

According to a press release issued by the treasury department, the sanctioned Indian firms are Austinship Management Pvt Ltd, BSM Marine LLP, Cosmos Lines Inc, and Flux Maritime LLP.

This marks the second round of sanctions targeting Iranian oil sales since President Donald Trump issued a national security memorandum on Feb 4, ordering a campaign of maximum pressure on Iran, the state department said in a press statement.

"The US Department of State is today designating 16 entities and vessels for their involvement in Iran's petroleum and petrochemical industry," the statement said.

The Department of State, along with the Department of the Treasury's Office of Foreign Assets Control (OFAC),

also imposed sanctions on 22 individuals and identified 13

vessels as blocked property across multiple jurisdictions for their involvement in Iran's oil industry.

"This network of illicit shipping facilitators obfuscates and deceives its role in loading and transporting Iranian oil for sale to buyers in Asia. It has shipped tens of millions of barrels of crude oil worth hundreds of millions of dollars. Today's action represents an initial step to realise President Trump's campaign of maximum pressure on the Iranian regime. It disrupts efforts by Iran to amass oil revenues to fund terrorists' activities," the statement said.

# RBI Lowers Risk Weight for NBFC, Microfinance Loans - Boosting Credit

MUMBAI- The Reserve Bank on Tuesday lowered risk weights for bank finance to NBFCs and microfinance loans, a move that will unlock more funds and boost credit.

A lower risk weight means that lenders need to set aside less funds as a safety net for consumer loans, implying an increase in their lending capacity. Both NBFCs and microfi-

nance institutions have witnessed a slow down in their lending after the central bank tightened lending norms by raising the risk weight in November 2023.

The risk weight on the exposures of commercial banks to NBFCs was increased by 25 percentage points (over and above the risk weight associated with the given external rating) in all cases where the extant risk weight as per external rating of NBFCs was below 100 per cent.

"On a review, it has been decided to restore the risk weights applicable to such exposures...," the RBI said in circular.

In another circular, the RBI said it has reviewed risk weights on microfinance loans. In November 2023, the risk weights on consumer credit

weights on consumer credit, including personal loans, but excluding housing loans, education loans, vehicle loans and loans secured by gold and gold jewellery, too was increased to 125 per cent.

"On a review, it has been decided that microfinance loans in the nature of consumer credit shall also be excluded from the applicability of higher risk



weights specified in the circular ibid and shall accordingly, be subject to a risk weight of 100 per cent," RBI said in another circular.

The central bank further clarified that microfinance loans which are not in the nature of consumer credit and fulfil certain criteria may be classified under regulatory retail portfolio (RRP) provided that the banks put in place appropriate policies and standard operating procedures to ensure fulfilment of the qualifying foresteened as a standard operation.

Also, microfinance loans extended by regional rural banks (RRBs) and local area banks (LABs) shall attract a risk weight of 100 per cent, the RBI said.

As per the MFIN data for the

As per the Mrin data for the third quarter of the fiscal, the portfolio has declined by 3.53 per cent on year on year basis, amounting to Rs 3,85,348 crore.

"It is a welcome move in view of the current headwinds faced by the sector; this shall to an extent provide some relief to the players and facilitate credit flow to a broader set of players than what was witnessed in the recent past," Anil Gupta, Senior Vice President Co Group Head - Financial Sector Ratings, ICRA, said.

# **STD Urges Taxpayers To Follow Fair-Trade Practices**

As part of its ongoing drive to check the practice of conversion of B2C invoices into B2B and passing on fake ITC to dealers especially those registered as work contractors, Jammu and Kashmir, State Taxes Department (STD) conducted simultaneous search and seizure inspections at various locations across Jammu division

The Department has urged the dealers to follow fair-trade practices and avoid indulging in tax evasion activities or fraudulent practices involving fake ITC as it is continuously monitoring such actions through AI based data analytics tools and any dealer indulging in such activities shall be dealt with seriously under GST law.

The department made an appeal to all the taxpayers to practice invoice-based business and report their actual sales and pay the necessary amount of GST in their monthly/quarterly returns to avoid enforcement actions and penalties.

The Department has impressed upon the taxpayers that any fraudulent activity is generating red flag inputs in various AI tools including Business Intelligence and Fraud Analytics (BIFA), E-way Bills Portal and other portals of enforcement wings and therefore need to be avoided.

The entire drive was carried out under the guidance of Commissioner State Taxes J&K, P K Bhat and under the supervision of Additional Commissioner Enforcement and Administration Jammu, Namrita Dogra.

#### State Taxes Deptt Busts Fake Input Tax Credit Case; Realizes Penalty Of Rs 11, 18, 068

In a major enforcement action, the team from Enforcement South Kashmir of State Tax Department has realized a huge penalty of Rs 11,18,068 from a tax payer carrying rigid tubes, pipes, hoses, and fittings made of propylene polymers in violation of GST regulations.

Acting on specific intelligence input, the enforcement team laid a special Naka and intercepted a vehicle in violation of GST norms by passing fake Input Tax Credit (ITC) without actual movement of goods in which 03 taxpayers were involved.

During investigation it was found that a Delhi based firm generated 02 e-invoices and E-Way bills worth Rs 73,29,554 in favour of two taxpayers but was carrying goods of Rs 36,64,777 only.

# Federal technology staffers resign rather than help Musk, DOGE

Washington, Feb 25 (AP) More than 20 civil service employees resigned Tuesday from billionaire Trump adviser Elon Musk's Department of Government Efficiency, saying they were refusing to use their technical expertise to "dismantle critical public services".

"We swore to serve the American people and uphold our oath to the Constitution across presidential administrations," the 21 staffers wrote in a joint resignation letter, a copy of which was obtained by The Associated Press. "However, it has become clear that we can no longer honour those commitments."

The employees also warned that many of those enlisted by Musk to help him slash the size of the federal government under President Donald Trump's administration were political ideologues who did not have the necessary skills or experience for the task ahead of them.

The mass resignation of engineers, data scientists and product managers is a temporary setback for Musk and the Republican president's techdriven purge of the federal workforce. It comes amid a flurry of court challenges that have sought to stall, stop or unwind their efforts to fire or coerce thousands of government workers out of jobs.

In a statement, White House secretary Karoline Leavitt was dismissive of the mass resignation.

"Anyone who thinks protests, lawsuits, and lawfare will deter President Trump must have been sleeping under a rock for the past several years," Leavitt said. "President Trump will not be deterred from delivering on the promises he made to make our federal government more efficient and more accountable to the hardworking American taxpayers."

The staffers who resigned worked for what was once known as the United States Digital Service, an office established during President Barack Obama's administration after the botched rollout of Healthcare.gov, the web portal that millions of Americans use to sign up for insurance plans through the Democrat's signature health care law.

All had previously held senior roles at such tech companies as Google and Amazon and wrote in their resignation letter that they joined the government out of a sense of duty to public service.

Trump's empowerment of Musk upended that. The day after Trump's inauguration, the staffers wrote, they were called into a series of interviews that foreshadowed the secretive and disruptive work of Musk's' Department of Government Efficiency, or DOGE.

According to the staffers. people wearing White House visitors' badges, some of whom would not give their names, grilled the nonpartisan employees about their qualifications and politics. Some made statements that indicated they had a limited technical understanding. Many were young and seemed guided by ideology and fandom of Musk - not improving government technology.

"Several of these interviewers refused to identify themselves, asked questions about political loyalty, attempted to pit colleagues against each other, and demonstrated limited technical ability," the staffers wrote in their letter. "This process created significant security risks."

Earlier this month, about 40 staffers in the office were laid off. The firings dealt a devastating blow to the government's ability to administer and safeguard its own technological footprint, they

# South Korea's Yoon defends his martial law decree as impeachment trial nears end

Seoul, Feb 25: In a final statement at his impeachment trial. South Korean President Yoon Suk Yeol defended his martial law decree that plunged the country into chaos as a bid to inform the public of the danger of the opposition-controlled parliament as he vowed Tuesday to push for political reform if reinstated.

spoke Yoon Constitutional Court as it wrapped up arguments in his impeachment trial. The court is expected to rule by mid-March on whether to remove Yoon from office or reinstate his presidential powers.

The liberal opposition-controlled National Assembly impeached Yoon, a conservative, after his short-lived Dec 3 martial law decree caused political turmoil, rattled its financial markets and hurt its international image. He has been separately arrested and indicted on rebellion charges in connection with his decree. If convicted, he would face the death penalty or life imprisonment.

Yoon has denied any wrongdoing and blamed the main liberal opposition Democratic Party, which obstructed his agenda, impeached many senior officials and slashed key parts of the government's budget bill, for the political crisis. During his marital law announcement, Yoon called the assembly "a den of criminals" and "anti-state forces."

"The reason why I declared martial law was because of desperation as I could no longer neglect a do-or-die crisis facing this country," Yoon said. "I tried to inform the people of these anti-state acts of wickedness by the mammoth opposition party and appealed to the people to stop it with intense surveillance and criticism."

After declaring martial law,



Yoon sent troops and police officers to the assembly, but enough lawmakers still managed to enter an assembly chamber to vote down Yoon's decree unanimously, forcing his Cabinet to lift it.

Yoon reiterated Tuesday that he had no intentions of disrupting assembly work and that deploying troops and police was meant to maintain order. But some commanders of military units sent to the assembly have testified that Yoon ordered them to drag out lawmakers to prevent them from overturning his decree.

During Democratic Party lawmaker Jung Chung-rai said that Yoon must be dismissed as he undermined the constitution by trying to seal the assembly and suppress its authority with armed troops. Jung also said Yoon's imposition of martial law disturbed public order because South Korea wasn't in an emergency that required such a drastic step.

"Yoon Suk Yeol is still refusing to have self-reflection and soul-searching and repeating sophistry and crafty remarks that say his emergency martial law was a high-level act of governance," Jung said. "We should dismiss him as soon as possible to get the Republic of Korea back on track.

Massive rallies by opponents

and supporters of Yoon have divided the streets of Seoul and other major South Korean cities. Whatever the Constitutional Court decides, experts say it will likely further polarise the country and intensify its conservative-liberal divide. If Yoon is formally thrown out of office, a national election must take place within two months to

find his successor. During more than an hour of testimony Tuesday, Yoon said he would push for political reforms and a constitutional revision to change the current presidential system if he regains his presidential powers. He also suggested stepping down before his single five-year term ends in 2027 to promote "political reform".

It's unclear whether and how Yoon's statement could affect the court's ruling.

South Korea adopted the current system that limits a president to a single five-year term in 1987, following decades of military-backed dictatorships. After Yoon's martial law stunt, there have been calls to change it. Some favour a parliamentary Cabinet system, others want a US-style setup in which a president can run for a second fouryear term or a system in which a president and prime minister split key responsibilities.

# Syria's national dialogue conference held as battered country seeks to rebuild

Damascus, Feb 25: yria's new rulers held a long-awaited national dialogue in the country on Tuesday after the fall of former President Bashar Assad and nearly 14 years of civil war.

About 600 people from across Syria were invited to the gathering in the presidential palace in Damascus, hosted by the new authorities led by the Islamist former insurgent group Hayat Tahrir al-Sham, or HTS. The group led the offensive that ousted Assad in December.

"Just as Syria has liberated itself by itself, it is appropriate for it to build itself by itself," interim President Ahmad al-Sharaa told the conference.

"What we are experiencing today is an exceptional and rare historical opportunity in which we must use every moment to serve the interests of our people and our nation and honour the sacrifices of its children," he said.

Syria's new rulers have promised an inclusive political transition. They will be closely watched by Syrians and the international community, including countries weighing whether to lift sanctions imposed during Assad's authoritarian rule.

Syria faces major chal-lenges, from rebuilding an economy and war-wrecked infrastructure to setting up a new constitution and justice mechanisms for those accused of war crimes.

# Federal employees may get more demands to justify their work at Elon Musk's direction

Washington, Feb 25: The turmoil that enveloped the federal workforce over the last few days is unlikely to cease anytime soon as the US government's human resources agency considers how to fulfil Elon Musk's demands.

The Office of Personnel Management told agency leaders Monday that their employees did not have to comply with a Musk-inspired edict for workers to report their recent accomplishments or risk getting fired. But later that evening, OPM sent out another memo suggesting that there could be similar requests going forward - and workers might be sanctioned for

noncompliance.

"Agencies should consider whether the expectation for employees to submit activity and/or accomplishment bullets should be integrated into the agency's Weekly Activity Report," wrote acting director Charles Ezell. He added that "agencies should consider any appropriate actions regarding fail to respond to activity/ac-

complishment requests." OPM originally sent employees an email over the weekend with the subject line "what did you do last week?" Recipients were asked to respond with "approx 5 bullets of what you accomplished".

White House press secretary Karoline Leavitt said more than 1

million employees had responded, which would be less than half of the estimated 2.4 million people in the federal workforce, according to US statistics. She said the idea for the request came from Musk, who used similar management tactics at his own companies, and she said that the administration was "working as

Federal workers faced conflicting directions on whether to respond. One employee, who requested anonymity out of fear of retaliation, was told to expect guidance that the request was optional. But when that never came. the employee sent in bullet points to avoid possible repercussions.

Musk continued to press the issue

on X, his social media platform, and criticized people in the administration that stood in his way.

"The email request was utterly trivial, as the standard for passing the test was to type some words and press send!" he wrote. "Yet so many failed even that inane test, urged on in some cases by their managers."

The billionaire entrepreneur, who serves as President Donald Trump's most powerful adviser. also suggested that he's being held back from even more dramatic reductions in government spending.

t's "a had thing" that Trumn has given Musk a prominent role in his administration, according to CNN polling from last week. Only a third saw it as "a good thing".

Another survey by The Washington Post and Ipsos found that Americans are divided on whether Musk is mainly cutting wasteful spending or necessary programs, with about a third following into each camp. Another quarter said they're not sure.

Rep Lisa McClain, a Michigan Republican, said Tuesday that her party was only delivering what voters asked for in the last election. "We got our marching orders.

We listened to the American people," she said. "And told us they wanted change. And buckle up, because that's exactly what we're giving them." Alina Habba, a former mem-

ber of Trump's personal legal team who now serves as a counsellor in the White House, told reporters that the government workforce needed to get on board with the president's goals.

# Bruised England, Afghanistan Eye Win To Stay In Champions Trophy

**LAHORE:** A battered England will hope to keep their Champions Trophy hopes alive when they face a dangerous Afghanistan in a crucial group B match here on Wednesday.

A defeat here would severely dent both the teams' dreams of a semifinal berth in the tournament, as South Africa and Australia have already notched up two points.

The days of England's white ball supremacy are far behind now, as the former world champions' creaking unit even failed to defend a 350-plus total against Australia in their tournament opener.

While England may take some comfort in posting a massive total, the reality is that it came against an Australian side missing their premier pacers – Pat Cummins, Mitchell Starc, and Josh Hazlewood.

The English bowlers then



failed to stop an Australian lineup that did not have lead batters such as injured Mitchell Marsh and now-retired Marcus Stoinis.

So, England will need to show massive improvement against Afghanistan on both those counts.

Afghanistan's three-pronged spin attack, consisting Rashid

Khan, Noor Ahmad and Mohammad Nabi, has the potential to trouble even the best, and England batters' recent outings against slow bowlers are not confidence inspiring either.

England also suffered a setback as all-rounder Brydon ings Carse has been ruled out of the tournament with a toe injury. off-

He has been replaced by legspinner Rehan Ahmed in an effort to strengthen their spin department.

This move will also provide Adil Rashid with proper backing, as, until now, Liam Livingstone had been performing that role with his mixed bag of off-spin, leg-spin, and seam-up deliveries.

But England's real problem lies in the patchy form of opener Phil Salt and Harry Brook in the middle-order.

Salt's only hundred in the format was in 2022 and since then the Welshman has not really converted his starts, often getting out after a quick 30 or 40.

The Afghans, on the other hand, have their own problems to tackle. They are coming off a 107-run shellacking by South Africa in their tournament opener.

They had reached the semifinals of the T20 World Cup 2024 with almost the same set of players but the ODI format demands much more consistency in performance and execution of strategies.

Afghanistan have the required talent but they need to find a way to channelise that consistently to challenge England, even in their most vulnerable state.

Match starts at 2.30 pm IST.

"We are cricket players, we are sportspersons, we are sportsmen. So, we control what we can do inside the ground. So, we don't worry about what's happening out of the ground. And that cannot do anything to our confidence.

"We play hard, we work hard, we have good net sessions. So that's what we're thinking of and we only can do what we can do in the ground," said the left-handed batter.

Afghanistan had sent ripples in the cricketing world by upsetting Jos Buttler's England by 69 runs in the 2023 Cricket World Cup in India and Shahidi expressed confidence going into the match on Wednesday despite an opening loss to South Africa by 107 runs.

Tournament hosts Pakistan and Bangladesh were knocked out of the event on Monday after suffering two successive defeats.

#### Pakistan Will Find It Hard To Beat India's B Team: Gavaskar

Pakistan's cricket team continued to invite scathing criticism a day after being knocked out of the Champions Trophy with the great Sunil Gavaskar saying that it would struggle to beat even a second-string Indian team.

India, the 2023 ODI World Cup finalists, defeated defending champions Pakistan by six wickets in the Champions Trophy in Dubai on Sunday, continuing their dominance over the arch-rivals.

"I think a B team (from India) certainly (can give Pakistan a run for their money). C team, I am not too sure. But a B team will be very, very hard to beat for Pakistan in their current form," Gavaskar said on

Pakistan, hosting an ICC tournament for the first time since 1996, were knocked out of the Champions Trophy after New Zealand beat Bangladesh in another Group A match. Pakistan are still winless in the event.

Since winning the Champions Trophy in 2017, Pakistan's cricketing fortunes have declined, with the team finishing fifth in the last two ODI World Cups.

# **Shubham Gill The Next Best, Big Thing: Hashim Amla**

South Africa batting great Hashim Amla on Tuesday labelled India opener Shubman Gill, who has had an "exceptional" start to ODIs, as the "next big thing" in international cricket along with Rishabh Pant and Ryan Rickelton.

The 25-year-old Gill, named India's vice-captain for the Champions Trophy, began with a match-winning century against Bangladesh and struck a vital 46 against Pakistan. "For India, you have got Shubham Gill; Rishabh Pant has been around for a while. For South Africa, we have Ryan Rickelton who has done really well off late," Amla said.

"Every country has about 2-3 cricketers who are going to come through and I think that's pretty normal, that you see that every five years some youngster poke in the head through international cricket, and possibly be the next best, big thing," he added.

#### 'Mbappé Available For Copa Semifinal Despite Tooth Problem'

Vilian Mbappé missed practice because of a tootly problem but will be available to play for Real Madrid in the Copa del Rey semifinal against Real Sociedad, coach Carlo Ancelotti said Tuesday.

Arsenal's chances of a first top-flight champion-ship since 2004 were massively damaged, though, on a sobering weekend when Arteta's second-place team stumbled to a 1-0 home loss to West Ham on Sat-



urday and first-place Liverpool won 2-0 at Manchester City on Sunday.

Just when there seemed to be life in the title race, Liverpool powered into an 11-point lead over Arsenal — having played one game more — and is reaching the end of a difficult run of five league games in a 15-day stretch culminating in a home match against New-

castle on Wednesday.

On the same night, Arsenal visits third-place Nottingham Forest and will still be without its four best attacking players — Bukayo Saka, Kai Havertz, Gabriel Martinelli and Gabriel Jesus — because of injury. Another absentee will be left back Myles Lewis-Skelly, who is suspended after his red card against West Ham.

Arsenal has received five red cards this season, two more than any other team.

Given the circumstances, Arteta said his players "probably have to do something nobody else has done in the history of the Premier League" to win the title this season.

"If somebody tells you at the start of the season that by this time, you have played five times with a red card over half an hour in each of those games, and you have lost this amount of players, what's the bet? You are in the middle of the table, at least, and you are out of the Champions League," Arteta said.

"That's not the situation. So that tells you the resilience, the resources, the ambition that the team has, every individual has, and that has been probably one of the proudest moments in my time working (here)."

# Galatasaray, Fenerbahce Spat Over Mourinho's Alleged Racist Comments

ISTANBUL: Galatasaray plans to start criminal proceedings against Jose Mourinho and file complaints with soccer's governing body after accusing the Fenerbahce coach of making racist comments after a Turkish league game.

The league leaders issued a statement after Monday's 0-0 draw with Fenerbahce announcing the action against Mourinho, the 62-year-old Portuguese coach who moved to Turkey from Roma last year after stints at high-profile clubs including Chelsea, Manchester United, Real Madrid and Inter Milan.

Fenerbahce rejected the accusation on Tuesday, saying the remarks had nothing to do with racism and were "deliberately taken entirely out of context and distorted in a misleading manner."



Mourinho was fined and suspended earlier in the season for a tirade against local match officials and the league. His comments regarding Turkish referees and the Galatasaray bench following Monday's match between the top two teams in the domestic league sparked further criticism.

In a statement, Galatasaray said Mourinho had "persistently issued derogatory statements directed towards the Turkish people."




