

A Breather: J&K's Rainfall Deficit Drops To 69%

More Rain, Snow Till Feb 28

Srinagar: The fresh spell of precipitation has brought down the rainfall deficiency by 14 per cent as the deficit rainfall has reduced from 83 per cent last week to 69 per cent till Wednesday.

Major precipitation has been recorded at Kargil station in Ladakh as well as Rajouri and Poonch districts in Jammu division over the last one week. After zero rainfall in the first 50 days of this year, Kargil recorded 16.4 mm rainfall against the normal precipitation of 25 mm in the last 57 days of 2025.

The precipitation deficit has reduced from above 70 per cent to 50 per cent in Rajouri and Poonch districts of Jammu division,

reveals data. In the entire Jammu and Kashmir, the defi-cit rainfall has reduced to 69 per cent compared to 83 per cent last week. According to data, against the normal precipitation of 215.5mm, the region recorded a rainfall of 65.8 mm from January 01, 2025, to February 26, 225.

However, other districts of Jammu and Kashmir despite witnessing a reduction in the precipitation deficiency continued to be categorised in the large deficiency list. The data | More on P6

J&K Assembly Gears Up For Crucial Budget Session

Srinagar: Preparations are underway for the highly anticipated Budget Session of the Jammu and Kashmir Legislative Assembly, which is set to begin on March 3, 2025. The session will be inaugu-

rated by Lieutenant Governor Manoj Šinha in Jammu, who is expected to address the mem-bers and present the government's vision for the upcoming fiscal year. According to officials, exten-

sive arrangements have been made to ensure the smooth conduct of the session. Security measures have

been heightened around the legislative complex, and essential infrastructure upgrades are being completed to accommodate the participants.

The session, which will include key financial discussions and deliberations on the budget, is expected to be crucial for the Union Territory.


The Budget Session comes at a time when the Jammu and Kashmir administration is

The J&K Reorganisation Act, 2019, empowers the Lieutenant Governor to nominate two women to the Assembly if female representation is deemed insufficient. Additionally, a 2023 amendment allows for the nomination of three more members-two from the Kashmiri migrant community, including one woman, and one representing displaced persons Pakistan-occupied from Jammu and Kashmir (PoJK).

Despite this legal framework, the nomination process remains in limbo. Government insiders suggest that discussions on the matter have stalled, with no clear directive on whether the nominations should be made solely by the LG or on the advice of the elected government. | More on P6

J&K Targets 2200 MW Power Boost by 2030

Srinagar: Jammu and Kashmir has informed Central Electricity Authority (CEA) that it has planned an additional 2200 Megawatts (MWs) of power till 2030.

This includes nearly 1,000 MWs of coal and solar energy with the officials saying that "Last JKPDD has already entered a Power Purchase Agreement (PPA) of coal-based power of over 390 MWs under Shakti Policy."

The official documents ac-cessed by the news agency– Kashmir News Observer (KNO) reads, "According to the data provided by Jammu and Kashmir, an additional 392 MW of Coal (Shakti Scheme), 620 MW of solar and 1206 MW of hydro is planned till 2030."

It also said that Jammu and Kashmir being a hilly state, the share of Distributed Renewable Energy (DRE) in the Renewable Purchase Obligation (RPO) trajectory has been taken as half of the share as stipulated in RPO-2023. "The other half of the DRE component has been considered to be met from RE general and from other sources."



Jammu: The Jammu and Kashmir Home Department has issued a notification under the Bharatiya Nagarik Suraksha Sanhita, 2023, defining "audio/ video electronic" evidence for official use.

As per an order, recordings from mobile phones, tablets, CCTV cameras, body-worn cameras, and other digital equipment used by authorized police officers will be considered valid.

Additionally, any electronic device authorized by the Police or Home Department will also be recognized. Officers assigned ICJS/CCTNS IDs will be deemed authorized to handle such evidence.

Centre to SC: Life Ban on Convicted Lawmakers Too Harsh

Srinagar: The Centre has opposed in the Supreme Court a plea seeking life ban on convicted politicians, saying imposing such a disqualification was solely within the domain of Parliament.

The centre argued before the Supreme Court that such a disqualification, extending beyond the current six-year period after serving prison sentences, would be "unduly harsh".

In an affidavit filed in court, the Centre said the prayer in a plea, seeking the same, amounted to re-writing of the statute or directing Parliament to frame a law in a particular manner which was wholly beyond the powers of judicial review.

"The question whether a



life-time ban would be appropriate or not is a question that is solely within the domain of the parliament," the affidavit said.

By confining the operation of penalty to an appropriate length of time, deterrence was ensured while undue harshness was avoided, it added.

There was, said the Centre,

nothing inherently unconstitutional in limiting the effect of penalties by time and it was a settled principle of law that penalties were limited either by time or by quantum.

"It is submitted that issues raised by the petitioner have wide ranging ramifications and clearly fall within the legislative policy of Parliament and the contours of judicial review would be suitably altered in such regard," the affidavit said.

The plea in the top court filed by advocate Ashwini Kumar Upadhyay seeks a life ban on convicted politicians aside from the expeditious disposal of criminal cases against MPs and MLAs in the country. In its affidavit, the Centre underlined that the apex court

Terrorists Fire At Army Vehicle In Rajouri

Jammu: An army vehicle came under fire from suspected terrorists in a forward village near the Line of Control in Jammu and Kashmir's Rajouri district on Wednesday, officials said.

There were no immediate reports of any casualties in the brief firing near Phal village in the Sunderbani sector, they said.

They added that the terrorists, believed to be hiding in a forest, fired a few rounds at the army vehicle passing through the area -- considered a traditional infiltration route for militants.

The troops returned fire while reinforcements were rushed to neutralise the terrorists, the officials said.

Why Do We Fall For Wellness Scams? Our **Cultural Biases, Myths Often To Blame**

etflix's Apple Cider Vinegar has renewed interest in Belle Gibson's infamous wellness scam, reminding us how vulnerable we can be to deception. While Gibson's scheme eventually collapsed, her story highlights how fraudsters can exploit our psychological and cultural biases to lure us into wellness traps. Part of our culture includes the shared mythologies and symbols that help us make sense of the

world. These stories and symbols seem to make our lives more "efficient" by surpassing tedious factchecking. Over time, these cultural codes

become embedded into our psy-chologies, operating as back-ground biases that shape our decision-making. By becoming aware of these bias-

es, we can develop a more critical approach to evaluating information presented to us. In doing so, we can protect ourselves from the Belle Gibsons of the world.

A desire for inner bodily purity

One pervasive wellness mythology suggests health can be found in the "pure" state of the body, and that illness occurs when outside contaminants pollute the body. As anthropologist Mary Douglas notes, we symbolically equate the "inner" with purity and the "out-er" with pollution. This leads to efforts to protect ourselves from outside threats. We are disgusted by the idea of the harmful "outside" getting inside and violating the body's inner sanctum. Gibson's cookbook and app promoted a diet that claimed inner

health problems (such as cancer) are the result of outside contamination, in this case by "bad" foods. This symbolism also appears in various diets that advocate for removing certain types of food, such as sugar or gluten, to achieve a state of inner sanctity and, there-

fore, health.

Suspicion of industrial-scale production

Our minds are often suspicious of large-scale and complex manufacturing processes, and will often devalue industrially produced products. This scepticism of scale stems from negative associations with factory work, questionable standards and a history of multinational corporations prioritising profit over people.

As a public, we are growing understandably weary of the multinational companies whose influence we can't seem to escape. Politicians often further this narrative by claiming that globalisation replacing local cottage industries with industrialised mega-companies – screws the little guys like you and me.

Gibson capitalised on a growing suspicion of the industrial-scale pharmaceutical industry to promote her bespoke "homegrown" wellness products. Locally-made goods often have increased value simply because they are made on a smaller scale, regardless of their quality or materials.

Historically, various groups including the Luddites and the hippie movement have rejected the industrial push. More recently, we saw these dynamics play out in COVID-19 vaccine denial, which partially stems from suspicions of the pharmaceutical companies.

A preference for natural over artificial

Culturally, the concept of the "natural" holds powerful meaning, positioning things found in nature as inherently superior to those manufactured by humans (deemed "artificial").

This natural/artificial dichotomy establishes a symbolic framework in which natural remedies, raw foods and authenticity represent the "proper" order of things - how life should be.


The "appeal to nature" bias persists because it resonates with our collective intuition that modern life has somehow disconnected us from important truths or healthier ways of living. Research has demonstrated we

tend to have a positive association with the concept of the "natural", which we understand as objects not altered by human intervention. This preference isn't merely aesthetic. It also reflects our belief in a moral order.


Gibson famously claimed alternative therapies - most notably apple cider vinegar - helped treat her alleged cancer. Similar patterns appear throughout the wellness industry, where influencers and companies market products by emphasising their natural origins and minimal processing.

These claims leverage our psychological bias toward natural remedies, even when the scientific evidence for their efficacy is lacking.

The findings, published in the American Journal of Psychiatry, provide a neurobiological basis for the mental disorder, which is marked by an impaired ability to perceive reality and delusional beliefs.

Researchers at the University of Zurich, Switzerland, stated that about 80 per cent of people with schizophrenia display impaired cognitive functioning. Symptoms can include hallucinations and highly disorganized behavior that may appear bizarre or purposeless.

The symptoms also vary greatly between individuals. For some patients, disturbances in perception are the main problem, while for others, cognitive impairments are more prevalent, the team said.

"In this sense, there is not one schizophrenia, but many, each with different neurobiological proles," said rst author Wolfgang Omlor, a senior physician at the University Hospital of Psychiatry Zurich.

However, the review found a uniform pattern of brain folding in the mid-frontal region -- responsible for attention, working memory, and language -- that suggested a developmental trait common to people with The symptoms also vary greatly between individuals. Brain folding occurs in the cerebral cortex, the outer layer of the brain, which is responsible for higher cognitive functions, such as decision-making and attention. More folding is linked with more advanced and complex cognitive abilities.

Because brain folding is largely completed in early childhood, brain development during this period appears to be less exible in schizophrenia patients, particularly in areas responsible for linking thinking and feeling processes, the team said.

They also observed differences in brain structures of the patients, which could reect the varying symptoms they might experience.

Downtown Residents Demand Fire Safety Measures

Srinagar: Amid rising fire incidents in Srinagar, particularly in the congested Downtown area, residents have urged authorities to make fire extinguishers mandatory in homes and conduct regular fire safety audits to prevent disasters.

Residents from various parts of Downtown said that due to closely packed wooden houses and narrow lanes, even a small fire quickly turns into a major disaster. "We have witnessed

multiple fire incidents in Srinagar recently, causing huge property damage. The houses here are built close to each other, and fires spread within minutes," said Bilal Ahmad, a resident of Nowhatta.

🔌 κο νιέψ Jamaat's New Avatar?

he decision of Jamaat-i-Islami leaders who unsuccessfully contested last year's Assembly election to float a new political party has generated some interest in the Valley. Named as the Justice and Development Front (JDF), the party will contest the upcoming grassroots elections. It will be the third new political party in Kashmir since the abrogation of Article 370 in August 2019. First two were the April Party led by Altaf Bukhari and the Democratic Progressive Azad Party (DPAP) founded by the former Congress veteran Ghulam Nabi Azad. Both of them have not been able to make any mark since their advent. In fact, the DPAP has all but disappeared from the political scene and Azad has almost retired from politics. Jamaat contestants in last year's election too couldn't win a single seat despite initial excitement. Except for Sayar Ahmad Reshi who polled 25000 votes in Kulgam, others were defeated by heavy margins.

Now, the question arises whether a new party could help these candidates. It may or may not do. There are no guarantees in politics. The USP of being a Jamaat-i-Islami is its religio-political agenda and its loyal cadre. Also, if we go by the Jamaat's history, the party despite its religious image hasn't only been about the religion. Jamaat schools were and continue to be forward-looking in matters of education. While religious instruction in these schools is a must, it is not the paramount and exclusive focus of education like the madrassas that sprang up in hundreds across the Valley through the nineties. Long before madrassas started turning out youth with knowledge restricted to religion, Jamaat produced doctors and engineers, scientists and academicians, even administrators, some of whom occupy posts in the higher echelons of the state bureaucracy.

Would this history and the background transfer to the JDF? Again, it may or may not happen. Over the last three decades of Jamaat's absence from electoral politics, generations have grown without any familiarity with Jamaat. They will find it difficult to relate to Jamaat, let alone a party with a purported connection to the parent organization. Anyways, the new party seems to have no connection to the parent in terms of its ideological leanings. Going forward, the JDF is likely to be judged on its own merits, and how best its leaders retain draw on Ja-

Can Kashmir Still Produce Great Works?

hen prejudice masquerades 'intellect' and 'analysis' and when certainty induced criticism is a proxy for narcissistic self -aggrandizement in society, the intellectual, poetic and literary foundations are hollowed out. This is my vantage point. From this 'perch', I feel sad and bad about the inexorable decline in our intellectual and social standards. Now let me dwell on the central point and theme of this essay. Broadly, a given society's intellectual quest must be to probe for and find truths referred to in the essay, explicate on these and render these as the predicate for further truths. (I must emphasize here that as Muslims, there are clear boundaries to the truth discovery process. There is just One Absolute Truth. But worldly truths are there awaiting discovery and there may be an element of relativism to these worldly and prosaic truths). The base of the argument and the central



Forcing Your Children to Marry Unwillingly is Un-Islamic

T t is important first to understand how forced marriage differs from arranged marriage. In the latter, the families of both spouses take a leading role in arranging the marriage but the choice of whether or not to accept the arrangement remains with the young people. In forced marriage, one or both spouses do not consent to the marriage and some element of duress is involved. The force may include threats of/actual physical or sexual violence, financial abuse (e.g., the taking away of someone's wages) and/or the individual being made to feel they are bringing 'shame' on the family by refusing to marry. Sometimes the victim is unable to explain that no one was physically forcing him to do it but it was clear he had no choice? The pressure to accept was overwhelming. It is important to note that forced marriage is not sanctioned within any culture or by any religion.

Islam and Forced Marriage

Despite numerous contentions to the contrary, forced marriage is not an Islamic tradition; it is a jahiliyya custom (pre-Islamic era), rooted in indigenous cultures, that has persisted in some Muslim communities.

Islam does not sanction or advocate any form of forced marriage. Unlike secular law, marriage within the ambit of Islam is not only a civil contract but a religious and spiritual contract between two people - which must be entered into freely and with mutual consent. According to Islamic custom, parents and guardians have specific rights in this matter; to arrange the marriage ceremony and conduct it as a respectful family event; give their advice and recommendation for a life partner for their children. These rights are encapsulated within the philosophy of 'willayah'. However, Islam does not allow parents, guardians or other relatives to enforce their will or choice on a boy or a girl since it is they who are the real parties to that contract. The right to exercise free will and consent in choosing a spouse is a God given right.

There are a myriad of reasons for forced marriage. In Muslim communities, misguided religious teachings and perverted interpretations of Islam lead families to believe that they are complying with Islamic ruling. Other factors may include the notion of protecting children; upholding cultural traditions; preserving family honor; social status; and building stronger families. Forced marriage also is used to prevent so-called "unsuitable" relationships outside regional & ethnic groups.

This is also clearly evident from important commandments given by the Holy Prophet (PBUH) in numerous Hadith, which lav down the foundational principles of formulating a marriage contract.

In the Sahih Al-Bukhari, for example, a chapter in the book of marriage has been given the heading: "No father or mother or any close relation can force his/her children to marry anyone against their free will and consent".

Within this chapter Abu Hurairah transmits from the Holy Prophet (PBUH) who said: "No female whether a widow or divorcee will be forced to marry anyone unless her express and categorical consent has been freely taken and in the same way a woman not previously married can never be forced to marry anyone unless her free consent and permission is taken'

Imam Bukhari has set another chapter heading within the book of marriage: "If parents force their daughter to marry someone against her wish then the marriage will be void"

Under this chapter Imam Bukhari reports a Hadith of the Holy Prophet (PBUH) from Khansa Bint e Hizam Al Ansarivah. She states that her father married her off to someone forcefully whom she did not like. She took her case to the Holy Prophet (PBUH) and upon listening to her; the Holy Prophet (PBUH) rejected the marriage and declared the marriage as void"

In another Hadith in the Sahih of Imam Bukhari it is narrated by Abdullah Ibn Abbas (r.a.d) that the Holy Prophet (PBUH) said that if a woman wants to marry and is already a divorcee or widow, her right of free consent and free choice is superior then the right of her guardian. If she is not previously married and this is her first marriage even then her parents or other guardians cannot enforce their choice on her. They are not allowed to force her to marry anyone against her free choice and free consent.

It is thus clearly apparent that forced marriages are totally unacceptable in Islam. Islamic commandments as mentioned above are very categorical in nature. Those who invoke Islam in order to justify their actions do so for ulterior motives. There is a need to educate all and sundry on these issues.

Need for Kashmir-Centric Urban Planning A Conversation with Prof. Haenraets

rban planning in Jammu and Kashmir is at a very critical juncture. The Institution of Engineers, in collaboration with civil society groups, organized a thorough workshop in which bylaws were deliberated upon.

Kashmir Observer interviewed Professor Jan Haenraets, Professor of Practice in the Preservation and Studies Program at Boston University. He has done extensive work in Kashmir. Following are the excerpts from the interview

Kashmir Observer: Tell us about the kind of technicalities that were discussed in the workshop regarding land pooling and land bylaws. Please talk us through it.

The panel brought together a number of speakers and a wider public audience for consultation and inputs. The speakers focused on proposals for changes to the bylaws. My perspective, as a conservation architect who focuses on the historic landscape, was that Srinagar is a very historic urban landscape, different from other cities in the subcontinent. You need a particular set of guidelines and regulations to ensure that the sustainable livability of the city is retained. What the speakers mentioned were the implications of some of the suggestions, such as the removal of certain elements of the bylaws, and how that could open the door to very free development. While I think everybody agreed that regulations should evolve, it is crucial that they are adapted carefully, especially for a particular place like Srinagar in Kashmir, not just Kashmir but the entire Kashmir valley.

Kashmir Observer: Have you visited the downtown part of Srinagar, and did you experience the current Smart City? How would you draw the difference between the two parts of the city?

I have been involved in Kashmir for about 15 years, and I have visited



historic places. The downtown, the old city, is remarkable, and I have seen huge changes taking place, such as the widening of roads and other changes we do need in a historic city. Srinagar doesn't have many multistory buildings; it retains a kind of medieval atmosphere, which is excellent and beautiful at the same time.

Progress is something that every citizen should receive. You should have a level of progress in your urban environment. But what happens at the same time, while we have these historic areas, is an explosion of automobile traffic, which has had a major impact, especially over the last 15 years, on the historic city. At the same time, we've seen stabilization in the valley, and the 2019 bill shifted the government more centrally to Delhi. In that whole context, we've seen an influx of tourism and visitation from national visitors to the valley. With the centralized government behind that, they've created ideas such as Smart City projects, which are implemented throughout the nation. Now, in the case of Srinagar, it is a good thing that there is significant investment in the public realm, including infrastructural elements like bus systems. But the problem is that those

proposals are not Kashmir-specific. We see developments with materials, designs, and systems like bicycle paths and electric bicycles, even though bicycling was not something common in Kashmir. So investments are happening here, but the execution is very poor. We see a contrast between the old city, where infrastructural improvement is necessary, and the new tourist hotspots, which feel somewhat alien to Kashmir

Kashmir Observer: According to the Building Bylaws 2021, a lot of changes have been suggested by experts sitting in Delhi, which have likely been contested by stakeholders and experts here in Jammu and Kashmir, not just in Kashmir but also in Jammu. How do you view these bylaws and their context?

There was a lot of discussion about that, and we need to recognize that bylaws are highly subjective. Some people will support certain proposals, while others may not. I have a particular view, as I come from a historic landscape background, focusing on environmental quality, livable cities, and the historic significance of places. However, others may come from economic or tourism backgrounds. I must say, some people mentioned that some of these shifts in the bylaws could benefit them, especially in terms of economic development, such as hotels or new town areas

where complete new developments may occur. Deregulation might benefit such projects. But again, in the historic city, this becomes problematic. So, there were different views.

Kashmir Observer: As an expert, are you satisfied with the way the Smart City is coming up? Given the different landscaping elements and other features in the city, do you think it is satisfactory, or do you have your own opinion?

I will give my personal opinion: I think it is a complete failure in Kashmir. The Smart City infrastructure, to me, is a complete failure. I believe everyone in Kashmir welcomes the financial investment in the region, but the proposals are being designed outside Kashmir by consultants who don't really understand the valley. They use design approaches that may be suitable for other cities in India, but they are not place-specific. For landscape infrastructure, urban realms, and public spaces, you need to understand the place. It's not enough to design in a drawing room and expect it to work. For landscape and public realm projects, you must understand the historic layers, climate, environment – all aspects of the place. One area where the Smart City project stands out as a failure is in horticulture and vegetation. They create paved surfaces with little to no horticulture. For any outdoor public space, you need to consider maintenance alongside the infrastructure. But what's happening here is more like interior decoration done outdoors – benches and flowers that could be found anywhere, which aren't place-specific, and there's no consideration for horticulture. Srinagar, Kashmir, is known for its green environment, but many trees are being cut down or damaged during this process, and green spaces are being replaced with concrete and stone pavements. To me, it's a pity. With the budget for that project, we could have completely landscaped the urban public realm of the old city.

Technology has made it easier to perform criminal investigations, enabling investigators to collect evidence without human intervention, analyze it, & present it in court. New tools & techniques have made it possible for defence agencies to solve crimes faster & more effectively, leading to the identification & punishment of criminals. Technology is a crucial part of law enforcement in Jammu & Kashmir (J&K), which is known for its unique challenges. The J&K Police, which manages complex & evolving security matters, can depend on modern technology to increase public safety, crime control & investigation efficiently. Digital evidence & forensics science have become increasingly widespread in modern criminal investigations. Criminals are using online platforms & devices to do crimes in the digital age. Digital tools have been created which are available & can be utilized by law enforcement agencies to solve crimes. The digital evidence consists of the information from various devices such as mobile phones, computers & as well as social media. Evidences like location. Internet Protocol Detail Records (IPDR), Call Detail Records (CDR data), communication records & financial transactions can be used to establish a timeline of events for investigators to follow in order to identify suspects.

Technology's Impact on criminal investigations & the challenges faced in utilizing technology.

In modern criminal investigations, technology is heavily used to improve the efficiency & precision of law enforcement. A series of traditionally used methods of investigating have always been important: questioning, collection of material & witness accounts, & eyewitness

a. Digital Forensics & Cybercrime Investigation.

Digital forensics is one of the most significant developments in criminal investigations. The use of computers, smartphones, tablets, & other digital tools has become increasingly common among criminals as they try to plan & execute crimes. The retrieval & analysis of data from these devices to obtain evidence in criminal cases is referred to as digital forensics. By employing digital forensics techniques to monitor hackers, cybercriminals, & those engaging in illegal online activities such as hacking or fraud, the J&K Police can enhance their investigative efforts. By using specialized software, investigators can track internet searches & other data, recover lost or deleted files. & monitor the communications with suspects. The development of these technologies will be crucial to the fight against crime in J&K, as cybercrime & inter-state crimes continue to grow.

b. CCTV Surveillance & Face **Recognition Technology.**

The use of CCTV cameras has made urban public areas more accessible for surveillance. Apart from detecting criminal activity, the cameras are essential in case of an incident. The integration of advanced technologies like facial recognition software is being used in CCTV systems to identify & track individuals. in addition to traditional surveillance. In Jammu & Kashmir, where ongoing conflicts & crimes are a concern, CCTV surveillance can be particularly effective as compared to other methods. By comparing their facial features with databases of known criminals or people of interest, facial recognition software can be used to track suspected criminal activity, those involved in anti-national activities, or any other criminal.

c. The use of drones in surveillance & crime scene documentation is possible.

In modern criminal investigations, drones are increasingly being used to monitor large or risky areas. The use of drones is a viable option in areas like Jammu & Kashmir where remote terrain poses logistical challenges. Law enforcement can make use of drones for crowd management, surveillance purposes & crime scene recording. In addition to conventional surveillance techniques, drones can also be utilized to monitor critical zones, crime hideouts, deep gorges & areas where the terrain is challenging to navigate.

d. Biometric Identification & **Fingerprint Analysis.**

The use of biometrics for identification is another area where technology has proven to be highly beneficial. The use of biometric technologies, including

eye scanning, face recognition, & fingerprints, has been linked to increased criminal investigations. The use of fingerprints at a crime scene is still an effective method of identifying suspects. The use of biometric databases enables defence agencies to quickly identify suspects by cross-checking them with a database of criminals. By utilizing biometric systems in criminal investigations. the J&K Police could potentially aid their investigation in an area where fugitives may attempt to circumvent arrest by altering their identity or appearance. Fingerprint matching can be a trustworthy approach to identifying suspects in cases of crimes.

e. GPS Tracking & Electronic Monitoring.

Criminal investigations often involve the use of GPS-based tracking systems & electronic monitoring devices to track the movements of suspects. These are especially useful in cases where longterm tracking of a suspect's whereabouts are needed. The use of GPS trackers & electronic monitors by authorities can ensure that suspects are following laws such as house arrests, geofencing etc during course of investigations. The J&K Police stated that GPS tracking can aid law enforcement agencies in their efforts to catch criminals. Moreover, law enforcement can access real-time data on crimes like kidnappings, murder plannings & car thefts that could lead to the recovery of lost property or the rescue of victims.

ALPR technology enables law enforcement to scan & track vehicle license plates automatically. This system can be utilized to patrol perimeter security, monitor movement of suspects, & identify if they have stolen a vehicle or even can track the lost vehicle. Because ALPR can identify vehicles of interest quickly without human intervention, it's especially useful in densely trafficked urban areas with multiple entry points. The J&K Police could make use of ALPR to oversee crucial entrance & exit points in the region, like non toll post crossings or key roads. Hence, they could monitor the movements of suspects trying to enter or exit sensitive areas or track cars involved in criminal activities.

Recent Event: Technological advancements are necessary for J&K Police to meet their needs.

In a recent event in Kashmir, the family of Umar Yaseen, a resident of Nowgam who disappeared from 22nd Dec 2024 & later found dead at Digdol Ramban eight days prior, is seeking justice for Umar Yaseen with respect to the murder or conspired accident that led to the discovery of his body. In that case & other long pending cases in J&K, the Jammu & Kashmir Police should proceed with their criminal investigations using modern technology. By utilizing state-of-the-art technology, case resolution & crime prevention can be significantly enhanced due to the local law enforcement challenges & crimes. To tackle these problems, the J&K Police should consider investing in cutting-edge technologies such as digital forensics, drone technology, biometric systems, & predictive planning. These technologies would enable the police to maintain order, gather more credible evidence, & respond better to incidents. It would also focus on investigations that are most important to public safety, allowing J&K Police to solve cases faster.

Application of Big Data Analytics in Criminal Investigations.

Criminology has been revolutionized by big data analytics, which empowers law enforcement agencies to analyze vast amounts of information in real time & extract relevant insights. Every day, social media, financial transactions, telecommunications, & IoT devices generate vast amounts of data in today's digital world. Advanced predictive analytics models will enable investigators to predict criminal activities, identify new threats, & allocate resources wisely. Technology is now a necessary component of criminal investigation, along with an improved approach. By utilizing these technological advancements, the Jammu & Kashmir Police can better manage sensitive security situations in the area. The use of technology can transform investigations, crack the (murder, cyber & terror) cases & improve public safety, including using the advanced surveillance techniques & digital forensics. By adoption of such technologies, J&K can enhance the security situation in their region & improve police force effectiveness. The J&K Police must enhance more technology to remain a forceful in the fight against crime with transparency & excellent policing.

A Breather: J&K's

reveals a deficiency of 60 to 84 per cent in other districts of Jammu and Kashmir including Srinagar, the summer capital of the Union Territory, having a deficiency of 74 per cent during the period.

There is a forecast of more snow and rain for the next two days, which would likely reduce the rainfall deficit of this season. The weatherman has issued yellow and orange alerts for Jammu and Kashmir, predicting light to moderate rainfall till February 28.

Amid the declining trend in precipitation for the last three consecutive years, Kashmir Valley has recorded the worst-ever deficit rainfall in 2025 in the last eight years.

Official data revealed that a deficiency of 70 per cent was recorded from December 2024 to February 2025.(KNO)

J&K Assembly

Before the Assembly elections in October 2024, there was speculation that these five nominated members could play a crucial role in shaping the balance of power. "In winters the local hydro power generation of Jammu and Kashmir power plants has reduced by almost 90 percent and in order to cater the requisite power demand, we need to have a base power availability that we procure from outside states. The energy is coal based energy," the official had said.(KNO)

Temp Plummets,

recorded at Gulmarg, a famous ski-resort

and other places today, which led to temperatures plummeting in the Valley.

As per the details shared by an Independent Weather Forecaster, Aadil Maqbool, Sadhna Top and Zojila Pass recorded a snow depth of 2 feet. Z Gali, Gurez, Sinthan Top and Gulmarg recorded a snow depth of one feet each till this evening while Sonamarg recorded 1.5 ft and Doodhpathri recorded 8 inches.

Pahalgam and Kupwara recorded rainfall of above 20 mm in the last 24 hours while Srinagar, the summer capital of Jammu and Kashmir, witnessed the rainfall of 7.8 mm during the period.

Chill returned to Srinagar as the city recorded the maximum temperature of 6.6 degree Celsius.

In its week-long weather forecast, Director Meteorological department (MeT), Dr Mukhtar Ahmad said that there is a possibility of light to moderate rain and snow at most places with isolated heavy rain and snow over both Kashmir & Jammu divisions for next two days.

On March 1 & 2, Ahmad said that amid generally cloudy weather, there is a forecast of light rain and snow at isolated to scattered places, adding that on March 3, light to moderate rain and snow is expected at many places.

From March 4 & 6, he said generally dry weather is expected.

Meanwhile, in its advisory, the local MeT department has said that there is a possibility of temporary disruption of surface transportation mainly over Sadhna pass, Razdan Pass, Sonamarg-Zojila-Gumri axis, Mughal Road, Sinthan Pass & other major roads of hilly districts are expected.

Tourists, travelers and transporters are advised to plan accordingly & follow administration and traffic advisory, it reads, adding that farmers are advised to suspend irrigation & other farm operations.

Significant fall in day temperature is expected during the above period, the MeT added.

HC Orders Reduction

extended to be connected to the expressway. "There should not be mushrooming of toll plazas in the Union Territory of Jammu and Kashmir and the Union Territory of Ladakh only with the sole aim and objective of minting money from the general public... Respondents are charging hefty toll fees at Bann toll plaza, whereas toll fees at other toll plazas are also high," the bench said in a 12-page order issued

on Tuesday. "Thus, not only the treasures of NHAI (National Highways Authority of India) are being filled with thousands of crores of rupees, private contractors are also enriching themselves by accumulating crores of rupees," it added.

Since the fees must be fair enough for the general public and should not be a source of revenue-generating mechanism, the respondents -- particularly the Union ministry concerned -- are directed to consider levying of "fair and genuine" fees at the toll plazas,

thereby slashing the existing fees at all the plazas as the current rates are on the higher side, the high court said.

"The decision in this regard (will) be taken positively within a period of four months from today (Tuesday)," according to the order.

The high court also ordered the respondents -- the NHAI, Jammu and Kashmir government and the Union Ministry of Road Transport and Highways -- to withdraw within one week the order or direction regarding redistributing the influence length from Lakhanpur to Udhampur between the Lakhanpur and the Bann poll plazas with effect from January 26 last year after closure of the Thandi Khui toll plaza.

"Respondents are directed to levy only 20 percent of the toll fee with immediate effect, ie, the toll fee at Lakhanpur toll plaza and Bann toll plaza shall be 20 percent of the rates earlier in force before 26.01.2024 till the national highway from Lakhanpur to Udhampur gets fully operational for smooth utilisation of the public," the high court said.

"Respondents charge the full toll at both these toll plazas only after the issuance of a certificate in this regard by an independent surveyor," it said.

The high court also directed the respondents not to establish any toll plaza within 60 kilometres of National Highway 44. "If there is any toll plaza in the Union Territory of Jammu and Kashmir or in the Union Territory of Ladakh within 60 kilometres on the national highway, respondents (are directed) to remove the same within two months from today (Tuesday)."

The respondents and the contractors of the toll plazas were directed not to employ anyone with a criminal background.

The high court also directed the respondents and the contractors to deploy personnel at the toll plazas only after verification by police agencies concerned. "In case of any deviation in this regard, the concerned SHO or in-charge shall be personally responsible for the same."

Centre to SC

held that the legislative choice over one option or the other couldn't be questioned in courts over its efficacy or otherwise.

Under Section 8 (1) of the Representation of the People Act, 1951, the period of disqualification was six years from the date of conviction or in case of imprisonment, six years from the date of release, it added.

"The disqualifications made under the impugned sections are limited by time as a matter of parliamentary policy and it would not be appropriate to substitute the petitioner's understanding of the issue and impose a lifetime ban," it said.

The Centre said as a matter of judicial review, the court could declare the provisions to be unconstitutional, however, the relief sought by the petitioner effectively sought to read "lifelong" instead of "six years" in all sub-sections of Section 8 of the Act. It said lifetime disqualification was the maximum that could be imposed under the provisions and such a discretion was "certainly within the power of Parliament".

"However, it is one thing to say that a power exists and another to say that it must necessarily be exercised in every case," the Centre argued.

The affidavit said the impugned laws were "constitutionally sound" and "did not suffer from the vice of excess delegation" aside from being intra vires the powers of Parliament.

While imposing any penalty, it said, Parliament considers the principles of proportionality and reasonability as for instance, the entirety of the Bharatiya Nyaya Sanhita, 2023, or penal law provide for imprisonment or fines up to certain limits and the rationale behind it was that the punitive measures would correlate with the gravity of offence.

There were numerous penal laws that prescribe imposing restrictions on the exercise of rights and freedoms, which in most cases are time-specific, it said.

The Centre said the petition failed to make the crucial distinction between basis of disqualification and effects of disqualification.

"It is true that the basis of disqualification is conviction for an offence and that this basis remains unchanged so long as the conviction stands. The effect of such conviction lasts for a fixed period of time. As stated above, there is nothing inherently unconstitutional in limiting the effect of penalties by time," it said.

The affidavit said the petitioner's reliance on Articles 102 and 191 of the Constitution was totally misplaced.

Articles 102 and 191 of the Constitution deals with disqualifications for membership of either house of parliament, legislative assembly or legislative council.

The Centre said Clause (e) of Articles 102 and 191 were enabling provisions that confer on Parliament the power to make laws governing disqualification and it was in exercise of this power that the 1951 Act was enacted.

"The Constitution has left the field open to Parliament to enact such further law governing disqualifications as it deems fit. Parliament has power both to determine the grounds for disqualification and the duration of disqualification," it said.

The Centre said the grounds for disqualification in the articles included holding of an office of profit, unsoundness of mind, insolvency and not being a citizen of India.

"It is submitted that these are not permanent disqualifications," it added.

The apex court on February 10 sought responses of the Centre and the Election Commission on the challenge to constitutional validity of Sections 8 and 9 of Representation of People Act. (inputs from PTI)
