This is the first budget of the National Conference-led government after it came to power in October last year, ending six years of central rule.

The last budget session took place in 2018 under the then PDP-BJP government in the erstwhile state of J&K, which was accorded the status of Union Territory after Ladakh was carved out as a separate UT following the abrogation

of Article 370 on August 5, 2019. He said the improved environment is contributing to economic progress, with J&K's economy expanding from Rs 1,64,103 crore in 2019-20 to Rs 2,45,022 crore in

The total net budget estimates for fiscal 2025-26 are Rs 1,12,310 crore, excluding provisions for ways and means advances and overdrafts," Abdullah said.

With a focus on a zero-deficit budget, he said: "The expected revenue receipts are Rs 97,982 crore and capital receipts are Rs 14,328 crore. Similarly, revenue expenditure is estimated to be Rs 79,703 crore and capital expenditure Rs 32,607 crore.'

Detailing the estimates, he said gross receipts are estimated at Rs 1,40,309.99 crore, including provisions for an overdraft of Rs 28,000 crore.

"Given these receipts, total gross expenditure is estimated to be Rs 1,40,309.99 crore," he added. Abdullah highlighted that the Union Territory's own revenues, both tax and non-tax, are esti-

mated at Rs 31,905 crore. "Additionally, Rs 41,000 crore is expected as central assistance and Rs 13,522 crore as CSS and PMDP for the Union Territory of Jammu and Kashmir," he added.

## **Astronomers Uncover Mysterious** 'Ghosts' Of The Radio Universe

adio astronomers have discovered a series of faint, ghostly circular objects in space using advanced radio telescopes such as the Australian Square Kilometre Array Pathfinder (ASKAP) and MeerKAT in South Africa. These cutting-edge telescopes, designed to detect radio signals rather than visible light, are unveiling an unseen universe filled with mysterious cosmic structures.

The extraordinary sensitivity of these telescopes is revealing a "low surface brightness universe", consisting of extremely faint radio sources that had never been observed before. Many of these discoveries come from the Evolutionary Map of the Universe (EMU) survey, a large-scale sky-mapping project using ASKAP, which is delivering the most detailed radio atlas of the southern hemisphere. Among the recent discoveries is Kýklos, a ghostly ring, and WR16, both surrounding rare and massive Wolf-Rayet stars—a late stage in the life cycle of massive stars. As these stars burn through their fuel, they become unstable and eject layers of gas, forming nebulous circular structures. The expelled material expands symmetrically in all directions, creating the distinct circular shapes seen in radio observations. Several newly discovered objects-Stingray 1, Perun, Ancora, and Unicycle-are supernova remnants, the aftermath of massive stellar



explosions. When a star collapses under its own gravity, it releases an immense burst of energy, sending shockwaves outward. These expanding shells of stellar debris appear as striking circular formations. A particularly intriguing supernova remnant, named Teleios (from the Greek "perfect"), stands out for its near-perfect symmetry. Unlike most remnants, which become distorted over time due to interactions with surrounding interstellar material, Teleios has remained untouched, providing rare insights into the physics of supernova explosions.

Another spectacular find is Diprotodon, one of the largest objects ever observed in the sky. Measuring nearly six times larger than the Moon, this remnant has only now been fully detected thanks to ASKAP's sensitivity. The name Diprotodon was inspired by an extinct Australian megafauna species, a giant wombat-like creature, due to its vast size. The internal structure of this remnant reveals complex interactions with its envi-

ronment, with different sections of the expanding shell colliding with

interstellar clouds. Another fascinating object, Lagotis, challenges previous classifications of cosmic structures. Originally identified as VdB-80, a reflection nebula within the Milky Way, new ASKAP data has revealed an additional structure-an HII region (a cloud of ionized hydrogen) surrounding the same stellar center. This discovery suggests that the nebula is actively interacting with a molecular cloud, much like a burrowing motion. This behavior inspired the name Lagotis, after the Australian greater bilby (Macrotis lagotis), an animal known for its digging nature.


ASKAP and MeerKAT are also shedding light on objects beyond our galaxy, including a class of mysterious radio ring galaxies. While these galaxies appear as normal disks in visible light, their radio signals reveal enormous rings, potentially caused by powerful supernova-driven shockwaves that have cleared the central regions of gas. However, the exact mechanism behind these structures remains uncertain, prompting further re-

One of the most puzzling discoveries is LMC-ORC, an Odd Radio Circle (ORC)-a newly identified class of objects with unknown origins. Only detectable in radio wavelengths, ORCs are among the most enigmatic findings in modern astronomy. Their formation mechanisms are still unclear, but ongoing studies are expected to shed light on their nature.

MeerKAT and ASKAP are merely the precursors to an even more powerful project-the Square Kilometre Array (SKA), an international collaborative effort that will revolutionize radio astronomy. The SKA will significantly enhance our ability to detect low surface brightness objects and uncover even more previously unknown cosmic struc-

## Brain Activity During Sleep Could Predict Recovery Of Patients With Brain Injury

spindles or brain activity occurring during the nondreaming stage of sleep could help predict recovery of consciousness and independent functioning in those who suffered a brain injury, a new study has suggested.

Researchers from Columbia University and the NewYork-Presbyterian healthcare system, US, said the studies have shown that unresponsive patients with a recent brain injury can possess a degree of consciousness hidden from families and doctors. For the study, published in the

journal Nature Medicine, the researchers looked through electroencephalograms or EEG recordings of brain activity in 226 comatose patients taken over a night.

"The electrical activity during sleep looks relatively chaotic and then occasionally in some patients, these

(bursts of) very organised, frequencies appear," said lead researcher Ian Claassen, an associate professor of neurology at Columbia University. These bursts of brain activ-

ity, called sleep spindles, often preceded the detection of cognitive motor dissociation—in which a patient appears unresponsive but shows evidence of brain activity-the return of consciousness and long-term recovery, the researchers said. The patients with sleep spindles and cognitive motor dissociation were more likely to recover consciousness and functional independence, the team said.

'Spindles happen normally during sleep and (the patients are) showing some level of organisation in the brain, suggesting circuits between the thalamus and cortex -- (brain regions) needed for consciousness are intact,' Claassen said.

In the study, sleep spindles

were seen in "approximate-ly every third behaviorally unresponsive patient after acute brain injury, frequently precede detection of CMD and are a promising complementary predictor for recovery of consciousness and functional independence". The researchers said that 76 per cent of the patients with sleep spindles and cognitive motor dissociation showed evidence of consciousness by the time they were discharged from the hospital. A year later, 41 per cent of these patients had recovered neurological function, with either minor deficits or a moderate disability, and

team said. They acknowledged the findings do not prove that inducing sleep spindles would translate to better outcomes, but raise the possibility that improving a patient's sleep may promote recovery.


### **Thousands Throng City Mosques On First Friday Of Ramazan**

Srinagar: An amount Rs. 9.82 crore has been incurred, so far, on construction of the Mini Secretariat at Batamaloo. This information was

given by Minister for Education, Sakeena Itoo, while replying on behalf of the Chief Minister in response to a question raised by Member Tariq Hameed Karra.

She further informed the House that the decision to execute the project was taken during a District Development Board meeting held on October 4,



2017, under the chairmanship of the Chief Minister of J&K (Chairman, District Development Board).

The project namely 'Construction of Mini Secretariat at Batamaloo', commenced in 2018 with a technically vetted cost of Rs. 48.23 crore. "An amount of Rs. 1 crore was released for the project, against which Rs. 82 lakh stands incurred," the

Minister stated.

She further informed that during the current financial year, additional Rs. 9 crore have been incurred, bringing the total expenditure on the project to Rs. 9.82 crore so far. "It is pertinent to mention that the pile foundation work of the project has been completed," she added.

The Minister also stated that the executing agency has now submitted a revised Detailed Project Report (DPR) amounting Rs. 80.26 crore, which is currently under consideration of the department.

## The Appropriation of Kashmiri Pheran

### It is one thing for a traveler to take a piece of Kashmir home, to carry it like a relic of a place that touched them. That is different. That is personal. But when a piece of identity is uprooted, sold off in bulk, and rebranded like a cheap imitation of itself, it is no longer admiration—it is erasure. It is cultural vandalism dressed as commerce

he Pheran is not just a garment. It is winter woven into wool, a whisper of the mountains, a thing that holds centuries inside its heavy folds. It belongs to the people of Kashmir like the veins belong to the body. It carries stories, prayers, whispers of lost winters. You walk into an old Kashmiri home, and there it is, draped around a mother warming her hands over the kangri, wrapped around a poet who stares out at the endless white of the valley, held close by a child who grows into it like roots stretch into earth. The Pheran is the past, the present, the unyielding memory of a land that has spent too long being taken, stripped, rewritten.

And yet, in the marketplace of the world-where everything sacred is a commodity waiting to be sold—it is being pilfered, reshaped, mispronounced, and paraded like a novelty from some exotic hinterland.

Walk through the tourist-filled lanes of Himachal Pradesh, and you'll see it. Hanging like an artifact in boutique shops run by women who dont know its significance. "Authentic Himachali winter wear," they call it. Some have gone to the extent of calling it Himachali Pheran!

And there it is, hanging under the neon glow of commercial greed, its price tag mocking those who carry it in their blood. Non-local manufacturers, sitting in workshops far removed from the crisp air of Kashmir, have begun to mass-produce it, tweaking its designs, slapping on new labels, selling it to those who don't know, those who don't care.

It doesn't stop there. No, theft is never satisfied with just the body-it wants the soul too. They speak of it as if it belongs to them, whisper

fictions about its origins, post filtered photographs with captions like Traditional Himachali Wear! The audacity tastes like iron in the mouth.

But when a piece of identity is uprooted, sold off in bulk, and rebranded like a cheap imitation of itself, it is no longer admiration—it is erasure. It is cultural vandalism dressed as commerce. The people who sell it now, who claim it as their own, will never know the way the Pheran holds warmth like a mother's arms in the dead of winter. They will never understand what it means to

soft heat of a kangri beneath its folds, or how it carries the scent of hearth smoke, of resilience, of loss. They will never know that for every Kashmiri who

wears a Pheran, it is not just

press frozen fingers into the

clothing—it is inheritance. it is defiance, it is survival.

To make it worse, some of the same people who drape themselves in the stolen warmth of the Pheran would not think twice before turning their noses up at a Kashmiri in any other state. The very garment they commercialize would be treated as 'too ethnic' when worn by the people it actually belongs to. The same outsiders who romanticize it in their curated Instagram posts would not sit

next to a Kashmiri man wearing one on a train, would not look a Kashmiri woman in the eye without suspicion.

Theft is not just about taking something. It is about stripping it of context, about making it palatable for the people who wouldn't dare understand its true weight.

But let it be said—loudly, clearly—that it is Kashmiri. It is not an aesthetic to be borrowed, a trend to be worn for a season and discarded. It is history, it is identity, and it will always belong to those who have felt the weight of snow pressing against their roofs, who have walked through the fog of their own breath in the morning light.

The Pheran was never meant to be pretty. It was meant to shield you when the world turned its back. It was meant to carry the scent of burning coal and the echoes of conversations held in whispers. It was never made for Instagram aesthetics.

Cultural misappropriation is not just about theft. It is about erasure.

It is about taking something and scrubbing it clean of its pain, its politics, its pulse. It is about reducing an identity to an accessory. It is about turning a battle-worn flag into a decorative rag.

Let's honor heritage with authenticity. If you wear the Pheran, know its story. If you admire it, respect its roots. And if you speak of it, acknowledge where it truly belongs. Culture is not a trend—it is identity. Let's protect it, not appropriate it.

s a flawed Muslim who used to take advantage of non-obligatory nature of the Ramzan Taraveeh prayers and not offer these, I would while away post Iftar time doing nothing. This became rather thematic every year. But this year-round, inspired by a dear friend of mine, who locked his house to offer taravee prayers along with his family, I resolved to put my laziness to rest. Taraveeh prayers beckoned me. The issue was where to offer these. The answer stared me in the face: it would be our very own Grand Mosque, Jamia Masjid.

First, a few words on the structural features and nature of Jamia Masjid.

An imposing structure in the heart of downtown Srinagar, our Grand Mosque dates back to almost seven centuries. The structural features of the Mosque are Persian in nature, with many turrets jutting outward toward the sky, a courtyard with a quasi- pond in the midst and spacious oblongish rectangular halls for prayers. Massive wooden columns support the top of the Mosque and connect these with the prayer halls. It appears that the locus of Downtown's life revolved around the Grand Mosque of Kashmir. Another feature of the Mosque is the institution of the Mirwaiz – a term of probable Perso-Arabic provenance that can be loosely translated as 'Master -Preacher'. The institution of Mirwaiz may be peculiar to Kashmir; it is the prerogative of a distinguished politicoreligious family of Kashmir dating back to Maulvi Yusuf Shah. The current Mirwaiz of Kashmir is Maulvi Umar Farooq(who happens to be a class mate and relative of mine).

These are the structural and cultural features of our Grand Mosque. But Jamia Masjid is more than an awe inspiring religio- historical structure. It is reflective of a structure of our belief and belief system, around which revolves the locus of our existence (as in the structure of our belief, spirituality and the Oneness of God Almighty). This thematic aspect of our Grand Mosque was revealed to me in a kind of a 'Eureka moment' for me. When I resolved to offer my Taravee prayers at Jamia Masjid this Ramzan, and when I set my foot in the compound of the Mosque, I could feel an aura, a spiritual energy immediately- in an intense form. As I sat myself on the prayer mats of the Grand Mosque, a certain calmness descended on my very being. It became more pronounced as the Imam of the Mosque commenced the Isha prayers that meshed into the Taraveeh prayers. The calm tonality and mellifluous voice of the Imam while he recited the Quran led to what may be called, the 'incredible lightness of Being'- a state of being that led to the emptying of the mind of worldly thoughts

and the syncing of the mind, body and soul toward a sublime state of being. The word that best describes this state would not be mere peace but Sakina (tranquility). What was (in my mind)- the chore of offering the Taraveeh prayers mechanically and as a mere ritual- something that made me averse to offering these prayers turned into a condition that could be held to be trance-like. The closest approximation of this trance-like condition could be the re-orientation of the self-soul-mind-

body toward a centre- the eschatological dimension of Being where the only 'thoughts' that filled the Being were that of God. At the conclusion of the Taraveeh, I felt light, effervescent and tranquil. I then mentioned this blissful, enchanting and sublime experience to my dear friend. We arrived at the conclusion that because of the centuries old ingress of Durood (praise of the Holy Prophet of Islam (PBUH) with intense love and dedication), Azkaar(remembrance of Allah) and prayers that

come right from the heart and the soul, our Grand Mosque was an intensely sacred space. While every mosque is sacred space, but our Jamia Masjid of Grand Mosque had sediments and layers of prayers that made it more intense a sacred space. When I stepped out of the prayer hall into the exit compound of the Mosque, the 'incredible lightness of Being', that I felt was not peculiar to me. The jaded faces and demeanors of prayer goers when they entered the Grand Mosque had given way to glowing faces and joyous demeanors. The sacred aura of Jamia Masjid had affected all.

As I put on my shoes, the tranquility (sakina) I felt was seductive. I wanted a repeat of the experience NOW! But I have to wait till tomorrow. My centre - mind, body, soul- was in alignment. The 'lightness of being' was incredible. All I could think of was next day's evening, when Taraveeh prayers would be offered again at our very own grand mosque!

## Ghazala Noor's Initiative to Teach Kids the New Way!

ducation in Kashmir has long been hindered by sys-blazers like Ghazala Noor Khan are lighting the path toward transformative change. As an educator, innovator, and founder of LittleRock Elementary, Ghazala's mission is to nurture foundational literacy, promote inclusivity, and redefine the way children learn. On the occasion of International Women's Day, we had an insightful conversation with her, in which she shares her journey, philosophies, and vision for education in Kashmir.

#### Q: Can you tell us about your journey and what led you to become an educator?

Growing up in Ranbirpora Mattan, a rural village in South Kashmir categorized as RBA (Reserved Backward Area), I witnessed firsthand the barriers to education. Despite my father being the first graduate in our area, our village lagged behind in literacy and quality education. Farming dominated our livelihoods, and the community lacked the motivation to prioritize education for their children.

Determined to change this, I pursued professional degrees in education (B.Ed, M.Ed) and a Master's in Sociology from Kashmir University. Working in reputed schools across Anantnag allowed me to gain diverse teaching experiences. While I initially taught older students, an opportunity to teach young children revealed how deeply rewarding it is to shape young minds. This realization became the foundation of my educational philosophy.

### Q: What drives your passion for education, and what changes do you hope to bring about?

Empathy and compassion are at the heart of my passion for education. I believe education has the power to transform lives, as it is not just a tool for knowledge but a means of self-actualization. As someone aptly said, "It is better to teach a child than to give gold in alms."

My vision focuses on a pragmatic approach to education, emphasizing foundational development from an early age. Education should nurture the mind, body, and soul, not just literacy and arithmetic. I advocate for skill-based, child-centric education that replaces traditional, restrictive classroom settings with open, interactive environments. Teachers should act as facilitators, guiding students to discover their unique potential.

#### Q: You've criticized conventional teaching methods in Kashmir. How does your approach differ?

Traditional pedagogies in Kashmir often rely on rote memorization, which stifles creativity and logical thinking. Children as young as three are conditioned to memorize sight words and shapes instead of developing phonemic awareness, a critical skill for reading and writing. This approach creates defective learning pathways, leaving many children dependent and struggling

academically. My method introduces a structured, synthetic phonics approach that fosters phonemic awareness, blending, and segmenting skills. This multi-sensory program caters to diverse learning abilities, enabling children to become early readers, writers, and speakers. Learning is integrated with play, stories, songs, and actions, ensuring a subconscious, lasting impact on the child's development.

Q: What inspired you to start



LittleRock Elementary, and how does it reflect your vision for education?

LittleRock Elementary was born during a challenging period lapses, which left me bedridden. The COVID-19 pandemic further ing, leaving parents and teachers struggling to support young learners remotely.

Language is the cornerstone of self-expression, fostering independence, creativity, and selfadvocacy. My program emphasizes stimulating LSRW abilities through phonemic awarenessthe understanding of phonemes, the smallest units of sound in a language.

Children are guided through a systematic process: developing phonemic awareness, mastering letter formation, blending sounds to form words, and segmenting sounds in words. This multi-sensory approach caters to diverse learning needs, enabling children to achieve 95% literacy within weeks. The remaining skills are honed through supplementary techniques, ensuring a compre-hensive foundation for lifelong

The budget has estimated the fiscal deficit for 2025-26 it to be at 3.0 per cent of the Union Territory's GDP.

"This is substantially lower than the 5.5 per cent in 2024-25 (RE)," he added.

The GDP for 2025-26 is projected at Rs 2,884,22 crore, reflecting a growth of 9.5 per cent over the previous year, he added.

The chief minister said the budget for J&K Police, which was around 11 per cent of total allocation, has been migrated to the ministry of home affairs' budget from 2024-25 onward.

"In addition to this, J&K will receive an extra Rs 5,000 crore in grants for 2024-25 and 2025-26. I sincerely thank the prime minister, home minister, and finance minister for their unwavering support in strengthening J&K's fiscal health and realising its vision for growth and prosperity," he said.

The budget emphasises inclusive growth, fiscal prudence, and strategic investments in key sectors, including infrastructure, agriculture, industry, healthcare, education, digital governance, and tourism.

To strengthen food security, Abdullah announced that 10 kg of free ration per person will be provided to AAY (Antyodaya Anna Yojana) beneficiaries from April 1 this year.

For social security, pension amounts have been increased to Rs 1,250 per month for persons below 60 years, Rs 1,500 per month for persons aged 60-80 years, and Rs 2,000 per month for those aged 80 and above, he said.

"This will increase the total pension outlay from Rs 1,209 crore to Rs 1,755 crore annually," he added.

Announcing free public transport for women, he said, "On International Women's Day, I announce free ridership for women on all government-owned public transport, including e-buses, starting April 1, 2025".

"This will enhance access to education and employment while ensuring safer, more affordable travel," he said.

He further proposed that the financial aid under the Marriage Assistance Scheme for AAY category girls will be enhanced from Rs 50,000 to Rs 75,000.

The Chief Minister announced a complete exemption of stamp duty on property transfers through gifts within blood relations. The move will promote ease of transactions, reduce inheritance disputes and encourage legal documentation of

property transfers.

About hydropower and energy reforms, he said J&K has a hydropower potential of 20,000 MW, but only 3,400 MW has been harnessed and added that initiatives are being taken so that Pakal Dul, Kiru, Kwar, and Ratle projects could add 3,000 MW by

"A new hydropower policy will be formulated to attract private investment and fast-track projects," he said.

The chief minister also announced 200 units of free electricity per month for Antyodaya families.

The budget also proposed to introduce a new hydropower policy to tap the UT's full potential of 20,000 MW and attract private investment.

"We are focused on bridging regional disparities, empowering youth and women, and fostering a business-friendly environment to attract investment and innovation," Abdullah, who also holds the finance portfolio, said while presenting his maiden budget in the assembly.

With an aim to unlock Jammu & Kashmir's industrial potential, Abdullah announced a significant step towards establishing a leather tanning industry.

"Currently, around 5,000-6,000 pelts produced daily in Kashmir go to waste due to the absence of processing facilities. To harness this opportunity, the government will formulate a policy to promote leather tanning industries, ensuring value addition. Processing these skins into leather will contribute an additional Rs 100 crore to J&K's economy," he said.

Emphasising the importance of a resilient rural economy, Abdullah announced the launch of the "J&K Green Mission" in

"We will unite communities to make villages clean and green through waste segregation, proper disposal, and vermicomposting," he said.

To ensure sustainability, the government will implement the Own Source Revenue (OSR) policy to make every village panchayat self-sufficient over the next five years

Additionally, under the Pradhan Mantri Awas Yojana - Gramin, 3.40 lakh houses have been sanctioned, with 50,000 more to be built in 2025-26, he said.

Buoyed by the tourism sector's recordbreaking show in 2024, with 2.36 crore tourist footfalls, Abdullah announced a strategic expansion plan under the SPREAD (Sustainable Promotion of Emerging Alternate Destinations) initiative.

"This initiative will help develop worldclass alternative destinations across J&K, reducing pressure on heavily visited locations. With the central government's support, we are already in the planning phase," he said.

He also announced an eco-tourism policy that will ensure sustainable tourism while tackling waste management challenges, particularly plastic waste at tourist sites.

A multi-stakeholder advisory committee to address issues in the tourism and hospitality sector will be set up too, he said, adding that Gulmarg Gondola attracted 7.68 lakh visitors in 2024, and the Kashmir

Marathon saw 1,800 global participants. "Tourism's contribution to GSDP will be increased from 7 per cent to 15 per cent in

the next 4-5 years," he added.

In order to bolster J&K's startup ecosystem, the government has also allocated Rs 50 crore for providing financial aid, mentorship and incubation for entrepreneurs.

"This will foster innovation, empower startups, and position Jammu and Kashmir as a dynamic hub for entrepreneurship," Abdullah said.

For MSMEs (micro, small and medium enterprises), he announced a new policy to provide price preference to local small businesses in public procurement, addressing concerns regarding central government's online marketplace GeM.

To combat illegal mining, he said that a mining surveillance system using satellite imagery will be implemented in collaboration with BISAG. Additionally, handheld e-challan devices will be introduced for enforcement, he noted.

Abdullah also unveiled the SEHAT App, saying this is set to revolutionise healthcare in J&K.

"This app will offer teleconsultation services, online doctor appointments in government hospitals, and a digital health records system integrated with AB-PMJAY-SEHAT insurance," he said.

The chief minister also added that the app will include Al-powered diagnostics, e-prescriptions, medicine delivery, and emergency health support. "Ambulance services and real-time updates on preventive care, vaccinations, and wellness programmes will also be provided."

On the education sector, he said the government will upgrade 40 higher secondary schools -- one boys' and one girls' school per district -- into integrated K-12 institutions.

"We are committed to transforming J&K into an educational hub by fully implementing NEP 2020 and launching four-year undergraduate programmes in all colleges," Abdullah said.

He also announced 600 additional seats in polytechnic colleges.

The government will encourage private universities to set up satellite campuses in I&K he added

To transform J&K into a hub of sporting excellence, the budget has envisaged setting up of national centres of excellence for water sports at Dal Lake (Srinagar) and Basohli (Jammu) and a gymnastics academy at Gindun Rajbagh and Khel Gaon, Nagrota.

The FY26 budget has proposed four state-of-the-art cricket academies with an allocation of Rs 8 crore, youth hostels in Jammu & Kashmir divisions with an outlay of Rs 10 crore, apart from the development of 247 playfields, stadiums, and sports courts.

The government aims to engage "75 lakh youths in sports activities across J&K, fostering a culture of fitness and excellence", he added.

The government has plans to establish the Jammu & Kashmir Skill and Entrepreneurship University (J&K SEU), he noted.

"This university will offer cutting-edge training in technology, healthcare, tourism, renewable energy, and traditional crafts while fostering innovation and industry partnerships," Abdullah said.

On infrastructure and government housing, he said a new legislative complex in Jammu has been allocated Rs 50 crore (Rs 208 crore total project cost). Additionally, 4,500 government residential units in Jammu and Srinagar will be constructed, with new projects for 300 more units.

"Twin towers with 64 modern 3 BHK and 4BHK flats at Canal Road, Jammu (Rs 20 crore allocation) will be constructed too," he said.

"This budget is a step towards a self-reliant, prosperous, and equitable Jammu & Kashmir," Abdullah said.

With major investments in industry, tourism, education, and infrastructure, the budget lays the foundation for economic growth, sustainability, and social welfare, he added.

Chief Minister's Awards will be instituted to recognize outstanding efforts in reducing Aggregate Technical & Commercial (AT&C) losses and conducting energy

Highlighting that major highways and tunnels were under execution, and rail connectivity via USBRL project was progressing rapidly, CM said that the budget has proposed 4,000 km of roads to be blacktopped in 2025-26 to improve connectivity across J&K.

CM said that Agriculture and allied sectors are crucial for the livelihoods of most of our population and Holistic Agriculture Development Programme (HADP) has an outlay of Rs 5013 crore until 2027-28 which is reshaping subsistence farming into commercial agricultures of the commercial agriculture and allied sectors of the commercial agriculture and allied secto

into commercial agri-economy.
On Industrial Development, CM said that J&K currently has 64 Industrial Estates and 46 more are under development and Government is committed to ensure infrastructure development in these estates. He said that the Government is streamlining SGST reimbursement and turnover incentives. He said to strengthen industry collaboration, the Government would constitute an Advisory Committee on Industries, ensuring regular engagement with businesses. CM proposed Rs 50 crore this year to support financial aid, mentorship and incubation for emerging entrepreneurs, He said that Government will bring a new policy to provide price preference to local MSMEs in public procurement

In tourism sector, CM said new master plans shall be prepared for major tourist destinations like Gulmarg, Pahalgam and Sonamarg. J&K's first National Water Sports Centre at Dal Lake & Basohli shall be established. A water park at Dwara village near Sidra Golf Course under PPP model

shall be developed in Jammu. The budget proposes to constitute a multi-stake-holder Advisory committee in Tourism & Hospitality sector.

CM said that Mission YUVA would be launched in the next financial year aiming to create 1,37,000 enterprises and to create 4.25 lakh jobs over five years through startups, MSMEs & skilling programs. The budget has proposed establishment of Jammu & Kashmir Skill & Entrepreneurship University (J&K SEU) to provide cutting-edge training in technology, healthcare, tourism, renewable energy traditional crafts. To support structured skill development, one lakh youth shall be trained over 5 years under PMKVY 4.0, PM Vishwakarma and other schemes besides reviving the Udaan Scheme. Special focus shall be given on first-generation entrepreneurs, women & youth from remote areas through credit support & market

CM said that his Government was committed to construct state-of-the-art Legislative complex in Jammu and an allocation of Rs 50 crore has been proposed in this budget for FY 2025-26. He said that provision of Rs 50 crore has been proposed in this budget to establish a National Law University in J&K and that Rs 125 crore has been apportioned for state-of the art judicial infrastructure across J&K.

Under the disaster management, CM stated that Rs. 39 crore Disaster Mitigation Fund has been proposed in the budget for flood & landslide protection, and GLOF monitoring systems for climate resilience.

Concluding his Budget speech, the chief minister commended the Budget for the financial year 2025-26 of the Union Territory of Jammu and Kashmir to the Legislative Assembly for consideration.

Later, the Chief Minister Omar Abdullah also presented the Supplementary Statement of Expenditure for the year 2024-2025 before the House.

criticism but described the Budget as a gift to the people of J&K. "I don't expect anything but criticism of this Budget from the Opposition... This Budget is a love letter to the people of Jammu and Kashmir," he said.

He said that he would never present the Budget again while observing Ramzan fast. Abdullah said this was the first budget of the J&K Assembly after 2018 and his first Budget as the finance minister.

He presented the Budget in the Assembly and spoke without stopping for almost one hour and 45 minutes while observing the sixth day of Ramzan fast.

The chief minister said he could have advanced or postponed the Budget Session. "After today's experience, I will never

present my Budget again while having Ramadan fast. Either I will pre or postpone the session or request the Speaker with folded hands to arrange the session around 6.30 pm (after breaking the daylong fast)," Abdullah told a press conference here.

He was responding to a question about the difficulty in holding the Budget Session during the ongoing holy month of Ramzan, especially in presenting the Budget when one does not swallow even a drop of water.

The chief minister said he was facing difficulty in speaking after the Budget speech that continued for nearly one hour and forty-five minutes in the Assembly.

"Interestingly, this was also the first time that any chief minister of J&K presented the Budget himself while holding the portfolio of the finance minister," Abdullah said.

The Chief Minister once again criticized the existing political structure of Jammu and Kashmir, calling it the "worst form of government" in the country. "I still maintain that a UT with an Assembly is by far the worst form of government in the country. I have no hesitation in saying this. There should only be two systems in this country—either you have a UT without an Assembly or a state," he asserted.

Moreover, the budget allocation for tourism has been raised to Rs 390.20 crore, representing an increase of Rs 121.77 crore compared to 2024-25. This boost in funding is expected to catalyse infrastructure enhancements, sustainability initiatives, and new tourism projects, thereby reinforcing the region's global standing.

The industrial development section of the CM's address highlighted efforts to stimulate entrepreneurship and boost the local economy. An allocation of Rs 50 crore has been proposed to support mentorship and incubation for emerging entrepreneurs, with the goal of transforming Jammu and Kashmir into a dynamic hub for startups.

"Local procurement through the GeM portal has surged, with purchases from local suppliers reaching Rs 1,527.74 crore," Omar said, adding that the government is committed to supporting local businesses. He also announced the implementation of a new policy to provide price preferences for local MSMEs in public procurement, aiming to level the playing field amidst rising competition.

To enhance the handicraft sector, the Chief Minister announced initiatives to promote 'Brand J&K', including the development of PM Unity Malls for artisans and the expansion of the Karkhandar Scheme. With employment support for over 4.22 lakh individuals, many from economically disadvantaged backgrounds, Abdullah said the government is dedicated to preserving and promoting J&K's rich cultural heritage.

### **Oppn Calls**

The party said by "limiting" the benefit only to AAY ration card holders, the government has effectively excluded a vast majority of the state's population.

"Out of 16 lakh ration card holders, merely 95,000 will benefit, which is just 5-7 per cent of the total population. Peoples' Conference chief Sajad Lone slammed the budget, saying it was a

"disappointment."

"The budget speech was, as expected, a disappointment -- same old style of parroting of Centrally Sponsored Schemes with Hindi nomenclature," Lone said in a statement.

He said the budget reflected a significant gap between political rhetoric and economic figures, emphasising that the presented data contradicted the ruling party's previous stance.

"It glorified and endorsed the BJP's 'Naya Kashmir' discourse. And statistics, which have been berated by the NC over the past decade have become the gospel truth.

"Suddenly, every government statistic from the past five years is being treated as gospel truth, and the incumbent government seems eager to jump into the frame and take credit for the same statistics that, until the other day, they told us were either fudged or fiction," Lone, the MLA from north Kashmir's Handwara, said.

He said he had expected a politically viable and "economically vibrant" budget, and not a routine statement of outlay and expenditure.

"Even the promised 200 units of electricity are only for AAY beneficiaries and are linked to the Centrally Sponsored Rooftop Scheme, which has approximately a 65 per cent Central share with a cap of 3

kW. Too many strings attached," he stated. The Peoples' Conference chief said linking social welfare payments to Dearness Allowance means, "We have to pray for a miraculous zero inflation for real increase."

"Petrol and diesel prices are set to increase by Rs 1 per litre and Rs 2 per litre, respectively, due to a reduction in rebates on petrol and diesel," he claimed.

The Handwara MLA also said the budget neglected "key employment sectors," emphasising that it offered nothing for job creation, daily wagers, contractual employees, or minimum wages.

He asserted that "the soul of statehood, which we believe was stolen from us, was relegated to yet another statistic."

In a jibe at the chief minister for praising Prime Minister Narendra Modi, Union Home Minister Amit Shah, and Union Finance Minister Nirmala Sitharaman, Lone said "the saga of love letters continues. This is a love letter to BJP-Part II."

The J&K unit of the BJP accused the NC government of "deceiving" the people of the Union Territory.

"The budget is nothing but jumla bazi and a stark betrayal of the promises made during the elections. Where are the 12 free gas cylinders that Omar Abdullah promised? Where is the one lakh job guarantee? Where is the free ration? This budget is a cruel joke on the people of J&K," BJP's J&K spokesperson Altaf Thakur said in a statement.

The BJP leader too slammed the government for offering 200 units of free electricity only to AAY beneficiaries, which he said covers just 1.5 percent of J&K's population.

"This is outright deception. Omar Abdullah came to power by making grand announcements, but his government has failed on every front. The people will not forgive this betrayal," Thakur said.

He said the budget is nothing but a "desperate attempt to cover up the NC government's incompetence.

'It is strange that on the one hand, the Union Territory of I&K has prayed before the Apex Court for quashment of the judgment of this Court quashing provisions relating to reservation in promotion, stating that the basis of the judgment of this Court that the provision enabling the State Government to enact provision, providing or reservation in promotions had not be applied to the erstwhile State of Jammu and Kashmir has eviscerated, whereas on the other hand the Respondent No. 3-General Administration Department has come up with the Circular No. 10-JK(GAD) of 2021 dated 05.03.2021 directing all the Administrative Secretaries to keep the slots meant for reserved category employees 2025 vacant/unfilled," the court said, adding, "It is not comprehensible as to how the said directions can be passed in utter disregard to the constitutional provisions applicable to the UT of J&K with the application of the constitutional provi-

The court said that applying the directions issued in terms of Circular dated 5 March 2021 "in denying benefits of reservation in promotion in J&K amounts to denying/treating reserved category employees/candidates of the UT of J&K differently than the reserved category employees/candidates of the rest of the Country, which amounts to class legislation, which is antithetical to the concept of equality laid down in the Constitution of India."

Referring to an affidavit filed by the government before the Apex Court with regard to its intentions to implement the reservation in promotions, the court said, "therefore denying reservation to all the members of the service, who are entitled to such reservation in promotions, amounts to denying them of their constitutions in the constitution of the constitutions are also such reservation of their constitutions are also such reservations."

"In absence of collecting any quantifiable data ...., the respondents (authorities) shall proceed to consider the petitioners for reservation in promotions against the reserved slots in view of Jammu and Kashmir Reservation Act, 2004 and rules framed thereunder till the exercise for collection of quantifiable data is made by the Administrative Departments", " the court said, adding, "The respondents are restrained from making any promotions unless candidates belonging to the SC/ST reserved categories entitled for consideration for reservation in promotions are considered.

## **Kashmiri Youth Trapped** in Myanmar, Traffickers **Demand Ransom**

SRINAGAR: What began as a journey for a better future has turned into a nightmare for Faizan Rasool, a 28-year-old from Safakadal, Srinagar. Promised a job in Thailand, he instead found himself trafficked into Myanmar, where he is now being held for ransom by abductors demanding ₹4.5 lakh for his release.

His family, struggling to make ends meet, is desperate and powerless. "He left home with dreams in his eyes... now we don't even know if he's alive," sobs his mother, clutching an old photograph of her son.

Faizan's ordeal began when a friend lured him with the prospect of overseas employment. Instead of reaching Thailand, he was trafficked across dangerous borders and abandoned in Myanmar-a region notorious for human trafficking and organized crime. His abductors now control his fate, threatening dire consequences if the ransom isn't paid.

His family is not alone in their suffering. Another Kashmiri youth-also named Faizan-recently returned home after paying the same ransom amount. His family, among the poorest in their neighborhood, is now buried under debt.

## **CM Proposes Allocation Of ₹15Cr For Flood Risk Monitoring Press Trust Of India**

JAMMU: Jammu and Kashmir Chief Minister Omar Abdullah Friday proposed an allocation of Rs 15 crore for monitoring glacial lake outburst flood risk, setting up early warning systems and mitiga-

He forwarded the proposal in his budget speech in the legislative assembly, recognising the rising threats of glacial lake outburst floods (GLOF) and landslides.

"Our Government is taking proactive measures to protect vulnerable communities and infrastructure from GLOFs and landslides. I propose an allocation of Rs 15 crore for GLOF risk monitoring, early warning systems, and mitigation strategies,' the chief minister said.

Additionally, under the National Landslide Risk Mitigation Programme (NLRMP), Rs 15 crore is earmarked for risk assessment, monitoring and engineering solutions

The chief minister said the 2014 floods in the Kashmir valley highlighted the need for proactive disaster mitigation.

"To enhance resilience, our government is establishing a Rs 39-crore Disaster Mitigation Fund, the first dedicated fund for prevention, early warning systems, and preparedness.

"By investing in tools, manpower, and infrastructure, we aim to reduce risks and safeguard lives and property across Jammu and Kashmir," he said.

perusal of a report by Ladakh Autonomous Hill Development Council, Kargil, contending that the administration of Ganderbal and officials of Police Station Sonmarg often allow tourist vehicles upto zero point of Zojila Pass while restricting passenger vehicles from Ladakh, leading to traffic congestion and endangering lives on this treacherous route. While advocating the environmental regulations and protections to preserve the unique ecological balance of the area, LAHDC Kargil also stated that the Wildlife Warden, Kargil vide his report dated 24 October 2024 has also shown concern about the increased tourism

and human activity in the fragile ecosystem of Ladakh, which has an adverse impact on the unique flora and fauna in this specific area.

The court also reproduced a relevant portion of the report: "Habital Destruction: The unregulated tourism and increased human activities in the fragile landscape could lead to the destruction of natural habitats. This could impact species that are already adapted to the area's harsh climate and sensitive ecosystem, potentially leading to loss of biodiversity. The area is home to species like Himalayan Brown Bear, Long Tailed Marmots."

Referring to disruption of Wildlife migration and Breeding Patterns, the report said that increased human presence and activities such as moving in the habitat zones, usage of vehicles could disrupt the natural migration and breeding routes of

"Many animals rely on specific migratory patterns for survival and interference in these patterns could lead to population decline."

As regards pollution, the report said that heavy traffic, especially from vehicles, may lead to air and noise pollution.

littering from increased tourism can contaminate the region, affecting plant life and animals that depend on clean water sources and unpolluted

The court also noted submissions by amicus curiae that in and around Zojila Pass there are many illegal commercial activities being going on and their unchecked expansion may not only lead to detrimental consequences for the fragile high mountain pass ecosystem and indigenous communities, but also pose significant environmental and social challenges, besides threat of habitat disturbance and poaching risks.

Amicus Curiae also submitted that recreational activities such as sledging and using snow scooters in the snow-bound high mountain pass can not only disturb the snow and ice cover, leading to soil erosion once the snow melts, but also contribute to air pollution through emissions from fuel consumption and the snow itself become contaminated with exhaust particles, oil spills, and other pollutants, thus posing a serious threat to ecological balance.

The court was hearing a Public Interest Litigation, treating a letter addressed by one Abdul Wahid in his capacity as Councillor, 2-Bhimbet Constituency, Ladakh Autonomous Hill Development Council, Kargil.

The letter dated 1 July 2024 under the subject "Save Ladakh's Environment, Ecology and Land from Encroachers and Resolve the Boundary Dispute between District Kargil Of UT Ladakh and District Ganderbal of J&K" had been addressed to the Chief Justice Abdul Wahid and same was placed before the Chief Justice who di-

## **J&K Struggles to Bridge Demand-Supply Gap**

SRINAGAR: Jammu and Kashmir is grappling with a severe power shortage, with an excessive gap of over 15% between electricity demand and the actual supply available to consumers. The shortfall, which peaks during winter months, continues to strain the region's energy infrastructure, forcing authorities to rely on external arrangements to mitigate the

According to official documents, the power deficit in J&K stands at approximately 14-16%, a figure significantly higher than the national average. The primary reason for the shortfall is the drop in electricity generation from hydropower plants during winters due to reduced water

**Improve Efficiency** 

A significant portion of J&K's power crisis is attributed to high transmission and distribution (T&D) losses, along with commercial losses due to power theft. Officials admit that these losses remain "substantial," but efforts are underway to improve the system and curb pilferage through enforcement drives.

Despite these challenges, the government has reported notable improvements in revenue collection and billing efficiency. By November 2024, revenue collection efficiency had increased to 81%, leading to a reduction in Aggregate Technical and Commercial (AT&C) losses to 18.82%—a key indicator of improved power

## **JK Schools Face Increase In Dropout Rate**

**SRINAGAR:** In a worrisome revelation, Jammu and Kashmir in the past two years is facing an ncrease in dropout rate at primary, upper primary and secondary school levels.

According to the official figures available, at primary level J&K was facing a dropout rate of 3.89 percent in the year 2022-23 at primary level that further increased to 8.87 percent in the year 2023-24.

It also states that that school at upper primary level, Jammu and Kashmir was facing a dropout rate of 2.65 percent in the year 2022-2023 and 4.23 percent in the preceding academic year.

According to the report, J&K is having a network of 24,241 schools including 18,724 government and 5,517 other management schools with a total enrollment of over 25.94 lakh students from Pre-Primary to class XII during 2023-24.

"Enrollment ratio has increased from 93.15 to 104.02 at Primary level, 66.55 to 68.93 at upper primary level and 58.66 to 60.85 at Secondary level from 2019-20 to 2023-24," it reads. –(KNO)

# Will Kohli, Rohit Retire After Champions Trophy Final Against NZ?

**NEW DELHI:** As anticipation builds for India's ICC Champions Trophy final clash against New Zealand in Dubai on March 9, the cricket world is abuzz with speculation surrounding the ODI futures of Virat Kohli and Rohit Sharma.

Former Indian cricketer Aakash Chopra has weighed in on the matter, suggesting that an ODI retirement for the two legends post-final would be understandable, though he remains uncertain about their

Following their retirement from T20Is after India's 2024 T20 World Cup victory, many believe a similar decision regarding ODIs could be imminent, regardless of the Champions Trophy outcome.



Speaking on his YouTube channel, Chopra addressed the swirling rumours, highlighting the complexities influencing their potential choices.

'It's entirely up to them. I will be very honest, it's not going to be easy. In 2025, Kohli's performance with the bat has been outstanding and Rohit's has been okay, okay. I won't say his performance is very good. He might change the scenario by scoring a hundred in the final,' Chopra stated, acknowledging the players' varying form in the lead-up to the final

'Someone asked me whether they would retire. I said I don't know. Their retirement after winning the T20 World Cup seemed slightly logical and it was along expected lines.

'It wasn't shocking, but here if they leave both T20Is and ODIs, only Tests will be left then. Will they go down that route? Who knows.

'The (ODI) World Cup is still two years away, and two years is a long time. Two years is a longer time when you are not playing the T20 format as well, although, to be fair, many ODIs have been kept in the coming 12 months. So they will remain involved,' Chopra predicted.

At 36 and 37, Kohli and Rohit face the daunting task of committing to another three-year cycle, raising questions about their longevity and India's tran-

Whether the Champions Trophy final marks the culmination of their ODI careers remains uncertain, but their decision will undoubtedly have a profound impact on the future of Indian cricket.

JAMMU: Aiming to give sports a major lift, Chief Minister Omar Abdullah on Friday announced a budgetary allocation of ₹152.69 crore for 2025-26 while announcing several

developmental initiatives. The CM told the Legislative Assembly that National Centres of Excellence for Water Sports will be established at Dal Lake in Srinagar and Basohli in Jammu. He said his government is prioritizing water sports promotion, including kayaking, ca-

noeing and paddle boating.
"Tourism assets at Manasbal are being enhanced, and jet skiing, speed boating and houseboats are being developed at Ranjit Sagar Lake," he said. He added that the Z-Morh Tunnel

has made Sonamarg an all-weather destination, "unlocking its potential for international standard skiing and ice-skating facilities."

The CM added that a Gymnastics Academy will be set up at Gindun Rajbagh and Khel Gaon, Nagrota.

Four state-of-the-art cricket academies will be also established with a budgetary allocation of ₹8 crore. Two new Youth Hostels, one each in Jammu and Kashmir, will be constructed with a provision of ₹10

crore. High-Performance Training Centers will be developed in all districts.

He added that to promote mass participation, "we aim to engage 75 lakh youth in sports activities across Jammu & Kashmir." "We are developing 247

playfields, stadiums, and sports courts across the region, along with the construction and upgradation of 19 sports buildings," the CM said.

The CM said two new swimming pools will also be commissioned in both capital cities. He said that dedicated sports facilities will be created for migrant populations to ensure inclusivity, while special emphasis will be placed on involving the rural and tribal population in games.

"Our vision is to make sports an integral part of community development, ensuring participation from all sections of society," Omar said.

### **NZ Pacer Matt Henry Doubtful For CT Final Against India**

New Zealand pacer Matt Henry has been rendered doubtful for the Champions Trophy final against India owing to a shoulder niggle but coach Gary Stead is hopeful that the in-form bowler will recover in time for the clash on Sunday.

Henry leads the tournament's top wicket-takers' list with 10 scalps, including a 5/42 against India in their group match.

The 33-year-old injured himself when he landed on his shoulder during the semifinal against South Africa in Lahore on Wednesday.

The coach was hopeful that Henry would be ready in time for the final.

New Zealand lost only one match during the preliminary engagements, against India. Henry's figures in that game are the best of the tournament so far.

### **Stokes In Contention For England's Next White-Ball Captain**

England Test captain Ben Stokes is in contention to become the country's next limited-overs skipper, replacing Jos Buttler, as ECB director Rob Key feels it would be "stupid" not to consider the talismanic allrounder, who has proven himself to be an "unbelievably good tactician".

Buttler resigned as England's white-ball captain midway into the Champions Trophy where the team failed to log a single win. This was just a few days after the side was hammered by India in a limited-overs away rubber. The 33-year-old Stokes missed the Champions Trophy due to a hamstring injury.

He has not played ODIs since the 2023 World Cup,

where he reversed his initial decision to retire from the format.

Stokes is currently in Abu Dhabi recovering with an England Lions training group and is expected to be fully fit for the summer assignments, which include a five-Test series against India in June-July-August.

### **Chelsea's 2024 Squad Most Expensive Ever In Europe: UEFA**

Thelsea's squad at the end of the 2024 financial year was the most expensive ever assembled in Europe in terms of transfer fees, according to a report released by governing body UEFA.

The "European Club Finance and Investment Landscape" report said Chelsea spent 1.656 billion euros (\$1.79 billion) on combined transfer costs.

That comfortably surpassed the value of Manchester United's squad in 2023, which cost 1.42 billion euros to assemble, and the 1.33 billion euros spent by Real Madrid, which was the highest squad cost in 2020. Chelsea have signed 41 players since Todd Boehly

and Clearlake Capital bought the club in 2022. According to the report which analyses all of Europe's top divisions, Real Madrid (1,073 million euros), Manchester City (854 million euros), Paris St Germain (808 million euros). Manchester United (771 million euros) and Bayern Munich (765 million euros) had the highest revenues in 2023.
