Video Of Police 'Kicking' Women Spark Outrage

Srinagar: A viral video showing a police officer assaulting women protesters in Kulgam has triggered widespread outrage, leading to protests inside the Jammu and Kashmir Assembly.

Members of the PDP and the NC on Monday raised in the Jammu and Kashmir Assembly the issue of the deaths of two brothers, who were among three people

missing since last month and demanded a high-level probe.

JKSSB, JKPSC Fill 11,526 Posts In 2 Yrs: Govt

Denies Any Paper Leak Scandals

Jammu:The Jammu and Kashmir Public Service Commission (JKPSC) and I&K Services Selection Board have collectively filled 11,526 vacancies over the past two years, the government informed the Legislative Assembly.

In response to a query by MLA Bashir Ahmad Veeri, the government stated that JKPSC recruited 2,175 candidates between 2023 and 2024. This included 1,291 from the Open Merit (OM) category, 162 from Scheduled Castes (SC), 180 from Scheduled Tribes from Residents of Backward Areas (RBA), 60 from ALC/IB, 56 from SLC, 66 from PSP, 116 from **Economically Weaker Sections** (EWS), and 24 from Persons with Disabilities (PHC).

Hydro Expansion, Smart Meters & Grid Revamp 24x7 Power For J&K: Omar Plans 3GW Boost By 2027

Iammu: Iammu and Kashmir Chief Minister Omar Abdullah on Monday said a well-coordinated plan which includes modernisation works in transmission and distribution system is under implementation to ensure 24x7 power supply to the consumers in the Union Territory.

Abdullah also said that no major progress has been achieved in the development of a coal block in Odisha. The coal block was allocated to J&K State Power Development Corporation (JKSPDC) jointly with NTPC in July, 2013 by the

Union Ministry of Coal. Of the total estimated geological reserves of 396 MT, 266 MT was allocated to NTPC and 130 MT to JKSPDC.

When Will Vande Bharat Finally Reach Kashmir? Ruhullah

Jammu: National Conference MP Aga Syed Ruhullah Mehdi on Monday questioned the government over the delay in launching the Delhi-Srinagar Vande Bharat train, asking why promised deadlines have been repeatedly missed.

Speaking in Parliament during a discussion, Ruhullah said that there was no clarity on when the direct train service would begin.

'We were told that the Vande Bharat train from



Delhi to Srinagar would start by January 26. Later, multiple dates were floated in the media, yet nothing has materialized," Ruhullah said, pressing the government for a definitive answer.

The National Conference

MP also raised concerns over reports suggesting that passengers may have to switch trains at Jammu or Katra, instead of a direct service to Kashmir. "Why this inconvenience? Why should Kashmir be treated differently?" he asked.

Ruhullah recalled that the railway minister had previously justified the non-operational status of the train by citing extreme winter conditions in Kashmir.

Assembly Passes Business Advisory Report

Jammu: The Jammu and Kashmir Legislative Assembly on Monday unanimously approved the recommendations of the Business Advisory Committee (BAC) regarding the House's business schedule.

The motion was moved by Member Mubarak Gul and was put to a voice vote by Speaker Advocate Abdul Rahim Rather, receiving unanimous support.

According to the BAC recommendations, House sittings on March 17, 22, and 24, 2025, will run from 10:00 AM to 5:00 PM, with a one-hour break from 1:30 PM to 2:30 PM. Additionally, the Government business initially scheduled for April 11 has been rescheduled to March 25, 2025.

To ensure efficient proceedings, the BAC has mandated that if Ministers choose to read written replies to Demands for Grants, those replies must also be circulated among all members.

Alcohol Consumption In Katra

SM Influencer Among 7 Booked

Jammu: Jammu and Kashmir Police have booked social media influencer Orhan Awatramani, popularly known as Orry, and seven others for allegedly consuming alcohol at a hotel in Katra, the base camp for the Mata Vaishno Devi pilgrimage. The incident has triggered widespread outrage, with political leaders demanding strict action.

According to officials, a complaint was lodged at Katra police station on March 15, alleging that guests at a hotel were consuming alcohol in violation of local rules. An FIR was subsequently registered against the accused, identified as Orhan Awatramani. Darshan Singh, Parth Raina, Ritick Singh, Rashi Dutta, Rakshita Bhogal, Shagun Kohli, and Anastasila Arzamaskina.

"Despite being informed that alcohol and non-vegetarian food are strictly prohibited in Katra due to its religious significance, the group consumed liquor on the hotel premises," a police officer said.

How Much Sleep Do You Really Need? Experts Say It Depends

■hances are, if you're reading this, you got some sleep last night. But are you feeling rested?

Experts say it's an important question to consider.

Most of us spend a third of our lives sleeping, but you may need more or less than eight hours a night. Here's what sleep scientists and doctors say about how much you really need - and whether your gender plays a role.

Sleep quality over quantity Sleep is still a mystery, despite how critical it is for our health.

"The reasons aren't entirely clear, but it's an essential thing that we all do," said Dr. Rafael Pelayo, a sleep specialist at Stanford University.

remarkable "Something happens when you sleep. It's the most natural form of self-care that we have.'

Most of the population gets between seven to nine hours — and that particular category has the lowest association with health problems, said Molly Atwood, a behavioral sleep medicine clinician at Johns Hopkins.

Once people either dip into less than six hours of sleep or get more than nine hours on average, the risk of health problems inches up, Atwood said, but everybody is different.

When you're trying to figure out how much sleep you need, it's important to think about the quality of it, Pelayo said: "What you really want to do is wake up feeling refreshed - that's what it's about."

"If somebody tells me that



they wake up tired, something is wrong," Pelayo said. 'You shouldn't leave your favourite restaurant feeling

How much sleep we need changes

The amount of sleep we need changes throughout our lives. Newborns need the most – somewhere be-

tween 14 to 17 hours. "Definitely when we're babies and children, because we are growing so rapidly, we do need a lot more sleep," Atwood said.

The National Sleep Foundation recommends most adults between 26 and 64 get between seven to nine hours of sleep. People who are 65 and older can get slightly less, and young adults between ages 16 and 25 can get slightly more.

Humans cycle through sleep stages roughly every 90 minutes. In the first portion of the night, Atwood said that more of the cycle is slow wave sleep, or deep sleep, which is essential to repairing and restoring the body. It's also when "growth hormone" is released.

In the latter hours of the night, more of the sleep cycle is spent in rapid-eye movement sleep, or dream professor who studies sleep at UC Berkeley.

Hormones may also impact women's sleep quantity and quality during pregnancy and menopause.

"With menopause in particular, women can develop deterioration in their sleep with an increased number and duration of nighttime awakenings," said Dr. Mithri Junna, a Mayo Clinic neurologist who specializes in sleep.

Atwood said women may also need more sleep right before their menstrual cycle. There are definitely times that your body's telling you that you need more sleep,' she said. "It's important to

When to seek help

sleeping You'll know if you're not getting enough sleep if you're feeling grumpy, irritable and inattentive. Long-term, those minor symptoms can become serious problems even deadly

"If you're not getting enough sleep or you have untreated insomnia or sleep apnea, your risk of depression increases," Atwood said.

'Your risk of cardiovascular issues like high blood pressure, risk of heart attack and stroke increases. Your immune system is compromised. You're at greater risk for Alzheimer's.'

If you're getting the recommended amount of sleep every night but still waking up feeling tired, you might consider going to your primary care physician.

They can rule out other health conditions that may affect your sleep, Atwood said. But if problems persist, seeking out a sleep specialist could be helpful.

Centre Yet To Approve Revised DPR For Srinagar Metro, Delaying Project

Approval for Rs 4893 Crore Proposal Still Pending with MoHUA

SRINAGAR: The long-anticipated Srinagar Metro Project, expected to alleviate traffic congestion and enhance urban mobility in the city, remains in limbo as it awaits clearance from the Ministry of Housing and Urban Affairs (Mo-HUA), Government of India.

In response to a question raised by MLA Tanveer Sadiq in the Jammu and Kashmir Legislative Assembly, the Housing and Urban Development Department disclosed that the revised Detailed Project Report (DPR), amounting to Rs 4893 crore and prepared by M/s RITES Ltd., has been submitted to the central ministry. However, the proposal has yet to receive official approval, stalling progress on the ambitious transit

Authorities further confirmed that, as of now, no discussions have been initiated with the Delhi Metro Rail Corporation (DMRC) or any other agency regarding the


project's execution and implementation since it remains stuck at the approval stage. Given the current status, setting a fresh timeline for its completion is not feasible.



Trump Freezes US-Funded Media Outlets Including Voice Of America

WASHINGTON: President Donald Trump's administration on Saturday put journalists at Voice of America and other US-funded broadcasters on leave, abruptly freezing decades-old outlets long seen as critical to countering Russian and Chinese informa-

tion offensives. Hundreds of staffers at VOA, Radio Free Asia, Radio Free Europe and other outlets received a weekend email saying they will be barred from their offices and should surrender press passes and office-issued equipment.

Trump, who has already eviscerated the US global aid agency and the Education Department, on Friday issued an executive order listing the US Agency for Global Media as among "elements of the federal bureaucracy that the president has determined are unnecessary.

Kari Lake, a firebrand Trump supporter put in charge of the media agency after she lost a US Senate bid, said in an email to the outlets that federal grant money "no longer effectuates agency priorities.

The White House said the cuts

would ensure "taxpayers are no longer on the hook for radical propaganda," marking a dramatic tone shift toward the networks established to extend US influ-

White House press official Harrison Fields wrote "goodbye" on X in 20 languages, a jab at the outlets' multilingual coverage.

VOA director Michael Abramow itz said he was among 1,300 staffers placed on leave Saturday.

"VOA needs thoughtful reform, and we have made progress in that regard. But today's action will leave Voice of America unable to carry out its vital mission," he said on Facebook, noting that its coverage - in 48 languages — reaches 360 million people each week

The head of Radio Free Europe/ Radio Liberty, which started broadcasting into the Soviet bloc during the Cold War, called the cancelation of funding "a massive gift to America's enemies." "The Iranian ayatollahs, Chinese communist leaders, and autocrats in Moscow and Minsk would celebrate the demise of RFE/RL after 75 years," its president, Stephen Capus, said in a



Modi Conveys Concerns To Kiwi PM Over Anti-India Activities In New Zealand

New Delhi: India and New Zealand on Monday inked a pact to institutionalise their defence ties and vowed to boost cooperation in the Indo-Pacific even as Prime Minister Narendra Modi flagged concerns to his Kiwi counterpart Christopher Luxon over certain unlawful elements indulging in anti-India activities in the island nation.

Following talks between Modi and Luxon, the two sides signed six agreements to ramp up cooperation in several including education, sports, agriculture and climate change, and decided to prepare a roadmap for cooperation in

the defence industry sector. In his media statement, Modi said India and New Zealand support a free, open, secure and prosperous Indo-Pacific, adding "we believe in the policy of development, not expansionism", remarks that came amid growing global concerns over China's expansionist behaviour in the region. The two leaders reaffirmed their commitment to supporting an Indo-Pacific where sovereignty and territorial integrity are respected, according to a joint statement.

Luxon arrived in the national capital on Sunday on a fiveday visit primarily to push for deeper economic engagement between the two sides.

Both prime ministers welcomed the launch of negotiations for a "balanced, ambitious, comprehensive, and mutually beneficial2 free trade agreement (FTA) lenge of irregular migration. according to a joint statement. In his remarks, Modi, referring to the 2019 Christchurch terror attack and the 26/11 Mumbai strike, said that terrorism in any form is "unacceptable"

"In this context, we shared our concern about anti-India activities by some illegal elements in New Zealand. We are confident that we will continue to get the cooperation of the New Zealand government against all these illegal elements," he said.

Modi said both sides decided to strengthen and institutionalise defence and security partnership and a roadmap will be prepared for cooperation in the defence industry sector.

Women, Children Killed In US Airstrikes Targeting Ansarallah Leadership In Yemen

Sanna: The airstrikes carried out by US and UK warplanes overnight were part of a new campaign to "take out" leaders of the Ansarallah resistance movement and "hold Iran accountable" for supporting them, a top White House official said on 16 March.

"This was an overwhelming response that actually targeted multiple Houthi [Ansarallah] leaders and took them out," Trump national security adviser Mike Waltz said on ABC's "This Week" on Sunday.

Most of the 31 people killed in the strikes were women and children, said Sanaa's health ministry spokesperson Anees al-Asbahi on Sunday, who also reported 101 oth-

ers wounded. "Targeting civilians proves US weakness; this will not deter us from supporting Gaza but will instead escalate the situation to something even stronger and more severe," said the Yemeni Supreme Political Council in a statement.

The difference between strikes targeting Yemen under Trump compared to those carried out under former president Joe Biden is that the US is now "going after the Houthi leadership and holding Iran responsible," Waltz stated.

'We inherited a terrible situation, and this is one of what will be a sustained effort to right that wrong and to reopen global commerce," he added.

Trump also warned Iran to end military support for Ansarallah. He said if Iran threatened the

United States, "America will hold you fully accountable, and we won't be nice about it!"

Delhi HC Directs Centre on Plea to Rename India as Bharat

New Delhi: The Delhi High Court has asked the Centre to expeditiously comply with an order of the Supreme Court for considering a representation for amending the Constitution and replacing the word India with "Bharat" or "Hindustan". Justice Sachin Datta also allowed the petitioner to withdraw his petition in this regard.

The order passed on March 12 said, "After some hearing, senior counsel for the petitioner seeks to withdraw the present petition with leave to pursue the matter with the ministries concerned for disposal of the petitioner's repres in terms of the order dated June 3, 2020 passed by the Supreme Court...the present petition stands dismissed as withdrawn." The Centre's counsel should appropriately convey to the ministries concerned for expeditious compliance of the order passed by the Supreme Court, it added.

The petitioner had initially approached the Supreme Court, which in 2020, directed the petition be treated as a representation that could be considered by appropriate ministries.

Petitioner Namaha, represented by senior advocate Sanjeev Sagar, then moved the high court for a direction to the authorities to decide his representation.

The Boeing Starliner capsule encountered so many problems that NASA insisted it come back empty, leaving its test pilots behind to wait for a SpaceX lift.

While the seven space station residents prepared for the new arrivals, one of the Russians — Ivan Vagner — briefly put on an alien mask in a lighthearted moment. Wilmore swung open the space station's hatch and rang the ship's bell as the new crew floated in one by one and were greeted

Wilmore's and Williams' ride arrived back in late September with a downsized crew of two and two empty seats reserved for the leg back. 'Indian Railways Providing High-**Quality Services To Passengers'**

NEW DELHI: Union Minister for Railways, Information & Broadcasting, Electronics & IT, Ashwini Vaishnaw, highlighted the achievements and future plans of Indian Railways during a discussion in the Rajya Sabha on Monday. He stated that Indian Railways is providing safe and high-quality services to passengers at affordable fares while securing a leading position globally.

Comparing Rail fares, he mentioned that fares in Pakistan, Bangladesh and Sri Lanka are higher than in India, while in Western countries, rail fares are 10-20 times higher than in India.

On the subsidy provided to passengers, the Railway Minister said that while the cost of train travel per kilometer is ₹1.38, passengers are charged only 73 paise, meaning a subsidy of 47% is provided. In the financial year 2022-23, passengers received a subsidy of ₹57,000 crore, which increased to approximately ₹60,000 crore in 2023-24 (provisional figures). He emphasised that the goal is to provide safe and improved services at minimal fares.

Highlighting the benefits of Railway electrification, the Minister noted that despite an increase in the number of passengers and cargo, energy expenses have remained stable.

Indian Railways aims to achieve Scope 1 net zero emissions by 2025 and Scope 2 net zero emissions by 2030. This non-fossil energy-based goal will completely offset the Railway's carbon emissions.

The Railway Minister also announced that locomotives manufactured at the Madhepura factory in Bihar will soon be exported. Indian Railways is exporting passenger coaches to Mozambique, Bangladesh and Sri Lanka, while locomotives are being exported to Mozambique, Senegal, Sri Lanka, Myanmar and Bangladesh.

Additionally, bogie underframes are being exported to the United Kingdom, Saudi Arabia, France and Australia, while propulsion parts are being sent to France, Mexico, Germany, Spain, Romania and Italy.

This year, India produced 1,400 locomotives, surpassing the combined production of the

U.S. and Europe. Additionally, 200,000 new wagons have been added to the fleet. The Railway Minister stated that in FY 2024-25, Indian Railways will transport 1.6 billion tons of cargo, making it one of the world's top three freight carriers, alongside China and the U.S. This underscores the increasing capacity of Indian Railways and its crucial role in the logistics sector.

He further stated that 41,000 LHB coaches have been manufactured with a strong focus on railway safety.

During Prime Minister Narendra Modi's third term, all ICF coaches will be replaced with LHB coaches. The implementation of long Rails, electronic interlocking, fog safety devices and the 'Kavach' safety system is progressing rapidly.

Expressing gratitude to Prime Minister Narendra Modi, Mr. Vaishnaw mentioned that earlier, Indian Railways received ₹25,000 crore in financial support, which has now increased to ₹2.5 lakh crore. This funding has led to significant infrastructure improvements, including the construction of 50 Namo Bharat trains designed for shortdistance travel, offering both AC and non-AC options.

Regarding the recent incident at New Delhi Railway Station, the Railway Minister informed the House that a high-level committee is investigating the unfortunate accident. All CCTV footage and relevant data have been secured and approximately 300 individuals have been interviewed to verify facts. Ten critical measures have been taken to prevent such incidents in the future.

The Railway Minister reiterated the government's commitment to serving the poorest sections of society. He emphasised that the number of general coaches is being increased to 2.5 times that of AC coaches.

Under the current production plan, 17,000 non-AC coaches are scheduled for manufacturing. He also stated that Indian Railways' financial position is strong, with continuous efforts to improve it. The Railway sector has successfully overcome challenges posed by the COV-ID-19 pandemic, with passenger numbers increasing and growth observed in both passenger and freight transportation.

Govt Committed To Strengthening Healthcare Infrastructure: Sakina Itoo

SRINAGAR: The Jammu and Kashmir government has reiterated its commitment to addressing gaps in the health sector and enhancing medical facilities in accordance with Indian Public Health Standards (IPHS) norms.

Responding to a query by MLA Daleep Singh Parihar, Health and Medical Education Department Minister Sakina Itoo stated that the administration is actively working to resolve the shortage of doctors across various healthcare institutions.

"Significant measures are being undertaken to fill vacancies for Medical Officers to ensure that healthcare services remain accessible to the public. Out of the 365 newly appointed Medical Officers, 14 have been assigned to District Doda, strengthening the



healthcare infrastructure in the region," Itoo said.

She further informed that 22 doctors are currently serving at healthcare centers including SDH Bhaderwah, SDH Gandoh, PHC Chinga, Bhella, Bhalla, Prem Nagar, Tapri, and Changa. Additionally, under the National Health Mission (NHM), 19 doctors have been deployed to further bolster medical services at these institutions.

"To reinforce healthcare delivery, 37 paramedics and nongazetted NHM staff have been deployed, ensuring that patients receive timely medical care and the infrastructure remains well-supported," she added.

Itoo also highlighted that the recruitment process for 181 Medical Officer positions is in progress through the Jammu and Kashmir Public Service Commission (JKPSC). "Once finalized, these doctors will be placed in health institutions facing acute shortages," she stated.

According to the Ministry of Health & Family Welfare's 2023 report, Jammu and Kashmir boasts 554 NTPHCs, making it one of the regions with the highest density of health institutions in the country. "J&K is dedicated to consolidating its existing healthcare network, which currently includes over 4,200 institutions spanning Primary, Secondary, and Tertiary levels," the minister emphasized.

A bench of Justices Surya Kant and N Kotiswar Singh asked the additional solicitor general Aishwarya Bhati to inform it about the time frame for the construction of the new high court building at Jammu for which land was allocated. Bhati offered to seek instructions on the issue and said for the time being CAT, Jammu could shift to a rented accommodation. The bench directed the Centre to provide sufficient staffers to the tribunal once it moved to the rented premises.

On January 2, the top court batted for a permanent building, along with permanent staff, for the Jammu and Kashmir CAT, saying it was prudent for the government not to deploy outsourced staffers in judicial and quasi-judicial bodies.

Why Another University? **Because Our Future Depends on It.**

ome argue that **Kashmir doesn't** need another university—that with 11 government-run universities, we should focus on bringing in industries instead. But this thinking gets the problem completely wrong.

It's **not** that we have run out of jobs. It's that our graduates aren't prepared for the jobs that exist. Employers don't hire degrees; they hire skills, innovation, and problem-solving ability—qualities that our current universities fail to instill. This is why thousands of our students remain unemployed despite holding degrees. We are not adding to the problem by **producing more graduates**—we are fixing the root cause by creating a university that actually prepares them for real-world opportunities.

Look at the world's top universities— Harvard, Stanford, MIT, Oxford, IITs, IIMs—none of them are just 'degree mills.' They are engines of research, innovation, and entrepreneurship. Why aren't their graduates jobless or their PhD's selling dry fruits on the road? So again, it's not that we have enough PhDs and other degree holders. The problem in J&K isn't that we have universities—it's that these universities fail to produce globally competitive graduates.

Also, it's not just about producing students for industry. It's about creating industries at home. Stanford alone helped create Silicon Valley, a global tech powerhouse. Imagine what Kashmir could achieve if we built an ecosystem that nurtured job creators, innovators, and industry leaders rather than just job seekers. We have not understood the

massive role of universities in nationbuilding. This is because our universities have not shown it to us. We think universities are simply big colleges. So we tend to think all universities must be the same.

Every major innovation—from AI medical breakthroughs—comes from universities with strong research foundations.

What role have our current universities played in shaping our economy? Have they provided groundbreaking models to the government for economic growth? Declining Militant Numbers

he number of active militants in Jammu and Kashmir has shrunk to 76, a report has revealed. About 59 of these are from Pakistan and just 17 are local - 3 in the Jammu region and 14 in the Valley. Among the foreigners, three are said to belong to Hizbul Mujahideen, 21 to Jaish-e-Mohammed (JeM) and 35 to Lashkar-e-Taiba. Official data, on the other hand, has indicated a significant drop in youth taking up guns, marking the lowest figures in 15 years. This is for the first time since 2011-12, that the number of active local militants has fallen to single digits, taking forward a trend from 2023 and 2024, with only one new recruit recorded in 2025 so far.

The drastically reduced number of militants has, in turn, resulted in a corresponding drop in the levels of violence, much more so in the plains. True, there have been occasional spikes in attacks but even these are growing now fewer and far between. Would this trend sustain? There's hope that it will, although such moments in the past haven't been built upon but frittered away. For example, the number of militants - both local and foreign - had, more or less, declined to the same levels in 2011. This had momentarily ushered in a peaceful environment. But the numbers surged again from thereon, especially the local recruitment, with south Kashmir as its hub. And by 2015, we had over 300 local militants in the Valley. However, the situation since has drastically metamorphosed, and, on their face, the things seem unlikely to go back to square one. But, it is also true that Kashmir remains an uncertain place.

The air in J&K is now filled with hope and a sense of foreboding. In recent years, Kashmir has transformed in most of its aspects. It is now easier to predict the continuation of the existing normalcy but the place can still surprise with its unpredictability. Last year, dramatic attacks claimed the lives of several security personnel and broke the prevailing calm. However, the occasional spikes in violence didn't detract from the larger drift of normalcy. It is this normalcy in the UT that made possible the peaceful Assembly elections after the break of a decade.

Looking back at the last five years, the two trends have largely undergirded the current calm: one is the steady decline in militancy and another is the growth in tourism. Going by the government data, millions of tourists have visited the union territory, something that has lifted the local economy otherwise crippled by the extended post Article 370 blockade followed by the COVID-19 shutdown.

The current hybrid governance has succeeded in building on these security and economic gains. The central government has also made it known that it is working on a comprehensive security and development roadmap for the UT which hopefully will further improve the situation, and usher in lasting peace and prosperity. But, at the same time, it is important that the elected government is given its due precedence in the matters of governance, and which won't be possible unless J&K is returned its lost statehood.


Fondly, Forever

ashir Ahmad Shah might have been a Bparamedic by profession but through his dedication to serve his people, he was a character one only comes across in legends and folktales. Destiny shapes such individuals but once in generations. In him the people of Rohama Rafiabad not just lost a dedicated paramedic but also a father fig-

I remember a dreadful yet amusing episode when a severe toothache kept me riling with pain all night and Bashir Ahmad Shah (Mama as we called him) decided to take me to a dentist he knew in the newly opened Sub-District Hospital of Baramulla the next morning. As we reached the dental section of the hospital, the employees there got up and greeted with respect and rever-ence a former colleague of theirs. Known for his sharp wit and a scathing sense of humor, Mama sat beside me as I lay on that peculiar dentist's chair, its recline unusually long, awaiting my dental examination. The drill buzzed in my mouth as the doctor cleaned the cavities to be filled with the new Zinc Oxide filling. I was shrieking with pain and I heard Mama whispering in my ears the words I will never forget: 'Eat more toffees'. Ten years later, the Zinc Oxide filling is still buried in my teeth but Mama is

Bashir Ahmad Shah joined the department of Health in 1970's as a 'Khidmadgar' but his father, Peer Saif Ud Din Shah, had entirely different notions of his only son. For him he was a pampered dreamer, someone who was well cared for but hadn't yet settled on a clear path in life. On his first posting in tehsil Handwara, Mama had barely stayed for a week and had come home in protest about the job being too hectic and difficult.



At his uncle Abdul Ahad Shah's insistence, he reluctantly returned to work.

He took him to Handwara and placed him under the guidance of a trusted doctor.

remarkable man. His life and service touched many, nearly all of whom gathered for a final glimpse of him before he embarked on his eternal journey

What began as a profession he initially disliked soon became his true calling, one he would grow to love passionately for the rest of his life.

The decade of 90's was the one marred with strife and terror in Kashmir and in our village of Rohama (in Rafiabad) the only healthcare provider was Bashir Ahmad Shah. To the people, he was nothing less than a doctor. In an era when stepping outside after dark was unthinkable, Mama fearlessly tended to his patients, unwavering in his commitment. He had a unique habit of sleeping in the room closest to the main entrance in order to ensure that he would immediately hear if someone knocked at night. It was a time of such fear that even opening the gates felt daunting, let alone venturing out to care for the sick and injured.

His family would often worry for him and at times scold him for putting his life in danger but he wouldn't listen. When asked if he ever feared going out with patients at night amid such strife and turmoil he would laughingly reply that 'the nerve that carries the emotion of fear to one's mind didn't exist in me.' At times in order to sneak out of his home at night without waking up his family he would escape through a window and come back through the same, so that the family wouldn't know in the morning what had transpired in the night. A dedicated public servant whose commitment went far beyond the confines of a 10-to-4 workday would be an apt description of him.

Reacting to a condolence post, a facebook user and a respected teacher of Rohama, Mr Gulzar Ahmad Bhat wrote: 'Bashir Sahab was a noble soul who rendered unforgettable service in almost every household of Rohama. I remember a day in 1986 when I had a shooting pain and was crying for relief, my father took me to his home at around 2am in the morning. In a few knocks on his gate, Bashir Sahab opened the door, examined me and gave me an injection. I felt relieved in a few minutes. In Bashir we lost an apostle of humanity whose vacuum would take generations to fill.'

Thousands of people carry countless stories about this remarkable man. Study Raises Possibility Of Country Without Butterflies

"Action must be taken," said Elise Zipkin, a Red Cedar Distinguished Professor of quantitative ecology at Michigan State University and a coauthor of the paper.

"To lose 22 percent of butterflies across the continental U.S. in just two decades is distressing and shows a clear need for broad-scale conservation interventions," Elise added.

In this paper, Zipkin and Haddad were among a working group of scientists with the USGS Powell Center for Analysis and Synthesis who aggregated decades of butterfly data from 35 monitor programs, including records of over 12.6

million butterflies. Using data integration approaches, the team examined how butterfly abundances changed regionally and individually for fornia tortoiseshell butterfly, which was enjoying a population boom not expected to be sustained.


"This is the

definitive study of butterflies in the U.S.," said Collin Edwards, the study's lead author. "For those who were not already aware of insect declines, this should be a wake-up call. We urgently need both local- and national-scale conservation efforts to support butterflies and other insects. We have never had as clear and compelling a picture of butterfly declines as we do now.'

Edwards had been a postdoctoral research associate at Washington State University, Vancouver, and now works at the Washington Department of Fish and Wildlife. The results reveal that 13 times as many species declined as increasedwith 107 species losing more than half their populations.

Indian-Made Gene Therapy For Blood Cancer Shows 73% Response Rate In Clinical Trials

ew Delhi: An indigenously developed gene therapy for specific blood cancers has shown a 73 per cent response rate among patients in India, according to results of clinical trials published in The Lancet Haematology journal.

Known as 'CAR T-cell therapy', the treatment involves modifying genes in one's T-cells -- a type of immune cells -- to help fight cancer. The study looked at patients with leukaemia, which occurs in bone marrow, and lymphoma, which affects the lymphatic system.

Researchers, including those from the Indian Institute of Technology-Bombay and Tata Memorial Hospital, Mumbai, said in low and middle-income countries, patients in whom 'Bcell' tumours continue to grow following a period of remission (relapse), or do not respond to treatment (refractory), suffer from poor outcomes due to an absence of effective therapies.

A type of white blood cell, Bcells are crucial to one's immune system as they produce antibodies to fight infections.

"The clinical trials of India's first gene therapy for cancer offer hopes of another chance to live among these patients, that there is one more drug that doctors can try," lead author Rahul Purwar, professor at IIT-Bombay and founder of Immuno ACT, told PTI.

'ImmunoACT', or Immuno-Adoptive Cell Therapy Private Limited, is a gene-modified cell therapy company, a spinoff of IIT Bombay

'CAR T-cells, just like normal T-cells, persist in the body for a long time. These cells help



to prevent a relapse," first author Dr Hasmukh Jain, professor of medical oncology, Tata Memorial Hospital, said.

The CAR T-cell therapy is also a cost-effective alternative to that available in the developed world, Purwar added.

"We developed it over a period of 11 years, starting with drug design and lab work, which was then translated into animal studies, before progressing to clinical trials," he said.

The injection 'talicabtagene autoleucel' is now approved in India, "available for USD 30,000," which is "less than one-tenth of the price of other approved CD19 CAR T-cell therapy products marketed worldwide", according to the research article.

In a linked commentary article, authors from the University of Pennsylvania in the US -- not involved in the study -- wrote that the approved CAR T-cell products cost USD 3,73,000 to 4,75,000, and clinical care and possible relocation expenses bring the total treatment cost to over USD 1 million.

"Therefore, access to CAR T-cell therapy is an important limitation to the success of this approach in not only high-income countries but particularly in low-income and middle-income countries," the research paper said.

In phase-1 of the India trials, talicabtagene autoleucel was injected into the veins of 14 patients aged 18 years or older having relapsed or refractory Bcell lymphoma. In phase-2 trials, the drug was given to 50 patients aged 15 years and older with relapsed or refractory B-cell leukaemia or B-cell lymphoma.

"Talicabtagene autoleucel had a manageable safety profile and induced durable responses in patients with relapsed or refractory B-cell malignancies," according to the research article.

"This therapy addresses an important unmet need for patients with relapsed or refractory B-cell malignancies in India," it said.

Jain said, the findings "give us an opportunity to test the therapy in the earlier settings and in combination with other immunotherapies".

These trials are now underway at the Tata Memorial Centre, he added.

Net Direct Tax Kitty Rises 13% To Rs 21.26 Lakh **Crore Till Mar 16**

NEW DELHI: Net direct tax collection grew 13.13 per cent to over Rs 21.26 lakh crore so far this fiscal aided by by higher advance tax mop up, govern-ment data showed on Monday.

During the year, the government collected Rs 10.44 lakh crore from four instalments of advance tax as against Rs 9.11 lakh crore in the previous fis-cal, registering a growth of


14.62 per cent.
The last instalment of the advance tax payment was due on March 15, 2025, for the current financial year.

Advance tax collection under the **Refunds worth** corporate tax catmore than Rs 4.60 egory rose by 12.54 lakh crore were per cent to Rs 7.57 lakh crore while issued during the non-corporates period as against witnessed a growth rate of 20.47 per Rs 3.47 lakh crore in the year-ago cent to Rs 2.87 lakh crore during the financial year.

An individual whose estimated tax liability is likely to be over Rs 10,000 (after considering tax deducted and collected at source - TDS and TCS) is required to pay advance tax that year, as per Section 208 of the Income-Tax Act. This includes salaried taxpayers.

Advance tax is to be paid before the end of the financial year on the income that one would have earned that year.

Advance tax is paid in four instalments – June 15, September 15, December 15, and

Indian Railways In Sound Financial Health, Says Minister Vaishnaw

NEW DELHI: Indian Railways' financials are in good condition with continuous improvement efforts underway, Railways Minister Ashwini Vaishnaw informed the Rajya Sabha on

During a debate on the working of the Railways Ministry, Vaishnaw noted that the national transporter has successfully overcome pandemic-related challenges, with passengers returning to train travel and both passenger and cargo traffic showing growth.

During 2023-24, Indian Railways reported a revenue of approximately Rs 2,78,000 crore against expenses of Rs 2,75,000 crore. Major expenditure components include staff costs (Rs 1,16,000 crore), pension payments (Rs 66,000 crore), energy expenses (Rs 32,000 crore), and financing costs (Rs 25,000 crore).

"Railways is fulfilling its expenses from its own income because of good performance. ...Overall, the financial condition is good and we are trying to improve it on constant basis," Vaishnaw stated.

The minister highlighted that Railways subsidises passenger fares while generating revenue from cargo and freight operations.

While the actual cost per kilometer stands at Rs 1.38, pas-



sengers are charged only 73 paise, resulting in a total passenger subsidy of approximately Rs 57,000 crore for 2023-24.

Vaishnaw emphasised that Indian train fares remain the lowest compared to neighbour-

ing countries.
"If you look at a journey of 350 km, Rs 121 is the fare of general class in India, Rs 400 in Pakistan, Rs 413 in Sri Lanka. This is the same in almost all categories," he noted, adding that fares have remained unchanged since 2020.

Energy costs have "stabilized" at Rs 30,000-32,000 crore, with the railways financially benefiting from electrification initiatives implemented after 2019.

The minister also outlined several achievements, including increased passenger and cargo traffic.

By March 31 this year, Indian Railways is projected to rank among the world's top three countries in cargo carrying capacity at 1.6 billion tonnes, behind only China and the United

Govt Mulls Returning Unused Highway Land to Owners

The government is contemplating amending the National Highways Act to provide for the return of an acquired land parcel for highways development to the original owner in case it remains unused for five years, a senior highways ministry official said on Monday.

NEW DELHI: Gold and silver prices hit fresh record levels on Monday, rallying Rs 1,300 each, tracking strong trends in the global markets amid uncertainty over US tariffs, trade tensions and growing expectations of monetary policy easing by the Federal Reserve.

According to the All India

Sarafa Association, the precious metal of 99.9 per cent purity, extending gains for the fourth day in a row, rallying Rs 1,300 to hit a fresh peak of Rs 90,750 per 10 grams.

It had closed at Rs 89,450 per 10 grams on Thursday.

Gold of 99.5 per cent purity zoomed Rs 1,300 to establish an lifetime high of Rs 90,350 per 10 grams from Thursday's closing level of Rs 89,050 per 10 grams.

According to HDFC Securities' Senior Analyst, Commodities, Saumil Gandhi, several factors have contributed to the record-breaking rally in precious metals, including buying by central banks and global economic instability.

Further, the demand for safe haven assets increased due to the trade and economic policies of US President Donald Trump, which in turn increased economic uncertainty worldwide, Gandhi said.

So far this year, the yellow metal prices had climbed Rs 11,360, or 14.31 per cent, to Rs 90,750 from Rs 79,390 per 10



Silver prices also surged Rs 1,300 to hit a fresh all-time high level of Rs 1,02,500 per kg. The white metal had concluded at Rs 1,01,200 per kg on Thursday.

Meanwhile, gold futures for April delivery inched up Rs 13 to Rs 88,004 per 10 grams on the Multi Commodity Exchange. On Friday, the yellow metal had hit a record peak of Rs 88,310 per 10 grams on the commodities bourse.

In the international mar-

kets, spot gold appreciated USD 14.48 to USD 2,998.90 per ounce. It had breached the psychological mark of USD 3,000 an ounce on Friday.
On similar lines, Comex gold

futures were trading higher at USD 3,007 per ounce. On Friday, it had hit a record high of USD 3,017.10 per ounce.

"Gold prices remain near record highs as expectations of further US Fed interest rate cuts strengthen, fuelled by cooling inflation," Chintan Mehta, Chief Executive Officer at Abans Fi-

nancial Services Ltd, said. Mehta further said, geopolitical risks have strengthened bullion prices after the US confirmed it would continue strikes against Yemen's Houthis until they cease attacks on Red Sea shipping, escalating tensions in the region.

Sensex Bounces Back 341 Pts On Gains In Banking Shares, Global Rally

MUMBAI: Benchmark BSE Sensex rebounded by 341 points on Monday, snapping its five-day losing streak following buying in banking stocks and a sharp rally in global shares. The 30-share BSE Sensex

climbed 341.04 points or 0.46 per cent to settle at 74,169.95 as 19 of its constituents ended in the green and 11 in the red. In intra-day trade, the benchmark jumped 547.44 points or 0.74 per cent to 74,376.35. The NSE Nifty rose by 111.55 points or 0.50 per cent to 22,508.75.

From the Sensex pack, Bajaj Finserv, Mahindra & Mahindra, Axis Bank, Bajaj Finance, Adani Ports, ICICI Bank, Zomato and UltraTech Cement were among the biggest gainers.

However, ITC, Nestle, State Bank of India, Reliance Industries, Asian Paints and Tata Consultancy Services were among the laggards.

Shares of IndusInd Bank jumped 5.30 per cent in intraday trade after the Reserve Bank on Saturday assured customers that the firm remains 'wellcapitalised', even as it directed the bank's board to complete remedial action relating to an estimated Rs 2,100 crore accounting discrepancy within this month. The stock finally ended at Rs 676.95, up 0.72 per cent.

"Markets started the week on

a positive note, gaining half a per cent as the consolidation phase continued. Strong global cues, along with buying interest in select heavyweights, particularly from the banking and financial sectors, led to a firm start, followed by a range-bound session," Ajit Mishra – SVP, Research, Religare Broking Ltd, said.

The BSE midcap gauge climbed 0.77 per cent, while smallcap index dipped 0.02 per cent.

Among BSE sectoral indices, healthcare surged 1.12 per cent, commodities (0.92 per metal (0.91 per cent) nancial services (0.83 per cent), auto (0.80 per cent) and bankex (0.71 per cent).

Telecommunication, realty and FMCG were the laggards.

In Asian markets, Seoul, Tokyo, Shanghai and Hong Kong settled in the positive territory. Stock markets in Europe were trading in the green. US markets ended sharply higher on Friday. "Despite a small hiccup, mar-

kets quickly gained ground to trade in positive territory as optimism across global markets aided recovery in local indices. However, with a lot of uncertainty surrounding the impact of US tariff policies on key economies, including India, investors would be watchful of the global events before taking any call," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

written reply. No proclamation has been issued on pharma, automobile and semiconductor sectors

"As informed by Department of Commerce, the impact of the above proclamations on India is being carefully examined and evaluated," he said.

Replying to another question, Chaudhary said out of 40 recommendations, India received 'Compliant' or 'Largely Compliant' rating in 37 recommendations by global money laundering and terrorist financing watchdog Financial Action Task Force (FATF).

It received Partially Compliant rating in 3 recommendations and none was rated as Non-compliant, he said. (PTI)

According to Sebi data, the complaints pending as of November 30, 2024, stood at During December, the regulator received 5,193 fresh complaints, bringing the total ap-

plications to 11,019. Of these, 5,383 complaints remained unresolved as of December 31, 2024, the regula-

tor said in a public notice on Tuesday. The markets watchdog also highlighted that the average resolution time taken by entities to submit Action Taken Reports (ATRs) to investors in December was eight days. For complaints escalated to the first-level review, the average resolution time was five days, showcasing the efficacy of the updated

Under the upgraded SCORES 2.0 framework, complaints are automatically forwarded to the concerned entity, which is given 21 days to submit an ATR to the investor.(PTI)

Govt Says 11 Airports Identified For Operations Under Public Private Partnership

(ex-showroom Delhi).

The Civil Aviation Ministry on Monday said 11 airports, including six small airports, have been identified for operations under the public-private partnership.

As per National Monetisation Pipeline (NMP), 25 airports operated by the stateowned Airports Authority of India (AAI) have been earmarked for leasing over the 2022 to 2025 period.

The airports are Bhubaneswar, Varanasi, Amritsar, Trichy, Indore, Raipur, Calicut, Coimbatore, Nagpur, Patna, Madurai, Surat, Ranchi, Jodhpur, Chennai, Vijay-awada, Vadodara, Bhopal, Tirupati, Hubli, Imphal, Agartala, Udaipur, Dehradun and Rajahmundry.

"Eleven airports consisting of select five (5) airports viz. Amritsar, Varanasi, Bhubaneswar, Raipur and Trichy, clubbed/paired with six (6) smaller airports have been identified for their operation, management and development under Public Private Partnership (PPP)," Minister of State for Civil Aviation Murlidhar Mohol said in a written reply to the Rajya Sabha on Monday. (PTI)

RBI Permits Settlement Of Trade Transactions With Maldives In Local Currencies

Reserve Bank on Monday said India's bi-lateral trade transactions with Maldives may also be settled in INR and/or MVR in addition to the ACU mechanism.

Asian Clearing Union (ACU) is a payment arrangement whereby the participants settle payments for intra-regional transactions among the participating central banks on a net multilateral basis.

The participants include central banks and the monetary authorities of Bangladesh, Belarus, Bhutan, India, Iran, Maldives, Myanmar, Nepal, Pakistan, and Sri

A Memorandum of Understanding (MoU) has been signed between RBI and Maldives Monetary Authority in November 2024 for establishing a framework to promote the use of local currencies -- Indian Rupee (INR) and Maldivian Rufiyaa (MVR) for bilateral transactions.

"In the wake of signing of Memorandum of Understanding (MoU)...it has been decided that India's bilateral trade transactions with Maldives may also be settled in INR and/or MVR in addition to the ACU mechanism, as hitherto," the RBI said in a circular. (PTI)

Rs 8.47 Crore Gold Seized **At Mumbai Airport; 3** Staffers Among 5 Held

The Mumbai Customs has seized more I than 10 kg of gold valued at Rs 8.47 crore in four operations at the international airport here and arrested five people, including three private airport staff members, officials said on Monday.

The seizures were made between March 13 and 15 and some of the accused had concealed the precious metal in their clothes and undergarments, they said.

Giving details, a Customs official said a private staffer at the Chhatrapati Shivaji Maharaj International Airport was intercepted and six ovalshaped capsules having 2.8 kg of 24-karat gold dust in wax form, valued at Rs 2.27 crore, were found concealed in the pockets of his pants. The person was arrested under the Customs Act, the official said. In the second seizure, another private staffer working in the international departures area was intercepted.

In the third operation, another private staffer at the airport was apprehended and two pouches containing 1.6 kg of 24-karat gold dust in wax form valued at Rs 1.31 crore concealed in his undergarments were recovered. After further investigation, the staffer and two other persons were arrested, the official said. (PTI)

Showkat Ahmad Bajad, his brother Riyaz Ahmad Bajad, and Mukhtar Ahmad went missing on February 13 while on their way to attend a function at the house of a relative in Ashmuii. However, the trio -- who were working as labourers -- never reached their destination.

Showkat Ahmad Bajad's body was retrieved from Vaishov nullah in Kulgam district on Sunday while that of his brother was recovered from the same spot a few days ago.

As the assembly proceedings commenced on Monday, Peoples Democratic Party (PDP) members, led by Wahid Para, said the deaths of the two tribal men have caused panic among the people and demanded an impartial investigation to bring perpetrators to justice.

Despite Speaker Abdul Rahim Rather's request to allow the Question Hour to proceed, PDP members continued to raise the issue from

Members of the ruling National Conference also joined in and called for a high-level inquiry into the deaths.

NC member Peerzada Feroze Ahmed pointed towards the "rising" cases of people going missing, which he said has caused panic among the people.

The members said similar incidents had been reported from Kathua.

Some NC members entered the Well of the House, seeking a probe into the deaths and the alleged mistreatment of a woman by the local police, triggering a ruckus.

The Speaker intervened and acknowledged the reports of misconduct involving a woman. He also reassured that Chief Minister Omar Abdullah, who was present in the House, would address the issue and ensure appropriate action

"The chief minister is sitting here. He has heard your issue. He will look into it. He will ensure action", the Speaker said.

Speaking to reporters outside the assembly, Para expressed concerns over the deaths, saying, "Such incidents have created insecurity among the people. We are not accusing anyone, but there is a critical need for an impartial probe as one community feels targeted.'

A group of protesters had blocked the Srinagar-Jammu National Highway in Kulgam district on Sunday night, demanding that the police initiate an investigation into the case and take action against those whom the kin of the deceased suspect to be responsible for the

On February 13, three Gujjar youths from Devsar had gone missing after leaving Ashmuji in Kulgam to attend a function. They were identified as Riyaz Ahmad, Showkat, and Mukhtar Ahmad Awan, all residents of Kulgam.

It said the DIG South Kashmir Range (SKR) would enquire into the incident that happened on Sunday and submit a report within 10 days.

Meanwhile, DIG (South Kashmir) Javaid Iqbal Matoo met the protesters blocking the national highway in Qazigund. "If anyone acted wrongly, they will be held accountable. A mother who lost her son has the right to protest," he stated, adding that an investigation into the deaths was ongoing.

Earlier, PDP leader Iltija Mufti criticised the officer's behaviour and demanded a probe.

"Shocking & unbecoming for a policeman to kick a woman only because she was peacefully protesting against the mysterious deaths in Devsar Kulgam. It is this high handed behaviour from officers expected to uphold law that creates a trust deficit alienating people even by the ministry of coal citing the reason that

NC MP Aga Syed Ruhullah Mehdi also condemned the police action. "The visuals of officers kicking mourning women are disgraceful. These deaths must be transparently investigated, and those responsible for both the tragedy and the police excess must be held accountable.

Protests broke out in the district on Sunday after the body of a youth, who was among three persons missing since last month, was recovered from a water body.

The chief minister said J&K has significant potential for solar energy, and the installation of solar rooftops is being encouraged through the PM Surya Ghar Muft Bijli Yojana.

He said as metering progresses and reaches a larger number of consumers, the government expects significant improvements in power supply, with no power cuts in low-loss areas.

'Such improvements are already evident on feeders where 100 per cent smart metering has been completed -- 45 in Kashmir and 50 in Jammu," he said.

The Delhi High Court had earlier sought the NIA's response on Rashid's appeal, with the order on his regular bail plea scheduled for March 19.

From Boos To Cheers: Hardik Pandya's '360 Degree Turnaround'

NEW DELHI: From incessant boos to frenzied adulation -- star India all-rounder Hardik Pandya has seen it all in the last few months, during which his life underwent a '360 degree turnaround' and keeping him afloat in the turmoil was his determination to never leave the battlefield.

As he gears up for his second IPL season as Mumbai Indians captain, Pandya can expect a markedly warmer reception at the Wankhede after playing crucial roles in India's T20 World Cup and the ICC Champions Trophy triumphs.

The backlash he faced in IPL 2024 was triggered by the team's decision to hand him the leadership role, replacing Mum-bai's very own Rohit Sharma, who led the franchise to five trophies.

"For me, it has always been about never leaving the battlefield. There have been phases in my career where my focus wasn't necessarily on winning but on surviving and holding my ground," Pandya told Jio-Hotstar ahead of the IPL, starting March 22.

"I realised that no matter what was happening around me, cricket would always be my greatest ally...I kept pushing through, and when all the hard work finally paid off, it

was beyond anything I could have scripted.
"The six-month phase where we won the World Cup, and then the kind of love and support I received upon returning -- it was a complete 360-degree turnaround for me," he added.

The 31-year-old said he never wavered from the belief that if he remained persistent, he would come out stronger.

"I didn't know exactly when that would happen, but as they say, destiny had its plan, and in my case, everything changed within two and a half months," he said.

Pay Cut For Players After Pakistan Suffers Huge Loss In CT

It was a massive setback for Pakistan as they faced an early exit in the first ICC event they hosted after nearly three

Adding to their woes, the Pakistan Cricket Board has reportedly suffered an 85 per cent loss after spending Rs 869 crore (approximately \$58 million) for hosting the Champions Trophy.

Pakistan had spent Rs 869 crore to upgrade their three Champions Trophy venues in Rawalpindi, Lahore, and Karachi apart from investing around Rs 347 crores on tournament preparations. The cost of upgradation of the stadiums turned out to be 50 percent more than the budget estimates.

PCB is said to have received Rs 50.3 crores (\$6 million) as the hosting fee. The earnings were negligible as far as ticket sales and sponsorships

were concerned, adding to the PCB's already poor financial position.

The staggering loss has forced the governing body to adopt belt-tightening measures and devise a strategy to wade through this difficult phase. According to reports, the

PCB has decided to lower the match fees for the national T20 championship by 90 percent and cut salaries of the reserve players by 87.5 percent.

Moreover, the arrangement of five-star hotels for avers has been withdrawn, and they will be housed in budget hotels.

'The PCB had recently reduced match fees from Rs 40,000 to Rs 10,000 without any official announcement... however, PCB chairman Mohsin Naqvi intervened, rejecting the decision and directing the board's domestic cricket department to reassess the matter,' said a report in Pakistan daily Dawn.

The ICC Champions Trophy 205 was held in a 'hybrid model' after India refused to travel to Pakistan citing security concerns.

BCCI Banning Brook In IPL Not Harsh: Moeen Ali

LONDON: Former England all-rounder Moeen Ali believes the BCCI banning Harry Brook for two years for his last-minute withdrawal from the IPL was "not harsh".

It is the second straight time Brook has pulled out of the top franchise-based league after being bought at the auction.

"It's not (harsh) though, I kinda agree with it," Moeen said on the Beard Before Cricket podcast, when asked whether a two-year ban would be harsh

"A lot of people do that (withdrawing). People have done it in the past, and then they come back in and end up getting a better financial package or whatever it is. It kinda messes up a lot of things as well at the same time," the all-rounder said.

England batter Brook was facing a two-year ban from the IPL since pulling out of his contract with Delhi Capitals ahead of the tournament beginning March 22.

"It's messed his team (Delhi Capitals) up, him pulling out. Any team that loses Harry Brook is messed up a bit, and they've got to now rejig ev-

erything and stuff like that. "Forget him for a second

pull out, the rule is you get a ban, unless it's a family reason or injury. If it's injury, it's different. But I think if you just pull out, then it's... I kinda agree with it (the rules)," Moeen, who will play for Kolkata Knight Riders this season, said.

The 26-year-old Brook had earlier withdrawn from the 2024 edition of IPL following the death of his grandmother.

Any foreign player who miss the IPL after getting picked at the auction faces two-year ban from the league unless he is injured.

According to the new rules introduced by the IPL, Brook is not eligible to play in the event, or be part of the auction, until the 2027 edition.

"Any player who registers in the auction and after getting picked, makes himself unavailable before the start of the season, will get banned from participating in the tournament and player auction for 2 seasons," states the new rule.

Brook was bought by Delhi Capitals for Rs 6.25 crore in the mega auction in November. In the previous auction too, he was secured by Delhi for Rs 4 crore.

Kohli, who has been with RCB since IPL's inception in 2008, led the franchise for more than a decade and remains its face.

Patidar has succeeded Faf du Plessis as captain with the South African moving to Delhi Capitals this season.

"This guy is going to lead you for a long time. He is going to do a great job. He has got everything that is required (to succeed)," Kohli said in his address to RCB's loyal fans at the team's Unbox event here on Monday. RCB have never won the IPL but Kohli remains hopeful.

"It feels amazing to be back. The excitement and happiness is like every other season. I have been here for 18 years and absolutely love RCB. We have an amazing squad this time around. Lot of talent in the team. I am personally very excited about this season," Kohli added. This will be Kohli's first IPL after retiring from T20 Internationals.

Bangladesh To Tour Pakistan For White-Ball Series In May

The Bangladesh cricket team will tour Pakistan for a white-ball series in May, which will include three T20Is and as many ODIs.

The series will be held after the conclusion of the 10th edition of the Pakistan Super League scheduled to take place from April 11 to May 18.

Originally, the series was part of the Future Tours Program but had to be postponed due to the busy schedules of both teams.

However, following recent discussions during the visit of Bangladesh Cricket Board Chairman, Farouq Ahmed, to Pakistan for the Champions Trophy, both boards have agreed to go ahead with the series in May.

Bangladesh had previously toured Pakistan last year for a two-Test series, which they won comprehensively 2-0.

Jio Ends Free IPL Streaming in India

peliance Jio, India's largest telecom firm by users, said On Monday certain tariff plans will continue to give subscribers free streaming access to IPL 2025 matches, among the country's most-watched sporting events.

The plan is applicable to users recharging their accounts with Rs 299 (\$3.44) or more and will enable them to watch matches on Reliance-Disney's newly merged JioHotstar streaming platform, the Reliance Group-owned firm said.

IPL, a money spinner and among the country's moststreamed content, is scheduled to be held between March 22 and May 25.

The move comes a month after Reuters reported that the Reliance-Disney JV will no longer offer completely free streaming for IPL cricket matches, as was the case in 2023 and 2024 in the old JioCinema platform, and will adopt a hybrid model where subscription kicks in after content consumption reaches a threshold.

Bowling Worries At IPL: KKR, SRH, MI Have Most Balanced Attacks

NEW DELHI: In a tournament that has fans flocking the grounds to see batters smash everything out of the park, bowlers have gradually established themselves as the cornerstone of success and the upcoming edition of IPL is going to be no different

If one looks at the bowling units of various IPL outfits, defending champions Kolkata Knight Riders, five-time champions Mumbai Indians and last year's runners-up Sunrisers Hyderabad have the most balanced line-ups.

With all-rounders rendered less useful due to the Impact Player Rule, most teams now look at playing five specialist bowlers. Some even have luxury of playing the sixth bowler if need be while defending a total.

So, what makes KKR special in terms of bowling?

In Harshit Rana, who has the uncanny ability of taking wickets with sheer pace and extra bounce, they have a potent Indian fast bowling option.

He would be supported by Varun Chakravarthy, who has been India's T20 trump card in recent years.

Add to that mix Anrich Nortje's blistering pace and Sunil Narine's guile, and 16 overs will be sorted for the side on most days. The uncapped Vaibhav Arora was

impressive last year and there is Andre Russell too who can always chip in with an over or two. In all of KKR's seven home games at the Eden Gardens, this attack cane be expected to be lethal.

In addition, Ramandeep Singh, and vice-captain Venkatesh Iyer can chip in with an over or two as per the team's requirements.

In case Nortje doesn't fire, there is the six-foot left-armer Spencer Johnson. On tracks like the one in Chennai, Moeen Ali's off breaks could also be handy.

By the look of things, KKR does

have the best bowling attack on paper. Mumbai Indians have had a torrid last four years even. But they have managed to retain their bowling core. In skipper Hardik Pandya, they have a proper bowler who can win matches with a sharp spell of fast

But MI's campaign will also depend on how the attack performs till



Jasprit Bumrah joins them in April.

The momentum shifts very quickly in IPL but a fit-again Deepak Chahar could be a handful with his incisive swing bowling during Powerplay overs.

He will have support of Trent Boult, who can bring the ball back into the right-handers at the start of the innings Mitchell Santner has mastered in

would have fancied better quality of

mascot for IPL teams Karn Sharma in their squad.

Once Bumrah comes in, the MI bowling will be too hot to handle. For Sunrisers Hyderabad, the biggest challenge for bowlers is to counter the flatness of the Uppal track.

But in Pat Cummins and Mohammed Shami, they have two smart operators who can assert themselves if the batting unit piles on the

The third Indian pacer could be a weak link but Harshal Patel, despite

a higher economy rate, is a good death overs bowler.

While they have a wrist spinner in Adam Zampa, it would be difficult to include him in all conditions. In this scenario, Rahul Chahar and Abhishek Sharma's slow bowling would be handy.

Talking about multiple utility bowlers, Ashish Nehra's Gujarat Titans is also a fine unit with World's best T20 bowler Rashid Khan there to support Kagiso Rabada, Mohammed Siraj, and Prasidh Krishna.

To support Rashid in slow bowling, Tamil Nadu captain R Sai Kishore and also Washington Sundar will have crucial roles to play.

For Rajasthan Royals, they have got a better spin attack with one among Wanindu Hasaranga and Maheesh Theeksana set to play. Riyan Parag's off-breaks are also

But it's the pace department where Jofra Archer might need more support from Indian bowlers.

Sandeep Sharma is good in specific conditions and young Railways man Ashok Sharma, who recently clocked 146 kmph in U23 Irani Cup is man to watch out for.

Ditto for CSK where save Matheesha Pathirana and R Ashwin, others in bowling unit don't inspire much confidence.

Mukesh Chaudhary was good a few seasons back and Anshul Kamboj is not bad either but whether they can deliver consistently is the question.


Khaleel Ahmed has been playing for nearly 10 years but no team has had faith in him in death overs where he has been profligate save the one odd season for Delhi Capitals.
