## J&K Women's Support Cells Face Shutdown, Survivors In Lurch

Srinagar: Thousands of women in Jammu & Kashmir who have sought refuge in the Special Cells for Women are now left in uncertainty, as the National Commission for Women (NCW) has decided not to extend the project beyond March 31, 2025. The move has raised seri-

ous concerns about the fate of survivors of gender-based violence, who rely on these support structures for justice and



rehabilitation. Violence-Free Home Established under the Woman's Right initiative, the

**THESE CELLS HAVE** SO FAR HANDLED over 9.800 cases of violence and abuse."

Special Cells have been operational since November 2021, providing critical psycho-social-legal support to women in distress.

Implemented by the Tata

Institute of Social Sciences (TISS) in collaboration with the I&K Home and Social Welfare Departments, these cells have so far handled over 9,800 cases of violence and abuse.

The uniqueness of these Special Cells lies in their strategic location-within the police stations of each district of Jammu & Kashmir. This ensures that women receive smooth access to the criminal justice system with the support of trained social workers, bridging the gap between

survivors and legal redress. However, with the NCW's decision to discontinue funding, these women may find themselves abandoned mid-process,

without support or protection. "We are not demanding permanent jobs, but we want to continue serving survivors,' said a social worker from the project, part of a dedicated team of 40 social workers and two regional coordinators.

# Speaker, PDP's Parra Spar Over Cut Motions

Jammu: The Jammu and Kashmir Assembly on Wednesday witnessed a ruckus over Peoples Democratic Party (PDP) MLA Waheed-ur-Rehman Parra's allegation that his cut motions in the grants were erased.

The supposed grievance prompted Speaker Abdul Rahim Rather to seek an apology from him for allegedly misleading the public and media

The Speaker clarified that, as per Rule 227 of the Assembly, MLAs must submit cut motions three days before the presentation of grants. However, Parra's motions were received just a day prior.

Referring to Parra's post on X, where he claimed he was denied the opportunity to submit cut motions, the Speaker accused him of attempting to influence public opinion unfairly. "You are an educated member and should not have misled the public," he said, urging Parra to apologize.

Parra defended his actions, stating that he had followed the same procedure used in previous sessions. His remarks led to a heated exchange with National Conference (NC) members and an Independent MLA, briefly disrupting proceedings.

The Speaker intervened, calling for order and reiterating that cut motions must be submitted in advance to allow time for compilation and responses from concerned departments. He criticized Parra for emailing his submissions at 11:37 PM, just a day before the session, making it difficult to process them in time. Despite the | More on P10

"Different toxins have been found. ## **Researchers Demonstrate New Technique For Boosting Plant Growth With Bacteria**

ANI esearchers have suc-

cessfully demonstrated a technique for encapsulating bacteria, which can subsequently be preserved and applied to plants to promote their growth and protect them from pests and infections. The technique paves the way for a variety of crop applications that will enable farmers to use these beneficial bacteria in conjunction with agrochemicals. "Many of the beneficial bacteria we know of are fairly fragile, making it difficult to incorporate them into practical, shelf-stable products

that can be applied to plant roots or leaves," says John Cheadle, co-lead author of a paper on the work and a Ph.D. student at North Carolina State University. "The technique we demonstrate here essentially stabilizes these bacteria, making it possible to develop customized probiotics for plants." At issue are plant growthpromoting bacteria (PGPBs), which are microbes that benefit plant health and growth, helping plants extract nutrients from the environment and protecting them from pests or pathogens.

Second, the researchers wanted to see how well pesticides would work when incorporated into the emulsion. For this, the researchers incorporated the pesticide fluopyram into the emulsion. They also added fluopyram to the saline solution by itself. The researchers then introduced C. elegans nematodes - which serve as a proxy for pests into the emulsion and the saline solution.

"Not surprisingly, the pesticide in saline solution killed the pest very quickly - all of the pests were killed within an hour," says Mariam Sohail, co-lead author of the paper and a recent Ph.D. graduate from NC State. "The emulsion worked more gradually, killing 95% of the pests within 72 hours. This is valuable to know, since it suggests our technique could be used strategically to provide sustained protection against specific pests or pathogens.

'Ultimately, we found our technique allows us to incorporate multiple active ingredients into a single delivery system and allows the PGPBs to survive and thrive," Sohail says.

'We also demonstrated that the emulsion improved the survival and reproductive success of these bacteria when applied to soil, as compared to applying the bacteria to the soil without the emulsion," Cheadle says. "Next steps will involve greenhouse testing and, later, microplots," says Khan. "We will likely want to evaluate different PGPBs and other active ingredients to see how they perform with different targeted plant species.'





#### **Govt Nod For Mughal Road**

SRINAGAR- The residents of Kashmir have expressed their happiness over the government's go ahead for the repair of the old Mughal Road that once linked Poonch district of Jammu with the Kashmir Valley.

The government has decided to resume work on the aforesaid alternative road project that will link the Kashmir Valley with Jammu -the state's winter capital. The road is called as Mughal road as it was the route toed by the Mughal's to visit India during the 17th and the 18th century. Asarai (resting place) at Shadimarag is still witness to the grandeur of Mughal carvans passing 'through this road.

By now, the lone. 300-kilometre national highway was the only link between Jammu and Srinagar, which often gets blocked due to frequent snowfall and landslides.

More than 350 people died this year when the Jammu-Srinagar national highway, the main lifeline, was cut off from the rest of the country due to the worst snowfalls in several decades.

The government has now given go ahead to the Mughal Road, which once completed will link Poonch district of Jammu with the Kashmir Valley.

"This road should be constructed. It will greatly help us. It takes us twothree days for us to reach Srinagar. We can reach Srinagar the same day once this road is completed. I am very thankful to the government," said Abdul Rashid at Thanamandi.

Mukhtar Ahmed. another local, said. "Once the road is completed, business activity will also pick up. Roadside hotels will come up as more passengers will come here. Moreover, it will take much less time to reach Kashmir Vallev'

Work on the road was stopped due to security concerns, as the army feared that the road may enhance the mobility of the militants in the militancy infested Poonch district.

The 89-kilonietre stretch was first taken up for execution in 1979 when there was no sign of militancy in the state. The construction of the road was simultaneously started from two sides- Shopian on the Kashmir side and Bafliaz on the Poonch side. However, the construction was not completed.

Five hundred years ago, Mughal emperor Akbar's legions marched down this road to defeat King Yousuf Shah Chak and integrate Kashmir with the rest of his empire. Now the state is looking again to the 84-km-long Mughal Road for much the same reasons.

The urgency of the Mughal road comes because of the unpredictability of the Jammu-Srinagar highway.

"Unpredictability" is actually a mild term for the vulnerability of the Jammu-Srinagar highway. Scanty rain or heavy snowfall, the sole roadlink between Kashmir and the rest of the country is known to collapse at the least provocation But the death of more than 200 villager in settlement barely two hours away from the snowed-up highway has perhaps driven home the urgency of the situation like little else could have.

Running past fields of maize, pine groves, lush meadows and gushing streams. 84 km of the Mughal Road will reconnect Shopian in Kashmir to Bufliaz in the Poonch district of Jammu, cutting travel time considerably. At present the road, which cuts through the Pir Panial mountain range, is motorable upto Sarbal, 20 km from the apple-rich belt of Shopian. While the Srinagar-Jammu National Highway is 300 km long, the Mughal Road between Jammu and Srinagar stretches 190 km.

The Mughal Road apart from shortening the distance of journey between Jammu & Srinagar would also create an environment, which would help in, greater Inter Regional Culture and Economic exchanges. The geographical isolation of the specific areas, which discouraged people to people contacts, will end and greater economic activity between the regions would follow

## JFK Assassination Files **Released**, Sending History **Buffs Hunting For New Clues**

Washington: More than 63,000 pages of records related to the 1963 assassination of Presi-dent John F Kennedy were released following an order by President Donald Trump, many without the redactions that had confounded historians for years and helped fuel

conspiracy theories. The US National Archives and Records Administration posted to its website on Tuesday roughly 2,200 files containing the documents. The vast majority of the National Archives' collection of over 6 million pages of records, photographs, motion pictures, sound recordings and artifacts related to the assassination have previously been released

Larry J Sabato, director of the University of Virginia Centre for Politics and author of "The Kennedy Half-Century," said it will take time to fully

review the records. "We have a lot of work to do for a long time to come, and people just have to accept that." he said.

Trump announced the release Monday while visiting the John F Kennedy Centre for the Performing Arts in Washington, saying his administration would be releasing about 80,000 pages.

Israel wanted to extend the first phase until mid-April, saying that any transition to the second phase must include "the total demilitarisation" of Gaza and the removal of Hamas.

filed the present appeal The bench said section 23(1) of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 was designed to protect senior citizens in situations, where they transfer their property, either through a gift or settlement, with the expectation that the transferee will provide for their basic amenities. If the transferee fails to meet these obligations, the senior citizen has the option to seek a declaration from the Tribunal to void

the transfer, the bench added. The Act acknowledges that property transfers from senior citizens, especially to children or close relatives, were often motivated by love and affection. The senior citizen's decision to transfer property was not merely a legal act but one made with the hope of being cared for in their old age. This love and affection become implied condition in



the transaction, even if the transfer document itself does not explicitly state it.

If the transferee does not provide the promised care, the senior citizen can invoke Section 23(1) to have the transfer annulled, the bench added.

## Parliament Panel to Centre: Add Heatwaves to Disaster Plans

New Delhi: A parliamentary panel has suggested that the Centre include "new and emerging" disasters, such as heatwaves, in its disaster management plans. The Department-related Parliamentary Standing Committee on Home Affairs, in a report tabled in the Rajya Sabha last week, also recommended setting up a system to regularly review and update the official list of disasters. "The committee recommends that the ministry may include new and emerging disasters in its disaster management plans, such as those caused by heatwaves etc. It further recommends establishing a formal mechanism for the periodic review and update of the Notified Disasters list to ensure the Act remains relevant and responsive to emerging disaster risks through consultation with experts, stakeholders and affected communities," the report read. The 31-member committee, headed by BJP's Rajya Sabha MP Radha Mohan Das Agrawal, also urged the ministry to study and plan for long-term disaster preparedness, considering climate change and the increasing frequency of disasters. It recommended greater investment in disaster-resistant infrastructure, including hospitals, schools and transport systems, to reduce damage and speed up recovery. Amruta S Nair, Climate Campaigner at Greenpeace India, said the parliamentary committee's recommendation to include heat-

waves in the notified disasters list is a welcome and long-overdue step that highlights the growing severity of the heat crisis. "It ensures heatwaves are prioritized in disaster management and response, covering prevention, mitigation and recovery. However, for this move to be

## Gold Bars Worth Rs 80 Crores, 19.66 Kg **Jewellery Seized In Ahmedabad**

ew Delhi: Directorate of Revenue Intelligence (DRI) conducted a search at a residential flat in Paldi, Ahmedabad on March 17, 2025, along with the officers of Gujarat Anti-Terrorism Squad (ATS).

As per a statement from the Ministry of Home Affairs, the search led to the recovery of 87.92 kilograms of gold bars, valued at around Rs 80 crores.

"Majority of the said gold bars bear foreign markings, indicating that these were smuggled into India," the ministry said.

The operation also uncovered 11 luxury watches, including a Patek Philippe watch studded with diamonds, a Jacob & Co timepiece, and a Franck Muller watch; and jewellery weighing 19.66 kilograms, studded with diamonds and other precious/ semi-precious stones.

The valuation of the said jewellery and luxury watches is in progress. In addition, cash amounting to Rs 1.37 crores was also recovered from the said residential premises.

"The search represents a major blow to illicit activities and underscores DRI's commitment to combating economic offences, and safeguarding the integrity and sovereignty of nation. Further investigations are currently underway," the ministry said.

Earlier on March 7, DRI in a joint operation with the Indian Coast Guard (ICG), seized 29.954 kg Hashish Oil worth Rs 33 crore from a tug-barge vessel sailing towards Maldives. DRI officers developed specific intelligence and identified a tug vessel towing a barge laden with rock boulders, which had departed from Tuticorin Old Port. It was revealed that a gang based in Tuticorin covertly loaded significant quantities of Hashish Oil onto the barge mid-sea during its voyage to the Maldives, with the assistance of a crew member from the vessel.

JAMMU: The Jammu and Kashmir government has established a robust healthcare framework aimed at making medical services affordable and accessible at the doorstep, Health and Medical Education Minister Sakina Itoo informed the Assembly on Wednesday. Responding to a query from

MLA Ajaz Jan, Itoo emphasized the government's commitment to improving healthcare infrastructure, ensuring ad-equate manpower, and upgrading medical equipment. Special focus has been placed on maternal and child health, managing communicable and non-communicable diseases, and preparing for future health challenges in line with IPHS and NMC norms.

Highlighting key projects in Poonch Haveli Constituency, she said that a Critical Care Block (CCB) is under construction at District Hospital Poonch at a cost of Rs 23.75 crore under the PM-ABHIM scheme. Additionally, one DIPHL lab at

He emphasised that the department handling this issue is crucial and should report directly to the chief minister.

"There should be nodal agencies at the district level for this issue under the chief minister's command, as well as in the office of the chief secretary for the resolution of their issues," he said.

Para said that Kashmiri Pandits who have been provided with land, employment, and housing should also have a well-defined transfer policy. "A transfer policy should be formulated to ensure their security. Some Pandits were killed due to the absence of such a policy," he said.

## Ask Centre To Hold Talks With Pak: NC MLA To BJP Members

JAMMU: National Conference (NC) MLA Ali Mohammad Sagar on Wednesday pitched for holding talks with Pakistan and urged the BJP members in the Jammu and Kashmir Assembly to push New Delhi to engage in dialogue with the neighbouring country.

The NC MLA also took a dig at the Bharatiya Janata Party (BJP) for communal clashes taking place across the country and said his party follows Mahatma Gandhi's ideology and not Nathuram Godse's.

"Nothing is possible without dialogue. You mentioned that former prime minister Atal Bihari Vajpayee held talks with Pakistan. (Prime Minister Na-rendra) Modi visited Pakistan. We always say that this is the only way to resolve issues," Sagar said while speaking in the Assembly on the grants announced by Chief Minister Omar Abdullah.

He also emphasised that the NC has always favoured dialogue as the path to achieve peace. "Our respected leader, Dr Farooq (Abdullah) sahab, had given you a suggestion (to hold talks with Pakistan) and I appeal to you with sincerity to pursue this path," he told the Bharatiya Janata Party (BJP) MLAs.

Seeking support of the BJP MLAs, Sagar said, "Please go to Delhi with this suggestion (of Faroog Abdullah) and tell them to hold talks with Pakistan. God willing, our issue will be resolved," he said.

Calling for reconciliation, the NC leader criticised what he described as attempts to impose a singular political ideology in the country.

Accusing the BJP of dividing people on the basis of religion and regions, Sagar said, "We do not harbour hatred towards the BJP, but we do not believe in its ideology, which divides people. We reject any thinking that pits a brother against a brother and a state against another state. We believe in Gandhi's India, not in Godse's India.'

Taking on the BJP over Jammu and Kashmir's downgraded status, he said, "Even veteran leader Karan Singh (son of Maharaja Hari Singh, the erstwhile ruler of Jammu and Kashmir) has opposed the downgrading of Jammu and Kashmir from a state to a Union Territory. You have not shown respect to Maharaja Hari Singh and insulted his dignity by dismantling his state and dividing it. This is unheard of in the history of any country.'

The BJP-led Centre abrogated the provisions of Article 370 of the Constitution, which had given a special status to Jammu and Kashmir, in August 2019 and bifurcated the erstwhile state into Union territories.

Referring to communal tensions in the country, Sagar said, "Communal clashes are taking place across India. We follow Gandhiji, not Godse. You want only one flower to bloom in this country but that cannot happen. We have always rejected communal politics."

He reiterated that talks are the only way forward. "Only talks can lead to a solution to problems. We must talk to Pakistan so that all issues are resolved," he said.

**SRINAGAR:** The Jammu and Kashmir government has no proposal to train educated youth as pharmacists at the village level, Health and Medical Education Minister Sakina Itoo informed the Assembly on Wednesday.

Responding to a question from MLA Balwant Singh Mankotia, Itoo said that multiple health institutions across various blocks, including Chenani, Basantgarh, and Ramnagar, are actively providing health-care services. Efforts are underway to ensure that vacant posts in these institutions are referred to recruitment agencies for timely appointments.

To strengthen emergency care, CHC Chenani and SDH Ramnagar have been equipped with upgraded medical facilities and trained personnel, with patients re-quiring advanced treatment referred to tertiary healthcare centers.

In Kalakote-Sundarbani Constituency, 205 out of 365 sanctioned medical and paramedical posts are currently occupied. A sonologist is available at SDH Sunderbani twice a week, and X-ray services operate round-the-clock at CHC Ka-lakote and SDH Sunderbani. A new X-ray machine for PHC Trayath is set to be installed at PHC Moughla, but the absence of a sanctioned X-ray technician post means patients requiring Xray services are referred to SDH Sunderbani and GMC Rajouri.

The minister assured that the health department is actively deploying technical staff to ensure full functionality of medical equipment

#### **Strengthen Food Safety** 'n a welcome exercise, authorities in Srinagar have

been carrying out intermittent food safety inspections to ensure compliance with quality standards by various food manufacturing units and commercial establishments. The officials gather samples from industrial areas, hospital canteens, and local markets and send these for analysis. The people would expect that the results of these samples are also placed in the public domain. We urgently need a strict oversight of food production and distribution across the city and also in other parts of the Valley. This is important to enhance consumer confidence and promote higher food safety standards

across the region. Food safety should not be a privilege but a fundamen-tal right of every citizen. However, going by some recent events, it remains one of the most neglected areas of public health in the Valley. The viral social media video about a dead mouse floating in cooking oil at a street vendor's stall near Hazratbal Shrine should shock us all. It is not an isolated incident but a symptom of a deep-rooted crisis. This was followed by reports of unhygienic practices in bakeries, hospitals, and food markets. which has hit the public confidence in much of the food sold on the market, giving rise to calls for immediate and stringent measures to safeguard public health.

This is an alarming situation. As things stand, street vendors, restaurants and even hoteliers operate with little to no oversight. The roadside vendors have been found to reuse oil multiple times, handling food with bare hands, and often storing it in substandard conditions. Worse, the unchecked use of adulterants in food products poses seri-ous health risks, contributing to a rise in gastrointestinal infections, food poisoning, and even cancer. Although recent activism of food safety authorities should be appreciated, they shouldn't act only after a crisis surfaces. The prevailing situation calls for routine, surprise inspections. We need a preventive rather than a reactionary approach to food safety.

True, the crackdown against the violators of the food safety standards is hampered the logistical issues. It remains woefully understaffed. And without sufficient manpower, thorough and regular inspections are impossible. This leaves room for food vendors to operate without fear of accountability. So, the need of the hour is for the government to fill up the vacancies in the department quickly. Food safety is not just a regulatory issue; it is a matter of life and death. We cannot afford to wait for another horrifying unhygienic incident to prompt action.

## **Changing Face of Kashmir's Labor Market**

Tale of Migrant and Indigenous Workforce

ne of my mentors, Emeritus Professor S. A. Abbasi, once said, keen observation is the key to producing authentic results and conclusions. This explains that observation is the most authentic source of understanding any natural, social, psychological or economic dynamics.

It is March 2025. In Kashmir, March witnesses vibrant activities in agriculture, construction and other sectors. A keen observer in Kashmir today would notice an unmistakable trend. I too have this habit of observing around (people, politics, education, and the environment). I observed, while much of the local labor workforce remains indoors during the early months of the year, migrant workers/laborers from other states have already taken over labor-intensive spaces in Kashmir. By mid-February 2025, thousands of migrant workers have arrived, setting to work each morning at 8 AM, while indigenous laborers remain largely absent from these job sectors. This phenomenon raises several questions about the work culture, economic dependencies, sociocultural factors, and policy implications surrounding the labor force in Kashmir.

Why do migrants dominate Kashmir's labor market? Is it purely about wages, or are there deeper differences in work ethic and economic drive? Are there alternative income sources that make locals less inclined toward hard labor? And most importantly, does the influx of migrant labor impact employment opportunities for Kashmiris? This article delves into these pressing questions, offering a broader perspective on the evolving labor market in Kashmir.

#### Work Culture and Economic Drive

The most apparent difference between the migrant and local labor workforces is the work ethic. Migrant laborers come to Kashmir with a clear purpose: to earn, save, and return home with financial stability. Their approach to work is marked by discipline, punctuality, and an unrelenting drive.

In contrast, a significant portion of the indigenous labor force seems reluctant to engage in the same kind of physical labor, at least dur-ing the winter months. This raises the question: is it an issue of work culture or economic necessity? Many local workers may feel less urgency to work because they have alternative sources of income, such as government jobs to one or more family members, land-based earnings, or remittances from family members working abroad. These economic cushions mean that many locals are not in immediate financial distress, making them less willing to take up physically demanding jobs.

many rural Kashmiris—remains dormant, and the tradition of winter hibernation remains dooply ingrained in the local psyche. Many ers. However, the reality is more complex. Migrant labor has been instrumental in filling critical gaps in Kashmir's workforce. The booming construction industry, for instance, relies almost entirely on migrant workers, as local labor participation remains minimal. Similarly, agricultural activities such as paddy transplantation and apple harvesting see heavy

involvement from outside laborers. However, the presence of migrant labor also creates a paradox. Since they are willing to work for lower wages, but much better than what they get in their native states, employers prefer them over local workers, further discouraging indigenous labor participation. This leads to a cycle where locals step away from labor-intensive jobs, and migrant workers become an irreplaceable part of the economy.

In certain sectors, this trend has resulted in a complete dependence on migrant labor. If for any reason, migrant workers were to stop coming to Kashmir, several industries-construction, brick kilns, horticulture, and road maintenance-would struggle to function efficiently.

#### Policy Interventions and the Way Forward

Some of the possible policy Interventions can be put in place to strike a balance, and mitigate economic losses to the local economy.

Training local youth in specialized trades such as masonry, carpentry, and machine operations could make them more competitive in the labor market.

#### Better Labor Wages in Kashmir

The daily rate for labour work in ranges between INR 600-700, Whereas labor work in most of the states outside mir fetches only INR 200-300. In Kashm laborers get daily allowances or compl tary benefits such as Chewing Tobacco or Cigarette and two time food (vegetar non vegetarian based on laborers choice) and tea in addition to the labor rate. Accounting these benefits to the day's labor rate amounts to around INR1000. These benefits are absent

in other states. Besides it, the migrant laborers feel protected and respected in Kashmir. These labor wages and benefits in Kashmir force mass migration of labour workforce from other states to Kashmir.

#### Climate, Tradition, and Social Perception

Another key factor influencing labor force participation in Kashmir is the region's unique sociocultural setting. Kashmir experiences harsh winters, and historically, this season has been associated with reduced economic activity. Agriculture-the primary occupation for

## Anantnag Schools Struggle Amid Staff Shortages

n alarming educational crisis has come to light in Anantnag district, where 376 lecturer positions remain vacant, leaving students without proper academic guidance. Adding to the distress, an RTI inquiry has revealed that 12 Higher Secondary Schools are functioning without full-

time principals, severely impacting their administration and overall academic environment.

Among the affected institutions are HSS Gohan, HSS Nowbugh, HSS Gadole, HSS Hardtoru, HSS Soaf, HSS Mantpora, HSS Chittergul, HSS Chaklipora, HSS Uttersoo, HSS Shangas, HSS Hiller, and HSS Nanil. The absence of permanent leadership in these schools has led to administrative inefficiencies, while the shortage of lecturers has disrupted the academic flow, depriving students of quality education.

With education being the backbone of societal progress, the situation demands immediate government intervention. Urgent measures are needed to fill these vacancies and restore stability to Anantnag's education sector. If left unaddressed, the crisis could have long-term repercussions on the academic future of thousands of students

## The Sufi Alchemy of Travel

Today, due to the advancement of science and technology, we have taken a lot of innovation in outward travel, but this same technology has made us so encumbered that our souls are imprisoned and our spiritual journeys and social interactions are on a decline. In today's materialistic age, there is a dire need to reconnect with our spiritual roots and embark on the spiritual journey of self-realization. In this era of spiritual and moral crisis, Sufis teach us how to transcend the snares of the lower self (nafs) and to achieve higher goals.

In Islam, this world is looked upon as a temporary transitional stage of man's life and it is reported that Prophet Muhammad (SAW) said, " Be in this world as a stranger or a wayfarer."

The Holy Quran comes up with a command to 'travel through the land' (29:20) and to contemplate over how God began creation and makes it work according to His 'perfect design'.

It clearly makes us understand that this world is one of the greatest miracles of God and if we observe things with a keen eye, there are clear signs in each and everything around us giving a notion that there is a perfect Designer and Planner behind this cosmos. This is the reality that we come across while studying the Holy Quran.

"We will show them Our signs in the horizons and within themselves until it becomes clear to them that it is the truth." (41:53)

However, it is never easy to travel as it is at times challenging and exhausting. There are hardships and trials in travel as is mentioned in a hadith of the Prophet (SAW),

#### "Travel is a kind of torture."

The Sufis from all the orders, love to travel from one place to another. They involve themselves in meeting new people, learning new things and gathering information regarding all the fields of life. Travel has a humbling effect as it makes us realize what a tiny place we occupy in this world.

Travel is a memorable and insightful experience for those who go for it. The soul dies of dwelling at rest, it becomes more alive by perpetual soaring. Travel offers a chance to connect deeply with God, embodying 'nadhar bil Ibrah' - looking through things to understand the reality behind creation. Travellers move beyond 'nadhar bi Shahwah' i.e., looking at things with a strong desire, seeking the signs of God (Ayatullah) in every leaf, stone, and breeze. Each step becomes a reminder of God's presence, guiding one to reconnect



with the Creator and discover the Ultimate Reality that sustains all of creation.

Maulana Azad once said, "I have gained half of my knowledge from travel. Reading in solitude provided me intellectual growth, but the observations of travel broadened my mental horizons. Those who do not travel live in a limited space of experiences. Travel gives a person indirect knowledge of the history of nations, just as scientists empirically understand the reality of

things, in the same way, travel provides practical knowledge of human qualities, moods and natures of different nations." As far as Sufism is concerned, it is all about the journey of a 'wayfarer' (salik) or conscious human soul towards the Ultimate Reality that

lies behind the temporal existence. The life of a Sufi can be summed up as a quest for the Ultimate Truth, the quest for self-realization as a part of the Divine Plan of existence. Hence, seeking or exploring is an essential part of a Sufi's life. There is a persistent longing for the divine beloved in a Sufi's consciousness as is expressed in the opening lines of Rumi's 'Mathnavi'. Seeking is the practical manifestation of the concept of Wahdat ul Wujud (The Unity of Being) and in the words of Rumi, "What you seek is seeking you." He tells a 'salik' to have a personal enquiry and to unfold his or her own myth, "Don't be satisfied with stories, how things have gone with others. Unfold your own myth." In most of the Sufi orders, travel is an integral part of the spiritual life of a Sufi.

According to Ibn Arabi,

'The whole existence, due to some reasons, is a part of 'world travel' which has no end, neither in this world nor in the hereafter. Man from the time immemorial is a traveller who is not stationary because the basis of existence is 'movement' and if this existence seizes to move, it will return to 'nothingness'... If we understand enough that our existence is established by this movement and its death is in inertness, then we will always make sure that we are on a travel...There are two types of travel: one is the travel that we are not made responsible for, but that is a requirement of our outward state, such as business travel, economic travel, tourism travel, or those travels that sustain our outward existence, such as the travel of our breath for life. The second is the travel for which we have been made responsible and there is a lot of good in adopting it. It is the journey of [religious life comprising of] Shariya and Tariqah." (Kitab ul Isfar)

Travel is a process of spiritual awakening as it unlocks the mysteries of the path in a splendid manner. Spiritual walks, adventures and getaways refresh minds with a broader insight to look beyond the temporal things and to search for the eternal bestowments. According to a Sufi poet,

"A [Sufi] friend taught me one thing well If you want [spiritual] light, travel Following this, I just set out exploring Since then, travel has become an integral part of my life."

Thus, here have been many globetrotting Sufis like Ibn Arabi, Shams Tabriz, Sheikh Saadi, Rumi, Imam Ghazali, Najmuddin Kubra, Shah Hamadan Mir Syed Ali Hamadani, Makdum Ashraf Jehangir Simnani, Makhdum Jahaniya Jahan Gasht, etc. who travelled different parts of the globe for spiritual nourishment. Shah Hamadan in particular is believed to have travelled the whole Islamic world three times and obtained the blessings from the great scholars and saints of his time.One can easily understand how difficult these travels would have been in those times without the conveniences of the present era. There were no roads, no convenient means of transport and there were the dangers of wild animals and robbers. The mules, horses and camels, were used to travel from one place to other. The unfavourable weather conditions would make the travel more difficult. His travels continued for about 21 years. Actually, travel was an integral part of his 'mujahida' i.e., striving in the path of God.

"And those who strive for Us - We will surely guide them to Our ways. And indeed, Allah is with the doers of good." (29:69)

Hardships offer challenges that are to be undertaken by a Sufi to make his 'tazkiyya' i.e., the spiritual purification. The trials and tribulations act as a barrier against the materialistic propensities and help in attaining higher spiritual goals. Rumi accepts these trials as the essential part of this learning experience,

"If you are irritated by every rub, how will your mirror be polished?"

There is no 'polishing' without 'rubbing' and it is 'rubbing' which enlightens you.

Some Sufis would travel long distances to benefit from other Sufi Sheikhs and gather spiritual blessings. Others would travel to do the ziyarah of Islamic historical places, khanqahs, shrines and holy relics to refresh their faith.

The Sufis undergo a state of spiritual ascension which refers to a sort of spiritual upliftment of an individual towards the metaphysical realms of self-realization. This spiritual odyssey demands complete annihilation (fana) of the ego of the individual to absorb and reflect the divine lights (tajaliyyat). The great Sufis like Bayazid Bistami and Ibn Arabi often refer to this state in their expressions.

Travel is always rewarding as it takes an individual close to his purpose or destination. The question is, what can be the best reward for a spiritual odyssey? The answer is 'self-realisation through Godliness' and this is what Sufis are offering.

"And you? When will you begin that long journey into yourself?"

## **Study Projects Loss In India's Solar Power Potential Due To Air Pollution**

'ndia's capacity to generate solar power could fall by 600-800 gigawatt-hour before mid-century due to air pollution and climate change, a study has projected.

The researchers from the Indian Institute of Technology (IIT), Delhi, found that northern, western and southern power grids -- where most solar parks are currently located -will experience significant challenges in maintaining performance due to climate change.

Pollutants in the air can absorb and scatter sunlight, thereby lowering the intensity of the sun's radiation reaching the earth's surface.

Further, generating solar power relies heavily on weather and climate. and is, therefore, vulnerable to the effects of climate change.

The findings, published in the journal Environmental Research Letters, "highlight the need for combined climate and pollution mitigation efforts to boost India's photovoltaic potential and secure a sustainable, resilient energy future".

Despite being endowed with abundant solar resources -- India receives nearly 300 clear-sky days every year -- the country has seen a persistent decline in incoming solar radiation, a phenomenon known as 'dimming', the authors said.

Using global climate models, the team projected the country's solar power potential by mid-century (2041-2050) under two scenarios -- one with moderate air pollution and climate change, and the other in which climate change

is weakly tackled and air pollution strongly controlled.

The results of the analysis suggested that the national average potential for generating solar power could fall by two to nearly four per cent, compared to that during 1985-2014, mainly due to a reduced radiation and increased temperatures.

Further, temperatures of solar cells could be expected to rise by 1.5-2 degrees Celsius, resulting in efficiency losses and an additional of about 18 days of efficiency de-rating, especially in solar-rich regions.

Based on data of solar power generated during 2023-24, loss in generation capacity was projected to range from 600 gigawatt-hours, under moderately controlled air pollution and climate change, to up to 840 gigawatt-hours, under a weak climate action with strong air pollution control, according to the study.

Solar cells -- used in making solar panels and for converting sunlight into electricity -- would need to be innovated for future assessments looking into India's solar power potential, the team said.

They called for robust measures for controlling air pollution and urgent climate action to mitigate losses in generating solar power.

Further, rapidly transitioning to renewable energy is crucial to mitigating both air pollution and climate change, the authors said.

In a statement Hyundai Mo-tor India Ltd (HMIL) said it will hike prices of its vehicles by up to 3 per cent effective in April 2025. The quantum of price increase will vary based on the variants and mode

## **Gold Rallies ₹700 To Hit Fresh Record High Of ₹91,950/10g**

NEW DELHI: Gold prices advanced Rs 700 to reach a new lifetime high of Rs 91,950 per 10 grams in the national capital on Wednesday on the back of continued buying by jewellers ahead of wedding season, according to the All India Sarafa Association.

Besides, increased tensions in the Middle East and concerns about the US economic slowdown have kept the demand for safe-haven assets intact.

The precious metal prices of 99.9 per cent purity soared by Rs 700 to hit a fresh all-time high of Rs 91,950 per 10 grams. It had concluded at Rs 91,250 per

10 grams on Tuesday. Gold prices of 99.5 per cent purity also rallied by Rs 700 to hit a record high of Rs 91,500 per 10 grams. Traders said increased buying by local jewellers

to meet festive and wedding season demand and a firm trend in the overseas markets mainly lifted gold prices to this year's highest Îevel.

Silver prices also surged by Rs 1,000 to hit a record peak of Rs 1,03,500 per kg from Tuesday's closing level of Rs 1,02,500 per kg. In futures trade, gold fu-

tures for April delivery rose

by Rs 19 to Rs 88,745 per 10 grams. In the morning trade, it climbed Rs 288 to breach the psychological level of Rs 89,000 per 10 grams.

"Gold prices maintained an overall upward trend but remained range-bound ahead of the highly an-ticipated Fed policy and statement tonight," Jateen Trivedi, VP Research Analyst Commodity and Currency at LKP Securities, said.

In the international markets, spot gold rose 0.15 per cent to USD 3,039.22 per ounce. During the session, it hit a record high of USD 3,045.39 per ounce.

Meanwhile, gold futures in the Asian market hours eked out another fresh alltime high by touching USD 3,052.31 per ounce.

MUMBAI: Indian economy continues to demonstrate resilience as evident in the robust performance of the agriculture sector and improving consumption despite escalating trade tensions, the RBI March Bulletin said on Wednesday. The resilience of the global

economy is being tested by escalating trade tensions and a heightened wave of uncertainty around the scope, timing, and intensity of tariffs, said an article on 'State of the Economy' published in the Bulletin. While engendering heightened volatility in global financial markets, these have

also caused apprehensions about the slowdown in global growth, it said. "Amidst these challenges, the Indian economy continues

to demonstrate resilience as evident in the robust perfor-mance of the agriculture sector and improving consumption," it said.

The reverberations of a tumultuous external environ-



ment, however, are being reflected in sustained foreign portfolio outflows, said the authors.

The article further said India's macroeconomic strength to face these challenges is bolstered by a decline in headline CPI inflation to a seven-month low of 3.6 per cent in February 2025 on account of a further correction in food prices.

### 'India's Structural Strengths Provide **Strong Foundation For Growth'**

MUMBAI- Sound fiscal policies, a well-calibrated monetary framework, and digital transformation initiatives are expected to provide a strong foundation for long-term sustainable economic growth, said RBI March Bulletin released on Wednesday.

It also said that macroeconomic fundamentals remain strong, and economic growth is poised to sustain momentum driven by robust domestic demand, steady investment activity, and ongoing policy-driven infrastructure development along with a pick-up in government spending.

An article on 'State of the Economy' published in the Bulletin noted that the resilience of the global economy is being tested by escalating trade tensions and a heightened wave of uncertainty around the scope, timing, and intensity of tariffs.

While engendering heightened volatility in global financial markets, these have also caused apprehensions about the slowdown in global growth. "Amidst these challenges, the In-

dian economy continues to demonstrate resilience as evident in the robust performance of the agriculture sector and improving consumption," the article said.

The reverberations of a tumultuous external environment, however, are being reflected in sustained foreign portfolio outflows, it added.

The article further said high frequency indicators suggest that aggregate demand continued to remain resilient in Q4:2024-25. "Activity indicators such as E-way bills and toll collections recorded double digit (yo-y) growth in February 2025," it said.

Also high frequency food price data for March so far (up to 17th) show an increase in cereal prices, both for rice and wheat. Edible oil prices have firmed up as well mainly driven by palm, soybean and sunflower oil. Pulses prices, on the other hand, continued to show broad-based moderation.

### **Govt Enhances Outlays To Rs 6,190 Cr For Two Schemes To Boost Milk Production**

**NEW DELHI-** The government on Wednesday enhanced outlays to Rs 6,190 crore for two schemes aimed at increasing milk production.

Information and Broadcasting Minister Ashwini Vaishnaw informed that the Union Cabinet has approved the revised Rashtriya Gokul Mission (RGM) and National Program for Dairy Development (NPDD).

Both the schemes, which seek to enhance milk production and raise farmers' income, will now have a total outlay of Rs 6,190 crore.

Union Cabinet, chaired by Prime Minister Narendra Modi, has approved the revised RGM to boost growth in livestock sector, the minister said.

Implementation of revised RGM, as central sector component of development programmes scheme, is being done with an additional outlay of Rs 1,000 crore, taking the total to

Rs 3,400 crore during 15th Finance Commission cycle from 2021-22 to 2025-26.

The revised NPDD, a central sector scheme, has been enhanced with an additional allocation of Rs 1,000 crore, bringing the total budget to Rs 2,790 crore for the period of the 15th Finance Commission cycle (2021-22 to 2025-26).

The initiative focuses on modernising and expanding dairy infrastructure, ensuring the sector's sustained growth and productivity.

With the implementation of the Rashtriya Gokul Mission and other efforts of the government, milk production has increased by 63.55 per cent in the last ten years, an official release said.

Also, the availability of milk per person, which was 307 grams per day in 2013-14, has increased to 471 grams per day in 2023-24.

Productivity has also increased by 26.34 per cent in the last ten years, it added.

### World Bank Approves USD 102 Mn To **Boost Pakistan's Microfinance Sector**

ISLAMABAD- The World Bank has approved USD 102 million for cashstrapped Pakistan for a project that aims to enhance access to microcredit and support the resilience of the microfinance sector and its borrowers, particularly in the face of climate-related shocks.

The financing under the 'Resilient and Accessible Microfinance (RAM) project' was approved by the World Bank board of directors on Tuesday, according to a statement issued by the World Bank.

Najy Benhassine, World Bank country director for Pakistan, said in the statement that microfinance is a critical tool for supporting the livelihoods of vulnerable populations in Pakistan.

"This project will help strengthen the resilience of the microfinance sector, particularly in the face of growing climate risks, ensuring that the sector can continue to provide essential financial services to those

who need them most, especially in rural areas," he said.

He also said that this project was part of the Bank's broader commitment to promoting financial inclusion in Pakistan and to increasing resilience to climate change, as spelt out in the new 10-year Country Partnership Framework.

According to the statement, the project will benefit nearly 1.89 million people, including more than 1 million women and over 350,000 youth, and especially those in vulnerable and low-income rural areas.

Through the provision of financial resources to microfinance institutions, the project will ensure that institutions can "continue to provide services even during climateinduced financial pressures".

"The project will provide increased access to microcredit for individuals and small businesses, providing them 'recovery loans' to help them gain financial stability," the statement read.

## Art 370 Was Removed Without Firing Single Bullet: Rajnath Singh

New Delhi: Defence Minister Rajnath Singh said the governsuccessfully removed ment Article 370 – a significant obstacle – without firing a single bullet, ensuring the complete integration of Jammu and Kashmir with India.

This historic move was achieved peacefully while ensuring the security of all stakeholders, he added.

Speaking at the Major Bob Khathing Memorial Event in Delhi on Wednesday, Singh emphasised the government's commitment to administrative reforms through the principles of "minimum government, maximum governance" and "good governance." He highlighted how these ini-

tiatives have reduced the gap between the government and the people.

Singh drew a parallel between the government's actions in Jammu and Kashmir and Major Bob Khathing's peaceful integration of Tawang with India. Praising Khathing's contribution to the Northeast, he remarked, "The work done by Major Bob Khathing for the Northeast is similar to what Sardar Vallabhbhai Patel did for national integration."

The Defence Minister also tens," he said.

underlined the government's robust foreign policy, which he attributed to the diplomatic acumen of figures like Khathing. "Today, India balances hard power and soft power in a multipolar world. It is a matter of pride that India has strengthened its global position. There was a time when India was not taken seriously on international forums, but today, when we speak, the world lis-

Singh stressed the importance of unity in achieving the goal of making India a developed nation by 2047 and acknowledged the Northeast's role in this journey. will be left vulnerable, with no structured system to help them seek justice.'

The sudden decision has sparked outrage, with activists questioning why such a crucial initiative is being discontinued when the need for it remains dire.

"Since J&K, as a Union Territory, does not have its own State Women's Commission, it is the responsibility of the NCW to ensure a smooth transition. They must extend their support for a few more months beyond March 31, giving the UT government time to take ownership of the initiative."

With institutional support now uncertain, appeals are being made to the UT administration, Home Department, and Social Welfare Department to step in and ensure the continuity of these essential services. logistical support, food, shelter and money, the suspects were involved in guiding the terrorists through the difficult terrains of Jammu province to ensure their safe passage," it said. adding, " The terrorists were then believed to have made their way to the hinterland districts of Kathua, Udhampur, Doda, Kishtwar, Reasi, Rajouri, Poonch, and also to the Kashmir Valley.'

The NIA statement said multiple locations were searched across Jammu. "NIA teams conducted extensive searches at the homes of over ground workers (OGWs) linked with the newly-formed offshoots and affiliates of banned terrorist organisations such as the LeT and JeM," it said, adding, "Premises of sympathizers and cadres of these outfits were also searched as part of the action taken by the anti-terror agency in the case RC-04/2024/NIA/JMU.'

The statement said that the case is linked with the series of attacks carried out by terrorists on security forces and civilians some months ago as part of a larger criminal conspiracy by terror organisations to wage a war against the Government of India.

"A total of 12 locations in Jammu district were searched today as part of the operation, and several incriminatory materials linking the terrorists with OGWs were seized. NIA teams are examining the material to unravel the terror conspiracy," it reads.

The transition in the state began with censorship and a communication blockade, effectively snatching away our voices," Parra said in the Assembly.

He further criticized the J&K government's media policy, calling it an attempt to control information rather than regulate journalism. 'The current media policy does not need a review; it needs to be completely scrapped. It is a tool of censorship meant to establish a statecontrolled press," he asserted.

Parra also raised the issue of the Srinagar Press Club's closure, highlighting the deployment of a police station inside the club and two senior officers in Press Colony. He argued that this move was not about security but a calculated attempt to police the media and suppress independent voices.

"The message was clear: the closure of the Press Club was an attempt to silence journalists and prevent independent reporting in Jammu and Kashmir," Parra stated. "By placing police inside the Press Club, the government has tried to muzzle the media and suppress dissent.'

Referring to the challenges faced by journalists in recent years, Parra recalled how the communication blockade had prevented Kashmiri reporters from publishing freely. "When we were all locked inside, the media could not write. And those in independent media who dared to report the truth faced consequences," he said.

Parra urged the J&K government to take a stand for independent journalism by restoring the Srinagar Press Club and relocating the police station. "Restoring the Press Club is not just about reopening a building. It is about ensuring that independent journalism can survive in Jammu and Kashmir," he stressed.

Parra also raised concerns over the allocation of funds for industrial development in Jammu and Kashmir. He pointed out that out of the

20,000 crore allocated for industrial estates over the past five years, 80% had been given to outsiders, leaving little for local entrepreneurs. "The J&K government has no industrial policy," he said, urging the administration to prioritize the interests of local businesses.

On the issue of land laws, Parra expressed fear and insecurity among the people of Jammu and Kashmir. He called for a revision of the land laws, stating, "We are not here to justify the actions of the past five years.'

The PDP leader further highlighted discrepancies in the implementation of the housing scheme, particularly the allocation of land based on the 2018 survey. He criticized the commodification of water resources and opposed the privatization of electricity, calling for a one-time rehabilitation plan for affected communities. Parra demanded a transfer policy for Kashmiri Pandits appointed under the Prime Minister's Package, ensuring their safety and convenience. He urged the government to expedite compassionate appointments for families of deceased government employees. Furthermore, Parra questioned why J&K police personnel were not receiving hardship allowances similar to those given to central paramilitary forces and demanded the removal of such anomalies.

#### J&K Govt Forms

"The committee will consist of Chief Secretary, Chairman, Additional Chief Secretary, Member, Administrative Secretary, Finance Department Member, Administrative Secretary, General Administration Department Member, Administrative Secretary, Planning, Development & Monitoring Department Administrative Member, Secretary, Department of Law, Justice & Parliamentary Affairs Member," the order states.

"The Committee shall examine various issues, including humanitarian, legal, and fi-nancial, related to the regularization of Casual, Seasonal Labourers or Other Workers etc. in Jammu and Kashmir, and suggest a comprehensive way forward," the order states.

The General Administration Department will service the committee, and it has been tasked with submitting its report within six months.

#### Stray Dog Menace

Kashmir has also filed a compliance report. "A copy of the same be also furnished to Ms. Gauri Maulekhi via email or WhatsApp ....," the court said, adding, "Ms. Gauri Maulekhi, shall examine both the compliance reports filed by the Union Territories of Jammu & Kashmir and Ladakh, and may, if she so desires, file her

response and/or additional suggestions, as may be deemed necessary."

Meanwhile a copy of a newspaper report was placed before the court, highlighting that stray dogs have reportedly been roaming unchecked inside the Government College for Women, M.A. Road, Srinagar, causing fear and distress among students.

The menace posed by stray dogs, not only in Srinagar but across both Union Territories, warrants immediate and serious attention," the court said, adding, "The issues raised in these PILs require urgent deliberation and appropriate remedial measures to mitigate the threat to public safety."

#### J&K Assembly

Akram echoed the demand, asserting that the lack of clarity around the cause of deaths necessitated a CBI inquiry.

"Nobody is listening to us. A CBI probe is needed," he said.

CPI(M) MLA Muhammad Yousuf Tarigami called for exposing the "invisible hands" behind the fatalities.

"It is ironic that the cause remains unknown. What happened there today could happen anywhere tomorrow." he warned.

In response, Minister Sakina Ittoo stated that the Home Department was already investigating the matter.

'We do not have jurisdiction over the Home Department to order another inquiry at this stage," she said, but assured that further steps would be considered once the current probe is completed.

In a written statement, the minister disclosed that laboratory reports from PGIMER Chandigarh detected traces of aluminum and cadmium, while the CSIR-IITR Lucknow report found Aldicarb sulfate, Acetamiprid, Diethyldithiocarbamate, and Chlorfenapyr.

Additionally, tests conducted by DRDE-DRDO Gwalior confirmed the presence of Chlorfenapyr and Abrin in food samples, including sattu and maize bread. The National Food Laboratory (FSSAI) in Ghaziabad also found traces of Chlorfenapyr and Chlorpyrifos. The CFSL Chandigarh report confirmed Chlorfenapyr in the viscera samples of all 17 victims.

Notably, the Union Home Ministry has already deployed an inter-ministerial team to investigate the cause of these deaths.

## **BCCI Could Lift Saliva Ban In IPL, Ball In Captains' Court**

NEW DELHI: In a move that could have global impact, the BCCI is considering lifting the ban on applying saliva on the ball in the Indian Premier League beginning March 22.

The proposal has been discussed at length internally within the BCCI and will be floated to captains of all IPL teams in a meeting in Mumbai on Thursday.

The International Cricket Council (ICC) had banned the age-old practice of applying saliva to shine the ball as a precautionary measure dur-ing the COVID-19 pandemic. In 2022, the ICC made the ban permanent.

The IPL too included the ICC ban in its playing conditions in the aftermath of the pandemic but its guidelines are outside the purview of the sport's governing body.

"Using saliva on the ball was



part of the essence of the game until COVID hit. Now that we don't have that threat anymore, we feel there is no harm in lifting the ban on saliva in the IPL. "We understand that it

makes a bigger impact in red ball cricket but even if it can

help bowlers a bit in the white ball game, it should be allowed in the IPL, which is a trend setting tournament. Let's see what the captains decide tomorrow.' a top BCCI official told PTI.

On the sidelines of the ICC Champions Trophy, senior India pacer Mohammed Shami had spoken about the need to use saliva on the ball in what has become a predominantly bat-

#### ters' game. The likes of Vernon Philander

and Tim Southreee had backed Shami's call.

"We keep appealing that we should be allowed to use saliva so that we can bring reverse swing back into the game and it becomes interesting," Shami had said during the 50-over event in Dubai, where India emerged victorious.

As per the existing rules, if it is a first instance of applying saliva on the ball, the fielding team's captain is summoned and issued a first warning.

"If it is the second instance during an innings, summon the captain of the fielding side and issue a second and final warning to the captain of the fielding side.

"If it is the third or subsequent instance he is subject to a fine, payable to BCCI, of the lesser of 10 lakh or 25% of his match fee," states last year's IPL playing conditions.



## **Boxing Champion Khelif Targets** Second Olympic Gold In LA

mane Khelif, who won Paris Olympics boxing gold amid a gendereligibility row, is determined to defend her title at the 2028 Los Angeles Games and says she will not be intimidated by U.S. President Donald Trump.

Trump signed an executive order banning transgender women from female sports in the United States last month and called Khelif "a male boxer" in his speech after signing the order.

"I will give you a straightforward answer, I am not transgender," she told ITV in an interview.

"This does not concern me, and it does not intimidate me.'

The International Olympic Committee's executive board recommended boxing's inclusion in the 2028 Games on Monday and Khelif said she dreamed of retaining her title in California.

"Second gold medal, of course. In America, Los Angeles ... I (will) defend with everything this gold medal," she said

"I believe that if the old Imane oper-

ated at 50% of her potential, then the Imane Khalif of today is even more motivated and determined."

Khelif was disqualified by the International Boxing Association at the 2023 world championships after a test that the body said rendered her ineligible to fight as a woman on the grounds of gender.

The IBA lost its Olympic recognition over governance issues, however, and the International Olympic Committee cleared Khelif to compete in Paris, aggressively defending its position after heavy

criticism A rival body to the IBA, World Boxing, was given provisional recognition as the international governing body of the sport last month.

The recommendation still requires final approval by the IOC at its session in Greece and outgoing President Thomas Bach said he was confident the session would approve it.

"At this point, I can say that the

IBA is a thing of the past," Khelif said. "As we say in Algeria, those who have nothing to hide should have no fear."
