

# **Spring Resolutions: Why It's The Best Time Of Year To Make Healthy Changes**

### The Conversation

In the middle of winter, when lack of sunlight can lead to low energy and low mood, we are expected to make new year resolutions. But why not wait till March, for spring, when the returning sunlight gives us the energy and improved mood to tackle fundamentally difficult things like starting a new diet or exercise regime? We need spring resolutions, not new year resolutions.

In winter, many animals hibernate by slowing their heart rate and metabolism to conserve energy when food and sunlight are scarce. Humans don't hibernate, but we do have a period during winter when we may slow down.

We might have slower metabolism (possibly leading to winter weight gain), feel sleepier (thanks to less melatonin from sunlight and have lower mood (also due to less sunlight) – which, in extreme cases, can lead to seasonal affective disorder, or Sad.

The slowing of our bodies during winter can be difficult because the demands on us don't change. Our work and family commitments, for example, don't slow down in those dark, cold months.

Stress is normal and our healthy biological response gives us the energy we need to deal with it. However, when stress is excessive and we feel like we don't have the resources to deal with it, we can feel "stressed out".

Feeling "stressed out" – fatigue, frustration and an inability to cope – can be heightened during winter due in part to the slowing of our bodies and the lack of energy and resources to deal with the stressful things we encounter.

January and February pass by in a blur. We attempt to get back into the swing of things and fulfil those new year resolutions, while still feeling the lethargy of winter.

New year resolutions come at a bad time. We are still feeling stressed and our bodies are in a state of mild hibernation lacking

the energy to tackle new workout routines or diets.

Then, suddenly, March arrives. The sun emerges, flowers bloom and our bodies begin to wake up. Getting out of bed is a little easier because it's not as dark anymore. Those new year resolutions that seemed so impossible in January might seem a little more doable after finally seeing the sun.

If you are starting to get some energy, looking back at those new year resolutions you really shouldn't have had to make, and feeling disappointed, don't be. Instead of focusing on what didn't

happen, make spring resolutions. But don't get excited and add too much. Remember, we were underresourced for months and it can take a while to bounce back.

Gentle spring resolutions

Think of gentle spring resolutions that might help you get some energy and improve your mood as

your body soaks up that vitamin D and finally starts moving with the spring thaw.

### Here are mine.

Move for 20 minutes a day, whether it's a walk, a run, grocery shopping, or chasing after kids. Start small and get moving any way you can. Walking doesn't cost anything, is low demand and has a huge impact on your health.

Drink water. Our bodies (which are about 60 per cent water) need hydration consistently to function well. Drinking water is one of the easiest and most effective health interventions out there.

Spend at least ten minutes a day in the sun (especially in the morning to help with sleep patterns). Sun is like a battery for the human body. It tells you to wake up and gives you needed energy for the day, while also helping mood levels. The golden rule for resolutions?

Keep them simple and achievable.

The appropriation bill is crucial as it allows the government to withdraw funds from the consolidated fund of the Union Territory to meet its expenses

for the financial year. Chief Minister Omar Abdullah, who also holds the finance portfolio, presented the appropriation bills for fiscal years 2025-26 and 2024-25 in the assembly, both of which were passed by voice vote after their introduction.

"We have not yet responded to the US president's letter, and this response is being prepared and will be presented soon through the appropriate channels and in the appropri-

"We do not negotiate directly with the United States under maximum pressure where we are witnessing military threats and increased economic sanctions from Washington," he said.



The Trump administration recently restored the so-called maximum pressure policy, first introduced during Trump's initial term in office in 2016.

Under this policy, Trump with-drew the United States from a landmark agreement on Iran's nuclear program in 2018 and reimposed crippling sanctions on Tehran.

The 2015 deal, signed between Tehran and world powers, saw Iran commit to temporary confidence-building restrictions on its nuclear activities in exchange for the removal of Western-imposed economic sanctions. On March 7, Trump an-

nounced he had written to Iran to call for nuclear negotiations and threaten military action.

The letter was delivered to Tehran on March 12 by UAE presidential adviser Anwar Gargash.

Leader of the Islamic Revolution Ayatollah Seyyed Ali Khamenei responded on March 21, stating that US threats "will get them nowhere" and warning of reciprocal measures "if they do anything malign" against Iran.

He also dismissed Trump's outreach for talks, accusing him of attempting to deceive global public opinion by portraying the United States as willing to negotiate while framing Iran as unwilling to engage

# **Trump's Crackdown: Will Green Card Holders Lose Digital Privacy?**

Srinagar- The Trump administration is considering a controversial new policy that would require Green Card holders and asylum seekers to disclose their social media accounts to the U.S. government.

The move, seen as an extension of the existing visa scrutiny policy, would impact millions of legal residents, including many Indians and other immigrants who have built lives in the United States, Critics argue that this could stifle free speech, discourage political activism, and even be used to bar government critics from securing permanent residency.

The proposal, announced in a notice released on March 5, is currently open for public comment. The administration justifies the policy as necessary for "national security screening", but opponents warn it could be a tool for ideological policing.

### Social Media Monitoring: From Visa Applicants to Green Card Holders

Under a 2019 policy introduced by Trump during his first term, visa applicants from abroad were required to disclose

their social media handles to the U.S. Citizenship and Immigration Services (USCIS) as part of their background checks. The

# Delhi Government To **Relocate Tihar Jail, Allocates Rs 10 Crore For Survey**

New Delhi: Chief Minister Rekha Gupta on Tuesday announced plans to relocate Tihar Jail to the city's outskirts while setting aside Rs 10 crore in the 2025-26 budget for survey and consultancy services related to the shifting of the jail. Established in 1958, Tihar Jail is one of India's largest prison complexes comprising nine prisons spread over more than 400 acres one prison in Rohini and six prisons in Mandoli.

"In order to decongest the existing Tihar Jail Complex for the welfare of prisoners, a new scheme for development of a new Jail Complex by shifting the existing Tihar Jail Complex to some other location has been formulated," the Delhi chief minister said while presenting the hudget in the assembly Located in West Delhi, Tihar is close to Tilak Nagar and Hari Nagar areas of the city. Originally designed to house approximately 10,025 inmates, it currently accommodates over 19.000, leading to overcrowding and security challenges. The Delhi government has initiated the development of new prison complexes in Narela to alleviate congestion. Meanwhile, a Tihar Jail source said, "We had also asked for space in Baprola, but due to encroachment, we couldn't get that. However, we have written to the Delhi government to provide 100 acres of land somewhere else " The source said that Jail Numbers 1 to 9 are designed to house approximately

5,000 inmates, but these accommodate over 12,000 prisoners at present

'Jail Number 10 to 16 are designed to house approximately 3,700 inmates, but currently accommodate over 3,900 inmates. Jail Number 4 in Tihar and 12 in Mandoli Jail are known as 'Mulaija Jail' which means first-time offenders. We have a large number of inmates in these two jails," said the source. The source also said that a shortterm proposal has been made for retrofitting the jail and vertically extending it up to two floors, making the capacity three times. "This will make the space sufficient for accommodation for up to five to ten years," the source said.

The chief minister in her budget also announced the formation of a society under the aegis of the Delhi Jail.

The society will focus on the refor-



# Assam Assembly Passes Bill To Regulate Coaching Centres

In case of violation of proposed law, the government can cancel or suspend their registration (File)Guwahati:

The Assam assembly on Tuesday passed a bill to regulate private coaching centres, making it mandatory for registration of all such institutes and strict compliance with laid-down guidelines.

During discussion on the proposed legislation, MLA Sherman Ali Ahmed was suspended from the House by Deputy Speaker Numol Momin for disrupting a minister's reply.

Mr Ahmed, who had been earlier suspended from the Congress, tried to intervene when Education Minister Ranoj Pegu was speaking, prompting the deputy speaker to suspend him for 10 minutes.

Mr Pegu, who had moved the proposed new law, said the



objective behind it is to control commercialisation of coaching centres and ensure that guardians get justice.

"The guardians and students had no one to approach if they are duped or misled by the coaching institutes. Hence, we have brought this bill," he said.

Mr Pegu said the provisions of the bill, including the period of 30 days given to apply

for registration for existing centres once the law is notified, have been carefully evaluated and enshrined.

He maintained that coaching centres are primarily to prepare students seeking admission to higher education institutions, like engineering and medicine, and hence, provisions of the bill cater to students aged 16 years and above.

'The Assam Coaching Institutes (Control and Regulation) Bill. 2025', which was passed by voice vote, provides for the control and regulation of private coaching centres and institutes, for providing better academic support in preparation for different competitive examinations.

It also specifies that no coaching institute will engage in any affairs relating to religious conversion, and shall strictly adhere to the secular principles as enshrined in the Constitution.

The institutes seeking registration have to provide information on its curriculum, duration of classes, co-curricular activities for the students, academic qualification of teachers, tuition fees, physical infrastructure and other facilities.

The tenure of a registration certificate will be two years, after which the institute has to reapply for renewal, according to the provisions of the bill.

# Israel releases Oscar-winning **Palestinian director**

HEBRON: Israeli authorities released an Oscar-winning Palestinian director who was illegally detained by the army after being attacked by Jewish settlers in the occupied West Bank. He said they beat him in front of his home while they filmed the assault.

Hamdan Ballal and the other directors of "No Other Land," which looks at the struggles of Palestinians living under Israeli occupation, had mounted the stage at the 97th Academy Awards in Los Angeles earlier this month when it won the award for best documentary film.

On Tuesday, with bruises on his face and blood on his clothes, he was released from an Israeli police station in the West Bank settlement of Kiryat Arba. He and two other Palestinians who had been attacked and detained were taken to a nearby hospital. Ballal said he was held at an army base, blindfolded for 24 hours and forced to sleep under a freezing air conditioner

"All my body is pain," he told The



Associated Press. "I heard the voices of the soldiers, they were laughing about me ... I heard 'Oscar' but I didn't speak Hebrew." Lea Tsemel, the attorney representing the three men, said they received only minimal care for their injuries from the attack and that she had no access to them for several hours after their arrest

Palestinian residents say around two dozen settlers-some masked, some carrying guns and some in military uniforms-attacked the West Bank village of Susiya on Monday evening as residents were breaking their fast during the Muslim holy month of Ramadan.



# 🔌 KO VIEW Valley's Changing Course

ome minister Amit Shah on Tuesday said that two Hurriyat-linked groups had renounced separatism, identifying them as J&K People's Movement and Democratic Political Movement. He urged all such groups to come forward and shed separatism once and for all while declaring separatism a history. This reflects a profound change in the ongoing situation in the Valley, something that was unthinkable a few years ago.

The home minister attributed this to the prime minister "Narendra Modi's vision of building a developed, peaceful and unified Bharat." Speaking in Rajya Sabha, the home minister backed up his claim with figures. While in 2004, 1,587 incidents of violence were reported in J&K, the number dropped to just 85. Similarly, civilian deaths, according to home ministry figures, have fallen from 733 to 26, and security personnel casualties have declined from 331 to 31 over the same period. It is also obvious that the stone-pelting is now virtually non-existent. Strikes, once a routine method of expressing dissent, have also disappeared.

However, the renunciation of separatism by the two Hurriyat constituent groups has a certain symbolic significance. It is rarely that a political outfit has severed ties to separatism. However, last year, a major politicoreligious party Jamaat-i-Islami decided to contest the Assembly election, effectively distancing itself from its separatist moorings. The party failed to win a single seat but did create some buzz in its strongholds in South Kashmir. In February, the same Jamaat leaders floated a new party christened as the Justice and Development Front (JDF), which will contest the upcoming grassroots elections. It is the third new political party in Kashmir since the abrogation of Article 370 in August 2019. First two were the Apni Party led by Altaf Bukhari and the Democratic Progressive Azad Party (DPAP) founded by the former Congress veteran Ghulam Nabi Azad. Both of them have not been able to make any mark since their advent. However, there are no full stops in politics and the past performance is never an indicator of what might happen in future.

Taken together, these developments do highlight a sea change in the situation. Will other outfits follow suit remains to be seen. It may be premature to conclude that the Valley has turned the page on its troubled past. While separatist politics may be over, separatist violence lingers. The latest encounter in Kathua is a case in point. However, for true peace to prevail, it needs to be built on by an outreach to people and giving them a sense of empowerment in the transformed state of affairs.



h, the spring-nature's grand resurrection, a symphony of Trebirth that awakens the slumbering earth from its wintry tomb. The trees, once skeletal and barren, now don emerald cloaks, their branches heavy with the promise of life. Buds, like shy maidens, unfurl into a riot of colors, painting the world in hues so vivid they seem to defy the very essence of winter's monochrome. The air, thick with the perfume of blossoms, hums with the melodies of winged wanderers-exotic birds adorned in plumage so resplendent, they seem to have flown straight out of a painter's dream. But now, even the **kangich** eludes me, not just in the orchards but in the corridors of my memory. The peach blossoms, though as breathtaking as ever, no longer stir the same awe. The thunderstorm's roar feels less like a promise and more like a reminder—a reminder of how much time has changed, how much I have changed. The spring, once a balm for my weary spirit, now feels like a stranger, its beauty a mirror reflecting all that I have lost "It's a secret," I whispered, entrusting her with the knowledge of my hidden haven, for she was the only one I truly trusted.

Those days, though long gone, remain etched in my memory like the intricate patterns of a morel's surface. We would crawl under the bushes, our hands scratched and our clothes snagged, all for the sake of uprooting those precious greens and carrying them home like trophies.

Once home, we would plant them in our lawns or kitchen gardens with great ceremony, as if we were laying the foundation of a grand botanical empire. We watered them diligently, our eyes sparkling with pride as we imagined them growing into lush, towering plants. For a few days, they

Among the many joys of those golden days, fishing was a cherished ritual, a pastime that bound me, my brother, and my cousin in a shared adventure. No, they were crystalline veins of liquid their waters so clear you could see the pebbles shimmering beneath the surface, each one a tiny jewel catching the sunlight. We would set out with nothing more than a stick, a knife, and our boundless enthusiasm. Tying the knife to the stick, we fashioned our makeshift spears, ready to hunt for the silvery flashes of fish darting through the water. The process was as much about patience as it was about precision. And then, there was the magic of refraction—the way the water bent the light, making the fish appear just out of reach, a trick of nature that both frustrated and fascinated us. It was a lesson in physics disguised as play, though we were too young to realize it then. The spring season, in particular, held a special allure. The elders would say that the fish tasted better in spring than in any other season. I never quite understood the logic behind this claim-was it the freshness of the water, the abundance of food, or some mystical quality of the season itself? Whatever the reason, it added an air of reverence to our springtime fishing expeditions, as though we were partaking in a tradition as old as the hills themselves. But now, those streams are but a shadow of what they once were. The crystal-clear waters have turned murky, choked with dirt, drainage, diapers, and polythene-a grim testament to the toll of progress and neglect. The fish, if any remain, are hidden beneath lavers of filth, their once-gleaming scales dulled by the pollution. The refraction of light, once a source of wonder, is now a distant memory, obscured by the grime of a world that has forgotten the beauty of simplicity. Yet, in my mind's eye, the streams still run clear. I can still see the fish darting through the water, their movements swift and graceful. Some of us, armed with ancient wisdom passed down through generations, would dab **Kohl** or **kajal** on our eyes, believing it to be a magical potion that sharpened our vision and granted us the power to spot morels where others saw only dirt and leaves. It was a charming superstition, one that added a touch of mystery to our already enchanted pursuit.

There was a place, hidden away from the prying eyes of the other children, where the earth seemed to conspire in my favour. It was there, in that secluded spot, that I would find the most magnificent morels giant, majestic, and unlike any the other children had ever seen.

I remember the day I brought home my first giant morel, its honeycombed surface glistening like a jewel. My sister's eyes sparkled with wonder as she exclaimed, "Baaya, che kati loubuth yi?" (Brother, where did you find this?) Her voice was filled with awe, and in that moment, I felt like a hero, a conqueror of nature's secrets. But I was careful, oh so careful, to reveal only the barest hint of my discovery. were the center of our universe. We would check on them morning and night, marveling at their resilience and dreaming of the day they would transform our humble gardens into verdant paradises.

But childhood, as it often does, had other plans. School, with its endless assignments and rigid routines, would soon reclaim our attention. The plants, once the objects of our undying devotion, were gradually forgotten. The watering cans gathered dust, and the dreams of lush gardens faded into the background. By the time we remembered our green companions, they had often withered, their leaves dry and brittle, their once-promising vitality reduced to a memory.

It was a cycle of passion and neglect, a reflection of the whimsical nature of childhood. We were fervent in our pursuits but easily distracted, our hearts as fleeting as the seasons. Yet, in those brief moments of care and attention, we learned something profound—about nurturing, about responsibility, and about the delicate balance of life.

Looking back, I can't help but smile at the irony. We worked so hard to collect those plants, braving thorns and dirt, only to abandon them when life got busy. But perhaps have lost a piece of ourselves—a connection to nature, to tradition, to the innocence of a time when the world felt pure and full of wonder.

It Is not just the streams that have changed; it is us. As we have dirtied our surroundings, so too have we dirtied our hearts. The things that once allured us—the sight of a fish breaking the surface, the sound of water trickling over stones, the smell of earth and greenery—no longer stir our souls. We have become desensitized, our senses dulled by the noise and clutter of modern life. The world moves faster now, and we with it, but at what cost?

The loss of those streams is more than an environmental tragedy; it is a metaphor for what we have sacrificed in the name of progress. We have traded the simplicity of nature for the complexity of convenience, the purity of clear waters for the pollution of our own making. And in doing so, we have distanced ourselves from the very essence of what it means to be alive—to feel, to wonder, to connect.

But perhaps there is still hope. Perhaps, in remembering those streams and the joy they brought, we can find the motivation to reclaim what we have lost. To clean not just our surroundings, but our hearts as well. To teach the next generation the value of nature, not as a resource to be exploited, but as a gift to be cherished.

The streams of my childhood may be gone, but their memory remains a reminder of a time when the world was simpler, and our hearts were lighter. And though we cannot turn back time, we can choose to move forward with greater care, with greater respect for the earth and for ourselves. For in the end, the cleanliness of our surroundings is a reflection of the cleanliness of our hearts. And only when both are pure can we truly find peace.

**NEW DELHI-**Finance Minister Nirmala Sitharaman on Tuesday said the Finance Bill 2025 provides unprecedented tax relief, and the 13.14 per cent projected growth in personal income tax collection is "realistic" and sup-ported by solid data.

Replying to the discussions on Finance Bill 2025 in the Lok Sabha, Sitharaman also said the customs duty rationalisation announced in the Budget will support manufacturing units, do-mestic value addition, promote

exports, facilitate trade and also provide relief to the

common people. In the 2025-26 Budget, the gov-So, the projected ernment has hiked collections for income tax rebate income tax for 2025to Rs 12 lakh per 26 are based on solid annum from Rs 7 data," lakh earlier. For the salaried class,

this rebate will be Rs 12.75 lakh per year after taking into account the standard deduction. The hike in I-T rebate will lead to tax foregone to the tune of Rs 1 lakh crore in FY26.

Sitharaman said the Budget also provides "marginal relief" under the Income Tax law for those taxpayers whose income exceeds Rs 12 lakh per annum by a small margin.

"The Finance Bill provides unprecedented tax relief to honour taxpayer... We have recognised the contribution of the middle class," she said.

Collections in personal income tax have shown considerable buoyancy in the last few years



and they have been increasing around 20 per cent year-on-year, the minister added.

"For the year 2025-26, the personal income tax collection is projected at Rs 13.6 lakh crore. The Revised Estimates for 2024-

25 is Rs 12.2 lakh crore. So, Rs 12.2 lakh crore is going to be Rs 13.6 lakh and this is done with a certain realistic calculation," Sitharaman said.

The personal I-T revenue is projected to grow by 13.14 per cent in FY26, after taking

into account a 7 per cent dip after factoring in the Rs 1 lakh crore revenue foregone. "So, the projected collections for income tax for 2025-26 are based on solid data," Sitharaman added. With regard to an amend-

ment regarding the abolition of the 6 per cent Equalisation Levy on online advertisements, Sitharaman said it was done to address "uncertainty in the international economic conditions". Talking about Customs tariff rationalisation, she said the Budget 2025 aims to boost domestic production and enhance export competitiveness by reducing duties on raw materials

SRINAGAR: In a gamechanging move for India's workforce, the Employees' Provident Fund Organisation (EPFO) is set to introduce instant Provident Fund (PF) withdrawals through Unified Payments Interface (UPI) and ATMs. The initiative, expected to roll out by May-end or June, promises seamless and faster access to retirement savings, em-powering millions of salaried employees across the country, wire service ANI reported on Tuesday.

The Labour and Employment Ministry has approved the proposal, which was rec-ommended by the National

Payments Corporation of India (NPCI), the body overseeing India's digital payments ecosystem. This move aligns with the government's broader vision of "ease of living" and financial inclusion through digital transformation.

### PF Withdrawals in Seconds: How It Works

Sumita Dawra, Secretary, Ministry of Labour and Employment, revealed that once implemented, members will be able to view their PF balance on UPI platforms, withdraw up to ₹1 lakh instantly, and even select their preferred bank account for direct transfers. # **Indian Carriers To Operate 25,610 Flights** Per Week In Summer Schedule: DGCA

MUMBAI-Indian carriers will operate a total of 25,610 flights per week during the summer schedule this year compared to 24.275 weekly flights in the same period last year, the Directorate General of Civil Aviation said on Tuesday. This translates to a 5.50 per cent year-on-year growth in the total number of departures per week. Compared to the ongoing winter schedule, which ends on March 29, the number of departures per week is up 2.41 per cent as the Indian carriers operated a total of 25,007 departures per week from 124 airports in the country, the DGCA said. There are 25.610 departures per week which have been finalised to/from 129 airports as per the summer schedule of 2025 compared to 25007 departures per week from 124 airports in the winter schedule of 2024, it said.



Additionally, the reforms will expand withdrawal options, enabling members to access funds for housing, education, marriage, and medical emergencies, apart from the existing provisions for illness.

## **Govt Discontinues Gold Monetisation** Scheme; Banks May Continue

**NEW DELHI-**The government has decided to discontinue the Gold Monetisation Scheme (GMS) starting from Wednes-day in view of the evolving market conditions, the finance ministry said.

However, the banks may continue their short term gold deposit schemes (1-3 years), the ministry said in the statement on Tuesday.

Till November 2024, approximately 31,164 kilograms of gold have been mobilised under GMS. The Gold Monetisation

Scheme was announced on September 15, 2015, with the objective to reduce country's reliance on the import of gold in the long run and mobilise gold held by households and institutions in the country to facilitate its use for productive purposes.

The GMS is comprised of 3 components -- Short Term Bank Deposit (1-3 years); Medium Term Government Deposit (5-7 years), and Long-Term Government Deposit (12-15 years).

"Based on the examination of the performance of the Gold Monetisation Scheme (GMS) and evolving market conditions, it has been decided to discontinue the Medium Term and Long Term Government Deposit (MLTGD) components of the GMS w.e.f. March 26, 2025," the ministry said. The Short-Term Bank Depos-

### **About 47 674 Direct Tax Defaulters** With Dues Of Rs 5.91 Lakh Cr **Untraceable: Govt**

NEW DELHI-About 47,674 direct tax defaulters who owe over Rs 5.91 lakh crore to the government have been declared untraceable, Parliament was informed on Tuesday.

In case of indirect taxes, as of January 31, 2025, as many as 60,853 tax defaulters having dues of Rs 43,525 crore have been declared untraceable.

In a written reply to the Rajya Sabha, Minister of State for Finance Pankaj Chaudhary said, the measures taken by Cen-tral Board of Direct Taxes (CBDT) to recover dues from the tax defaulters include making available databases like individual transaction statement and 360-degree profile generated by the department and those maintained by other agencies like FIU-IND to the field units for identification of assets for recovery.

Additionally, measures are taken to monitor the arrear demand collection/reduction in respect of top 5,000 cases of arrear demand in all the jurisdictions and giving targets to field formations for annual cash collection and reduction of the demand.

The measures taken by Central Board of Indirect taxes and Customs (CBIC) to recover dues from the tax defaulters include coordinating with Income Tax Department and various banks, attachment of bank accounts of defaulters, besides seeking information from Financial Intelligence Unit (FIU-IND).

Also, CBIC officers co-ordinate with state revenue authorities in all cases of arrears where defaulters are not traceable.

### **'Over 30k Taxpayers Declare Foreign** Assets, Income Of Rs 30,300 Cr Due To **Nudge Campaign'**

NEW DELHI-Finance Minister Nirmala Sitharaman on Tuesday said more than 30,000 taxpavers have revised their I-T returns or filed belated returns and declared additional foreign assets and income of about Rs 30,300 crore.

SMS and E-mails were sent to around 19,501 select taxpayers, asking them to review their Income Tax Returns filed for the 2024-25 based on information available to Income Tax of foreign deposits etc," she said in reply to Finance Bill 2025 in the Lok Sabha. As a result of the campaign,

she said out of 19,501 taxpayers, a total of 11,162 taxpayers revised their returns and filled out Schedule Foreign Assets Form, declaring total assets of Rs

MUMBAI-The rupee snapped its seven-session rally and settled with a loss of 11 paise at 85.72 against the US dollar on Tuesday, as increased demand for dollars from importers, coupled with the greenback's recovery against major currencies, weighed on the rupee.

Forex traders said the Indian rupee halted its seven-day winning streak, reflecting a shift in market sentiment towards risk aversion.

However, mixed-to-positive domestic markets and foreign fund inflows cushioned the downside.

At the interbank foreign exchange, the rupee opened at 85.59 and touched the high of 85.58 against the greenback during the day. The unit later turned volatile and hit the day's low of 85.84 before ending the session at 85.72 against the dollar, 11 paise lower from its previous closing level.

On Monday, the rupee appreciated 37 paise to close at 85.61 against the US dollar, wiping off all its losses in 2025. The domestic unit had added 154 paise in the last seven

trading sessions. "We expect the rupee to trade higher on foreign inflows and positive domestic equities. However, rising

crude oil prices may cap sharp gains. "Traders may take

# **'No Reserved Admission Provision For Underprivileged In Private Schools'**

## In Seven Years, Over 5,400 Children Went Missing In J&K, Ladakh

SRINAGAR: Data from 2016 to 2022 reveals that over 5.400 children were reported missing in Jammu & Kashmir and Ladakh, with more than 1,500 still untraced.

In 2016, 1,070 children went missing, and 716 remained untraced. In 2017, 725 children were reported missing, with 506 still untraced. The figures for 2018 stood at 800 missing, with 384 still untraced, and in 2019,

661 children were reported missing, leaving 401 untraced. The numbers remained concerning in subsequent years: 627 children went missing in 2020 (444 untraced), 723 in 2021 (483 untraced), and 821 in 2022, of whom 445 remain untraced. Ladakh also recorded

missing children, with some still untraced. Authorities have been urged to strengthen child protection mechanisms and intensify efforts to trace missing children.

# **Air Quality Regularly** Monitored In Khrew, Pulwama, **Khonmoh: Govt**

SRINAGAR: The Jammu and Kashmir government reported on Tuesday that air quality is regularly monitored across the Union Territory, with Khrew currently classified as moderately polluted.

Responding to a question from MLA Justice Hasnain Masoodi, the Minister for Forest, Environment, and Ecology stated that the J&K Pollution Control Committee is monitoring air quality in Khrew, Pulwama, and Khonmoh to mitigate risks to human life, agriculture, and livestock.

The data indicate that Khrew's air quality falls under the "Moderately Polluted" category. The committee has taken legal action against 86 default-

ing industries, imposing environmental compensation and

ordering unit closures. The minister also noted that cement plants must install On-line Continuous Emission Monitoring Systems (OCEMS), with real-time data uploaded to the Central Pollution Control Board server. Additionally, the Health Department is exploring initiatives under the National Programme on Climate Change and Human Health (NPCCHH) to strengthen preventive, diagnostic, and treatment services at PHC Khrew.

The government has also imosed a moratorium on establishing new air-polluting industries, including cement plants, stone crushers, brick kilns, hot mix plants, and mining blocks, until air quality improves.

## **Over 7.6 Lakh Soil Samples Tested** In J&K, Ladakh

SRINAGAR: A total of 7,62,708 soil samples have been tested in Jammu & Kashmir, while 2,298 samples have been tested in Ladakh to date under the Government of India's Soil Health and Fertility Scheme (SHFS), the Ministry of Agriculture and Farmers Welfare informed the Lok Sabha on Tuesday.

The scheme, aimed at im-proving soil health and issuing Soil Health Cards (SHCs) to farmers, follows a grid-based soil sampling approach-2.5 hectares in irrigated areas and 10 hectares in rain-fed areas. The SHCs provide farmers with detailed soil analysis, helping them use fertilizers efficiently and maintain soil fertility, a response, reads.

"Jammu & Kashmir has witnessed a significant number of soil samples tested, contributing to improved agricultural practices in the region. However, Ladakh has recorded a comparatively lower number of soil tests, indicating the need for expanded soil testing facilities in the cold desert region."

Meanwhile, the government has approved 25 new mobile soil testing laboratories across five states in 2024-25, but no such sanction has been made for J&K or Ladakh.

The Soil Health and Fertility Scheme continues to be a key initiative in promoting sustainable farming and precision agriculture across the country, with farmers benefiting from scientific soil health management strategies.

in seven years, allocating Rs 1.12 lakh crore for 2025-26. He described it as a roadmap for economic growth and a reflection of the people's aspirations.

While introducing the bills, the chief minister said that the bill authorises the payment and appropriation of sums from the Union Territory of Jammu and Kashmir's consolidated fund for the services of the fiscal years 2025-26 and 2024-25.

"The Jammu and Kashmir legislative assem-bly enacts this bill in the seventy-sixth year of the Republic of India, exercising powers vested under the Jammu and Kashmir Reorganisation Act, 2019," it stated.

The bill authorises the expenditure of Rs 1.40 lakh crore from the consolidated fund of the Union Territory of Jammu and Kashmir for the fiscal year 2025-26.

It specifies that sums not exceeding those listed in column 3 of the schedule, amounting to a total of Rs 1.40 lakh crore will be used to cover various expenses during the fiscal year 2025-26 for services specified in column 2 of the schedule.

Furthermore, the bill states that the sums authorised by this Act to be paid and applied from the consolidated fund of the Union Territory of lammu and Kashmir shall be appropriated for the services and purposes detailed in the schedule for the said year.

As per the recommendation of the appropriation bill for the year 2025-26, the Lieutenant Governor under the Jammu and Kashmir Reorganisation Act, 2019, recommended the introduction and consideration of the bill by the Jammu and Kashmir Legislative Assembly.

This bill is introduced under Section 43 read with Sections 41 and 44 of the Jammu and Kashmir Reorganisation Act, 2019, to authorise the appropriation from the Consolidated Fund of Jammu and Kashmir of the funds needed to cover expenses charged to the consolidated fund and grants made by the Legislative Assembly for the expenditure of the Jammu and Kashmir Government for the fiscal year 2025-26, as specified in the bill," according to the bill.

While presenting the budget on March 7, Abdullah expressed that J&K stands on the brink of a new era of peace and prosperity, with a semblance of normalcy returning after over three-and-a-half decades of turmoil.

He commended Prime Minister Narendra Modi, Union Home Minister Amit Shah, and Union Finance Minister Nirmala Sitharaman for their support across various sectors.

The assembly also passed the Jammu and Kashmir goods and services tax (Amendment) bill, 2025, by voice vote. This bill, also introduced by the Chief Minister, aims to align the Union Territory's GST Act with recent amendments made to the Central Goods and Services Tax Act, 2017.

This was the first bill of the budget session by the National Conference-led government, introduced on behalf of the Chief Minister.

### This Is Endorsement

As Lone agitated over the move, the Speaker told him the amendment wouldn't ratify status and was brought to align J&K's GST law with Central Goods & Services Tax Act.

"We were not consulted when Article 370 and statehood was snatched from us. Why are we being consulted now to ratify UT status?" Lone asked

"It would be an endorsement of conversion of Jammu & Kashmir into a UT. I wouldn't be part of this sin," Lone said angrily and walked out.

If we were not interested in resolving their issue, we would not have formed the committee. We are surprised that protests are taking place even after the committee's formation," he told the House.

Speaking in the House, Abdullah said he would look into the reasons behind the protests. "You are admitting that there was iniustice against them, which means you accept that nothing was done for them in the last 10 years. We have taken the lead to resolve it," he said.

The CM took a dig at BJP MLA Sham Lal Sharma, telling him that as a minister in the previous government, he was aware of the steps taken to resolve the issue.

"A committee has been formed under the chief secretary. I want to request the daily wagers to call off their strike and talk to the committee. Once the recommendations come, we will implement them," Abdullah said.

Earlier on Thursday, the CM said a panel has been formed to address the issue of regularisation of daily wagers in the Union Territory, which will submit its recommendations to the government in six months.

After around 30 minutes of disruption in the proceedings, BJP MLAs staged a walkout from the House.

"I speak for myself that I am not worried that he will not obey the law despite the division bench saying don't do this or that," Justice Anup Jairam Bhambhani said during the hearing.

After submissions by the NIA and the counsel for Rashid, a bench of Justice Chandra Dhari Singh and Justice Bhambhani said it would pass a detailed order.

The high court said the NIA's apprehensions can be dealt with by imposing appropriate con-ditions on Rashid in case he is allowed to attend the Parliament session, which will go on till April 4, while remaining in custody.

While Rashid's plea had sought custody parole to attend Parliament, his counsel on Tuesday said they are only urging for permission to attend the House in custody and assured the court that the MP would obey the conditions and order of the court in letter and spirit.

The bench said the courts and the Lok Sabha Speaker are not powerless and one should not undermine the position and the power of the Speaker and of the Secretary General to enforce discipline inside Parliament.

"We are not granting him bail here. He is in custody, we are sending our officers with him throughout, except where they are not allowed.

"Then he is in the confines of the highest temple of democracy, he is inside Parliament. At least don't undermine the position and the power of the Lok Sabha Speaker and of the Secretary General to enforce discipline inside Parliament. You (NIA) say no he will not be in control. How?' Justice Bhambhani said.

As the NIA counsel urged the court to see the role attributed to the accused in the case, the bench said, "We do not for a moment undermine the seriousness and the heinousness of the allegations against him. Be sure of that. National security is above everything, no question about that."

The court asked the NIA to suggest additional conditions, which it feels appropriate to be imposed on Rashid.

"Can we take special permission from the secretary general or the Speaker of the Lok Sabha that one prison official or police official in plain clothing will remain with him even inside the Parliament," it said, adding that Rashid will have to undertake that he will remain true to his oath as a parliamentarian.

The court added, "There is a single judge's order (earlier granting custody parole to Rashid to attend Parliament for two days). If you (NIA) have any further apprehension, then please tell us. We will include it as additional conditions but be confident of the court's powers and the speaker's powers. Don't come from a point of fear that he will do this or that. Nothing will happen. We are there.... You are telling us to ignore the fact that he is an elected representative of the people".

The bench also told Rashid's counsel that he should not do anything that would become a cause of concern for the State to think that he did not abide by the conditions.

Rashid's counsel said he was not asking for custody parole and only urging to be allowed to attend the session. He assured the court that the MP would obey the conditions and order of the court in letter and spirit.

Facing strong opposition from the NIA, Rashid's counsel argued that there are marshals in Parliament and the moment he would switch on his mike to utter anything, his mike would be taken away and he would be thrown out of the House.

### To this, Justice Singh said, "Then it will become a national issue that his mike has been taken away and he has been thrown out by the marshals".

Rashid's counsel told the high court that he would soon challenge a trial court's March 19 order dismissing his regular bail plea in the case. Rashid, who is facing trial under the Unlawful Activities (Prevention) Act (UAPA) in a 2017 terror funding case, has challenged a March 10 trial court order refusing him custody parole or interim bail to attend Lok Sabha proceedings till April 4.

In the reply filed to the appeal on March 17, the NIA said Rashid couldn't be allowed to use his status as MP to "get away from rigours of imprisonment".

The NIA argued that Rashid could neither be granted interim bail nor allowed custody parole as he had no enforceable right to attend Parliament session while in lawful custody.

Rashid's counsel earlier urged the high court to permit him to attend the ongoing Parliament session on custody parole, akin to a previous two-day reprieve granted to him.

Custody parole entails a prisoner being escorted by armed police personnel to the place of visit.

The Baramulla MP, who defeated Omar Abdullah in the 2024 Lok Sabha polls, is facing trial in a terror funding case with allegations that he funded separatists and terror groups in Jammu and Kashmir.

He has been lodged in Delhi's Tihar Jail since 2019 after the NIA arrested him in the 2017 terror-funding case. He was granted interim bail for one month in September last year to campaign in the Jammu and Kashmir Assembly election.

According to the NIA's FIR, Rashid's name cropped up during the interrogation of businessman and co-accused Zahoor Watali.

After being chargesheeted in October 2019, a special NIA court framed charges against Rashid and others in March 2022 under Sections 120B (criminal conspiracy), 121 (waging war against the government), and 124A (sedition) of the Indian Penal Code and for offences relating to terrorist acts and terror funding under UAPA.

Though there has been no fresh contact with the terrorists, the search parties on Monday found four loaded magazines of M4 carbine, two grenades, a bulletproof jacket, sleeping bags, tracksuits, several packets of eatables, and separate polythene bags, the contents of which will be known only when they are opened by the bomb disposal squad, they said.

The police chief, who along with Inspector General of Police, Jammu Zone, Bhim Sen Tuti is camping in Kathua, was seen leading from the front deep inside the forested area, holding an AK assault rifle and directing the operation from the ground.

One of the inputs suggested that two groups of at least five terrorists each infiltrated on Saturday. The local villagers, meanwhile, organized a community kitchen for the security personnel and the mediapersons at the outer cordon.

According to officials, some village women collecting firewood reported seeing around five terrorists who had sought refuge in the expansive nursery area.

A seven-year-old girl sustained minor injuries when a stray bullet passed close to her arm. She was shifted to a local hospital.

A 48-year-old villager, Anita Devi, said heavily armed terrorists caught hold of her husband when they were at the nursery to collect firewood.

'The terrorists held my husband at gunpoint and asked me to come near. But my husband signalled me to run and I ran. One of the terrorists tried to stop me but I started shouting, which attracted the attention of two more people who were cutting grass," Anita Devi said.

She said the incident occurred around 4.30 pm on Sunday, and they all returned home and informed police. They were wearing beards and commando dresses. Anita Devi sai

"When we passed the Finance bill, I repeatedly mentioned 'Union Territory of Jammu and Kashmir' regarding consolidated funds. Why didn't Sajad Lone Sahab stage a walkout then? All of us took oath under the Union Territory and fought elections under it. Would anything change if we would expunge the word 'UT' from the bill? It wouldn't change anything," CM Omar said, accusing the opposition of show off for cameras and said that it wouldn't change anything.

Omar said that he is vigorously fighting for restoration of J&K's statehood. "We passed a resolution in the first cabinet meeting and submitted it to the Prime Minister," he said, adding that he also raised the demand of statehood with the Prime Minister during a function at Sonamarg. He added that he raises the demand for restoration of Statehood whenever he goes to Delhi. NC, BJP Spar

Jammu as they marched towards the assembly, the CM's residence, and the civil secretariat, demanding the release of their wages and regularisation.

As the Question Hour concluded in the assembly on Tuesday, Leader of Opposition and BJP leader Sunil Sharma brought up the issue, demanding that the government holds talks with the daily workers employed by the government and end the strike.

"Two organisations associated with the Hurriyat have announced the severing of all ties with separatism. I welcome this step towards strengthening Bharat's unity and urge all such groups to come forward and shed separatism once and for all," he wrote on X.

Shah said it was a big victory for Prime Minister Narendra Modi's vision of building a developed, peaceful and unified Bharat.

The All Parties Hurriyat Conference (APHC) is an amalgam of various separatist parties in Jammu and Kashmir. Most of its constituents have been banned by the government.

Saleem said in his communication that he and his organisation have no sympathy for the ideology of APHC, which "has not been able to address the legitimate aspirations and grievances of the people of Jammu and Kashmir.'

"I am a loyal citizen of India. My organisation and I are not affiliated with any organisation or association having an agenda that goes directly or indirectly against India and its interests. Both my organisation and I owe allegiance to the Constitution of India," Saleem said.

In March 2019, when IAS officer Shah Faesal guit bureaucracy and launched his own party by the identical name and style, Saleem had taken strong exception, saying his JKPM was launched on April 4, 2000, at the Press Club in Jammu, and it became a constituent member of the APHC.

Faesal later withdrew his resignation and was reinstated to the service. He was posted as deputy secretary in the tourism department in 2022.

In his media communication on Tuesday, Saleem wrote, "I, Shahid Saleem, Chairman JKPM do hereby solemnly declare... My organisation as well as I have no connection or affiliation with either APHC(G) or APHC (A) or any of their constituents or any other entity pursuing a separatist or similar such agenda.

"My organisation and I do not have any inclination or sympathy for the ideology of APHC, which has not been able to address the legitimate aspirations and grievances of people of Jammu and Kashmir," he said.

Saleem warned that any use of his name or that of his organisation with the APHC of its factions or constituents or any other entity pursuing a separatist or similar agenda will be liable to legal action.

Sartaj, who had previously worked as the Jammu coordinator of the Hurriyat Conference and was booked under the Public Safety Act on multiple occasions, came out with a public notice, almost identical to the one issued by MeT Issues

from March 28 to April 3, the MeT said.


