

## **Mindful Eating: How To Enjoy Your Meals And Avoid The Risks Of Eating Too Fast**

Tou can have your cake and eat it  $too-just\ do\ it\ slowly.$  Experts tend to focus on the kinds of foods you can eat to improve your health. But the speed at which you devour your dinner matters just as much. There are risks with eating too fast - think stuck food and the potential to overeat before your brain tells you to stop. (Inhaling your food also risks annoying your slower-paced dining companions or the person who took the time to cook your meal).

Here are some tips from scientists on how to slow down and take a more mindful approach to consuming your diet.

#### How fast is too fast?

If you're the kind of person who can regularly polish off breakfast, lunch or dinner in less than 20-30 minutes, you are eating too fast, "It takes about 20 minutes for the stomach to communicate to the brain via a whole host of hormonal signals that it's full," said Leslie Heinberg at the Center for Behavioral Health at the Cleveland Clinic. "So when people eat rapidly, they can miss these signals and it's very easy to eat beyond the point of fullness.'

#### Why is that a problem?

People who eat quickly are likely to swallow more air, Heinberg said, which could lead to bloating or indigestion. Not chewing your food properly can also compromise digestion, meaning you won't get all of



the nutrients from your food. Unchewed pieces of food also could get stuck in your esophagus.

Some previous studies have suggested that people who eat quickly have the highest risk of obesity, while the slowest eaters were the least likely to be obese.

How can you slow down when eating? For starters, turn off the TV and put down your phone. "If you're eating while you watch TV, people tend to eat until there's a

commercial or the show is over," Heinberg

said, adding that people are less inclined to pay attention to the body's own signals that it's full. "When we do things while we're eating, we're eating less mindfully. And that often causes us to eat more.'

She said that when people focus exclusively on eating, they tend to enjoy the meal more and eat less. Heinberg also acknowledged the pace at which you eat is often an ingrained habit, but said change is still possible. She suggested things like using your non-dominant hand to eat, trying utensils you might not ordinarily use like chopsticks or taking a deliberate break to drink water

when your plate is partially empty. If you have a busy life, it might be unavoidable to eat lunch at a work meeting or snack while running errands. But Sarah Berry, chief scientist at the British nutritional company ZOE, said when possible, "be mindful of what the food tastes and feels like." "If we're not fully present, it's very easy to eat more quickly and not notice how much we've consumed," Berry said.

### Chew your food, just like mom told you to

One of the simplest things to do is to increase the number of bites you take, said Helen McCarthy, a clinical psychologist with the British Psychological Society. "If you chew each mouthful a little bit longer, that will slow down your eating,"

The kind of food you eat may also make a difference, pointing out that it's much easier to eat ultra-processed or fast foods quicker because they typically have a softer texture. "It's hard to eat vegetables and protein at the same rate as something that's highly processed and requires less chewing," McCarthy said.

Some of her patients also reported an unintentional side effect once they began eating more slowly, referencing one woman who often ate a tube of potato chips every evening. When McCarthy told her to slow down and eat every single chip individually, her patient told her "it was like having a mouthful of claggy chemicals." "She didn't find (the chips) enjoyable anymore," Mc-

## 'More Than Social Skills, These Factors Indicate Autism Diagnosis'

People with autism are typically diagnosed by clinical observation and assessment. To deconstruct the clinical decision process, which is often subjective and difficult to describe, researchers used a large language model (LLM) to synthesize the behaviors and observations that are most indicative of an autism diagnosis.

Their results show that repetitive behaviors, special interests, and perception-based behaviors are most associated with an autism diagnosis. These findings have the potential to improve diagnostic guidelines for autism by decreasing the focus on social factorswhich the established guidelines in the DSM-5 focus on but the model did not classify among the most relevant in diagnosing autism.

Our goal was not to suggest that we could replace clinicians with AI tools for diagnosis," says senior author Danilo Bzdok of the Mila Quebec Artificial Intelligence Institute and McGill University in Montreal.

"Rather, we sought to quantitatively define exactly what aspects of observed behavior or patient history a clinician uses to reach a final diagnostic determination. In doing so, we hope to empower clinicians to work with diagnostic instruments that are more in line with their empirical re-

The scientists leveraged a transformer language model, which was pretrained on about 489 million unique sentences. They then fine-tuned the LLM to predict the diagnostic outcome from a collection of more than 4,000 reports written by clinicians working with patients considered for autism

The reports, which were often used by multiple clinicians, included accounts of observed behavior and relevant patient history but did not include a suggested diagnostic outcome.

The team developed a bespoke LLM module that pinpointed specific sentences in the reports that were most relevant to a correct diagnosis predic-

They then extracted the numerical representation of these highly autismrelevant sentences and compared them directly with the established

diagnostic criteria enumerated in the DSM-5.

The researchers were surprised by how clearly the LLM was able to distinguish between the most diagnostically relevant criteria. For example, their framework flagged that repetitive behaviors, special interests, and perception-based behavior were the criteria most relevant to autism.

While these criteria are used in clinical settings, current criteria focus more on deficits in social interplay and lack of communication skills. The team expects their framework

will be helpful to researchers and medical professionals working with a range of psychiatric, mental health, and neurodevelopmental disorders in which clinical judgement forms the bulk of the diagnostic decision-making process.

## 2 Terrorists Killed, 5 Security Men Injured

Jammu: A fierce gun battle in a remote forested area of Kathua district has left two terrorists dead and five security personnel injured as the security forces intensified their operation to neutralise an infiltrating group of about five militants, officials said on Thursday.

It was not immediately clear whether it was the same group that had been evading an ear-lier cordon in Sanyal forest of Kathua region or another batch of freshly infiltrated terrorists.

The encounter triggered intense firing and explosions, the officials said.

The gunfight, centred near Jakhole village in the Ghati Juthana area of Rajbagh, involved a group of approximately five terrorists and an initial exchange of gunfire resulted in injuries to Special Police Officer Bharat Chalotra, who sustained facial wounds.

He was treated at a Kathua hospital before being transferred to Government Medical College Hospital in Jammu, where his condition was stated to be stable.

The officials said that two terrorists were killed in the onslaught led by the Special Operations Group (SOG) of the Jammu and Kashmir Police and assisted by the Army, the BSF and CRPF.

Adding to the tension, three security personnel, including a Sub-Divisional Police Officer (SDPO), were reportedly trapped near the gunfight's location, adjacent to a rivulet

concealed by dense foliage. The officials said a clear picture would emerge only after the ongoing | More on P10

No Attendance, No Exams

#### **CBSE Moots Tough Measures Against Dummy Schools**

New Delhi: The Central Board of Secondary Education (CBSE) has announced stricter measures to curb the practice of "dummy schools," stating that students who do not attend regular classes may be disqualified from appearing for Class 12. board examinations.

Officials emphasized that the onus of taking admission in "dummy schools" lies with students and parents.

The board is considering amendments to its examination bye-laws, which could require non-attending students to take the National Institute of Open Schooling (NIOS) exams instead.

A senior CBSE official explained that surprise inspections would be conducted, and students found missing from school may be barred from taking board exams. "The responsibility of ensuring regular attendance falls on both the student and their parents," the official stated. Schools promoting the dummy school culture or sponsoring non-attending students could also face action under CBSE's affiliation and examina-

## PM Modi To Flag Off First Train To Kashmir On April 19

Srinagar: Prime Minister Narendra Modi will flag off the first train from Katra to Kashmir on April 19, marking a significant step in expanding rail connectivity to the

The train will chug off from Katra town in Reasi district and will cross the Pir Panjal mountain range to reach Srinagar and then its final destination at Baramulla in north Kashmir.

PM Modi will flag off the train from Katra in the pres-ence of Railway Minister Ashwini Vaishnaw, Union Minister of State Dr Jitendra Singh, Jammu and Kashmir Lieutenant Governor Manoj Sinha and Chief Minister Omar Abdullah, reports said.

At present, the train operates from Sangaldan to Baramulla. The Prime Minister is scheduled to land at Udhampur Army airport from New Delhi on the morning of April 19 and then fly to the world's highest railway

bridge over Chenab river in Reasi district.

PM Modi will be briefed about the construction of the bridge, which is considered to be an engineering marvel, the report added.

The Prime Minister will then reach the Mata Vaishno Devi base camp, Katra from where he will flag off Vande

of the Udhampur-Srinagar-Baramulla Rail Link (USBRL) project, 209 kms was commissioned in phases with the first phase of the 118 km Qazigund-Baramulla section commissioned in October 2009, followed by the 18 Banihal-Qazigund link in June 2013, 25 kms of the Udhampur-Katra stretch in July 2014 and the 48.1 km Banihal-Sangaldan section in February, last year. | More on P10

## Rashid Challenges Rs 1.45 Lakh Per Day Travel Cost

New Delhi: Jammu and Kashmir MP Abdul Rashid Sheikh, commonly known as Engineer Rashid, has moved the Delhi High Court against the Rs 1.45 lakh daily travel cost required for his commute from Tihar Jail to Parliament.

Earlier, the court had permitted Rashid—currently in judicial custody-to attend parliamentary sessions under the condition that he bears his own travel expenses. Now, he is seeking the removal of this condition, arguing that the high cost could prevent him from representing his constituency.



During a hearing before Chief Justice Devendra Upadhyaya and Justice Tushar Rao Gedela, Rashid's counsel, Advocate Vikhyat Oberoi, informed the court that authorities had set the daily travel cost at Rs 1.45 lakh. Oberoi emphasized that Rashid was not | More on P10

## 1 In 5 Ultra-Rich Indians Planning To Move Abroad

New Delhi: One in five ultrahigh-net-worth individuals (Ultra-HNIs) in India is either in the process of migrating abroad or planning to do so, while still retaining their Indian citizenship, according to a report by Kotak Bank.

The report highlighted that many of these wealthy individuals plan to settle permanently in their chosen foreign destinations. Among them, professionals show a higher tendency to migrate compared to entrepreneurs or inheritors.

The report said "1 in 5 Ultra-HNIs surveyed are currently in the process of or plan to migrate, most of whom intend to reside in their chosen host country permanently while retaining their Indian citizenship".

Additionally, those aged between 36-40 years and those above 61 years are more likely to consider relocation than others in different age groups.

The findings come at a time when India's ultra-rich population and overall wealth are projected to witness significant growth. The number of Ultra-HNIs in the country is expected to rise to 4.3 lakh by 2028.

The report added "India Ultra-HNI numbers and wealth is expected to grow to reach 4,30,000 with a total wealth of Rs 359 trillion by 2028"

As their wealth grows, more Ultra-HNIs are looking beyond India's borders for investment opportunities. The report notes that nearly one-third of India's ultra-rich now hold global assets,

## **Leaked Signal Thread Reveals Trump Officials' Houthi Strike Plans**

Washington: Defence Secretary Pete Hegseth texted about plans to kill a Houthi militant leader in Yemen two hours before a military operation meant to be shrouded in secrecy, according to screenshots of a chat released by The Atlantic on Wednesday.

The revelation that highly sensitive attack plans were shared on a commercial messaging app, possibly on personal cellphones, has triggered outrage in Washington and calls from Democrats that members of Trump's national security team be fired

Republican President Donald Trump's administration has sought to contain the fallout from the revelation that the March 15 chat included The Atlantic's editorin-chief Jeffrey Goldberg on the encrypted messaging app Signal.

Hegseth has repeatedly denied texting war plans, and Trump and his top advisers are saying no classified information was shared, bewildering Democrats and former US officials, who regard timing and targeting details as some of the most closely held material ahead of a US military campaign.

## Over A Billion Pounds Of Coke Plastic Waste To Enter Waterways: Study

WASHINGTON: By 2030, Coca-Cola products will account for an estimated 1.33 billion pounds (602,000 metric tons) of plastic waste entering the world's oceans and waterways each year, according to a stark new analysis published Wednesday by the nonprofit Oceana.

That's enough plastic to fill the stomachs of 18 million whales.

The report arrives amid mounting concerns over the human health risks posed by the spread of microplastics, which scientists increasingly link to cancer, infertility, heart disease, and more.

"Because of that, they really matter when it comes to the impact of all this on the ocean."

Coca-Cola ranks as the world's top branded plastic polluter, followed by PepsiCo, Nestle, Danone, and Altria, according to a 2024 study published in Science Advances.

Oceana's estimate is based on Coca-Cola's publicly reported packaging data from 2018 to 2023, combined with sales growth forecasts to create a "business-as-usual" scenario.

The result: the company's plastic use is projected to exceed 4.13 million metric tons (9.12 billion pounds) annually by 2030.

To estimate how much of that plastic will reach aquatic ecosystems, researchers applied a peer-reviewed method developed by an international team of scientists and published in the academic journal Science in 2020 to arrive at the 1.33 billion pounds estimate, which is equivalent to nearly 220 billion half-liter bottles.

For Oceana, the clearest solution to reduce this staggering figure lies in bringing back reusable packaging - whether in the form of returnable glass bottles, which can be reused 50 times, or thicker PET plastic containers. which are designed for 25 uses.

Hamas spokesman killed in Israeli strike

aza: Hamas said Israeli air strike killed one of its official spokesmen in Gaza on Thursday, the latest highranking operative targeted since Israel resumed its bombardment.

The group said in a statement it mourned the loss of Abdul Latif al-Qanou who was killed in what it called a "direct" strike on a tent he was in, in the Jabalia area of northern Gaza.

A fragile ceasefire that brought weeks of relative calm to Gaza ended on March 18 with Israel resuming its bombing campaign across the territory.

According to the health ministry in Hamasrun Gaza, at least 855 peo-



ple have been killed since. Qanou is the latest Hamas official to be killed in recent Israeli strikes.

Israel's military said last week it had killed the head of Hamas's internal security agency, Rashid Jahjouh, in an air strike. Days earlier, Hamas

had named the head of its government in the Gaza Strip, Essam al-Dalis, and interior ministry head Mahmud Abu Watfa, among a list of officials it said were killed in strikes.

actor's involvement in the infamous 1998 blackbuck poaching case. Since then, Khan has faced multiple threats. In April 2024, two shooters, allegedly from the Bishnoi gang, fired gunshots outside his Bandra residence before being arrested.

After this, security was enhanced with bulletproof glass protecting his balcony and CCTV cameras keeping watch on the road outside. Two months later, Navi Mumbai Police claimed to have discovered a plot to kill the actor when he travelled to his farmhouse at Panvel near Mumbai.

Security around the actor was further tightened following the murder of politician Baba Siddiqui, who was known to be a close friend of Salman, in October 2024.

## Food Safety Team Seizes Expired **Food Items In City**

**SRINAGAR:** Following the directions of Deputy Commissioner (DC) Srinagar, Dr Bilal Mohi-Ud-Din Bhat, market inspections are being continuously conducted in Srinagar City to ensure sale of quality food items to the consumers.

Accordingly, acting promptly on a specific tip-off, the Food Safety Department carried out a targeted raid on a wholesaler's premises in Saraf Kadal, Srinagar.

The raid, conducted in response to an anonymous complaint, uncovered an alarming stockpile of expired food items, including milk and milk products valued at approximately Rs. 55,000. Shockingly, the seized stock also include items that had expired as far back as 2018.

During the inspection led by Assistant Commissioner Food Safety Srinagar, it was observed that expired goods were stored alongside fresh supplies, reflecting a disregard for fundamental food safety practices and consumer health. When questioned, the Food Business Operator (FBO) at the premises failed to provide any satisfactory explanation on the presence of expired products.

The Food Safety team seized the expired items to prevent them from reaching consumers and contributing to potential health hazards.

As per the Food Safety and Standards Act (FSS Act), the case has been forwarded to the Adjudicating









The Food Safety Department reiterated its instructions to all Food Business Operators (FBOs) to ensure expired food items must be stored in a designated quarantine area, sepa-





rate from fresh supplies. Any expired items found exhibited for sale will face strict penalties under the relevant provisions of the FSS Act.

#### Soz Revolts, Blasts Faroog

Abdullah's Decision 'Insult To Kashmir Genius' **Observer News Service** 

**NEW DELHI-** Senior National Conference leader and former union minister Saifu-ud-din Soz, today revolted against his party leadership's decision to support the BJP led government at the center and made an "impassioned" appeal to Farooq Abdullah to "reconsider your stand" in the interests of people of Kashmir.

"RSS will continue to guide and inspire the destiny" of the Vajpayee government" and the contention of Faroog Abdullah that he needed maximum support (funds) from the center, for the welfare of the state and had this compulsion for supporting the BJP government "is fraught with dangerous consequences", Soz said in a strongly worded statement issued

He said that "short run political and economic gains involving many awkward compromises are no substitutes for long term and enduring political assertions" adding that even after Abdullah offered his party's support to the BJP, there was "no guarantee" that the ruling alliance will support National Conference commitment to restore internal autonomy to Jammu and Kashmir".

"I don't think that Farooq is naive and does not understand that, in response to a coalition consensus, the BJP has just temporarily put the abrogation of Art. 370, uniform civil code and Ram Mandir on a back burner",

The four-time Lok Sabha member and "official spokesman" of the National Conference, Soz, is said to have tried his best in last few days to convince Abdullah against taking any "hasty decision" on extending support to Vajpayee government. Soz is learnt to have been in touch with other senior National Conference leaders on this issue and most of them, including some senior ministers of Farooq government are reported to be in unanimity with Soz's stand. Soz, sources said talked to Farooq on phone late last evening and this morning, but seems to have failed in persuading his leader to change the stand.

Soze, as already reported, attended the meetings of the United Front, even after Farooq Abdullah declared to have severed his relations with the Front, regretted that Abdullah took such a major decision without taking into confidence his senior party colleagues and also putting the issue before the party working committee, highest decision making body.

This stance of Farooq Abdullah, not convening the party working committee before taking such an important decision" is an insult to the genius" of the people of Kashmir, Soz said and asked "are the people of Jammu and Kashmir supposed to live at the mercy of a central government of the day"?

Soz also charged Farooq Abdullah with "misquoting" his father, Sheikh Muhammad Abdullah, in dealing with the center. "All the Sheikh said was that center and state should endeavor to maintain a harmonious relation within the frame work of center-state relations", Soz said and added that Farooq was "mistaken in his belief that generally people have short memories. He said that Faroog's announcement that he would be placing the issue of extending support to BJP after having taking the final decision himself, was "nothing short of adding insult to the injury".

Soz advised Farooq Abdullah, to reconsider his decision, "even at this late stage" and try to appreciate the fact that "short run political or economic gains involving many awkward promises are no substitute for long term and enduring pro-people assertions which always rest on calm reflec tions and cool thinking". "My worry is that Doctor Sahib, in his hurry to drove-tail short run situa-

tions of advantage with his politics of compromise, might cripple the very goose that invariably laid the golden eggs for him", Soz said. (Kashmir Observer, 28 March, 1998)

## Thawing Permafrost

new study has revealed that permafrost in Jammu & Kashmir and Ladakh is thawing due to climate change. This is the ice that has been frozen for thousands of years and its thawing poses far-reaching environmental challenges for the region and beyond.

Significantly, permafrost covers nearly 65% of J&K and Ladakh. Over a quarter of this is continuously frozen, providing stability to glaciers, river systems, and even entire settlements. But rising temperatures are disrupting this delicate equilibrium. This primarily doesn't bode well for the water resources. Glaciers and permafrost act as natural reservoirs. They gradually release water to sustain water bodies through dry months. But should they thaw earlier, as is happening due to rising temperatures, this will make river flows erratic, which, in turn, will affect the agriculture, power and water supply.

There are larger environmental consequences for the region. Permafrost stores carbon and methane, and once it melts it releases these into the atmosphere, This, in turn, will aggravate the existing global warmingWhat is more, thawing permafrost could awaken ancient microbes, posing unforeseen threats to public health.

With glaciers also gradually receding over the past two decades, it is a double whammy. It threatens the discharge in the region's water bodies. Thawing of glaciers is taking place all over J&K as well as Ladakh. Climate change in the Himalayas is triggered largely by global factors such as rising temperatures due to greenhouse gas emissions, industrial and agricultural activity, as well as deforestation at a global level.


This has created two immediate problems for our region: one, the glaciers are melting and another due to increasingly snowless winters, glaciers are not adequately replenished.

Kashmir witnesses its heaviest snow during chilai kalan and the snowfall progressively reduces in February and March when spring sets in. But this year chilai kalan was completely dry, the last such seasons were in 2015 and 2018. This winter, and the 2023-24 winter, more or less, also were largely dry.

Heavy snow in these two months helps in the glacier formation which in turn charges up the Valley's water bodies through summer. So increasing the frequency of dry winters signals trouble. More so, at a time when the Valley's major glaciers have shown marked signs of depletion in recent decades. Biggest of them is the Kolahai glacier. The area of Kolahai, according to a study, has retreated to 11.24 square kilometers from 13.87 sq kms since 1976. This doesn't augur well for the future. Kashmir's plight is not an isolated event, but a harbinger of what awaits us all if the world continues down this path of unchecked environmental degradation.

## **Supplying Polluted Water Violates Consumer Rights**

Providing unsafe drinking water to people not only violates environmental laws but is also a clear violation of the Consumer Protection Act

recently commemorated World Consumer Rights Day, observed every year on March 15. This day serves as a reminder of the importance of consumer rights and their protection. World Consumer Rights Day was first observed in 1983, and the date was chosen to commemorate U.S. President John F. Kennedy's address to the U.S. Congress on March 15, 1962, in which he formally recognized these rights. He was the world's first leader to do so.

This year's theme for World Consumer Rights Day 2025 was "A Just Transition to Sustainable Lifestyles." This theme clearly reflects the importance of making sustainable and healthy lifestyle choices accessible and available to all consumers, including access to safe drinking water.

Soon after commemorating Consumer Rights Day, people across the world, including J&K, celebrated International Water Day on March 22. This year's theme for the occasion was glacier preservation. After writing on both these issues recently, I found a close relationship between water and consumer rights, which led me to write this piece for public awareness and to sensitize the government about this critical issue.

#### Access to Clean Drinking Water Is a Consumer Right

When we talk about consumer rights, people in the Indian subcontinent—especially in Jammu & Kashmir—hardly imagine that access to clean drinking water is also a consumer right. This is because Jammu & Kashmir has been blessed with numerous fresh drinking water sources, and we never anticipated

However, neither consumers nor the government seem to recognize this fact.

#### Pollution in Drinking Water Sources

I have always spoken based on facts, which I gather through RTI or other reliable sources. I have personally visited Doodh Ganga at its source near Navkan Valley in the Pir Panjal





mountains, about a 10-hour hike from Yusmarg. At its source, the water is so pristine and clean that words cannot do justice to its purity. However, just 15 to 20 kilometers downstream, Doodh Ganga becomes heavily polluted.

This pollution is an open fact, and the National Green Tribunal (NGT) has issued multiple orders in this regard following my petition filed four years ago. Recently, the NGT reprimanded the Commissioner Secretary of the Housing & Urban Development Department for failing to address the water pollution in Doodh Ganga. Hefty penalties are expected

rage against municipal institutions in Bijbehara, Mattan, and Anantnag for allowing drains to discharge directly into Jhelum, as these towns lack sewage treatment plants. He criticized the government's misleading response in the Assembly and voiced his frustration on social media, stating that the "administration's response was riddled with flaws and misinformation."

Similarly, MLA Uri, Sajjad Shafi, condemned the PHE - Jal Shakti Department for cutting off drinking water supply to some villages in his constituency due to non-payment of fees. He even

#### Lawmakers Express Concern

Untreated sewage and fecal waste continue to enter Doodh Ganga, Jhelum, and other water bodies across J&K. The same contaminated water is then supplied to the public.

Recently, MLA Bijbehara expressed out-

ing access to clean water is also a key objective of the UN's Sustainable Development Goals (SDGs). However, given the current state of affairs a Jamma & Kashmir, achieving these goals seems increasingly difficult.

Despite spending billions of rupees under

the Jal Jeevan Mission, the government has failed to provide safe drinking water. Pipeline have been laid across every corner of J&K, yet the water supplied remains contaminated—as proven in the Doodh Ganga case pending before the NGT for the last four years.

Research shows that most foods in India contain these residues, some of which have levels higher than safe limits. This situation raises serious health concerns and highlights the need for better food safety regulations and greater public awareness. The recent appeal by the Union Minister of State for Health and Family Welfare for a comprehensive national strategy for monitoring pesticide residues in food is important to enhance public health and food safety in India. Contamination of food with pesticides poses a serious health risk, which

is further worsened by modern farming practices and reckless use of chemicals. Although several regulatory measures are in place, there are gaps in monitoring, enforcement and public education, which require stronger government action at

both the central and state levels. Reports from the Food Safety and Standards Authority of India (FSSAI) and various independent studies show that pesticide residues have been found in more than 50% of food samples tested in India. Some foods, such as vegetables, fruits, cereals, pulses and spices, have been found to contain pesticides in excess of the maximum residue limits (MRLs) set by regulatory bodies. # Masjid Al Aqsa in Islamic History

asjid al-Aqsa holds immense significance in Islamic religious tradition as well as history. It is known as the first qibla of Muslims' the direction toward which Muslims face to offer their salat'as well as the third holiest site in Islam. It is built on the site where the noble Messenger (saws) led all the earlier Prophets in prayer when he was transported by night from Masjid al-Haram before his miraj (ascension to Heaven) to the point referred to in the Qur'an as Sidrat al-Muntaha (53:10-16).

In contemporary history, it has become a contested place because the zionists claim it is built on the site where their first and second temples originally existed. A great deal of myth is interwoven into this narrative despite the fact that the temple was destroyed repeatedly by invading forces. The Babylonian king Bakhtnasr (Nebuchadnezzer) attacked Jerusalem in 587 BC and destroyed the temple (Beyetel). The Israelites were enslaved and suffered greatly for more than 70 years.

There were several phases of rebuilding and destruction of the temple the last being the Romans' destruction of it in 70 CE. No trace of the temple has ever existed. While the some hardcore zionists are currently trying to encroach on the Haram al-Sharif (the noble Sanctuary) and are even demanding the right to worship there, Rabbinical law prohibits Jews from setting foot on the Temple Mount for fear of desecrating the 'holy of Holies' in Jewish religious tradition. There is in fact a board erected near the Haram al-Sharif that houses both the Masjid al-Aqsa as well as Dome of the Rock and numerous madrassas and other smaller structures, prohibiting Jewish trespassing of the Haram al-Sharif.

Let us first consider who built Masjid al-Agsa: was it the fatherand-son Prophets Daud and Prophet Sulayman (as), as claimed by the zionists, or built even earlier? We know from the Qur'an (2:127-128) that the father and son Prophets, Ibrahim and Ismail (as) built the Ka'aba in conformity with the command of Allah. The Ka'aba in Makkah is the first House of worship for Allah on earth. Prophet Ibrahim (as) had settled his first son Ismail (as) and his mother, Hajar (as) there, again according to the command of Allah.

Prophet Ibrahim (as), however, did not live in Makkah; he lived in Palestine in the place that takes its name from him: al-Khalil (Hebron). Is it conceivable that Prophet Ibrahim (as) would build a place of worship in Makkah but not have a place of worship in Jerusalem that is right next to Hebron? As the Patriarch of all the Prophets of Allah, Ibrahim (as) also built a place of worship in Jerusalem. This came to be known as Beteyel (meaning the House of Allah in Hebrew).

When Ibrahim's (as) second son Is'haq (Isaac) was born and grew up in Hebron, he would go to worship in Beteyel. Interestingly, Is'haq (as) who was also a noble Prophet of Allah, also prayed in the Ka'aba in Makkah and performed the Hajj pilgrimage there together with his father (Ibrahim (as) and brother (Ismail (as), again according to the commands of Allah. It was Ibrahim (as) that named Beteyel as Masjid al-Aqsa' the farthest mosque' in deference to the Ka 'aba, from which it was located far away to the northwest.


Yaqub (as), known in the Bible as Jacob who was the son of Is'haq (as), was also a noble Prophet who opened Beteyel as a place of worship for all those that accepted the One true God, Allah. Naturally in the land of Palestine many other tribes resided. The land takes its name from the Philistines, the people that lived there. Among the other tribes were the Moabites and Hittites. The latter tribe was the one to which the mother of Sulayman (as) belonged. It needs recalling that İbrahim (as) was born in Ur (present-day Iraq) and was forced into exile because of the oppression and persecution he faced at the hands of the tyrant Nimrood. After a long journey, Ibrahim (as) finally settled in al-Khalil (Palestine).

Prophetic history takes many turns and it is no different with the Prophets from the lineage of Ibrahim (as). Prophet Yusuf (as) [Joseph] was greatly loved by his father Yaqub (as). This created huge jealousy among his step-brothers who plotted to kill him but finally decided to thrown him a well.

He was rescued from the well and sold into slavery ending in Egypt where the ruler employed him. The ruler's wife had a crush on him because Yusuf (as) was a very handsome young man but Allah protected him from committing sin and despite being innocent, he ended up in prison where he spent many years. When he was finally released, the king appointed him to the important post of the kingdom's treasury and he became the de facto ruler of Egypt. The story of Yusuf (as) is narrated in exquisite detail in the noble Qur'an in the surah by the same name (Surah Yusuf).

Once Yusuf (as) had attained power in Egypt, he invited his family' father, mothers and brothers' to live with him in Egypt. They readily accepted the offer as narrated in the chapter on Genesis 46 in the Torah. No one from Yaqub's (as) family was left to take care of Beteyel/Masjid al-Aqsa. Thus, he gave charge of the masjid to the local inhabitants, the Palestinians. The children of Yagub (as), referred to as Bani Israel in the noble Qur'an lived in Egypt for more than 400 years. There was never a hint that they should return to Palestine to reclaim ownership/custodianship of Masjid al-Agsa.

Many generations later, the Bani Israel were taken as slaves by the pharaohs and it was not until Allah raised Musa (as) [Moses] among them that he led them out of slavery

During this time, Musa (as) died and Allah raised another Prophet, Daud (as) who was a soldier in the army of Saul. Because of his courage, Daud (as) was made king and entered Palestine to establish his kingdom there.

It was Sulayman (as) who rebuilt the temple (Masjid al-Aqsa) with the support and help of the indigenous people, principally the Palestinians. The father-son rule, however, lasted a total of 73 years. Thereafter, his sons divided the kingdom and power once again slipped from their hands. A of Prophets emerged among their progeny but the Bani Israel were always argumentative and refused to abide by the teachings of the Prophets. The Qur'an narrates that they killed many of their prophets among them Zakariya (as) as well as his son Yahya (as).

As mentioned earlier, the Babylonian king Bakhtnasr (Nebuchadnezzer) laid siege to Jerusalem and took over the city and Palestine in 587 BC. He destroyed the temple/ Masjid al-Aqsa and enslaved all the people. This story is narrated in detail in the Bible in Kings 2 Chapters 24 and 25. The Torah also says that the Israelites were enslaved in both the Nile (Egypt) and in the Euphrates (by the Babylonians).

The Persian King Cyrus the Great rescued the Bani Israel after seventy years of slavery in Babylon. He also permitted them to return to Palestine from where the Babylonians had driven them out. The Persian Empire faced a rival in the Roman Empire and constant battles occurred between them. In the year 70 CE, the Romans captured Jerusalem and destroyed the temple one more time. Barely 65 years later in what is referred to as the Bar Kokhba revolt, the Romans massacred the Bani Israel and even dug out the foundations of the temple in the year 135 CE. By now, the Romans had accepted Christianity as their religion and their enmity toward the Jews intensified as killers of Prophet Isa (as) [Jesus].

The Romans, however, faced a

constant threat from the Persians and in the year 614 CE, the latter took control of Jerusalem from the Romans. In Makkah where the noble Messenger (saws) had started his mission of propagating Islam, the mushriks made fun of Muslims because the fire-worshipping Zoroastrians had vanquished the Christian Romans. The Qur'an narrates this in the opening ayats of Surah al-Rum in which Allah (swt) says that not only the Romans but Muslims too would be victorious within a period of less than 10 years.

Given the plight of Muslims at the time' their numbers were small and they faced great persecution' the Makkah mushriks made great fun of the Qur'anic ayats but Allah's Word came true' as it was bound to' within the stipulated timeframe and not only the Romans defeated their Persian rivals but the Muslims also triumphed over their Makkah foes in the Battle of Badr.

It is also pertinent to note that when Muslims migrated from Makkah to Madinah, for the first 17 months, they faced toward Masjid al-Aqsa in their salat. It was during dhuhr salat in the second year of the hijrah that Allah's revelation about the change of gibla from Masjid al-Aqsa in Jerusalem to Masjid al-Haram in Makkah came. This is narrated in the Quran (2:142-43). The masjid in Madinah where the Prophet (saws) was leading the Muslims in salat is today called Masjid Qiblatain (Masjid of the two giblas).

Jerusalem, however, came into Muslim possession only during the Khilafah of Umar (ra) in the year 638 CE. The Christian Patriarch, Sophronius had insisted that he would hand over the keys of Jerusalem only to the ruler of Muslims. The second Khalifah Umar was on a campaign in the Golan Heights and when word reached him, he hurried to Jerusalem to take possession of the keys without causing any bloodshed in the city.

When he entered the city, Umar (ra) located the place where the noble Messenger (saws) had led all the Prophets in prayer before his ascension of Heaven on his mi'raj. After cleansing the place thoroughly, he led the Muslims in prayer and a makeshift mosque was erected there. This simple structure later developed into what is called Masiid al-Agsa today and has been in Muslim possession ever since.

There is also another more impressive structure that emerged on the Haram al-Sharif. This is called the Dome of the Rock and has a huge gold dome. The Ummayyad ruler Abdul Malik built this about 50 years later over the rock where the Heavenly stead, the Buraq was tethered when the Prophet (saws) led the other Prophets in prayer. After mounting the Burag that started to ascend, the rock followed. The Angel Jibrail (as) asked the noble Messenger (saws) to order the rock

The noble Messenger (saws) put

his foot on the rock ordering it to stop. To this day, there is a footprint on the rock and it remains suspended except for very thin metal rods underneath it. This is the place where the Dome of the Rock Mosque exists.

The Muslims lost Masjid al-Aqsa and Jerusalem to the Crusaders in the year 1099 CE. Muslim rulers surrounding Palestine had become corrupt, much like the rulers today and had lost the will to defend Islam or Muslims. It was not until another 88 years before Salahuddin Ayyubi liberated Masjid al-Aqsa and Jerusalem from the clutches of the Crusaders.

Unfortunately the decline in Muslim rule and corruption in their ranks has led to the loss of Masjid al-Aqsa one more time. It occurred in several phases. When the Ottoman Empire was defeated and dismembered, the British colonialists took control of Palestine and in typical colonial style started to disburse Muslim lands to others. The Europeans had never tolerated the Jews in their midst; the frequent pogroms against them being a constant reminder of the intolerance of the Europeans. In 1918, when Britain occupied Palestine, they conspired to hand it over to the Jews' actually the zionists' as a permanent homeland totally ignoring the rights of the indigenous Palestinian people. At the time the Zionist state was created in Palestine in 1948, more than 60 percent of Palestinian land was handed over to the zionists. The rest was grabbed by the zionists in 1967 together with East Jerusalem that houses the Masjid al-Aqsa as well as the Dome of the Rock.

That is where the situation stands today: Masjid al-Aqsa, indeed the entire Haram al-Sharif is under Zionist occupation and threat of destruction. Even while Muslims throughout their history provided sanctuary to the Jewish people after they suffered persecution elsewhere, the Zionists have turned out to be the worst kinds of oppressors in history. They act with impunity and are extremely hostile toward the indigenous Palestinian people. Heavily armed, they shoot at the slightest pretext and have no regard for Palestinian life.

The corrupt Muslim rulers are totally subservient to the imperialists and zionists. Reposing hope in them to rescue the Muslims is a waste of time. It would require a figure like Salahuddin Ayyubi to rise among the Muslims to liberate Masjid al-Aqsa and Palestine from another group of Crusaders, this

Until then, Muslims can pray and prepare for that day. A good starting point would be to become better informed about their history that seems to have been largely forgotten.

## Inheritance to Orphans Under Islamic Law

Let the same Creator answer in Whose name orphans are being expelled from their rights

n the court, as Sana and her mother sat shaking in their shoes, the judge asked the official:

"Yes, Your Honour," the official replied. "Under what provision?" "Your Honour, their grandfather has

guard. The official continued: "Your Honour, the grandfather was an unlettered man. Hence, his decision to let the defendants have the hold of the land is his form of the will.

The Judge agreed with the official, favoured the defendants and gave them legal rights over the land. This was yin and yang between de jure and de facto.

Afshana could not recall what her paternal aunt looked like until the latter came to see Afshana's younger brother who was lying on the deathbed. The aunt was the only kind enough relative to show up after two decades. No one else ever came from her deceased father's family to see the widowed mother living with her brother or the children who lived in an orphanage.

The argument of the greedy kinfolk of an orphan: "Orphans are not mentioned in the inheritance law in the Holy Book, thereby they stand ousted from any inheritance." Well, there is no direct mention, for sure; however, I ask, "Where is it written in the Holy Book that the orphans shall 'not' receive any share?" Our'an:

- Did you see him who denies the Hereafter? [107:1]
- Such is the one who repulses the orphan [107:2]
- And when the relatives and the orphans and the poor are present at the time of division of inheritance, give them something out of it [the property] and speak to them words of appropriate kindness. [4:8]
- Let those who, if they themselves died, would fear for the future of their helpless children, let them fear Allah and speak appropriate words [i.e., show the same concern for orphans [4:9]
- Do good to your parents and relatives,

- and orphans and the needy [2:83] And that you stand firm for justice to orphans. [4:127]
- So as for the orphan, do not oppress him [93:9]
- And you devour others' inheritance
- greedily [89:19] But no, you do not honour the or-

phan [89:17] There are two things Allah gave a human: Shariat, and Shu'oor. Shariyat is law. Shu'oor is sense. The inheritance to orphans is one of those things He has explained in His final book, the Qur'an, not in words of one syllable. Some matters were left by Him for us humans to evaluate sensibly, looking for guidance in the light of the holy Qur'an and the teachings of Prophet Muhammad (PBUH). But we have become good at nothing but creating controversies out of the ambiguity in

these matters. One day I asked my father, "Baba, how is it that I am sure I am born in the right belief and the other person in the wrong one? How is the latter to be blamed if they were born in the wrong belief?" My father answered: "No, Aisha, God shall ask you, 'If in the world you had time to study so much of science and art, how come did you not care to study the book

I sent for you?" I think my father did a fair job at raising me. If I am to turn into a rogue, that would be on me now.

This inheritance 'puzzle' is as simple as it gets: Aisha is a legal heir of her father, Hasnain. In turn, Hasnain is a legal heir of his own father, Ghulam Rasool, who is also Aisha's grandfather. Hasnain will pass on the ancestral property to Aisha which he himself will inherit from Ghulam Rasool. Since Ghulam Rasool is alive, the division of the property has not taken place yet. Sadly, Hasnain dies before he could inherit any fortune from his father. Now Aisha finds no inheritance not because she ceases to be the daughter of her deceased father who 'was' the son of Ghulam Rasool, but simply and plainly because her father died without having received any property from Ghulam Rasool. But losing her father is what her gluttonous co-heirs equate with 'Aisha is no longer entitled to any share in the property'. There is no divine law or lack of it behind this no-share

theory. It is poor math and pure politics. The following are the verses from the Qur'an for the orphaned children whose parent(s) died while they were minors and

were left with some wealth from them: And do not eat up their [the or-

phans'] property along with your own. It is surely a mighty sin. [4:2] Indeed those who unjustly eat up the property of orphans eat up a fire into their own bellies. And they will soon be burning in a Blazing Fire. [4:10]

And do not go near the wealth of the orphan [6:152]

In case the father had gathered no savings or security in his lifetime that his legal heirs could inherit, what is the way out for Aisha? Here comes the crucial role of Ghulam Rasool. There is a reason that the Islamic law has allowed Ghulam Rasool to make a will for any cause of his choice within one-third of his wealth and discouraged him from giving away his property to his children while he is still alive and in need of his wealth. Ghulam Rasool has the freedom to leave a will or leave everything for the children. The trick though is that Ghulam Rasool is barred from making the will for his legal inheritors. In his life, he can give anyone anything, but once he leaves the world, his say in things, except for his will made in compliance with the Muslim law, holds no merit. The Shariat takes over. My father cannot leave a one-third property will in my name and let my siblings and his wife look for their

small shares in the two-third of his property – movable or immovable - which I am again also a rightful shareholder of apart from receiving a will.

What one can deduce from the Qur'anic verses mentioned above, and many more not mentioned in this article, is that the grandfather is under an obligation to make a will for his orphaned grandchildren. If this society had been kind enough, the title of this article could have been the reverse: How an Orphan Lands a Lion's Share in the Property by Means of a Will? If the grandfather has five children and fifteen grandchildren, the twenty together would have to look for their share in the two-third while the orphan singularly got one-third. While this is wishful thinking and also something I wouldn't propose, give the orphan as much of share as the other children in the family would (indirectly) inherit from the grandfather, give or take, for creep's sake!

#### **Gold Rises Rs 365 To Reclaim Rs 91,000/10 Gram-Mark**

New Delhi- Gold prices increased by Rs 365 to Rs 91,050 per 10 grams in the national capital on Thursday amid a strong trend in the overseas markets. according to the All India Sarafa Association.

The precious metal of 99.9 per cent purity had closed at Rs 90,685 per 10 grams on Wednesday.

Gold of 99.5 per cent purity also rose by Rs 365 to Rs 90,600 per 10 grams against the previous close of Rs 90,235 per 10 grams.

"Gold maintains its gains as the global risk sentiment has been increased, following the new auto tariffs announced by the US President Donald Trump on Wednesday," Saumil Gandhi, Senior Analyst of Commodities at HDFC Securities, said.

Silver prices also went up by Rs 200 to Rs 1,01,700 per kg. It had ended at Rs 1,01,500 per kg on Wednesday.

Meanwhile, gold futures for April delivery surged by Rs 828 or 0.94 per cent to trade near a record high of Rs 88,466 per 10 grams on the Multi Commodity Exchange (MCX).

On March 20, the yellow metal prices rose to hit a lifetime high of Rs 89,796 per 10 grams.

Spot gold in the international markets climbed by USD 34.77 or 1.15 per cent to trade near a record high of USD 3,054.05 per ounce.

"Gold prices surged near USD 3,050 per ounce as expectations of lower US GDP data and the anticipated reciprocal tariffs from the US on April 2, fuelled uncertainty," Jateen Trivedi, VP Research Analyst of Commodity and Currency at LKP Securities, said.

Additionally, threats from the US towards the Eurozone over potential support for Canada have heightened market risks, further boosting safe-haven demand, Trivedi said.

## **Parliament Approves Finance Bill 2025, Completes Budget FY26 Exercise**

New Delhi- The Rajya Sabha on Thursday returned the Finance Bill 2025 to the Lok Sabha, along with 35 government amendments, including one that abolishes a 6 per cent digital tax on online advertisements, thus completing the 2025-26 budgetary exercise that started on February 1.

The House also returned the Appropriation Bill (3) with a voice vote.

Earlier in the day, Finance Minister Nirmala Sitharaman had moved the two bills in the House.

The Lok Sabha had passed the Finance Bill on March 25 and passed the Appropriation Bill on March 21. Replying to the debate lat-

er in the evening, she said the tendency of the finance ministry would be to exercise caution and not let go of revenues.

"But, here we wanted to use this opportunity to show

our respect for Indian taxpayer. We have moved towards setting Rs 12 lakh as threshold

pay any tax," Sitharaman said. The Union Budget 2025-26 envisages a total expenditure of Rs 50.65 lakh crore, an increase of 7.4 per cent over the current fiscal.

The total capital expenditure proposed for the next fiscal is Rs 11.22 lakh crore and an effective capital expenditure of Rs 15.48 lakh crore.

It proposes a gross tax revenue collection of Rs 42.70 lakh crore and a gross borrowing of Rs 14.01 lakh crore.

According to Budget documents, Rs 5,41,850.21 crore has been earmarked for Centrally Sponsored Schemes for the financial year starting April 1, 2025. This compares with Rs 4,15,356.25 crore for the current financial year.

For central schemes, Rs 16.29 lakh crore have been earmarked for FY26 compared to Rs 15.13 lakh crore for 2024-25.

Budget estimates of expenditure for 2025-26 have increased due to several reasons, including a rise in payment of interest on market loans, treasury bills, external loans, small savings and provident funds; higher requirements of Armed Forces, including capital expenditure; and more provisions for employment generation scheme.

Total resources being transferred to states, including devolution of states' share, grants/loans and releases under Centrally Sponsored Schemes, in Budget 2025-26 are Rs 25,01,284 crore, a rise of Rs 4,91,668 crore over the actuals

The fiscal deficit for FY26 is projected at 4.4 per cent against 4.8 per cent in the current fiscal.

The GDP for FY2025-26 is estimated at Rs 3,56,97,923 crore, which is 10.1 per cent over the Revised Estimates for FY2024-25 of Rs 3,24,11,406 crore released by the National Statistical Office(NSO).

### **High Court Seeks Status Report On Ex-Ministers Staying In Govt Accommodation**

JAMMU: The Jammu and Kashmir High Court has directed the Estates Department to submit a status report on two politicians-former Chief Minister Ghulam Nabi Azad and former J&K BJP President Ravinder Raina-regarding their continued occupation of government accommodation. The directive was issued by a Division Bench comprising Chief Justice Tashi Rabstan and Justice M.A. Chowdhary during the hearing of a public interest litigation (PIL No. 17/2020) that seeks the eviction of overstaying ex-ministers, ex-legislators, and politicians from official residences.

During the hearing, Senior Additional Advocate General (Sr. AAG) S.S. Nanda, representing the Estates Department, informed the court that only three politicians remain in government accommodation. One of them, former MLC Ravinder Sharma, has challenged his eviction in a separate writ petition, where the court has granted a stay on his removal.

Nanda also stated that the J&K government's Designated Committee is set to review the matter of allotments and sought three weeks to file an updated report on Azad and Raina's status.

However, the petitioner's counsel, Advocate S.S. Ahmed, along with Advocate Rahul Raina, argued that the continued occupation of government residences by these two politicians violates the court's earlier rulings. They emphasized that security concerns and official accommodation should be treated separately, citing a precedent set by the Delhi High Court in Subramanian Swamy's case. Ahmed pointed out that previous governments had evicted two former Chief Min-isters and over 180 politicians, arguing that the same principle should be applied in this case.

After hearing both sides, the Division Bench ordered the Estates Department to file a detailed status report on the two politicians by the next hearing date. Recognizing the case's significance, the court scheduled the next hearing for April 23,

### **Police Conduct Raids Across Kashmir In Probe Against Proscribed Groups**

**SRINAGAR:** In a significant crackdown, Jammu and Kashmir Police on Thursday conducted multiple raids across the Valley as part of ongoing investigations into the activities of proscribed organizations.

According to officials, the ids were carried out in Ganderbal, Shopian, and Baramulla districts, targeting individuals linked to banned groups, including Jamaat-e-Islami (JeI), Jammu and Kashmir Democratic Freedom Party (JKDFP), and Jammu and Kashmir Muslim League (Masrat Alam faction).

Authorities stated that searches were conducted at the residences of individuals suspected of involvement in unlawful activities deemed a threat to public order and national security. During these operations, police recovered

incriminating materials connected to the activities of these banned organizations.

The recovered evidence has been taken into custody and will be examined as part of multiple cases registered under the Unlawful Activities (Prevention) Act (UAPA).

Police officials emphasized that all raids were conducted in the presence of magistrates and independent witnesses to ensure legal transparency.

"The operation aims to dismantle anti-national and separatist networks by identifying and prosecuting individuals engaged in such activities," an official said.

Over the past several days, security forces have intensified their crackdown, executing multiple raids across Kashmir as part of efforts to curb separatist activities and enforce law

## **'Proactive Steps Taken To Mitigate Glacial Lake Outburst Floods'**

**JAMMU:** The Government of Jammu and Kashmir is taking proactive steps to mitigate the risks associated with Glacial Lake Outburst Floods (GLOFs) in the Union Territory.

The initiative involved a phased approach, including data collection, identification of highrisk glacial lakes and develop-ment of early warning systems.

The region's unique geography, with its high-altitude glaciers and lakes, makes it particularly vulnerable to GLOFs. Rising global temperatures are accelerating glacier melting, leading to formation of numerous glacial lakes that are at risk of sudden breach, releasing millions of cubic meters of water and debris.

To address this threat, the J&K government has adopted a comprehensive, holistic and proactive approach, initiating numerous technologically advanced measures on this account. These included

Expeditions and Data Collection; gathering detailed data through bathymetric surveys, water sampling and meteorological data collection to understand the dynamics and characteristics of glacial lakes,

Risk Assessment and Categorization; identifying highrisk glacial lakes based on 17 critical parameters including size, location and potential mass movement zones,

Early Warning Systems; establishing a fully functional



Early Warning System (EWS) response to potential GLOF besides Mitigation Measures; developing and implementing specific mitigation measures, including lakelowering techniques and sitespecific mitigation measures.

The Focused Glacial Lake Outburst Flood (GLOF) Monitoring Committee (FGMC) has been constituted to oversee implementation of the mitigation strategy. The committee has identified 14 high-risk glacial lakes, 3 moderate-risk lakes and 7 low-risk lakes. Expeditions have been conducted to high risk lakes, including Sheeshnag and Sonsar to enhance understanding and preparedness.

The government plans to continue its efforts to expand the mitigation program, improve predictive abilities for heavy rainfall events and sensitize the stakeholders, including NDR, SDRF and ITBP to be prepared for any emergent situation. Likewise, awareness generation has been specially focused upon and

Aapda Mitras are being sensitized and activated to remain vigilant in local areas. Building on the momentum

of its initiatives, the government of Jammu and Kashmir has undertaken a series of specialized expeditions to study critical glacial lakes in the region.

Led by Dr. Sunil Dhar from the Department of Environmental Sciences, Central University of Jammu, these expeditions have focused on three high-risk lakes in the Kishtwar district: Mundiksar Lake, Hangu Lake and an unnamed lake.

The expeditions have provided invaluable data on lake conditions, environmental factors, and potential GLOF risks. This information will be crucial in developing risk mitigation strategies and enhancing early warning systems. A subsequent expedition to Gangabal Lake, a high-altitude glacial lake in the northwestern Himalayas, assessed the lake's physical and geological characteristics, including local geomorphology, natural dam stability, and glacier conditions.

#### **NC MLA Demands Judicial Probe** Into Deaths of Two Gujjar Men

**SRINAGAR:** National Conference (NC) legislator from Budhal, Javid Igbal Choudhary, on Thursday called for a judicial probe or an inquiry by a central agency into the disappearance and subsequent deaths of two Gujjar men in Kulgam.

Highlighting the concerns of the Gujjar community, Choudhary pointed to a series of trou-bling incidents, including the deaths of 17 people in Budhal, which, he said, have eroded trust in the authorities.

On the first day of the recess during the ongoing budget session of the Jammu and Kashmir Legislative Assembly, Choudhary visited the bereaved families in Kulgam to gather firsthand information about the case.

"The targeting of Gujjars and the lack of credible investigations into these deaths raise serious concerns. I urge a judicial probe or an investigation by a central agency into these incidents," he stated.

Two of the deceased, Showkat and Riyaz, originally hailed from Khawas in Budhal and had migrated to Kulgam, where they worked as laborers after purchasing small plots of land. Choudhary noted that their deaths, along with earlier mysterious fatalities in Budhal, remain unexplained.

After meeting the victims' families, Choudhary alleged a "deliberate cover-up" and expressed disappointment over the indifferent attitude of law enforcement agencies. He called upon Union Home Minister Amit Shah and Lieutenant Governor Manoj Sinha to intervene and ensure a transparent investigation through the National Investigation Agency (NIA) or the Central Bureau of Investigation (CBI).

#### **PHE Daily Wagers Defer Strike Over Festivals**

JAMMU: Public Health Engineering (PHE) daily wagers have temporarily called off their strike for 10 days following an appeal from Chief Minister Omar Abdullah and in consideration of the upcoming Eid and Navratri festivals.

Speaking on behalf of the PHE Employees United Front, Ravi Hans stated, "The Chief Minister urged us to end the strike due to the public inconvenience it was causing. Given the approaching festivals, we have decided to defer our strike until April 7."

The decision followed a meeting between PHE Minister Javed Rana and the protestors, during which the minister assured them that pending wages would

be released in a phased manner. The daily wagers have been demanding regularization of ser-

vices, immediate release of pend-

ing salaries, an increase in minimum wages, and compensation for those who retired at 60.

While addressing the Assembly, Abdullah acknowledged the water crisis triggered by the strike and urged the workers to engage with the government panel formed to address their concerns.

Hans warned that if the government fails to act within the 10-day period, the workers will resume their agitation with greater intensity. "If our demands are ignored, the administration will face serious consequences. As soon as the Assembly session begins on April 7, our protest will also commence," he asserted.

Minister Javed Rana described the workers' demands as legitimate, stating that the issue of pending wagesamounting to Rs 400 crorewould be taken up in the upcoming cabinet meeting.

Sources said that the cabinet meeting was held under the chairmanship of Chief Minister Omar Abdullah.

"The meeting commenced at 3: 00 PM and lasted till 4:30 PM," they said, adding that the cabinet gave its nod to modalities worked-out by different departments for implementation of announcements of free power and free ration to AAY beneficiaries and enhancement of pension and marriage assistance scheme.

The key budget announcement include 200 units of free electricity for all Antyodaya Anna Yojana (AAY) households under the PM's Surya Ghar Muft Bijli Yojana and 10 kilograms of free ration per person for the families falling in this

In his budget speech, the CM also announced increasing pensions for over 10 lakh elderly, widows, divorcees, and specially-abled individuals.

As per the CM's budget speech announcement, monthly pensions will now be Rs 1,250 for those below 60 years, Rs 1,500 for those aged 60-80, and Rs 2,000 for individuals above 80 years. The Marriage Assistance Scheme for AAY category girls has also seen an increase, with financial aid enhancing to Rs 75000 from Rs 50000.

It may be mentioned that a group of terrorists were intercepted by the SOG in the Hiranagar sector of Kathua district on Sunday evening.

Despite a massive search operation, the terrorists managed to escape the initial cordon, the officials said, adding it is assumed that the same could have been possibly spotted near Jakhole, approximately 30 kilometers from the initial encounter site.

The terrorists were moving through the forest area when a police party headed by a SDPO moved in after getting specific information, the officials said, adding they came under heavy firing resulting in the gunfight.

Reinforcements from the police, army, and CRPF were immediately deployed to the area.

The quiet village Suffain in Kathua district was shattered by the relentless sounds of gunfire, grenades, and rocket fire as a fierce exchange raged throughout the day, punctuated by a series of powerful explosions.

Earlier, a group of terrorists was intercepted on Sunday evening within a 'dhok', a local term for an enclosure in a nursery, in Sanyal village near the International Border with Pakistan.

A subsequent massive search operation, involving the police, army, NSG, BSF, and CRPF, utilised advanced technical and surveillance equipment, including helicopters, UAVs, drones, bulletproof vehicles, and sniffer dogs.

The search teams discovered evidence on Monday, including four loaded magazines of M4 carbine, two grenades, a bulletproof jacket, sleeping bags, tracksuits, food packets, and materials for constructing improvised explosive devices (IEDs) near the Hiranagar encounter site.

Police believe the terrorists infiltrated on Saturday, possibly via a ravine route or a newly constructed tunnel from across the border.

Delhi HC Refuses Urgent Hearing The Delhi High Court on Thursday

refused to grant an urgent hearing to Er Rashid Sheikh, seeking waiver of condition to bear travel expenses for attending the ongoing Parliament session "in-custody".

The plea was mentioned for urgent hearing during the day before a bench of Chief Justice D K Upadhyaya and Tushar Rao Gedela, which said if the application has been filed, it will come up on Friday on its own.

The counsel said he was seeking deletion of the condition to bear all expenses for travel and other arrangements and not seeking reduction in the amount given by the prison authorities.

"You file the application and it will come up for hearing tomorrow on its own. We have made it clear and we can't be more clearer," the bench said.

Rashid, in his application, said the order granting him permission to attend Parliament was uploaded on the court's website on March 26 afternoon and in the evening his counsel received an email from the jail authorities that he is required to pay around Rs 1.45 lakh each day for travel and related arrangements. This would make a total of Rs 8.74 lakh for six days, the plea said.

allocation priorities, pointing out that while states like Andhra Pradesh and Bihar received financial packages, Jammu and Kashmir's allocation was reduced.

"You have given packages to Andhra Pradesh and Bihar, but the place that truly needs a package is Jammu and Kashmir, which has been devastated by militancy for 30 years," Rashid said.

"Instead of increasing our allocation, you have reduced it by Rs 1,000 crore compared to last year.'

The MP also took a veiled dig at Jammu and Kashmir's leadership, stating that while the government in Srinagar might hesitate to raise such demands, he had no qualms about seeking economic justice for the

"Our Chief Minister may feel shy to say this, we don't know what stops him, but we demand that J&K be given its full share," he asserted.

Rashid also challenged the 'doubleengine government' narrative, questioning the rationale behind selective financial aid.

"If we are all under the same Constitution, then all states and people should be treated equally. Why do you give packages to some states and ignore others?" he asked.

Notably, the Delhi High Court on Wednesday permitted Rashid to attend the ongoing Parliament session under custody, rejecting the NIA's concerns about him being a flight risk.

The court, in its March 25 order, imposed strict conditions, barring Rashid from using any communication devices, accessing the internet, or interacting with anyone outside jail except within Parliament premises. He is also prohibited from addressing the media. Additionally, Rashid will bear the cost of his travel and security arrangements.

Currently lodged in Tihar Jail, Rashid has been in judicial custody since his arrest by the NIA in 2019 in connection with a 2017 terror-funding case. He had initially sought interim bail or custody parole to attend the Lok Sabha session but later requested in-custody attendance instead.

## **IPL 2025: RCB Look Up To Batters** To End 17-Year CSK Jinx

CHENNAI: Royal Challengers Bengaluru's hopes of exorcising a 17-year jinx hinge on their experienced batting unit finding its range when they face familiar foes Chennai Super Kings in their IPL match here on Friday.

The Royal Challengers have beaten the Super Kings only once at Chepauk – in the inaugural edition of the tournament in 2008. In the current RCB squad, only star batter Virat Kohli was part of that moment and now he will like to breach the CSK's fortress for a second time.

But that's easy to dream. As ever, the Chennai outfit is constructed to win their home matches on a pitch that offers considerable help to spinners. They have the ever-famil-

iar Ravindra Jadeja and have brought back 'old boy' Ravi-chandran Ashwin through last year's players' auction.

The Chennai side has also added Afghanistan left-arm wrist spinner Noor Ahmad too to the squad, and the troika did well against fellow five-time



champions Mumbai Indians a few days back.

The triumvirate bowled 11 overs against Mumbai, conceding an appreciable 70 runs for

The pitch is expected to retain its character for this match as well, and the RCB batters, led by Kohli, will have to lift their game several notches to outwit an experienced bowling unit.

Outwit is the key word here. The Royal Challengers' batting unit should be clever more than downright aggressive to score off CSK's three-pronged spin unit, and Kohli should lead

Negating spin has not always been a strong point of Kohli's batting but in the last two years or so he has showed massive improvement in that department.

Central to that change is his willingness to play more sweep/slog sweeps against spinners, and Kohli will have to bring all those expertise to the table on a blockbuster Friday

But then Kohli alone won't able to tackle a competent bowling machine, and he will require full-hearted support from Phil Salt, skipper Rajat Pa-tidar, Liam Livingstone, Jitesh Sharma etc.

Looking at the Chepauk pitch, RCB might even consider bringing in Jacob Bethell, possibly for Tim David, who also

provide a left-arm spin option. They will also keep an eye on the fitness of pacer Bhuvneshwar Kumar, who missed the first match against KKR due to a niggle, and if the veteran is fit then he will come in for Rasikh

you all know how well it helped the spinners, he was very aware. So, I believe right now, he is batting as well as he has ever done.'

RCB have not beaten CSK at their home ground even once in the last 16 years. Rajat Patidar and his men will once again face a spin test when they take on the five-time former champions at Chepauk on Friday.

Asked if playing spin is a problem area for the RCB batters, Karthik said, 'I don't think there's any problem. We played one match, a completely new side to what we had last year. One of the strengths, I believe, is the way we play spin. And as this tournament unfolds, you'll see it happen.

"CSK have three good spinners, no doubt. But we also have very good batters, competent batsmen, who we trust. One of the reasons why we picked them is how well they play spin."

## 'Problem Resolver' Igor Tudor Looks To Be The Right Coach For Juventus

MILAN: Igor Tudor could be exactly the coach Juventus needs and at exactly the right time.

Tudor accepted the job last weekend, replacing Thiago Motta with the storied Italian club in disarray and discord.

Juventus is out of all competitions, having been eliminated from the Champions League and the Italian Cup. In Serie A, its faint chance of challenging for the title has evaporated after conceding seven goals and scoring none in its last two matches 4-0 and 3-0 losses to Atalanta and Fiorentina.

That has left a shellshocked Juventus in left fifth place and at risk of not qualifying for the Champions League next season. Motta also reportedly lost the support of key players. Enter Tudor.

The 46-year-old has a reputation for being a fixer, coming into clubs during the season and turning things around - having done that at Udinese (twice), Hellas Verona and Lazio.

Tudor also has a reputation as a no-nonsense coach, who can handle



difficult players and who will follow his own beliefs rather than toe the line to appease club bosses.

He left Marseille and Lazio after falling out with the hierarchy.

"Am I someone who resolves problems? I consider myself a coach," Tudor said in a news conference on Thursday. "I started coaching young and I've been doing it for 10-15 years, I have gone around a lot, I can also be a bit particular because I make choices with my

heart.

"I continue if I feel it is right. If not, I go home regardless of my contract. I live in the present. I want to be here for 10 years but I will do my work in the same way. We can't control what happens in the future.'

Tudor has been given a contract until the end of June, taking him through to the end of the domestic season and the Club World Cup in the United States. His contract will reportedly

be automatically renewed for another year if Juventus qualifies for the Champions League.

Juventus is one point below fourth-placed Bologna and Tudor's first match in charge will be on Saturday, at home to Genoa.

"I believe a lot in this team because it has quality players and a great desire to improve," Tudor said. "We know that we are going through a difficult period and that there has been little time to work on changes, but there are no excuses in life and I have never looked for them."

Tudor knows Juventus well, having spent almost a decade as a player at the club, and then returning as an assistant coach to Andrea Pirlo in 2020-21. Pirlo and Tudor were fired at the end of that season.

The Croatian tactician is very much aware of the demands of the record 36time Serie A champion.

'This club has a unique work culture. I've told the lads about some moments I experienced here as a youngster ... what makes up Juve: Respect, discipline, sacrifice and the will to win," Tudor said. (AP)

## Barcelona's Squad Depth Set To Be **Tested With Busy Run Of Games**

aLiga leaders Barcelona will not Lhave a moment to catch their breath as they play Osasuna and Girona in the space of three days after a punishing international break left their players either fatigued or unavailable and manager Hansi Flick fuming.

Barca and Osasuna were forced to reschedule their March 8 fixture following the death of the Catalan club's doctor and, with a busy schedule in other competitions, March 27 was the only date available straight after the international break.

As 13 Barcelona players return from national team duty, Brazil's Raphinha has no time to fly back and recover for Thursday's game while several others participated in Nations League quarter-finals that went to extra time and penalties.

Barca play every three days until April 15, a run of seven games in three competitions. After playing Osasuna, they host Girona on Sunday and Atletico Madrid in the Copa del Rey semifinals three days later following a 4-4 draw in the first leg.

Barcelona and Osasuna had appeals to postpone the game rejected and Flick's side must now fulfil the fixture without key forward Raphinha, who has played every LaLiga game this season and has 27 goals and 20 assists in all competitions.

Raphinĥa's leadership and his form have put him in the conversation for



the Ballon d'Or but Flick did not mince his words when he bemoaned the fact he will not have the Brazil winger on Thursday when his side will be tested by Osasuna.

Midfielder Pedri said: "We're a little tired, but we can't forget that we're Barca. If it's decided we have to play on Thursday, we'll do it and give everything we have to win La Liga."

Barcelona are on a seven-match winning streak in LaLiga but Osasuna were the first team to beat them this season with a stunning 4-2 victory in September.

Back then Flick took the blame when his decision to rest key starters backfired but this time he has no choice but to rotate his squad with

Spain duty. Real Madrid will keep an eye on

Barca's game on Thursday, with the two Spanish giants level on 60 points.

Real's form in LaLiga has been a roller-coaster since the start of February but Carlo Ancelotti's side host Leganes on Saturday, a straightforward fixture on paper against a team battling relegation and with one win in eight games.

Athletic Club, who are fourth with 52 points, will also watch Thursday's Barca match closely as they welcome Osasuna to the Metropolitano three days later in a game that was postponed to Sunday so their opponents could play the Catalans.

# UK's Royal Society Decides Not To Take Action Against Elon Musk



had signed an open letter expressing dismay at what they described as "continued silence and apparent inaction" from the Royal Society over Musk's fellowship.

They said Musk's behaviour, including what they said was embracing conspiracy theories, breached the Royal Society's code of conduct, while the situation had become more serious because of his position in Trump's administration, which they said had engaged in "an assault on scientific research".


