

## **J&K Statehood Certain, But No Timeline: Shah**

New Delhi: Statehood in Jammu and Kashmir will be restored as promised before, Union Home Minister Amit Shah has said, without giving any timeline.

Shah said at the "Times Now Summit 2025" Friday night that assembly elections were held in Jammu and Kashmir peacefully last year.

"We have given the assurance that statehood will be restored. From the very beginning, we have said that statehood would be given. But it can't be disclosed when it will be given at a public forum," he said when asked about the timeline for restoration of statehood.

When Article 370 was abrogated and the erstwhile state of Jammu and Kashmir was bifurcated into two Union territories in 2019, Shah had said in Parliament that statehood of Jammu and Kashmir would be restored at an appropriate time.

"This was the first election in Kashmir after 40 years in which there was no re-polling in any place. Not a single tear gas or bullet was fired. Sixty per cent people exercised their franchise, this is a huge change," he said.

## What To Know About Earthquakes Like The One That Hit Myanmar

Navpyidaw : Early Friday, a major 7.7 magnitude earthquake that originated near Mandalay. Myanmar, shook the Earth as far as Bangkok, about 800 miles (1,300 kilometres) away.

Two hard-hit cities in Myanmar suffered extensive damage, with images from the capital, Naypyidaw, showing rescue crews pulling victims from the rubble of collapsed buildings. Authorities in Bangkok said deaths had occurred at three construction sites, including a highrise that collapsed.

the earth-Experts say quake, which occurred along the Sagaing Fault, was close to the Earth's surface, generating intense seismic forces.

Preliminary estimates by the US Geological Survey show that nearly 800,000 people in Myanmar may have been within the zone of the most violent shaking and that death tolls exceeding 1,000 people, and perhaps much higher, are probable.

What are earthquakes and why do they happen in certain parts of the world?

The Earth's crust is broken up into several pieces called tectonic plates, which fit together like a jigsaw puzzle. This formation is "mostly stable, but along the edges they are moving," Columbia University geophysicist Michael Steckler said.

Pressure builds up when sliding plates get stuck, increasing "very slowly for decades or for hundreds of years, and then

Earthquakes typically occur along edges of tectonic plates. But their impacts may be felt in a broader region.

Earthquakes that occur in the ocean don't always attract attention, but those that occur close to where people live can cause deaths and injuries, most often from collapsed buildings. What do scientists know

about earthquakes in advance? Scientists have a good idea of where earthquakes are likely to occur, "but we can't predict when they'll occur," USGS seismologist Will Yeck said.

However, after the initial big earthquake, researchers are able to project that other smaller earthquakes nearby, called aftershocks, are likely.

Aftershocks are triggered "because of changes to stress in the Earth from the main shock,' Yeck said.

Given the magnitude of the quake in Myanmar, "you will probably see aftershocks for the next several months," Steckler said. What should you do if you're

in a building when earthquake shaking begins? In regions of the world with

known active fault lines, including California and Japan, building codes are often designed to withstand earthquakes. But that's not true everywhere.

"If you feel shaking, the guidance depends on where you are in the world," Yeck said.

## **Diego Garcia Buildup: Is America Preparing to Attack Iran?**

Tehran: Time is ticking on a major war in Middle East. The chess pieces are being put in place. The U.S. military has deployed operational B-2 Spirit long-range nuclear stealth bombers at Diego Garcia, signalling potential strikes against Iran.

Historically cautious, America's approach to Iran seems to be changing under President Trump, especially after its failure to force Islamic Republic into submission. Tehran's refusal to abandon its nuclear advancements and recent direct and in-

direct attacks on Israel following Gaza war have fuelled new American adventurism. The strategic deployment at

the U.S. base in the Indian Ocean archipelago of Diego Garcia, indicates preparations for significant military action. Nearly every significant U.S. military engage-

ment in the Middle East dating back to Operation Desert Storm in 1991 began with bomber sorties launched from Diego Garcia.

These moves by the Trump administration also come on the heels of numerous statements, some intentional, some leaked by senior Trump officials--including the president himself. Responding to media reports of impending US strikes, a top Iran official said on Friday that if the United States follows through with military threats against Iran, U.S. allies and American military bases in the region will become targets.

"If they threaten Islamic Iran, then, like powder kegs, America's allies in the region and U.S. bases will be made unsafe," said parliament speaker Bagar Qalibaf.He added that negotiating under pressure and threats would equate to surrendering to the other party's demands, "which would be a prelude to war, which no nation would accept."

Tensions between US and Iran reached a boiling point this month after Trump sent a formal letter to Iran's Supreme Leader, Ayatollah Sayyed Khamenei, de livering a clear and decisive ultimatum: Iran has two months to accept a new nuclear deal or face severe consequences. This unprecedented move by the Trump administration signals a potential turning point in US-Iran relations.

According to officials familiar with the letter, Trump warned that if the Iranian govern ment does not agree to the terms by the deadline, the US would take decisive measures and this could include, coordinating military strikes with Israel, or even launching unilateral military action. However Supreme Leader has roundly rejected the Trump ultimatum saying the US was not seeking negotiations with Iran but rather imposing demands on it.



The Islamic Human Rights Commission (IHRC) had expressed concern over attacks against protesters after it was revealed that Nigerian authorities



In the leaked communique, Nigerian authorities had warned that though the pro-Palestinian demonstrations were peaceful, the protesters had the potential to seek justice by attacking US and Israeli interests in the country. Therefore,

their demos must be stopped. This method has been used by Nigeria's pro-Israel officials in recent years to prompt the forces to stage a violent crackdown on the demonstrators.

At least one person was killed, and many more were injured after police opened fire on the Quds Day demo in Abuja in 2023.

In 2014, Nigerian security forces killed 34 demonstrators after opening fire on a rally in Zaria. The annual Quds Day demonstration is held worldwide by

## 300 % Due To Israel's Aid Blockade

Miscarriages In Gaza Surge By

Gaza City: Miscarriages among

pregnant women in the Gaza Strip have surged by 300 percent due to Israel's blockade of humanitarian aid shipments, according to figures from the Palestinian Health Ministry reported by Al-Akhbar.

The rate of miscarriages soared after Tel Aviv ordered the closure of the Kerem Shalom crossing earlier this month, cutting off the flow of essential medications, including heparin injections critical for women with blood clotting disorders.

Without medicine or sanitary supplies, the situation for

pregnant women in Gaza is "catastrophic," according to Dr. Suha al-Masri, a Gaza obstetrician who says hospitals struggle to offer only "primitive solutions."

"Due to the shortage of medication resulting from the blockade, we find that many of them are silently losing their fetuses or living the remainder of their pregnancies under the constant threat of losing the baby at any moment," Masri told Al-Akhbar.


"We are not only losing mothers and fetuses, we are losing a future that was meant to be born," she added.

"I felt like a part of me had died. My son wasn't just a victim of my health condition: he was

also a victim of the siege. The occupation killed my fetus, not with missiles, but by withholding my medication," said Nisreen Ayyad 29, a resident of Gaza City who recently had a miscarriage.

"Whenever I hear about an imminent bombing, I put my hand on my stomach and tell it: Hold on. Don't be afraid; Mom is with you. But I'm the one who's afraid. I'm afraid he'll be killed before I see him," Ruba Masoud, 28, told Al-Akhbar.

According to figures released by the Gaza Health Ministry, at least 950 infants under one year of age have been killed since the start of the US-Israeli genocide in Gaza.

## **US Judge Halts Deportation Of Turkish Student At Tufts**

OSTON: A federal judge in Massachusetts on Friday temporarily barred the deportation of a Turkish doctoral student at Tufts University, who voiced support for Palestinians in Israel's war in Gaza and was detained by US immigration officials this week

Rumeysa Ozturk, 30, was taken into custody by US immigration authorities near her Massachusetts home on Tuesday, according to a video showing the arrest by masked federal agents. US officials revoked her visa.

The US Department of Homeland Security has accused Ozturk, without providing evidence, of "engaging in activities in support of Hamas," a group which the US government categorizes as a "foreign terrorist organization.

Oncu Keceli, a spokesperson for Turkiye's foreign ministry, said efforts to secure Ozturk's release continued, adding consular and legal support was being provided by Turkish diplomatic missions in the US

"Our Houston Consul General visited our citizen in the center where she is being held in Louisiana on March 28. Our citizen's requests and demands have been forwarded to local authorities and her lawyer," Keceli said in a post on X.

Ozturk's arrest came a year after she co-authored an opinion piece in Tufts' student newspaper criticizing the university's response to calls by students to divest from companies with ties to Israel and to "acknowledge the Palestinian genocide.

A lawyer soon after sued to secure her release, and on Friday, the American Civil Liberties Union joined her legal defense team, filing a revised lawsuit saving her detention violates her rights to free speech and due process

## **Columbia President Quits Amid Trump's Crackdown On Pro-Palestinian Activism**

olumbia University's interim president stepped down on Friday, marking the second leadership departure, after the Donald Trump administration's crackdown on pro-Palestinian student activities prompted her to agree with sweeping policy changes at the Ivy League school.

Katrina Armstrong resigned effective immediately, and journalist Claire Shipman, the school's board chair, has been appointed as the new interim president.

Armstrong had taken over the role from the university's former president, Minouche Shafik, who stepped down in August

Armstrong's resignation came just a week after the institution conceded to a series of demands from the Trump administration to open talks to regain access to \$400 million in frozen research funding, which



had been withheld over allegations of anti-Semitism on campus.

Trump's joint task force to com bat anti-Semitism welcomed Armstrong's resignation, calling it "an important step toward advancing negotiations as set forth in the preconditional understanding reached last Friday" in a statement.

The Trump administration has repeatedly accused the university's leadership of not doing enough to address "anti-Semitism" during students' mass campus protests against the Israeli regime forces' genocidal war against the Palestinians in the Gaza Strip.

The Trump administration has warned at least 60 other academic institutions that they could face penalties over ongoing probes into "anti-Semitism on college campuses.

Columbia University is currently facing multiple federal investigations, and it has become a primary focus of Trump's immigration crackdown targeting pro-Palestinian student activists.

One such individual, former Columbia graduate student and green card holder Mahmoud Khalil, is currently being detained by Immigration and Customs Enforcement (ICE).

#### Former Nepal King Gyanendra fined by Kathmandu civic body for vandalism

ormer King Gyanendra Shah was on Saturday issued a letter demanding fine by Kathmandu's civic body following the damage caused to public property and environment during the pro-monarchy protests in parts of the Nepalese capital a day before.

Parts of Kathmandu on Friday witnessed a tense situation after pro-monarchy protesters pelted stones, attacked the office of a political party, set fire to vehicles and looted shops in the Tinkune-Baneshwor area of Kathmandu.

Two persons, including a TV cameraman, were killed and 110 others injured in the clashes between the security personnel and the pro-monarchy protesters. As the protest was organised on the call of Gyanendra Shah, Kathmandu Metropolitan City's (KMC) mayor Balendra Shah sent a letter to his residence at Nirmala Niwas at Maharjgunj on the outskirt of Kathmandu asking him to pay Nepali Rupees 7,93,000 as compensation against the damage.

## 128 Faculty, 268 **Consultant Posts** Vacant At SKIMS, DHS

Srinagar, Mar 29: A total of 388 positions remain vacant at Sher-e-Kashmir Institute of Medical Sciences (SKIMS) Soura, including 128 faculty posts, highlighting the pressing staffing shortages in the region's healthcare sector.

According to official data, the sanctioned faculty strength at SKIMS Soura is 293, of which only 165 positions are currently filled, leaving 128 posts unoccupied. Additionally, out of 16 sanctioned medical officer positions, only two are occupied, while 14 remain vacant. The paramedical workforce also faces shortages, with 246 out of 776 sanctioned positions lying vacant.

A senior official revealed that 13 of the 128 faculty positions have been referred to the Jammu and Kashmir Public Service Commission (JK-PSC), while 115 are pending approval for revival or concurrence. Similarly, all 14 vacant medical officer positions at SKIMS have been referred to JK-PSC, whereas of the 246 vacant paramedical posts, 21 have been sent to the Jammu and Kashmir Services Selection Board (JKSSB), with the remaining 225 un-

der consideration. The crisis extends to the Directorate of Health Services in both Jammu and Kashmir. In the hospitals under the Directorate of Health Services Jammu (DHSJ), 11 senior consultant positions and 131 consultant positions remain unfilled. In Kashmir, 42 consultant positions are vacant in district hospitals, with an additional 84 vacancies in sub-district hospitals. DHSJ is also short of 337 medical officers, while 254 posts of medical officers remain

Srinagar: The usual festive rush ahead of Eid-ul-Fitr is missing from the markets of Srinagar and other parts of the Kashmir valley, leaving traders grappling with sluggish sales and looming losses.

With Eid-ul-Fitr expected to be celebrated on either Monday or Tuesday, depending on the moon sighting, the bustling shopping scenes that typically mark the festival season are noticeably absent this year.

Markets in and around Lal Chowk-the commercial hub of Srinagar-are witnessing significantly reduced footfall, with local traders attributing the downturn to a rise in online shopping and growing financial constraints among consumers due to increasing prices.

Sales are down by nearly 70 percent compared to previous Eid seasons," said Suhail Shah. Vice President of the Lal Chowk Traders Association. "The market outlook is worse than on regular days.'

ew Delhi- Influential Shia leader and lone Congress minister in Farooq Abdullah government Moulvi Iftikar Ansari, appears certain to face expulsion from the party in case he refuses to quit as a minister.

Taking exception to Farooq Abdullah's overtures with the BJP, the Congress leadership feels that "it is right time" to ask Iftikhar to resign and work for "revitalising the party" in the state, highly placed sources said here tonight. In case Ansari refuses, the party will be left with no other alternative but to expel him, the sources added.

Incidentally, senior Congress leader Mufti Mohammad Syed had a long meeting with the newly appointed party president Sonia Gandhi, late last night. Mufti's meeting with Sonia assumes significance in the background of wavering approach of former Congress chief Sita Ram Kesri with regard to party affairs in Kashmir, making it virtually defunct.

The party leaders are sore that no action was taken against Ansari even as he openly campaigned against the Congress candidates in just -concluded Lok Sabha elections in Kashmir. "Time has come now to show the Moulvi his right place" a senior AICC leader told this reporter.

How Domestic Violence Silently Strips Children of Their Inheritance

n the deep shadows of domestic violence, another injustice often goes unnoticed in Kashmir — one that impacts not just women, but their children: the quiet erasure of a child's right to inheritance and maintenance when a mother leaves an abusive home. While society insists on preserving family honour

and reconciliation at all costs, we are raising a generation of children who are dispossessed — emotionally,

legally, and financially — because our systems are not

Take the case of Ayaan (name changed), an 11-year-old boy from Srinagar. When his mother fled their home to escape physical and emotional abuse, she left behind more than a broken marriage. She unknowingly left behind her children's rightful share of their father's property.

At the mediation centre, where her case was diverted instead of going to court, the pressure to "settle amicably" was immense. Without legal counsel and fearing social stigma, she signed a mutual separation. No mention was made of maintenance for the children, no agreement was reached about inheritance rights, and no steps were taken to secure residence or education support for Ayaan or his younger sister.

Shortly after, her husband transferred family property to his brother, effectively disinheriting his own children.

#### Mediation Centres: Peacekeeping or Burying Rights?

Mediation centres in Kashmir, though set up with good intentions, often fall short of justice when it comes to domestic violence cases. Reconciliation is prioritised over responsibility. Women are told to "adjust," and children's futures are reduced to afterthoughts.

Crucially, these centres:

• Do not verify whether maintenance and property rights are being addressed.

• Lack protocols to protect the child's inheritance or financial security.

• Often operate without trained legal professionals or trauma-informed counsellors.

• Pressure survivors into settlements that favour abusers and overlook long-term needs.

#### The Cultural Trap: Honour vs Justice

In Kashmiri culture, izzat (honour) remains a powerful force. But this honour is unevenly distributed it demands silence from women and compliance from children, while allowing men to escape accountability. When a woman leaves a violent home, she is expected to walk away quietly, often without any financial security, dignity, or legal protection.

The same cultural conditioning that tells women to "adjust" also denies their children access to proper-



ty — even though Islamic law grants them fixed shares in their father's estate.

#### What the Law Says - and Where We Fail

Legally, children and women have multiple protections:

• Section 125 CrPC mandates that fathers pay maintenance for children.

• The Protection of Women from Domestic Violence Act (PWDVA), 2005 offers residence, protection, and financial relief.

• Muslim Personal Law (Shariat Application Act, 1937) clearly outlines inheritance rights for children — both sons and daughters.

But when these legal tools are not used — either due to lack of awareness or systemic neglect — the result is what we see in cases like Ayaan's: children left with no home, no inheritance, and no legal recourse.

#### A Call for Structural Change

To move forward, we must reimagine our mediation and legal systems. Some immediate reforms that can be implemented:

1. Mandatory Legal Representation: No woman should go through mediation without a lawyer, especially when children's rights are involved.

2. Child-Centric Agreements: Settlements must address maintenance, inheritance, and residence of children as non-negotiable elements.

3. Inheritance Safeguards: Property transfers made post-separation should be reviewed to prevent

unlawful disinheritance.

4. Stronger Court Oversight: Courts must play a proactive role in ensuring that children's inheritance and financial rights are upheld, even in out-ofcourt settlements.

5. Training for Mediators: Cultural sensitivity must be balanced with legal knowledge. Mediators must be trained to identify coercion and trauma.

#### The Future They Deserve

The right to a safe home, financial stability, and a fair share in inheritance should not be lost when a mother walks away from abuse. We must stop asking survivors to pay the price for their freedom with their children's futures.

Children like Ayaan are not collateral damage — they are citizens with rights. If our society and institutions fail to protect those rights, we are not just failing women — we are failing the very foundation of our future.

he world's major growth engines are about to run in reverse. The policies and uncertainties of US President Donald Frump's second administration have hit a sluggish global economy with a transformational exogenous shock. Risks are especially worrisome in both the United States and China, which have collectively accounted for a little more than 40% of cumulative global GDP growth since 2010. America is now the problem, not the solution. Long the anchor of the rules-based international order, the US has turned protectionist, posing major risks to an already fragile global trade cycle. At the same time, Trump's MAGA ("Make America Great Again") movement has driven a powerful wedge between the US and Europe and divided North America, with Canada's very independence in Trump's crosshairs. The central role of the US in sustaining post-World War II geostrategic stability has been shattered. The US will be unable to put the genie back in the bottle. Trump's shocking actions have eroded the trust that has underpinned America's global leadership, and the damage will be evident long after Trump has left the scene. Having once abdicated its moral authority as the anchor of the free world, who is to say it can't happen again? This breakdown in trust will cast a long and lasting shadow over economic performance, not least in the US itself, where it is affecting business decision-making, especially the costly long-term commitments associated with hiring and capital spending. Businesses need to scale their future operations relative to confident expectations of future growth trajectories - now an increasingly uncertain proposition. Asset values and consumer confidence, too, have been shaken. Uncertainty, the enemy of decision-making, is likely to freeze the most dynamic segments of the US economy. For China, state-directed policy guidance might temper the initial blow of a Trump policy shock. But the pressures of Trump's tariff escalation will undermine China's export-led growth model, which is especially problematic for economic growth, given the lingering weakness of China's domestic demand. The country's long-promised consumer-led rebalancing of the economy remains more of a slogan than an actual shift in the sources of Chinese growth - especially with a deficient social safety net that continues to encourage fear-driven precautionary saving. China's just-announced 30-point action plan to boost household demand draws much-needed attention to the seemingly chronic plight of the Chinese consumer. But it offers only modest support to an inadequate social safety net.



mentum in the early part of this year - exemplified by accelerated shipments of Chinese exports ahead of Trump's tariff hikes - I suspect that the downside risks will progressively build. That points to a fractional reduction of forecasts for global economic growth for 2025, with the slowdown becoming considerably more pronounced in 2026 and after. That could easily push an increasingly fragile world economy down to the 2.5% growth threshold, typically associated with outright global recession. Nor is this likely to be a standard shortfall of global growth. To the extent that the tariff war is aimed at promoting friendshoring and strengthening supply-chain resilience, the global economy's supply side is likely to come under significant strain. A new layer of adjustment costs is being imposed on a once-globalized world. Reshoring to higher-cost local producers not only takes considerable time but also erodes the efficiencies of production, assembly, and delivery that have underpinned worldwide disinflation over the past three decades. Nearly five years ago, in the depths of the CO-VID-19 shock, I warned that the onset of stagflation was only "a broken supply chain away." Subsequent experience and research have borne that out, confirming that the supply-chain disruptions during the pandemic and its immediate aftermath generated significant upward pressure on prices. A global trade conflict implies a similar dynamic. The higher costs associated with Trump's coming "reciprocal" escalation of multilateral tariffs, which are due to be announced on April 2, are especially problematic. In the face of a likely shortfall of economic growth, the added cost and price pressures are likely to tip the scales toward a global stagflation. The Trump shock, in short, is the functional equivalent of a full-blown crisis. It is likely to have a lasting impact on the US and Chinese economies, and the contagion is almost certain to spread throughout the world through cross-border trade and capital flows. Perhaps most importantly, this is a geostrategic crisis, reflecting a reversal of America's global leadership role. In the space of little more than two months, Trump has turned the world inside out. If my assessment of this shock is anywhere close to the mark, concerns over the global economic forecast seem almost trivial.

The Trump shock is likely not only to exacerbate the Sino-American conflict but also to weaken both countries' growth prospects significantly.

Don't count on other economies filling this void. Eventually, India might be able to take up some of the slack. But its relatively small share of world GDP – currently 8.5% (in purchasing-power-parity terms), compared to 34% for China and the US combined – means that that day is in the distant future.

The same is true of Europe. While the European Union's 14% share of world GDP is nearly double that of India, Europe remains saddled with anemic growth, compounded by mounting trade pressures associated with an escalating global tariff war.

If the apparent breakdown of the transatlantic

alliance has a silver lining, it is that the incentives for strategic cohesion should have an outsize impact on European defense spending. But that will also take time. Meanwhile, Europe will equally be exposed to the adverse effects on business and consumer expectations and decision-making, comparable to those afflicting the US.

What does all this mean for global economic prospects in the coming years? The current baseline expectation of around 3.3% world GDP growth for 2025-26, as per recent forecasts by the International Monetary Fund, is far too sanguine. Women who consider themselves detestable or meritless also prefer to keep quiet.

When women are timid or scared of expressing their feelings and emotions, they keep them inside as they feel the fear of rejection from others.

The act of self-silencing comes from the motivation of maintaining relationships and connections with others, since these are at the core of women's self-concept


**Religious OCD**—It Exists!

als who are tidy or organised. However, few are aware of the detrimental impact it can have on well-being, especially when intersecting with religious practices, as it did with mine. OCD is a common mental illness which affects people from all walks of life around the world.

Those who receive a diagnosis usually suffer debilitating symptoms ranging from intrusive thoughts to compulsive rituals, health anxiety and repetitive actions.

#### How does OCD affect religious acts?

I was diagnosed with OCD at the age of twelve and suffered daily with intrusive thoughts. As I began performing salah regularly, it became almost impossible to maintain the minimum requirements for Islamic obligations. My struggle with fasting started soon after I was diagnosed, although I didn't know that my mental health was the main factor. Fasting worsened my anxiety which in turn triggered my OCD and increased my compulsive rituals. I would furiously scrub my hands with soap, sobbing until they were red and raw.

The symptoms weren't limited to cleaning impulsively; I would sit for hours ruminating on pointless things and exaggerating scenarios in my head. My anger, anxiety and OCD became uncontrollable, and by the time Maghrib arrived, I could not sit with my family and eat. I felt it was better to stay alone in my room where my symptoms would only affect me until I calmed down.

Praying was similarly challenging as the rituals drained my energy. I was so weakened by hunger and compulsive behaviours that I just couldn't pray. Moreover, the khushu (focus) I once had during salah had vanished, reducing the

to manage praying while suffering from symptoms of OCD. Although OCD becomes a diagnosed mental disorder when it becomes overwhelming, you can still experience intrusive thoughts and impulsivity without the label

How often do we question a missed rakah, or let our subconscious wander? These distractions can make one doubt the validity of their prayer and induce a need to start the prayer from the beginning.

Wudhu is a necessary act that precedes salah; however, it becomes an exhausting task when paired with illness. Intrusive thoughts hinder the completion of wudhu, allowing people to doubt their actions, leading them to believe their ablution has been broken or wasn't performed correctly.

My intrusive thoughts appeared in the form of an alter ego, a harsh voice in the back of my head feeding me the worst negative affirmations. It told me I wasn't going to Jannah and that Allah & didn't love me anymore. Sometimes I was able to quieten it for a while and hear my own voice assure me that I was worthy, at other times it became an engorged darkness which suffocated me and told me that there was no hope and

that there never would be. My mind would convince me I wasn't 'clean' enough to stand before Allah ®. I firmly believed that my prayer wouldn't count if I had missed a spot, and the years I spent being scolded for not being able to perform wudhu correctly by my Islamic school teachers didn't help either. I also thought that I would be severely punished if I chose to ignore the 'missed' areas. Having Contamination OCD can come with sensory issues,

such as feeling like the skin on one arm doesn't 'match' the other. For example, I would wash my right arm, then my

distress, anxiety, and an unshakeable feeling of guilt and resentment. I started resenting mandatory acts, only to feel guilty for doing so.

As my disorder spun out of control, it became harder to retain the energy to fast and perform other duties in Ramadan. I felt the blessed month was not so blessed for me, and my guilt and resentment were exacerbated by a lack of understanding from other Muslims. As these thoughts, which can also be called waswas, worsened – my iman felt weakened, heightening negative feelings and convincing me I was a bad Muslim.

When it comes to mental health help from religious professionals, it's sad to say that there isn't much. Scholars are qualified to provide religious and spiritual advice, however, when it comes to religious, spiritual and mental health advice combined, they're suddenly at a loss. This is a recurring dilemma within the Muslim community, a problem which doesn't have a concrete solution, although this is improving gradually.

#### What is Waswas?

Waswas is an Arabic word meaning "whispers." Essentially, these are intrusive thoughts from the devil whispering into vour subconscious. Waswas is referenced in the hadith as negative thoughts from Shaytan, and not from oneself.

There are two types of waswas, the first one comes from the nafs (the self) and the other from the Shaytan. It is the second type which becomes overwhelming and obsessive, leading to extreme disruption in life and interfering with duties. Waswas plays on an individual's fears, exaggerating them, making you believe they have occurred, or will, occur.

It took a long time for me to

distinguish my own voice between the 'bad' one, and there are still days, even months, where I'm unable to tell the difference. What worked for me, was learning to sit with my thoughts, and come back to them once things seemed a little clearer. When an intrusive or obsessive thought enters my mind, I let it be, I wait, and I continue. This action, along with prescribed medication from my doctor, made my disorder manageable. When I started medication things started to get better, and slowly I began working on my spiritual relationship with Allah sagain.

#### The Qur'an and Hadith on OCD

Although the Qur'an itself does not explicitly mention OCD, there are many verses which touch on the struggles associated with it. Waswas is clearly written in Surah An-Nas.

'Say, (O Prophet) "I seek refuge in the Lord of humankind, the Master of humankind, the God of humankind, from the evil of the lurking whispererheld accountable and Allah 🎕 will forgive us. He 🛎 said, "Allah forgives my followers those (evil deeds) their souls may whisper or suggest to them as long as they do not act (on it) or speak." (Bukhari)

## **Trump Optimistic About** US-India Trade Talks, Calls Modi 'Smart Man'

**YORK/WASHINGTON:** NEW President Donald Trump has described Prime Minister Narendra Modi as a "very smart man" and his "great friend" while emphasising that tariff talks between the US and India would "work out very well".

The remarks assume significance as they came the same day Foreign Secretary Vikram Misri spoke with US Deputy Secretary of State Christopher Landau to discuss bilateral trade, including the reduction of barriers to achieve a balanced trade relationship.

"Prime Minister Modi was here just recently and we have always been very good friends," the US president said in the White House on Friday.

The remarks came days before Trump's reciprocal tariffs on the United States' trade partners kick in on April 2. "India is one of the highest

tariffing nations in the world.... it's brutal, it's brutal. They're very smart. He (Modi) is a very smart man and a great friend of mine. We had very good talks. I think it's going to work out very well between India and our country," Trump said.

"And I want to say you have a great prime minister," he said. During their conversation, Misri and Landau "touched on the growing bilateral trade, defence and technology cooperation, and issues relating to mobility and migration", the

Ministry of External Affairs (MEA) said in New Delhi. US State Department Spokesperson Tammy Bruce said the two officials discussed "ongoing efforts to reduce barriers to achieve a fair and balanced bilateral trade relationship" and strengthen collaboration in defence and technology."

US Assistant Trade Representative Brendan Lynch is currently in India and holding talks with his Indian interlocutors on firming up a bilateral trade agreement (BTA).

Prime Minister Modi visited Washington DC in February and held bilateral discussions with Trump. The visit came less than a month after Trump was sworn in as US President for a second term. During Prime Minister Modi's visit to the US last month, both sides announced plans to negotiate a mutually beneficial, multi-sector BTA. In the past, Trump called India

a "tariff king" and a "big abuser".

### **India's Solar PV Module Manufacturing Capacity To** Reach 125 GW By 2030: Joshi

NAVSARI- India's solar PV module manufacturing capacity will increase to 125 gigawatt (GW) by 2030 from the current 80 GW and its installed solar cell manufacturing capacity will soon touch 40 GW from 25 GW at present, Union Minister of New and Renewable Energy Pralhad Joshi said in Gujarat's Navsari district on Saturday. In 2014, solar PV module manufacturing was nearly absent in the country, he said after inaugurating a state-of-the-art 5.4 GW solar cell manufacturing facility of Waaree Energies Limited at Degam here. "Today, companies like Waaree are producing 80 GW solar PV modules. By 2030, our total solar PV manufacturing capacity will be 125 GW. Similarly, solar cell manufacturing was nil in 2014. But today we are manufacturing 25 GW, and very soon we will reach a target of 40 GW. We are moving ahead with the thinking of integrated solar, right

## **RBI Allows Banks To Hike ATM** Charges To ₹23/Withdrawal Beyond **Free Monthly Usage From May 1**

MUMBAI- The Reserve Bank of India on Friday permitted banks to increase charges on ATM cash withdrawals beyond the mandatory free monthly usage by Rs 2 to Rs 23 per transaction from May 1. Customers are eligible for

five free transactions (inclusive of financial and non- financial transactions) every month from their own bank Automated Teller Machines (ATMs). They are also eligible for

free transactions (inclusive of financial and non-financial transactions) from other bank ATMs -- three transactions in metro centres and five in non-metro centres. "Beyond the free transac-

tions, a customer may be charged a maximum fee of Rs 23 per transaction. This shall be effective from May 1, 2025," the RBI said in a circular. Currently, banks are al-

lowed to charge Rs 21 per transaction, after a customer exhausts the free transaction limit The RBI further said the

NEW DELHI- Flying out of the Delhi airport will become expensive for international pas-sengers from April 16, with regulator AERA approving higher and variable user development fees for economy and business class travellers.

Taking into consideration that 80 per cent of the traffic at the airport is domestic, AERA has decided to leave the User Development Fee (UDF) for domestic passengers unchanged at Rs 129 for the fourth control period.

Currently, the UDF is uni-form for both domestic and international passengers. The domestic UDF for embarking passengers is Rs 129 and for disembarking passengers is Rs 56.

Besides, the landing charges will be different for wide-body and narrow-body planes on both domestic and international segments.

With the revision, the UDF for embarking economy class international passengers will jump 404 per cent and in the case of business class passen-gers, the increase will be 528 per cent.

Under the revised tariff regime, international passengers flying economy class from the airport will have to pay a UDF of Rs 650 and for those landing here, the rate will be Rs 275.

In the case of international business class passengers, the UDF will be Rs 810 for embarking and Rs 345 for disembarking passengers, respectively, the Airports Economic Regulatory Authority (AERA) said in a release on Friday.

#### **'Office Supply Down 1% Across Top 7 Cities In Jan-Mar Despite Rise In Demand'**

New supply of office space declined 1 per cent in the January-March period to 99 lakh sq ft across seven major cities despite high demand, according to Colliers India.

The new supply of office space stood at 100 lakh (10 million) sq ft in the year-ago period.

As per the data, the new supply in Bengaluru declined 16 per cent in January-March to 37 lakh sq ft from 44 lakh sq ft in the year-ago period.

Chennai saw a decline of 33 per cent to 2 lakh sq ft from 3 lakh sq ft.

Delhi-NCR saw a more than five-fold jump in new supply to 27 lakh sq ft from 5 lakh sq ft.

Hyderabad witnessed a 88 per cent decline in new supply to 3 lakh sq ft from 26 lakh sq ft.

In Kolkata, new office supply dipped 50 per cent to 1 lakh sq ft from 2 lakh sq ft.

New supply of office space in Mumbai declined 60 per cent to 4 lakh sq ft from 10 lakh sq ft.

In Pune, the new supply of office space jumped 2.5 times to 25 lakh sq ft in January-March this year from 10 lakh sq ft in the corresponding period of the preceding year.

During the first quarter of the 2025 calendar year, Colliers data showed that the gross leasing of office space rose 15 per cent to 159 lakh sq ft across these seven cities from 138 lakh sq ft in the year-ago period. (PTI)

#### **China, Bangladesh Sign Nine Agreements After Key Meeting Between Xi, Yunus**

China and Bangladesh on Friday signed nine agreements after Muhammad Yunus' meeting with President Xi Jinping during which the Bangladesh Chief Adviser highlighted student protests that led to regime change in Dhaka and urged Beijing to play a "greater role" in establishing peace and stability.

Additionally, Bangladesh secured a commitment of USD 2.1 billion in investments, loans and grants from the Chinese government and its companies, Bangladesh's official news agency BSS reported.

Bangladesh welcomed Chinese companies to participate in the Teesta River Comprehensive Management and Restoration Project (TRCMRP), according to a joint statement issued after the meeting between Yunus and Xi.

The previous Hasina government wanted India to do the Teesta river basin project.

Bangladesh welcomed Chinese companies to also participate in the Mongla Port Facilities Modernisation and Expansion Project, the joint statement said.

After his talks with Xi, the two countries signed nine agreements enhancing economic and technical cooperation between the two governments and cooperation in the areas of development, translation and publication of classical literary work, exchange and cooperation on cultural heritage, news exchange and media, and health sector, state-run news agency Bangladesh Sangbad Sangstha (BSS) said. (PTI)

#### **Infra Sectors Growth Slips To** 5-Month Low Of 2.9% In Feb

The output of eight key infrastructure sectors slowed down to a five-month low of 2.9 per cent in February, as against 7.1 per cent growth registered a year ago, according to official data released on Friday.

On a monthly basis, the production growth of the core sectors was lower than the 5.1 per cent expansion recorded in January. The previous low level of growth at 2.4 per cent was recorded in September 2024. In February, production of crude oil and natural gas recorded a negative growth.

The production growth of coal, refinery products, steel and electricity moderated to 1.7 per cent, 0.8 per cent, 5.6 per cent, and 2.8 per cent, respectively, against 11.6 per cent, 2.6 per cent, 9.4 per cent and 7.6 per cent in February last year. However, fertiliser and cement output rose to 10.2 per cent and 10.5 per cent, respectively, during the month under review.

The growth of core sectors -- coal, crude oil, natural gas, refinery products, fertiliser, steel, cement and electricity -- was 4.4 per cent during April-February this fiscal. It was 7.8 per cent in the same period last fiscal.

The eight core sectors contribute 40.27 per cent to the Index of Industrial Production (IIP), which measures overall industrial growth.

Aditi Nayar, Chief Economist, Head - Research & Outreach, ICRA Limited said, "The core sector growth moderated to a five-month low of 2.9 per cent in February 2025 from 5.1 per cent in January 2025, although this was partly on account of the leap year-related high base. (PTI)

#### AI Express Eyes 30 Mn Passengers **Next Fiscal, More Partnerships**

Seeking to consolidate its position in the high growth low-cost segment, Air India Express aims to carry 30 million passengers in the next fiscal year, plans to have more virtual interline partnerships and offer only economy class seats in all its planes after cabin standardisation.

The Tata Group-owned airline, which currently has a fleet of 104 planes and over 485 daily flights, is focused on deepening its network and expects to add 15 more aircraft in the next financial year. These will include nine white-tail Boeing 737s.

Elaborating on the airline's strategy, its Managing Director Aloke Singh on Friday said the airline has seen significant growth and has carried more than 20 million passengers this fiscal year. The count is projected to rise to 30 million in 2025-26.

The airline's overall weekly departures have increased 50 per cent to 2,727 in the 2025 summer schedule from 1,825 in the year-ago period. The number of destinations will be increased to 54.

The summer schedule of 2025 will be from March 29 to October 25 next year. While the number of routes has grown significantly, the number of stations has not grown as much. It is the broad strategy that let's look at depth before breadth, Singh said at a briefing.

Among other initiatives, Singh said the airline will look to have more virtual interline partnerships with foreign low-cost carriers and there are six such partnerships at present. (PTI)

#### Multi-Crore Chit Fund Scam:

## JKP Registers Case Against **Actor Shreyas Talpade**

SRINAGAR: The Jammu and Kashmir police have registered a fraud case against 15 individuals, including Bollywood actor Shreyas Talpade, for allegedly duping people out of crores under the guise of a chit fund scheme. According to reports, the accused were running a company named 'The Loni Urban Multistate Credit and Thrift Cooperative Society Limited,' which promised villagers lucrative returns on their investments. Agents of the company allegedly lured hundreds of people by assuring them that their money would double in a short span. However, after collecting crores from unsuspecting villagers, the company reportedly shut down operations and fled the district. The fraudulent scheme had been operational in Mahoba for the past ten years before coming under legal scrutiny.Authorities have registered a case at the Srinagar police station, and an investigation is underway to uncover the full extent of the scam. Further action will be taken based on the findings of the probe. This is not the first time Shreyas Talpade has been accused of fraud. Last month, an FIR was registered against him and actor Alok Nath in Uttar Pradesh for allegedly duping investors of over Rs. 9 crores. Alok Nath and Shreyas Talpade, along with five members of a credit cooperative society, were booked in a fraud case at Gomti Nagar Police Station in Lucknow, Uttar Pradesh.Previously,

they, along with 11 others, were implicated in a similar case in Sonipat, Haryana, connected to a multi-level marketing fraud. The controversy centers around a cooperative society that had been soliciting investments for six years, assuring high returns. Reports suggest that Alok Nath and Shreyas Talpade had promoted the investment schemes of the society, lending credibility to the fraudulent operation. Meanwhile, Talpade's team has issued an official statement in the light of him being named in a multi-crore chit fund scam.

They have rubbished the reports of the actor being named in the scam, and have termed the actor's involvement in fraud or misconduct as completely false and baseless. The actor's team said in the statement, "It is deeply unfortunate that in today's world, a person's hardearned reputation appears to be vulnerable to undue tarnishment by unfounded rumours. Recent reports alleging Mr. Shreyas Talpade's involvement in fraud or misconduct are completely false, baseless and devoid of any merit whatsoever. As a public figure, Mr. Talpade, like many other celebrities, is frequently invited to various corporate and annual events, which he attends as and when possible".

The team said that beyond such appearances, the actor has no association whatsoever with the company in question."Needless to say, Mr. Talpade has no nexus whatsoever with any fraudulent or unlawful acts as are being al-leged and/or circulated. We urge everyone to verify facts before spreading misinformation and request that Mr. Talpade's name be kept away from these baseless rumors. Mr. Talpade is a law abiding citizen who remains committed to maintaining the highest standards of integrity, honesty and professionalism in all of his endeavoursm," he added.

### **Mughal Road Closure Continues To Trouble Pir Panchal Residents**

SRINAGAR: The prolonged closure of the historic Mughal Road has left residents on both sides struggling with travel difficulties, impacting daily life, businesses, and education.

### LMD Jammu Fines E-Commerce **Firm For Misleading Packaging**

SRINAGAR: The Legal Metrology Enforcement Unit Jammu has imposed a penalty of ₹1.80 lakh on a West Bengal-based ecommerce platform for supplying a customer with less than the declared quantity of a cosmetic healthcare product.

The action followed a written complaint received by the Controller, alleging that the prepackaged commodity delivered through the platform contained only 50% of the declared net quantity. A subsequent inquiry and quantity measurement test confirmed this discrepancy, which constituted a serious violation of consumer rights and contravened key provisions of the Legal Metrology Act, 2009, and the Legal Metrology (Pack-aged Commodities) Rules, 2011. Upon receiving a notice from the department, the defaulting firm refunded the entire amount to the aggrieved customer. In response, the com-pany admitted its violation and applied for departmental compounding—a legal remedy under the Act. The case was subsequently compounded, and a penalty of ₹1,80,000 was imposed, with the firm assuring immediate compliance with packaging regulations and net quantity corrections. In an official statement, Con-

troller Legal Metrology J&K Anuradha Gupta reaffirmed the department's commitment to consumer protection and fair-trade practices, especially within the rapidly growing ecommerce sector.

She emphasized that the department would continue its rigorous inspections and enforcement actions to en-

sure compliance with regulatory norms. The Controller also stressed the importance of verifiable product information and accurate net content declarations, particularly for prepackaged commodities sold online, to safeguard consumers from deception and misleading sales practices.

According to the Legal Metrology (Packaged Commodities) Rules, 2011, manufacturers, packers, importers, suppliers, and sellers are legally obligated to ensure consumers receive the precise quantity they purchase. E-commerce platforms must also provide clear and accurate online information, including details of the manufacturer/packer/importer, country of origin (for imported products), generic name of the commodity, Maximum Retail Price (MRP), net quantity, Unit Sale Price (USP), and customer care details (name, address, contact number, and email of a person or office).These declarations are crucial in preventing fraud and ensuring transparency in online transactions. The Legal Metrology Depart-

ment has urged consumers to remain vigilant while making purchases and to report any discrepancies or grievances to the Legal Metrology Department, J&K, for redressal.

### J&K Waqf Employees Get 20% **Salary Hike**

SONAMARG: The scenic hill station of Sonamarg in central Kashmir's Ganderbal district has witnessed a significant surge in tourist footfall in the first two months of 2025. From January 1 to March 10, a total of 1,33,854 tourists visited the snow-laden valley, marking a positive trend in the region's tourism sector.

Official data reveals that January alone recorded 55,934 visitors, including 1,114 foreign and an equal number of domestic tourists. February saw a steady increase, with 57,186 arrivals, among them 2,019 foreign travellers and 1,565 locals. The first ten days of March added another 20,734 visitors to the tally.



#### AIFF Draft Constitution To Include 5 **Players In Executive Committee**

The draft constitution of the All India Football Federation (AIFF) has proposed several radical changes, including the provision for inclusion of at least five former national players in the 14-member Executive Committee and removal of the office bearers through a no-confidence motion.

The draft constitution, prepared by retired Justice L Nageswara Rao has been submitted to the Supreme Court. An SC bench comprising Justices PS Narasimha and Joymalya Bagchi on March 25 commenced final hearing on pleas related to the finalisation of the AIFF Constitution.

The matter is likely to be taken up by the bench for further arguments and final disposal on April 2. The draft constitution says that the current elected

members of the Executive Committee (after polls in September 2022), "shall stay in power and serve their permitted full term(s) of four years, subsequent to which fresh elections shall be conducted in the manner prescribed in this amended Constitution."

#### **Tamim Igbal Discharged After Heart Attack, Thanks Fans For Prayers**

Former Bangladesh captain Tamim Iqbal expressed his gratitude on Facebook after being discharged from the hospital following a heart attack on Monday. The 36-year-old who retired from international

'By all your prayers, I am at home now,' said Tamim in a message posted in Bangla on his Facebook page.

Brazil have sacked head coach Dorival Jr, the coun-try's football confederation (CBF) said on Friday, after the five-times world champions were thrashed 4-1 away to fierce rivals Argentina in a humiliating qualifying loss in Buenos Aires. However, he never seemed to get to grips with the national team job and failed to earn the trust of Brazil's demanding fans after winning only seven of his 16 games in charge.

## All India Players Who Competed In Last 3 ICC Events, Deserve Respect: Rohit

NEW DELHI: Rohit Sharma says the Indian team has endured cricket's vicissitudes in the last nine months but it waged a collective battle to achieve success and every member of the side that competed in the last three ICC tournaments deserves "respect".

In their last three ICC limitedovers tournaments. India have lost only one out of 24 matches, with the defeat coming against Australia in the 2023 ODI World Cup final in Ahmedabad.

The India team recently won the ICC Champions Trophy and the T20 World Cup in Barbados last year.

In between India lost a rare home Test series against New Zealand and away in Australia.

Reflecting on his remarkable tenure as India captain, Rohit said: "Look at what this team has achieved in this big three tournaments. After playing the tournament like that and getting defeated only once and that too in a final (2023 ODI World Cup)."

'But imagine if we had won that as well to go undefeated in three ICC tournaments is

crazy, never heard of but I will take this, 23 wins in 24 games is unheard of. It looks very nice from the outside but the team has gone through a lot of ups and downs.

"We had some really tough times as well but that is when you got to celebrate. If you do things like this you got to celebrate. I feel all the people who played these three tournaments, they deserve respect," Rohit said in a video posted by Mumbai Indians on their 'X' page. Interestingly, Rohit's inter-

view has come on the day when BCCI top brass was due to set the future roadmap for the side but somehow the meeting has been postponed.

"It's for any sportsman who are going through something and there is a low, they want to fight back, bounce back and try and make it whatever is front of you into a high.

"And thereafter we had a little bit of low where we lost a home series and we didn't play well in Australia and then came the Champions Trophy. These nine months are perfect example of how life is, it is always going to



be up and down."

Rohit said the journey to the glory and the change in mindset started in 2022 after India crashed out in the semifinal of the T20 World Cup in Australia.

"But thereafter we made a lot of things clear with the players that this is what we expect from

you and this how we want you to play. So there was lot of clarity, a lot of conversations with the players to perform.

"There needs to be a freedom amongst the group so that they go out and play without any fear. There were few lows, a few series that we lost but we never panicked and we never went away from our thought process.

"When you are building a squad the first thing that you need to put in front of you is what does the team want? Where did we lack in the previous series, previous tournaments? Why did we not get

#### the results?"

#### Sportsman Needs To Have Grit **And Determination**

Reflecting on a forgettable 2024 IPL, where Mumbai In-dians finished last, Rohit said every sportsman needs to have determination to bounce back. He said he was focussed to end his career in the shortest format on a high, which he did after the T20 World Cup triumph.

"...that is where as a sportsman you need to show a little bit of grit, determination to comeback from the low. It (2024 IPL) was a low for the team and I think we didn't play our best cricket also and there were so many things after IPL to look forward to.

#### Faced Many Ups & Downs In Career

"My career for 17-18 years has always been up and down, which has taught me so many things in life, and these nine months were no different," he said.

Talking about his journey with MI, the dashing opener said: "Obviously, since the time I started till now lot of things have changed because I used to bat middle-order then, now I am opening the batting. I was captain then (MI), now I am not the captain. There were a few teammates with whom I won championships, they are not there, they are in the coaching role now.

"So, the roles have changed, a lot of things have changed but the mindset has not changed. What I want to do for this team has not changed, just to go out there and win games and trophies, that is what MI is known for all these years."

## 113th EPFO Executive Committee meeting reviews progress in implementation of claim settlement through UPI, CITES 2.01 system upgrades and processing of applications for Pension on Higher Wages

Srinagar: The 113th meeting of Executive Committee (EC) of Central Board of Trustees (CBT), EPF was held in Srinagar, Jammu & Kashmir on 28th March, 2025. The meeting was chaired by Smt. Sumita Dawra, Secretary, Ministry of Labour and Employment and attended by Shri Ramesh Krishnamurthi, Central Provident Fund Commissioner, EPFO. Other senior officers of Ministry of Labour & Employment and the EPFO as well as representatives of employers and employees were also present in the meeting. Among the key discussions were new initiatives to streamline EPFO's processes and enhance its delivery systems. Following agenda items were

the Seamless PF claim settlement via UPI: The Executive Committee reviewed the progting. ress of the digital initiative of EPFO to streamline claim settlements by immediate credit to bank account through the UPI ems. platform. Development of API and system integration with SBI and NPCI is being done by CDAC (technology partner) to ensure a smooth rollout in alignment with EPFO's IT modernization project, CITES 2.01. This initiative underscores EPFO's commitment to enhance ease of living for its members.

Proposal to increase the auto claim limit to 5 lakhs The EC welcomed and appreciated the proposal as it will immensely help in ease of living of EPF subscribers. IT Infrastructure and CITES 2.01 Implementation: EPFO highlighted completion of hardware upgrades and progress in Consolidation of decentralized databases. Modules for User Management, Centralized Payments, and Re-engineered ECR are undergoing rigorous testing,

ensuring seamless deployment in the coming months. Despite multiple challenges, EPFO assured stakeholders of its commitment to completion of the roll-out within the next two months.

Processing of Pension on Higher Wages gains momentum: The EC appreciated the notable progress in the processing of PoHW cases, with total application processed increased by 22.8% as compared to last month. Furthermore, 3,26,152 demand letters were issued which shows a substantial increase of 29.5% as compared to last month figures. These achievements highlight EPFO's commitment to completing the task as per the directions of the Hon'ble Supreme Court.

#### **'BJP Will Be In Power**

"It will come. It was the decision of the Constituent Assembly (to introduce UCC). The Congress might have forgotten it but we have not. We said we would abrogate Article 370. We have done that. We said we would construct a Ram temple at Ayodhya. We have done that too. Now UCC remains. We will do that too," he said.

Shah said the Uttarakhand government has already enacted the law for implementation of the UCC in the state.

"One by one, all the BJP-ruled state governments will introduce it. Gujarat has already set up a committee for it. It is an ongoing process. All states will bring it as per their convenience," he said.

Asked about the alleged discovery of a huge amount of cash at the Delhi residence of High Court judge Yashwant Varma, the home minister said the Chief Justice of India has taken cognisance of the issue and ordered an inquiry (through a committee of three high court judges).

"We are cooperating with it. We should wait for the outcome of the committee constituted by the chief justice," he said.

The Supreme Court on Friday rejected a PIL seeking Delhi Police to register an FIR over the alleged discovery of burnt wads of cash from Justice Varma's residence.

Shah said, "When no FIR can be registered, how can a seizure be carried out? The FIR can only be registered with the Chief Justice of India's permission." Asked whether the RSS interferes in the functioning of the Modi government, the home minister said there has been no interference from the Sangh, the BJP's ideological fountainhead.

"The RSS has been preparing patriots for the last 100 years. I have learnt from the RSS how to keep patriotism at centre while keeping many dimensions together. There is no question of interference," he said. Asked about the prevailing internal

security situation, Shah said as union home minister he got three problems as legacy issues: Naxal violence, terrorism in Jammu and Kashmir and insurgency in the Northeast.

"In last 10 years, 16,000 youths have surrendered in these three theatres. As the home minister of the country, it is my duty to bring peace in all these places. It is the priority of the prime minister and naturally it is my priority too. Because of the problems, development stopped in these places," he said.

Asked about the government's stand on the Places of Worship (Special Provisions) Act, 1991, the home minister said he did not want to comment on it as it is subjudice.

"I am sure the Supreme Court will deliver an appropriate order on it. We will definitely obey the court order," he said.

The Places of Worship (Special Provisions) Act, 1991, prohibits the conversion of any place of worship and aims to maintain the religious character of such places as it existed on August 15, 1947, with the exception of the Ram Janmabhoomi-Babri Masiid case.

The Supreme Court is currently dealing with multiple petitions challenging the Act.

Asked why the government has not yet filed an affidavit in the court on the subject, Shah said, "We will certainly file an affidavit".

The police spokesperson said during the procession, a large crowd gathered

under the directions of the organisers and raised 'objectionable' slogans.

By sloganeering, the organisers allegedly tried to create a law-and-order situation and blocked the Sonpah-Beerwah road, thereby causing obstructions to the public, he added. The spokesperson said police took

cognisance of the incident and registered a case under sections 126(2) and 189(6) of the Bharatiya Nyaya Sanhita at the Beerwah police station.

Further investigation is underway and necessary legal action will be taken against those involved, he said.

Police have urged citizens to maintain peace and refrain from activities that could disturb public order.

#### 4 Slain Cops

policemen were retrieved from the encounter site on Friday evening, Jagbir Singh's body was recovered early Saturday, officials said.

Amidst surcharged atmosphere and emotional scenes, thousands of people attended the last rites, raising slogans in praise of the slain policemen. Anti-Pakistan slogans were also chanted during the processions, they added.

Senior BJP leader and MP Jugal Kishore Sharma, along with former J&K BJP president Ravinder Raina, attended the funeral of Constable Ahmad, who is survived by his wife, four-year-old daughter, and elderly parents.

Deputy Inspector General of Police (DIG) (Udhampur-Reasi range) Rayees Mohammad Bhat joined the 'Nimaz-e-Jinazah' (prayer before burial) and led the wreath-laying ceremony.

"This saga of sacrifice has been going on for a very long time. We have lost many diamonds in this fight against terrorism and we are proud of the sacrifices," the officer said.

He said the fight against terrorism would continue till the Pakistansponsored menace is completely defeated.

"This is the message of our bravehearts and it is our responsibility to take this fight to the conclusion," the DIG said.

MP Jugal Kishore Sharma lauded the sacrifices of the policemen, saying that Pakistan was pushing terrorists into J&K to divert attention from its internal crises.

"The backbone of the terrorism is broken and it is taking its last breath. It will be uprooted soon," Sharma said.

Bodies of Chib and Jaswant Singh were also cremated with full honours, with mourners condemning Pakistan and hailing the bravery of the fallen personnel.

The villagers remembered the slain policemen as kind-hearted individuals, vowing that their sacrifices would not go in vain.

Jagbir Singh's body was brought to the police headquarters in Jammu, where former chief minister Omar Abdullah led the wreath-laying ceremony before it was handed over to his family. Singh, who had joined the police in 1997, is survived by his wife, daughter, and son.

J&K minister Satish Sharma, who attended Singh's funeral, expressed grief over the loss and called for a strong response against Pakistan.

"I want to urge Prime Minister Narendra Modi, Home Minister Amit Shah, Lieutenant Governor Manoj Sinha and J&K DGP Nalin Prabhat that the time has come when the enemy nation is strongly dealt with and given a befitting reply," he said.

He said the policemen fought bravely against the terrorists and eliminated two of them, thus frustrating their plan to cause more damage.

Congress leader, former minister Choudhary Lal Singh also attended the funeral of the policemen.

> Kashmir. Abdullah was talking to reporters after visiting the bereaved families

of four police personnel in Kathua, Reasi and Jammu districts. The cops were killed in a gunfight with infiltrating terrorists in the Safiyan forest of Kathua district on Thursday.

Two Pakistani terrorists, believed to be affiliated with the proscribed Jaishe-Mohammad, were also killed in the encounter. A massive search operation is underway to track and neutralise other members of the group.

"Visited the families of our bravehearts -- Balvinder Singh, Tariq Ahmad, Jaswant Singh and Jagbir Singh -- who laid down their lives in the line of duty during the Kathua encounter. Their sacrifice is etched in our hearts forever. We stand with their families in this hour of grief," according to a post on the X handle of the Chief Minister's Office.

Omar Abdullah on Saturday led the wreath laying ceremony of head constable Jagbir Singh, incharge of police post Safiyan, at police headquarters Gulshan Ground here.

Deputy Chief Minister Surinder Choudhary, minister Satish Sharma, Director General of Police Nalin Prabhat and other senior civil, police, CRPF, BSF and Army officers also laid wreaths at the coffin containing the remains of the fallen policeman.

Talking to reporters after visiting the home of selection grade constable Tariq Ahmad, the chief minister said encounters and terror attacks were nothing new and had been happening in the Jammu region for the past three to four years.

"Even in Reasi district, there was an attack on a passenger bus (ferrying pilgrims last year). There were attacks in Jammu city. The reason behind this is that when the Chinese army made an incursion into Ladakh, we needed an army to counter them," Abdullah said.

"We could not remove the army from the valley and so the troops stationed in Jammu were sent to Ladakh, as a result of which there was a shortage somewhere. Now, that shortage is being slowly overcome," he added.

Assuring that the compensation cases of the fallen policemen would be taken up by the home department when offices reopened after Eid next week, he said "we should try not to have such incidents".

"We have to control militancy in such a way that the martyrdom of people is stopped forever," Abdullah said.

He added such incidents had happened in the past as well and "I am of the opinion, although I do not have any intelligence reports, that it was a new group (of terrorists) who had crossed into this side".

The chief minister said it was good fortune that the terrorists were caught by the police.

"If they were not caught by the police, then I do not know what they would have done by moving deep inside. Our four brave police officers sacrificed their lives but I think that many innocent lives have been saved by their timely action," Abdullah said. Asked if the situation in the valley

had improved over the years and terrorists shifted their base to the Jammu region, Abdullah refused to give a direct answer and said he would be accused of indulging in politics at a time of grief.

"We have just left a house where there is mourning. I have been to four places today. I have to express my condolences to each family member. Obviously, we have to take some more steps to improve the (security) situation," the chief minister said.




