LG Sacks 2 **Employees Over Terror Links**

Over 70 Dismissed So Far Under LG's Zero-Tolerance Policy

Srinagar: In a move reflecting the administration's hardline stance against ter-rorism, Jammu and Kashmir Lieutenant Governor Manoj Sinha on Thursday dismissed two government employees for alleged involvement in terrorist activities. The action was taken under Article 311(2)(c) of the Constitution, which allows termination without departmental inquiry in matters of national security.

The dismissed individuals Ishtiyak clude Ahmad Malik, a Senior Assistant in the Public Works Department, and Basharat Ahmad Mir, an Assistant Wireless Operator in J&K Police. Officials said both had "deep-rooted" links to terror networks and posed "serious threats" to national security.

Malik, appointed in 2000, was accused of working with proscribed terror outfit Hizbul Mujahideen and Jamaat-e-Islami. Sources said he not only facilitated the creation of an Over Ground Worker (OGW) network but also provided food, shelter,


and logistical support to militants. Investigations revealed his role in organizing violent mobs during the 2016 unrest after the killing of Hizbul commander Burhan Wani.

Malik's name emerged during the interrogation of Hizb activist Mohammad Ishaq, arrested in May 2022. The two were later charge-sheeted under the Unlawful Activities (Prevention) Act (UAPA).

Basharat Ahmad Mir, who held sensitive posts in the I&K Police wireless wing, was reportedly in contact with a Pakistani intelligence operative and was sharing found classified informa-

tion. Sources said his dismissal was necessary to prevent any compromise to the integrity and sovereignty of India.

This brings the total number of government employees dismissed over terror links to more than 70 under LG Manoj Sinha's tenure. The LG's administration has adopted a comprehensive approach to dismantle the terror ecosystem, combining security crackdowns with developmental initiatives aimed | More on P6

No One Will Be Allowed To Spread Terror In J&K: Shah Says Meeting With Omar 'Cordial', Focused On Governance & Security

Srinagar: Union Home Minister Amit Shah has asserted that any attempt to spread terror in Jammu and Kashmir will be dealt with firmly, reaffirming the Centre's uncompromising stance on national security.

Speaking to a national news channel, Shah said, "We will not let anyone conspire to spread terror in J&K. If anyone tries such things, they will be punished.'

He emphasized that national



security remains a top priority for the government, adding, "We will not compromise, nor will

we allow anyone else to do it." Referring to his recent

three-day visit to Jammu and Kashmir, the Home Minister described his meeting with former Chief Minister Omar Abdullah as "cordial", with discussions centred on development and governance. "We have always supported regional governments equally, without any bias," Shah stated.

Reiterating the Centre's commitment to working with the elected leadership of Jammu and Kashmir, Shah said collaborative

governance was essential for progress in the region.

Commenting on the recent terror incident in Kathua, Shah said infiltration attempts continue to be backed by Pakistan. "It is certainly not Russia. This has been happening for years. But both our soldiers and the government are alert. We will punish them if they try," he said.

KPs Demand Waqf Like Act To Protect Temples

Srinagar: As the Waqf Amendment Act sparks nadebate, Kashmiri Pandits are calling for a similar law to protect Hindu religious places in Jammu and Kashmir, The Kashmiri Pandit Sangharsh Samiti (KPSS) has warned that it will approach the Supreme Court if their demands are not met.

The KPSS claims that more than 1,400 temple properties across the Kashmir Valley have been encroached upon. The group says this would not have been possible without the involvement of government officials and some politicians.

Sanjay Tickoo, president of KPSS, said, "Forged sale deeds have been made, and such encroachments could not happen without administrative support. We now demand the formation of a Sanatan Board to manage Hindu temples, just like the Waqf Board does for Muslim shrines. Both boards should work together to promote communal harmony."

He added that KPSS would wait until June before moving to the Supreme Court if no action is taken. | More on P6

Udhampur Encounter Enters 2nd Day

Jammu: An anti-militancy op-eration in the dense Jofar forest area of Jammu and Kashmir's Udhampur district entered its second day on Thursday, with intermittent and then fresh intense gunfire reported between joint forces and suspected militants.

The gunfight, which began on Wednesday, resumed with renewed intensity late Thursday morning as security personnel, including the Army, J&K Police, and paramilitary troopers, tightened their cordon around a vast stretch of the forest.

According to official sources, the operation is taking place in a highly rugged and densely wooded terrain, which is making the search effort both slow and challenging. "The forest area is extremely tough to navigate. Visibility is poor, and there are multiple natural hideouts," said an officer on the ground.

Scientists Genetically Engineer Wolves With White Hair, Muscular Jaws Like The Extinct Dire Wolf

Three genetically engineered wolves that may resemble extinct dire wolves are trotting, sleeping and howling in an undisclosed secure location in the US, according to the company that aims to bring back lost species.

The wolf pups, which range in age from three to six months old, have long white hair, muscular jaws and already weigh in at around 80 pounds — on track to reach . 140 pounds at maturity, researchers at Colossal Biosciences reported Monday.

Dire wolves, which went extinct more than 10,000 years old, are much larger than gray wolves, their closest living relatives today. Independent scientists

said this latest effort doesn't mean dire wolves are coming back to North American grasslands any time soon. "All you can do now is

make something look su-perficially like something else"- not fully revive extinct species, said Vincent Lynch, a biologist at the University at Buffalo who was not involved in the research.

Colossal scientists learned about specific traits that dire wolves possessed by examining ancient DNA

from fossils. The researchers studied a 13,000 year-old dire wolf tooth unearthed in Ohio and a 72,000 year-old skull fragment found in Idaho, both part of natural his-

Then the scientists took blood cells from a living gray wolf and used CRISPR to genetically modify them in 20 different sites, said Colossal's chief scientist Beth Shapiro. They transferred that genetic material to an egg cell from a domestic dog. When ready, embryos were transferred to surrogates, also domestic dogs, and 62 days later the genetically engineered pups

were born. Colossal has previously

announced similar projects to genetically alter cells from living species to create animals resembling extinct woolly mammoths, dodos and others. Though the pups may

physically resemble young dire wolves, "what they will probably never learn is the finishing move of how to kill a giant elk or a big deer," because they won't have opportunities to watch and learn from wild dire wolf parents, said Colossal's chief animal care expert Matt James.

Colossal also reported

today that it had cloned four red wolves using blood drawn from wild wolves of the southeastern US's critically endangered red wolf population. The aim is to bring more genetic diversity into the small population of captive red wolves, which scientists are using to breed and help save the species.

This technology may have broader application for conservation of other species because it's less invasive than other techniques to clone animals, said Christopher Preston, a wildlife expert at the University of Montana who was not involved in the research. But it still requires a wild wolf to be sedated for a blood draw and that's no simple feat, he added.

Colossal CEO Ben Lamm said the team met with officials from the US Interior Department in late March about the project. Interior Secretary Doug Burgum praised the work on X on Monday as a "thrilling new era of scientific wonder" even as outside scientists said there are limitations to restoring the past.

"Whatever ecological function the dire wolf performed before it went extinct, it can't perform those functions" on today's existing landscapes, said Buffalo's Lynch.

ACB Arrests Girdawar, **Lumberdar With Rs 20,000 Bribe**

Srinagar: Anti-Corruption Bureau (ACB) on Thursday said to have trapped and arrested Girdawar of Chatabal and Lumberdar from Halqa Habakadal, Srinagar red-handed while demanding and accepting a bribe of Rs 20,000.

As per a statement issued to Kashmir Observer, a spokesman said that ACB received a written complaint alleging therein that Avaz Ahmad Hurra, Girdawar, Chatabal, Srinagar, who is holding additional charge of Patwari Halqa Habakadal and Halqa Shivpora is demanding Rs 50,000 as bribe in lieu of issuance of revenue extracts required for sale deed of an old house located at Mandir Bagh, Srinagar

"As per the complaint, the complainant was forced to pay Rs 30,000 a few days ago and remaining Rs 20,000 was asked to be paid today in order to receive the requisite documents. The bribe demand was communicated through Lamberdar (tout) Rafiq Ahmad who was acting in connivance with the Girdawar," the statement reads.

Unwilling to pay the bribe, the complainant approached ACB Srinagar and submitted a written complaint, requesting legal action against the accused pub-

Kashmiri's Wait To Visit Father's Grave Ends

AWASI (MUZAFFARABAD) - Raja Naseeruddin was just three when his father died in a traffic accident. On Friday, 59 years later, he saw his father's grave for the first time.

Naseeruddin was one of 19 Indian Kashmiris who travelled to Pakistan-controlled Kashmir by bus on Thursday, the first to run across the heavily fortified military line dividing Kashmir in nearly 60 years.

"How can I express myself? I simply don't know how," said a tearful Naseer after offering prayers at his father's simple grave in the mountain village of Lawasi. I don't remember my father, I was too young when he died." he said.' "Now, at least I feel relief to

have visited his grave. I want to come here again." Naseer's family, like so many others, was split apart by the Line of Control drawn across the scenic valleys of Kashmir.

After his father was killed in 1946 near Muzaffarabad his mother took him to live with relatives near Srinagar. A year later, with the armies of newly independent Pakistan and India were battling over Kashmir, Naseer was unable to return to his home Village — and so it was until this week.

"Returning to my land, I feel like a fish being thrown back into water." he said.

Lingering Stray Menace

he ongoing escalation in dog bite incidents across Kashmir is yet another grim reminder that the government has failed to check the dog population. Early this April, at least 44 dog bite cases were reported on a single from various districts, including Srinagar, Kupwara, Pulwama, and Narbal. Downtown Srinagar was the most affected, with over 20 people, including women and children, reportedly attacked by a rabid dog in the congested localities of Sakidafar and Nowpora. This may also be because the Srinagar cases are reported more than those from the other parts of the Valley.

So, the issue is no longer a minor public nuisance. The rising dog bites, together with growing canine population, are a serious public health concern demanding immediate government intervention.

The data speaks for itself: Jammu and Kashmir recorded over 51,000 dog bite cases in 2024, up from around 34,000 the previous year, and more than double the 22,000 reported in 2022. The menace seems to have only further grown this year. with 4,824 cases reported in January.. In Ladakh too, the numbers have nearly doubled since 2022. Thankfully, no rabies-related deaths have been reported in recent years, but there is every possibility that rising dog bites may lead to fatalities.

Hence we urgently require a pro-active government to tackle the crisis. We already have the Animal Birth Control (ABC) Programme, which is meant to sterilise and vaccinate stray canines. But its erratic and often tardy implementation has made it ineffective in checking dog numbers. Although the new ABC Rules of 2023 and the National Rabies Control Programme have provided a policy platform, these have not translated into visible relief on the ground so far.

Srinagar Municipal Corporation has also failed to check the dog overpopulation, despite taking some steps in this direction. Early this year, the corporation had decided to open its third dog sterilization centre in Chatterhama to enhance the ongoing sterilization to contain canine population. Although the city already has limited capacity sterilization centres at Shuhama and Tengpora, we need more such facilities to address the problem at hand. Srinagar alone has an estimated 60,000 to 70,000 stray dogs warranting more sterilization facilities like Chatterhama.

At the end of the day, authorities need to see whether the growing dog bites are a result of the lax implementation or it is because the scale of the problem has outgrown the existing means to address it. Canine overpopulation is a human-created problem and must be tackled with a humane but firm hand. Left unaddressed, it threatens not just the safety of people but also the credibility of institutions meant to protect them.

Waqf and the Wounds We Ignored

he recent Waqf Amendment Bill, passed with little public debate, is more than a piece of legislation. It feels like a quiet dismantling of a centuries-old legacy. For the Muslim community, Waqf is not just about land or assets. It is a sacred trust, a form of charity that lives beyond the donor, serving the poor, funding education, and sustaining places of worship.

This new law strengthens the state's powers to survey, take over, or repurpose Waqf land without prior consultation with the Waqf

Board. It raises a deeply troubling question: why is community-managed endowment being subjected to government overreach when similar safeguards exist for other religious institutions? Article 26 of our Constitution assures every religious group the right to manage its own affairs. Then why this selective intervention?

Yet, painful as it is, we must also introspect. The truth is, Muslims too have failed the Waqf system. We allowed political appointees, indifferent boards, and corrupt caretakers to

mismanage properties meant for the collective good. Many Waqf assets have been lost not just to external encroachment but to our own silence and complacency

I remember how a small Waqf clinic once gave my mother free medicine. How my early education was funded by the rent from a humble Waqf shop. These memories are not personal, they are shared by thousands. But the institutions that shaped them are now under threat,

not just by law, but by neglect. The Sachar Committee estimated Waqf land to be worth over Rs. 1.2 lakh crore. But instead of empowering the community to manage this wealth with transparency and professionalism, we are seeing more centralization, which risks further misuse.

We must speak up, not just to oppose the bill, but to reform our own systems. Waqf is not just law. It is life, faith, and trust. Let's defend it with dignity and rebuild it with integrity.

Kashmir's Private Schools Are Thriving But Teachers Are Starving

Long trapped in silence, Kashmir's private school teachers continue to face chronic exploitation and neglect in an issue the system refuses to fix.

n a country where government employment opportunities are scarce and cannot possibly accommodate the flood of qualified youth, the private sector becomes the de facto employment avenue. Among private employers, private educational institutions—particularly schools-form a significant share. Yet, this sector, which claims to be the torchbearer of enlightenment and progress, is riddled with systemic exploitation, especially when it comes to the treatment of its most vital asset: the teacher.

Nowhere is this more evident than in the private schools of Jammu and Kashmir, where thousands of educated and competent individuals are employed under conditions that barely scratch the surface of decency. These schools, which advertise aggressively for the most qualified candidates, demanding advanced degrees and relevant teaching experience, fail spectacularly when it comes to offering fair compensation. The term "salary negotiable"-a common euphemism in recruitment notices—is merely a smokescreen that hides widespread underpayment and financial insecurity.

Prospective teachers are routinely subjected to extended "trial periods," during which they are paid paltry sums-or in some cases, nothing at all. Their fate hangs on the whims of school managements who offer neither job security nor transparency. This exploitative model forces many teachers to work for salaries as low as Rs 3,000-5,000 per month-less than what an unskilled labourer might earn for basic manual work. Skilled labourers with equipment often take home three to four times that amount. This stark wage disparity is an insult to the teaching

Let us be clear: these teachers are not mere placeholders in classrooms. They are qualified professionals, expected to remain updated with the latest pedagogical practices, adopt new technologies, and cater to a generation of students more demanding and

dynamic than ever before. Yet, the economic reality forced upon them is bleak. Teachers are not even in a position to maintain basic professional decorum, let alone invest in teaching aids or digital

tools now considered standard. The COVID-19 pandemic only deepened this crisis. Many private schools conveniently halted salary disbursements for months on end, pushing already vulnerable educators and their families into near destitution. In one reported case, a teacher received only two months' salary over the course of an entire year. Another went viral on social media after a cab driver offered him a ride; the teacher had no money to pay the fare because he hadn't been paid by his school for months. These are not isolated incidents—they are a reflection of the larger rot.

Such wage practices make a mockery of the Minimum Wages Act and flay the basic labour rights. Worse, they contradict the very ethos of education. What message are we sending when those who shape the minds of future generations cannot afford basic healthcare, food, or transportation?

Behind every teacher stands a family that has invested years of financial and emotional support in the hope that their educated child

will lift them out of hardship. Instead, private school teachers are being driven to despair. They are denied annual increments, performance incentives, job security, and even dignity. Those who dare speak up are swiftly silenced, dismissed without notice or blacklisted in the small, interconnected education community.

This exploitation must end. The government must take immediate and decisive action. The School Education Department and Labour Department should collaborate to establish a regulatory framework that governs hiring practices and salary structures in private schools. A Salary Fixation Committee should be formed to set minimum pay standards, with provisions for annual increments and performance-based incentives. Moreover, a Grievance Redressal Cell is essential to address and resolve complaints without fear of retaliation.

All is not bleak, however. Institutions such as the Sir Syed Memorial Educational Institute Doru in South Kashmir are proving that ethical employment practices are not only possible but sustainable. Teachers there are paid respectable salaries, on time, and according to official norms. This model must be replicated across the region if private education is to be considered a respectable and viable employment sector for youth. The time for silence has passed.

The time for silence has passed. The plight of private school teachers is no longer a private affair, it is a public issue that questions the credibility of our education system, the morality of our institutions, and the conscience of our society.

Parray Pora and the Paradox of Possibilities

A Kashmiri sister challenges STEM bias to support her brother's pursuit of arts amid systemic and social hurdles.

y younger brother recently appeared in his 10th board examination through JKBOSE. A curious kid by nature, he keeps experimenting with things. Sadly, those things are not scientific gadgets. He will not become an engineer. Or a doctor.

I knew it since a year, and I knew I would be the one to help him assess other promising disciplines. I knew the answer very well, but since I am a good advocate, I asked him, "Baby, are you interested in mathematics?" "No!" He left no doubt about it. "Can physics or chemistry be your calling?" "No, I do not understand them well." "Alright," I said, "I think you will do something in arts. I see you are interested in language."

I decided that once his board exams were over, I would see a good private school for him where he could find opportunities to realize his potential. I was considering CBSE, and I had it sorted in my mind. Subconsciously, he sometimes calls me 'Mama'.

His subconscious sees me as a substitute to a mother for him if or when he needs one. He has put his faith in me. My friend told me that when she had asked him about what he was thinking of pursuing after grade 10, he replied, "That Aisha Di will decide." A year has passed, his board examination is over, and it is time to get things done for him.

I have come to know that if I get him admitted in a private school outside of our village's vicinity, he will not receive a backward certificate. Practically speaking, that is a big issue.

Here I am not going to speak of the principles or unethical exploitation, if any, behind a backward certificate. For now, the matter at hand for me is that we belong to the backward category and whomever I asked for suggestions, nobody supported my decision of giving up a backward certificate by getting him admitted in one of the top schools in the valley. And since it is my brother and not my certificate or future, I have no say in whether he

Now where I have received my science and math tuitions from during my higher secondary school years, I asked a teacher working at that institute that if by any chance they had expanded the institute to include arts stream as well. They had not. There is only one small dilapidated place of which I know where arts stream is being taught to 11th and 12th grade students.

should or should not need it.

I am speaking of Parray Pora that has mainly been the hub of coaching institutes in the valley. We've a friend's place there which would be a safe accommodation for my brother for these two years. But I'm struggling to find a decent coaching institute for him in a place where students flock like sheep. When I joined as a student, I found my seniors and juniors there, even my childhood crush! Parray Pora has been the melting pot of pan-Kashmir students.

As I saw no choice, reluctantly, I thought I might have to settle for the private school in the nearby town. "But I didn't get any backward certificate because I did my higher secondary studies from the town as well," my KAS officer friend pressed. What on earth was I supposed to do then?

Looking for some hope, I called an IAS/KAS academy in Parray Pora to inquire if they taught arts to higher secondary students: "No Ma'am, we teach only medical students on the higher secondary level. But your brother can opt for medi-

cal stream and not appear in NEET. Basically, the last year's results came better from students who came from medical background. If your brother wants to appear in administrative exams in future, he can join our institute. He needs to take up science only for basic studies and we will build him until he graduates and he can straightaway go for administrative exam while holding only a bachelor's degree."

Appearing in the UPSC examinations while holding a bachelor's degree only is a trap some - or maybe many - students fall for. Generally, it is not enough exposure. I asked my KAS officer friend if it was doable to let my brother take up science just for the sake of the administrative examinations. He was against the advice given to me by the guy at the IAS/KAS academy. "They are saying so

because they don't have other options available." I went to my brother and asked him if by any chance he wants to set his base in science. "No chance," he was crystal clear.

I don't want to contaminate my brother's mind. His natural abilities need nurturing. Now all I am left with is the option of getting him admitted in the local government higher secondary school and simultaneously in a good private coaching institute. But where is that 'good private coaching institute?'

The government schools which have the cream of the teaching faculty are not seen as decent schools. I am yet to do some research regarding why that is so. How many loopholes can I count in this educational procedure in this third world country which apparently produces world class mathematicians and scientists, which is

home to some of the toughest examinations in the world?

I swear, had cleaning windowpanes been seen as a job of honor and money, every parent would be sending their kids to companies who could teach their kids to clean the windows in the most eloquent of ways, with the best soaps rags and tools.

What about my classmate who studied astrophysics on scholarship basis in the UAE and gave it up to pursue literature? He was the brightest student in the class. What about another bright student who is pursuing humanities at the Delhi University after studying science in 11th and 12th grade? Yet another valedictorian who got selected for a prestigious course at the Ashoka University - what about her, a history student? What about another of my acascience and math in 11th and 12th grade and recently qualified All India Bar Examination? What about this KAS officer friend who was originally a BDS student?

On a larger scale, what about

On a larger scale, what about Jacinda Ardern, Christopher Nolan, J. K. Rowling, Irfan Habib, Yuval Noah Harari, Frank Lloyd Wright, Anne Sullivan, van Gogh, Beethoven, Emily Dickinson? What about André Rieu who brought Emma Kok to his show, and who breathtakingly sang Barbara Pravi's Voilà? I found a voice in that song for the woman in me.

As a tourist, what else can I see in Agra if an architect were not to design the Taj Mahal? Do these fields play no role in our society? Is history not supposed to be remembered and written? Is society not supposed to be studied? Does the flower vase on my side table containing flowers which lends a happy aura to the walls in my room hold no significance in my well-being? What about my gardener who creates a small heaven in my lawn where I sit and soak vitamin D?

I will not give up on my brother. If he does not want to pursue science, there is no reason for him to. A classmate of his considered less intelligent compared to my brother opted for medical studies and our mother remarked, "But how will he manage?" I saw the flip side of this statement and I looked at my brother and asked him, "Darling, do you think I am supporting you to take up arts because perhaps I think you are less intelligent? I'm supporting you because I know you will deliver better in the field of arts than in science. You have to work hard anyhow, be it science, be it arts!'

The MeT said that Srinagar recorded a rainfall of 2.8 mm, 5.3 mm in northern district of Kupwara and 4.2 mm in southern resort of Pahalgam.

Due to the wet weather, authorities suspended vehicular movement on the Bandipora-Gurez road as a precautionary measure on Thursday.

Meanwhile, the minimum night temperatures remained above normal across Jammu and Kashmir, with most parts of the Kashmir division recording temperatures 2.4 C above normal and the Jammu division 4.6 C above normal.

Gulmarg recorded the lowest minimum temperature in Kashmir at 2.8 C, while Bhaderwah was the coldest in the Jammu region at 10.0 C, according to the MeT.

The agency in an earlier statement said that it had secured the successful extradition after years of sustained and concerted efforts to bring to justice the key conspirator and "mastermind of the deadly attack" that claimed 166 lives.

"With the active assistance of USDoJ, the US

Sky Marshal, NIA worked closely with other Indian intelligence agencies, NSG through the entire extradition process, which also saw India's Ministry of External Affairs and Ministry of Home Affairs coordinating with the other relevant authorities in the United States to take the matter to its successful conclusion," the statement read.

Senior advocate Dayan Krishnan and special public prosecutor Narender Mann, who are representing the NIA, reached the Patiala House court premises shortly after news that Rana had landed in Delhi. Police officials asked mediapersons to leave and said they were ensuring the court premises were fully vacant. The lawyers, however, refused to comment.

Special NIA judge Chander Jit Singh is hearing the case against Rana. Advocate Piyush Sachdeva from Delhi Legal Services Authority is representing the accused.

Meanwhile, tight security has been ensured outside the NIA headquarters at the CGO complex here and the entire premises has been cordoned off by security personnel of Delhi Police and Central Reserve Police Force (CRPF).

Key roads outside and around the NIA office has been closed for any vehicular traffic. Entry and exit from gate no 2 of Jawaharlal Nehru Stadium metro station, which is opposite the probe agency's office, has been barred.

The announcement that Rana would be finally extradited came when Prime Minister Narendra Modi visited the US capital in February. "We are giving a very violent man back to India immediately to face justice in India," US President Donald Trump said at a joint press conference with Modi on February 14.

Trump said his administration has approved the extradition of "very evil people of the world" Rana "to face justice in India".

Rana was lodged in the Metropolitan Detention Centre in Los Angeles.

He was held in judicial custody in the US following proceedings initiated under the India-US Extradition Treaty for his extradition. The extradition finally came through after Rana exhausted all legal avenues to stay the move.

The District Court for the Central District of California had ordered his extradition on May 16, 2023. Rana then filed multiple litigations in the Ninth Circuit Court of Appeals, all of which were rejected.

He subsequently filed a petition for a writ of certiorari, two habeas petitions, and an emergency application before the US Supreme Court, which were also denied.

"The extradition proceedings were initiated between the two countries after India eventually secured a surrender warrant for the wanted terrorist from the US government," the NIA said.

Rana is accused of conspiring with David Coleman Headley alias Daood Gilani, and operatives of designated terrorist organisations Lashkar-e-Taiba (LeT) and Harkat-ul-Jihadi Islami (HUJI) along with other Pakistan-based co-conspirators, to carry out the the three-day terror siege of India's financial capital.

Both LeT and HUJI have been declared terrorist organisations by the Indian government under the Unlawful Activities (Prevention) Act, 1967.

Among the 166 killed were US, British and Israeli nationals. Besides, 238 were injured in the mayhem carried out by a group of 10 Pakistani terrorists on a railway station, two luxury hotels and a Jewish centre after they sneaked into Mumbai through the Arabian Sea.

The terrorists had targeted multiple iconic locations in Mumbai, including the Taj Mahal and Oberoi hotels, Leopold Cafe, Chabad House

and Chhatrapati Shivaji Terminus train station, each of which Headley had scouted in advance.

Rana would be the third person to be sent on trial in India in the case after Ajmal Kasab and Zabiuddin Ansari alias Abu Jundal. In November 2012, Ajmal Amir Kasab, the lone surviving terrorist among the Pakistani group, was hanged to death in Yerawada Jail in Pune.

Rana had served in the Pakistan Army medical corps before emigrating to Canada in late 1990s and started his immigration consultancy firm. He later moved to the US and set up an office in Chicago.

Through his firm, Rana gave cover to Headley to carry out reconnaissance mission in Mumbai so that the terrorists could launch the attacks.

The officials said Rana's extradition would

help probe agencies expose the role of Pakistani state actors behind the 26/11 attacks and may shed new light on the investigation.

His extradition from the US could provide important leads into his travels in parts of

northern and southern India days before the carnage in 2008, NIA officials said. Rana visited Hapur and Agra in Uttar Pradesh, Delhi, Kochi in Kerala, Ahmedabad in Gujarat, and Mumbai in Maharashtra with his wife Samraz Rana Akhtar between November

13 and November 21, 2008, they said. Rana had submitted business sponsor letters from 'Immigrant Law Center' and property Tax payment notice from the Cook County as his

address proof.

The Federal Bureau of Investigation (FBI) of the US arrested Rana in Chicago a year after the attacks in October 2009 for providing support for an aborted plan to behead employees of a newspaper, in Copenhagen (Denmark) in retaliation for the publication of cartoons depicting the Prophet Mohammed in it, and also for providing material support to Pakistan-based terrorist outfit LeT, which orchestrated the Mumbai attacks.

However, Rana was acquitted of conspiracy to provide material support to the Mumbai terror attacks. He was, however, convicted in 2011 in the other case and sentenced to 14 years, the officials said

India has been trying to extradite Rana for many years because of his association with LeT and HUJI, Headley and for his active involvement in the Mumbai attacks.

It is alleged that Rana was aware of Headley's terror links and even helped in reconnaissance of targets in Mumbai and planning the attacks on the National Defence College (NDC) in New Delhi and Chabad House in Mumbai.

The NIA had registered a case on November 11, 2009 under sections 121A of Indian Penal Code, Section 18 of UAPA and Section 6(2) SAARC Convention (Suppression of Terrorism) Act against Headley, Rana and others for being part of a criminal conspiracy with LeT and HUJI members to commit terrorist acts in New Delhi and other places in India.

During the NIA investigation, the roles of senior functionaries of banned terror groups LeT and HUJI -- Hafiz Muhammad Saeed alias Tayyaji, Zaki-ur-Rehman Lakhvi, Sajjid Majid alias Wasi, Illyas Kashmiri and Abdur Rehman Hashim Syed alias Major Abdurrehman alias Pasha have emerged.

They were working in active connivance and assistance from Pakistan spy agency ISI's officers namely Major Iqbal alias Major Ali, Major Sameer Ali alias Major Samir, all residents of Pakistan, the officials said.

"Recording of reasons in support of conclusions arrived at in a judgment or order by the Courts in judicial system has been recognized since very inception of system," the bench said, adding, "Right to know the reasons for decisions made by the Judges is an indispensable right of a litigant. Even a brief recording of reasoned opinion justifying the decision made

would suffice to withstand the test of a reasoned order or judgment."

The Bench further said that a non-speaking,

unreasoned or cryptic order passed or judgment delivered without taking into account the relevant facts, evidence available and the law attracted thereto has always been looked at negatively and judicially de-recognized by the courts.

"Mere use of words or language of a provision in an order or judgment without any mention of the relevant facts and the evidence available thereon has always been treated by the superior courts as an order incapable of withstanding the test of an order passed judicially," the court said, adding, "Ours is a judicial system inherited from the British Legacy wherein objectivity in judgments and orders over the subjectivity has always been given precedence. It has been a judicially recognized perception in our system that the subjectivity preferred by the Judge in place of objectivity in a judgment or order destroys the quality of the judgment or order and an unreasoned order does not subserve the doctrine of fair play."


"Our concerns are not just about temples," Tickoo said, "but also about jobs and human rights violations faced by Kashmiri Pandits."

The KPSS also criticized the Jammu and Kashmir Assembly for staying silent for decades on temple encroachments and only showing concern now over Waqf property regulations.

"If the government fails to act within two months, the KPSS has vowed to seek justice through the Supreme Court," they said.

Meanwhile, the BJP's Jammu and Kashmir unit has expressed support for the KPSS's demands, stating that Kashmiri Pandits have every right to raise their voice for the protection of their religious places and properties, and that the government must act to safeguard temple lands.

Altaf Thakur, spokesperson for the BJP's J&K unit, said, "What our Pandit brothers are demanding is genuine. Many of their lands were forcefully encroached upon when they were displaced. Now that they are seeking a bill for the protection of these properties, the government should pass it."

Multiple Rusting Iron Bridges In Bandipora Endanger Commuters

BANDIPORA: Several dilapidated iron bridges along key routes in north Kashmir's Bandipora district have become a growing concern for commuters, locals and officials alike.

With some of these bridges witnessing frequent VIP movement, military convoys, and regular public traffic, the crumbling infrastructure now poses a serious safety risk.

Among the most affected is the iron bridge at Naninara Sumbal, located on the vital Bandipora-Srinagar road. This bridge, which has long shown signs of wear and tear, is now in a severely deteriorated condition. Large cracks, rusted joints and shaky supports have made it increasingly dangerous for both pedestrians and vehicular traffic.

Another iron bridge at Guroora, also on the Bandipora-Srinagar road, has been damaged multiple times in the past, vet no substantial repair work or replacement has been undertaken.

"Every time it rains or a heavy vehicle passes, we fear the bridge might collapse. It's been patched up too many times, but we need a permanent solution," said Abdul Hameed, a local shopkeeper near the site.

Meanwhile, locals have urged both the Sonawari and Bandipora MLAs to look into the matter and ensure prompt action is taken, so that commuters no longer have to suffer due to the deteriorating condition of these crucial bridges—(KNO)

'Agriculture, Allied Sectors Power Over 78% Of J&K's GDP'

Kashmir Earns Rs 181 Crore From Minor Mineral Extraction In 5 years

SRINAGAR: The Kashmir division has witnessed a significant boost in revenue from minor mineral extraction, collecting Rs 181.04 crore over the past five years. The financial year 2023–24 marked the highest revenue generation at Rs 53.99 crore, reflecting a growing focus on regulated mining practices.

Responding to rising concerns over illegal mining, particularly in District Budgam, the government said authorities have intensified enforcement actions. "Between 2022 and January 2025, a total of 1,499 vehicles and machinery involved in unauthorized extraction were seized, and 79 FIRs were lodged. The cumulative compounding fines collected during this period amounted to Rs 1.63 crore." it said.

The figures were shared by the Jammu and Kashmir government in the Legislative Assembly, following queries raised by 14 MLAs regarding illegal mining activities in the Dood-Ganga and Shali Ganga rivers in Budgam.

In its response, the government denied any recent illegal exploitation in these areas, as-

serting that stringent action is being taken against violators whenever such activities are detected.

Officials said that out of 202 active mineral leases in the region, 144 have been allotted to local residents, while 58 are held by non-locals. This allocation is seen as a step toward empowering local communities and ensuring transparency in resource utilisation.

Earlier, the National Green Tribunal (NGT) had taken serious note of environmental violations in the region. In its March 8, 2022 order in Raja Muzaffar Bhat vs. Union of India & Others, the NGT held the J&K government accountable for failing to prevent solid waste dumping, untreated sewage discharge, and illegal mining in Doodhganga and Mamath Kul in Budgam. The tribunal directed the state to pay Rs 1 crore as interim compensation for environmental restoration.

In compliance, the Mining Department deposited the amount with the Deputy Commissioner, Budgam, and seven restoration works were subsequently undertaken and completed by the Flood Control Department in Doodhganga Nallah and Mamath Kul.

To strengthen oversight, the I&K government has instituted a robust monitoring mechanism. A Multi-Departmental District Level Task Force Cell, headed by Deputy Commissioners, has been established alongside Divisional-Level Monitoring Squads, District Officers, and Mineral Check Posts to curb illegal mining and unauthorised transportation of minerals.

The district-wise data from Budgam reveals a dynamic enforcement trend: From 2022 to 2023, 658 vehicles/machinery were seized, 13 FIRs lodged and Rs 1.06 crore fines were collected. In 2023-24, 424 seizures, 21 FIRs, Rs 81.73 lakh fine. In 2024–25 (up to January), 417 seizures, 45 FIRs, and Rs 71.21 lakh were collected.

Revenue collection from minor minerals in Kashmir has seen notable fluctuations: 2020–21: Rs 9.71 crore, 2021-22: Rs 43.81 crore, 2022-23: Rs 32.97 crore, 2023-24: Rs 53.99 crore, 2024-25 (till Jan): Rs 40.56 crore.

The government said it continues to emphasise strict compliance with mining regulations for sustainable resource management and environmental protection in the region—(KNO)

CHENNAI: A beleaguered Chennai Super Kings will have their task cut out against Kolkata Knight Riders after losing regular skipper Ruturaj Gaikwad to injury, as they look to break a frustrating run of defeats in the IPL here on Friday.

Gaikwad has been replaced by MS Dhoni after a fracture to his elbow ruled him out for the rest of the season, with the veteran wicketkeeper-batter taking over as the leader again.

CSK will hope Dhoni's return at the helm brings them luck as the five-time winners try to overcome a string of defeats.

Heading into the critical game, in which a loss could spell more trouble for CSK, the



home team is taking some solace from the batters' impressive show in the last match against Punjab Kings, which they lost by 18 runs after being set a stiff target of 219 in Mullanpur.

CSK are now hoping for a change in fortune at Chepauk, which has so far this season not afforded them the advantage it has been know to give in the past, something that has also

forced longtime coach Stephen Fleming to express his frustration after a massive loss against Royal Challengers Bengaluru some days back.

The likes of Devon Conway, Rachin Ravindra and Shivam Dube will be entering the match on the back of some welcome runs, and that is one positive for CSK in these difficult times.

The bowling will more or less remain the same with Khaleel Ahmed, Mukesh Choudhary and Matheesha Pathirana handling the pace department and the trio of R Ashwin, Ravindra Jadeja and Noor Ahmad hoping to work their magic with their spin bowling.

As far as the Knight Riders are concerned, they will be smarting from their narrow

loss against Lucknow Super Giants three days back, and will look to get back to winning ways before it gets too late for the defending champions.

Their bowlers were taken to task by LSG batters at Eden Gardens and they will hope for a much-improved performance at Chepauk, while the batting unit will bank on the likes of Quinton de Kock, Sunil Narine, skipper Ajinkya Rahane, Angkrish Raghuvanshi, Andre Russell and Rinku Singh to fire and lead their resurgence.

CSK are placed ninth in the standings after four losses and a solitary win, while KKR are in sixth position with two wins and three defeats in five

PSL Matches To Begin 1 Hour After IPL Games To Avoid Clash

KARACHI: The Pakistan Super League management, in a bid to minimise direct airtime clash with the Indian Premier League, has scheduled its matches one hour after the IPL matches commence.

Salman Naseer, the PSL CEO, said in a podcast that PSL matches will begin from 8:00 pm, one hour after the IPL games commence at 7 PST.

The PSL will begin in Rawalpindi on Friday.

This is the first time since the two leagues were launched that they are clashing in the same window.

Naseer said they had no option but to schedule the PSL in the April-May window because of the packed calendar earlier this year.

"It is not an ideal situation but we are confident that the PSL has its own fan base and will attract the usual eyeballs," Naseer said.

He said that since the PSL was in its 10th year, a num-

ber of new things have been added to make the broad-

cast quality top notch.

Naseer added that one advantage of having the PSL in the same window as the IPL was that the franchises had been able to sign some reputed overseas stars, who went unsold in the IPL auction.

He also said that the PSL had got queries from interested parties on buying two new teams that would be added to the tournament by next year.

Asked about the rocky relationship between some of the franchise owners and the PSL management, some of whom had publicly lashed out at the PCB for its handling of the league, Naseer said it was not appropriate for anyone to wash dirty linen in public.

Naseer said all franchise owners now would be given revised fees for the next 10 years and all had the right to accept the PCB offer or decide otherwise.

Cricket To Feature Six Teams In 2028 LA Olympics

NEW DELHI: Cricket will witness six teams battling for top honours when the sport returns to the Olympics at the 2028 Los Angeles Games after a gap of 128 years.

This was confirmed by the organisers on Wednesday.

Cricket last featured at the Olympics in the 1900 edition of the Games in Paris, where a one-off, two-day match between Great Britain and France was held, which is now recognised as an unofficial Test. At LA 2028, cricket will be played in the T20 format, with six teams competing in both the men's and women's competitions.

Every team will be able to name a 15-member squad as a total of 90 athlete quotas have been allocated for each gender.

The International Cricket Council (ICC) consists of 12 full members in Afghanistan, Australia, Bangladesh, England, India, Ireland, New Zealand, Pakistan, South Africa, Sri Lanka, the West Indies and Zimbabwe.

Another 94 countries form the associate members group.

Qualification criteria for the 2028 Games are yet to be confirmed for the cricket tournament but USA are likely to earn a direct spot at the quadrennial extravaganza as host nation, meaning only five teams will be allowed to make the cut through the qualification process.

Cricket is one of five new sports which will feature at the next Olympic Games. The International Olympic Committee (IOC) approved cricket's inclusion for LA28 in 2023, along with baseball/softball, flag football, lacrosse (sixes) and squash.

Dhoni To Captain CSK For Rest Of IPL With Gaikwad Ruled Out

Chennai Super Kings were dealt a severe blow on Thursday as regular skipper Ruturaj Gaikwad was ruled out of the IPL due to an elbow injury, a development that has brought back Mahendra Singh Dhoni in the leadership role.

CSK head coach Stephen Fleming confirmed the development.

"We have an uncapped player, MS Dhoni, who will take over as captain for the remainder of the IPL," Fleming told mediapersons ahead of the match against KKR on Fridav.

Dhoni had previously captained CSK from 2008 till 2023 and won five IPL titles. He handed over the captaincy to Gaikwad ahead of the 2024 season.

Gaikwad sustained the blow when he was hit by a short ball from Jofra Archer on March 30, and since then he has played two games.

Rajasthan Royals Skipper Sanju Samson Fined Rs 24 Lakh

Rajasthan Royals skipper Sanju Samson has been asked to pay a hefty fine of Rs 24 lakh after his team maintained a slow over-rate during their match against Gujarat Titans in the Indian Premier League in Ahmedabad.

Gujarat Titans won the match by 58 runs. Set a target of 218, the Royals were all out for 159 in 19.2 overs at the Narendra Modi Stadium on Wednesday.

"The rest of the members of the playing XI, including the Impact Player, will be fined either Rs six lakhs or 25 per cent of their respective match fees, whichever is lesser," the IPL said in a statement on Thursday.

Currently, GT lead the pecking order with four wins and a solitary loss in five matches, while RR are placed way down at seventh position with two victories and three defeats in five games.

Kylian Mbappe's Legal Team Say Several PSG Accounts Frozen

France football captain Kylian Mbappe's legal team have appealed to the French sports minister and UEFA for his former club Paris St Germain to pay him 55 million euros (\$61.25 million) in unpaid wages and said several of the club's accounts had been frozen on Thursday.



"We're going to go on the attack," Delphine Verheyden, Mbappe's lawyer, told a press conference.

The French League (LFP) ordered PSG to pay the player last year but the French Football Federation ruled that Mbappe's request was inadmissible because of an ongoing procedure in a civil court.

Mbappe's legal team, however, have turned to a Paris court to freeze 55 million euros in PSG's accounts.

Mbappe became PSG's all-time top scorer during his seven-year stay in the capital but the 26-year-old joined Real Madrid as a free agent last year.
