### Efforts Pay Off?: Kashmir Stag 2025 Census Eyes Record Numbers

Srinagar: The Department of Wildlife Protection has kicked off its biennial census to assess the population of the endangered Kashmir Stag, locally known as Hangul, in and around the Dachigam National Park. This year's count is particularly significant, with officials hopeful the number will cross the 300 mark for the first time in decades.

ed in April 2023, the Hangul population stood at 289-up from 261 in 2021-marking a 10.72% rise. The increase has brought cautious optimism among conservationists who say sustained habitat recovery and anti-poaching measures are beginning to show results.

A major contributor to this upward trend is the Trees for Hanguls™ initiative, launched by the social enterprise Grow-Trees.

1.22 lakh trees ĥave been planted as part of the project, aimed at restoring the Hangul's fragmented habitat and ensuring a reliable food source.

"Back in 2008, their numbers had dropped to just 127," says

Pradip Shah, co-founder of Grow-Trees.com. "But with focused conservation work, the population is slowly bouncing back. Of the 289 Hanguls counted in 2023, 275 were in Dachigam and 14 in Tral Wildlife Sanctuary.'

### Srinagar Hits April Peak After 80 Years

**MeT Issues** 'Yellow, Orange Alert' From April 18

Srinagar: In an unusual weather shift, Kashmir witnessed its hottest day of the season on Tuesday, with Srinagar recording a scorching  $30.4^{\circ}C$  — a full 10.2°C above the average for this time of year.

Srinagar recorded the highest ever maximum temperature of 31.1 degrees Celsius on April 20, 1946, the officials of the meteorological department said.

Other parts of the Valley followed suit. Qazigund touched 29.8°C, Kupwara 29.5°C, Kokernag 27.5°C, and Pahalgam  $25.4^{\circ}C$  – all marking the hottest day of the season so far. Even the snow-covered slopes of Gulmarg weren't spared, where temperatures soared to 20.7°C — a startling 11.2°C above normal.

Amid the unexpected heatwave, the Meteorological Department (MeT) has issued

### 'No One Listens To Me Anymore': **Ruhullah On Rift With NC**

Srinagar: National Conference MP Aga Ruhullah Mehdi has said that his party has virtu-ally cut off communication with him, especially after he joined the student-led protest against the new reservation policy outside Chief Minister Omar Abdullah's residence in December last year.

"Until Assembly elections and for some period thereafter my views were taken seriously. I was told that even if the party didn't agree with my methods, it aligned with my politics and ideas," Ruhullah said in an interaction on



Twitter space. "But after the reservation (protests), the communication (between him and the party) has become almost non-existent."

The NC leader said there were now no takers for his

views within the party, saying the situation changed after the Assembly elections were over. "From Parliament elections which the party persuaded me to contest, to up until Assembly polls, my opinion was valued and taken as a direction for the party," he said, "But things changed after the elections were over. Thereafter the party gradually lost interest in my opinion."

### 'Neutrino Weighs Under 0.45 Electronvolts', Study **Sets Upper Limit For Universe's Lightest Particle**

study has set a maximum value, or upper limit, that a neutrino -- the lightest sub-atomic particle -- weighs under 0.45 electronvolts, which is at least a million times lighter than an electron. Findings of the study, published in the journal Science, takes scientists closer towards understanding the fundamental laws of nature.

The KArlsruhe TRItium Neutrino, or KA-TRIN, experiment is an international collaboration of scientists looking to work out the "absolute mass" of a neutrino. Considered the lightest particles in the universe, neutrinos are formed during nuclear reactions -- when nucleus of two atoms merge (fusion) or a nucleus of an atom breaks apart (fission). A neutrino is not a charged particle. The researchers explained that neutri-

nos act as "cosmic architects" by influencing how galaxies are formed and spread in the universe.

Given their active role in shaping the visible structures in the universe, a precise measurement of a neutrino's mass is, therefore, essential for a complete understanding of the fundamental laws of nature, the team said.

The newly set maximum value halves the previous one of 0.9 electrovolts, also calculated by the KATRIN team in a 2022

study published in the journal Nature. "For this result we have analysed five measurement campaigns, totalling approximately 250 days of data collection from 2019 to 2021 -- about a quarter of the total data expected from KATRIN," author Kathrin Valerius from Karlsruhe Institute of Technology, Germany, said. "With each campaign, we have gained new insights and further optimized the experimental conditions," author Susanne Mertens from the Max Planck

Institute for Nuclear Physics, Germany, said.

For assessing the mass of neutrinos, the ongoing KATRIN experiment looks at the beta decay of 'tritium'. Beta decay is a type of radioactive decay in which a nucleus gives out an electron or a positron (positively charged electron). Tritium is an isotope of a hydrogen atom, carrying the same number of protons but differing in the number

of neutrons. However, owing to the excess number of neutrons, tritium is unstable and radioactive in nature. Analysing the energy of the electrons emitted from the decay of tritium allows for a direct measurement of a neutrino's mass, the researchers said.

Technical instruments required for the experiment include a 70-metre-long beamline housing an intense source of tritium, and a high-resolution spectrometer (to separate the emitted particles) with a diameter of 10 metres. "Stemming from 36 million electrons

collected in 259 measurement days, a substantial reduction of the background level, and improved systematic uncertainties, this result tightens KA-TRIN's previous bound by a factor of almost two." the authors wrote.

"On the basis of the first five measurement campaigns, we derived a best-fit value, resulting in an upper limit of (less than) 0.45 electronvolts," the authors wrote.

Advisory on NFT Frauds: Risks and Prevention Tips

Non-Fungible Tokens (NFTs) have gained immense popularity, but the market is also rife with scams, frauds, and exploitation. Inves-

tors and collectors should remain vigilant against deceptive schemes. Below are common NFT frauds and how to avoid them.

**Common NFT Scams & Frauds** 

1. Fake NFT Marketplaces & Phishing Sites Scammers create fake versions of legitimate NFT platforms (e.g., OpenSea, Rarible) to steal users' wallets and funds. - Red Flags: Slightly altered URLs (e.g., "Opensea.io" instead of "opensea.io").

Unsolicited links in emails/DMs. Requests for private keys or seed phrases. 2. Rug Pulls (Exit Scams)

Developers hype up an NFT project, take investors' money, then abandon it. - Red Flags:

Anonymous or unverified team. Overpromising unrealistic returns. Liquidity suddenly withdrawn after minting.

3. Counterfeit NFTs Fraudsters mint fake copies of popular NFTs and sell them as originals.

Prevention: Verify NFT authenticity on blockchain explorers (Etherscan, Solscan). Check the official collection link on the creator's verified social media.

4. Pump-and-Dump Schemes

Groups artificially inflate NFT prices before dumping them on unsuspecting buyers. - Red Flags:

Prevention: Always verify official links from the project's website.

Sudden, unexplained price surges.

Heavy promotion in shady Discord/Telegram groups.

5. Fake Giveaways & Airdrop Scams Scammers impersonate celebrities or projects, offering "free NFTs" in exchange for wallet access.

Rule: Never share your private key or connect your wallet to untrusted sites. 6. Social Engineering & Impersonation Fake Twitter/Discord accounts of influencers or brands trick users into buying fraudulent NFTs.

How to Protect Yourself Use Reputable Marketplaces Verify Smart Contracts before minting Enable 2FA on wallets and accounts.

Never Share Seed Phrases/Private Kevs. Research Projects Thoroughly (team, roadmap, community trust). Beware of Too-Good-To-Be-True Offers

### **City Residents Fume Over** 'Frequent Call Drops'

Srinagar: Residents across several parts of Srinagar are anguished over mobile network issues, saying they are unable to receive phone calls on time and only find out through delayed missed call alerts

The problem, which has been worsening in recent weeks, is affecting daily communication and even posing challenges in emergencies.

The locals from Srinagar areas like from downtown and upper town said that they receive a "missed call" message several minutes later-sometimes as late as 10 minutes.

The affected areas include Nowhatta, Hawal, Habba Kadal to uptown localities like Rajbagh, Bemina, Sonwar and Hyderpora, etc..

Owais Ahmad, a local from Habba Kadal, said it is extremely frustrating. "My phone is in full network, but I don't receive any calls. Ten minutes later, a message pops up: 'You have a missed call.' What's the use then?" he said.

Wahid, a college student from Shivpora, said this is

not just a technical glitch, it's a communication blackout. "I missed an urgent call from my college about a presentation. I only found out much later. These delays are costing us opportunities," he said.

Similarly, residents said the situation is worse during the evenings when the network appears to vanish altogether.

"I had to call my doctor urgently last night," said another resident, adding none of his calls went through. "The doctor later told me he tried calling me too, but couldn't connect. This is unacceptable," he said.



### **Shrinking Farmlands**

ew data shows that all is not well with agriculture in Kashmir. In just the last four years, the area left fallow - land once tilled - has grown from 120,000 to 135,000 hectares. The net sown area hovers around 30% of our total land, refusing to recover, as per the Financial Commissioner (Revenue) of J&K. It was recorded at 736,000 hectares in 2020-21, dropped slightly to 733,000 hectares in 2022-23, and saw a modest uptick to 738,000 hectares in 2023-24. And every year, more and more farmland is swallowed by roads, colonies, shopping plazas, and brick kilns.

Another reason is the vanishing of streams. As a report in this paper points out, Bandipora and Baramulla, paddy fields lie dry and untended. These are not isolated stories. They are part of a larger state of affairs across the Valley.

Urban sprawl is part of the problem. The rapid urbanization aggravated by the prevailing political conflict in the region has triggered massive internal migration from the rural to urban centres. This has led to a horizontal expansion of the capital Srinagar and the major and small towns. The urban population which in 2001 was 24.81 percent shot up to 27.37 percent in 2011. Srinagar has witnessed the most influx of the internal migrants.

According to the 2014-15 J&K economic survey, Srinagar district ranks first in the state with 98.6 percent urban population followed by Jammu district with 50 percent. This is because Srinagar has been the principal destination for the people fleeing the hinterland through the nineties. The city is now one of the fastest growing in the world.

In 2011, a London based-based Think Tank on urban affairs City Mayors Foundation put Srinagar at 92nd place in the global ranking of the 300 fastest growing cities. And among the 37 Indian cities which figure in the list, Srinagar was at 23rd position.

The frenetic growth of the city is exemplified by a chaotic spectacle of the work in progress on hundreds of private housing colonies across the region. This is also happening in the countryside, with agricultural land being used to build housing colonies. What's at stake is not just agriculture - it's food, freedom, and identity.

We must act while there is still land to protect. Strictly curb the conversion of farmland. Regulate development activities, which scar the countryside. Promote green alternatives. Most importantly, give farmers the support they need. Help them irrigate, market, and adapt to the changing economy.

### **Kashmir's Dead Horse Theory**

This theory is painfully relevant to the region, where systemic issues continue to be met with superficial solutions rather than genuine reforms.

th an overwhelming mandate, the elected government has an opportunity to fix crisis-ridden higher education. If the government misses this chance, they'll be just flogging the dead horse in the name of reforming system.

The first positive sign however came when a recent high-level education meet passed some comforting instructions. Things look promising, but will they translate into action? That's a big question on Kashmir's Dead Horse Theory.

It's a satirical metaphor that illustrates how individuals, institutions, and governments often refuse to acknowledge problems. Instead of abandoning failed strategies, they double down on them - wasting time, resources, and effort in the process. This theory is painfully relevant to the state of higher education in Jammu and Kashmir, where systemic issues continue to be met with superficial solutions rather than

J&K's higher education system faces a range of deep-rooted challenges, like lack of properresearch infrastructure, uncertain career prospects for contractual faculty (which constitutes about 50% of teaching force), outdated curricula (shuffling the syllabi units in between semesters won't make it updated), poor industryacademia linkages, and the unpreparedness of Government Degree Colleges (GDCs) to implement the ambitious Four-Year Undergraduate Programme (FYUGP) under NEP 2020.

Yet, rather than addressing these core issues, decision-makers often resort to bureaucratic patchwork solutions-committees, reports, marginal policy adjustments—that do little to change the ground reality. Instead of dismounting the dead horse (accepting that the current system needs an overhaul), they persist in finding ways to justify and sustain it, even when it is clear that these efforts are futile.

One of the most pressing concerns in J&K's higher education sector is the lack of research infrastructure in colleges. With the introduction of FYUGP, students are expected to undertake research projects, yet most GDCs, barring few, lack proper laboratories and funding. Instead of acknowledging this and providing concrete financial and infrastructural support, the response has been predictable: more committees, more assessments, and more task forces to "review" the situation.

The reality is that, GDCs are ill-equipped to support research at this level. Yet of addressing these gaps, policymak on pushing forward with implemen FYUGP. This is akin to holding meetin

This is the equivalent of impreving the diet of the dead horse, an illusion of progress that does not change the core issue.

Another glaring issue is the plight of conctual faculty members and a plight of contractual faculty members, who form a significant portion of the teaching workforce in GDCs of J&K. Despite their years (some with above 15 years) of service, they remain in precarious positions, with no clear path to job security.

A practical approach would be to formulate a long-term policy ensuring their career progression. When asking about reforms and a policy, concerned ministers satisfy everyone with a statement, "examining the issue", which is followed by a prolonged silence.

Thing is, when 50% of teaching force is not stable, hired and fired every eight months,

The government should learn from Himachal Pradesh and Haryana, the twin northern states that have regularized thousands of higher education contractual teachers in past

At this moment, the faculty recruitment process remains another area where Dead Horse Theory logic prevails. It's time to abandon API matrix to hire and promote teaching staff. The system should focus on developing a real-timeall-time evaluation model, with a major focus on quality not quantity.

Notably, the crisis in J&K's higher education cannot be resolved by renaming policies, forming committees, or making symbolic gestures. It requires bold and structural reforms that must translate into action on ground. Colleges need well-equipped labs, funding for student projects, and faculty training in research methodologies. A massive investment is need of the hour.

A structured, merit-based system for regularization and career progression of contractual teaching staff is also necessary. About 90% of the non-permanent teaching force is well quali-

### Srinagar-Pahalgam Route Can Transform South Kashmir

his is to highlight the immense potential of the pro-Srinagar–Pahalgam road via Khrew and Tral. It's a transformative infrastructure project that promises to significantly benefit South Kashmir's connective ity, economy, and tourism sector. Spanning approximately 70 km, this route would reduce the travel distance between Srinagar and Pahalgam by nearly 30 km compared to the traditional path via Anantnag and Bijbehara.

The road is planned in two key segments: Wahab Sahib Khrew to Pastuna (27 crore) and Bathnoor Karmula to Lehndajan Pahalgam (44.10 crore). The Detailed Project

Reports (DPRs) for both have been prepared and are currently awaiting environmental clearances and funding. Specifically, 108 kanals (approx. 13.5 acres) of forest land and the felling of 845 trees are involved.

While environmental groups such as the Environmental Policy Group (EPG) have voiced valid concerns regarding deforestation and ecological impact, it is crucial to contextualize these fears. Forests across the world have been moderately altered for national development and this is not unprecedented. Kashmir's fertile terrain allows for effective afforestation; for every tree cut, ten can be planted and sustained with proper policy. What matters most is the government's sincerity in balancing development with conservation.

Some local resistance, particularly from Khrew, stems from past industrial mismanagement, such as pollution from cement factories. However, this road construction is not a polluting industry, it is an enabler of growth. It will catalyze tourism, allow locals to establish small businesses, and open avenues in hospitality, transport, and recreation.

Roads are the lifelines of development. Beyond tourism, this road can uplift socio-economic standards by improving access to healthcare, education, and employment. Villages en route-long isolated-will find new relevance and prosperity. It will also spotlight local heritage and cultural richness, further encouraging responsible, eco-conscious tourism if implemented with sustainability in mind.

In conclusion, while environmental diligence is necessary, it must not become a tool to halt progress. The Srinagar-Pahalgam road via Tral-Khrew represents a golden opportunity to reimagine growth in South Kashmir. We urge the authorities to expedite approvals and adopt mitigation strategies that honor both nature and development.

### The Brothers Who Brought Kashmir's Looms Back to Life

As global markets turn to handmade and sustainable luxury, two Kashmiri brothers are leading an artisan revival—bringing jobs back to the Valley, restoring cultural pride, and putting their homeland's traditional crafts on the international map.

hen Mir Nawaz and Mir Waseem were growing up in the Kashmir Valley in the late 1980s, the rhythmic clatter of looms was a familiar sound in the neighborhood—a song of craftsmanship passed down for centuries. It is a sound they would later chase across states and decades, long after it fell silent in their

Today, the two brothers stand at the helm of Miras Carpet Industries, a thriving enterprise that has quietly be-come one of India's leading names in hand-knotted carpets and pashmina shawls. Their journey, however, began far from the design studios and export ledgers of modern business.

Raised in a middle-class family sons of a junior engineer in the power department-Mir Nawaz and Mir Waseem were instilled with values of integrity and discipline. But they were also witnesses to a slow unraveling. In the 1990s, as political strife gripped the region, Kashmir's fabled artisan sector-renowned for its intricate carpets and heritage shawls-began to collapse. Master weavers laid down their tools. The looms went quiet.

"It was heartbreaking," recalls Nawaz. "These were craftsmen who once wove art that could hang on museum walls. And they were being forgotten."

In 2005, the brothers took a leap of faith. With a loan of just Rs 50,000, they opened a small carpet store in the ruins of Hampi, a town in Karnataka known more for its ancient temples than its textiles. The decision was both improbable and symbolic: resurrect a dying tradition from the soil of a distant land. They called it Miras, an Urdu word

meaning "legacy." From the outset, Miras was more than a commercial venture. The brothers sought out Kashmiri artisans who had left the trade, offering them fair wages and respect. They prioritized quality over scale, tradition over trend. Each carpet, each shawl, they insisted, had to tell a story.

The gamble worked. Today, Miras operates over 20 production units and 36 active pashmina looms. Its team includes 250 artisans, and its products—

delicate silk-on-silk rugs, handwoven Sozni shawls—are exported to markets in Europe, the Middle East, and the United States. The company now derives 80 percent of its revenue from international sales.

But the revival hasn't stopped at commerce. Miras has quietly become an ecosystem for skills, employment, and cultural preservation. In an industry increasingly threatened by machine-made replicas, Miras carpets are known for achieving 40 knots per square inch—a technical feat that few global manufacturers can replicate.

In 2019, the company launched Miras Crafts, an e-commerce platform with separate portals for Indian and global buyers. The move brought centuries-old artistry into the homes of urban consumers—with just a click.

Next, the brothers are returning home in a way they never have before. Construction is underway for a 65,000-square-meter headquarters in Gulmarg, Kashmir. It will serve as both a production hub and cultural center, complete with live loom demonstrations for visitors. "We want people to see the magic happen," says Waseem. "To understand what it takes to weave history into every inch.'

The company is also expanding its retail footprint, with ten new stores planned in major Indian cities, including Delhi, Mumbai, and Chennai.

And yet, despite its success, the core of Miras remains deeply personal. For Nawaz and Waseem, the business is not just about selling textiles-it's about reclaiming a narrative. A region known globally for conflict is, through their work, being remembered again for craftsmanship.

In Kashmir, where many youth still struggle with unemployment and limited opportunity, Miras is quietly altering futures—one artisan, one loom, one legacy at a time.

"Reviving this industry was never just about carpets," says Nawaz. "It was about restoring dignity—to the art, and to the artist."

### One Professor's Mission to Rethink Kashmir's Education

Prof Anunaya Chaubey leads a pioneering design thinking initiative in Kashmir, inspiring students and challenging outdated educational norms across the Valley.

There was a time, not too long ago, when asking questions in a classroom in Kashmir felt almost sinful. I remember my own school days clearly: critical thinking was unwelcome, curiosity was met with reprimand. Today, thankfully, the landscape is shifting. The National Education Policy (NEP) 2020 puts critical thinking at the heart of learning. But policies are only words unless they find meaning in the classroom – and that's where design thinking comes in.

My own understanding of this began in 2020, when I joined the Anant Fellowship for Climate Action. It was a transformative experience. I had long been working on environmental activism, but this fellowship added a rich academic layer to my work. It made me realise how deeply intertwined design thinking is with activism, education, and public policy.

Since then, I've been fortunate to witness something remarkable. Prof Anunaya Chaubey, Provost of Anant National University in Ahmedabad, has made it a mission to reach out to Kashmiri students, engaging them in conversations about sustainability,

innovation, and design.
When Prof Chaubey visited National Innovations Public School (NIPS) in Shopian last year, I watched the students react in disbelief as he spoke about the hazards of pesticides. In a region known for apple production, the use of chemical fertilisers has long been normalised. But for these students, it was a moment of awakening. They wanted to know: What are the alternatives? What can we do?

A similar energy filled the room during his session at Birla Open Minds School in Pampore. Design thinking, as a concept, was new to them - but it resonated deeply. It wasn't abstract theory. It was a tool to understand, analyse, and solve the problems they live with every day.

In January this year, Anant University hosted 35 students from three Kashmiri schools at their Ahmedabad campus in a programme charmingly titled Winter Is Cool. It was more than an academic trip. It was an immersion into a way of thinking that encourages empathy and solutions rooted in lived experience. Artists like Rayees Wathori helped anchor the programme, making it interactive

and inspiring.
Prof Chaubey returned to Kashmir this April, and I joined him in workshops from Pampore to Bijbehara. At NIPS Shopian, students discussed ways to reduce pesticide use and pollution in Dal Lake. At Whizkids School in Anantnag and Government Boys Higher Secondary School Bijbehara, the conversations deepened. We weren't lecturing - we were listening. That's what design thinking demands: listen, empathise, act.

But such efforts face barriers — especially in government schools. In the last five years, these institutions have grown increasingly reluctant to open their doors to external academic programmes. I believe this is rooted in fear and a lack of exposure. Unfortunately, the ones who suffer are the students, especially those from less privileged backgrounds.

We also visited Islamia College in Srinagar. Despite limited time, Prof Chaubey addressed students of English literature, sparking interest in

applying design thinking to their disciplines. Dr Tehmina Yousuf, the principal, was so moved she proposed an exposure trip for her staff and students to Anant University.

Design thinking, after all, isn't just a buzzword. It has real-world implications. Take, for example, the 2013 Right to Fair Compensation Act. It aims to compensate landowners fairly for acquisitions. But in a diverse country like India, fairness can't be one-size-fits-all. Farmers in Rajasthan with 5-acre plots are compensated at four times the market value. What about farmers in Kashmir or Himachal, whose average landholding is just half an acre? They receive the same — which is hardly equitable. This is a classic policy flaw — made without design thinking, without

And then there's the shocking example of the new auditorium at Bijbeĥara Higher Secondary School. Beautiful space, big stage — but no ramp. A wheelchair-using student recited a prayer during our workshop. Afterwards, he remained stranded on stage for two hours. It broke my heart. This isn't just poor design — it's a violation of the Rights of Persons with Disabilities Act. And yet, no one questioned it during construction. No engineer. No principal. No one saw the need. This is what happens when design thinking is absent – we create podiums without ramps and policies that deepen inequalities.

When I raised the issue with the local MLA, Dr Bashir Veeri, he promised to act. But promises are not enough. We need a culture where such things are unthinkable to begin with.

Critical thinking and design thinking are not luxuries – they are life skills. They empower our students to analyse the world they live in, question injustice, and build better solu-tions. I am grateful to Anant National University, and especially to Prof Chaubey, for continuing to nurture this change in Kashmir.

As his tenure comes to a close, I hope the work doesn't stop. Because our classrooms — and our society need design thinking now more than

### Visa cancellations sow panic for international students, with hundreds fearing deportation

Washington, Apr 15 (AP) At first, the bar association for immigration attorneys began receiving inquiries from a couple students a day. These were foreigners studying in the US, and they'd discovered in early April their legal status had been terminated with little notice. To their knowledge, none of the students had committed a deportable offense.

In recent days, the calls have begun flooding in. Hundreds of students have been calling to say they have lost legal status, seeking advice on what to do next.

"We thought it was going to be something that was unusual," said Matthew Maiona, a Boston-based immigration attorney who is getting about six calls a day from panicked international students. "But it seems now like it's coming pretty fast and furious."

The speed and scope of the federal government's efforts to terminate the legal status of international students have stunned colleges across the country. Few corners of higher education have been untouched, as schools ranging from prestigious private universities, large public research institutions and tiny liberal arts colleges discover status terminations one after another among their students.

At least 600 students at more than 90 colleges and universities have had their visas revoked or their legal status terminated in recent weeks, according to an Associated Press review of university statements and correspondence with school officials. Advocacy groups collecting reports from colleges say hundreds more students could be caught up in the crackdown.

Students apparently targeted over minor infractions

Around 1.1 million international students were in the United States last year — a source of essential revenue for tuition-driven colleges. International students are not eligible for federal financial aid, and their ability to pay tuition often factors into whether they will be admitted to American schools. Often, they pay full price.

 $Many\, of\, the\, students\, losing\, their\, legal$ status are from India and China, which together account for more than half the international students at American colleges. But the terminations have not been limited to those from any one part of the world, lawyers said

Four students from two Michigan universities are suing Trump administration officials after their F-1 student status was terminated last week. Their attorney with the American Civil Liberties Union, Ramis Wadood, said the students never received a clear reason why.

"We don't know, and that's the scary

The students were informed of the terminations by their universities via email, which came as a shock, Wadood said. The reason given was that there was a "criminal records check and/or that their visa was revoked," Wadood said, but none of them were charged or convicted of crimes. Some had either speeding or parking tickets, but one didn't have any, he said. Only one of the students had known their entry visa was revoked, Wadood said.

Students have filed similar lawsuits in several other states, arguing they were denied due process.

In New Hampshire, a federal judge last week granted a temporary restraining order to restore the status of a Ph.D. student at Dartmouth College, Xiaotian Liu, while he challenges the revocation of his visa.

In a break from past, feds cancel students' status directly

At many colleges, officials learned the legal immigration status of some international students had been terminated when staff checked a database managed by the Department of Homeland Security. In the past, college officials say, legal statuses typically were updated after colleges told the government the students were no longer studying at the school.

The system to track enrollment and movements of international students came under the control of Immigration and Customs Enforcement after 9/11, said Fanta Aw, CEO of NAFSA, an association of international educators. She said recent developments have left students fearful of how quickly they can be on the wrong side of

"You don't need more than a small number to create fear," Aw said. 'There's no clarity of what are the reasons and how far the reach of this is."

Her group says as many as 1,300 students have lost visas or had their status terminated, based on reports from colleges. The Department of Homeland

Security and State Department did not respond to messages seeking comment. Foreigners who are subject to removal proceedings are usually sent a notice to

appear in immigration court on a certain date, but lawyers say affected students have not received any notices, leaving them unsure of next steps to take.

Some schools have told students to leave the country to avoid the risk of being detained or deported. But some students have appealed the terminations and stayed in the United States while those are processed.

Still others caught in legal limbo aren't students at all. They had remained in the U.S. post-graduation on "optional practical training," a one-year period — or up to three for science and technology graduates that allows employment in the U.S. after completing an academic degree. During that time, a graduate works in their field and waits to receive their H-1B or other employment visas if they wish to keep working in the U.S.

Around 242,000 foreigners in the U.S. are employed through this "optional practical training." About 500,000 are pursuing graduate degrees, and another 342,000 are undergraduate students.

Among the students who have filed lawsuits is a Georgia Tech Ph.D. student who is supposed to graduate on May 5, with a job offer to join the faculty. His attorney Charles Kuck said the student was likely targeted for termination because of an unpaid traffic fine from when the student lent his car to a friend.

Ultimately, the violation was dismissed. "We have case after case after case exactly like that, where there is no underlying crime," said Kuck, who is representing 17 students in the federal lawsuit. He said his law firm has heard from hundreds of students.

"These are kids who now, under the Trump administration, realize their position is fragile," he said. "They've preyed on a very vulnerable population. These kids aren't hiding. They're in school."

Some international students have been adapting their daily routines.

A Ph.D. student from China at University of North Carolina at Chapel Hill said she has begun carrying around her passport and immigration paperwork at the advice of the university's international student office. The student, who spoke on condition of anonymity for fear of being targeted by authorities, said she has been distressed to see the terminations even for students like her without criminal

### PM's J&K Visit

Kashmir, Saqib Yousuf Yatoo (IRTS), confirmed the postponement of the PM's visit, stating that no fresh date has been announced

The Vande Bharat Express, specially designed to operate in sub-zero temperatures of the Kashmir Valley, is already stationed at Katra. The train consists of eight fully airconditioned coaches equipped with cab heating, HVAC systems with 9kW heating capacity, sealed gangways, infotainment displays, CCTV surveillance, LED lighting, mobile charging ports, automatic plug doors, and electro-pneu-

Although the train is capable of running at speeds up to 160 km/h, it will operate at a limited speed of 85 km/h between Katra and Srinagar, as per the Commissioner of Railway Safety (CRS) approval.

Officials said the journey will reduce travel time between the two cities to just three hours, compared to the current 6–7 hours by road.

The USBRL project spans 272 km and includes 119 km of tunnels. It connects major areas including Udhampur, Reasi, Ramban, Anantnag, Pulwama, Budgam, Srinagar, and Baramulla. Two iconic engineering marvelsthe Chenab Bridge, the world's highest railway bridge, and the Anii Khad Bridge, India's first cable-stayed railway bridge-are part of this ambitious project.

The Chenab Bridge stands at 467 meters, making it 35 meters taller than the Eiffel Tower. Officials revealed that around 29,000 tonnes of steel were used in its construction. Designed to withstand earthquakes up to magnitude 8, the bridge posed significant engineering challenges due to its location in a high-seismic zone.

Approved in 1994-95 and declared a National Project in 2002, the USBRL has been completed in phases. Key sections such as Qazigund-Baramulla (2009), Banihal-Qazigund (2013), Udhampur-Katra (2014), and Banihal-Sangaldan (2020) have already been commissioned. A trial run of MEMU trains was also successfully conducted last year on the electrified Reasi-Sangaldan section.

Currently, train services in the Valley are operational only on the Sangaldan-Baramulla section, while long-distance trains terminate at Katra. (KNO)

### **Lone Accuses CM Omar Of Orchestrating Disruption Over Waqf Bill**

SRINAGAR: Peoples Conference (PC) President and Handwara MLA Sajad Gani Lone on Monday accused Chief Minister Omar Abdullah and National Conference (NC) legislators of deliberately derailing the Assembly's discussion on the Waqf Bill.

Lone said the disruption was scripted to prevent the passage of a resolution that would have held political significance for Muslims in India.
In a detailed post on X, Lone

referred to the recent remarks made by the Chief Minister, who had said the Assembly members committed a mistake by filing the Waqf Bill discussion under an adjournment motion instead of a government resolution.

'The Speaker may have allowed the discussion on the Waqf Bill, but unfortunately our members committed a mistake by filing it as an adjournment motion," Omar Abdullah had said during a public address in Pulwama.

Responding to this, Lone wrote that he had already pointed out the same procedural error on April 7, the day the National Conference members began their protest in the Assembly. "What CM sahib has said today, I had already tweet-ed on April 7. And for saying the same, the NC members used all possible political pejoratives against me," he wrote.

Lone accused the ruling party of showing political non-chalance toward the Waqf Bill and called it a "criminal" act. He questioned the conduct of over 50 NC legislators who, he said, disrupted the Assembly proceedings for three consecu-



"Are you telling us that collectively the Speaker, the Chief Minister, and all NC legislators and lawyers could not notice for three days that they were making a mistake?" Lone wrote. "Are you telling us that the collective IQ of your legislators is such that a glaring mistake staring at their faces for three days was unnoticeable by them?"

He alleged that the Assembly protest was not a mistake but a deliberate move by the ruling party to block a resolution. "This was your script. The whole song and dance performance was orchestrated by you. You did not want a resolution from the J&K Assembly," he said.

Lone said a resolution from Jammu and Kashmir would have carried weight and sent a strong message, but the government ensured that no such opportunity was allowed. "You were not interested in passing the resolution and did not allow the tiny opposition to even make a statement," he said.

He also questioned the Chief Minister's absence during the days of disruption. "Where were you for three days? I know for some time you were in the Tulip Garden," he wrote.

Lone demanded an apology from the Chief Minister and called for an emergency oneday session of the Assembly.

### **Govt Singling Out Muslims: Tanvir**

SRINAGAR: National Conference (NC) Chief Spokesperson and MLA Tanvir Sadiq on Monday alleged that the ongoing reforms in Waqf properties are a targeted attempt to undermine the Muslim community, questioning why similar regulations are not applied to other

religious groups. Speaking to the media, Sadiq claimed the reforms are part of a broader strategy that began during the tenure Muhammad Sayeed and have since facilitated greater government control over religious

endowments. According to him, the systematic transformation of the Waqf Board into a governmentdominated body started as early as 2003. "Traditionally, the management of Waqf affairs was in the hands of local communities. Now, due to lack of proper documentation, state officials can decide the fate of shrines, mosques, and grave-

yards," he said. that Waqf Emphasizing properties are built on community trust through voluntary contributions, Sadiq as-

serted that they must remain free from government interference. "Only Muslims have the right to manage Waqf. No government can claim ownership over assets donated for the welfare of the community," he added.

He said the party has already approached the Supreme Court over the issue and expects a iust outcome. Criticizing the selective nature of the reforms, he pointed to the lack of similar oversight on over eight lakh acres of temple land, arguing that "in a secular country, reforms must be uniform across all communities.

Responding to BJP leader Sunil Sharma's recent remarks about the NC, Sadig dismissed them as ineffective and accused the BJP of policy inconsistency, citing their contradictory position on the Jal Shakti scam during legislative sessions.

Sadiq further blamed the BIP-PDP alliance for exacerbating the crisis in Jammu and Kashmir. "The damage began in 2003 and worsened in 2014 when Mufti Sayeed partnered with the BJP. Both parties are equally responsible for the region's decline since then," he

**SRINAGAR:** More than four months (125 days) after the tragic deaths of 17 individuals in Budhal village, Rajouri, investigative agencies across the country remain unable to unravel the mystery. While normalcy has returned to the village, the grief of losing loved ones lingers, and pressing questions about the incident remain unanswered.

The victims, mostly innocent children, are believed to have been poisoned, but key details such as the source of the toxin and where the children were brought from—continue to evade authorities. The people of Budhal and the wider state are demanding answers, waiting for clarity on these suspicious deaths.

Health Minister Sakina Itoo informed the Assembly that hundreds of samples from Budhal were sent to reputed laboratories across the country, revealing traces of different pesticides. However, the Central Forensic Science Laboratory (CFSL) in Chandigarh detected chlorfenapyr, a toxic

pesticide, in the viscera of all 17 deceased, confirming poisoning as the cause of death.

Despite this critical finding, the case remains unresolved. The Assembly saw demands for a Central Bureau of Investigation (CBI) probe, but the Health Minister argued that some reports were still pending and that the investigation was progressing in the "right direction."

With no concrete results even after four months, frustration is mounting among locals and officials alike. A police officer connected to the case stated, "The investigation is still ongoing," but provided no further updates.

The deaths were reported between Dec 7 last year and Jan 19. Villagers linked the deaths to a wedding feast on Dec 2, last year. Since then, Budhal faced a row of funerals. The deceased belonged to the families of Fazal Hussain, Mohammad Aslam and Moham-

mad Rafig. The government also had to ban social gatherings in the hamlet which is located 57km from main Rajouri town—(KNO)

The department in this period has witnessed a 67 percent



Transmission and Distribution capacity has increased by more than 35% during the last five years.

### **Orchardists Advised To Spray Fungicide Before Rains**

SRINAGAR: With weather forecasts predicting rainfall across Kashmir from April 18, horticulture experts have strongly advised orchardists to spray fungicides ahead of the rains to prevent scab and other fungal infections that threaten apple crops during wet conditions.

Experts said rainfall plays a key role in the spread of foliar diseases. "Moisture from rain wets leaf surfaces and creates an ideal environment for fungal infections to thrive. Rain also helps spores travel from one part of the tree to another and from plant to plant," they said.

To minimise this risk, applying fungicides before rain can significantly reduce the chances of infection, they said, adding that if the plant is already coated with fungicide, it forms a protective barrier, reducing the likelihood of disease development.

Dr Tariq Rasool, a senior scientist at Sher-e-Kashmir University of Agricultural Sciences and Technology (SKUAST), said, "Had there been no further rains forecast, there would be little need to spray fungicides at this stage. Since the weather department has predicted more rains from Friday, it is crucial for growers to act quickly and spray fungicide before the showers begin."

He said that in areas where there is currently full bloom, people need to go for a mist spray, adding that there is nothing wrong with spraying during bloom if they had sprayed 10 days earlier.

Dr Tariq said that only recommended fungicides must be sprayed. "However, if they (farmers) had sprayed just five or six days ago, then they don't need to spray again as of now," he added.

He said that last year a few farmers complained about some fungicide; in that case, they can avoid that particular one and use any other recommended fungicide. Any fungicide can create problems in some areas due to location and other issues, he said.

Dr Majid, another horticulture expert, said that orchardists who last sprayed their apple trees in the first week of April—and whose trees are now in full bloom-can safely go ahead with another round of fungicide spraying, but they must spray mistly.

"New research confirms that applying fungicides during bloom does not adversely affect the fruit. The notion that scab won't strike during flowering is a myth-scab can attack at any time. So, if it's been over 10 days since your last spray, you should definitely spray before the rain begins," he advised.

Dr Majid recommended using mist sprays rather than forceful sprays to protect delicate flower petals and young fruits. "Avoid the practice of soaking or 'bathing' the entire tree. A gentle mist spray is more effective and safer for the crop. Also, the morning hours are the best time for spraying," he said.

He warned farmers against mixing fungicides with other chemicals like pesticides and insecticides at this stage. "This is a critical period for scab prevention, and growers should focus solely on fungicide applications. Even if light rain occurs a few hours after spraying, the fungicide will still provide protection and reduce the risk of disease," he said. - (KNO)

### **Over 60 Public Libraries Functional In Kashmir**

SRINAGAR: Amid efforts to promote literacy and equitable access to educational resources, out of more than 70 public libraries across Kashmir valley, approximately 63 libraries are functional, while 9 remain closed - primarily due to nonavailability of staff or lack of infrastructure, reveals an official government document.

Data accessed suggests the highest concentration of functional libraries found in Srinagar district, which boasts at least 13 operational libraries, including prestigious institutions like SPS Central Library, City Central Library, and Gani Memorial Library.

In other districts with a strong functional presence Baramulla with 12 out of 17 libraries functional, 8 out of 9 libraries functional in Budgam, 5 out of 7 libraries functional in Kupwara, 6 in Anantnag, 5 in Bandipora, 4 in Pulwama, 2 in Kulgam and Ganderbal each and 1 in Shopian.

However, on the flip side, 9 libraries across districts like Baramulla. Kupwara, Budgam and Srinagar are marked "Closed". Baramulla leads with the highest number of closed libraries (5), followed by Kupwara (2), and with closures mostly attributed to staff shortages and accommodation issues

Those closed include, Tehsil Library Zadibal (Srinagar), border Block Delina, Kunzar, Tujjar Sharief, Pahlipora and Wagoora in Baramulla while Tanghdar, Kandi Karnah in Kupwara and Khansahab in Budgam.

The report further mentions that proposals are underway to upgrade Tehsil Libraries of Shopian, Ganderbal, Kulgam, and Bandipora to District Library status, indicating efforts to decentralize and strengthen library infrastructure.

The government has also initiated a drafting committee for comprehensive library legislation in J&K to address issues such as funding, staffing, networking, infrastructure, and promotion of a eading culture.

Meanwhile, frequent users and locals paint a different picture. 'Many of these libraries', they say, are in a state of neglect, lacking basic facilities -specifically a library in Sopore town, visitors complain of poor upkeep, low footfall, and almost no public outreach.

"The library has potential, but the collection is outdated and internet access is unreliable. It doesn't match today's academic needs," said Adil Ahmad, a postgraduate student from Sopore.
