# Will Kashmir's Low Snowfall Lead To Water Crisis This Summer?

Srinagar: Kashmir's higher reaches have experienced a dramatic decline in snowfall this winter, sparking growing concerns among experts about the region's water supply in the upcoming summer months. The reduced snow volume poses significant risks, particularly for irrigation and potable water needs. Dr. Irfan Rashid, an Assistant Professor at the

University of Kashmir and a prominent researcher on cryosphere studies, explained that this year's snowfall is unusually low, particularly in the mountainous regions which typically receive large amounts of snow. He warned that if this trend continues, the region could face substantial challenges in managing water resources for agriculture and local communities. # **SC Gives Centre Week To File Response** Says No Changes To 'Waqf By User' Till Next Hearing

#### KO Web Desk

New Delhi: The Supreme Court on Thursday granted the Centre a week's time to file a response to the petitions challenging constitutional validity of Waqf (Amendment) Act, 2025

The Supreme Court noted assurance of the Centre that till next date of hearing, wakf, including 'waqf by user',

which is declared by notification or registered, will neither be denotified nor its character changed.

Further, the Centre gave a statement that no appointments will be made to the Waqf Council or Waqf boards.

A three-judge bench of Chief Justice of India Sanjiv Khanna and Justices PV Sanjay Kumar and KV Viswanathan resume hearing the case at 2pm on Thursday.

The top court fixed the next date of hearing in the week commencing May 5 by when the responses of Centre, states and


petitioners opposing the Act will be filed. The court directed five petitions to be selected as lead petitions that will be decided by the petitioners.

The assurance of solicitor general Tushar Mehta came when he informed a bench of Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and K Viswanathan that the

waqf law was passed by Parliament with "due deliberations" and it should not be stayed without hearing the government.

The Centre also strongly opposed the apex court's proposal to pass an interim order against the denotification of waqf properties, including 'waqf by user', aside from staying a provision allowing the inclusion of non-Muslims in the central waqf councils and boards.



## 'Night-Time Sleep Improves One's Recall Of Sequence **Of Events, Benefits Seen Even After A Year'**

ight-time sleep improves one's recollection of sequence of events, rather than simply protecting memory from declining, according to a study.

Findings of the study, published in the journal Nature Human Behaviour, also showed that benefits of a night's sleep in remembering order of events were evident, even after more than a year.

"While our memory for features such as object size and colour declines over time, sleep can improve our memory for event sequence," senior author Brian Levine, senior scientist at the Rotman Research Institute, Baycrest Academy for Research and Education, Canada, said.

"This study deepens our understanding of how critical sleep is for integrating experiences into memory," Levine said. The researchers explained that the study involved a 20-minute audio-guided tour of artworks displayed at Baycrest.

Over 50 participants took the tour and responded to questionnaires that tested their memory.

The tests were taken at five intervals, starting from an hour to 15 months after the tour and included questions on physical features of the artwork and the sequence of tour items.

The researchers found that sleep boosted the participants' recollection of the sequences, whereas that of features declined.

"We show that sleep actively and selectively improves the accuracy of memory for a one-time, real-world experience (an art tour) - specifically boosting memory for the order of tour items (sequential associations) versus perceptual details from the tour (fea-tural associations)," the authors wrote.

As part of a second experiment, the participants were randomly assigned to either a wake or a sleep group. Both the groups did the tour and took two memory tests.

However, the sleep group took the second memory test after a night of sleep in a sleep laboratory, while the wake group took it in the evening after nor-

mal daily activities. Additional memory tests were completed by both the groups one week, one month and 15 months after the tour. Recordings of brain activity showed that specific brain waves during

deep sleep - slow waves and spindles - were linked to an enhanced memory overall.

Further, advantages of sleep in recollecting sequence of events were evident after a single night of sleep, and this advantage held at all test points, including 15 months later, the researchers said. "Sleep-related memory enhancement was associated with the duration and neurophysiological hallmarks of slow-wave sleep previously linked to sequential neural replay, particularly spindle - slow wave coupling," the authors wrote.

### And A Golden Era Comes To An End **Admirers Bid Tearful Farewell To Nazki**

SRINAGAR- Mir Ghulam Rasool Nazki, a legend of Persian, Urdu and Kashmiri, besides being well versed with Arabic and English, who bid adieu to this world yesterday evening, was laid to rest at his final abode in Malakhah grounds, amidst recitation of verses from holy Quran.

Large number of people from different walks of life were present when the body of Nazki, draped in white shroud, was lowered inside the grave. Many of them, were seen sobbing, some with swollen red eyes, wiping their tears.

Almost all the sections of the society were present at the funeral. There were poets, scholars, writers, critics, religious leaders, activists of different political parties, journalists, media personnel and last but not the least the poor and ordinary people of Khatidarwaza locality, where Nazki spent most of his lifetime. `We have been orphaned" said Mohammad Ismail, around 60, adding that "Baday Nazki sahib hamari her tarah say madad kiya kartay thay" (The elder Nazki would alwavs help us).

The funeral procession started this morning from Nazki's Shivpora house and jenaza was offered at Syed Sahib's shrine at Sonawar. From theme the funeral procession left for Malakah cemetery, but not before another jenaza being offered at Kathidarwaza, with Nakzi's old neighbours insisting on that.

The burial took place well before Friday prayers and thus came an end to an era which in! Kashmir literature will be written in golden letters, not be forgotten ever.

Hardly few minutes before his end came, Nazki, who had written epitaph of thousands of men of letters, politicians and friends, penned his own epitaph down, in Kashmiri and handed it over to his poet son Faroog Nazki. The epitaph not only communicates his date of death but also of his infinite love for Prophet Mohammed (SAW) as he begged of His mercy. "The end is nearing, and this sweating on my body, this is the last time you will see it" Nazki is said to have told one of close friends Qazi Ghulam Rasool, who happened to be with him at the time of death. In his epitaph, Nazki is said to have written about all the details regarding his last rites, asking his son Farooq to abide by his directions strictly.

# Iran Confirms Second Round Of Nuclear Talks With The US Will Be In Rome

# More Than 130 Students In US Join Federal Lawsuit **Over Revoked Visas**

# **School Education Dept Faces Acute Shortage Of Teaching Staff**

SRINAGAR: The School Education Department has acknowledged a severe shortage of teaching personnel and urged administrative bodies to avoid deploying teaching and nonteaching staff in non-academic roles, stating it disrupts the education process.

Financial Commissioner (Additional Chief Secretary) School Education Department, Shantmanu, in a formal communication, highlighted that teaching staff were being deployed by Deputy Commissioners in administrative offices without approval or prior information to the Education Department. "The primary duty of the

teaching staff is to impart quality education, and such deployments divert them from their core role," Shantmanu noted. He emphasized that the department already faces acute TEACHER

staff shortages and warned that this administrative practice hampers students' academic progress. All Deputy Commissioners have been directed to restrict such deployments and maintain the operational integrity of educational institutions.

Shantmanu added that if there is any specific requirement of staff for administrative tasks, the matter should be routed through the Directorate of School Education or the administrative department for proper handling.

## **One-Time Relaxation In Age Criteria For Class-1 Admissions**

SRINAGAR: In a key decision, the School Education Department on Thursday announced a one-time relaxation for determining the minimum age for admission to Class 1st in Jammu Division for the 2025-26 aca-

demic session. Financial Commissioner Shantmanu said the minimum age will be reckoned as of September 30, 2025, for the upcoming session. However, from the academic session 2026-27 onwards, the age will be reckoned as of March 31 of the respective year.

This decision follows requests and representations concerning age eligibility in the context of the National Education Policy (NEP) 2020, which mandates a minimum age of three years for pre-primary enrollment.

The relaxation is intended to accommodate children enrolled in Nursery during the 2022-23 session. The directive applies to all educational institutions in Jammu Division, except for winter zones.

Shantmanu stressed strict compliance to ensure a smooth admission process and reiterated that no further relaxations will be granted post-2026-27.

The event witnessed enthusiastic participation from CRPF personnel, with around 50 individuals stepping forward to donate blood. A total of 50 blood units were collected during the



# Waqf: A Welcome Pause

he Supreme Court's observations and interim intervention in the implementation of the amended Waqf Act, 2025, mark a timely and necessary pause. The central government, on its part, has told the Court that it will put on hold at least two contentious provisions of the Waqf Act, 2025- the concept of 'waqf-by-user' and representation of non-Muslims on waqf boards till the next week. This is an acknowledgement of the fact that in a pluralistic society like India, religious sentiments of any community need to be handled with sensitivity and care.

The backlash against the amended law hasn't come out of nowhere. It reflects real anxiety and unease among many in the Muslim community. The provision of waqf-by-user, which says that land can be treated as waqf if it's been used for religious or charitable purposes over time — even without official records - is a legal grey area. In a land where property disputes already drag on for decades, where documentation is patchy at best in many places, this clause opens the door to more confusion, conflict, and perhaps even social unrest.

Then there's the matter of appointing non-Muslims to waqf boards. While representation is generally a good thing in public institutions, religious bodies work a bit differently. For many Muslims, the waqf is not just another administrative structure - it's deeply tied to faith, to history, to a community's way of giving back. Having outsiders manage or influence its working feels intrusive, even disrespectful. These are not just political or legal concerns - they touch something much more emotional and personal.

To its credit, the government has promised the Court that it won't move forward with these changes until a proper hearing happens. This is a welcome gesture. But more than legal back-andforth, what is needed now is honest conversation. Reforms, if they are genuinely meant to improve transparency and governance, should be discussed openly with the people they impact the most.

And one can hope that the central government has good intentions and wants to do right by the Muslim community. There's certainly the need for reform in Waqf. It is important to know what happens to the large amounts of money collected at the Waqf administered religious places and institutions. Also, the Muslim leaders need to introspect whether the Waqf properties have been used for the welfare of the community. More specifically, whether they have been used to build hospitals and educational institutions. That said, the inefficient use of resources or corruption is not just limited to Waqf but something that afflicts religious bodies across the communities. So to pick up Waqf selectively for reform is a decision that the government should reconsider. For now, the case is in the Supreme Court and we can hope that its decision will address the fears of the Muslim community and, meanwhile, the government too would make efforts in this direction.

# **America Self-Destructs**

ambition to assert US sovereignty over Canada, Greenland, and the Panama Canal, even as his embrace of geopolitical spheres of interest effectively legitimizes efforts by other powers – Israel and Turkey in Syria, Russia in Ukraine – to seize territory by force **W** S President Donald Trump is not known for respecting science and history. From promoting unproven treatments for COVID-19 to insisting that any discussion of shameful elements of America's past is "divisive," he prefers to manipulate them for political ends. One wonders

whether he realizes, when he waxes nostalgic about America's historical "greatness," that he is usually referring to times when the United States was a geopolitical weakling.

Trump's invocation of the Monroe Doctrine is a case in point. When President James Monroe asserted in 1823 that the Western Hemisphere was solely the domain of the US, America was far from establishing itself as a global power. And while it has been used to rationalize US intervention and imperialism since then, Monroe's original vision was focused on keeping European colonialism at bay. It certainly elections, in one of the biggest partisan swings in US history. The tariffs also indirectly contributed to the Panics of 1890 and 1893, which, at the time, was the worst economic downturn the US had ever experienced.

Invoking the era before 1913, when the federal income tax was introduced, Trump has also floated the idea of using tariffs to finance the entire US government budget. This reflects not only a gross misunderstanding of how tariffs work – Commerce Secretary Howard Lutnick says it would amount to "let[ting] all the outsiders pay," even though tariffs are paid by importers – but also a total disregard for historical experience and mathematical reality.

Tariff revenues could not cover the US government's expenses in the early 1900s, and they certainly could not do so today, no matter how many civil servants the unelected billionaire Elon Musk and his Department of Government Efficiency renowned scientific research institutions, including the National Science Foundation, the National Institutes of Health, the Department of Energy, and the National Oceanic and Atmospheric Administration. As the US cuts funding for research and development, China is pouring money into it, having invested \$52 billion in R&D last year – up 10% from 2023.

Moreover, the Trump administration is dismantling US foreign-aid programs, including the US Agency for International Development (USAID), a leading tool of US soft power. Trump has also withdrawn the US from the World Health Organization and the Paris climate agreement, while embracing coercive bilateral deal-making, such as his effort to control Ukraine's endowment of critical minerals.

The US appears eager to turn even Europe, its closest partner, into an enemy, potentially driving it to pursue deeper engagement with China. In light of its

# The Spy's Shadow **Over 370**



An ex-intelligence chief's revelation about secret political backing for Article 370's abrogation puts Kashmir's oldest party in the crosshairs of public anger and historical reckoning.

The political discourse in Jammu and Kashmir has entered yet an-

other phase of disillusionment. In a recent media interview tied to the release of his new book The Chief Min-ister and The Spy, former RAW chief A.S. Dulat dropped a bombshell: Farooq Abdullah, the patriarch of the Na-tional Conference (NC), had "secretly backed" the abrogation of Article 370.

It's the kind of statement that could be dismissed as political sensationalism, except Dulat backs it with detail. On page 208 of the book, he writes that Farooq told him in 2020, "Maybe the NC could even have had the proposal passed in the legislative Assembly in Jammu and Kashmir. 'We would have helped,' he told me. 'Why were we not taken into confidence?'" The passage landed like a thunderclap in a region still reeling from the constitu-tional move of August 5, 2019. The NC quickly denied the claim,

but for many Kashmiris, Dulat only confirmed what they had long suspected: betrayal from within.

The recent election campaign led by Aga Ruhullah Mehdi revived public hope. The NC had promised that the first business of the Assembly would be to pass a resolution opposing the abrogation of Article 370. But when the legislative agenda was released, the resolution was missing. It was PDP MLA Waheed ur Rehman Parra who introduced one, only to be shut down by the Speaker under the bizarre pretext that he couldn't hear it amid the noise. Yet visuals from the session showed

the Speaker calmly reading the reso-

lution. When social media outrage followed, the Assembly scrambled to introduce a watered-down version the next day. It made no mention of August 5, 2019. It didn't condemn the revocation. It was a resolution in name only.

The confusion deepened when the Congress's state president, an NC ally, emerged from the session and claimed the resolution was about restoring statehood, not Article 370. Public rage only intensified. While some NC MLAs attempted damage control on social media, their explanations fell flat. Even Aga Ruhullah later distanced himself from the language of the resolution.

Then came Omar Abdullah's curi-ous praise of Prime Minister Narendra Modi, adding fuel to the fire. His remark, "There are no clouds in the sky," struck many as tone-deaf and illtimed. The party's attempt to deflect blame onto the PDP was undone by Dulat's revelation, and by history.

This isn't the first time the Abdullahs have traded principle for power. L.K. Advani, in his memoir, recalls how Farooq gave up autonomy in exchange for a cabinet berth in the Vajpayee government. The legacy goes even further back, to Sheikh Abdullah's own compromises.

The writing is on the wall. The betraval didn't begin on August 5, 2019. That was merely the final signature on a deal decades in the making.

# When a Spy Becomes a Friend

The friendship between Farooq Abdullah and A. S. Dulat reveals something deeper about the way politics and power work behind the scenes.

In Kashmir, very little stays secret for long. But one story that has always puzzled peo-ple here is the strange and steady friend-ship between Dr Farooq Abdullah, the National Conference patriarch and A. S. Dulat, the former head of India's spy agency, RAW.

Their friendship is not new. It goes back to the 1990s, a time when Kashmir was caught in a storm of violence, fear and broken trust. Dulat was deputed by Delhi to try and understand the ground situation. But he did more than just observe. He started to build relationships. And the one he built with Farooq Abdullah became more than just a working connection.


They met often, spoke freely, and even laughed in each other's company. In his books, Dulat talks about how much he enjoyed Farooq's company. He calls him a man of charm, jokes and sharp thinking. Farooq, on his part, never denied the closeness. He welcomed Dulat into his home, even during times when others were not allowed in.

For many people in Kashmir, this closeness was hard to digest. Dulat was, after all, a spy. He was part of the system that many Kashmiris see as responsible for their pain. So why was the leader of Kashmir's oldest political party so friendly with him?

Some say Farooq trusted Dulat more than he trusted many Delhi politicians. Others believe Dulat was the only one who really listened. There are stories—now told openly—of latenight calls, quiet visits, and advice given when the National Conference was facing trouble. At times, it felt like Dulat was part of the party's kitchen cabinet.

This has not aged well. Today, people ask: what was really going on? Was this friendship just personal? Or did it affect political decisions? Did it help Delhi keep control of Kashmir through soft influence?

Dulat always says he believed in peace, and that the only way forward in Kashmir was



through dialogue. He says he never hid his friendship with Farooq, because it was based on mutual respect. That may be true. But in a place like Kashmir, where wounds run deep and history is full of shadows, even friendship can look suspicious.

Farooq has always been a survivor. He knows how to shift his stand, how to play the crowd, and how to keep doors open on both sides. That's part of his charm-and part of the reason why people don't fully trust him. His friendship with Dulat adds to that doubt.

The story of Farooq and Dulat is not just about two old men who liked each other's company. It is about the quiet ways in which power moves. It is about the blurred lines between personal and political. And it is a reminder that in Kashmir, even friendship is never simple.

# **Kashmiri Volunteer's Mission Medicine**

In Srinagar, flouting traffic laws has long been routine until technology made it harder to hide.

knew we were in trouble the moment I saw that blue uniform. The traffic cop was glued L to his phone, but it wasn't for scrolling Instagram – he was taking pictures. A moment later, my brother confirmed it: "He booked us with a chalan.

And just like that, our idyllic plan to breathe in the spring air at Badam Vaer turned into a thousand-rupee setback. My brother got the message: Pillion rider without crash helmet. Fine: Rs 1000. Section 129 of the Motor Vehicles Act had officially ruined my mood.

Yes, I knew the rules had tightened in the Val-ley. My brother had even reminded me to wear a helmet. But I struggle with severe anxiety – the weight of a helmet on my head or anything tight around my neck makes me feel like I'm suffocating. So, I carried it in my hand, hoping I could throw it on if we spotted a cop in time. But who can outrun technology these days?

In Kashmir, bending traffic rules has been second nature. Growing up, there were rarely zebra crossings. Cars never paused for pedestrians. We crossed roads like dodging bullets – pure instinct. It's not that we're lawless; it's more that the law never felt real. I'd call it a mutual understanding between drivers and traffic police.

I even owe part of my education to this un-

spoken system. Back in 2017, when my mental health made hostel life impossible, I convinced my father to get me a scooter. No license. No number plate. No helmet. But I rode to class every day, guilt wrapped around me like a shawl. It was wrong, yes. But I told myself: this was about a girl's education. That scooter was my ticket to independence.

Ironically, it was only after Mr Basant Rath be-came IG of Traffic that things changed. He brought a level of discipline we weren't ready for – and we both hated and admired him for it.

Now, enforcement is smarter, quicker. A phone camera is enough to book you. Still, some lessons come with grace. Once, I jumped a red light after a long day of tuition, assuming it was harmless. A man, old enough to be my father, gently pulled up beside me and said, "My dear, don't break signals." I never did again.

So yes, I got fined. But the photo – me in shades, peeking from behind my brother, helmetless – is kind of iconic. "A thousand bucks for a memory," I ioked

Maybe that's how Kashmir changes - not all at once, but in small, personal reckonings. And maybe, just maybe, that traffic cop's photo was exactly what I needed.

After years of volunteering in hospitals, a Srinagar Samaritan has opened a discount pharmacy — and a lifeline for those who can't afford treatment.

'n a quiet corner of Baghat, Srinagar, far from the chaos of hospital corridors, a modest medical store is trying to do something un-usual – put care before commerce. At Qadri Haq Medicate, the man

behind the counter, Sheikh Tassaduk Amin, knows most of his customers by name. He knows which ones are battling cancer, whose dialysis is due next week, and who's struggling to pay for their monthly prescriptions. Every customer gets an 18 percent discount – no paperwork, no proof of poverty. "It's simple," he says. "People are sick. They need help. We do what we can."

But this shop isn't just about dis-counts. It's the next chapter in a story that began nearly a decade ago – when Tassaduk, now in his thir-ties, saw his own father wrestle with liver disease. The struggle to manage medications, the endless waiting in hospital lines – it stayed with him. His father survived. The experience changed his son.

In 2016, during one of the most violent summers Kashmir has seen, Tassaduk stepped up. As protests erupted and hospitals overflowed with the injured, he joined a local volunteer group called Help Poor and camped inside Srinagar's main hospital for weeks. While others ran for cover, he stayed - fetching medicines, coordinating care, comforting patients' families. He wasn't a doctor, but he was often the one people turned to when doctors weren't around.

"It was chaos," he remembers. "But in that chaos, I found my calling.'

Since then, Tassaduk has become a familiar face in Kashmir's shadow



healthcare network - a volunteer who shows up when systems fall short. Need a blood donor at mid-night? He'll find one. Can't afford a scan? He'll try to arrange it. Life-saving drugs like chemotherapy injections or immunosuppressants aren't available in his shop yet, but through his work with Help Poor, he helps desperate families source them from wherever possible – Delhi, Amritsar, even Mumbai.

"We get calls from everywhere," he says. "People hear there's someone in Srinagar who can help. That's enough for me."

He's hoping to eventually stock those high-cost, critical medicines at his store – not just to sell them, but to make them more accessible, especially for poor and terminally ill patients who often have nowhere else to turn. "We're working on it,"

he says. "It'll take time. But we'll get there.'

The store itself is small - just enough room for a counter, shelves, and a few waiting chairs. But it's the tone that sets it apart. There's no upselling. Just quiet service and a phone that doesn't stop ringing.

For Tassaduk, this is more than business. It's personal. It's about the people he's met in hospital wards, the families he's sat with during endless waits, the patients who whisper "thank you" even when the help is small.

In a place where healthcare often feels out of reach, Tassaduk Amin is doing what the system can't – showing up, sticking around, and reminding people that compassion still has a place behind the counter.

# 'No Evidence Technology Causes 'Digital Dementia' In Older Adults'

In the 21st century, digital technology has changed many aspects of our lives. Generative artificial intelligence (AI) is the latest newcomer, with chatbots and other AI tools changing how we learn and creating considerable philosophical and legal challenges regarding what it means to "outsource thinking".

But the emergence of technology that changes the way we live is not a new issue. The change from analogue to digital technology began around the 1960s and this "digital revolution" is what brought us the internet. An entire generation of people who lived and worked through this evolution are now entering their early 80s.

So what can we learn from them about the impact of technology on the ageing brain? A comprehensive

new study from researchers at the University of Texas and Baylor University in the United States provides important answers.

Published today in Nature Human Behaviour, it found no supporting evidence for the "digital dementia" hypothesis. In fact, it found the use of computers, smartphones and the internet among people over 50 might actually be associated with lower rates of cognitive decline.

#### What is 'digital dementia'?

Much has been written about the potential negative impact from technology on the human brain.

According to the "digital dementia" hypothesis introduced by German neuroscientist and psychiatrist Manfred Spitzer in 2012, increased use of digital devices has resulted in an over-reliance on technology. In turn, this has weakened our overall cognitive ability.

Three areas of concern regarding the use of technology have previously been noted:

An increase in passive screen time. This refers to technology use which does not require significant thought or participation, such as watching TV or scrolling social media. Offloading cognitive abilities to

technology, such as no longer memorising phone numbers because they are kept in our contact list. Increased susceptibility to distraction.

#### Why is this new study important?

We know technology can impact how our brain develops. But the effect of technology on how our brain ages is less understood.

This new study by neuropsychologists Jared Benge and Michael Scullin is important because it examines the impact of technology on older people who have experienced



significant changes in the way they use technology across their life. The new study performed what

technology use in people aged over 50 and examined the association is known as a meta-analysis where with cognitive decline or dementia. the results of many previous stud-They found 57 studies which inies are combined. The authors cluded data from more than 411,000

searched for studies examining

adults. The included studies measured cognitive decline based on lower performance on cognitive tests or a diagnosis of dementia

#### A reduced risk of cognitive decline

Overall, the study found greater use of technology was associated with a reduced risk of cognitive decline. Statistical tests were used to determine the "odds" of having cognitive decline based on exposure to technology. An odds ratio under 1 indicates a reduced risk from exposure and the combined odds ratio in this study was 0.42. This means higher use of technology was associated with a 58% risk reduction for cognitive decline.

This benefit was found even when the effect of other things known to contribute to cognitive decline, such as socioeconomic status and other health factors, were accounted for.

# **Eating Almonds Daily Can Help Control Blood Sugar In Asian Indians: Study**

Consuming almonds daily can help control blood sugar levels in specific populations, such as Asian Indians, according to a research article.

Analysing previously published research on almonds and cardiometabolic health, an international team of researchers and physicians said almonds can help improve metabolic health by reducing 'bad' cholesterol and increasing beneficial gut bacteria.

Findings, published as a consensus article in the journal Current Developments in Nutrition, reinforce almonds' role as a heart-healthy, weight-supporting, and gut-friendly food, the team said.

The findings also reveal how almonds can potentially benefit specific populations such as Asian Indians, where rising rates of cardiometabolic diseases are a concern, study author Dr Anoop Misra, chairman of Fortis Centre for Diabetes, Obesity and

Consuming almonds was found to lower LDL, or 'bad' cholesterol by five units, and diastolic blood pressure in small but significant amounts of 0.17-1.3 mmHg. For Asian Indians with pre-diabetes, eating

Cholesterol, told PTI.

almonds daily can help reduce fasting blood glucose and HbA1C, the researchers said.

"The most current meta-analyses on almond consumption and various health-related endpoints suggest that almond consumption does not result in weight gain and results in small reductions in LDL cholesterol and diastolic blood pressure, as well as improved glycemic responses in certain populations (i.e. Asian Indians)," the study said.

Dr Misra said, "These benefits aid weight loss efforts by helping stabilise energy levels and reduce appetite fluctuations. When paired with balanced nutrition and physical activity, almonds can be a health-promoting part of a weight loss plan."

## Trade Recalibrations Worrisome; **India Will Focus On Policy Agility, Long-Term Vision: FM**



Press Trust Of India MUMBAI- Union Finance Minister Nirmala Sitharaman on Thursday said India will focus on policy agility and long-term vision to navigate the global challenges amid ongoing trade recalibrations worldwide.

The country offers investors policy stability, growth, prudent macroeconomic policies and democratic institutions, she noted.

The most effective path" for building economic resilience is to foster domestic efficiencies and competitiveness, Sitharaman said.

Acknowledging that the fi-nancial markets have been impacted as a result of the trade recalibration, she said India's financial markets have shown remarkable resilience despite recent global uncertainties. Stock markets globally have

faced turmoil ever since US President Donald Trump an-nounced sweeping tariffs on most nations, including India, earlier this month. The markets recovered some ground after the US government announced a 90-day pause on the imple-mentation of the reciprocal tariff.

Domestic institutional investors transition from lending a supportive hand to being a dominant force underlines the growing maturity and depth of India's capital market, she said. The finance minister said she appreciates how the retail investors have placed their faith in the markets today, and

# Markets Surge For 4th Day; Sensex Reclaims 78k-Level

**MUMBAI-** Benchmark indices Sensex and Nifty surged nearly 2 per cent on Thursday, registering their fourth day of rally as investors turned buoyant after foreign investors returned to domestic equities amid expectations of a breakthrough in US-Japan trade negotiations over reciprocal tariffs. The 30-share BSE benchmark

Sensex jumped 1,508.91 points or 1.96 per cent to reclaim the 78,000 level. It finally settled at 78,553.20. During the day, it soared 1,572.48 points or 2.04 per cent to 78,616.77.

As many as 2,427 stocks advanced while 1,522 declined and 157 remained unchanged on the BSE. The NSE Nifty surged 414.45 points or 1.77 per cent to 23,851.65. In four days, the BSE benchmark jumped 4,706.05 points or 6.37 per cent, and the Nifty surged 1,452.5 points or 6.48 per cent. "Benchmark indices posted sharp gains on Thursday to end

the week on a high note, posting four consecutive sessions of gains. Broader Mid and Small

caps also closed higher. "Markets opened lower on weak global cues after sharp overnight losses in US indices. After initial jitters, markets quickly bounced back to steadily climb higher throughout the day as the focus shifted to domestic factors and ongoing earnings. Banks continued to drive the benchmarks higher with private lenders leading the gains ahead of the earnings announcements," Satish Chandra Aluri, Analyst, Lemonn Markets Desk, said. From the Sensex firms, Eternal, ICICI Bank, Bharti Airtel, Sun Pharma, State Bank of India, Bajaj Finserv, Kotak Mahindra Bank and Reliance Industries were among the biggest gainers. On the other hand, Tech Mahindra and Maruti were the laggards.

The BSE midcap gauge climbed 0.56 per cent and smallcap index went up by 0.52 per cent.

All BSE sectoral indices ended higher. Bankex jumped 2.56 per cent, telecommunication (2.22 per cent), financial services (2 per cent), services (1.47 per cent), teck (1.19 per cent), energy (1.13 per cent), auto (1.01 per cent) and healthcare (0.91 per cent). Foreign Institutional Inves-

tors (FIIs) bought equities worth Rs 3,936.42 crore on Wednesday, according to exchange data. On Tuesday, FIIs bought equities for Rs 6,065.78 crore.

MUMBAI: The RBI on Thursday said banks can open/close rupee accounts (non-interest bearing) in the name of their overseas branches or corre-

pointed Li Chenggang, previously China's Ambassador at World Trade Organisation (WTO) as its new international trade representative signalling its intentions to open a dialogue with the US to discuss massive tit for tat tariffs slapped against each other.

A fact sheet on tariffs by the White House on Tuesday said China now faces up to a 245 per cent tariff on imports to the US as a result of Beijing's retaliatory actions of imposing 125 per cent levies against US imports.

The unit has pared all its losses since April 2, when US President Donald Trump announced sweeping reciprocal tariffs on multiple countries. On April 2, the rupee was

quoted at 85.52 against the US dollar. According to forex traders, a positive trend in domestic equities following a reprieve from the US tariffs boosted overall investor sentiment

even though some recovery in crude prices weighed down on the Indian currency. At the interbank foreign

exchange, the domestic unit opened at 85.48 and moved between the high of 85.31 and the low of 85.62 against the greenback during intraday. The unit ended the session at 85.38 against the dollar, logging a gain of 26 paise from its previous closing level.

The rupee closed Wednesday's session with a gain of 16 paise at 85.64 against the dollar.

In the preceding four sessions, the Indian currency has added 130 paise, or over 1.5 per cent, since its April 9 closing mark of 86.68 against the greenback.

The Indian currency witnessed one of the most substantial weekly appreciation fueled by an influx of overseas capital and a prevailing appetite for risk, said Dilip Parmar, Research Analyst, HDFC Securities.

"Fiscal spheres are responding favorably to developments concerning trade between the United States and China, while the 'China plus one' di-

dex, which gauges the greenback's strength against a basket of six currencies, was trading marginally lower by 0.09 per cent at 99.29.

Brent crude, the global oil benchmark, rose 1.21 per cent to USD 66.65 per barrel in futures trade.

Anuj Choudhary, search Analyst at Mirae Asset Sharekhan, said the rupee gained on surge in the domestic equities and FII inflows.

However, importer buying of dollars and recovery in crude oil prices may cap sharp gains, he said, adding "Traders may take cues from weekly unemployment claims and housing data from the US. USD-INR spot price is expected to trade in a range of 85.20 to 85.70."

On funding of accounts of non-resident banks, the RBI said banks may freely pur-chase foreign currency from their overseas correspondents/ branches at ongoing market rates to lay down funds in their accounts for meeting their bonafide needs in India.

However, transactions in the accounts should be closely monitored to ensure that overseas banks do not take a speculative view on the Indian Rupee (INR). Any such instances should be notified to the Reserve Bank.

The RBI also said forward purchase/sale of foreign currencies against the rupee for repatriation/ funding is prohibited.

### **European Central Bank Cut Interest Rates For** Seventh Time In Row **Associated Press**

FRANKFURT- e European Central Bank cut interest rates Thursday for the seventh time in a row to counter worries about economic growth fuelled by President Donald Trump's tariff onslaught. The bank said in a statement that "the outlook for growth has deteriorated due to rising trade tensions".

It cited "exceptional uncertainty" about the future economic situation, saying future rate decisions would be taken on a meeting by meeting basis. The bank's move should support economic activity in the 20 countries that use the euro currency by making credit more affordable for consumers and businesses.

The bank's rate-setting council decided at a meeting in Frankfurt to lower its benchmark rate by a quarter percentage point to 2.25%. The bank has been steadily cutting rates after raising them sharply to combat an outbreak of inflation from 2022 to 2023.

Now that inflation has fallen, growth worries have taken centre stage. The economy in the 20 countries that use the euro grew a modest 0.2% in the last three months of 2024. Inflation was 2.2% in March, close to the bank's target of 2%.

# **Borrowers To Benefit From Intro Of** 'Blended Interest Rates': Icra

**NEW DELHI-**Rating agency Icra on Thurs-day said borrowers would benefit from the introduction of 'blended interest rates' for co-lending and sourcing arrangements as proposed by the Reserve Bank of India's draft framework.

On April 9, 2025, the RBI came out with a draft framework for co-lending and sourcing arrangements to cover a wide-ranging variety of arrangements among regulated entities (REs), which were not expressly covered in the past.

The draft framework also offered enhanced coverage of all asset segments vis-àvis only priority sector lending (PSL) in the past

This draft framework gains prominence given that the size of co-lending transactions have been witnessing robust growth over the past few years, the agency said.

According to the Icra report, the comprehensive scope of the proposed framework is set to provide clarity and guidance on permitted arrangements.

All categories of sourcing and co-lending

arrangements, with certain exceptions, are covered under the draft directions; this would significantly increase clarity for REs and re-shape the way such arrangements currently operate.

"Borrowers to benefit from introduction of 'blended interest rates' as draft directions propose to shift to a blended interest rate, which is calculated as an average rate of interest derived from the interest rates charged by respective funding REs, weighted by their proportionate funding shares," it said.

Under the proposed co-lending arrangements, Icra added that asset classification by the regulated entities shall be applicable at the borrower level.

This implies that if any of the regulated entities classifies their exposure as SMA (Special Mention Account)/NPA (Non-Performing Asset), the same classification shall be applicable to the exposure of other regulated entities as well, it said, adding that this will bring clarity on reporting of asset classification.

"In a nutshell, the draft framework is set to usher in greater operational flexibility for NBFCs but stricter compliance on default loss guarantees (DLGs) and disclosures," Icra said.

low, especially in areas that usually see tens of meters of snow." According to satellite data, many high-altitude regions in Kashmir and the western Himalayas have witnessed significantly less snowfall this season.

This shortfall in snowfall could lead to more than just immediate water shortages. Dr. Rashid highlighted that a reduced snow cover would also result in accelerated glacier melt. "When snow cover is reduced, glaciers lose their protective shield earlier in the season, exposing ice to warmer temperatures. which leads to faster melt rates," he explained. "This poses a long-term risk to the region's water security." The timing of snowfall is crucial. Dr.

Rashid emphasized that snow during the core winter months is vital. as it lasts longer and provides more consistent water flow throughout the year. "Even late snowfall in areas like Gulmarg or Zojila won't compensate for what's been lost earlier in the season," he said. "The snow deficit this year could significantly affect water flow during the peak summer and autumn months."

However, Dr. Rashid said that if western disturbances bring substantial precipitation in the coming months, the region's natural water reservoirs might still hold up. Meanwhile, officials from the Irrigation and Flood Control (I&FC) Department have acknowledged the low snowfall but assured that the situation is under control for now. A senior I&FC official stated, "At the moment, our water levels, including those in the Jhelum, are within normal range, and we don't foresee any immediate water shortages. However, if rainfall during March, April, and May is below average, it could lead to problems with drinking water and irrigation." The official further emphasized that contingency plans are in place to address potential shortages. "We are better prepared this year than last. Last year was difficult, but we managed without major disruptions. Ultimately, it will depend on the weather over the next few weeks." Adding to the concern, unusually high temperatures this early in the year have further exacerbated the situation. Dr. Rashid pointed out that Srinagar recently reached 30 degrees Celsius, the second-highest temperature recorded this season. "If these temperatures persist, it will accelerate the snowmelt and further deplete glaciers," he said. (inputs from KNO)

The apex court, while hearing the matter on Wednesday, proposed to stay certain key provisions of the Act, including the power to denotify properties declared as wagf by courts and inclusion of non-Muslims in central waqf council and boards.

On Thursday, Mehta asked whether the court might consider staying, directly or indirectly, the Act based upon some prima facie or tentative reading of some of the sections.

"If your lordships are going to stay a statutory provision," Mehta said, "it by itself is rare. We will have to take your lordships to the history of legislation, followed by amendment".

He said the government received several representations, which ultimately resulted into the amended Act. Opposing the stay, the law officer

Arsenal look set to qualify, but the five clubs below them are battling for the three other places.

Third-placed Newcastle United (59 points) visit seventh-placed Aston Villa (54) on Saturday while fourth-placed Nottingham Forest (57) are away at Tottenham Hotspur on Monday. Outgoing champions Manchester City (55) are currently hanging on to fifth place but can illafford any slip-ups at a rejuvenated Everton on Saturday.

Chelsea (54) have slipped down to sixth place after successive draws and, with a tough-looking run-in, will be desperate for a victory at Fulham on Sunday.

Bournemouth, Fulham and Brighton and Hove Albion are all still harbouring hopes of qualifying for Europe. Bournemouth are at Crystal Palace on Saturday while Brighton visit Brentford.

Fourteenth-placed Manchester United are on course for their worst finish since 1990 and Ruben Amorim's side will seek to snap a three-match winless run in the Premier League as they host Wolves on Sunday.

# Wounded Real Madrid Look For **Domestic Success After CL Exit**

s Real Madrid lick their Awounds following a humbling Champions League quarter-final exit, coach Carlo Ancelotti must rally his troops as they look to reel in LaLiga leaders Barcelona.

Reigning European champions Real were crushed 5-1 on aggregate by Arsenal without really offering a threat over two legs, a major cause for concern as Real trail Barcelona by four points in LaLiga.

What will worry Ancelotti more is that his side have won one of their last five matches in all competitions -- a 1-0 vic-

tory over relegation-threatened Alaves last weekend.

Kylian Mbappe, Real's top scorer this season with 33 goals in all competitions, saw red in that game and the Frenchman will be suspended for Sunday's home match against Athletic Bilbao, who are fourth in the standings.

Real must hope that Barcelona drop points against Celta Vigo the day before or they will be staring at a sevenpoint deficit to the leaders before they face Athletic, a team that have lost just once in their last 22 league games and beat them 2-1 in December.

Little wonder then that Ancelotti's job hangs by a thread ahead of the Copa del Rey final later this month - a Clasico against Barcelona. "It could be this year, next year when my contract runs out (in June 2026)... There's no problem about it," Ancelotti said when asked about his future as Real's manager.

"But when I am done here, I will be grateful to this club. It could be tomorrow, in one year, or in 10 years, but I will be grateful to this club. And that's it, full stop. "We have done very well in


the last seasons but this year we have had to suffer. Things haven't gone as expected, but in sport it happens because there are no unbeatable teams."
