'Indian Attack Imminent': Pak Defence Minister

Srinagar: Pakistan's defence minister, Khawaja Muhammad Asif, claimed on Monday that a military incursion by India was imminent in the aftermath of a deadly terror attack on tourists in Jammu and Kashmir's Pahalgam last week.

Tensions have been high between the two nuclear-armed nations since the attack that killed 26 people and triggered outrage in the country. There have been several calls for action against Pakistan.

"We have reinforced our forces because it is something which is imminent now. So in that situation, some strategic decisions have to be taken, so those decisions have been taken," Defence Minister Khawaja Muhammad Asif told Reuters in an interview at his office in Islamabad.

'Spotted, Cornered, Gone' **The Silent Chase** For The Pahalgam Killers

Srinagar: Five days after a bloody attack in Pahalgam's Baisaran meadows left 26 people dead, four terrorists are still on the run, and the forces are chasing them through the thick forests of South Kashmir.

According to The Indian Express, security teams managed to locate the attackers not once, but at least four times. Every time, they slipped away. Once there was even an exchange of fire deep inside the woods. But it ended the same

way: with the killers vanishing into the forest Sources told IE said the terrorists were tracked down

using a mix of local tips,

intelligence feeds, and endless foot patrols.

But tracking someone in these woods is nothing like chasing them in the open. Visibility drops, gunfire echoes off the trees, and the terrain eats up time.

"It's a cat and mouse game," an officer told the newspaper. "Sometimes we almost have them. Sometimes we see them. But they're gone before we can close in. It's thick forest. You can lose a man five feet away from you."

The first real sighting came near Hapat Nar village. Forces rushed in. But between the trees and the rocky gullies, the attackers melted away.

Later, they popped up again in the forests of Kulgam. A brief firefight broke | More on P6

Up To 7 Yrs Jail For Illegal Bird Trade: Wildlife Deptt

Srinagar: Wildlife Department Kashmir has warned against the sale, purchase, or possession of Scheduled birds, calling it a criminal offense under the Wild Life (Protection) Act, 1972.

As per an official communication issued from the office of Wildlife Warden, Wetlands Division Kashmir, Srinagar it has been informed that any individual or bird vendor found engaging in such activities will be subject to legal action.

As per Section 51 of the Wild Life (Protection) Act, 1972, any person who contravenes the provisions of this Act shall be punishable with imprisonment for a term which may extend to seven years or with a fine up to Rs. 01 lakh, or both.

If the offense involves a bird specified in Schedule I, the punishment shall be not less than three years and may extend to seven years, along with a fine of at least Rs. 25000.

If the offense involves a bird specified in Schedule II, the punishment shall extend up to three years, along with a fine of at least Rs. 25000.

It has come to the notice of Wildlife authorities that some of the Birds listed under Schedule I & Schedule II are being traded by the vendors or possessed for bird keeping which is strictly prohibited.

Individuals who are currently in possession of any of the Scheduled birds are urged to surrender them voluntarily at the nearest wildlife facility to avoid legal consequences. The authorities will ensure proper rehabilitation and care of the surrendered species.

New Delhi: You are constructing huge highways but people are dying there because of lack of facilities, the Supreme Court on Monday said as it pulled up the Centre over the delay in formulating a cashless scheme for treating motor accident victims.

A bench of Justices Abhay S Oka and Ujjal Bhuyan observed that despite its January 8 order, the Centre neither complied with the direction nor did it ask for an extension of time.

The top court said though Section 164A of Motor Vehicles Act was brought into force on April 1, 2022 for a period of three years, the Centre did not implement it by framing the scheme for the interim relief to claimants.

"You are in contempt. You have not bothered to seek extension of time. What is this going on? You tell us when will you frame the scheme? You don't care for your own statutes. This is one of the welfare provisions. Three years (since) this provision has come into place. Are you really working for the welfare of common

man?" the bench asked. "Can you be so casual? Are you not serious about this provision? People are dying in road accidents. You are con-

structing huge highways but people are dying there because there is no facility. There is no scheme for golden hour treatment. What is the use of constructing so many highways?" the top court questioned the secretary of the Ministry of Road Transport further.

The golden hour under Section 2 (12-A) of the Motor Vehicles Act, 1988 refers to a one-hour window following a traumatic injury under which a timely medical intervention will most likely prevent death.

India, France Sign Deal For 26 Rafale-Marine Jets

India and France on Monday inked an intergovernmental agreement to procure 26 naval variants of Rafale fighter jets at a cost of around Rs 64,000 crore for the Indian Navy.

The pact provides for setting up of a production facility for Rafale fuselage as well as maintenance, repair and overhaul facilities for aircraft engines, sensors and weapons in India, according to the defence ministry. The agreement will also facilitate the transfer of technology for the integration of indigenous weapons in India, it said without elaborating. The ministry said the delivery

of the aircraft would be completed by 2030, with the crew undergoing training in France

and India. India is procuring the jets for deployment on board aircraft

carrier INS Vikrant. Manufactured by French defence major Dassault Aviation, the Rafale-Marine is a carrier-borne combat-ready aircraft with proven operational capabilities in the maritime environment.

The sealing of the mega deal

to start around five years after the signing of the contract. In July 2023, the defence ministry accorded the initial approval for the mega acquisition

The chill of fear has extended beyond the immediate aftermath of the Pahalgam attack, gripping the livelihoods of countless individuals across Kashmir. In Srinagar, the usually bustling Dal Lake now sees fewer shikaras ferrying tourists, and the vibrant handicraft emporiums along its banks wear a deserted look. "This is our season," said a houseboat owner on Dal Lake.

"These cancellations are a disaster for families like mine who depend entirely on the summer months to earn a living. How will we sustain ourselves now?" Similar sentiments echo through the deserted streets of Pahalgam and the silent hotels of other tourist spots, painting a grim picture of the economic repercussions.

Tourist destinations along Kashmir's border regions, including Keran, Gurez, and Uri, have also seen a significant decline in visitor numbers. The ongoing security concerns and heightened tensions along the LoC have deterred many tourists from visiting these oncepopular areas.

An estimated 80-90% of hotel and travel bookings for Kashmir in the upcoming months (April-August) have been cancelled following the attack. Thousands of bookings scheduled for August alone have been called off across the valley.

Major tourist destinations across Kashmir are experiencing empty taxi stands, vacant hotel rooms, and deserted restaurants.

Chief Minister Omar Abdullah acknowledged the fear among tourists but urged them not to leave, stating that doing so would allow the "enemies" to win. Tourism industry leaders are appealing for calm and urging tourists not to let fear overshadow the safety of key destinations.

Actor Atul Kulkarni visited Kashmir and appealed to people to visit the state in large numbers as an act of defiance against terrorism.

Abdullah further said he had no words to apologise to them. "What could I have told a child whose father was stained with blood wounds, or to the woman who was just married? They were seeking answers as to what their mistake was, as they had come for the first time to enjoy holidays in Kashmir." he said.

Underlining the impact of the ghastly attack on the entire country, he said, "From north to south and from east to west... from Arunachal to Gujarat and Jammu and Kashmir to Kerala... the entire country has been affected by this attack.

The need to remain united in the face of this attempted division cannot be overemphasised," the resolution said.

It appealed to all states and Union territories to ensure the safety, dignity and well-being of Kashmiri students and citizens residing or travelling there, and to take all necessary measures to prevent their harassment, discrimination or intimidation.

"This House calls upon all political parties, religious and community leaders, youth organizations, civil society groups, and media houses across the nation to maintain calm, reject violence and divisive rhetoric, and work collectively to uphold peace, unity, and constitutional values," the resolution stated.

Speaking on the issue, Speaker Abdul Rahim Rather emphasized the urgent need for all members of the House to collaborate in creating a safe and conducive atmosphere for tourists.

He called upon everyone to unite in honouring the families who have lost their loved ones, ensuring their sacrifices are not in vain. He stressed the importance of unity in emerging stronger together.

Mirroring New Delhi's steps, Islamabad ordered the expulsion of Indian diplomats and military advisers, cancelled visas for Indian nationals and barred its airspace to Indian airplanes.

"How can I leave my husband here. I have built a house here. We came here because of the government's policy ... What have we done? What is our fault in this? We have election card, Aadhar card. I have voted in elections." she said.

With tears rolling down her cheeks, Rafiqa appealed to Jammu and Kashmir Lieutenant Governor Manoj Sinha to let them live in Kashmir -her home for the last 12 years.

"I appeal to the Governor sahib, please do not be cruel to us. We have not committed any sin. Please let us live here. If not, then kill us and send our bodies across the border," she said.

Zahida Begum, another such Pakistani woman, said she wants to live in peace, in Kashmir.

"Police have asked me to leave. I do not want to go back. I have two daughters, Maryam and Aamna. My son, Faizan, is 10 and they are telling me to keep him here. I do not want to go back, please forgive me. I want to live here," she said.

Begum showed up her domicile certificate, Aadhar, election card, and ration card, which she said were issued by the government.

"It will ruin the lives of my children. I have been living here for 15 years, I have lived a good life and I want to live in peace. Even my children do not want to go back," she said.

Most of these women had married former Kashmiri militants who had crossed over to Pakistan or Pakistan-Occupied Kashmir (PoK) for arms training during the height of militancy in the 1990s and early 2000s.

Over the years, many militan

attackers were already gone. No trail. No witnesses.

The geography isn't helping either. Kishtwar range, which should have been buried under snow, is open this year. Without the snow, it's just another way out – a hidden route south toward the thicker jungles of Jammu. It's a harder place to track and a softer target for infiltrators.

There's a front door to Kashmir, and there's a back door through Jammu," another officer said. "And that back door isn't locked as tight."

For now, the forces are betting that pressure will break the attackers. That one mistake – one call, one careless move - will give them away.

Two stolen mobile phones from the tourists they killed might be the key. Intelligence agencies are watching closely for any signal, any cross-border message.

But until that slip happens, the forests of South Kashmir are still hiding the men who tore apart a peaceful meadow just days ago. And the hunt goes on.

"On the recommendations of the Ministry of Home Affairs, the Government of India has banned Pakistani YouTube channels for disseminating provocative and communally sensitive content, false and misleading narratives and misinformation against India, its Army and security agencies in the backdrop of the tragic Pahalgam terror incident in Jammu and Kashmir," officials said.

In a missive to BBC India head Jackie Martin, the MEA conveyed the country's strong sentiments over the reporting on the Pahalgam terror attack. It objected to the description of terrorists as "militants" in its reporting on the Pahalgam tragedy.

In one news flash, the BBC said, "Pakistan suspends visas for Indians after deadly Kashmir attack on tourists". This was flagged by the government as objectionable.

"A formal letter has been sent to the BBC on terming terrorists as militants. The External Publicity Division of the MEA will be monitoring the reporting of the BBC," an official added.

The government has also blocked a message doing the rounds on VhatsApp terming it as "misleading". The message talked about the contribution of one rupee every day for "modernisation of the Indian Army and for soldiers who are injured or martyred in the war zone".

The Pakistani military has resorted to unprovoked firing across the Line of Control (LoC) in the last four days and Indian troops responded to them effectively.

After the terror attack, India announced a raft of punitive measures against Pakistan on Wednesday, including suspension of the Indus Waters Treaty, shutting down of the only operation land border crossing at Attari and downgrading of diplomatic ties

In response, Pakistan on Thursday shut its airspace to Indian airliners and suspended all trade with India. including through third countries. Pakistan rejected India's suspension of the Indus Waters Treaty and said any move to stop the flow of water would be seen as an "act of war".

that statehood be restored as a means to strengthen the fight against terrorism. Responding to them, Abdullah said the National Conference (NC) had raised the demand for statehood restoration earlier and would continue to do so through appropriate channels, but not by exploiting a tragedy.

"This time there will be no politics on anything, including statehood and business rules, except the condemnation of terror and solidarity with the families," he said. "Curse be on me if I go to the Centre and push for statehood at this moment.'

Abdullah also announced a dedicated helpline for students and other residents of Jammu and Kashmir studying or working outside the Union Territory.

"The students faced some problems outside the UT after the terror attack. Nobody can deny that. I am thankful to the state governments which acted promptly to normalize the situation," he said.

He praised his cabinet colleagues-Surinder Choudhary, Sakina Itoo, Javed Rana, Satish Sharma, and Javed Ahmad Dar-for rushing to different states on short notice to meet officials and ensure the safety of students and businessmen.

The chief minister said the helpline would allow students and businessmen to register concerns for timely government intervention, although he hoped such situations would not arise again.

Abdullah also issued a stern warning against the spread of misinformation on social media in the aftermath of the attack.

"While 90 percent of people are upholding the truth, there are 10 percent trying to spread falsehood. I warn them to desist immediately as we will not tolerate the spread of falsehood," he said.

Earlier, CPI(M) leader M Y Tarigami and independent legislators Muzaffar Iqbal Khan, Sheikh Khurshid, and Shabir Ahmad Kullay had called for the immediate restoration of statehood. Tarigami stressed that empowering the people through statehood was critical to fighting terrorism effectively. He also criticized the demolition of houses linked to suspected

Abdullah said the attack on civilians in Pahalgam took place after a gap of 21 years. "We thought such attacks were a story of the past. Unfortunately, this (Pahalgam) attack has recreated a situation we hoped had been left behind. We never know when another such attack might take place. I do not have the words to seek forgiveness from the families who lost their dear ones." he said.

The chief minister, however, noted that even in the face of this inhuman and dastardly attack, a new ray of hope has emerged from Kashmir.

[•]For the first time in many years, I witnessed protests that were truly unified. No political party or leader orchestrated them, and no organised banners or candlelight marches were planned. The outrage and grief were spontaneous, coming straight from the hearts of the people. Every mosque observed silence." he said.

Abdullah also emphasised that this change must be encouraged and strengthened. "We must boost and nurture this spirit of unity, compassion, and resilience that has emerged from among the people themselves," he added.

Addressing the Assembly earlier while moving the resolution, Deputy Chief Minister Choudhary said, "This House expresses its profound shock and anguish at the barbaric and inhuman attack on innocent civilians in Pahalgam on April 22, 2025.

He reiterated the House's unequivocal condemnation of the heinous and cowardly act that resulted in the loss of innocent lives.

Quoting the resolution, Choudhary said, "Such acts of terror are a direct assault on the ethos of Kashmiriyat, the values enshrined in our Constitution. and the spirit of unity, peace, and harmony that have long characterized Jammu and Kashmir and our nation."

This House stands in full solidarity with the victims and their families, the document stated. "We extend our deepest condolences to those who have suffered irreparable loss and affirm our collective resolve to share their grief and support them in their hour of need."

"I urge all members of this esteemed House to rise and observe two minutes of silence as a mark of respect for the victims and to show solidarity with the affected families," he said.

Speaker Rather vehemently condemned this act and expressed deep condolences to the victims' families, pledging commitment to fostering communal harmony.

"We urge the government to take immediate measures to enhance the safety and security of tourists, residents, and students from outside the region. All members should collaborate diligently towards achieving this goal," Rather said.

He highlighted nationwide protests against this cowardly act, emphasizing Congress"s unwavering support for government efforts to restore peace and ensure the safety of the nation.

The secretary on Monday said a draft scheme was prepared but a roadlock was hit as the General Insurance Council (GIC) raised objections.

"The GIC has not been cooperative. It has contended that it should be permitted to check the status of insurance policy of motor vehicle involved in an accident," the secretary said.

The top court also recorded the submission that the scheme for golden hour will be brought into force within a week from Monday.

The bench then directed for the notified scheme to be placed on record by May 9 and posted the matter on May 13.

On January 8, the top court directed the Centre to formulate the scheme for the cashless medical treatment of motor accident victims in the golden hour period mandated under the law.

The bench referred to Section 162(2)of the Act, and ordered the government to provide by March 14 the scheme which could save numerous lives with prompt medical care to accident victims.

It underscored the importance of providing immediate medical care during the critical period and said delays caused by financial concerns or procedural hurdles often cost lives.

The top court also underlined the statutory obligation on the Centre to frame the scheme as it "sought to uphold and protect the right to life guaranteed by Article 21 of the Constitution".

The law, therefore, provides the insurance companies carrying on general insurance business in India to provide for the treatment of road accident victims, including during golden hour in accordance with the scheme made under the MV Act, it said.

Despite the provision being in force since April 1, 2022, the government was yet to implement the scheme, prompting the court's intervention. The Centre had submitted a draft

Shoaib Akhtar, Basit Ali's YouTube **Channels Banned In India**

Cormer Pakistan cricketers Shoaib Akhtar and Basit CAli's YouTube channels have been blocked in India following "an order from the government related to national security or public order" in the wake of Pahalgam terror attack.

The Indian government has withheld several Pakistani channels after the April 22 terror attack in which 26 people, mostly tourists, were gunned down.

The move follows recommendations from the Ministry of Home Affairs in which it said that the Pakistani YouTube channels were "disseminating provocative and communally sensitive content, false and misleading narratives and misinformation against India, its Army and security agencies".

Dawn News, Irshad Bhatti, SAMAA TV, ARY NEWS, BOL NEWS, Raftar, The Pakistan Reference, Geo News, Samaa Sports, GNN, Uzair Cricket, Umar Cheema Exclusive, Asma Shirazi, Muneeb Farooq, SUNO News and Razi Naama are the other Pakistani channels banned in India. Following the order, the channels have been withheld by YouTube.

AIFF Want Churchill Brothers To Return I-League Trophy

A fter disobeying the order of the Court of Arbitration and handing out the I-League trophy to Churchill Brothers FC at a private function in Goa, on Sunday, the AIFF now want to do a U-Turn.

Hours after CAS stayed AIFF's decision to declare Churchill Brothers as I-League champions and barred the Indian football federation from conducting any formal felicitation ceremony, the national federation awarded the winners trophy to the Goan club, a development which may invite action from the international body.

All India Football Federation (AIFF) deputy Secretary General M Satyanarayan presented the trophy to Churchill Brothers and claimed that they learnt about the CAS order only after the ceremony was conducted.

SRINAGAR: Senior Congress leader Ghulam Ahmad Mir on Monday said they were fully supportive of the central government's anti-terror efforts in the wake of the deadly Pahalgam terror attack that claimed over two dozen lives last week. Mir, while addressing the special session of the Legislative Assembly called in the af-termath of the Pahalgam terror attack, condemned the attack in the strongest words and called for unity across political, regional and religious lines to defeat the divisive agenda of

terrorism. Stressing that the tragedy must not be politicised, Mir said, 'Today, there is no election. We have to respond in one voice. beyond any party interest."

The Congress leader lauded the government's initial steps taken after the attack, including the convening of an all-party

meeting. He said that the Congress Party was committed to supporting all efforts aimed at restoring peace and ensuring security for citizens. "The entire country stands united with the government. There is no place for politics in this moment of grief and determination," Mir said

However, Mir also flagged concerns regarding security lapses.

Mir also criticised the aftermath of the 2019 abrogation of Article 370, questioning the effectiveness of the steps taken post-reorganisation in curbing

militancy. "Seven years have passed, but incidents continue,"

living across the country, stating that innocent Kashmiris should not face discrimination or hostility in the aftermath of the attack.

He urged both the Centre and state governments to ensure the safety of Kashmiris studying, working, and living in different parts of India. "Our people should be seen with the same trust and humanity that the locals in Pahalgam showed during the attack, carrying the injured, providing shelter, and standing tall in the face of ad-versity," Mir added.

Praising the local people and hoteliers of Pahalgam for their humanity and bravery, Mir noted how they carried injured tourists to safety without any hesitation.

Mir said that the 'terrorists' real agenda was not just physical destruction but to sow communal hatred between Hindus and Muslims.

"We must send a strong message from this house that India will not be divided. Jammu and Kashmir will not bow to terror," he said. He also questioned the security 'lapses', stating that Pahalgam was being considered a highly secure zone, es-pecially during the Amarnath Yatra season. "Where did the terrorists come from? Who supported them? Why were precautionary measures lackng," he asked.

Appealing to the media, Mir, during his address, also cautioned against sensationalism that could vitiate the national atmosphere. "Media must act responsibly. Amplifying terrorist agenda by giving communal colour to the tragedy will only serve the enemies of peace," he said-(KNO)

Terrorism Has No Religion: Tarigami

JAMMU: Member of Legislative Assembly (MLA) Kulgam, Muhammad Yousuf Tarigami, on Monday said that terrorism has no religion and that Muslims in Kashmir have suffered deeply due to its violence. Speaking during a special session of the Assembly, Tarigami also criticized the government's practice of demolishing the houses of individuals whose family members have joined militant ranks. Expressing sorrow over the

recent tragic killings in Pahalgam, Tarigami said it was painful to have to reconvene the House so soon to mourn the loss of innocent lives. Describing the attack as brutal and unfortunate, the CPI(M) leader asserted that terrorists were attempting to divide people through such acts of violence.

"Many massacres have taken place, hundreds have been killed. Let me ask, which religion or sect did they belong to? A majority of them were Muslims," Tarigami said. He cited the killings of former Speaker Wali Muhammad Yatoo, political leaders, and even his own father-in-law as examples of the widespread suffering inflicted on Kashmiri Muslims.

Tarigami stressed that terrorism has no religious affiliation, pointing out that prominent Muslim clerics like Mirwaiz Farooq and Qazi Nisar were also among those killed. "The terrorists have only one aim - to spread terror. They have nothing to do with any religion," he said.



He also took a swipe at sections of the media for attempting to portray the violence through a Hindu-Muslim lens. "We need to introspect deeply to understand the gaps that led to incidents like Pahalgam," he said.

Calling for a more inclusive approach, Tarigami emphasized that the people of Jammu and Kashmir should not be alienated but rather involved in efforts to combat terrorism. He lamented that while the Assembly was discussing the issue, those directly responsible for security management were not present to answer questions.

The Kulgam MLA also highlighted the urgent need to ensure the safety of students from Jammu and Kashmir studying outside the Union Territory. "If we fail to do so, we risk allowing the terrorists to succeed in their mission," he warned.

Reacting to the recent demolition drive in Kashmir, Tarigami questioned the government's approach. "If the terror ecosystem has been dismantled, as some claim, how has it revived? There must be accountability," he said. He added that the right to shelter is a fundamental right and that families should not be punished for the actions of individual members.



Gen Z's Trading Trap

With smartphones and social media dreams, Gen Z is rushing into the stock market, and learning painful lessons about risk, addiction, and the cost of easy money.

When Faizan Mir made his first trade, he felt like he had found a secret door. It was 2020, deep into the pandemic lockdown. The world outside his home in Anantnag, Kashmir, had fallen still, but inside his small room, life seemed to speed up.

On his phone screen, a few clicks sent numbers jumping, turning green. His heart raced. His mind raced faster.

He made $\gtrless600$ that day. More than what his father earned in a full shift at the orchard. It felt magical.

He didn't know it then, but that day would change everything.

Across India, Faizan was part of a quiet revolution that was only just beginning. In those lockdown months, millions of young Indians, some still teenagers, discovered trading. With free apps, viral Instagram reels, and Telegram groups promising riches, the stock market no longer looked like an old man's game.

By 2024, nearly half of all stock investors in India were under the age of 30. It's a staggering jump from just a few years ago. What was once a slow climb toward wealth had turned into a race. A race most young traders did not understand they were running uphill.

At first, the trading apps felt like video games. Bright charts. Leaderboards. Notifications that buzzed like rewards. Every small win felt like leveling up. Every loss, like a challenge to try again. Psychiatrists now warn that



the brain does not know the difference. Dr. Parth Soni, based in Vadodara, says the highs and lows of trading trigger the same parts of the brain as gambling. "It's addictive," he says. "It makes you believe the next win is just around the corner."

But the next win rarely comes. Seven out of ten day traders lose money, according to SEBI. Nine out of ten futures and options traders lose even more. Over three years, retail traders in India lost ₹1.8 lakh crore.

You wouldn't know it by scrolling through Instagram or You-Tube. Finfluencers flood young people's feeds with videos about escaping the 9-to-5, driving luxury cars, living in beach houses. Most make more money selling courses and memberships than they ever did trading. It's a dream built on false hope. Nobel laureate Robert Shiller once warned that bubbles form when people feed each other stories of easy wealth. Today, that bubble grows through hashtags and viral clips. The old scams have new packaging. "Pump and dump" schemes, where influencers hype up cheap stocks only to dump them later, cheated dozens last year alone. SEBI fined 55 groups for market manipulation in 2023.

In the background, the education gap yawns wider. Only 27 percent of adults and just 16.7 percent of teenagers in India are considered financially literate. Without knowing the basics of money—risk, patience, planning many young people mistake gambling for strategy.

Some pay with lost savings.

Others pay with something even more precious.

In Chennai, a 21-year-old student ended his life last year after falling into debt from trading losses: ₹22 lakh borrowed from friends, apps, anyone who would lend.

In Kashmir, Faizan's story did not end so tragically, but it did leave scars.

After a few small wins, his bets grew bigger. He borrowed from cousins and friends. He joined premium Telegram groups that promised secret tips. Sometimes he would wake up in the middle of the night just to check his trades. Slowly, his balance slipped into red.

When the calls from lenders started coming, Faizan stopped answering. He pulled away from friends. He stopped showing up to classes. For a while, he barely left his room.

Today, Faizan says he is done with trading. His phone is quieter now. No notifications. No charts. No leaderboards. He is working toward his degree again, thinking about a steady job. Something real. Something that doesn't vanish with a single swipe.

"I wanted a shortcut," he says, looking down at his hands. "But there are no shortcuts. Only lessons."

Faizan learned that in trading, easy wins come with hard falls.

Sections of the media are deepening mistrust rather than demanding accountability after the tragic attack on tourists in Kashmir.

The recent attack on tourists in Pahalgam, Kashmir, was a moment that demanded serious questions and responsible journalism. Instead, much of the Indian media chose to spread anger and suspicion, especially against ordinary Kashmiris who had nothing to do with the violence.

The attack, which took place in what should have been one of the most secure areas, should have led to tough questions. How did the attackers move around so easily? Why did the security system fail? These were the queries that needed urgent answers.

Yet, rather than focus on these vital inquiries, many television channels and social media outlets rushed to target an entire community

an entire community. Headlines like "Kashmiri separatism raising its head again?" and "How long will Kashmiris hide terrorists among them?" were flashed across major TV channels. On social media, calls for boycotting Kashmiri students, businesses, and workers outside the Valley went viral. It did not stop at words.

In Delhi and other cities, Kashmiri students reported being harassed and called

names. Traders from Kashmir were threatened in markets they had worked in peacefully for years.

This is not just unfair; it is dangerous. Kashmiris, who have lived through decades of violence and loss, are now being blamed for acts they neither supported nor committed. They are being made scapegoats at a time when they should be partners in finding a path to peace. In moments like these, the

In moments like these, the true role of the media becomes clear. Journalism should speak truth to power, not punch down at ordinary citizens. It should demand accountability from those responsible for public safety, not deepen the wounds of already suffering communities. After the Pahalgam attack, very few journalists asked the essential questions about intelligence failures or security gaps. Instead, many preferred to stoke emotions and raise their ratings.

When sections of the media focus on division rather than truth, it becomes harder for real solutions to take root. Hatred spreads faster than facts, and innocent people pay the price. True journalism does not build walls of mistrust; it builds bridges of understanding. It challenges those who must answer, and it protects those who deserve justice.

If the media genuinely cares about the unity and safety of the country, it must stop chasing anger and start chasing the truth. Only by facing uncomfortable questions can we hope to prevent future tragedies.

Blaming the innocent is easy. Holding the powerful accountable is harder. But it is the only way forward.

Being Kashmiri is carrying your heart like contraband – everywhere inspected, everywhere distrusted.

After the attack in Pahalgam, where blood spilled and screams tore through the meadow, the old narrative was revived. Every Kashmiri was blamed again. But here's what most headlines missed: even in grief, we opened our homes.

Hotels flung open their doors. Restaurants cooked extra meals. Villagers shared their meager supplies with stranded tourists. Drivers offered free rides to the airport, refusing money. Across Pahalgam and beyond, kindness became instinct, not strategy.

In Kashmir, even amid heartbreak, hospitality runs deeper than fear.

Far from these mountains, a different story unfolded. Kashmiri students were assaulted. Shopkeepers were threatened. Tenants were evicted overnight. Jobs were lost simply for having a Kashmiri surname. Social media roared with calls to "bulldoze" us, "teach us a lesson," erase us.

But here in the valley, no mobs formed. No tourists were hurt. Instead, tea was poured. Beds were made. Bread was broken together.

This isn't because we are naïve or weak. We know betrayal well. We've buried sons and salvaged dreams from

the ashes. Rage would be easy, justified even. Yet time and again, Kashmir chooses generosity over anger, welcome over resentment.

Being Kashmiri isn't about politics or religion. It's about an impossible resilience: a commitment to humanity even when humanity feels like a oneway street.

When the world shuns us, we don't return hate with hate. We offer bandages to those who mistrust us. We light stoves for those who might never defend us. We hand umbrellas to people who would rather throw stones.

It's not martyrdom. It's who we are. Generations raised under the long shadow of conflict learn this truth: if sorrow must exist, let it end with us. Let it not pass to the next soul. Let it not become bitterness that scars every handshake, every shared meal.

There is a sickness spreading, but it is not ours. It is the sickness of cruelty worn as pride. It is forgetting that dignity cannot survive selective compassion.

Today, cruelty can trend faster than compassion. But here, among these battered hills and bullet-torn alleys, something stubborn survives. A belief that kindness is not conditional.



Study Estimates 80% Length of India's Rivers Posing Risks from Antibiotic Pollution

ighty per cent of total length • of India's rivers could be pos-ing environmental and health risks due to antibiotic pollution, a study has estimated.

Along with India, Nigeria, Ethiopia, Vietnam, and Pakistan are among the countries facing similar risks due to pollution from antibiotics, the research, published in the Proceedings of the National Academy of Sciences (PNAS) Nexus, said.

Researchers from McGill University, Canada, explained that antibiotics -- they help fight bacterial diseases -are not completely metabolised while passing through the body, nor completely destroyed or removed by most wastewater treatment facilities.

Potentially 315 million people in India could be exposed to environmental risks arising from rivers contaminated with antibiotics, according to the study, which measured amounts of 21 antibiotics at 877 locations globally. Findings highlight the need for appropriate wastewater management plans and improving current practices, the

team said.

Regulations and guidelines on use of antibiotics also need to be updated, with a particular focus on high-risk substances and locations that pose the greatest risk, they said. Most high-risk areas were noted to co-

incide with places where antibiotics are readily available without prescription and are sometimes used preventively.

Previous studies have estimated human consumption of antibiotics to have increased by 65 per cent between 2000 and 2015.

For this study, the researchers analysed the 'RiverATLAS' dataset. The global network of RiverATLAS contains 8,477,883 individual river reaches (or segments), representing about

36 million kilometres of the world's rivers. The dataset is maintained by McGill University.


The team estimated that in a year, people consume around 29,200 tonnes of the 40 most used antibiotics -- about a third of the amount enters the world's rivers and 11 per cent enters oceans and lakes, after metabolism and wastewater treatment.

Further, six million kilometres of rivers around the world could be exposed to antibiotic levels exceeding thresholds that protect ecosystems, with major contributions from amoxicillin, ceftriaxone, and cefixime, the authors said.

Cefixime, which helps treat bronchitis among others, was found to be the substance contributing the most to pollution in rivers in India.

The team also predicted high antibiotic levels in regions already affected by antibiotic resistance, including south and southeast Asia.

"Annual human consumption of the 40 most used antibiotics (29,200 tonnes), 8,500 tonnes (29 per cent) are released into the river system and 3,300 tonnes (11 per cent) reach the world's oceans or inland sinks," the authors wrote.

Floriculture Dept Launches Drive To Revive **City's 'Lung Spaces'**

Srinagar: In a move to combat the environmental impact of urban pollution, the Department of Floriculture Kashmir has launched a major initiative to revive Srinagar's parks and gardens, often described as the city's 'lung spaces'.

Speaking about the project, Director Floriculture Kashmir. Shakeel-ul-Rehman Rather said that the department plans to plant at least 15,000 perennial trees across Srinagar. "Over the years, pol-

lution and environmental degradation have severely impacted the health and vitality of existing plants," he said. "Many trees have either grown too old or lost their ability to withstand changing conditions."

The new plantation drive will focus on perennial species that require a one-time plantation effort but provide long-term benefits. "We will plant them only once," Rather said. highlighting the department's focus on sustainability and longevity.

The Director said that the campaign will start with Srinagar's prominent parks and gardens and is expected to be expanded to other districts in subsequent phases. Officials believe the effort will not only enhance the green cover but also help improve air quality and urban aesthetics.

He added that the department aims to enhance the green cover of urban spaces, making them more resilient to climate change and more inviting for citizens-(KNO)

Passenger Traffic At Airport Records Sharp Decline vere burn injury. AGENCIES

Srinagar: Passenger traffic at Srinagar International Airport has witnessed a steep decline following An official also added the cause of death is the recent terrorist attack in Pahalgam, Anantnag.

According to data accessed, the number of passengers travelling through Srinagar Airport fell noticeably over the past few days, beginning April 23, soon after the Pahalgam attack.

It says, on April 23, a total of 17,653 passengers travelled through the airport across 112 flights with 6,561 arrivals and 11,092 departures.

However, from the very next day, the numbers started dropping. On April 24, the airport handled 15,836 passengers on 118 flights including 4,456 arrivals and 11,380 departures.

The downward trend continued on April 25, with 14,041 pas-

sengers travelling on 100 scheduled flights, in addition to a few additional flights that carried minimal numbers-24 arrivals and 794 departures on four extra flights. Similarly, on April 26, Srinagar Airport witnessed 14,783 passengers travelling through 106 scheduled flights, with an additional three flights carrying 28 arriving and 351 departing passengers.

Airport officials said that while flight operations have remained largely unaffected in terms of the number of flights, the load factor (passenger occupancy) has fallen. The fear triggered by the attack has led to a dip in tourist arrivals, affecting the overall air traffic," an official said.

He said that the security situation continues to be monitored closely and that all flights are operating normally, but the immediate aftermath of the attack has definite-


ly impacted air travel demand.

Meanwhile, travel industry stakeholders, especially those associated with tourism, said they are worried about the declining footfall and its potential impact on Kashmir's tourism season.

'April to June is our prime season. Such incidents severely dent the confidence of tourists. The dip in air traffic is already reflecting this," said a travel operator in Srinagar, adding that most of the bookings have been cancelled.

Meanwhile, the authorities have assured enhanced security measures in and around tourist hotspots to ensure the safety of visitors.

Notably, the attack in Pahalgam claimed the lives of 26 people, mostly tourists and was widely condemned. Security has since been heightened across South Kashmir and other tourist areas—(KNO)

🔌 κο νιέψ **Peace Lies Broken**

he last few days have made it painfully clear: we are back to square one along the Line of Control. In the aftermath of the brutal terror attack in Pahalgam, the fragile calm that had prevailed over the LoC for the better part of the past few years has shattered. The Indian and Pakistani armies have traded fire across Poonch and Kupwara for four consecutive days, with Pakistani troops resorting to unprovoked smallarms fire. Indian forces have given a befitting reply to firing from Pakistani positions. The message, however, is unmistakable, a dangerous spiral of hostility is taking shape once again.

The government's response to the Pahalgam attack has been swift and tough. New Delhi suspended the decadesold Indus Waters Treaty, closed the Attari land crossing, expelled Pakistani military attaches, and ordered Pakistanis who entered through land borders to leave by May 1. The measures mark a serious diplomatic rupture between two neighbours. The terrorist attack at Pahalgam left India with no option but to react. And these are just initial steps. The prime minister Narendra Modi has made it clear that India will pursue the Pahalgam attackers "to the end of earth." The PM has vowed to "identify, track, and punish every terrorist and their backers" and this has resonated with a country that is justifiably outraged.

As things stand, the LoC ceasefire between the two countries seems to be all but over. It was an agreement, which although first signed in 2002, was reinstituted in the wake of the abrogation of Article 370 in August 2019. It was one of the oddest circumstances for the agreement to be restored as at that time the relationship between the two neighbours had sunk to its lowest. And since then the understanding has held, despite apparently zero diplomatic engagement between the two countries. After the Pahalgam attack, the situation in India is such that few are in a position to call for business as usual relationship with Pakistan. The people are rightly calling for justice for the victims of the terror attack.

It is a tough situation. The ceasefire is crumbling. Dialogue is dead. And Kashmir once again finds itself caught between crosshairs . Tourism has received a mortal setback and terrorism is once again rearing its head. Worse, the clouds of a potential war are hovering over the region with unpredictable consequences. At the same time, it has become difficult to urge the central government to pull back from the brink. However, there is hope that in the end the tough situation will resolve itself. Here's hoping with hope.

Digital platforms like J&K Bank's online demat services and fintech apps such as Groww or Zerodha bring investing to the valley's youth. Yet technology alone isn't enough. Local financial advisors. familiar with Kashmir's unique risks, can tailor plans to match goals and safeguard capital.

Start by defining your needs: education fees, home repairs, or future travel. Adopt a long-term view, reinvest dividends, and let compounding work its magic. Over time, these steps can turn modest investments into meaningful support during lean seasons.
