#### 12 Nights Of **Ceasefire Violations Along LoC**

Srinagar: The ongoing tensions between India and Pakistan have intensified with the Pakistan Army violating the ceasefire agreement for the 12th consecutive night along the Line of Control (LoC). This escalation follows the deadly Pahalgam terror attack on April 22, 2025, which killed 26 civilians, mostly tourists, and worsened the already fragile relations between the two nations.

Pakistan's recent violations, which began on the night of May 5-6, saw unprovoked firing using small arms across multiple sectors, including Kupwara, Baramulla, Poonch, Rajouri, Mendhar, Naushera, Sunderbani, and Akhnoor. This marks the continuation of a disturbing trend that has been ongoing since the attack. In response, the Indian Army carried out retaliatory actions to safeguard personnel and infrastructure, adhering to standard operating procedures.

The unrelenting barrage of fire has left the people in border areas living in fear. "For 12 consecutive nights, 53 incidents of small-arms fire and mortar shelling have been reported in villages across Kupwara, Baramulla, Poonch, Rajouri, and Akhnoor," an official stated. The constant barrage of artillery has forced resi-

## **Need To Ensure Innocent People Are Not Harmed: CM**

Srinagar: Chief Minister Omar Abdullah on Tuesday said security forces should tread cautiously in their hunt for Pahalgam terror attack perpetrators and ensure that no innocents are harmed in the process.

"We all understand the situation. It will take time. We can neither deny the situation nor shut our eyes to it. But, we also have to see that in our efforts to catch those responsible for what happened in Pahalgam, we must ensure that innocent people are not harmed," Abdullah told reporters here.

He said the crackdown on terror should not look like "all the people of Kashmir are being detained" to catch a few people responsible for the attack".

"There is a need to remain



cautious and act prudently in this, and we have conveyed our viewpoint to the concerned quarters on this issue," he said.

On the death of a Kulgam man, who was allegedly picked up by security forces for questioning in the aftermath of the April 22 attack, the CM said it should not have happened.

"But, there are reports of

arrests and detention from various places, it is not (good) for the people of J-K, especially for the people Kashmir who have come out for the first time to express their anger against any attack This impression should not go out that all are being punished to punish the Pahalgam attackers," he said.

Residents of a village in Kulgam district found 22-year-old Imtiyaz Ahmad Magray's body on amid allegations that he was taken away by security forces for questioning in the wake of the Pahalgam attack.

Children Above 6, Widows & Divorcees Now Eligible for Ration Cards

Srinagar: In a significant move aimed at strengthening food security across Jammu and Department Kashmir, the of Food, Civil Supplies & Consumer Affairs, Government of Jammu and Kashmir, has enhanced inclusion measures under the Public Distribution System (PDS).

The information was given by Minister for Food, Civil Supplies & Consumer Affairs, Transport, Technology, Science Information Technology, Youth Services & Sports and ARI & Trainings, Satish Sharma, here today while interacting with the media.

"In accordance with the Government Order No. 47-JK(FCS&CA) of 2024, the new directive mandates the inclusion of children aged six years and above in family ration cards. These children will be incorporated into relevant categories such as Antyodaya Anna Yojana (AAY), Priority Household (PHH), Priority Household (NPHH), or Exclusion, in accordance with existing guidelines", maintains the minister.

The Minister further said that in a bid to ensure no eligible citizen is left behind, the Department of FCS&CA has been directed for undertaking identification and inclusion of previously omitted eligible beneficiaries into the PDS framework, adhering to established norms.

"A notable provision of the order addresses the inclusion of widows and divorcees who were not previously covered under the system. Upon notifying the department, such individuals will be eligible for issuance of separate ration cards based on their financial status and eligibility under the National Food Security Act (NFSA),"the | More on P6



## Study Finds Men More Likely To Fall Sick, Die From 3 Common Health Issues

en in many countries are more likely to fall sick and die from hypertension, diabetes, and HIV/ AIDS as compared to women, according to a new study.

However, compared to women, men were found to be less likely to seek medical care and adhere to treatment for these common health conditions due to norms related to masculinity and healthcare financing.

Men were also more likely to smoke, while women were more likely to be obese and engage in unsafe sex, the study, published in the journal PLOS Medicine, found.

The research highlights sex-based differences at each step of the "health pathway", which includes being exposed to a risk factor -- such as smoking -- developing a condition, diagnosis, treatment and death, study authors said.

"Most of these differences are not explained by sex (biology) alone, but by socially-constructed gender -- highlighting the impor-

tance of taking a gender justice approach to reducing health inequities. A gender analysis can help to shape systems of health for all," Kent Buse, co-founder of Global 50/50, a UK-based research initiative seeking to achieve gender equality in global health,

The findings are in line with those from previous studies showing men using fewer preventive, diagnostic, and treatment services for conditions such as HIV and CO-VID-19, compared to women.

The study found that men and women received different care for hypertension in 200 countries.

Also in 39 countries such as Afghanistan, Bangladesh, Ecuador and Ethiopia, men and women received different care for diabetes, and in 76 countries, including Australia, Chile, Italy and Lesotho, they received different care for HIV.

Overall, the authors said strategies need to be developed for encouraging men to participate in preventive and health care services. 'We have long advocated the benefits of publishing sex disaggregated data. As our



Gendered Health Pathways demonstrates, such data can reveal where the health journevs of men and women diverge be it in relation to the risk factors they are exposed to. their health care seeking behaviours or their experiences in health care systems. That is an important first step towards health equity." Buse said.

"Males had significantly higher prevalence

rates of conditions in 56 per cent of countries for HIV and AIDS, 30 per cent for diabetes, and four per cent for hypertension," the authors wrote.

"Females, on the other hand, had significantly higher prevalence rates of conditions in 14 per cent of countries for HIV and AIDS, five per cent for diabetes, and only in India for hypertension," they

Further, compared to women, death rates were found to be higher among men in 131 countries (64 per cent) for HIV/AIDS, 107 for hypertension (53 per cent) and 100 for diabetes (49 per cent).

Death rates among women were higher, compared to men, in 25 countries for HIV/ AIDS, nine for diabetes and only in the United Arab Emirates for hypertension, the study found.

Women were also seen to have higher rates of diagnosis, treatment, and control. For the study, data on risk factors, disease prevalence, and death rates were obtained from the Global Burden of Disease (GBD)

## **Police Books Four Drug Peddlers Under PIT NDPS Act**

Srinagar: In the relentless crackdown against drug trafficking and dismantling the illegal narcotics network, Srinagar Police on Tuesday said to have booked four notorious drug peddlers under the Prevention of Illicit Traffic in Narcotics Drugs and Psychotropic Substances Act (PIT-NDPS Act).

These drug peddlers Tawfeeq Ahmad Khan S/o Mohammad Ayoub Khan R/o Shangulipora Noorbagh, Aaqib Mushtaq Kenoo S/o Mushtaq Ahamd Kanoo R/o Pamposh Colony Noorbagh, Imran Ahmad Bhat S/o Aijaz Ahmad Bhat R/o Guzerbal Noorbagh and Faizan Rashid Wani S/o Ab. Rashid Wani R/o Palpora Noorbagh have been booked under the PIT-NDPS Act after obtaining the formal detention orders from Divisional Commissioner, Kashmir on the basis of dossiers prepared by Srinagar police against them, a police spokesman said in a statement issued to Kashmir Observer.

Consequently, said that these drug peddlers were detained and subsequently lodged in Kot Balwal Jail Jammu and District Jails of Udhampur, Kathua and Bhaderwah

"These drug peddlers have been involved in the peddling of narcotics among the youth of Srinagar on an alarming scale. Besides, they were also involved in several NDPS Act cases of various police stations of Srinagar. Despite several NDPS Act cases registered against them, they did not mend their ways after getting bailed out from courts and were brazenly promoting drugs among the youth of the valley, especially in Srinagar, through their illegal narcotics network. Srinagar Police has also set into motion the process to attach their properties under the provisions of PIT-NDPS Act," the statement reads.

Pertinently, Police has been systemically targeting and dismantling the illegal narcotics infrastructure in the Srinagar city and numerous drug peddlers have been detained under the PIT NDPS Act in Srinagar till date.

"J&K Police affirms its steadfast commitment of eliminating drug peddling in the region with the full might of law. We also caution those engaged in this unlawful activity that the long arm of law would catch them sooner than anticipated and every offender will face justice," police said.


the DC Office Complex, here. Speaking on the occa-

## Mental Health Stigma

"n Kashmir, as in many parts of the world, mental health is still widely misunderstood and often dismissed as madness, as a report in this paper makes clear. Yes, we talk about mental health more now. Schools and workplaces hold occasional workshops. But when someone close to us actually breaks down, we often don't know what to do. We advise them to "snap out of it," or "stop overthinking." There is a reason for it. We don't want to acknowledge that there is a mental health issue, which is seen as madness by most people. In turn, this has created a stigma over the disease. We generally don't talk openly about depression, anxiety, or trauma. This calls for a change in attitude. More so, in a place where, according to a study, a striking 55.72% of the Kashmiri population is grappling with depression, with the most susceptible age group being individuals aged 15 to 25

We are now seeing the cost of this silence. There's been a disturbing rise in suicides among Kashmir's youth, and yet we still lack the mental health services they desperately need. In a welcome decision in 2023, Jammu and Kashmir announced the setting up of a dedicated mental health authority, in response to the growing mental health crisis in the union territory, more so in Kashmir Valley. The primary objective of this authority is to oversee and regulate all mental health facilities within the region, ensuring they are properly registered and conform to established guidelines.

For example, casual use of terms such as "psychotic," "crazy," or "psychopath" perpetuates negative stereotypes and stigma. The terms, often thrown around without understanding their clinical implications, can harm individuals and discourage them from seeking support. It's crucial to differentiate between clinical terms and everyday language to avoid further stigmatization.

With over 150 million Indians requiring mental health care services, yet only around 30 million seeking help, there's an urgent need for both education and awareness. One of the critical aspects of tackling this issue is addressing and dispelling misconceptions. Terms associated with mental health are often misused and misunderstood, contributing to the stigma surrounding the topic.

Mental health has in recent years become an endemic global malaise. But it isn't getting enough attention as unlike diseases like Covid-19 which have visible physical manifestation, mental health is a psychological at fliction. It is shrouded in part secrecy and part mystery. The result is that it generally goes unnoticed unless the symptoms acquire extreme manifestation. While mental health struggles may not always claim lives, they quietly erode the quality of life — and only through sustained awareness and open conversation can we begin to offer real support.

## A New Beginning for Kashmir Classrooms

today's changing education landscape, school inspections must move beyond their outdated role as fault-finding exercises. They must become tools for academic reflection, renewal, and reform. The Directorate of School Education Kashmir's (DSEK) recent circular on academic inspections marks a step in the right direction.

Instead of top-down audits, the new model proposes a layered inspection system—engaging all levels, from directors to zonal officers-based on clear guidelines and standardized tools. This encourages continuous dialogue over one-time evaluations. The focus expands beyond infrastructure or rule adherence to core

academic areas: classroom engagement, teacher preparedness, use of teaching-learning materials, and competency-based strategies.

What makes this shift promising is its continuous nature. Schools are no longer expected to perform only for "inspection days." The goal is to build a culture of self-assessment and consistent improvement. Monitoring tools act as checklists for growth, not fear. Even local resources, like the Village Knowledge Register, are being integrated into learning.

This system also strengthens the link between training and classroom practice. Teachers often return from workshops unsure how to apply what they've learned. With regular, support-

ive monitoring, strategies shared by SCERT, DIETs, and other agencies can take root in classrooms. Competencybased education, inclusive pedagogy, and activity-based learning become part of real teaching, not just theory.

The role of inspectors is being redefined—from passive evaluators to active mentors. Instead of simply noting gaps, they can guide school leaders and teachers, recognize good practices, and suggest professional development. School heads, in turn, must create environments where dialogue, reflection. and collaboration are embedded in daily routines.

The success of this model depends on trust and shared commitment. Inspectors must prepare carefully and offer actionable, respectful feedback. Schools should welcome visits as opportunities for support, not judgment. Grades should reflect academic health, not just surface-level compliance.

It's time we move past surprise visits, rigid formats, and hollow reports. We need inspections that support, not intimidate. Done right, this shift can lead to schools that are not only compliant, but competent, creative, and centered on learning outcomes.

## Kashmir's Hidden Horsemen

A secret field of ancient horsemen in Jammu and Kashmir could rewrite Central Asian history. But years after their discovery, the statues are crumbling, and no one is stopping it.

n June 2017, Natalia Polosmak, a Russian archaeologist known for uncovering the Siberian Ice Maiden, stepped into the thick woods of Gora Gali in Pirpanjal region. She had traveled thousands of miles following a rumour.

It was just a vague tip about strange statues lost in the mountains. She thought she might find a few carved rocks. What she found instead stopped her in her

Nearly 200 life-sized stone horsemen, frozen mid-ride, were scattered across the forest floor.

Some stood upright, their stone faces staring toward the horizon. Others had fallen, overtaken by roots, moss, and mud. The figures were hauntingly detailed: highcheekboned riders wearing boots and tunics, holding curved daggers, small bows, and goblets.

Some shared a single horse, packed two or three at a time. Women appeared beside or behind them, draped in carved skirts and ornaments. They seemed part army, part funeral procession.

have never seen anything like this in India," Polosmak later recounted. "These are not purely Indian faces."

She was right.

The statues didn't look like anything in India's official archaeological record. To her, they pointed elsewhere-back to Central Asia, to a nomadic empire that swept through parts of South Asia 1,500 years ago and then seemed

The Hephthalites, also called the White Huns, were feared horsemen who once ruled large swaths of north India. They were said to be brutal and mysterious. Their skulls were artificially stretched, their art a mix of Persian, Gandharan, and steppe influences. They built little and left behind fewer records. Much of their story remains a guess.

Until, perhaps, now



Polosmak first saw two statues like these at the Archaeology Museum in Srinagar in 2013. They had no labels and no context. They stayed in her memory. Four years later, with help from the Gerda Henkel Foundation and scholars from the University of Kashmir, she set out to find their origin.

The path to Gora Gali was unmarked. Locals led her there. The statues were hidden in two clusters at high altitudes. The area's name, Ghoragali, literally means "horse pass." The people in nearby villages treated the figures with a mix of reverence and

confusion. Some called them Pandavas from the Hindu epic. Others said they were devtas, divine guardians. A few used fragments of them as laundry platforms or garden walls.

"We don't know who made them," said Ghulam Rasool, a village elder. "But they have always been here.

Polosmak and her team, which included Dr. Mohammad Ajmal Shah and Yatoo Mumtaz Ahmad, documented the entire site using 3D laser scanning and drone surveys. A Russian company created detailed digital models of the

statues, mapping every curve and crack. The idea was to preserve what they could before time and weather destroyed the rest.

The carvings, it turned out, were more than artistic. They told stories. Some horsemen gripped swords with mushroom-shaped pommels. Others had bows, arrows, and elaborate saddles. Some horses showed teeth, their mouths open in mid-snarl. Traces of red paint clung to the stone, suggesting they were once brightly colored. The details matched artifacts from Central Asia, even as local influences appeared in their style and weapons.

One rider had a long nape, flat and stretched-the clearest sign yet of the Hephthalite practice of skull deformation.

Nearby, the team found stone basins fed by streams, shaped like ritual ablution pools. They were decorated with lotus flowers, Dharma wheels, and other Buddhist and Hindu symbols. This blend of spiritual markers, like the mix of foreign and local aesthetics, hinted at a period of cultural fusion and flux.

Dr. Ajmal Shah believes the statues date to the 5th or 6th

century, when the White Huns ruled this region. Coins from that era show similar faces. The name of the nearby village, Gool, may come from "gula," a Hun title for warrior-rulers.

Yet no official Indian agency has moved to protect the site.

There are no signs, fences, or guards. The Archaeological Survey of India was informed but never followed up. Rain erodes the carvings. Trees grow into their cracks. Some statues have already disappeared. No one knows i they were taken or destroyed.

A former ASI official called the silence a historic failure. "This should be a major archaeological find," he said. "But it's being forgotten in real time."

The digital scans offer one lifeline. They may one day form the basis of a virtual museum. But the real statues still lie in the woods, exposed to weather and wandering cattle. No one has excavated the ground beneath them. Their full story may still be buried. Some scholars think the site

is a war memorial. Others say it could be sacred, linked to ancient funeral rituals or collective sacrifice. The repetitive faces, somber stares, and presence of women and children suggest more than just a military display.

"These may be the dead," Polosmak wrote in a Russian journal. "Or their guardians. Stone witnesses to a world that is already gone.'

Back in the village, life moves on. Locals herd goats and chop firewood. Tourists rarely visit. The forest keeps its secret.

And the stone horsemen, their mouths half-open, keep watching.

## The Lesson Plan Solution for Kashmir

The NEP 2020 offers Kashmir a chance to rebuild its education system from the ground up. But without thoughtful lesson planning, its promise will remain out of reach.

In the hills and hamlets of Kashmir, the classroom remains a fragile space. ■In many government schools, a chalkboard and some benches are all that greet children every morning. But beyond the crumbling walls and basic infrastructure, the real challenge lies in something more invisible: the absence of structured lesson

It is easy to assume that a teacher who knows their subject will naturally teach it well. But mastery of content means little if the teaching has no direction. Good teaching does not begin when the teacher walks into the classroom. It begins long before, with careful thinking about what students need to learn, and how they will learn it best.

Lesson planning has always mattered, but with the arrival of the National Education Policy (NEP) 2020, it has become even more urgent. The policy calls for a shift away from rote learning and passive memorisation. It urges schools to recognise that children are different. They come to class with different strengths, interests and learning styles. A one-size-fits-all model no longer works. The teacher is expected to meet every child where they are, and help them grow from there.

This is a tall order, especially in Kashmir, where classrooms often have children with wide gaps in prior learning. Some may be first-generation learners, while others face stress at home that affects their ability to focus. Some pick up

concepts quickly; others need more time. The classroom, in truth, is never a homogenous group, it is a "class within a class".

To navigate such diversity, a teacher needs more than just content knowledge. They need a plan. And that plan must account for the topic being taught, the teaching materials to be used, the expected outcomes, and the ways to assess if learning has taken place. Without this planning, teaching becomes a blind walk. Students remain passive listeners instead of active participants. Competencies like critical thinking, problem-solving, and collaboration, all central to the NEP, remain distant dreams.

The truth is, traditional methods of teaching have led to superficial learning. Students may remember facts but struggle to apply them. They can recite definitions but cannot analyse or evaluate real-life problems. Skills like creating new ideas or working in teams are often ignored. The cost of this is visible in Kashmir's youth unemployment rate, one of the highest in the country. Education is supposed to prepare young people for life, not just for exams. But without effective

lesson planning, this preparation is weak. The solution lies in shifting from content delivery to competency development. One useful model that teachers can adopt is the 5E lesson plan — a structure built around five steps: Engage, Explain, Explore, Elaborate and Evaluate.

The first step, Engage, is about awakening curiosity. Rather than starting a class with dry facts, a teacher can tell a story, pose a question, or share a picture. This helps students become ready to learn, and connects the lesson to their lived experience.

Next comes Explain, where the teacher introduces key concepts clearly and confidently. This is still teacher-led, but it should go beyond the "chalk and talk" method. Visual aids, real-life examples, and hands-on materials can help students grasp ideas more effectively.

The third step, Explore, shifts focus to the students. They work in groups, conduct small investigations, or solve problems together. This encourages peer learning, and helps students build leadership and collaboration skills – both vital in the 21st century.

Elaborate comes next. Here, students apply what they have learned to new situations. This could involve debates, case studies, or linking the topic to current issues. It helps them deepen their understanding and see the relevance of classroom knowledge in the real world.

Finally, Evaluation allows the teacher to check if learning has actually happened. This is not just about asking a few questions at the end of the class. A good evaluation assesses not just knowledge, but understanding, skill, and application — a


method sometimes called KUSA. Teachers in Kashmir have often been accused of sticking to outdated methods. But the problem is not always laziness. Sometimes, it is the absence of training, support, and time. A culture of planning needs to be nurtured in schools, with heads and administrators playing a key role. Planning should not be seen as extra work. It is, in fact, the very foundation of meaningful teaching.

To build a future-ready Kashmir, where children are confident thinkers and not just silent note-takers, we must invest in the art of planning. The NEP gives us a direction. It is now up to us, and especially our teachers, to chart the course. Without a plan, the classroom becomes a place of lost potential. With one, it can become a space of transformation.

The bond between a father and his child is shaped by values, principles, and the legacy left behind.

₹ixteen years after my father, Abdul Rashid Qureshi, passed away, I find myself reflecting on the lessons he taught me, the strength he embodied, and the life he lived with purpose.

Born in 1956 in Nambla, a village in Tehsil Uri, Baramulla, my father's early years were marked by simplicity. His childhood in Boniyar, surrounded by Kashmir's natural beauty, left a lasting impression. His father, Ghulam Mohi Ud Din Qureshi. was a postmaster. He was a man devoted to service. His mother, Aisha Begum, embodied honesty and integrity, shaping his values.

Tragedy struck early when my father lost his father, forcing him to leave school to support his family. Yet, even then, he never surrendered to hardship. Instead, he worked tirelessly, embracing every job with dignity. His first roles were labor-intensive, and later, he worked as a washerman: long hours, exhausting work. But he never complained. For him, hard work was about integrity, not praise.

In time, he found his calling as a driver. It wasn't just a job;

it became his passion. Driving allowed him to support his family and experience life beyond his village. Soon, his driving skills earned him respect and admiration. People saw not just a driver but a man who took pride in his work.

My father valued family above all. He had a brother, Bashir Ahmad Oureshi, and a sister, Saiyda Begum, with whom he shared both struggles and joys. Family meant everything to him, and he passed that value to me. He was also a loyal friend. His close friendships with Abdul Rashid Mir and Abdul Hamid Thaker were built on trust

and respect. From 1993 to 1999, my father worked as a driver for civil projects in Uri, earning a reputation for honesty and dependability. His dedication led him to Hindustan Construction Company in 2005, where he worked on the Uri II Hydroelectric project. It was there he earned the title of Best Driver. But for him, the real reward was knowing he had given his best.

Despite leaving school early, my father's thirst for knowledge never waned. He was an avid reader of novels,

newspapers, and magazines. His intellectual curiosity was contagious, and it sparked a similar passion in me. One topic he often spoke of was Hagoog-ul-Ibad: the rights we owe to others. He believed in service, not just to God, but to humanity, and he lived by this principle every day.

Even in his passing, my father's legacy endures. His life exemplified persistence, humility, and service. His influence continues to guide me as I navigate my own path. I remember the dreams he had for me, especially his wish that I would become a teacher and pursue endless education. Though my journey has taken different turns, his aspirations remain close to my heart.

Sixteen years later, my father's lessons, strength, and commitment to doing good still shape who I am. I will forever be grateful for the father I had and the example he set. His legacy is a gift I carry with me. One of purpose, principle,

## J&K Bank Aims To Cross Rs 5,000 Cr Profit Mark By 2030: MD & CEO Amitava Chatterjee

Srinagar: Jammu and Kashmir Bank, which crossed the Rs 2,000-crore profit mark in fiscal year 2024-25, aims to cross the Rs 5,000 crore profit milestone by 2030, its Managing Director and CEO Amitava Chatterjee has said.

Chatterjee emphasized on the need for the bank to focus more on supporting the agriculture sector, while expanding its footprints in the rest of the country as part of its diversification plan.

"The vision or aspiration of the bank is to cross Rs 5,000 crore profit by 2030. So that will be our way forward. Yes, we have increased the net profit by Rs 300-400 crore in the last fiscal. Obviously we would like to increase it by Rs 500 crore next



year, but the ultimate vision is to cross Rs 5,000 crore by 2030," Chatterjee told PTI.

He said the bank has been raising the bar each passing year by posting record profits for the past three financial years.

For the full 2024-25 fiscal, the bank reported nearly an 18

per cent rise in net profit to Rs 2,082.46 crore, compared to Rs 1,767.27 crore reported for FY 2023-24.

Chatterjee said, the bank is one of the main pillars of supporting the local economy, besides the government.

"We need to continuously support the local economy and we need to support the agriculture sector much more than what we have been able to do in the past," he said, adding "on the agriculture front, we are now focusing more on investment credit".

Commenting on the revision of MSME criteria, he said it is likely that the Jammu and Kashmir region will come up with new units in the small and medium sector.

"There is another very good

scheme, YUVA, being introduced by the government. It also gives us a very good opportunity to support 3.5 lakh youth of the region to get into some new kind of a business. Within this state, we are well placed to support the people and we are going to do that," he noted.

Chatterjee said, while the bank has a strong presence in Jammu and Kashmir and Ladakh Union territories, it has a significant presence in the rest of the country as well.

"... We are present in 20 other states of the country. This gives us an opportunity of diversification. While we are very focused and positive in our growth strategy in the two union territories, we will also try to diversify our portfolio to the other parts of the country," he said.

## **End Policy Of Arrests: Mehbooba To LG**

Srinagar: PDP supremo Mehbooba Mufti on Tuesday wrote to Jammu and Kashmir Lieutenant Governor Manoj Sinha and said security agencies' response to the Pahalgam attack appeared to be a "sweeping and indiscriminate crackdown", pointing to hundreds being detained or booked under the stringent Public Safety Act.

With the Amarnath Yatra approaching, Mehbooba also sought Sinha's intervention in putting an end to the policy of arrests and punitive measures and ensure the release of innocents.

"The response from various security agencies that has followed appears less like a focused investigation and more like a sweeping and indiscriminate crackdown. Over 3,000 arrests and nearly 100

Public Safety Act (PSA) detentions have been reported," Mehbooba said in the letter.

The former chief minister of the erstwhile state said such numbers were alarming and did not reflect justice but rather a collective form of punishment.

"This approach not only risks alienating families and communities but also begs the question: where will all this lead us to? While we are all unequivocally in favour of justice, the actions currently being undertaken amount to mass retribution," Mehbooba said.

"No democratic and responsible society can or should accept such treatment of its own people. I have long maintained that the people of Kashmir have extended a hand of goodwill," she added.

It is now for the rest of the nation to respond in kind,

the Peoples Democratic Party (PDP) supremo asserted.

"It is deeply disheartening that the actions of a few terrorists are now determining how security agencies respond to the situation and go on a spree of arrests of innocent civilians," she said.

The nation is grieving the tragic and cowardly terror attack in Pahalgam and this heinous act has been widely condemned across the country, more so by the people of Kashmir, Mehbooba said.

"In fact, we went a step further by observing a complete shutdown and hitting the streets in protest. This spontaneous response marked a significant and heartening shift -- for the first time, Kashmiris openly defied terrorism and stood united with the nation during this critical time," she said.

#### **6 Kashmir Districts**

Kashmir's seven civil defence districts — Anantnag, Budgam, Baramulla, Kupwara, Srinagar, Uri (in Baramulla district), and Awantipora (in Pulwama district) – which are spread over six revenue districts.

Officials said the exercise is part of a broader strategy to strengthen passive defence infrastructure and community response mechanisms. "This is a practice drill. We urge citizens to remain calm and cooperate with authorities," an official said.

The Union Home Secretary Govind Mohan chaired a high-level video conference on Tuesday with Chief Secretaries and civil defence heads across the country to finalise the preparations. Over 270 "civil defence districts" — areas with critical installations such as military bases, hospitals, schools, and refineries — will be covered under the operation.

The Directorate of State Disaster Response Force (SDRF) and Civil Defence Kashmir has issued a public advisory notifying people of the siren test scheduled at 4 PM. "Please don't panic. This is a mock drill to test emergency systems," the advisory stated.

The drill is being held amid heightened national security concerns, particularly after the April 22 terror attack in Pahalgam, which left 26 dead. Officials said the exercise aims to enhance coordination between agencies and ensure grassroots preparedness in case of emergencies.

Students, healthcare staff, railway officials, government and private employees, and uniformed personnel from police, paramilitary, and defence forces will participate. States have been instructed to test communication systems, clean and ready bunkers, and conduct evacuation simulations.

Dal Lake Mock Drill by Srinagar Police

Ahead of the main drill, Srinagar Police in collaboration with SDRF and Tourist Police conducted a mock rescue operation in Dal Lake on Tuesday. The exercise simulated emergency response to boat capsizing incidents, a move prompted by recent weather-related tragedies.

Senior officers including SSP Srinagar and SSP Enforcement oversaw the drill, which aimed at improving real-time disaster response on water bodies.

Nationwide Scale
The mega drill, possibly the largest since the
1971 war, is being executed across all states
and union territories. In Delhi, the government
rolled out "Operation Abhyaas" at 55 sites and
issued dos and don'ts to the public. Instructions
include identifying safe shelters, staying calm,

and avoiding phone use during the siren.
In Punjab, mock drills will be conducted in
20 locations including Amritsar, Ludhiana,
and Pathankot. Karnataka will hold the drill
in Bengaluru, Karwar, and Raichur, while
Jharkhand will focus on evacuations and blackout protocols.

Chandigarh will conduct a blackout rehearsal from 7:30 to 7:40 PM. Uttar Pradesh has expanded the drill to all districts despite only 19 being initially identified.

Nearly 6 lakh volunteers are expected to participate nationwide, with BJP units and public representatives encouraged to join the effort. The MHA emphasized that civil defence is key to national resilience in the face of "new and complex threats."

Mock drills will also test radio links with the Indian Air Force, control room operations, and alternate communication channels. Officials noted that similar mobilizations occurred during COVID-19 and past crises like the Parliament attack and the Kargil conflict.

"This exercise is crucial to strengthen local response capabilities and safeguard civilian lives and infrastructure," an MHA official said.

The drill will assess how effective air raid sirens are in alerting people about aerial threats. It aims to train civilians to respond quickly and safely in case of an air strike.

Hotline and radio links between civil authorities and the Indian Air Force will be activated and tested.

The drill will check how well control rooms and their backups (shadow rooms) perform during emergencies.

People, including students, will be trained to protect themselves during hostile attacks through basic civil defence techniques.

The drill will include blackout exercises, where residents may be asked to switch off lights to simulate conditions during an air raid. Authorities will practice shielding critical infrastructure like airfields, refineries and rail yards from aerial detection or attack.

The preparedness of rescue teams and firefighters will be tested. Evacuation plans will also be rehearsed to move people from danger zones to safer areas.

Civilians will receive hands-on training in providing basic first aid, handling fire fighting equipment, and taking shelter during emergencies.

Planned across 244 civil defence districts, the drill will involve district authorities, civil defence volunteers, home guards, NCC, NSS, NYKS, and students. Civilians will also be trained to respond in emergencies.

been sounded. The tehsildar has arranged 20 harvesters to speed up the harvesting process. Ninety-five percent of the harvesting has already been completed in these belts," another farmer from Treva, Rakesh Kumar told PTI here.

The violence, coupled with the heightened security measures following the attack, has led to widespread panic. With India suspending trade, downgrading diplomatic ties, and deporting all Pakistani nationals, the situation remains tense. To further heighten security, the Indian Army and Border Security Force (BSF) are on high alert along the LoC and the International Border, with armed forces directed to maintain strict vigilance and not lower their guard.

Amid these rising tensions, Indian forces apprehended a Pakistani national near the LoC in Poonch district. The individual is being questioned to ascertain further details about his intentions, signaling the continuing volatility in the region.

Residents are feeling the strain of this conflict. "I don't know how long we can stay like this. Our children are scared to even sleep," said Shabir Ahmad, a Poonch local. Rukhsana Begum, a resident of Rajouri, expressed her frustration, saying, "We're caught in the middle. No one seems to care about the people who are suffering here."

As the threat of escalation looms, the impact of the repeated ceasefire violations on civilian life is undeniable. The ongoing conflict, exacerbated by the diplomatic fallout following the Pahalgam attack, has created a volatile and fearful atmosphere for those living along the border.

significant step towards digitizing the pension sanctioning process for government employees.

Chief Minister said, "Whatever we can do to simplify the retirement process and post-retirement of our employees, I think that is a responsibility that lies on our shoulders. Employees who have served J&K and its people for long years deserve a simplified process. And the more we do for our employees, I think the more we need to appreciate it."

Extending his congratulations to the officers and his best wishes to all pensioners who will benefit from the initiative, the Chief Minister said that verification of pensioners also needs to be made pensioner-friendly as every year pensioners have to prove that they are still alive and have to submit various documents and to visit offices in person. "So this initiative, I think, is something that all employees will appreciate," he said.

Highlighting the inclusive nature of the portal, he said it also covers ex-legislators who are pensioners. "So my suggestion would be that together with the Assembly Secretariat, some sort of briefing material can be sent out to all the ex-legislators, so that they are aware of this change and how better to utilize it," he added. Acknowledging the challenges faced by employees nearing retirement, he noted that the last few months of service are often consumed by paperwork. He emphasized that more often than not, efforts are made to post such employees close to Srinagar or Jammu to ease their transition. "With this initiative I believe that process will be simplified. Now, going ahead, what we must always try and do is to ensure that employees get their dues on

time," he said.

The Chief Minister also pointed out that timely disbursement of dues—such as GP fund—is a recurring concern among employees. "So for that, in the Finance Department, we are working closely to ensure that these sort of issues are resolved. But generally, clearly, the initiative that has been taken today, I think, is a welcome one." he remarked.

Earlier, Director General Accounts & Treasuries Fayaz Ahmad Lone presented an overview of the Pension Suvidha Portal. The portal supports the digitization of pension records for 2,40,000 pensioners under the Old Pension Scheme (OPS). He added that data collection was executed through multiple modes: treasury visits for 2,31,127 pensioners, home visits for 7,002, video calls for 1,819 pensioners residing abroad, and postal notices to 9,513 individuals. The portal captures comprehensive data including name, date of birth, service de-

tails, and photographs of pensioners.

Notably, he said, the initiative has helped identify and rectify several anomalies, including pension disbursement after death in some cases, duplicate dearness allowance payments,

and premature cessation of recoveries.

He informed that the objectives of the portal include streamlining and digitizing pension processing, enhancing efficiency and transparency, reducing paperwork, reconciling pension disbursement with banks, and enabling real-time tracking of pension application status.

Key features of the portal include early SMS and email alerts issued eight months before an employee's retirement, online application submission with required document uploads, and integration with JKHRMS and JKPaySys for service and salary details. It is also linked with the offices of the Accountant General and J&K Bank for seamless electronic data exchange.

The portal facilitates the issuance of PPOs, provides post-retirement services tracking, and supports online KYC updates and the use of Jeevan Pramaan for life certificate submission.

The streamlined workflow involves eight stages: registration, application submission by the employee, DDO review and approval, sanction by the Pension Authority, submission to the AG's office, authorization and PPO number issuance, payment processing by the Treasury, and final completion.

The portal engages a wide range of

stakeholders. Retiring employees can initiate and monitor their pension cases, while DDOs and Pension Authorities are responsible for verification and processing. The Accountant General's office authorizes PPOs, treasuries handle payments, and pensioners can view disbursement details, request for revision, and apply for transfer of pension accounts online.

On the occasion, the Chief Minister also handed over a settled pension case to Mr. Ragubhir, a retired employee who superannuated on 30th April this year.

**CS Pushes For Swift Claim Settlements, Financial Inclusion Of All**

SRINAGAR: Chief Secretary, Atal Dulloo on Tuesday chaired a comprehensive review meeting to assess the implementation status of various financial inclusion and social security schemes of the Government of India being executed through banks and financial institutions in J&K.

The meeting focused on the progress under major schemes including Pradhan Mantri Jan Dhan Yojana (PMJDY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJ-BY), Atal Pension Yojana (APY), saturation of unbanked rural areas, priority sector lending, credit flow to MSMEs, agriculture sector initiatives including Kisan Credit Cards (KCC), and skilling interventions undertaken through Rural Self Employment Training Institutes (RSETIs) established in the UT.

While reviewing the current status of population coverage under these schemes, the Chief Secretary also took stock of the compliance on earlier directions issued to financial institutions. He directed the concerned agencies to ensure saturation of all identified unbanked rural centres before the stipulated deadline of June this year.

Stressing on the need for prompt and efficient claim settlements, Dulloo observed that the success of these social security schemes should be judged not merely by the number of beneficiaries enrolled, but also by the speed and effectiveness of claim settlements.

He emphasized that financial institutions must instill confidence in the public by providing full assistance in processing and settling their genuine claims, and proactively reaching out to families. especially in case of the death of insured members, to ensure timely support.

To ensure the schemes reach the most deserving, the Chief Secretary directed for the inclusion of Self Help Group (SHG) members registered with

During the meeting, Principal Secretary, Finance, Santosh D. Vaidya, highlighted the noteworthy performance of J&K Bank, stating that it had achieved an 11% year-on-year

growth in its business, significantly reduced its Non-Performing Assets (NPAs) to 3.37%, and brought down its cost-toincome ratio to 58% from the earlier 71%. He appreciated the bank administration for these achievements and termed the performance as satisfactory and commendable.

Managing Director, J&K Bank, Amitava Chatterjee, also shared important statistics on the implementation of social security schemes across the UT. As the lead bank and Convenor of UTLBC, he detailed the bank's efforts to popularize financial inclusion schemes and expand credit outreach to the priority sectors.

He pointed out that the latest statistics clearly reflect significant improvement over the figures presented in the previous review meeting held under the chairmanship of the Chief Secretary. He pointed out that the UT has recorded significant strides in financial inclusion and social welfare coverage as per the performance data for various centrally sponsored schemes thereby highlighting the growing participation of citizens and strong involvement by banking institutions here.

In its presentation the Convenor UTLBC, Rayees Maqbool revealed that J&K currently hosts2,197 brick-and-mortar bank branches in addition to 5,135 Banking Correspondents (BCs) and a network of 2,661 ATMs operated by 37 banks and financial institutions ensuring that one banking touch point is available per 1,227 of population.

The meeting was apprised that efforts are underway to fully cover the remaining 21 URCs identified by RBI here under tier 5 areas (population under 5,000) with banking touch points. It was announced that 150 additional Gram Panchayats are scheduled to be covered by May 15, 2025, by J&K Bank.

Regarding the implementation of Pradhan Mantri Suraksha Bima Yojana (PMSBY), an accident insurance scheme for citizens aged 18-70 years saw 6.04 lakh enrollments during FY 2024-25; reaching the cumulative coverage of 23.57 lakh beneficiaries in the UT.

The Micro, Small, and Medium Enterprises (MSME) sector absorbed Rs. 22,688 Cr, accounting for 62% of priority sector lending. A total of 2.96 lakh accounts were supported with J&K Bank leading the table with Rs. 5,537 Cr disbursements in this sector.

The meeting was informed that the agriculture sector too received focused attention with Rs. 6,430 Cr disbursement out of a target of Rs. 11,056 Cr, achieving nearly 58% of the set goal.

Under PM Mudra and PM Vishwakarma Yojana aiming at empowering the entrepreneurs as on March 31, 2025 substantial disbursements were made under Shishu, Kishor, and Tarun categories providing support to small entrepreneurs, women, and youth-led micro businesses

It was added that under the PM Vishwakarma Yojana, growing traction was observed across various trades. The RSETI performance in skilling of rural masses (since 2009) depicted training of 1,07,672 trainees, and starting of 78,059 ventures (72.5%), and nearly 50% beneficiaries availing bank credit to start their respective enterprises.

## 'Consistent Care, Inhalers Key To Managing Lifelong Disease'

SRINAGAR: Asthma, a chronic respiratory condition affecting millions globally, is a lifelong disease requiring consistent and proper medical care, experts said on Tuesday.

While there is no permanent cure, asthma can be effectively managed through timely diagnosis, regular monitoring, and adherence to prescribed treatment. Inhalers are considered the cornerstone of therapy.

Noted Pulmonologist Naveed Nazir Shah said the incidence of asthma in the community is around 2.5 to 10 per cent. He said the region's greenery, flowering plants, pollens, and cold waves, along with triggers like dust, smoke, cold air, and stress, can lead to more frequent and potentially lifethreatening asthma attacks.

Dr Shah said asthma often begins in childhood and continues into adulthood. While symptoms may be mild initially, they can become severe if not properly treated. Environmental factors such as pollen, dust, and air pollution also contribute to asthma attacks. He said all necessary diagnostic facilities for allergy and asthma are available in Kashmir.

The noted pulmonologist called for educating the public about the disease, as many people only follow treatment during attacks and stop once their symptoms improve. This inconsistency can lead to increased severity and a higher risk of future attacks.

"Inhalers remain the safest and most effective method of delivering asthma medication directly into the lungs," Dr Naveed said. "Unlike oral medications, inhalers act quickly, require lower doses, and minimise systemic side effects."

He added that asthma symptoms like wheezing, shortness of breath, coughing, and chest tightness can worsen without appropriate treatment. Inhaled corticosteroids and bronchodilators help control inflammation and open airways. Dr Shah debunked the misconception that inhalers are addictive or harmful, calling it "entirely baseless".

Dr Javid, another chest disease specialist, urged the public to overcome myths and fear surrounding the use of Rotacaps, inhalers, and nebulisers, particularly in cases of acute severe asthma or spasmodic bronchitis. He said these devices are not only safe but crucial for immediate symptom relief and preventing complications during respiratory emergencies.

Dr Javid said that during acute asthma attacks or spasmodic bronchitis episodes, airways narrow rapidly, causing shortness of breath, wheezing, and a drop in oxygen levels. "In such cases, fast-acting bronchodilators delivered through inhalers, nebulisers, or Rotacaps can open the airways within minutes," he said—(KNO)

## **Under Construction Footbridge Collapses In Gbl Village**

SRINAGAR: An under construction footbridge collapsed in Lati Gundroshan area of Shadipora, leaving the residents of Ganderbal and Bandipora districts anguished.

The footbridge continued to remain incomplete for the last 15 years. According to the locals, the footbridge was intended to connect several villages.

They said the under construction footbridge collapsed today, resulting in minor injuries to two individuals. "We have waited nearly 15 years for this vital link. It's still not usable," said a local resident. Another remarked, "No shikara operator relies on this bridge it's been practically abandoned due to its incomplete state."

An official from the Roads and Buildings (R&B) Division Sumbal, under the Public Works Department (PWD), confirmed that the bridge is being executed by SICOP, a government-run corporation, while the department oversees the work.

"About 50% of the plates had been installed when a sudden imbalance caused the ropeway to collapse," the official stated.

The official further alleged that Shikara operators had been anchoring sand-laden boats beneath the structure and using the incomplete bridge to haul them—a possible factor that may have contributed to the collapse.

## **Some Consider Indian Cricket** Their Personal Fiefdom: Gambhir

NEW DELHI: "Those living in glass houses shouldn't throw stones at others." India head coach Gautam Gambhir hardly pulled back punches as he responded to criticism from a couple of former Test stars, accusing them of treating Indian cricket as their "personal fiefdom".

While Gambhir didn't take names, he dropped enough hints to make it obvious that the target of his outburst were two former India skippers from Mumbai, who have been critical of him since his playing days.

"Í am into this job for eight months. If results don't come, I am fine with criticism. It is people's job to criticise. There are people who are sitting in the commentary box for 25 years and feel that Indian cricket is their personal fiefdom,' Gambhir said at ABP News' 'India At 2047' Summit.

"Indian cricket's no one's personal property and it belongs to 140 crore Indians," he asserted.

These people have raised questions about my coaching, concussions (when he left 2011 Tour of England after a head injury), to distribution of Champions Trophy prize money," the straight-talker from Delhi said.

A former India head coach, who is also a commentator, had spoken about Gambhir's "concussion" not being particularly serious during the team's 0-4 whitewash at the hands of England in

As far as the Champions Trophy prize

money is concerned, it was former India skipper Sunil Gavaskar, who wondered in his column for 'Sportstar' whether Gambhir would follow his predecessor Rahul Dravid and share the windfall with the support staff.

"After India's T20 World Cup win, Ra-

hul Dravid, always a team player, chose not to take more than his fellow coaches.

"He shared the reward equally with them. However, with the announcement of the Champions Trophy rewards, we haven't heard any comment from the current coach, Gautam Gambhir, on whether he will adopt Dravid's approach. Does Dravid's example no longer hold value?'

Gambhir did not take Gavaskar's name but it was evident that he had not taken kindly to the poser in the column.

"I don't owe any explanation to anyone as to whether I have given money or not...Those living in glass houses shouldn't throw stones at others."

Gambhir also rejected the speculation surrounding his differences with Test and ODI skipper Rohit Sharma.

'...who are these people, who are saying all these things? These are speculations done by experts and those who run YouTube channels. Two months back, a coach and a captain together won a Champions Trophy.

"Imagine what you would ask if we ouldnt have won CT. I respect w Rohit has done for Indian cricket. I have got a lot of time for someone like Rohit Sharma. It was from start and it will remain like that with him," he asserted.

## **India Shouldn't Play Pakistan Till Terrorism Ends: Gambhir**

India head coach Gautam Gambhir on Tuesday called for a complete halt to cricketing engagements with Pakistan at any forum, including Asia Cup and ICC events, in the aftermath of the Pahalgam terror attack

At an ABP event, Gambhir said the national team should not be playing the arch-rivals till cross-border terrorism ends. India have not played a full series against Pakistan

since 2007 due to the tense relations between both countries. They only play each other at multi-team events and even that should be discontinued, said "My personal answer to this is absolutely no. Till all

this (cross-border terrorism) doesn't stop there should not be anything between India and Pakistan," said Gambhir when asked about the future of Indo-Pak cricket in the current environment.

"Ultimately this is government's call whether we play them or not. I have said this before also, no cricket match or Bollywood or any other interaction is more important than the life of Indian soldiers and Indian citizens," Gambhir said.

# Captaincy Became Too Much In The End; Stepped Down To Be Happy: Kohli

**BENGALURU:** The constant pressure of leading India and Royal Challengers Bengaluru for nearly a decade and the relentless scrutiny around his batting "became too much in the end" for Virat Kohli, who says he stepped down from leadership to be in a "happy space"

Kohli resigned as T20 captain after the World Cup in 2021, following which he also relinquished RCB's leadership role. A year later, he quit Test captaincy following the defeat to South Africa.

Kohli said he reached a point in his career where the constant attention became unbearable.

"At one point, it did become tough for me because there was just too much happening in my career. I was captaining India for a period of 7-8 years. I captained RCB for nine years. There were expectations on me from a batting perspective every game that I played," said Kohli in an 'RCB Bold Diaries' podcast.

"I didn't have this sense that the attention was off me. If it wasn't captaincy, it would be batting. I was exposed to it 24x7. It did get very tough on me, and it did get too much in the end.'

Kohli, who also took a monthlong break from cricket in 2022 and did not touch a bat during that phase, added that a time had come in his life when he was struggling to by happy in

'That's why I stepped down because I felt like if I've decided I want to be in this place, I need to be happy

"I need to have a space in my life where I can just come and play my cricket without being

judged, without being looked at as what are you going to do this season and what's going to hap-pen now," said Kohli, who has been with RCB since the inaugural edition of the IPL

Leading India to the Under-19 World Cup title triumph does not guarantee one a seamless entry into the senior team, and Kohli said it was his determination and the backing of then skipper Mahendra Singh Dhoni and coach Gary Kirsten, which helped him secure the No. 3 batting spot in the side.

"I was very realistic about my abilities. Because I had seen a lot of other people play. And I did not feel like my game was anywhere close to theirs. The only thing that I had was determination. And if I wanted to make my team win, I was willing to do anything.

That was the very reason

I got chances to play for India initially. And Gary (Kirsten) and MS (Dhoni) made it very clear to me that we are backing you to play at number three." Kohli said the two encour-

aged him to play his natural game, knowing that he would always be a fighter on the field.

"This is what you can do for the team. What you represent on the field, your energy, your engagement, is of the biggest value to us. We want you to play that way. 'So, I was never looked at as

this outright match winner who can change the game from anywhere. But I had this thing, I'm going to stay in the fight. I'm not going to give up. And that is what they backed.'

Kohli feels nervous energy is something that is crucial to success in cricket, and no matter how many runs one scores,

it is something that keeps a player in competitive mode. 'What happens when

you're young is you feel like, if I have scored X amount of runs by the time I'm this age or whatever', things will ease out. It never happens like that.

"And that is the marker actually. When you stop feeling that nervousness or that anticipation of how things are going to unfold is when people say that you're done," he said.

"So that never goes away from you because that very energy is what keeps you engaged to do what you need to do in that moment, in that pres-
