Waqf Islamic Concept But Not Essential To Islam: Centre

New Delhi: The Centre on Wednesday defended the Waqf (Amendment) Act, 2025 in the Supreme Court and said though wagf was an Islamic concept, it was not an essential part of Islam.

Arguing before Chief Justice B R Gavai and Justice Augustine George Masih, Solicitor General Tushar Mehta said, "Waqf is an Islamic concept. But it is not an essential part of Islam.. Waqf is nothing but just charity in Islam." "Charity is recognised in every religion, and it cannot be regarded as an essential tenet of any religion," he said.

Earlier in the day, Mehta asserted nobody could claim right over public land by using waqf by user principle which was a statutory right and the law could take it away.

"Waqf by user" refers to a concept where a property is recognised as waqf based on its long-term use for religious or charitable purposes, even without formal documentation.

Responding to the challenge against the validity of the 2025 law, Mehta argued the amended law dealt with the secular aspects of wagf and activities that were non-essential to Islam.

Mehta said the "waqf by user" concept did not permit "wholesale takeover of waqf properties" by the state as alleged.

"Waqf by user is not a funda-mental right, it is a creature of statute, and what the legislature creates, it can also take away," he said. | More On P10

'Strong Climate Plans Antidote To Prevailing Economic Uncertainty'

ew Delhi- UN climate change chief Simon Stiell on Tuesday said clear and strong climate plans are an antidote to the economic uncertainty gripping the world. Addressing the 2025 Nature Summit in Panama City, he said that at a time when tariffs, trade barriers and slowing growth have been dominating headlines, robust climate policies can help get trade flowing and economies growing. Stiell said that while global supply chains are being fractured, climate chaos will result in even more serious and sustained im-

"In the Panama Canal, climate change has already driven water

levels lower. Slowing shipping and disrupting trade routes. For the average person, that means costs going up and less money to spend. It also means critical medical supplies delayed for those in desperate need, businesses collapsing and livelihoods vanishing," he said.

But amid all the change and disruption, he said, clean energy projects are in pipelines all around the world. "Investors have their fingers on the button, waiting to push go on multi-billiondollar commitments that will make lives better."

Governments just need to give signals to markets and, for that, a new generation of national climate plans or NDCs are utterly essential, he said.

Stiell said that unlike in the past,



when climate plans often focused mainly on cuts to greenhouse gas emissions and old-fashioned energy, the new generation of climate plans should be about growth and building a better future where nature is protected.

"Done right, these plans can attract a bonanza of benefits. More jobs. More revenue. And a virtuous cycle of increased investment. But unless it's implemented an NDC is just a piece of paper. That's why political leadership now is so

important," he said. He added that political and policy signals from almost all of the world's largest economies are very clear: global decarbonization is unstoppable and continues to gather pace and scale.

Countries like Brazil, Germany and China are stepping up with ambitious climate plans. Green technologies are growing fast and becoming cheaper, he said.

The UNFCCC executive secretary, however, warned that the world cannot afford a two-speed transition, where some countries race ahead with clean energy and climate resilience and leave others

"We need to work together to ensure that everyone benefits. That new markets open and new trade routes form," he said.

Div Com Led Panel Reviews Policy For Repairs Near Dal Lake

SRINAGAR: To frame a comprehensive policy to address the issue of repair & renovation of houses & buildings within 200 meters of Dal Lake, a meeting of committee members was held under the chairmanship of Divisional Commissioner (Div Com) Kashmir, Vijay Kumar Bidhuri.

The meeting was attended by Deputy Commissioner, Srinagar; Vice Chairman, LCMA; Vice Chairman, Srinagar Development Authority; Director, Tourism Kashmir; Member Secretary, PCC; Chief Engineer, UEED; Chief Town Planner, Kashmir and HOD, Department of Environment Science University of Kashmir.

The meeting discussed and deliberated on the agenda points which includes to lay down the norms/eligibil-

ity conditions for declaring a building to have been constructed legitimately, prior to imposition of ban by the Hon'ble High court.

It also discussed norms for granting permissions by the BOCA LCMA for carry ing out repair/renovation/ reconstruction of the legitimately constructed buildings within 200 meters of the Dal Nigeen Lakes, prior to imposition of ban on 19.07.2002.

The members also discussed prescribing norms to be followed by the buildings granted permission for repair/renovation/reconstruction for ensuring scientific and proper waste disposal.

Further, measures for sustainable construction using alternate technologies in order to make the construction process lake friendly and norms for maintaining aesthetics and heritage patterns were also discussed.

Massive Fire Guts Five Houses In Nawakadal

Srinagar: A devastating fire tore through the congested Nawakadal locality of Srinagar late Tuesday night, damaging at least five residential houses and reducing the wedding dreams of a local family to ashes. Among the worst affected was a household preparing for the wedding of their daughter, whose trousseau and other wedding items were completely destroyed in the blaze.

The fire, which broke out around midnight, caused widespread panic in the densely packed neighbourhood. Residents described a scene of chaos as flames quickly engulfed multiple structures.

Nazir Ahmad, the bride-tobe's uncle, recounted the harrowing moments. "We were coming out of the masjid when we heard people screaming. In no time, the fire had spread to several houses. The area is so congested that we couldn't even get close to help contain it," he said, his voice trembling.

The family had been preparing for a wedding scheduled for August. "We had collected everything for her marriageclothes, jewellery, household items. Everything is gone. We had so many dreams for her, and all of them were consumed by the fire," Ahmad said with tears in his eyes.

Local residents expressed gratitude for the swift action of the Fire & Emergency Services (F&ES) Department, crediting their timely response with preventing an even greater tragedy.

Officials from the Fire Services Department confirmed that five houses—comprising both double-storey and three storey structures-were involved in the blaze. Preliminary findings suggest an electrical short circuit as the cause.

Pakistan To Extend Closure Of Its Airspace For Indian Flights By Another Month: Report

Islamabad: Pakistan has decided to extend the closure of its airspace for Indian flights by another month, a media report said on Wednesday.

Pakistan banned its airspace for India last month after the steps taken by New Delhi in the wake of the Pahalgam terrorist attack on

The ban was imposed for a month until May 23, as una Notice to Airmen (Notam) will be issued.

The development comes amid heightened tensions between the two neighbours following India's precision strikes under 'Operation Sindoor' on terror infrastructure in Pakistan and Pakistan-occupied Kashmir on May 7.

The Indian military has been maintaining that Pakistan pleaded for stopping the military actions after India hit eight military installa-



der International Civil Aviation Organisation rules the airspace restrictions cannot be imposed for more than one month at a time.

Quoting sources, Geo News reported that the decision to extend the ban is expected to be announced on Wednesday or Thursday, and tions in Pakistan on early May 10 in response to Pakistan's attempts to target Indian military bases.

This is not the first time Pakistan has imposed such restrictions. Pakistan closed its airspace for Indian flights during the 1999 Kargil conflict and the 2019 Pulwama crisis.

'Lawyers Avoid Work in Vacation, Judiciary Blamed for Case Backlog'

New Delhi: hief Justice of India B R Gavai on Wednesday said lawyers don't want to work during vacation but the judiciary is blamed for the backlog of cases.

A bench comprising Chief Justice B R Gavai and Justice Augustine George Masih got miffed when a lawyer urged listing of a petition after the summer vacation.

"The first five judges are sitting through the vacation and continuing to work, yet we are blamed for the backlog. In reality, it is the lawyers who are unwilling to work during the vacations,' the CJI said.

Recently, the top court issued a notification on the benches that will function during the upcoming summer vacation, rechristened as "partial court working days", from May 26 to July 13.

Significantly, there will be two to five vacation benches sitting during the partial court working days and even top five judges, including the CJI, will be holding courts during this period.

According to earlier practice, there used to be only two vacation benches during the summer vacation, and senior judges were not supposed to hold courts.

The notification outlined the weekly allocation of justices across benches

From May 26 to June 1, the CJI, Justices Suryakant, Vikram Nath J K Maheshwari and B V Nagarathna will be heading the five benches respectively.

During this period, the apex court registry will remain open from 10 am to 5 pm for all officers and staff.

The registry will be closed on all Saturdays (except July 12), Sundays, and public holidays.



Basavaraju, Backbone Of India's **Naxalite Movement, Killed**

NEW DELHI: Indian commandos shot dead the Maoist insurgent chief and 26 other guerillas on Wednesday, the country's home minister said, calling it a decisive blow to the decades-long conflict.

India is waging an all-out offensive against the last vestiges of the Naxalite rebellion, named after the village in the foothills of the Himalayas where the Maoistinspired guerrilla movement began nearly six decades ago.

More than 12,000 rebels, soldiers and civilians have died since a handful of villagers rose up against their feudal lords there in 1967.

At its peak in the mid-2000s, the rebellion controlled nearly a third of the country with an estimated 15,000 to 20,000 fighters.

Prime Minister Narendra Modi said he was "proud of our forces for this remarkable success", adding that the government was "committed to eliminating the menace of Maoism and ensuring a life of peace and progress"

In the latest incident, 27 rebels were killed in the central state of Chhattisgarh, including Nambala Keshav Rao, alias Basavaraju, the general secretary of the banned Communist Party of India-Maoist group, interior minister Amit Shah said.

"This is the first time in three decades of Bharat's (India's) battle against Naxalism that a general secretary-ranked leader has been neutralised by our forces,' he said in a statement.

"I applaud our brave security forces and agencies for this major breakthrough," Shah added, calling Rao the "topmost leader, and the backbone of the Naxal movement"

Shah said that in wider operations 54 people had been arrested, and a further 84 Naxalites had surrendered in the states of Chhattisgarh, Telangana, and Maharashtra.

Shah repeating a vow to crush the rebels, saying that the

"Modi government is resolved to eliminate Naxalism" before March 31 next year.

The firefight broke out deep inside a forest in Chhattisgarh's Narayanpur district, a remote and densely wooded region that has long served as a Maoist stronghold. Senior state police official Vivekanand Sinha said the gun battle took place after intelligence reports indicated the presence of 'top Maoist leaders" in the area.

A police commando also died during the fierce action, said local police chief P. Sundarraj.

A crackdown by Indian troops in a stretch of territory known as the "Red Corridor" has killed more than 400 rebels since the beginning of 2024, according to government data.

Police said they had killed 31 Maoist rebels during a threeweek operation this month aimed at capturing a strategic hill range

The conflict has also seen several deadly attacks on government forces. A roadside bomb killed at least nine Indian troops in January

Suicide Blast Targets Army School Bus In Balochistan, 4 Children Killed

Islamabad: Four children were killed in a blast targeting an army school bus in Pakistan's troubled Balochistan province, a government official said on Wednesday.

"The bus was on its way to a school in an army cantonment, said Yasir Iqbal, the administrator of Khuzdar district, where the incident took place.

Around 40 students were in the bus that was headed to an arAround 40 students were in

the bus that was headed to an army-run school, when the blast took place, Igbal said, adding that several were injured in the incident.

US Warns Of Syria's Collapse Without **Embracing Rebranded Al-Qaeda**

Washington: US Secretary of State Marco Rubio has appealed for further American and regional support for the Hay'at Tahrir al-Sham (HTS)-led administration in Syria to ward off its "potential coll amid the ruling regime's suppression of minorities.

Speaking before the Senate Foreign Relations Committee, Rubio issued the warning about the possible collapse of the HTS regime of Abu Mohammed al-Jolani while defending the removal of US sanctions on Damascus and urging deeper American involvement to prevent another war in Syria.

"Given the challenges they're facing, are maybe weeks — not many months — away from potential collapse and a full-scale civil war of epic proportions, basically the country splitting up," the US secretary of state said.

Rubio stressed that sanctions relief "will not suffice," urging "congressional action or a

The US official said sanctions relief could enable "neighboring countries to begin to assist the transitional authority to build governance mechanisms that allow them to actually establish a government, unify the armed forces under one banner and the like.

Underlining the necessity of US engagement with the HTS-led

administration in Svria. Rubio said, "If we engage them, it may work out, it may not work out. If we do not engage them, it is guaranteed to not work out."

Acknowledging concerns about Jolani, a US-designated terrorist, and members of Syria's transitional authority, he said, "The bad news is that the transitional authority figures—they didn't pass their background check with the FBI.'

Youth Congress sues BJP IT cell chief, Arnab Goswami

n FIR has been registered against BJP IT cell head Amit Malviya and Editorin-Chief of Republic TV, Arnab Goswami for allegedly running false information, police said.

The case was registered at High Grounds police station on Tuesday, based on the complaint from the Indian Youth Congress's legal cell head Shrikant Swaroop B N against the duo under Sections 192 (wantonly giving provocation with an intent to cause riot) and 352 (Intentional insult to provoke breach of peace) of the Bharatiya Nyaya Sanhita, they said.

Swaroop accused Malviya and Goswami of "masterminding a heinous and criminally motivated campaign to

disseminate patently false information." He alleged that the accused have "maliciously propagated the fabricated claim" that the Istanbul Congress Centre in Turkiye is the office of the Indian National Congress (INC).

'This act was executed with clear and undeniable criminal intent to deceive the Indian public, defame a major political institution, manipulate nationalist sentiments, incite public unrest, and undermine national security and democratic integrity," he stated.

Swaroop further stated that the actions of Malviya and Goswami are set against the volatile backdrop of strained relations between India and Turkiye, driven by the latter's perceived support for Pakistan.

Trump's Sweet Tooth: He Eats 'Good Amount' Of Candy, Likes Pink Starbursts, Tootsie Rolls

President Donald Trump has a sweet tooth and his favourites are pink Starbursts and Tootsie Rolls.

So said Karoline Leavitt, the White House press secretary, at a briefing Tuesday for the children of reporters who cover the White House. It was part of a day of activities the White House organised as it observed the annual Take Our Daughters and Sons to Work Day event.

The Republican president and his wife, first lady Melania Trump, also held separate events of their own.

One child asked Leavitt about Trump's daily candy consumption. She characterised his intake as a "good amount" and added that "he likes pink Starburst and



A few questions touched on administration policy, such as the state of the US-Mexico border and what Trump is willing to do about climate change.

But even more questions were about his favourite foods and they led Leavitt to share that Trump also likes to eat a "big, beautiful steak," ice cream sundaes with chocolate sauce and some toppings, and hamburgers and fries from McDonald's.

She appeared to be stumped

by a few of the inquiries, including about the president's favourite soccer player and his favourite child. Trump has five adult children.

'That is a very controversial question and I'm not going to answer it," Leavitt said after the laughter subsided, "I know he loves all of his children very much, and they're all great kids.'

Earlier Tuesday, the first lady joined a few dozen children whose parents work in the Executive Office of the President in decorating wooden American flags.

She used a glue stick to attach two silver glittery stars to her red, white and blue flag after she took her seat at one of two tables in the Jacqueline Kennedy Garden on the South Lawn. The first lady admired the children's work and told several that their creations were "beautiful."

Kuwaiti University Student Sentenced To Three Years In Prison For Insulting Emir on X

ubai: A university student in Kuwait has been sentenced to three years in prison with hard labour after the country's top court upheld her conviction for insulting the Emir and inciting the overthrow of the regime through posts made on the social media platform X.

The Court of Cassation on Monday affirmed earlier rulings by the Criminal Court and the Court of Appeal, which found the student guilty of publishing politically sensitive content using a fake account.

Prosecutors argued that the student had posted a series of articles and comments deemed offensive to the Emir and critical of Kuwait's political system.

Shortage Of Vital Vaccines For Children Sparks Concern In Pulwama

Pulwama: A severe shortage of essential childhood vaccines has caused distress among parents and healthcare workers in south Kashmir's Pulwama district.

According to reports, critical vaccines—including Penta (Pentavalent), IPV (Inactivated Polio Vaccine), RVV (Rotavirus Vaccine), and PCV (Pneumococcal Conjugate Vaccine)—are unavailable at multiple vaccination centres across the district.

A health worker involved immunisation efforts, speaking anonymously, revealed that the shortage has persisted for the past two months. "We are facing repeated issues, and parents often get frustrated when we have to send them back without vaccinating their children due to unavailability," the worker said.

Parents have raised urgent concerns about the health risks posed by this disruption, fearing that delays in immunisation could leave infants and young children vulnerable to preventable diseases. They said that vaccination sessions are scheduled weekly, and despite the expectation of maintaining adequate stock, the supply chain has been hampered over recent weeks for reasons unknown.

This situation has led parents and local representatives to seek immediate intervention from higher authorities. They have appealed to Deputy Commissioner Pulwama, Basharat Qayoom (IAS), and MLA Waheed Para to address the crisis immediately.

A concerned parent said, "This vaccine shortage is endangering our children's health. We urge the authorities to restore supply chains, ensure equitable distribution, and keep the public informed about when supplies will be replenished."

Commissioner Deputy Pulwama, Basharat Qayoom, said he has instructed the Chief Medical Officer (CMO) and relevant officials to take immediate steps to ensure the availability of vaccines. "Most vaccines are currently available at several centres, and the supply is expected to be replenished by this Saturday," the DC assured

It is important to note that the vaccines in question—Penta, IPV, RVV, and PCV—are vital for protecting children against serious diseases. Penta vaccine guards against Diphtheria, Pertussis, Tetanus, Hepatitis B, and Hib. IPV prevents polio, RVV against rotavirusinduced diarrhoea, and PCV protects against pneumococcal infections like pneumonia and meningitis. These vaccines are integral to the routine immunisation schedule for infants and young children—(KNO)

Heaps Of Dirt Removed As Watchi Residents Clean **Irrigation Canal**

Srinagar: Residents of a Watchi village in Zainapora hamlet of south Kashmir's Shopian district are expressing outrage after they removed heaps of dirt during the cleaning of a local irrigation canal, which was dumped directly onto the main road, causing significant inconvenience to commuters and pedestrians.

The residents of Watchi said that the road from Watchi to Melhoora has become nearly impassable at several points due to the piles of mud and debris left by the contractor in charge of the desilting operation.

They said that the cleaning was meant to improve water flow to nearby fields, but residents say poor execution has created a new problem.

"Instead of properly disposing of the silt, the contractor dumped it right on the main road," said Ghulam Nabi, a local resident.

'We are not against canal cleaning, but why should we suffer for their negligence?" asked Shabnam Jan, a local resident. "The road is not just dirty—it's dangerous. Slippery mud makes accidents more likely." Locals have requested concerned authorities to look into the matter and direct the contractor not to dump slit on the road.

Meanwhile, an official told KNO that they have already taken cognizance of the issue and debris will be cleared while no slit will be allowed to put on the road while cleaning of the canal—(KNO)



BSF Foiled Infiltration Bid Of Nearly 50 Terrorists During 'Operation Sindoor': DIG Mand

Jammu: The Border Security Force (BSF) foiled an infiltration bid of nearly 50 terrorists during "Operation Sindoor" on May 8, a top official of the paramilitary force said on Wednesday.

Deputy Inspector General (DIG) of the BSF, SS Mand, said, "On May 8 a major infiltration attempt involving 45–50 heavily armed terrorists was thwarted by the alert BSF personnel in Samba district.

He said, "The group, attempting to sneak into Indian Territory under the cover of ceasefire violations, was met with a fierce counteroffensive. BSF retaliated with heavy mortar fire, neutralizing enemy positions and forcing the infiltrators to retreat."

"We had prior intelligence that a large group was attempting infiltration. Our alert troops identified them early, and within 1.5 hours of engagement, the group was repelled with heavy losses. Our forces responded with precision and intensity, degrading their bunkers and suppressing their firepower," DIG Mand said.

He said that in a decisive and calibrated military operation, the BSF destroyed multiple terrorist hideouts in Pakistan's Sialkot sector along the India-Pakistan International Border during Operation Sindoor, launched in response to the April 22 Pahalgam terror attack, which left 26 civilians, mostly tourists dead.

"Even two weeks after the operation, Pakistani Rangers have reportedly abandoned their posts along the international border, signaling the extent of damage and demoralization inflicted by Indian forces," he added.

DIG Mand praised the high morale and preparedness of BSF troops, emphasizing the leadership of officers on the frontline. He also highlighted the commendable performance of women soldiers, who operated shoulder to shoulder with their male counterparts during the high-stakes confrontation. "We are truly proud of our women troops," he said.

Following the setbacks during "Operation Sindoor," Pakistan resorted to drone warfare, attempting to target civilian and military installations in Jammu. However, India's air defense systems and BSF's anti-drone units successfully intercepted these drone incursions. On May 9, Pakistan initiated unprovoked firing along the IB and launched drones aimed at BSF camps and border villages, but all such attempts were neutralized—(KNO)

22 km Of Neglect

Key Shopian Road Turns Nightmare For Commuters

The narrow road connecting Shopian to Aglar through Trenz, a stretch that links more than twenty villages, has become almost impossible to travel.

The 22-kilometer route, vital for daily commuting, transporting goods, and emergency services, lies in ruins.

Deep potholes and crumbling asphalt turn into pools of water when it rains, making it dangerous for vehicles and pedestrians alike.

For the people who live along this road — in villages like Trenz, Chitragam, Pahno, and Turkwangam — the

road's condition isn't just an inconvenience. It has become a barrier.

During the rainy season, some villages are nearly cut off, making it harder to reach hospitals, schools, and markets. Local farmers struggle to move their produce on time, and during harvest season, traffic jams choke the road for hours near the IGC Lassipora area, where vehicles barely inch forward.

The situation has drawn the attention of lawmakers. In the most recent Jammu and Kashmir Assembly session, several elected representatives raised the issue, pressing for immediate repairs.

The Minister for Roads and Buildings and the Chief Minister assured the house that the work would begin once the weather improved. But with summer already here, there has been no sign of repair crews or equipment on the road

Imran Dar, who lives in Trenz, said, "Every election we hear promises about fixing this road. Every year, it just gets worse. Ambulances avoid this route, school buses take longer detours, and farmers lose precious time transporting their crops. How much longer do we have

'Land Mafia Looting Karewas From Sholipora To Khansahib'

Budgam: In a blatant violation of environmental laws and the Land Revenue Act of 1996, large-scale illegal excavation of Karewas is reportedly taking place from Sholipora to Khansahib in Central Kashmir's Budgam district. Locals have accused the Land Mafia' of looting the mineralrich soil while the authorities turn a blind eye.

Locals have taken to social media to express their anger, tagging the District Mineral Officer Budgam and questioning the administration's silence on the matter. They allege that despite repeated appeals, no concrete action has been taken to stop

the illegal activity.

"This is not just land theft, it's an environmental disaster in the making. These Karewas are a natural heritage and crucial for horticulture and agriculture. Their destruction will have long-term consequences," said a concerned resident of Khansahib.

Environmentalists have also raised alarm, saying that the unregulated digging has already caused irreversible damage to soil fertility and the local ecosystem.

Locals allege that heavy machinery is being used to dig out earth from the Karewas, which is then sold for construction and landfilling purposes, violating multiple sections of the J&K Land Rev-

enue Act and environmental protection laws

Despite visible destruction and public outcry, the district administration, particularly the Geology and Mining Department, is yet to act decisively. Calls are growing louder for immediate intervention and strict legal action against those involved.

"If the authorities continue to remain inactive, the day is not far when these fertile plateaus will vanish, leaving behind only dust and devastation," a local activist warned.

Concerned locals from Budgam have demanded a halt to the illegal mining and strict enforcement of existing laws to safeguard the fragile Karewa ecosystem. [KNT].

Why a Newspaper **Still Matters**

'n today's digital age, where information is abundant and misinformation is even more pervasive, the role of a newspaper remains critical. More so, with the rise of social media, which has brought new challenges to the redibility and reliability of public discourse. In this environment, professionally produced journalism, grounded in fact, accountability, and editorial scrutiny has become more necessary than ever.

Kashmir Observer was launched in March 1997, at a time of deep uncertainty and political upheaval. Journalism in Kashmir, then and now, operates under extraordinary constraints. The region's turbulent history has often left little space for independent, balanced reporting. Despite this, we began publication with a clear editorial objective: to reflect the reality on the ground with integrity, depth, and independence.

We did not aim to merely report events as they occurred. We sought to explain their context, their consequences, and their underlying causes. While others, with few exceptions, focused on press statements and official handouts, we chose to focus on the stories behind the headlines, especially those related to the human cost of conflict, the social and economic issues affecting

everyday life, and the long-term implications of political developments.

Over the past two quarter of a century, Kashmir Observer has earned its credibility the hard way, by staying committed to facts, fairness, and independence in one of the most difficult media environments in the country. From the beginning, we've tried to keep our reporting balanced, to give space to multiple points of view, and to publish analysis that explains rather than provokes. That's easier said than done. In Kashmir, where resources are limited, and economic survival often depends on fragile revenue streams, independent journalism is always under strain.

The challenges for the media in Kashmir Valley are formidable. The me dia in the region has a particularly unenviable job to perform. The problems faced by it are both universal to the conflict situations and unique to the region. One of the major problems bedeviling the freedom of expression in the Valley is the economic sustainability of the local newspapers. Being a place with only a small private sector and little industrial presence, government

advertising is a predominant source of revenue for the newspapers. Even with these limitations, we at Kashmir Observer have tried to innovate. Our supplements and thematic pullouts-Young Kashmir, Bazar Observer, Jobs & Careers, and Khyen Chyen—were efforts to both diversify revenue and provide meaningful content to our readers. These platforms have brought attention to culture, employment, education, health, environment and more, subjects often overlooked in the highly politicized media space.

We also recognize that the media landscape is changing. The digital space has transformed how news is consumed and shared. The shift to digital has made access to news faster, but it has also blurred the lines between fact and fiction. Anyone with a phone and an opinion can now pass it off as news. As a result, facts are often drowned out by half-truths, speculation, and loud claims with little basis. It is here that a newspaper fills in the vacuum. It doesn't just carry information, it takes responsibility for it. It checks, verifies, and places it in context. It is this process of accountability that separates journalism from noise.. True, a newspaper is not infallible, but it is transparent, regulated, and guided by principles of journalistic ethics.

Today, a newspaper is not just a hard copy but it has also taken on a digital avatar, living across platforms such as e-paper, websites, apps, and social media handles. This digital presence has expanded the reach of traditional news organizations like Kashmir Observer. But here they are not a source of misinforma crucial role in offering verified a cluttered, noisy environment, a newspaper's digital presence becomes just as important as its print edition. Kashmir Observer has steadily grown into this space. Our digital edition, along with our social media platforms, now reaches millions across and beyond Jammu and Kashmir. This online reach- among the strongest in the Union Territory - gives us both a responsibility and an opportu

nity: to bring verified, well-sourced journalism to audiences.

As we move forward, Kashmir Observer will continue to pursue ethical journalism: that is, to report fairly, to reflect reality accurately, and to remain accountable to our readers. In an age where misinformation spreads quickly and truth becomes harder to establish, this mission is more urgent than ever. That said, the media in the union territory has been receiving government ads and also performing its job well like in the rest of the country. True, this also reflects positively on the approach of the successive governments towards the media. And it should stay that way. The alternative is the free run to misinformation and disinformation.





Kashmir's Investment Trap

The dream of fast profits is drawing young Kashmiris into risky investments, and into the hands of unverified market "experts." Here's what we need to change.

n Kashmir, more and more people are talking about stocks, gold, and crude oil these days. With few stable job options, investing seems like a promising way to grow savings. But behind the hopeful stories, a silent crisis is unfolding.

Many people are losing their hard-earned money. Not to the markets alone, but to the people they trust to guide them. I've seen cases where investors give full control of their finances to individuals

who claim to be market experts. These so-called advisors promise big returns and use technical terms that sound impressive but mean little to everyday investors.

Often, they open trading accounts not in the investor's name, but in their own, leaving the real investor with no access or protection. When profits come, they celebrate. But when losses hit, as they often do, these advisors blame the market and vanish. The investor is left with regrets and an empty balance sheet.

This pattern is not rare. It is slowly spreading in homes across Kashmir, especially among first-time investors who want better futures but don't know where

The fix isn't complicated. Open accounts in your name. Keep your documents updated. Never hand over your passwords or full control. Learn the basics. Read up. Ask questions. And most importantly, check if the person advising you is certified and experienced.

Investing is not gambling. It's not magic either. It takes patience, knowledge, and caution. If more people in Kashmir take the time to understand how the market really works, we can turn this wave of loss into one of real financial growth. Author is a Srinagar-based reputed financial advisor.

The unlikely land reform that began with two men, a field diary, and a forgotten village in South Kashmir.

n the folds of South Kashmir, tucked between apple orchards and old boundaries that exist more in memory than on paper, two revenue officials decided they'd had

Across India, especially in hilly or rural regions, land records are often a confusing mess — one that fuels family disputes, delays development, and sidelines the poor. But this patwari and girdawar, posted to a sleepy tehsil with no special funds, permissions, or staff, decided to do something rare: they rolled up their sleeves and fixed what they could.

Her Name Was Zoon

Before memes and microphones, there was Zoon Dub—a 20-minute monologue that challenged power, people, and the pulse of times.

There was a time in Kashmir when Thursdays belonged to Zoon Dub. At 9:15 PM sharp, everything else stopped: dinner conversations, shop-keeping, even quarrels.

keeping, even quarrels.
Radios crackled to life across the valley, tuned religiously to what was then Radio Kashmir, Srinagar.

What followed was not just a 20-minute serial drama. It was a collective ritual. And the plot was simple.

Zoon, a village woman with wit and wisdom, offered commentary on everything from politics to patriarchy, often without naming either.

Her world was local, but her insight was universal. What elevated the show, however, was its writing. It was sharp, subversive, and steeped in Kashmiri humour.

And the magnetic voice of Shameem Banu, who played Zoon with such authenticity that listeners felt she lived next door

Created by Ali Mohammad Lone, one of Kashmir's finest dramatists, Zoon Dub aired for nearly two decades, becoming the longest-running and most popular radio drama in the Valley's broadcasting

Its format was deceptively light. A monologue, a few interactions, but its impact was seismic.

Zoon's gentle barbs exposed corruption, critiqued bureaucracy, and challenged regressive customs, all while making listeners laugh.

The legend has it that people would even skip weddings to hear Zoon. She wasn't merely a character, she was a phenomenon.

It was satire that didn't shout, commentary that didn't preach.

The show's success was rooted in its craftsmanship. Lone's scripts were lyrical yet grounded, drawing from Kashmiri folklore, idioms, and everyday speech.

Shameem Banu's delivery turned every line into lived experience. She had no training, but her voice had gravity. She was Zoon.

She was Zoon.

At the height of its popularity, Zoon Dub rivaled television in influence, especially in rural areas where TV hadn't yet arrived. Listeners wrote letters, sent gifts, and even visited the station hoping to meet Zoon.

Teachers used her quips in classrooms. Politicians tuned in uneasily, aware they might be the next subject of her critique.

might be the next subject of her critique.
But the show's cultural dominance couldn't shield it from institutional decay.
As the 1990s strife intensified, key staff

fled, and Radio Kashmir became a guarded, skeletal version of its former self.

When Shameem Banu passed away in the late 2000s, Zoon Dub died with her.

The archives still held her recordings

The archives still hold her recordings, but few have heard them in years. The reels—some digitized, many still fragile—gather dust behind locked doors at Radio Kashmir. There is no plan to re-air them, no public memorial for the voice that once united a people.

The tragedy is not just that Zoon Dub ended. It's that we let it vanish without

In today's Kashmir, where FM channels churn out pop playlists and podcasts cater to urban youth, Zoon Dub feels like a relic.

But its disappearance is not merely a consequence of changing tastes, it reflects a broader cultural amnesia.

The institutions that created such masterpieces are either broken or inaccessible. The drama unit that produced Zoon Dub, once hailed as the finest in India, is barely functional. Writers aren't groomed. Performers aren't supported.

And so, Zoon remains silent.
But for those who remember her, she remains vivid. A reminder of what Kashmiri storytelling once was and what it could still be.

Her laugh, her wisdom, her resilience echo in memory, even if the airwaves have forgotten.

In a valley searching for itself, perhaps it's time to turn the dial back, to Zoon Dub, and the kind of art that spoke truth with a smile.

It came from the edges of Europe, settled in the valley, and now grows like memory—persistent, invasive, beautiful, and slightly wild.

Ashmir is a place where stillness grows tall. The wind carries snow in its sleeves and folds valleys into stories. Mountains keep their secrets under white veils.

Botanists call it an invasive species elsewhere, but here it is less threat, more treat.

The plant's history is thick with contradiction. Introduced to Britain in 1763 as a garden darling, it later spilled beyond its borders, seizing forests with such hunger it had to be cut back by hand, hacked at the root, its beauty a kind of blade.

In some places, even the bees avoid it. The nectar is too toxic, the welcome too wild. But Kashmir tells a different tale. Here, it decorates the damp woods, anchors the slopes, hums in the language of the land.

It is the state flower, yes, but more than that, it is a mood, a memory of colour in a mystic landscape.

in a mystic landscape.

Its presence is poetry with roots. The people say it helps the forest breathe. That it sweetens the silence. That it stands as proof of nature's patience.

Its sap once soothed toothaches. Its nectar, under certain moons, becomes "mad honey", thick with a toxin that slows the heart and brightens the mind. Danger and balm held in the same stem.

That, too, is Kashmir. A place where every beauty is doubled. Where even the flowers hold their breath. Where something as small as a petal might outlive the shade.

So when you walk those slopes, and you find that violet ghost rising beside you, remember: some things bloom not because the land is gentle,

but because the heart insists on colour anyway.

When Love Meets Addiction

He uncovered the secret, faced the pain, and chose to stand, for love and for family.

Zaffar hated addiction. He'd seen it rot lives from the inside. He swore it would never touch his home. Perhaps that's why he built a life on discipline, love, and clean living in a city corner. But some battles begin where you least expect them, within your own walls.

Zaffar married Zarina with deep love and hope. They had children, and tried to raise them with care and values. But love, as he would learn, is sometimes not enough to protect a family from what hides in plain sight.

Before they were married, Zarina had picked up a habit that, to her, didn't seem dangerous at the time.

In her childhood home, chewing tobacco was as common as a cup of tea. No one questioned it. It passed from one generation to the next like a harmless ritual

But what began as curiosity slowly turned into something stronger. And when she entered her new home with Zaffar, she carried it with her.

At first, there were only signs.
A faint bitter smell, small colourful sachets tucked into strange places, tins hidden in cushions and cuphoards.

cushions and cupboards.
Then Zaffar noticed the



change. Zarina suddenly became distant, emotionally and physically. He couldn't understand why.

He began putting the pieces together. The growing coldness. The physical signs. The denial. The lies. Zarina would brush him off, sometimes even blame unseen forces. "Someone is do-

ing black magic on us," she once said.

But one day, Zaffar found a carton with nearly sixty tins of chewing tobacco stuffed deep in Zarina's bag. His heart sank.

Hoping for help, he turned to Zarina's family. Maybe they'd speak to her, maybe they'd care. But they didn't. They waved

it off. "It's just a small habit," they said. There was no concern for Zarina's health. No talk of change. Instead, they dismissed Zaffar's pain like it was his fault. He was alone now.

And in that loneliness came a deeper fear: his children. He worried they'd start copying what they saw. He worried that their visits to their maternal home, where the habit was so normal, would one day shape their choices too.

Zaffar couldn't say all this out loud. It would spark fights. So he stayed silent. He gently discouraged visits to Zarina's home, but she didn't understand. She took the children anyway, stayed for days. The distance between them widened.

One evening, Zaffar sat down with her. No shouting. No anger. Just a voice full of empathy and love.

"It's not just about you anymore," he said. "They watch us. If they see you do this, they might one day follow. And by then, it'll be too late."

Zarina listened. For the first time, really listened. Tears came. She remembered her own childhood, watching her elders chew tobacco without ever thinking it was wrong. Now she stood on the edge of repeating that cycle.

That night, she made a choice. She decided to quit. The days that followed were hard. Headaches. Sleepless nights. Cravings that pulled at her body. But Zaffar stood by her. He brought cardamoms and chewing gum to help with the cravings. He didn't give up. Neither did she.

The house began to change.

The air felt lighter. The children laughed more. Slowly, the habit that once lived in corners and shadows disappeared.

But fear never truly left Zaffar. Every time Zarina visited her family, he worried. Would the old habit call her back? Would she slip? He never said this out loud. He simply stayed silent, hoping she would understand.

Maybe if someone had spoken up earlier, this story would've taken a different path. Maybe if Zarina's elders hadn't treated addiction like tradition, things would've been easier.

Still, Zaffar did what many don't. He faced it. Stayed. Loved. Fought the battle most don't see.

And this story, though personal, is not rare. Across homes, across cities, these small habits, seen as harmless, grow in silence. They pass from hand to hand, room to room, generation to generation. Until someone stops it.

Zaffar did. Not with anger. But with empathy.

What Does It Mean To 'Accept' Or 'Reject' All Cookies, And Which Should I Choose?

t's nearly impossible to use the internet without being asked about cookies. A typical pop-up will offer to either "accept all" or "reject all". Sometimes, there may be a third option, or a link to further tweak your preferences.

These pop-ups and banners are distracting, and your first reaction is likely to get them out of the way as soon as possible – perhaps by hitting that "accept all" button.

But what are cookies, exactly? Why are we constantly asked about them, and what happens when we accept or reject them? As you will see, each choice comes with implications for your online privacy.

What are cookies?

Cookies are small files that web pages save to your device. They contain info meant to enhance the user experience, especially for frequently visited websites.

This can include remembering your login information and preferred news categories or text size. Or they can help shopping sites suggest items based on your browsing history. Advertis-

ers can track your browsing behaviour through cookies to show targeted ads.

There are many types, but one way to categorise cookies is based on how long they stick around

Session cookies are only created temporarily – to track items in your shopping cart, for example. Once a browser session is inactive for a period of time or closed, these cookies are automatically deleted.

Persistent cookies are stored for longer periods and can identify you – saving your login details so you can quickly access your email, for example. They have an expiry date ranging from days to years.

What do the various cookie options mean?

Pop-ups will usually inform you the website uses "essential cookies" necessary for it to function. You can't opt out of these – and you wouldn't want to. Otherwise, things like online shopping carts simply wouldn't work.

However, somewhere in the settings you will be given the choice to opt out of "non-essential cookies". There are three types of these: -functional cookies, related to personalising your browsing experience (such as language or region selection) -analytics cookies, which provide statistical information about how visitors use the website, and -advertising cookies, which track

information to build a profile of you and help show targeted advertisements.

Advertising cookies are usually from third parties, which can then use them to track your browsing activities. A third party means the cookie can be accessed and shared across platforms and domains that are not the website you visited.

Google Ads, for example, can track your online behaviour not only across multiple websites, but also multiple devices. This is because you may use Google services such as Google Search or YouTube logged in with your Google account on these devices.

Should I accept or reject cookies?

Ultimately, the choice is up to you. When you choose "accept all," you consent

When you choose "accept all," you consent to the website using and storing all types of cookies and trackers.

This provides a richer experience: all features of the website will be enabled, including ones awaiting your consent. For example, any ad slots on the website may be populated with personalised ads based on a profile the third-party cookies have been building of you.

By contrast, choosing "reject all" or ignoring the banner will decline all cookies except those essential for website functionality. You won't lose access to basic features, but personalised features and third-party content will be missing.

The choice is recorded in a consent cookie,
and you may be reminded in six to 12 months.

Also, you can change your mind at any time, and update your preferences in "cookie settings", usually located at the footer of the website. Some sites may refer to it as the cookie policy or embed these options in their privacy policy.

How cookies relate to your privacy

The reason cookie consent pop-ups are seemingly everywhere is thanks to a European Union privacy law that came into effect in 2018. Known as GDPR (General Data Protection Regulation), it provides strict regulations for how people's personal data is handled online.

These guidelines say that when cookies are used to identify users, they qualify as personal data and are therefore subject to the regulations. In practice, this means: -users must consent to cookies except the essential ones -users must be provided clear info about what data the cookie tracks -the consent must be stored and documented -users should still be able to use the service even if they don't want to consent to certain cookies, and -users should be able to withdraw their consent easily.

Since a lot of website traffic is international, many sites even outside the EU choose to follow

GDPR guidelines to avoid running afoul of this privacy law.

Better privacy controls

Cookie pop-ups are tiresome, leading to "consent fatigue" – you just accept everything without considering the implications.

This defeats the purpose of informed consent.

There is another way to address your online privacy more robustly – Global Privacy Control (GPC). It's a tech specification developed by a broad alliance of stakeholders (from web developers to civil rights organisations) that allows the browser to signal privacy preferences to websites, rather than requiring explicit choices on every site

GPC is not universally available, and it's not a legal requirement – a number of browsers and plugins support it, but broader adoption may still take time.

Meanwhile, if you're worried you may have accidentally consented to cookies you don't want, you can find an option in your browser settings to delete cookies and get back to a clean slate (be warned, this will log you out of everywhere). If you want to learn even more, the non-profit Electronic Frontier Foundation has a project called Cover Your Tracks.

'Two-Thirds Of Job Seekers Open To New Roles Don't Know What Job Titles Sector To Look For'

umbai- Even though 67 per cent of professionals interviewed are open to new opportunities, they do not know what job titles or industries to search for, a report said on Wednesday.

According to research by professional network LinkedIn, 65 per cent of professionals stated they can explain their career goals to a friend but don't know how to search for that role, and 64 per cent find job filters confusing.

"Two-thirds (67 per cent) of professionals in India say they're open to new opportunities, however, they don't know what job titles or industries to search for," the report said.

Another 74 per cent wished they could discover relevant roles they hadn't thought to search for, it said.

As job titles evolve and skills become central to hiring decisions, there is increasing demand among job seekers for easier ways to find opportunities based on their skills and goals, rather than predefined titles or keywords, it added.

The report by LinkedIn is based on inputs from over 2,001 employed and unemployed respondents aged 18-78 years between April 25, to May 6, 2025.

In Stroke Care Structured Rehabilitation Plays Crucial Role: Experts

hen a 69-year-old woman slipped into a minimally conscious state after a major stroke last year, her family began preparing for the worst. Doctors across cities told her son,

who had flown in from abroad, that her chances of recovery were slim to none. She was unresponsive, unable to move and showed only faint signs of awareness. Today, she can sit up, track conver-

sations and respond with gestures. It is not a miracle. It is the outcome of timely neuro-rehabilitation, scientific precision and relentless persistence. As India marks the World Stroke

Awareness Month, the incident underscores a critical yet under-addressed truth in Indian stroke care.

While emergency treatment can

save lives, rehabilitation is what gives those lives meaning.


After multiple hospitals expressed

helplessness, the patient was admitted to Health Care at Home (HCAH), a chain of recovery and rehabilitation hospitals. There, she underwent a medically

There, she underwent a medically supervised, multidisciplinary neuro-re-habilitation programme led by specialists in Physical Medicine and Rehabilitation (PMR).

Her treatment plan included Multi-

Her treatment plan included Multimodal Sensory Stimulation, Hyperbaric Oxygen Therapy (HBOT) and advanced robotic and virtual therapies designed to activate dormant neural pathways and support functional recovery, said Dr Gaurav Thukral, co-founder and chief operating officer, HCAH.



"We see too many lives plateauing after emergency care simply because structured rehabilitation is not started in time," said Dr Thukral.

"At HCAH, the PMR-led model ensures that every therapy is medically prescribed and clinically timed. Whether it is exoskeleton-based gait training, end-effector robotics, virtual reality therapy, or HBOT, these interventions require specialist oversight and infrastructure not available in standard physiotherapy settings," he added.

Dr Varun Rehani of BLK-Max Super Speciality Hospital, Delhi, said that in stroke care, urgency must also extend beyond the emergency room or ICU.

The golden 90-day window after a stroke is when the brain's neuroplasticity is at its highest. Intervening during this time can significantly influence long-term recovery, said Dr Rehani, who is a neurology consultant at hospital's Centre for Neurosciences, Advanced Aneurysm Treatment, Epilepsy,

Parkinson's Disease.

"Delaying rehabilitation risks losing that vital opportunity. Early, intensive, and scientifically guided care that includes neurostimulation and evidence-based therapies can dramatically improve outcomes," he highlighted while talking to PTI.

The woman was diagnosed with a Disorder of Consciousness (DOC), a condition often misunderstood as irreversible. Her progress aligns with emerging global and Indian evidence highlighting the role of early neuroplastic stimulation in recovery, Dr Thukral said.

Dr Arunav Sharma, associate consultant, Neurosurgery, Sir Ganga Ram Hospital, added, "Patients with impaired consciousness are frequently written off. But the brain may still retain the ability to respond if the right areas are stimulated. Through Multimodal Sensory Stimulation, we engage various senses, including touch, movement, sound, smell, taste and vision to activate dormant neural networks. This approach can open up new possibilities in neuro-recovery."

Week by week, signs of improvement emerged. The patient blinked on command.

She began to respond to voices with subtle movements. Eventually, she reached out for her son's hand, a gesture that once felt impossible.

With more than 1.8 million stroke cases annually, India is witnessing a sharp rise in post-stroke disability. Yet, structured rehabilitation, particularly when led by PMR experts, remains underutilised in most parts of the country, Dr Thukral said.

Report: World's Supply Of Critical Minerals For Clean Energy Concentrated In Fewer Countries

rankfurt (Germany)- The world's sources of critical minerals are increasingly concentrated in just a few countries, most notably China, leaving the global economy vulnerable to supply cutoffs that could disrupt economies and hit consumers with higher prices, a report said Wednesday.

The Paris-based International Energy Agency's report looked at the availability of minerals and metals that may be small in quantity — but large in impact when it comes to shifting the economy away from fossil fuels toward electricity and renewable energy.

It found that for copper, lithium, cobalt, graphite and rare earth elements, the average market share of the three top producing countries rose to 86 per cent in 2024 from 82 per cent in 2020.

China is the leading refiner for 19 out of 20 strategic minerals studied in the report, and has an average share of around 75 per cent. Indonesia showed strong growth in nickel, a key component in making steel and batteries for electric vehicles.

The current trend toward export restrictions and trade disputes increases concerns, the IEA said. "Critical mineral supply chains can be highly vulnerable to supply shocks, be they from extreme weather, a technical failure or trade disruptions," said IEA executive director Fatih Birol. "The impact of a supply shock can be farreaching, bringing higher prices for consumers

Birol cited the energy crisis in Europe after Russia cut off natural gas supplies over the invasion of Ukraine. Another cautionary tale is the global shortage of silicon-based computer chips during and after the pandemic, which disrupted auto production.

and reducing industrial competitiveness.'

"The golden rule of energy security is diversification," Birol told The Associated Press in an interview. "And it goes beyond energy security, it is also economic security."

Market forces are important in developing new sources but won't be enough. "There is a need for well-designed government policies" in the form of financing and other measures, he said.

China is a massive global source of critical minerals required for a wide range of goods that includes computer chips, robots, electric autos, batteries, drones, and military equipment. It also dominates the refining and processing of many of these critical minerals, including lithium, cobalt, graphite and more.

China has placed export limits of many of these key products and tightened controls on others as President Donald Trump's trade negotiations escalate, stifling US industry and the nation's ability to find quick alternatives. Without access to China's significant reserves, US manufacturers have a harder time competing amid mounting global supply tensions.

Trump has made reducing US dependence on foreign critical minerals a core tenet of his first 100 days back in office as part of a national security and economic resilience agenda. This goes beyond China; the Trump adminis-

tration finalized a rocky deal with Ukraine granting American access to the nation's vast mineral resources earlier this month.

Trump is also looking to expedite deep-sea mining in international waters, much to the chagrin of environmental groups. He called for a boost in the domestic copper industry in a February executive order alongside other calls for the federal government to fast-track new mine permits; has reviewed a minerals proposal from Congo, a conflict-riddled nation also rich with mineral reserves; and attempted to strong-arm Greenland into providing more of its minerals to the US.

Interim Trade Deal With US Likely By July 8; India For Full Exemption From 26% Additional Tariff

NEW DELHI- India and the US are likely to agree on an interim trade agreement before July 8 with New Delhi pushing for full exemption from the 26 per cent reciprocal tariff on domestic goods, an official said.

The US on April 2 imposed an additional 26 per cent reciprocal tariff on Indian goods but suspended it for 90 days till July 9. However, the 10 per cent baseline tariff imposed by America remains in place.

The government official said India's endeavour to protect its sensitive sectors may entail some quota or minimum import price (MIP). Such sectors include agri goods and dairy.
Commerce and Industry

Minister Piyush Goyal was in Washington earlier this week to give an impetus to trade talks. He met with US Trade Representative (USTR) Jamieson Greer and US Commerce Secretary Howard Lutnick.

In a post on X, Goyal said that he held good discussions with the US Commerce Secretary towards expediting the first tranche of India-US bilateral trade agreement.

"Talks are moving positively. Before July 8, we are looking at concluding an interim deal before the first tranche. It will include goods, nontariff barriers, some areas of services also like digital. We are trying that the 26 per cent



additional duty and the 10 per cent baseline tariff should not be there for India," the official said, adding that India is seeking concessions for its labour-intensive sectors such as textiles and leather.

At present, the Trump administration requires approval from the US Congress to bring tariffs below the MFN (most favoured nation) rates.

But the administration has the authority to remove the reciprocal tariffs imposed on a number of countries, including India.

India may look at certain commitments from the US on the duty concessions for its labour-intensive sector in the first tranche of the proposed bilateral trade agreement (BTA). Both countries have fixed a deadline to conclude the first phase of the pact by fall (September-October) of this year to more than double bilateral trade to USD 500 billion by 2030.

The minister-level meetings were followed by the

deliberations between chief negotiators of the two countries, which will continue until May 22.

Officials from New Delhi and Washington are looking to take advantage of the 90-day tariff pause window to advance the talks. The US has suspended the additional 26 per cent tariffs on India till July 9. It was announced on April 2 to bridge the widening trade deficit.

To boost bilateral trade, India is seeking duty concessions for labour-intensive sectors like textiles, gems and jewellery, leather goods, garments, plastics, chemicals, shrimp, oil seeds, chemicals, grapes, and bananas in the

proposed pact with America. On the other hand, the US wants duty concessions in sectors like certain industrial goods, automobiles (electric vehicles in particular), wines, petrochemical products, dairy, and agriculture items such as apples, tree nuts and GM (genetically modified) crops.

Trade Agreement By July: Official

NEW DELHI- Negotiations for a proposed trade pact between India and the 27-nation European Union are progressing at a faster pace and both the sides are looking at concluding the talks for an early harvest trade agreement by July this year. official said on Wednesday.

The early harvest or an interim trade agreement would include issues such as intellectual property rights (IPRs), government procurement, tariff, and non-tariff barriers, the official said.

An Indian official team from the commerce ministry is visiting Brussels this week for the next round of negotiations on the trade agreement with the European Union (EU). This visit comes in the backdrop of recently-concluded eleventh round of talks between chief negotiators of both the sides on May 16 here in the national capital.

'We are looking for an early harvest. We are trying to do it as early as possible...targeting by July for early harvest," the



The two sides have agreed to conclude the agreement in two phases on account of the uncertain global trade environment, particularly due to the US tariff actions under President Donald Trump.

India has followed the practice of negotiating trade pacts in two phases with Australia. The early harvest pact

would lead to a full fledged free trade agreement.

Besides demanding significant duty cuts in automobiles and medical devices, the EU wants tax reduction in products like wines, spirits, meat, poultry and a strong intellectual property regime.

Indian goods' exports to the EU, such as ready-made garments, pharmaceuticals, steel. petroleum products, and elec-

trical machinery, can become more competitive if the pact gets concluded successfully.

In June 2022, India and the 27-nation EU bloc resumed negotiations for a comprehensive free trade agreement, an investment protection agreement and a pact on geographical indications (GIs) after a gap

It stalled in 2013 due to differences over the level of opening up of the markets. On February 28, Prime Min-

ister Narendra Modi and the European Commission President agreed to seal a muchawaited free trade deal by the end of this year.

The India-EU trade pact negotiations cover 23 policy areas or chapters, including Trade in Goods, Trade in Services, Investment, Sanitary and Phytosanitary Measures, Technical Barriers to Trade, Trade Remedies, Rules of Origin, Customs and Trade Facilitation, Competition, Trade Defence, Government Procurement, Dispute Settlement, Intellectual Property Rights, Geographical Indications, and Sustainable Development.

PM To Unveil India's First 9000 HP Electric Locomotive On May 26

AHMEDABAD- Prime Minister Narendra Modi will unveil India's first 9,000 horsepower locomotive engine, take part in a roadshow and multiple events during his two-day visit to Gujarat starting from May 26, state government officials said on Wednesday. He will participate in a host

of events in Dahod, Bhuj, Vadodara and Gandhinagar after arriving at the Vadodara airport at around 10am on Monday, they said.

The Vadodara Municipal Corporation has planned a one-km-long roadshow near the airport to greet the PM and congratulate him for the success of Operation Sindoor, said VMC standing committee chairperson Sheetal Mistry.

Modi will stay at the airport for around 15 minutes and leave for his main event of the day in Dahod district.

'People of Vadodara, including women, will stand on both sides of the roadshow route near the airport to express their gratitude to the PM for the huge success of Operation Sindoor," Mistry told reporters.

At Dahod, the PM will visit a Railway locomotive manufacturing unit and inaugurate India's first 9,000 horsepower locomotive engine made at the facility, which has been set up with an investment of Rs 20,000 crore, said a release by

the Gujarat government.

The Railway factory in Dahod, established under the PPP model, will produce 1,200 engines over the next 10 years.



A key feature of these engines is their ability to carry cargo weighing up to 4,600 tonnes. The locomotive engines will be equipped with air conditioning and a toilet facility for drivers, it said.

Additionally, an advanced cover system has been installed to enhance safety and prevent accidents. The 9,000 HP, 6-axle electric engine will have an average speed of 75 km per hour, said the release.

From the factory, the PM will reach an open ground near Kharod village in Dahod district to address a gathering, it

From Dahod, the PM will travel to Kutch district to address a public meeting at Mirzapar Road near Bhuj town. Later, he will visit the revered Mata Ashapura Temple at Mata No Madh in Lakhpat taluka of Kutch, according to the release.

Govt To Decide On Renewing Indigo's Leases Of Turkish Airlines Planes: Indigo CEO

NEW DELHI- IndiGo is fully compliant with all regulatory frameworks and regulations for operating flights with planes leased from Turkish Airlines, IndiGo CEO Pieter Elbers said on Wednesday and also mentioned that it is for the government to decide on the renewal of the leases.

The comments also come against the backdrop of aviation watchdog BCAS, on May 15, revoking the security clearance for Turkish company Celebi Airport Services India Pyt Ltd in the "interest of national security", days after Turkiye backed Pakistan and condemned India's strikes on terror camps in the neighbouring country. Some online travel portals

and associations have also issued advisories asking people not to visit Turkiye.

IndiGo is operating direct flights to Istanbul with two leased Boeing 777 aircraft from Turkish Airlines having over 500 seats each. It also offers codeshare seats to more than 40 points in Europe and the US through the codeshare partnership with the Turkish carrier.

To a query regarding renewal of the leases for the two aircraft, Elbers said it is up to the government to decide. "It is important to recognise

that the operation to Istanbul

is taking place in the context of the Air Service Agreement (ASA) between India and Turkiye. IndiGo is fully compliant with all regulatory frameworks and regulations which are there. We have thousands actually of Indian customers booked mostly beyond Istanbul," he said while discussing the airline's fourth quarter and 2024-25 full year financial results.

The current leases for the two Turkish Airlines planes are ending this month. Elbers said the renewal of the leases is up to the government to decide and added that, "we have this operations in place for sometime now".

In response to a question on the possible scenario of the leases not getting renewed, he said that as a good airline, IndiGo makes sure that there are back plans in case of changes. The ASA allows for carriers of

Turkiye and India to operate a total of 56 flights per week between the two countries -- 14 flights from India to Turkiye and 14 flights from Turkiye to India each by Indian carriers and the same number by airlines of Turkiye.

CCPA Issues Notice To Uber Over 'Advance Tip' Feature For Faster Service

NEW DELHI- Consumer protection watchdog CCPA has issued a notice to ride-hailing platform Uber for allegedly "forcing or nudging" users to pay advance tips for faster service.

"The practice of 'Advance Tip' is deeply concerning," Consumer Affairs Minister Pralhad Joshi said in a social media post.

"Forcing or nudging users to pay a tip in advance, for faster service is unethical and exploitative. Such actions fall under unfair trade practices," the minister wrote.

Joshi emphasised that tipping is meant as a token of appreciation, given after service completion, not as an entitlement beforehand.

Taking cognizance of the issue, the minister directed the Central Consumer Protection Authority (CCPA) to

investigate the matter. "Today CCPA has issued a notice to Uber in this regard, seeking explanation from the platform," he posted.

close of Rs 96,130 per 10 grams. "A weak dollar supported gold prices. Investors are also evaluating sovereign risk after Moody's downgraded the US credit rating due to fiscal deficit concerns," Abans Financial Services' Chief Executive

Officer Chintan Mehta said.

The downgrade has heightened uncertainty around the long-term stability of US finances, prompting investors to seek safe-haven assets like gold, Mehta said.

In addition, silver prices climbed Rs 1,660 to Rs 99,160 per kg (inclusive of all taxes) on Wednesday. The white metal had finished at Rs 97,500 per kg in the previous market close. On the global front, spot gold rose USD 21.79 or 0.66 per cent to USD 3,311.76 per ounce.

"Gold edged higher on Wednesday reclaiming the USD 3,300 level amid rising geopolitical tensions and US fiscal concerns," Saumil Gandhi, Senior Research Analyst of Commodities at HDFC Securities, said.

Meanwhile, investor jitters stemming from ongoing uncertainty regarding tariff policies and an upcoming crucial vote on President Donald Trump's major tax reforms are leading to caution, with the US dollar weakening and gold rising, Gandhi added.

Kotak Securities' AVP-Commodity Research Kaynat Chainwala said rising geopolitical tensions following reports of a potential Israeli strike on Iranian nuclear facilities supported gold prices.

Domestic Air Passenger Traffic Grows 8% To 143.16 Lakh In April

NEW DELHI- Indian airlines flew 143.6 lakh passengers on domestic routes in April, 8.45 per cent more as compared to the year-ago period, amid rising air traffic demand.

In terms of domestic market share, IndiGo topped the list with 64.1 per cent of the pie, followed by Air India Group (27.2 per cent), Akasa Air (5 per cent) and SpiceJet (2.6 per cent), according to the latest data

"Passengers carried by domestic airlines during January-April 2025 were 575.13 lakh as against 523.46 lakh during the corresponding period of the previous year thereby registering an annual growth of 9.87 per cent and monthly growth of 8.45 per cent," DGCA said in its monthly report.

In terms of On Time Performance (OTP) of scheduled domestic airlines -- computed for the four metro airports at Bengaluru, Delhi, Hyderabad, and Mumbai -- IndiGo's OTP stood at 80.8 per cent while that of Akasa Air and Air India Group was 77.5 per cent and

"It is the border villages of J-K which have suffered the most. They have suffered due to the shelling from Pakistan. All communities have suffered and the suffering of the border villages, where lives have been lost, where livelihoods have been lost, have been ignored by the mainstream media," she said.

No one is talking about the suffering of Poonch, Rajouri and the villages next the Line of Control, Ghose said.

The delegation is likely to visit the areas near the Line of Control (LoC) in the valley.

"We have come to tell the people of these border villages that you are not alone. We are standing with you, we will always stand with you and we will bring your plight to the notice of the mainstream media.

"We will work towards rebuilding your lives, we are here for you and we will always be with you in your hour of need," she added.

Waqf Islamic

Any stay of the provision on abolition of unregistered "waqf by user" properties would defeat the purpose of the law which has been enacted to remedy the mischief like usurpation of government land, Mehta added.

"The Centre is the custodian of properties on behalf of 14 crore citizens," he said, "and nobody has the right over government land.

Mehta said, "There is a Supreme Court judgment which says the government can save the property if it belongs to the government and has been declared as waqf.'

Contesting the argument of government officers arbitrarily claiming land as government property from now on and override waqf status, he called it "misleading and false."

On the point of an officer above the rank of a district collector deciding the dispute on the claim over an alleged waqf property, he said officer wouldn't finally determine the property's ownership.

Mehta said the eviction or takeover of property could only occur after due process through the Waqf Tribunal proceedings (under Section 83) and subsequent appeals.

The possession would continue with the waqf until the issue was fully adjudicated, he said.

The SG cited the extensive deliberations of the Joint Parliamentary Committee, which held 96 sittings, received 97 lakh representations, and incorporated feedback from 25 Wagf Boards and several state governments.

government could protect public lands even if erroneously entered as waqf, and that mere entry in the waqf register did not confer ownership. Mehta said no affected parties

authorized to speak publicly. "We've known for a while that our systems were outdated. Now we're finally being told to fix them." The circular spells out six main actions every department must take, with strict timelines and little room for error.

First, any department still running an official website on a private domain-like ".com" or ".org"-must move it to a government-authorized domain such as ".gov.in" or ".jk.gov.in". Websites hosted without prior approval will be taken down. The National Informatics Centre (NIC), the central agency overseeing IT in government, will help with the transition.

Second, all official communication must now happen through NIC-issued government emails. Any mail sent from private accounts—Gmail, Yahoo, or otherwise-will be ignored. This rule is intended to clamp down on spoofed messages and unauthorized

Third, departments are required to conduct thorough audits of their IT systems. This includes checking if the computers use licensed software, updated antivirus protection, and safe network practices. The use of cracked software and unsupported operating systems has been explicitly banned. Fourth, IT staff across all depart-

ments will be required to undergo training sessions. These will cover cybersecurity basics, legal responsibilities under India's IT laws, and protocols issued by the country's cyber emergency response agency. Fifth, government offices must now stick to standardized guidelines when

buying new technology. That means

no more outdated or unverified tools,

a practice that has left many departments with incompatible or vulnerable systems in the past. Finally, every department must submit a detailed compliance report within 15 days. Those who fail to do so, or are found in violation later, risk

disciplinary action.

This isn't the first time states/union territories have tried to modernize their digital security frameworks. But such orders often get delayed or diluted during implementation. Whether this one sticks will depend on how seriously departments take the threat and how tightly it's enforced.

Kashmir's unique situation adds urgency. With a history of political instability, internet disruptions, and increased reliance on digital governance, the region has little room for error when it comes to cybersecurity.

Some experts welcomed the changes, especially the mandate to use government-approved domains and emails. "Those two steps alone can reduce the risk of phishing drastically," said a cybersecurity analyst based in Srinagar. "A lot of attacks succeed simply because people think they're clicking on a legitimate link or replying to an official email."

Still, there are concerns. Many departments, especially in rural districts, lack full-time IT teams or even stable internet connections. Bringing their systems up to date in just two weeks could be an uphill task. In some cases, departments still run on decade-old machines, and official communication is done through personal WhatsApp groups and Gmail addresses.

"There's no denying this was

needed," said a district official from South Kashmir. "But doing it properly, and in such a short time, is going to stretch a lot of us."

The NIC's involvement may help smooth out the process. And the warning of disciplinary action is a strong signal that this isn't a symbolic gesture. But for many, the hope is that the move marks the start of a long-overdue shift in how digital systems are managed.

"It's not just about blocking threats," said the IT officer. "It's about building trust in the system, so people can use services online without wondering if

their data is at risk." If the plan succeeds, Jammu and Kashmir may become a model for other regions struggling with similar problems. But the next 15 days will be the real test. (Reporting contributed by Sameer Hussain)

Five Guilty Of Hate Crime For Racist Abuse Of Vinicius, Says LaLiga

Five Valladolid fans who racially insulted Real Madrid star Vinícius Júnior in 2022 have been found guilty in the first ruling in Spain that condemns racist insults in a soccer stadium as a hate crime, the league

A Valladolid court convicted the fans for their insults in a league match, sentencing them to one year in prison plus a fine of up to 1,620 euros (\$1,837). The jail time is suspended on condition they don't commit any offense or visit soccer stadiums hosting official national competitions for three years. The league called Wednesday's ruling "a firm step towards eradicating racism in sport."

Last year, three Valencia fans were handed eightmonth prison sentences after pleading guilty to racially insulting Madrid forward Vinícius Júnior.

That was the first conviction for racism-related cases in professional soccer in Spain, but it was not based on a hate crime. The Valencia fans were convicted of a crime against moral integrity, with the aggravating circumstance of discrimination based on racist motives.

Based on her complaint, an FIR was registered and further investigation was taken up during which police obtained details of the fake account and conducted a technical analysis

"Surveillance revealed that the SIM card linked to the fake account was issued in Ghazipur in Uttar Pradesh. Further analysis helped trace the current location of the accused to Nangloi in Delhi," said the DCP. A team conducted a search operation and apprehended the accused from Nangloi. A mobile phone and SIM card used in the offence were recovered from her possession.

During interrogation, she confessed that she grew suspicious after her husband, whom she married in 2023, shared a photo with friends in which the complainant also appeared. Indian Author Wins International Booker For Story Collection 'Heart Lamp'

LONDON: Indian writer, lawyer and activist Banu Mushtaq on Tuesday won the International Booker Prize for her short story collection "Heart Lamp".

The 77-year-old is the first author of Kannada-language literature to receive the prestigious literary award for translated fiction.

"This moment feels like a thousand fire flies lighting a single sky -brief, brilliant and utterly collective,' Mushtaq said at a ceremony at the Tate Modern gallery in London.

"I accept this great honour not as an individuals but as a voice raised in chorus with so many others.'

Mushtaq will share the £50,000 (\$67,000) prize with her translator Deepa Bhasthi, who also helped choose the stories.

"Heart Lamp" gathers 12 stories originally published between 1990 and 2023. They portray everyday life in Muslim communities of southern India, focusing on the experiences of women and girls.

Critics praised the collection for its dry and gentle humour, its witty, colloquial style and its searing com-



mentary on patriarchy, casteism and religious conservatism.

Mushtaq, based in Karnataka state. southwest India, is known for her advocacy in women's rights and her legal work confronting discrimination.

The jury hailed her characters - from spirited grandmothers to bumbling religious clerics -- as "astonishing portraits of survival and

"My stories are about women -how religion, society, and politics demand unquestioning obedience from them, and in doing so, inflict inhumane cruelty upon them, turning them into mere subordinates,' she said.

Max Porter, chair of th judges, hailed "Heart Lamp" as "something genuinely new for English readers."

The majestic big cats are slightly smaller than their African cousins, and have a fold of skin along their bellies. Hunting and human encroach-

ment caused the population to plunge to just 20 by 1913, and the lions are now found only in Gujarat's sprawling Gir wildlife sanctuary, where they roam dry deciduous forests and open grasslands.

Following years of concerted government efforts, the lion population is steadily rising.

The latest counting exercise, spread over four days, covered over 35,000 square kilometres (13,513 quare miles) across 11 districts in riyavrat Gadhvi, a former mem of the state wildlife board, said

But while numbers are rising, the conservation organisation WWF warns that the Asiatic lion faces a "threat of genetic inbreeding arising from a single population in one place".

Lions are a source of pride for India, particularly in Gujarat's Saurashtra region, where man and beast

Pakistan's Last Elephants Battle Tuberculosis With 400 Pills A Day

team of doctors and vets in Pakistan has developed a novel treatment for a pair of elnts suffering from tuberculosis. treatment involves feeding the ants at least 400 pills a day. e jumbo effort by staff at the hi Safari Park involves adminisg the tablets - the same as those to treat TB in humans - hidden e food ranging from apples and nas to Pakistani sweets. The unt of medication is adjusted to

unt for the weight of the 4,000-kilogram (8,800-pound) elephants. But it has taken Madhubala and Malika several weeks to settle into the treatment. After spitting out the first few doses, they tasted the bitter medicine and crankily charged their keepers.

"Giving treatment for TB to elephants is always challenging. Each day, we use different methods," said Buddhika Bandara, a veterinary surgeon from Sri Lanka who flew in to oversee the treatment. "The animals showed some stress in the beginning, but gradually they adapted to the procedure," said Bandara, who has helped more than a



dozen elephants recover from the illness in Sri Lanka. Mahout Ali Baloch wakes early daily to stew rice and lentils mixed with plenty of sugar cane molasses and rolls the concoction into dozens of balls pierced with tablets. "I know the pills are bitter," the 22-yearold said, watching the elephants splashing under a hose to keep cool.

Four African elephants - captured very young in the wild in Tanzania arrived in Karachi in 2009. Noor Jehan died in 2023 at 17, and another, Sonia, followed at the end of 2024. An autopsy showed she had contracted tuberculosis, which is endemic in Pakistan. Tests on Madhubala and Malika also came back positive, and the city councilwhich owns the safari park-assembled a team to care for the pachyderms.
