LG Pays Tribute To Army Man Killed In Kishtwar

Srinagar: Lieutenant Governor Manoj Sinha on Friday paid heartfelt tributes to Sepoy Gaykar Sandip Pandurang, who was martyred during an anti-terror operation in Jammu and Kashmir's Kishtwar district.

"Salute to the indomitable courage of braveheart Sep Gaykar Sandip Pandurang, who made the supreme sacrifice for the nation during the anti-terror operation in Kishtwar. The grateful nation will forever be indebted to his valour and unwavering commitment to duty. We stand united in solidarity with the family of the martyr in this hour of grief," the LG said in a statement.

The soldier from Maharashtra's Ahmednagar district was part of the 17 Rashtriya Rifles and was killed during a cordon and search operation in Kishtwar's Singhpora-Chatroo area. The operation to neutralize four hiding terrorists is still underway.

Earlier in the day, the Army held a wreath-laying ceremony at the Military Hospital in Jammu. Chief of Staff of the White Knight Corps, Major General Shailendra Singh, led tributes, joined by senior officers from the Army, police, BSF. and civil administration.

Sepov Pandurang's mortal remains were sent to his native village in Karandi, Akole tehsil, for the final rites.

SIA Cracks Down On Terror Sleeper Cells

Raids 18 Locations Across 4 Districts In Jammu

Srinagar: The State Investigation Agency (SIA) on Friday launched a crackdown on terror sleeper cells and their associates, conducting coordinated raids at 18 locations across the Jammu region and recovering substantial incriminating material, an official said. The operation targeted the terror ecosystem in the districts of Poonch, Rajouri, Udhampur and Ramban, said

a spokesperson of the SIA. Of the 18 locations raided, 12 were in the Surankote subdivision and three in the Haveli tehsil of Poonch district,

The spokesperson said that additional operations were carried out at one location each in Raiouri town (Raiouri district), Ramnagar (Udhampur district) and Ramban.

"A considerable quantity of incriminating material has been seized and secured in accordance with established legal protocols. The material is currently under detailed scrutiny and further investigation is underway," he added.

Several suspects have been summoned to join the investigation at the SIA headquarters in Jammu. The spokesperson said these actions | More on P10

'Initial Five Years Of Service Not To Count' **HC Sets Aside Decade-Old Cabinet Decision on ReT Seniority**

Srinagar: Setting aside government's eleven-year-old cabinet decision being in "ignorance of settled legal position", the High Court of J&K and Ladakh on Friday ruled that the five years service rendered by Rehbar-e-Taleem teachers before regularization shall not count for the purpose of fixing their seniority.

Allowing two appeals in this regard, a Division Bench of Justices Sanjeev Kumar and Sanjay Parihar set aside its single bench's verdict 31 December 2014 which had concluded that that there was nothing wrong in the Government taking a policy decision to confer the benefit of seniority upon the



ReTs on their regularization with effect from the date they were initially engaged.

"As a consequence,the impugned provisio, to the extent it provides that "the five years service rendered by Rehbar-e-Taleem teachers before regularization shall count for the purpose of fixing their senior-ity" is set aside," the Division Bench said while allowing the appeals filed by aggrieved

General Line teachers through advocate Tasaduq H. Khawja.

The government vide an order on 28 April 2000 launched Rehbar-e-Taleem (ReT) Scheme which provided for engagement of Teaching Guide (ReT) to perform the teaching duties in the schools facing deficiency of teaching staff. The ReT was to be engaged initially for a period of two years which was extendable for a period of further three

years subject to satisfactory performance etc of the ReT. The ReT was entitled to a monthly honorarium of Rs. 1500 for the first two years and Rs. 2000 per month from the third year onwards. There was also a stipulation in the

Centaur Hotel Transfer **J&K Forms High-Level Oversight Committee**

Srinagar: The Jammu and Kashmir government has approved the formation of a high-level committee to oversee the transfer of Srinagar's iconic Centaur Lake View Hotel to a private firm, Lago Vue Srinagar Private Limited, as per the terms of an existing concession agreement.

According to an or-der issued by the General Administration Department, the Divisional Commissioner Kashmir will head the committee, which includes the Deputy Commissioner Srinagar, the Commissioner Srinagar Municipal Corporation, and officials

from multiple departments. The committee has been tasked with ensuring a smooth, time-bound transfer of the property, situated on the banks of Dal Lake. The hotel, inaugurated in 1984, was originally a joint venture between the J&K government and the Hotel Corporation of India, under a 99-year lease agreement. Various departments have been assigned specific roles in the process. The Revenue Department will document land allocation and other property details, while the Public Works Department (R&B) will catalog items

within the premises and advise on their removal. The Culture | More on P10

No Caste-Based Segregation In J&K Prisons Now

Srinagar: In a significant move, the administration of Jammu & Kashmir has amended the Union Territory's Prison Manual-2022 to prohibit the caste-based segregation in jails and defined criteria for declaring a person as "habitual offender".

According to amendments carried out by LG-led admin-istration in the Prison Manual, it shall be strictly ensured that there is no discrimination/ classification /segregation of prisoners based on the basis of

their caste. "It shall be strictly ensured that there is no discrimination of prisoners in allotment of any duty/ work in prisons on the basis of their caste," reads the amendments.

As per the amendments, the provisions of the Prohibition of Employment as Manual Scavengers and their Rehabilitation Act- 2013 shall have a binding effect even in Prisons and correctional institutions.

"Manual scavenging or hazardous cleaning of a sewer and septic tank inside a prison shall not be permitted," the amendments state.

The government has also redefined the term "habitual offender" in its Prison Manual, 2022.

According to the amend-ments, a habitual offender is someone who, within a continuous five-year period, has been convicted and sentenced to imprisonment more than twice for crimes | More on P10

• survive warming oceans, clownfish cope by shrinking in size. Scientists observed that some of the orange-striped fish shrank their bodies during a heat wave off the coast of Papa New Guinea. Fish that slimmed were more likely to survive. Heat waves are becoming more common and intense underwater due to climate change. Warmer water temperatures can bleach sea anemones that clownfish call home, forcing them to adapt to stay alive. Scientists monitored and measured 134 colorful clownfish in Kimbe Bay during an intense heat wave in 2023 that's still bleaching corals worldwide. They found that 101 clownfish decreased in length on one or more occasions from heat stress. "We were really

"This is another tool in the toolbox that fish are going to use to deal with a changing world," said Simon Thorrold, an ocean ecologist at Woods Hole Oceanographic Institution, who was not involved with the new study. The tactic helps clownfish weather heat waves in the shortterm, but it's not yet clear how the fish will fare if they have to keep it up in the years to come, Thorrold said. **Researchers** found the shrinking was temporary. Clownfish possessed the ability to "catch up" and grow back when their environment got less stressful, showing how living things are staying flexible to keep up with a warming world, said study author Melissa Versteeg with Newcastle University. "These natural systems really are under stress, but there's a capacity for incredible resilience," Versteeg said.

study author Morgan Bennett-Smith with Boston University. The findings were published Wednesday in the journal Science Advances. Though scientists don't yet know how clownfish shrink, one idea is that they could be reabsorbing their own bone matter. It's possible the smaller stature may help the clownfish save energy during a stressful scorch since smaller fish need less food.

Certain clownfish breeding pairs also synced their shrinking to boost their survival odds. The females adjusted their size to stay bigger than their partners, keeping the female-dominated social hierarchy intact, researchers said. Other animals also decrease in size to beat the heat. Marine iguanas get smaller during El Nino events that usher warm waters into the Galapagos. But this coping strategy hadn't yet been spotted



600 Kanal Kah-Charai 'Gifted' To Ikhwanis **Observer News Service**

SOPORE- Revenue officials in Bandipore tehsil have blessed a virtual loot of kah-charai (grazing) lands belonging to the village community in several villages of Bandipore tehsil. At the behest of some high-ups, authorities are reported to have allotted' hundreds of kanals of such land to Ikhwani counter-insurgents during recent times.

According to reports, 500 to 600 kanals of the grazing land on Kuil Gurdal road and Baji road in Malangam had been 'gifted' to the Ikhwanis of Malangam village by revenue officials. The beneficiaries' indude Abdul Rahman Khan, Moli Khan Chandi Khan and Sher Dil, all of Malangam. They have raised their houses on the lands and even sold portions of them. The tehsildar, Bandipore has allegedly made the allotments.

Reports said the tehsildar also allegedly allotted a custodian building in the tehsil complex at Bandipore to a ruling National Conference halqa president, Muhammad Muzaffar Malik of Onagam. He demolished the building and raised his own residential house in the sspremises under the tehsildar's nose. The tehsildar, reports alleged, had the temerity to attest the mutations of the grazing lands as well as the building.

Villages that witnessed the virtual plunder of the grazing lands include Kuil, Mangnipora, Aloosa, Gurdal, Malangam and Kema. The people of these areas have expressed grave concern over the loot and urged the authorities to call an immediate halt to the murky deals. They also demanded a probe into the allotments made by the tehsildar so far.

6,800 international students in the 2024-2025 school year, amounting to 27% of its total enrollment, according to university statistics.

"Why Are These Students **Dying?**" Court Grills Rajasthan **Over Kota Student Suicides**

New Delhi: The Supreme Court on Friday grilled the Rajasthan gov ernment over the surge in student suicides in the city of Kota calling the situation "serious".

A bench of Justices J B Pardiwala and R Mahadevan said 14 suicide cases were reported from the city so far this year.

"What are you doing as a state? Why are these children dying by suicide and only in Kota? Have you not given a thought as a state?" Justice Pardiwala asked the counsel representing state of Rajasthan. The counsel said a special investigation team (SIT) was formed in the state to examine cases of suicides.

The top court was hearing a matter over the death of a 22-yearold student studying in IIT, Kharagpur. The student was found hanging in his hostel room on May It was also dealing with another case of a girl, who was a NEET aspirant and was found hanging in her room in Kota where she lived with her parents.

The bench learnt that an FIR was lodged in connection with the death of IIT Kharagpur's student. The top court, however, ques-

The bench, however, was not convinced with the explanation of the IIT Kharagpur counsel and the police officer.

"We could have taken a very strict view of the matter. We could have even proceeded for contempt against the police officer in-charge concerned of the jurisdictional police station," it said.

The bench then refrained from saying "anything further" with the FIR being lodged and progressing investigation.

The investigation, it said, should be carried out expeditiously in the right direction.

In the Kota suicide case, the bench disapproved non filing of the FIR.

The state's counsel said the investigation in the case was ongoing and the SIT was aware of suicide cases in the state.

"How many young students have died so far in Kota?" the bench asked the counsel.

After the counsel said 14, the bench retorted, "Why are these students dying?" It said the task force constituted by the top court would take its time before giving a composite report to the court.

12-year-old boy died by allegedly consuming pesticide after he was accused of theft and asked to do sit-ups by a shopkeeper for "stealing" a packet of chips at Panskura in Paschim Medinipur district, a police officer said Friday.

Krishendu Das, a class 7 student, allegedly lifted a packet of chips from a shop at Gosaiber bazar in the Panskura area on Thursday evening after he failed to find the shopkeeper Subhankar Dikshit. He had called out "uncle I will buy chips" repeatedly without any response and finally left the shop allegedly with one packet of chips, the officer said quoting his griefstricken mother.

He was allegedly chased by Dikshit who came back to the shop soon afterwards, slapped and asked to do situps in full public view, the officer said quoting a complaint by the family.

The officer said a probe is underway Das' mother was summoned to the spot and she also scolded him and slapped him while the boy claimed he picked up the junk food packet lying in a heap before the shop and would have come to pay later.

River Transport In J&K To Be A Reality Soon

Chief Secretary, Atal Dulloo, chaired a high-level meeting to explore the introduction of Inland Water Transport (IWT) across the major river systems in Jammu and Kashmir.

Besides the Chairperson, Inland Waterways Authority of India (IWAI) the meeting was attended by ACS, Jal Shakti De-partment; Divisional Commissioner Kashmir, Commissioner Secretary Tourism, Secretary Transport, Secretary PWD, and other senior officers from J&K administration.

The Chief Secretary emphasized the immense potential of river transport in the Union Territory, not only as an ecologically sustainable mode of travel but also as a complementary alternative to road connectivity. He stated that the river systems in J&K-most notably Jhelum, Chenab, and Ravi-link sev-

eral districts, thereby presenting a unique opportunity to develop a cost-effective, less congested, and environment-friendly transportation network.

Seeking technical and infrastructural support from IWAI, Dulloo urged the Authority to extend their assistance to UT for making inland water transport a reality at the earliest. He called for collaborative development

of the necessary infrastructure, including terminals and electric cruise operations, in coordination with the Tourism, Transport, and PWD departments. During the meeting, IWAI

representatives presented findings from their preliminary surveys, which had been conducted to assess the feasibility of river stretches for water transport. The surveys identified viable segments on the Jhelum, Chenab, and Ravi rivers for potential IWT operations.

It was also highlighted that the development of inland water transport aligns with the Government of India's national policy of promoting river transport for its comfort, efficiency, and pollution-free nature. Plans were discussed to procure electric-powered cruise vessels with a capacity of up to 20 passengers, which would operate between designated terminals on these rivers.

The Chief Secretary reiterated the government's commitment to fast-tracking this sustainable transport model, particularly given its tourism potential and its utility in connecting the underserved areas. He directed the concerned departments to prepare a coordinated roadmap with defined timelines for its implementation in the shortest possible time.

Labour Commissioner Cancels **Registration Of 447 Trade Unions**

JAMMU: In a significant administrative development aimed at reinforcing compliance with statutory labour laws, Labour Commissioner and Registrar of Trade Unions of Jammu & Kashmir, Charandeep Singh, has ordered cancellation of registration for 447 trade unions and associations across the Union Territory.

This action has been taken following their persistent failure to submit mandatory annual returns as prescribed under the Trade Unions Act, 1926.

Under Section 28 of the Act, every registered trade union must file an audited annual statement detailing its income, expenditure, assets and liabilities. Despite repeated notices and availability of a streamlined digital submission sys-tem introduced under the UT's

"Ease of Doing Business" reforms, these unions failed to comply with some having remained inactive for more than a decade.

"This action has been taken under Section 10(b) of the Trade Unions Act, after due process and sufficient notice," stated Charandeep Singh. "Non-filing of annual returns constitutes a serious statutory breach and is indicative of either prolonged inactivity or cessation of operations. We are committed to ensuring that only active and accountable unions continue to be recognized in Jammu & Kashmir.'

This landmark decision is a step towards establishing a robust and responsible framework for trade unionism that genuinely safeguards the interests of workers and enhances the credibility of organised labour representation.

Lachipora Residents Seek Posting Of Gynecologist, Pediatrician

SRINAGAR: Residents of Lachipora area in Boniyar tehsil of north Kashmir's Baramulla district have urged authorities to post a gynecologist in their village.

A delegation of locals expressed their distress over the absence of essential medical specialists, stating that it has caused significant hardship in the area.

"With a population of around 4,000, our village is facing severe healthcare challenges," said Mushtag Ahmad Mir, a local resident. "In the absence of a gynecologist and other key specialists, patients - particularly pregnant women and children are forced to travel many kilometers to Baramulla hospital for even basic medical care.'

He added, "This not only causes immense distress but also poses a serious risk to lives, especially during medical emergencies or harsh weather conditions."

The residents have also demanded the appointment of a pediatrician in the area. "Having a pediatrician would be a huge relief for the children here," said Ghulam Qadir Ahangar, another resident.

He further criticized the alleged neglect by local representatives over the years, saying it has worsened their struggle to access adequate healthcare.

"We urge the Hon'ble Lieutenant Governor and the district administration to address this issue on humanitarian grounds," he appealed.

Kashmir's Climate **Clock Is Ticking**

or decades, Kashmir was the summer escape. When the plains baked, people came here for snow-fed rivers, shaded orchards, and air that felt like relief. But the valley isn't cooling anyone down anymore. It's heating up, and fast.

In 2023 and 2024, Srinagar clocked some of its hottest days in recorded history, with temperatures rising past 35°C. That might not raise eyebrows in Delhi or Chennai, but for a highaltitude region like Kashmir, it's a seismic shift. Fields cracked open. Apple blossoms came too early, then wilted. Dal Lake, once pristine, turned warm and green with algae.

This isn't just weather. It's climate collapse in motion. The Himalayas, often called the Third Pole, are warming nearly twice as fast as the rest of the planet. Glaciers are melting faster. Rivers either flood or vanish. The natural rhythm-snow in winter, melt in spring, bloom in summer-is offbeat and unreliable now.

The hit to agriculture is direct and devastating. Apple trees need a steady cold before they bloom. Without it, the harvest fails. Saffron growers in Pampore say their yields are falling because autumns arrive too hot. Even livestock is under stress. Vets are seeing more animals suffer heatstroke, and mortality rates are climbing.

Nature is showing the strain, too. Glacier-fed lakes are swelling and could burst, putting entire villages at risk. Forests are drying out, and wildfires, once rare, are becoming more likely. Birds are shifting their migration patterns. Lakes are now battling rising temperatures, pollution, and algae blooms that choke life below the surface.

This is also a public health issue. People are falling sick more often during heat waves. Kashmir's homes, mostly designed for snow, trap the heat. Water sources are depleting. Women and children walk longer to fetch water. Doctors are reporting more cases of dehydration, exhaustion, and mental stress. There's growing anxiety among young people-an awareness that the place they love may not survive the century.

The world needs to pay attention. If Kashmir, once one of the coolest parts of the country, is getting too hot to handle, what does that say about the rest of us?

The fixes aren't revolutionary. Smarter irrigation, crop rotation, solar grids, and reforestation all exist. We just need to act. Policy helps. So does pressure from people. Save energy. Stop waste. Push for cleaner air. It's not about doing everything. It's about doing something. Kashmir isn't just losing its chill. It's losing the balance that kept its culture, economy, and ecosystems intact.

It's a story I hear often. Not just from students, but from earlycareer researchers, job aspirants, even teachers trying for transfers or fellowships.

In Kashmir, you can be full of promise but still fall short, by iust a decimal.

Our systems treat marks as the final word. If you're on the wrong side of a cut-off, it doesn't matter what else you've done. The num-bers speak, and everything else stays unheard.

This hits differently here than in most places. Kashmiri students often study in universities that don't inflate marks. They don't get coached to "crack" exams. Many are first-generation learners, juggling academics with family work or political disruptions. They've grown up amid shutdowns, curfews, and internet blackouts.

Still, they show up, sit exams, write papers. But the system that judges them doesn't ask where they're coming from. It just adds up their marks and draws a line.

And that line is brutal.

Central recruitment agencies don't account for institutional differences. A 75% from the University of Kashmir, earned under strict evaluation, is treated as less than an 85% from a lenient one elsewhere. There's no normalization, no adjustment for context.

Worse still, interviews for fellowships or teaching jobs are often skipped. Selection is done entirely by numbers. Sometimes just an Excel sheet and a calculator.

So, those with practical experience, deep thinking, or the ability to connect with students get passed over. And those who memorized better or came from more generous grading systems get in.

This doesn't just hurt individuals. It's a loss for the region Our classrooms and labs

public institutions miss out on people who understand the place and want to serve it.

And the damage goes deeper. Many bright young Kashmiris grow disillusioned. They stop applying, or move abroad where systems look at more than marks. Others give up entirely. You can't ask people to keep trying if their every effort is weighed only by numbers.

Other countries have figured this out. In Finland, early education barely uses grades. In the U.S., top universities now ask for essays, references, and interviews instead of just GRE scores. In Germany, the Max Planck Institutes want to know how you think, not just what you scored.

Even Singapore's government jobs combine academics with real-world problem-solving tasks and interviews

We can do this too. Kashmir, in particular, needs systems that see beyond percentages. We need to ask better questions: What has this person done? What do they care about? How do they solve

A few simple changes could make a big difference. Normalize scores across universities. Blind the applications so the evaluators don't see names or institutions. Add interviews. Allow flexibility, let a research paper or a field project outweigh a small GPA gap. Listen to what students and colleagues say about a candidate. Use tech to find patterns we might miss.

Above all, let's stop confusing cut-offs with capability. Some of the greatest minds in history wouldn't clear today's selection lists. And many of our best local minds-deep thinkers, diligent workers, firstgeneration scholars-are already being left out.

We don't need to lower the bar. We just need to widen the lens. A mark-sheet will never tell the whole story. But a thoughtful, human-centered process might.

Kashmir has no shortage of talent. What we lack is a system that knows how to recognize it.

The climate clock is ticking loudly here. And what happens next will echo far beyond the valley.

alk through any market in Kashmir today and you'll notice the silence first. Not the peaceful kind, but the uneasy one.

Shopkeepers sit idle. Taxi drivers nap in parked cars. Fruit vendors wait for buyers who don't come. Sales are down, and it's not just a bad day or a slow week. It's becoming a new normal.

Kashmir's economy, once rooted in self-reliance and steady local production, is fraying. And while political changes and flareups often make headlines, this quieter economic unraveling is just as worrying.

Across the Valley, livelihoods are shrinking, and families are feeling the squeeze.

Older generations remember a different Kashmir. Their parents and grandparents were skilled artisans, farmers, carpenters, and weavers. The region didn't just consume, it produced.

In villages and towns, people knew how to build homes, grow food, fix tools, and craft items by hand. They took pride in that. Today, those skills are fading.

Young people are turning away from these vocations. Many see them as outdated or unprofitable. Traditional jobs don't carry the shine of a government post or a tech gig. But the shift has left a gap.

As fewer people grow their own vegetables, make furniture, or repair machines, Kashmir has become dependent on outside markets, even for things it once made with ease.

This isn't just about tradition. It's about survival. With fewer local industries, cash doesn't circulate the way it used to. People earn less, spend less, and save less. That slowdown shows up everywhere, from fewer taxis on the road to shrinking demand in grocery stores.

tions, fewer tourists are coming, and when they do, they spend cautiously. That leaves guides, hotel owners, pony handlers, and street vendors scrambling to make a living.

Farming, too, is struggling. Young Kashmiris are moving away from agriculture. Many fields lie untended or underused, and the know-how that kept them productive is fading.

Without fresh talent and new techniques, farming remains labour-intensive and low-income, pushing even more people away.

But all is not lost.

Kashmir has a chance to turn this around, and that chance lies with its people, especially the young.

Skill development needs to become a central focus. Not just in modern coding or finance, but in age-old crafts and practical trades.

Carpentry, weaving, pottery, and even

farming, when blended with technology and design thinking, can create jobs that are both meaningful and profitable.

There are sparks of this already. In small workshops and classrooms, some organizations are training young people in block-printing and papier-mâché. Others are experimenting with solar dryers for saffron and organic fertilizers. These are small efforts, but they carry big potential.

For this to grow, support is key. Government programs must move beyond slogans and offer real training, grants, and market access

Schools and colleges need to promote vocational education alongside academics. And families should be encouraged to see value in work that's hands-on, creative, and rooted in local knowledge.

Tourism can also be revived with fresh thinking. Eco-tourism, craft trails, and heritage stays can bring visitors in while supporting local jobs and preserving the environment.

Farmers, too, can benefit from new irrigation systems, crop diversification, and better cold storage

Most of all, the community must talk openly about this shift. We need to stop thinking of traditional skills as "lesser' and start seeing them as the foundation of a stronger economy.

That mindset change, simple as it sounds, can do more than any single policy.

Kashmir's economy won't fix itself overnight. But it can heal. Slowly, steadily, with care. The land is still fertile. The hands are still capable. What's needed is a belief that change is possible, and that it can start right here, with us.

Kashmir Uploads Its Future Cloud servers hum in the hills, AI is streamlining farms, and a generation raised on 2G is now building the future.

hen Sahil Qadri fired up a basic code editor in his small Srinagar home in **V V** 2009, he was doing what thousands of young coders around the world do. But there was one big difference.

His internet connection was running on 2G. It took minutes to load a single library, and video tutorials buffered endlessly. Still, he stuck with it.

Today, Sahil works remotely for a Bengaluru-based AI startup. His journey, from 2G to AI, mirrors a slow but steady shift happening across the Valley.

The global rise of artificial intelligence is no longer just a Silicon Valley story. It's already transforming everyday services in Kashmir.

In healthcare, for instance, a valley-based startup is testing an AI tool that reads X-rays and flags possible lung infections. In agriculture, pilot projects are using machine learning to predict apple harvest yields. These aren't polished commercial products

yet. But they point to something deeper: local developers and engineers are starting to apply AI to problems that matter here.

Generative AI, too, has made an entrance. Scribes and scholars in Srinagar are experimenting with it to enhance their work. Teachers in Anantnag are using it to explain complex topics to students with varying learning styles. It's not replacing people, but it's changing how they work.

When Kashmir's longest internet shut-down lifted in early 2020, businesses scrambled to digitize. That's when cloud computing took off.

A small chain of valley-based pharmacies moved its entire billing and inventory system to the cloud. Local schools began relying on Google Workspace and Microsoft Teams to run classes.

The cloud has been a game-changer in a region where physical infrastructure remains tricky and unreliable.

You don't need to maintain bulky serv-



ers when you can rent space from Amazon Web Services or Google Cloud. Even small businesses are now uploading data, running analytics, and managing customer flows remotely

During the pandemic, this shift helped some companies stay afloat. For students, it meant access to online lectures, recorded sessions, and remote exams. The cloud didn't just bring convenience, it brought continuity.

With more data moving online, cyber security has become a pressing issue.

In 2022, a prominent institute in Kashmir faced a ransomware attack that locked student records for days. That scare prompted a wave of interest in digital safety.

Today, local IT firms are offering basic cyber hygiene training. There's talk of biometric logins and encrypted messaging apps, but adoption is slow. Most people still rely on simple passwords and unsecured Wi-Fi.

But change is brewing. A small cyber security collective was recently launched in Pulwama. A handful of saffron growers now use IoT sensors to monitor soil moisture in Pampore. A Srinagar-based tech store sells smart lights and voice-controlled fans that work with Alexa.

These devices don't just add flash, they bring efficiency. Farmers get alerts when their crops need water. Shops track stock with connected shelves. Even traffic police are testing smart cameras that can detect violations without human monitoring.

Still, limited 5G penetration and frequent power cuts hold things back. Some innovators are turning to edge computing-processing data locally, right on the device. That reduces the need for constant internet, a big plus in Kashmir's unpredictable connectivity landscape

While quantum computing feels far away

from Kashmir's current tech stack, it's not completely out of reach. Last year, an NIT Srinagar student made headlines for contributing to an open-source quantum project hosted by IBM.

These moments, though rare, matter. They show what's possible when young minds in Kashmir plug into global tech currents. Quantum may not solve local problems now, but it symbolizes something bigger: ambition.

But as digital adoption grows, so does electricity use. Data centers, though not yet based in Kashmir, consume massive energy. Local activists and engineers are pushing for greener solutions. Solar-powered routers, energyefficient devices, and cloud platforms that use renewable energy are gaining traction.

Even students are joining in. A group from Islamic University of Science and Technology recently developed a prototype laptop that runs on low-voltage solar panels. It's earlystage, but it speaks volumes about where the conversation is headed.

Technology is not just reshaping jobs-it's creating them. Dozens of Kashmiri youth now work as freelance developers, digital marketers, and UI/UX designers. Many found clients through platforms like Upwork and Fiverr. Some were self-taught, using free courses from YouTube and Coursera during lockdowns

At the same time, there are real fears. What if AI replaces human jobs? What about bias in algorithms?

Educators are now blending tech with ethics, discussing these issues in classrooms and seminars. A few schools are even piloting AI awareness classes at the high school level.

Kashmir's tech scene is still small. But it's not passive. It's growing, it's localizing, and it's adapting fast.

The innovations may not be big, but they are real. They speak to a place trying to modernize without losing its soul.

▼was in 11th grade in 2007. My





the soft glow of Medina's early light. I stood outside Gate No. 21 of Masjid al-Nabawi, hand in hand with my mother and father. We had made it together to this sacred land. And it didn't feel real at first.

We walked the same streets where the Prophet Muhammad (peace be upon him) once walked, prayed in the mosque where he led the faithful, and breathed the same stillness in the air, as if the city itself was holding its breath in reverence.

Inside the mosque, every step felt lighter. The call to prayer echoed gently across the marble courtyard.

My father placed his hand on my shoulder. My mother looked at the Prophet's resting place through tearfilled eyes. I whispered: Alhamdulillah.

After our prayers, we made our way to Badr. It's not a long drive, but the air changes. The land opens up, raw and wide. And then we were there, on the ground where the first battle of Islam was fought.

The battlefield was silent now, but I could almost hear the cry of Allahu Akbar in the wind. I imagined the courage it took. A small group, standing firm in their faith, facing an army three times their size. My chest tightened. This wasn't just history. It was sacrifice, carved into the soil beneath our feet.

We stood before the graveyard of the martyrs of Badr. My mother closed her eyes. My father reached into his pocket and handed me a small notebook. "For your duas," he said.

I wrote the names of friends, family, even strangers who had asked me to pray for them. And I asked Allah for courage, even a fraction of what those early believers had.

Later that afternoon, we climbed Jabal al-Malika. It's a mystic mountain outside Medina. Bare, beautiful, and strangely peaceful.

The golden desert stretched in every direction. There were no crowds, no noise, just the crunch of gravel beneath our shoes and the whisper of wind in our ears.

As we climbed, I kept thinking about the signs of God. Not just in scripture, but in silence, in shade, and in sand.

On that mountain, I felt my heart slowing down. I didn't say much. I



didn't need to.

Masjid Quba was next. A small, simple mosque, but its spirit is vast.

The Prophet (PBUH) laid its foundation with his own hands. I prayed two rakats, just like he once did. The hadith says that's equal to an Umrah.

But even without the reward, there was a gentleness in that mosque I won't forget. It felt like the beginning of something, like stepping into a home built on brotherhood and belief. From there, we went to the site of

the Battle of the Trench.

The land was hushed, the trench now only marked by history and imagination. But I pictured the Prophet (PBUH) striking that rock and saying Persia, Byzantium, and Yemen would fall to Islam.

I remembered how he consulted his companions, dug with his own hands, trusted Allah completely.

In that place, I felt the power of faith that's both patient and practical. Then came the most emotional

stop-Masjid Sayyid al-Shuhada, at the foot of Mount Uhud. This is where Hamza ibn Abdul

Muttalib, the Prophet's uncle, was martyred, along with seventy others. I stood at the edge of their resting

place, watching pilgrims place their hands over their hearts. My father leaned on his walking stick. "He was called the Lion of God," he said.

I thought about that title. What it means to fight for truth, to die with dignity. I looked up at the mountain.

The Prophet once said, "Uhud loves us, and we love it." And I understood.

We also visited Masjid Qiblatain, the mosque where the Qiblah was changed during prayer, from Jerusalem to the Kaaba.

That moment was more than geography. It was a pivot in identity. A spiritual direction set for a growing Ummah.

Standing there, I thought about change. The kind that comes from revelation, and the kind that happens in a single moment, when Allah decides it's time.

Our last stop was a small, humble garden: the date orchard of Salman al-Farsi (RA).

Here, the Prophet (PBUH) planted 300 date palms so Salman could earn his freedom.

I had read that story before. But standing under those trees, it came alive. I saw how faith freed a Persian seeker. I saw how love and justice weren't ideas. They were roots, growing in real soil.

My mother ran her hand along one of the trunks. "He planted this," she whispered. And I believed her.

This journey wasn't just travel. It was awakening. It was walking in the footprints of giants.

And it was a reminder that faith lives in land, in memory, and in the company we keep.

friends and I spent most of our days dreaming about the future: what courses we'd pick, what colleges we'd aim for. But one thing we never talked about was starting a business. That just wasn't in the air around us. Our parents wanted us to be doctors, engineers, judges. Anything steady, anything safe.

Only one classmate ever mentioned business. His older brother ran a small travel agency. He'd talk about cabs, tourists, and how Kashmir could thrive if peace lasted.

Slowly, his confidence rubbed off on some of us. A few even began to imagine running their own ventures. But we always hit the same wall: how do you do business in a place where life can be shut down overnight?

Then 2008 arrived, and everything fell apart.

That summer, protests erupted over a controversial land transfer to the Amarnath Shrine Board. What started as political disagreement quickly turned into weeks of marches, clashes, and mass shutdowns. Roads emptied, shops stayed closed, and tension hung in the air.

By September, over 40 civilians were resting in different cemeteries. We stayed indoors, listening to news bulletins and the sound of gunfire from our windows. Schools remained shut for months. So did any dreams we had of becoming entrepreneurs.

I later heard that my classmate's brother-who once welcomed tourists with brochures and bookings—was now selling apples from a cart to feed his family.

We hoped that was the worst of it. But in 2010, the Valley exploded again. What followed was five months of street protests, stone pelting, and curfews. Over 120 civilians died. Most were young.

I remember the silence of empty roads, the helplessness of not being able to visit relatives, and the panic every time mobile networks were cut.

A friend of mine had just taken a bank loan to buy a cab. He was hoping to drive tourists around Gulmarg. That cab sat in his driveway for months, untouched. Eventually, he sold it at a loss just to repay the loan.

But Kashmiris are used to rebuilding. That's what we do. We move forward after every fall. Slowly, things picked up again, until 2016.

Protests that summer were the most intense I'd ever seen. Schools, shops, even hospitals struggled to function. The shutdown lasted nearly five months. Internet was gone. Newspapers faced curbs. This time, it felt like something inside people truly broke.

Then came 2019. The abrogation of Article 370. A total communication blackout. I still remember how surreal it felt to lose touch with the outside world for weeks. Some areas were under restrictions for nearly eight months. Many small businesses collapsed quietly. The ones that survived did so by sheer will.

After all those years, we began 2020 with almost no expectations. But slowly, the air changed. For the first time in over a decade, there was something close to normal.

New cafés opened. Young people started online delivery services. Shopping malls and cab apps began popping up. Everyone seemed to be trving something new. My own cousin launched a winter clothing brand and started shipping across India. It felt like we were finally being allowed to breathe again.

Then, the Pahalgam attack happened. News of the attack spread quickly. But for us, it wasn't just a breaking news headline. It felt like someone had stabbed the heart of our recovery. In every café, home, and shop, people said the same thing: Not again.

We've seen this cycle too many times. Every time Kashmir starts to stand, something pulls it down. But something is different now. People are angrier. And more determined.

No one wants to go back to the hopelessness of the past. Locals came out and condemned the attack in loud, united voices. Some rushed to help the injured. Others offered shelter to stranded tourists. In the middle of grief, there was this quiet resistance: We will not let this break us.

The hospitality industry is not just about money for us. It's personal. We've grown up in homes where a stranger at the door is treated like family. During snowstorms or highway closures, I've seen families offer meals to tourists without being asked. This is who we

Still, we can't do this alone.

The government has to act. Not with curbs, but with support, protection, and genuine investment in people's futures. If young Kashmiris want to start a business, they should be able to do it without fear that tomorrow it'll all come crashing down again.

'Only 32% Of Job Seekers Consider Themselves Prepared For Interviews'

large number of job seekers attend interviews without preparation and fail to unlock their true potential, said a report on Friday.

It said only 32 per cent of job seekers consider themselves prepared for interviews, reflecting their limited confidence while facing hiring managers.

"Despite the vast opportunities in the Indian job market - with 3.1 lakh jobs posted on Apna in the first quarter of 2025 alone - many candidates still struggle with confidence and lack of effective interview preparation.

"This gap holds back a large number of job seekers from unlocking their true potential and unlocking possibilities," Apna.co founder and CEO Nirmit Parikh said, quoting the report titled 'Interview Readiness Index 2025'.

He said, the future lies in AI-powered tools that offer personalised feedback and real-time interview simulations.

The report also underscores that the rising impact of digital tools in boosting interview readiness as job seekers who leveraged online tutorials, mock interviews, or AI-powered platforms reported significantly higher confidence levels (38 per cent) compared to just 24 per cent among those who did not use such resources.

As technology continues to transform the job search landscape, digital fluency is rapidly becoming a key



driver of interview preparedness and confidence, the report added.

"These innovations can bridge the preparation gap, helping candidates build confidence, sharpen their skills, and truly showcase their abilities. Our goal is to empower every Indian to not just prepare better, but to believe in themselves, build confidence, and unlock meaningful career opportunities by becoming truly interviewready," Parikh added.

Apna.co's 'Interview Readiness Index 2025' is based on a survey of over 10,000 respondents across the country. The report has drawn insights from individuals who attended at least one interview in the past year, with 67 per cent experiencing virtual interviews, followed by 61 per cent phone interviews, and 57 per cent in-person rounds.

The Conversation

The report further revealed that nearly half (49 per cent) of candidates with over six years of experience feel well-prepared for interviews.

Confidence declines among midcareer professionals, with just 34 per cent of those having 3 to 6 years of experience reporting readiness. The level of confidence dips further to 29 per cent among early career professionals with 1 to 3 years of experience, it stated.

It also revealed sharp contrasts in confidence level among candidates in different cities.

Job seekers in tier I cities lead the way, with 45 per cent saying they feel prepared for interviews, compared to 32 per cent in tier II cities and just 26 per cent in tier III towns, the report said.

NIT Rourkela Develops Biosensor To Detect Breast Cancer Cells Without Expensive Lab Procedures

Researchers at National Institute of Technology (NIT), Rourkela have developed a novel semiconductor device-based biosensor that can identify breast cancer cells without the need for complicated or expensive laboratory procedures, according to officials.

The developed biosensor does not require any added chemicals to work. It is highly effective in distinguishing the cancerous cells from the healthy breast cells, offering improved accuracy compared to the existing methods of biosensing devices for breast cancer diagnosis, they said.

The research has been published in the prestigious Microsystem Technologies journal.

According to Prasanna Kumar Sahu, Professor at the Department of Electrical Engineering, the rise of potentially fatal illnesses has drawn attention in recent years to the global emphasis on biomolecule evaluation and Point-of-Care (POC) testing. Among these diseases, cancer is a significant global public health concern. In this context, India has seen a significant rise in breast cancer cases in the past few decades.

"Since cancer cells often do not show any initial signs of progression, it is crucial to diagnose them at an early stage for prevention and cure. While several diagnostic procedures such as X-ray, mammography, Enzyme-Linked Immunosorbent Assay Test (ELISA), Ultrasonography and Magnetic Resonance Imaging (MRI) are used to identify the disease, they require specialised equipment and trained personnel.

"Additionally, these diagnostic methods are often inaccessible to people in remote areas," Sahu said.

The COVID-19 pandemic further highlighted these challenges due to the relocation of medical resources, resulting in delayed cancer screenings and treatments, he said.

"This underscores the urgent need for simpler, faster, and more affordable diagnostic tools that do not rely on complex infrastructure," Sahu added.

The NIT team has designed a novel approach that uses the physical properties of cancer cells to detect them. Cancerous breast tissues, which hold more water and are denser than healthy tissues, interact differently with microwave radiation. These differences, known as dielectric properties, make it possible to distinguish between healthy and cancerous cells.

The research team has proposed an electronic device, Tunnel Field Effect Transistor (TFET), based on TCAD simulation results that can effectively detect breast cancer cells. FETs are commonly used in electronics but here they have been adapted to function as a sensitive detector of biological materials. Unlike many traditional tests, this biosensor does not need any added chemicals or labels to work.

"A small cavity is etched into the transistor under the gate area and an equivalent material of biological sample of cells is placed in the cavity to check the sensitivities of the device. The sensor then reads changes in electrical signals based on the properties of the sample, essentially 'sensing' whether the cells are cancerous or healthy.

"Because cancer cells like T47D have a higher dielectric constant than healthy ones like MCF-10A, the sensor picks up these differences quickly and with high precision," Sahu said.

The findings show that the sensor is sensitive in detecting T47D cancer cells due to their high density and permittivity. It is also highly effective in distinguishing cancerous cells from healthy breast cells, offering improved sensitivity compared to existing technologies.

Eventually we lose focus, we disengage. Time seems to pass slowly, and we may even start to feel restless. Whether it be watching a movie that disappoints, a child complaining that "there's nothing to do", or an adult zoning out during a meeting – boredom is a universal experience.

Generally defined as difficulty maintaining attention or interest in a current activity, boredom is commonly viewed as a negative state that we should try to avoid or prevent ourselves from experiencing. But what if there's another way to view boredom, as a positive state? Could learning to embrace boredom be of benefit?

This complex interplay of networks involves several key brain regions "working together" during the state of boredom. The insula is a key hub for sensory and emotional processing. This region shows increased activity when detecting internal body signals – such as thoughts of boredom – indicating the movie is no longer engaging. This is often referred to as "interoception".

The amygdala can be likened to an internal alarm system. It processes emotional information and plays a role in forming emotional memories. During boredom, this region processes associated negative emotions, and the ventral medial prefrontal cortex motivates us to seek alternative stimulating activities. scheduling ourselves to keep busy. As adults we juggle work and family. If we have kids, the habit of filling the day with schooling and after-school activities allows us to work longer hours.

In between these activities, if we have time to pause, we may be on our screens constantly organising, updating, or scrolling to simply stay occupied. As a result, adults inadvertently model the need to be constantly "on" to younger generations.

This constant stimulation can be costly – particularly for our nervous system. Our overscheduling can feed into overstimulation of the nervous system. The sympathetic nervous system which manages our fight-or-flight response is designed to deal with times of stress.

India May Let U.S., Foreign **Firms Bid For Government Contracts: Sources**

NEW DELHI- India is opening up a chunk of its protected government procurement market to foreign firms, including the U.S., two government sources said, in a shift that could extend to other trading partners after it was offered to the U.K. under a trade deal this month. The government is likely to

allow U.S. firms to bid for contracts worth over \$50 billion, mainly from federal entities, as it negotiates a trade deal with Washington, the sources said.

Total public procurement including by federal, state and local governments and state-run firms – is worth an estimated \$700 billion-\$750 billion per year, according to government estimates. Most is reserved for domestic firms, with 25% set aside for small businesses, although sectors like railways and defence can buy from foreign suppliers when domestic options are unavailable.

Earlier this month, India and the U.K. agreed on a free trade pact that gives British firms access to federal government contracts in select sectors - covering goods, services and construction – on a reciprocal basis.

"In a policy shift, India has agreed to open its public procurement contracts gradually to trading partners including the U.S. in a phased manner and reciprocal manner," said one of the officials, with the knowledge of the matter.

Both sources requested anonymity, as details of the ongoing talks have not been made public. The Commerce Ministry did not respond to requests for comment on the U.S. proposal or extending the plan to other nations.

India has long resisted join-ing the World Trade Organisa-tion's Government Procurement Agreement, citing the need to protect small businesses.

In its March report on foreign trade barriers, the U.S. Trade Representative said India's re-strictive procurement policies pose challenges for U.S. firms due to "changing rules and limited opportunities."

Indian Trade Minister Piyush Goyal visited Washington this week to advance trade talks, with both sides aiming to sign an interim agreement by early July, officials said.

New Delhi is pushing to clinch a trade deal with the U.S. within the 90-day pause on tariff hikes announced by U.S. President Donald Trump on April 9 for major trading partners, which includes a 26% tar-iff on imports from India.

RBI To Give Record Dividend Of Rs 2.69 Lakh Crore To Govt

MUMBAI- The Reserve Bank on Friday announced a record Rs 2.69 lakh crore dividend to the government for FY25, 27.4 per cent higher than 2023-24, helping the exchequer to tide over challenges posed by US tariffs and increased spending on defence due to the conflict with Pakistan.

The decision on the dividend payout was taken at the 616th meeting of the Central Board of Directors of Reserve Bank of India held here under the Chairmanship of Governor Sanjay Malhotra.

The central bank had transferred Rs 2.1 lakh crore dividend to the government for the fiscal 2023-24. The payout was Rs 87,416 crore for 2022-23.

In a statement, the RBI said the transferable surplus for the year (2024-25) has been arrived at on the basis of the revised Economic Capital Framework (ECF) as approved by the Central Board in its meeting held on May 15, 2025.

The revised framework stipulates that the risk provisioning under the Contingent Risk Buffer (CRB) be maintained within a range of 7.50 to 4.50 per cent of the RBI's balance sheet.

During accounting years 2018-19 to 2021-22, owing to the prevailing macroeconomic conditions and the onslaught of the Covid-19 pandemic, the Board had decided to maintain the Contingent Risk Buffer (CRB) at 5.50 per cent of the Reserve Bank's Balance Sheet size to support growth and overall economic activity.

The CRB was increased to 6 per cent for FY2022-23 and to

6.50 per cent for FY 2023-24. Based on the revised ECF, and taking into consideration the macroeconomic assessment, the Central Board decided to further increase the CRB to 7.50 per cent, the RBI said.

"The Board thereafter approved the transfer of Rs 2,68,590.07 crore as surplus to the Central Government for the accounting year 2024-25,"



it said.

The government has estimated Rs 2.56 lakh crore as dividend/surplus for FY26 from the Reserve Bank of India, nationalised banks and financial institutions.

The government aims to bring down the fiscal deficit during 2025-26 to 4.4 per cent of the GDP from 4.8 per cent estimated for the preceding fiscal. Commenting on the RBI's decision, Aditi Nayar, Chief Economist with Icra, surplus transfer is about Rs 0.4-0.5 lakh crore (equivalent to 11-14 bps of GDP), higher than the amount that was likely assumed in the FY26 Union Budget, implying

an equivalent upside to nontax revenues, which would provide some buffer to make up for a miss in taxes or disinvestment receipts, or higherthan-budgeted expenditure in the fiscal.

"This provides some comfort on the fiscal front," she said.

The Board also reviewed the global and domestic economic scenario, including risks to the outlook. It also discussed the working of the Reserve Bank during the year April 2024 -March 2025 and approved the central bank's Annual Report and Financial Statements for the year 2024-25.

Giving details about the revised ECF, the RBI said the computation of market risk buffer requirement to adopt an integrated approach, wherein the off-balance sheet portfolio is also reckoned, together with the on-balance sheet portfolio.

The computation of market risk buffer requirement may also include investments in Foreign Currency Assets in minor currencies, it said.

Markets Rebound Nearly 1%; Sensex Surges Over 760 Pts

MUMBAI- Equity benchmark indices Sensex and Nifty rebounded sharply by nearly 1 per cent on Friday, propelled by buying in market heavyweights Reliance Industries, HDFC Bank and ITC.

Besides, hopes of a record dividend from the RBI and easing US treasury yields bolstered investor sentiment, traders said.

After a flat start, the 30-share BSE benchmark bounced back and surged 769.09 points or 0.95 per cent to settle at 81,721.08. During the day, it jumped 953.18 points or 1.17 per cent to 81,905.17.

As many as 2,361 stocks advanced while 1,589 declined and 156 remained unchanged on the BSE.

The NSE Nifty rallied 243.45 points or 0.99 per cent

to 24,853.15.

On a weekly basis, the BSE benchmark dropped 609.51 points or 0.74 per cent and the Nifty declined 166.65 points or 0.66 per cent.

"The domestic market has recouped nearly half of the week's losses, supported by gains in FMCG and IT stocks. FMCG benefitted from the early and above-normal monsoon forecast, while IT stocks saw a rebound follow-

ing a healthy correction. "Optimism around a potentially record-high dividend from the RBI is boosting hopes for fiscal consolida-

tion, reflected in falling Indian bond yields," Vinod Nair, Head of Research, Geojit Investments Limited, said. From the Sensex firms,

Eternal, Power Grid, ITC, Bajaj Finserv, Nestle, Axis Bank, Kotak Mahindra Bank and

Adani Ports were among the biggest gainers.

On the other hand, Sun Pharma was the only laggard, declining nearly 2 per cent. The company's stock fell

after it reported a nearly 19 per cent drop in consolidated net profit for the quarter ended March 31, 2025. The BSE midcap gauge

climbed 0.50 per cent and smallcap index went up by 0.45 per cent.

FMCG jumped 1.49 per cent, utilities (1.02 per cent), power (1.01 per cent), financial services (0.99 per cent), bankex (0.99 per cent), oil & gas (0.94 per cent) and energy (0.82 per cent).

Gold Rises Rs 100 To Rs 98,750/10 G Amid Firm Global Trends

NEW DELHI- Gold prices rose Rs 100 to Rs 98,750 per 10 grams in the national capital on Friday amid firm global cues, according to the All India Sarafa Association.

The precious metal of 99.5 per cent purity appreciated by Rs 100 to Rs 98,300 per 10 grams (inclusive of all taxes).

Firm trends in the international markets and persistent concerns about US fiscal policy continued to support longer-term demand for bullion prices, the association said. However, silver prices plunged by Rs

2,000 to Rs 99,200 per kg (inclusive of all taxes) on Friday. The white metal had closed at Rs 1,01,200 per kg on Thursday.

On the global front, spot gold increased by USD 35.46 or 1.08 per cent to USD 3,330.23 per ounce.

"Gold edged higher set for its biggest weekly gain since mid-April, as fiscal concerns in the US continue to provide a supportive backdrop," Kaynat Chainwala, AVP-Commodity Research at Kotak Securities, said.

Goyal Meets US Commerce Secy For 2nd Time In A Week To Discuss Proposed Trade Pact

NEW DELHI- Commerce and Industry Minister Piyush Goyal on Friday met US Commerce Secretary Howard Lutnick in Washington, their second meeting within a week, to discuss the proposed bilateral trade agreement currently under negotiation between the two countries

On May 20 also, Goyal held a meeting with Lutnick to expedite the talks on the first phase of the trade pact.

The meeting assumes significance as both the coun-

tries are looking at finalising an interim trade pact by July 9, the day America's 90-day suspension of reciprocal tariffs on Indian goods comes to an end.

The US on April 2, imposed an additional 26 per cent reciprocal tariff on Indian goods but suspended it for 90 days. However, the 10 per cent baseline tariff imposed

by America remains in place. The four-day discussions between the chief nego-tiators of both the countries have also concluded in Washington on May 22.

In the interim trade deal, New Delhi is pushing for full exemption from the 26 per cent reciprocal tariff on Indian goods.

Due to the 90-day suspension of the 26 per cent additional import duty, Indian exporters are at present pay-

ing just 10 per cent baseline tariffs, instead of 26 per cent earlier proposed.

At present, the Trump administration requires approval from the US Congress to bring tariffs below the MFN (most favoured nation) rates. But the administration has the authority to remove the reciprocal tariffs imposed on a number of countries, including India.

India may look at certain commitments from the US on the duty concessions for its labour-intensive sector in the first tranche of the proposed bilateral trade agreement (BTA). Both countries have fixed a deadline to conclude the first phase of the pact by fall (September-October) of this year to more than double bilateral trade to USD 500 billion by 2030 from the current USD 191 billion.

resorts weren't spared the heat. Pahalgam, typically a cool escape for tourists, touched 28.8°C, and Kokernag logged 31.5°C. Gulmarg, the Valley's popular ski destination, saw the mercury rise to 24.0°C.

In the Jammu region, a slight dip in temperature was observed, though the weather remained harsh. Jammu City recorded a maximum of 38.2°C. Other areas such as Banihal (29.2°C), Batote (27.7°C), Katra (35.2°C), and Bhaderwah (31.4°C) also experienced elevated temperatures.

Director of the MeT Department, Dr Mukhtar Ahmad, said that isolated heatwave conditions are likely to persist across J&K. He added that while generally hot and dry weather is expected, a brief spell of light rain in isolated areas, especially during late afternoons, could provide minimal relief through May 26.

From May 27 to 31, the weather is predicted to stay mostly dry and hot, with the possibility of thundershowers at scattered places.

The department has also issued an advisory, predicting a 1-2°C rise in maximum temperatures in Kashmir till May 23, with scattered heatwave conditions expected. A slight dip of 2–3°C is anticipated after that. Meanwhile, in the Jammu division, temperatures may rise further by 2–3°C till May 26, heightening the possibility of heatwave conditions.

"Thunderstorms with gusty winds may occur at isolated places during late afternoon hours," the advisory noted.

The prevailing conditions have led to concerns, especially for children, the elderly, and those with pre-existing health conditions. Authorities have urged people to stay hydrated, avoid direct exposure to the sun during peak hours, and take necessary precautions to com-

"We did not hit (Pakistan's) civilian installations. Operation Sindoor and the incidents that followed completely exposed the fact that Pakistan is sponsoring terrorism in India because it was the Pakistan Army that replied after we hit their terror bases," Shah said.

The home minister said Operation Sindoor "exposed" this fact as top Pakistan Army officers were seen offering namaz and shouldering the coffins of the terrorists who were killed.

The operation was successful as it used the correct firepower and achieved its aims besides "showing the reality" to Pakistan, Shah said.

The home minister also said that global experts and the world were "praising" the bravery and firepower of the Indian armed forces.

The operation also brought to the fore the fact that the 'Aatmanirbharta' (self-reliance) achieved by India in defence production was successful, he said.

Lauding the BSF for carrying out its duties during the operation, Shah said the force "proved its mettle" by not allowing the Pakistani forces to move even an inch.

The home minister also paid condolences to the two BSF troopers who were killed during the operation along the International Border in Iammu.

Shah recalled that India has been facing Pakistan-sponsored terrorism for many decades but a "befitting reply was not given" until the Modi government came to power (in 2014).

"We were defensive... Our police force and BSF did their best to protect the people but a befitting reply was not given. After 2014, when Prime minister Modi took charge, the biggest attack took place in Uri (2016) where our jawans were burnt alive.

"We conducted a surgical strike (across the border) and hit the terrorists by entering their hideouts for the first time. We thought that terrorism will stop but it did not, and the Pulwama attack happened (in 2019)," Shah said.

"That's where my world begins. But we've always been told that we had to solve that ourselves," he said.

On India's oil purchases from Russia, Jaishankar said Europe was driving up energy prices for all developing countries, including India by sourcing crude oil from the Middle-East.

"Wealthy Europe turned to the Middle-East because it had a problem with Russia and offered inflated prices to get oil redirected to Europe." "So what happened was that many countries -- not just us -- could no longer afford it. The major oil companies didn't even respond to purchase offers because they were too busy selling to Europe," Jaishankar said.

"What was the rest of the world supposed to do? Say 'okay', we'll just do without energy because Europeans need it more than us," he asked.

Jaishankar also described terrorism as a major global challenge.

"Of the major collective challenges today, I would place terrorism at the top - alongside climate change, growing poverty, and the consequences of the COVID-19 pandemic in the Global South," he said.

In a separate interview to Danish broadcaster TV 2, Jaishankar said the understanding between India and Pakistan on May 10 to stop fighting and military actions was firmed up "directly" by the militaries of the two sides.

The external affairs minister's comments came against the backdrop of US President Donald Trump's claim that Washington played a role in brokering the truce.

To ease difficulties, the government has already changed school timings. Schools within Srinagar will now operate from 8:30 AM to 2:30 PM instead of 9 AM, and other schools across Kashmir will run from 9 AM to 3 PM instead of 9:30 AM.

"The department will decide on summer vacations based on the evolving weather conditions." Itoo said.

The Meteorological Department predicts the heatwave to continue till May 26, with scattered rainfall expected from May 27 to 30, which may bring some relief. Srinagar recorded a maximum temperature of 33.2 degrees Celsius on Friday, 7.8 degrees above normal, while Kupwara saw 32.4 degrees Celsius.

The ongoing intense heatwave has made daily life unbearable, especially for students who are currently attending schools under these extreme conditions.

military installations or air bases. We only hit the terrorist bases in Pakistan. Those who committed a criminal act on our land -- the laish-e-Mohammed. Hizbul Mujahideen and Lashkar-e-Toiba -- their bases, houses, training camps and launchpads used against India were destroyed," Shah said.

The home minister added, "We thought it was enough that we hit the terrorists but Pakistan proved that it was sponsoring terrorism, as they took the Indian strikes as an attack on themselves and targeted civilian locations and military bases in India."

But the Indian air defence displayed "marvellous strength" as Pakistan could not touch any of India's installations, Shah said.

"After this, we hit their air bases and gave a strong response by introducing them to our fire power and exposing their hollow air defence," he said.

The Modi government gave a "stronger" response than Uri as it demolished terror bases across the front. Shah said.

Lauding the BSF, Shah said, "The bravery shown by the BSF in the 1971 war that was imposed upon us, and the contributions made by the force (in the creation of Bangladesh) cannot be forgotten by India and neither should Bangladesh ever forget it."

The BSF played a "significant" role in the creation of Bangladesh and set an "exemplary" standard of bravery by standing shoulder-toshoulder with the armed forces in fighting against injustice, Shah recalled.

The home minister said the 2.75 lakh personnel-strong BSF was working in some of the most difficult conditions marred by geographical challenges along the two borders (with Pakistan and Bangladesh).

"I want tell you that the Modi government is standing behind you like a rock and the Ministry of Home Affairs will soon implement some technology solutions and models to strengthen border security in areas where it is not possible to erect fences," Shah said.

The home minister also awarded gallantry and other service medals to BSF personnel during the event, which was attained by Union Home Secretary Govind Mohan, Intelligence Bureau Director Tapan Kumar Deka, and BSF Director General Daljit Singh Chawdhary.

criticised Europe for backing Pakistan when it was under military dictatorship.

"Our borders have been violated by Pakistan in Kashmir ever since our independence in 1947. And what have we seen in the eight decades since then," he asked.

"That large, democratic Europe, to use your own term, has stood side by side with military dictatorships in the region.

"No one has supported the military regime - and undermined democracy in Pakistan in so many ways - as much as the West," he said.

The external affairs minister was in Copenhagen as part of his three-nation tour of the Netherlands, Denmark and Germany.

Jaishankar emphasised that India supports countries' sovereignty and internationally recognised borders.

"But my worldview and my view of Europe are shaped by my own experiences. You talk about the inviolability of borders -- well, why don't we start with the inviolability of my borders?"

"We had the conflict for a few days (and) we resolved that conflict for the moment in its particular military form through an understanding for the cessation of fighting and military action. And this was something that we negotiated directly between the militaries of the two countries," he said.

"The trigger for it was that after we had had fighting for a few days, we hit them very hard on the morning of (May) 10..and that caused the Pakistanis to say, 'Ok, we're prepared to stop the firing and reach an understanding about how to deal with it." Under Operation Sindoor, India carried out precision strikes on nine terror infrastructures early on May 7 in response to the April 22 Pahalgam terror attack.

Following the Indian action, Pakistan attempted to attack Indian military bases on May 8, 9 and 10. The Pakistani attempts were strongly responded to by the Indian side.

Foreign Secretary Vikram Misri on May 10 announced that India and Pakistan reached an understanding to stop all firings and military actions on land, air and sea, with immediate effect

aviation operators until June 23, 2025. The restriction also applies to Pakistan's military aircraft.

In a reciprocal move, Pakistan has extended its ban on Indian flights through its airspace until June 24.

Pakistan had initially closed its airspace to Indian carriers on April 24, a day after India suspended the Indus Waters Treaty and took other retaliatory steps following the terror attack in Pahalgam. On April 23, India announced a series of measures against Pakistan, including the closure of the Attari land border crossing, suspension of the Indus Waters Treaty, and downgrading diplomatic ties, citing Pakistan's involvement in the cross-border massacre.

In response, Pakistan shut its airspace for Indian flights and halted all trade, including through third countries.

It was further provided that the services of the ReTs shall be transferable after regularization within the District to which they belong. This proviso was added to the Scheme vide Government Order on 25 June 2014. It was this proviso that was challenged by the appellants with the contention that the same impacted the seniority of the General Line Teachers appointed in the School Education Department on the recommendations of the Jammu & Kashmir Service Selection Board (JKSSB) on different dates.

"There is ample authority on the proposition that no employee can be given seniority from the date he is not borne on the service, class, category, or grade as the case may be," the Division Bench underlined. ReT becomes a member of service only when there is formal order of appointment issued after evaluation and assessment of his or her performance on completion of five years as ReT, the Division Bench said.

"The government, acting in ignorance of the settled legal position, took the policy decision to confer the benefit of seniority on ReT with effect from the date they were initially engaged, notwithstanding the fact that on said date they were not borne on the cadre of service constituted by the Rule of 1979," the Division bench said.

The Government also did not take into consideration the fact that by adding the proviso in the ReT, they had acted to the serious prejudice of the General Line Teachers who were appointed prior to the regularization of various ReTs, the Division Bench said.

"The Writ Court (single bench) appears to have been greatly swayed by extension of certain welfare provisions to the ReTs from time to time and has erroneously concluded that the Government itself had been treating the ReTs on a par with the General Line Teachers," the Division bench said, adding, " As a consequence, the writ petition is allowed and the impugned provision, to the extent it provides that "the five years service rendered by Rehbar-e-Taleem teachers before regularization shall count for the purpose of fixing their seniority" is set aside."



What To Know Ahead Of The Final Round In The Premier League

LONDON: Here what's to look out for heading into the final round of the Premier League on Sunday:

FIGHT FOR THE CHAMPIONS LEAGUE

Five teams – Manchester City, Newcastle, Chelsea, Aston Villa and Nottingham Forest – are bidding for the remaining three Champions League qualification spots alongside alreadycrowned champion Liverpool and second-place Arsenal.

City is in third place on 68 points. Fourth-place Newcastle, fifth-place Chelsea and sixthplace Villa each have 66, and seventh-place Forest has 65.

City is away to Fulham and, because of its superior goal difference (+26) compared to its rivals, knows a draw is all but certain to secure a top-five finish.

Indeed, Newcastle (+22) and

Chelsea (+20) have a much better goal difference than Villa (+9) so are virtually sure of getting into the Champions League with victories. Chelsea has the toughest match – away to Forest – while Newcastle hosts Everton and Villa visits Manchester United, which is coming off losing the Europa League final.

Forest must beat Chelsea and also needs one of Newcastle and Villa to lose or draw their games to secure Champions League qualification. It would be a huge achievement, given Nuno Espirito Santo's team was fighting relegation last season.

A sixth-place finish guarantees a place in the Europa League.

FAREWELLS

Man City star Kevin De Bruvne heads the list of players bidding farewell to their teams on the final day.

De Bruyne already had a big Etihad Stadium sendoff on Tuesday



after the win over Bournemouth but this will be the last game in his 10-year career with City. Elsewhere, Trent Alexander-Arnold's goodbye to Liverpool hasn't been so celebrated by some Reds fans unhappy at him leaving his boyhood team on a free transfer. His last game for Liverpool is against Crystal Palace at Anfield and Liverpool manager Arne Slot said Friday he hasn't decided if Alexander-Arnold will start.

Others heading into the final games for their clubs include

Victor Lindelof and Christian Eriksen (Man United), Jorginho and Kieran Tierney (Arsenal), Abdoulaye Doucoure (Everton) and Lukasz Fabianski (West Ham).

On the managerial front, there's still plenty of speculation about the future of Tottenham manager Ange Postecoglou despite leading the team to the Europa League title. What he says - or how he behaves after the home game against Brighton will be telling. It could also be Ruud van Nistelrooy's final game in charge of relegated Leicester.

Trophy lift and records: Liverpool's players will finally get their hands on the Premier League trophy after closing their title-winning campaign against Palace, the FA Cup winner -adress rehearsal of sorts for the season-opening Community Shield in August.

Mohamed Salah, who has 28

goals and 18 assists this season heads to Anfield with a couple of records in sight. He is one goal or assist away from the Premier League's single-season goal contribution record of 47 – held jointly by now-retired strikers Alan Shearer and Andrew Cole - and two assists short of the record for most assists in a Premier League season, held by De Bruyne and Arsenal great Thierry Henry.

Salah looked likely to break both of those records but has just one goal and one assist in his last eight matches.

Former Liverpool manager Jurgen Klopp will be at Anfield on Sunday.

PLAYOFF FINAL

Before the last round of Premier League games, there's a huge match at Wembley Stadium on Saturday to discover which team will be playing in the top flight next season.

Sunderland and Sheffield United meet in the Championship playoff final for the right to join Leeds and Burnley in getting promoted from the second tier.

The playoff final is the most lucrative one-off match in world soccer, with Sunderland - last in the Premier League in 2017 - in line to get an estimated revenue uplift of around 200 million pounds (\$260 million) in projected matchday, broadcast and commercial revenue in case of promotion, and much more if the team was to survive the first season back in the top flight.

For Sheffield United, the uplift would be an estimated \$180 million as the club is still benefitting from parachute payments from the last time the team was in the Premier League – in the 2023-24 season.

Sunderland's team contains Jobe Bellingham, the younger brother of Real Madrid star Jude Bellingham.
