New Delhi: External Affairs Minister S Jaishankar on Monday told a parliamentary panel that Pakistan was informed by the DGMO about Indian strikes on terror camps in their territory only after they were executed, sources said.

He also said he never spoke to Pakistan and cleared the air about alleged US "interference", saying the decision to halt the military operation was taken bilaterally after a request from the Pakistan side.

members of Addressing the Consultative Committee on External Affairs here, the minister said the cessation of Operation Sindoor was done only after Pakistan DGMO asked for the halting of hostilities and there was no question of US mediation between the two, the sources said.

The Congress and Rahul Gandhi have been targeting Jaishankar, alleging that he had informed Pakistan beforehand about the Indian strikes at terror camps.

The sources said the minister told the MPs at the meeting that only the DGMOs of the countries spoke to each other and no other Indian official spoke with the Pakistani side.

He said the US was urging India to speak with Pakistan and it was told that terror and talks

Twenty-six men were gunned by terrorists in Pahalgam in Kashmir on April 22, following which India launched Operation Sindoor in the early hours of May 7, resulting in massive damage to terror infrastructure in Pakistan and Pakistan-occupied-Kashmir.

Hold Rajya Sabha Polls In **J&K: NC To EC**

Srinagar: The Conference on Monday appealed to the Election Commission of India to hold elections for the Rajya Sabha seats in Jammu and Kashmir, while pointing out that more than six months have passed since the Assembly polls.

The Jammu and Kashmir ruling party also pointed out that while the poll panel has announced bypolls to assembly seats in four states, it left out the Budgam and Nagrota assembly

'Jammu and Kashmir has a right to representation in the Rajya Sabha. I appeal the Election Commission to hold elections as soon as possible as there is no representation of Jammu and Kashmir in the Rajya Sabha," NC chief spokesperson Tanvir Sadiq told reporters here.

He said more than six months have passed since the Assembly elections were held in Jammu and Kashmir but the Rajya Sabha seats are still vacant.

"Despite six-seven months having passed, elections for the Rajya Sabha seats from Jammu and Kashmir have not taken place. Moreover, everywhere by-elections are taking place except for Budgam and Nagrota. Why only delay in Jammu and Kashmir?" he posed.

While the Budgam assembly segment fell vacant after Chief Minister Omar Abdullah decided to give it up to retain Ganderbal, the Nagrota | More on P10

J&K NEET Aspirant Dies By Suicide In Kota

2nd Case This Month, 15th In 2025

Srinagar: In yet another tragic incident, a NEET (National Eligibility cum Entrance Test) aspirant, this time from Jammu and Kashmir, died by suicide in Kota, Rajasthan, highlighting the ongoing mental health crisis among students preparing for com-

An 18-year-old NEET aspirant from Kashmir allegedly hanged herself from the ceiling fan of her paying guest room here at Pratap Chauraha in Kota, police on Monday said.

The student, identified as Zeeshan, had arrived in Kota just a week ago to prepare for the NEET UG medical entrance exam. The incident occurred in Mahavir Nagar, a locality known for housing students attending coaching

This is the 15th such incident this year and second this month alone.

According to police reports,



Zeeshan took her life by herself in her room late on Sunday evening.

Before she killed herself, the girl spoke to a relative of hers on the phone and told him that she might commit suicide before hanging up, Circle Inspector Ramesh Kavia, posted at Mahaveer Nagar Police Station, said.

Burhan, the relative, immediately called another student Mamta, who lived in the same building on the floor above, and asked her to check on Zeeshan, he said.

Mamta rushed to Zeeshan's room, found it bolted from inside, and shouted for help. A crowd gathered and

broke open the door with the rowed from some carpenters working nearby, he said.

They found Zeeshan hanging from the ceiling. She was rushed to a hospital, but was declared dead.

According to police, Zeeshan had returned to Kota a month ago, having earlier lived in the city enrolled at a coaching institute to prepare for the medical entrance exam. This time, she was engaged in self-study and hadn't enrolled anywhere.

14-Year-Old Srinagar **Student Dies By Suicide**

Family Alleges School Harassment Over Tattoos

Srinagar: A Class 10 student of Kashmir Harvard Educational Institute died by suicide last week, with his family alleging he was subjected to harassment by school authorities over tattoo marks on his body.

The deceased student, identified as 14-year-old Nouman Sofi, was reportedly found dead at his residence shortly after an alleged confrontation at school. His family claims he had previously been suspended over the issue of tattoos, but was readmitted after submitting affidavits and recommendations.

On the day of the incident, the family says Nouman was called to the principal's office and was not allowed to attend his classes. His sister, who was also called to the school, alleges that staff members confronted them and displayed Nouman's tattoos to others present.

"The tattoos were already being removed through laser treatment," she said. "Still, he was shamed and isolated."

She further claimed that Nouman was accused of attacking another student during a school picnic, though the student in question reportedly dismissed it as a casual interaction. Despite this, a teacher allegedly labelled Nouman a "murderer" in front of staff and students.

The family says they have audio recordings of the conversation and are demanding action against those involved. They have ruled out pursuing any compensation.

In the aftermath of the incident, MLA Habba Kadal, Advocate Shamim Firdous, visited the bereaved family to express her condolences and support. She assured them that the matter would be raised with the Honourable Education Minister and the relevant authorities.

ECIR Under PMLA Not Quashed By FIR Discharge: HC

Srinagar: The High Court of J&K and Ladakh has held that the mere discharge or quashing of a FIR by a competent court does not automatically result in the quashing of an Enforcement Case Information Report (ECIR) filed under the Prevention of Money Laundering Act, 2002.



PCOS Affects Women's Speed Of Response By 50 Pc, Accuracy By 10 Pc: IIT Bombay Research


olycystic Ovary Syndrome or PCOS impacts women's focus by decreasing speed of response by about 56 per cent and accuracy by about 10 per cent, researchers from Indian Institute of Technology Bombay (IIT Bombay) said. PCOS is an endocrine disorder in women, with symptoms like irregular or absent periods, polycystic ovaries, and increased levels of male hormone (androgen).

The findings emphasise the need to understand PCOS as a complex medical condition that not only affects physical but also cognitive health.

In their recent study, Maitreyi Redkar and Prof Azizuddin Khan from the Psychophysiology Laboratory, Department of Humanities and Social Sciences at IIT Bombay found that women with PCOS are slower to react and more easily distracted than their healthy counterparts.

They assessed women with attention tasks after dividing them in two groups, 101 women with PCOS and 72 healthy women.

"The cognitive experiments are specifically designed to capture the subtle millisecond-level differences in how individuals respond to critical stimuli. These minute delays reveal significant impairments in attention, which may impact our real-life functioning. In the specific context of focused attention, it is not just about concentrating on the task at hand to respond at the right

showed over a 50 per cent slower response and made about 10 per cent Researchers used two task-based tests, more errors than the healthy ones in the focused attention test.

Similarly, PCOS women performed about 20 per cent slowly, with 3 per cent extra errors in the divided attention task.

Among the two types of attention, PCOS women performed poorer in focused attention, the research revealed. The hormonal imbalance associated with PCOS could lead to decreased alertness and longer reaction times. Along with elevated androgen levels, the participants with PCOS had insulin resistance that is linked to attention.

Insulin resistance causes poor glucose metabolism and affects brain cell (neuron) activity, leading to poor performance in focused attention tasks.

"PCOS is a heterogeneous condition, which means that its symptoms and severity vary depending on the hormonal profile, metabolic health, mental health and socio-environmental conditions of the individual. Despite the variability in PCOS symptoms and their severity, the impairments in the core cognitive abilities of attention and processing speed seem to be prevalent across women," Prof Khan said.

While the challenges of low accuracy and slow response time seem daunting, playing brain games focusing on attention and memory can improve response time and accuracy, the research revealed.

"Increasing physical activity levels, maintaining a nutritious diet, and reducing weight are beneficial not just for PCOS symptoms but also for cognitive health. Even improving sleep hygiene contributes significantly to improving attentional accuracy and reaction time," Prof Khan added.

'Love Bug' Computer Virus Wreaks Fresh Havoc

EW YORK- Copycat variants of the "Love Bug" virus labeled "Joke" and "Moth-er's Day" infected computers around the world on Friday, a day after the most widespread cyberattack ever-wreaked havoc on business and government operations.

as the virus, first detected in Asia, spread around the globe, forcing network administrators to shut down e-mail systems at major companies and penetrating the Pentagon, the Central Intelligence Agency and Britain's Parliament. Security experts said the virus was far more devastating

Tens of millions of the computers have been disabled so far

than last year's Melissa bug, with losses now counting in the billions from damaged data and the distractions of fighting the software scourge, and warned that it could take weeks to stem the invasion. 'There's a potential 'that anyone who receives this virus can

go to the Internet and (find) tools to change codes within the virus program that can give the e-mail or the attachment a new name," said Simon Perry, vice president for security products at Computer Associates Inter-national Inc. (NYSE: CA - news). The Islandia, N.Y is a leading maker of anti-Virus software

such as inoculuteIT. For the time being, most of the virus variants are only cosmetically different from the original virus. "Based on our re-

search, we believe that the variants are coming from a number of different people," Perry said. ASIA AND EUROPE TAKE STOCK OF IMPACT: Computer users woke up on Friday to the chilling implications for a world that is now so wired up that quarantining such bugs may

prove an endless cat-and—mouse game -— with far-reaching financial consequences. Computer Economics, a market research firm located in Carlsbad, Calif, estimated that the virus already had caused \$2.61 billion dollars in damages worldwide, but most experts

said precise figures would be difficult to pin down. The impact of the bug in Asia on Friday was possibly muted by the fact the markets in four countries-Japan. South Korea.

China and Thailand - were closed for public holidays on Friday. European Enterprise Commissioner Erkki Liikanen said: "The Love Bug is a warning to us all that security must be given top priority if consumer and user confidence is to be maintained as we move into the information age."

A German government spokeswoman said the virus had penetrated its foreign, jus-tice, interior and economics ministries. The spokesman reported no serious damage as the interior ministry called in a special task force to advise on counter-measures. Britain's Consumers Association said 30 to 50 percent of UK businesses seemed to be affected. "It is spreading very rapidly. Yesterday we had 10 to 15 percent." said Alan Stevens.

Kit experts warned the full effects of the bug may carry through the weekend.

Trump Vows To 'Win' Against Harvard, Threatens Funding

WASHINGTON: President Donald Trump vowed Monday to prevail in his clash with Harvard and again threatened to take away billions in funding from one of the world's top universities.

"I am considering taking Three Billion Dollars of Grant Money away from a very antisemitic Harvard, and giving it to TRADE SCHOOLS all across our land." Trump said, without giving details, in one of a flurry of texts on Monday, the Memorial Day holiday in the US.

He also brought up the issue of removing foreign students from Harvard -- a key source of enrollment and tuition money US -- saying he is waiting for Harvard to provide a list of these

Trump said he wants this list "so that we can determine, after a ridiculous expenditure of BILLIONS OF DOLLARS, how many radicalized lunatics, troublemakers all, should not be let back into our Country."

He added: "But have no fear, the Government will, in the end, WIN!"

The Trump administration moved last week to block Harvard from enrolling foreign students, but on Friday a judge suspended the order pending a hearing this week.

Trump is furious at Harvard -- which has produced 162 Nobel prize winners -- for rejecting missions and hiring, amid his claims the school is a hotbed of anti-Semitism and "woke" liberal ideology.

Trump is attacking US universities and other sources of what he sees as left-leaning power in the country like the media as he tries to exert tight, unprecedented presidential control over life in America.

In his fight with Harvard, Trump has threatened to put \$9 billion of government funding under review, then went on to freeze a first tranche of \$2.2 billion of grants and \$60 million of official contracts. The administration has also targeted a Harvard Medical School researcher

Spain Hosts European, Arab Nations To Pressure Israel To End Its Gaza War MADRID: The international community should look to sanction Israel to stop the war in Gaza, Spain's foreign minister said,

ahead of a Madrid meeting of European and Arab nations on Sunday to urge a halt to its offensive. Countries Israel had long

counted on as allies have been adding their voices to growing international pressure after it expanded military operations against Gaza's Hamas rulers, whose 2023 attack on Israel sparked the devForeign Minister Jose Manuel Albares told France Info radio.

Humanitarian aid must enter Gaza "massively, unimpeded, neutrally, so that it is not Israel who decides who can eat and who cannot", he said.

NIA Arrests CRPF Jawan for Pakistan Link

New Delhi: The National Investigation Agency (NIA) has arrested a CRPF personnel for allegedly spying for Pakistan, officials said on Monday.

The accused, Moti Ram Jat, was actively involved in espionage activity and had been sharing classified information related to national security with the Pakistan intelligence officers (PIOs) since 2023, they said.

Jat, an assistant sub inspector with the Central Reserve Police Force (CRPF), was receiving funds from the PIOs through various conduits, officials said.

The anti-terror agency has arrested Jat from Delhi and is interrogating him, they said.

Meanwhile, the CRPF said it has dismissed him from the service.

Jat came under the scanner in the course of close monitoring of his social media activity by the CRPF, in coordination with the central agencies, during which

Washington; As the Trump administration cut billions of dollars in federal funding to scientific research, thousands of scientists in the U.S. lost their jobs or grants, and governments and universities around the world spotted an opportunity.

The "Canada Leads" program, launched in April, hopes to foster the next generation of innovators by bringing earlycareer biomedical researchers north of the border.

Aix-Marseille University in France started the "Safe Place for Science" program in March - pledging to "welcome" U.S.based scientists who "may feel threatened or hindered in their research.'

Australia's "Global Talent Attraction Program," announced in April, promises competitive salaries and relocation

"In response to what is happening in the U.S.," said Anna-Maria Arabia, head of the Australian Academy of Sciences, "we see an unparalleled opportunity to attract some of the smartest minds here."

Since World War II, the U.S. has invested huge amounts of money in scientific research conducted at independent uni-

versities and federal agencies. That funding helped the U.S. to become the world's leading scientific power — and has led to the invention of cell phones and the internet as well as new ways to treat cancer, heart disease and strokes, noted Holden Thorp, editor-in-chief of the journal Science.

But today that system is being shaken.

Since President Donald Trump took office in January, his administration has pointed to what it calls waste and inefficiency in federal science spending and made major cuts to staff levels and grant funding at the National Science Foundation, the National Institutes of Health, NASA and other agencies, as well as slashing research dollars that flow to some private universities.

The White House budget proposal for next year calls to cut the NIH budget by roughly 40% and the National Science Foundation's by 55%

"The Trump administration is spending its first few months reviewing the previous administration's projects, identifying waste, and realigning our research spending to match the American people's priorities and continue our innovative domi-

Already, several universities have announced hiring freezes, laid off staff or stopped admitting new graduate students. On Thursday, the Trump administration revoked Harvard University's ability to enroll international students, though a judge put that on hold.

Research institutions abroad are watching with concern for collaborations that depend on colleagues in the U.S. but they also see opportunities to potentially poach talent.

"There are threats to science south of the border," said Brad Wouters, of University Health Network, Canada's leading hospital and medical research center, which launched the "Canada Leads" recruitment drive "There's a whole pool of talent, a whole cohort that is being affected by this moment.

Promising a safe place to do

Universities worldwide are always trying to recruit from one another, just as tech companies and businesses in other fields do. What's unusual about the current moment is that many global recruiters are targeting researchers by promising something that seems newly threatened: academic freedom.

New Delhi: The southwest monsoon hit Kerala on Saturday, marking its earliest arrival over the Indian mainland since 2009 when it reached the southern state on May 23, the India Meteorological Department (IMD) said.

Normally, the southwest onsoon makes its onset over Kerala by June 1 and covers the entire country by July 8. It starts retreating from northwest India around September 17 and withdraws completely by October 15.

The monsoon had set in over the southern state on May 30 last year; June 8 in 2023; May 29 in 2022; June 3 in 2021; June 1 in 2020; June 8 in 2019; and May 29 in 2018, IMD data showed.

Data available since 1975 showed that the monsoon reached Kerala the earliest in 1990 (on May 19), 13 days before the usual date.

According to meteorologists, there is no direct relationship between the onset date and the total rainfall over the country during the season.

The monsoon arriving early or late in Kerala does not mean it will cover other parts of the country accordingly. It is characterised by large-scale variabilities and global, regional and local features, an IMD official said.

The IMD in April forecast above-normal cumulative rainfall in the 2025 monsoon season, ruling out the possibility of El Nino conditions. which are associated with below-normal rainfall in the Indian subcontinent.

According to the IMD, rainfall between 96 per cent and 104 per cent of the 50-year average of 87 cm is considered 'normal'.

Rainfall less than 90 per cent of the long-period average is considered 'deficient'; between 90 per cent and 95 per cent is 'below normal'; between 105 per cent and 110 per cent is 'above normal'; and more than 110 per cent is considered 'excess' precipitation.

hree cyber thugs have been arrested for duping a Delhi resident of Rs 25 lakh by putting him under 'digital arrest', police said on Monday. Rahul Verma, Shantanu Richoriya (26), and Arjun Singh (25), were arrested from a hotel in the Paharganj area of the national

capital, they said. The suspects operated from hotel rooms in Delhi and worked with account holders, commonly known as 'mules', who were brought in person to facilitate transactions, an official said.

"Mahender Jain filed a complaint stating that he was conned into transferring Rs 25 lakh by a man who posed as a crime branch officer from the Nashik police, Deputy Commissioner of Police (Southwest) Surendra Choudhary said.

On March 21, Jain received a video call during which the caller claimed that his Aadhaar card details had been misused to open fraudulent bank accounts and were

linked to money laundering by a major airline company, he added.

The officer said that the caller allegedly showed Jain a photocopy of a bank card and coerced him into transferring his savings, selling his wife's jewellery, and making further payments through online gateway and RTGS.

The fraudster threatened Jain of police action if he failed to comply, he said.

A probe was launched after registering a case under relevant sections of the BNS and the accused were traced, the officer said.

"During interrogation, it was found that Rahul Verma initially supplied his bank account to other accused but later became an active part of the syndicate," a senior police officer said.

The three accused facilitated the movement of money through mule accounts, contacted international handlers via social media, and attempted to evade detection using fake identities, the officer said.

PGIMER-Chandigarh Operates On 7.7 Ft Tall Cop From J&K

CHANDIGARH: PGIMER's Department of Neurosurgery has treated a 35-year-old male patient, a Jammu and Kashmir Police head constable, who had reached a height of 7 feet 7 inches, a rare and extreme manifestation of acromegaly due to uncontrolled growth hormone secretion, the institute said.

The Post Graduate Institute of Medical Education and Research here has successfully treated over 100 cases of acromegaly — a rare feat.

The hormone disorder caused by functional pituitary adenomas, was treated through the endoscopic transnasal approach, a minimally invasive technique that avoids incision on the head.

The medical facility in a statement on Monday said its neurosurgery team, led by doctors Rajesh Chhabra, Apinder-preet Singh, and Shilpi Bose, performed this intricate procedure with the support of a neuroanaesthesia team led by Dr Rajeev Chauhan.

PGIMER Director Prof Vivek Lal lauded the surgery, saying, "The successful treatment of over 100 complex pituitary tumour cases is a testament to the clinical excellence, precision, and teamwork at PGIMER. These outcomes reinforce our unwavering commitment to delivering the highest standard of care through innovation and compassion."

The head constable, the PGIMER said, had been facing increasing joint pain, vision issues, and difficulty with daily activities. He underwent a tumour removal via the scarless transnasal route.

Post-surgery, his hormone levels began to normalise, and his symptoms showed marked improvement within weeks. Dr Rajeev Chauhan, Addi-

He said that depending on the hormone involved, the condition can cause a variety of symptoms -- abnormal growth of hands and feet (acromegaly), weight gain and facial puffiness (Cushing's disease), and breast discharge with irregular periods in women not pregnant (prolactinoma).

"Often silent in early stages, these tumours can lead to serious complications if not diagnosed and treated promptly," he said.

People experiencing abnormal growth patterns, menstrual changes, or unexplained weight gain are advised to seek medical evaluation to rule out hormonal imbalances and pituitary disorders, Dr Chhabra said.

With timely intervention, medical or surgical, including advanced options like Gamma Knife radiosurgery, patients can expect full recovery and restored quality of life, the state-

Abdullah, during his first stint as the chief minister of erstwhile state of Jammu and Kashmir from 2009-14, had held cabinet meetings in remote areas like Gurez, Machil, Tangdhar of north Kashmir and Rajouri and Poonch areas of Jammu region.

The decision to hold a special cabinet meeting comes two days after Abdullah on Saturday proposed a dual approach to resus-

citate the Jammu and Kashmir tourism sector, severely impacted by the Pahalgam terror attack, urging the Centre to mandate PSUs to hold meetings in Kashmir and to convene parliamen-

SRINAGAR: Following the directions of Deputy Commissioner (DC) Srinagar, Dr. Bilal Mohi-Ud-Din Bhat, Drug and Food Control Organization (DFCO), Food Safety wing has launched intensified market inspections across Srinagar City to ensure food products sold in the market are safe for consumption and adherence to hygiene standards in food establishments.

A team of the Food Safety Department, led by Assistant Commissioner Food Safety Srinagar, accompanied by Food Safety Officers conducted inspections at various markets in the City including Bemina, Momin Abad, Tengpora, Batamaloo, Exhibition Crossing and Lal Chowk.

During the market inspection, Notices were issued to as many as 7 Food Business Operators for not adhering to good storage practices. The FBO owners were also sensitized about the critical importance of adhering to proper storage practices, particularly for packaged drinking water,

carbonated water/beverages and dairy products such as milk and milk-based items. Improper storage, especially exposure to direct sunlight, can degrade

Meanwhile, All Food Business Operators (FBOs), including wholesalers and retailers, have been directed to implement corrective measures within two days to ensure that sensitive food items including packaged drinking water, carbonated beverages, and dairy products are not stored under direct sunlight. Compliance with storage conditions specified on product labels is mandatory to uphold food safety standards and protect public health.

Failure to adhere to these storage requirements will result in strict enforcement action under the Food Safety and Standards Act. The Food Safety department has urged all stakeholders to cooperate in maintaining safe storage practices to ensure the highest standards of consumer safety and public health.

DC Ganderbal Reviews Performances Of Banks At DLRC

GANDERBAL: A meeting of the District Level Review Committee (DLRC) and the District Consultative Committee (DCC) was held today in the Conference Hall, Mini Secretariat, Ganderbal.

The meeting, convened under the chairmanship of Deputy Commissioner (DC) Ganderbal, Jatin Kishore, was aimed at reviewing the performance of banks and line departments for

In the Micro, Small, and Medium Enterprises (MSME) sector, banks reported significant progress, having exceeded the targets set for the sector under the Annual Credit Plan. This achievement was hailed as a positive development for the local economy and employment generation in the district.

BJP Committed To Border Residents Welfare: Sunil Sharma

SRINAGAR: As many as 18 civilians lost their lives and around 2,000 structures, including homes and shops, were damaged in four days of indiscriminate shelling by the Pakistan Army along the borders in Jammu and Kashmir, the BIP said on Monday.

Leader of Opposition in the J&K Assembly, Sunil Sharma, who is also BJP's general secretary, shared these details after completing a 10-day tour of the affected border areas along with four MLAs on the directions of the party's central leadership. A detailed report with recommendations for rehabilitation has been submitted to the government.

"Pakistan resorted to cowardly shelling on civilian areas after our forces carried out Operation Sindoor on May 7 to dismantle terror infrastructure in response to the Pahal-



gam terror attack on April 22," Sharma told reporters at the party headquarters here.

He said 14 civilians were killed in Poonch, two in Rajouri, and one each in Uri (Baramulla) and Jammu during the shelling. Additionally, nearly 1,500 to 2,000 structures – mostly homes – were damaged, along with losses to livestock and agriculture.

Sharma said his team visited the affected areas including Hiranagar, Arnia, R S Pura, Akhnoor, Rajouri, Poonch, Uri, and Tangdhar. "Despite heavy losses, we found border residents proud of the Indian Army's response. They expressed confidence in the government's support," he said.

He added that the Union Home Ministry has started constructing more underground bunkers for the safety of residents, and the process for rehabilitation has begun. The Centre has also announced one government job for the next of kin of each person killed in the shelling, with files for these cases already forwarded to the General Administration Department.

Sharma said that while the State Disaster Response Fund (SDRF) allows for Rs 1.20 lakh compensation for damaged structures, the BJP has recommended a special financial package in its report to help affected families rebuild their lives.

"The BJP stands firmly with the border residents and will ensure they receive all necessary support," Sharma added.

Soaring Temperature

ammu and Kashmir is reeling under an intense heatwave, with temperatures soaring well above the seasonal average across the Valley. Srinagar has been sizzling at around 34°C — nearly 8 degrees higher than normal — while other towns like Qazigund, Kupwara, and Kokernag also faced sweltering conditions. Even the usually cool hill stations weren't spared: Pahalgam has hit 29°C and Gulmarg recorded an uncharacteristic 24.0°C, offering little relief to residents or tourists seeking a break from the heat.

Such unusually hot temperatures in May should be a source of concern for the Valley, as it should be anywhere else. It disrupts the weather pattern which, in turn, profoundly affects our lives. The soaring temperatures have also consequences for crops. It could lead to their premature ripening, disrupting their development cycle and adversely affecting both their quality and quantity. Apple growers are particularly concerned, as the excessive heat can hinder color and size development of the fruit, impacting the market value of their produce.

While the heatwave persists, there is little immediate relief in sight. The Meteorological Department has forecast severe heatwave for the next four days and from there is possibility of some rain.

That said, it hardly detracts from the concern about the creeping climate change. Though global in scale, it affects every region of the world. And as the continuing erratic weather in Kashmir in recent years reveals, the region is increasingly feeling the impact. According to reports and some surveys, many natural streams in various parts of the Valley have run dry in recent years. And the reason for this is the steady depletion of the glaciers. This has not only reduced the discharge in the rivers and streams but also made many water bodies extinct, affecting the irrigation in the Valley. However, such disturbing changes aren't specific to Kashmir only. This is becoming a worldwide phenomenon. There is thus an urgent need for the world to come together and take remedial measures to pre-empt the catastrophe. But it may take decades before the world is able to sufficiently reign in the factors which are contributing to the disruption in the climate. And the places like Kashmir which have little hand in climate change are bearing the brunt of it. As continuing heatwaves show, the world needs to quickly get its act together before it is too late - that is, if it hasn't already.

That simple idea is beginning to take root in places like Kashmir, where families once saw education as the only path to success. Now, many are realizing that knowing how to earn, save and invest is just as powerful as earning a degree.

In towns like Anantnag and Baramulla, teenagers are freelancing online, helping out in family shops, or running small ventures from home. They aren't just chasing income. They're learning discipline. They're saving for emergencies. Some are even helping their parents plan for the future.

One 17-year-old, who earns from tutoring, said he sets aside a third of his money each month. "My father told me to always save something," he said. "So I do. I don't know what it'll be for, but I'll be glad I did."

This silent change is reshaping how young people approach adulthood. They're starting to see money not as something abstract but as something to manage grow and understand

stract, but as something to manage, grow and understand.

And that's a big shift in a region where economic uncertainty often overshadows dreams.

Financial literacy isn't about teaching children to chase wealth. It's about helping them plan, prioritize and protect their futures. It's about building a mindset that values effort, responsibility and resilience.

Degrees matter. But they don't guarantee stability. A curious mind, an honest work ethic, and a small savings habit can carry a young person far, especially when the world around them is unpredictable.

The earlier they learn that, the better prepared they'll be.

very Kashmiri home once pulsed with life—a warm, welcoming mehfil where stories flowed, hearts opened, and bonds deepened.

Picture a winter night, the kangri glowing, elders sharing waez, kids wide-eyed at tales of Raja Rasalu, friends laughing over nun chai and salted bread.

These weren't just cozy get-togethers. They were lifelines—our therapy, our history class, our support system.

Today, those mehfils are dis-

appearing.
A combination of digital isolation, migration, instability, and shifting cultural values is steadily dissolving the communal fabric of Kashmiri society. In its place, we are witnessing a rise in individualism, loneliness, and emotional disconnect, especially among the youth.

The transformation is most visible in family settings. Ear-

As villages turn into towns, and towns into congested commercial zones, community interactions shrink. In city apartments, people barely know their neighbours. The culture of casual knock-and-enter visits, common in Kashmiri villages, has nearly vanished in urban neighbourhoods.

Young working professionals, especially in cities like Srinagar, report a lack of belonging. "I meet 100 people a day, but I feel I have no one to really talk to," shared a young entrepreneur.

The Global Balance Shifted After the Pahalgam Attack

omething changed after the Baisaran bloodbath. Not just the usual outrage or mourning. Something deeper.

The April 22 assault that killed 26 civilians in Kashmir didn't just spark another round of tension between India and Pakistan, it exposed the cracks in a decades-old global arrangement.

India didn't wait this time. It acted fast, yes, but more importantly, it acted differently.

Pulling out of the Indus Waters Treaty wasn't just about water, it was about leverage. That river system sustains millions in Pakistan. Taking control of it wasn't only a warning. It was a dessage: we're done playing by

the old rules.

The bigger message, though,

wasn't for Pakistan. It was for Washington.

The United States condemned the attack, as expected. It called for calm. But that was the problem. India didn't want balance, it wanted clarity.

When a country loses civilians to what it says is cross-border terrorism, it doesn't want "both sides" language. It wants the world to say what it sees. Instead, India got cautious statements, cold nudges, and

business-as-usual diplomacy.
It's not that the U.S. doesn't value India. It does. The defense deals, tech ties, and shared concerns about China show that. But America still has a foot in both camps.

Pakistan, for all its troubles, remains part of the U.S. security equation, especially in the post-Afghan-

istan chessboard. So, Washington hedges. It stays friendly with both, even when one side feels wronged. For India, that balancing act

is starting to wear thin. Especially when the costs of restraint are so high.

And so, India is doing what rising powers do: it's widening its circle.

Stronger defense deals with

France. More energy talks with the UAE. And warmer signals from Russia.

It's not abandonment of old particle of the Russian R

ners. It's diversification. Because in moments like this, dependence feels like a risk. Pakistan, meanwhile, is facing

Pakistan, meanwhile, is facing its own reckoning. Its appeals to the United Nations didn't gain traction. Its usual backers—China, Turkey—

stood by, but others stayed silent. Even Muslim-majority nations like Saudi Arabia called for calm instead of taking sides. That silence speaks volumes. Sympathy is thinning.

Water, airspace, cyberspace- each front has opened up in this conflict. But the real story isn't any single battle. It's the shifting landscape of alliances, of expectations, of what countries will do when pushed.

Pahalgam wasn't just a tragedy. It was a turning point. And now, everyone's watching what comes next. But no one's sure who they'll be standing with when it does.

The Scrub Pad King

Meet the man who turned scrap into scrubs, and unemployment into opportunity

Then Riyaz Ahmad Zargar talks about his childhood, he doesn't sugarcoat **V** it. "We had nothing," he says, sitting on a wooden bench outside his small factory in Budgam. "Not even the home we were born in. We lost that too."

He was still a teenager when his father died. A sudden heart attack, right after the small street-food business his father started collapsed under mounting debt. The man who had cooked his way through hard times, who believed a little bit of spice and sweat could build a life, was gone.

Riyaz didn't have time to cry. "There was no space for grief. My mother and sister were looking at me. I had to do something.

After trying to rebuild their lives in Anantnag, they returned to their hometown Rainawari's narrow lanes where his father once dreamed of a home.

But the house had already been sold to cover debts. All that remained was a battered suitcase and a prayer.

Some men stumble into business with capital and connections. Riyaz had neither. What he did have, he says, was "a mind full of worry, and hands ready to work."

So he worked as a salesman, as a delivery guy and as someone knocking on strangers' doors trying to sell things people didn't want. "One man slammed the door in my face. Another didn't even let me finish my sentence."

It was during one of those long, humiliating days that he noticed something strange. "Every shop had these plastic scrub pads for cleaning pots, windows, floors. Small things, but everyone used them."

He looked closer. They were cheap, they sold fast, and almost none of them were made locally.

"I thought, why not make these here?

What do I have to lose?" Turns out, he had a lot to lose: sleep, pride,

even what little money he scraped together. The early days were chaos. He experimented in his backyard, mixing materials, cutting up nets, failing again and again. But with each failure, he says, "I learned something new."

He kept reinvesting whatever he earned. "First month, I sold 20 pieces, then 100 and then 500. I was packing them myself, loading them onto my bike."



Eventually, he saved enough to rent a room in Babdem, Srinagar. That became his first

A second one came up in Budgam, where dozens now work to make the bright-coloured scrubbers that end up in homes, ho-

tels, hospitals, even army kitchens. Trucks carry them across India.

But ask him what he's most proud of, and he doesn't talk about turnover. He talks about

"I've hired men who used to beg. Wom-

en who lost their husbands. People no one would even look at twice."

Riyaz employs accountants, watchmen, factory workers, drivers, and more.

But the work begins even before the factory. His supply chain includes scrap collectors and garbage pickers, who bring in raw materials others throw away.

"They collect the waste plastic. We process it, clean it, and reuse it. So we're helping the environment too, in a way," he says. "But more than that, we're giving work to people who had none.

One of them, Altaf, says he's been with Riyaz for over five years. "He gave me work when my own family wouldn't. My kids go to

Inside the Budgam unit, you can smell melted plastic and hear the whirring of cutting machines. A man sorts sponges into baskets. A woman wraps them in paper sleeves. There's nothing flashy here. No logos on the walls, no startup jargon.

"Riyaz sahib just tells us to work honestly," says a supervisor. "He pays on time. That's

At home, things have changed too. He bought a house in Burzahama, a prominent, if not plush, neighbourhood north of Srinagar. It's not a mansion, but it's sturdy, warm, and full of light.

He made sure his sister had the wedding she once thought was impossible. He now has two kids of his own.

"Sometimes I sit in my garden and thinkhow did this happen?" he says. "Then I remember all those nights I didn't sleep. All the times I wanted to give up. But I didn't."

He says his biggest lesson isn't about business. "It's about faith. You have to believe in something. Yourself, your people, or just the idea that tomorrow can be better."

Riyaz never went to business school. He never had a mentor or investor. What he had was a reason to get up every morning. "I was scared of becoming nothing. I didn't want my father's death to be the end of our story."

And so he wrote a new one. Not in headlines, but in homes. In hands that now earn. In meals that now cook on stoves scrubbed clean by the very thing he built

When he's asked what's next, he shrugs. "Maybe a school. Or a bigger factory. But mostly, I just want to help more people. If I can help someone stand on their feet, that's more than enough."

hen Cruelty Goes Vira

A disturbing wave of voyeurism and sadism is sweeping through young digital lives, especially in Kashmir.

n a cold afternoon in 2023, two boys in Sopore's Zaloora village swung sticks at each other, their faces twisted with anger. Nearby, a third boy didn't step in to stop the fight. He recorded it.

The video went viral, amassing thousands of views. For him, the fight wasn't a problem to solve but content to share.

This disturbing moment reflects a growing trend: youth increasingly drawn to sadism and voyeurism, finding entertainment in others' suffering and private moments. Sadism-the enjoyment of causing suf-

fering-and voyeurism-the thrill of secretly watching others-have found unsettling new life in the digital age. Social media platforms amplify these impulses, turning realworld cruelty into shareable entertainment. In Kashmir, the problem feels especially

A 2019 study by the University of Kashmir found that 25.8% of students had been bullied, with 14% admitting they had bul-

lied others. Even more alarming, bullying came from multiple sources: 33% from teachers, 32% from seniors, and 47% from peers.

"Kids see violence normalized everywhere," said Aisha Malik, a school coun-selor in Srinagar. "They're not just copying what they see, they're filming it, sharing it,

The case of Sainik School Mansbal in 2024 brings this to light. A Class 11 student ended up in hospital after brutal ragging by seniors, requiring stitches. The school principal called it "a failure of oversight."

Despite a zero-tolerance policy by the School Education Department in April 2024, such incidents persist, often unreported. "Students fear retaliation," Malik explained. "And some think it's just normal."

So, what fuels this troubling pattern? Emotional neglect, experts opine, plays a major role. Many young people grow up in homes where open communication is rare. Lacking strong connections, they turn to the



internet, where algorithms feed them cha-

otic, sensational content.

"When you watch someone get humiliated online and laugh, it's not always cruelty," said Dr. Farooq Ahmad, a Srinagar psychologist. "Sometimes it's numbness. They're disconnected from real emotions." He sees many teens mistaking violent clips and humiliating pranks for entertainment.

The digital world doesn't merely reflect these impulses, it rewards them. Platforms prioritize engagement, and shocking content often wins.

In 2021, Kashmir Law College in Srinagar became a battleground when a ragging dispute escalated into a brawl, injuring several students. Videos of the clash spread online, racking up thousands of likes before re-

"The algorithm doesn't care about morality," said Bilal Khan, a local techie. "It just pushes what keeps people watching."

This craving for attention can be deadly. In Bijbehara, a teenager was arrested in 2024 after performing a risky stunt on railway tracks for social media fame. "He wanted to be famous," said a police officer. The boy was sent for counseling, but such

cases are common across Kashmir. From dangerous stunts to sharing fight videos, youth are risking their lives chasing a digital high. "It's like an addiction," Malik said. "But it's never enough."

The problem extends beyond physical violence. Online gambling and gaming are tied to similar voyeuristic and self-destructive patterns. In Srinagar, a 28-year-old lost 80 lakh

on the Teen Patti app, sinking into debt. In Kupwara, another man lost 28 lakh playing PUBG, reportedly considering selling a kidney to recover losses. "These aren't just games," Dr. Ahmad said. "They're emotional traps feeding the same impulses as watching someone suffer."

So, what can break this cycle? Parents and teachers must lead. "Kids mirror what they see at home," Malik said.

Disrespect or aggression in the household often spills into online behavior. Schools can help by teaching empathy and media literacy.

A 2023 pilot program at a Srinagar high school introduced classes on spotting harmful content, resulting in a 15% drop in bullying reports. "It's not perfect, but it's a start," said the school teacher.

Tech companies also have a crucial role. Algorithms could promote content that inspires kindness or curiosity instead of shock

"The digital space can be a tool for good," Khan said. "But it takes intention."

Some platforms have begun flagging harmful content, but enforcement remains inconsistent. Why the lack of urgency to

For now, Kashmir's youth-and young people worldwide-are caught in a vicious cycle. They seek connection and validation but find cruelty and chaos instead. "We need to teach them that real joy

comes from building something, not breaking someone," Dr. Ahmad said. Until that lesson takes hold, videos of

violence will keep spreading, likes will pile up, and the line between entertainment and harm will blur even further.


Scientists Develop Validate Scale To Measure Stigma In Patients With Sickle Cell Disease

esearchers in India have developed and validated a scale to measure stigma in a patient suffering from sickle cell disease and their caregivers.

Described in a paper in The Lancet Regional Health Southeast Asia journal, the 'ICMR-SCD Stigma Scale for India' or ISSSI is the first such tool in the country and fourth in the world, available in clinical and research settings.

India accounts for the second-highest prevalence of sickle cell disease in the world, following sub-Saharan Africa. The condition is a genetic disorder in which red blood cells are mis-shaped, affecting their ability to deliver oxygen.



The team, including researchers from the Indian Council for Medical Research (ICMR), said that despite the huge burden of sickle cell disease and associated stigma in India, not much research has been done, and no stigma measurement tool is available.

ISSSI characterises the nature of stigma under these categories -- perceived stigma, internalised stigma, experienced stigma and disclosure stigma.

The team's study developed and validated the ISSSI for patients and caregivers across six districts where sickle cell disease is endemic, including Alluri Seetharama Raju in Andhra Pradesh and Anuppur in Madhya Pradesh.

Findings highlight ISSSI's psychometric robustness and utility in clinical and research settings, the researchers said.

"The ISSSI (captures) multidimensional aspects of stigma, including familial and reproductive, social disclosure, illness burden, interpersonal, and healthcare interaction challenges," the authors wrote.

Future studies should apply the ISSSI scale across diverse cultural and linguistic contexts to improve its generalisability and impact, they said.

People with sickle cell disease often suffer from episodes of severe pain, chronic fatigue, swelling, infections, and potential organ damage, significantly impacting their quality of life.

'Health Isn't Shaped By Genes Alone - It's In The Air And All Around Us'

India stands at the cusp of becoming a global leader in exposomics research, with the potential to reshape its understanding and prevent the disease, said Dr Kalpana Balakrishnan, Dean of Sri Ramachandra Institute of Higher Education and Research.

Balakrishnan, who was part of a recent forum on exposomics organised by the Johns Hopkins University in Washington DC, told PTI that India's unique blend of traditional and modern health risks makes it "a natural laboratory" for exposome science.

The term "exposome" was coined by Dr Christopher Wild in 2005. It refers to the totality of environmental exposures that individuals experience throughout their lives, from conception to death.

Unlike a genome, which is inherited and fixed, the exposome is dynamic, ever-shifting and deeply intertwined with health outcomes.

Noting that genes and genetic susceptibility alone cannot explain why people develop a chronic disease, Balakrishnan said, "Someone may not have the genetic markers for heart disease or diabetes, but still end up with them because of multiple environmental exposures experienced over a life course. That's the exposome."

While the Human Genome Project advanced genetic science within a decade, diseases affecting the cardiovascular system, endocrine disorders and mental health issues remain poorly understood through genetics alone, she explained, emphasising the need for cutting-edge tools that can capture exposures from chemical, physical, biological and psychosocial hazards and their interactions with lifestyles or living conditions.

When asked about what kind of tools and technologies are needed for exposome mapping, Balakrishnan told PTI that High Resolution Mass Spectrometry (HRMS) that can simultaneously screen thousands of chemical compounds in air, water, soil and food is one of the key technologies

you expect – A, B, and C. You do untargeted analysis to discover D, E, F and beyond. Otherwise, you stay blind to the unknowns," she said.

For biological responses, Next Generation Sequencing (NGS) and a suite of omics platforms, including metabolomics, proteomics, and genomics, are vital.

"These help us understand how internal systems react to exposures," Balakrishnan said, noting that samples from blood, urine and other tissues provide critical biological signatures.

However, exposomics isn't confined to the laboratory. It now includes satellite-generated data for physical exposures like air pollution, urban heat islands, vegetation cover, and land-use changes.

"We can map environmental factors at high spatial resolution for entire populations," she said, adding that this is especially critical for a country like India, where environmental risks vary drastically by region and socioeconomic status.

Highlighting the complexity of exposomic data, Balakrishnan, who is also the director at World Health Organisation (WHO) Collaborating Centre for Occupational Environmental Health, mentioned that mapping it requires deep learning and AI-powered pattern recognition beyond basic statistical methods.

"These computational tools are crucial. We need them to make sense of massive, layered datasets across environmental samples, biological responses, and population demographics," Balakrishnan told PTI.

She further referred to the successful models in the North American and European exposome consortia, where patterns between pollution, green spaces, and genetic variants are predicting risks for diseas-

es like diabetes and cardiovascular conditions. "Imagine if we could replicate and scale that here in India,"

she said.

India's opportunity lies in its landscape, which includes traditional public health challenges like poor sanitation and lack of clean water. These challenges exist alongside modern hazards like ultra-processed food, air pollution and psychosocial stress.

"We're seeing exposure overload from both ends," Balakrishnan said. "That's why we need a holistic, integrative framework in the numerous ongoing cohorts in the country, and exposomics can give us that," she added.

Stressing that India cannot rely on siloed scientific approaches, she further stated that it is not just the job of medical scientists.

"We need engineers, economists, social scientists, and urban planners in the room – to-

gether with policymakers from the start," she emphasised.

Adding an international perspective, Dr Rima Habre, associate professor of environmental health and spatial sciences at the University of Southern California and co-director of the NIH-funded NEXUS Center for Exposome Research Coordination, said India holds immense potential for global collaborations in exposomics.

Speaking to PTI, Habre said, "I connected with Dr Balakrishnan around exposomics at a recent visit to Ahmedabad, India, where we were both invited speakers at an ICMR-NIOH conference.

"I presented our vision in the NEXUS Center, which I co-lead with Dr. Gary Miller and Dr. Chirag Patel, to link US-based and international researchers and infrastructure for a truly global exposome initiative."

She added that India's diversity of environmental and social stressors, shaped by unique regional policies and cultural practices, offers unparalleled insight into the totality of health-relevant exposures.

"Dr Balakrishnan's work in establishing large, population-based cohorts in India is foun-dational for exposomics," Habre said, calling for a globally connected but locally governed framework to reduce the environmental burden of disease.

Poornima Prabhakaran, Director of the Centre for Health Analytics Research and Trends (CHART), Ashoka University, echoed the sentiments.

India's longitudinal research infrastructure provides a fertile ground to pioneer large-scale exposomics studies tailored to developing country contexts, she told PTI.

"As a global effort to scale exposomics gathers momentum, we must account for a multitude of diverse exposures across geographies and populations spanning biomarkers, environmental risk factors and 'omics'," she said.

This is in light of the recent Exposome Moonshot Forum hosted in Washington DC where there is already an effort across EU (EIRENE) and now US (NEX-US) and IREN to initiate this effort globally, Prabhakaran said.

Secretary in Industries & Commerce, who also holds the charge of Director JKEDI, gave a comprehensive presentation highlighting key developments under the J&K Startup Policy 2024-27, including startup registrations, workshops conducted, awareness initiatives and startups shortlisted for seed funding.

The Dy CM was also apprised of various Memorandums of Understanding (MoUs) signed by JKEDI, as a nodal agency for implementation of J&K Startup Policy, with national and statelevel institutions aimed at fostering mentorship and knowledge exchange.

Speaking on the occasion, the Deputy Chief Minister directed the officials to initiate collaborations with reputed national and international institutions to mentor and accelerate startups in J&K.

India Surpasses Japan To Become 4th Largest Economy At \$4 Trillion, Says Niti Aayog CEO

NEW DELHI- India has become the fourth largest economy in the world, overtaking Japan, NITI Aayog CEO BVR Subrahmanyam has said.

Subrahmanyam said the overall geopolitical and economic environment is favourable to India. "We are the fourth largest economy as I speak. We are a USD 4 trillion economy as I speak," he said.

Citing IMF data, Subrahmanyam said India today is larger than Japan. Till 2024, India was the fifth-largest economy in the world.

"It is only the US, China and Germany which are larger than India, and if we stick to what is being planned and what is being thought through, in 2.5-3 years, we will be the third largest economy," Subrahmanyam said.

The International Monetary Fund (IMF), in its World Economic Outlook (WEO) report released in April had said that India is expected to be the fourth largest economy in the world with a GDP of USD 4.19 trillion in 2025, ahead of Japan.

India's nominal GDP for 2025 (FY26) is expected to be USD 4.187 billion marginally more than the likely GDP of Japan which is estimated at USD 4.187 billion, the IMF had said.



According to IMF data, India's per capita income has doubled from USD 1,438 in 2013-14 to USD 2,880 in 2025.

The IMF in its WEO report also said the Indian economy is projected to grow at 6.2 per cent in 2025-26, slower than earlier estimated rate of 6.5 per cent, due to escalated trade tensions and global uncertainty.

"For India, the growth outlook is relatively more stable at 6.2 per cent in 2025, supported by private consumption, particularly in rural areas," the IMF had said.

According to the report, the global growth is projected at 2.8 per cent in 2025, lower by 0.5 percentage points estimated earlier. In 2026, the global economy is estimated

to grow at 3 per cent.



Sensex Rises 455 Pts To End At Over Week's High On Early **Monsoon, Easing Trade Worries**

MUMBAI- Benchmark Sensex on Monday advanced by 455 points to close at over a week's high due to buying in auto and IT shares following positive macro factors and easing trade worries as US President Donald Trump delayed 50 per cent EU tariffs to July 9.

Rising for the second session, the 30-share BSE Sensex jumped 455.37 points or 0.56 per cent to settle at 82,176.45. During the day, it surged 771.16 points or 0.94 per cent to 82,492.24. The NSE Nifty climbed 148 points or 0.60 per cent to settle at 25,001.15, a level not seen since May 16.

The early arrival of monsoon and the Reserve Bank announcing a record Rs 2.69 lakh crore dividend to the government for FY25 also added to the optimistic trend in the markets, experts said.

Among Sensex stocks, leading tractor and auto manufacturer Mahindra & Mahindra rose the most by 2.17 per cent. HCL Tech, Tata Motors, Nestle, ITC, Hindustan Unilever, Larsen & Toubro, and Tech Mahindra were the major gainers. In contrast, Eternal, UltraTech Cement, Power Grid, Tata Steel and Kotak Mahindra Bank were among the laggards. Eternal dropped the most by 4.51 per cent.

NITI Report Suggests Adoption Of Turkiye's Program To Address Skill Gaps In India

NEW DELHI- A NITI Aayog report on Monday mentioned Turkiye as one of the nations from which India can adopt global best practices for addressing skill gaps in the country's medium enterprises.

The report titled 'Designing a Policy for Medium Entern listed programmes of Turkiye in addition to Canada, Singapore and Australia for encouraging medium enterprises.

The report said Turkiye's "KOSGEB provides distance training on entrepreneurship; an effective, easy and flexible entrepreneurship training without time and space constraints by E- Akademi Programme ... Entrepreneurship Support Programme, preferential treatment for women, youth and handicapped entrepreneurs."

Also, observing that Turkey's e-Academy is an online training platform providing subsidised courses, enhancing accessibility for SMEs across regions, the report said, "online training programs can be offered at a subsidized rate,



and free of cost for marginalized groups (as provided in Turkey's e-Academy)."

Turkiye is facing backlash in India for its support to Pakistan during Operation Sindoor, which was launched by the country to destroy terror infrastructure following the Pahalgam terror attack, in which 26 people including tourists, were killed.

India's aviation security regulator BCAS earlier this month revoked the security clearance of Turkish firm Celebi Airport Services India on grounds related to national security with immediate effect.

The NITI report said for medium enterprises to succeed in a globalized market, there is a clear need for a tailored, datadriven approach to skill development that can align with industry needs and ensure a competitive, skilled workforce.

To address challenges faced by medium enterprises, it recommended the introduction of a working capital financing scheme linked to enterprise turnover, a Rs 5 crore credit card facility at market rates and expedited fund disbursa mechanisms through retail banks, overseen by the Ministry of MSME.

The report also suggested the upgradation of existing technology centres into sector-specific and regionally customised India SME 4.0 Competence Centers to promote the adoption of Industry 4.0 solutions.

The Aayog also recommended the establishment of a dedicated R&D cell within the Ministry of MSME, leveraging the Self-Reliant India Fund for cluster-based projects of national significance.

The MSME sector contributes approximately 29 per cent to India's GDP, accounts for 40 per cent of exports, and employs over 60 per cent of the workforce.

'US Officials Likely To Visit **India For Next Round Of Talks On Interim Trade Pact'**

NEW DELHI- A team of US officials is expected to visit India in the coming weeks for the next round of discussions on the proposed interim trade agreement between the two countries, sources said.

The visit gains importance as India and the US are likely to agree on an interim trade agreement before July 9, with New Delhi pushing for full exemption from the 26 per cent reciprocal tariff on domestic goods.
"The US team is expected

in India for trade talks. Negotiations are moving at a faster pace," one of the sources said.

India's chief negotiator, Special Secretary in the Department of Commerce Rajesh Agrawal, concluded his fourday visit to Washington last week. He held talks with his US counterpart on the proposed agreement.

Commerce and Industry Minister Piyush Goyal was also in Washington last week to give an impetus to trade talks. He met with US Commerce Secretary Howard Lutnick twice during his visit.

The US on April 2 imposed an additional 26 per cent reciprocal tariff on Indian goods but suspended it for 90 days till July 9, later. However, Indian goods still attract the 10 per cent baseline tariff imposed by

At present, the Trump administration requires approval from the US Congress to bring tariffs below the MFN (most



administration has the authority to remove the reciprocal tariffs imposed on a number of countries, including India.

Both countries have fixed a deadline to conclude the first phase of the proposed bilateral trade agreement pact by the fall (September-October) of this year. According to sources, there is a possibility that both sides agree on an interim trade deal before the first tranche.

The US remained India's largest trading partner for the fourth consecutive year in 2024-25, with bilateral trade valued at USD 131.84 billion. The US accounts for about 18 per cent of India's total goods exports, 6.22 per cent in imports, and 10.73 per cent in the country's total merchandise trade.

With America, India had a trade surplus (the difference between imports and exports) of USD 41.18 billion in goods in 2024-25. It was USD 35.32 billion in 2023-24, USD 27.7 billion in 2022-23, USD 32.85 billion in 2021-22 and USD 22.73 billion in 2020-21. The US has raised concerns over this widening trade deficit.

Rakesh Gangwal, Family Trust Likely To Sell 3.4% Stake In IndiGo For Rs 6,831 Cr

NEW DELHI - InterGlobe Aviation promoter Rakesh Gangwal and his family trust are likely to offload up to 3.4 per cent stake worth at least Rs 6,831 crore in the airline on Tuesday, according to sources.

Gangwal, the co-founder of IndiGo, has been offloading his holding in a phased manner following a bitter fallout with co-founder Rahul Bhatia.

Apart from Gangwal, the Chinkerpoo Family Trust, whose trustees are Shobha Gangwal and JP Morgan Trust Company of Delaware, will be divesting 3.4 per cent stake in IndiGo, the country's largest airline, the sources said.

Investment banking firms Goldman Sachs (India) Securities Pvt Ltd, Morgan Stanley India Company and J P Morgan India are the placement agents for the stake sale, they added. Currently, Gangwal and

the family trust together hold about 13.5 per cent in IndiGo.

Under the proposed transaction, to be executed on May 27, up to 1.32 crore equity shares will be sold at a floor price of Rs 5,175 per share, as per the term sheet accessed by PTI.

The floor price is at a 4.5 per cent discount compared to the closing price of Rs 5,420 per share on Monday.

The sources said 1.32 crore shares will amount to around

3.4 per cent stake in the company and the offer size, based on the floor price, is pegged at around USD 803 million or about Rs 6,831 crore.

The proposed share sale, to be done in multiple tranches on BSE and NSE, will be entirely secondary in nature and will not have any fresh issuance of

As part of the deal structure, a 150-day lock-up period will apply to the vendors and their immediate relatives, barring one exception -- they may transfer shares worth at least USD 300 million to a single investor or investor group through a negotiated transaction, subject to certain pricing and lock-up conditions.

In August 2024, Rakesh Gangwal's family trust sold a 5.24 per cent stake in the airline for Rs 9,549 crore. Before that, Gangwal had sold shares of IndiGo in March.

The share sale is part of Gangwal's decision in February 2022 to trim his shareholding after a bitter feud with co-founder Rahul Bhatia over alleged corporate governance

Trump's Tariffs Launched Global Trade Wars, A Timeline Of How We Got Here

NEW YORK- Volley after volley of new tariffs from US President Donald Trump have plunged the country into trade wars abroad, creating uncertainty for busi-

nesses and households. Trump is no stranger to tariffs. He launched a trade war during his first term as well, taking particular aim at China by putting taxes on most of its goods. At the time, Beijing responded with its own retaliatory tariffs on a range of US products. And Trump also used the threat of more tariffs to force Canada and Mexico to renegotiate a North American trade

Fast-forward to today, and economists stress there are greater consequences on businesses and economies worldwide under Trump's more sweeping tariffs this time around — and that higher prices leave consum-

ers footing the bill. There's also been a sense of whiplash from Trump's backand-forth tariff threats and responding retaliation seen over the last few months.

Here's a timeline of how we got


JANUARY 20

Trump is sworn into office. In his inaugural address, he again promises to "tariff and tax foreign countries to enrich our citizens." And he reiterates plans to create an agency called the External Revenue Service, which has yet to be established.

On his first day in office, Trump also says he expects to put 25 per cent tariffs on Canada and Mexico starting on February I, while declining to immediately flesh out plans for taxing Chinese

JANUARY 26

Trump threatens 25 per cent tariffs on all Colombia imports and other retaliatory measures after President Gustavo Petro's rejects two US military aircraft carrying migrants to the country,



deportation.

In response, Petro also announces a retaliatory 25 per cent increase in Colombian tariffs on US goods. But Colombia later reversed its decision and accepted the flights carrying migrants. The two countries soon signalled a halt in the trade dispute. **FEBRUARY 1**

Trump signs an executive order to impose tariffs on imports from Mexico, Canada and China

 10 per cent on all imports from China and 25 per cent on imports from Mexico and Canada starting February 4. Trump invoked this power by declaring a national emergency – ostensibly over undocumented immigration and drug trafficking. The action prompts swift outrage from all three countries, with promises of retaliatory measures. **FEBRUARY 3**

Trump agrees to a 30-day pause on his tariff threats against Mexico and Canada, as both trading partners take steps to appease Trump's concerns about border security and drug trafficking. **FEBRUARY 4**

Trump's new 10 per cent tariffs on all Chinese imports to the US still go into effect. China retaliates the same day by announcing a flurry of countermeasures, including new duties on a variety of American goods and an anti-monopoly investigation into Google.

China's 15 per cent tariffs on coal and liquefied natural gas products, and a 10 per cent levy on crude oil, agricultural machinery and large-engine cars imported from the US, take effect February 10. **FEBRUARY 10**

Trump announces plans to hike steel and aluminum tariffs starting March 12. He removes the exemptions from his 2018 tariffs on steel, meaning that all steel imports will be taxed at a minimum of 25 per cent, and also raises his 2018 aluminum tariffs from 10 per cent to 25 per cent.

FEBRUARY 13

Trump announces a plan for "reciprocal" tariffs - promising to increase US tariffs to match the tax rates that countries worldwide charge on imports "for purposes of fairness." MARCH 4

Trump's 25 per cent tariffs on imports from Canada and Mexico go into effect, though he limits the levy to 10 per cent on Canadian energy. He also doubles the tariff on all Chinese imports to 20 per cent.

All three countries promise retaliatory measures. Canadian Prime Minister Justin Trudeau announces tariffs on more than USD 100 billion of American goods over the course of 21 days. And Mexican President Claudia Sheinbaum says her country would respond with its own retaliatory tariffs on US goods without specifying the targeted products immediately, signalling hopes to de-escalate.

China, meanwhile, imposes tariffs of up to 15 per cent on a

wide array of key US farm exports, set to take effect March 10. It also expands the number of US companies subject to export controls and other restrictions by about two dozen. MARCH 5 Trump grants a one-month

exemption on his new tariffs impacting goods from Mexico and Canada for US automakers. The pause arrives after the president spoke with leaders of the "Big 3" automakers — Ford, General Motors and Stellantis.

In a wider extension, Trump postpones 25 per cent tariffs on many imports from Mexico and some imports from Canada for a month. MARCH 10

China's retaliatory 15 per cent tariffs on key American farm products - including chicken, pork, soybeans and beef — take effect. Goods already in transit are set to be exempt through April 12, per China's Commerce Ministry previous announcement.

Trump honours fallen soldiers at Arlington, calling them 'America's best and bravest'

Arlington, May 26: President Donald Trump paid tribute to fallen service members during a Memorial Day ceremony at Arlington National Cemetery on Monday, in an address that honoured the "great, great warriors" yet also briefly veered into politics as he boasted of a nation he is "fixing after a long and hard four years.'

Though the holiday is one that US presidents typically treat with pure solemnity, Trump began it with an all-caps Memorial Day social media post that attacked his predecessor and called federal judges who have blocked his deportation initiatives "monsters who want our country to go to hell."

Yet at Arlington National Cemetery, where more than 400,000 have been laid to rest, Trump commemorated the sacrifice of US service members and singled out several Gold Star families to tell the stories of their fallen relatives.

"We just revere their incredible legacy," Trump said. "We salute them in their eternal and everlasting glory. And we continue our relentless pursuit of America's destiny as we make our nation stronger, prouder, freer and greater than ever before."

"Their valour," he said, "gave us the freest, greatest and most noble republic ever to exist on the face of the earth. A republic that I am fixing after a long and hard four years.'

During his remarks, Trump told the story of Navy Senior Chief Petty Officer Shannon Kent, killed along with three other Americans by a suicide bomber in 2019 in Syria, leaving behind her husband, 3-year-old son and 18-month-old son.

The Pine Plains, New York, native was on her fifth combat deployment, he said, embedded with a team hunting Islamic State group militants in Syria, serving as linguist, translator and cryptologic technician working alongside special forces.

"She was among the first women ever to do it, and she did it better than anyone," Trump said, calling out Kent's family for applause at the ceremony.

The crowd also heard of Air Force Senior Master Sgt. Elroy Harworth from Erhard, Minnesota, whose plane went down in enemy territory during the Vietnam War, dying while

his wife was seven months pregnant. His son, who was cheered in the audience, followed his father's path and has been in the Army for 20 years.

There was also the story of Army Cpl. Ryan McGhee of Fredericksburg, Virginia, who enlisted after the September 11, 2001, attacks and whose mother was in the audience.

Trump said McGhee knew he wanted to be an Army Ranger since he saw the towers fall on that day, did three tours in Afghanistan, then deployed to Iraq. Sixteen years ago this month, the president said, McGhee died in a firefight, and "gave his life at 21 years old."

Vice President JD Vance, who spoke before Trump, said the lesson of all the gravestones is: "We must be cautious in sending our people to war." He urged the crowd to push political leaders to treat the lives of soldiers

as the "most precious resource." Later in his remarks, Trump pointed to a "big, big celebration" coming next year as the US celebrates its 250th birthday, joking that "in some ways, I'm glad I missed that second term' when he lost to Joe Biden.

"Because I wouldn't be

as the crowd laughed. "In addition, we have the World Cup and we have the Olympics. Can you imagine? I missed that four years. And now look what I have, I have everything. Amazing the way things work out."

Prior to speaking, Trump placed a wreath at the Tomb of the Unknown Soldier, a sombre tradition for US presidents. The president paused after placing the wreath, then stepped back and saluted during the playing of taps. Vance and Defense Secretary Pete Hegseth joined

The PM unveiled the country's first 9,000 horsepower locomotive engine as well as a rolling stock workshop built at a cost of Rs 21,405 crore.

He flagged off the Ahmedabad-Veraval Vande Bharat service and Valsad-Dahod express train and told the gathering that state-of-the-art Vande Bharat trains were now operational on 70 routes across the country.

"There was a time when India had to import locomotives and coaches. Today, we manufacture them in India and export them to other countries," the PM said.

The Vande Bharat service launched during the day between Sabarmati station in Ahmedabad and Veraval station will be a boon for devotees visiting the renowned Somnath Temple in Gir Somnath district.

He also announced that 100 per cent electrification of railway lines has been achieved in

'Pakistan Considers Terrorism As Tourism' Prime Minister Narendra Modi on Monda asked the people of Pakistan to raise their voices against terrorism, asserting while India believes in tourism, "Pakistan considers terrorism as tourism," a mindset he warned was not only ruining their nation, but also posing a grave danger to the world.

Speaking at a rally in Bhuj, Gujarat, on his first visit to the state since Operation Sindoor, India's military response to the April 22 Pahalgam terror attack, in which tourists were targeted, Modi warned that if Pakistan's citizens do not choose peace, they would face the wrath of the Indian Army.

"Those who promoted terrorism ruined your future," Modi said to the gathering in Bhuj, a town in Kutch district that shares both land and maritime borders with Pakistan, in a message directed at the citizens of the neighbouring country.

"While India believes in tourism, Pakistan considers terrorism as tourism, which is very dangerous for the world," he said while addressing the public after launching projects worth over Rs 50,000 crore.

"Terrorism is a way of making money for your (Pakistan) government and Army. The people of Pakistan must come forward to end terrorism. Live a happy and peaceful life and have your meal. Otherwise, my bullet is there for you (sukh chain ki zindagi jio, roti khao. Varna meri goli to hai hee)," the Prime Minister asserted in the direct message to those across the border.

The Prime Minister, who completed 11 years in office on Monday, highlighted India's rise to become the world's fourth-largest economy, surpassing Japan, and challenged Pakistani citizens to reflect on their own nation's standing.

"I want to ask the people of Pakistan -- what have they achieved? Today, India is the 4th largest economy in the world. But what is your situation? Those who promoted terrorism ruined your future," he said.

He recounted the aftermath of the Pahalgam massacre, stating "Post-Pahalgam attack, waited for 15 days hoping Pakistan will take action on terrorism, but it seems it is their bread and butter. On the night of May 9 when Pakistan tried to attack civilians, our military attacked with double force and decimated their air bases.'

central government had launched the postmatric scholarship scheme for ST candidates to help them complete their education by providing financial assistance in the form of a scholarship amounting to Rs 18,000 per student plus Rs 2,300 as maintenance allowance, the spokesperson said.

The objective of the scheme was to provide financial support to tribal students studying at the post-matriculation or post-secondary stage to enable them to complete their education, along with reimbursement of compulsory fees charged by recognized institutes.

"The private institutes situated in Jammu district managed to obtain documents of ST students and submitted them to the directorate of tribal affairs.

"But the officers and officials, without verifying the genuineness of the institutes. their infrastructure and the course content, disbursed scholarship amounts worth crores between 2014 and 2018 directly into the bank accounts of these institutes," the spokesperson alleged.

ACB's verification further revealed that the students against whom payments were released had neither sought admission nor attended the free computer courses.

"Some of the students, though they sought admission under the said scheme, never attended or only partially attended the computer courses. However, the benefit, in the form of full tuition fees, was credited to the accounts of different computer institutions," he alleged.

The investigation also pointed out that one of the institutes, in order to increase its strength, managed to obtain documents of ST students from remote areas and filled scholarship forms in their names.

"Moreover, some fake bank accounts were opened in the names of ST students without their consent or knowledge, as it was

mandatory to include account numbers in the forms for crediting maintenance allowance directly into the students' accounts," the spokesperson claimed

The officers and officials, by sheer abuse of their official positions and in criminal conspiracy with the owners of the institutes through manipulation of records and violation of scheme guidelines, misappropriated huge amounts of government funds during the years 2014 to 2018, causing massive loss to the public exchequer, he alleged.

Further investigation in the case is underway, the spokesperson said.

"What we now require is targeted districtlevel planning — identifying where the potential lies and where gaps need to be filled. These short-term objectives will cumulatively guide us toward our long-term goal of Viksit Jammu & Kashmir by 2047," he said.

On the occasion, the Chief Minister also released a series of key reports, including the District Domestic Product J&K Report 2022–23, District Good Governance Index 4.0 J&K Report 2023–24, J&K Sustainable Progress Report 2022–23, and the District Progress Report 2022-23.

He cautioned against focusing solely on the distant 2047 horizon, emphasizing the need to set medium- and short-term benchmarks that allow for real-time performance tracking and corrective action.

The Chief Minister welcomed the data presented during the meeting, especially insights from Mission Yuva, and called for its integration into sectoral planning across departments.

Referring to Mission Yuva and the DGGI reports, the Chief Minister stressed the importance of using this data constructively. "These findings must improve our planning and programmes. I urge all line departments and district administrations to reorient their schemes in a manner that addresses the issues highlighted by both data sets," he said.

He said that the District Good Governance Index should not be perceived as a ranking of 'good versus bad' governance, but as a barometer of 'good to better' governance. "Districts that have shown strong performance must continue to lead by example, while those that lag must be supported to identify structural gaps and implement reforms. Any such systemic constraints should be immediately brought to the Secretariat's attention for resolution." he added.

Touching upon Jammu & Kashmir's performance in national rankings, the Chief Minister shared a balanced view. "While we are currently ranked second among Union Territories, that comparison is limited given the nature of UTs. What is more important — and encouraging — is our 10th place rank nationally. That shows we're holding our ground, but we must do better," he remarked.

Chief Minister Omar Abdullah expressed gratitude to NITI Aayog and UNDP for their sustained technical support. "We request our partners at NITI Aayog to actively share best practices from across India that are replicable in Jammu & Kashmir. We don't need to reinvent the wheel. If something works well in another state, let us adapt it here. Likewise, if we are doing something commendable, let that be shared nationally for wider benefit."

Chief Minister Omar Abdullah emphasized also the need to preserve the current templates for performance measurement. "Once we have established a template, we must not tinker with it. Changing the goalposts — be it benchmarks, data methodology – which otherwise renders year-on-year comparisons meaningless. Let us retain these standards for continuity, transparency, and accountability in governance," he said.

The Chief Minister reiterated the importance of focused and data-backed governance.

"Let us approach our goals step by step start with targeted short-term interventions at the district level, scale up to territory-wide strategies, and ultimately work towards the overarching vision of Viksit Jammu & Kashmir 2047." he added.

offence serves as the foundation for commencing action under the PMLA, where as the offence of money laundering under Section 3 of the Act is a distinct and ongoing offence that must be evaluated independently." Consequently, the court said, the discharge in the predicate offence may influence the procedures under the PMLA; however, it cannot be regarded as an automatic or definitive basis for

nullifying the ECIR. Referring to the Enforcement Directorate's authority to summon individuals under Section 50, the court said that it is intended for the acquisition of factual evidence pertaining to money laundering offences. "Obtaining a summons under this section does not inherently indicate that one is an accused in a money laundering investigation. This indicates that the individual may have information or docu-

ments pertinent to the investigation. The court said that Kansal's discharge does not constitute a legitimate ground for nullifying the summons. "The authorities may execute the summons issued pursuant to the applicable legislative laws and procedural regulations.'

The issuance of summons is a fundamental component in the execution of a fair and unbiased investigation.

"It affords the relevant parties an opportunity to be heard, to articulate their case, and to address the allegations levied against them. These procedural safeguards are crucial for preserving the integrity of the investigative and adjudicatory processes established by the Act," the court said. The aim is to guarantee the presence of individuals or companies for scrutiny while ensuring the process is transparent, equitable, and lawful. "The summons mechanism compels individuals to come before authorities, so ensuring the accurate collecting of evidence, assisting in the revelation of truth, and ultimately preserving the effectiveness

and integrity of the judicial process". Consequently, the issuance of summons under the PMLA should be regarded as an essential element of due process, intended to advance the rule of law and bolster public trust in the legal system, the court said. "The discharge in the predicate offence, albeit substantial, does not, as a legal principle, impact the ongoing validity of the summons."

The Saudi Federation ruled in favor of Al-Nassr in a decision that also ensures Al-Orubah will be relegated.

Gavi, Isco Back In Spain Squad For Nations League Semi Against France

Midfielders Gavi and Isco were recalled by Spain manager Luis de la Fuente on Monday in his squad for next month's Nations League semi-final

Barcelona's Gavi, 20, last played for Spain in November 2023 before being sidelined for several months after tearing his knee ligaments.

Gavi, capped 27 times by Spain, has made 42 appearances for Barcelona this season, winning LaLiga, the Copa del Rey and Supercup with the Catalan club. Isco returned to the Spain squad after a six-year

absence. The 33-year-old former Real Madrid player has been rewarded for a fine season with Real Betis in which he scored 12 goals and provided 10 assists in 32 appear-

ances and helped them reach Wednesday's Conference Spain play France on June 5 in the German city of Stuttgart.

Alonso Takes Over As Real Madrid Coach, Vows To Follow In Ancelotti's Footsteps

MADRID: Xabi Alonso officially took over Real Madrid's coaching job on Monday, vowing to follow in the footsteps of Carlo Ancelotti and saying he has "a good feeling" about the team's future under his command.

Madrid announced the hiring of Alonso on Sunday, a day after the club paid tribute to Ancelotti at the team's final Spanish league match of the season at the Santiago Bernabeu Stadium. Ancelotti is taking over the Brazil job after four mostly successful seasons in his second stint with the club.

"I'm here to take over from Carlo Ancelotti, who was my coach and is a great person," Alonso said. "He is a coach who left his mark



ence. Without his guidance, I probably wouldn't be here. I'll pick up his legacy with pride and honor of now being in the position that Carlo was before, and I hope to live up to the expectations and lead this club to achieve

all of its objectives.' Alonso said it felt good returning home to Madrid, player from 2009-2014.

"Without a doubt this is a very special day for me," Alonso said. "I'm very happy to be at a place where I feel is my home. I may have been a few years away, but the link with Real Madrid and Madrid fans has always existed."

The ceremony to introduce Alonso began with

the showing of a video with some of Alonso's highlights as a player for Madrid, Spain and other clubs where he played as a midfielder. There were also highlights of his stints as a coach at Madrid's youth squads, Real Sociedad's 'B" team and with Bayer Leverkusen, which he left after this season. The 43-yearold Alonso, who arrives on a contract until June 2028, watched the video alongside his wife and other invitees.

"Today is a very special day for all of us, it's the start of a new phase," Madrid president Florentino Pérez said. "Because we have a new coach who already is one of the best in the world and who represents the values of Real Madrid because he knows exactly what this shield and this shirt means."

Mohamed Salah: Talks With Saudi League Officials Were Serious

Salah has been voted Football Writers' Association men's player of the year for the third time and gave an interview with On Sport Egyptian TV channel after the ceremony, which was aired on Sunday.

new generation of workforce the Gen Z -- those under the age of 35 -- is rewriting the rules of career growth, as they are stepping away from conventional education pathways, questioning linear career growth, and disengaging from rigid corporate cultures, a senior executive of a digital recruitment platform

India is home to the world's largest youth workforce. And within that, Gen Z is rapidly emerging as a force of its own, they are expected to comprise

27 per cent of India's workforce by 2025.

"We are witnessing a profound generational shift in the workplace, one that challenges not just how we recruit, but why we exist as employers. India is at the heart of this change," said Devashish Sharma, Founding Member and CEO Taggd, a digital recruitment platform.

Gen Z is giving more importance to purpose than perks, and a non-linear growth in career over guarantees.

"They want to work for companies that stand for what's important. Whether it's sustainability, ethics, diversity or



equality," Sharma said, adding that 80 per cent of Gen Z professionals choose mentorship

and advancement over a bigger paycheck.

For Gen Z, flexibility is a

non-negotiable standard. The 9-to-5 model doesn't resonate for them. Gen Z values independence in how they work. They prefer flexible schedules, asynchronous collaboration, and environments that reward outcomes over hours.

"In order to cater to this culture, the companies are responding with hybrid structures, result-driven roles, and internal gig economies," Sharma said.

Since the Gen Z workforce is resetting the manner in which past generations have worked, organisations need to evolve in order to remain relevant. "To achieve this, top-down manage-

ment must give way to participative leadership, policy-heavy cultures must be replaced with people-first ecosystems, and, most importantly, trust must be gained via action," he said.

According to Taggd India Decoding Jobs Report 2025, there is a 35 per cent rise in skill-based hiring, as companies prioritise adaptability, problem-solving, and role-specific competencies over degrees. This change is indispensable for building a workforce ready for cross-functional roles that define the hybrid

The methods of hiring must evolve to cater to the needs of

ever-evolving industries. Taggd IDJ Report 2025 predicts that hiring will skyrocket, for instance, 20 per cent in IT and 25 per cent in manufacturing.

'Much Can Happen Over Coffee': Top Court Asks Couple To Settle Dispute

New Delhi: The Supreme Court on Monday asked a couple engaged in divorce proceedings to go on a dinner tonight to iron out their grievances and settle the dispute amicably.

A bench of Justice B V Nagarathna and Justice Satish Chandra Sharma was hearing a plea filed by a fashion entrepreneur seeking permission to travel abroad with her three-year-old child.

"You have a three-year-old child. What is the ego between the parties? Our canteen may not be so good for this. We will provide you another drawing room. Meet over dinner tonight. Much can happen over a cup of coffee," the bench observed. The top court asked the couple to swallow the past like a bitter pill and think about the future.

Observing that it expects a positive outcome, the top court posted the matter for Tuesday.

"On prayer made by senior counsel for the petitioner for the travel of the petitioner along with the minor child, we have directed both parties to interact with each other and revert to the court tomorrow," the bench said.

Karnataka Lawyer Invests In "Trump Hotel Rental Scheme", Loses Lakhs

Haveri: A 38-year-old advocate was duped by cyber-criminals who allegedly lured him into investing in a Trump Hotel rentals scheme using an AI-generated video of US President Donald Trump promising high returns, police said on Monday.

The issue came to light on May 6, when the victim approached the Haveri Central Crime Police Station with his complaint, they added.

In his statement, the advocate said that in January this year, he came across a video on YouTube offering an investment opportunity in "Donald Trump Hotel Rentals." When he clicked the link, he was directed to download a mobile application.

He was then asked to fill out a form, which included submitting his bank account details and IFSC code.

According to the police, the victim followed the instructions and paid Rs 1,500 to activate his account. He was prom-



ised a 3 per cent daily return on his investment.

Initially, he received returns and made profits on his investments. Trusting the scheme, he invested more money when asked by the fraudsters, hoping to double his earnings.

In total, he deposited Rs 5,93,240 to various bank accounts, UPI IDs, and digital wallets between January 25 and April 4. However, he stopped receiving returns and was unable to recover the invested amount.

A case has been registered under the IT Act and Section 318(4) (cheating) of the Bharatiya Nyaya Sanhita, police said. During the investigation, it

was found that the complainant was tricked through a 'fake' link. Consequently, Rs 1.5 lakh in the bank account to which the money was transferred has been frozen, a senior police officer said. Police have appealed to the public to stay alert and avoid clicking on suspicious links.

"It has come to light that crores of rupees have been swindled across the country through fake links such as the Trump Hotel Rental scheme, which falsely promises to double your money.

French President Macron plays down apparent shove from wife in Vietnam

French President Emmanuel Macron played down on Monday an incident in which his wife, Brigitte, pushed him in the face as the couple arrived in Vietnam to begin a tour of Southeast Asia.

In a video, Brigitte Macron appeared to shove her husband before he descended from the presidential plane late on Sunday, causing him to step back before he recovered and waved to the cameras on the tarmac

She remained momentarily hidden behind the plane's fuselage, blocking any view of her body language. The couple, who have been married since 2007, then descended the steps together, with Brigitte refusing her husband's arm.

"I was bickering, or rather joking, with my wife," Macron told reporters in Hanoi. "It's nothing."

He cautioned that this was

not the first time in recent weeks that the content of videos of him had been twisted by people he described as "crackpots".

Macron cited a video shared on social media that showed him removing a crumpled white object from a table on a train during a visit to Ukraine. Some social media users suggested — without providing evidence — that the object was a bag of cocaine.

Macron said it was a tissue and his office accused France's enemies of spreading fake news.

Earlier on Monday, an Elysee official said of the latest video: "It was a moment when the president and his wife were relaxing one last time before the start of the trip by having a laugh."

"It was a moment of closeness."

Macron's visit to Vietnam, the first by a French president in almost a decade, comes as he aims to boost France's influence in its former colony.
