Fresh Mock Drills Today For States Bordering Pak

Srinagar: Amid continued tensions with Pakistan, India is set to conduct large-scale civil defence mock drills across several border states on Thursday, aimed at bolstering emergency preparedness and testing civilian response mechanisms.

The exercise comes weeks after the country's first such drill since 1971, held hours before the launch of Operation Sindoor – a retaliatory military strike following the deadly Pahalgam terror attack.

The upcoming drills, be held in Gujarat, Punjab, Rajasthan, and Jammu & Kashmir, have been ordered by the Union government and will simulate emergency scenarios such as air raids, blackouts, and mass mobilization of civil defence resources. These states, sharing sensitive borders with Pakistan, bore the brunt of cross-border aggression during the recent conflict, prompting heightened vigilance. Sirens will be sounded in

key border districts, followed by brief blackout periods and emergency response checks. The drills are intended to assess the readiness of both civilians and authorities in the event of renewed hostilities. Civil defence authorities have begun issuing

directives, while district administrations are coordinating with local emergency services to ensure smooth execution.

Barmer District Collector Tina Dabi confirmed the drill's implementation per central instructions, with special emphasis on Jaisalmer, which lies close to the international border.

In a parallel move, the Haryana government has announced a state-wide civil defence exercise codenamed 'Operation Shield', to be held on the same day. The operation will cover all 22 districts starting from 5:00 PM and includes a controlled power outage between 8:00 PM and 8:15 PM in high-sensitivity zones. Essential services like hospitals and police stations will remain unaffected. According to official sources, the drill will involve civil defence wardens, registered volunteers, and youth organisations, aiming to improve inter-agency coordination and



Srinagar: The crescent for the last month of Islamic calendar – Zilhaj – was sighted in Kashmir on Wednesday.

'Faking Green Credentials Can Hamper Brand Value; Discourage Sustainable Shopping'

xaggerating or faking "green credentials" can lead to a drop in brand value by damaging trust of consumers and discourage sustainable shopping, a study by Indian Institute of Management (IIM), Lucknow has found. The research explored how deceptive green marketing, also knows as "greenwashing", can create a negative impact on the consumer trust, brand perception, and buying behaviour.

Conducted in collaboration with researchers from the University of Hail, Saudi Arabia, University of Turin, Italy, Princess Nourah bint Abdulrahman University, Saudi Arabia, and Institute of Management Studies Ghaziabad, India, the research has been published in the prestigious journal, Business

Strategy and the Environment. According to officials, greenwashing has become a common practice among brands to attract consumers, build a positive perception, and manipulate buying behaviour.

ing Attribution Theory and the Elaboration Likelihood Model. This framework with an emphasis on "situational involvement", meaning the degree of personal relevance a consumer assigns to environmental issues, helped in analysing "why" and "how" people react to greenwashing.

"The research team tested the developed framework on 353 consumers from the United States of America and analysed the data using structural

can affect consumer attitude towards a equation modelling, a method mostly used in the social and behavioural science fields," said Sushant Kumar, Assistant Professor, Marketing Management, IIM Lucknow.

Kumar said that the study found that greenwashing does not just fool people; it also damages brand trust and discourages sustainable shopping.

'Greenwashing is dangerous for brands, but consumers appreciate green claims. A business' green claims should be substantiated by evidence that can be verified by consumers. When consumers grow sceptical about a brand exaggerating or faking green credentials, their positive feelings about the brand drop," he said.

"People with greater environmental knowledge are more likely to critically assess eco-claims made by the brands and react more strongly," Kumar said. The team now plans to explore several other aspects of consumer behaviour such as recommendation of a brand or product involved in greenwashing. The team also plans to study the consumers' sentiments while consuming green brands and later discovering false claims by the brand.

Student Held For Post On **Indo-Pak Conflict Released** From Pune Jail

New Delhi: It was an emotional reunion for a teen student with her family as she walked out of jail on Tuesday night after having spent over a fortnight behind bars for her social media post criticising the Indian government amid the Indo-Pak conflict.

The 19-year-old student of engineering was granted bail by the Bombay High Court which had made scathing remarks against the Maharashtra government for "being bent upon ruining her life" and turning her into a "hardcore criminal".

The court had also pulled up the girl's college -- Sinhgad Academy of Engineering -- for issuing a rustication order against the girl "hurriedly" without giving her an opportunity to explain herself.

The high court suspended the rustication order and directed the authorities at the Yerwada central jail, where the girl was lodged, to release her forthwith on Tuesday itself.

Pursuant to the order, the student, originally from Jammu and Kashmir, was released from the jail around 9.30 PM on Tuesday after all formalities were completed, her lawyer Farhana Shah said.

Her family members were present outside the jail for the emotional reunion and wished to stay away from the media glare and

She was later sent to judicial custody at Yerwada prison. The college also rusticated her immediately.

Challenging her rustication and seeking quashing of the FIR, the student approached the Bombay High Court. On Tuesday, the High Court

strongly condemned the government's response, labeling it "absolutely shocking" and "radical." The court ordered her immediate release to allow her to appear for her ongoing semester examinations and directed the Sinhgad Academy of Engineering to provide her with a hall ticket and, if necessary, arrange security and a

separate classroom for her exams. The police were also instructed to ensure adequate protection for the student when she attends college, addressing her expressed fears.



UN Blasts New US-Backed Aid Distribution System In Gaza

GAZA CITY: The UN on Wednesday condemned a US-backed aid system in Gaza after one person was killed and 48 people were injured during a chaotic food distribution that saw shots fired by the Israeli military.

The issue of aid has come sharply into focus amid a hunger crisis coupled with intense criticism of the Gaza Humanitarian Foundation (GHF), a shadowy group that has bypassed the longstanding UN-led system in the territory.

With the war sparked by Hamas's October 2023 attack on Israel entering its 600th day on Wednesday, Palestinians in Gaza felt there was no reason to hope for a better future. In Israel, the relatives of people held hostage in Gaza since the October 7 attack longed for the return of their

The draft bill lays down the procedure for appointment of the inspectors general of registration, registrars, and sub-registrars, streamlines the appointment process for registrars in case of vacancies, and vests rule-making authority

The UN has repeatedly hit out against the GHF, and Philippe Lazzarini, head of the UN agency for Palestinian refugees, on Wednesday reiterated the criticism.

"I believe it is a waste of resources and a distraction from atrocities. We already have an aid distribution system that is fit for purpose," he said during a visit in Japan.

'Bread and water' On the ground in Gaza, the air strikes killed 16 people since dawn Wednesday.

Heba Jabr, 29, who sleeps in a tent in southern Gaza with her husband and their two children, was struggling to find food.

"Dying by bombing is much better than dying from the humiliation of hunger and being unable to provide bread and water for your children", she told AFP.

Israel imposed a full blockade on Gaza for over two months, before allowing supplies in at a trickle last week.

A medical source in southern Gaza told AFP that after Tuesday's stampede "more than 40 injured people arrived at Nasser Hospital, the majority of them wounded by Israeli gunfire", adding that at least one had died since.

The source added that "a number of other civilians also arrived at the hospital with various bruises".

Aligarh Mob Attack: Seized Meat Sample Not from 'Cow'

Aligarh : The ongoing police investigation into a mob violence case in Harduaganj has taken a twist after a laboratory report confirmed that the seized meat sample did not belong to a "cow or any cow progeny", a police officer said.

This revelation comes after a violent mob attacked four men on 24 May, suspecting them of transporting prohibited cattle meat. Their vehicle was also set ablaze by the mob, and local Bajrang Dal leaders claimed that this was the same vehicle the villagers had intercepted a fortnight ago with similar "illegal meat". However, police had released it on that occasion, saying it was buffalo meat. SP (rural) Amrit Jain told

PTI on Wednesday that police immediately rescued the victims from the mob and admitted them to hospital.

"The meat sample was sent to a government laboratory for testing. The forensic report of the meat sample has confirmed that it was not of cow or any cow progeny. We are investigating the entire sequence of events and will take action on the basis of our findings," Jain said.

The officer confirmed that four individuals named in the FIR lodged by the victims have already been arrested, with more arrests expected as the police search for others involved The initial report had named 12 alleged attackers and 25 un-

He has called for a fast-track court to deal with the case. A Congress party delegation, including MP Imran Masood and former MP Kunwar Danish Ali, also met the four injured men at the hospital on Tuesday.

A delegation of Samajwadi Party (SP) leaders led by Rajya Sabha member Ramji Lal Suman is expected to arrive in Aligarh on Wednesday to meet the victims.

'Jury Is Still Out' On Iran-US Talks

Nations' atomic watchdog said Wednesday that "the jury is still out" on negotiations between Iran and the U.S. over Tehran's rapidly advancing nuclear program, but described the continuing negotiations a good sign. Rafael Mariano Grossi, director-general of the International Atomic Energy Agency, made the comment to journalists attending a weeklong seminar at the agency in Vienna. Grossi acknowledged one of his deputies was in Tehran on Wednesday, Iranian officials identified the official as Massimo Aparo, the head of the IAEA's safeguards arm. That's the division that sends inspectors into Iran to monitor its program, which now enriches uranium up to 60% purity — a short, technical step from weapons-grade levels of 90%. Turkiye Will Fine Airline Passengers Who Unbuckle Before The Plane Stops

NKARA: Airline passengers in Turkiye who unbuckle their seat belts, access overhead compartments, or occupy the aisle before their plane has fully stopped now face fines under new regulations issued by the country's civil aviation authority.

The updated rules, which aim to enhance safety and ensure a more orderly disembarkation, came into effect earlier this month. They were adopted following passenger complaints and flight inspections indicated a growing number of safety violations during taxiing after landing, according to the Turkish Directorate of Civil Aviation.

It is not unusual in Turkiye for passengers to stand up or



move inside the cabin soon after the plane has landed, often leading to chaotic disembarkation.

Under the new regulations, commercial airlines operating flights in Turkiye are required to issue a revised version of the ed to wait for those in front of standard in-flight announcethem to exit first instead of rushing forward.

The circular does not say how much passengers who disregard the regulations could be fined, but Turkish media reports have said fines of up to \$70 will be imposed. "Despite announcements in-

forming passengers of the rules, many are standing up before the aircraft reaches its parking positions and before the seat belt sign is turned off," the aviation authority noted.

"This behavior compromises the safety of passengers and baggage, disregards the satisfaction and exit priority of other travelers," it said.

There have been no immediate reports confirming that the newly introduced fines are being enforced.

King Charles Picks A Side As Trump Pushes Canada To Join US

ing Charles III will outline new Prime Minister Mark Carney's government priorities in a speech in the Canadian Parliament on Tuesday, 27 May. It's widely viewed as a show of support in the face of annexation threats by US President Donald Trump.

Trump's repeated suggestion that the US annex Canada prompted Prime Minister Carney to invite Charles to give the speech from the throne. The king is the head of state in Canada, which is a member of the British Commonwealth of former colonies.

Carney said in a statement the visit speaks to the "vitality of our constitutional monarchy and our distinct identity."

It is rare for the monarch to deliver what's called the speech from the throne in Canada. Charles' mother, Queen Elizabeth II. did it twice in her 70-year reign, the last time in 1977.



The speech is not written by the king or his UK advisers as Charles serves as a nonpartisan head of state. He will read what is put before him by Canada's government.

3 Live Mortar Shells Defused In Jammu's Transport Nagar

JAMMU: Three unexploded mortar shells were recovered near the Regional Transport Office (RTO) in Narwal area of Transport Nagar in Jammu on Wednesday.

The shells, believed to be remnants of Pakistan's ceasefire violation during 'Operation Sindoora', prompted an immediate response from the Jammu and Kashmir Police and the Indian Army's Bomb Disposal Squad (BDS).

Local residents alerted authorities to the suspicious objects, leading to a rapid deployment of security forces to secure the area.

The Bomb Disposal Squad was called in and successfully defused the three RPG shells through a controlled mechanism, ensuring the safety of the surrounding community. The operation was completed with-

he suicide of an 18-year-old NEET aspirant from Jammu and Kashmir in Kota has shaken people in Kashmir. A girl under immense pressure to crack the tough competitive examinations couldn't take it any longer and ended her life. It is not an isolated tragedy but a grim reminder about what lakhs of students go through when forced into career paths that go against their interests or aptitude. This is the 15th student suicide reported from Kota in 2025 and the second this month alone. The latest victim, Zeeshan, had previously lived in Kota for coaching but returned a month ago to prepare independently. She reportedly told a relative she was considering suicide shortly before ending her life.

According to a study, student suicides in India are rising at an alarming rate, 4% annually, double the overall suicide trend. The numbers have jumped from 6,654 in 2011 to over 13,000 in 2021. These are the lives and families being wrecked. And we need to talk about this. More so in places like Kashmir, where open conversations around mental health are still rare, and the silence can be deadly.

This is why our schools, coaching centres, and even families must make mental well-being a priority. Counselling shouldn't be a last resort, it should be available from the start. More importantly, children must know that their worth is not tied to a rank card or an exam result. They are not failures for choosing a different path.

For years now, the message to India's youth has been loud and clear: crack NEET, JEE, or UPSC, or risk being called a disappointment. Family WhatsApp groups buzz with success stories of children becoming doctors and engineers. Relatives casually ask 15-year-olds whether they want to pursue medicine or engineering. They do this out of a deeply ingrained belief that only two or three professions are worth pursuing. Even when a child resists, parents often double down, confusing pressure with love and control with concern. The death should thus be a wake-up call. We need to acknowledge that the real failure lies with us: parents, educators, policymakers, and society at large. We have built an education culture that rewards conformity, punishes creativity, and leaves no room for emotional well-being. Rising student suicides call for fundamental overhaul of the existing social approach to education.

Linguistic Resilience

In Kashmir and beyond, young people aren't abandoning identity, they're reinventing it. To mourn this evolution and call it erosion, is to misunderstand how culture really survives.

ou don't need to walk through a university gate or open a dusty grammar book to see where language really lives. It's there in the chatter of school kids switching between Kashmiri and Hindi midsentence, in the Urdu phrases tucked between English status updates, in the auntie at the market giving directions with a mix of all three. In Kashmir, like in much of the world, language doesn't stay still. It flows, adapts, and reinvents itself, often faster than we can measure.

And yet, each time a young person hesitates in their mother tongue, someone sounds the alarm. "We're losing our culture," they say. "They don't speak like we did." But language doesn't disappear just because it sounds different. It changes because people change. Cultures do too.

Take any young student in Srinagar. She might write her college essays in English, crack jokes with classmates in Urdu, and talk to her grandmother in Kashmiri. This isn't a crisis. It's fluency in a modern, layered identity. It shows adaptability, not loss.

But there's a deep nostalgia that clings to ideas of linguistic purity, as if only an untouched version of a language is real, and everything else is a fall from grace. It's a comforting story, especially for those who no longer need to hustle for a job or impress a visa officer. But for most Kashmiris, especially the young, switching tongues is not about fashion. It's strategy.

When a mother encourages her child to master English or Urdu, she's not denying her roots. She's reading the world and making hard choices. She knows these languages open doors-to education, to work, to safety. That doesn't mean Kashmiri is dead. It just means her child is walking more than one path.

Kashmiri culture itself never grew in a vacuum. The language carries centuries of borrowings: Persian, Arabic, Sanskrit, Turkic, The Wazwan that so many cherish came with cooking influences from Central Asia. The pheran has traveled through history in forms borrowed and remade. If we insist on pure origins, we'll lose the thread of what made Kashmiri culture rich in the first place.

Still, the loudest calls to "preserve" culture often come from those who can afford to romanticize the past. They sit comfortably with

ture isn't something we keep under glass. It doesn't survive because we protect it from change. It survives because we keep using it, shaping it, stretching it. Every time someone shares a meme in mixed language, every time a bilingual video goes viral, that's not erasure. That's creativity.

Some of the most vibrant cultural work in Kashmir right now is happening online. Young creators are mixing languages, genres, aesthetics. They are not confused. They are multilingual, multidimensional, and unapologetically hybrid. They know how to speak to their peers, and to the world, without losing themselves in the process.

Still, the loss narrative clings tightly. It paints these young people as victims of a sweeping, homogenizing tide. It sees them as swept up, not steering. But talk to them and you'll find something else: agency. These are not passive adopters of global culture. They are active participants, picking and choosing, combining and resisting, all on their own terms.

They're not trying to erase the past. They're trying to make it speak in a present that's more connected and more complicated. They're bringing Kashmiri identity into conversation with the world—not to replace it, but to enrich it.

We might be better off shifting our question. Instead of asking what's being lost, let's ask what's being created. Because something is. A teenager who listens to classical Kashmiri music while watching English dramas is building a new kind of cultural fluency. A college graduate fluent in four languages is living a culture that has never been more flexible, or more alive.

This is not cultural decline. This is cultural improvisation. It's not the end of Kashmiri identity, it's another chapter in its long and storied evolution

The truth is, culture has always been this way. It adapts. It absorbs. It survives by moving, not by standing still.

So maybe the real danger lies not in language change, but in the idea that it must be stopped. Maybe the most Kashmiri thing we can do is stay open, curious, and unafraid of change. Because the young people shaping Kashmir today aren't losing their identity. They're reinventing it, for a world where identity is no longer a single story, but many.

Boom in the Mountains

Kashmir's real estate revival is happening far from its city streets.

Tou can tell a lot about a place by what people are build ing. In Kashmir, that story is changing fast. The residen tial colonies of Hyderpora and Lal Bazar, once the go-to for steady real estate growth, aren't moving much these davs. Prices have staved flat for a couple of years. But if you head toward the hills-Gulmarg, Pahalgam, Sonmarg-you'll find a different story. Properties there have doubled, even tripled, in value since the pandemic.

It's not just because of beauty. It's business. Tourism has bounced back hard after COVID. And land in these destinations is being snapped up quickly, not by homeowners, but by hoteliers guesthouse builders and anyone betting on Kashmir's travel revival. The contrast is sharp. In residential colonies, buyers seem to be waiting. In tourist spots, they're racing.

Other hill stations, like Lonavala near Mumbai, have long been favorites for investors. But Kashmir, despite its unpredict able politics, is seeing faster jumps in prices. It's caught up, and in some ways, pulled ahead.

But even good markets aren't bulletproof. A recent incident in Pahalgam brought things to a brief pause. These shocks, political or otherwise, are reminders. Real estate in Kashmir, while promising, is not without its risks.

That's why many investors are no longer putting all their eggs in one basket. They're branching out, into stocks, gold, silver, and even international funds. Financial advisors in the Valley are get ting more calls than ever. People are asking smarter questions. They're not just buying land. They're building portfolios.

The ground is shifting, literally and financially. In Kashmir, real estate is no longer just about where you live. It's about where people want to go, and how you plan for what comes next.

Kashmir's AI Boom Came Without a Rulebook

ashmiris are used to things changing slowly. But some shifts don't wait for headines. Artificial intelligence is one of them. It's already here, and silently working behind the scenes. altering how we learn, work, heal, and live. Most people don't talk about AI. But they're feeling its effects.

Take education. Students in Kupwara can now use an app to study for exams with lessons that adjust to their pace. AI doesn't get tired or demand tuition fees. It just works. In hospitals across the Valley, doctors are using AI tools to read X-rays and spot problems

earlier than ever before. These are small victories, but they matter, especially in places where resources are thin.

Farmers are also tuning in. In Pulwama and Budgam, some now rely on apps that predict rainfall and suggest the best time to sow seeds. That kind of help, tailored and on time, can protect crops and incomes. Even shopkeepers are turning to tools like Google Lens to read labels in unfamiliar languages. These everyday uses of AI make life easier in places where help isn't always at hand.

But there's another side. Surveil-

lance cameras in markets now use facial recognition. Officials call it smart security. But when cameras track your face and movements, it starts to feel like being watched all the time. In a region like ours, where trust is already fragile, that changes how people behave, what they say and where they go.

Jobs are shifting too. Banks use AI to filter loan requests. Offices automate customer service. That means fewer humans in roles many depended on. If AI keeps expanding without retraining workers, unemployment could rise silently, like the tech itself.

And here's the deeper problem:

We're not building AI in Kashmir. We're only consuming it. That means we don't decide how it works or who it helps. If an algorithm trained elsewhere misreads a Kashmiri name or face, who takes the blame?

We need more than new gadgets. We need conversations. Local developers, teachers, lawmakers — they all have a role in shaping how AI fits into our lives. Because it's not just a question of progress. It's a question of power.

Kashmir's Sikkim Dream Despite clean produce, willing farmers, and a ₹500 crore fund, Kashmir's organic push lacks one vital ingredient: political will.

The sun was still climbing over the ridges of Gurez when I stepped onto a potato field, soft with dew and dark with life. A farmer knelt beside me, his fingers moving through the soil like someone reading an old, familiar story. He didn't say much, but his silence carried the same confidence I'd once heard in the voice of Nazir Ahmad Gurezi, a senior lawmaker who stood here in 2017 and declared that Gurez could be Kashmir's organic capital.

'This place has everything it needs," Nazir had said then. And he wasn't wrong.

There's something unspoiled about Gurez. The land is high, the air is sharp, and the soiluntouched by years of chemicals-is ready. Nazir's dream was to grow clean food here: peas, potatoes, and promise.

And now, across Kashmir, from Pulwama's modest plots to the apple-heavy orchards of Baramulla, that dream is beginning to stir.

But dreaming is easy. Building takes more. And that is where, the far northeast Sikkim is showing the way.

In 2003, Pawan Kumar Chamling, then chief minister, did something few politicians ever dare. He banned chemical pesticides. Slowly, methodically, Sikkim walked toward purity. Officers trained farmers. Compost pits multiplied. Fields were watched, nurtured, kept clean. By 2015, all of Sikkim's 66,000 farming families were organic.

"We didn't just grow food," said Prem Das Rai, a former Sikkim MP. "We built a way of life."

The land responded. Soil grew softer. Streams ran clearer. Bees returned, and cardamom yields rose. Sikkim's farmers earned more, because clean food fetches clean money. Tourists came in droves, chasing mountain air and pesticide-free meals. Schools taught children how to farm without poison. The world noticed. In 2018, the UN gave Sikkim its highest prize for environmental policy.

That's the story Kashmir wants to tell.

Kashmir's agriculture is no small affair. It feeds most of its people and brings in billions. Apples, saffron, vegetables-they grow as easily here as wildflowers after snowmelt. Already, fifty thousand hectares are organic. More than twenty thousand are certified. In Bangund village, Pulwama, farmers like Bashir Ahmed stopped using chemicals back in 2017. Last summer, I saw him stack red, firm tomatoes into crates bound for Delhi.

"We're making good money now," he told me, wiping sweat from his temple. Bangund became Kashmir's first organic village in 2018. Just seventy-two families. Four hundred kanals of land. But it's something.

Then there's Gurez. Tucked between mountains and memories, it's perfect for growing food that doesn't need much help—off-season peas, potatoes with bite, barley with history. "Gurez could be our Sikkim," says Dr. Waseem Ahmad of SKUAST, Kashmir's agricultural university. A 2013 industry report even predicted that organic farming could bring Kashmir ₹11,600 crore and create eight million jobs by 2025. That kind of change isn't abstract, it's the difference between ₹7,800 a year and ₹19,500 in a farmer's pocket.

But the road ahead is slippery. Kashmiri apples are also drowning in pesticides. Chemicals coat the trees each March. The same rain that makes the orchards bloom washes those toxins into the ground and the rivers. In 2010, doctors at SKIMS hospital

found that nearly all of 432 brain cancer cases in orchard workers were linked to pesticides. "Our apples are our pride," says activist Dr. Raja Muzaffar Bhat. "But they're poisoning us." The National Green Tribunal fined the gov-

ernment ₹39 crore in 2021 for pesticide pollution in Doodh Ganga. A ₹149 crore cleanup followed. But the water still runs brown during the rains. I saw it myself in Baramulla–a stream that once reflected the sky now reflected nothing at all.

Even farmers who want to go clean hit snags. Insha Rasool tried organic farming in 2019 but couldn't find decent seeds. Showkat Hussain, who runs training schools in Bandipora, says farmers crave change, but lack the tools. "They need help," he told me. Bashir, back in Bangund, just wants a truck to move his harvest. The government has a ₹500 crore fund set aside for natural farming this year. Much of it lies untouched. Political parties, for their part, rarely mention organic farming at all.

"Sikkim had a plan," says Dr. Waseem. "We're scattered."

But Sikkim stumbled too. Early on, its farmers panicked over smaller harvests. The government stepped in with seed kits, subsidies. storage, and roads. They didn't just ask farmers to change, they helped them do it.

Kashmir's steps are slower. There's an organic market in Srinagar now. That helps. Over 3,400 farmers have been trained. That helps too. But what about trucks? Cold storage? Real-time help when pests come? Markets in every district? That's what Bashir wants.

And then, there's Gurez. Declaring it an organic valley, like Sikkim did, could light a fuse. Eco-tourism could follow. Training centers could bloom. And farmers, seeing success in their neighbors, might finally believe. The world wants what Kashmir can grow.

In 2022, the global organic food market hit 10.7 lakh crore. Kashmir's saffron, apples,

herbs-they belong on those shelves. That same 2013 report estimates that going organic could triple farmer incomes.

Sikkim did it with just seventy-five thousand hectares. Kashmir has more. Sikkim had fewer people. Fewer resources. Less attention. Still, it worked.

"If they could," Dr. Waseem says, "we can." But it won't happen by itself. Kashmir needs leaders who dream with budgets. It needs roads, trucks, seeds, and stories. It needs teachers in the fields, not just in offices. And above all, it needs belief-real, plantedin-the-soil belief.

In Bangund, Bashir pointed to his tomatoes. His shirt was damp. His smile was shy. "This is just the beginning," he said. Maybe it is.

Kashmir has the land. It has the water. It has the farmers. What it needs now is the will. Sikkim showed the world how it's done. The question is no longer if Kashmir can do it. It's whether it will.

What Eid al Azha **Teaches Us in Kashmir**

A schoolgirl captures how sacrifice, sharing, and small acts of kindness shape Eid, and everyday life, in the Valley.

n Kashmir, Eid al Azha begins long before the prayer. You see it in the crowded markets, where people bargain over animals and children pull their parents toward sweet shops. Tailors work late into the night. Bakeries smell like cardamom and fresh bread. Everyone's preparing for something bigger than a celebration.

This festival is built around a story most of us know: Prophet Ibrahim was ready to sacrifice his son, Ismail, to obey God. At the last moment, a ram was offered in his place. That story isn't just religious—it's deeply human. It's about giving up something you love for something greater. And in Kashmir, where life itself often asks for sacrifice, it feels especially close. Eid morning starts early. Men gather in open fields or at mosques, shoulder to shoulder. The prayer is short, but powerful. There's peace in those few minutes, a sense of unity that's hard to describe, but easy to feel.

butchers move from house to house. The process is quick but respectful. The meat is divided into three parts: one for your family, one for friends and relatives, and one for those in need. That last portion matters most. You'll see kids carrying parcels to neighbors, or families making sure no one nearby is forgotten.

For many, this is the busiest time of the year. Farmers and herders earn more during Eid season than at any other time. Transporters move livestock across districts. Shopkeepers stock up. Bakers make 0 double batches. Everyone's

brings people together, always. Kitchens fill with the smells of Rista, and fried delicacies. Guests drop in. No one ever leaves without eating something. The meals are rich, but the conversations are simple-about school, crops, weather, and life.

But what stands out most is the giving. People here make sure everyone is included. If a neighbor can't afford an animal, others help. If someone's alone, they get a knock on their door. Even a short visit means something.

One Last Look at Madinah

A personal account of one Kashmiri man's final moments in Madinah, where every tear carried a prayer and every step whispered a name.

didn't want to leave.

The air in Madinah that morning felt different, almost heavier, as if it too sensed my goodbye. I had spent days in the city of the Prophet [PBUH], days soaked in peace and stillness, days I wanted to stretch into forever. But my time had come. The road to Makkah awaited. My suitcase was ready, my passport tucked away. Yet my heart-my heart wasn't going anywhere.

I walked slowly toward Masid an-Nabawi, toward the Green Dome I had looked at a hundred times, maybe more. Each step felt harder than the last. How do you leave a place where your soul finally felt at rest? When I reached the Raudahthe Prophet's resting place-I stood still for a moment. I didn't rush. I didn't speak. I just breathed. And then, quietly, I whispered the words every visitor says:

Allāh. As-salāmu 'alayka yā Nabiy Allāh.

I tried to hold back tears, but I couldn't. They came on their own. There are things in life we feel more than we understand. That's how it was standing there, in front of the man who changed the world, and changed my heart. I offered my salaam not just for

me, but for so many others. I had

promised I'd carry their names,

their love, their prayers. I said

them silently, one by one. Some I

barely whispered. Others caught

in my throat. Dr. Eqbal. Bilal.

The streets didn't burn, they calmed. The heat didn't drain, it wrapped you gently. It felt like Madinah breathed its own kind of mercy. Like the breeze had a

Nissar. Altaf. Ishfaq. Tariq. There memory. And when it was finally time to leave, I kept turning back. One more glance. One more look at the Green Dome. I didn't want to blink. I didn't want to forget how it felt to be here. Now I'm in Makkah. But I keep thinking of Madinah. Of that walk, those names, that stillness. A part of me is still there, and maybe always will be.

Then comes the sacrifice. Skilled

The Last Kite of Babawayil

In a Kashmiri village that once defied dowries and danced with birdsong, one man returns in memory to a time when love was simple, homes were loud, and the world felt whole.

Peer Mohammad Amir Qureshi

had only gone to fetch milk. A short walk to the next village, nothing dramatic. I pushed Lopen the gate to come back, and there it was: noise, laughter, that unmistakable joy that hangs in the air when children land at their maternal home.

The courtyard was alive. Cricket balls flew. scooters zipped, kids yelled over each other, stirring up clouds of dust. Watching them, something shifted in me. I didn't plan on remembering anything that day, but suddenly, I was gone-back to my own childhood, to my own nanihaal.

I used to ache to go there. My brothers and I all did. We'd wait for our turn like it was a sacred gift. "One at a time," our parents would say. "Each of you will get your turn." And when mine finally came, the joy was electric.

It wasn't just about grandparents, though of course, they were everything. It was about the orchard too. Those grapes hidden like secrets beneath green leaves, and cherries, red and warm, dangling like jewels. It was about the smells and stories, the shade of old trees and the feel of mud floors under bare feet. Our house there wasn't fancy. It was made of mud and wood, but the love inside it was sturdy, like stone.

There was a stream once, right at the en-

trance. It sparkled, clear and constant, fed by Branan Tal, a sacred spring the villagers revered. Now, that stream is dry-a silent wound across the land.

The village itself, Babawayil, sits silently in Ganderbal. From afar, it looks like any other: green hills, thick orchards, clusters of modest homes. But it holds a distinction most don't. It is dowry-free.

In a region where marriages often carry the weight of cash and gifts, Babawayil chose another path. Here, people marry without exchanging dowries. They believe love shouldn't come with a price tag. I didn't understand the weight of that as a child, but now, looking back, I see what a radical thing it was, and still is.

The gate to our home was wooden, with a sheet of tin that rattled softly in the wind. Goats bleated near the cowshed, a calf pressed against its mother. Towering walnut trees lined the path to the verandah. That space-open, airy, grounded in earth and sky-was where mornings started with tea and evenings closed with spellbound stories. One walnut tree stood grander than the rest. It leaned toward the ground, almost like it was bowing. Its nuts were smooth, golden inside. That tree knew every secret I had.

From the kitchen window, I'd watch the birds come. They feasted on our grapes-nightingales, sparrows, tiny, darting guests. It was a melody I never got tired of. Now, the branches are still. The birds are gone. People say it's because of phone towers, climate shifts, shrinking green space. Maybe it's all of that. All I know is, silence has replaced their song.

My grandfather, whom we called Baba, was the village imam. But more than that, he was a kind, deeply principled man. My grandmother used to grumble when the birds got to the fruit. Baba would just smile and say, "Let them be. They eat off their right too." That one sentence taught me more about compassion than any sermon.

He had this small tradition with us. He'd bring coconut biscuits wrapped in dark brown paper. Maybe they cost two rupees back then. They weren't special, but to us, they were gold. Even now, I can taste them when I close my eyes.

My grandmother had her own ways of showing love. She kept a sandook-a big wooden chest. It smelled of old wood and time. She'd pull out chocolates or peanuts from it like magic tricks. That chest was a treasure, not for what was in it, but for how it made us feel.

And then there were the kites. Oh, the kites. I once begged my grandmother for one, and she walked me to her friend Hafeez Aapa's house. Her son handed me a kite, bright and feather-light. I carried it home like it was made of glass. When I flew it, the whole sky opened up. In those moments, I didn't care for food or sleep. I was a boy with a thread in hand and the wind on my side.

The village shop, Amm Soab's place, was another world. No shelves, no plastic. Just tin boxes with glass fronts, filled with biscuits. It smelled sweet, familiar. The shopkeeper would tease, "Ye Serchuk kar che aamut yoar?"-"When did this one from Serch arrive?" My cousin Rukhsana Didi would laugh. She always walked with me. Our grandmother had told her, "Stay with him. Don't let him wanderthere are dogs." And she listened. Always.

I went back and forth to that shop all day, spent every spare coin I had. My grandmother scolded me for it every time: "Why do you keep running to the shop again and again?" But I couldn't help it. That shop was happiness, packed in tin.

All three of my maternal uncles lived in that house then. They'd argue over who got to host me for dinner. "I brought meat," one would say. "No, he's eating with us," another would insist. They didn't just live under one roof-they lived with one heart. There was no bitterness, no jealousy. Just love, loud and generous.

They'd take me to the garden they called Daejj. Baba would be there, cutting grass,

working the soil. He grew cherries, almonds. He had a tree for each daughter. "Pick from her tree," he'd say. "Those are hers." Even the land knew where it belonged.

In the evenings, my aunt would take me to fetch water. There was always a shortage, and everyone would line up at the spring. Her friends would smother me in kisses, which I hated. I'd wipe their saliva off with my sleeve, right in front of them. I wasn't shy.

When we walked back, people would stop us. "Isn't this Maej's son?" I'd giggle at how they said 'Moaj' as 'Maej.' I'd repeat it just to tease them.

After sunset, my grandmother wouldn't let me outside. "There are soldiers out." Inside, the kitchen would fill with voices. My uncles, my grandparents, they'd sit and talk. No phones. Just stories, plans, debates, and jokes. thought those evenings would never end.

But they did.

The kite is gone. The shop is quiet. The stream has dried. The walnut trees stand over a house that now holds more silence than sound. My uncles live behind different doors now. We all do. Not just in new homes, but in the way we live-separate, silent, guarded. Sometimes, late at night, I wonder: did we grow up, or did we just grow apart?

Too Much Sitting Increases Risk Of Future Health Problems In Chest Pain Patients - New Research

or patients hospitalized with chest pain, the amount of time they spend sedentary afterward is linked to a greater risk for more heart problems and death within a year. That's the key finding of a new peer-reviewed study my colleagues and I published in the journal Circulation: Cardiovascular Quality and Outcomes.

We asked 609 emergency room patients experiencing chest pain - average age of 62 - to wear a physical activity monitor for 30 days after leaving the hospital. The monitor measured movements, sitting time and sleep throughout the day. We then followed patients for one year to track whether they had additional heart problems or died.

We found that patients who averaged more than 15 hours of sedentary behavior daily — which does not include sleep

were more than twice as likely to experience more heart problems or die in the year after discharge than patients who accrued a daily average of 12 hours of sedentary time.

But our goal wasn't just to document that sitting is harmful. It was also to figure out what patients should do instead to low er their risk.

We found that replacing 30 minutes of sedentary time with moderate or vigorous movement, like brisk walking or running, was most beneficial. It was associated with a 62% lower risk of experiencing more heart problems or dying in the year after discharge. But we also found that replacing 30 minutes of sedentary time with just light movement, such as slow walking or housework, lowered the risk of heart problems and death by 50%.

Sleep was also a healthier option. Replacing 30 minutes of sedentary time with sleep lowered the risk of heart problems and death by 14%.

Why it matters

Over 8 million people in the U.S. are admitted to the hospital with chest pain suggestive of acute coronary syndrome. annually. This covers a range of conditions involving reduced blood flow to the heart, including angina and heart attack.

Patients with acute coronary syndrome remain at high risk of having another heart problem even with optimal medical treatment.

The risk also remains high for patients with chest pain who are discharged without a diagnosis of acute coronary syndrome, as their unexplained chest pain may be a precursor to more serious heart problems. Given this risk, there is a need to identify risk factors that can be modified to improve a patient's prognosis after hospitalization for chest pain.

In previous research, we found that patients with acute coronary syndrome had a fear of exercise and were sedentary, spending over 13 hours a day sitting.

Given that sedentary behavior has been linked to poor heart health in the general population, we were concerned that patients were unknowingly increasing their risk of having another heart problem.

Our latest findings confirm that sedentary time is a harmful behavior for these patients. But beyond telling patients to stop sitting so much, our work provides important guidance: Any movement, regardless of how intense, can be beneficial after hospitalization. This is especially relevant for people recovering from heart problems who may find exercise difficult or scary.

While exercise provides the best "bang for your buck" in terms of health benefits, our findings are good news for patients who may not have the time, ability or desire to exercise. And for those unable to fit in more movement, just getting an extra half hour of sleep is a small, doable step that can make a meaningful difference for your health after hospitalization.

What still isn't known

Researchers don't fully understand why sedentary time is harmful. Muscles help regulate blood sugar and lipid levels. It is thought that when muscles aren't used, such as when patients sit for hours, this can lead to harmful elevations in blood sugar and lipids.

In turn, this can cause inflammation, plaque buildup in the arteries and organ damage. More research is needed to understand the biological mechanisms so that we can determine just how much movement is needed in a day.

What's next

While our study highlights the potential risks of sedentary behavior after being hospitalized for chest pain, it was an observational study. Clinical trials are needed to confirm that replacing sedentary time with activity or sleep can improve prognosis.

Local Weather Conditions Can Impact Prevalence Of Tuberculosis: Study

esearchers who mapped tuberculosis cases in African countries found that local weather conditions and access to cities can influence prevalence of the bacterial disease.

The study's methodology of identifying disease patterns could help fight tuberculosis in a more targeted manner around the world -- particularly in regions where resources are limited, they said.

Tuberculosis (TB) mostly affects the lungs and can be deadly if untreated. The disease -- symptoms of which include persistent cough, chest pain and fever spreads through the air when an infected person coughs or sneezes.

Focusing on 14 nations, including Nigeria and Mozambique, the team, including researchers from Curtin University and The Kids Research Institute Australia, analysed prevalence of tuberculosis from 50 population-based surveys, involving over 15 lakh people.

The researchers estimated how common the disease is at a local level, breaking each country down into grids, each five square kilometres in area, to identify hotspots. "Here we estimate 1.28 million TB cases across 14 countries, with marked spatial variations," the authors wrote in the study published in the journal Communications Medicine.

'Factors such as temperature, precipitation, and access to cities are positively associated with higher TB prevalence, while higher altitude is linked to lower TB prevalence," they wrote.

For example, rainfall tends to keep one spends indoors, thereby increasing person-to-person contact, crowding, and

affecting ventilation levels -- all of which have been linked to spreading of tuberculosis, the researchers explained.

Lead researcher Alemneh Liyew, PhD candidate from Curtin University's school of population health, said the study uncovered dramatic differences in disease



burden between local regions within countries -- which could prove vital in reducing the impact of tuberculosis.

"This study highlights how factors such as higher temperatures, rainfall, altitude and better access to cities can influence the prevalence of tuberculosis.

"With this data, health resources can be better targeted towards the communities that need them most," Liyew said.

The study is also the first to provide local-level tuberculosis maps across Africa, the researcher said.

"Until now, we haven't been able to see where within countries the disease is most concentrated," Liyew said.

Author Kefyalew Alene, associate professor Curtin University, said the study's findings could potentially help fight the disease outside of Africa. "While some aspects of the study are Africa-specific, using mapping to identify patterns associated with tuberculosis could help battle the disease in a more targeted manner elsewhere," Alene said.

Heart Attack Or Panic Attack? Why Young Men **Calling Ambulances For Unmanaged Anxiety**

nxiety affects one in five Australian men at some point in their lives. But the condition remains highly stigmatised, misunderstood and under-diagnosed.

Men are around half as likely to be diagnosed with an anxiety disorder compared to women. Some feel pressure to be fearless and hide their emotions. Others simply don't understand or have the language to describe anxiety symptoms.

This has serious consequences. Our latest research shows young men are turning to ambulance services when their symptoms become overwhelming – some even think they're having a heart attack.

So why do so many men wait until they need to call emergency services, rather than seek support earlier from a GP or psychologist? And what prompts them to call? We reviewed the paramedic notes of 694 men aged 15 to 25 years in Victoria, Australia, to find out. Young men haven't seen

others asking for help

Boys are raised to value courage, strength and self-assurance, and to suppress vulnerability.

When parents encour-



age boys to "face their fears",

opportunities for early intervention are missed.

Recently, we have seen positive shifts challenging restrictive masculine stereotypes. This has improved awareness surrounding men's depression

opening up conversations, normalising help-seeking and leading to the development of men's mental health programs and resources. However. men's anxiety remains in the shadows. When anxiety is talked about, it's not with the same weight or concern as depression. This is despite men's anxiety having harmful health impacts including turning to alcohol and drugs to cope, and increasing the risk of male sui-

What does anxiety look like?

When men are encouraged to talk about anxiety, they describe various challenges including repetitive worries, feeling out-of-control and intense physical symptoms. This includes a high heart rate, shortness of breath, body pains,

tremors and headaches.

Jack Steele, a prominent Australian personality and one half of the Inspired Unemployed, opened up about his anxiety difficulties on The Imperfects Podcast last year saying:

"I didn't know what anxiety was. I thought I was the opposite of anxiety. The way I explain it, it's like [...] your whole body just shuts down. My throat starts closing up and my whole body just goes numb. [...] It feels like you're just so alone. You feel like no-one can help you. You genuinely think the world's ending – like there's no out."

These physical symptoms are common in men but can be frequently dismissed rather than recognised as anxiety. Our research has found that, when left unaddressed, these symptoms typically worsen and arise in more and more contexts.

Why do anxious men call ambulances?

Our new study investigated the consequences of men's anxiety going unaddressed.

First, we used data from the National Ambulance Surveillance System to identify and describe the types of anxiety young men experience. We then looked at the characteristics and contexts of young men's anxiety presentations to ambulance services.

rather than offering emotional comfort and tenderness, anxietv gets positioned in conflict with masculinity. This leads to a disjuncture between the support young men are met with (and come to expect) from others, and the support they may

want or need. This also means boys grow up believing their male role models - dads, brothers, grandads, coaches - don't get anxious. deterring boys and men cide. from seeking help. As a result, anxiety goes undiagnosed and

Global Growth Strained, India Resilient: WEF Economists

NEW DELHI- Chief economists from across the world are the most optimistic about a strong economic expansion in South Asia, with India looking set to be the primary engine of growth in 2025 and 2026, a new survey showed on Wednesday.

The chief economists, however, warned of the overall global growth coming under strain from trade policy shocks and AI disruption, the World Economic Forum (WEF) said in its latest 'Chief Economists Outlook' report.

A majority of surveyed economists saw the current US economic policy as having a lasting global impact, with 87 per cent expecting it to delay strategic business decisions and heighten recession risks.

The global growth outlook was divided, with weak prospects in North America, resilience in Asia-Pacific and cautious optimism in Europe.

"The outlook for China remains muted, and the chief economists were divided over whether it will reach its target of 5 per cent GDP growth this

"Optimism remains highest for South Asia, where 33 per cent expect strong or very strong growth this year," the WEF said.

The survey of chief economists from across the world in private and public sectors found that the growth outlook for South Asia has been robust despite a challenging global environment.

Among all regions, chief economists surveyed were most optimistic about South Asia's prospects, with one-third expecting strong or very strong growth for the remainder of 2025.

However, the region's immediate challenges intensified in early May with the outbreak of military exchanges between India and Pakistan.

Across the region, chief economists expected moderate to high inflation.

The report noted that India, South Asia's largest economy, looked set to be the primary engine of growth, with GDP expansion forecast by the IMF at 6.2 per cent for 2025 and 6.3 per cent in 2026.

Although the rerouting of Chinese exports is casting a shadow over the region's economic prospects, a recently concluded trade deal between India and the UK was another source of optimism, it said. Globally, public debt con-

cerns were seen mounting as defence spending rises, with 86 per cent of chief economists expecting increased government borrowing.

Artificial intelligence was expected to drive growth, but 47 per cent anticipated net job losses.

NEW DELHI- The government on Wednesday announced a 3 per cent increase in the Minimum Support Price (MSP) for paddy to Rs 2,369 per quintal and up to 9 per cent rise for pulses and oilseeds for the 2025-26 kharif marketing season.

The agriculture ministry's proposal on MSP for the new kharif season was approved in the meeting of the Cabinet Committee on Economic Affairs (CCEA) chaired by Prime Minister Narendra Modi. The announcement comes

amid southwest monsoon reaching earlier than usual, giving a boost to the sowing of kharif crops, which contribute over 50 per cent of India's total annual foodgrain production.

Briefing media after the cabinet meeting, Information and Broadcasting Minister Ashwini Vaishnaw said, "Two key decisions were taken for the welfare of farmers -- kharif crops MSP and interest subvention scheme." In the last 10-11 years,

Sesamum support rate has been increased by Rs 579 per quintal to Rs 9,846, while that of nigerseed by Rs 820 per quintal to Rs 9,537 for 2025-26.

Among cash crops, cotton MSP has been increased by Rs 589 per quintal each to Rs 7,710 (medium staple) and Rs 8,110 (long staple), respectively, for 2025-26.

In recent years, the government has been promoting the cultivation of crops other than cereals, such as pulses and oilseeds, and nutri-cereals/Shree Anna, by offering a higher MSP for these crops.

The increase in 2025-26 kharif crops MSP is in line with the Union Budget 2018-19 announcement of fixing the MSP at a level of at least 1.5 times the All-India weighted average cost of production.

The expected margin to farmers over their cost of production is estimated to be highest in the case of bajra (63 per cent), followed by maize (59 per cent), tur (59 per cent) and urad (53 per cent). For the rest of the crops, margin to farmers over their cost of production is estimated to be at 50 per cent, the minister added.

Policies, Subsidies Boost EV Sales In India But Market Share Remain Modest: Study

NEW DELHI- While central and state policies helped increase the total number of electric vehicles (EVs) sales between 2014 and 2023, they did not do enough to increase their share in the overall vehicle market due to challenges like consumer preference for internal combustion engine (ICE) vehicles and a lack of charging infrastructure, according to a new study published on Wedpesday.

Wednesday. India plans to reduce its carbon emissions per unit of GDP by 45 per cent by 2030 and achieve net zero by 2070. A key focus is on the transport sector, which contributes 14 per cent of India's energy-related carbon emissions. The country also wants to become a global hub for EV manufacturing to boost growth, cut imports and create iobs

create jobs. India has introduced policies, incentives and rules to promote EVs, aiming for 30 per cent EV sales in cars, 70 per cent in commercial vehicles and 80 per cent in two- and three-wheelers by 2030.

Consumer durables (or white goods production) grew 6.4 per cent during the reporting month against a growth of 10.5 per cent in April 2024.

In April 2025, consumer nondurables output contracted 1.7 per cent compared to a decline of 2.5 per cent a year ago.

Infrastructure/construction goods reported a growth of 4 per cent in April 2025, down from an 8.5 per cent expansion in the year-ago period.

The data also showed that the output of primary goods contracted by 0.4 per cent in April 2025 against 7 per cent growth a year earlier.

The expansion in the intermediate goods segment was 4.1 per cent in the month under review, up from 3.8 per cent a year ago.

NEW DELHI: Indian export consignments have gradually started moving through the Red Sea route again, exporters body FIEO said on Tuesday.

The gradual movement signals a cautious recovery in shipments after months of disruptions on the route caused by regional tensions.

Last year, the situation around the Bab-el-Mandeb Strait, a crucial shipping route connecting the Red Sea and the Mediterranean Sea to the Indian Ocean, escalated due to attacks by Yemen-based Houthi militants. Due to attacks, the shippers

were taking consignments



through the Cape of Good Hope, encircling the African continent, resulting in delays of almost 14-20 days and higher freight and insurance costs. "Consignments are gradually going through this important sea route. It will cut transportation time," Federation of Indian Export Organisations (FIEO) Director General Ajay Sahai said.

He also said freight rates have stabilised because of a dip in ship demands from China.

Around 80 per cent of India's merchandise trade with Europe passes through the Red Sea and substantial trade with the US also takes this route. Both these geographies account for 34 per cent of the country's total exports.

The Red Sea strait is vital for 30 per cent of global container traffic and 12 per cent of world trade. About 95 per cent of the vessels had rerouted around Cape of Good Hope adding 4,000-6,000 nautical miles and 14-20 days to journeys.

Rupee Settles Flat 85.40 Against US Dollar

The Airports Council International Asia-Pacific & Middle East's Air Connectivity Ranking 2024 showed a 14 per cent year-on-year increase in both Asia-Pacific and Middle East regions, driven by strong international demand, robust network recovery, and the return of major travel corridors.

Among the top 10 hub airports with connectivity leadership in 2024, Delhi airport is at the tenth spot, while the list is topped by Dubai International Airport, according to a release. Shanghai Pudong Internation-

al Airport (China) is at the second place, followed by Hamad International Airport (Qatar) and Incheon International Airport (South Korea) at the third and fourth positions, respectively.

Guangzhou Baiyun International Airport (China) is at the

Delhi International Airport Ltd (DIAL) operates the Indira Gandhi International Airport (IGIA) in the national capital.

Delhi airport provides connectivity to 153 destinations, including 81 domestic and 72 international routes. It is also in line with the government's endeavour to develop IGIA as a global transit hub, DIAL said in a separate release.

Stock Markets Close Lower For 2nd Day; Sensex Down 239 Pts

MUMBAI- Stock markets declined for the second straight day on Wednesday with benchmark Sensex falling by 239 points dragged by losses in FMCG major ITC.

The 30-share BSE barometer declined 239.31 points or 0.29 per cent to settle at 81,312.32. During the day, it lost 307.61 points or 0.37 per cent to 81,244.02. The 50-issue NSE Nifty dropped 73.75 points or 0.30 per cent to close at 24,752.45.

Analysts said the key indices remained largely rangebound ahead of the monthly expiry on Thursday and the release of GDP and industrial production data. FMCG, auto, and pharma shares declined while banking, mainly PSUs, media and energy shares advanced.

Among Sensex stocks, ITC fell over 3 per cent after British multinational BAT trimmed its ownership in the conglomerate by divesting a 2.5 per cent stake for Rs 12,927 crore (USD 1.51 billion) through a block deal.

IndusInd Bank, Nestle, UltraTech Cement, Mahindra & Mahindra, Power Grid, Asian Paints, Sun Pharma and Tech Mahindra were also among the laggards. Bajaj Finance, Bharti Airtel, ICICI Bank, Adani Ports and HCL Tech were among the gainers.

"The domestic indices remained rangebound with a negative bias, primarily due to the lack of support from FIIs and prevailing premium valuations. A lingering concern over India-US trade relations following the end of the 90-day pause period continues to pose an external risk," Vinod Nair, Head of Research, Geojit Investments Limited, said.

Gold Climbs Rs 500 To Rs 99,000/10 G; Silver Rallies Rs 1,000/Kg

NEW DELHI- Gold prices climbed Rs 500 to Rs 99,000 per 10 grams in the national capital on Wednesday amid a firm trend in the overseas markets, according to the All India Sarafa Association.

The precious metal of 99.5 per cent purity rose Rs 500 to Rs 98,500 per 10 grams (inclusive of all taxes).

Also, silver prices rallied Rs 1,000 to Rs 1,00,000 per kg (inclusive of all taxes) on Wednesday. The metal had declined Rs 1,370 to Rs 99,000 per kg in the previous market session.

Globally, spot gold increased by USD 23.16 per ounce or 0.7 per cent to USD 3,323.87 per ounce.

"Gold prices traded positive as markets await the release of the FOMC (Federal Open Market Committee) meeting minutes and speeches from US Federal Reserve officials for further policy signals," Kaynat Chainwala, AVP Commodity Research at Kotak Securities, said.

India's industrial production data for April will be released later in the day, while the FY25 GDP and quarterly estimates for Q4 are scheduled to be released on Friday.

At the interbank foreign exchange, the domestic unit opened at 85.59 and moved between an intraday high of 85.33 and a low of 85.72 against the greenback.

The local unit ended the session at 85.40 (provisional) against the

dollar, unchanged from its previous close.

On Tuesday, the rupee closed 30 paise lower at 85.40 against the greenback.

According to Jateen Trivedi, VP Research Analyst - Commodity and Currency, LKP Securities, the rupee traded flat as the dollar index remained steady.

"With major economic data lined up this week -- including the US Fed meeting minutes, Q1 GDP, and Core PCE Price Index -the rupee's trajectory will largely be guided by foreign fund activity in the secondary markets. In the near-term, the rupee is expected to move within a range of 84.80 to 85.75," he said.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading higher by 0.05 per cent at 99.47.

Analysts attributed the greenback's strength to improving US consumer confidence on better than expected durable goods orders and consumer confidence data.

Cabinet Approves Continuation Of Interest Subvention Scheme For Farmers Press Trust of India

NEW DELHI- The government on Wednesday approved continuation of Modified Interest Subvention Scheme (MISS) for 2025-26 under which farmers get short-term credit at affordable rate through Kisan Credit card (KCC).

The decision regarding continuation of MISS for fiscal year 2025-26 with existing 1.5 per cent interest subvention was taken by the Union Cabinet, informed Information and Broadcasting Minister Ashwini Vaishnaw.

The continuation of the scheme will cost exchequer Rs 15,640 crore.

MISS is a Central Sector Scheme aimed at ensuring the availability of short-term credit to farmers at an affordable interest rate through KCC.

Under MISS, farmers get short-term loans of up to Rs 3 lakh through KCC at a subsidized interest rate of 7 per cent, with 1.5 per cent interest subvention provided to eligible lending institutions.

Additionally, farmers repaying loans promptly are eligible for an incentive of up to 3 per cent as Prompt Repayment Incentive (PRI), effectively reducing their interest rate on KCC loans to 4 per cent.

For loans taken exclusively for animal husbandry or fisheries, the interest benefit is applicable up to Rs 2 lakh.

An official release said that no changes have been proposed in the structure or other components of the scheme.

HC Raps Judge, Woman **Over Husband's Plea For Ailing Son's Custody**

Mumbai: The Bombay High Court has slammed a family court judge for refusing urgent hearing on a man's plea seeking interim custody of his 2-year-old son who has to undergo an open heart surgery, noting such conduct was "unbecoming of a judge'

Justice Rohit Joshi of the High Court's Aurangabad vacation bench on Tuesday also expressed displeasure with the child's mother for opposing the application filed by her ex-husband seeking the boy's custody for the surgery.

The court was hearing a petition filed by the child's father seeking his interim custody. As per the plea, the child has to undergo the open heart surgery at the MGM Hospital in Chhatrapati Sambhajinagar tentatively in the first week of June. The man said he had filed an

application before the family court concerned at Kaij in Beed district and also sought an urgent hearing of the same

However, the family court refused to grant an urgent hearing.

Justice Joshi said that in such a serious matter where a child is required to undergo an open heart surgery, the family court judge has not deemed it



appropriate to take the case for hearing to consider whether interim custody should be granted to the father.

"The conduct of the judge (family court) to say the least is unbecoming of any judge," the High Court said. The high court also rebuked the child's mother for opposing the father's plea for interim custody.

"Equally shocking is the conduct of the mother who is opposing the prayer for interim custody despite specifically admitting that the child is required to undergo the operation," the court said.

The High Court bench allowed the father's plea for interim custody of the child and directed the mother to hand over the boy's custody to the father for the surgery.

"The child will be in the custody of the father during the course of hospitalization and the mother will get custody of the child back subject to further medical advice," the high court said.

'Single Hand Can't Clap' SC Gives Interim Bail To 23-yearold Influencer In Rape Case

New Delhi: The Supreme Court on Wednesday gave interim bail to a 23-year-old accused of raping a 40-year-old, noting that charges had not been framed even though he has been in jail for nine months. It also said the woman was "not a baby" and "a single hand can't clap".

In scathing comments, a bench comprising Justices B V Nagarathna and Satish Chandra Sharma also asked how Delhi Police could file a rape case against the man, a social media influencer, when the woman had gone voluntarily with him.

"A single hand can't clap. On what basis have you filed case under Section 376 of IPC. She is not a baby. The woman is 40 years old. They have gone together to Jammu. Why have vou invoked 376. This lady goes to Jammu seven times and the husband is not bothered," the bench observed.

The top court said this is a fit case to grant interim bail as the accused has been in jail for nine months and charges have not been framed in the case. The apex court directed that

the accused be produced before trial court and granted interim bail subject to terms and conditions. He shall not misuse his liberty and not attempt to



contact the woman, the bench said.

The apex court also remarked on the man, asking, "Who gets influenced by such people?

The top court was hearing a plea filed by the man against an order of the Delhi High Court which declined to grant him bail considering the seriousness of the allegations. According to the police com-

plaint, the woman first came into contact with him in 2021 through social media while seeking a social media influencer to promote her clothing brand. During initial interactions,

the accused allegedly re-quested an iPhone to enhance content creation, which she arranged through an authorised Apple Store in Jammu.

However, their professional relationship soured after the accused attempted to resell the device. The authorised seller

Trump says he warned Netanyahu to hold off on Iran strike to give US more time for nuclear talks

Washington, May 28 (AP) President Donald Trump said Wednesday he has told Israeli Minister Beniamin Prime Netanyahu to hold off on striking Iran to give the US administration more time to push for a new nuclear deal with Tehran.

"I told him this would be inappropriate to do right now because we're very close to a solution," Trump told reporters at the White House.

"Now, that could change at any moment. It could change with a phone call. But right now, I think they want to make a deal. And, if we can make a deal, (it would) save a lot of lives.'

Trump added that an agree-ment could come together "over the next couple of weeks,

if it happens." The Israeli prime minister's office did not immediately respond to a request for comment.

Trump's comments came as the head of the United Nations' atomic watchdog said "the jury is still out" on negotiations between Iran and the US over Tehran's rapidly advancing nuclear programme. But Rafael Mariano Grossi,

director-general of the International Atomic Energy Agency, described the continuing negotiations between Iran

and the US as a good sign. Grossi said he's in nearconversation dailv with Iranian Foreign Minister Abbas Araghchi, as well as talking to Steve Witkoff, the US Middle

East envoy. Grossi acknowledged one of his deputies was in Tehran on Wednesday. Iranian offi-cials identified the official as Massimo Aparo, the head of the atomic energy agency's safeguards arm.

That's the division that sends inspectors into Iran to monitor its programme, which now enriches uranium up to 60 per cent purity – a short, technical step from weapons-grade levels of 90 per cent.

"For the moment, the jury is still out," Grossi told journalists attending a weeklong seminar at the agency in Vienna. "We don't know whether there's going to be an agreement or not."

However, he described the meetings as a good sign.

"I think that is an indication of a willingness to come to an agreement. And I think that, in and by itself, is something possible."

Iran and the US so far have held five rounds of talks in both Muscat, Oman, and in Rome, mediated by Omani Foreign Minister Badr al-Busaidi. A sixth round has yet to be set. Talks focused on Iranian

villages, maps drawn decades ago no longer match the land as it exists. Boundaries shift, families grow, and deals are sealed with handshakes, not stamps.

'This isn't just about converting paper into PDFs," said Kumar Rajeev Ranjan, Secretary of Revenue. "You need to verify, cross-check, and sometimes even investigate. Otherwise, you're just digitizing chaos."

The job ahead is massive. Officials estimate that over 6.5 million land parcels across the union territory must be mapped and recorded, along with around 100,000 ownership changes, or mutations, that are still pending. These include everything from inheritance transfers to court decisions that were never updated in the system.

To help manage this, the government has trained dozens of "Master Trainers"-local officials and experts who will lead district teams in scanning, digitizing and verifying data. The target is to deploy 100 such trainers per district.

One pilot site, Khairi Dadyal village in Nagrota tehsil, has already been fully digitized. Locals there can now see their Records of Rights on a screen at the local revenue office, and soon from their phones. Another village, Chak Wahab Din in Suchetgarh, has gone live too.

These are small steps, but they matter.

In Srinagar, officials at the National Informatics Centre (NIC) have developed

Dr. Anwar Hussain, a land rights researcher, said the reform could have "generational impact."

'Land disputes have wrecked families here," he said. "If done transparently, this digitization could end decades of pain."

That's why the administration plans to involve citizens directly. Before records are finalized, village-level camps will be held where locals can check details, raise objections and suggest corrections. For rural areas with limited internet access, the government is also setting up display kiosks and offering mobile support through trained volunteers.

Beyond individual ownership, the plan also aims to clean up government records. All land parcels will soon be linked to a Unique Land Parcel Identification Number (ULPIN), tied to Aadhaar data where available. This will help identify illegal encroachments, optimize land use and streamline welfare schemes like PM-KISAN.

Financial Commissioner Shaleen Kabra believes this will reshape how property is bought and sold. "Once records are online, and deeds are paperless," he said, "the whole process becomes faster and cleaner."

After the completion of the process, many reckon, people won't be forced to bribe someone to get their document moved from one desk to another.

Still, hurdles remain.

The infrastructure for 207 new record rooms-climate-proof facilities where physical documents will be stored for backup-hasn't been funded yet.

And while digitization is racing ahead in some districts, others lag due to staff shortages, outdated maps, or ongoing disputes.

A Geographic Information System consultant advising the project, said the work is intense but rewarding.

"It's like detective work," he said. "You're not just digitizing land. You're tracing stories, famies, migrations. Every map tells a story.'

Back in Kupwara, Ghulam Nabi is still waiting for clarity on that disputed land. But this time, he's hopeful.

"They came to our village last week with tablets and showed us our plots," he said. "They asked if the names were right. I've never seen that happen before. Maybe now, our children won't have to fight for this again."

The government hopes to complete most of the digitization by next year. Whether that deadline holds or not, one thing is clear: Jammu and Kashmir's land history is finally being rewritten by codes, maps, and shared data.

The Qualifier 1 and Eliminator of the ongoing Indian Premier League is unlikely to be impacted due to security reasons in the aftermath of the recent conflict between India and Pakistan following the barbaric Pahalgam attack, the Punjab Police said on Wednesday.

The IPL schedule had to be tinkered after the tournament was suspended for a week following the military conflict between India and Pakistan.

According to the revised schedule, Mullanpur will host the qualifier 1 on Thursday and the eliminator on Friday, while the qualifier 2 and the final will be held in Ahmedabad on June 1 and 3.

"There are two very important matches at Mullanpur stadium tomorrow and day after tomorrow. There is a qualifier and an eliminator. People are coming from all corners of India. There is a lot of enthusiasm among the people," Arpit Shukla, Special DGP (Law and Order), Punjab said.

"We have arranged for extensive security around the stadium and its periphery. Today, there is a review of it. Our police force is deployed around 65 Gazetted officers and more than 2,500 is deployed.

"We will ensure that those who are coming do not face any kind of trouble. On the other hand, the security measures will be very strict. Yesterday, we had a rehearsal of the mockdrill. Today also the police force is rehearsing the mockdrill," he added.

MUMBAI: IPL's costliest-ever player Rishabh Pant at last delivered the goods with a ton in the final match but Lucknow Super Giants missed the bus. Axar Patel's Delhi Capitals nosedived from cruise control. Former winners Chennai Super Kings, Rajasthan Royals and Kolkata Knight Riders cut a sorry figure while Sunrisers Hyderabad misfired all the way through.

In all, it took 67 days including a 10-day break, for the IPL to go through its preliminary round of 70 matches this year which witnessed some surreal highs and disappointing lows.

Here's a recap so far before the playoffs begin:

Young Guns Make A Strong Dent:

RR's Vaibhav Suryavanshi was a 13-year-old when he was picked in the mega auction last December and at 14 in May, he became the youngest ever to

score the fastest IPL ton for an Indian off 35 balls and second fastest ever, against Gujarat Titans.

His finesse in stroke play and spunk at the biggest stage captivated the game's greats.

While India T20I opener Abhishek Sharma was also among those who hit centuries, it also included Punjab Kings' uncapped Priyansh Arya, who took apart a lowly CSK with his maiden IPL ton. Prabhsimran Singh also showed he has got the goods while Ayush Mhatre gave CSK some reasons to smile.

Daunting SRH Misfire:

Last year's runner-up SRH came in with one of the most intimidating batting line-ups but the all-out attack approach fell flat on its face.

SRH began the IPL with the second highest total ever of 286/6 against RR and ended with the third highest, of 278/3

against KKR. In between, it looked like SRH never had a Plan B with the



bat, Nitish Kumar Reddy largely disappointed and not having a quality spinner to bowl in the powerplay hurt them.

CSK Learn Their Lessons The Hard Way:

Change is the only constant goes the old adage and CSK learnt it the hard way this year. The side was forced to part with its philosophy of keeping young talent on the bench and rely only on seasoned players such as MS Dhoni.

Sai Sudharsan Comes Of Age:

The young Southpaw showed that a no-risk approach with relentless attack at every opportunity can be a way to amass runs. he tops the charts right now with more than 670 runs and was deservingly rewarded with a national call-up for the Test tour of England.

From being retired out for batting slowly in 2023 to being one of the best batters in 2025, Gujarat Titans' Sudharsan proved his time has come.

Mumbai Indians Do A Mumbai Indians:

Four defeats in first five games marked yet another typical Mumbai Indians' start to an IPL, but Hardik Pandya's men came back roaring to win next six matches to establish themselves among the front-runners. Rohit Sharma and Tilak Varma have blown hot and cold but

Suryakumar Yadav showed why he is among the best in the business with remarkable consistency, while Jasprit Bumrah's 17 wickets in 10 matches must set alarm bells ringing in opposition camps.

RR's Forgettable Season:

From sweating on Sanju Samson's fitness and form to lack of gumption shown by others, RR endured a forgettable season to finish second last ahead of CSK.

Parting ways with key players including Jos Buttler, Ashwin, Yuzvendra Chahal and Trent Boult disturbed their balance more than perhaps RR imagined.

High-Flying DC Nosedive:

The Capitals began this IPL looking like they won't put a foot wrong but when it came to being clinical and consistent, the fight petered out.

DC began with five wins in first six matches and were perched at the top of the table, but a stunning nosedive saw them lose five

out of the next eight.

KKR Misfire But Rahane Stands Tall:

Rahane waged a lone battle of sorts but the season was also poor for the franchise's costliest player and vice-captain Venkatesh Iyer. With five defeats in first eight matches, it was all but over quite early for the defending champions who failed to play like one.

Marsh, Pooran Stand Tall In LSG Rabble:

Five wins in first eight games -- built largely on the top-order's success -- gave LSG a chance to finish in the final four but there were more areas of concerns than bright spots.


