Eid-ul-Azha Being Celebrated Today

Srinagar: Eid-ul-Azha, commemorating Prophet Abraham 's absolute submission to the command of the Almighty, is being celebrated in Kashmir on Saturday along with many parts of the Muslim world.

Massive congregations are due at major venues for ritual Eid prayers in the morning, to be followed by slaughter of lawful animals and distributing their flesh among family, relatives and the needy. The sacrifice signifies the miracu-

The sacrifice signifies the miraculous appearance of a lamb which came under the knife at the altar Prophet Ibrahim (Abraham) (AS) had prepared for his son, Prophet Ismail (AS).

In Srinagar, the major congregations are scheduled to be held at J amia Masjid, the Hazratbal shrine, the TRC grounds, and the imambargahs of Zadibal, and Hassanabad. Prayers will also be held at all mosques and shrines across Kashmir. According to the Holy Quran, Prophet Abraham (AS) repeatedly dreamt himself, slitting the throat of his son, and confiding in Hazrat Ismail, found him urging to fulfil God's command.

As the Prophet, having blindfolded himself, ran the knife over his son's throat, he found a lamb to have been slaughtered instead and Hazrat Ismail standing safe beside him.

The ritual of Hajj, during which pilgrims replicate the various stages of Prophet Abraham 's experience, coincides with Eid-ul-Azha sacrificing a lawful animal bringing it to culmination.

A joyous occasion across the Muslim world, Eid is often accompanied by preparing special dishes, donning new clothes particularly for children and visiting friends and relatives to give greetings.

On Arafah Day Srinagar Markets Witness Massive Rush

SRINAGAR: A day ahead of Eidul-Azha, Srinagar's markets were packed to capacity as residents thronged shops on Arafah Day to make last-minute purchases. From bustling lanes in Lal Chowk to the narrow alleys of Downtown, the festive atmosphere was palpable, with families shopping for groceries, garments, mutton, and other essentials.

Adding to the celebratory mood, bakery shops across the city witnessed an overwhelming rush and remained open till late evening on Friday to cater to the rising demand. Popular bakeries in Karan Nagar, Khanyar, and Rajbagh had long queues of customers eager to pick up tradi-

tional cakes, breads, and pastries. "It's a joy to see families out in such numbers, preparing together for Eid." said Irfan Malik, a shopper in Goni Khan. "The streets are alive with activity, and the spirit of the

festival is in full swing." Despite the cheerful ambiance, many residents expressed disap-

pointment over the absence of market regulation. Shoppers across the Valley complained of arbitrary pricing and no visible presence of enforcement authorities from the Food, Civil Supplies and Consumer Affairs (FCS&CÅ) department.

"We haven't seen a single official in the markets this week," said Aijaz Dar, a consumer in Nowhatta. "There is complete chaos-every shopkeeper is charging differently, and there's no standard being followed."


Vendors, too, said they had not received any updated rate lists or inspection visits. "Usually we expect some checks before major festivals,

but this time there has been none," said Younis Rather, a trader in Soura. "That leaves both shopkeepers and customers confused."

Meanwhile, the district administration and traffic police made spe-cial arrangements to manage the crowd, particularly in high-footfall areas. "We have deployed additional personnel and introduced route diversions to facilitate smooth movement," a traffic official stationed at Residency Road said.

As the Kashmir Valley prepares to celebrate Eid-ul-Azha on Saturday, citizens have urged the authorities to ensure more consistent oversight and enforcement in markets. "Festivals come and go, but the government must ensure that basic consumer rights are protected all year round," said Nusrat Ali, a teacher shopping in the old city.

Despite challenges, the strong turnout and vibrant market scenes on Arafah Day reflected the community's resilience and eagerness to celebrate the sacred occasion of Eid with devotion and joy.

Advani Quits In Jinnah's Defence

NEW DELHI - Just two days after his remarks on Muhammed Ali Jinnah, L K Advani on Tuesday resigned as the president of the Bharatiya Janata Party,. His resignation came a day after the top RSS brass demanded that Advani withdraw his utterances. Returning home on Monday, Advani had brushed aside all criticism and described his visit as "an unforgettable week in my life". He said he welcomed a debate on the remarks about Jinnah.

Significantly, Advani wrote the resignation letter just before leaving Karachi on Monday.

RSS has been demanding that he withdraw his statements in Pakistan specially that Muhammad Ali linnah was secular.

Hours after the midnight demand of the Sangh Parivar founthead that he "review" the statements made in Pakistan during his weeklong visit.

Advani called Sanjay Joshi., RSS pointsman in-BJP to his residence this morning and handed over to him a letter announcing his resignation as party President.

The party made this disclosure in a press statement along with which it released a lefter written by Advani to Joshi significantly "just before" leaving Karachi yesterday.

"I have decided to request the party to relieve me of Presidentship." the letter said.

Jammu:Chief Minister Omar Abdullah on Friday lauded Prime Minister Narendra Modi for fulfilling what he called a century-old dream of connecting Kashmir to the rest of India by rail – a project once imag-ined during British rule. Speaking at the formal in-

auguration of the Udhampur-Srinagar-Baramulla Rail Link (USBRL), Omar struck a mix of praise and political reflection. "Even the Britishers dreamt of a railway to Kashmir, but it is Prime Minister Modi who has made that dream a reality," he said. "What they couldn't achieve, you have."

However, Omar didn't shv away from addressing the altered political status of Jammu and Kashmir. Sharing the stage with PM Modi and Lieutenant Governor Manoj Sinha during the flagging off of the Katra-Srinagar Vande Bharat Express,



he remarked:

"Call it fate or destiny, but I've been present at every major railway inauguration in J&K – from Anantnag to Banihal to Katra. Back in 2014, the same four of us were here when Katra station was inaugurated. At that time, I was the Chief Minister of a state. Today, I stand here as Chief Minister of a Union Territory. 
Srinagar: Before towering cranes and cutting-edge engineering transformed the Himalayan landscape, the monumental dream of connecting "Kashmir to Kanyakumari" by rail began with the plodding footsteps of humble mules. This extraordinary backstory underpins the official realization of the Udhampur-Srinagar-Baramulla Rail Link (USBRL), inaugurated by Prime Minister Narendra Modi on June 6, 2025, a project crowned by the aweinspiring Chenab Bridge.

According to Afcons Infrastructure Limited, the company behind the Chenab Bridge, the earliest and most formidable hurdle wasn't just the de-sign of the world's highest railway arch bridge, but simply reaching its remote and treacherous location. Surrounded by steep, ancient Himalayan slopes, the only viable option for transporting essential equipment and construction materials was initially by horses and mules.

"Initially, mules and horses were used by the project team to reach the location," a company spokesperson revealed. This arduous, painstaking effort laid the groundwork for what was to come. Slowly, temporary roads were meticulously carved | More on P10

id-ul-Azha, also known as the Festival of Sacrifice, is a time for Muslims to reflect upon the spirit of sacrifice and seek divine blessings not only for themselves but for the entire Muslim ummah and humanity as a whole. Families purchase livestock for the ritual sacrifice, and its distribution among relatives and the needy people. This is both a sacrifice and an act of charity, carrying a profound spiritual significance. According to religious tradition, the festival commemorates the willingness of the Prophet Ibrahim to sacrifice his beloved son, Ismail, as commanded by Allah. However, as Prophet Ibrahim prepared to carry out the sacrifice, Allah provided a ram to be sacrificed instead, symbolizing the ultimate act of submission and devotion to the Creator.

While the festival is often associated with the act of sacrificing animals, its essence lies in the profound message of selflessness and devotion exemplified by Prophet Ibrahim. It serves as a reminder for Muslims to submit wholeheartedly to Allah's will and seek His pleasure.

This Eid comes in the wake of the four-day war between India and Pakistan over the tragic Pahalgam terror attack that killed 25 tourists and one pony operator. Thankfully the ceasefire followed, saving the region from large scale death and destruction. This makes the Eid festivity all the more blessed.

So, while we celebrate Eid, we need to be mindful of the sections of our society that are struggling to make ends meet, over and above the trauma and grief that we have been experiencing for so many years now. This calls for us to be much more austere in our celebration. We need to show that we care about them on Eid too.

Those of us who can afford to spend should instead donate the amount we would otherwise spend on consumables for our brethren in distress. The same goes for the people who spend lavishly on Eid feast. They would earn more Sawab and God's goodwill should they also contribute some amount to the people who have nothing. Let this Eid further strengthen and sustain the spirit of community effort that has made us resilient in the face of the worst adversity.

More than an occasion of joy, Eid in Kashmir is a time for reflection. And of mourning too, for the thousands who have died over the past over three decades. Eid is inherently also about joy and celebration but there is nothing routine about this joy. The festival is about spiritual renewal and a sense of fulfilment. In Kashmir and of course in other troubled spots of the world, Eid assumes a meaning that runs even deeper. It is a very solemn occasion for individual and collective reflection and remembrance. It is also about our obligation towards our society.

he days before Eid al-Azha feel different in Kashmir. The air thickens with scent of livestock, of grass crushed under hooves, of wet wool and mouthwatering delicacies. In the villages and towns,

from the banks of Jhelum to the orchards of Shopian, animals are tethered near doorsteps. Children name them, feed them, sometimes grow attached. But everyone knows the moment is coming.

It always begins with the moon. Once sighted, everything moves. Tailors stay open late. Men visit butchers and brokers. Women count savings tucked into shawls. The streets get busy, but not noisy. Kashmir knows how to move calmly, especially during sacred days

Eid al-Azha is not just a ritual here. It's a conversation with God that echoes through generations. People know the story well: the Prophet Ibrahim, the dream, the knife, the son, the divine replacement. But the story means more in a place like Kashmir. Where lives are shaped by strife, sacrifice isn't just a lesson. It's a lived thing.

On the first morning of Eid, prayers spill out from mosques and Eidgahs into open spaces. Men in white, boys in crisp kurtas, rows forming on dewy grass. The imams speak of faith, of obedience, of the love between a father and son. Then the people return home, where the animals wait, and the blades have been sharpened with care.

This is not done casually. A proper qurbani must happen after the Eid prayers, scholars say, or it's counted only as charity. The animal must be healthy, the act deliberate.

A full-grown sheep can cost between Rs 12,000 to 18,000. For many, it means months of saving. Some families pool in together. Others give two animals: one for themselves, one on behalf of someone who passed, or someone too poor to afford their own.

In the city, the meat often gets packed in neat polythene bags and sent discreetly to neighbours and the poor. In the villages, the pro-

advance. Some young men learn the process just for these days. How to hold the animal, how to say the prayer, where to cut. It's not just skill. It's intention. "You have to be clean, in body and in mind," said Irfan, a part-time butcher from Sopore. "Otherwise, it's just meat." In Kashmir, nothing happens

far from memory. People remember fathers who once chose the animal, mothers who stayed up late making spice blends. A sacrifice, in many homes, carries their absence. The act becomes personal. The prayer whispered before the cut often includes names no longer spoken aloud.

Still, there is joy. Children watch wide-eyed. Some cry. Some boast. Old women distribute dried dates after the meat is sorted. Kitchens fill with sound: pressure cookers, knives on chopping boards, the soft bubbling of gravy thickening on a stove. The smell of meat and masala drifts through alleys. For a while, everything feels full.

And yet, the day remains solemn. Kashmiris have learned to celebrate without spectacle. This is not a loud festival. It's not about fireworks or lights. It's about fulfilment. The moment when a man offers something precious, not because he must, but because he chooses to.

That choice, of giving what is loved for something higher, is what gives the day its shape. It's what ties Kashmir's landscape to its living spirit.

In a place that has seen too much sorrow, this act of sacrifice gives some solace.

By nightfall, the animals are gone. The courtyards are washed. The meat is stored. The prayers have been said. But something lingers.

A feeling that something intimate has taken place. A gesture between earth and sky.

And tomorrow, the valley wakes again. Not just fed, but reminded.

hen the crescent moon appeared this year, signaling Eid-ul-Azha, there was a peaceful but powerful change in the air over Jammu and Kashmir. It was more than the usual festive announcement. It was a coming of age moment for the region.

Women-led self-help groups and startups are popping up, contributing to a new economic pulse.

And it's not just infrastructure or economics. The people feel it too.

Prime Minister's decision to visit during Eid sent a message of respect and connection. For many, this was a rare moment where politics and faith came together with warmth and hope. PM's words emphasized dignity, peace, and shared growth. So what does this all mean?

It means Kashmir is no longer seen as just a strife zone. It's a place of potential and promise. This transformation is real and measurable, not just hopeful talk.

Highway To The Heart Of Kashmir

We call it a highway. But on days when the fog rolls in and time slows down. NH-44 feels more like a memory I keep returning to.

he first time I travelled from Jammu toward Srinagar, something inside me shifted. The warmth of the plains faded behind me. The air turned cool and sharp. Pine trees appeared like sentinels on the slopes, and fog hung low like a secret trying not to spill.

This wasn't just a drive. This was something else.

NH-44, as it's officially called, is the main road connecting the Kashmir Valley to the rest of India. For most people, it's a highway. For me, it's more like a companion, one that breathes with the weather, sighs with the hills, and speaks in the language of tunnels, rivers, and forests.

You begin low, in the dust and heat of Jammu. Slowly, the road climbs, curling through mountains like it's thinking its way forward. The sound of traffic begins to fade. The air smells of damp earth, burning wood, and wildflowers you don't know the names of. And then the tunnels arrive.

The Chenani-Nashri Tunnel, 9 kilometers straight through a mountain, is the first real pause. You enter in daylight. Then darkness swallows you. It's silent inside, even with engines running. Like the world took a breath and asked

you to wait. When you come out, light hits you again. But it feels softer. Calmer.

Further ahead is the Qazigund-Banihal Tunnel. It cuts through the Pir Panjal range and shortens the journey by hours. But what it really does is remind you of what human hands can do, and what they can't. We can dig, carve, build. But we can't erase the mountain's silence. It stavs with you. like background music that never quite fades.

This road isn't always easy. In winter, landslides block it without warning. Snow can erase the path entirely. You see trucks parked in lines, drivers cooking meals over small fires. Some sleep in their cabins for days. No one complains much. Maybe it's because everyone knows that this road doesn't belong to any of us. We just borrow it.

I remember one winter stop at Patnitop. Snow covered everything. The trees stood still, like they were listening. I didn't talk. No one did. And somehow, that felt like the right thing.

But it's not all stillness. Sometimes, the road laughs. Monkeys sit on railings like old men watching the world go by. Flowers burst out of rock faces, bright and stubborn. Dhaba cooks shout orders over the steam of rajma chawal and hot roti. There's Kehwa, too: sweet, spiced, unforgettable.

These roadside joints aren't just pit stops. They're homes. A place to warm your hands, to hear a story, to feel human. I once watched a mechanic fix a stranger's tire with tape and praver. When I asked how much, he smiled and said. "Whatever you feel is right." I gave him what I had. He nodded like we were even.

Even the flyovers seem to know where they are. They don't shout for attention. They just rise slowly above cliffs and rivers, like they're whispering their way across.

I've seen so many people on this road. Pilgrims, students, honeymooners, army convoys, fruit sellers. Buses full of families staring out foggedup windows. Bikers chasing something they probably can't name. And always, the road watching them all pass.

NH-44 isn't just a stretch of highway. It's a place where stories happen. Where people change without even noticing. Where nature doesn't just sit on the side. It rides with you.

This road doesn't just take you to Srinagar. It brings you home to yourself.

A Reading Room in the Hills of Kashmir

In a remote corner of Budgam, a tiny library inside a government school is slowly reviving the lost habit of reading and is becoming a guiding light for others.

't was around 1:30 in the afternoon when we arrived. The sun hung low, casting soft shadows on the green hills of Narabal, a village in Budgam district.

A few of us, academic monitors, had come to visit one of the government middle schools perched in this part of Kashmir. From the outside, the campus looked still, almost too still. For a moment, we hesitated. Was school already over? Then we stepped closer. Through

an open window, I saw something unexpected: a room full of students and teachers, all silently flipping through books. Some leaned back, lost in thought. Others followed words with a finger, lips moving slowly. Nobody spoke. Nobody checked a phone.

Twelve feet by twelve, that room

may not have looked like much. But inside, it held something rare: a working school library. Not just a cupboard with textbooks or a locked trunk filled with unused novels, but an actual space for reading.

The wooden shelves were packed. Fiction, nonfiction, fantasy, poetry, short stories. Someone had even arranged the books by genre. It felt like a place built with love.

I slipped out, not wanting to dis-turb them. The head of the school came after me and we sat on a low bench outside under a walnut tree. I asked him, "When do the students get a break?"

"From 1:00 to 1:30 they have lunch," he said. "From 1:30 to 2:00, they choose if they want to read. Most of them stay back for books." I've visited dozens of government schools in Budgam. I've seen how

books, when they exist at all, are

kept in tin boxes labeled "library." You might find a few English readers, old Urdu storybooks, maybe a science text from ten years ago. They sit there, untouched, as if just being present was enough. No shelves, no space, no plan. So I asked the headmaster: what

difference does this reading room make?

He smiled. "The internet gives vou speed," he said. "But books give you depth. Our students read slowly. They think more. They ask better questions. Some even started writing their own stories.'

I asked about the kind of books they had.

"It's not just math or grammar," he said. "We bought fiction to build imagination. Nonfiction to open their minds. Biographies, adventure, poetry. Books about animals, space, forests, feelings. Stories from

Kashmir. Things they can relate to." He paused for a moment, then added, "It's like watching a garden grow. One child, silent and shy, now reads aloud in morning assembly. Another started a wall magazine with handwritten reviews of her favourite books."

I thought back to the rooms I've walked into where books are counted only to fill registers. Where dusty cupboards are locked with rusted chains. Where the idea of a library is a line item in an audit report. But in that small reading room, it

was different. A few weeks later, I visited another school in the plains. It had space, four unused rooms. Still,

their books were packed in a tin trunk, unopened for months. When I asked the teacher about it. she said, "We're planning to use one room for library, but we're waiting for furniture." Why wait?

You don't need mahogany shelves or big donations to build a reading habit. A few plastic containers, a mat on the floor, a dozen borrowed books. That's enough to start. What matters most is intent.

And the need is urgent. A recent education survey showed that nearly 65% of students in rural Jammu and Kashmir struggle with basic comprehension by middle school. Add to that the endless distractions of phones, reels, and screens, and you've got children growing up in a world of noise, not meaning. A world where attention is fleeting and depth is lost.

But something changes when a child sits with a book. They learn to pause. To listen. To imagine. They learn to feel things that algorithms can't feed them. Stories

teach them empathy. Pages teach them patience.

I saw it with my own eyes: a girl no older than ten, holding a fantasy book in one hand and her chin in the other, completely still. Next to her, a boy reading about mountaineers. Behind them, a teacher marking his favourite line from a biography with a pencil.

This wasn't a scene from a private school brochure. It was a government school. And it was beautiful.

The school education department in Jammu and Kashmir has talked about digital classrooms, smart boards, and e-learning. That's fine. But let's not forget the power of a paperback. Let's not leave books to die in tin boxes

hey weren't always silent. There were days when the house echoed with the sound of children running down the hallway, their laughter spilling into the corners. But when the noise faded, what remained was silence. The kind that presses against your chest. Sahil lived inside that silence for years.

He married Muskaan with hope in his heart. He had seen her once, and something about her stayed with him. A softness in her eyes, maybe. He thought it was love. But Muskaan didn't see him the same way.

Her family had chosen Sahil for her, and she walked into the marriage without a word of protest, but also without a trace of warmth.

From the beginning, her distance wasn't hard to miss. She answered his questions in half-sentences, never met his gaze for too long, never asked how his day had gone.

It was a slow, silent pushing away. But enough to leave Sahil standing alone, even when hev sat h "She never said it outright," Sahil once told a friend. "But her silence said everything." Still, he stayed. Because love, for him, wasn't conditional. He believed in staying through the cold days, in waiting for spring. He made tea for her every morning, fixed the loose hinge on her cupboard, remembered the dates she for-

something would melt in her. But Muskaan was not waiting to be melted. She had built walls early and kept them strong. She visited her parents' home often, ignoring Sahil's messages while she was away. Sometimes, days would pass without a proper word between them. He asked her once, politely,

got. He believed that one day,

if she was happy. She looked away and said,

'This is my life now. What does happiness have to do with it?'

It was the closest she ever came to telling the truth. Over time, Muskaan's cold-

ness shifted into something sharper. She didn't raise her voice, but she made sure her indifference stung. She involved their children in it too, carefully planting ideas in their young minds. Ideas that made Sahil the outsider in his

own home. "She's turning them against me," he confided to a cousin one night, his voice barely above a whisper. "I don't know what I've done to deserve this." What he had done was love too much. He had mistaken tolerance for strength, and silence for peace. Muskaan's family, always on her side, saw Sahil's kindness as weakness. They knew she hadn't wanted the marriage. But no one had asked Sahil what he wanted, or how it felt to wake up every day beside a woman who wouldn't meet his eyes.

The room he had decorated with soft curtains and pale green walls for her comfort became his prison. She never touched the books he bought her. Never noticed when he

changed the curtains with the seasons. He began to feel invisible inside his own efforts. The children were growing. They loved him, but he saw confusion in their eyes now.

They didn't know why their mother was always cold, or why their father was always silent. They only knew something was missing. Something important. Something neither

There's a kind of heartbreak that doesn't announce itself. It just builds, moment by moment, in the space between two people who once shared a bed but never truly shared their lives. Sahil's heartbreak was like that.

When he finally decided to let go, it wasn't dramatic. He didn't shout. He didn't accuse. He simply stopped waiting. Stopped hoping. He began to live for something else. Maybe peace. Maybe the chance that one day, his children would come to him not out of habit, but out of understanding.

Muskaan never asked why he stopped trying. Maybe she knew.

There is no tidy ending to this story. No last-minute reconciliation. No perfect healing. Sahil still carries the scars. But he carries them with the strength of a man who chose truth over illusion.

And as for justice, Sahil doesn't seek it from this world. "In the end," he says, "I've left it to Allah. I trust His court more than any other."

Maybe that is where true healing begins. Not in forgetting the hurt, but in letting go of what you can't change, and into the light with

But here I am, days later, still thinking about a scene where Joy, the old ringleader of Riley's emotions, human means you can feel a lot

mind. Joy leads the charge, culowed here.

Then puberty hits. And with it

one is willing to sit with. That hit close to home. How often do we look at someone who's upset and say, "That's who they really are"? We dismiss kindness and softness as fake. But why can't someone be angry and still love us? Why can't someone feel afraid and still show up? Why do we expect calmness, politeness, per-

fection, all the time? The film doesn't preach. It shows. It shows how kids, especially girls, learn early to hide what's uncomfortable. How families sometimes encourage joy so much, other feelings begin to feel like flaws. A child learns to be good, not whole. Riley, like so many real kids, wants to belong so badly she starts trimming parts of herself

to fit. Anxiety in the film isn't just a villain. It's a mirror. It shows how fear of failure, of not being enough, takes over. How it talks loud and fast. How it silences other voices in your head. When Riley spirals, it's painful to watch, but painfully familiar, too Pixar doesn't sugarcoat the impact. At one point, Riley stops hearing her own voice. Her inner self is buried under noise, under pressure, under expectations. It's the kind of moment that makes you wonder: how many kids, especially in high-pressure homes, feel that way every day? How many grownups still do?

Think about what we tell boys when they cry: "Don't be weak." Think about what we tell girls when they speak up: "That's not ladylike." Think about the damage in those casual lines. The boy learns silence, not strength. The girl learns obedience, not confidence. And the child learns that love is conditional.

Inside Out 2 doesn't offer neat answers. It can't. But it does something rare: it starts a real conversation. About parenting. About trauma. About how we pass our wounds down, without meaning to. It reminds us that emotions aren't the problem, shame is.

Of course, the movie ends on a high note. Riley finds balance. Her emotions learn to coexist. It's neat, hopeful. Maybe too quick, too clean. Real healing takes longer. Sometimes it doesn't happen at all. But even in this ideal world, the message is clear: wholeness is better than perfection.

Maybe it starts with us. Maybe the best thing we can do is top pretending we're okay when we're not. Maybe we can listen more, scold less. Let our kids cry. Let them rage. Let them be. And maybe, just maybe, the next generation won't have to watch a cartoon to feel understood.

The Kashmiri Elegist Who Left Too Soon

In a Budgam village, a young poet gave grief its rhythm and remembrance its language. Years since his passing, Syed Hussain Mosvi's Marsiyas still echo with devotion, longing, and the light of divine sorrow.

Then someone you love dies, you don't lose them all at once. They disappear slowly, in pieces. A shirt left in the wardrobe. A silence where their voice used to rise. A prayer they once whispered, now lingering in the curtains, in the dusk, in the dust.

That's how I lost my grandfather. And that's how I have held onto him. Through the echo of his verses. Through the trembling of his voice when he spoke of Karbala. Through the hush that falls when his Marsiva is recited even now, in the Imam Bargah in Budgam, where time seems to bow down before grief.

Syed Hussain Mosvi wasn't just a poet. That word, though true, feels too small. He was something else. Something closer to a lantern. He was a bright light carried carefully through storms.

He came from Pallar, a village where the air smells of snow and books and the incense of old prayers. He lived only thirty-five years, but he spoke with the weight of centuries.

When he wrote, it was as if history passed through him like wind through chinar leaves. His words didn't perform. They remembered. And remembrance, in his hands, was sacred.

I still hear his lines each year on the 25th of Rajab, when thousands gather to mourn Imam Musa Kazim (AS). That night in Budgam is unlike any other. The sky is heavy. The crowd sways like a sea in sorrow. And then comes his voice, his Nouha, spoken now by others, but still his in soul.

That cry doesn't age. It doesn't soften. It cuts through the years, fresh as the first wound. And maybe that's what makes him eternal. His poetry bleeds, but never dries.

His Marsiyas were more than poems. They were places. You didn't read them. You entered them. In them, the desert of Karbala came alive. The sun grew cruel. The thirst returned. And in the center stood Hussain, not as a story from long ago, but as a heartbeat.

Mosvi always began with a Hamud, a praise of Allah. But his Hamuds didn't feel like praise from a distance. They felt close, trembling, full of awe, like someone who had caught a glimpse of the Beloved in the middle of a tear.

Yā Khãliq-e-arz-ô-samå wàthrêth zamėēn bàrmā

'Wal-arḍa farashnāhā 'Kôrřûth wàsfā (O Creator of earth and the sky so wide.

Who spread the land with perfect pride.)

And in Surbandh, again:

Hàmmdaş ham sárdãrā Nãt-ē-Råsôôlè-můkhtārā

Sàr-é-dafțăr zěbaãnåý (Praise be to Allah, forever raised on high.

We glorify His Chosen-a light that shall not die.)

These were not introductions. They were veils lifting. Rumi once wrote, "The wound is where the light enters you." And that's what Mosvi's Hamuds did. They opened the wound gently. They let the light in.

He didn't just write Marsiyas. He taught. At the Islamic School in Budgam, he wasn't only an educator. He was a cultivator, of thought, of faith and of wonder. Students recall not lessons but presence: The calm force of a man who could quote Ali (AS) and Ghalib in the same breath.

He helped lay the foundations of Jamia Babul Ilem, a place where knowledge is still taught with reverence, not rush. He believed, like Iqbal, that knowledge without soul is a hollow tree.

There was something else in him too. Something hard to name. Presence and peace, maybe. You could be with him and feel unhurried, unhidden. He listened the way some people pray. He spoke the way some people light candles, softly. and without drawing attention to the flame.

And yet, the flame burned bright.

His Nouhas and Marsiyas were not performances. They were prayers. And in them, the sorrow of Karbala did not feel distant or foreign. It felt like it lived in our own ribs.

His elegy Zameen feels like the earth itself remembering. Wahee feels like revelation through grief. Bukah means weeping, but his verses weep not just with tears, but with truth.

When he recited in the days of Aga Syed Ahmad, people didn't cry out of ritual. They cried because the past had suddenly entered the present. Karbala stood beside Budgam. Dust and blood beside snow and saffron.

Poets like him don't need a library to be remembered. They become the book. And when you read their work, you feel not just educated, but changed.

Even now, his son Syed Mehdi Mosvi carries his name, and his rhythm. The flame did not go out. It was passed, like a sacred trust.

It's been years since he died. But his Marsiyas remain soaked with truth. Still tender. Still trembling. Like Russell said, the greatest men leave us at a loss. Not because we forget, but because remembering them hurts in the most beautiful way.

Syed Hussain Mosvi's life was not long. But some stars don't need centuries. Some voices don't need microphones. Some wounds don't need healing.

He wrote with his whole being. And in doing so, he reminded us how to grieve. How to praise. How to remember.

He reminded us that Karbala is not history, it is presence. That poetry is not decoration, it is direction.

And maybe that's what he leaves behind. Not just words. But a way to live, with dignity, with devotion, with fire.

As Sohrab Sepehri once said, "Let us not seek melodies or words, let us open the window and let the wind play.'

Syed Hussain Mosvi opened the window. And the wind still plays.

SRINAGAR: The Jammu and Anti-Corruption Kashmir Bureau (ACB) has filed a chargesheet in the Court of Special Judge Anti-Corruption Baramulla against 84 individuals-including officials of the Municipal Committee (MC) Sumbal and 82 illegally appointed beneficiaries-for fraudulent appointments made in 2009-2010.

According to the ACB, the case stems from a tip-off received by the then Vigilance Organization Kashmir (VOK), now ACB, alleging widespread corruption and illegal appointments across various urban local bodies in Kashmir. A verification was launched, leading to the uncovering of a major recruitment scam in MC Sumbal, Bandipora.

The probe revealed that the then President of MC Sumbal, Ghulam Ahmad Wani, and the then in-charge Executive Officer, Abdul Rashid Shah, in collusion with beneficiaries, illegally appointed 82 individuals to various posts. These

Report on Audit of the Consolidated Financial Statements.

Opinion

1. We have audited the accompanying consolidated financial statements of Jammu and Kashmir Bank Limited ('the Bank') and its subsidiary & associate (together, 'the Group') which comprise the consolidated Balance Sheet as at 31st March 2025, the consolidated Profit and Loss Account, and the consolidated Cash Flow Statement for the year then ended, and a summary of significant accounting policies and notes to the consolidated financial statements including s summary of significant accounting policies and other explanatory information (herein after referred to as 'the consolidated financial statements'). The consolidated financial statements included the Returns for the year ended on that date of:

(i) Audited Standalone financial statements of the Bank with 63 branches/offices audited by us and 981 branches/offices audited by Statutory Branch Auditors.

(ii) One subsidiary audited by the subsidiary company auditor; and (iii) One associate audited by the associate appointed auditor. The branches/offices audited by us and those audited by the other Auditors have been selected by the Comptroller and Auditor General of India in accordance with the Guidelines issued to the bank by the Reserve Bank of India.

In our opinion and to the best of our information and according 2. to the explanations given to us and based on the consideration of reports of other auditor on separate audited financial statements / financial information of the subsidiary, associate and branches, as referred to in paragraphs 9 to 12 below, the aforesaid consolidated Financial Results:

Key Audit Matters

The financial impact pending such implementation is not likely to be material as per the management. The carrying value of the advances (net of provisions) may be materially misstated if, either individually or in aggregate, the IRAC norms are not properly followed.

Considering the nature of the trans actions, regulatory requirements, existing business environment, estimation/ judgement involved in valuation of securities and calculation of provisions, it is a matter of high importance for the intended users of the Standalone Financial Statements. Considering these aspects, we have determined this as a Key Audit Matter. Accordingly, our audit was focused on

Modi pointed to the large turnout at the Mata Kheer Bhawani Mela and the upcoming Amarnath Yatra as evidence of the region's resilience and unity.

Referring to Chief Minister Omar Abdullah's remarks, Modi highlighted that the completion of the Udhampur-Srinagar-Baramulla rail link, including the iconic Chenab and Anji bridges, fulfills a long-held dream and marks a historic milestone for Jammu and Kashmir.

The 272-kilometre rail project, built at a cost of nearly Rs 44,000 crore, includes 36 tunnels and 943 bridges, ensuring all-weather connectivity that will drive economic integration.

Modi also announced the expansion of MBBS seats in the region from 500 to 1,300 and the establishment of a new medical college in Reasi district to improve healthcare.

Chief Minister Ômar Abdullah praised the completion of the rail link and paid tribute to former Prime Minister Atal Bihari Vajpayee for declaring the project of national importance. Abdullah humorously noted the change in Jammu and Kashmir's status from a state to a union territory after the abrogation of Article 370 and expressed confidence that statehood will be restored under Modi's leadership.

30 Year Wait Ends

359 meters above the Chenab River in Reasi district, the 1,315-meter-long bridge is engineered to withstand high winds and seismic activity. The Prime Minister walked to a viewpoint near the bridge, receiving a briefing on its engineering marvels, and also visited a railway museum, interacting with the project's engineers and workers. He formally inaugurated the bridge, a significant step in connecting Kashmir by rail, and released commemorative coins and stamps to celebrate this engineering feat.

Following the Chenab Bridge event, PM Modi proceeded to inaugurate India's first cable-stayed Anji Khad Bridge, another crucial component of the USBRL project, which further enhances connectivity in the region's challenging terrain.

At noon, the Prime Minister flagged off two Vande Bharat Express trains from Shri Mata Vaishno Devi Katra Railway Station – one to Srinagar and another back to Katra. These stateof-the-art trains are specially designed for cold climates, featuring advanced heating systems and anti-spall layers. They will operate six days a week, significantly reducing the 190 km journey to approximately 3 hours, with stops at key stations like Reasi and Banihal. The new Vande Bharat services are expected to greatly boost tourism and connectivity in Jammu and Kashmir. Regular commercial operations for these Vande Bharat trains will commence on June 7, 2025. Beyond rail infrastructure, the Prime Minister dedicated multiple development projects worth over Rs 46,000 crore to the nation at Katra. These projects encompass critical road infrastructure, flyovers in Srinagar, and the Shri Mata Vaishno Devi Institute of Medical Excellence, the first medical college in Reasi district, valued at over Rs 350 crore. He also laid the foundation stone

for additional projects aimed at enhancing healthcare, education, and economic growth in theregion.

After a historic day in Katra, the Prime Minister departed by helicopter at approximately 2:30 PM, returning to Delhi.

Speaking at a public rally following the launch of the Kashmir rail service, Sinha said the historic inauguration has not only linked Jammu and Kashmir with the rest of India by rail but has also connected the hearts of millions across the nation.

"I feel 'Kashmir to Kanyakumari' is no longer just a slogan after Prime Minister Narendra Modi flagged off the Vande Bharat trains running between Katra and Srinagar. This is now a reality," the LG said.

He further highlighted that the rail connectivity fulfills the dream of former home minister Sardar Vallabhbhai Patel and Syama Prasad Mookerjee, who envisioned a unified and strong India. "Today, we have connected not iust railway tracks but also the hearts of lakhs of Indian citizens," Sinha added.

The inauguration event also witnessed Prime Minister Modi unveiling some of India's most iconic engineering feats: the world's highest Chenab Railway Bridge, the country's first cable-stayed Anji Rail Bridge, and the entire Udhampur-Srinagar-Baramulla Rail Link (USBRL) project. These infrastructure marvels are set to redefine connectivity and spur economic prosperity in the region.

Terming the occasion historic and momentous, Sinha expressed his heartfelt gratitude to Prime Minister Modi for dedicating these projects to the people of Jammu and Kashmir and the nation at large.

"The skills of our engineers and the dedication of workers who carved through the challenging Himalayan terrain have bridged gaps between the 'crown jewel of India' and the rest of the country," he said.

The LG also emphasized the transformative socio-economic progress the Union Territory has witnessed under the leadership of Prime Minister Modi in the last six years. "The prime minister's policies, speedy implementation. and push for industrialization have brought Jammu and Kashmir to the forefront of growth," he noted.

Sinha revealed that since April 2022, projects worth over Rs 1.15 lakh crore have been dedicated or had their foundation stones laid in the region, signifying an unprecedented development push.

He also praised the government's firm stance against terrorism, referring to Operation Sindoor, which avenged the brutal Pahalgam terror attack and marked a clear red line against terror activities. "Our armed forces are prepared to protect the nation's integrity while creative power is harnessed for building a developed India," he said.

In addition to rail connectivity, the Prime Minister laid the foundation stone and inaugurated several critical road infrastructure projects to improve last-mile connectivity, especially in border areas. These include the widening of National Highway-701 from Rafiabad to Kupwara and the construction of the Shopian bypass road on NH-444, worth over Rs 1,952 crore. The LG also mentioned two new flyovers at Sangrama Junction on National Highway-1 and at Bemina Junction on National Highway-44. aimed at easing traffic congestion and improving commuter experience in Srinagar. Highlighting developments in healthcare, Sinha announced the foundation stone laying of the Shri Mata Vaishno Devi Institute of Medical Excellence in Katra, a Rs 350-crore project that will become the first medical college in the Reasi district and significantly boost regional healthcare infrastructure.

With these developments, Jammu and Kashmir stands on the threshold of a new era, one defined by integration, connectivity, and progress, Lt Governor Manoj Sinha affirmed.

His candid remarks – part nostalgia, part political assertion – subtly renewed the demand for restoration of Jammu and Kashmir's statehood, which was revoked in 2019.

Omar also acknowledged the role of former Prime Minister Atal Bihari Vajpayee, crediting him for granting the USBRL the status of a 'project of national importance'. "I was in Class 8 when the foundation was laid. Now at 55, I'm seeing its completion. It's a historic moment,' he said.

The Chief Minister said the new railway link would significantly benefit both residents and tourists, especially during weather-induced highway closures that often lead to sky-high airfares.

PM Modi also inaugurated the world's highest railway bridge - the Chenab Bridge and India's first cable-stayed railway bridge over Anji Khad. Together, they mark the full operationalisation of the USBRL, built at a cost of 43,780 crore. The Prime Minister also launched development projects worth

46,000 crore and interacted with engineers and passengers aboard the Vande Bharat train.

out, eventually extending 11 kilometers on the North bank and 12 kilometers on the South bank of the river, finally allowing heavier machinery to reach the site.

The journey from rudimentary transport to engineering marvel epitomizes India's resolve. Krishnamurthy Subramanian, Executive Vice Chairman, Afcons, emphasized, "The Chenab Railway Bridge is more than just a marvel of engineering. It is a symbol of India's resolve to conquer the most formidable challenges with ingenuity and courage."

With access secured, the colossal construction could truly begin. The project utilized the world's tallest crossbar cable cranes and specialized heavy machinery to tackle the daunting terrain. The very slopes that once necessitated mules were "tamed using massive consolidation grouting, making them sturdy for the colossal arch foundations.'

A moment of profound triumph arrived on April 5, 2021, when the single, majestic arch, constructed from both sides using a cantilever technique, met precisely at its crown. PTI reported that the subsequent viaduct construction presented further unique challenges, with its complex transition areas requiring a meticulously planned, four-section launching sequence. Giridhar Rajagopalan, Deputy Managing Director, Afcons, highlighted an Indian Railways first: incremental launching on both a transition curve and a longitudinal gradient simultaneously for the viaduct portion.

This dedication to quality was upheld through the establishment of a NABLaccredited laboratory on-site - a first in Indian Railways' history – ensuring stringent quality monitoring at every stage.

Rising 359 meters above the river, the Chenab Bridge stands 35 meters higher than the iconic Fiffel Tower in Paris, truly earning its title as the world's highest railway bridge. After its inauguration, Prime Minister Narendra Modi, holding the Tricolour high, walked across this incredible testament to human perseverance and engineering, having traveled to the spot in a rail engine coach – a fitting tribute to the journey from mules to high-speed rail.

"We used 29,800 metric tons of steel on that structure," Kumar said. "It's in seismic zone 5. But it's been designed to withstand strong winds and earthquakes."

A few kilometers away, the Anji Bridge-India's first cable-stayed rail bridge-spans a deep gorge with 96 high-tension cables. Wind speeds here can reach 225 kmph.

'The bridge was built for those conditions," Kumar explained. "We used 849 metric tons of steel and designed it to hold steady even in the most difficult weather"

As Prime Minister Narendra Modi Fridav flagged off the first Vande Bharat Express on this route, Kumar said the focus is also on service.

Two trains will run daily between Katra and Srinagar, reducing travel time to around three hours. "It will bring consistency and speed to travel across the region," he said. "And it's part of a wider effort to connect remote areas across India-Mizoram, Sikkim, the Himalayan belt."

The USBRL project, he added, reflects a shift in execution. "We are working under a clear mandate to complete projects quickly, once they begin. It's a different pace now."

For a railway official who has tracked the slow rise of infrastructure in the mountains, the moment carries massive satisfaction. "This wasn't easy," Kumar said. "But it has been worth the effort."

One Engineer's

engineer with Indian Railway Construction International Limited (IRCON), shared the journey of his association with the project at the Banihal railway station, located 100 km from Srinagar along the national highway.

"As a manager in IRCON, I was initially posted in Srinagar and later had my postings in Baramulla and Anantnag. My main job was to look after the tracks, bridges, station buildings, platforms and electrification. At that time, very few people from outside used to come to the Valley for work," Kumar told PTI videos.

He also said the locals in Kashmir are very cooperative and "if militancy is taken out of this place, it will turn into a real heaven".

Prime Minister Narendra Modi on Friday flagged off two specially-designed Vande Bharat trains, one from Katra to Srinagar and the other from Srinagar to Katra, to mark the completion of the USBRL project.

"I came to Kashmir from my home state Bihar in 2003 to work on the UBSRL project. Initially, I was really scared. There were forces everywhere, and bomb blasts were happening. I was not sure if I would continue for a long time. But with time, I got used to it and continued my work," Kumar said.

Kumar said he was transferred outside Kashmir several times before being posted here again.

"Seeing the project get completed today brought me a lot of joy," he added.

Recalling the loss of a 30-year-old colleague named Sudhir Kumar Pundir from Meerut in 2004, Kumar said he was abducted from a railway construction site in south Kashmir's Awantipora and later police recovered his body with his throat slit.

"The unfortunate incident will remain engraved in my mind forever. Pundir was on duty when he was abducted from a railway construction site," Kumar said.

Fearful of the risks associated with working in Kashmir, the IRCON engineer said he decided to quit his job and go back to his native place.

The rails now hold the answer.

long-pending dream of lakhs of people in Jammu and Kashmir had finally been realised. This project was stuck for years, but during our tenure, we chose to challenge the challenge itself-and we delivered," he said.

Referring to the Pahalgam terror attack that claimed the lives of 26 people, mostly tourists, Prime Minister Modi called it an assault on 'insaniyat' and 'Kashmiriyat', accusing Pakistan of attempting to derail peace and tourism in the region.

The Prime Minister also launched infrastructure and development projects worth 46,000 crore during the event, underscoring the Centre's push for economic revival and stability in the Union Territory.

Pahalgam Attack

the symbolic significance of the inaugu-ration, featuring the world's highest arched Chenab railway bridge and India's first cablestayed Anji bridge, Modi emphasized that despite such attacks, Jammu and Kashmir is poised for progress.

"Pakistan stands against humanity, social harmony, and economic prosperity," Modi said, adding that the attack was aimed at robbing Kashmiris of their 'rozi-roti' (livelihood).

The Prime Minister praised the courage of Adil Hussain Shah, a young pony ride operator who lost his life resisting terrorists during the attack, and lamented the loss of 26 innocent lives, including tourists and locals.

"I cannot explain how happy I am right now. It was like an impossible dream, and we gave up on it so many times. Today, the train has finally rolled out and it is a moment of pride for all of us. I am thankful to the government for motivating us continuously," Kumar said.

He also said the all-weather train will be a game-changer for the holistic development of the Himalayan region.

Will Kohli Come Out Of **Test Retirement If India** Lose In England?

NEW DELHI: Former Australia captain Michael Clarke believes Virat Kohli, who considers Test cricket as the pinnacle, could come out of retirement if India suffer a heavy defeat in the upcoming five-Test series in England and is requested to return by the team man-agement and selectors.

Kohli had announced his retirement from the longest format last month after featuring in 123 Tests for India, scoring 9,230 runs at an

average of 46.85, including 30 centuries. "I believe this. If India go to England and get flogged, if they lose the series 5-0 for example, I think the fans will want Virat Kohli to come out of retirement and play Test cricket again," Clarke told the Beyond 23 Cricket podcast on Friday.

"And I honestly, I think if he was asked by the captain, selectors and supported by fans, if they get beaten big time in England, I think he'll come. He still loves Test cricket.

"I think his words, I think those words, like you could hear his passion for Test cricket is real.'

Following his long-cherished dream of winning the IPL with Royal Challengers Bengaluru. Kohli had said the title triumph still ranked "five levels under Test cricket". Both Kohli and Rohit Sharma had an-

nounced their retirement from Tests ahead of the England series, which begins with the opening match in Leeds on June 20.

"Rohit Sharma retires from Test cricket. I think tactically any team will miss his captaincy. I think tactically he was a bril-liant captain. Virat Kohli walks away from test cricket. Devastating! What an absolute champion he's been and test cricket will miss him," Clarke said.

Shubman Gill has been named captain following Rohit's retirement.

"He (Virat) sees it as the pinnacle and he's still playing good enough cricket. He definitely made the decision to retire and whatever his reasons are, everybody comes to that time in their career," said Clarke, who captained Australia in Tests and ODIs between 2011 and 2015.

"If that's the case, then so be it. But if they don't perform, if they get beaten, like I say, 5-0 in England, which I don't think they will. I think they can still win in England, even without Virat Kohli and Rohit Sharma. I think this Indian squad is a good squad," he added.

Clarke also heaped praise on young batter Sai Sudharsan for his

impressive performances in the IPL for Gujarat Titans. "Forget he's the lead-

ing run scorer, but to me, this kid is a superstar. He left hander. I think he's a number three in test cricket. I think he's probably going to open the batting in time in In-dia's T20 team."

"He's in their test squad. He gets his first opportunity in England. I think he can walk straight into bat number three. I think technically he's very good. He's got all the shots and mentally he's ready. He really impressed me.

And he's a good looking player as well. He's got that left hander backlift. He plays all the shots; against the quicks he'll take on the short ball..



Gill-Led India Depart For England, Aim To End 18-**Year Long Wait**



he Shubman Gill-led Indian cricket team took off for England from Mumbai on Friday for a five-match Test series, part of the 2025-27 ICC World Test Championship cycle.

India have not won a series in England since 2007. India's last tour to England in 2021 ended in a 2-2 draw.




